Rural Sikkim registers 76% voter turnout



GANGTOK, 03 Nov: Rural Sikkim posted an impressive 76% voter turnout for the panchayat polls today. As per statistics released by the State Election Commission, North Sikkim recorded the highest turnout of 83% followed by South Sikkim where 77% of the electorate exercised their franchise followed by West and East districts tied at 75%. Voting was held for 84 zilla territorial constituencies and 849 gram panchayats at 849 polling booths across the State today. These seats were contested by 1,290 candidates.

North records highest voter turnout

MANGAN, 03 Nov (IPR): North District has recorded 83% voter turnout which is the highest percentage of voter turnout in the State. Voting went off peacefully today at all 76 polling stations in the district.

10,386 out of the 12,455 eligible voters in the

13 contested Zilla Territorial Constituencies and 22 Gram Panchayat wards, exercised their franchise. A total of 5202 male and 5184 female voters cast their

votes bringing the voting percentage to 83%.

The voting percentage will further increase after the postal ballots are counted. The Presiding Officers, polling officers along with the EVMs and Election ma-terials have started arriving at Zilla Bhawan Control

South records 77% voter turnout

NAMCHI, 03 Nov [IPR]: South Sikkim saw voter turnout of 77% [55,757 voters] for the Zilla and Gram Panchayat elections with the highest voter turnout percentage of 95% recorded at Rolak Kabey Ward un-der Ben Namprik GPU. The highest number of voters turned out at Tshalamthang Ward under Namphing GPU where 650 voters cast their vote today. The total number of voters in South district is 86,377.

The South Returning Officer (RO), Raj Yadav informed that no law and order situation was reported from any of the 233 Polling Stations located in the South district.

Visually impaired cannot recognise new Rs 50 note: PIL in HC

NEW DELHI, NOV 3 (PTI): The newly issued Rs 50 currency notes cannot be differentiated from others by visually impaired persons, a PIL to-day claimed in the Delhi High Court which sought the RBI and the Centre's stand on the issue.

A bench of Acting Chief Justice Gita Mittal and Justice C Hari Shankar said the matter need-ed urgent attention of the Reserve Bank of India (RBI) and the central government as it was of public importance.

"The issue is of public importance and relates to the rights of the visu-ally impaired persons. It needs an urgent atten-tion of the RBI and Central government. Let it be considered," the bench

It, however, refused to stay the printing and circulation of the new Rs 50 notes which were issued on August 18.

The bench issued no-

tice and directed the Centre and RBI to file their responses in two weeks turn to pg03

Banks, telecos to indicate deadline for linking Aadhaar: SC

NEW DELHI, NOV 3 (PTI): The Supreme Court today made it clear that banks and telecom service providers will have to indicate the last date of linking bank accounts and mobile numbers with Aadhaar in their communications with customers.

Currently, the last date to link Aadhaar with bank accounts is December 31 this year while for mobile numbers, it is February 6, 2018. The top court did not pass any interim order on the pleas challenging the constitutional validity of the Aadhaar Act as well as linking of 12-digit unique biometric identification number with bank accounts and mobile numbers.

It said that final hearing in all Aad-haar-related issues would start before another bench in the last week of November and that bench would decide on the issue.

Moreover, the Centre has already extended the deadline till December 31.

A bench comprising Justices A K Sikri and Ashok Bhushan was told by the advocates representing the petitioners that "panic" was being caused among the people as the messages sent by the banks and mobile service providers were warning

them the services would be deactivated if Aadhaar is not linked.
"We make it clear that in the messages

sent by banks and telecom service providers, the date of December 31, 2017 and February 6, 2018, shall also be indicated as the last date of linking Aadhaar with bank ac-counts and mobile numbers," the bench said. The court issued notice to the Centre on

four separate pleas and tagged them with the main petition which would come up for final hearing before a constitution bench.

At the outset, the bench said that since another bench was scheduled to com-mence the hearing on Aadhaar-related pleas from the last week of November, the matters listed before it should also be decided by that bench.

Senior advocate Shyam Divan, representing one of the petitioners, referred to the recent affidavit filed by the Centre and said it has been told by the government that the December 31 deadline for linking Aadhaar with bank accounts may be ex-

"The notification says the process (of linking Aadhaar with bank accounts)

should be completed by December 31, 2017 or else the accounts would cease to operate. Now, they say it may be extended till March 31, 2018, Thererfore, till March 31, bank accounts should not be made non-operational," he said.

He said Attorney General K K Venu-gopal had recently mentioned the matter before Chief Justice Dipak Misra but not made a statement that no coercive action would be taken till March 31, 2018 against those who have not linked their mobiles or bank accounts with Aadhaar.

"The whole idea is not to coerce people. If they are extending the deadlines, this aspect must be clarified," Divan ar-gued while also raising the issue of linking of Aadhaar with mobile numbers.

When the bench asked the Attorney General about it, Venugopal referred to the apex court's judgement declaring right to privacy as a fundamental right and said in that verdict, Justice D Y Chandrachud had emphasised on a robust regime for protection of data.

He said the report of Justice Sri Krish na committee, which has initiated the

process of reviewing the entire issue of data protection, is likely to be ready by first week of March and that is why he had mentioned the matter before the CII for extension of time till March 31, 2018 for linking of Aadhaar to avail the benefits of various government schemes

"It was opposed tooth and nail (by the petitioners). The court had said it will hear it in the last week of November," the Attorney General said.

When the petitioners again said the Centre should not take coercive action against anyone till March 31 next year, the bench said, "till December 31, time is al-

ready there".

"Since the final hearing in these matters would start in the end of November and time is already extended up to December 31, 2017, there is no need to pass any interim order at this stage.

"However, liberty is granted to the pe-titioners to press prayer for stay in case the hearing does not take place or contin-

ue beyond that," the bench said.

At the fag end of the hearing, senior advocates Arvind Datar, Anand Grover and KV Vishwanathan, representing the petitioners, said the Centre cannot compel the citizens to link Aadhaar either with bank accounts or mobile numbers.

Datar said that under the prevention of money laundering rules, the government cannot say that bank accounts would be discontinued after December 31 unless linked with Aadhaar.

"There is no doubt that these arguments need consideration. The matter is going to come up in the last week of November and the time (to link Aadhaar with bank accounts) has been extended till December 31," the bench said.

Vishwanathan argued that the Centre should tell the banks and mobile service providers not to send messages to customers threatening them of deactivation of accounts or mobile numbers if they fail to link it with Aadhaar as the "public is in a panicky situation due to this".

On October 30, a bench headed by

the CII had said that a constitution bench would be constituted and Aadhaar-related matters would come up for hearing before it in November last.

While the final publication of electoral rolls was done on October 23, the commission has al-lowed remaining service personnel to register as voters, the EC said.

The poll panel had found that the electoral rolls of service voters were faulty as many of those who had ceased to be in service or had passed away, continued to be part of the rolls, EC

functionaries explained.

The draft rolls, published on October 4. tained names of 17,60,392 service personnel.

Competence best judged by higher judiciary, not IB: SC Collegium NEW DELHI. NOV 3

(PTI): Professional competence of those being considered for appointment as judges can best be determined by the members of the higher judiciary and not by the Intelligence Bureau (IB), the Supreme Court collegium has said.

The apex court collegium, headed by Chief Justice Dipak Misra, has said this while recommending the names of three of the four advocates for appointment as judges of the Jharkhand High Court. "As regards com-

ments of Intelligence Bu-reau about professional competence...we are of the view that professional competence can best be determined by the members of the higher judiciary who have the opportunity to observe his performance on a dai-ly basis," the collegium, which also comprised Justices J Chelameswa and Ranjan Gogoi, said.

"As regards com-ments touching upon his integrity, the same are qualified by Intelligence Bureau's own statement that 'there is nothing on record'. In our view, it would not be appropri ate to take cognisance of any unsubstantiated in-formation based on discreet inquiries made by the Intelligence Bureau," the collegium said.

The apex court collegium has recommended the names of advocates Rajesh Kumar, Anubha Rawat Choudhary and Kailash Prasad Deo for appointment as judges of the Jharkhand High Court after finding them suitable for elevation to the bench.

"Their inter se se-niority be fixed as per the existing practice," it said.



Unfortunately, Even Etiquette Needs To Be Enforced

Honking curtailed, let's try and curtail mobile phone urges now

 D^{rive} out to any section of road in Sikkim where traffic cops are unlikely to spy on the driving habits of the hands controlling the wheels, and you are bound to come across drivers chatting away on their mobile phones. An occasional driver might have the hands-free option to service his telecom-dependence, but a majority will have a hand pressed to their ears to keep conversations going. The frequency of such sightings is unnerving, but the practice continues. As the town limits approach, so do the artful dodges to evade detection. And this is only one of the risks and irritations one suffers on Sikkim roads.

Driving into Gangtok is not an experience recommended for those short on patience. The windfall of EMI-option ownership has littered the roads with more vehicles than can move unhindered on the capital's hemmed by buildings roads. For a highway, a national one at that, NH10 in Gangtok is ridiculously ambushed by bottlenecks in its course up the Gangtok hill, and any drive to town needs lurching and stalling through serpentine stretches of idling vehicles and groaning engines and moaning passengers. What is now noticeably missing from the experience is the harassment of near ceaseless honking by the more impatient drivers who somehow believe that the horn helps clear out jams. Well, they didn't, at least not in Sikkim, but the relative calm of reduced honking on Gangtok roads has made the traffic snarls slightly less unnerving. This, largely thanks to the bordering on facetious sight of traffic police personnel displaying banners discouraging avoidable honking. Drivers and commuters are not used to traffic cops making such sober 'appeals', given that its reprimands or tough traffic management that they are normally seen doing, and it is perhaps for this reason that the placard effort was initially either not noticed, or suspected of being even a prank. But the uniform is a powerful medium to convey messages it seems, and thus, without any challans being cut or drivers embarrassed on the highway the Gangtok propensity to honk every time the vehicle ahead so much as slows down, has been quelled. Of course, the occasional instinctive pressing of the horn still happens, but more and more drivers are learning to control their urge only because the cops have been

The honking on Gangtok roads has come down for this reason and not because of a realisation that it is irritating, disturbing, unnecessary or [noise] pollution-causing, and with that is reinforced the dejection that despite everything, even etiquette, unfortunately, needs to be enforced. Since the traffic personnel have achieved so much so quickly for Gangtok and Sikkim's other towns, it is hoped that they also fashion some means of saving commuters from irresponsible driving common on Sikkim roads, the perpetually talking on phone syndrome requiring immediate attention.

And this effort needs to move beyond the city roads and needs interventions along the otherwise not-policed stretches.

Particle physicists discover mysterious structure in Great Pyramid - here's how they did it

Particle physicists have uncovered a large base. Pered a large, hidden void in Khu-fu's Pyramid, the largest pyramid in Giza, Egypt - built between 2600 and 2500 BC. The discovery, published in Nature, was made using cosmic-ray based imaging and may help scientists work out how the enigmatic pyramid was actually constructed.

The technology works by track-ing particles called muons. They are very similar to electrons – having the same charge and a quantum property called spin – but are 207 times heavi-er. This difference in mass is quite important as it turns out it determines how these particles interact when hitting matter.

Highly energetic electrons emit electromagnetic radiation, such as X-rays, when they hit solid matter - making them lose energy and get stuck in the target material. Due to the muon's much higher mass, this emission of electromagnetic radiation is suppressed by a factor of 207 squared compared to electrons. As a result, muons are not stopped so quickly by any material, they are highly penetrative.

Muons are commonly produced in cosmic rays. The Earth's upper atmosphere is constantly bombarded with charged particles from the sun but also from sources outside of our solar system. It is the latter that provide the more energetic cosmic rays that can produce muons and other particles in a chain of reactions

As muons have a relatively long lifetime and are pretty stable, they are the most numerous particles seen from cosmic rays at ground level. And although a lot of energy is lost on the way, muons with very high energies

DOING SCIENCE WITH MUONS

The particles are fairly easy to detect. They produce a thin trail of "ionisation" along the path they take – which means that they knock electrons off atoms, leaving the atoms charged. This is quite handy, allowing scien-



tists using several detectors to follow the path of the muon back to its origin. Also, if there's a lot of material in the way of the muon, it can lose all of its energy and stop in the material and decay (split into other particles) before being detected.

These properties make muons great candidates for taking images of objects that otherwise are impen-etrable or impossible to observe. Just like bones produce a shadow on a photographic film exposed to X-rays, a heavy and dense object with a high atomic number will produce a shadow or a reduction in the number of muons being able to pass through that object.

The first time muons were used in this way was in 1955, when E. P. George measured the overburden of rock over a tunnel by comparing the muon flux outside and inside of the said tunnel. The first known attempt to take a deliberate "muogram" hap-pened in 1970 when Luis W. Alvarez looked for extended caverns in the second pyramid of Giza, but found

Within the last decade or so. muon tomography has experienced a bit of a fresh boost. In 2007, a Japanese collaboration took a muogram of the crater of the volcano Mt Asama to investigate its inside structure.

Muon scans are also being used to investigate the Fukushima reactor remnants. In the UK, the University

of Sheffield is proposing to use measurements of the muon flux to monitor carbon storage sites

EXPLORING KHUFU

The easiest way to use muons to investigate large objects such as a pyramid is to look for differences in the muon flux coming through it. A solid pyramid would leave a shadow or a reduction in the number of muons in that direction. If there is a large hollow void inside the pyramid the muon flux would be increased in the direction of that void. The bigger the difference between "solid" and "hollow" the easier it becomes.

All you need to do is sit some-

where near the ground, look a bit upwards from the horizon towards the pyramid and count the number of muons coming from every direction. As cosmic muons need to be somewhat energetic to pass through a whole pyramid and as our detector "eyes" are relatively small, we need to sit there and count for quite a while, typically several months in order to count enough muons. In the sa way as we have two eyes to get a 3D image of the world in our brains, we want two separate detector "eyes" to get a 3D image of the void inside the pyramid.

The interesting thing about the approach of this team is that they have chosen three different detector technologies to investigate the pyramid. The first one is a bit old fash-

ioned but offers a supreme resolution of the resulting image: photographic plates which get blackened by the ionisation. These were left for months inside of one of the known chambers in the pyramid and analysed in Japan

after data taking was finished.

For the second method plastic "scintillators" that produce a light flash when a charged particle passes through them were employed. These kinds of detectors are used in several

modern neutrino experiments.

And finally chambers filled with gas, where the ionisation caused by the charged particles can be mon-itored, were used to look directly along the direction of the newly dis-

covered cavern.

The electronic signal of those detectors was directly phoned back to Paris via a 3G data link.
Of course a pyramid with three known caverns and a large hollow gallery inside is a bit of a complex object to take a muogram of (it only shows light and dark). So often these pictures need to be compared to a computer simulation of the cosmic muons and the known pyramid, with warts and all. In this case, a careful analysis of the pictures of the three detectors and the computer simulation yielded the discovery of a 30 metre long void, up to now unknown, inside of the Great Pyramid of Giza. What a great success for a new toolkit.

The technique can now help us study the detailed shape of this void. While we don't know anything about the role of the structure, research projects involving scientists from other backgrounds could build on this study to help us discover mo

It's great to see how cutting-edge particle physics can help us shed light on the most ancient human culture. Perhaps we are witnessing the beginning of a revolution in science – making it truly interdisciplinary.

Is drinking wine really good for your heart?

 ${f A}$ s the weekend approaches, people are opening wine bottles in bars and restaurants and homes around the world, ready to kick back and

This relationship with wine has a long history. The oldest known winery, dating back to 4100 B.C, was discovered in 2010 by archeologists in an Armenian cave. Wine was used in ceremonies by the Egyptians, traded by the Phoenicians, honoured by the Greek God Dionysus and the Roman God Bac-chus. By 2014, humanity was consuming more than 24 million liters of wine every year globally. Now there is some fear that extreme weather events in western Europe during 2017 have reduced production substantially and prices of this high-demand commodity are set to rise.

So why is wine so popular? Aside from its flavours, and capacity to help people relax, wine has gained something of a reputation as a "healthy" alcohol — with researchers in the past noting associations between red wine drinking in France, and lower incidence of heart disease.

However, wine drinking is also known to in-

crease risks of serious health issues, including liver cirrhosis, sudden cardiac death, alcoholic cardio-myopathies and cardiac rhythm disorders. Excessive consumption and chronic misuse of alcohol are risk factors contributing to an increase in global disease.

How does the average drinker know what to believe? And how much wine is safe? As medical researchers, we recently published an in-depth analysis of the anatomy of wine. This included analysis of the risks and benefits of consumption, comparisons with other alcoholic beverages and a discussion around wine's much publicised health

WINE AND HEART DISEASE

Modern scientific intrigue surrounding wine has grown immensely since the 1970s, when large, international studies first reported a link between light-to-moderate consumption of alcohol and low-er rates of ischemic heart disease (IHD) occurrence and associated deaths. IHDs are a group of diseases characterised by a reduced blood flow to the heart, and account for significant deaths worldwide.

Similar results have been reported individually for wine, specifically red wine. This phenomenon was eventually coined "the French paradox" after Renaud and de Lorgeril, two scientists who became known for this work, observed a relatively low risk of IHD-associated mortality in red wine drinkers despite a consumption of a diet rich in saturated fat.

Does this mean red wine is good for the heart? This is a complex question and as yet there is no consensus on the answer. More than one factor needs to be considered in order to explain this situation. Drinking patterns, lifestyle characteristics and dietary intake are all important for individuals to obtain a healthy cardiovascular profile.

The Mediterranean diet has been put forward as one explanation. This diet emphasizes consump-tion of plant-based foods in addition to the moderate consumption of red wine and has been labelled as beneficial by scientific advisory committees.

In the Mediterranean diet, the low-consump

tion of saturated fat, emphasis on a healthy life style, and more independently, alpha-linoleic acid (an essential fatty acid) and red wine, may allow this diet to confer the much researched cardio-pro-

CHOLESTEROL, INFLAMA-TION, BLOOD PRESSURE

Red wine contains over 500 different chemical substances. One class, called "polyphenols," has been widely investigated for imparting the apparent antioxidant and anti-inflammatory effects of red

Alcohol and polyphenols are thought to have several positive health impacts. One is a contribution to an increase in HDL-cholesterol or "good cholestrol" and a decrease in LDL-oxidation or "bad cholesterol." They also contribute to a decrease in inflammation. They are thought to increase insulin sensitivity. And they are understood to improve blood pressure.

There is no consistent pattern when wine is compared to beer and spirits. Some report wine's superiority in a reduction from IHD and mortality. Others report it for beer and spirits. Others suggest there is no difference. This suggests that alcohol and polyphenols both contribute to explaining the French paradox, in addition to lifestyle factors

Despite the beneficial effects of wine and al-cohol consumption, drinking is still a potential risk-factor for atrial fibrillation, the most-common "rhythm alteration" of the heart.

HOW MUCH SHOULD YOU DRINK?

In much of the research, adverse effects were increasingly observed with excessive or binge-consumption of wine, while low-to-moderate intakes lowered IHD and mortality risks.

In response, various governing bodies have come forth with guidelines for alcohol consumption. These follow similar patterns, but vary remarkably by country and source. And the definition of "one standard drink" used in each guideline is highly variable, and discrepant between coun try borders. This causes great confusion. Readers should be wary of this when interpreting alcohol consumption guidelines.

The World Health Organization recommends

low-risk alcohol consumption of no more than two standard drinks per day with at least two non-drinking days during the week. Here one standard drink is defined as $10\ g$ of pure ethanol.

The American Heart Association recommends alcohol in moderation — less than or equal to one to two drinks per day for men and one drink per day for women. Here one drink is defined as 12 oz. of beer, 4 oz. of wine, 1.5 oz. of 80-proof spirits, or 1 oz. of 100-proof spirits.

The Dietary Guidelines for Americans 2015 – 2020 developed by the United States Department of Agriculture recommends a moderate consumption of alcohol. This equates to up to two standard drinks per day for men and one for women. Here, one stan-

dard drink is defined as 14 g of pure ethanol. The Canadian Centre for Addiction and Mental Health guidelines recommend low-risk alcohol consumption — up to three drinks per day for men and two for women. One drink is defined as 12 oz. of 5 per cent beer, 5 oz. of 12 per cent wine, and 1.5 oz. of 40 per cent spirits

FUTURE RESEARCH OPPORTUNITIES

Observational data around alcohol consumption and heart health suggests that a light-to-moderate intake, in regular amounts, appears to be healthy. However, when mathematical models have been applied to determine causation (an approach known as Mendelian randomization) the results have been mixed.

Some studies have found light-to-moderate drinking beneficial, while others have reported long-term alcohol consumption to be harmful for

For doctors, it is quite clear what to recommend to patients when it comes to diet, exercise and smoking. Given the inconsistencies in the findings relating to alcohol, and wine specifically, recommendations for consumption are less obvious.

For wine drinkers too, definitive answers on wine and health remain elusive. There is, however, immense research potential in this area for the

And as all the guidelines say, one or two glasses of red wine tonight will be just fine.

Bleaching powder won't do, crush eggs to tame dengue: Expert

KOLKATA, NOV 3 (PTI): As West Bengal is grap-pling with the outbreak of dengue, an expert has observed that spraying of bleaching powder or insecticides will be ineffective as mosquito eggs cannot be crushed by it.

The senior ento-mologist is of the view elimination of mosquito eggs is the only way to tame dengue.

"Spreading bleach-

in controlling dengue because bleaching powder does not crush the eggs laid by dengue mosquitoes. Effect of these insecticides lasts half-an-hour or at the most

It kills only mosquitoes, a scientist of the Zoological Survey of India, Dr Devi Shankar Suman told PTI. "The primary source of dengue mosquito is larval

habitat which they lay around. So the most important part is to finish off the eggs," he said. The West Bengal government has ordered civic bodies to spread bleaching powder in areas where dengue cases have been reported.

So far, there have been 13 deaths in state-run hos pitals due to dengue while over 20,000 cases reported from parts of the city and its surrounding suburbs.

Describing eggs of dengue mosquitoes as the "strongest stage in the life-cycle of mosquitoes carrying the virus", Suman said that the biological characteristics of this mosquito were very different and unless and until they were understood, it would be difficult to destroy it.

'To smash the eggs, you have to spray insecticide within 24 hours because after that the eggs create a protective layer around them and not let any insecticide penetrate it. So you need a 1,000-time more stronger dose of insecticide to quash them. Egg is the strongest stage in the life-cycle of dengue mosquitoes," he added.



entomologist has been conducting a research work on mosquitoes and has collected samples from sever-al areas like New Alipore, Maheshtala, Garia and Botanical Gardens and other places in the

He disagreed with doctors' claims that dengue this season had changed character making it more difficult to deal with.

Elaborating on the

character of the mosquitoes, he said that dengue mosquitoes lived in the periphery of houses and it could breed in one-litre of water as well as in water contained in a bottle cap.

"Locating the breeding place is more important before spraying insecticides here and there. Recent research shows that there is no successful method to penetrate in those bottle caps or cans we use daily.
Only people can eliminate the vector. If it is not repetitive, it will not be affective.

We do not have the tools and techniques to smash the eggs," he said.

Dengue mosquitoes lay eggs on moist soil which can last up to a year, until the ground is flooded again,

According to the ZSI scientist, dengue mosquitoes can fly up to 200 metre and people should be very cautious if any dengue case is reported from a particular locality.

"It bites mostly during day time when humans are active but not at night. We must remember that dengue mosquitoes do not lay eggs in dirty water but in water which are kept in a place for over a period of

"Once dengue mosquitos enter a locality, it is almost impossible to drive them away from that area. Once they lay eggs, those will remain intact for the next six months or even a year," he said.

India look to wrap up series, New Zealand aim fightback

RAJKOT, Nov 3 (PTI): India are poised for their third T20 International series triumph in five years but would be wary of a strong fight-back from the usually plucky New Zealand when the two sides clash in the second game of the three-match series here tomorrow.

The comprehensive 53-run victory in the series opener at Delhi has put India firmly in the saddle for sweeping to a winning 2-0 lead at the Saurashtra Cricket Associa-tion Stadium here in Kandheri.

The resounding victory, riding on the exhilarating batting exploits of their top-order and, in particular openers Shikhar Dhawan and Rohit Sharma, was the country's first-ev-er over the Kiwis in the shortest form of the game.
The 2007 World T20 champions

have produced impressive death bowling with Bhuvneshwar Kumar and Jasprit Bumrah leading the pace department, while the spinners also pitched in with some ex-cellent bowling in the middle overs.

Considering the immense all-round strength that the hosts boast of, it's going to be a Herculean task for the Kane Williamson-led New Zealand to prevent India from surg-ing to a third T20I series victory in eight contests, going back to 2012-13, three of which were drawn en-

The last game is scheduled at Thiruvananthapuram on November

The Indian top order batting,



with superb stroke-makers in Dhawan, Sharma and Kohli, has to be tamed early if New Zealand hope to carry on the fight till the series-end-

Dhawan and Sharma put on a record 158-run partnership that went into the 16th over to ensure that India ended up with a plus-200 total despite a brief wobble towards the

The Black Caps' new ball attack of Trent Boult and Tim Southee lacked discipline in Delhi. It's a bit of a surprise that these two experienced Kiwi howlers have been inunlike the Indian duo of Bumrah and Bhuvneshwar.

And the catching too has let the Black Caps down in contrast to some superb outfield efforts by the Men in Blue.

"We were outplayed in all the areas, fielding included, which is something we pride ourselves on and something we need to be much better at in Twenty20 cricket," Williamson had said after the Delhi loss to Virat Kohli-led India.

Kohli has led the team from the ing the 2000-run landmark in

If the top batsmen fall cheaply, there are others spearheaded by former captain Mahendra Singh Dhoni to come to the home team's

In slow bowling too leggie Yuz-vendra Chahal has continued to trouble the Black Caps' batsmen, in particular captain Williamson and senior pro Ross Taylor who is un-able to read the twirl on the ball off

Only the left-handed Tom Latham, among the visiting team's batsmen, has shown a consistently sound and effective approach against the spin bowlers.

India had clinched back-to-back wins in the last two games of the 50-over ODI rubber for a 2-1 verdict in their favour.

Incidentally, this would be the second T20 International to be played at this venue on the outskirts of the city which was the home ven-ue of IPL side Gujarat Lions earlier this year. The first one was against Australia in October, 2013, won by the home side.

It has also hosted two ODIs at this stadium in 2013 and 2015 and in both these games India ended up on the losing side against England and South African respectively.

Migratory birds arrive in Bhitarkanika National Park



KENDRAPARA (ODISHA), Nov 03 (PTI): Much to the ornithologists delight, migratory birds have started arriving at the wetland spots of the Bhitarkanika National Park in Kendrapara district.

The marshy and swampy wet-land spots in the Bhitarkanika National Park have again emerged as a congenial and human-interfer-ence-free winter habitat for feathered guests from cool northern hemisphere, officials said.
"Their flight has started from

the past one week. Roughly around 20,000 birds have so far been sighted. Their number will rise steadily in coming days," said Divisional Forest Officer, Rajnagar Mangrove (wildlife) Forest Division, Bimal Prasanna Acharva.

For the past one week, flocks of these winter guests are crowding the Satabhaya, Habelikhati, Eka-kula, Raipatia water bodies and creeks. The habitat of these birds extends around ten km stretch, he

There is ample food for the birds as the place is crisscrossed by innumerable water inlets and nullahs and is free of human interference, the DFO said.

Prominent among the winged

visitors to Bhitarkanika this time are Indian Skimmers, Grey Peli-cans and White-backed Vultures, Lesser Adjutant and Grater Spotted Eagles. All of these sighted species are conferred endangered status under the International Union for Conservation for Nature (IUCN) s Red Book Data containing the list of highly threatened animals worldwide, said forest officials.
Other delicate and prominent

birds sighted this time are Blacktailed Godwit, Northern Pin-tail, Lesser Whistling Duck, Grey Plover, Egret Spotted Bills, Oriental Darter, White Belley Seagull and Black-necked Stork.

These species barring the White-backed Vultures are winter migrant avian creatures from northern hemisphere and cool places like Ladakh. They pre-fer Bhitarkanika wetlands for its unique eco-system and cool and serene environment.

Unbearable cold during winter months forces these mi species to temporarily leave their original habitat.

The Chilika lake and the Bhi-tarkanika wetland spots are the favoured destination of migratory birds, officials said.

Lack of human interference,

ideal climatic condition, cool breeze and the river system here have emerged to the liking of these delicate chirpy winged species. This itself is a positive sign and thus further research on the behavioural pattern of these threatened species is being taken up, said wildlife officials.

A museum which offers kids the space to dream

THIRUVANANTHAPURAM, NOV 3 (PTI): It was a place where the city children s dreams got wings long before the advent of amusement parks.

The decades-old Dolls Museum here,

though may have lost its old sheen now with competition from mobile games and TV cartoons, still offers a space for children especially the underprivileged to entertain themselves at an affordable rate.

Named after the country's first Prime Minister Jawaharlal Nehru, the museum, set up in 1980s, has more than 3,000 dolls, made of China clay, papier mache, cloth, coir, wood, rubber, ceramics, mud and plastic. The dolls, displayed in six rooms of the

museum, not only kindle dreams in the minds of children but also teach them the first lessons about India's culture and heritage.

Set up on the lines of Shankar's Inter-national Dolls Museum in New Delhi, the state-run 'Chacha Nehru Children's Museum' at Thycaud in this Kerala capital city is one of the two such facilities in the country recognised by the Museums Association of India, official sources say.

Government schools in the city and

outskirts, which cannot afford tours to expensive amusement parks, bring their stu-dents to this low-key museum which take them down a wonderland of dolls, ranging from ordinary festival puppets to rare eth-ic figurines, in different sizes, shapes, costumes and expressions.

One inch to six feet tall dolls, decked up in traditional attires of various Indian states, give the children a glimpse of the

country's rare cultural diversity. Besides dolls, the museum houses an

impressive collection of stamps and ethnic masks also

A science museum, set up in a separate room with various theory-based exhibits, is also an attraction.

Besides, government schools, some private kindergarten schools also bring the children to the museum as part of their

Tucked away in the first floor of the

headquarters of Kerala State Council for Child Welfare (KSCCW) at Thycaud, the museum had been a hotspot of city children once when amusement parks and TV cartoons were just a hearsay.

The museum is also a solace for the underprivileged inmates of KSCCW.

"Even children from remote village

schools come in large numbers here as part of their annual tour. There were days we had welcomed up to 300 children at one go," Anju, a KSCCW staff, told PTI.

Rs 5 is charged from each child as entrance fee. But, it may be reduced further on occasions based on the request of school authorities, she said.

The variety and simplicity of Dolls Museum at times also attracts senior citizens and foreigners.

"Recently, a senior couple from Nil

ambur in north Kerala came here. They said they came to know about the dolls museum from some of their friends in the city. They spent around an hour here

watching each doll," she said

"It was really nice to see how the dolls brought a smile on the face on the senior citizens," she said.

Museum curator Sumod C R said it had been designed in a way to provide entertainment as well as impart knowledge and information to children.

"We have a total of 3.200 dolls at our museum. Ours is not at all a profit motive institution. Many people express doubt that whether today's children are interested to visit a dolls museum at a time when variety of entertainment are on offer at

their finger tip," he told PTI.

"But, there are a large number of underprivileged children also in our society. And our humble museum is still a hope for them," he said.

Detailing features of the museum, the

official said children would get a clear pic-ture on the lifestyle of people in various states of the country without going there through the dolls here.

"There are a large collection of dolls

decked in traditional attires of each state with glittering jewellery and in the typical costumes of the respective places. Puppets, displaying cultural forms of various states, can also be seen in our museum,"

Besides Indian men and women, the facility also displays models of English people, cartoon characters and figurines of Hindu gods and animals and birds.

The museum has got a new look after the recent renovation undertaken as part of the silver jubilee celebrations of KSCCW.

IBBI is continuing with interactions on the draft rules and indicated that feedbacks can be considered if they reaches them till November 10. Dubey said initially firms, individual business and corporate guaranteers will be brought

Ready to work with India to promote bilateral relations: China

BEIJING, Nov 3 (PTI): China today said it was ready to work with India to promote "constant progress" of bilateral relations, amid fresh strains in ties af-ter Beijing again blocked Paki-stan-based JeM chief Masood Azhar's designation as a global terrorist by the UN.

China yesterday for the fourth time blocked India, the US and other nations' bid to list Pathankot terror attack mastermind Azhar as a global terrorist, saying "there is no consensus" within the members of the sanctions committee.
India reacted sharply to Chi-

na's move, saying "accommodating with terrorism" for narrow objectives was both short-sight-

ed and counterproductive.
China's Assistant Foreign
Minister Chen Xiaodong today told the media that China attached great importance to its relations with India.

"India is an important neigh-bour of China," Chen said, adding China plans to step up ties with neighbours under the "neigh-bourhood diplomacy with Chinese characteristics in the new era" enunciated by President Xi Jinping during the recently concluded key Congress of the ruling Communist Party of China



India to promote constant progress of bilateral relations guided by this diplomacy with Chinese characteristics for the new era," Chen said without elaborating.

He said China has been fol-

lowing this concept and vision over the past few years in its cooperation with the neighbours and deepening mutual political trust promoting practical cooperation with them

In the last two years, China has stonewalled efforts by India to declare Azhar as a global ter-

Last year in March, China was the only member in the 15nation UN organ to put a hold on India's application with all other 14 members of the Council supporting New Delhi's bid to place Azhar on the 1267 sanctions list that would subject him to an assets freeze and travel ban.

The relations between the two neighbours are also

strained by a 73-day standoff at Dokalam over Chinese army s plans to build a strategic road the area also claimed by

Officials here said Chinese Foreign Minister Wang Yi will travel to India next month to New Delhi to attend the Russia, India, China (RIC) Foreign Min-isters meeting during which he would also hold talks with the Indian leadership on the bilateral relations during the second term of Xi.

SC seeks Centre's reply on pleas challenging **Aadhaar Act**

NEW DELHI, NOV 3 (PTI): The Supreme Court today sought the govern-ment's response on four petitions challenging the constitutional validity of the Aadhaar Act and linking of bank accounts and bile numbers with the 12-digit biometric identification number.

The apex court did not pass any interim order in the matter saying that final hearing in all Aadhaar-related issues would start before an-other bench in the last week of this month and the Centre has already extended the deadline till December 31.

A bench comprising Justices A K Sikri and . Ashok Bhushan, however, said that the banks and telecom service providers should indicate the last date of linking bank accounts and mobile numbers with Aadhaar in the messages sent by them to their cus-

"We make it clear that in the messages sent by banks and telecom service providers, the date of December 31, 2017 and February 6, 2018, shall also be indicated as the last date of linking Aadhaar with bank accounts and mobile numbers," the bench said.

Senior advocate Shy-am Divan, appearing for one of the petitioners, referred to a recently filed affidavit by the Centre and said the government has said the deadline for linking Aadhaar may be extended till March 31, 2018.

The bench, however, said the petitioners can raise this issue before the court which would hear all Aadhaar-related matters in the last week of November.

"There is no doubt that these

need consideration. The matter is going to come up in the last week of No-vember and the time (to link Aadhaar with bank accounts) has been ex-tended till December 31," the bench said.

On October 30, a bench headed by Chief Justice Dipak Misra had said that a constitution bench would be constituted and Aadhaar-related matters would come up for hearing before it in November last.

Several petitions challenging the Centre's move to make Aadhaar card mandatory for availing various services and benefits of welfare schemes have been filed in the apex court.

Recently, a nine-judge constitution bench of the apex court had held that Right to Privacy was a Fundamental Right under the Constitution Several petitioners chal-lenging the validity of Aadhaar had claimed it violated privacy rights.

The Centre had on

October 25 told the top court that the deadline for mandatory linking of Aadhaar to receive benefits of government schemes has been extended till March 31, 2018 for those who do not have the 12-digit unique biometric iden-tification number and number and were willing to enroll for it.

Some petitioners in the top court have termed the linking of the Unique Identification Authority of India (UIDAI) number with bank accounts and mobile numbers as "illegal and unconstitutional".

They have also object-ed to the CBSE's alleged move to make Aadhaar card mandatory for students appearing for examinations, a contention denied by the Centre.

Dina Wadia fought a long legal battle for Jinnah House

MUMBAI, Nov 3 (PTI): The seafront bungalow on Malabar Hill built by Pakistan founder Mohammed Ali Jinnah was at the centre of a prolonged battle between his daughter Dina Wadia and the Indian government.

Wadia died in New York yesterday

at the age of 98. Her petition to regain control of her childhood home is still pending for a final hearing the before division bench of the Bombay High

The palatial 'Jinnah House', originally known as South Court, was witness to meetings of the Muslim League and a crucial meeting between Mahatma Gandhi, Jawaharlal Nehru and Jinnah before partition.

Wadia, born to Jinnah's Parsi wife, Rattanbai Petit, in London in August 1919, had insisted that the stately house, designed in European-style architecture, be called South Court.
In 2007, Pakistan's then president

Pervez Musharraf had expressed his desire to acquire the house as Pakistan's property to convert it into a consulate.

The same year (in August 2007), Wadia (then 88), knocked the doors of the Bombay High Court with a petition claiming that the title of the mansion be handed over to her as she was the only heir to Jinnah.

Wadia spent many years in Mumbai but had been living in the US for the past few decades. In her petition, she said she wished to spend her remaining

Wadia, in the petition, had claimed that the bungalow could not be classi-fied as "evacuee property" as her father

had died without leaving behind a will. The petition last came up for hearing before a division bench of Justices S V Gangapurwala and A M Badar on July 28 this year which adjourned it simply to September 7. It has not come up for hearing since then. Soon after her petition was filed, the high court had directed the Union government to file their

affidavit in response.

In October 2007, the govern filed its affidavit stating that the Jinnah House belongs to the government and that only Jinnah's sister Fatima or her le-

gal heir can claim right over the property. Wadia had, however, claimed that she was the only heir of Jinnah and hence the title of the house should be

According to Wadia, the (then) state of Bombay took over the property, because Fatima was the trustee of Jinnah's will, and had been declared an evac uee (those who migrated to Pakistan post-partition) in 1949.

handed over to her.

Wadia, in her petition, claimed that her father's will was not probated by the Bombay High Court and therefore had no effect on any operation of law.

Fatima, therefore, could not be the legal owner and so the house should be handed over to his (Jinnah) legal heir.

Also, she (Wadia) is the sole legal heir of Jinnah's property, both under Hindu Law (applicable to Khoja community--to which Jinnah belonged--before Independence) or the Shia Muslim law, her petition claims. In its reply, the Union government

had claimed that her petition is not maintainable and is barred by prolonged and unexplained delay.

The reply filed by G Balasubrama-

nian, deputy secretary to the Ministry of External Affairs, had stated that Gov ernment of India had issued a notifica-tion on June 27, 1949 under the Bombay Evacuee Property Act, by which the possession of Jinnah House was vested with the Custodian.

On June 10, 1955, another notifica-tion was issued under the Displaced Per-sons (Compensation and Rehabilitation) Act, by which the right, title and interest was vested in Government of India.

Jinnah had bequeathed the Jinnah House to his unmarried sister Fatima by his will dated May 30, 1939. Fatima migrated to Pakistan at the time of partition and was declared an evacuee and hence the property was taken over by the Indian government under the Bombay Evacuee Property Act, the affidavit filed by the government had said. In August 2010, the high court had

ordered for status quo to be maintained in the matter, but had permitted the Centre to complete the renovation work of the bungalow without making any structural changes.

Wadia wanted the mansion, built by her father in 1936 at a cost of Rs 2 lakh, be called South Court.

In a newspaper interview during a visit to Mumbai in 2008, she had said, when asked about the Jinnah House bungalow in south Mumbai, "Why do you keep calling it Jinnah House? That's the name the British gave it. Its real name is South Court. Why don't you refer to it by its original name?"

In 2004, she visited Jinnah's tomb in Karachi, along with Nusli and his two sons. In the visitors' book, she then wrote, "May his dream for Pakistan

Das says although it is scary to see independent filmmakers struggle to get funds for their films, she is "relaxed" about not being burdened with the expectations of a producer.

"Ever since I made the film, it brought me a kind of relief that even after 'Village Rockstars', I don't get people to finance my films, I'll be able to make something good out of a shoestring budget. I won't stop making movies because I don't have a pro-

Besides being the director and producer, Das has also written and edited the

The filmmaker says the contrasting name for the film came up spontaneously.

"Children in villages are not exactly aware about what being a rockstar means. In the film, the word rockstar epresents the spirit of these

"It also has subplots where we see people grap-pling with floods, which is an annual event in Assam. How they know that floods will destroy their crops yet they

continue to face the challenges like poverty in their vil-lage," she says.

Das says people tend to glorify poverty in films and in real life, it is the government that has the power to improve the infrastructure to

benefit the people.

"As a director, I'm just narrating a story, which is my responsibility. I don't consider myself an activist. I try to address the issue in a dif-ferent way and that doesn't mean I'm trying to avoid the

Das says she is in talks with producers to help in the theatrical release of "Village Rockstars", which is expected to be in March-April.


