West Bengal administration cancels permission for GMCC rally SUMMIT REPORT

KALIMPONG, 07 SEPT: The West Bengal administration has cancelled the permission granted to the Gorkhaland Movement Coordination Com-mittee for a rally that was slated to be held in Darjeeling today. The last minute cancellation was reportedly 'due to law and order problem' as per the administration.

GMCC coordinator, Kalyan Dewan said that the administration cancelled their permission

on 06 Sept.
"People who are observing the indefinite strike have the right to know about our stand, future plans and what is happening in the Com-mittee and the rally was supposed to do that for us," he added.

He informed that the GMCC would talk to the administration and seek permission to hold the rally soon.

According to Mr Kaly-an the GMCC will hold a meet on 10 Sept to dis cuss the bipartite meet ing with West Bengal Government at Siliguri which is scheduled to be held on 12 Sept.

SIT begins probe into Gauri Lankesh killing case

BENGALURU, SEP 7 (PTI): The Special Investigating Team (SIT) has started its probe into the murder of journalist- activist Gauri . Lankesh with the Karnataka government saying today it was hopeful of nabbing the assailants "as soon as possible."

The state government yesterday announced the formation of a 21-member SIT team headed by IGP (Intelligence) B K Singh with DCP (West) M N Anucheth as the Investigating Officer to probe the killing of Gauri that led to a wave of country wide protests and con demnation across the

political spectrum.
"SIT members have started their investi-gation into the Gauri Lankesh murder case and the state government is hopeful of nabbing the assailants as soon as possible." state Home Minis ter Ramalinga Reddy told reporters here.

Replying to a query, Reddy said the Inquiry Officer has been given full freedom to probe the matter and make public information as and when required.

WB Govt plants stories, Sikkim Police tries to uproot them

ADGP CONDEMNS **ALLEGATIONS OF** SIKKIM POLICE 'GUARDING' WANTED DARJ **LEADERS**

SUMMIT REPORT GANGTOK, 07 SEPT:

After the recent Namchi fi-asco which saw a clash between the police administra-tions of Sikkim and West Ben-gal, another controversy has erupted fueled by some media outlets and social media pages

about the Sikkim Police providing security to wanted GJM leaders from Darjeeling sup-posedly in hiding in Sikkim.

On Wednesday, TV News Channel ETV Bangla had reported that Gorkha Janmukti Morcha chief Bimal Gurung along with some other leaders was in hiding at a guesthouse near "Rangeet river" guarded by Sikkim Police personnel.

The report was also wide-

ly shared on social media.

Today, the Additional Di-rector General of Police, Special Branch, A. Sudhakar Rao, issued a press statement condemning the news as 'completely malicious and baseless'.

Mr Rao has underlined that Sikkim Police was a professional organization that 'it acts as per the Consti-tution and Law.'

The ADGP has further

stated that 'never in 120 years in the history of Sikkim Police, such allegations have been made by anyone.'

It may be recalled that on 01 Sept, West Bengal police attempted to effect arrests of Gorkha Janmukti Morcha leaders in Sikkim without adequate documentation and

are also alleged to have shot dead a GJM supporter in an encounter carried out near Bhanjyang in South Sikkim.

All this was allegedly done without informing Sikkim Po-lice therefore resulting in an FIR being registered at Namchi Police Station against the Kalimpong Superintendent of Police on charges of murder. Several WB police personnel were also detained in Namchi while some of them, including the Kalimpong SP, fled the State after abandoning their

vehicles near Melli check-post. Following the incident, the West Bengal police claimed that the Sikkim Police was informed about the raid but were feigning ignorance while allegations were also made that Sikkim Police helped Bimal Gurung escape from Namchi.

The WB Police has since

then issued a "lookout notice" against Bimal Gurung and some other GIM leaders and yesterday also took out arrests warrants for them.

Meanwhile, media reports also quoted the WB Tourism Minister, Gautam Deb, who has been fast and free with his allegations against Sikkim, its gov-

ernment and its police, as pass ing comments against the bail granted by the District & Sessions Court at Namchi to Sabitri Chamling, a GTA Sabhasad whom the WB Police had attempted to arrest on 01 Sept, allegedly on gun-point, in Namchi.

This attitude has not gone down well in Sikkim, and Yanzi Pinasha, the lawyer who had successful secure bail for Sabitri Ghising today announced that she was considering to file contempt charges against the WB Minister for his comments against the Sikkim judiciary.

India refuses to be part of declaration of an intl meet over Rohingya issue

Nusa Dua (Indonesia), SEPT 7 (PTI): India dis sociated itself today from declaration adopted at an international conference as it carried a reference to violence in Rakhine state of Myanmar, from where 125,000 Rohingyas have fled to Bangladesh.

An Indian parliamentary delegation, led by Speaker Lok Sabha Sumitra Mahajan, refused to be a part of the Bali Declaration adoped at the World Parliamentary Forum on Sustainable Development held here in Indonesia.

"This was in view of the fact that the declara-tion, which was to be adopted at the conclusion of the Forum, was not in line with the agreed global principles of sustainable development," said a press release issued by

GLA claims responsibility for Mirik blast

DARJEELING (WB), SEP 7 (PTI): The Gorkhaland Liberation Army (GLA) today claimed responsi-bility for the IED explosion which occurred near the gate of the PWD bungalow in Darjeeling's Mir-ik sub-division last night.

GLA posters too sur-faced for the first time today in the hills since the indefinite shutdown was announced by the Gorkha Janmukti Morcha (GJM). The shutdown over the demand for a separate state of Gorkhaland entered its 85th day today.

The blast occurred

last night, two days af-ter shops and markets opened in the Mirik and Kurseong sub-divisions. A few shops in Mirik were opened in the morning, but they downed shut-ters by afternoon.

Subsequently, GLA claimed responsibility for the blast and warned of an "armed struggle" if the politi-cal parties settled for "anything less Gorkhaland". than

Posters of GLA say-ing "Gorkhaland Birodhi

Hoshiyar" (Those opposed to Gorkhaland, be careful) were pasted on

houses and shops at Mirik.
The GLA, the posters said, could go to "any extent" to achieve its "dream" of a separate state and claimed that the outfit was not affiliated to any political party.

"We will spare no traitors, be it the GNLF, JAP, TMC or GJM. We will be forced to bomb the house of any politician who attempts to compromise on Gorkhaland," the

posters said.
"The posters were hand-written in Nepalese They claimed that the GLA was responsible for last night's blast in Mirik. We are looking into the mat-ter," Inspector General of Police, Darjeeling range, Manoj Verma, told PTI.

Meanwhile, absconding GJM supremo Bimal Gurung today released an audio clip from an undisclosed location.

"The GJM will not take part in the September 12 talks with the state government if the issue of Gorkhaland is not dissent a delegation to Delhi to talk to the Union home minister regarding our demands," he said in the audio clip. The search operation

to trace Gurung, against whom cases have been lodged under the Unlaw-ful Activities (Preven-tion) Act (UAPA), continued in the Darjeeling hills and adjoining areas.

An arrest warrant was yesterday issued by the Darjeeling chief judicial magistrate against the GJM chief and seven others for their alleged involvement in violence and arson in Darjeeling on June 8.
Peace rallies were tak-

en out at certain parts of the hills during the day, but they failed to convince the shopkeepers to open their shops and business establishments.

Picketing by GJM sup-porters was strength-ened in some areas and nosters and leaflets were distributed in support of the strike.

Internet services remained suspended in the hills since June 18.





Cong labels "derailment sarkar" tag on Centre after 3 accidents

NEW DELHI, SEP 7 (PTI): The Congress today at-tacked the government over back-to-back train derailments, and said the Modi dispensation should be renamed as "derailment sarkar".

Congress communi-cations in-charge Randeep Surjewala said rail-way safety was in shambles in the country as daily train accidents pose a grave threat to passenger safety.

"Third derailment in 24 hours. Who is accountable? "How many derailments will it take for the Railway Ministry to sit up and take notice? asked the Congress on its official Twitter handle.

Three trains jumped off the tracks in Uttar Pradesh, New Delhi and Maharashtra within a span of nine hours today, the latest in a string of such incidents which saw the exit of Suresh Prabhu as railway minister in the Cabinet reshuffle last Sunday. Luckily, barring inju-

ry to a passenger in the accident in the national capital, no casualties were reported in other incidents. Surjewala said, "3rd train derailment today. Safety in shambles. Modi Sarkar should be renamed as 'Derailment

railment, he said daily train accidents exposed the grave threat to passenger safety as the Railway Ministry remained in "deep slumber".

"Another train accident caused by derailment in U.P. Post reshuffling of cards, when will we have passenger safety measures in place?" he

asked on Twitter.

The 11th National Conference of Indi-National an Academy of Tropical Parasitology-TROPACON 2017 [IATP-TROPACON 2017], organized by the Department of Microbi-ology-Sikkim Manipal Institute of Medical Science [SMIMS] with the theme 'Food Hygiene, Safe Environment and Sanitation towards Freedom from Parasitic Disease', was held today here at the SMIMS auditorium hall.

The event had Secretary of Development Planning, Economic Reforms & North East Council Affairs, Sonam Y Lepcha, as chief guest along with Vice Chan-cellor of Sikkim Manipal University, Lieutenant Colonel Dr MD Venkatesh, and Dean-SMIMS [officiating], VK Mehta, as guests of honor.

The programme also

featured a pre-conference workshop and CME wherein discussions were conducted on respiratory parasitic infection especially those which prevalent in the North East like parago-



nimiasis which should be considered in the differential diagnosis of tuberculosis and malignancy.

Discussions were also held on geohelminthiasis [soil transmitted helminthes] which is a major health problem in devel-oping countries like India and is a major cause of morbidity in school going children leading to malnutrition, growth retardation, anaemia and Vitamin A deficiency.

While addressing the gathering, Secretary for Development and Planning, Economic Reforms

and North East Council Affairs Department, Sonam Y Lepcha, assured support in academic ac-tivities of SMU since the state government and SMU share an important relationship for the development of medical fa-cilities in the State.

Vice Chancellor-SMU. Lt Gen [Dr] Venkatesh, said, "Most parasitic diseases [except malaria] prevalent in the develop-ing world are categorized under neglected tropical parasitic diseases since they suffer from lack of

icy makers with very little investment made towards the expansion of knowledge base, prevention and control of these diseases."

The Health Department needs to be dynamic in spreading aware-ness and take preventive measures for the same, he added.

It may be mentioned here, the three-day conwill provide faculties, remedical searchers, practitioners and public health pro-fessionals an opportunity to present research

findings, experiences and views to a wider audience and also facilitate knowledge sharing and interaction.

Death for 2, Salem gets life sentence

MUMBAI, SEP 7 (PTI): A Special TADA court today awarded death sentence to Tahir Merchant and Firoz Abdul Rashid Khan in the 1993 Mumbai serial blasts case but gangster Abu Salem escaped the noose and handed down life imprisonment due to a provision in the Extradition Act.

Besides Salem, the court sentenced Karimullah Khan to life imprisonment while awarding 10 years in jail to the fifth convict, Riyaz Siddiqui.

The court also imposed a fine on the five accused totalling Rs 27.09 lakh. Firoz Khan was fined Rs 4.75 lakh, Karimullah Khan Rs 8.88 lakh, Tahir Merchant Rs 4.85 lakh, Abu Salem Rs 8.51 lakh and Riyaz Siddiqui Rs 10,000.

The court had in June convicted six persons, including a prime accused Mustafa Dossa and Salem, 24 years after the blasts left 257 people dead. It. however, let off

accused Abdul Quayyum for want of evidence.

Salem, a notorious

close to fugitive mob boss Dawood Ibrahim, escaped death sentence at the Extradition Act bars India from seeking capital punishment for an accused extradited from a country where the practice is not in force.

Before Salem's extra-dition in 2004 following his arrest in 2002 in Portugal, India had assured Lisbon that he would not be awarded capital pun-ishment, if convicted in the case.

This was the second set of trial in the case.

All the seven accused were facing multiple charges which includ-ed criminal conspiracy, waging war against the Government of India and murder.

The court, in its June 16 ruling convicting six accused, held that the prosecution had proved that Salem was one of the main conspirators, and he delivered three AK-56 rifles and ammunition and hand grenades to actor Sanjay Dutt (convicted under Arms Act in the earlier phase of the trial)

Gender Empowerment from the Grassroots

Aim to leapfrog from Panchayats to the Assembly and Parliament

Panchayat elections are round the corner and this will be the second firm the second the second firm the secon will be the second time that fifty percent of the representatives from rural Sikkim will necessarily be women. Women's reservation in panchayat elections started tentatively with 33% quota which was then hike to 40% and has now arrived at 50. Sikkim accords more seats to women in rural and urban bodies than are prescribed elsewhere in the country, and while it is easy to dismiss this as inconsequential as many would be wont to do, it has been a huge step forward towards securing an empowered future for the State's ladies. It was always also a very brave move by State Government and the party in office since politics is essentially a male-dominated domain and finding the around 400 women candidates required to meet the quota continues to remain a challenging ask. Agreed, the party has an organised cheli morcha, but contesting elections and holding office, even at the gram panchayat unit level, requires consistent commitment which is not easy to find or all that common. Even if the party in office enjoys better organizational depth in the State. these remain difficult numbers to deliver. For political outfits which limit engagements to the capital and the occasional public meeting, this is an impossible figure to conjure which is why so many of the parties make only a token participation or boycott the panchayat elections all together.

Nevertheless, Panchayati Raj Institutions are split 50/50 between the sexes and it will now essentially be up to the women themselves on how far they can stretch this increased involvement in decision-making. The concept of reservations to deliver empow erment is not perfect, it has many flaws but most of its limitations are imposed by the benefited sections themselves. The reservation for women in Panchayats all over the country, for instance, fails to deliver the required results because many women Panchayats from the reserved wards are stand-ins for their more pow-erful and politically savvy husbands. Instead of delivering empowerment, this willingness of the womenfolk to allow such subversion only reinforces subjugation A similar pattern can be spied in Sikkim as well but is not as entrenched as it is elsewhere. Here, the State has a chance to play the reservation concept to deliver real empowerment. The moment panchayat elections are announced, the womenfolk of the ear-marked wards should come together and agree on a candidate. The ruling party is already on record assuring that panchayat candidates will be chosen on people's recommendations. Given the numbers, this is going to be a difficult task, but if the womenfolk were to ignore party considerations and lovalties and think only about themselves for a while and select only the most deserving lady candidate and not the lady with the most influential husband or family. Unfortunately, as mentioned, the practice of token women Panchayats is very much prevalent in Sikkim too. If the women were to demolish this practise and consciously ignore candidates who have been propped up by the male side of their families, Sikkim could be looking at real empow erment. The future should deliver even more than just 50% women panchayats; when there are 986 women for every thousand males in Sikkim, why should the elected representation not reflect similar figures at all - from the Legislative Assembly to the Parliament? Someone needs to ask, for instance, why Sikkim has never sent a woman to the Rajya Sabha. The next leap however will have to be for the women to take themselves. They have been provided the stepping stool to reach there with the panchayat reservations and through their performance and increased political presence, they can secure increased representation at all levels if they so desire.

Why universities must fight the new wave of authoritarianism

The march in Charlottesville, Va., earlier this The march in Charlottesville, va., earner und summer by white supremacists, neo-Nazis and other right-wing extremists illuminated the growing danger of authoritarian movements both in the little latest and across the globe. United States and across the globe.

It's signalling a danger that mimics the increasingly forgotten horrors of the 1930s.

Neo-Nazis in the United States, and possibly those worldwide, appear especially emboldened be-cause they've found a comfortable, if not supportive,

place at the highest levels of the U.S. government.
President Donald Trump's administration has included white supremacist sympathizers like Steve Bannon, Jeff Sessions and Stephen Miller. All three embrace elements of the nefarious racist ideology that was on full display in Charlottesville.

Trump's refusal to denounce their Nazi slogans and violence in strong political and ethical terms has suggested his own complicity with such movements.

It should surprise no one that David Duke, a for-mer imperial wizard of the Ku Klux Klan, told the media in the midst of the violence in Charlottesville that white supremacists were "going to fulfil the promises of Donald Trump ... to take our country

'God bless him'

Nor should it surprise anyone that Trump's silence delighted the far right.

The Daily Stormer, a white supremacist website, even had this to say: "No condemnation at all. When asked to condemn, he just walked out of the

room. Really, really good. God bless him."

It appears that the presence of Nazi and Confederate flags celebrating a horrendous history of millions lost to the Holocaust and slavery, of lynch-ings and church bombings, and the assassinations of Black civil rights leaders like Medgar Evans and Martin Luther King, Jr., did little to move Trump.

Charlottesville has resurrected elements of a past that resulted in some of the worst crimes in human history. The ideology, values and institu-tions of a liberal democracy are once again under assault by those who don't believe in equality, justice and democracy.

All of these alarming developments raise serious questions about the role of higher education in a democracy.

What role, if not responsibility, do universities

have in the face of a new wave of authoritarianism? What purpose should education serve when rigorous knowledge is replaced by opinions, the truth is labelled "fake news" by the president of the United States and his devotees, unbridled self-interest replaces the social good and language operates in the ervice of fear, violence and a culture of cruelty?

Universities must hold up democratic ideals

Surely, institutions of higher education cannot limit their role to training at a time when democracy is under assault around the world.

Colleges and universities must define themselves anew as a public good, a protective space for the promotion of democratic ideals, of the social imagination, civic values and a critically engaged

Renowned education professor Jon Nixon argues that education must be developed as "a protected space within which to think against the grain of received opinion: a space to question and challenge, to imagine the world from different standin relation to others and, in so doing, to understand what it means to assume responsibility."

Given the ongoing attack on civic literacy, truth, historical memory and justice, surely it's all the more imperative for colleges and universities to teach stu-

dents to do more than master work-based skills.

Instead, we must educate them to become intelligent, compassionate, critically engaged adults fully aware of the fact that without informed citizens, there is no democracy.

There's much more at stake here than protecting and opening the boundaries of free speech.

There is the more crucial necessity to deepen and expand the formative cultures and public spheres that make democracy possible.

Educators cannot forget that the struggle over

democracy is about much more than the struggle over economic resources and power. It's also about language, agency, desire, identity and imagining a future without injustice.

Return to authoritarianism not far-fetched

As the historian Timothy Snyder has observed, it's crucial to remember that the success of authoritarian regimes in Germany and other places su ceeded, in part, because they were not stopped in the early stages of their development.

The events in Charlottesville provide a glimpse

of authoritarianism on the rise and shine a spotlight upon the forces that are trying usher in a new and dangerous era, both in the United States and

While it may seem far-fetched to assume Amer-ican-style totalitarianism will soon become the norm in the United States, a return to authoritarianism is clearly no longer the stuff of fantasy or hysterical paranoia.

That's especially since its core elements of hatred, exclusion, racism and white supremacy have been in-corporated into both the highest echelons of political power and throughout the mainstream right-wing media, especially Fox News and Breitbart.

The authoritarian drama unfolding in the Unit-

ed States includes the use of state force against immigrants, right-wing populist violence against mosques and synagogues and attacks on Muslims, young Blacks and others who do not fit into the vile script of white nationalism.

Charlottesville was just part of a larger trend of

domestic terrorism and homegrown fascism that is

on the upswing in the United States.

Trump's administration, after all, has announced it will no longer "investigate white nationalists, who have been responsible for a large share of violent hate crimes in the Unites States.

DESISTANO.

Trump has also lifted restrictions imposed by the Obama administration in order to provide local police departments with military surplus equipment such as armed vehicles, bullet-proof vests and grenade launchers.

These actions accelerate Trump's law-and-order agenda, escalate racial tensions in cities that are often treated like combat zones and reinforce a warrior mentality among police officers.

Equally telling is Trump's presidential pardon of Joe Arpaio, the notorious white supremacist and disgraced former sheriff of Maricopa County, Arizona. Not only did Arpaio engage in racial profiling, despite being ordered by the court to desist, he also had a no-torious reputation for abusing prisoners in his Tent City, which he once called "a concentration camp."

A nod to domestic terrorism

There is more at work here than Trump's endorsement of white nationalism: he's also sending a clear message of support for a culture of violence that both legitimizes and gives meaning to acts of domestic terrorism.

What's more, there's a clear contempt for the rule of law. And there's also an endorsement not just for racist ideology, but for institutional racism and consequently the primacy of the race-based incarceration state.

In his various comments, tweets and policies, Trump has made clear that he does not see himself as the leader of the country, but as the head of a right-wing movement fuelled by rage, isolation, so-cial atomization and communal disintegration, galvanized by a culture of fear and bigotry. He preys upon a populist hatred of democracy.

At the moment we're seeing a looming collapse

of civic culture.

A healthy democracy always struggles to pre-serve its ideals, values and practices. When taken for granted, justice dies, social responsibility bees a burden and the seeds of authoritarianism

We may be in the midst of dark times, but resis-

tance is no longer an option but a necessity.

And educators have a particular responsibility to address this growing assault on democracy. Any other option is an act of complicity, and a negation of what it means for education to matter in a democratic society.

'Instant divorce' ban: the end result or the first step in reforming Islamic law?

"UN-ISLAMIC, arbitrary, unconstitutional." That was the judgement of the Indian Supreme Court as it announced a ban on the contentious practice of instant "triple-talaq".

Triple-talaq is a form of Islamic divorce which allows a husband to dissolve his marriage instantly and unilaterally, simply through pronouncing "talaq" (divorce) three times to his wife.

While it has long existed in cus-tomary practice, it carries little for-mal sanction within Islamic law itself. It receives no endorsement in the Qur'an, which stresses unambiguously that all divorces should work through a staggered process which allows space for reconciliation. And authoritative works of jurisprudence uniformly declare instant-talaq to be "sinful", if not always technically "forbidden".

It is on these grounds that, espe cially over the last century, a large majority of Muslim countries have banned instant-talaq, including neighbours Pakistan and Bangladesh. including Sri Lanka has also banned it. Nevertheless, instant-talaq had remained legal in India. Delivered either in peremail or WhatsApp, it led to count-less women suffering the fates of instant abandonment, homelessness or

This is why this decision is being hailed as one of the most important moments in India's history for the emancipation of women. In a year notable for the erosion of women's rights across the globe, it is some-thing to be celebrated.

Yet, this historic ban raises the estion of how much further it may go. Will it lead to a wholesale reform of Muslim laws in India? Or, will the intervention stop here? To answer this, we need to explore the complex place that Muslim family laws have occupied in India's constitutional and

A PATCHWORK OF PERSONAL LAWS

It can be difficult to understand how India, with its religious pluralism and secular constitution, has become one of the final refuges for such reviled practices as instant-talaq. The answer lies in the complex relationship between the Indian state and its often

beleaguered minorities.

Ever since India's independence,

and following the traumatic effects of partition, politicians have pledged protect religious freedoms by allowing minorities to live according to their own laws, in all family matters

This means that, in Indian law and politics, the ability of minorities to live freely has become merged with the idea that the state must not intervene in community-specific practices, such as matrimonial regulations. So while judges or politicians else-

where across the Muslim world, from Morocco to Indonesia, have managed to reform Islamic laws, bringing them under their own courts or codifying

them, this never happened in India.

India has never installed a uniform set of family laws for all citizens. And most Muslim laws themselves have remained stubbornly uncodified. They often function in an unregulated space at the community level, with religious marriages remaining unregistered, and divorces happen-

ing outside of court.

India's commitment to the protection of minorities is admirable and necessary, and is something to be cherished. But it has carried some

unintended by-products.

The historic reluctance of the courts and politicians to intervene

too boldly in minority laws has allowed controversial fringe customs to survive. These include not only instant-talaq, but polygamy and nikah-halala, a practice by which an ex-wife is compelled to take out and consummate an interim marriage be-

fore remarrying her first husband.

Too often, women have been the main victims of these "religious" practices – their individual rights sac-rificed to the supposed rights of the

THE END OF NON-INTERVENTION?

So does the Supreme Court's ban mark a broader departure from this long-term strategy of non-interven-

On the one hand, the court's own announcement of the ban differs from its past failures to implement its verdicts in Muslim laws. In the famous Shah Bano case of 1985, the court attempted to amend Muslim laws on alimony, but the government, under political pressure, overturned its decision.

That will not happen this time. Instead, the current BJP government is on the court's side on this issue. It has long expressed its opposition t

Monsoon rains claimed 164 lives in Pakistan: NDMA

ISLAMABAD, SEP 7 (PTI): Heavy rains and related flooding in Pakistan have killed 164 people, includ-ing 39 children, during the current monsoon season, weather officials said.

The torrential rains have also left hundreds of people homeless. The National Disaster Management Authority (NDMA) and provincial government teams are carrying out rescue and relief operation in the affected areas.

Sindh and Punjab provinces were the worst hit with 38 fatalities in each province since the advent of the monsoon season, the NDMA said

yesterday.
"From June 26 till
September 6, a total of

164 people have been reported killed, including 39 children, while 167 people injured in rain-related incidents and 440 houses damaged," it said.

Monsoon hits Pakistan every year in June and the season normally ends in September. During this period, the country receives heavy rains which cause severe flooding in many areas.

The most destructive floods caused by heavy rains hit the country in 2010 in parts of Khyber Pakhtunkhwa, Punjab and Sindh, leaving over 1,500 people dead.

According to a UN report, 557,226 houses were destroyed and over six million people were

Flood situation improves marginally in Assam

GUWAHATI, SEP 7 (PTI): The flood situation in Assam marginally improved today, even as one person lost his life and 56,000 eople remained affected across four districts, the Assam State Disaster Management Authority (ASDMA) said today.

One person was killed by the

flood waters in Dhemaji district,

according to a report by ASDMA.

The third wave of the devastating flood has so far claimed the lives of 75 people across the state, the report said.

Flood-related incidents in Assam has so far claimed a total of 159 lives in the state, including eight deaths in Guwahati. ASDMA said 56,000 people

are affected at present in Dhemaji, Lakhimpur, Morigaon and Nagaon districts.

Till yesterday, over a total of 62,000 people were impacted by the latest wave of floods

across six districts in Assam. As per the report issued to-day, Nagaon is the worst hit with over 25,500 affected, followed



by Morigaon with nearly 23,000

bearing the brunt of the deluge. Currently, 151 villages are and over 6,500 hectares of crop areas are inun-

dated, the report said.

Authorities are running

40 relief camps and distribu tion centres in five districts, where 7,842 people are taking shelter.

River Brahmaputra is currently flowing above the red mark at Nimatighat in Jorhat.

Other rivers like Dhansiri at Numaligarh in Golaghat, Jia Bharali at N T Road Crossing in Sonitpur and Kushiyara at Karimgani town are also flowing above the danger mark, the re-

In wake of Gauri's assasination, journalists denounce trolling on social media

NEW DELHI. SEP 7 (PTI): Online abuse heaped on a dead Gauri Lankesh lays bare the "hostile atmo-sphere" people are facing today on social media where an army of trolls is either "intimidating dissenters" or fomenting tension, according to leading journalists.

Shocked at the gunning down of the 55-year-old journalist -activist, an outspoken critic of Hindutva politics, many journalists and activists concurred that a "climate of fear" was being built by "paid trolls" on Facebook and Twitter to silence those holding divergent views or to "spread disinformation".

Senior TV journalist Ravish Kumar said that he felt like he was a "dead man walking" ever since he heard about the chilling murder of Lankesh at the entrance of her home in Bengaluru, an eerie reminder of the killings of rationalist Narendra Dabholkar and former vice-chancellor of Hampi University M M Kalburgi. "Gauri Lankesh's kill-

People have been killed in the last few years just because they had a divergent opinion or dis-sented against an idea.

"Even after her (Lankesh's) death, many on social media are using abusive language to de-scribe her. Look at your timelines (on Facebook and Twitter), there are people watching, what you are writing. She was killed to send out a message to all of us that if you dissent, you will meet this fate," Kumar said at a

gathering yesterday.
Senior journalist Paranjoy Guha Thakurta, who was trolled for an article recently, shared how the world over peo-



ple were fighting an "or ganised army of trolls, paid for by those with vested interest, either political or corporate"

"And, especially the extreme-right-wing people are using the techniques and the tac-tics in a Goebbels-like manner to spread disinformation, which is a propaganda, for a purpose, which is extremely pernicious. Fake news is being spread through WhatsApp and other media to foment hatred and tension, like in the Muzaffarnagar riot case," he

Facebook has more users than the popula-tion of China and it's is only growing. "So, it can-not be ignored or wished away." Thakurta said.

"It (social media) is like a surgeon's scalpel. It is sharp and can be used to remove a diseases part of the body and the same tool can be used to injure, maim or even kill somebody. Facebook and Twitter are becoming a difficult terrain, espe-cially for journalists and outspoken people," he

Amid an outrage over the cold-blooded murder of Lankesh, scores of fellow journalists from various media houses yesterday gathered at the Press Club of India here, and also expressed con-cern over tasteless jibes being hurled on social media, for the political views she held.

social media, who described her with demeaning epithets.

"It is a tough time for journalists. And, even RTI activists and environmental activists have been killed in the past. Now, social media is being used to intimidate and threaten people. If you have a different opinion or if you dissent and air your view on Face-book or Twitter, you will be trolled and harassed."

General Secretary of Broadcast Editors Association Ajit Anjum said it was a difficult time for journalists and people expressing divergent views, especially on social media.

"People are being killed on social media first," he said.

Noted Supreme Court lawyer Vrinda Grover, who was present at the protest meet, expressed her horror over the killing, and said, "We are

living in very dangerous

times."

"This was not random Lankesh was killed because she stood and fought for ideas of justice and values enshrined in our Constitution -- liberty, equality. And, even after her death, people are using abusive language for her on social media. People being abused or intimidated on social media to silence them, is a very dangerous trend," she added.

instant-talag, and is planning to draft a new Muslim matrimony law to replace it. And one section of opinion, now emboldened within the party, has long sought the wider reform of Muslim family laws. But on the other hand, the court's verdict

has managed to ban instant-talaq in a way

that does not demand further reforms.

This case had threatened to turn into a gloves-off battle, between the constitutional rights to equality and freedom of religion. Any decision that confronted this question would have had deep implications both for Muslim laws, and the legal codes applied to other communities.

Perhaps intentionally, the court has deft-managed to dodge this question. By allowing each of its justices to apply different lines of reasoning, some constitutional and some Qur'anic, the bench managed to argue that instant-talaq infringes both Islamic and constitutional standards alike. "What is bad in theology is bad in law also," claimed Justice Kurian Joseph. The ban implies no conflict of values

With feelings running high, this decision shows considerable pragmatism. Some commentators have praised it for its balancing of divergent opinions, while others have shown more regret at its caution. Some have suggested that the verdict, by declaring in-stant-talaq un-Islamic while placing the system of personal laws itself beyond scrutiny. actually leaves the foundations of this system even stronger. It reinforces Muslim family laws, even as it restricts some among them.

REFORM FROM WITHIN

So, this ban could realistically be a one-off decision, rather than a first step.

But what may be different this time is

that there has been vocal demand for further changes from among Indian Muslims themselves.

The internal call for change from com-

munity voices during this case has been decisive. This includes the petitioners themselves, an array of Islamic feminist groups, and a range of Muslim public intellectuals and lawyers. Together, all have also provoked huge grassroots interest and a size-able campaign of social activism.

Emboldened by the current decision. many of these people are now pursuing the next steps. Some want polygamyand nikah-halala, questions which the Supreme Court refused to consider this time, to be addressed. Some are even asking for a comprehensive codification of Muslim laws.

If wider reforms to Muslim laws do come, they may be initiated not on the whims of the courts or parliament, but in response to pressure from community voices. And such changes always carry more legitimacy if they are driven from within.

Del Potro shatters Federer's dream of Nadal US Open showdown

New York, Sep 7 (AFP): Juan Martin del Potro sensationally gatecrashed the US Open again, stunning five-champion Roger Federer and shattering hopes of a first New York showdown between the Swiss legend and

The Argentine giant, who won his only Grand Slam title in the city in 2009 by beating Federer in the final after seeing off Nadal in the semis, triumphed -5, 3-6, 7-6 (10/8), 6-4 in front of a spellbound Arthur Ashe Stadium crowd. The 28-year-old will once

again face world number one Nadal in the semi-finals on Fri-day, a stunning achievement for a man who had saved two match points to beat sixth seed Dominic Thiem in the last 16.

Nadal, who will keep his world number one status fol-lowing third seed Federer's exit, had earlier defeated Russian teenager Andrey Rublev 6-1, 6-2, 6-2 in just 97 minutes.

It will be a sixth US Open semi-final for Nadal and 26th a the majors while Del Potro, the 24th seed, will be playing in just his fourth last-four match at the

For 36-year-old Federer, it was a first Slam loss of 2017 af-ter he had captured the Australian Open and Wimbledon titles to take his career tally to 19

"I served really good. I hit my forehand as hard as I could and I played a great match. I deserved to win," said Del Potro who will be in his first Slam semi-final since Wimbledon in 2013.
"This feels like my home

court. I played Rafa here in 2009 too. Hopefully I can get the same result on Friday."

Del Potro, whose career was almost ended last year after un-



wrapped up the first set thanks to a break in the 11th game secured with a blistering crosscourt pass.

Federer, who had a 16-5 winning record over Del Potro ahead of the quarter-final, levelled the tie after breaking for a 3-1 lead in the second.

However, the match turned in the third set tiebreak when Del Potro saved four set points before a weary and error- rid-dled Federer dropped serve again to trail 3-2 in the fourth.

Victory was Del Potro's eight minutes short of three hours with a deep forehand as Federer was left to survey the wreckage of 41 unforced errors.

"It's hard to explain, I didn't

play that badly," said Federer.
"I just ran into a guy who was better on the bigger points I don't deserve to still be in the

Nadal will take an 8-5 record over Del Potro into the semi-fi-nal where the winner will face either Kevin Anderson or Pablo

Carreno Busta for the title.

"Juan Martin is a top player. When he's playing well, it's difficult to stop him. Probably the forehand is maybe the fastest on the tour," said Nadal, who is chasing his second major of the year to add to his French Open.

Rublev, bidding to be the youngest man in 17 years to reach the semi-finals, had no complaints over his loss to Na-

"He gave me a lesson: 1, 2, and 2," said the Russian, who lost 16 of the last 19 points of the opening set and finished with 43 unforced errors.



The Oriental fruit fly (Bactrocera dorsalis) is considered to be the most destructive, invasive and widespread of all fruit flies and is also a menace in 65 other countries in Asia, Africa and the Americas.

The agri-tech company Biofeed's "lures" hung on trees, contain an organic customised mix of food and feeding stimulants and control or therapeutic agents delivered by a patented gravity-controlled fluid release

Attracted by the odour, the fruit fly takes a sip and soon dies, without any chemicals

reaching the fruit, air or soil.

"We were hoping to bring a solution that will replace spraying and increase

by the results, demonstrating the future otential for some farmers to bring about 900 times more marketable pro market," said the company's CEO Nimrod

rael. However, until now there was no solution for this problem. So we took the challenge and chose to focus on India," Israely told Israel21c, an online news magazine

Pak must change approach towards terror groups: US

WASHINGTON, SEP (PTI): Pakistan must "change its approach" towards terror groups oper-ating from its soil and take a decisive action against them, the US has said.

The remarks from the US came after for the first time the BRICS Summit in their joint declaration named Pakistan-based terrorist groups as a con-cern for regional security and called for action against them.

"As the adminis-tration has said, Pakistan must change its approach," a State Department spokesperson told PTI in response to a question on the BRICS statement that BRICS statement that named Pakistan-based Lashkar-e-Taiba Jaish-e-Mohammed among the terror groups that create problems in the region.

"We look to the Pakistan government to take decisive action against militant groups based in Pakistan that are a threat to the region," the spokesperson said.

Pakistan has denied allegations it harbours these groups.

India, Indonesia far behind in measles vaccination: WHO

MALE, SEP 7 (PTI): India and Indonesia are far behind in their battle against measles and account for over 90 per cent of the unvaccinated children in the Southeast Asia, the WHO said here today, asserting that the vaccination drive was hampered due to miscon-

ceptions and misinformation.

According to the Southeast Asia Regional Office of the World Health Organiza-tion (WHO SEARO), 3.1 million children in India and 1.1 million in Indonesia did not measles vaccination in

Together they account for 91 per cent of unvaccinated children in the region, with India alone accounting for 67 per cent of the children missing immunisation.

Health officials have expressed concern about the situation as measles still kills an estimated 134,200 children worldwide every year, which



includes more than 54.500 in Southeast Asia.

"There is no global goal or big fund to eradicate measles, so countries should allocate funds for it, especially India

and Indonesia, where the largest numbers of unimmunized children reside," Pem Namgyal, the WHO SEARO di-rector of family health, gender and life course, told PTI on the

sidelines of the office's 70th regional committee meeting.

He said the two countries were still far behind the Mal-dives and Bhutan, which have been declared free of measles.

India and Indonesia, home to 1.3 billion and 261 million people respectively, are Southeast Asia region's most-populous countries.
One of the largest miscon-

ceptions about the measles vaccination, usually called MMR or MR vaccines, is that it can cause autism. During phase 1 of the MR campaign in India, some negative messages were floated through social media (whatsapp and Facebook) in Karnataka, Tamil Nadu and Puducherry. There was some coverage of these negative social messages on local television channels

as well. 'This leads to some hesitancy to accept MR vaccine in these states," Namgyals said. "Since the campaign was

still ongoing and the state governments realised that this could negatively affect the coverage, they took immediate actions which included editorials in newspaper stat-


ing benefits of MR vaccina tion campaign advocacy cam-paign, involvement of local ce-lebrities to counter the wrong messages and social media messaging targeting negative

rumours." he said. "The state governments also decided to extend the duration of the MR campaign in states. As a result of all these actions, high coverage was achieved in all the states.

Learning from this experience, India has put together a communication strategy for the next phase of MR cam-paign which is currently under implementation," he said.

In a predominantly Mus-lim country like Indonesia, there is also resistance due to the widespread view that the vaccine contains pork gelatine, which is forbidden in Islam.

Namgyal, however, dismissed these misconceptions, saying the vaccine was harmless.



"ENORMOUS DAMAGE" has been caused by Hurricane Irma on the Dutch side of the Caribbean island of St Martin, the Dutch Royal Navy has said. Many houses are missing roofs and hotels are under water, it added. France's interior minister, Gerard Collomb, said eight people had died on the French side of the island, adding that the figure was likely to rise in the coming hours.

China, India should make sure differences do not go out of control: Wang

BEIJING, SEP 7 (PTI): China and India should shed their mindset of regarding each other as rivals or threats and make sure that their differences do not go out of control, Chinese Foreign Minister Wang Yi said today.

In his first comments on India-China ties after this week's meeting be-tween Prime Minister Narendra Modi and Chinese President Xi Jinping on the sidelines of the BRICS Summit, Wang said bilateral relations were "affected and undermined" during the past few months "for clear reasons". Without mentioning the 73-day standoff between the militaries of the two countries at Dokalam, Wang said, "going forward, the two sides need to work together to follow-up on the con-sensus reached by the two leaders and make sure bilateral relations stay on

Speaking to the media after his talks with Nepalese Deputy Prime Minister and Foreign Minister Krishna Bahadur Mahara, Wang said the Sino-India relationship "should not be derailed".

harmonious relations and win-win cooperation which is the natural choice and the right choice" for both, Wang

"There should be no confrontation. We need to build strategic mutual trust and the two sides need to work to really look at each other as cooperative partners rather than be driven by an old-fashioned mindset and regard each other as rivals or threats," he said. Both the countries should also

"make sure that differences do not go out of control", Wang said.

"Both sides need to remain committed to the five principles of peaceful coexistence and work together to properly handle disputes and also work together to maintain tranquillity in the border areas," he said.

After the end of the Dokalam standoff, Modi and Xi had a positive meeting at Xiamen. Putting behind the standoff, India and China had agreed to move forward in their ties with President Xi telling Prime Minister Modi that he wants to put the relationship on the "right track".

Nine dead as Hurricane Irma rips through Caribbean

MARIGOT, SEP 7 (AFP): Powerful Hurricane Irma cut a swathe of deadly destruction as it roared through the Caribbean, claiming at least nine lives and turning the tropical islands of Barbuda and St Martin into mountains of rubble.

One of the most powerful Atlantic storms on record, the rare Category Five hurricane churned westward off the northern coast of Puerto Rico early morning on a potential collision course with south Florida where atrisk areas were evacuated.

St Martin -- a pristine resort known for its vi-brant nightlife -- suffered the full fury of the storm, with rescuers on the French side of the island saying at least eight peo-ple had died there and another 21 were injured.

With some 95 per-cent of homes destroyed on the French side of the island -- the other half belongs to The Neth-erlands -- a delegation of troops, rescuers and medics arrived from France headed by Overseas Territories Minister Annick Girardin to help

with rescue efforts. "It's an enormous catastrophe. Ninety-five percent of the island is destroyed," top local offi cial Daniel Gibbs said in a radio interview.

"I'm in shock. It's frightening."

Guadeloupe prefect Eric Maire called the situation in St Martin "dramatic," saying the island -- which is divided between the Netherlands and France -- was with-out drinking water or electricity, and warning the death toll was almost certain to rise.

To the southeast, Barbuda, part of the twin island nation of Antigua and Barbuda, suffered 'absolute devastation with 95 percent of properties damaged, and up to 30 percent demolished, according to Prime Minister Gaston Browne

"Barbuda now is liter ally rubble," Browne said.

One person is known to have died on the island of 1.600 residents. apparently a child whose family was trying to get to safer ground.

And on the island of Barbados, a 16-yearold professional surfer named Zander Venezia died while trying to ride a monster wave generated by the storm, the World Surf League said.



Is this the real life, is this just fantasy? Rami Malek looks just like late Queen frontman Freddie Mercury in the first photo from the upcoming biopic Bohemian Rhapsody.Entertainment Weekly published the first look on Tuesday, September 5, which would have been the singer's 71st birthday. He died at age of 45 in November 1991 of bronchial pneumonia resulting from AIDS.
