Artisans with Rs 20 lakh turnover exempt from GST registration

HYDERABAD, SEP 9 (PTI): The GST Council today exempted artisans and folk artists with an annual turnover of up to Rs 20 lakh from registration under the just introduced Goods and Services Tax (GST).

West Bengal Finance Minister Amit Mitra said besides exempting artisans, the 21st meeting of the highest decision making body of the GST exempted clay idols from the tax. Also, no registration would be required for inter-state job works, he said.

"For artisans, artists, folk arts and tribal arts, no registration will be required up to Rs 20 lakh

(turnover).
Clay idols are exempt now," he said, adding that "job work inter-state, you don't need any registration now up to Rs 20 lakh turnover." On government work

contract, the tax rate has been reduced to 12 per cent from 18 per cent. "That will save govern-ment a lot of tax."

A committee of ministers has been formed to look into technical issues facing the GST-Network, the IT backbone and por-tal for registration and tax returns under the

GST regime.

"GSTN has major problems. We had much discussions and all that has to be settled and a committee of ministers has been formed along with a committee of officers," he said.

The panels would look into the glitches, he said. "Small and medium enterprises are suf-fering today, this has to be corrected."

Jammu and Kashmir Finance Minister Haseeb Drabu said the deadline for filing of sales return or GSTR-1 for the month of July - the first month of implementa-tion of the new tax regime, has been extended by a month to October 10. Drabu said hike in cess on cars was not discussed.

Chief Minister Pawan Chamling was conferred the Grand Prix Award for his pioneering work in transforming Sikkim into an Organic State during the One World Award ceremony held at Legau in Germany on 08 Sept.

A press release informs that the award was jointly handed over by Federal Minister of Bavaria State. Dr Gerd Muller, and German Organic pioneer and Managing Director of Rapunzel Naturkost, Joseph Wilhelm. The other winner of the OWA Grand Prix Award was United

World Colleges.

The One World Award, ini-

honours people, projects, initiatives and innovative ideas that promote ecological, economic and social improve-ments and that encourage justice in the world. The OWA award is endowed with a total prize money of 45.000 Euro.

The awards are presented every three years by the or-ganic food producer Rapunzel and IFOAM, the global umbrella organization of organic movements.

Five finalists were shortlisted this year namely: Nass-er Abufarhal [Palestine], the pioneer of the Fairtrade and organic farming movement in Middle East; Amin Babayev

[Azerbajan], the soil scientist & founding father of his country's organic movement Pro-fessor; Shamiso Mungwashu [Zimbabwe], the (young) organic and Fairtrade pio-neer; United World Colleges (UWC) with its institutions in Freiburgi Germany and Pune India and; Chief Minister

A press release from the



Today, 10 September is World Suicide Prevention Day and this section returns to this frequently visited theme again. As per the World Health Organisation, as many as 8 lakh people commit suicide every year and around 25-times more attempt suicide. The numbers paint a scary picture and make this a challenge requiring the world's attention. Remember, apart from the 8.00.000 lives lost to avoidable reasons, there are 2 crore others who have tied a noose for themselves or attempted some other form of ending their lives! If their triggers are left unattended, they will be among the statistics of those who 'successfully' self-destructed in the coming years. They are also clearly grappling with serious issues and even if those around them do not notice (or choose to ignore) the suicidal tendencies, they cannot be left untouched by the deep trauma of such conditions. When one takes this aspect also into consideration, then the impact of suicides and suicidal tendencies multiplies many times over because each victim and person at risk is part of a family, belongs to a circle of friends, goes to school, college or office and touches many lives on a daily basis and no matter how consciously one tries to camouflage the condition, it does get out and affect others; and with every death to a suicide, everyone associated with the person is hit by a sense of guilt at not having intervened in time. Hence, as much for the lives that can be saved through some timely intervention as also to save those left behind from wracking guilt, the theme for WSPD this year needs to be taken to heart. World Suicide Prevention Day is being observed across the world today reflecting the sentiment - 'Take a minute, change a life.'

What is being underlined through this theme is our collective responsibility as a community to look out for those struggling with suicidal thoughts, notice their condition and engage with them in a non-judgmental way, hear them out, offer sound counsel if we can and help them access professional assistance. Suicide is a vexed problem facing Sikkim which is why more people here need to spare a minute to muster the resolve to get engaged. Studies across the world have borne out that most times, all that it takes to pull a person back from the brink is a gentle word of support, even a gesture conveying that they need not suffer in isolation.

This section has spoken often about how Sikkim is

seeking to address the challenge of suicides without having figured out why so many here ending their own lives. That is an important data analysis to undertake and should be done soon, but today, let's also focus on the need to remove the stigma still associated with suicides and suicide attempts, not just on the victims but also on their families. This stigma stops many from seeking help and also denies the community the opportunity to learn and prepare for the challenge. It is important that people who have lived through a suicide attempt to be able to share their experience more widely and teach others about the value of human engagement. Societies which have sought the assistance of survivors to inform the suicide prevention programmes have learned that words and actions of others are important mediums of saving lives. Those who have overcome suicidal tendencies have often spoken movingly about reaching the point where they could see no alternative but to take their own life, and about the days, hours and minutes leading up to this. They often describe realising that they did not want to die but instead wanted someone to intervene and stop them. Many say that they actively sought someone who would sense their despair and ask them whether they were okay. That is where the investment of a minute to notice these signals becomes important. The agencies engaged in addressing the problem of suicides can help by informing people at large about how they should respond and act when they notice someone around them struggling with such dark thoughts, because, let's also accept that most of us do not know how to face such situations. And because we do not know, we choose to ignore.

As the WHO message for the day share, "Life is precious and sometimes precarious. Taking a minute to reach out to someone – a complete stranger or close family member or friend – can change the course of

Why UN sanctions against North Korea's missile program failed

e past few months have seen the coming of age of North Korea's nuclear weapons capability.

For most of the last 20 years, the international nmunity has been struggling to stop this from

A sixth nuclear test on September 3 – of what was possibly a hydrogen bomb – followed July's two suc-cessful tests of an intercontinental ballistic missile with the capability to hit the U.S. The same month, the U.S. intelligence community assessed that North Korea's arsenal consists of "up to 60" weapons, and that the country had successfully manufactured a compact warhead capable of being mounted on a missile.

My research on how nation states illegally obtain missile technologies and my experience conducting outreach related to U.N. sanctions give me some in-sight into the methods North Korea used to make illicit procurements and the limitations in using technology-based sanctions to prevent them.

TECHNOLOGY-BASED SANCTIONS

In 2006 – following North Korea's first nuclear test – the U.N. Security Council prohibited the "supply, sale or transfer" of "items, materials, equipment, goods and technology" that could contribute to the country's missile program.

Efforts to prevent North Korea's acquisition of missile technology by certain nations – notably the United States – had been underway since the 1990s. However, the U.N. sanctions went further by placing standardized legal requirements on all states to pre-vent the development of North Korea's weapons of mass destruction programs.

These sanctions are "universal." That means they are obligatory for all states around the world. Each nation is responsible for implementation within its borders. Missile, nuclear and military technologies are regulated through national export control systems. Governments must grant an export license for the exports of certain goods and technologies. This allows governments to do a risk assessment on transactions and minimize the diversions to undesir-able uses, such as weapons of mass destruction programs or human rights abuses.

In theory, all countries should have the capaci-ty to implement these technology-based sanctions. Having an export control system has been mandatory for states since the passage of U.N. Security Council resolution 1540 in 2004. However, more than a decade after this resolution was passed, many na-tions – particularly developing ones – are still strug-

gling with implemention.

This has led to uneven execution of missile-related sanctions on North Korea. A recent report has de-

scribed the U.N. sanctions regime as a "house without foundations," noting that not a single element of the sanctions regime "enjoys robust international

SOURCES OF MISSILE TECHNOLOGY

As North Korea's missile program has advanced, its sources of missile technology have evolved.

North Korea began by importing full missile

systems and seeking to reverse-engineer or repli-Sate them. For example, after procuring short-range Scud missiles from Egypt in the late 1970s, North Korea "reverse-engineered" them by the mid-1980s. The 1990s saw North Korea develop the Nodong, a scaled-up Scud design. It also experimented with longer-range missiles in the late 1990s and mid-2000s. These Taepodong missiles drew together elements of the shorter-range systems such as their engines The Taepodong-2 allegedly had an intercontinental range, although it was never successfully tested.

Since taking power in 2011, Kim Jong Un has ac-

celerated North Korea's missile program. In the past year alone, the country has tested four seemingly new missiles for the first time – including a submarine-launched ballistic missile and an intermediate range ballistic missile, as well as the ICBMs tested in July. Kim has also made significant progress in developing the nuclear warheads the missiles are designed to carry. The sixth nuclear test undertaken in early September – by far the largest of those conducted by the the country – was the fourth carried out under his leadership.

The country has also sought to learn how to produce required parts and components at home. North Korea's program is opaque, but some episodes provide insights into where the country has been ob-

taining its technology.

Rocket debris salvaged from the sea following a satellite launch in December 2012 suggested an ongoing reliance on the international market place for parts. A 2013 U.N. report suggested the rocket had used modern components sourced from China, Switzerland, the U.K. and the U.S., as well as "cannibalized" Scud components and other 1980s vintage

more advanced manufacturing technologies. Footage from the leadership's frequent factory visits has shown that North Korea has acquired advanced machine tools of use in missile and nuclear programs. Photographs from a parade in April 2017 suggest that North Korea's new submarine-launched ballistic missile was constructed with wound filament. This material is lighter and stronger than aluminum, and a significant step forward in capability

Recent discussion over the possible Ukrainian or Russian origin of North Korea's rocket engines has

been heated, with the argument refuted by some experts. This reflects a broader debate regarding the genesis of the country's recent successes: Was it the result of imported technology or testimony to North Korea's ability to master advanced WMD technologies themselves?

EVADING SANCTIONS

To make these advances in their missile program, North Korea has had to evade sanctions and the broader scrutiny of the international community Their illicit procurement techniques include using front companies, obscuring the end user, falsifying documentation and mislabeling cargo. A 2017 U.N. report notes that North Korea's evasion techniques increasing in scale, scope and sophistication

North Korea's military and weapons of mass destruction procurement networks are global in nature. According to one study, they have touched m than 60 countries.

Due to geographical proximity, historic relationship and broader trading links, China has played an unparalleled role in these networks. Many middlemen and procurement agents have operated in China, and increasingly - as the country's private sector develops - its manufacturers have been a source of technology. A series of revelations in early 2017 demonstrated that Chinese manufacturers and Chinese-North Korean joint ventures are benefiting North Korea's missile program – including with machine tools, components and materials.

THE EFFECTS OF SANCTIONS?

Observers might rightfully ask: Have sanctions failed? This question is complicated. It might be more useful to consider what the effects of sanctions

The primary objectives of technology-based sanctions have been to slow and prevent North Korea's nuclear and missile development. The recent ICBM tests clearly prove these measures have not prevented North Korea's missile development. Whether they slowed progress is debatable. As U.S. Ambassador to the U.N. Nikki Haley recently observed, they are un-

likely to change North Korean behavior.
What is undeniable is that sanctions have had unforeseen consequences. Research suggests that sanctions could have made North Korea's procurement efforts more sophisticated as Chinese middlemen monetize the risk.

Americans tend to view North Korea as an inward-looking, economically isolated state cut off from the international community. However, the country's illicit networks – including those supplying its missile program - are global, adaptive and resilient. That makes them difficult to shut dow

Until recently, factual, objective reporting has been the mantra of modern journalism. But is objectivity a relevant concept in the era of fake news, filter bubbles and alternative facts? In dealing with a less-than-truthful presidential administra-

tion, mainstream media has become more adver-sarial. News articles and broadcasts sound like editorials, with journalists labeling President Trump a 'liar" and warning citizens about what they describe as dangerous tilt toward fascism. The masthead of the venerable Washington Post now says, "Democracy Dies in Darkness," a strongly worded statement reflected in its sharply critical coverage of the Trump presidency.
It may be time for a re-

calibration of the notion of

objectivity. In recent years, the concept been watered down by the practice of "balanced" reporting. Each side is given equal time, regardless of the relative merit of their arguments, creating false equivalencies and confusing the public.

Perhaps, journalists should apply their craft using a more scientific approach. Scientists, too, seek the truth. But they pursue evidence based solu-tions, regardless of TV ratings, circu-

lation numbers or social media "likes."

Journalism could adopt a similar approach as it struggles to regain its relevance. The best way forward is not necessarily a return to objectivity. Rather, it is through a rigorous approach to seeking and telling the truth – one that relies on real facts and the preponder-ance of evidence. Our profession and our democracy depend on it.

Smoke in Drukair plane, passengers evacuated at Kolkata airport

meeting on August 5 approved a hike in cess on mid, large size cars, SUVs, hybrid and luxury ones to up to 25 per cent, from earlier 15 per cent.

Following that an Ordiance to hike the cess rate has been promulgated and the GST Council will now look at the quantum of hike on such cars.

The council will also consider lowering tax rates on over two dozen products, including idli/dosa batter, dried tamarind, custard powder and kitchen gas lighter after anomalies in their fixations were pointed out.

The council will also for mulate a mechanism to deal with businesses that are deregistering their brands post GST to avoid taxes. The fitment committee

has proposed to the GST Council to consider May 15, 2017, as the cut off date for considering as a registered brand for the purpose of levy of GST, irrespective of wheth er or not the brand is subse quently deregistered.

Unbranded food items are exempted from GST, whereas branded and packaged food items attract 5 per cent rate.

Hence, many business-are deregistering their brands to avoid the levy.

Mishra was suspended as principal of the medical col-lege on August 12 after the deaths were reported. He resigned the same day taking moral responsibility.

There were allegations that

the deaths happened due to disruption in oxygen supply as the vendor had not been paid for several months.

While the Uttar Pradesh

government vehemently denied that shortage of oxygen led to the deaths, a high-power probe committee headed by Chief Secretary Rajive Kumar indicted Mishra and others of laxity and other charges.

The medical college attracted global attention when more than 60 children died at the hospital within a span of a week last month.

We try to play positive, we try to play good, but we try to win." United, renowned for their swashbuckling style under

former manager Alex Ferguson, have made a strong start to the Premier League season, games and scoring 10 goals in the process to top the table. But, talking at United's

CBI books 19 companies for sending over 400 crore abroad NEW DELHI, SEP 9 (PTI): The

CBI has registered a case against 19 companies which have sent over Rs 424 crore in foreign remittances through about 700 transactions, suspecting it to be a case of money laundering through shell companies.

It is alleged that during the year 2015 unidentified officials of Punjab National Bank (PNB), Mint Street branch, Chennai entered into a criminal conspiracy with 19 accused companies which were account holders in the branch.

...in furtherance of the conspiracy, the above said companies were sending for-eign exchange to Hong Kong without any genuine business transactions," the FIR, registered last evening, alleged.

It said the accounts thus opened were used for the purpose of sending advance foreign remittances.

"The modus operandi was that the customers got remittances from various other banks to their accounts by way of RTGS (real time gross settlement). The customer presented their request with a quotation issued by foreign suppliers for 100 per cent ad-vance remittances," it said. The customer made re-

quest for remittance to foreign supplier based on the quotation, it alleged. The remittance amount

was kept in such a way that it would not exceed the thresh-old limit of USD 1 lakh for

each remittance in order to circumvent the regulatory requirements and applicability of the RBI," it said.

The CBI said there were advance remittances made for imports through var-ious current accounts opened during the period from January 2015 to May 2015 totalling to Rs 424.58 crore.

"All the advance remit-tances were routed through NOSTRO (account held by PNB with a foreign bank in a foreign

currency) account maintained with HSBC, New York," it said.
The bank had found that

none of units were functioning at the available address.

The RTGS credits emanated mostly from some credit cooperative societies, at Mumbai and other places.

The RTGS transactions were made by the remitter through fictitious persons in whose names accounts could have opened in the co-operative societies in Mumbai

remittances sent in the name of foreign suppliers who had opened accounts in various banks in the UAE, Hong Kong and Taiwan The remittances were routed through HSBC. New York to these banks, the CBI alleged.

"It is clear that this is a case of money laundering through shell companies and there has been loss of foreign exchange to the tune of Rs 421.58 crore to the country," it alleged.

to Greece ISTANBUL, SEP 9 (AP): Turkish authorities say 40 Syrian migrants have been stopped from illegally crossing to Greece.

Turkey's coast guard says the migrants, among them 18 children, were stopped yesterday off the

western province of Izmir. In footage filmed from a coast guard boat, the group is seen in a rubber dinghy. As the coast guard vessel approaches, one man lifts and then brief ly lowers a small child toward the sea, while another man raises his arms in prayer. The coast guard then pulls in the dinghy and transfers the migrants to its boat.

Turkey and the European Union signed a deal last year to curb the illegal flow of migrants to Greece. Turkey is host to more than 3 million Syrians who have fled the ongoing civil war in their country.

Canada extradites two to India over honour killing

Montreal, Sep 9 (AFP): Canada's Supreme Court has ruled that two of its citizens can be extradited to India for their alleged role in an honour killing 17 years ago.

Surjit Singh Badesha, 72, and Malkit Kaur Sidhu, 67, are wanted in connection with the murder of Jaswinder Kaur Sidhu who was 25 at the time of her death.

The suspects, both Ca-nadian citizens of Indian origin, are the uncle and mother of the slain woman.

Jaswinder Kaur Sid-

hu's body was found with her throat slit in June 2000 in Punjab state.

Indian prosecutors say that she was the victim of an honour killing planned by her mother and uncle, who furiously opposed the young woman's marriage to a poor rickshaw driver, something the victim had kept

secret for a year.

After revealing her marriage to her family, the victim reportedly flew from Canada to India to reunite with her husband, Mithu Sidhu.

The couple was later attacked as they rode a scooter in a village near Sangrur, Punjab in June 2000. Her husband was severely beaten and left for dead while Sidhu was kidnapped and later killed.

Rohingya exodus to Bangladesh nears 3,00,000

Cox's Bazar (Banglaadesh), Sep 9 (AFP): Nearly 300,000 Rohingya Muslims have fled Myanmar's Rakhine state into Bangladesh in the 15 days since new violence erupted, the United Nations said today.

The figure has jumped about 20.000 in a day.

'Some 290,000 Rohingya arrived in Bangladesh since August 25," said Joseph Tripura, a spokesman for the UN refugee agency.
Officials said the UN has found

more Rohingya in villages and areas which were previously not included by relief agencies.

Most of the Rohingya are arriving by foot or boat across Bangladesh's 278 kilometre (172 mile) border with Myanmar, a fourth of which is made up by the Naf river.

The UN said there was a sharp increase in arrivals on Wednesday, when more than 300 boats arrived in Bangladesh.

On Thursday the UN had put the number at 164,000.

The Rohingya have long been

dhist majority Myanmar, which denies them citizenship.

Myanmar's government regards them as illegal migrants from Bangladesh, even if they have lived in the country for generations.

Refugee camps near Bangladesh's border with Myanmar already had about 300,000 Rohingya before the upsurge in violence and are now overwhelmed.

The tens of thousands of new arrivals have nowhere to shelter from

The latest figure takes the number of Rohingya refugees who have arrived in Bangladesh since violence erupted last October to 377,000.

Those flocking into Bangladesh have given harrowing accounts of killings, rape and arson by Myanmar's army. The Myanmar authorities deny any wrongdoing.

Most have walked for days and the United Nations says many are sick, exhausted and in desperate need of shelter, food and water.



Mass exodus as Hurricane Irma eyes Florida, batters Cuba

MIAMI, SEP 9 (AFP): After laying waste to several Caribbean islands, Hurricane Irma was barreling today towards Florida, where some 5.6 million people faced orders to evacuate as the monster storm made landfall in Cuba.

Irma - which has killed at least 19 people and devastated thousands of homes in the Caribbean - made landfall late yes-terday on the Camaguey Archipelago of Cuba as a maximumstrength Category 5 storm.

The hurricane weakened slightly to a Category 4 hours later, swirling some 245 miles (395 kilometers) away from Miami and packing still powmaximum sustained winds of 155 miles per hour, according to the US National Hurricane Center.

In Cuba officials reported "significant damage" in parts of the island's center without providing further details, but said there were not yet casualties.



More than a million people on the Caribbean's largest land have evacuated as a precaution, authorities said.

Irma is expected to strike the Florida Keys late today and tomorrow before moving inland, and many residents have joined a mass exodus amid increasingly dire alerts to leave.

"Irma remains an extremely dangerous hurricane!" tweeted the National Weather

Service early today.

"It's not too late to get off the Keys!!!" the agency said, "You still have time, this morning, to get out! Please, the Keys are not safe."

According to Florida's Di-

vision of Emergency Manage ment some 5.6 million residents have been ordered to evacuate - nearly a quarter of

the state population. Warning that Irma would be worse than Hurricane Anwhich killed 65 people in 1992 - Florida's governor said all 20.6 million Floridians should prepare to flee.
"If you're in an evacuation

zone, you should be very cau-tious, you should get out now," Governor Rick Scott told CNN. "This is a powerful storm bigger than our state."

Bumper-to-bumper was snaking north out of the pen-insula, with mattresses, gas cans and kayaks strapped to car roofs.

North of the Keys, in Mi-

ami Beach, 82-year-old Cuban- American Orlando Reves had suddenly to flee his assisted living facility.

"It is frightening," he told AFP at a shelter in Miami.

"We had to leave without a cent, without taking a bath, or bringing anything."

The storm ravaged a series of tiny islands before slam-ming into the Virgin Islands and Puerto Rico.

French state-owned reinsurer CCR estimated Irma had caused 1.2 billion euros (USD 1.4 billion) worth of damage

to homes, vehicles and businesses in the territories of Saint Martin and Saint Barts.
"Houses are smashed, the

airport is out of action," Saint Barts resident Olivier Toussaint told AFP.

"Upside-down cars are in the cemeteries. Boats are sunk in the marina, shops are destroyed." Meteorologists meanwhile were closely monitoring two other Atlantic storms.

Jose, another powerful Category 4 storm, was heading towards the same string of Caribbean islands Irma has pummeled in recent days.


