 ${f F}$  ormer Chief Minister, Sikkim Democratic Front president Pawan Chamling has rubbished allegations against his party was behind the court case against the One Family One Job scheme and has called it laughable.

In his weekly Facebook Q&A released by the party today, Mr Chamling contends that the SDF will never risk the future of "our poor people for political

He also added that such cases would have been rectified in the next five years, had SDF come to

Taking a jibe at the ruling party, Mr Chamling said, "If we had any electoral gain in mind, we would have included this scheme in our Election Manifesto and said – "If you vote for us, we will give this job within 10 days or 100 days".

The SDF president went on to state that people are more interested in knowing why the SKM government failed to deliver its promise of regularising the OFOI employees within 100 days of coming to power.

#### Mamata cites central data to counter **Amit Shah on development**

KOLKATA, DEC [NDTV]: Bengal Chief Minister Mamata Banerjee today accused Union Home Minister Amit Shah of "spewing lies" during his visit to Bengal, citing his claims that the state has been going downhill in terms of industry and development. The Union minister, she said, has contradicted the data of his own government, which puts Bengal in the number one position in MSME (Medium and Small Enterprises) and the construction of rural roads. "Amit Shah has told a bunch lies yesterday. He claimed our state is 'zero' in industry but we are number one in the MSME sector. He claimed we couldn't build rural roads. But we are number one in that. This is the Government of India's information," the Chief

Minister said.

The BJP, she said, is "cheatingbaaz" party, which can do anything for politics. "You are the home minister. It doesn't suit you to tell lies," the Chief Minister said.

Yesterday, Banerjee's close aide and party spokesperson Derek O'Brien had taken on Amit Shah over lies told during his weekend visit to the state.

He had tweeted a claim versus fact list, which that started with Mr Shah's claim that Ms Banerjee had joined a new party after being expelled the Congress. Ms Banerjee had founded a new party after walking out of the Congress, Mr O'Brien had pointed out.

What stung Minister Chief most was the Union Home Minister's claim that her government had left the state's economy in shreds.

Mr Shah, who was on a two-day visit to the state over the weekend, had cited data from '50s and '60s to attack the Trinamool Congress, which came to power in the state in 2011 after 35 years of Left rule. "After independence,

Bengal would contribute one-third to the GDP. It has fallen ever since. Bengal's contribution to the Industrial Production right after independence was 30 per cent. Now at 3.5 per cent," Mr Shah said. "In 1960, Bengal was one of the richest states in the country. In 1950s, Bengal produced 70 per cent pharma products. Now it is around 7 per cent. Bengal jute industries that gave employment to many, are shut," he said, adding, "Our sankalp is to make Bengal Shonar Bangla once again," he

#### India halts UK flights till Dec 31 over new strain of Coronavirus

New Delhi. 21 Dec [NDTV]: The government today banned flights from the UK till December 31 over a new fast-spreading strain of the coronavirus in that country. The ban will start from Wednesday and all passengers arriving from the UK before then will be tested on arrival at airports.

"Considering prevailing situation in UK, the government of India has decided that all flights originating from UK to India to be suspended till 31st December," said the aviation ministry after a joint monitoring group on COVID-19 met this morning to discuss the mutant coronavirus that has spread rapidly in the UK, sending cases rocketing within days.

Union Secretary Rajesh Bhushan said the new variant had an unusually large number genetic changes and the development "calls for enhanced epidemiological surveillance, enhanced containment" and other measures to effectively tackle the challenge.

"India has been seeing a sustained decline in the number of fresh Covid-19 cases for over two months now, accompanied by a decline in the number of deaths. In this scenario, interjection anv SARS-CoV-2 of a variant virus through passengers with air travel history could pose critical risks for pandemic management in India," he said.

**Passengers** flights from Britain arriving before midnight tomorrow will be subjected to RT-PCR tests at the airport. Those who test positive will be sent to institutional quarantine while the rest will be asked to home-isolate for seven days.

Canada, Saudi Arabia, and several European countries have suspended flights from the UK over the new strain, believed to be 70 per cent more infectious. British Health Secretary Matt Hancock says "the new variant is out of control".

Much is unknown about the strain, but experts say current

vaccines should still be was first detected in at a time when several effective against it.

Health Minister Harsh Vardhan said the government was fully alert about the new strain and stressed "there's no need to panic".

### Arunachal panchayat, civic polls to be held on Tuesday

ITANAGAR, DEC 21 (PTI): All arrangements have been made for simultaneously holding panchayat and municipal elections in Arunachal Pradesh on Tuesday, election officials said.

Ballot papers for panchayat constituencies have been collected by respective district officials, while EVMs have been commissioned for elections to Itanagar Municipal Corporation Pasighat Municipality, they said.

A total of 4.89 lakh voters are eligible to 1,472 stations, State Election Commissioner Hage Kojeen said on Monday.

The elections have been delayed by over two years due to various reasons, he said.

Elaborate security arrangements have been made to ensure smooth and peaceful polling.

More than 8,000 security personnel, including nine companies of Central Reserve Police Force (CRPF), besides 7,517 state police personnel have been deployed for the elections, a senior police officer said.

As many as polling stations have been identified as hypersensitive, and 536 as sensitive. Inspector General of Police (Law and Order) Chukhu Apa said. The state has 25 Zilla Parishads with 241 constituencies and 2,215 gram panchayats with 8,436 constituencies.

The IMC has 20 wards while the Pasighat Municipality has eight.

The ruling BJP has already won 96 of the 241 Zilla Parishad exercise their franchise Member constituencies unopposed, while election to the Vijoynagar seat in Changlang district will not be held due to the prevailing law and order situation there.

Vijoynagar recently witnessed violent protests over the voting rights of former Assam Rifles personnel.

The saffron party has also won 5,410 of the total 8,436 gram panchayat constituencies and five seats in the IMC.

Elections will not be held in the entire Dibang Valley district as all the segments in both

Zilla Parishad and gram panchayat have been won by the ruling party unopposed, Kojeen said.

East Siang is the only district where elections will be held in all the polling stations, he said.

As many as 110 gram

panchayat segments in the state have fallen vacant due to various reasons. The SEC will take a final call on conducting by-elections in those segments after the current electoral process is over, the official said The state administration has declared a holiday Tuesday. government and semigovernment banks and commercial establishments, besides educational institutions and markets will remain closed.

Governor Brig (Retd) Dr B D Mishra appealed to the voters to exercise their franchise on Tuesday.

"Every single vote has democratic significance and all voters must avail of it. Beyond the constitutional right, it is our moral, social and national responsibility as well to cast our vote,"

New Delhi, 21 Dec [NDTV]: Facebook today clarified that an error on its part caused the blocking of the accounts by farmers protesting against the government's agricultural laws on Sunday. The social networking site said its automated systems flagged the pages of Kisan Ekta Morcha as "spam" following increased activity, although the group's Instagram account (owned by Facebook) remained unaffected.

"As per our review, our automated systems found an increased activity on the Facebook www.facebook. com/kisanektamorcha and flagged it as spam, which violates our Community Standards. We restored the page in less than three hours we became aware of the context. review showed that only the Facebook page was affected by the automated systems while the Instagram remained account unaffected," Facebook said in a statement.

The company added that while it relies on automated systems to detect spams, it also uses human expertise to understand the context behind increased activity on a page. "The vast majority of our work fighting spam is done automatically recognizable patterns of problematic behaviour. For example, if an account is posting over and over in quick succession that's a strong sign something is wrong. However, we also rely on our human review team to work on cases where human expertise is needed to understand the context of a particular situation. In Q3, 2020 out of the 1.9 billion pieces of content removed globally for violating our policies on spam, we restored 74.9 million pieces of content globally, we identified when issues ourselves," said Facebook company spokesperson

Facebook had taken down community pages of Kisan Ekta Morcha for around three hours Sunday, sparking widespread criticism what farmers said was an attempt to muzzle their voices.



#### Some clichés never go out of style

In the current times of overbearing rightwing monoculturalism, the fact that Sikkim, despite attempts at regimenting people by their community, remains largely unmoved by arguments which seek to other, remains a constant source of relief. Some continue to see individuality at the community level as somehow diluting a larger identity, but they are clearly hamstrung by regressive narrow-mindedness which continues to see empowerment and confidence as somehow detrimental to cultures and identities. Thankfully, such mindsets remain in minority in Sikkim. In an India where boorish religious heads want to hound certain idols out of temples, certain sexes away from worship, and impose caste obsessions on the entire population, the fact that Sikkim is yet to allow communal gimmickry political currency holds up a light that should never be allowed to dim. Clichéd as it may sound, Sikkim should never stop celebrating its diversity, its people should never hesitate from supporting expressions of cultural uniqueness by other groups, and even as such cultural expressions are made by individual groups and communities, the celebrations should be joined by all. Make it a habit and an instinctive response, and troublemakers keen to sow differences by fanning fear of the others will find themselves out of jobs. And make no mistake, agent provocateurs, if given the chance, will tease out hesitations and feed on suspicions thereby weakening the collective society. We have seen how that can wreck havic on vast swathes of even a nation as big as ours, so its damage potential for a society as small as Sikkim's should have the residents doubly wary.

Agreed, "unity in diversity" is an overused cliché, a phrase which has accompanied us for far too long as a topic for essay-writing contests and argument for debates; and since everyone has heard it so often that it fails to elicit either pride or passion anymore, perhaps it is time to turn the approach on its head and reinforce unity. "Diversity in unity", as some thinkers have proposed for the country in the past, carries a nice spin to it, forces one to ponder longer and also acknowledges the fact that confident diversities mean self-assured identities which will be the best safeguard for unity. Unencumbered diversity inspires confidence which goes on to powers empathy; forced identities and ideas on the other hand fan fear which breeds intolerance which is a debilitating, self-defeating

To its credit, despite rather loud criticism by quite a few, Sikkim has rather consistently supported the aspiration of individual communities to express their individualities. And such an approach is also in perfect sync with the requirement for decentralization, empowerment and going back to the roots as one can see in the revival of organic farming, without being regressive or posturing. Endorsing diversity, once it becomes a habit, is no longer limited to cultures, and would also mean supporting free expression, accepting differing views, living with divergent traits and allowing free thought - if that is not the empathy and tolerance that a people need to thrive as a community, unencumbered by factionalism or hate, then what is?

Diversity, once ingrained, provides diverse people with the ability to be okay with and open to things that set them and others apart - religion, culture, race, gender, sexual orientation, physical and mental ability, language (the list goes on) and understanding and accepting of people for who they are. Being culturally aware provides an opportunity to stand back and consider that there are certain backgrounds, personal values, beliefs and upbringings that shape the things we all do. Something that is considered inappropriate behavior in one culture may be perfectly acceptable in another. Learning about other cultures helps people relate to one another and be okay with different perspectives. Everyone and every community can benefit from such attributes. Now more than ever.

# **Coronavirus New Variant - Genomics** Researcher Answers Key Questions

A new variant of SARS-CoV-2, the virus which causes COVID-19, is thought to be driving increased transmission of the disease in parts of the UK. The government has placed some regions including London under new, stricter coronavirus restrictions, known as Tier 4. People in Tier 4 areas will not be able to gather with anyone outside their household for Christmas, while those in the rest of the country can only gather on Christmas Day itself.

Boris Johnson, the prime minister, and his chief scientific advisors said that the new variant could increase transmission of COVID-19 by as much as 70% and increase the R or reproduction number by 0.4.

What's the significance of this new discovery? The Conversation asked Lucy van Dorp, a microbial genomics researcher and an expert in the evolution of pathogens, some key questions about what we know at this point in time.

WHAT DO WE KNOW ABOUT THIS NEW VARIANT?

The new UK variant, known as VUI-202012/01 or lineage B.1.1.7, was first announced by Matt Hancock, the health secretary on December 14. It was subsequently confirmed by Public Health England and the UK's COVID-19 sequencing consortium. Screening back through databases of SARS-CoV-2 the first sample was taken in the county of Kent on September 20.

The variant carries 14 defining mutations including seven in the spike protein, the protein that mediates entry of the virus into human cells. This is a relatively large number of changes compared to the many variants we have in circulation globally.

To date, genetic profiles - or genomes – of this variant have been largely sequenced and shared from the UK but include some in Denmark and two cases in Australia. There have also been reports of a case in the Netherlands. These countries all have very large genome sequencing efforts and it is very possible that these observations do not reflect the true distribution of this variant of the virus, which could exist undetected elsewhere. We will know more as

more genomes are generated and

Thanks to the efforts of data sharing, genomic surveillance and COVID-19 test results in the UK, it seems that this variant is now starting to dominate over existing versions of the virus and that it may be responsible for an increasing proportion of cases in parts of the country, particular in regions where we also have rapidly expanding case

It is always very difficult to disentangle cause and effect in these cases. For example increases in the appearance of certain mutations can be due to viral lineages carrying them rising in frequency just because they happen to be the ones present in an area where transmission is high, for example due to human activities or choice of interventions.

Though this is still a possibility, there are clearly enough concerning observations so far for this variant to warrant very careful characterisation, surveillance and interventions to curb transmission.

IS IT MORE DANGEROUS?

Chris Whitty, the chief medical officer, stated clearly that there was no evidence to date that this variant alters disease severity, either in terms of mortality or the seriousness of the cases of COVID-19 for those infected. Work is underway to confirm this.

HOW DO VIRUS MUTATIONS HAPPEN?

Mutations are a natural part of virus evolution. In the case of SARS-CoV-2, these mutations may arise due to random errors during virus replication, be induced by antiviral proteins within infected people, or via genetic shuffling - known as recombination. Though signs of recombination are not currently detected in SARS-CoV-2.

Most viral mutations are expected to have no impact. For example, when our team assessed individual mutation replacements in more than 50,000 genomes from the first wave of the pandemic, we detected none that significantly altered viral fitness - the ability of the virus to survive and

mutation, or in this case a particular combination of mutations, may strike lucky and offer the virus a new advantage. Viruses carrying these combinations of mutations may then increase in frequency by natural selection given the right epidemiological environment.

WHERE DID THE VARIANT COME

Right now, we don't know. To date, scientists have not identified any closely related viruses to support the theory that the variant had been introduced from abroad. The patterns of mutations observed are more supportive of an extended period of adaptive evolution most likely in the UK based on current data.

Similar patterns of mutation to these have been observed in the evolution of SARS-CoV-2 in chronically infected patients with weaker immune systems. The current hypothesis is that such a scenario of chronic infection, in a single patient, may have played a role in the origin of this variant. This will continue to be investigated.

HOW MANY VARIATIONS OF SARS-COV-2 HAVE WE FOUND?

There are many thousands of lineages of SARS-CoV-2 which differ on average by only a small number of defining mutations. It remains true that SARS-CoV-2 currently in global circulation have little genomic diversity. Subtleties in the mutations carried in different lineages can, however, be very useful for reconstructing patterns of transmission.

As an example, work early in the pandemic used lineage assignments to identify at least a thousand introductions of SARS-CoV-2 into the

WHY IS THIS ONE DIFFERENT?

It is important to note that many of the mutations defining the UK variant have been observed in SARS-CoV-2 before and even sometimes quite early in the pandemic.

Yet the UK variant, or lineage, is defined by an unusual number and combination of mutations. One of these mutations, N501Y, has previously been shown to increase binding of the virus to receptors in our cells. N501Y was first sequenced in a virus in Brazil in April 2020 and

However, every so often a is currently associated with a SARS-CoV-2 variant also rising in frequency in South Africa - an independent lineage from B.1.1.7 that is also

warranting concern. The particular deletions identified in the spike protein of B.1.1.7 have appeared in multiple other lineages of the virus at increasing frequency and are also observed in chronic infections where they may alter antigenicity - recognition by immune antibodies. These deletions may also be associated with other mutations in the binding region of the coronavirus spike protein, including those observed in infections among farmed mink and a mutation shown to play a role in the virus's ability to evade the immune system in humans. B.1.1.7 also harbours a truncated ORF8 gene, with deletions in this region previously associated with decreased disease severity.

The functional effect of these mutations and deletions, particularly when in the combination reported in B.1.1.7, are still to be determined. The high number of mutations and the recent increase in prevalence of this particular variant, together with the biological relevance of some of the mutation candidates, emphasises the need for in-depth study.

WHAT DOES THIS MEAN FOR THE VACCINE?

At the moment we don't know. Though we should be reassured that vaccines stimulate a broad antibody response to the entire spike protein, so it is anticipated that their efficacy will not be significantly hampered by mutations. This is already being

However, there is an increasing body of evidence that other species of seasonal coronaviruses exhibit some ability to escape immunity over longer time periods.

It is therefore conceivable that we may reach a point where we are required to update our COVID-19 vaccines, as we do for influenza, to reflect the variants in circulation at the time. It's too early to say if this will be the case now, but extensive genome sequencing, data sharing, and standardised reporting of variants will be vital to inform these

# How to reduce the spread of fake news - by doing nothing

 $\mathbf{W}^{\mathrm{hen}}$  we come across false information on social media, it is only natural to feel the need to call it out or argue with it. But my research suggests this might do more harm than good. It might seem counterintuitive, but the best way to react to fake news - and reduce its impact - may be to do nothing at all.

False information on social media is a big problem. A UK parliament committee said online misinformation was a threat to "the very fabric of our democracy". It can exploit and exacerbate divisions in society. There are many examples of it leading to social unrest and inciting violence, for example in Myanmar and the United States.

It has often been used to try to influence political processes. One recent report found evidence of organised social media manipulation campaigns in 48 different countries. The UK is one of those countries, as demonstrated by news reports about a local branch of the Conservatives which urged activists to campaign by "weaponising fake news".

Social media users also regularly encounter harmful misinformation about vaccines and virus outbreaks. This is particularly important with the roll-out of COVID-19 vaccines because the spread of false information online may discourage people from getting vaccinated - making it a life or death

With all these very serious consequences in mind, it can be very tempting to comment on false information when it's posted online - pointing out that it is untrue, or that we disagree with it. Why would that be a bad thing?

INCREASING VISIBILITY

The simple fact is that engaging with false information increases the likelihood that other people will see it. If people comment on it, or quote tweet - even to disagree - it means that the material will be shared to our own networks of social media friends and followers.

Any kind of interaction at all - whether clicking

on the link or reacting with an angry face emoji that if you have seen things before, you are more - will make it more likely that the social media platform will show the material to other people. In this way, false information can spread far and fast. So even by arguing with a message, you are spreading it further. This matters, because if more people see it, or see it more often, it will have an even greater effect.

I recently completed a series of experiments with a total of 2,634 participants looking at why people share false material online. In these, people were shown examples of false information under different conditions and asked if they would be likely to share it. They were also asked about whether they had shared false information online in the past.

Some of the findings weren't particularly surprising. For example, people were more likely to share things they thought were true or were consistent with their beliefs.

But two things stood out. The first was that some people had deliberately shared political information online that they knew at the time was untrue. There may be different reasons for doing this (trying to debunk it, for instance). The second thing that stood out was that people rated themselves as more likely to share material if they thought they had seen it before. The implication is

likely to share when you see them again. DANGEROUS REPETITION

It has been well established by numerous studies that the more often people see pieces of information, the more likely they are to think they are true. A common maxim of propaganda is that if you repeat a lie often enough, it becomes the truth.

This extends to false information online. A 2018 study found that when people repeatedly saw false headlines on social media, they rated them as being more accurate. This was even the case when the headlines were flagged as being disputed by fact checkers. Other research has shown that repeatedly encountering false information makes people think it is less unethical to spread it (even if

they know it is not true, and don't believe it). So to reduce the effects of false information, people should try to reduce its visibility. Everyone should try to avoid spreading false messages. That means that social media companies should consider removing false information completely, rather than just attaching a warning label. And it means that the best thing individual social media users can do is not to engage with false information at all.

#### Sydney Test in doubt as Covid-19 outbreak wreaks havoc on Australian sport

Емма Кемр ADELAIDE, 21 [THEGUARDIAN]: The Sydney Test could yet become a victim of Sydney's Covid-19 outbreak as new border closures and restrictions wreak havoc with the Australian sporting calendar.

Australia's match against India, due to start at the Sydney Cricket Ground on 7 January, has been in doubt since last week when a coronavirus cluster emerged on the city's northern beaches.

But news that almost every state and territory has declared the greater Sydney region a hotspot has put the showpiece event at greater risk of being cancelled.

Sydney to Hobart yacht was cancelled race for the first time in 76 years and there have postponements and logistical upheaval to the Big Bash League, A-League and W-League.

Cricket officials have been planning for all scenarios, as they did in November when a Covid cluster in South Australia threw into doubt the feasibility of Adelaide Oval hosting the first Test. In the end it went ahead.

Several alternatives have been thrown up, including swapping the Sydney and Brisbane Tests - the latter begins at the Gabba on 15 January – to get around

the issue of travelling **DEC** from Sydney to Brisbane.

Another option is to stage the second and third Tests in Melbourne and skip Sydney altogether - before playing the fourth at the Gabba. The SCG clash could also be moved to Manuka Oval in Canberra.

But Cricket Australia's interim chief executive Nick Hockley said it had time on its side and it had "made no changes to our schedule, and our preference remains to play the match at the Sydney Cricket Ground".

"CA has prepared for the possibility of Covid-19 hotspots and state border closures over the course of the summer and the protocols that we have On Saturday the put in place have been in ensuring the safety and success the men's and women's domestic and international programs to date," Hockly said.

# Lewis Hamilton did something far greater

**GILES RICHARDS** 21 DEC LONDON, [THEGUARDIAN]: debate will rage on over whether Lewis Hamilton is the greatest Formula One driver of all time but, as with all arguments spanning sporting eras, it will never be resolved. What is incontrovertible is that he is F1's most successful driver and it was recognised in his winning the Sports Personality Year award. Hamilton deserved it but had he not won it would not matter a jot. His actions off the track this year stand alongside his remarkable achievements; had far greater import than what is ultimately a trinket to crown a popularity contest and they engendered a legacy that will span generations.

The 35-year-old took his seventh F1 title this year, matching Michael Schumacher's record. Having also surpassed Schumacher's records of pole positions and grand prix wins, Hamilton stands alone at the very top of his sport.

He did it with another outstanding display Mercedes. From 17 races (in which he competed in 16, missing one having contracted Covid-19) he took pole 10 times and won 11. That he was in another class was epitomised at the Turkish Grand Prix, where he sealed the title. Everything was ranged against him. Mercedes struggled at the track which was low on grip and where they could not bring their tyres up to their operating temperature and he

qualified in sixth.

What followed was the perfect rebuttal to the bluster of the claim that anyone would be successful in his car. Hamilton displayed a mastery of the wet and drying conditions that was almost otherworldly and nearly all of the other 19 best drivers in the world were unable to match it. Hamilton circled flawlessly on the treacherous surface while his rivals slid and spun as if on a different track. He called the race to perfection, with a touch and feel to make his worn tyres last and take a magnificent win. Difficult conditions allow the greats to shine and this was as memorable a display as Ayrton Senna's

at Donington in 1993. He won by 30 seconds from Sergio Pérez and tellingly his teammate Valtteri Bottas - in an identical car to Hamilton - span six times, had a collision and finished 14th, lapped by world champion.

Hamilton's season, indeed his career, have been rich with such outstanding moments, yet it was his strength of character that really stood out this year when for once the "personality" part of the Spoty award is

appropriate. The world champion began speaking his mind at the opening round in Australia in March. Under the shadow of the emerging coronavirus pandemic driver after driver repeated platitudes which they had been fed: that the FIA and F1 knew best and they were confident the decisions being made were the right ones. They

Hamilton in contrast was blunt. He believed that holding an event of more than 100,000 people was irresponsible and that it should be cancelled. He was even more explicit in stating why it was going ahead. "Cash is king," he said.

As Covid struck and the race fell apart, a pause to highlight

then the season, and the terrible effects of the virus became clear. one could only further Hamilton's admire courage in saying what F1 and the FIA had shied away from.

More, of even greater significance followed. After the killing of George Floyd, Hamilton, incensed by the racial injustice, was once more the only driver to speak out in his anger and desire for change. The silence across F1 was deafening and he called it out. "I see those of you who are staying silent, some of you the biggest of stars, yet you stay silent in the midst of injustice," he said.

Spurred on, many of his fellow drivers were emboldened to join his condemnation of racial injustice and the trickle became a wave as Hamilton, who had direct experience of racism since he was a child, pushed harder for change. A move for

the anti-racist cause. hurriedly arranged for the first GP, was adopted to take place before every race. F1 had to react and created the We

Race As One initiative

with a commitment to

encourage a greater

range of ethnic minorities

into the sport. Hamilton's team were also invigorated. The drivers' overalls were to be black and their cars – historically the silver arrows - would be painted for the first time in black livery and they initiated their own diversity programme. Yet Hamilton would not let the cause which was of greater import to him than the world championship slide from view. He began wearing Black Lives Matter T-shirts and repeatedly brought up anti-racism and equality issues.

Nor was this just rhetoric. He created and funded the Hamilton Foundation, a long-term project with the Royal Academy of

Engineering, to engage young black people in STEM subjects and encourage them to enter motor racing and engineering.

the Tuscan At Grand Prix Hamilton wore a T-shirt drawing attention to the shooting of Breonna Taylor. As the backlash began, especially the tedious, bleating reactionary from the 'politics don't belong in sport' brigade, he was unbowed. "Want you to know I won't stop using this platform to shed light on what I believe is right," he said.

fearlessness, determination make a difference, that illustrates why Hamilton, for all his glorious skill, deserves acknowledgement this year more than ever. He has 6.1m followers on Twitter and 21.3m on Instagram, he is F1's most recognised global star and his words travel the world like no other in the sport. How many people had heard of Breonna Taylor before his actions? How many cared about racial injustice? How many young people have had their horizons broadened and their perceptions and prejudices challenged because Hamilton put his position to good use rather than be subsumed in a morass of anonymity?

In 2020 Hamilton stood up to be counted. He did not do it for recognition but because it mattered. Reason enough to celebrate this truly great British

# Concern among Muslims over halal status of COVID-19 vaccine

In October, Indonesian diplomats Muslim clerics stepped off a plane in China. While the diplomats were there to finalize deals to ensure millions of doses reached Indonesian citizens, the clerics had a much different concern: Whether the COVID-19 vaccine was permissible for use under Islamic

As companies race to develop a COVID-19 vaccine and countries scramble secure questions about the use of pork products — banned by some religious groups has raised concerns about the possibility of disrupted immunization campaigns.

Pork-derived gelatin has been widely used as a stabilizer to ensure vaccines remain safe and effective during storage and transport. Some companies have worked for years to develop pork-free vaccines: Swiss pharmaceutical company Novartis has produced a pork-free meningitis vaccine, while Saudiand Malaysia-based ΑI Pharma is currently working on one of their

But demand, existing supply chains, cost and the shorter shelf life of vaccines not containing porcine gelatin means ingredient is likely to continue to be used in a majority of vaccines for years, said Dr. Salman Wagar. general secretary of the British Islamic Medical Association.

Spokespeople Pfizer, Moderna and AstraZeneca have said are not part of their and

other companies means that some countries with large Muslim populations, such as Indonesia, will receive vaccines that have not yet been certified to be gelatin-free.

This presents dilemma for religious communities, including Orthodox Jews Muslims, where consumption of pork products is deemed religiously unclean, and how the ban is applied to medicine, he said.

"There's a difference amongst opinion Islamic scholars to whether something like take pork gelatin and make undergo a it chemical transformation, Waqar said. "Is that still considered to be religiously impure for you to take?'

The majority consensus from past debates over pork gelatin use in vaccines is that it is permissible under Islamic law, as "greater harm" would occur if the vaccines weren't used, said Dr. Harunor Rashid, an associate professor at the University of Sydney.

There's a similar assessment by a broad consensus of religious leaders in the Orthodox Jewish community as well.

"According the Jewish law, the prohibition on eating pork or using pork is only forbidden when it's a natural way of eating it," said Rabbi David Stav, chairman of Tzohar, a rabbinical organization

If "it's injected into the body, not (eaten) through the mouth," then that pork products there is "no prohibition vaccines. especially when But limited supply and are concerned about preexisting deals worth sicknesses," he said.



Yet there have been dissenting opinions on the issue — some with serious health consequences for Indonesia, which has world's largest population, 225 million.In 2018, the Indonesian Ulema Council. the Muslim clerical body that issues certifications that a product is halal, or permissible under Islamic law, decreed the measles and rubella vaccines "haram," or unlawful, because of the gelatin. Religious community leaders began to urge parents to not allow their children to be vaccinated.

"Measles subsequently spiked, giving Indonesia the third-highest rate of measles in the world." said Rachel Howard, director of the health care market research group Research Partnership.

A decree was later issued by the Muslim clerical body saying it was permissible to receive the vaccine, but cultural taboos still led to continued low vaccination rates. Howard said.

"Our studies have found that some

feel uncomfortable with accepting vaccinations containing these ingredients," even when the Muslim authority issues guidelines saying they are permitted, she said.

Governments have

taken steps to address the issue. In Malaysia, where the halal status of vaccines has been identified as biggest issue among Muslim parents, stricter laws have been enacted so that parents must vaccinate their children or face fines and jail time. In Pakistan, where there has been waning vaccine confidence for religious and political reasons, parents have been jailed for refusing to vaccinate their children against polio.

But with rising vaccine hesitancy misinformation spreading around the globe, including in religious communities, Rashid said community engagement is "absolutely necessary."

#### UK holds crisis talks as France closes border on virus fears

Prime Minister Boris Johnson is to chair meeting of the government's emergency committee later Monday after France closed its borders to arrivals from the U.K. to stem the spread of a new strain of the coronavirus circulating in London and the southeast of England.

The meeting of the COBRA civil contingencies committee comes amid warnings of "significant disruption" around the ports in the English Channel, with tailbacks going back miles into Kent, the county in southeastern England.

#### German court convicts man of murder over synagogue attack

BERLIN (AP): A German court on Monday convicted a right-wing extremist of murder and attempted murder and sentenced him to life in prison for his attack on a synagogue last year on Yom Kippur, Judaism's holiest day. He killed two people after he failed to gain entry to the building.

The Oct. 9, 2019, attack is considered one of the worst anti-Semitic assaults in Germany's post-war history.

28-year-old The defendant, Stephan Balliet, posted a screed against Jews before trying to shoot his way into the synagogue in the eastern city of Halle while broadcasting the attack live on a popular

at the Naumburg state court, which met in the state capital of Magdeburg for security and capacity reasons, on Monday found him "seriously culpable," news agency dpa reported. That

means he will be effectively barred from early release after 15 years, which is typical for people in Germany given life sentences.




