Sikkim breaks century mark of daily cases after four months

SUMMIT REPORT GANGTOK, 18 APR:

The second wave of L Covid-19 has crashed into Sikkim in earnest with 105 fresh cases being reported in the State on Sunday. This is the fifth time that daily cases have broken the 100-mark and four months since the last time it had crossed triple-figures, something which has not happened since 19 December, 2020. There are now 399 active cases of Novel Coronavirus in the State.

Of these 105 new cases, only eight had symptoms severe enough to require hospitalisation.



The obscure maths theorem that governs the reliability of Covid testing

LONDON, 18 APR [THEGUARDIAN]: Maths quiz. If you take a Covid test that only gives a false positive one time in every 1,000, what's the chance that you've actually got Covid? Surely it's 99.9%, right?

No! The correct answer is: you have no idea. You don't have enough information to make the judgment.

This is important to know when thinking about "lateral flow tests" (LFTs), the rapid Covid tests that the government has made available to everyone in England, free, up to twice a week. The idea is that in time they could be used to give people permission to go into crowded social spaces – pubs, theatres – and be more confident that they do not have, and so will not spread, the disease. They've been used in secondary schools for some time now.

There are concerns over LFTs. One is whether they'll miss a large number of cases, because they're less sensitive than the slower but more precise polymerase chain reaction (PCR) test. Those concerns are understandable, although defenders of the test say that PCR testing is too sensitive, able to detect viral material in people who had the disease weeks ago, while LFTs should, in theory, only detect people who are infectious.

But another concern is that they will

tell people that they do have the disease when in fact they don't – that they will return false positives.

The government says – accurately – that the "false positive rate", the chance of a test returning a positive result in a person who does not have the disease, is less than one in 1,000. And that's where we came in: you might think that that means, if you've had a positive result, that there's a less than one in 1,000 chance that it's false.

It's not. And that's because of a fascinating little mathematical anomaly known as Bayes's theorem, named after the Rev Thomas Bayes, an 18th-century clergyman and maths nerd.

Bayes's theorem is written, in mathematical notation, as P(A|B) = (P(B|A) P(A))/P(B). It looks complicated. But you don't need to worry about what all those symbols mean: it's fairly easy to understand when you think of an example.

Imagine you undergo a test for a

rare disease. The test is amazingly accurate: if you have the disease, it will correctly say so 99% of the time; if you don't have the disease, it will correctly say so 99% of the time.

But the disease in question is very rare; just one person in every 10,000 has it. This is known as your "prior probability": the background rate in the population.


World Heritage Day at NIT-Sikkim



of Sally Clark turned on the prosecutor's fallacy. She was convicted of murdering her two children, after another expert witness said that the chance of two babies dying of sudden infant death syndrome (Sids) in one family was one in 73m. But the witness failed to take into account the prior probability - that is, the likelihood that someone was a double murderer, which is, mercifully, even rarer than Sids. That, taken with other problems - the expert witness didn't take into account the fact that families which have already had one case of Sids are more likely to have another - led to Clark's conviction also being over-

Let's go back to the LFT tests. Assume that the one-in-1,000 false positive rate is accurate. But even if it is, and you get a positive result, you don't know how likely it is that you have the virus. What you need to know first is (roughly) how likely it was, before you took the test, that you might have had it: your prior probability.

At the peak of the second wave, something like one person in every 50 (2% of the population) in England was infected with the virus, according to the Office for National Statistics' prevalence survey. That was carried out with PCR tests, not LFTs, but let's use that as

Say you tested 1 million people,

Now, though, the prevalence has dropped enormously - down to about one person in every 340 in England. If we run through the same process, we get a very different picture: of your million people, about 2,950 will have had it. Again assuming your test identifies all of them (and again remembering that won't be true in reality), you'll have 2,950 true positives, and about 997 false ones. Suddenly your false positive rate is 997/3,947, or about 25%. In fact, last week government data showed that the false positive rate for LFTs since 8 March was 18%. This rate will rise if prevalence falls - which might become problematic if, for instance, it means an entire class of children has to take time

These sums only apply, of course, if you're truly testing the population at random. If people are using the tests because they think there's a good reason why they might be positive - perhaps they have symptoms, or were recently exposed to someone who had the disease - then your prior probability would be higher, and the positive test would be stronger evidence.

Even doctors struggle with Bayesian reasoning. In one 2013 study, 5,000 qualified American doctors were asked to give the probability that someone had cancer, if 1% of the population had the disease and they received a positive result on a 90% accurate test. The correct answer was about one in 10, but even when given a multiple-choice answer, almost three-quarters of the doc-

None of this means LFTs are a bad idea - I think, cautiously, that they will be useful, especially since positive results will be confirmed by PCR, and if the PCR comes back negative the patient can return to work or school or whatever. But it's worth remembering that, if you read that a test is 99.9% accurate, it doesn't mean that there's a 99.9% chance that your test result is correct. In fact, it's much more complicated than that.

But that means that your test, despite giving the right answer in 99% of cases, has told 9,999 people that they have the disease, when in fact they don't. So if you get a positive result, in this case, your chance of actually having the disease is 99 in 9,999, or just under 1%. If you took this test entirely at face value, then you'd be scaring a lot of people, and sending them for intrusive, potentially dangerous medical proce-

dures, on the back of a misdiagnosis. Without knowing the prior probability, you don't know how likely it is that a result is false or true. If the disease was not so rare - if, say, 1% of people had it – your results would be totally different. Then you'd have 9,900 false positives, but also 9,990 true positives. So if you had a positive result, it would be more than 50% likely to be true.

This is not a hypothetical problem. One review of the literature found that 60% of women who have annual mammograms for 10 years have at least one false positive; another study found that 70% of prostate cancer screening positives were false. An antenatal screening procedure for foetal chromosomal disorders which claimed "detection rates of up to 99% and false positive rates as low as 0.1%" would have actually returned false positives between 45% and 94% of the time, because the diseases are so rare, according to one pa-

Of course, it's not that a positive test would immediately be taken as gospel patients who have a positive test will be given more comprehensive diagnostic checkups - but they will scare a lot of patients who don't have cancer, or foetal abnormalities.

A misunderstanding of Bayes's theorem isn't just a problem in medicine. There is a common failure in the law

In 1990, a man called Andrew Deen convicted in the retrial.) was convicted of rape and sentenced to 16 years, partly on the basis of DNA evidence. An expert witness for the prosecution said that the chance that the DNA came from someone else was just

one in 3m. But as a professor of statistics explained at Deen's appeal, this was mixing up two questions: first, how likely would it be that a person's DNA matched the DNA in the sample, given that they were innocent; and second, how likely would they be to be innocent, if their DNA matched that of the sample? The "prosecutor's fallacy" is to

treat those two questions as the same. We can treat it exactly as we did with the cancer screenings and Covid tests. Let's say you have simply picked your defendant at random from the British population (which of course you wouldn't, but for simplicity...), which at the time was about 60 million. So your prior probability that any random per-

son is the murderer is one in 60m. If you ran your DNA test on all of those 60 million people, you'd identify the murderer – but you'd also get false positives on about 20 innocent people. So even though the DNA test only returns false positives one time in 3m, there's still about a 95% chance that someone who gets a positive test is innocent.

Of course, in reality, you wouldn't pick your defendant at random - you'd have other evidence, and your prior probability would be greater than one in 60m. But the point is that knowing the probability of a false positive on a DNA test doesn't tell you how likely it is that someone is innocent: you need some assessment of how likely it was that they were guilty to begin with. You need a prior probability. In December 1993, the court of appeal quashed Deen's conviction, saying it was unsafe - precisely because the judge and the expert witness had

About 20,000 people would have the disease, and of the 980,000 who don't, it would wrongly tell about 980 that they do, for a total of 20,980 positive results. So if you tested positive, your chance of a false positive would be 980/20,980, or nearly 5%. Or, to put it another way, it'd be almost 95% likely that you really had the disease.

Railways to run Oxygen Express trains via green corridors to fight Covid

NEW DELHI, 18 APR [NDTV]: Stepping up the fight against the novel coronavirus pandemic, Railways is all set to operate "Oxygen Express" trains, Union Minister Piyush Goyal said today, adding that it will help to "to get oxygen in bulk and rapidly to patients".

Green corridors are being created to ensure fast movement of these trains.

"Railways is leaving no stone unturned in the battle against COVID-19. We will be running Oxygen express trains using green corridors to get Oxygen in bulk and rapidly to patient," the Railways Minister said in a tweet. Liquid Medical Oxygen (LMO) and oxygen cylinders will be transported on these trains.

Madhya Pradesh and Maharashtra had "approached Ministry of Railways to explore whether Liquid Medical Oxygen (LMO) tankers could be moved by Railways," a government statement read.

Availability of oxygen is "a key element in the treatment of certain medical conditions in the Covid infection," the statement further said.

The government is also working towards increasing the number of isolation of beds in the trains, the Union Minister said in another post. More than three lakh isolation beds can be set up - depending on the states demand - he explained.

"Govt under PM @NarendraModi leading the fight against COVID-19: 50 COVID-19 isolation coaches with 800 beds ready at Shakur Basti Station & 25 coaches will be available at Anand Vihar Station in Delhi. Railways can setup >3 lakh isolation beds across the country on States' demand," he posted.

The measures come as India - hit by the second Covid wave - sees an alarming spike in Covid cases. This morning, the country's tally surged to 1.47 crore cases with 2.61 lakh fresh cases - the biggest spike so far.

Protesting farmers show black flags to BJP MP in Haryana

He said 70 protesting farmers were detained for a brief period. About two weeks ago, a group of protesting farmers had blocked Mr Saini's car and smashed its windscreen as he was leaving a BJP worker's home at Shahabad Markanda,

Farmer leaders have said they would continue with their "peaceful social boycott" of the leaders of the ruling Bharatiya Janata Party (BJP) and its allies.

Chief Minister Mamata Bannerjee, the Congress leader asked, "Is this the manner in which a prime minister should refer to a chief minister?"

"I cannot imagine a Jawaharlal Nehru or a Morarji Desai or a Vajpayee speaking that language," he said.

Private vehicle would not come within expression of 'public place': SC

vate vehicle does not come within the expression of a public place as per the explanation given under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, the Supreme Court has said. A bench comprising justices UU Lalit and KM Joseph made the observation while deciding an appeal challenging an order passed by the Punjab and Harvana High Court affirming their conviction and sentence under the NDPS Act.

Two bags of poppy straw were recovered from the accused while they were sitting in a jeep at a public place. The trial court, after considering the evidence on record, acquitted accused Major Singh but convicted accused Boota Singh, Gurdeep Singh and Gurmohinder Singh, under the NDPS Act and sentenced them to rigorous im-

prisonment for 10 years. They were also asked to pay a

NEW DELHI, APR 17 (PTI): A prifine of Rs 1 lakh, failing which they were directed to undergo further rigorous imprisonment for two years. The accused argued before the top court that the vehicle in question was a private one belonging to accused Gurdeep Singh and was not a public conveyance, though it was parked on a public road.

The apex court held that the evidence in the present case clearly shows that the vehicle was not a public conveyance but a private one belonging to Gurdeep Singh, and acquitted the accused as they were charged under the wrong

The Registration Certificate of the vehicle, which has been placed on record also does not indicate it to be a Public Transport Vehicle.

The explanation to Section 43 shows that a private vehicle would not come within the expression 'public place' as explained in Section 43 of the NDPS Act.

"On the strength of the decision of this court, the relevant provision would not be Section 43 of the NDPS Act but the case would come under Section 42 of the NDPS Act, the bench said.

It is an admitted position that there was total non-compliance of the requirements of Section 42 of the NDPS Act, the top court said.

Total non-compliance of Section 42 is impermissible... In the circumstances, the courts below fell in error in rejecting the submissions advanced on behalf of the appellants.

We, therefore, allow this appeal, set aside the view taken by the High Court and acquit the appellants of the charge levelled against them.

"The appellants be released forthwith unless their custody is required in connection with any other offence, the bench said.

Road Rage

To make roads safer, prioritise policing against rash driving

colleague driving to Gangtok recently was near-Aly run off the road by a speeding taxi raging to overtake. The road was broad and there was no incoming traffic, hence the reason why the taxi missed brushing against the colleague's car by a whisker made no sense. And then there was another close shave, this time with a private SUV. Talk to others who drive on the highway, or even the capital roads at night, and many more of such anecdotes will tumble out. But pause with the episodes a while, and it all makes sense. It is born from the power of engines which have too many more horse-powers than the hands on the wheels can control. Add the knowledge of too many traffic jams on the roads and the race to rush gets explained, not justified though. Combine this is with the less than adequate training most people receive before they become drivers, and safe driving is no longer about just your driving skills and depends as much on the proficiency controlling vehicles all around you. This also still being tourist season, when it comes to passenger vehicles, the stress of traffic jams and the opportunity to squeeze in an extra trip or getting to destinations before the curfew further contribute to the rashness that is becoming too common on the roads here.

It is obvious that the National Highway and the side roads is in desperate need for an extra helping of tar, but our drivers, especially those of taxi vehicles, seem to be in even more urgent need of an extra class on driving etiquette and a reintroduction to road safety. The spate of accidents, most minor and the occasional fatal crashes, point to a total lack of concern for driving rules, traffic rules and most importantly, pedestrian and passenger safety. Available technology ensures that engine failure, that favourite excuse of "steering lock," can no longer be blamed for mishaps, every single one of them occurs due to rash and reckless driving. And then there are the many close shaves that every commuter experiences on a regular basis. Every single one of them could have ended much worse, and many of the involved drivers will eventually become of part of a pile up eventually. The noticeably high number of head-on collisions bears out that most accidents occur due to reckless speeding. And this applies to the recklessness which rides on two wheels as well.

One cannot ignore the fact that all recent accidents have involved either taxis of two wheelers. It is thus advisable that we tighten our seat belts and snap on the helmets more snuggly and they tease out the reasons for such frequent road mishaps. Accidents are the culmination of "bad habits", and we are not speaking drugs here although that is also a factor in many cases. That drivers do not observe basic traffic rules unless there is a cop around is common knowledge. Overtaking from the wrong side of the road, failing to signal when stopping or stopping abruptly, stopping at 'unauthorised' points... By themselves, these do not lead to major mishaps, but once the keenness to avoid traffic and safety rules becomes instinctive, larger risks are run once the city limits are crossed. The above mentioned reasons would suggest that our drivers tend to manifest a casual approach to their task and/ or are oblivious to the rules of the road - which are hard to digest. The motor vehicles department, after all, issues licenses to the drivers after some tests and checks which are now mandatory. How come drivers still emerge from their training wet behind the ears?

If we are to feel safe on the roads we must all make a conscious effort at righting our wrongs. Drunken or rash driving should be heavily penalised and not just those vehicles parked on the wrong side of the road. The issuing of driving licenses should be made stricter and cracking down on rash driving prioritized because once this becomes a habit everyone around is put in harm's way.

How Taiwan beat COVID-19 - new study reveals clues to its success

Paiwan has been widely applauded for its man-**L** agement of the pandemic, with one of the lowest per capita COVID-19 rates in the world and life on the island largely returning to normal.

Just 11 people have died from COVID-19 in Taiwan since the pandemic began, an impressive feat for a country that never went into lockdown.

At the start of the pandemic, Taiwan was considered a high-risk country for COVID-19 due to its proximity to China and the frequent travel that takes place between the two countries.

With a history of SARS in 2003, which was not considered to be handled particularly well, the Taiwanese government acted quickly to close its borders this time around. It set up a Central Epidemic Command Centre on January 20 2020 to coordinate cooperation across different government ministries and agencies, and between government and businesses.

A new study in the Journal of the American Medical Association has examined further just why Taiwan did so well at conquering COVID-19. The study's authors, from a range of health institutes and hospitals in Taiwan and the US, compared the estimated effectiveness of two types of COVID-19 policy in the early months of the pandemic: casebased and population-based measures.

Case-based measures include the detection of infected people through testing, isolation of positive cases, contact tracing and 14-day quarantining of close contacts. The population-based measures included face mask policies, personal hygiene and social distancing.

The effects of these policies were quantified by estimating the effective reproduction number (R number).

The R number is a way of rating an infectious disease's ability to spread - it represents the average number of people that one infected person will pass a virus onto. An R number of greater than 1 means the virus will continue to spread and outbreaks will continue. An R number below 1 means

that case numbers will start to reduce.

While previous studies in other countries have simulated hypothetical scenarios, this paper combined transmission modelling with detailed real data to estimate effectiveness.

The authors collected data on 158 cases between January 10 and June 1 2020 from the Taiwan Centers for Disease Control, and all cases were confirmed by PCR testing. The data related to locally acquired cases, confirmed clusters, and imported cases in people who entered Taiwan before March 21 2020.

They then compared the outcomes they found in Taiwan with an estimated R number of 2.5, based on the estimated equivalent number in nearby China at the beginning of its COVID-19 outbreak.

THE WINNING COMBINATION The study found that the case-based poli-

cies alone, like contact tracing and quarantining, could lower the R number from 2.5 to 1.53. Quarantine contributed the most to lowering the R number.

Case-based interventions could not substantially prevent transmission from one person to another, but could reduce transmission onwards from those secondary cases to a third or fourth person, as long as close contacts quarantined.

Population-based policies like social distancing and face masks, meanwhile, reduced the R number from 2.5 to 1.3.

The authors concluded that it was the combination of case-based and population-based policies, along with widespread adherence, that led to Taiwan's success in containing COVID. Combining both approaches led to an R number estimated using two different methods to be 0.82 and as low as 0.62. They also found that considerable population-based policies were needed to achieve containment even though the number of circulating

Neither approach would have been sufficient alone, even in a country with an effective public

health system and sophisticated contact tracing. WHAT DOES THIS MEAN FOR OTHER COUN-

Acknowledging that all models make assumptions, and this analysis is no different, this paper does confirm that the full suite of public health measures we have been using fairly consistently across the world - to varying degrees of length and stringency - have been necessary. Though it's worth noting that the results in the study reflects a time when new variants with greater transmissibility were not a problem.

The authors assumed that testing and isolation occurred simultaneously. This was the case in Taiwan, but not in other countries, for example England, where delays between testing, results and isolation diminish the effectiveness of case-based measures.

Taiwan is an island nation with the ability to control the introduction of new cases through border control, and the authors acknowledge the findings of this study may not be fully applicable to other countries. This is the reason the authors focused on the effectiveness of case-based and population-based interventions on local transmission, rather than on border controls on the number of introductions of COVID-19.

The authors conclude that intensive contact tracing is not possible when public health systems are overwhelmed. This never happened in Taiwan due to the success of its strategies, but it did, for example, take place in Ireland in January 2021, which experienced a damaging third wave of COVID-19.

This paper also found similar results for seven-day and 14-day quarantine and suggest that the quarantine period could be shortened. This is being considered by some countries, including the USA, but it has not been introduced on a widespread basis to date.

We already knew there was much to be learned from Taiwan's success in preventing COVID-19 from taking hold. Now, as vaccines roll out and new variants emerge, we have more information about the comparative and combined contributions of public health measures.

Learning to live with COVID — the tough choices ahead

s mass vaccination continues to Abe rolled out, the UK is beginning to see encouraging signs that the number of COVID deaths is reducing, and that the vaccines may be reducing the transmission of coronavirus.

While this is very welcome news, a mass vaccination programme is unlikely to be enough to eliminate the virus, so we need to turn our thoughts towards the ethics of the long-term management of COVID-19.

One strategy would be to aim for the elimination of the virus within the UK. New Zealand successfully implemented an elimination strategy earlier in the pandemic and is now in a post-elimination stage.

An elimination strategy in the UK would require combining the mass vaccination programme with severe restrictions on international travel to stop new cases and variants of the virus being imported. However, the government has been reluctant to endorse an elimination strategy, given the importance of international trade to the UK economy.

One of the main alternatives to the elimination strategy is to treat coronavirus as endemic to the UK and to aim for long-term suppression of the virus to acceptable levels. But adopting a suppression strategy for the long term will require us to make a societal decision about the harms we are and are not willing to accept. THE LIBERTY, EQUALITY AND

MORTALITY TRILEMMA

The first year of the pandemic has taught us that, without suppression measures, coronavirus will lead to significant death and harm, including long COVID. But evidence suggests that mitigation measures, such as lockdowns and effective test, trace

and isolate systems, may be effective

in reducing transmission of the virus. These measures have their own costs. Lockdowns significantly restrict civil liberties and cause a wide range of other harms, including significant non-COVID mortality and morbidity. Recent models suggest that in the long term, the mitigation of the pandemic could lead to 100,000 non-COVID deaths. On the figures from this model, deaths from the virus itself may come to only account for about 54% of the overall death toll of the outbreak in the UK.

The extent of some of the costs of mitigation measures could be lessened by targeting these interventions at certain groups, such as those who have not been vaccinated, or those who have a particularly high risk of death from COVID, such as those over the age of 65. However, these targeted strategies involve forms of unequal treatment and possible dis-

This is the fundamental trilemma of the long-term suppression strat-

egy. The societal decision we make about the acceptable level of viral suppression involves a choice about which of three competing values we should prioritise and which we must compromise. We can maximise one or two of these values, but we can't have all three.

We might be able to reduce COVID deaths while safeguarding equality, but only if we are willing to accept the potential need for future lockdowns, severe travel restrictions, and the costs to freedom and general health that entails. We might be able to reduce COVID deaths while protecting the freedom of those who do not pose a transmission risk by introducing COVID certificates or passports, but only if we are willing to accept the inequality that such schemes involve.

Finally, we can give everyone in society as much freedom as possible, but only if we are willing to accept the increased COVID deaths it will probably involve if the virus has not yet been sufficiently suppressed in other

The moral question about the suppression strategy has been framed as one concerning how many COVID deaths we should be willing to accept each year. This invites comparisons between COVID and annual deaths from other infectious diseases, such as influenza, which has caused fewer than two deaths per 100,000 people per year in European countries since 2000, and those that we have lived

with in the past, such as tuberculosis, which caused around 100 deaths per 100,000 people per year in England and Wales at the beginning of the 20th century.

These comparisons are illuminating because they provide a baseline for the number of deaths from an infectious disease that we have historically found acceptable to live with. If we accept a bad flu year with over 22,000 deaths in England without imposing significant societal restrictions, then perhaps we will come to accept the same number of deaths with COVID.

But these comparisons are relevant to only one of the key ethical values. In the context of COVID, we might have to risk a higher number of COVID deaths in the absence of significant societal restrictions or inequality.

To decide what is acceptable on the suppression strategy, we have to confront the fundamental conflict between values in the COVID trilemma.

Covid curbs shouldn't stop those going to vaccination sites: Centre

NEW DELHI, 18 APR [NDTV]: With restrictions returning to many parts of the country to check the spread of coronavirus as cases continue to soar, the government today told the states to make sure that vaccination efforts are not hampered.

While tough restrictions were announced in Maharashtra earlier this week for 15 days as the state government stopped short of announcing a lockdown, Bihar, Tamil Nadu and other states have also announced fresh curbs to break the chain of transmission.

However, cases are still on a rise. This morning, India recorded the biggest-ever daily spike as 2.61 lakh cases were recorded in the previous 24 hours, taking the caseload to 1.47 crore infections.

Even as many states have flagged vaccine shortage, the Health Ministry today asserted that



over 12 crore doses have been administered in three months after India began "the world's largest COVID-19 drive'

"In view of rising COVID-19 cases across many states and union territories, various measures are being undertaken to control the spread of COVID-19 which also COVID-19 curfews and partial or complete lockdown in some states or districts for variable periods. Similarly, for management of COVID-19 cases, certain hospitals are being earmarked as dedicated COVID-19 hospitals for management of only COVID-19 cases," a government statement

"In this regard, it is advised that COVID-19

vaccination should not be affected by COVID-19 curfews or lockdowns and the movement of beneficiaries to and from COVID-19 Vaccination Centres (CVCs) should not be restricted during such interventions," the statement further read.

Vaccination vices "should be provided in a separate

building or block in these hospitals that is distinctly separated from the building or block where management of COVID-19 patients is being done," it further said. "This will ensure that beneficiaries of vaccination are not inadvertently exposed to COVID-19 at these hospital," the centre has suggested.

in handling the COVID pandemic.

Prime Minister Modi has been addressing public rallies in West Bengal for the eightphase assembly elections in the state.

India has been witnessing a massive surge in coronavirus cases.

BJP member found dead at Chakdah CHAKDAH (WB), APR

18 (PTI): The body of a BJP member was found at Chakdah in West Bengal's Nadia district in the early hours of Sunday, police said.

After the body of Dilip Kirtania (31) was found, BJP activists in the area started protest demonstrations staging roadblocks alleging that he was murdered by miscreants belonging to the rival TMC, the police said.

Kirtania's members alleged that he had gone out in the night to attend to nature's call, but did not return home, police said quoting the complaint lodged.

"As he did not return home for a long time they started a search and found him lying injured a few metres away from his residence. Doctors declared him brought dead when he was rushed to Chakdah state General hospital. He had several injuries in his private parts," a police offi-

BJP party activists started protests as the news of Kirtania's death spread in the area.

cer added.

Demanding arrests of those behind the murder, the BJP activists also staged protests putting up a blockade on NH 34, police said.

Polling for the Chakdah seat was held on Saturday during the fifth phase of the West Bengal Assembly election.

Police had arrested one Independent candidate Koushik Bhowmick for carrying a country-made pistol outside a polling booth during Saturday's polling.

42 new cases push Andamans COVID-19 tally to 5,331

Andaman and Nicobar Islands COVID-19 caseload surged to 5,331 as 42 more people tested positive for the virus, a health department official said on Sunday.

The COVID-19 death toll in the archipelago rose to 64 as one more person succumbed to the infection in the last 24 hours, he said.

Of the 42 new coronavirus cases, 31 were detected in South Andaman district during contact tracing and the rest 11 tested positive for COVID-19 during rapid antigen test at the airport upon arrival, he said.

Malkangiri district recorded the least number of new cases at four.

Messi had again showed, at age 33, that he can still completely dominate a final.

But hanging over the cup was what it truly meant to the inscrutable Argentine.

For coach Ronald Koeman, with his team also in the league title race, nothing has changed. It is up to Messi to decide, while Koeman crosses his fingers.

Messi showed he is a born winner, Koeman said after claiming his first title since the former defender returned to coach the club last summer.

We hope this is not Messi's last Copa. We want him to stay with us.

Bumrah one of the best death bowlers, makes my job easier: Boult



CHENNAI, APR 18 (PTI): Jasprit Bumrah is "one the best death bowlers" in the game, gushed star New Zealand seamer Trent Boult after the Indian pace spearhead yet again played a key role in Mumbai Indians' triumph against Sunrisers Hyderabad.

Bumrah conceded only 14 runs in his four overs and took one wicket as MI bowled out SRH for 137 after setting them a 151-run target.

"It's great to see a guy (Bumrah) like that operate. How clear he is with what he is doing with the ball throughout his whole spell," Boult said after MI beat Sunrisers Hyderabad by 13 runs on Saturday. The dynamic duo of Boult and Bumrah have combined fabulously in the MI set up. The two churned out sensational performance in the last edition to help their side win an unprecedented fifth title.

"But at the death, I personally believe, he is one of the best death bowlers in the world. He makes my job a heck of a lot easier," he added.

"It is always nice being on the right side of those situations. Hopefully, we can get a bit of momentum into this tournament". While spinner Rahul Chahar (3/19) and Boult (3/28) did the heavy lifting with the ball, the Kiwi said it was a team effort.

"It's hard to pin-point one performance there. A lot of credit to the whole side for hanging in there. We knew we were a few runs short of the par score.

"But we also knew that this is a pitch where you can fight. And you get a couple of wickets, you can really get back in the chase.

"I thought a couple of direct hits om Hardik (Pandya) and the three wickets from Rahul were important when we were bowling. And then Bumrah there, bowling his four overs for only 14 was pretty amazing," he added.

Mumbai has manged to defend sub par scores in the previous two games and Boult feels accuracy is vital while bowling at the Chepauk.

"The contrast between Wankhede and Chepauk Stadium is quite considerable. It looks like its swinging around nicely and it's a perfect surface in Mumbai. "Here as a pace bowler, you got to be extremely accurate. Key has really been our ability to bowl dot balls and keep pushing the run rate."

MI are slated to play their first five matches here before moving to Delhi.

"It gives us a chance to settle at the venue. But the key would be to obviously read the conditions quickly as possible and make the most of them really.

"So, it's a unique situation. We've got five here, four in Delhi, move around a little bit. But, I think especially in the first half of the tournament you obviously get on the right side of a couple of results and it's nice to get those couple of wins in the last two matches," he said.

London, 18 [THEGUARDIAN]: Fulham were seconds away from a win that would have made survival appear that little bit more realistic and, perhaps, put the wind back in their sails for a great escape. That prospect seems exceedingly remote now and their desolation at full time suggested they knew it. They were leading through Josh Maja's second-half penalty and, largely thanks to a heroic performance from goalkeeper Alphonse Areola, looked to have repelled an Arsenal barrage as the game entered its seventh minute of stoppage time.

Then Mat Ryan, making his home debut in Arsenal's goal, advanced upfield for a corner and managed to flick the ball across goal. It was drilled back in by Dani Ceballos and Areola, who would claim unsuccessfully that he had been unsighted by an offside Rob Holding, pushed the shot away. But the substitute Eddie Nketiah was positioned to stab in an equaliser that leaves nobody especially happy: a draw is a near-fatal blow to Arsenal's remaining hopes of qualifying for European

football via the domestic route. At the end Fulham's contingent sunk to their knees; at the interval they could feel happy enough with parity given Arsenal, who had emerged with their tails up before losing their way, had just been denied the lead by a toe's length. Like many that fall foul of VAR, which is deployed on a weekly basis in such a way as to debase an entire sport, there was nothing wrong with Ceballos's 41st-minute header at first glance. He had been one of three Arsenal players queuing

up to convert Héctor Bel-

the far post, succeeding in doing so with a firm finish across Areola. There would have been no need for a review if, shortly afterwards, Martinelli's firsttime shot from 10 yards had beaten Areola. The chance arose after Emile

lerín's precise cross to Smith Rowe had bustled cross-shot, but then Mato the byline and, with space at a premium, managed to cut back. Areola was down sharply in a crowded box to save with his left hand and Fulham retained hope of establishing a platform.

Scott Parker had,

like Mikel Arteta, made five changes to his starting lineup and opted for speed on the counter. Maja, Ademola Lookman, Ivan Cavaleiro and Bobby Decordova-Reid all have plenty of that and the lineup had a similar look to the one that, five games previously, had earned Fulham a win at Anfield and seemingly a clear path to survival. They stabilised in the period between those misses and Ceballos's frustration, playing patiently around Arsenal's press at times, and had a chance of their own midway through the first half. Decordova-Reid's deflected shot fell kindly for Maja in the box and, via the inside of Holding's leg, his first-time strike dribbled millimetres wide.

That level of penetration would not be enough to improve their fortunes but, from their first moment of menace after the break, they found an unlikely breakthrough. Arsenal had been banging at the door again, Lacazette fizzing wide and Saka rapping the outside of a post with a charge upfield.

Gabriel cut out his attempted through pass for Ola Aina but, given a second bite as the ball ran free, Lemina nipped in ahead of the Arsenal centre-back. Down he went, the contact perhaps anticipated somewhat as the pair collided, and although Craig Pawson initially seemed reluctant to award a penalty, a glance towards his assistant referee solidified his decision.

This time VAR found nothing to niggle at after again checking for a tight offside call earlier in the move and, eventually, with Parker barely able to watch from the touchline, Maja beat home debutant Ryan from the spot.

Jailed Putin critic Alexei Navalnv could die at any minute, doctors warn Moscow, 18

[THEGUARDIAN]: Jailed Kremlin critic Alexei Navalny risks cardiac arrest at "any minute" as his health has rapidly deteriorated, doctors warned Saturday, urging immediate access to Russia's most famous prisoner.

On 31 March, Vladimir Putin's most prominent opponent went on hunger strike to demand proper medical treatment for back pain and numbness in his legs and hands.

On Saturday, Joe Biden added his voice to a growing international chorus of protest at the treatment of the activist, describing his situation as "totally unfair".

Navalny, 44, was imprisoned in February and is serving two-and-a-half years on old embezzlement charges in a penal colony in the town of Pokrov about 100km (60 miles) east of Moscow.

Navalny's personal doctor Anastasia Vasilyeva and three more doctors, including cardiologist Yaroslav Ashikhmin, have asked prison officials to grant them immediate access. "Our patient can die any minute," Ashikhmin said on Facebook on Saturday, pointing to the opposition politician's high potassium levels and saying Navalny should be moved to intensive care. "Fatal arrhythmia can develop any minute."

Navalny barely survived a poisoning with the novichok nerve agent in August which he has blamed on the Kremlin. His doctors say his hunger strike may have exacerbated his condition.

Having blood potassium levels higher than 6.0 mmol (millimole) per litre usually requires immediate treatment. Navalny's were at 7.1, the doctors said. "This means both impaired renal function and that serious heart rhythm problems can happen any minute," said a statement on Vasilyeva's Twitter account. The doctors said he had to be examined immediately "taking into account the blood tests and his recent poisoning".

Navalny's spokeswoman Kira Yarmysh, who accompanied him when he collapsed on a plane after the poisoning in August, said the situation was critical again. "Alexei is dying," she said on Facebook. "With his condition, it's a matter of days." She said she felt like she was "on that plane again, only this time it's landing in slow motion", pointing out that access to Navalny was restricted and few Russians were aware of what was actually going on with him in prison.

On Saturday, responding to reporters' questions about Navalny's plight, Biden responded: "It's totally, totally unfair, totally inappropriate."

More than 70 prominent international writers, artists and academics, including Jude Law, Vanessa Redgrave and Benedict Cumberbatch, have called on Putin to ensure that Navalny receives proper treatment immediately.

Global death toll passes 3m as pandemic 'grows at an alarming rate'

London, 18 Apr [theGuardian]: A grim Covid-19 milestone was passed on Saturday when it was revealed that the global death toll from the disease had passed three million.

The news was described as "chilling" by Wellcome Trust director Jeremy Farrar, who warned that the true number of deaths was probably much higher. "Worryingly, this pandemic is still growing at an alarming rate," he said. "Hundreds of thousands are dying every day."

According to the Covid-19 dashboard, run by Johns Hopkins University, there have been more than 140 million cases of the disease since the pandemic began last year with the official death toll reaching 3,001,068 yesterday morning. The worst affected country was the US with more than 31 million cases and more than 560,000 deaths.

India and Brazil have also fared badly with the former recording more than 14 million cases and 175,000 deaths, while the latter has suffered just under 14 million cases and almost 370,000 deaths. Britain, which has also been hit heavily by the disease, has had more than four million cases and has a death toll that currently stands at more than 127,000.

"Only when we have tools to detect, treat and prevent Covid-19 everywhere will we be able to stop this pandemic and this senseless, tragic loss of life," added Farrar, who said



that a small number of rich countries had key roles to play in bringing the pandemic to a halt.

"The UK, the US and other wealthy nations are in a position where they can and should set out a timetable immediately for sharing vaccine doses with the rest of the world, alongside their national rollouts. There can be no more delays."

In the UK it was revealed that on Friday there were 35 deaths, 2,206 new cases, 120,000 first vaccinations administered and 485,000 second vaccinations administered.

The impact of Britain's

lengthy lockdown and the fast rollout of vaccines across the country over the past four months has helped the UK to do relatively well recently in terms of declining numbers of deaths and hospitalisations. "I think in our own little world in the UK we're actually doing pretty well now," said Sir John Bell, regius professor of medicine at the University of Oxford.

In November Bell predicted on BBC News that Britain would have a near- normal spring this year. "I stand by that," he told the Observer last week. "We are going to have a spring and a summer that will look pretty close to usual." However, there were still issues to worry about, he added. "We have this challenge of getting the world vaccinated and that is not going to happen this summer.

"That means the ongoing creation of some pretty interesting variants will continue round the world and any one of those could turn out to be much more pathogenic or much more infectious than existing strains. We are walking on a tight ridge with all this going on around us."

On the other hand, there will soon be a broad selection of vaccines available in the UK, and if used in combination with each other, these could provide deeper and broader protection against new variants, Bell added.

"I think you can expect a little uptick in numbers of cases in the next few weeks because schools are back and lockdown is coming to an end. However, I would really hope that given the level of vaccination that has taken place - particularly for the vulnerable and elderly – that we will see less in the way of hospital admissions and deaths which are already at a very low level. But if those numbers start to go up, we could have something to wor-

also suggested plans are being prepared to give Covid jabs to the under-18s in the UK once vaccine trials on youngsters in the US have been completed. These would help limit the spread of the Covid virus and help to build some kind of herd immunity among the population in Britain.

However, Saul Faust, professor of paediatric immunology at Southampton University, told the Observer last week that he thought it was doubtful that a rollout of vaccines for the under-18s would take place this year.

"Although we may soon have the clinical data from US vaccine trials of under-18s, it is unlikely that children and young people will become the highest priority for immunisation - although that could change if circumstances in this country alter," he said.

"For example, if a new variant affecting younger people begins to sweep schools, there would be a good moral argument for immunising young people for their own benefit to prevent school closures," added Faust.

"Such a move is only likely to be approved if there was enough vaccine in the country, and with the AstraZeneca vaccine being restricted at present and with the prospect that it may be necessary to give older people a booster jab in autumn, it would seem unlikely that we will be immunising young people in the UK before 2022, when vaccine ry about." Could Marine Le Pen finally triumph with her third tilt at French presidency?

PARIS, 18 APR [THEGUARDIAN]: In Paris's symbolic Place de la République, under the watchful gaze of France's allegorical figurehead Marianne, the skateboarders are not in the mood to discuss politics.

For the young here, as everywhere, life has been paused during a pandemic that has halted studies, jobs, socialising and parties. What they want is their lives back, not to talk about an election.

"Right now, there are more important things to worry about," says one young skateboarder.

Like the youngsters in the Place de la République, Macron's administration has more pressing Covid-related issues to deal with, but Le Pen is in full campaign mode. On Friday, she tweeted that her Rassemblement National (RN) party had found its election HQ in Paris's chic 16th arrondissement.

In Burgundy, the RN has got a head start on rivals, putting up its posters on municipal noticeboards and posting flyers through letterboxes, urging voters to get behind the RN candidate in June's regional elections.

Head south to Provence, a far right stronghold, and the RN is being tipped to easily win both rounds of the regionals, though locals stop short of saying they are ready to hand her the keys to the Elysée.

Claude Millesi, 72, who lives in Nice, said he would be voting for Le Pen for president because "it's time for a change", but the owner

of a popular coffee shop in nearby Cannes said that while the whole area was "pretty rightwing", he felt the RN's moment had passed. "Nobody wants racism and civil war," Macron's popularity is current-

ly hovering at about 37% - low but still considerably higher than that of his two predecessors at the same time in their mandate – 29% for Nicolas Sarkozy and 17% for François Hollande - though both turned out to be one-term presi-

In the middle of a health cri-Outside Paris it is a different sis that Macron has described as a "war", presidential advisers believe it would be a disaster for him to even mention next year's election, let alone announce he is seeking a second term. Le Pen has been less backward in coming forward to make her third bid for the presidency.

> Asked if Le Pen could win, Sylvain Crépon, a senior lecturer in politics specialising in the far right at the university in Tours, says a victory is "possible, but not prob-

"Six years ago, we could be almost certain Marine Le Pen would not win an election. That has changed. She has a better chance than last time but we have to put any potential victory in context," he said. "A general election will follow the presidential, and the RN has few local or regional representatives, few elected representatives in parliament, very little financial means and not that many voters.

"Of course it would be a revolution if she were to be elected but she doesn't have the capacity to put her politics into effect by getting a majority in parliament and forming a government." The most likely result of this would be cohabitation with the mainstream right, resulting in a dilution of her power. However, a President Le Pen would still be head of the armed forces and responsible for defence and foreign policy.

"She could still do a lot of dam-

age," Crépon says. So far, nine candidates have thrown their hat in the presidential ring, including Jean-Luc Mélenchon for the hardleft party France Insoumise (Unbowed France). It seems unlikely the Socialist party can come up with a credible presidential hopeful in the next 12 months, and even less likely they will stand a chance of winning. For a brief moment, Anne Hidalgo, the mayor of Paris, seemed the Socialists' brightest hope, but recent estimates have put her first round result at a disastrous 5-10%.

However, the opposition Les Républicains could pull a charismatic candidate - perhaps the popular former prime minister Édouard Philippe – out of the political hat.

Of the 27 opinion polls published since the beginning of 2021, all suggest it will be a rerun of 2017 with Macron and Le Pen head-to-head in the second round. Of the 12 second-round polls published, none has Le Pen winning.

But political analysts point out that the polls may not be worth the graph paper they are printed on. Alexandre Dézé, a professor at Montpellier university and Sciences Po in Paris, said the polls had become a form of "self-fulfilling prophesy".

"It's pure manipulation, and they're worth nothing at all. How can you ask people what way they will vote when we don't even know who the candidates are and we have no idea of their programmes?" Dézé told the Observer. He insisted the RN "remains dangerous and anti-democratic".

"It's the party of people who are fed up and want to vote for Le Pen as a protest," he said. Like Crépon, he pointed out that the RN still has few mayors, local councillors or elected representatives in parliament. The party has just one senator in the upper house, and six MPs in the 577-seat Assemblée Nationale. That Le Pen is able to do so well is because the far right has become a "personality cult", Dézé said.

Rwanda arrests woman deported from US on genocide charges

KIGALI, 18 APR [ALJAzeera]: A Rwandan woman who was deported by the United States after serving a prison term for lying on her naturalisation application has been arrested upon arrival in Rwanda, where she faces seven charges related to the 1994 genocide.

Thierry Murangira, spokesman for the Rwanda Bureau of Investigation, said Beatrice Munyenyezi will be charged for crimes ranging from murder to complicity in rape, which occurred as she was manning a roadblock in the southern city of Butare.

His comments on Friday evening came after Munyenyezi, who had

secured US citizenship in New Hampshire in 2003, was flown into Rwanda's capital, Kigali, accompanied by US federal agents.




Munyenyezi denied accusations of involvement in the genocide during her trial in the US. She did not speak to waiting journalists as Rwandan police took her into custody when she arrived.

During the genocide between April and July of 1994, some 800,000 people were

slaughtered, mainly from the ethnic Tutsi minority but also moderate Hutus. The roadblock where Munyenyezi is accused of committing the crimes was situated outside a hotel in Butare that was owned by her in-laws.

Munyenyezi's motherin-law, Pauline Nyiramasuhuko, and her husband Arsene Shalom Ntahobali, were convicted and sentenced by the international criminal tribunal for Rwanda in Arusha for their roles in the genocide. Munyenyezi was stripped of her US citizenship and jailed for 10 years in 2013, after she was found guilty by a court of misrepresenting material facts when she secured the naturalisation.

Plemons plays Tom White, the lead FBI agent investigating the murders. The character is the film's traditional hero, which is why it was originally


