Success in Sikkim eludes national parties

GANGTOK, APR 7 (PTI): Winning the Lok Sabha or assembly polls in Sikkim has eluded the national parties for the past four decades since the state came into being.

It has been the regional parties - Sikkim Sangram Parishad (SSP) of Nar Bahadur Bhandari and Sikkim Democratic Front (SDF) of Pawan Chamling which have won the lone Lok Sabha seat and the state assembly since 1979.

In an exception, in the first Lok Sabha polls held in Sikkim in 1977, two years after its merger with India, the Congress had won unopposed to the Parliament.

In respect to the assembly polls it has tasted limited success so far. The party had won 1984, two in 1994 and a lone one in 2004.

Resentment over unmet promises brews in Assam's tea city

ZAFRI MUDASSER NOFIL DIBRUGARH (ASSAM). APR 7 (PTI): Minimum wages, ST status, basic amenities and permanent employment avenues are some of the demands of Assam's tea tribes, who form a considerable chunk of voters in this Lok Sabha constituency but are struggling to be heard above the din of political rhetoric. This tea town, which goes to the polls on April 11, is home to around 4.5 lakh voters of the community, made up of scores of tribes who form the bulk of workers in the tea gardens of the state.

But things have not improved much for tea garden workers despite leaders from the community getting elected to Parliament several times. This time there are four contestants in the fray who hail from the community -- Rameshwar Teli (BJP), Paban Singh Ghatowar (Congress), Titus Bhengra (Bahujan Mukti Party) and Israil Nanda (Independent).

In 2017, the Assam government formed an advisory board to fix minimum wages of tea workers. The board recommended an amount of Rs 351 but a final decision is yet to be taken. At present, a tea garden labourer gets a daily wage of Rs 167. According to Teli, who represents the constituency in the Lok Sabha, the government cannot raise wages and it is up to tea garden owners to take a decision.

"We cannot put pressure on the tea garden owners to raise wages. They will face problems. So what our government is doing is giving support to the tea garden community to improve their living conditions. We are giving free rice, monetary help to pregnant women, mobiles to line sardars (head of labourers) and scooters for girls," Teli told PTI.

His political rival, former Union minister and Congress candidate Paban Singh Ghatowar, questions the BJP's stand on the minimum wage issue saving it has been fooling the tea garden community.

open its account in the 32-member assembly of the Himalayan state.

The fortunes of parties like the CPI, CPI-M, Trinamool Congress and the Nationalist Congress Party (NCP), who have contested in Sikkim at various times, have been equally disappointing so far with more than 60 per cent candidates of all national parties forfeiting their deposits since 1979.

Asked, a BIP senior leader said that strong regional sentiments among the people, who feel more comfortable with local leaders has led to the complete rout of the national parties in the polls in the state.

"The regional parties like the ruling Sikkim Democratic Front have an assembly seat in milked the vulnerabilities of the local people to their advantage by telling of the BJP leader. "We

them that if the national parties come to power in the state they will abrogate Article 371(F), which protects their rights and provides special provisions for Sik-

kim." he said. "We have been unsuccessful so far in convincing that we will safeguard their rights," the BIP leader said, adding, it would require more interaction between the party's leadership and the people for any headway in the electoral politics of Sikkim.

This time the party is repeating its foray in the state assembly polls despite the previous debacles and has put up candidates in 12 seats as well as in the lone Lok Sabha seat.

The Sikkim National Peoples Party (SNPP) president Delay Barfungpa confirms the analysis cannot trust the national parties to protect Article 371F," Barfungpa said.

The Sikkim PCC president Bharat Basnett felt that the national parties have not given enough importance to Sikkim because it has "just one Lok Sabha seat".

"It is the national parties' indifference towards Sikkim, its people and issues which have prevented them from making inroads in the state's politics," he said.

Basnett, who is the party's candidate for the lone Lok Sabha seat this time, said Congress had done important things for Sikkim like granting special status to it under Article 371F and inclusion of Nepalese language under eighth schedule of Constitution.

"Yet the Sikkimese people have not reposed confidence in the Congress, elections after elections, for de- sue of delay in reservacades," he said.

He also blamed the regional ruling parties for creating a fear psychosis among the people against the national parties saying they will snatch the special status if allowed to rule Sikkim.

The SDF spokesperson Bhim Dahal, agrees that the Sikkimese people are not comfortable with the national parties when it comes to voting for them in elections.

"The national parties like the Congress and BJP have paid only lip service to the aspirations of Sikkim while ruling at the Centre ... The tendency of the central government to sit on important demands of the Sikkimese people for decades have led to strong undercurrent against them among the local people," he said.

Dahal, a former Lok Sabha MP, cited the is-

tion of assembly seats for the Limboo and Tamang communities as an example of the national parties' apathy

As long as the national parties continue to remain indifferent towards Sikkim it is unlikely that the Sikkimese people will trust them, he added,

towards Sikkim.

The SSP had been in power in the state since 1979 to 1994, while the ruling SDF under Pawan Kumar Chamling has held the tight reins of the state since 1994.

Chamling is the longest-serving chief minister of the Himalavan state and is looking forward to return to power for the sixth consecutive term.

GANGTOK, APRIL 07 (IPR): Preparations for dispatch of polling parties has been started by the East District Administration. the District Election Officer (East), Kapil Meena, informs. Training for the same has been scheduled for 08 April for all the tables which will dispatch polling materials.

The Strong Rooms which house the prepared EVMs and VVPATs will be opened on 10 April at 7:30am in the presence dates and their election agents at Brihaspati Parsai Senior Secondary School, he adds.

A complete plan for activities on the day of dispatch and thereafter for reception of polling parties is being made by Office of District Election Officer.

The dispatch of all 214 polling parties will be completed by noon on 10 April with Sector Magistrates escorting the polling parties both on the day of dispatch and on the day of reception after the polling is over.

The sealing of strongrooms for the Sikkim Parliamentary Constituency and for 13 Assembly Constituencies of East District, including Sangha, will then be done in the presence of candidates/ agents and General Observers on the night of 11 April after reception is completed.

Sufficient number of reserve machines have been prepared and will be provided to Zonal Magistrates and Sector Magistrates for any replacements on the day of polls if needed.

Will PM Modi have courage to fight from Kerala or Tamil Nadu, asks Shashi Tharoor

NEW DELHI, APR 7 (PTI): Rahul Gandhi's decision to contest from Wayanad shows he has the confidence to win from both north and south India, senior Congress leader Shashi Tharoor said Sunday and asked whether Prime Minister Narendra Modi would have the courage to fight from a seat in Kerala or Tamil Nadu. With Gandhi contesting the Lok Sabha polls from Kerala's Wavanad constituency, there is palpable excitement across the southern states that the next prime minister could be elected from the the region, Tharoor told PTI in an interview.

Tharoor also slammed Modi and the BJP for suggesting that Gandhi chose Wayanad to "run away" from majority dominated areas, saying the ruling party has repeatedly resorted to peddling bigotry. It was dismaying that this was coming from the prime minister, he added.

"By reinforcing his role as a torchbearer for the BJP's bigotry, Mr Modi has disregarded the principled position that a prime minister of India must be a prime minister for all Indians," he told PTI from Thiruvananthapuram. Addressing a

rally in Wardha in Maharashtra, the prime minister had said the opposition party was "scared" to field its leaders from constituencies where the majority dominates. Tharoor claimed Gandhi's decision to contest from Wayanad comes at a time of "unprecedented strain" on the spirit of that has held the country together since its Independence in 1947.

Under the BIP-led Centre, he alleged, relations between the southern states and the federal government have "steadily deteriorated" over a number of issues such as threats to the economic security of the south as well as the future of its political representation.

In that context, Gandhi has made a bold statement of intent to suggest he can be the bridge that repairs the growing north-south divide within the country, Tharoor said, adding that it also signals that the Congress chief has the confidence to win elections in both the north and the south.

"Can Narendra Modi make such a claim? Would he have the courage to fight for a seat in Kerala or Tamil Nadu?' the former diplomat turned politician asked.





For Labour Because not enough is being said on their behalf

We see them around often, but don't always notice them. They labour on tasks which are necessary, but would not have the necessary workforce had it not been for their privations which draw them away from home to worksites across the country. They power development with their sweat, plod away, are often humiliated and yet they persevere. Had it not been for them, the planners who chart development for the country would have seen their projections stuck to the drawing board and never translated on ground. Take a look around, the sewage line does not get laid only because there is a budget for it, but because there are stomachs desperate enough to work through cold, wet nights to lay them. Cardamom is not a cash crop because Sikkim has progressive farmers, but because there are backs willing to take the load by the maund after they have harvested a crop which, let's accept it, few here have any actual understanding of. Gangtok's highways would not be neatly parted of their overnight sludge, had an entire army of labourers not been at hand to begin clearing the debris at the break of dawn. Drive on the highways, and it becomes obvious that the poor roads do not stand a chance of improving if workers from outside were not trucked in. Trekking is possible not only because Sikkim is pretty, but because realities are quite ugly for some making them carry loads wearing slippers and plastic shoes up trails where even the tougher trekkers slip despite their better shod feet.

And still, they do not figure anywhere in the pecking order and in most cases, don't even get to enjoy the infrastructure they build. Unfortunately, they also make easy targets, often denied even of their due remunerations. We read reports of Indian stuck in the Middle East, not paid their dues and unable even to afford an air ticket home, and we offer them the wrong response - clucking our tongues in sympathy when we should have been raging against the systems which allow such denials. Sikkim got a taste of such inhumanity in the wake of the 18 Sept earthquake when choppers evacuated the management and officers, but labourers at hydel and other construction sites had to foot it across dangerous terrain. Many of them complained of not having received their dues and only few of them had any plans of returning. They fled with their lives, leaving behind their earnings. It is unlikely that anyone even attempted to trace them down and clear their dues. They are probably being exploited somewhere else now.

The anonymity in which the labour force works and fades away is still an unfortunate reality, and one that needs to be addressed. Not just because they deserve better, but also because we need to be better. The maltreatment is not just a governmental failing, but more a societal shortcoming. It is because we, as consumers, do not pay enough heed to basic human rights that the labour, as a class, gets denied. The West now has the luxury to pay attention to such issues which the developing world still looks at as distractions. When we celebrate laws banning bonded labour and child labour in India, we should perhaps thank buyers in the West who put pressure on manufacturers to become more humane. The pressure for better protections and more genuine safeguards have to come from the lay people, who themselves have to deliver better as well. The government fixes the minimum wage, but apart from government employ, how many other workplaces offer them? How many domestic servants, even discounting meals, are volunteered such remuneration? And vet there are people willing to work for less, willing to look the other way despite a law [of minimum wage] being broken. The labour force does not require a more compassionate government, it requires fellow citizens who notice them, listen to them, respect them and when the situation demands, speaks for them.

Putin's plagiarism, fake Ukrainian degrees and other tales of world leaders accused of academic fraud

A recent college admissions scandal in the United States, which revealed that wealthy parents had bribed officials at elite universities, exposed the price some people are willing to pay to say, "I went to an Ivy League school."

In a country where the myth of academic meritocracy persists despite plenty of evidence to the contrary, many people were shocked to learn that the education system was rife with illegal and unethical conduct.

But academic fraud is nothing new – and it wasn't invented in the United States. In certain countries, my research on academic corruption attests, some public officials have built their entire political careers on the false pretense of scholastic achievement.

LYING LEADERS

You'd think that former German Minister of Defense Baron Karl-Theodor Maria Nikolaus Johann Jacob Philipp Franz Joseph Sylvester Buhl-Freiherr von und zu Guttenberg already had a long enough name.

But in 2006, he decided to add the title of "Dr." to it, completing his doctorate of law at Germany's University of Beyrouth.

Or so he said.

It turns out that Guttenburg, then widely seen as the successor to Chancelor Angela Merkel, had plagiarized large sections of his Ph.D. dissertation comparing U.S. and European legal systems.

The internet sleuths who outed his fraud in 2011 gave Guttenberg yet another name – the sobriquet "Googleberg." He was forced to resign, fled possible criminal prosecution in Germany and, in the United States, landed an honorary position at the Washington-based Centre for Strategic and International Studies think tank.

Romanian Prime Minister Victor Ponta initially tried a different approach when he was accused of academic plagiarism soon after taking office in 2012: He denied everything.

"The only reproach I have is that I did not list authors at the bottom of each page, but put them in the bibli-

ography at the end," he said.

Ponta quit his post in 2015 after going on trial for tax evasion and facing a series of other scandals.

But he still defended his aca-

"After...stepping down from the political scene, I wish to pursue a new doctorate while adhering to and respecting all of the standards and requirements," he said bravely, after admitting to having plagiarized more than half of his 2004 dissertation on the International Criminal Court. Ponta later wrote to the rector of Bucharest University to renounce

his degree. **DENIAL: THE STRONGMAN'S TACTIC**

Russian President Vladimir Putin has been far less receptive to repeated allegations that he was not the intellectual braintrust behind his 1997 dissertation, "Mineral and Raw Materials Resources and the Development Strategy for the Russian Economy."

Accusations against Putin first surfaced in 2006, when an investigation by the Brookings Institution alleged he copied about 16 pages of his 200-page Ph.D. dissertation from other sources.

Twelve years later, the Russian strongman found himself defending against accusations that his dissertation had been ghostwritten. According to former Russian legislator Olga Litvinenko, Putin's dissertation was written by her father, Vladimir Litvinenko, Putin's academic advisor and the rector of Saint Petersburg Mining University.

Also helpful in "writing" Putin's dissertation, says Litvinenko: a photocopy machine.

Employing the only cut-and-paste technology available in the late 1990s, she says her father helped Putin cheat by using scissors to snip paragraphs from various sources, glued them together and copied them to create new pages in his dissertation.

Putin has never responded to the allegations.

MODELS OF CHEATING

Guttenberg's, Ponta's and Putin's reactions to their false doctorate scandals are all completely appropriate, my research finds – if you consider the cultural context in which each occurred.

Leaving office, or even fleeing the country, after allegations of academic corruption, as Guttenberg did, is a rational response in his situation.

Germany ranks sixth of 129 countries worldwide in terms of adherence to the law, according to the World Justice Project's annual "rule of law" index. There, such criminal acts bring professional disgrace, a likely conviction in court and possibly even jail time.

In an emerging democracy that still struggles with corruption, however, such as Romania, bravado is a reasonable way to handle allegations of academic malfeasance. Among European countries, Romania is among the least likely to hold public officials accountable for abuses of power or to demand transparency from government employees, according to the World Justice Project, which ranks the rule of law worldwide.

And in a well-established autocracy like Russia, frankly, top politicians can afford the luxury of simply ignoring allegations of a

falsified resumes. Putin has held top office, as either president or prime minister, since 1999.

His grip on power is so all-encompassing that he is immune to the negative consequences of academic scandal – or pretty much any scandal. UKRAINE'S DISSERTATION FACTORIES

The same holds true in Ukraine, another struggling young democracy.

In Ukraine, it is traditional for top politicians to hold doctorates. All of the five presidents that have run Ukraine since its independence from the Soviet Union in 1991 have had their Ph.D.'s – at least in theory.

But since the country has dozens of private firms that offer ghost-written dissertations for sale, it has also become a Ukrainian tradition to expose politicians with unearned doctorates.

President Victor Yanukovych's doctorate and professorship was called into doubt when people noticed that his 2004 application to run for president contained numerous grammatical errors – including the misspelled word "proffesor."

In 2017, former Ukranian Prime Minister Arseniy Yatsenyuk was also accused of plagiarizing his dissertation.

Both followed Putin's model: Ignore the scandal and hope it will just go away.

It did. Yanukovych became president on his second try in 2010. Yatsenyuk remains one of Ukraine's leading politicians.

DON'T ASK ME ABOUT MY DEGREE

When asked about how they made their fortune, billionaires often cite Henry Ford's quip: "I am ready to account for any day in my life, but don't ask me how I made my first million."

The car manufacturer's bon mot hints at the shady – sometimes illicit – origins or great wealth.

For some European and Russian politicians – or even American college graduates – today, the modern equivalent might be, "Don't ask me how I earned my degree."

Cervical pre-cancer rates down 88% in decade since HPV vaccinations began – first findings

Cervical cancer is the third most common cancer among women in the UK under the age of 35 after breast and skin cancer. In the majority of cases, the cancer only develops if the patient is infected with human papillomavirus (HPV) types 16 or 18. This virus is mainly transmitted between people having vaginal, anal or oral sex. At some point in their lives, four in five people will be infected by HPV strains – as many as 14 can cause cancer in total. According to recent studies, other cancers heavily linked to HPV infections include head-and-neck, vulvo-vaginal and anal.

In an effort to reduce rates of cervical cancer, a number of countries launched immunisation programmes in the late 2000s, starting with Austria in 2006. The UK and its devolved governments launched a school immunisation programme in 2008 to vaccinate all girls aged 12-13. To speed up the time lag associated with achieving the benefits of vaccination, they also kicked off a three-year catch-up programme for girls aged up to 18 years.

A decade on, we are finally able to publish the first results. The data relates to Scotland, since it was cervically screening women from the age of 20 until 2016 – before falling into line with the minimum age of 25 used in the rest of the UK. This meant that Scotland obtained screening data for the 2008-09 cohort before the change in screening age. Scotland also has very detailed information about take-up rates, which have been very high: running to approximately 90% in Scotland for the routinely vaccinated girls and 65% for the older girls vaccinated as part of the catch-up programme.

For the first time, we can now confirm that the vaccination programme has begun to profoundly alter the prevalence of HPV 16 and 18 among Scottish women – and presumably elsewhere as well.

THE STUDY

My team performed an eight-year study of the women eligible for the Scottish national vaccination and cervical screening programmes. We looked at their vaccination status, year of birth, indicators of deprivation and whether they lived in urban or rural areas. Using complex statistical modelling, we were able to calculate the effect of vaccination on cervical pre-cancer. Though not all pre-cancer be-



comes cancer, all cancer requires pre-cancer. Cervical pre-cancer occurs quicker than cancer and therefore this focus has allowed us to see the impact of the vaccine earlier.

Among women born in 1995-96 – the first group to go through the regular vaccination programme in 2008/09 – there has been an 88% reduction in rates of cervical pre-cancer. This is a fall in incidence from 1.44% to 0.17%.

Not only that, women born in these years who had not received the vaccine were also less likely to develop cervical pre-cancer. This was because the high vaccine uptake meant that HPV incidence was much lower in their age group, thanks to a phenomenon known as "herd protection". This is particularly good news, since this group is also less likely to attend cervical screenings.

The findings clearly show that the routine HPV vaccination programme for girls aged 12 to 13 has been a resounding success. This is consistent with the fact that we have also seen a big fall in high-risk HPV infection in Scotland in recent years. The obvious conclusion is that we are going to see far fewer cases of cervical cancer in years to come.

From September, the UK is going to extend the vaccination programme to boys – becoming one of numerous countries to do so. This is in response to the fact that rates of head and neck cancer are rising in men: approximately 60% of head and neck cancer is associated with HPV16 infection, and should therefore be mostly preventable through vaccination. This programme should also mean that high-risk HPV infections among the population should be eliminated more quickly, which should have knock-on benefits for rates of HPV-driven cancers.

Meanwhile, in parts of Canada, HPV vaccinations are now being offered to uninfected women as part of the cervical screening process. This may protect older women from developing cervical cancer. This process may be adopted internationally, including the UK. When we look at the picture as a whole, eliminating the HPV virus, and making huge inroads into the various cancers that it helps develop, is now becoming a realistic possibility.

He said in the last five vears. Chief Minister Mamata Banerjee has showered Alipurduar, which was made a district from being a sub-division within Jalpaiguri district in 2014, with several projects including an university, medical college and an engineering college.

Tirkey, however, admitted that connectivity in remote areas of the district, which is crisscrossed by several rivers,

"Colleges and hospitals have come up, but getting there becomes a problem for us during monsoons. Overflowing rivers cut us off from the rest of the district. It is extremely difficult for us to get access to emergency medical aid and children cannot go to school," said Minati Oraon who lives in a small hamlet in Mahakalguri.

Five major rivers -Torsa, Kaljani, Raidak, Javanti and Sankosh apart from several smaller rivers and rivulets flow through Alipurduar.

Tirkey, a three-time RSP MLA from Kumargram assembly seat within Alipurduar Lok Sabha constituency, had joined the TMC and won in TMC ticket in the 2014 general elections.

With Leftist trade very strong among the tea garden workers, Alipurduar seat has been the citadel of Left Front constituent RSP from 1977 to 2014. In the 2014 elections,

TMC's Dasrath Tirkey won by 21,397 votes defeating Manohar Tirkey of the RSP, while the BJP came third. While Dasarath Tir-

key got 3,62,453 votes, RSP's Manohar Tirkey bagged 3.41.056 votes and BIP's B B Oraon polled 3,35,857 votes in 2014. The Congress stood fourth polling 1,16,118 votes.

RSP candidate Mili Roy said she was confident of wresting the seat from the TMC. "We take everybody together, we do not indulge in divisive politics as is being done by the others," she said.

Besides the TMC, the BJP, the RSP and the Congress, three other candidates - the SUCI and two Independents - are in the fray from the seat.

Gauhati HC imposes penalty on gym for 'discrimination' against person with disability

GUWAHATI, APR 7 (PTI): In a path-breaking judgement on making services accessible to persons with disabilities in the state, the Gauhati High Court has imposed penalties on a gym and the Assam government for discrimination against such a person.

Gauhati High Court Judge Ujjal Bhuyan, last petition filed by Arman Ali, Executive Director of National Centre for Promotion of Employment of Disabled (NCPEDP) People against inaccessible, disabled-unfriendly services by the gym.

According to the case history, Ali had applied for a membership with the gym in 2011. On realising his disability, the gym demanded as condition for membership doctors certificates from both his physician as

The gym also subjected him to a rigorous workout in an attempt to discourage him, during which he was also put through humiliation and ignominy by members of the staff and other users. Ali's petition stated.

"I was almost treated like an untouchable and they used all tactics to discourage me. The final straw was their offer of a month-long conditional membership with charges equivalent to an annual

Referring to the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act Rights of Persons with Disabilities Act 2016, which have equal opportunities and non-discrimination as its fulcrum. Justice Ujjal Bhuyan, in his order, also made a reference to Section 29 of the RPWD Act, which casts a duty on appropriate governments to conduct, encourage, support or promote awareness campaigns and sensitisation programmes to ensure RPWD were protected.

Justice Bhuyan also directed the Assam government to ensure that all officers and employees of the Social Welfare Department undergo training and awareness programmes and campaigns in terms of Section 39 of the 2016 Act in accordance with commissioner of persons with disabilities, Assam and Assam State Legal Services Authority.

Social Welfare Department, have further been instructed to issue general circular to all government and private establishments, highlighting the salient features of the 2016 Act and to ensure that public buildings and public facilities and services are made accessible to

Cash remains king for election campaign merchandise in Bengal



KOLKATA, APR 7 (PTI): The government's push for cashless transactions has apparently not made much impact on the trade of election campaign merchandise in Bengal, as currency notes remain the preferred payment mode for poll favourites, such as party flags and t-shirts.

Sale of campaign materials have picked up pace in the last one week, as the seven-phase Lok Sabha elections in the state kicks off from April 11, traders said.

"Much of the business is in cash this time as well," said a shopkeeper in the Burrabazar area, the biggest wholesale

market in eastern India.

The response was similar from other traders in the market, who pointed out that buyers through digital wallets and other online payment modes, as availability of cash has eased post demonetisation.

"For us, the mode of transaction remains cash, as it was in 2014. Cash is most convenient and helps buyers evade Election Commission's expenditure restrictions," another shopkeeper said.

Flags are a highly sought after merchandise among other poll materials like umbrella.

AGARTALA, APR 6 (PTI): The Tripura unit of the Congress has lodged a complaint with the Election Commission, seeking the immediate arrest of Chief Minister Biplab Kumar Deb for allegedly spreading communal hatred in the state.

Tripura Pradesh Conress vice-president Tapas Dey filed the complaint on Friday with Chief Electoral Officer (CEO) Sriram Taranikanti, accusing Deb of repeatedly making false statements with "a motive to divide communities in the state on the lines of caste, creed and religion".

Dey also called for the chief minister's immediate arrest.

The office of the CEO has confirmed receiving the complaint against the chief minister.

It was unbelievable, will cherish for long: Joseph on dream IPL debut HYDERABAD, APR (PTI): Young West Indian pacer Alzarri Joseph described his record-breaking bowling effort on his IPL debut as "unbelievable", saying he will cherish the moment for a long time to come. The soft-spoken Joseph (6/12) claimed the best bowling figures in IPL's history, bettering Sohail Tanvir's 6/14 registered in the inaugural edition in 2008. The previous best figures on IPL debut was Andrew Tye's 5/17,

"Unbelievable. It's a great start. I dont' think I could have asked for anything better. So I will really cherish this moment." said Ioseph at the post-match press conference after helping Mumbai Indians secure a 40run win over Sunrisers Hyderabad here on Saturday night. Defending a modest 136 for seven, Joseph wreaked havoc with the ball to bundle out Sunrisers for 96.

Joseph claimed the wickets of dangerman David Warner, Vijay Shankar, Deepak Hooda, Rashid Khan, Bhuvneshwar Kumar and Siddharth Kaul to hand Mumbai Indians their third win from five games. Asked what was going on his mind before his debut match, he said: "It was my first game. So I just wanted to go out and put all my effort into this team.

"The score doesn't really matter. I just go out and put my best foot forward. You get the information from the first ball so you know what variations you need to use."

Joseph said the Wankhede pitch was not the best one for shot-making and they believed in defending the modest total at the break.

"The pitch wasn't the easiest to play on, so 136 from 120 balls we knew we were in for a game if we take some early wickets," he said.

Stating that his sole aim is to help his side win the IPL crown, Joseph said he was happy to finish off things for Mumbai by claiming the last wicket of Kaul.

How CBSE helped students beat exam stress: Specialised audiovisual presentations, toll-free helpline

(PTI): Specialised audiovisual presentations on issues affecting youth, a toll-free helpline for students, an interactive voice response system - that is how the CBSE helped students counter the board exam stress this year.

According to the Central Board of Secondary Education public relations officer, Rama Sharma, as many as 12,000 calls were received on the interactive voice response (IVR) service, which was a new feature introduced this year.

Through the IVR system, students, parents or stakeholders can obtain pre-recorded useful information on tackling board exams which included tips for better preparation, time and stress management, frequently asked questions, along with live tele-coun-



selling services. With the introduction of the IVR system, the board saw a considerable decline on the calls received on the toll-free helpline in the first phase of counselling, which commenced on February 1 and ended on April 4. The second

phase will begin after the board results are declared.

The board had roped in a total of 87 counsellors, comprising 65 from India, two special educators and 22 from foreign schools. The helpline got more calls from students as compared to parents.

As many as 1,122 calls were received, with more boys (797) calling

up the helpline as com-

pared to girls (222).

The helpline also received more calls from students of private schools as compared to

government schools.

understand why, but it might be because the boys are a bit distracted and usually start preparing at the last-minute causing

them to stress more. Girls, on the other hand, are more organised when it comes to studies," another official said.

"Many a times, students used to call and say, 'Please talk to my parents. They are reprimanding me and pressurising me'. Students have even called up to say they are distracted and are not able to concentrate because they had a break-up," the other official said.

Some students even had suicidal thoughts and said they were "feeling like killing themselves" and some others even said they did not want to pursue a particular stream, but were being forced to do so by their parents. he said.

For the first time, a comprehensive audiovisual presentation titled 'Knowing Children Better' was prepared and uploaded on the CBSE's website and other social media platforms. The presentations were on issues like tackling exam anxiety, internet addiction, substance abuse, depression.

According to Sharma, the presentations received 75,000 hits on YouTube, while 92,000 views on Twitter with the presentation on tackling exam anxiety getting the maximum number views.

The board had also prepared a course compendium for students. The compendium of courses after class 12 was an earnest effort of the board to facilitate students while scouting for right course choices, the board had said.

The compendium featured traditional courses like engineering, chartered accountancy, medicine, while also details and eligibility criteria for unconventional subjects like how to become a detective, artificial intelligence, robotics, among others.

Middle-order woes for Sunrisers ahead of Kings XI clash

Hockey player's last wish triggers movement for organ donation in Canada

Canadian hockey player,
who died in a bus crash
caused by an Indian
truck driver, has become
an inspiration for a national movement for organ donation in the country. Deceased hockey player Logan Boulet's parents
have initiated a program
"Green Shirt Day" being
observed Sunday across
the country, to inspire
people to donate organs

and help the life of others.

Boulet had signed for his organ donation long before he died in an accident last year that killed 16 people after a Saskatchewan hockey team's bus collided with a truck driven by a non-resident Indian Jaskirat Singh Sidhu of Calgary.

Sidhu was sentenced last month to eight years in prison for dangerous driving causing death and bodily injury. The player's parents, Toby and Bernadine Boulet, are spreading the message of how their son's decision helped the lives of others and how he has inspired hundreds of thousands of Canadians to become organ donors.

They are conducting the first annual "Green Shirt Day in partnership with Canada's Organ Donation Community.

Support for organ donation in Canada is at roughly 90 per cent, but only 23 per cent of Canadians are registered organ donors. According to Canadian Transplant Association President Brenda Brown nothing like the Logan Boulet Effect has been seen before in Canadian history and raising more awareness will hopefully raise this percentage. A memorial service is also being held to mark one year since the tragedy.

Up against 179 farmers, Kavitha says she has full faith in the community

NIZAMABAD, APR 7 (PTI): Sitting TRS MP K Kavitha, daughter of Telangana Chief Minister K Chandrashekar Rao, is up against 179 farmers who are contesting en masse, but she is not ruffled as she confidently says, "I have full faith in my farmers."

The 179 farmers entered the fray for the April 11 Lok Sabha elections as a mark of protest, alleging that the ruling Telangana Rashtra Samithi (TRS) had failed to ensure Minimum Support Price for turmeric and red jowar (sorghum) produce and in getting the Turmeric Board established in Nizamabad.

There are a total of 185 candidates in the seat, prompting the Election Commission to arrange for jumbo EVMs.

Kavitha says the farmers who are protesting and contesting are supporters of the BJP and the Congress. "Let them be in the fray."

Farmers in general, she says, are benefiting from the state's welfare schemes like Rythu Bandhu.

Asked if she is tensed with farmers contesting en masse, Kavitha replies, "Not at all, wait till results. You will get to know."



She says the TRS swept recent assembly polls and will win handsomely in the Lok Sabha polls as well. "Out out 17 parliamentary constituencies, we will win 16 while AIMIM will bag one seat," she claims.

She has been addressing rallies and is determined to visit all 40 blocks that comprise 800-odd villages in the constituency.

Kavitha, who has two kids, says it has been more than a week since she has seen them. "When I was leaving home, I told them I will be busy with elections and won't be available for the next 20 days. They said you will win anyway, so why do you want to go," she says.

Though none in the family has lost elections so far barring once, Kavitha says "nothing comes easy".

After polling, she says, she has another exam -- "that of my son. I have to be with him."

Asked about her father's assessment of national politics, she says, "Honestly, we haven't talked for the last 15 days as I am in

my constituency. But he believes that the development agenda of this nation needs to change."

Political parties should start taking their manifestos seriously and implement all promises," she says, adding that her father, as chief minister, has given "a decent shot" at implementing the promises he made in the assembly poll.

Citing an example, she says, "We were able to fix the electricity crisis in the state within six months. If it is possible in Telangana, it is possible across the country. Right now, we are producing more power than the nation. But we are not able to efficiently distribute it. Tall leaders talk about villages without power till now, which actually looks pretty bad in the global scenario," she adds.

Asked if the 100-odd welfare schemes are putting pressure on the state exchequer, she says, "It is a wrong thought. Our chief minister's idea is to create more wealth. Economists talk about minimising spending, but don't talk about wealth creation. Our government believes in creating more wealth and distributing it to the poor."


after vote JERUSALEM, APR 7 (AFP): Israeli Prime Minister Benjamin Netanyahu pledged Saturday to annex settlements in the occupied West Bank if he wins the upcoming general election. His comments come just days before the closely-fought April 9 poll and could be seen as an appeal to rightwing voters, who do not believe in the feasibility of a peace agreement with the Palestinians. "I will apply (Israeli) sovereignty, but I don't distinguish between settlement blocs and isolated settlements," he said in an interview with Channel 12 television.

Settlements built on land occupied by Israel in the 1967 Six-Day War are deemed illegal by the international community and their ongoing construction is seen as a major barrier to peace.

Annexation prove to be the death knell for the two-state solution. Senior Palestinian official Saeb Erekat said Netanvahu's statement on annexation was "not surprising." "Israel will continue to brazenly violate international law for as long as the international community will continue to reward Israel with impunity, particularly with the Trump administration's support," he said on Twitter.




