Mass Covid testing drive at Namthang

NAMCHI, 22 JUL (IPR): A COVID-19 mass testing drive was held at various places under Namthang today. The team from Namthang Primary Health Centre led by Medical Officer, Incharge, Namthang PHC, Dr Mingyur D Lassopa, Dental Surgeons: Dr Sushmita Chettri and Dr Ayesha Chettri collected RT-PCR samples and did RAT as well. In Upper and Lower Passi villages under Rateypani Gram Panchayat Unit a total of 17 RATs were conducted out of which 14 were detected as positive whereas 209 RT-PCR samples were collected.

At khorlang village under Tanzi-Bikmat Gram Panchayat Unit the team collected a total of 14 RT-PCR samples. They also did 04 RATs out of which 03 people were detected as positive.

Overall the team today collected a total of 223 RT-PCR samples and conducted 23 Rapid Antigen Tests of which two were done at Namthang Primary Health Centre and one person was detected positive.

41,383 fresh Covid cases in India, marginally lower than vesterday

New Delhi, 22 Jul [NDTV]: India added 41,383 new coronavirus cases over the last 24 hours while deaths from COVID-19 rose by 507. The country's overall case load now stands at 3.12 crore, while total fatalities are at 4.18 lakh, according to the health ministry.

India's test positivity rate (positive cases identified for every 100 tests) continues to decline. For the 31st straight day it is below the 5 per cent-mark at 2.12 per cent.

About 2,224 active cases were reported in the last 24 hours to take the tally to 4.09 lakh. About 3.04 crore people have recovered across the country so far, taking the recovery rate to 97.35%. Over 20 lakh vaccine doses were administered in the last 24 hours. The total doses administered in the country have exceeded 41.76 crore so far, the health ministry said.

Kerala contributed 17,481 cases to the country's daily numbers. It was followed by Maharashtra (8,159 cases).


For the first time, three different variants of CO-VID-19 - Delta, Alpha and Beta - have been detected among 75 coronavirus cases in Mizoram, health officials said. The samples were sent for genome sequencing to the National Institute of Biomedical Genomics (NIBMG), Kalyani in West Bengal in June this year.

Sikkim records 250+ new cases for second consecutive day, week's count 1000+ already

SUMMIT REPORT GANGTOK, 22 JUL:

Cikkim registered 250+ new **J**cases for the second consecutive day today and for the third time in the past four days when 294 fresh cases of Covid-19 were confirmed in data released by the Integrated Disease Surveillance Programme of the Health Department this morning. The State had recorded 251 new cases on 21 July, 147 on 20 July and 257 on 19 July. Before this, the last time that Sikkim had breached the 250-mark was on 10 June, 2021 when 287 new cases had been reported.

Since Sunday, Sikkim has picked up 1,104 new cases of Covid and seen seven more deaths. A total of 5,881 tests have been conducted since 18 July giving an average test positivity rate of nearly 19% for the five days in question.



As per the Daily Report of Covid-19 in Sikkim released by the IDSP cell, the 294 new cases were detected from the screening of 1,658 samples

daily case positivity rate of 17.70% for the past 24 hours. Sikkim's tally of confirmed cases of COVID-19 now stands at 24,341.

Out of the 294 new cases, yesterday, giving Sikkim a 139 were registered in East

District, 47 in West District, 90 in South District and 18 in North District.

In the meantime, Sikkim's Covid toll increased to 328 with two more COVID deaths reported from STNM hospital.

Of the new cases, 172 were found in RT-PCR testing of 979 samples while 119 people tested positive for COVID-19 in rapid antigen three more cases were detected in TruNat testing of nine samples.

While the number of new cases was close to 300, hospitals here saw only 10 more admissions with the rest apparently with symptoms mild enough not to require hospitalization.

Of the 2,719 active cases of Covid in the State at present, only 104 are in hospital and the rest are recuperating under home or facility isolation. Eleven of the COVID patients in hospital are currently admitted in ICU.

On the other hand, Sikkim's count of recovered cases crossed the 21,000-mark today and stands at 21,030 with 189 COVID patients making full recoveries in the last 24 hours and returning to their regular lives.

Dalai Lama's advisers were on list of potential Pegasus targets: Report

NEW DELHI, 22 JUL [NDTV]:

The closest advisers of the Tibetan spiritual leader, the Dalai Lama, have been found on the list of potential surveillance targets with the Israeli spyware Pegasus that is only sold to governments, news website The Wire reported on Thursday.

Phone numbers of staff of other Buddhist clerics, several Tibetan officials and activists were also found on a leaked database that showed they had been marked for being monitored from late 2017 to early 2019, the publica-

The inclusion of their phone numbers, however, may not mean that they have been infected by Pegasus, as that can only be confirmed through forensic analysis of the device, it added.

Congress leader Rahul Gandhi, political strategist Prashant Kishor, Union Ministers and dozens of journalists were found on the list of targets earlier this week in the scandal that has been dubbed "bigger than Watergate" by the opposition and strenuously dismissed by the government.

According to The Wire, the first records of surveillance on those around the Dalai Lama relate to the staff of the 17th Gyalwang Karmapa, Urgyen Trinley Dorji, the highest-ranking monk in Tibetan Buddhism, who had been living outside India since early 2017.

The Karmapa, who fled to India in 2000 as a teenager, has had a testy relationship with the Indian intelligence community; In March 2018,

he obtained a Dominican passport, unbeknownst to India, the news website reported. The Dalai Lama's long-term envoy in New Delhi, Tempa Tsering, who is currently the di-

rector, India and East Asia, Office of His Holiness the Dalai Lama in New Delhi, also appears on the list, it said. During the period when the phones were selected for surveillance, the Dalai Lama had met

with former US President Barack Obama in Delhi and India's relationship with China was just recovering following the Doklam crisis.

"Other names in the database are of senior aides Tenzin Taklha and Chimmey Rigzen. The head of the trust that will oversee the delicate task of selecting the next Dalai Lama, Samdhong Rinpoche, was also inserted in the list in mid-2018," The Wire reported.

The records also include the phone numbers of the head of the then Tibetan government in exile, Lobsang Sangay, and several other Tibetan activists in India, it said.

The Wire is among 17 media organisations that are publishing the investigation that says Pegasus had been used in attempted or successful hacks smartphones using malware that enables the extraction of messages, records calls and secretly activates microphones.

The maker of the spyware NSO, which has said it sells its spyware to only "vetted governments", has rejected the reports as "full of wrong assumptions and uncorroborated theories". NDTV has not independently verified the reporting.

Centre refutes Covid death undercounting allegations

NEW DELHI, 22 JUL [PIB]: There have been some recent media reports alleging that India's toll of excess deaths during the pandemic could be in millions, terming the official COVID-19 death toll as 'vastly undercounted'.

In these news reports quoting findings from some recent studies, US & European countries' age-specific infection fatality rates have been used to calculate excess deaths in India based on the sero-positivity. The extrapolation of deaths has been done on an audacious assumption that the likelihood of any given infected person dying is the same across countries, dismissing the interplay between various direct & indirect factors such as race, ethnicity, genomic constitution of a population, previous exposure levels to other diseases and the associated immunity developed in that population.

Furthermore, the seroprevalence studies are not only used to guide strategy and measures to further prevent the spread of infection to the

also used as another basis to extrapolate deaths. The studies also have another potential concern that the antibody titers may diminish over time, leading to underestimation of true prevalence and corresponding overestimation of Infection Fatality Rate. Further, the reports assume that all the excess mortality figures are COVID deaths, which is not based on facts and totally fallacious. Excess mortality is a term used to describe an all-cause mortality figure and attributing these deaths to CO-VID-19 is completely mislead-

India has a thorough contact tracing strategy. All the primary contacts, whether symptomatic or asymptomatic are tested for COVID-19. The true detected cases are the ones that test positive with RT PCR, which is the gold standard of COVID-19 test. In addition to the contacts, given the vast availability of more than 2700 testing laboratories in the country, anyone who wants

test done. This coupled with vast IEC about the symptoms and access to medical care has ensured people could reach out to hospitals in case of need.

Given the robust and statute based Death Registration System in India, while some cases could go undetected as per the principles of Infectious Disease and its management, missing out on the deaths is unlikely. This could also be seen in the case fatality rate, which, as on 31st December 2020, stood at 1.45% and even after an unexpected surge observed in the second wave in April-May 2021, the case fatality rate today stands at 1.34%.

Moreover, the reporting of daily new cases and deaths in India follows a bottom-up approach, where districts report the number of cases & deaths to the State Governments and to the Union Ministry on a continuous basis. As early as May 2020, to avoid inconsistency or confusion in the number of deaths being

vulnerable population but are to get tested is able to get the reported, Indian Council of Medical Research (ICMR) issued 'Guidance for appropriate recording of COVID-19 related deaths in India' for correct recording of all deaths by States/ UTs as per ICD-10 codes recommended by WHO for mortality coding.

In his statement in Rajya Sabha yesterday, Shri Mansukh Mandaviya, Union Minister of Health & Family Welfare has refuted allegations of hiding COVID-19 deaths and said that the Central government only compiles and publishes data sent by the state governments.

The Union Health Ministry has been repeatedly advising States and UTs through formal communications, multiple video conferences and through deployment of Central teams for recording of deaths in accordance with laid down guidelines. The Health Ministry has also regularly emphasized the need for a robust reporting mechanism for monitoring district wise cases and deaths on a daily basis. States have been advised to conduct thorough audits in their hospitals and report any cases or deaths that could have been missed with a district and date-wise details so as to guide a data-driven decision making. During the peak of the 2nd wave, the entire health system was focused on effective clinical management of cases requiring medical help, and correct reporting & recording could have been compromised which is also evident in a few states such as Maharashtra, Bihar & Madhya Pradesh reconciling their number of deaths recently.

In addition to this reporting, the robustness of statute based Civil Registration System (CRS) ensures all the births and deaths in the country get registered. The CRS follows process of data collection, cleaning, collating and publishing the numbers, which although is a long time-consuming process, but ensures no deaths are missed out. For the expanse and the amplitude of the activity, the numbers are usually published the next year.

The sources claimed the raids were based on "conclusive evidence of tax fraud" by the channel. Bharat Samachar's recent reporting has been critical of the UP govern-

Woman briefly arrested for WhatsApp post to "gift" beef to Himanta Sarma

Guwahati, 22 Jul [PTI]: A woman from a village in Assam's Nalbari district was briefly arrested for allegedly uploading an "objectionable post", proposing to "gift" cow meat to state Chief Minister Himanta Biswa Sarma, said the police.

"Yesterday a girl up-'objectionable post' in her WhatsApp status. We have registered a case and arrested her. Later she was released on bail because it was a bailable offence," a top police official said.

It is the first such case of arrest after the state government tabled the cal BJP leader. Assam Cattle Preservation Act, 2021, to regulate illegal transportation of cattle and sale of beef in Assam. The Bill also proposes to forbid sale and purchase of beef in places predominantly inhabited by Hindu, Jain, Sikh and other non-beef eating communities or within a radius of 5 km of any temple.

Fake invoicing racket of 338 Crore busted in Assam, 2 arrested

GUWAHATI, [NDTV]: A whopping 2 338 crore racket of fake invoicing has been unearthed by GST officials in a major bust of tax evasion scam in Assam.

According to a media statement, the Directorate General of GST Intelligence (DGGI), Guwahati Zonal Unit, said that a city-based businessman and a tax consultant were behind the scam.

The Additional General (ADG) of GST Intelligence in Guwahati Unit said Amit Kumar, owner of Maruti and tax consultant Sourav Bajoria have been arrested under several sections of the GST act.

The duo had also generated fake credit of Input tax (TTC) involving 2 28.97 crores of GST.

"Amit Kumar, was engaged in receipt and issuance of fake invoices of coal. The firm showed purchase of coal from Gujarat, Punjab and Delhi to his Guwahati unit to avail input tax credit (ITC) The unit subsequently issued invoices

to cement manufacturers, coke manufacturers, and other traders etc in

northeast without supply of any goods. The fake invoices/bills of coal by the firm were used as cover document for the coal procured clandestinely and to pass on irregular ITC," the ADG said.

He also added that Amit Kumar had created two more fake entities by the same name Maruti Traders at Ludhiana and Gandhidham and showed business

"This huge racket of fake invoicing involved other firms in Delhi, Punjab and Gujarat which were found to be nonexisting," the official said. On the role of the tax

consultant the top official said, "He (Sourav Bajoria) colluded with Amit Kumar and caused the commission of the fraud. He was instrumental in dealing with trans-

actions for Amit. Sourav maintained the books of accounts, prepared the Financial Accounts and got the account audited and filed the GST returns pertaining to M/s Maruti Traders of Guwahati, Gujarat and Ludhiana which turned out to be non-existent entities

during search."

Both the accused have been produced before the Chief Judicial Magistrate, Kamrup Metro and sent to 14 days judicial custody.

Covid may have claimed as many as 50 lakh lives in India: Experts

NEW DELHI, 22 JUL [NDTV]: actual death count from Covid-19 could range between 1.3 million to a staggering 5 million, with even the most conservative estimate putting its tally at more than double the U.S., the highest recorded in the world so far.

The numbers, derived from research models and local authority data, range from three to 10 times the country's official count, adding to evidence that the true cost of the outbreak has been massively underreported.

As corpses floated in the Ganges, a river sacred to millions of Hindus, and crematoriums and graveyards were overwhelmed, skepticism grew over the death toll of around 420,000 recorded by Prime Minister Narendra Modi's government, which has used the ostensibly low mortality rate to defend Covid track record.

Bloomberg proached authorities in about half of 28 states and territories seeking death data from April and May for the last two years and analyzed figures from researchers and experts. The result is clear: the real toll has been vastly underestimated because of a combination of under-counting, a backlog in the civil registration system and a lack of testing leading to Covid deaths being classified as other conditions like heart disease. The findings dovetail with estimates from researchers around the world. Bhramar Mukherjee, a professor at the School of Public Health at the University of Michigan, has devoted much of the past year to modeling pandemic. Her studies suggest the death toll is around 1.3 million up to June 15.

Rukmini S, a leading data journalist, has written that the numbers she's gathered suggest a death toll closer to 2.5 million.

A report from the Washington-based Center for Global Development think tank released Tuesday studied data from three different sources, finding that excess deaths - a term public health experts use to describe mortality from all causes during a crisis that is above what would have been expected in 'normal' conditions - likely ranged between 3.4 million to 4.9

"Regardless of source estimate, actual deaths during the Covid pandemic are likely to have been an order of magnitude greater than the official count," said the report, co-authored by Arvind Subramanian, former chief economic adviser to the government and two other researchers. "True deaths are likely to be in the several millions, not hundreds of thousands, making this arguably India's worst human tragedy since partition and independence."

The federal Health Ministry in a July 14 press release called media reports on higher Covid death counts "speculative." Health Minister Mansukh Mandaviya told Parliament Tuesday that "detailed guidelines for reporting of deaths have been issued by Union Health Ministry to all states and union territories." The ministry did not respond to written ques-

tions from Bloomberg. Despite widespread reporting on oxygen shortages across India as the second wave of infections hit the country in April and May, the minister added that "no deaths due to lack of oxygen has been specifically reported" by local governments.

The states of Tamil Nadu, Karnataka, Kerala and Odisha combined have close to 300,000 excess deaths in the six months to June, according to all-cause mortality numbers analyzed by Bloomberg - more than 5.5 times their official Covid death data of about

That already represents three-quarters of the official toll, though they are just four among 28 states and territories and 17% of the nation's 1.4 billion people.

State government officials say in most cases that people who had not been tested or had tested negative - but showed coronavirus symptoms - were not counted in the official toll. In rural areas, many people went untested, untreated and ultimately uncounted, contrary to federal government guidelines. At least six states did not respond to requests for allcause death data.

BJP welcomes domicile grant to J-K women married outside

JAMMU, JUL 21 (PTI): The BJP's Jammu and Kashmir unit on Wednesday welcomed the decision of domicile grant to native women married outside the Union Territory.

In a significant move, the Jammu and Kashmir administration on Tuesday had announced that it would issue a domicile certificate to the husband of a native woman.

"The NC, PDP and the Congress had been selling dreams of all sorts to people of Jammu and Kashmir since the past so many decades," J-K BJP president Ravinder Raina said.

"It was ironic to see that secessionist leaders who had married women from outside the country, including Pakistan, had ensured state subject rights and status for them. But daughters of Jammu and Kashmir who were marrying people within India but outside the UT were losing all the rights in J-K," he said.

The Union Cabinet in 2020 had approved the Jammu and Kashmir (Adaptation of State Laws) Second Order, 2020 issued under section 96 of the Jammu and Kashmir Reorganisation Act, 2019.

"We welcome the passage of J-K (adaptation of state laws) second order 2020, which seeks to grant domicile status to husbands of J-K women married outside," Raina said.

With the enactment of the Jammu and Kashmir Reorganisation Act,

the idea of 'Ek Bharat Shreshtha Bharat' has been put into play, he said.

"All such anti-women. anti-youth, anti-people laws and arrangements have been put beneath the carpet. The families of women marrying outside have been made eligible for domicile status. This marks another milestone post August 5, 2019 in J-K history and the people of J-K, especially women, are upbeat and in high spirits," he

Raina expressed his sincerest thanks to the central government led by Prime Minister Narendra Modi as well the UT dispensation led by Lieutenant Governor Manoj

Mamata Banerjee explains Khela Diwas date after BIP attack

NEW DELHI, 22 JUL [NDTV]: West Bengal Chief Minister Mamata Banerjee today said she had chosen the date August 16 to observe Khela Diwas or Day of Sport as a mark of respect to sixteen football fans who died in a stampede during a football match on this day in 1980 at Kolkata's Eden Garden stadium.

Yesterday, in her annual Trinamool Martyrs' Day speech delivered virtually, she said she wanted to commemorate the slogan and the spirit it symbolised on this day. Coined by a young party leader, the slogan became an anthem in the Assembly poll campaign.

But today's explanation on why August 16 was chosen was possibly a response to criticism of her choice of date by Rajya Sabha MP Swapan Dasgupta, known to be close to the BJP.

Mr Dasgupta had yesterday tweeted that August 16 was the day the Muslim League launched its Direct-Action Day in 1946 that triggered the great Calcutta killings -communal riots in which many lives were lost.

"In today's West Bengal, Khela Hobe has come to symbolise a wave of terror attacks on opponents. Interesting Mamata Banerjee has declared



August 16 as Khela Hobe Diwas," he said.

His tweet reinforced BJP claims of widespread post-poll violence in Bengal. The matter is in fact currently in Calcutta High Court.

"16 August used to be commemorated by many sporting clubs earlier. But that is dying out now. That's why we have chosen to mark Khela Hobe Diwas on August 16," Ms Banerjee said.

"In the coming days, Khela Hobe indeed. To protect civilization and culture, sports, the sporting spirit is very important. Those who are misinterpreting don't understand that spirit," Ms Banerjee said, adding, "Khela Hobe has become a theme across India. We are happy about that. So, we have fixed a day to celebrate the spirit."

On 16 August this year, the state's sports and youth department will distribute one lakh footballs to sporting clubs across the state. 283 clubs of the Indian Football Association will get 10 footballs each. The rest will go to clubs in villages.

"50,000 'joyee' footballs have already been made by our mothers and sisters," the Chief Minister said. "Joyee" is the brand name of footballs being made by an NGO run by former footballers.

August 16 is also a day after Independence Day. "But our freedoms are being threatened today. We need to defend that. We need to fight for freedom of speech," Ms Banerjee added.

Yesterday, in Martyrs Day speech, Ms Banerjee had attacked the BJP and said, "Khela Hobe in many states and will continue till the BJP is ousted from power in the country."

6,000 stranded as Konkan Rail route disrupted due to heavy rain

MUMBAI, 22 JUL [PTI]: vices in this section are Nearly 6,000 passengers were stranded as train services on the Konkan Railway route in Maharashtra's Ratnagiri district were suspended on Thursday after a river overflowed following heavy rains in the area, officials said.

So far, nine trains have been regulated due to disruption of services on the route, they said.

Regulating trains means they have been either rerouted, shortterminated or cancelled.

Konkan Railway officals said these trains were at safe locations on different stations and the passengers in them were also safe and they were being provided food and water.

Water level at the Vashishti river bridge between Chiplun and Kamathe stations in Ratnagiri has risen above the danger mark after the heavy downpour, an official said.

"In view of the safety of passengers, train sersuspended temporarily," he said.

According to rail officials, 5,500-6,000 passengers were stranded in trains which were regulated at various stations on the Konkan Railway route.

The Konkan Railway informed that due to the flood situation at Chiplun, so far nine long distance trains have been regulated.

Out of these, the Dadar-Sawantwadi special train was regulated at Chiplun station and the CSMT-Madgaon Janshatabdi special train at Khed station.

Konkan Railway spokesperson Girish Karandikar said passengers in these trains were

Despite several challenges, the Konkan Railway was providing food and water to the stranded passengers, he said.

"We have made arrangements to provide tea, snacks and water to all the stranded passengers," Karandikar said.

This is the second disruption on the Konkan Railway route in the last few days. On July 19, train ser-

vices on the route were suspended for a day due to seepage of water in the Old Goa tunnel near Panaji. The Konkan Railway

has a 756-km-long track from Roha near Mumbai to Thokur, located close to Mangaluru.

The route, spread across three states- Maharashtra, Goa and Karnataka - is one of the challenging terrains, as it consists of many rivers, gorges and mountains. Train services of the

Central Railway in the Kasara Ghat section of Maharashtra's Thane district and near Lonavala hill town in Pune district adjoining Mumbai were also severely affected on Thursday after heavy rains caused flooding, washing out of tracks, boulder crashes and mudslides in that region, officials said.

The Challenges of **Being Local**

Protections require deeper understanding, more empathy

N ow that some public interest has been generated on local-nonlocal issues and the issues of belonging to Sikkim, the State should discuss the issue threadbare.

The Local-Nonlocal issue is an easy divide to tease; something that lazy politicians and even lazier agent provocateurs are wont to tickle often and whenever they feel the need to be noticed. With an election cycle arrive times of irrationally high aspirations, inflated senses of entitlement and shrinking opportunities, a refusal to share becomes an easy position to adopt. And while one may wish for society to be more open and accommodating, a refusal to be so, while unhealthy, is not necessarily illegal or unconstitutional. What is worrying however is when the public domain becomes occupied by voices which mistake protection to mean an exclusive club put together at the cost of denying others. For them, even some basic courtesies extended to those outside the club tantamount to dilution, and because those who understand the issues better do not speak up, noise routinely blanks out reason whenever such situations arise.

One sees such insular positions taken on a routine basis in locations as diverse as North India and the North East Region and even South of the Vindhyas where the local-nonlocal argument often collapses into violence. Most other times, it simmers below the surface, bubbling occasionally with distasteful remarks and inexcusably accepted offensive stereotyping. It is disturbing to see what appear to be sane, "educated," mature and informed voices try and justify expressions of hate, but when appeals are made based on the belongingness of a people, such positions become difficult to avoid, even for the sane, educated, mature and the informed. Admittedly, irrational positions and shallow nationalism are not rare outpourings even in Sikkim, but the State has thus far been spared the ugliness of the more aggressive posturing or even sabre-rattling beyond the limited circulation of press conferences or the slightly wider, but socially limited, network of social media.

There is never room for complacency though because issues have a habit of occasionally growing unexpectedly big in Sikkim – the protest by truck drivers, the Rule 4(4) protection movement and the college students' showdown in recent years for instance. Hence, it is advisable that the divisive Frankenstein of local-nonlocal positioning is not allowed to grow any larger in Sikkim. The best way to do this would be to address all related issues in an open manner. To begin with, Sikkim should also realise that in the issues related to Residential Certificates, the groups receiving these documents are nonlocal only as far as their status on official documents in concerned, as far as the social milieu is concerned, they have been part of the local mix for more than five decades now and widely accepted as such. What is also apparent is that they will not be claiming anything which is exclusively protected for the Sikkim Subjects and are essentially being extended gestures which allow them a more dignified access to rights they already enjoy.

But let us leave what privileges accrue to whom and whose share gets compromised for a later debate, for now, let's extend the need for Sikkim to leverage such debates to discuss more issues more extensively and more openly. The quickness with which the Merger happened in 1975 and the short-sightedness with which several rules were drawn up and put into practice have led to situations which extend beyond just the demarcation of locals and non-locals in Sikkim. There is a staggered segregation even among the "locals" with official government notifications drawing up to five categories of people who can be issued Certificates of Identification and among these five categories are three groups which enjoy different levels of privileges even though they are all "Sikkimese". Complicating matters further are existing ambiguities and nonexistent guidelines for officials on who is to be certified as what and for what purpose in Sikkim. Added to this whole mix is the literal interpretations of the English in rules, something which the grandchildren of non-locals who were in service of the Sikkim Government on or before 31 December, 1961 were shell-shocked by and what will cause dismay to the great grandchildren of Sikkim Subjects in less than a decade.

Too many complications have become rather vexed because they remained unaddressed for too long. Now, a situation has been created which has opened an opportunity to untangle the confusions. All that will be required will be for everyone to seek out transparency, fair-play and open minds. Invest these to the public debate and this will not be a very difficult problem to solve. And the "locals" will have to take the lead in opening such dialogues for it to have any durable results...

Study finds lower antibody activity against delta variant at single dose – but vaccines still work

hris Whitty, the chief medical officer for Eng-■land, recently announced that the delta variant is no longer of concern because it now comprises 98% of new cases in the country and is therefore "the normal variant".

This virus has spread to at least 90 countries and is 50% more transmissible than the alpha variant (the variant first identified in Kent), which is around 50% more transmissible than the original coronavirus that caused the pandemic.

With cases rising exponentially and restrictions lifted, it is important to understand how well the vaccines are faring against the delta variant.

A new study from the Pasteur Institute in France found that the delta variant is less sensitive to neutralising antibodies (the Y-shaped proteins that latch onto the coronavirus and stop it from entering our cells). The researchers compared three "variants of concern" – alpha, beta and delta – for their sensitivity to different sets of antibodies:

antibodies used as drugs to treat people with COVID (monoclonals)

antibodies from infected people six months after they recovered

antibodies from vaccinated people who were previously infected

antibodies from vaccinated people who had not been infected.

Monoclonal antibodies are engineered by pharmaceutical companies to target a single part of the spike protein. The researchers used four of these monoclonals to test the different viruses. The alpha variant continued to be neutralised by all four monoclonals. And the delta variant was neutralised

by three out of four. But the beta variant, which is known to be the most difficult to neutralise, had lost sensitivity to two out of four monoclonals.

Thankfully, our immune system makes a remarkable array of antibodies against different parts of the virus proteins. This is known as a "polyclonal response". Do these polyclonal antibodies contain neutralising antibodies that prevent delta variant

To find out, the researchers drew blood from a small group (56 people) six months after they recovered from COVID. They found a four to sixfold reduction in the neutralisation of the beta and delta variants compared with the alpha variant. This does not mean that people are more susceptible to infection with the new variants; immune protection is not merely defined by antibodies. However, it does mean that the beta and delta variants are sufficiently different from previous viruses to affect the immune response.

Encouragingly, when previously infected people were vaccinated (Pfizer, AstraZeneca or Moderna vaccines), they all showed an increase in neutralising antibodies against all three variants. A single dose of vaccine was enough to boost neutralising responses to the delta variant.

These findings chime with recent work from the University of Oxford and Public Health England (PHE), and with studies that have yet to be pub-

The results were not so encouraging for those who received one dose of vaccine in the absence of a previous infection. The Oxford group reported that a single dose of vaccination conferred poor neutralising antibodies against the delta variant. This was also the case in the French study for both Pfizer and Astra-Zeneca vaccines at ten weeks after vaccination.

Both peer-reviewed studies showed that booster vaccinations had the desired effect of increasing neutralisation against the delta variant, albeit at lower efficacy compared with the alpha variant.

WHAT IT MEANS FOR IMMUNE PROTECTION

These studies show that our vaccines are still effective against these variants. Further data from PHE and from a Canadian study that awaits peer review show substantial vaccine-induced antibody activity against the delta variant.

In real-life terms, there is a significant reduction in hospitalisations and deaths due to COVID in the UK this summer, compared with similar rising cases last autumn.

The advanced UK vaccination rollout is sparing us the severe effect of the fast-spreading delta variant, so far. But will we be spared thousands of new long-COVID sufferers in the aftermath of the rising infections? Scientists don't yet know the effect of vaccines on preventing long COVID, but it is known that mild infection can lead to long COVID.

Vaccine coverage in the UK and worldwide is not enough to achieve herd immunity, which is important to protect those who can't be vaccinated. Under the circumstances, we need to curb transmission to prevent further variant mutations from incapacitating the vaccines.

Continuing surveillance of our antibodies' effectiveness against new variants is critical to determine when we need further booster vaccinations and when we need to update our vaccines. As schools are closing and many of us are getting ready for our summer holidays, it is important to continue to take sensible precautions and ensure that our vaccines remain effective for longer.

Alt goes mainstream: how surfing, skateboarding, **BMX and sport climbing became Olympic events**

The Tokyo Olympics will be novel Chloe Kim have continued to inspire **■** in more ways than one. Aside from the challenges of mounting the games during a pandemic, there will also be a range of new sports competing for fans' attention.

As well as baseball/softball (being reintroduced after a 12-year hiatus), karate, and basketball 3x3, four youth-focused action sports will debut: surfing, skateboarding, sport climbing and BMX freestyle.

According to the International Olympic Committee (IOC), the inclusion of these new events is "the most comprehensive evolution of the Olympic program in modern history".

For many fans, however, the addition of action sports raises big questions: are they really Olympic sports, and do they deserve to take the place of more established events?

COMPETITION FOR YOUNGER FANS Our research shows the process

and politics behind this decision go back over 20 years, part of the IOC's big goal of making the Olympics more attractive to younger spectators.

While the Summer Olympics are considered the most-watched sporting spectacle in the world, the numbers of young viewers have been declining for decades. The median age of the US TV audience for the 2016 Rio Games was 53.

Aware of this, the IOC has tried to attract younger audiences by incorporating newer action sports in both the summer (windsurfing, mountain biking, BMX racing) and winter (ski cross, big air) Olympic programs.

Since its controversial inclusion in the 1998 Nagano Winter Olympics, snowboarding has become the darling of the winter games. With X Games-inspired presentation and youth cultural icons such as Shaun White and Torah Bright, snowboarding was credited with a 48% increase

in 18- to 24-year-old viewers at the 2010 Winter Olympics.

Since then, a new generation of young, cool snowboarders such as and attract global audiences.

That success is driving the inclusion of more action sports at the Summer Games. But the IOC has also pursued other key initiatives, such as the Youth Olympic Games and an Olympics YouTube channel.

Since 2010, the Youth Olympics have been an important testing ground for new sports, social media innovation and concepts like the Sports Lab in Nanjing in 2014, and the Urban Park in Buenos Aires in 2018. Not everything makes it past the trial stage, but much does.

AGENDA 2020 AND THE NEW VI-

The arrival of IOC President Thomas Bach in 2013 and introduction of the Agenda 2020 policy accelerated the modernising process.

In 2015, the IOC worked with the Tokyo Organising Committee to shortlist five new sports - karate, baseball/softball, surfing, skateboarding, and sport climbing - for possible inclusion in the 2020 games. When all five were confirmed for Tokyo, Bach proclaimed:

"We want to take sport to the youth [...] With the many options that young people have, we cannot expect any more that they will come automatically to us — we have to go to them."

Following a review to measure the overall performance of all sports, various international federations developed strategies to become more youthfriendly. The International Cycling Union approved BMX freestyle, and the International Basketball Federation added basketball 3x3 for Tokyo.

This pressure to attract younger fans has had a knock-on effect, with other sporting bodies wanting to bring new events into the fold. The current battle over the possible

NOSTALGIA AND PROGRESS

With the action sport economy plateauing, many in the industry have actively supported Olympic inclusion. But the countercultural heritage of many of these sports has led to tensions.

Many participants view them nostalgically as alternative lifestyles rather than conventional sports. The associated value systems they celebrate - self-expression, creativity, fun are often considered at odds with the disciplinary, hierarchical, nationalistic Olympic ethos.

This saw the initial proposals to include surfing, skateboarding and sport climbing in Tokyo hotly contested by many within the wider action sporting cultures, worried about the loss of autonomy and control of "their" sports.

While the Olympic athletes are enthusiastic ambassadors for their sports (and likely to see significant economic and cultural rewards), there are those within the action sport worlds who view Olympic inclusion as just another money-making stunt — part of a longer process of "selling out" with little benefit for their sports.

Our research shows it has been mostly older male "core" participants who've been most opposed to the inclusion of action sports.

However, an international survey showed younger participants and women were much more enthusiastic. Those under 19 were most supportive, with 80% agreeing with the statement: "I think this is a great idea and I would likely watch more of the Olympics".

A SHOWCASE FOR FEMALE ATH-

LETES

The new-look games have also had their logistical challenges. Action sports organising bodies have had to navigate complex new terrain, including determining how athletes

Olympic inclusion of freerunning will qualify, competition formats, equipment, uniforms, drug testing and venue suitability — all complicated by the pandemic.

But, the inclusion of the new sports (with equal male and female representation) has also helped the Tokyo Olympics come the closest ever to the IOC's gender equality targets, with female athletes making up 49% of all Olympians.

For women in action sports, the Olympics are creating more opportunities for athletes and leaders in activities long dominated by men.

The phenomenal talents of female athletes showcased in Tokyo including 13-year-old skateboarder Sky Brown (Great Britain), surfer Carissa Moore (US) and climber Akiyo Noguchi (Japan) - may well see the gender dynamics shifting in these sports post-Olympics.

A CHANGING OLYMPIC LAND-

Without spectators, alas, Tokyo won't be the urban festival envisioned pre-COVID, with live music, art and a youth-friendly vibe at the urban and beach locations.

Nevertheless, the action sports central to that concept aren't going away. Paris in 2024 will see the addition of kiteboarding and breaking/break-dancing, part of a trend that will continue at the Los Angeles games in 2028.

Traditional ideas about which events are (or aren't) legitimate sports will also shift over coming years as the IOC stakes its claim in an increasingly competitive sports and leisure market.

With the survival of the games so dependent on viewers and sponsorship dollars, the IOC will only fight harder to stay relevant to the next generations of Olympic fans.

Arunachal govt disburses loans to 789 SHGs

ITANAGAR, JUL 22 (PTI): The Arunachal Pradesh government has disbursed more than Rs 8 crore as loans to 789 Self Help Groups (SHGs) of the state under the Deendayal Antyodaya Yojana National Rural Livelihoods Mission (DAY NRLM).

Chief Minister Pema Khandu on Wednesday virtually disbursed the amount of Rs 8, 27,47,000 under the scheme which was provided by three banks -State Bank of India (SBI), Arunachal Pradesh Rural Bank (APRB) and the Arunachal Pradesh State Cooperative Apex Bank (APSCAB).

The scheme is being implemented by the Arunachal State Rural Livelihood Mission (Ar-SRLM) of the state Rural Development department facilitating a subsidized loan amount of Rs 1 lakh to each eligible SHG, officials informed.

The event is a part of the nationwide Azadi ka Amrut Mahotsav' in line with the Aatma Nirbhar Bharat mission to commemorate 75th anniversary of Indian Independence in 2022.

ArSRLM is currently implementing DAY NRLM in 22 districts and has brought 33,516 rural households under it. The dedicated mission management units at the state, district clusters and block levels provide continued handholding support to SHGs for strengthening their institutions, financial inclusion, promotion of livelihoods and expanding existing basket of livelihoods of SHG members, the officials said.

Commending SRLM, especially its blocklevel coordinators, Khandu said that savings, thrift and micro finance support to the SHGs under DAY NRLM have been instrumental in initiating a transformational change at the household level in rural areas.

We are striving hard to address the formidable challenge of financial inclusion in rural areas where our citizens are not having desired level of access to financial services. ArSRLM is taking forward the state government's vision of deepening financial inclusion by providing access to affordable and appropriate financial services which would contribute towards improving GDP and lowering income inequality, Khandu said.

Asserting that it is the vision of the state government to transform rural economy of the state, Khandu said that a proper roadmap has to be evolved to take the process further.

He said the government would soon have a brainstorming with the concerned minister, coordinators and partner banks to take financial inclusion further into rural areas besides increasing the loan amount. It is a matter of pride that we today have about 3,796 SHGs, mostly of women, across the state. Our aim should be to handhold each of them through all means at our disposal.

PRITHVI MAN SHRESTHA KATHMANDU, 22 JUL [KATH-**MANDUPOST**]: The second coronavirus wave exposed Nepal's fragile health system.

As the cases started to soar beginning April, hospitals started turning away patients while acute shortages of beds, oxygen and ventilators, besides other essential medical goods, were reported from across the country.

After creating a devastating health crisis, the second wave abated, but only after claiming the lives of around 6,000 people in two months or so. After the coronavirus overwhelmed Nepal, various countries came forward to provide assistance, supplying different kinds of medical goods like ventilators, intensive care beds and oxygen concentrators, among others.

Amid a dismal vaccination coverage—only 4 percent of the population has been fully vaccinated so far—and a possible third wave hitting the country, concerns have now grown over the lack of health

According to officials at the Health Ministry, inadequacy of human resources has emerged as one of the biggest challenges as the country braces for a potential third Covid-19 wave.

"We need an additional 20,000 personnel, including doctors and nurses, to make our health system more resilient against a health crisis like the one during the second wave," said Dr Samir Kumar Adhikari, joint spokesperson for the Health Ministry. "Specialist doctors and medical officers are in a greater need."



As of mid-July 2020, Nepal had 90,946 health personnel, including doctors, specialist doctors and health workers. But the number decreased to 90,369 by mid-March of 2021, according to the Economic Survey 2020-21.

Infrastructure remains a challenge but it could be built on a temporary basis in times of crisis, officials say. However, they say it's simply impossible to fill the gap between the need and demand of health workers.

"We need an additional 15,000 hospital beds and logistical management has been taking place smoothly," said Adhikari. "But we are facing difficulties managing the required staff strength."

Considering the time it takes to recruit permanent staff, the federal, provincial, and local governments have been recruiting health workers on a contract basis.

"During our recent survey about our strengths and weaknesses during the second wave of the pandemic, we found massive staff shortages at several health institutions. They may not be able to handle the potential third wave," said Dr Krishna Prasad Paudel, spokesperson for the Health Ministry. "The provincial governments are not getting specialist doctors required for critical care even though they are making utmost effort to recruit them by paying competitive salaries."

The Lumbini provincial government is a case in point.

It can hire health workers for the approved 583 posts for four hospitals on a contract basis and it has also allocated the necessary budget for the purpose. Of the total posts, 463 have been filled so far.

"Despite our effort, we are facing difficulty hiring doctors, particularly specialist

doctors," said Dr Bikas Devkota, secretary at the Health and Population Ministry of Lumbini Province. "Doctors are not showing interest to join the workforce at these hospitals. I don't know why."

According to officials at the Health Ministry, even though medical officers have reached Primary Health Centres at the local level, there are not enough specialist doctors.

There are also concerns about a lack of paediatricians, as many believe the third wave could affect children. Children aged 14 and below are not being vaccinated in Nepal, and doctors have warned that they could be vulnerable to the new coronavirus variants.

The government in the first week of June asked hospitals to set aside 20 percent of wellequipped beds for children. But the hospitals need doctors as well to attend to children.

District Hospital, Mugu

is an example. It does not have a single paediatrician even though the hospital has arranged for doctors in adequate numbers.

"We have 12 doctors, including two specialists, and 10 medical officers at the hospital," Dr Dabal Malla, medical officer at the hospital, told the Post over the phone. "But we don't have a single paediatrician and there is no neonatal Intensive Care Unit."

According to him, there is also a shortage of nursing staff at the hospital.

Besides human resources, the hospital also lacks Intensive Care Unit beds and ventilators, according to Dr Malla.

Nepal received 4,126 oxygen concentrators of different capacities, 6,945 oxygen cylinders, 1.48 million oxygen kits, 13,820 body bags and 218 ventilators, among other things, from different foreign governments and domestic

and international agencies between April 14 and July 4, according to the Department of Health Services.

But the country lacks human resources with technical expertise to operate some of these equipment.

According to the Nepal Society of Critical Care Medicine, technical officials with years of experience are needed to run critical care and intensive units, but they are not available in most of the hospitals throughout the country.

"Equipment can be purchased or they may be received under donations, but what will we do with such equipment when we do not prepare the manpower needed to operate these equipment?" Hem Raj Paneru, general secretary of the society, had told the Post in May.

"In some hospitals, the problem is not a lack of equipment but a lack of people with expertise to operate them."

When the second wave of Covid-19 was ravaging the country, Tikapur Hospital in Kailali was struggling to provide care for patients because it did not have the manpower to operate ventilators.

At that time, the hospital had to send patients in need of ventilator support elsewhere.

As far as human resources for children are concerned, Health Ministry officials say they are working out on some models.

Dr Paudel, the spokesperson for the ministry, concedes that apart from medical professionals, the country faces a crunch of human resources to operate some crucial machines and equipment.

All NLFB militants to surrender today: Assam CM

GUWAHATI, JUL 22 (PTI): In a major development that can bring peace in Assam's Bodoland Territorial Region (BTR), all militants of the newly formed insurgent group National Liberation Front of Bodoland (NLFB) will surrender on Thursday, Chief Minister Himanta Biswa Sarma said.

The decision was reached at the highest political level of the state, and around 20 militants, including the outfit's chief M Batha, will lay down their arms at Lalpani in Udalguri district.

The group was floated after some disgruntled cadres of the erstwhile militant outfit National Democratic Front of Boroland (NDFB) returned to the forest. NLFB is active mostly in the BTR.

The surrendered NLFB militants will be received by Bodoland Territorial Council (BTC) chief Pramod Boro at Lalpani and they will be brought to Guwahati later in the day after completing all formalities at Majbat in Udalguri.

"People's trust in the Govt policies is reflected by NLFB's decision to return to the mainstream today. I welcome their homecoming," Sarma tweeted. He said that the Assam government is committed to the allround development of BTR and will protect the socio-cultural and political identity of

the Bodo people. Sharing a video foot-



age of the militants walking through a narrow jungle path, Sarma tweeted, "Further peace dawns in BTR with the homecoming of NFLB top cadres to mainstream. A great leap forward towards a peaceful Assam. Sharing live visuals of the event."

Director General of Police Bhaskar Jyoti Mahanta told PTI that the entire outfit is going to surrender.

Since its formation a few months ago, one member was killed in a police encounter and 27 others have been arrested, an Assam Police source said.

"This peace deal is an initiative at the political level, mainly by the chief minister. We have got information that M Batha will also surrender," he added.

Batha, a former NDFB militant, was among the 1,615 insurgents from all the factions of the NDFB who had laid down their

arms on January 30 last year after the signing of the third Bodo Peace Accord.

However, he was not satisfied with the implementation of the accord, and later went underground after the Bodoland Territorial Council (BTC) polls in December

He then announced the formation of the NLFB, which has mostly been involved in extortion in the BTR.

Meanwhile, BTC chief Pramod Boro said that the BTR will be free from all insurgent activities after the surrender of the NLFB militants. "After the third Bodo

Peace Accord, our region had become insurgencyfree. But due to some misunderstanding, Batha and a few others returned to the jungle," he told PTI while on the way to receive the militants.

This is a joint effort between the Assam government and the BTC ad-

ministration that resulted in this move towards peace, Boro said.

Asked how many cadres will lav down their arms, the BTC chief said, "We have got information that NLFB has around 20 cadres and all of them will surrender. I will take them to Guwahati to keep them in the safe custody of Assam Police."

The All Bodo Students' Union (ABSU), United Bodo People's Organisation (UBPO) and all the factions of the NDFB had signed the third Bodo Peace Accord with the Centre and Assam government on January 27 last year, ending years of violence.

The accord provided political and economic bonanza to the Bodoland region sans a separate state or Union territory.

A total of 3,439 militants of different groups have surrendered in Assamsince 2016, Sarma had said in the state Assembly on July 12.

All passengers arriving by flight have to undergo mandatory RT-PCR test before they are allowed entry into the islands, the official said.



it certainly wasn't the Olympic start the U.S. women's soccer team had anticipated, a rare loss didn't skewer the squad's hopes for gold.

The United States fell to Sweden 3-0 Wednesday night in the team's opener in Tokyo, snapping a 44-match unbeaten streak. It was a surprising result for the favorites in the field.

In fact, it may have lit

Defender Tierna Davidson said Thursday that veteran Kelley O'Hara was rallying the squad ahead of Saturday's match against New Zealand.

"She was like: 'We don't have a choice. We have to come out the next game and we have to be absolutely ruthless." Davidson said. "So I think that's what everyone has on their mind right now."

There's still a good chance that the world's top ranked team makes it to the knockout round and even a medal match. At the 2008 Beijing Olympics, the United States fell 2-0 to Norway in the first match, then went on to win gold — a fact U.S. forward Christen Press pointed to after the game.

Britain sits atop Group E after its 2-0 victory over Chile. The Netherlands leads Group F on goal differential after a 10-3 victory over Zambia, the lowest-ranked team in the competition.

DUBAI, JUL 21 (PTI): India opener ShikharDhawan jumped two places to 16th after his unbeaten half-century in the first match against Sri Lanka while Virat-Kohli remained at second spot in the latest ICC ODI rankings issued on Wednesday.

Dhawan's unbeaten 86 in the first game of the ongoing three-ODI series in Colombo helped him accumulate 712 rating points and gain two slots, while Kohli has 848

Another senior India batsman Rohit Sharma is at third position with 817 points in the list headed by Pakistan's Babar Azam (873).

The rankings took into account the threematch series between Zimbabwe and Bangladesh, the third Ireland versus South Africa match and the first two ODIs between Sri Lanka and India.

Among the bowlers, India's YuzvendraChahal (up four places to 20th),



Hasaranga (up 22 places to 36th), South Africa's TabraizShamsi (up eight places to 39th), Ireland's Simi Singh (up six places to 51st) and Zimbabwe's Blessing Muzarabani (up 23 places to 70th) were among the others to make headway.

In the ICC T20 rankings, Pakistan opener Mohammad Rizwan and middle-order England batsman Liam Livingstone made huge progress after finishing as the leading run scorers for their teams in the three-match series won 2-1 by England. Wicketkeeper-batsman

Rizwan has attained a career-best seventh position after aggregating 176 runs in the series including an unbeaten 76 in the final match in Manchester, performances that helped him gain four places.

The 29-year-old had reached the top 10 for the first time in his career after a Player of the Series effort against Zimbabwe in April this year and has reaped benefits of his continued good effort.

Livingstone has galloped 144 places to reach 27th position after playing just eight T20Is since his debut against South Africa four years ago.

Chess World Cup: Praggnanandhaa set for Vachier-Lagrave challenge in Round 4

SOCHI (RUSSIA), JUL round four. 22 (PTI): Three Indian Grandmasters remain in contention for the honours in the men's section of the FIDE chess World Cup with focus on teen prodigy R Praggnanandhaa in the fourth-round matches on Thursday.

The experienced P Harikrishna and fast-rising ViditSantoshGujrathi are also in the fray and will be aiming to keep their winning run going.

Play in the tournament resumes on Thursday after a day's rest on Wednesday.

The Chennai-based Praggnanandhaa, playing in his maiden World Cup, faces highly-rated Frenchman Maxime-Vachier-Lagrave, ranked 16th in the world, in

Vachier-Lagrave comes into the match on Thursday after a hardfought win over Russian David Paravyan via the tie-break.

The 15-year old Praggnanandhaa's good run has drawn the attention of chess pundits and the manner in which he kept his cool in round three after veteran Michal Karsenkow forced a tiebreak won appreciation.

The Indian teenager, however, faces a tough task against the French player, who came into the tournament after winning the title in the Croatia Grand Chess Tour event recently. There is a wide gulf in the ELO rating (Vachier-Lagrave's 2760 as against 2608 of Praggnanandhaa) apart from the experience fac-

However, the Indian will fancy his chances in a world cup knockout game as the tournament has already witnessed a few upsets including that of the world No. 2 FabianoCaruana, Anish-Giri and ShakriyarMamedyarov, among others.

Harikrishna takes on Iran's M Amin Tabatabaei in the fourth round and starts favourite on the asis of the ratings.

Gujrathi (ELO 2726), who overcame the stubborn challenge of compatriot B Adhiban in the tiebreak, will be up against highly-rated American Jeffery Xiong (ELO 2709) in what promises to be a battle among equals.

Nepal must be watchful of the geopolitical fallout of US Afghan pullout, analysts say

KATHMANDU, 22 JUL [KATHMANDUPOST]: The United States' announcement to withdraw all its troops by September 11, after two decades of military presence, could trigger a geopolitical flux in the region, and observers say some impact on Nepal cannot be ruled out.

Major powers and key stakeholders like the United States, Russia, China, India, Pakistan and Iran, among others, are weighing likely scenarios in the country, as fears of the Taliban taking over loom large. Reports suggest the Taliban of late have rapidly expanded their territorial control closing in on Kabul, the capital.

Foreign policy experts and observers say pulling out the American troops from Afghanistan and a possible takeover by the Taliban would hamper regional peace and security.

Arjun Kant Mainali, a former joint secretary at the Foreign Ministry, said Afghanistan is headed towards a power vacuum, which will have a huge impact in the region, thereby Nepal seeing some ripple effects.

None of Afghanistan's neighbours will benefit from a Taliban takeover, and with New Delhi having its diplomatic stakes—along with massive investments—the United States, according to Mainali, could encourage India, with which Nepal shares an 1,800-kmlong open border, to engage with Afghanistan.

A possible triumph of the Taliban would threaten Indian investments worth billions in various sectors, including dams, roads and other infrastructure. How South Asia's biggest country engages with Afghanistan and its outcomes are likely to have a profound impact on the region. Pakistan, Afghanistan's next door neighbour, too is weighing its options, and Islamabad too is likely to make its moves to put New Delhi in check with the backing of China, which has its own rivalry with India and an interest in Afghanistan. Beijing, through its Belt and Road Initiative, aims to enhance its economic and diplomatic influence. The Chinese investment so far has failed to pick up pace largely due to the constant instability and American presence in Afghanistan. But these two key aspects are going to change in less than two months from now. A senior Foreign Ministry official told the Post that the ministry has been closely following the developments in Afghanistan and possible repercussions in Nepal in the aftermath of the US pullout.

An immediate impact would be loss of jobs for Nepali nationals working in Afghanistan. The number of Nepalis working in Afghanistan is estimated to be around 100. Their safety would be a primary concern and most probably they would return home in the event of a Taliban takeover.

The Foreign Ministry official said what is more concerning is a threat to regional peace and security, which

"Already, we are hosting some refugees from Afghanistan and the number could rise because our immigration and vetting systems are poor and weak,"

refugee agency in Kathmandu, Nepal is currently hosting around 50 Afghan refugees in Kathmandu. They come under the category of "urban refugees".

If the peace talks falter or fail altogether, it could hamper relations between Washington and Islamabad. Instability or Taliban gains in Afghanistan could embolden militants in Pakistan, thereby threatening regional peace.

"What is happening in Afghanistan and how situations will unfold, especially after the US pullout, will have a larger impact on the ties between India and Pakistan as well as India and China. A possible spillover effect in Nepal cannot be ignored," said Ramesh Nath Pandey, a former foreign minister.

"As SAARC chair, Nepal needs to constantly raise its voice—and make it heard—at the regional level about the threats to regional peace and security from instability in Afghanistan."

But the only platform where Nepal has some wherewithal to exert influence is in a moribund state, largely because of India-Pakistan rivalry.

Afghanistan joined SAARC in 2007 as its eighth member. SAARC itself is struggling to take its process forward and hold its 19th summit ever since India pulled out in 2016, charging Pakistan with attacking its military base in Uri in Jammu and Kashmir.

As the SAARC chair, Nepal can make a broader call for maintaining regional peace, but the bloc's charter won't allow any specific discussion on any specific country's matters or issues concerning two or more countries.

Arjun Bahadur Thapa, former secretary general of SAARC, however, ruled out any possibility of discussing Afghanistan and the unfolding situation at the regional bloc's platform.

"There is no record of member states discussing internal matters of any country," Thapa told the Post. "Even if Nepal, as the SAARC chair, takes any initiative, a response is far-fetched."

Experts and observers say even though there are concerns about regional peace and security coming under threat after the US pullout from Afghanistan, much depends on how individual countries engage each other and the regime in Kabul.

According to Pandey, both India and China, Nepal's immediate neighbours, have high stakes in Afghanistan, and Kathmandu needs to monitor closely how they engage Kabul and its forthcoming government. Thapa, the former secretary general of SAARC, said countries like India, China and Pakistan that have high stakes in Afghanistan are working bilaterally or individually.

"But one thing is sure, if there is any instability in Afghanistan, it will definitely hamper regional peace and security," he said. "For China, further instability could affect its own investment plans. With Americans set to pull out, Beijing is likely to step up its engagement in Kabul. So will India. A geopolitical flux is just on the cards."

With Washington more likely to outsource its Afghan policy to Delhi after the pullout, some analysts say there are chances the Biden administration could start seeing Central Asia, including Nepal, through India's prism.

China's Zhengzhou begins cleanup after deadly storms



BEIJING (AP): Residents of the storm-ravaged central Chinese city of Zhengzhou on Thursday were shoveling mud from their homes and hauling away wrecked cars and piles of destroyed belongings following floods that killed at least 33 people in the city and surrounding areas.

Rains continued to pound parts of Henan province of which Zhengzhou is the capital

Streets have been turned into rivers and people were stranded in apartments, offices, hotels and rural homes in dozens of cities and towns.

In the worst incident in Zhengzhou, 12 people died Tuesday night in the subway system when it was inundated with flood waters.

Another eight people remain missing in the floods, the official Xinhua News Agency reported.

The storm front is now shifting to northeastern Henan, affecting cities including Hebi, Anyang and Xinxiang, according to state broadcaster

Xinxiang saw its heaviest rainfall in recorded history, with more than 25 centimeters (9.8 inches) in the 19 hours

between Wednesday night and Thursday afternoon, according to the city's weather agency. The local government has urged people not to leave home unless it's necessary.

Residents took to social media to seek assistance as lakes and rivers overflowed and water and electricity were cut. Outside help was not arriving and residents were relying on themselves, those postings said.

Public transport in Anyang has been suspended and people were asked to work from home on Thursday, state broadcaster CCTV reported.

Zhengzhou, a city of 12

million people, saw dryer conditions on Thursday, although large parts of the city remained underwater. Along with flooding subway stations and stranding trains, the rains collapsed roads and disrupted rail and air transport.

Water, electricity and gas supplies were also cut and more than 40 temporary sites were set up in the city to provide clean water.

Zhengzhou is a major hub for China's railway network and some trains were stuck on the tracks for as long as 40 hours, prompting rescuers to send passengers food and wa-

ter. Some were able to return to their point of departure, while other passengers had to be rescued at the point where they had been stranded, according to local newspaper Henan Daily.

More than 3million people in Henan have been affected by the flooding, and direct economic losses are estimated to be 1.2 billion yuan (189 million US dollars), CCTV said on its news app. Tens of thousands have been moved to emergency shelters.

The rains in Henan will start to weaken on Thursday night, according to the China Meteorological Administration. Just as the rainstorms are winding down, Typhoon In-Fa is approaching Taiwan and the costal provinces in southeastern mainland China.

Spanish judge questions Twitter hack suspect wanted by US

MADRID (AP): A British involvement in last summan charged in the United States in connection with a Twitter hack last year that compromised dozens of influential accounts is set to appear before a Spanish judge Thursday.

Joseph O'Connor, 22, is set to be questioned via videoconference from Estepona, the southern Spanish resort town where police arrested him on Wednesday on a U.S. arrest warrant, a Spanish National Court spokesman said.

U.S. prosecutors accuse O'Connor of involvement in a July 2020 hack of more than 130 accounts, including those of prominent politicians. celebrities and technology moguls.

A criminal complaint filed in federal court in the Northern District of California also charges O'Connor for hacks taking over Twitter, TikTok and Snapchat accounts, as well as cyberstalking a juvenile.

The Madrid-based National Court handles extradition requests in Spain. A court spokesman, who was not authorized to be named in media reports, said that the judge will decide whether O'Connor should remain in custody while awaiting extradition procedures.

Those procedures can take months before being resolved and involve both a judicial review and the Spanish Cabinet's approval.

The FBI informed Spanish authorities about O'Connor's alleged mer's hack, the National Police said in a press release. It said Spanish and U.S. agents took part in his arrest and search of the suspect's residence, confiscating two computers and a mobile phone.

The U.S. criminal complaint charged O'Connor - who went by the online handle PlugWalkJoe - with crimes including cyberstalking, making extortive and threatening communications and intentionally accessing a computer without authorization.

O'Connor has denied wrongdoing in previous interviews. His lawyer couldn't immediately be

During the highprofile security breach a year ago, fake tweets were sent from the accounts of Barack Obama, Joe Biden, Mike Bloomberg and a number of tech billionaires including Amazon's then-CEO Jeff Bezos, Microsoft cofounder Bill Gates and Tesla CEO Elon Musk.

The bogus tweets asked followers of highprofile accounts to send Bitcoin payments. O'Connor is at least the fourth suspect charged in connection with the

Spain's National Police said Thursday that O'Connor was permanently residing in Marbella, another southern coastal city popular with foreign residents and that he had been on their radar at least since April 2020 as part of an alleged criminal group committing fraud online.

Hong Kong police arrest 5 trade union members for sedition

HONG KONG (AP): Hong dard against the soci-Kong police on Thursday arrested five trade union members over children's books they described as seditious, and a court denied bail for four editors and journalists held on charges of endangering national security, as part of a widening crackdown on dissent in the city.

The five who were arrested are members of say restricts freedoms the General Association promised to the former of Hong Kong Speech Therapists, according to local media reports.

The association published three children's books that Li Kwai-wah, a senior superintendent of the national security department, said have seditious intent.

The books feature stories that revolve around a village of sheep that has to deal with wolves from a different village. The sheep take action like going on strike or escaping by boat, according to the synopses published on the association's website.

Li said that the stories referenced the 12 Hong Kong activists who were arrested at sea while trying to flee the city, after most of them were charged in connection with massive antigovernment protests in 2019. There was also a story about wolves who are "cruel and try to occupy the area" where the sheep live, and try to kill them, Li said.

"Of course, when we prosecute the case, we are not the one to prove that these materials have actually caused the inciting to others," said Li.

"And the children. maybe because of the information inside ... can turn their mind and develop a moral stan-

The 2019 rallies calling for more civil rights and universal suffrage shook Hong Kong for months, often descending into violence between police and protesters. Beijing responded last year with a sweeping national security law that critics British colony that are not found on mainland China.

The publishing of such books "brings hatred against the government and administration of justice, and (incites) violence to others," Li said. He added that the books targeted children between the ages of 4 and 7.

The national security law criminalizes secessionism, subversion, terrorism and foreign collusion in the city's affairs. Since it was implemented, more than 100 pro-democracy supporters have been arrested and many others have fled abroad.

Olympic opening ceremony director fired for Holocaust joke

TOKYO (AP): The Tokyo Olympic organizing committee fired the director of the opening ceremony on Thursday because of a Holocaust joke he made during a comedy show in

Organizing mittee president Seiko Hashimoto said a day ahead of the opening ceremony that director Kentaro Kobayashi has been dismissed. He was accused of using a joke about the Holocaust in his comedy act, including the phrase "Let's play Holocaust."

"We found out that Mr. Kobayashi, in his own performance, has used a phrase ridiculing a historical tragedy," Hashimoto said. "We deeply apologize for causing such a development the day before the opening ceremony and for causing troubles and concerns to many involved parties as well as the people in Tokyo and the rest of the country."

Tokyo has been plagued with scandals since being awarded the Games in 2013. French investigators are looking into alleged bribes paid to International Committee Olympic members to influence the vote for Tokyo. The fallout forced the resignation two years ago of Tsunekazu Takeda, who headed the Japanese Olympic Committee and was an IOC member.

emony of the pandemic-delayed Games is scheduled for Friday. The ceremony will be held without spectators as a measure to prevent the spread of coronavirus infections, although some officials, guests and media will attend.

tomorrow and, yes, I am sure there are a lot of people who are not feeling easy about the opening of the Games." Hashimoto said. "But we are going to open the Games tomorrow under this difficult situation."

Earlier this week, composer KeigoOyamada, whose music was to be used at the ceremony, was forced to resign because of past bullying of his classmates, which he boasted about in magazine interviews. The segment of his music will not be used.

Soon after a video clip and script of Kobayashi's performance were revealed, criticism flooded social media.

"Any person, no matter how creative, does not have the right to mock the victims of the Nazi genocide," said Rabbi Abraham Cooper, associate dean and global social action director of the Simon Wiesenthal Center, a Los Angeles-based human rights group.

He also noted that the Nazis gassed Germans with disabilities. "Any association of

this person to the Tokyo Olympics would insult the memory of 6 million Jews and make a cruel mockery of the Paralympics," he said.

Kobayashi is a former



comedy duo Rahmens and known overseas for comedy series including "The Japanese Tradition."

Japan is pushing ahead with the Olympics against the advice of most of its medical experts. This is partially due to pressure from the IOC, which is estimated to face losses of \$3 billion to \$4 billion in television rights income if the Games were not held.

The official cost of the Olympics is \$15.4 billion. but government audits suggest it's much more. All but \$6.7 billion is public money.

Koichi Nakano, who teach politics at Sophia University, wrote on Twitter that the opening ceremony chaos underscores a lack of awareness in Japan about diversity.

Tokyo Governor Yuriko Koike said she learned of Koyayashi's comments from Hashimoto.

"I was astonished." she said.

Kobayashi's caust joke and Oyamada's resignation were the latest to plague the Games. Yoshiro Mori resigned as organizing committee president over sexist remarks. Hiroshi Sasaki stepped down as creative director for the opening and closing ceremonies after suggesting a Japanese actress should dress as a pig.

Also this week, the chiropractor for the American women's wrestling team apologized after comparing Olympic COVID-19 protocols to Nazi Germany in a social media post. 
