# 91 new cases after VRD Labs begin new week after Sunday off

GANGTOK, 20 APR:

With both VRD Labs [where RT-PCR tests can be carried out] back in operation on Monday after a Sunday off, Sikkim registered another surge in Covid cases with 91 new cases of novel coronavirus reported in the last 24 hours.

Of the 91 new cases, only 11 were admitted in hospital today. The State now has 488 active Covid cases, 48 of whom are currently admitted in hospital with the rest having mild enough symptoms to prescribed only home isolation.

While 71 of the new cases were reported from East District, one was detected in West District and 19 in South District.

The 91 cases were picked up in the testing of 489 samples collected on Monday.

In the meanwhile, the number of recovered cases of COVID-19 improved to 6,021 with the discharge of four more persons from home isolations after completing their isolation period.



In his daily health bulletin on Tuesday, Health Department State IEC Officer, Sonam Gyaltsen Bhutia, informed that 72 persons were found positive in the RT-PCR testing of 321 samples, while two more reported positive in TrueNat from Greendale School Road,

testing of two samples and 17 samples returned positive for COVID-19 in rapid antigen testing of 160 samples.

14 new cases were reported from the Tadong area of Gangtok, which includes three three from Metro Point, two from 5th Mile-Tadong, two from Lumsey, two from Daragaon, one from Gairi Gaon and one from Tadong Bazaar.

Likewise, new cases reported from in and around the capital include four from

Shyari, two from Development Area, one from Kazi Road, two from Lower Burtuk, two from VIP colony, two from Chandmari, two from Development Area, two from Sichey, two from Deorali, one from Upper Tathangchen, one from Namnang, one from Housing Colony Arithang, one from Upper MG Marg, one from Decheling, one from near Bar-Pipal, one from AG Office quarters at Shyari. one from Pani House and one from Arithang.

Chief Minister, PS Tamang today announced that schools and colleges in the state will remain shut till 30 April and that Government offices will function with 50% employees from 22 April onwards.

Later in the evening, the Education Department took out a circular informing that all government, government aided [Centre and State] and private educational institutions, universities, colleges, tutorials, coaching institutes and hostels shall remain closed till 30 April.

The circular also informs that all activities related to the CBSE examinations slated to be held during this period shall be taken up after 30 April as per the convenience of the CBSE Centre Superintendents.

It further adds that online mode of education will continue during this period.

## India's devastating 2nd wave is driving global Covid surge

NEW DELHI, 20 APR [THEWASHING-**TONPOST**]: More than a year after the pandemic began, infections worldwide have surpassed their previous peak. The average number of coronavirus cases reported each day is now higher than it has ever been.

"Cases and deaths are continuing to increase at worrying rates," said World Health Organization chief Tedros Adhanom Ghebreyesus on Friday.

A major reason for the increase: the ferocity of India's second wave. The country accounts for about one in three of all new cases.

It wasn't supposed to happen like this. Earlier this year, India appeared to be weathering the pandemic. The number of daily cases dropped below 10,000 and the government launched a vaccination drive powered by locally made vaccines.

But experts say that changes in behavior and the influence of new variants have combined to produce a tidal wave of new cases.

India is adding more than 250,000 new infections a day - and if current trends continue, that figure could soar

to 500,000 within a month, said Bhramar Mukherjee, a biostatistician at the University of Michigan.

While infections are rising around the country, some places are bearing the brunt of the surge. Six states and Delhi, the nation's capital, account for about two-thirds of new daily cases. Maharashtra, home to India's financial hub, Mumbai, represents about a quarter of the nation's total.

In Delhi, many hospitals had shrunk their coronavirus wards - believing the worst was past - when the second wave struck.

On April 9, the city added 8,500 cases, a record in the pandemic. Four days later, it was 13,500. Four days after that, the number jumped to more than 24,000.

The soaring number of cases has overwhelmed hospitals. The city is facing an acute shortage of oxygen and nearly all its intensive care beds are full, Kejriwal said Monday.

Mohammad Shahzad, a 40-year-old accountant, was one of many desperately seeking care. He developed a fever and grew breathless on the afternoon of April 15. His wife, Shazia, rushed him

#### ICSE Class 10 board exam cancelled due to "worsening situation" of Covid

New Delhi, 20 Apr [NDTV]: The ICSE Class 10 board examination has been cancelled due to the "worsening situation" of the coronavirus pandemic, the board said today days after it had made the exam optional.

The Council for the Indian School Certificate Examinations (CISCE) board had just days ago postponed its Class 10 and 12 examinations after a nationwide Covid surge and requests from parents and students made them rethink.

"The safety and wellbeing of our students and teaching faculty is our topmost priority and of paramount interest," the board said in a circular.

The board had said that new dates for ISC Class 12 examination will be announced in June. While exams will be held for Class 12 students later, Class 10 students were allowed to either opt out or take the exam in offline mode later.

The board today cancelled the examination as the country records grim records and unprecedented spike in cases in the second and more deadly wave of Covid. Today is the sixth consecutive day India recorded over 2 lakh cases.

The ISC Class 12 examination, like its CBSE counterpart, will be held at a later date after the Covid situation improves. The CBSE has also cancelled examinations for Class 10 students.

CISCE also said that the Class 10 students will be marked by devising a "fair and unbiased" criterion. The date of results will be announced later, the board said, adding that Class 11 admissions and online classes must begin at the earliest at affiliated schools. The Class 10 exams were scheduled from May 4 to June 7.

Over 35 lakh students appearing for the board exams stand affected by the decision.

For three hours, they went from hospital to hospital trying to get him admitted, with no luck. She took him home. At 3:30 a.m., with Shahzad struggling to breathe, she called an ambulance. When the driver arrived, he asked if Shahzad truly needed oxygen - otherwise he would save it for the most serious patients.

The scene at the hospital was "harrowing," said Shazia: a line of ambulances, people crying and pleading, a man barely breathing. Shahzad finally found a bed. Now Shazia and her two children, 8 and 6, have also developed covid-19 symptoms.

The streets are quiet across Maharashtra, where authorities have told people to stay inside and have shut nonessential businesses until the end of the

The stillness is deceptive.

Oxygen is in such short supply that tankers are hauling it in from other states. Patients still face a scramble to find available hospital beds.

From early morning until late at night, Prafulla Gudadhe's phone does not stop ringing. Each call is from a constituent and each call is the same: Can he help to arrange a hospital bed for a loved one?

Gudadhe is a municipal official in Nagpur, a city in the interior of Maharashtra. "We tell them we will try, but there are no beds," he said. About 10 people in his ward have died at home in recent days after they couldn't get admitted to hospitals, Gudadhe said, his voice weary. "I am helpless." In the western state of Gujarat, the second wave has swamped hospitals and crematoriums.



He also said that there will be no free vaccines for those between the age of 18 and 45 years.

"No free vaccines for 18-45 yr olds. Middlemen brought in without price controls. No vaccine guarantee for weaker sections. GOI's Vaccine Discrimination- Not Distribution- Strategy," he said in a tweet.

The government on Monday announced that all adults will be eligible for COVID vaccination from May 1 while private

tion work. Assam State Disaster Management Authority chief executive officer Gyanendra Tripathi said the order will be applicable in only those districts which have 100 or more active COVID-19 pa-

At present, 13 out of 33 districts in Assam have 100 or more active positive cases, a National Health Mission spokesperson said.

The order further said that gatherings in open spaces have been capped at 50 per cent or 400 persons, whichever is lower, while it will be 50 per cent in closed venues.

"Number of guests in private functions at private venues, including mar-

riages to be restricted to 100 persons. Funeral/last rites related gatherings should ensure not more than 20

persons for each deceased," it added. Religious places can allow 20 persons per hour, while in the "iconic" places 50 persons can be allowed in an hour, the guideline stated.

In case of educational institutes not more than 50 per cent students can attend in person on any day and the schools should stagger class timings so that no large gathering of students takes place.

The order asked schools to opt for the online mode of teaching and said the education department will issue detailed guidelines in view of the COVID-19 precautionary measures.

#### **High Court questions** Gujarat's claim on adequate beds for Covid-19



AHMEDABAD, 20 APR [PTI]: The Gujarat High Court on Tuesday questioned the state government's claim that there were enough beds for COVID-19 patients and sought to know why infected persons were still unable to get admitted, if beds were vacant.

In its submission on Tuesday, the state government informed the ernment has ensured adcourt that of 79,944 beds at COVID-19 hospitals and other care facilities in the state, 55,783 were occupied, while the rest were vacant.

Government lawyer Manisha Shah made the submission during an online hearing on a plea filed suo moto by the division bench of Chief Justice Vikram Nath and Justice Bhargav Karia on coronavirus situation two weeks ago.

"Complaints are coming, maybe you are also receiving that patients are not being admitted because there is no vacancy in hospitals. Beds are not available. The figures shared by you suggest that even designated hospitals have vacant beds," the bench told the state.

"(If that is true) then why are people running around, finding sources and recommendations getting hospitals beds and treatment?" the bench asked the state.

The court also raised concerns about people's claims that 108 ambulances are now taking considerable time to pick up patients who are in a critical condition.

Moreover, the court also sought to know why critical patients were not taken in by government hospitals, if they came in private vehicles instead of "108" ambulances.

In the government's defence, Ms Shah said that although beds were available at other facilities, some at a distance from patients' homes, people want to get admitted to specific hospitals, which results in full occupancy in those hospitals.

Ms Shah also assured the court that the govequate supply of medical oxygen and there was no scarcity of the life-saving gas at present.

A special control room has been set up at the Chief Minister's Office to monitor the oxygen supply to hospitals, she added.

On a query raised by the bench about RT-PCR testing, Ms Shah informed that all districts have the facility to conduct these tests and the government conducts an average of 1.65 lakh tests, including around 75,000 RT-PCR tests, which are considered more accurate than antigen test.

Senior advocate Percy Kavina, who was allowed to share views of other High Court lawyers, expressed displeasure about the Centre's decision of discontinuing a scheme of providing insurance cover to "corona warriors" under the Pradhan Mantri Garib Kalyan Yojana (PMGKP).

"Only 287 insurance claims were processed under the PMGKP, which is now being shut. Just 287 claims across the country? Though the new scheme is coming, but why not continue PMGKP?" Ms Kavina asked. After hearing all submissions, the court asked the government to file an affidavit and scheduled the next hearing on April 27.

### Act on corruption complaints in 3 months: Vigilance body to departments



NEW DELHI, 20 APR [PTI]: The Central Vigilance Commission (CVC) has asked all central government organisations to decide on corruption complaints against employees within three months.

The move comes after the anti-corruption watchdog noted with concern that corruption complaints were not being taken to a logical conclusion or the action taken on them were not being updated in the records.

It has been observed from the proposals being received by the commission for the purpose of vigilance clearance that complaints received against an employee gets registered or received and stays in the vigilance profile of the employee for a very long time, the

CVC said in an order. "This has led to a situation where the vigilance clearance is being delayed or denied for no fault of the employee," it said. All anonymous or pseudonymous complaints must be filed, the CVC said.

"Action on the remaining complaints must be taken to the logical conclusion within three months of the date of receipt of the complaint," it said in the order issued on Monday.

A logical conclusion here implies that the decision shall be taken by the organisation to either file the complaint or register a vigilance case for further investigation or register a non-vigilance administrative action case for further investigation, the CVC said.

"As a pilot, to begin with, the backlog complaints received till December 31, 2020, shall be disposed of according to the guidelines issued in this circular and compliance reported by May 31, 2021," the anti-corruption watchdog said.

At the end of the third month from the date of receipt of a complaint against the employee and after deciding on the course of action, a copy of the complaint shall be made available to the employee concerned within 15 days through speed post, wherever the name is mentioned in the complaint, it said.

In cases where the employee's name is not explicitly mentioned in the complaint, a copy of the complaint shall be made available to the staff concerned at the stage of registration of vigilance or non-vigilance case, the CVC said in the order issued to secretaries of all central government departments.

The purpose is to inform the employee that the complaint is being examined by the organisation, it said, adding that the staff shall also be informed that full opportunity would be given to him during the examina-

Once a decision has been made to take up the matter as a vigilance case, the organisation shall send its inquiry report to the commission or Chief Vigilance Officer (CVO) seeking first stage advice within three months of registration of such regular case, the directive said.

"This timeline shall strictly be adhered to," it said in the directive issued to all chief executives public sector banks, enterprises, insurance companies and autonomous bodies, among others.

## Work Harder at Inspiring Excellence

More attention should be diverted to stem the regression from privileges to entitlement

recent discussion on ideas of identity teased **A**out something which should have been obvious all along - a lot of the passion behind reinforcing and reasserting identities, as much as they may be about ideas of self and of belonging, are also about privileges which accrue when such claims fructify. Privileges, however, are only one step away from ingraining a sense of entitlement even instilling sloth, and that is where futures can get compromised.

Maybe the minds that should be applying themselves to finding solutions are too occupied with other pursuits or maybe because the fire in the belly is just not burning strongly enough, whatever the reason, measures aimed at securing the futures for the present and coming generations remain perennially short-term in Sikkim. We speak of employment here. Quotas, reservation and guaranteed employment are short-term measures; options put in place till such time that the 'local' workforce acquires the skills and training required for the wider opportunities available. Make these protections permanent and the policy ends up rewarding mediocrity because it stops placing a premium on excellence. Why, after all, will a 'local' work hard at becoming employable when the carrot of guaranteed placement keeps dancing in front of him/her? In fact, to do so [work hard at becoming employable] would be seen as a waste of energy by many. But this approach is self-defeating. Sikkim is growing, both, in census figures and aspirations, and the job opportunities here will never be able to keep pace. Every job opportunity that opens in Sikkim in the next five years, once it is filled, will remain occupied on an average for the next thirty years. Even if all these job openings are made available only to locals, one still looks at an increasing number of job seekers entering the job market every year. School enrolments are up and the number of graduates has been consistently rising in the State, why, despite the density of "universities" here and one proper Central University, the State is in the process of establishing a state university as well because of the overflow. Given how young the pursuit of education is in Sikkim and the manner in which the population is growing, the number of job-seekers will keep multiplying every year. The State, even after 100% reservation, will soon run out of job opportunities.

The policy makers in government and noise makers outside have to realise that the solution is not in reserving jobs in Sikkim, but grooming generations to become employable anywhere in the world. Once that happens, jobs in Sikkim will automatically go to locals and this will come bundled with pride because they would have been earned on merit and not recommendations or old laws. This cannot happen though if people are spoilt for doles. It is not suggested that jobs in Sikkim should not be reserved for locals; what is being suggested is that celebrating protectionism only grooms mediocrity. Protections exist and should be maintained as a safety net, but aspirations have to be set much higher. One way to do this would be by fixing accountability not just on those who organise skill development programmes [by checking up on how many self-employed youth emerged from the training], but also following up on the funds the government invests on students by way of free education, text books, scholarships and other aids. It would not be a bad idea to release figures on how much the State spends on an average on its youth since the time they join school to the time they graduate. When the figure stares them in the face in black & white, maybe more of the youth will be inspired to put their education to better use than demanding a job from the government. If this happens, they will inspire more to follow in their footsteps. That is the chain reaction of achievers that the State has to aim at setting off, not pampering the youth with a policy that makes them lazy.

# No, Vaccine Side Effects Don't Tell You How Well Your Immune System Will Protect You From COVID-19

If someone gets a headache or feels a bit under the weather after receiving a COVID-19 vaccine, it's become common to hear them say something like "Oh, it just means my immune system is really working hard." On the flip side, when people don't notice any side effects, they sometimes worry the shot isn't doing its job or their immune system isn't reacting at all.

Is there any link between what you can notice after a vaccine and what's happening on the cellular level inside your body? Robert Finberg is a physician who specializes in infectious diseases and immunology at the Medical School at the University of Massachusetts. He explains how this perception doesn't match the reality of how vaccines work.

WHAT DOES YOUR BODY DO WHEN YOU GET A VACCINE?

Your immune system responds to the foreign molecules that make up any vaccine via two different systems.

The initial response is due to what's called the innate immune response. This system is activated as soon as your cells notice you've been exposed to any foreign material, from a splinter to a virus. Its goal is to eliminate the invader. White blood cells called neutrophils and macrophages travel to the intruder and work to destroy it.

This first line of defense is relatively shortlived, lasting hours or days.

The second line of defense takes days to weeks to get up and running. This is the long-lasting adaptive immune response. It relies on your immune system's T and B cells that learn to recognize particular invaders, such as a protein from the coronavirus. If the invader is encountered again, months or even years in the future, it's these immune cells that will recognize the old enemy and start generating the antibodies that will take it down.

In the case of the SARS-CoV-2 vaccines, it takes approximately two weeks to develop the adaptive response that brings long-lasting protection against the virus.

When you get the vaccine shot, what you're noticing in the first day or two is part of the innate immune response: your body's inflammatory reaction, aimed at quickly clearing the foreign molecules that breached your body's perimeter.

It varies from person to person, but how dramatic the initial response is does not necessarily relate to the long-term response. In the case of the two mRNA COVID-19 vaccines, well over 90% of people immunized developed the protective adaptive immune response while fewer than 50% developed any side effects, and most were mild.

You may never know how strongly your body's adaptive immune response is gearing up.

The bottom line is you can't gauge how well the vaccine is working within your body based on what you can detect from the outside. Different people do mount stronger or weaker immune responses to a vaccine, but post-shot side effects won't tell you which you are. It's the second, adaptive immune response that helps your body gain vaccine immunity, not the inflammatory response that triggers those early aches and pains.

WHAT ARE SIDE EFFECTS, ANYWAY?

Side effects are normal responses to the injection of a foreign substance. They include things like fever, muscle pain and discomfort at the injection site, and are mediated by the innate immune re-

Neutrophils or macrophages in your body notice the vaccine molecules and produce cytokines molecular signals that cause fever, chills, fatigue and muscle pain. Doctors expect this cytokine reaction to happen any time a foreign substance is injected into the body.

In studies where neither recipients nor researchers knew which individuals were getting the mRNA vaccine or a placebo, approximately half of people aged 16 to 55 who received a SARS-CoV-2 vaccine developed a headache after the second dose. This reaction may relate to the vaccine - but a quarter of people who received just a placebo also developed a headache. So in the case of very common symptoms, it can be quite difficult to attribute

them to the vaccine with any certainty.

Researchers anticipate some reports of side effects. Adverse events, on the other hand, are things that physicians do not expect to happen as a result of the vaccine. They would include organ failure or serious damage to any part of the body.

The blood clots that triggered the U.S. to pause distribution of the Johnson & Johnson vaccine are a very rare event, apparently happening with onein-a-million frequency. Whether they are definitely caused by the vaccine is still under investigation but if scientists conclude they are, blood clots would be an extremely rare side effect.

WHAT COMPONENT IN THE SHOT CAUSES SIDE EFFECTS?

The only "active ingredient" in the Pfizer and Moderna vaccines is the mRNA instructions that tell the recipient's cells to build a viral protein. But the shots have other components that help the mRNA travel inside your body.

To get the vaccine's mRNA into the vaccinated person's cells where it can do its job, it must evade enzymes in the body that would naturally destroy it. Researchers protected the mRNA in the vaccine by wrapping it in a bubble of lipids that help it avoid destruction. Other ingredients in the shots like polyethylene glycol, which is part of this lipid envelope - could cause allergic responses.

IF I FEEL SICK AFTER MY SHOT, DOES THAT SIGNAL STRONG IMMUNITY?

Scientists haven't identified any relationship between the initial inflammatory reaction and the long-term response that leads to protection. There's no scientific proof that someone with more obvious side effects from the vaccine is then better protected from COVID-19. And there's no reason that having an exaggerated innate response would make your adaptive response any better.

Both the authorized mRNA vaccines provided protective immunity to over 90% of recipients, but fewer than 50% reported any reaction to the vaccine and far fewer had severe reactions.

# COVID: Is it OK to manipulate people into getting vaccinated?

ored Panda, a website that pub-Dlishes "lightweight and inoffensive topics", reports an allegedly true case from the US of a woman who refused to have her child vaccinated. The woman, who is described as a "conspiracy theory magnet", provided 15 reasons why vaccines are more harmful than the disease they protect

When the doctor realised that he wouldn't be able to dissuade her of her beliefs, he decided to present her with another one:

Have you considered the possibility that anti-vaccine propaganda could be an attempt by the Russians or the Chinese to weaken the health of the United States population?

The doctor deliberately deceived the woman and probably reinforced her belief in conspiracy theories by pretending to find them plausible himself. But the tactic worked. The mother consented to have her child vaccinated.

Right now, vaccination is key to overcoming the COVID-19 pandemic and regaining safe individual freedom. Yet a minority of people, like the woman in our example, still refuse vaccination on mistaken beliefs. But how far can we go to change their minds?

in using similar tactics to make the woman consent to her own COVID-19 vaccination?

THE BEST-INTERESTS VIEW

Support for the doctor's unconventional approach might come from a view recently developed by philosopher Moti Gorin and colleagues. They argue that a patient's best interests should be a doctor's primary guide in influencing medical decision-making, at least in situations where the doctor cannot mitigate severe biases through an open conversation.

Gorin and colleagues think about best interests objectively: such interests should be understood according to professional standards, not just in terms of what happens to be a person's preference. And they emphasise that respect for a patient's autonomy doesn't "require that all patient preferences be honored, regardless of how informed or competent they are". Sometimes, we are allowed or even required to override them.

If we apply this view to our case, we seem to get a clear result: assuming that vaccination is in the woman's best interests and that the doctor cannot change the mother's mind through an open conversation, the manipulative counter-question was permissible and completely justified.

But we might still feel uneasy.

Would the doctor be justified After all, the doctor deliberately induced a false belief in the woman and deceived her about his intentions. For this reason, we should look for another perspective on this case.

THE DISQUALIFICATION VIEW

The early modern legal theorist Samuel Pufendorf can help here. In his work on contracts, Pufendorf claimed that consent is invalid and obtained impermissibly if the consent-receiver - in our case, the doctor - "disqualified" himself by violating the norms of his role.

A doctor is bound by professional norms, which include, at a minimum, the obligation not to deceive patients. But our doctor engaged in deception and thereby disqualified himself.

This "disqualification view" gives us a verdict directly in opposition to the best interest view of Gorin and colleagues. And it is this disqualification view that we ought to adopt.

The disqualification view, unlike the best interests view, remains faithful to central medical norms. Particularly during a pandemic where public trust in the medical profession is key, allegiance to such a norm must be secured.

It is simply not worth sacrificing central medical norms to change the minds of the few "conspiracy theory magnets" out there and thereby risking the erosion of public trust in the medical profession.

From the perspective of public health, the few people who strongly adhere to conspiracy theories do not pose a real threat. And from the perspective of their individual health. people's adherence to conspiracy theories, which are immune to rational circumspection, could justifiably be seen as their own responsibility rather than something doctors have to overcome by deception.

So, how far can we go to convince people who believe in conspiracy theories that their views are wrong? Well, rational persuasion should be a doctor's first choice. If this remains unsuccessful, there are still various other types of influence consistent with professional norms. For instance, a doctor could still nudge a person into deciding at a later point to cool down, frame information in a certain way, or make certain pieces of information very salient, for example, by using pictures and videos, at least as long as doing so assists balanced decision-making.

All of these influences can make a difference and be consistent with professional norms. Sometimes, however, they might not make a difference at all. If so, we should simply accept that.

# "Hollow, without substance": Mamata Banerjee on new central vaccine norms

NEW DELHI, 20 APR [NDTV]: West Bengal Chief Minister Mamata Banerjee today criticised the Centre's new COVID-19 vaccine policy, calling it "hollow and without substance". She accused Prime Minister Narendra Modi of allowing open market sales after depleting the stocks by sending shipments abroad.

In a letter to PM Modi, Ms Banerjee asked him to design an alternative policy that would help people buy doses at affordable rates.

"I'm informed that the Central government has announced the much-delayed 'universal' vaccine policy on 19th April, 2021, which appears to be hollow, without substance, and a regrettable show of evasion of responsibility... at the time of crisis," she wrote in the letter today.

"When the number of cases...is spiraling...the



Centre has chosen to tactically indulge in empty rhetoric..." she wrote, reminding PM Modi that he had not responded to her April 24 letter seeking permission for West Bengal to purchase vaccines directly.

The Centre yester-

day opened up vaccinations for all adults from May 1 and allowed state governments to procure stocks from the manufacturers as well as the open market. In recent weeks, several states had called for opening up the vacci-

nation drive for people of

all ages and complained about vaccine shortage.

Ms Baneriee's letter today sought to punch holes in the Centre's revised vaccination policy saying it might lead to "unscrupulous mechanisms" in the market.

"The announcement

does not address major issues like the quality, efficacy, stable flow of supply...it (vaccine policy) appears to be based on market prices which may put the common people under huge financial burden," she wrote.

Addressing an election meeting in Murshidabad, the Trinamool Congress founder said PM Modi had exported vaccines to other countries to boost his image while states like Maharashtra, Delhi, Rajasthan, and West Bengal have struggled to get doses they required to combat the COVID-19 pandemic, PTI reported.

"Yesterday the PM said the medicine (vaccine) will be available in the open market. Where is the open market, where is the availability? You have already shipped out the majority of stock to foreign destinations." she alleged, according to PTI.

### 920 pigs die of African Swine Fever in Mizoram in less than a month



AIZAWL, 20 APR [PTI]: At least 920 pigs died due to African Swine Fever (ASF) in less than a month in Mizoram, an official said on Monday.

Four districts have been affected by the ASF that was first reported on March 21 from Lungsen village in south Mizoram's Lunglei district near the Bangladesh border, Animal Husbandry and Veterinary Department's Joint Director Lalhmingthanga told PTI.

So far, 577 pigs have died in Lungsen village, and 32 died in the Electric Veng area of Lunglei town. Besides, 78 died in the Edenthar neighbourhood and 74 in the Armed Veng locality of Aizawl, he said.

Further, 159 pigs died in three villages of Mamit district, while a detailed report from Serchhip is awaited, he added.

Lungsen in Lunglei district, Zawlnuam in Mamit district, Keitum in Serchhip district have been declared as "infected" areas to stop further spread of the disease. In Aizawl, three localities -- Bawngkawn, Armed Veng and Edenthar have also been identified as "infected" areas. Electric Veng, Salem Veng and Rashhi Veng in Lunglei town have also been declared as "infected" areas.

ASF is a highly contagious and deadly viral disease, affecting both domestic and feral swine of all ages.

Experts said that it is not a threat to human health, and cannot be transmitted from pigs to human beings.

## Overflowing sewer, dug-up road greet patients at some of Kathmandu's big hospitals

KATHMANDU, 20 APR [KATHMANDUPOST]: On Friday Bishnu Khanal, 46, took his mother-in-law Narayani Nainawasti, 86, for her eye surgery to the TU Teaching Hospital, Maharajgunj, but when he stopped the taxi in front of the BP Koirala Lions Center for Ophthalmic Studies, he was shocked to see the overflowing sewage at its gates.

"It's stinking sewage, and I had to be very careful in crossing the leaked sewage as she could barely see what was there," said Khanal.

Like Khanal, hundreds of patients, dozens of doctors and hospital staff are compelled to put up with the foul smell and need to be extra careful while walking on the road. Not only for eye patients, the leaked sewage has troubled those who need to visit the emergency ward.

"People go to the hospital for treatment but the foul smell and this mismanagement makes normal people irritated. This is so embarrassing to see the stinking sewage on the premises of such a big and reputed hospital," said Khanal who came from

It's not only Khanal, Babulal Lama, 50, who has been running canteen on the premises of the eye hospital for the past seven years said the leakage of drain has been taking place for the past four years and the hospital administration has done nothing to resolve the problem.

Urban planners say that the drainage and garbage problem on the hospital premises should be managed by the hospital itself. "The hospital should be more sensitive about the issue," said Kishor Thapa, a former government secretary and an urban planning expert.

"Because of the foul smell, people hardly come to my canteen. Even doctors and staff are facing this problem but nobody bothers to repair the system," said Lama.

When the Post contacted Kamal Ghimire. administration chief of the Ophthalmic Studies, he acknowledged the problem and said the problem is beyond the hospital's capacity to solve. "We all are suffering, we are trying our best to solve this issue but we have failed about it," said Ghimire.

He blamed the Bhat-Bhateni Superstore. which has been constructing an annex at the hospital, for the sewage overflow. "Bhatbhatani has been constructing an emergency building for TU Teaching Hospital, but it didn't consider the management of drainage. until Bhatbhatani opens it, the problem won't be solved," said Ghimire.

When the Post contacted Min Bahadur Gurung, the chairman and managing director of Bhat-Bhateni Group to inquire about the problem, he said the accusation is baseless. "As per our charity efforts, we are constructing a building for the hospital and have allocated Rs 150 million for the work, do you think we do not consider the drainage system?" said Gurung. "That is why there is no working condition in Nepal," Gurung added.

This is not only the case of the TU Teaching Hospital, the sewage problem has been a perennial problem for Bir Hospital, the country's oldest hospital. With multiple complaints from the general public, doctors

and staff from the Trauma Center and Bir Hospital, the Kathmandu Metropolitan City and Kathmandu Upatyaka Khanepani Limited had said they had sorted out the problem a few months ago.

"But when it rains, the roads in front of the Bir Hospital and Trauma Centre get waterlogged with drain water," said Nanda Lal Sah, 40, who runs a juice shop below the overhead bridge that links the Khula Manch and the Bir Hospital. When the Post reached the area on Sunday, still the western side of the road, that is linked with Bir Hospital and Truma's footpath and up to New Road Gate, one could see the sewage with foul smell on the roadside.

"Now summer has come. It will be really difficult to breathe here if this sewage problem is not addressed properly," Shah said.

When the Post contacted Dr Peeyush Dahal, dean at the National academy of Medical Sciences, at Bir Hospital he said this problem was a genuine concern. "This problem should be solved permanently as it is very sensitive. Local, federal and central governments should work together to solve this problem," said Dahal.

Meanwhile, the road that leads to Prasuti Griha from Thapathali Chowk has been dug for over a month, and has been left full

Samjhana Dhungana, whom the Post met at the maternity hospital's gate who was discharging her niece who gave birth on Saturday, said she was shocked to see the bumpy road section and the trouble faced by the pregnant women visiting the hospital.

"Last week when we brought my niece during night-time for child delivery, it was raining and the road was bumpy and was slipperv at the same time, and now it's sunny and it's too dusty. Imagine its impact on pregnant women and the newborn," said Dhungana, 30, who came from Kapan.

Apart from the bumpy and dusty road, leaking sewage in front of the Norvic Hospital is a perennial problem and though Norvic is taken as a hospital for VVIP people, its entry gate stinks of the sewage and the road has been left bumpy for over a month.

Krishna Prasad Pandey, 40, who has been running Palpali Bhojanalaya for the past 14-years in the area said his business has gone down due to the dusty road. "People refuse to come here to eat because of the dust, also we can't live without masks, more than of the Coronavirus, we are fed up with the dust," said Pandey.

"If the road that leads to the country's two finest hospitals seated in juxtaposition has not been maintained for over a month, you can imagine other places," said Pandey. He said he is fed up with cleaning his eatery every morning with water as a pile of mud gets inside with the little customer who

When the Post contacted ward-11 chairperson Hiralal Tandukar under whose jurisdiction the construction work has been taking place at Thapathali, to inquire about the treacherous road condition, he admitted of being late. "It's because we need to be very conscious while digging the area as there are underground telephone cables, Melamchi water pipe lines and electricity lines, this area is very complicated," said Tandukar.

He said a total of Rs 30 million has been allocated for repairing the inner road from Thapathali to Babarmahal, and for overall management work such as laying the drainage pipe and maintaining and widening the footpaths.

"There is a separate committee formed that includes the traffic police, and officials from Norvic Hospital and Prasuti Griha to coordinate the work. We will complete this work as soon as possible,' said Tandukar.

However, the local shop owners say the road section is the most vulnerable, and that gets dug time and again under various pretexts and left in a sorry state.

Urban planners say that hospital areas are sensitive zones, therefore the local governments and the hospital administration themself should be extra cautious.

"If there is a drainage issue inside the hospital premises, the hospital administration should look into the problem, and in case of Thapathali and Bir Hospital, it's the local body that should work on it without any delay," said Thapa.

After the local election in 2017, it's the local government's responsibility to look after the city's infrastructure and its maintenance, but the Kathmandu Metropolitan City has been saying that it's the Kathmandu Upatyaka Khanepani Limited's Department of Water Supply and Sewerage which should look into the issue and there is a blame game going on.

"For the problem at Thapathali it's KMC's responsibility, but for the Bir Hospital KUKL is responsible, but the KMC has been voluntarily helping to resolve the problem at Thapathali," said Ram Thapa, Chief of Physical Infrastructure Department at the city.

Meanwhile, Milan Kumar Shakya, acting manager at KUKL says it has already installed a bypass drain line. "The logged water might have leaked from the drinking water pipe. I will send our official to inspect the area," said Shakya. "Last time we solved the problem because the whole blame was put on us though the city office is equally responsible for it, we are committed to addressing this problem."

There has been a lot of commitment from the officials in the bureaucracy towards solving the issue. Before being elected as the city's new mayor in May 2017, Bidya Sundar Shakya in his election manifesto had pleaded to solve Kathmandu's drainage problem as his first priority, but the problem is intact even after three years.

Another urban planner Suman Mehar Shrestha says such a tendency among government officials shows how weak our bureaucracy is at the implementation level.

"Everyone knows that hospitals are sensitive locations, doctors keep on lecturing about personal hygiene but looking at the hospitals and the mismanagement of their surroundings and the infrastructure shows how backward we are in practical approach," said Shrestha.

"If the problem of hospital's drain or hygiene is not addressed on time, this may someday cause another pandemic; this is a serious issue and it should be addressed without delay," said Shrestha.

## Rajnath Singh asks armed forces to help states amid COVID-19 surge: Report

NEW DELHI, 20 APR [PTI]: As India reels under a massive spike in coronavirus cases, Defence Minister Rajnath Singh has asked the army to extend assistance to state administrations to deal with the pandemic, including by offering help in creation of additional capacities to treat COVID-19 patients.

Sources in the security establishment told news agency Press Trust of India that following Rajnath Singh's communication to Army Chief Gen MM Naravane, it was decided that the Army would consider offering treatment to civilians in its medical facilities, wherever possible, besides extending other assistance to civil administrations.

"Rajnath Singh has conveyed to Gen MM Naravane that the Army units in various states can get in touch with state administrations to understand their requirement like creation of additional capacities to deal with increasing volume of patients. Subsequently, it was decided that the senior-most army officer in a state would get in touch with



wherever possible," they The sources told Press Trust of India that the Defence Minister has been in touch with the top brass of his ministry and the three forces on how the civilian administration across the country could be assisted in battling the COVID-19 situation.

offering to treat civilians

The sources further said that it was also communicated to the leadership of the Indian Air Force and the navy to gear up their preparedness in dealing with the situation.

Separately, Defence Secretary Ajay Kumar reviewed the possible areas where the armed forces can extend assistance to the civilian authorities.

Following his review,

the Defence Ministry instructed 67 hospitals run by Cantonment Boards across the country to ensure medical services to cantonment residents as well as those from outside. The Defence Research and Development Organisation (DRDO) has already been told to extend all possible assistance it can extend to civil administrations across the country.

The DRDO has already reopened a medical facility near the Delhi airport for treatment of COVID-19 patients. The facility has been made operational with 250 beds and their number is being increased to 1,000.

The premier organisation is coming up with a similar facility in Lucknow.

India has witnessed a massive spike in coronavirus infections as the country recorded over two lakh cases daily in the last five days.

## Liverpool draws at Leeds amid criticism of Super League role

LEEDS, APR 20 (AP): Liverpool conceded an 87th-minute equalizer to draw at Leeds 1-1, denying Jurgen Klopp's team a spot in the top four of the English Premier League.

Which position Liverpool finishes might not matter anymore, given the team is one of the 12 clubs behind the creation of a controversial Super League that is threatening to split the historic structure of European soccer.

breakaway league could potentially launch as early as next season, rendering meaningless the race for Champions League qualification that currently involves Liverpool, Chelsea and Tottenham three of the six rebel English clubs. Liverpool stayed in sixth place, outside the Champions League places, after Spain defender Diego Llorente scored with a header from an inswinging corner to earn Leeds a point that the team's second-half

deserved.

Sadio Mane on Monday stroked the ball into an empty net in the 31st minute from a squared pass from Trent Alexander-Arnold to give Liverpool the lead and put the deposed champion on course for a fourth straight victory.

Ham and into fourth place. Liverpool came in for lots of criticism ahead of the game from its own fans and those of rival clubs for being greedy and damaging the integrity of the English and wider game because of its role in the Super League plans. The club's American ownership bore the brunt of the criticism but the players were jeered and verbally abused as they arrived at Elland Road.

Leeds' players wore T-shirts during the warmup, which had the words "Earn it" on the front and Football is for the fans on the back seemingly a message to the rebel clubs.

# **UEFA** president urges Super League owners to reverse decision



MONTREUX. SWITZER-LAND (AP): In a direct appeal to the owners of the English clubs in the Super League project, UEFA president Aleksander Ceferin urged them Tuesday to change their minds out of respect for soccer fans.

Ceferin both cajoled and criticized the six-club English group — made up of American billionaires. Middle East royalty and a Russian oligarch less than 48 hours after the Super League was launched in alliance with three clubs from each of Italy and Spain.

"Gentlemen, you made a huge mistake," Ceferin said in a speech to European soccer leaders at the UEFA annual meeting. "Some will say it is greed, others (will say) disdain arrogance, flippancy or complete ignorance of England's football culture. It does not matter.

"What does matter is

that there is still time to change your mind. Everyone makes mistakes."

Ceferin urged them to turn back out of respect for fans in England, aiming another barb at what he earlier called "a few selfish people."

"Come to your senses," he said. "Not out of love for football because I imagine some of you don't have much of that."

Ceferin also lavished praise on UEFA executive committee colleague Nasser al-Khelaifi, the president of French champion Paris Saint-Germain. PSG has so far resisted offers to be one of the 15 founding Super League members. Bayern Minich and Borussia Dortmund have also stayed out.

"Nasser, thank you from the bottom of my heart. You showed that you are a great man," Ceferin told the Qatari official before also citing Bayern chief executive Karl-Heinz Rummenigge.

The UEFA president also spoke about an email he received from a fan of Tottenham, one of the six rebel clubs from the Premier League.

"If you read the email you would be close to crying," Ceferin said of the fan he identified only as Trevor, whom he had given two tickets to the 2019 Champions League final, when Tottenham lost to Liverpool.

Ceferin said fans and governments have supported UEFA in resisting the proposed 20-team Super League, which threatens to directly challenge the Champions League and damage the historic pyramid structure of European soccer.

"We cannot lose this match," said Ceferin, a Slovenian lawyer.

The clubs have not said when their planned breakaway league, underwritten by American

bank IP Morgan Chase. would kick off.

On Monday, Ceferin said he wanted Super League clubs and their players banned from all UEFA competitions "as soon as possible."

It is unclear if UEFA's legal statutes and Champions League rules will allow that before Real Madrid, Chelsea and Manchester City play in the semifinals next week. Manchester United and Arsenal also play next week in the Europa League semifinals.

Earlier Tuesday in a speech that seemed to blame the club owners and absolve players, FIFA president Gianni Infantino said he can only "strongly disapprove" of the Super League. "If some elect to go their own way, then they must live with the consequences of their choice," Infantino said. "They are responsible for their choice."

## Moeen Ali brings all-round value to CSK: head coach Fleming

MUMBAI, APR 20 (PTI): Chennai Super Kings head coach Stephen Fleming feels that England player Moeen Ali has strengthened the team as he brings allround value to it, which was missed in the last IPL season. Fleming said Ali's impressive batting at No. 3 has been instrumental in the team getting good scores so far this season.

"He is adding an all-round aspect to our game which we lacked last year," Fleming said of Ali, who hit a quickfire 26 and returned with figures of 3/7 in CSK's 45-run win over Rajasthan Royals on Monday night. "His contribution was just what we were looking for. We are absolutely happy with the way he has started," Fleming said at the postmatch press conference.

The head coach said his team has not played "a good 20 overs with the bat" yet but still getting high scores.

"I'm really excited about the way we are playing. The long resource we have, we're using and we are pushing opposition hard. So we are playing a positive brand throughout," the former New Zealand captain said.

He said captain Mahendra Singh Dhoni would get better as he spends more time in the middle. Dhoni scored 18 off 17 balls after coming at number five. "Yes, his form is restoring, every time he gets some balls in the middle he's going to get better and better,"

Fleming said. "There will be opportunities where we would probably look to throw MS Dhoni up as with (Ravindra) Jadeja and others." Fleming said because of the "many resources" his team has, it's facing the challenge of managing the batting order.

"At the moment we are just trying to be a solid order and look for simple parts of the game and what the conditions provide us in terms of how we can attack.

"We know we have got a lot of batting and the way we are playing is really encouraging. We haven't put together a perfect innings by any means but the skipper will be a big part of it going forward," Fleming added.

He said the team will continue to back opener Ruturaj Gaikwad (10) despite his struggles and failing for the third straight game.

## 31 new cases take COVID-19 tally of Andamans to 5,421

PORT BLAIR, APR 20 (PTI): The COVID-19 tally of Andaman and Nicobar Islands rose to 5,421 on Tuesday as 31 more people tested positive for the infection, a health official said.

Nineteen new patients have travel history, while 12 fresh infections were detected during contact

tracing, he said. The Union territory now has 145 active cases, while 5,212 people have recovered from the disease and 64 patients have succumbed to the infection to date, the official said.

The administration has so far tested over 3.53 lakh samples for COVID-19, he said.

A total of 13,418 health workers have received the first dose of the COVID-19 vaccine, while 8,335 have been administered the second jab thus far, the official said.

Around 64,804 people aged above 45 have been administered the first jab, while 281 have received the second dose, he added.

# Hungary's poor Roma children struggle with digital education

BODVASZILAS, Hunga-RY (AP): Mihaly Horvath, a 12-year-old in a village in northeastern Hungary, can't wait for his school to reopen.

As a devastating COVID-19 surge swept Hungary in the spring, classes were suspended and students were ordered to study online. But Mihaly's family, part of Hungary's large Roma minority, doesn't have a computer or internet access at their home in Bodvaszilas, and he says he's falling behind in his lessons as a result.

"Some students have telephones, some have computers. But there are others like me who don't have either," he said from the yard of a dilapidated house where he lives with nine other family members. "It's more difficult for Gypsy kids like us. Some don't even have writing utensils or anything else."

His is one of thousands of Roma families in Hungary that have been particularly hard hit by the pandemic. Many already marginalized Roma adults lost work as Hungary's economy buckled under coronavirus lockdowns, pushing their families deeper into poverty. Some have reported selling their belongings, like mobile phones, to make ends

et. Karmen Bastyur, Mi-



haly's great aunt, said most of the Roma children in Bodvaszilas don't have access to digital devices and aren't completing printed homework assignments given out by the school.

"There's no help for them. (Mihaly) can't take advantage of online education since we don't have a computer," she said. "It would be easier because he could talk with his teacher who could help him with homework that he doesn't understand."

According to an August 2020 survey by the National Democratic Institute, a U.S.-based nonprofit organization, only 41% of Roma households in Hungary have access to both cable and mobile internet and 13% report no access to the internet at all.

A November 2020 report from Hungary's deputy ombudsperson for national minorities acknowledged that for Roma children from poor families, "the transition to digital education multiplied their already existing disadvantages."

Mihaly's relatives, like many Roma, rely on seasonal work or informal day labor for income. But business closures and other pandemic restrictions have caused them to lose work, leading to deeper impoverishment and food insecurity.

David Vig, director of the rights group Amnesty International Hungary, said the state has done little to help such workers, who were ineligible for unemployment benefits or wage support when their jobs disappeared.

"There is zero labor protection for those who work in (day labor)," he said. "Any COVID-related state support, if you don't have an official (work) contract, is not there."

Roma make up nearly 10% of Hungary's population, according to some estimates, and many live in one of the 1,300 segregated slums across the country.

Bodvaszilas is located in one of the least-developed regions in the 27-nation European Union. It's GDP per capita was only 40% of the EU average in 2013, according to Eurostat.

The local municipality provides one hot lunch to school-age children each weekday, in place of the free meals students normally receive at school. But Mihaly's family still struggles to put enough food on the table.

"Sometimes me and my husband don't eat and rather leave the food for the children," said Bastyur, who lives with Mihaly in the three-bedroom house along with children, grandchildren and cousins.

Two weeks ago, the family was told that the small, decaying house they rent had been sold and they must be out in a month or police would be called to evict them.

"He told us to clean up the yard, clean the house, remove all our furniture and leave. But we don't know where to go," Bastyur said.

"Our dream would be to have our own place where the kids could live in peace ... so me and my two grandchildren won't have to live in this misery," she said, through tears.

On Monday, Hungary reopened kindergartens and the first four grades of elementary schools. Mihaly is looking forward to May 10, when his grade can return to in-person classes. But by then, his family isn't sure he'll have a house to come home to.

# Israeli police scuffle with protesters in Arab neighborhood

JAFFA, ISRAEL (AP): Israeli police scuffled with protesters in an Arab neighborhood near Tel Aviv for a second night late Monday after the assault of a rabbi over the weekend.

The protesters, in-

cluding Arabs and Jews, say Jewish nationalist religious groups are buying up property in the traditionally Arab district of Jaffa, which has rapidly gentrified in recent years as luxury housing has gone up. Video taken by The Associated Press late Monday showed protesters and plainclothes police pushing and shoving as the police appeared to take a young Arab boy away in an unmarked squad car with flashing lights.

The police said a "young male" was briefly detained for setting off fireworks and



then released "due to his age" without providing further details

ther details.

The latest tensions began Sunday when two Arab men punched and kicked Rabbi Eliyahu Mali, the head of a local yeshiva, while he was out looking at properties, according to local media. Police arrested the men, and right-wing politicians condemned the attack as a hate crime.

Rival protests were held that night, with police forming a barrier between religious Jews condemning the attack and mostly Arab residents demonstrating against police. Some protesters later hurled rocks and fireworks at the police.

Jaffa was a major trading port before the creation of Israel and the Arab-Israeli war of 1948, when many of its Palestinian residents fled or were driven from their homes. They joined a larger exodus of some 700,000 refugees from what is now Israel. Today, Jaffa is a trendy district adjacent to Tel Aviv that is home to both Jews and Arabs.

# Portland police make 2 arrests amid protest vandalism



PORTLAND, ORE. (AP): Some people in a small crowd calling for the abolition of police broke windows as they marched in Portland on Monday night, hours after authorities said that a man who was fatally shot by an officer in a city park last week had an orange-tipped replica gun.

The Portland Police Bureau said on Twitter late Monday it had made two arrests for criminal mischief after declaring the assembly of about 80 people in northeast Portland unlawful. Windows were broken at a bank building, a fast-food restaurant, a grocery store and at a Boys and Girls Club, the department said.

The protest followed the police killing Friday of Robert Douglas Delgado, 46, who had reportedly been acting like a cowboy and doing "quickdraws" with what appeared to be a handgun in Lents Park. Delgado's gun turned out to be a replica with an orange tip, which is typically intended to distinguish toy guns or BB guns from functioning firearms.

The police investigation into the shooting was hampered by a crowd of "fairly aggressive people" who showed up at the park after the shooting. Demonstrators that night broke windows, burglarized businesses and set fires, and police made four arrests after declaring a riot.

Portland has been the scene of regular protests, many involving violent clashes between officers and demonstrators, since the police killing of George Floyd in Minneapolis in May. There were demonstrations for more than 100 straight days last summer, and earlier last week, a crowd set a fire outside the city's police union head-quarters following recent fatal police shootings in Chicago and Minneapolis.

Portland police on Monday issued a timeline of events as well as dispatch audio around the time of Delgado's shooting. The first officer arrived at 9:36 a.m. with others arriving shortly after, and within about four minutes officers reported Delgado had been shot and was down.

Police haven't said what happened before he was shot. Delgado was shot by officer Zachary DeLong from about 90 feet (27 meters) away, police said, while two officers fired a 40mm device that shoots non-lethal projectiles.

It wasn't clear why DeLong fired his rifle as others were using less-lethal options. According to dispatch radio traffic, DeLong had reported that Delgado was "very noncompliant" and had been making obscene gestures toward officers.

"I think the gun's in his back pocket," DeLong radioed to dispatch at one point.

An ambulance was called and by 9:48 a.m., officers were performing CPR on Delgado, who died of a single gunshot wound, police said.

DeLong is on paid administrative leave, authorities said.

Latino groups want DOJ probe

of shooting by Chicago police

CHICAGO (AP): Latino lawyers and community leaders on Tuesday will ask the Department of Justice to investigate the fatal shooting of a 13-year-old boy by a Chicago police officer.

The group also will call on Mayor Lori Lightfoot to accelerate court-supervised changes to policing in Chicago, end foot pursuits by officers, and to invest federal COVID relief dollars to help young people in the neighborhood where Adam Toledo lived and died.

Officer Eric Stillman was responding to a call of shots fired around 3 a.m. on March 29 when he chased Adam into a dark alley in the Little Village neighborhood, a predominantly Latino area southwest of downtown. Bodycam video released last week shows the youth appearing to drop a handgun and begin raising his hands less than a second before Stillman fires his gun and kills him. His bodycam footage later shows Stillman shining a light on a handgun on the ground near the boy after he shot

Stillman is white and Adam was Latino. The video prompted grief and demonstrations in Chicago, a city with a long history of police misconduct and distrust between police and the community, especially among Black and Latino residents. It also came against the backdrop of a trial in Minneapolis for former Officer Derek Chauvin in the death of George Floyd and of another killing of a Black man, Daunte Wright, by a white officer in a Minneapolis suburb.

Lightfoot has said the city must allow its independent review agency to complete its investigation, but that she understands "that the surge of outrage around it is rooted in a long legacy of trauma in our city and country around police violence."

Chicago agreed to hundreds of changes in policing under a consent decree approved by a federal judge in 2019 after a Justice Departinvestigation found a record of racism and abuse by Chicago police, going back decades. The investigation was prompted by the 2014 killing of Laquan McDonald, a Black 16-year-old, by a white officer. Jason VanDyke was later convicted of murder for shooting the teen 16 times, video of which the city fought to suppress.

# Will continue to bat the way I love to, says RR skipper Samson

MUMBAI, APR 20 (PTI): Rajasthan Royals captain Saniu Samson is not bothered about failures and said he would continue to play his shots and keep on batting the way he loves to in the ongoing Indian Premier League. Samson scored a blistering ton in the first match which Royals lost narrowly to Punjab Kings but failed to come good against Delhi Capitals and against Chennai Super Kings on Monday night.

"Yeah, actually it keeps on happening in this format of the game. I think IPL definitely demands a lot of risk-taking shots. And I said before when I succeeded, I took a lot of risks. That's why I scored a hundred. So, it depends actually on the day, the mindset you are coming with," Samson said at the post-match press conference after RR lost to CSK by 45 runs here on Monday night.

"Actually, I don't want to restrict my shots, I want to keep on playing my shots and keep on batting the way I love to bat actually. So, I'm also accepting a lot of failures on the way. So, I am not at all worried about getting out, but at the same time, I will definitely look to keep on contributing to my team's victory in the coming matches."

He said the IPL is a long tournament and it was normal to fail in a few matches.

"Pressure to perform

is always there. When you play IPL, pressure is always there. Sometimes you succeed and sometimes you fail. I think IPL is a long format and you play 14 continuous matches, it is very normal to fail in a few matches. "(But) it is always crucial to remember how good a team we are...So, we'll keep on coming back and keep on trying to win the coming matches," Samson said.

Samson said the chase on Monday night would have been easy if dew had come in.

"Looking at the previous matches, we played here or which we watched on the TV, I

think bowling first has more advantage than bowling second. So that's why we opted to bowl first and actually restricting CSK around 180 was really good work by our bowlers.

"I thought if the dew comes on and the wicket eases out a bit, it would have been an easy chase for us actually," he added. Asked about the bat-

ting order, the RR captain backed Shivam Dube, who could not get going on Monday, for the crucial No 4 position. "I think our batting


#### China rejects accusations of abuses in Xinjiang

**BEIJING (AP):** China's government on Tuesday rejected accusations of abuses in the Xinjiang region after a human rights group appealed for a U.N. investigation into possible crimes against humanity. Accusations of forced labor or detentions in the northwestern region are "lies and false information concocted by anti-China forces," said a foreign ministry spokesman, Wang Wenbin. He accused critics of trying to "undermine Xinjiang's stability and security and curb China's development."

On Monday, Human Rights Watch appealed to the U.N. Human Rights Commission to investigate reports of mass detention of Muslims, a crackdown on religious practices and other measures against minorities. It said they amount to crimes against humanity as defined by the treaty that established the International Criminal Court.

More than 1 million people have been confined to camps in Xinjiang, according to foreign governments and researchers. Authorities there are accused of imposing forced labor and birth controls.

Beijing rejects complaints of abuses and says the camps are for job training to support economic development and combat Islamic radicalism. The government is pressing foreign clothing and shoe brands to reverse decisions to stop using cotton from Xinjiang due to reports of possible forced labor.



# Byron Bay locals protest planned Netflix reality series 'Downton Abbey 2'

CANBERRA, AUSTRALIA (AP): Angry Byron Bay locals are protesting the filming of a reality television series that some fear will damage the reputation of their trendy Australian tourist town.

Around 100 surfers paddled to sea Tuesday to form a cancel symbol off the coast of the New South Wales state town in the hope that Netflix will can the series about social media influencers.

Several Byron Bay businesses have refused to sign filming permits that would allow "Byron Baes," a contemporary abbreviation of "Byron Babes," to be shot on their premises.

"It's potentially going to threaten businesses if the portrayal of Byron is as absurd as I guess a lot of the doco-soap-reality shows are," Byron Shire Mayor Simon Richardson told Australian Broadcasting Corp.

"As a community, we should have a right to be able to not be exploited and to go about our business and also just have a community that has its real and genuine concerns and challenges shared rather than a picture postcard filmed with people who have potentially been here for five minutes," Richardson added.
