At 3,062, Mumbai reports highest daily rise in Coronavirus Cases

MUMBAI, 19 MAR [PTI]: Mumbai has reported its biggest hike in coronavirus cases for the second consecutive day. The Maharashtra capital that had logged 2,877 cases yesterday, recorded 3,062 Covid cases in the last 24 hours, which is the city's highest single-day increment in its total cases ever.

With this, Mumbai's total of active cases has reached 20,140, whereas its overall coronavirus total is 3,55,897. The city's recovery rate settled at 91 percent; 1,334 people were discharged today.

10 people died in the last 24 hours because of the illness, taking the total count of deaths in the city to 11,565.

The daily figure in Maharashtra is slightly lower than yesterday. The state had logged 25,833 fresh cases on Thursday - highest since the outbreak of the pandemic last year. Today, it reported 25,681, which is over 60 per cent of the countrywide total of daily coronavirus cases.

3 new cases, 3040 vaccinated

GANGTOK, 19 MAR:

Three new cases of novel coronavirus were reportded in Sikkim in the last 24 hours. Of the three new cases, one person from East District and two from West District were found positive for COVID-19 in the testing of 147 samples on Thursday.

Meanwhile, the State has witnessed two more recoveries to improve the figure of recovered cases in Sikkim to 5918. The state tally of confirmed cases of COVID-19 reported so far has reached 6199 and there are now 49 active cases of novel coronavirus in Sikkim.

In his daily health bulletin on Friday, Health Department State IEC Officer, Sonam Gyaltsen Bhutia informed that all three new cases were detected in rapid antigen testing of 30 samples, while 115 samples tested by RT-PCR and 02 by TrueNat testing were returned negative for COVID-19.

While giving details of new cases, he said that samples of one person from Metro Point, Tadong in East District and two from Dentam in West District were found positive for COVID-19.

On the other hand, 3040 persons received COVID vaccination shots in different parts of Sikkim on Thursday, in which 2515 persons received the first dose of the vaccine and 525 persons have completed the vaccination schedule with the second shot of the vaccine.

Mr Bhutia informed that 133 healthcare workers [72 first dose & 61 second dose] and 579 frontline workers [115 first dose and 464 second dose] received COVID vaccination yesterday in different parts of the State. He further added that 484 persons in the age group of 45 to 59 years with comorbidities and 1845 persons in age group of 60 years and above have also received the first dose of the vaccine.

In district-wise break-up, 1452 persons have received first dose of COVID vaccine and 274 were given second dose in East District, while 481 persons have got the first dose and 64 received the second dose of vaccine in West District.

In North District, 382 persons received the first dose of vaccine and 03 have completed the vaccination schedule with the second dose. In South, 254 persons received the first dose of vaccination and 184 got the second dose.

Also, 120 healthcare workers [62 first dose & 58 second dose], 308 frontline workers [92 first dose and 216 second dose], 167 persons in age group of 45 to 59 years and 1131 persons in age group of 60 years and above were vaccinated for COVID-19 in East District.

In West District, 02 healthcare workers [1 first dose & 1 second dose], 65 frontline workers [02 first dose and 63 second dose], 131 persons in age group of 45 to 59 years and 347 persons in age group of 60 years and above have received their vaccine shots.

Trinamool MPs go to Election Commission, claim free, fair polls a "distant reality"

New Delhi, 19 Mar [PTI]: Alleging that fair elections in West Bengal are becoming a distant reality, a delegation of TMC MPs met the Election Commission on Friday to register their protest against the poll panel's reported decision to not permit state police personnel within 100 metres of polling stations.

The TMC parliamentary delegation, including Saugata Roy, Yashwant Sinha, Md Nadimul Haque, Pratima Mondal and Mahua Moitra, described the Election Commission's approach as partisan and biased.

"It is becoming in-

creasingly free, fair and transparent elections in State of West Bengal is becoming a distant reality. This is evident from the partisan and biased approach

ongoing elections in the State, a memorandum submitted to the top poll panel said.

"On the first count, it has been reported in media that the ECI has decided to not permit presence of State police within 100 m of polling

Central Forces in such arena. If true, this decision is unprecedented and casts severe aspersions on the reputation of the police administra-

> tion in the State of West Bengal," it added. The memorandum

said this needs to be substantiated at the appropriate level.

Stating that the ECI's decision is only for West Bengal and not the other four poll-bound states in the country, the Trinamool Congress said the deployment of central forces should be to help the state government deal with law and order and "not deliberately demonise the state police personnel that have worked under different governments".

Tejashwi Prasad Yadav tables ADR report in Assembly

PATNA, MAR 19 (PTI): Bihar assembly Tejashwi Prasad Yadav on Friday said he has documentary proof according to which 18 out of 31 state ministers are facing serious criminal cases.

With Speaker Vijay Kumar Sinha's permission during Zero Hour, the RJD leader referred to a report of the Association for Democratic Reforms (ADR) according to which 18 ministers are facing criminal cases, including murder, kidnapping and robbery.

"Let the ADR report be made part of the proceedings. I want to table it on the floor of the House," he said, to which the Speaker replied, it is already in public domain and there is nothing new in it. The report even included cases relating to violation of the model code of conduct, Sinha said, adding that a 10-year old case for violation of model code of conduct is pending against the Speaker himself.

"There are many more people including you (Tejashwi) who may be facing such cases," he said while allowing him to table the ADR report in the Assembly but refused to make it part of the House proceedings. The RJD leader said, he had raised the issue during a debate a few days ago in the House that more than 64 per cent of ministers are facing criminal cases and "You (Speaker) had sought documentary proofs in support of my claim".

19 (PTI) Congress leader Rahul Gandhi Friday assured that the Citizenship Amendment Act (CAA) will not be implemented in Assam if the party is voted to power in the state in the coming Assembly poll.

It will be ensured in the state assembly that the CAA is not implemented in Assam, Gandhi told students of Lahowal College in Dibrugarh dis-

"In the other states, we will stop it (CAA implementation) after we (Congress) come to power at the national level," he said.

Asked to comment on whether BJP is mixing religion and politics, he said that the saffron party does not use religion but hatred to create divisions among different sections of the society.

"No religion has asked to use hatred. Where is it written in Hinduism that there should be 'nafrat' (hatred)? It is BJP that spreads hatred to divide society and wherever they do it Congress goes there to promote love, brotherhood and harmony," he said. In an apparent reference to the RSS, the senior Congress leader said that there is

fidence as they are the future of democracy.

"BJP ka kaam hain

todna, hamaara kaam hain jodna (BJP's work is to divide but our job is to unite people), he said.

Gandhi said there is a brotherhood".

He also accused the saffron party of selling off Assam's resources to outsiders like the tea companies in the state, the Guwahati airport to the Adanis and the tea companies.

"Assam's resources and wealth must go into the pockets of the Assamese. The state must be managed in the interest of the people here", the Congress leader said.

The erstwhile Congress government, he said, had laid the foundation for the country's future growth, employment and development initiating several including schemes, MGNREGA and Food Security. "Can you name the schemes started by BJP? We had promised in Chattisgarh to waive off farm loans and we did it.

We have a record of not making promises in the air. We give guarantees", he asserted.

In Assam Congress has given '5 guarantees'. They are five lakh government jobs to youths in five years, upto 200 units of free electricity per household, Rs 365 daily wage to tea workers and Rs 2000 per month to housewives besides the assurance not to implement the CAA in the state, he said.

Instill Conservation by **Cultivating Pride**

Invite collaborations instead of talking down

Toming up on 21 March is World Forestry Day. Given these times of resurgent muscle-flexing as the way to confront the virus, expect it to pass without much ado in Sikkim unless, of course, the powers that be seriously believe that locking everyone in for the night is defence enough. That said, just like the other Days on the official calendars when a lot of superficial concern and generic rhetoric is pompously delivered, don't expect any outpouring of genuine 'concern' and committed activity telescoped even into a once-a-year routine.

What can Sikkim do on World Forestry Day?

It might undertake a lot of plantation (but it's too early for that), some seminars and an odd workshop or two depending on what the budget allows and reams and reams of press releases and messages. Such initiatives, well-meaning though they might be, mean little and achieve even lesser. The State's biodiversity hotspot credentials are much touted and often compromised and one needs to only look out of the window to notice the abundance of green and may be even surmise that forests are doing rather well here and do not really need a Day to flag worries and concern. But like most surmises, this would be a superficial solace as well.

The forests are under stress, as much from the Machiavellian demands of "development" and obsessed-with-cement "vikas" as from the sheer stress of population growth in a small area. That said, Sikkim is lucky that it is snuggled in the horseshoe that gives it a bio-diversity that few places its size can boast of. One could carry on endlessly about the variety of flora and fauna that are abundant in Sikkim, but that is exactly what we are striving to make a point against.

No, not the flora and fauna, but the tokenism that goes by way of concern on ecology-related issues in Sikkim. What is most ironic about environment-related issues in this Himalayan State is that all initiatives are taken by the government voluntarily. The environment cess for example, as also the clause proposed to be added to work orders for all civil works which will require contractors to undertake plantation works around their work sites (which remained a proposal and was never followed-through), the ban on plastics and the legislations protecting jhoras from dumping. All these decisions were taken by the government on its own. Even the environmental impact assessments for major projects are taken up by an arm of the government and over-watch maintained by another arm. Apart from the physical impossibility of one arm twisting the other if it misbehaves, there is also too much overlap and too many "considerations" which make such supervision inconsequential.

And there is more that is askew with this picture? All these decisions emanate from public pressure in other places, but here they flow top-down which is not always the best option. When people pressurise governments to initiate well-meaning policy decisions, they do so after they have informed themselves better and decided to get engaged. When government agencies take the initiative, they talk down to the people and that does not always lead to an informed populace. Sikkim should still consider itself lucky that all these measures have come its way voluntarily. What is after all obvious is that no one would have missed them if the government had decided to ignore these initiatives.

But conservation can never succeed when it is forced or dictated. It has to be a collaborative effort which should involve everybody. Before the government announces another pro-environment legislation, it should perhaps direct the Human Resource Development Department to prepare Sikkim-specific text books for Environment Studies [a subject already in the syllabus] at least till class VIII for all schools in Sikkim. If this is done and some activity-based topics included in the curriculum, then the generation still in schools will understand the environment they live in better. If they understand it, they will also appreciate its uniqueness and will soon start taking pride in it. No one will then have to lecture them about conservation anymore because the pride of living in Sikkim will automatically imbibe it into their mindsets. Sikkim, its ecology and its people will then be safe forever.

Halting Vaccine Rollout: Is Allowing Harm Worse Than Doing Harm?

The UK and EU were recently engaged in a heat-**▲** ed disagreement over the safety of the Astra-Zeneca vaccine. Germany, France and other EU states halted the AstraZeneca vaccine rollout while the European Medicines Agency (EMA)

investigated the possibility that the vaccine might cause a rare, sometimes fatal, blood clot called cerebral venous sinus thrombosis

In the latest announcement, the EMA says that no causal link between the AstraZeneca vaccine and CVST has been proved. Their report admits that there is still a possible link to the rare blood clots, which deserves further analysis, but in the absence of proven causality rollout should continue.

Some commentators framed the disagreement between the UK and EU as reflecting bad blood and division over Brexit. Others stressed disputes over how to interpret statistical patterns. Underlying these disagreements, though, was a remarkable agreement. Both UK and EU commentators seemed to agree that if the vaccine causes clots, we should stop using it. They disagreed over whether we have evidence the vaccine

causes clots, not over how we should respond if it

The claim that if the vaccine causes deadly blood clots, then we must stop using it may be compelling to many, but it is also tricky because stopping the vaccine rollout has costs. We have excellent evidence that the AstraZeneca vaccine is effective at stopping symptoms and probably transmission. So stopping using the vaccine is equivalent to letting many people unnecessarily contract COVID-19, with potentially fatal consequences for them or others.

FIRST, DO NO HARM

Even if the vaccine has fatal side-effects in a few cases, vaccinating the population might save many more lives than it costs. So why the apparent agreement that if the vaccine has fatal side-effects, we should halt the rollout?

A core principle of medical ethics is "first, do no harm". This can seem a peculiar principle - of

ing patients. It gets some bite if we spell it out more fully: "Do no harm, even if doing harm would lead to more benefit."

Consider this deliberately grotesque example lecturers often use to make this point more vivid to

course we don't want doctors going around harm- ers. But it is contested - and for lots of good reasons.

First, some have argued that drawing a strong distinction between doing and allowing doesn't reflect some fundamental ethical difference, but is more like a psychological quirk of humans, grounded in a desire to avoid blame. Maybe we should just



bored students: a doctor could remove a heart and lungs from a healthy patient and use the heart to save one patient, the lungs to save another. The net result of this operation would be "positive": two lives saved for one life lost. Still, it seems obvious that the doctor shouldn't go around cutting open healthy patients, regardless of this "net benefit". "First, do no harm" captures that thought.

Underlying this "do no harm" principle is a deeper claim that it is worse to do harm than to allow harm to happen. In the grotesque example, it is worse to kill someone than it is to let two people avoidably die from lack of an organ transplant. Or, in the real world case of the COVID jab, it is worse to cause some to suffer a blood clot than to let very many people die from lack of a vaccine.

Again, this distinction between what we "do" and what we "allow" can seem intuitive in some cases, such as killing one person to give her organs to othbite the bullet and accept that sometimes we have to get our hands dirty.

Second, the dividing line between doing and allowing is itself blurry. Think about another COVID case, lockdown policies. A feature of lockdown was that vulnerable women were trapped with violent partners, sometimes with tragic consequences. These consequences were predictable. In implementing lockdown, did the government "cause" these harms, or merely "allow" them to happen?

Of course, there is debate over all of these issues. Some think we can distinguish "doing" and "allowing" and that this distinction is ethically important. What is clear, though, is that debates about vaccine safety go beyond scientific debates about when we can infer claims about cause and effect. Rather, these debates are grounded in ethical assumptions that we can, and should, question and contest.

Racism is behind anti-Asian American violence, even when it's not a hate crime

ver the past year, attacks on Asian OAmericans have increased more than 150% over the previous year, including the March 16 murders of eight people, including six Asian American women, in Atlanta.

Some of these attacks may be classified as hate crimes. But whether they meet that legal definition or not, they all fit a long history of viewing Asian Americans in particular ways that make discrimination and violence against them more likely.

I have researched and taught on Asian America for 20 years, including on the pernicious effects of stereotypes and attacks on individuals. Race can play a role in violence and prejudice, even if the offender does not clearly express a racist intent.

Much remains unknown about the attacks in Atlanta, but the man charged with the murders has said he did not have a racial prejudice against people of Asian descent. Rather, he has claimed he has a sexual addiction. But that statement indicates that he assumed these women were prostitutes, whether that's true or not.

This assumption, and the resulting violence, is just one of many that Asian Americans have suffered through the years. A LONG HISTORY OF PREJUDICE

The presupposed connection between Asian women and sex dates back almost 150 years: In 1875, Congress passed the Page Act, which ef-

fectively barred Chinese women from

immigrating, because it was impossible to tell if they were traveling "for lewd and immoral purposes," including "for purposes of prostitution." The assumption that all Chinese women were of questionable moral character placed the burden on the women themselves to somehow prove they were not prostitutes before being allowed to immigrate.

The U.S. military contributed to this conception of Asian women as hypersexualized. During the wars in the Philippines at the start of the 19th century, and during the mid-20th-century wars in Korea and Vietnam, servicemen took advantage of women who had turned to sex work in response to their lives being wrecked by war.

In the 1960s, the U.S. government brokered a deal with Thailand to be a "rest and relaxation" center for military personnel fighting in Vietnam. That bolstered what became the foundations of Thailand's modern-day sex tourism industry, which attracts men from the United States and Europe.

This association of Asian women with men's sexual fantasies has permeated popular culture, such as a scene in the 1987 Stanley Kubrick movie "Full Metal Jacket" in which a Vietnamese woman entices two servicemen by saying, "Me love you long time," and regular themes in the animated comedy "Family Guy." This makes Asian women more desirable to sex traffickers, brought over to serve male desires in spas and massage parlors such as the ones attacked in Atlanta.

This history of sexualization of Asian women, shaped by the U.S. military and patriarchy, creates the backdrop to the Atlanta shootings. It helped create the conditions for the Asian spas and massage parlors to be there in the first place. It presents Asian American women as submissive, responsive agents of sexual temptation.

Race and gender inform what happened, and the public response to it, whether the alleged shooter articulates racist motives or not.

STEREOTYPES AND PERCEP-TIONS MATTER

Other crimes against Asian Americans may also lack clear evidence of racial bias, but still echo anti-Asian American stereotypes.

For instance, many elderly Asian Americans have been shoved to the ground in recent weeks, and Vicha Ratanapakdee, an 84-year-old man, died in one such incident in February in San Francisco.

The public defender representing the accused perpetrator in Ratanapakdee's death denies that race motivated the crime. But that is different from saying race was not a factor at all.

Practically all Asian Americans, but elderly men in particular, are often viewed as nonaggressive, meek and unable or unwilling to fight back, in contrast to men of other races. They are easy targets.

IT'S NOT ALWAYS A CRIME

Other anti-Asian American racism isn't criminal at all, but still fits with the nation's racist history. As

COVID-19 spread across the U.S., Asian-owned restaurants and stores were the first to experience declining revenue, even though most of the earliest cases in the U.S. came from

Europe.

There is a long history of suspecting Asian Americans of carrying disease into the U.S., which made it seem natural for people to avoid Asian American-owned businesses. President Donald Trump's repeated public declarations that the "Kung Flu" virus came from China reinforced those feelings.

This race-based and erroneous assumption has resulted in Asian Americans having among the highest unemployment rates in the nation, though they had among the lowest before the pandemic.

It defies logic to claim that race isn't relevant in attacks on Asian Americans unless the perpetrator actively references it. Research has found that most Americans assume a person of Asian descent is foreign-born, unless there is some aspect of their appearance that clearly marks them as American - such as being overweight.

Asian Americans of all types experience this perception of being "forever foreigners" in a wide range of ways. Regardless of whether some or all – or none – of these latest assaults on Asian Americans are proved to be hate crimes or not, race plays a historic role.

As days went by, he was exhausted and saw almost no hope that the monument he worshipped every day would be put back to its glory. He ultimately gave up entirely. "The stupa was dissipating, chunks of its body were severely cracked, and the layers of asphalt buried its foundation underneath, and for long nobody did anything,

The shrine, which locals believe dates back centuries, was one of the highlights of the neighbourhood and a major part of the daily rituals of the community. How the monument became forsaken is a long story, he says, one of how time works.

"The family's elders passed away and their family moved out of the area and they didn't know the condition of the shrine. While the community people still offer pujas and revere the shrine, nobody had the ownership to repair it and no one really cared enough to initiate its conservation, not even the community's representatives," he said.

But all that has changed now. The once half-buried and filmed in a layer of dust and grime stupa today stands tall in its renewed grandeur through the initiative of a social organisation Chiva Chaitya. And with the restoration work, footfall has increased multifold. And the milieu of the place has found a facelift, say the locals there. It has become chahakilo, bright in English, says Shahi.

are doing great work of conserving the uniqueness of the Valley and re-strengthening people's relationship with the shrines that have surrounded us," he said. "These shrines are an important part of Kathmandu's inheritance and culture, one that needs to be preserved," said Shahi.

Chiva Chaitya's chiva restoration project started as the country prepared to break from the lockdown of the Covid-19 pandemic. Amid the gloom of an economic collapse across the country, where the tourism industry suffered the most, the group found themselves determined to work on the protection of communal heritage to foster the distinct identity of the Valley's culture and tourism and people's relationship with tangible inheritance.

Chaityas, or stupas, are a significant part of Kathmandu's heritage and culture that goes beyond the Gregorian calendar, says Sumati Bajracharya, a 77-year-old Buddhist intellect and the author of the book 'Chiva Chaitya'. And the people of the Valley for long have built chaityas wherever they have

The shrines are worshipped on a day to day basis by different ethnic groups on different occasions representing the various phases of life, such as Janko, which is celebrated when an elderly person reaches a certain age, or death anniversaries. Chaityas are a significant part of all the rituals.

Chaityas are also an ode to the dead, made in remembrance of someone endeared. And in Buddhism, chaityas are also regarded

"The people in Chiva Chaitya as a three-dimensional representation of the mandal that embodies the principle of life. They are also one of the distinctive highlights of baha and bahi monasteries.

"Chaityas have a long history. They existed even before Buddha's time and the term initially was referred to as a place of resting or meditation, later it was referred to the idea of using, 'chiti' (ash) of the deceased to make a stupa in their memory," said Bajracharya.

"The concept of chaitya has evolved with Buddhism. At first it was just made with earth, without the Pancha Buddhas or the gajur (pinnacle), but today we see all kinds of them, and in many ways their existence attributes to the uniqueness of our culture," said Bajracharya. And even today, the culture of building chivas has continued in the Newa Buddhist community.

However, over the years, chiva chaityas, which are pieces of heritage and history, have been undermined and overlooked. "In terms of conservation and protecting what we have, people have not understood what these stone monuments mean in our culture-even archaeologically speaking," said Amar Tuladhar, a board member and the treasurer of Chiva Chaitya.

These shrines have been damaged, shifted, demolished without properly understanding their value, said Bajracharya and Tuladhar, even more with the road construction projects underway. At Dallu, the layers of asphalt used haphazardly to make roads had buried half of its structure.

For the organisation, as they restore chaityas in the valley, confronting the indifference of the people and seeing how the government has not considered the importance of the chaityas has been frustrating. But in each of their restoration projects to date, they have made it a point to work closely with the local ward office, community people and the private owners of the monuments.

They started by documenting stupas, now they are restoring them "We believe if we are to protect these chaityas, we need to establish ownership—only then, will people question and make more effort in the preservation of the chaityas and their culture," said Prabin Shakya, the vice-president of the organisation.

> Their first restoration project started in Swayambhu, where two chivas (chaitya in Nepalbhasa) had been damaged when a tall tree had fallen over them. The chivas parts were stored in the office of Swayambhu Bikash Kosh for quite some time and nobody knew the whereabouts of the chiva chaityas, said Tuladhar. "The owners of the chaityas had also filed a police complaint, but we were told they were unable to find it and then we went and searched in the Kosh's store and we found the pieces-they were severely damaged," he said.

> Within a few days, their group dispersed to get permission from authorities, mainly the ward office. Then they managed all resources and brought together the concerned people of the shrine to work on restoring the chaitya.

> The restoration cost came to be around Rs85,000, says Tuladhar. But at Dallu, where they had to dismantle the chaitya, replace parts and build the foundation of the shrine, the cost was more.

> "The cost depends on how much of the chaitya needs to be restored and how. And with that the size of the chaitya, the workforce needed, and the logistics required," says Tuladhar. "For these operations, we usually collect money from our friends and benefactors. But oftentimes, the community people have stepped in to contribute to the restoration. It happened in Dallu and even at Dhoka-tole near Hanuman Dhoka Durbar Square," he said.

> In the past five months, the group has restored about five chaityas, and they plan to cover at least six more this year. Just a week back at Dhalko Ward No. 17, next

to the Indrayani temple, the organisation restored a terracotta chaitya which they believe to be over hundreds of years old. "A tree was growing from underneath the chaitya, and in the process was tearing down the chaitya's structure, so we had to dismantle the parts and take out the tree," said Tuladhar.

With each restoration, Tuladhar and his team have been gathering a lot of praise and support from people. Last year, they were also funded by the World Monument Fund that had also enlisted 'chiva and chaityas' of Kathmandu on their watchlist of 2020.

The group that was initiated by five friends—Prabodh Kasa, Prabin Shakya, Suban Tuladhar, Ashish Manandhar and Amar Tuladhar—has come a long way from just discussing the importance of the shrines to actually restoring them. Today, they understand that more than wishful thinking, one needs to take action to make way for the change they want to see.

"We started talking in 2012-13 about how these chaityas are mostly overlooked by the state and the people. We wanted to make people aware of how these shrines are important both culturally and socio-economically. We believe it can attract more tourists too," said Shakya.

Then, they were a social group that was recording and documenting chaityas in the Valley, trying to create an inventory through images, and their history. Alongside, they also promoted chaityas through community and school interactions, chaitya tours, cultural tourism conservation programmes and cleaning activities. They registered as an organisation in 2019.

And as an organisation, these days they are also working to establish GPS locations of chaityas in the valley. Till date, they have recorded over 1,300 chaityas, but they estimate the count of chaityas in the Valley to be over 4,000, excluding well-known chaityas like Swayawambhu, Khasti, Namobuddha, Dhando chaityas.

Although their work still mostly remains hidden in the larger conversation of heritage conservation, the group's role has been crucial to start off ground-level mobilisation and motivation and to bring attention to the chaityas that we see in almost every neighbourhood of the Valley.

"This is just the beginning for us, and we believe this journey will continue and expand with people taking their first steps to be aware and then to making steps to protect monuments that already exist around us," said Shakya, the vice-president.

Anjir Man Baniya, the site manager of the group, has also witnessed this optimism. He has seen the concern of people grow with their attempt to restore the monuments in their community. "A lot of people come asking what we are doing, and if we are doing the restoration in the right way," he said. At Dallu, he saw about 13 local clubs come together to pull up the chaitya and restore its structure.

Today, the process for him and the team has been heartwarming. "When you first see what you have to fix, it feels like an unimaginable attempt with so much to do, but as the chaitya comes together, nothing beats the peace you find at the end," he said.

"It's gratifying to see how you are able to bring everyone together for a cause. The triumph for the team has been in raising concerns of a community in their ownership of the monuments they have lived with."

Not disappointed with my dismissal, few things not in *my control:* Suryakumar

AHMEDABAD, MAR 19 (PTI): His terrific innings in only his second international outing was cut short by a controversial dismissal, but Suryakumar Yadav took it on his chin, saying few things are "not in my control". Survakunar smashed

a blistering 57 off 31 balls to set up India's series-levelling eight-run win against England in the fourth T20 International against England here on Thursday night.

Just when he was looking to pile on England's misery, the Mumbai dasher was given out in a controversial fashion. "Regarding my dismissal, not really disappointed because few things are not in my control. Things that are in my control, I try to control that and things outside that, are not in my hands," Suryakumar said at the post-match press conference on Thursday.

He began his foray in international cricket with a stunning six off England pacer Jofra Archer.

"I am very happy with the way the things went. My plan was really clear when I went out to bat. I have seen Archer in the last two-three seasons in the IPL, I watched all of his games, whenever a new batsman comes in, what plans he has, obviously I had my plans as well," added Suryakumar.

"It was a great opportunity for me to bat at number three for India. Yeah, I knew he will come a little short at me."

During India's innings, two umpiring seemed to have gone against the hosts. Suryakumar was dismissed by Sam Curran. The right-handed batsman tried to play a shot but Dawid Maian ended up taking the catch.

Replays indicated that the ball might have hit the ground when Malan was taking the catch. However, as the soft signal was out, the third umpire upheld the on-field call citing "lack of conclusive evidence".

Suryakumar was not included in India's squad for the white-ball series against Australia despite a stellar IPL and domestic season

Speaking about how he prepared for the series against England, Suryakumar said, "I have always said that the passion for this game has always kept me going."

"I kept working hard, I only knew that I have one option and I try to do things that are in my control. I kept on working on my skills and fitness and I knew that when the time is right, an opportunity will come and I will grab it with both hands.

"There were some butterflies, I was happy when I got to know that I will be playing at three, I knew what I had done before, I just followed the same process which I do while playing for my franchise. "I knew this situation really well, I wanted to do the same things. I did not do anything different, I just expressed myself," he said.

India-England series is a trailer for other teams to improve ahead of T20 WC: Ramiz

KARACHI, MAR 19 (PTI): Former Pakistan captain Ramiz Raja has termed the ongoing series between India and England as a "trailer" for other teams, saying the five-match T20 rubber will help them to improve their skills and strategy ahead of the T20 World Cup later this year.

"I think it is a trailer for other teams on how to improve their skills, strategies for this format before the World Cup," he said in an interview on the Cricket Baaz YouTube channel.

"We have two of the best teams playing and I think England is the team to beat in the World Cup." Ramiz heaped praise on the England team for their metoric rise in white-ball cricket. "Their rise in white ball cricket has been massively impressive given the fact that until some years back they didn't even give priority to ODIs or leave alone T20 cricket," he said.

"England are fearless now and playing attacking cricket in white ball format."

Ramiz also felt that England had shell shocked the quality top order of the Indian team with their express pace.

The former Pakistan batsman also described Misbah-



ul-Haq as the poor man's MS Dhoni, saying the Pakistan head coach needs to adopt a "modern thinking" approach to guide the team.

"Misbah's training and upbringing is different. Let me put it this way, he is the poor man's Dhoni. MS was also restrained, no expressions and not emotional. Misbah is also like this but I think now he has to go on modern thinking," he said. "Misbah has to take a new direction because there is a need to set the GPS right for Pakistan cricket because aggression is in our DNA. I think at times he gets too protective and he gets cagey as soon as we lose a match. But if our products and talent is right we shouldn't be afraid of hiccups and setbacks." Asked

to compare Misbah with India's head coach Ravi Shastri, Ramiz made some interesting observations.

"When we played against Ravi we felt he was a misfit in Indian team because he had aggression, he was a go getter, team player ready to open bat down the order and his body language was different. We felt he wanted to be a Imran

Khan type player because we were like that. "I think he took this attitude to the Indian team and fortunately for him the same number of matches and captain, Virat Kohli is also like even the points system was that aggressive and expressive and this has made a big difference to the Indian team."

Ramiz also called for the appointment of a chief executive for the Pakistan team who would oversee only technical

cricket matters related to the team selection, coaches, players etc. He also felt that time has come for Pakistan to stop reliance on foreign coaches.

"In the past I could understand we needed foreign coaches because we were young to this field but now we have grown ourselves in this area. "In fact I think there is no need to have permanent coaches with the team for all tours and we should only be appointing specialist coaches as required on tour to tour series to series basis.

"Appointment of coaches should be tour based and opposition based. Use their expertise for a series and move on rather than carry on with them for a long period."

Talking about the World Test Championship, Ramiz said: "The current format was lopsided and prolonged and it made no sense not having India and Pakistan series.

"Teams didn't play the weird. Next time when the WTC is held no cricket should be held at that time. No ODIs or T20s, if you want to promote test cricket and infuse life into it and also attract sponsors to this format.

Lahore court orders FIA to register case against Pakistan captain Babar Azam

KARACHI, MAR 19 (PTI): Pakistan captain Babar Azam's problems in his personal life continue to grow as a sessions court in Lahore has ordered the Federal Investigation Agency (FIA)'s Cyber Crime Circle to register a first information report (FIR) against him in a harassment case.

The order from Judge Hamid Hussain came on Thursday after a hearing in Lahore on a petition filed by a woman, Hamza Mukhtar who claimed she had been getting threatening messages on her Whats App, threatening her with dire consequences after she filed a case against the Pakistan captain.

At the hearing the FIA officials informed the court that after Hamiza filed a complaint with the Cyber Crime Cell and they started an inquiry they found one of the numbers used to send the threatening messages belonged to Babar

Hamiza has alleged that she was constantly receiving "threatening messages" from different mobile numbers on WhatsApp and that unknown persons also used to "threaten and blackmail her that they have



her objectionable pictures and videos and will upload (them) on social media in order to harm her repute in society and ruin her life."

She said she had approached the FIA to trace the unknown numbers and they found one of them was registered to Babar Azam and two others to two women, Maryam Ahmed and Salme BB who were served notices to join the FIA's inquiry proceedings to record their version.

The court was told that of the three, only Ahmed appeared in front of the agency and denied knowing the petitioner or sending her abusive messages.

According to the report, Ahmed had stated that she would provide her mobile phone for technical analysis but she failed to do so.

The FIA said Babar's brother Faisal Azam appeared on behalf of the cricketer and requested the FIA to "wait for some time" to record Babar's statement.

However, Babar has not yet appeared for the inquiry, the FIA report said.

In his order, the judge wrote that since a regular inquiry had already commenced on the petitioner's complaint, the "respondent is ordered to proceed further with respect to registration of FIR against the culprits within the stipulated time after [completion] of legal formalities".

Earlier this year, the Lahore High Court (LHC) had suspended the order by a sessions court to the Naseerabad police in Lahore to register a case against Babar Azam on Mukhtar's complaint.

Hamiza has also filed harassment, sexual abuse and other cases against Babar in the court.

Pogba returns from injury to help Man Utd beat Milan in EL

MILAN, MAR 19 (AP): Paul Pogba returned from injury to score the winner as Manchester United beat AC Milan 1-0 to reach the Europa League quarterfinals, while Mislav Or ic netted a hat trick as Dinamo Zagreb stunned Tottenham 3-0 to eliminate the London team.

Pogba was brought on at halftime and had an immediate impact as he scored two minutes later to help United secure a 2-1 aggregate victory.

"Paul looked like he'd been out for six weeks He's been working really hard but playing football is a different matter and you can see that he needs more time," United coach Ole Gunnar Solskjaer said.

"He couldn't play for more than 45 minutes and he'll get better and better which is fantastic for us for the rest of the season ... He's going to give us a big boost."

Arsenal, Roma, Ajax and Villarreal all went through as well.

In Milan, former Manchester United forward Zlatan Ibrahimovic also made his comeback from injury as a substitute but saw his best effort saved as his powerful header was clawed away by goalkeeper Dean Henderson.

"There's so much disappointment, we played two matches well, today we just missed a goal," Ibrahimovic said. "We made an error at the back but that's football and if you don't take your chances it's more difficult to go through.

"But now I'll be back to help the team. ... We didn't deserve to go out tonight, but you also learn from negative moments to grow and we'll move forward."

Ibrahimovic played for United from 2016-18, helping it win the Europa League in 2017. That was the English side's last trophy.

After conceding a late equalizer in a 1-1 draw at Old Trafford, United started positively at San Siro but Milan slowly got into the match and had the best chance with the last kick of the first half as Rade Krunic volleyed wide of the left post.

Pogba had missed the past 10 matches but warmed up during halftime and replaced Marcus Rashford immediately after the



break. And he put United in front moments later. Milan failed to clear the ball following a shot by Daniel James and the ball eventually fell to Pogba, who fired into the roof of the net from close range.

Pogba almost set up a second for United three minutes later when he found Mason Greenwood but the forward's attempt was saved by Milan goalkeeper Gianluigi Donnarumma.

Pogba also headed over shortly before full time in a dynamic performance from the Frenchman. SPURS STUNNED

Or ic completed his hat trick with the winner in extra time as Dinamo Zagreb overturned a 2-0 deficit from the first leg to reach the quarterfinals 3-2 on aggregate.

Spavor and Kovrig were detained in December 2018, days after Huawei executive Meng Wanzhou was arrested at the request of the US at the airport in Vancouver, British Columbia. The US is seeking her extradition to face fraud charges related to her company's dealings with Iran.

The two Canadians have been held ever since, while Meng has been released on bail. They were charged in June 2020 with spying under China's national security laws. Spavor, an entrepreneur with North Korea-related business. was charged with spying for a foreign entity and illegally providing state secrets. Kovrig, an analyst and former diplomat. was charged with spying for state secrets and intelligence in collaboration with Spavor.

Prosecutors have not released details of the charges and trial proceedings in national security cases are generally held behind closed doors. The state-owned Global Times newspaper said Kovrig was accused of having used an ordinary passport and business visa to enter China to steal sensitive information and intelligence through contacts in China since 2017, while Spavor was accused of being a key source of intelligence for Kovrig.

In Vancouver on Thursday, Meng's lawyers told an extradition hearing Canadian officials abused their power when they conspired with the US to arrest her. Defense lawyer Tony Paisana said Canadian Border Services Agen-

cy officers took Meng's phones, obtained their passwords, then handed to them to Canadian police so the data could be shared with the FBI.

Paisana said Meng was never told during questioning that she faced an arrest warrant in the US and would have immediately asked for a lawyer if so informed. British Columbia Supreme Court Associate Chief Justice Heather Holmes suggested border officers would have questioned Meng more rigorously if their exam was actually a covert criminal investigation, as her lawyers said.

China has demanded Meng's immediate and unconditional release, saying the US engineered her detention as part of a drive to contain China's growing rise. Canadian authorities say Kovrig and Spavor were arbitrarily arrested to put pressure on Ottawa and say they should be released without charge.

China has also restricted various Canadian exports, including canola oil seed, and handed death sentences to another four Canadians convicted of drug smuggling.

Lebanese are gripped by worry as economic meltdown speeds up

BEIRUT (AP): Shops closing, companies going bankrupt and pharmacies with shelves emptying — in Lebanon these days, fistfights erupt in supermarkets as shoppers scramble to get to subsidized powdered milk, rice and cooking oil.

Like almost every other Lebanese, Nisrine Taha's life has been turned upside down in the past year under the weight of the country's crushing economic crisis. Anxiety for the future is eating at her.

Five months ago, she was laid off from her job at the real estate company where she had worked for years. Her daughter, who is 21, cannot find work, forcing the family to rely on her husband's monthly salary which has lost 90% of its value because of the collapse of the national currency.

The family hasn't been able to pay rent for seven months, and Taha worries their landlord's patience won't last forever. As the price of meat and chicken soared bevond their means, they changed their diet.

"Everything is very expensive," she said.

Taha's family among hundreds of thousands of lower income and middle class Lebanese who have been plunged into sudden poverty by the crisis that started in late 2019 - a culmination of decades of corruption by a greedy political class that pillaged nearly every sector of the economy.

The Lebanese pound has lost more than 25% in value over the past weeks alone. Inflation and prices of basic goods have skyrocketed in a country that imports more than 80% of its basic goods. Purchasing power of salaries has dramatically declined and savings have evaporated — all on top of the coronavirus pandemic and a massive explosion last August at Beirut's port that damaged parts of the capital.

More than half the population now lives in poverty, according to the World Bank, while an intractable political crisis heralds further collapse.

Alia Moubayed, man-

cial services company, said the "sharp contraction in growth, coupled with hyperinflation and devaluation" has pushed more people into precarious employment, raised unemployment levels and brought more than 50% of the population below the poverty line, compared to an estimated third in 2018. Lebanon has been without a government since the last one resigned in August, with top politicians unwilling to compromise over the formation of a new Cabinet that could forge a path toward reforms and recovery. Street violence

"People are dying, and no one cares!" said Taha as she visited a cousin who owns a perfume shop in Beirut's commercial Hamra Street. Both wore masks to prevent the spread of the coronavirus.

and sectarian tensions are

on the rise.

Once a famous shopping district, known for its boutiques, bustling cafes and theaters, Hamra Street has changed amid the pandemic. On a recent day, many shops were closed, some because of lockdown measures, others permanently because of the economic crisis. Merchants in those still open complain they are selling almost nothing.

Beggars solicited passers-by for money. A woman and her child sat on the pavement next to a drawing on a wall with the words: "We are all beggars." "It cannot get worse," said Ibrahim Simmo, 59, who manages a clothes shop. Sales have dropped 90%, compared to previous years. He couldn't sell his winter stock during the nearly two-month-long virus lockdown earlier their year, and now the currency crash is making things worse.

Ibrahim Farshoukh, 28, said he barely pays the rent for his shop where he sells handmade leather bracelets and bags. Sometimes his wife stays behind while he takes to the streets, trying to sell bracelets to passers-by. "The situation is unbearable," he added. The vast majority of the population gets paid in Lebanese pounds, meaning their incomes decline further while prices shoot up and pensions evaporate. The crisis has also depleted foreign reserves, prompting stark warnings the Central Bank can no longer finance subsidies of some basic commodities, including fuel.

Videos on social media show fistfights in supermarkets as shoppers try to get to subsidized products such as cooking oil or powdered milk. In one video, armed members of one of Lebanon's intelligence check ID cards inside a supermarket before handing over a bag of subsidized rice.

People who once lived comfortably are now unable to pay school fees and insurance premiums, or even eat well.

"I don't remember the last time we ate meat. I cannot afford it," said Taha, whose husband is an airport maintenance employee. The family's diet now mainly consists of lentils, rice, and bulgur, she said.

The currency collapse has forced some grocery shops, pharmacies and other businesses to temporarily shut down, as officials warn of growing food insecurity.

Nabil Fahd, head of the supermarket owners' association, told the local MTV station that people are hoarding goods, which stores can no longer restock once something is sold out, storeowners have to pay more in Lebanese pounds for new supplies. We are "in a very, very serious crisis," he said.

The price of bread, the country's main staple, was raised twice over the past year — and then, earlier this month, bakers reduced the weight of a pack of bread. without changing the price. Taha blames Lebanon's corrupt political class for bringing the small nation to near-bankruptcy.

Assem Shoueib quit his job at a leading newspaper in Beirut in 2000 and moved with his family to France, where he opened a Lebanese restaurant near Paris. Walking through Hamra Street on a recent visit back, the 59-year-old said he made the right decision.

Europe pause of AstraZeneca sends ripple of doubt elsewhere

KAMPALA, UGANDA (AP): The have pushed back against skeptisuspension of the AstraZeneca vaccine in several European countries over the past week could fuel skepticism about the shot far beyond their shores, potentially threatening the rollout of a vaccine that is key to the global strategy to stamp out the coronavirus pandemic, especially in developing nations.

As things stand, it's either AstraZeneca or nothing for some poorer countries. The vaccine from the Anglo-Swedish drug maker is cheaper and easier to store than many others. It will make up nearly all of the doses shipped in the first half of the year by COVAX, a consortium meant to ensure lowand middle-income countries receive vaccines.

With little other choice, most developing countries that had the AstraZeneca on hand pushed ahead with it even as major countries in Europe suspended its use over the past week after reports that unusual blood clots were found in some recipients of the shot — despite insistence from international health agencies that there was no evidence the vaccine was responsible.

But while governments in Africa and elsewhere expressed their determination to continue using the shot, not everyone is con-

"Why should I allow it to be used on me? Are we not human beings like those in Europe?" Peter Odongo, a resident of a town in northern Uganda, told the Daily Monitor newspaper this week.

The East African country has received 864,000 AstraZeneca doses via COVAX so far but had administered fewer than 3,000 by Tuesday. Authorities blamed logistical challenges in transporting the vaccines deep into the country, but newspaper reports cite resistance to the vaccine.

Even before the latest debate over AstraZeneca, vaccine skepticism had been a concern across the world, as many people are hesitant about shots developed in record time. African countries have faced particular hurdles on a continent wary of being a testing ground for the West. Some leaders cism, while others, such as those in Burundi and Tanzania, have fed it by appearing to deny the seriousness of COVID-19.

"Unfortunate events" in Europe will "clearly not be helpful for our public confidence, in building public confidence and trust on the use of that particular vaccine and other vaccines for sure," John Nkengasong, director of the Africa Centers for Disease Control and Prevention, told reporters Thursday, as he encouraged African countries to continue their vaccinations.

That came hours before the European Union drug regulator gave the same message to its 27 members. The European Medicines Agency said its experts concluded that the vaccine is not linked to an overall increase in the risk of blood clots, though it could not definitively rule out a link to rare types of clots and the vaccine. In response, countries including Italy, France and Germany announced they would resume use of the shot.

Even before those reversals, several developing nations had said they would stick by the shot.

"We will continue the inoculations," said Lia Tadesse, health minister of Ethiopia, which received 2.2 million doses of the AstraZeneca vaccine last week.

Authorities in India — home to the vaccine manufacturer that will likely make a large portion of the doses destined for the developing world — said Wednesday they would continue AstraZeneca inoculations with "full vigor" as infections jumped in several parts of the country. After initially saying it would delay use of the vaccine, Thailand said Tuesday it would carry on with AstraZeneca, and the prime minister even got his shot in public.

Brazil's state-run Fiocruz institute delivered the first Astra-Zeneca shots bottled in Brazil on Wednesday as the Health Ministry sought to allay concerns about the blood clot reports, urging calm.

Very few developing countries bucked the trend. Congo, for instance, halted use of AstraZeneca, putting its vaccination campaign on hold even before it began since it has no doses of anything else. Indonesia also initially paused the shot but then said Friday it would resume using it. European and other wealthy countries have several vaccines to choose from, but Astra-Zeneca is currently the linchpin in the strategy to vaccinate the rest of the world. Some developing countries have received doses of Chinese-made or Russian-made vaccines — often as donations — but, at least in Africa, these allotments have usually been relatively small. The Chinese and Russian vaccines have not yet been endorsed by WHO and so cannot be distributed by COVAX


Africa, with a population of 1.3 billion, hopes to vaccinate 60% of its people by the end of 2022. That target almost certainly will not be met without widespread use of AstraZeneca. And experts have warned that until vaccinations rates are high the world over, the virus remains a threat everywhere.

The eroding confidence in the AstraZeneca vaccine only compounds the difficulties Africa will face in rolling out their inoculation campaigns. The continent is home to some of the world's weakest health systems. Nations there have struggled just to test enough people for the coronavirus, and the actual toll is unknown because of challenges in tracking cases and deaths. According to the Africa CDC, more than 4 million coronavirus cases have been confirmed across the continent, including over 108,000 deaths.

In an analysis released Thursday, the World Bank found that 85% of low- and middle-income countries had a plan to vaccinate but less than a third had public engagement strategies to combat hesitancy and misinformation about vaccines.

That means confusion like that caused by the pause in AstraZeneca across Europe can be hard to iron out.

"It complicates the situation," said Dr. Misaki Wayengera, head of a technical taskforce that's advising Uganda's pandemic response, referring to the suspension. "It's the best shot we have here, and we should be able to take it."


