EC makes fresh push for electoral reforms with Law Min

NEW DELHI, FEB 18 (PTI): The Election Commission on Tuesday made a fresh push for electoral reforms with the government, including making paid news and false affidavits electoral offences.

In a meeting with Legislative Secretary G Narayan Raju, Chief Election Commissioner Sunil Arora and fellow Commissioners Ashok Lavasa and Sushil Chandra also discussed linking of voters list or electoral roll with Aadhaar numbers to clean up duplicate entries, a poll panel statement said.

In a letter to the Law Ministry, the commission recently proposed that provisions of the Representation of the People Act be amended to allow EC to seek Aadhaar numbers of those applying to be voters and those who are already part of the electoral rolls, sources in the poll panel explained.

Accepting the proposal to give it legal backing to collect Aadhaar data, the Law Ministry is learnt to have asked the poll panel to ensure that the data is protected at multiple levels.

The EC recently listed out steps to protect the data from possible leaks.

The poll panel also pitched for having more than one qualification date in a year for a person to become a voter the statement said.

At present, January 1 is the only date every year for a person to qualify as a voter. The EC wants multiple dates so that more people turning 18 years of age can apply to become voters throughout the year.

A statement by the Election Commission said Arora reminded the Law Ministry brass that there are more than 40 different proposals of electoral reforms which are "pending since long".

Another proposal that the EC pressed for on Tuesday is making electoral law gender neutral for armed forces personnel, the statement said.

As of now, an armyman's wife is entitled to be enrolled as a service voter, but a woman army officer's husband is not, according to the provisions in the electoral law.

A bill which lapsed following the dissolution of the previous Lok Sabha proposes to replace the term 'wife' with 'spouse', thus making the provision gender neutral.

GANGTOK, 18 FEB: Temporary employees hired under Mahatma

Gandhi National Rural **Employment Guarantee** Act [MGNREGA] with Rural Development Department have thanked Chief Minister PS Tamang for his recent announcement promising regularization of MGNREGA employees.

They are now hoping to their regularization orders at the earliest.

"We came to know that the concerned department has already moved a file for regularization. We would like to also thank the RDD Min-

ister and the department for such quick action," they expressed.

Addressing a press conference here this afternoon, MGNREGA employees from different districts thanked the State government and the CM for initiating the regularization process.

They informed that there were 220 MGN-REGA employees in the State of whom 170 have already qualified for regularization [as per criteria enumerated in a recent government notification] having completed continuous service of five years as on 31 December 2018.

"MGNREGA employees have been working at every GPU and the seniormost MGNREGA employee has already completed 12 years of continuous service. The file for our regularization was moved in the previous government as well but nothing happened of it. We are very happy with the new government for having immediately taken this initiative in the interest of MGNREGA employees and their fam-

ilies," they said. They further reiterated their hope to receive the regularization orders at the earliest.

Over 50 pc of Indian birds at long-term risk: Report

GANDHINAGAR, FEB 18 (PTI): A report on Indian birds has claimed that over 50 per cent of the 867 species studied exhibit a population decline in the long term, while 146 are at great risk in the short term.

The study - 'State of Indias Birds 2020' - states raptors, migratory seabirds and habitat specialist birds were most affected in past decades.

The research was released Monday at the ongoing United Nations 13th Conference of the Parties to the Convention on Migratory Species here.

"This assessment of nearly 867 Indian species makes it very clear that our birds are in overall decline, in some cases catastrophically so," states the report.

For the long-term, over 25 years, the data found that 52 per cent of 261 species were projected to decline, while for the short-term, almost 80 per cent of 146 species were on a decline.

The number of birds in the Western Ghats, considered one of the worlds foremost biodiversity hotspots, declined by almost 75 per cent since 2000, the report said.

On the positive front, the study said Indian Peafowl, the national bird, has shown a dramatic increase in both abundance and distribution across the country.

The number of house sparrows has also stabilised nationwide, although there is still a marked decline in their population in cities, it

Using data uploaded by birdwatchers on the online platform eBird, the analysis indicates that 48 per cent of species have remained stable or are increasing in the long-term (over 25 plus years), while 79 per cent show a decline in the last five years, the report said.

Of the 146 species for which current annual trends could be estimated, nearly 80 per cent are declining, with almost 50 per cent declining strongly, it said.

The report relies on over 10 million observations contributed by over 15,500 birdwatch-

The report is a result of collaboration between 10 research and conservation organisations, including the Ashoka Trust for Research in Ecology and Environment, Bombay Natural History Society, Wildlife Institute of India, World Wide Fund for Nature India, Salim Ali Centre for Ornithology and Natural History and Wetlands International South Asia.

Tokyo marathon cancels mass race over coronavirus scare

TOKYO, 18 FEB [THEGUARD-IAN]: The mass participation race at the Tokyo marathon, which was expected to have 38,000 people taking part, has become the latest sporting casualty of the coronavirus. In a statement organisers confirmed the event on 1 March will now be limited to the elite field of 176 athletes and 30 wheelchair athletes.

"We have been preparing for the Tokyo marathon 2020 while implementing preventive safety measures, however, now that a case of Covid-19 [coronavirus] has been confirmed within Tokyo, we cannot continue to launch the event within the scale we originally anticipated," they said.

Organisers said that all registered runners would be allowed to defer their entry until next year. But they would have to pay again and would also not get their money back from this year's race. One British runner who had entered the race told the Guardian that she understood the decision but from a personal and financial perspective it was hard to take 13 days before the race.

"My husband Max and I had been planning



to run the Tokyo marathon for over two years so to hear this news is gutting," said Sarah Dudgeon, who had been hoping to run the race in under three hours.

"We understand and respect the decision but you can't helping feeling the personal ramifications. We had trained hard through the winter and were hoping this would be the running holiday of a lifetime. As things stand, we don't know whether the £3,000 we have paid for flights and hotels will be refunded if we decide to run the race next year."

Last week organisers had sounded confident the event would go ahead, announcing plans to distribute surgical masks to runners and volunteers as part

preventive safety of measures against the virus. They had also told the 1,800 runners from China they could defer their entry until 2021 without any penalty.

However, the continuing spread of the virus meant on Monday they had little choice but to take the drastic step of limiting the race - which doubles up as an Olympic trial for Japanese marathon runners - to just over 200 participants.

to raise more concerns about whether the virus could disrupt the Olympic Games in Tokyo, which are due to start on 24 July. So far there have been more than 70,000 cases in China, with 1,770 deaths. Last week senior officials at

the International Olympic Committee insisted there was no plan B to reschedule the Games.

"There's no case for any contingency plans or cancelling the Games or moving the Games," John Coates, the head of an IOC inspection team, said. He added the World Health Organisation had advised him that a back-up plan was not necessary and that the Games remain "on track".

Other experts have warned that the coronavirus-related health risks to Japan are hard to predict. "There is no guarantee that the outbreak will come to an end before the Olympics because we have no scientific basis to be able to say that," said Shigeru Omi, a former regional director of the WHO.

The Tokyo marathon is the biggest sporting event to be affected by the coronavirus. In the past month the World Indoor Championships, due to take place in Nanjing, China in March, were cancelled along with the Shanghai Formula One Grand Prix.

Other sporting events to have been called off or postponed in recent months because of the virus include the Hong Kong Sevens international rugby tournament, the annual Singapore Yacht Show and almost all sports in China.

The London marathon said the situation for the race in April remained unchanged. Hugh Brasher, the event director, said: "We, along with the rest of the world, are monitoring closely the developments relating to the spread of coronavirus and noting the updates and advice given by the UK government, the World Health Organisation and other public bodies. With more than two months to go before the event on Sunday 26 April, we will continue to monitor the situation. We will keep our deferment policy under review as the situation evolves."

Sources in the poll panel pointed out that other proposals pending with the government include making filing of false declaration a ground for disqualification and putting a cap on expenditure by candidates in legislative council polls in the coming days.

The EC has also asked the government to make bribery during poll period a cognisable offence.

While the Law Ministry is the administrative ministry for the EC, the Legislative Department is the nodal unit for issues related to the poll panel.

Referring to the issue of filing false declaration, the arces said, as of now, it attracts six months' jail term but the EC wants to make it an "electoral offence".

Conviction in an electoral offence is a ground for disqualification. "Jail term of six months does not instil fear, disqualification will," another official explained.

As of now, candidates contesting legislative council elections don't have a bar on campaigning expenses, which, the EC wants to put a cap on.

The expenditure should be half of what is allowed for candidates contesting assembly polls. Every state has a different expenditure limit based on its size, number of voters and assembly seats.

As of today, bribery in elections is a non-cognisable offence where an investigation cannot take place without a magistrate's permission. The EC wants to make it a cognisable offence and bring in the category of "serious" crimes like murder, dowry, death, and rape.

The legislative secretary assured that the ministry is already examining these proposals, the statement said.

Aligarh SP leader's son shot dead in 'road rage' case



ALIGARH (UP), FEB 18 policeman, were injured their supporters, the poty leader's son was shot dead during a violent clash that broke out here after a "road rage" incident involving them and a local BJP politician's son, police said on Tuesday.

They said 20-yearold Sachin, son of a district-level SP leader Puranmal Prajapati, was killed Monday night in Palasahibabad locality in Sasni Gate area as the argument following the collision between two motorcycles led to stone-pelting and firing.

At least six people, including the deceased's younger brother and a

They were on a motorcycle which collided with the two-wheeler of Amit, son of Ishwar Chand Upadhyay, a BJP leader who was previously an office-bearer in the party's district unit, the police said.

The incident led to a heated argument between them which escalated into stone-pelting and gunshot firing as the two sides were joined by set Amit's motorcycle

'Cyanide' Mohan gets lifer in 19th murder case ment. According to the

MANGALURU, FEB 18 (PTI): Notorious serial killer 'Cyanide' Mohan has been sentenced to life imprisonment by a court here for the murder of a 23-year old woman from Kasaragod district of Kerala in 2006, the 19th of the 20 murder cases slapped against him.

Sixth additional district and sessions court judge Sayeedunnisa on Monday sentenced Mohan to life and imposed a fine of Rs 25,000 on him.

The sentence shall commence after he serves the sentence of imprisonment in the other cases, the judge said.

This is the 19th case out of the 20 murder cases registered against the criminal, who has killed several women using the deadly cyanide after befriending and raping

Earlier, he had been awarded death sentence in five cases and life imprisonment in three cases. Two of the death penalties were later commuted to life imprisoncharge sheet in the latest case, Mohan met the woman while she was coming to work at a unit of CAMPCO here.

After befriending and offering to marry her, on January 3 in 2006, he took her to Mysuru and stayed in a lodge near the bus stand. Like in all other cases,

the next morning, Mohan asked the woman to remove her ornaments. The two went to the KSRTC bus stand where he asked her to consume a pill convincing her that it was a contraceptive. However, it was laced with cyanide.

The woman, who consumed the pill in the washroom, collapsed and declared brought dead at a hospital where she was rushed by those in the room. As in previous cases, Mohan went back to the lodge and left the place along with her ornaments.

He was arrested later from Bantwal in 2009, after which he admitted to killing 20 women.

Gujarat govt partners with SBI to facilitate MSME loans AHMEDABAD, FEB 18 signed between principal has increased this year

(PTI): The Gujarat government on Tuesday signed an MoU with State Bank of India (SBI) to facilitate approval of loans to entrepreneurs in the MSME sector with ease and within a short time-frame.

As per the MoU, the top public sector lender will provide working capital to entrepreneurs seeking to start new micro, small and medium enterprises (MSME) within a short time -frame after providing theoretical approval within 15 days of making an application, the government said in a re-

lease here. The MoU was

secretary M K Das and SBI Ahmedabad circle general manager Ramesh Kumar Agarwal.

Within 15 days of making an application, the bank will provide theoretical approval to the project. Start-ups can submit an application on either the MSME portal or to the local nodal agencies, it said.

The SBI decided to help MSME entrepreneurs in Gujarat looking at their high recovery rate, said the release.

SIC probing irregularities in **APSSB** examination: Khandu

ITANAGAR, FEB 18 (PTI): Arunachal Pradesh Chief Minister Pema Khandu on Tuesday said a special investigation cell (SIC) is probing the alleged irregularities in the examination conducted by the Arunachal Pradesh Staff Selection Board (APSSB).

Khandu said those involved in the APSSB fiasco will not be spared and the guilty will be punished.

"Within a day of investigation, the SIC has got several leads and I assure the people that soon the guilty will be in the dragnet of law," he said.

Speaking at a function here, Khandu said, "For the last three years I have been repeating ... that corruption in any form will not be tolerated and those found guilty, irrespective of power and position, will not be spared. I am surprised that despite repeated warnings people still have the courage to do



corruption."

The APSSB came under public criticism after purported optical mark recognition (OMR) sheet went viral on social media, soon after the results of the examination for lower divisional clerk (LDC), junior secretariat assistant (JSA) and other posts were published on its website on February 14.

Several

who appeared in the examination on Monday launched a protest march here, demanding immediate suspension of APSSB chairman VC Verma and controller of examinations SK Jain for their alleged failure to conduct the exams properly.

The chief minister said the APSSB was constituted to provide transparent, fair and

equal playing ground for the unemployed youths of the state to join government jobs at the lower levels.

PATNA, FEB 18 (PTI): Election strategist-turned-politician Prashant Kishor on Tuesday questioned the Nitish Kumar government's development model, even as he sneered at the chief minister for making ideological compromises to stay in an alliance with the BJP.

Kishor, who has been vocal about his opposition to the Citizenship Amendment Act (CAA), said Kumar needs to spell out whether he is with the ideals of Mahatma Gandhi or those who support Nathu Ram Godse.

Speaking at a press conference here, he said, "Nitish ji has always said that he cannot leave the ideals of Gandhi, JP and Lohiya... At the same time, how can he be with the people who support the ideology of Godse. Both cannot go together. If you want to stay with the BJP, I don't have any problem with it but you

cannot be on both sides."

"There has been a lot

of discussion between me and Nitish ji on this. He has his thought process and I have mine. There have been differences between him and me that the ideologies of Godse and Gandhi cannot stand together. As the leader of the party you have to say which side you are on," he added.

In a direct assault on Kumar's model of governance, Kishor said Bihar was the poorest state in 2005 and continues to

"There has been development in Bihar during the last 15 years, but the pace has not been as it should have," the former JD(U) leader said.

He challenged Kumar to a debate with him in an open forum on data points pertaining to the state's development. "People are asking

what has Kumar done for Bihar's development and what will he do if his JD(U) wins the upcoming state polls," he said.

Kishor, the architect of several successful political campaigns, announced the 'Baat Bihar programme, aimed at making Bihar one of the 10 best states in the country. It will be launched on February 20.

He said he will work towards developing young leaders in the state.

In January, the JD(U) had expelled Kishor from the party, saying his conduct in recent past has made it clear that he does not want to abide by the party's discipline.



Curtailing Corruption

Read, notice, realize and demand accountability

In the year 2017, the Legislative Assembly was $oldsymbol{\mathsf{L}}$ informed that a total of 515 corruption cases had been registered by the Vigilance Police in Sikkim in the past 23 years. This works out to an average of around 22 Vigilance "cases" every year. That works out to two per month with a December off. But averages can be misleading and it would be more interesting to also find out how these cases are spread out over the years, when they record a slump or when they surge. Meanwhile, something like 259 government servants and 256 private citizens have been implicated in these cases and chargesheets have been drawn up in 183 instances. Now, with the Vigilance Police bringing in contract investigators with CBI experience, expect more cases to be filed, more raids and social media convictions. But can this be expected to have any real effect on corruption? Unlikely, because crackdowns have for far too long been about settling scores than establishing accountability. But we get ahead of the story.

Corruption cannot be tackled by government agencies instituted directly to combat this problem, the noise about CBI in Sikkim is thus just that, noise. After all, these agencies, whether the CBI or the Vigilance, with their charter to investigate corruption, become convenient weapons of mass political destruction. In the hands of politicians, as we see often with CBI and almost always with Vigilance, this arsenal gets aimed at reputations and does not target the faulty system itself. The system, after all, outlives reputations and political coteries and everyone in the political ratrace will want the system sustained in its murky existence so that it can be oiled to serve their needs when they command it. This explains why such agencies make raids, file FIRs and draw up chargesheets into major media events, but downplay the actual trial and verdicts or even the processing of such cases.

Even when earnestly implemented and enforced without bias, this approach addresses only one end of the corruption chain. A more effective option would be for those who feed this monster to decide otherwise. Corruption would get automatically contained. But that is easier said than done and would require a ground swell of civil activism, even the tremors of which not yet in the making; at least not in Sikkim yet.

Does that mean that corruption cannot be contained? What would life be without some optimism? Of course corruption can be contained; by deploying guerrilla tactics that seem to serve every de-prioritised issue so well. Instead of knocking on doors of anti-corruption agencies, the people should start studying documents produced by the non-aggressive arms of the executive like the CAG reports and the even the annual reports of respective departments with more interest. These documents encapsulate findings and claims and each links up with accountability. It is because people continue to ignore the importance of fixing accountability and demanding it that the system continues to corrode. The voters have to demand of their elected representatives to hold departments and its officials accountable. The leaders need votes and if the voters lay the condition of accountability in exchange for support, then their representatives will deliver them accountability. Once the message gets through that transgressions in handling of public accounts will no longer be excused with merely "don't do it again" advise, things will start falling into line. Corruption would have been curtailed to a significant extent.

Kashmir: Why Trump's Offer of International Mediation is a Good Idea

Before a recent meeting in Davos with Pakistani prime minister Imran Khan, Donald Trump reiterated his offer to help mediate over the issue of Kashmir.

It's been six months since India revoked the special constitutional status for the disputed territory of Indian-administered Jammu and Kashmir and put the state on lockdown. While internet restrictions have eased, connectivity remains patchy and prominent local politicians are still in detention.

Khan's administration objected to the revocation on the grounds that Jammu and Kashmir is internationally recognised as a disputed territory. It argued that India's unilateral decision contravened UN resolutions on the conflict, the Geneva Conventions, and India's own constitution and supreme court. Pakistan also expressed concerns about ethnic cleansing and genocide.

Since then, the Indian government of prime minister Narendra Modi has repeatedly refused to accept mediation over Kashmir, something Khan says he is open to. The question of mediation is likely to come up at a forthcoming visit to India by Trump in late February.

My ongoing doctoral research suggests that mediation by the world's great powers – such as the US, UK, Russia, China or Turkey – to resolve the festering conflict over Kashmir could pave the way for greater security cooperation in the Pakistan-India-Afghanistan triangle.

The disputes over the line of control that separates Indian- and Pakistani-administered Jammu and Kashmir, and the Durand Line separating Pakistan and Afghanistan, are remnants of the decolonisation process. These disputes have complicated security relations in South Asia and led to lingering instability, hindering regional cooperation and integration.

Since 1989, India has deployed between 600,000 and 700,000 soldiers to Jammu and Kashmir. Alleged human rights abuses on the part of

the Indian security forces have included rape, torture, extrajudicial killings, custodial disappearances, and the violent suppression of protests – one of the fundamental rights of citizens in a democracy. These have been documented in reports by the UN Office of the High Commissioner of Human Rights. In the summer of 2016, 17,000 demonstrators were injured in a brutal security crackdown. This has fuelled a further sense of marginalisation among local Kashmiris.

A SHARED HISTORY

I'm looking at the Kashmir issue from the perspective of the English school of international relations, a theoretical approach to international affairs that emphasises countries' pursuit of shared interests and values through common institutions, human rights and diplomacy. This theory argues that the great powers have a special responsibility to maintain security and stability in the world.

In the Pakistan-India-Afghanistan triangle, despite deep-seated conflicts, all three countries have repeatedly turned to the institutions and norms of international society to seek to resolve disputes and defuse tensions. For example, Pakistan and India have repeatedly attempted to engage in a bilateral dialogue and to share intelligence on terrorism. Afghanistan's inclusion in the South Asian Association for Regional Cooperation (SAARC) is another example of this desire to use international institutions to defuse tensions. Such regional cooperation is a foundation upon which to build a more cooperative trilateral relationship – if the countries choose to do so.

Pakistan, India and Afghanistan have a shared history going back to the Mauryan Empire of the fourth century BC. Ethnic and religious identities spill over borders and the common cultural heritage is rich, spanning music, food, cinema, poetry, language and spirituality.

The security threats plaguing this region are shared too. Violent extremist groups are a concern not only for India, but for Afghanistan and Pakistan too. While India repeatedly blames Pakistan for

attacks in Jammu and Kashmir and other parts of India perpetrated by the Jaish-e-Mohammed and Lashkar-e-Tayyaba militant groups, Pakistan believes that India supports the Tehreek-e-Taliban Pakistan, which has caused tremendous insecurity in Pakistan over the past two decades.

It also accuses India of supporting secessionism in the province of Balochistan, which threatens the economic corridor between China and Pakistan. Afghanistan has been destabilised by the Afghan Taliban and Haqqani Network and regularly blames Pakistan for backing them.

This cycle of allegations and counter-allegations hides the fact that these terrorist groups are non-state actors who work across borders. A comprehensive counter-terrorism strategy requires security and intelligence cooperation, alongside an approach that addresses the political, social, economic and psychological factors underlying terrorism.

BREAKING THE DEADLOCK

A first step towards unravelling the knotty security dynamic in this region could be a positive response to the American offer to mediate on Kashmir. In the absence of bilateral headway in the peace process, third-party mediation is a reasonable way of attempting to break the deadlock. The successful settlement of the dispute over Kashmir could open the way to negotiations on the other core and interlinked issue of transnational terrorism.

The Pakistan-India, Pakistan-Afghanistan, and India-China territorial disputes are legacies of colonisation. The mistrust between Pakistan and India has hampered efforts to forge cooperation in the wider South Asian region, as shown by the cancellation of the 19th SAARC summit in 2016.

If India wants to be a great power in the emerging world order, it must first achieve a peaceful and stable neighbourhood. Accepting Trump's offer would be a step in this direction.

Caroline Flack's death is yet another reason to be angry at the way the media treats women

In October 2019, a few days after World Mental Health Day, Caroline Flack, renowned television presenter and, until recently, host of ITV's flagship show Love Island, took to Instagram to write about the pressure she felt under:

This warning shot, directed toward traditional media, trolls and fans alike, wasn't heeded by all. When Flack and her boyfriend, Lewis Burton, were allegedly involved in a physical fight at her home on Thursday December 12, she was arrested and charged with assault. The tabloid furore that followed can only be described as gleeful.

The Daily Mail published closeup photographs of blood-spots on Flack's pink front door, alongside a list entitled "A History of Flack's Toyboy Lovers". Painting Flack as a "cougar", the implication was that she was somehow unbalanced, and that her charge of assault was an inevitable outcome of her unruly behaviour. Her penance.

It is of course impossible to know what happened, but the media's treatment of Flack is sadly familiar and emblematic of a broader trend of treatment of female celebrities in and by the media. Over the years my work has focused closely on the media's portrayal of gender. I've seen countless instances of the way that women – who have both talent and youth on their side and dare to date, dress glamorously and speak their

minds – have been seen as a threat by

the popular press.

Kathleen Rowe, an American former newspaper reporter and editor turned academic, wrote about "unruly women" back in the 1990s as women who "use humour and excess to undermine patriarchal norms and authority", citing examples from Mae West to Roseanne Arnold. But contemporary unruly women arguably look and perform differently. As recent studies on celebrity suggest, modern-day celebrities are widely interpreted as images rather than as real people.

And this is particularly the case with women. In their study of the forms and functions of female celebrity, academics Su Holmes and Diane Negra identified a "gendered dynamic" in the contemporary treatment of celebrities, conveyed clearly through the "popular interest and pleasure in the misfortunes of female celebrities". Citing comparative research undertaken by reporter Alex Williams and published in The New York Times, they noted his finding that parallel incidents involving drug use, attempted suicide, relationship breakdowns and mental health issues demonstrated a clear, gendered disparity. Williams concluded that:

"Men who fall from grace are treated with gravity and distance, while women in similar circumstances are objects of derision, titillation and black comedy."

CELEBRITY AS COMMODITY

While the notion that stories and images can injure is well-trodden ground, it is easy to forget that news is not neutral on this score. High-pro-

file women whose job, like Flack's, is to "perform", or to "front" shows, are particularly exposed to the risks of press intrusion and vilification. The media's role in "taking them down a peg or two" isn't new either, but speaks to a long history of women's abuse by the media, tapping into and regurgitating the Madonna/whore dichotomy. Simply put, women are either chaste and maternal or bad, mad and promiscuous.

Of course, such a simplistic rendering of women works to benefit a society in which male power and control is retained. And many women beyond Flack have experienced similar treatment recently – from Amy Winehouse to Megan Markle.

This group of women isn't homogeneous – but the pattern of their treatment is. Like all women, Flack's life was undoubtedly complex, but was flattened for the benefit of a providing a known narrative, and driving sensational headlines.

Mental health is an important facet of the conversations that have come out in the press after the tragic news that Flack took her own life on February 15. While much of the news coverage has been empathetic, highlighting her talent and kindness toward others, there is still a sense in some stories that her struggles with mental health prove that she wasn't a worthy woman after all. The Daily Mail couldn't help reprising Flack's "turbulent love life", while The Sun – although sympathetic – speculated in some de-

tail about Flack's mental health.

It's important to note that Flack

herself hadn't had an opportunity to speak about what had happened. In the months following her arrest, she was silenced, apart from a rare Instagram post in which she hinted at the pressure she was under.

Whether a legal silencing strategy or a PR-related one, what's known is that Flack didn't tell her story, at least not publicly. And considering the level of toxic trolling that high-profile women are frequently subjected to online, it's not a surprise. Jesy Nelson from the girl-band Little Mix is just one recent example of a celebrity who reported that online trolling drove her to attempt to take her own life.

Much needs to change. The treatment of high-profile women in the press and online affects all women because it's so visible, so palpable – from MPs, to celebrities, to teenage girls trying to navigate everyday life. But it also effects the whole of society. And we deserve better. The media is not however a hypodermic syringe, injecting us with a message that is directly and wholly received. We are not passive consumers.

But as British academic Rosalind Gill has argued, the media doesn't just reflect society and gender norms, it shapes them. These representations and narratives about women are inauthentic – but, more than that, they are damaging. Change can happen but it needs to be structural and collective and kind. Imagine if we could all get behind that.

Affidavit case: SC reserves verdict on plea of Fadnavis to review order asking him to face trial

NEW DELHI, FEB 18 (PTI): The Supreme Court on Tuesday reserved its verdict on former Maharashtra chief minister Devendra Fadnavis' plea seeking review of its 2019 judgement asking the BJP leader to face trial for allegedly failing to furnish details of pending criminal cases against him in his 2014 poll affidavit.

Senior advocate Mukul Rohatgi, representing Fadnavis, told a bench headed by Justice Arun Mishra the issue will have very far reaching consequences for other candidates fighting elections and the top court needs to re-examine its October 1, 2019 decision. In its judgment last year, the apex court had set aside the Bombay High Court order which gave a clean chit to Fadnavis and held that he did not deserve to be tried for the alleged offence under the Representation of Peoples Act (RPA).

During arguments, Rohatgi said a candidate can be criminally prosecuted for violating the two conditions



of not disclosing cases where charges have been framed and where he or she has been convicted.

"This will seal my fate. It is an important question as it affects Article 21. This is a matter which requires a relook," Rohatgi told the bench, also comprising justices Deepak Gupta and Aniruddha Bose.

The apex court's verdict had come on an appeal by one Satish Ukey, who had challenged the high court's order.

On July 23, 2019 the top court, while reserving the verdict on Ukey's plea, had said that the alleged "omission" by Fadnavis of not disclosing information about two criminal cases in his election affidavit may be decided in the trial.

The apex court had said that it was concerned with a limited issue whether prima facie Section 125A of the RP Act is attracted or not.

The provision deals with the penalty for "filing false affidavit" and says that if a candidate or his proposer fails to furnish or gives false or conceals any information in his nomination paper on issues like pending criminal cases then the person may be awarded six months jail term or fine or both. Ukey had contended the BJP leader

filed a false affidavit by not disclosing two criminal matters and yet the trial court and the high court held that no prima facie case was made out for prosecution of the chief minister.

He had said that a candidate was under mandatory legal obligation to disclose details of all cases, in which either charges have been framed or the trial court had taken cognizance, in nomination papers.

The petitioner had alleged that Fadnavis, in his election affidavit filed in 2014, had failed to disclose the pendency of two criminal cases against him.

It was contended that the chief minister did not disclose the information as required of him under the election law and the non-disclosure of these two pending criminal cases was in violation of Section 125A of the RP Act and constituted an offence in itself.

The two cases of alleged cheating and forgery were filed against Fadnavis in 1996 and 1998 but charges were

Activist seeks thorough probe in CBI judge Loya's death

MUMBAI, FEB 18 (PTI): A group of citizens on Tuesday demanded a thorough inquiry into the death of special CBI judge Brijgopal Harkishan Loya in 2014.

The group has written a letter to Maharashtra Chief Minister Uddhav Thackeray, seeking a time-bound probe into the death of Loya.

Loya, who was hearing the high-profile Sohrabuddin Sheikh fake encounter case of Gujarat, died of a cardiac arrest in Nagpur on December 1, 2014, when he had gone to attend the wedding of a colleague's daughter.

Social activist Ashok Pai, addressing a press conference on behalf of the group, also demanded proper compensation for the judge's family, saying he was on an "official" tour.

Pai said on Tuesday he met NCP president Sharad Pawar, whose party is a key constituent of the Maha Vikas Aghadi (MVA) government in Maharashtra, and raised these demands with him.

Pawar assured to look into the demands, he said at the press conference at the Mumbai Marathi Patrakar Sangh.

"We have handed over a letter to Maharashtra Assembly speaker Nana Patole and dispatched a copy of the letter to Chief Minister Uddhav Thackeray (seeking a probe into Loya's death)," Pai said. As the matter relates to "mysterious" death of a sitting judge of the CBI, all facts about it must be made public after a detailed and time-bound probe, Pai said.

The Loya death case had reached the Supreme

The Supreme Court had held that Loya had died of "natural causes" and had rejected PILs seeking an SIT probe into the death, questioning their motive.

The SC had held that petitions were moved by political rivals to settle scores which was a serious attempt to scandalise the judiciary and obstruct the course of justice through a "frontal attack" on its independence.

Bengali actor and former MP Tapas Paul dead



KOLKATA, FEB 18 (PTI): Veteran Bengali actor and former Trinamool Congress MP Tapas Paul died of a cardiac arrest in a Mumbai hospital early Tuesday, his wife said. He

was 61. Paul, who had a long history of heart problems, was admitted to a private hospital in Mumbai, where he had gone to meet his daugh-

ter in January.

The two-term former MP from Krishnanagar, who moved away from both cinema and active politics after the CBI arrested him in the Rose Valley chit-fund scam in December 2016, is survived by his daughter Sohini and wife Nandini.

According to Nandini Paul, the actor was rushed to hospital on February 1 after he fell ill at the Mumbai airport on his way to the United States for treatment.

The actor-politician, known for films such as "Saheb" and "Amar Bandhan", was on the ventilator till February 6.

"He was taken off the ventilator and was recovering, but suddenly his condition worsened and he died of cardiac arrest around 3.30 am on Tuesday," Nandini Paul told PTI.

Paul had been suffering from heart ailments and been in and out of hospitals for treatment during the past two years.

Hooghly Mohsin College in bioscience.

West Bengal Chief Minister Mamata Banerjee said in her condolence message that Paul's death had left a deep void in films and politics.

"Saddened shocked to hear about the demise of Tapas Paul. He was a superstar of Bengali cinema who was a member of the Trinamool family. Tapas served the people as a two-term MP and MLA. We will miss him dearly. My condolences to his wife Nandini, daughter Sohini and his many fans," Banerjee tweeted.

A romantic hero, having endeared himself to the Bengali audience since his debut film "Dadar Kirti" in 1980, Paul became a household name with his leading roles in "Parabat Priya" (1984), "Bhalobasa Bhalobasa" (1985), "Anurager Choyan" and "Amar Bandhan" (1986).

He made his Bollywood debut in Hiren Nag's "Abodh" (1984) opposite Madhuri Dixit Nene.

"The loss of Tapas Paul who was one of the very first actors, I have worked with is felt by many. May God bless and comfort his family during this difficult period," Madhuri wrote on Twitter.

He was awarded the Filmfare Award for "Saheb" (1981).

In a career spanning over three decades, Paul

had worked with veteran

actors Prosenjit Chatterjee, Soumitra Chatterjee, Ranjit Mallick and Raakhee Gulzar.

Some of his last appearances were in films such as "Khiladi" and "Aat ta Aater Bongaon Local".

Actor Ranjit Mallick described Paul's death as

"untimely". "I am yet to come to terms with the news. He was like my younger brother. He was not keeping well for some time," Mallick said.

Paul's colleagues in films and politics, actors Debasree Roy and Chiranjeet Chakraborty, both TMC MLAs, said they had lost a dear friend and the film industry a brilliant actor.

Paul, inspired by Banerjee and her fight against the Left Front regime, joined the Trinamool Congress in 2000 two years after it was formed.

He was elected as the MLA from Alipore Assembly seat in 2001. Paul was elected as the MP from Kishnanagar Lok Sabha seat for two consecutive terms from 2009.

After his arrest in the Rose Valley chit-fund scam, Paul's family members had time and again alleged that the party did not bother to enquire about him. He was arrested and given bail after 13 months.

After his release from prison in 2018, Paul withdrew from active politics and communicated to the TMC his unwillingness to contest elections.


CPI(M) slams cases against social media users in J-K

AMANPREET SINGH BERLIN, FEB 18 (PTI): British F1 ace Lewis Hamilton and Lionel Messi, arguably the world's greatest footballer, were declared the joint winners of the prestigious Laureus World Sportsman of the year award here.

The duo received the same number of votes, a first in the 20-year history of the awards with the jury unable to split Hamilton and Messi.

Messi, the six-time FIFA World Player of the year, is the first team-player to bag the award. He though was not present to receive the award on Monday and sent a video message.

They pipped golfing great Tiger Woods, Kenyan marathoner Eliud Kipchoge, tennis legend Rafael Nadal and MotoGP champion Marc Marquez.

American gymnast Simone Biles, who won five gold medals at the 2019 World Championships, grabbed the World Sportswoman of the year award, her third in four years after winning it in 2017 and 2019.

In the Sportsperson of the year with a disability category, Oksana Masters, born with limb impairments caused by radiation from Chernobyl and adopted by an American single parent, was recognised for an outstanding year in

2019. She won five gold

medals and a silver at the World Para Nordic Skiing Championships.

South Bronx United (SBU), a football programme based in New York, was honoured with the Sport for Good Award. The programme uses football to achieve educational outcomes for young people from underserved communities.

The 2019 Rugby World Cup winners South Africa won their second Laureus World Team of the Year Award, beating Jurgen Klopp's Liverpool and the

Women's Football Team, among others.

For the 2020 Laureus World Comeback of the Year, Germany's gritty F3 driver Sophia Florsch was the winner.

Travelling at 276km per hour, she had lost control of her car at the Macau circuit, crashing through safety barriers and leaving her with a spinal fracture which required an 11-hour surgery and months of rehabilitation.

In November 2019, a year on from her accident, the 18-year-old Sophia was back in the cockpit, racing once again in the Macau Grand Prix.

Egan Bernal, who became the youngest rider to win the Tour de France at 22, grabbed the World Breakthrough of the Year award.

German basketball great Dirk Nowitzki was recognised at the Ceremony with the Laureus Lifetime Achievement Award for his contribution to the sport of basketball.

Spanish Basketball Federation got the Exceptional Achievement Award.

PSG are better placed than ever to satisfy European obsession

PARIS, 18 FEB [THEGUARDIAN]: PSG's dumbfounding defeat to Manchester United in the last-16 of the Champions League last season was among the worst moments in the club's 50-year history. There is fierce recent competition for that accolade, however, with the 6-1 defeat at Camp Nou in 2017 perhaps even more difficult to stomach. Things are looking better this time around though. As the club look forward to a last-16 tie with Borussia Dortmund, they are better placed than ever before to reach the promised land.

Neymar's birthday is probably circled in bold red pen on every PSG fan's calendar. Every year since he arrived at the club his birthday party has been quite the event. The lavish, 300-guest, late-night affair – which usually arrives in the middle of a busy run of games provides an opportunity for the often fragile relationships between PSG players, coaches and officials to become ever more strained, while also attracting criticism and unwanted attention.

This year, coach Thomas Tuchel, sporting director Leonardo and president Nasser Al-Khelaifi declined to attend given that PSG were playing Nantes in the league less than 48 hours after the soirée began. "It gives the impression that we are not 100% focused and professional," Tuchel explained.

However, this year's party became a positive story for PSG. Around midnight Neymar reportedly delivered a speech, saying: "For the first time, I am entirely happy in Paris," and that he wants to "do everything I can alongside my teammates to win everything this year". After the transfer tug-of-war between PSG and Barcelona last summer, when Neymar agitated for a move, the sighs of relief were practically audible outside the Parc des Princes.

Neymar's newfound contentment has been obvious on the pitch for some time. Despite an utterly ridiculous booking following an exchange of words with an official during PSG's 5-0 win over Montpellier earlier this month, he has quietly (by his standards) gone about hitting his best and most consistent form since arriving in France in 2017.

While Ángel Di María remains the hugely underappreciated creator-inchief and Kylian Mbappé continues to attract his own headlines, Neymar, when fully fit, has been unstoppable. He has 11 goals and eight assists in his last 11 games and it is clear that genuine chemistry is developing between the "fab four" of Neymar, Mbappé, Di María and Mauro Icardi.

The squad remains cliquey but Tuchel deserves credit for keeping his team together, both sportingly and socially. PSG are a far more tactically versatile, fluid and streetwise unit under the German than they ever were under Laurent Blanc or Unai Emery, who were both far less successful in asserting their authority over an unruly group.

Leonardo - who returned as sporting director last summer - has played his part in achieving some relative calm. His remit extends well beyond recruitment and he has acted as something of a bad cop for Tuchel in issues of discipline, refusing to accept the previously rampant double standards, while also drawing media attention away from the coach and his squad.

"I am going to speak to you in

French. If some of you don't understand me, all you have to do is take lessons." Leonardo told the squad in July before publicly criticising Neymar for his late return to pre-season. "He was supposed to turn up and didn't," Leonardo told Le Parisien. "We are going to look at the measures we can take, like we would have done for all employees." His deft handling of the Neymar-to-Barcelona saga was also crucial; he played hardball with both the player and the Catalan club, while giving honest assessments of the ongoing situation in the press. Meanwhile, Nevmar's relationship with Tuchel and the rest of the squad remained intact, helping his eventual repatriation.

Leonardo had left the same role back in 2013 under something of a cloud after a lengthy touchline ban following an altercation with a match official. After that PSG lost any semblance of a holistic approach to recruitment. Patrick Kluivert was a disaster as director of football - infamously not even recognising new signing Thomas Meunier when they shared a taxi together - and his successor, Antero Henrique, had a discordant relationship with Tuchel. Expensive transfer failures have been common. Grzegorz Krychowiak (€25m), Gonçalo Guedes (€30m), Thilo Kehrer (€37m), Jesé (€25m) Julian Draxler (up to €45m) and Leandro Paredes (€40m) have all flopped to varying degrees.

Leonardo oversaw much of PSG's initial rise under QSI ownership, with Thiago Silva and Zlatan Ibrahimovic being two of many marquee additions during his first spell. He is playing his part again this season. Leonardo has listened to Tuchel's concerns about the balance of the squad and filled key gaps in defence and midfield. Abdou Diallo arrived from Borussia Dortmund to bolster the centre-back position; Pablo Sarabia (10 goals in his last 13 games) joined from Sevilla and added versatility; Keylor Navas is the experienced and consistent elite level goalkeeper the club have long needed; and Idrissa Gueye has finally replaced Blaise Matuidi as a dynamic midfield presence.

Borussia Dortmund - Tuchel's former club - will give PSG a stringent examination on Tuesday night but, with the three Spanish giants, Manchester City, Bayern Munich and even Juventus all below par domestically this campaign, PSG will be quietly confident about their prospects in the Champions League. Nevertheless, problems remain. Neymar has missed PSG's last four games with injury and his coach says he "may not be 100%" on Tuesday. Marquinhos, Juan Bernat and Marco Verratti are returning from injury and Mauro Icardi's stream of goals has evaporated, with just one in his last eight games.

Improvements and problems aside, PSG are still PSG. The mental frailty that has characterised previous Champions League exits still lurks in the background and, as Mbappé's touchline toy-throwing against Montpellier underlined, things still are not perfect. However, since the Manchester United defeat, Tuchel and Leonardo have quietly begun to mould a well-rounded, astute, harmonious and more committed squad. who are now better placed than ever to satisfy the club's European obsession. Things might finally be coming together in Paris. Even Neymar is happy.

Earlier this month, Pandya was ruled out of the Test series against New Zealand after failing to regain full match fitness.

The decision was taken after the 26-year-old consulted spinal surgeon James Allibone in the United Kingdom.

Pandya underwent a successful surgery in October last year to treat an acute lower-back injury and has remained out of action since.

Horror crash mars end of Daytona 500

MIAMI, FEB 18 (AFP): Denny Hamlin sealed back-to-back victories in an incident-packed Daytona 500, winning a photo finish in a race marred by a horrific crash that left veteran driver Ryan Newman seriously injured.

Joe Gibbs Racing driver Hamlin followed up his victory in 2019 with his third career win at Daytona, becoming the first racer to win the opening leg of the NASCAR season since Sterling Marlin in 1995. However, Hamlin's celebrations were muted by a last-lap crash that left Roush Fenway Racing's Newman hospitalized on Monday.

The 42-year-old Newman's Ford Mustang had led on the final lap but spun out of control, hit the wall and flipped onto its roof before bursting into flames at the Daytona International Speedway. Newman's car was also sent flying into the air after being struck by Go Fas Racing's Corey LaJoie.

Several ambulances sped onto the circuit



ing the crash.

Black screens were erected around the site of Newman's car as workers extracted the driver from the wreck. NASCAR executive vice president Steve O'Donnell later told reporters that Newman was in serious condition at a local area hospital, but his injuries were deemed non-life-threatening.

"He's in a serious condition, but doctors have indicated his injuries are non-life-threatening," a statement from Roush Racing read out by O'Donnell said. "We

appreciate the thoughts and prayers and ask that you respect the privacy of Ryan and his family at this time," O'Donnell added.

Newman's fellow competitors had earlier voiced concern over the plight of the driver following the race. "I knew it was bad,"

Won't rule out playing 2023 World Cup, says Taylor

WELLINGTON. FEB 18 (PTI): Veteran New Zealand batsman Ross Taylor doesn't rule out playing the 2023 ODI World Cup but says his form, fitness and motivation level at the end of next year will decide whether he actually manages a place in the squad.

The 35-year-old will become the first cricketer in the world to complete 100 games across three international formats when he steps out for the first Test against India at Basin Reserve on February 21.

"I haven't ruled it (2023 World Cup) out but I still think it's a long way away. First and foremost I want to get to next year - the Twenty20 World Cup and

then the home summer and then I'll have a good idea on how I'm placed at the end of next summer," Taylor was quoted as saying by 'stuff.co.nz'.

"Whether there is still a drive, whether I'm good enough, whether I'm fit enough, and whether I deserve my spot in the side. If I can tick all those, then definitely 2023 is an option."

The big-hitting batsman said despite his desire to continue, he won't out himself under too much pressure.

"You always want to do well and first and foremost the game is more important. At the same time you can put extra pressure on yourself. You've just got to

go out and enjoy it and take it as another game. Hopefully I can contribute in any way I can," he said.

Japan completes virus testing for quarantined ship **Токуо, FEB 18 (AFP)**: All passengers and crew on board a ship quarantined off Japan have now been tested for the new coronavirus, the government said Tuesday, as more countries moved to evacuate citizens from the boat.

South Korea became the latest to announce it would remove its citizens from the Diamond Princess, where more than 400 people have tested positive for COVID-19.

Japan has faced criticism for its handling of the situation, with dozens of new infections detected almost daily since the ship arrived in early February.

But it has defended its approach and health minister Katsunobu Kato insisted again Tuesday that passengers who test negative will be allowed to leave the ship from Wednesday.

"We have done tests for everyone (on the ship)," he told reporters.

"Some results have already come out... and for those whose test results are already clear, we are working to prepare disembarkation from the 19th," he said. Kato said the process would last two or three days. But those who had close contact with people who have tested positive will have their quarantine reset to the date of their last contact with an infected person.

Crew are also expected to remain to observe another quarantine period after the last passengers leave the ship.

So far, the United States, Canada, Australia, Hong Kong and now South Korea have said they will evacuate their citizens from the ship.

South Korea will send a presidential aircraft on Tuesday to fly back four nationals and one Japanese spouse, an official told reporters. There are 14 South Koreans on board in total, but the other ten have declined to be evacuated from the ship because they live in Japan, the Yonhap news agency reported.

Early Monday, more than 300 Americans were evacuated from the ship, among them over a dozen who have tested positive for the virus.

The Americans, like citizens from other countries being evacuated from ship, will have to undergo another 14-day quarantine. Canada said Tuesday it had "secured a chartered flight to repatriate Canadians on board the Diamond Princess" but gave no details on when the process would take place.

There were 256 Canadians on board the ship, with 32 so far testing positive for the virus.

While foreign governments have couched their decision to remove citizens as an attempt to reduce the burden on Japanese authorities, many have interpreted the evacuations as criticism of Tokyo's handling of the situation.

The US and Australia have told citizens that if they decline repatriation and an additional 14-day quarantine, they will not be allowed home for at least two weeks, suggesting they do not believe the ship-based quarantine has worked.

Dutch court upholds shareholder appeal in \$50 bn Yukos case

Dutch court Tuesday up-Abeld an appeal by shareholders of the dismantled oil giant Yukos in a landmark ruling, boosting their fight in a \$50 billion case for compensation.

The ruling overturns a lower Dutch court's decision in favour of Russia, which had contested an original decision by the Hague-based Permanent Court of Arbitration that awarded shareholders billions of dollars after Yukos was dismantled in the mid-2000s.

"The Appeals Court in The Hague decided today that a previous ruling in favour of the Russian Federation was incorrect," the court said in a statement, adding an original \$50 billion award by the PCA -- an international arbitral tribunal -- "is in force again".

Russia said it would ap-

The long-awaited ruling comes almost 14 years after the once powerful company filed for bankruptcy and follows a controversial 2014 ruling that ordered Russia to pay out billions of dollars in compensation to its former shareholders.

that Russia had forced Yukos

into bankruptcy with excessive tax claims and then sold off its assets to state-owned companies. It based its ruling on the provisions of a multilateral 1994 accord, the Energy Charter Treaty, which aimed to promote energy security.

It then ordered Moscow to pay more than \$50 billion to the former shareholders -- a record award for the arbitration tribunal.

- Shock turnaround -

In a shock turnaround a local Dutch court in 2016 annulled the PCA's decision, saying it was "not competent" to rule in the case, based on the treaty.

But appeals judges disagreed with the lower court's findings, saying "Russia was under an obligation to enforce the treaty unless it was in breach of Russia law."

"This court finds that there was no breach of Russian law." Yukos' main shareholder GML hailed the ruling.

"This is a victory for the rule of law. The independent courts of a democracy have shown their integrity and served justice. a Brutal klep-The PCA that year ruled tocracy has been held to account," chief executive Tim



Osborne said in a statement.

Tuesday's decision however may not be the end of the saga: the parties may still fight the decision at the Dutch Supreme Court, officials said.

Moscow "will continue to defend its legitimate interests and, in an appeal, contest the verdict", Russia's justice ministry said in a statement.

Yukos, once Russia's biggest post-Soviet oil company, was broken up after its former owner, Kremlin critic and ex-tycoon Mikhail Khodorkovsky, was arrested in 2003. His arrest came after

Russian President Vladimir Putin had warned the nation's growing class of oligarchs against meddling in politics.

Yukos was sold off in opaque auctions to state companies led by Rosneft between 2004 and 2006. State-owned Rosneft was then small, but has since become a leading player among the world's biggest listed oil companies by production volume.

The claimants have since sought to win compensation for what they say are their losses caused by the breakup of Yukos.

- 'Not political' -

The question "relates to the circumstances of the Yukos takeover by the Russian oligarchs during its privatisation in 1995 and 1996," Russian government lawyer Andrea Pinna told AFP ahead of the ruling.

As the former Soviet Union crumbled in the early 1990s, unscrupulous businessmen amassed immense fortunes and influential empires by scooping up former Soviet assets -- particularly in raw materials -- at bargain-basement prices.

"Russia considers that the acquisition of Yukos was only possible through corruption and other illegal

acts," Pinna said. This was "not a political case but purely a legal one in which \$50 billion is at stake," the lawyer insisted.

But Emmanuel Gaillard, representing former shareholders, told AFP that "Russia is making considerable diplomatic efforts to try and discredit the players in this case."

"Their strategy is to distort everything, to complicate everything, to make people forget about the greatest expropriation of the 21st century," Gaillard said.

Khodorkovsky, who is no longer a stakeholder, spent a decade in prison on charges of tax evasion, fraud and embezzlement which he and his supporters say were trumped up in revenge for his political ambitions.

He was suddenly pardoned by Putin in 2013 and flown out of the country.

His business partner Platon Lebedev spent more than 10 years in jail for fraud, tax evasion and money laundering after a trial denounced by human rights activists.

Apple to miss revenue forecast as iPhone supply hit by coronavirus

↑ pple announced Monday it open have been operating at re-**A**would miss its March quarter revenue forecast and global iPhone supplies would fall because of the deadly coronavirus epidemic, triggering a fall in Asian stock markets.

The COVID-19 death toll now exceeds 1,800 in China, where it has infected more than 72,000 after emerging in the central province of Hubei in December.

The virus has sparked global economic jitters, with travel bans and mass quarantines inside China forcing factories to suspend operations and shops to close.

Apple, which depends on components from Chinese suppliers and has a big market in China, has been hammered on both fronts.

"We are experiencing a slower return to normal conditions than we had anticipated," Apple said in Google parent company Alphabet a statement.

"As a result, we do not expect to meet the revenue guidance we provided for the March quarter."

Apple had forecast revenue of \$63 billion to \$67 billion for the second quarter to March.

The US tech giant did not disclose how much it expected the outbreak to shave off its revenues.

But it said that worldwide iPhone supply would be "temporarily constrained" as its manufacturing partners in China were only slowly ramping up work after being closed because of the travel restrictions.

Consumer demand in the crucial Chinese market had also been dampened after all Apple stores were shut. "Stores that are (now)

duced hours and with very low customer traffic," the company said. "We are gradually reopening our retail stores and will continue to do so as steadily and safely as

Apple analyst and Loup Ventures co-founder Gene Munster told Bloomberg that the company was feeling the hit from its dependence on Chinese consumers.

"This is the double-edged sword of being in China," he said.

"They're the only big (US tech) company with China exposure, so they are working through the pain of what has largely been a success for the company over the past decade."

Other Silicon Valley behemoths -- such as Facebook, Amazon and -- either have limited access to the market or are blocked outright by China's internet firewall.

However supply chains of global firms such as Apple supplier Foxconn and auto giant Toyota have also been disrupted with production facilities in China temporarily closed.

Sportswear giants Nike and Adidas also shuttered hundreds of stores in the country this month and warned of a negative impact on their earnings.

- Stock market contagion -

Apple suppliers suffered in Tuesday trade after the forecast.

Sony, which provides Apple with key imaging components, lost 2.5 percent, while electronic parts maker Murata Manufacturing plunged more than three percent on the Tokyo bourse. "Traders were downhearted about Apple's announcement," Chibagin Asset Management's Yoshihiro Okumura

Tokyo's benchmark Nikkei 225 index closed down 1.4 percent -its fourth straight session in the red, while Hong Kong's main market was down 1.3 percent.

Monday marked the second time in as many years that Apple cut earnings forecasts due to setbacks in the Chinese market. It followed a downgrade for the 2019-20 financial year due to a lag in iPhone sales, which the company blamed on the US-China trade war.

International Monetary Fund chief Kristalina Georgieva has said there could be a cut of up to 0.2 percentage points to global growth because of the virus.

Outside of hardest-hit Hubei which has been effectively locked down to try to contain the virus, the number of new cases has been slowing and China's national health authority has said the outbreak is under control.

However, World Health Organization chief Tedros Adhanom Ghebreyesus said that the trend "must be interpreted very cautiously".

Further moves by China's central bank on Monday to cushion the world's second-largest economy against the health crisis appear to have done little to allay concerns.

State media said China may postpone its annual parliamentary session, which has been held in March for the past 35 years.

Jaishankar meets EU leaders; holds talks on economic, social issues

BRUSSELS, FEB 18 (PTI): External Affairs Minister S Jaishankar met top leaders of the European Union and held wide-ranging talks on issues, including economic cooperation, climate change and capacity building, that would "benefit both India and EU".

Jaishankar, who was in Germany during the weekend for the Munich Security Conference, arrived here on Monday to prepare the ground for Prime Minister Narendra Modi's planned visit for the India-EU summit here next month.

The foreign minister met EU Commissioner for International Partnerships Jutta Urpilainen and the two leaders discussed experiences in capacity building and development partnerships.

"Coordination these issues would be to the benefit of both India and EU," Jaishankar tweeted.

The minister also held "positive and productive" parleys at the Foreign Affairs Council of the EU.

"Thank the attending Foreign Ministers, Ambassadors & senior officials and most of all HR (High Representative) @ JosepBorrellF. Looking forward to working together to strengthen this key partnership," he said.

Jaishankar also met EU Commissioner for Trade Phil Hogan and "exchanged views on the prospects for India-EU economic cooperation."

He appreciated President of the European Council

Eu-India relations and expressed confident that "his (Michel) leadership can translate that into substantive outcomes."

Jaishankar held a very

"engaging" conversation with Executive Vice-President for the European Green Deal Timmermans Frans and the two leaders discussed experiences on sustainability, climate change, environment and innovation.

Iaishankar also had an open discussion with members of the European Parliament representing a broad spectrum of politics and member states.

"The interaction covered political, economic and social issues. Noted their deep interest in India and our relations with the EU," he tweeted.

Jaishankar's comes weeks after the European Parliament Charles Michel for postponed until March his vision for the EU and a vote on a joint motion, combining five different resolutions tabled by its members against India's Citizenship Amendment Act, which was debated at its Plenary session in

Brussels. During bate, Helena Dalli, the Vice-President of the European Commission and High Representative of the Union for Foreign Affairs and Security Policy, had said the Commission was looking forward to Prime Minister Modi's visit to Brussels in March for the 15th India-EU Summit.
