### Second wave wanes, Sikkim goes seven days with under 100 new cases

ovid infections are clearly going down in Sikkim, and today, for the seventh day in a row, new cases came in at under 100 when only 37 new cases were reported in the past 24 hours. These 37 cases were picked up from the testing of 444 samples yesterday giving the State a daily test positivity rate of 8.3%.

Department, Government of Sikkim, launched a Help Desk/ e-Suvidha Kendra today at Commercial Taxes head office Gangtok. The Help desk was inaugurated by Revenue Secretary of Finance Department, CL Sharma.

The help desk is meant for GST registered tax payers of Sikkim who find it difficult to file their monthly GST returns.

They can also solve interest penalty related problems by consulting

the Help desk officers, informed Commissioner, Commercial Taxes Division, Finance Department, Jigmee Dorji Bhu-

He informed similar Help Desks will shortly open in South and West districts as well.

Revenue Secretary of Finance Department CL Sharma informed that they are also ready with a new Incentive Scheme on lottery basis for voluntary declaration on Tax Invoice. This scheme shall cover transactions within Sikkim for those who have a tax invoice value of a minimum of Rs 10,000 and maximum of Rs 1,50,000.

To claim this incentive, all invoices need to be declared in the Invoice Declaration System on www.sikkimtax.gov.in. After the invoices are declared a verification mail will be sent to the registered e-mail ID. The buyer needs to verify within 15 days or before the last day of the month, whichever is earlier, to qualify for the draw, informed CL Sharma. This incentive scheme will start from October 2021, he added.

The newly connected electricity supply line at the Menmetso Trout Farm was inaugurated by Secretary, AH & VS Department, a press release informs.

On the occasion, the Directorate also organized an awareness program on Riverine Fisheries Conservation which was attended by fish farmers, fishermen and stakeholders. Sangey D Bhutia congratulated the officers and staff of the Directorate for the commendable work done in the

achievement of the Directorate considering various hurdles along the way especially the lack of adequate budgetary pro-

Further, he also urged the general public including the fishermen and stakeholders to come forward and support the Directorate in the conservation of Riverine Fisheries Resources.

Director, Directorate of Fisheries, N Jaswant, in his speech highlighted the importance of Riverine Fisheries conservation. He stated that the population of various fish species has depleted drastically in the recent past due to various anthropogenic activities.

Dr. Pushpa Tamang in the year 1993 had reported about 48 fish species in the drainages of Teesta & Rangeet River system of Sikkim. An independent study conducted by MoEF in the year 2002 had years of its establishment, is a remarkable reported only 31 species. Further, as per aquatic biodiversity.

a preliminary report of the ongoing study being conducted by the College of Fisheries, Lembucherra, Tripura, only 21 species have been reported in Sikkim.

He also stated that among the various reasons for decreasing population of indigenous fishes is the introduction of cat fishes in our riverine system. It is being promoted by a religious practice of the local people called Chettda whereby live fishes (mainly cat fish) are released in the river. There are around five locations where the population of these cat fishes are observed to be the largest. The cat fishes feed upon the small frys and fingerling of the indigenous fishes thereby decreasing their population. Apart from that illegal fishing practices like the use of poison, electric fishing by use of batteries/ UPS which wipes out entire generation of fishes has been contributing to the loss of



The Director also highlighted that indiscriminate loss of aquatic biodiversity is going to have grave repercussions. The fishermen community who are dependent on fishing for their livelihood will be directly affected due to reduced catch. It will also affect the ecology in some way or the other causing the breakdown of the ecosystem. Therefore, the need of riverine fisheries conservation is of outmost importance at this point of time.

The Director also talked about the State Fisheries Policy which is being for- sanctuary shall also be done.

mulated by the Directorate of Fisheries for the first time in the State's history. He further stated that the policy shall focus on:

1. Fish (Flesh & Seed) Production: With the objective to increase the per capita fish consumption of the state from a mere 1.2 Kg per annum to the national average of around 10 Kg the Directorate shall strive for increasing the fish seed and flesh production by formulation and implementing various schemes and programmes.

2. Indigenous fish conservation: Breeding protocol of various indigenous fish species shall be developed and regular ranching of the seed produced shall be done to increase the population of indigenous fishes in the wild. Apart from that, conservation of the breeding and feeding ground of various fish species by providing highest level of protection through some notification or declaration of Fish

the Delhi University had issued an official notification announcing that it would hold physical classes for Science stream students from September 1 in view of a decline in coronavirus cases, following which a section of teachers had expressed displeasure over the university's decision to call students to campus. The university had later deferred its decision, with DU registrar Vikas Gupta saying that the Delhi Disaster Management Authority had not issued any guidelines on reopening of campuses, PTI said.

Talking about the Delhi government's latest announcement that schools and colleges can reopen from September 1, Mr Gupta on Friday said, "We have an executive council meeting on August 31 and we will plan after that and hold a meeting. We won't be able to resume from September 1. Whenever we open, we will first open for Science students."

### In a first, 9 Supreme Court judges take oath in one go

NEW DELHI, 31 AUG [NDTV]: Nine new Supreme Court judges, including three women, were administered their oaths of office by Chief Justice NV Ramana on

Tuesday morning. This is the first time in the history of India's judges have been sworn in at one time. The ceremony was held in the court complex's auditorium building to ensure social distancing and adherence to Covid protocols; traditionally it is administered in the chief justice's court room.

The new judges include Justice Abhay Oka (former Chief Justice of Karnataka High Court), Justice Vikram Nath (former Chief Justice of Gujarat High Court), Justice Jitendra Kumar Maheshwari (former Chief Justice of Sikkim and Andhra Pradesh High Courts) and Justice Hima Kohli (former Chief Justice of Telangana High Court).

Iustice BV Nagarathna (former Karnataka High Court judge) was also sworn in.

The daughter of former Chief Justice ES Venkataramiah, Justice Nagarathna will become India's first woman chief justice in 2027. However, she is likely to have a tenure of only one month.

The other new judges are Justice CT Ravikumar (former Kerala High Court judge), Justice MM Sundresh (former Madras High Court judge), Justice Bela M Trivedi (former Gujarat High Court judge) and Justice PS Narasimha (senior advocate and former Additional Solicitor General). Two weeks ago Jus-

tice Vikram Nath, in his capacity as then Chief Justice of Gujarat High Court, delivered an interim order that said six sections of a state law to stop "love jihad", including one that places highest court that nine burden of proof on the accused could not be allowed to stand. "If the state takes any action for inter-religion marriage, you come to us, we will

> In 2014 Justice Oka, when he was a Bombay High Court judge, ruled "freedom of religion includes right of an individual to claim he is an atheist". This was in response to a plea to restrain the government from forcing citizens to declare their religious affiliations.

> protect you," he had said.

Justice Maheshwari, when she was with the Andhra Pradesh High Court, said "freedom of speech includes right to opt for medium of instruction in (the) mother tongue". That was while quashing a state order seeking to implement English as the medium of instruction for primary schools.

Ravikumar, Justice whose father was a bench clerk in a magistrate's court in Kerala's Changanassery, is famous for having observed that "the law is long, but life is short". The statement was delivered in 2013, and in the context of a person's right to a speedy

Justice Narasimha, in his capacity as ASG, represented the government in the Italian marines case. He also appeared for Hindu parties in the Ayodhya land title suit.

### MLA leaves BJP for Trinamool, 3rd to return after Mamata Banerjee's win

KOLKATA, 31 AUG [NDTV]: BIP MLA Biswajit Das today switched to the ruling Trinamool Congress in Bengal, becoming the third lawmaker to return since Mamata Banerjee's big victory in the April-May state polls.

Biswajit Das had moved to the BJP in an exodus of Trinamool Congress leaders just before the election.

Like many others who claim to have "realized their mistake", he has now joined the reverse tide from the BJP to Mamata Banerjee's party.

Tanmay Ghosh, another MLA who had moved to the BJP and won, returned to the Trinamool on Monday.

The biggest homecoming was that of Mukul Roy, the BJP's first import in Bengal, who returned to the Trinamool in June after four years.

In Bengal politics, Mukul Roy's return was symbolic of the Trinamool's resurgence, and, as the party had calculated, gave other defectors like him a lot to think about.

The return of the defectors is key as the Trinamool preps for the 2024 Lok Sabha election. Its wants to prevent a repeat of 2019, when the BJP

scored big gains at the Trinamool's cost. Mukul Roy had a big hand in it, but the BJP could not sustain the gains by the time it came to the state election.

Mamata Banerjee won a third term with the Trinamool scoring 213 of the state's 294 assembly seats. The BJP put up a tough challenge but was limited to a distant second, with 77 seats. With the latest exit, the BJP's strength in the assembly is down to 72.



### "Will get Ayurvedic treatment in jail": Supreme Court denies Asaram bail

NEW DELHI, 31 AUG [NDTV]: Self-styled godman Asaram's plea for interim bail to receive Ayurvedic treatment was turned down by the Supreme Court today as it noted that what he had been convicted for was "not an ordinary crime at all".

The self-styled godman, who is serving life imprisonment after he was convicted of raping a 16-year-old devotee at his ashram, had sought interim bail for two months on medical grounds to receive treatment in Uttarakhand.

"You will get all ayurvedic treatment in jail itself," the court said, turning down his plea.

In 2018, a Jodhpur court sentenced the self-styled godman to life imprisonment after he was found guilty of raping the 16-yearold at his ashram in 2013. He was convicted under sections of the IPC, the Iuvenile Justice Act and the Protection of Children from Sexual Offences (POCSO) Act.

Two of his co-accused got 20 years in jail each and two were acquitted. During the trial in the Jodhpur case, nine witnesses who testified against Asaram were attacked and three of them died. Arguing against his plea for bail in Supreme Court, the Rajasthan government said that the self-styled godman wants to get his sentence suspended under the garb of receiving treatment.

The state argued that Asaram had made similar pleas in 2014 and 2016 and both times, a committee of doctors appointed by the Supreme Court found that his health condition was stable.

#### Rise in Covid cases in some states indicates 3rd wave: ICMR

NEW DELHI. 31 AUG: Head of Epidemiology and Communicable Diseases at the Indian Council of Medical Research (ICMR), Dr Samiran Panda, said on Monday that the states which did not face an intense second wave of the COVID-19 pandemic are now with the increasing trend of COVID-19 cases, showing early signs of the third wave.

Dr Panda said that it is important to not talk of India as a whole and to instead take a state-specific view COVID-19 because all the states are not homogenous.

"Several states began imposing COVID-19 restrictions and increased vaccinations, learning from Delhi and Maharashtra. Due to this, the second wave in several states was not as intense, leaving scope for a third wave. Therefore, the increasing number of COVID-19 infections in some states presently is indicating a third wave," he said.

"Every state should look into their number of COVID-19 infections and its intensity in both the first and the second wave of the pandemic to decide about their strategy/ pandemic preparedness for the possibility of the third wave," the doctor

Tata Motors Ltd. Chief Financial Officer P.B. Balaji said during an earnings call last month the government should continue with the existing EV subsidy plan, which places an emphasis on localization and affordability of electric models. India's government has said it has no plans to cut import duties on electric vehicles.

### **Crowded Out by Cars**

#### Instead of cursing traffic jams, collaborate to find a solution

There is a footpath lining the highway in Gangtok, and yet ■ parents are not comfortable sending children out on their own. And it is not just the virus that discourages them. Two decades back, children would rarely stay at home, gathering in groups and heading outdoors. That is a luxury which is denied the generation now in school because outdoors in the capital is a now one big parking lot. People have been noticing the increase in traffic on Gangtok roads, many have even ventured explanations and some have stuck their necks out with criticism, and all have come to the same conclusion – Gangtok has been taken over by cars. Cars have captured public spaces and pushed everything else away. The neighbourhood streets, even those which lead to dead-ends, have been consumed and the town still needs to come up with more and more ingenious ways to park its cars. Despite the obvious glut on the roads, the rush is showing no signs of abating. Some years ago, a study by the Central Road Research Institute [yes, there is such an institute] revealed that vehicles were occupying almost as much space [10.8%] as the forest cover [11.5%] in the National Capital Region of Delhi. Anyone who has watched the explosion of vehicles in Gangtok will agree that Sikkim's capital too is trying hard to bring vehicular occupation at par with its green cover. Here, the plant life might not be getting hacked away to make space for more parking lots, but it is being choked to death by the swarm of idling engines stuck in impossibly long traffic jams which grip the roads during peak office hours nowadays. There might not be too many people who remember how long a pony ride from Ranipool to Gangtok took in earlier times, but it could not have been much longer than what it takes to make it from Tadong to MG Marg in a car nowadays.

Admittedly, all this description is not required because it is obvious to every Gangtokian that traffic and cars have become a problem and a nuisance. What has still not been accepted is that this problem needs to be addressed. The only initiative taken to address the problem of too many cars has been the commissioning of more parking lots some of which are built and ready but await an inauguration. While more parking is definitely required, this is not enough of a solution primarily because the parking space being created will already be too cramped by the time the structure is completed. For another, more parking space does not address the problem of vehicular movement. In this regard, Gangtok's topography and building practices play spoilsport, making the creation of alternate roads impossible.

The only real option then is to reduce the number of vehicles on the roads. This cannot be achieved by stronger legislations [in case someone is floating that idea], but can be pulled off with an approach which combines structured parking fees, safe and spacious parking in the outskirts [of the congested areas, say beyond Deorali or Burtuk at the other end or even along the bypass] and fast, frequent and reliable public transport. Bigger cities around the world have worked this combo quite well and there is no need why Gangtok should not try out the model as well. This is but one option that can be mulled and what would be even better for Gangtok to attempt will be a series of brainstorming meetings aimed specifically at addressing its traffic and parking challenges. Experts from diverse fields can be invited to study the problem and offer solutions. Think about it the next time you stare aimlessly out of the car window at another one Gangtok's traffic jams.

### Government funds are not 'taxpayer money' media and politicians should stop confusing the two

hetoric plays an important role in tax debate  $oldsymbol{\mathsf{K}}$  and therefore tax policy. If your side manages to gain traction in the public imagination with labels such as "death tax" or "dementia tax", you have gone a long way to normalising the labels and winning support.

Some truth underpins these particular labels — an estate tax is triggered by a person's death, and the United Kingdom's abandoned levy for end-of-life care would have been particularly relevant for dementia sufferers.

Nevertheless, these tags are essentially political messages and we should expect unbiased media to use neutral terminology. Fair reportage would not, for example, repeat the extreme libertarian claim that "tax is theft" — a baseless slogan incompatible with the rule of law.

However, both reputable media and politicians of every stripe invariably use the phrase "taxpayer money" to describe government funds, despite the phrase having no constitutional or le-

This article argues that truth-based media should avoid the phrase, and progressive politicians should recognise they fall into a conservative trap when they repeat it.

TAXPAYERS DON'T OWN THEIR TAXES

Richard Murphy, one of the founders of the UK's Tax Justice Network and author of The Joy of Tax, explains that "taxpayers' money" is the money left in our pockets after we have paid taxes that are legally due. Money payable through taxes is the government's property.

This is quite easy to prove — try not paying your income tax and see if the courts will enforce government property rights in that money.

Murphy also observes that "taxpayer" is typically understood as "income tax payer", thereby implicitly preferring high income earners while excluding beneficiaries. But a goods and services tax (GST) ensures everyone is a taxpayer, and indirect taxes disproportionately affect the poor.

Similarly, at a local level, "ratepayer" has become synonymous with the propertied voice to which councils should pay heed, even though renters (rather than the registered ratepayer for a leased property) bear the effective burden of local rates.

If the government is the legal owner of its funds, then, does it hold tax revenue in trust for taxpayers? Not at all. Subject to the rule of law, governments can do what they choose with their

ers' Union claim to bring government waste to public notice. Rightly so — as citizens, we should demand proper stewardship of government

But our actionable right as electors is to vote a wasteful government out of office. The electorate as a whole, rather than an ideological interest group, determines the size of government we should have.

Unlike trust beneficiaries, we do not have an equitable interest in the government's money. If it were otherwise, groups of taxpayers might have some claim on the government to spend or not spend its money in particular ways.

For example, paying taxes to fund belligerent activities is problematic for pacifists, notably certain religious groups. A Religious Freedom Peace Tax Fund Act, which has been regularly introduced to the United States Congress, would permit dissenting taxpayers to assign the defence portion of their taxes to supporting peace work and social services.

Proponents of the legislation have not sought to pay less tax than their fellow citizens but to direct how their tax contribution is spent. These attempts have failed, as they must do. Democratic political communities permit dissent, but nonconformism does not extend to directing how taxes should be spent.

TAX IS PART OF THE SOCIAL CONTRACT

In The Variorum Civil Disobedience (1849), a reflection on his imprisonment for failing to pay a highway tax, Henry David Thoreau recognised that an individual citizen can protest against government by refusing to pay tax (and accept the

consequences), but they cannot treat the government's choices in its expenditure as if it were a cafeteria. He wrote:

"It is for no particular item in the tax-bill that I refuse to pay it. I simply wish to refuse allegiance to the State, to withdraw and stand aloof from it effectually. I do not care to trace the course of my dollar, if I could, till it buys a man or a musket to shoot one with — the dollar is innocent — but I am concerned to trace the effects

of my allegiance."

Liberal democracies are based on some form of metaphorical social contract, most obviously manifest in the constitution. Under this arrangement, parliamentarians are elected representatives, not agents for particular groups.

Like any government that fails to comply with the basic values of society, groups that seek to control government expenditure outside the electoral process can be seen as bending, if not breaching, the social contract.

A HANDBRAKE ON DECISIVE ACTION

A progressive government should reject the suggestion that its funds are not its own to use as it sees fit for the betterment of society — as always, in accordance with New Zealand's two fundamental constitutional principles of parliamentary sovereignty and the rule of law.

Kowtowing to a myth of "taxpayer money" may act as a handbrake on decisive action. We are taxed in accordance with statutory law. If Inland Revenue seeks to collect more from us than is due, we have access to various tribunals and courts.

These legal rules and processes determine what is mine and what belongs to the government. Broadly, we are free to deal with our own property as we see fit — and the government is

Media and progressive politicians should stop perpetuating the untruth that taxpayers retain some residual property interest in the taxes they pay. Taxpayer money is nothing more than their after-tax property and the government's money is its own.

# How Japan's Olympic success has been followed by COVID failure

 $\mathbf{F}$ rom a sporting perspective, the Tokyo Olympics were a massive success for Japan. Finishing third behind the Olympic behemoths of the US and China, Japan secured a record 27 gold medals. Yet, as the closing ceremony reached a crescendo, on the Tokyo streets ambulances were taking patients from hospital to hospital in a desperate search for available beds.

During the first week of August, there were 2.897 cases of ambulances unable to admit patients to hospitals nationwide, a sharp increase from previous weeks. And with the delta variant now dominant, each day is currently seeing a record-breaking number of new COVID-19 cases.

Just before the Olympics, everything had seemed to be on track: Japan's vaccination programme had just reached the impressive milestone of one million vaccinations per day, case numbers were manageable, and both the International Olympic Committee and Japanese government had promised a "safe and secure" games. Since then, though, Japan's situation has nose-

OPERATING IN 'DISASTER MODE'

Japan is now facing not only record cases, but also record numbers of severely ill patients: 1,974 as of August 26 2021. In Tokyo alone, daily infections have topped 4,000 throughout August, including more than 270 severe cases at the time of writing.

New guidelines stipulating that only highrisk patients be hospitalised mean that more than 20,000 infected individuals in Tokyo are staying at home. Unsurprisingly, reports are emerging of patients whose conditions have deteriorated rapidly, in some cases ending in

To deal with this spike of patients unable to receive medical care, the prime minister, Yoshihide Suga, has outlined plans to set up "oxygen stations" to give supplemental oxygen outside of hospital and to offer the Ronapreve antibody cocktail treatment for patients to use at home.

The government's expert panel has described the situation as "out of control", with the capital's hospitals now operating in "disaster mode". The panel is advising that at this stage, the public should take its own measures

to protect itself from the virus. Public attenisy yet to crest. Its impact on the health system tion has fixed on the Tokyo metropolitan area, but the virus has now spread and is rampant throughout the country.

THE ROLE OF THE OLYMPICS

There was widespread opposition to the staging of the Olympics before they began, as the public was sceptical of the claims of a "riskfree" games. Undoubtedly the event helped the virus spread.

In the end it was not the athletes that were the problem, but rather the mixed messaging of staging the world's biggest mega-event in the middle of a pandemic. Despite spectators not being allowed into Olympic venues, people still gathered to watch the games in parks and bars across the country. Public compliance with government measures deteriorated.

As the Suga government's own chief COVID-19 expert, Shigeru Omi, has explained, the Olympics "affected the public's perception" of the crisis, weakening the government's own stay-at-home message and undermining the declaration of a state of emergency.

VACCINATIONS TO THE RESCUE?

Taro Kono, the minister in charge of Japan's vaccine rollout, has trumpeted his country's success in inoculating its population. Japan went from vaccine laggard to one million doses per day in an astonishingly short time, and the majority of the elderly population have received two doses.

Still, with only 43% of the population fully vaccinated (approximately 54% had received at least one shot as of August 26), Japan is near the bottom of the OECD vaccination table.

So far Japan's death rate has not increased in tandem with the infection rate. While there is likely some degree of lag, other countries have shown that high vaccination rates do help to erode the link between infection and death - meaning the climbing vaccination rate may have spared the country from an worse out-

Nonetheless, the dominance of the more infectious delta variant, together with Japan's still relatively low vaccination rate, bodes ill for the coming months.

WHERE IS THIS ALL GOING?

Japan's current wave has begun to slow but

is already visible and will likely worsen. The fallout in terms of long COVID will reveal itself in

A key problem is that the government has lost credibility. Staging the Olympics was only the latest in a series of mixed messages on COVID-19 - last year the government's "Go To" travel campaign encouraged tourism in the middle of the country's third wave, while the delayed vaccination campaign is partly the result of prioritising domestic-vaccine development over imports. The recent cover up of Japan's first case of the lambda variant, as it was related to the Olympics, has add-

The government meanwhile has expanded the scope of the current states of emergency that are in place, adding more prefectures. Suga's top adviser Omi has called for a 50% reduction in mobility to flatten the curve and to relieve pressure on hospitals. Experts have also demanded legal changes to allow for stricter lockdown measures, like those implemented in Europe. Yet legal changes will require time.

ed to public distrust.

With a general election scheduled for October, growing frustration over the government's crisis management is threatening Suga and his Liberal Democratic Party's electoral prospects. In post-Olympic polls, support for the government slipped below 30%, the lowest since the prime minister took office.

For various reasons, his party's victory had seemed preordained. Although the opposition has so far failed to take advantage of the government's failures, with two potentially devastating months ahead, now Suga's position has never been more precarious. If the situation becomes dire, the challenge may even come before the election from within his own party.

Right now, it is hard to see the government regaining the public's trust, and the short-term outlook is bleak. However, as the situation deteriorates, the Japanese public itself may sufficiently alter behaviour to slow the virus's spread.

### 443 people died of AIDS in Mizoram in a year: Govt

AIZAWL, AUG 31 (PTI): At least 443 people died in Mizoram due to complications caused by AIDS during the financial year 2019-2020, as per official data.

According to statistical handbook Mizoram 2020, released on Monday, 2,339 people were diagnosed with AIDS during 2019-2020.

In 2018-19, 2,237 people were found to be HIV-positive and 716 died due to the disease.

The handbook released by the State Economics and Statistics Department said that 51,691 blood samples were tested during 2019-2020 as against 65,615 samples in 2018-2019.

With 2.32 per cent of its total 10.91 lakh population (2011 census) infected, Mizoram has the dubious distinction of being the highest AIDS prevalent state in the country, as per the National AIDS Control Or-



ganisation (NACO).

Mizoram reported its first HIV-positive case in October 1990.

According to the Mizoram State AIDS Control Society (MSACS), 23,092 people, including 1,972 pregnant women, were diagnosed with AIDS and 2,877 people died of the disease from October 1990 till September 2020.

More than 78 per cent of HIV-positive cases in the state were sexually transmitted, while about 20 per cent of the cases were transmitted through sharing needles by intravenous drug users, it said.

It has been estimated

that about 1.19 per 1,000 people are diagnosed with AIDS in Mizoram, according to MSACS.

The AIDS incident rate was highest among vouths in the age group of 25-34, which was tagged at 42.59 per cent, followed by people in the age group of 35-49 at 26.49 per cent, it said.

### One new case takes COVID-19 tally of Andamans to 7,565

PORT BLAIR, AUG 31 (PTI): Andaman and Nicobar Islands reported just one new COVID-19 case, which took the tally in the Union Territory to 7,565, a health department official said on Tuesday.

The fresh case was detected during contact tracing, he said.

The death toll remained at 129 as no new fatality due to the infection was reported in the last 24 hours, the official said.

One more person was cured of the disease during the period, taking the total number of recoveries in the archipelago to 7,431.

The Union Territory now has five active cases. The local administra-

tion has been strict to contain the spread of the

disease and has adopted an approach of tracking, testing and treating, he said, adding that people arriving here from the mainland are mandato-

rily required to undergo

NEW DELHI, AUG 31 (PTI): The Indian cricket board could soon get richer by at least Rs 5000 crore with the addition of two new franchises during the 2022 edition of Indian Premier League.

The IPL, which is currently an eight-team tournament, will become a 10-team affair from the next edition and during a recent governing council meeting, the modalities of the bidding process were chalked out.

"Any company can buy the bid document paying Rs 75 crore. Earlier top brass was thinking about keeping the base price for two new teams at Rs 1700 crore but later it was decided to keep the base price at



Rs 2000 crore," a senior BCCI source told PTI on the condition of anonymity.

The source, who has dealt with the financial side of IPL in the past, said that the BCCI stands to gain at least Rs 5000 crore if the bids go as per plan with plenty of large business

conglomerates showing active interest in bid-

'The BCCI is expecting anything in the range of 5000 crore if not more. There will be 74 IPL games next season and it's a win-win situation for everyone."

It is learnt that only companies with Rs 3000 crore will be allowed to bid for the teams. In a welcome news,

the BCCI is planning to allow a consortium to bid for teams as it makes the bidding process more vibrant.

"I think more than three business entities

won't be allowed to form a consortium but if three business come together and wants to jointly bid for a team, they are welcome to do so," he said.

Among the venues where the teams could be based include Amedabad, Lucknow Pune.

The Narendra Modi Stadium in Ahmedabad and Ekana Stadium in Lucknow, with bigger capacities, could be the choice for franchises.

Some of the names that are doing the rounds include the Adani group, RPG Sanieev Goenka group, noted pharma company Torrent and a prominent banker who has shown active interest in buying teams.

# Europe sees higher inflation on fleeting factors like oil

FRANKFURT, GERMANY rus pandemic.

(AP): Consumer prices spiked higher than expected in Europe in August, boosted in large part by more expensive fuel. Economists say the jump is temporary, but it could raise questions about how persistent higher inflation might turn out to be.

The 19 countries that use the euro currency saw inflation spike to an annual 3.0% in August, up from 2.2% in July, according to figures released Tuesday by European Union statistics agency Eurostat.

The increase was so large in part because some prices were much lower a year ago due to one-time factors connected to the coronavi-

Oil prices, following a price slump a year ago during the depths of the pandemic recession, contributed to a 15.4% rise in energy costs. With volatile fuel and food left out, core inflation was 1.6%. The latest figure also reflects other transitory factors, such the timing of summer retail sales in France and Italy, and the expiration of German tax breaks on retail purchases.

**Economists** have cited a raft of additional reasons for recently higher prices in Europe. Some hotels and tourist businesses have marked up prices after the end of pandemic lockdowns, while supply chain disruptions and higher raw

material prices have raised prices for producers of goods as economic activity has picked up.

The inflation question has been getting global attention, especially after annual U.S. consumer inflation reached 5.4% in July. The International Monetary Fund says it sees inflation returning to pre-pandemic levels in most countries next year, but adds that there's high uncertainty about that. It cautioned that central banks may need to take action if price increases prove to be more per-

sistent than expected. Since many of the factors are temporary, economists do not expect the European Central Bank to attempt to counter inflation by curtailing negotiations, according

its stimulus programs or by raising interest rates. The central bank's most recent projections from Iune see inflation hitting 1.9% for all of this year. and falling to 1.5% next year. The ECB's governing council next meets Sept. 9 to review its polpath is uncertain. icy stance.

Still, higher inflation is getting public attention, as witnessed by the front page of Germany's Bild newspaper trumpeting a "new inflation shock" after German figures came in at 3.4% based on inflation outcomes of several regions, the highest in 13 years. Inflation has been low across the developed world for years, with economists theorizing that causes could include digitalization, aging populations and global competition in labor markets.

### No stranger to plagues, Venice opens film fest with caution

**VENICE (AP):** Visitors to Venice could be forgiven for not realizing that beyond the majesty of St. Mark's Square and the romance of gondola rides lies a city that helped provide a baseline of what the world knows today about containing pandemics.

It was here that the term "quarantine" was coined, after merchant ships arriving in the 15th-century Venetian Republic were moored for 40 days ("quaranta giorni" in Italian) to see if their crews were afflicted with the plague. It was here that the first isolated pestilence hospital was built on a solitary island in the lagoon, a precursor to today's COVID-19 isolation wards. And it was in Venice that 16th-cendoctors donned beak-nosed masks filled with aromatic herbs to cleanse the air they breathed when treating the sick — an attempt at self-protection that today is the favored choice for Venetian Carnival costumes.

Venice's central place in the history of battling pandemics provides a relevant backdrop to this year's Venice Film Festival, which opens Wednesday with the premiere of Pedro Almodovar's in-competition film "Parallel Mothers." Almodovar developed the project during Spain's 2020 coronavirus lockdown, one of the harsh-

est in the West. In a pre-opening screening Tuesday, Italian director Andre Segre presents a short documentary shot last year showing how Venice organizers coped with COVID-19 to stage the first and only in-person international film festival during the first year of the outbreak, a limited affair that nevertheless showed it could be done. Cannes came back to life this year after skipping 2020, and other big fes-



tivals went largely virtual after the pandemic

erupted. The scenes in Segre's film — shocking then, normal now — feature half-full theaters for Hollywood premieres, masked movie stars, cleaners in hazmat suits and the "blink, blink, blink" of remote thermometers taking temperatures at festival checkpoints.

Similar precautions are planned for this year, with a huge barricade once again sealing off public access to the red carpet and limited chances for fans to catch VIP water taxi arrivals on the Lido. More than 10 testing stations have been set up for staff and festival-goers, who must show proof of a negative test, vaccination or having recently recovered from COVID-19 to enter screenings. Masks are required indoors.

In other words, the Venice show is going on — other premieres at the world's oldest film festival include the debut of Denis Villeneuve's "Dune" and Kristen Stewart as Princess Diana in "Spencer" — even as Italy copes with new infections driven by the highly contagious delta variant.

For Venice, though, it's really nothing new.

"The history of Venice is a history that teaches us how our city, first among European capitals, understood ahead of time how to manage viruses," said Simone Venturini, Venice's tourism chief. "These recurrences are studied and recalled even more today because the Venetian model is a model that paradoxically

is still used." Beginning with the first confirmed plague to strike Venice — the 1348 outbreak that killed at least a third of its population — the city put place containment measures even without understanding epidemiologically how it spread, said Fabio Zampieri, a history of medicine professor at the University

of Padua Medical School. Based on the belief that "bad air" was to blame for what became known as the Black Death, Venetian authorities closed churches and restaurants. canceled religious processions and ordered a thorough cleaning of homes and public venues, Zampieri

said. During the pestilence that erupted in 1423, Venice's senate decided to lock down the whole city, prohibiting entry of people from suspected plague-ridden places and punishing locals who gave sick foreigners shelter with six months in jail, he said. A year later, Venice opened the first "lazzaretto," a hospital on ed exclusively to plague

That concept would transform years later into a proper quarantine, an isolated place for people merely suspected of carrying the plague crews of merchant ships — to wait out 40 days of surveillance while their cargo was disinfected, he

said. During the 1575-1577 plague, doctors increasingly used the beaknosed masks filled with aromatic herbs to try to protect themselves from the sick, still not realizing that the plague was carried mostly by bacteria-infected fleas on rats, not "bad air."

"It was still a crucial experience for the history of medicine, the history of health care and the history of managing infectious diseases," Zampieri said.

After the 1630 pestilence again wiped out around a third of the population, weary Venetians gave thanks to the Virgin Mary that even more lives weren't taken: They built the Santa Maria della Salute (St. Mary of Health) church across the Grand Canal from St. Mark's Square, one of the city's most visible and iconic images.

The central location of the huge, white octagonal domed basilica at the tip of Venice's custom's port was entirely intentional, to show the city's gratitude that it had once again survived and rebounded from the pestilence, said art historian Silvia Marchiori, curator of the Venice Patriarchate's Manfrediniana museum.

"When you arrived in Venice, you arrived from the sea, not land, so you had to notice this great temple that was built in white Istrian stone to attract attention," she said.

To this day, Venetians venerate an icon of the Madonna in the basilica during one of the city's main religious festivals on Nov. 21, a day dedicated to offering prayers for good health, she said.

Whether by prayer, public health policy or discipline, Venice as a whole fared relatively well during its latest pandemic. The city took the extraordinary decision in February 2020 — when coronavirus was just beginning to be detected in northern Italy — to cancel its famous Carnival. It stayed locked down during the worst of the pandemic, watching as neighboring Lombardy and even parts of the surrounding Veneto region got slammed with infections and deaths in one of Europe's worst-hit countries.

Venice has been rewarded with a steady return of visitors this spring and summer, just in time for celebrations marking the 1,600th anniversary of the founding of the city, the film festival, sailing regattas and star-studded fashion shows by Valentino and Dolce & Gabbana.

It's all part of Venice's efforts to attract visitors who stay, spend and appreciate the city's history and artistry, rather than day-trippers who take a gondola ride down the Grand Canal and call it a day, said tourism chief Venturini.

"These are the pillars on which we're building a post-COVID tourism,"

Standing on the tarmac, Taliban leaders pledged to secure the country, quickly reopen the airport and grant amnesty to former opponents.

In a show of control, turbaned Taliban leaders were flanked by the insurgents' elite Badri unit as they walked across the tarmac. The commandos in camouflage uniforms proudly posed for pho-

Getting the airport running again is just one of the sizeable challenges the Taliban face in governing a nation of 38 million people that for two decades had survived on billions of dollars in foreign aid.

Afghanistan is finally free, Hekmatullah Wasiq, a top Taliban official, told The Associated Press on the tarmac. The military and civilian side (of the airport) are with us and in control. Hopefully, we will be announcing our Cabinet. Everything is peaceful. Everything is safe.

Wasiq also urged people to return to work and reiterated the Taliban pledge offering a general amnesty. People have to be patient, he said. Slowly we will get everything back to normal. It will take time.

Just hours earlier, the U.S. military had wrapped up its largest airlift of non-combatants in history.

On Tuesday morning, signs of the chaos of recent days were still visible. In the terminal, rifled luggage and clothes were strewn across the ground, alongside wads of documents. Concertina wire stills separated areas while overturned cars and parked vehicles blocked routes around the civilian airport a sign of measures taken to protect against possible suicide car bombers entering the facility. Vehicles carrying

the Taliban raced back and forth along the Hamid Karzai International Airport's sole runway on the military side of the airfield. Before dawn broke, heavily armed Taliban fighters walked through hangars, passing some of the seven CH-46 helicopters the State Department used in its evacuations before rendering them unusable.

Taliban spokesman Zabihullah Mujahid addressed the gathered members of the Badri unit. I hope you be very cautious in dealing with the nation," he said. Our nation has suffered war and invasion and the people do not have more tolerance.

At the end of his remarks, the Badri fighters shouted: God is the great-

In an interview with Afghan state television, Mujahid also discussed restarting operations at the airport, which remains a key way out for those wanting to leave the country.

Our technical team will be checking the technical and logistical needs of the airport, he said. If we are able to fix everything on our own, then we won't need any help. If there is need for technical or logistics help to repair the destruction, then we might ask help from Qatar or Turkey.

He didn't elaborate on what was destroyed.

Marine Gen. Frank McKenzie, the head of U.S. military's Central Command, earlier said troops disabled 27 Humvees and 73 aircraft so they cannot be used again. He said troops did not blow up equipment needed for eventually restarting airport operations.

The airport had seen chaotic and deadly scenes since the Taliban blitzed across Afghanistan and took Kabul on Aug. 15. Thousands of Afghans besieged the airport, some falling to their death after desperately hanging onto the side of an American C-17 military cargo jet. Last week, an Islamic State suicide attack at an airport gate killed at least 169 Afghans and 13 U.S. service

It's clear what we want. We want Shariah (Islamic law), peace and stability, he added.

Their country's future is in their hands. They will choose their path in full sovereignty, he wrote. This is the chance to bring their war to an end as well.

The majority of the billions of dollars Afghanistan holds in foreign reserves is now frozen in America, pressuring its now-depreciating Afghani currency. Abdul Maqsood, a traffic police officer for the past 10 years on duty near the airport, said he hadn't paid for the past four months.

We keep coming to work but we are not getting paid, he said.

Medical equipment remains in short supply, while thousands who fled the Taliban's advance remain living in squalid conditions. A major drought also has cut into the country's food supplies, making its imports even more important and raising the risk of people going hungry.

Also in question are the rights of women, who faced oppression under the Taliban's earlier rule.

Schools have reopened, and on Tuesday morning dozens of elementary school students headed to schools in a neighborhood near the airport. The Taliban have ordered schools to be segregated but it is often not enforced for vounger children.

I am not afraid of the Taliban, said Masooda, a fifth-grade student.

Rises in unemployment in Germany and elsewhere in Europe have been moderate by international standards during the pandemic. That is because employers made heavy use of salary support programs, often referred to as furlough schemes, which allow them to keep employees on the payroll while they await better times. eral Labor Agency pays at least 60% of the salary of employees who are on reduced or zero hours.
