Thief Minister Prem Singh Tamang today said that Sikkim will remain strong till the Nepali, Bhutia, Lepcha and business communities of Sikkim stay united in communal harmony. He asserted that if there is communal harmony, no one can touch Sikkim and violate the rights of Sikkimese

The CM was speaking as the chief guest of the state-level celebration of Baisakhi Parva 2078 here at Manan Kendra on Wednesday. This year Baisakhi Parva was celebrated as Ekta Diwas by bringing all 21 communities of Sikkim together. It has to be mentioned that the celebration committee was formed as an initiative of Nepali Sahitya Parishad by taking representatives from all 21 communities of Sikkim.

In his address, the CM stated that it is a unique and historic moment for the State to witness all 21 communities together for the first time under one roof to celebrate Ekta Diwas. He congratulated the celebration committee for bringing all communities together for a celebration. This would not only give a strong message to the Sikkimese society but to the nation as well, he added.



The CM said that if the people are not united, then others will take advantage of the disharmony. He stated that immediately after forming the government in the state, the SKM government has started working to again unify the divided society of Sikkim.

"SKM party came to power with the slogan to unify the divided Sikkimese society, to take it forward and we have been working as per our slogan and we have also been receiving the support of the people of Sikkim in this mission," he said.

Punctuality and attendance are expected of employees. They do not be a second of the s pected of employees. They don't need to be spelled out, and when abided by, are not virtues or signs of excellence, but the expected basic conduct. Unless, of course, you are a pampered government servant in Sikkim where you can thumb your collective noses at these basic "rules of conduct" to such an extent that it takes a tongue-lashing from the Chief Minister to get the head babu to devote an entire day and draft a "standard operating procedure" to ensure "Punctuality and Attendance in Government Offices."

Social media was abuzz all of Wednesday with a video of the Chief Minister inviting dilettante government officers who saunter in late and leave early to apply for voluntary retirement if the very basics of their job requirements were becoming difficult to abide by.

While some commentators scoffed at the sudden realisation of rampant incompetence, most people on Facebook welcomed the attitude, sharing in the CM's frustration with getting the steel frame to perform.

Be that as it may, despite Wednesday being a holiday, the Office of the Chief Secretary released an ambitiously titled, "Standard Operating Procedure (SOP) for Ensuring Punctuality and Attendance in Government Offices."

Among the announcements is one which informs that the Chief Secretary will depute "Inspecting Officers" who will be policing attendance in departments other than the ones they are posted in. This is probably to counter the cronyism which hamstrings seniors at the same department from "taking action" against even juniors given to habitual absenteeism.

The Chief Secretary goes over the basics in most of the points. Heads of Departments, for instance, are reminded that they should "institutionalise" a system to carry out periodic inspection of their offices by "designated" officers at 10AM and then again at 4:30PM.

HoDs should also themselves carry out surprise checks periodically, the CS directs further.

Clearly accepting that this approach will not deliver the required punctuality, the CS goes on to inform that he will be deputing Inspecting Officers "from other Departments/Offices for checking the attendance/punctuality in any Department or government office."

The CS also appears to understand that these Inspecting Officers will not be very popular when they carry out their inspections so the "concerned" Superintendents of Police have been directed to provide these officers with the "requisite police personnel... for assistance during the checking.'

NO COVID PATIENT IN ICU

Sikkim with 21 new cases

The number of active L cases of coronavirus has increased to 193 in Sikkim with 21 new cases reported in the last 24 hours although there is no one in the ICU of the Covid wing of STNM Hospital. The state's tally of confirmed cases of COVID-19 has now reached 6456. With no new recovery, the figure of recovered cases of COVID-19 in Sikkim stands still at 5990.

In his daily health bulletin on Wednesday, Health Department State IEC Officer, Sonam Gyaltsen Bhutia informed that 21 samples returned positive for COVID-19 during the testing of 413 samples on Tuesday. He added that 15 cases were detected in RT-PCR testing of 364 samples, while

six more persons were found positive in the rapid antigen testing of 49 samples.

While giving details of new cases, he mentioned that two persons from government quarter, Shyari, one from near Barpipal, Sichey, one from Paljor Namgyal Girls School Road, one from Arithang, two from Tadong, one from near TV Tower and one from near Lal Bazaar have tested positive for the virus.

Likewise, one person from Majhitar, two from Mamring, one from Majhigaon, Rangpo and one from IBM Rangpo in East District and one from Jorethang and two from Namchi in South District also reported positive for COVID-19, Mr Bhutia

He added that two

from Army Hospital also tested positive and they are following COVID protocols of the army. He said that one 26-year-old tourist, who reported positive at Central Referral Hospital, has gone missing after getting the test report and is not answering any phone calls.

On the other hand, 9,486 persons [8950 first dose & 536 second dose] have received vaccination for COVID-19 in different parts of Sikkim on Tuesday. In category-wise vaccination details, 61 healthcare workers [23 first dose & 38 second dose], 443 frontline workers [178 first dose & 265 second dose] and 8,982 persons in age group of 45 years & above [8749 first dose & 233 second dose] were vaccinated for COVID-19.

Sources in the TMC said senior leaders of the party are in a quandary over who should they support during campaigns or on the day of polling, as most of the activists seemed to have sided with Bimal Gurung.

"Statehood is not an issue for us this assembly polls. We are more concerned about the development of the Hills, jobs, administrative overhaul. We have come up with a 52-point manifesto," Binay Tamang told PTI.

Bimal Gurung, who returned to the hills last year and crossed over to the TMC from the BJP, maintained that Gorkhaland will always be the "most pertinent" issue for his outfit, while also clarifying that the overall development of the region is dominating the poll narrative this time.

'The tea, timber, and tourism industries have faced a major setback due to the COVID-19 pandemic. People now want jobs, development, and a better standard of living," he said.

The BJP, which has now emerged as a challenger to the supremacy of both the GJM factions, stressed that the party if voted to power, will offer a "permanent political solution" in the region.

Union Home Minister Amit Shah has also allayed fears over NRC implementation and asserted that Gorkhas and their identities would never be harmed.

"We haven't really said anything about statehood. The party, however, has plans to chalk out a permanent political solution for the Hills. Apart from development, especially in remote areas, generating jobs is also important," BJP Darjeeling district president and GJM turncoat Kalyan Dewan said.

Roshan Giri, the Bimal Gurung faction's general secretary, claimed that the BJP was making "false promises".

"Since 2009, they had been making similar promises but nothing changed in the Hills. The TMC has promised a permanent political solution. We have full faith in Didi (Mamata Banerjee)," he told PTI.

Asked if the fight between the two GIM factions will give the BJP an advantage, both the parties replied in the negative.

"Binoy Tamang is not a factor in the hills. It's "only Bimal" that matters," Bimal Gurung stated. Darjeeling often referred to as the "Queen of the Hills", draws thousands of tourists from across the globe every year. The place, also known for its world-class tea, is ethnically dominated by the Gorkhas.

Lepchas, Sherpas, and Bhutias also make for a sig-

nificant part of its population.

Several tea gardens, however, have closed down owing to a paucity of funds, and many workers went out of jobs. Also, the labourers had long been seeking a revision in daily wages.

"We are fighting for the rights of tea garden workers and revival of the tourism sector. The TMC, GIM and the BJP are fooling the masses," CPI(M) leader Ashok Bhattacharya said.

Senior TMC leader in North Bengal and minister Gautam Deb feels the statehood demand has caused a lot of bloodshed in the Hills, and the region has not progressed well all these years. People in Darjeeling have suffered enough over

this separate statehood demand. But, it has not yielded any result. We would fight for the growth and betterment of the region," he said. The demand for Gorkhaland was first made in the

1980s, with the Subhas Ghisingh-led GNLF launching a violent agitation in 1986, which dragged on for 43 days, resulting in the deaths of hundreds The movement led to the formation of the Darieel-

ing Gorkha Hill Council in 1988, following the intervention of the then Prime Minister Raijy Gandhi and former West Bengal chief minister Jyoti Basu.

The Council administered the Hills for 23 years with a certain degree of autonomy.

In 2007, however, the statehood demand gained momentum again after the formation of the GIM, under Bimal Gurung's leadership, who was once a trusted aide of Ghisingh.

After the TMC took over the reins of Bengal in 2011 by ending the 34-year Left rule, the Gorkhaland Territorial Administration (GTA) was formed with Bimal Gurung as its chief. But peace was short-lived in the region as Bimal Gurung, unhappy with the current state of affairs, rekindled the agitation in support of Gorkhaland in 2013, and engineered a 104-day-long strike in 2017, accusing the TMC government of trying to "wipe out" Gorkha identity.

The three-month-long strike changed equations in the Hills and Bimal Gurung was forced to go into hiding as several cases, including some under UAPA, were slapped on him.

The agitation led to a split in the GJM, with Binay Tamang, his deputy, emerging as the leader of one of the factions with the help of the TMC. Bimal Gurung, subsequently, joined hands with the

BJP and helped it bag the Darjeeling Lok Sabha seat for the third consecutive time in 2019 and also the assembly segment in a by-poll. In October last year, making a dramatic appearance in Kolkata, he quit the BJP-led NDA and aligned

with the TMC, underscoring that the saffron party has "failed to find a sustainable solution" for the Hills. The Mamata Banerjee camp, which already enjoyed the Binay Tamang faction's support, welcomed Bimal Gurung in its fold, with her government going

slow on the criminal cases filed against him. According to a GJM source, who did not wish to be named, the elections this time will actually be a test of strength for the two GIM factions.

Polling for the three assembly seats in the Hills will be held on April 17.

Lakhs ignore Covid rules for Shahi Snan in Haridwar

DEHRADUN, 14 APR [PTI]: Throwing caution to the wind amid rising cases of coronavirus, thousands of seers gathered on Wednesday at Har ki Pairi in Haridwar to take a dip in the Ganga during the third Shahi Snan of the Kumbh Mela. The Shahi Snan marked Mesh Sankranti and Baisakhi. With large number of devotees taking the holy dip, Covid protocols like social distancing appeared almost impossible. By noon between eight to 10 lakh people had taken a bath in the Ganga, Uttarakhand police chief, Ashok Kumar, who was supervising the arrangements at Haridwar, said.

According to the senior officer, crowds at the Ganga ghats were much smaller than expected at the third shahi snan considered the most



important. He attributed this to the Covid restrictions in place. Police personnel were seen distributing masks among people in the Kumbh Mela area.

Social distancing norms were violated openly by the seers and their followers at Har ki Pairi. No masks were worn by a large number of them. The seers from the akhadas took the dip along with their revered deities in palanquins at the Har Ki Pairi. Lakhs of common devotees bathed at the other ghats in Haridwar and Rishi-

kesh.

Gauhati High Court upholds bail order of Assam activist Akhil Gogoi

GUWAHATI. 14 APR [PTI]: The Gauhati High Court has upheld the bail order of activist Akhil Gogoi by a Special National Investigation Agency (NIA) Court in relation to his alleged role in violent protests against the Citizenship (Amendment) Act in Assam in 2019.

Dismissing an appeal by the NIA, a High Court bench comprising Justices Suman Shyam and Mir Alfaz Ali said any act aimed at creating civil disturbance will not come within the purview of the Unlawful Activities (Prevention) Act, 1967 unless committed with the requisite intention.

"Upon going through the impugned judgement and order dated 01.10.2020 in the light of materials placed before us, we are of the considered opinion that the views expressed by the learned Special Court, NIA leading to granting is a possible view in the facts and circumstances of the case," the High Court said in its order on April 9.

Habituated is Not the Same as Prepared

Preparedness does not mean only post-disaster drills

The South-West Monsoon this year, experts at private forecaster Skymet Weather have predicted, will be 103 per cent (907 mm) of the Long Period Average rains for India, ranging between "normal and above normal", with a model error of five per cent. This is the third year in succession that India may see "above normal" rains during the season. The last time it happened was in 1996, 1997, and 1998, Skymet has pointed out. Anyone who has been in Sikkim long enough knows the horror that the rains of 1997 had perpetuated. What should also offer pause is the prediction that the Eastern parts of the country, where Sikkim is also located on Met Maps, are expected to see some deficiency during initial parts of the season, but above normal rain in August-September. Expect the monsoon months to be slightly wetter than last year. This is also an El Nino year, a weather phenomenon associated with deficient rain, but that system, we are told, is already waning and even if it sets in, will do only after September and hence not affect monsoon in the country.

So much for the science of meteorology.

Moving on, irrespective of what the South-West Monsoon has in store for the rest of the country, Sikkim, the Gangtok ridge and its attached mountain features, have hosted pre-monsoon showers of substantial intensity, and just these rains have been enough to start scratching at the hill sides. The drainage has taken a hit, site excavations have collapsed and the water supply teetering. You can now begin shuddering with speculations of what the four "official" months of monsoons have in store by way of damage and connectivity disruptions, because, the nor'westers teasers are already unleashing what the monsoon months have always been pregnant with in Sikkim. This will not take much imagination for anyone who has been in Sikkim for any length of time; we are habituated for it. Unfortunately, and surprisingly, Sikkim has still not developed preparedness for it.

Sikkim hills might be young and prone to crumbling, but even a superficial observation will bear out that there are just too many scars on its hills now. Go up to the Ridge and look towards Tsomgo and a monster slide gashes the hill face there. The vision should be shocking, but one does not hear of it having generated any concern. Construction site excavations poke out more than just the marked out sites and the entire stretch from Deorali to Tenzing & Tenzing on the national highway in Gangtok spills muck and slush every time it rains. Neither however appear to have attracted any long-term interventions. The Indira Byepass has seen a rash of constructions in the recent years, and the road surface sinks in ugly reminders of amiss planning. The shoulder of the road has already caved in some sections, retaining walls have given up at others and potholes the size of craters ambush from innocent looking

The general disinterest towards precautions is dangerous, because the out of sight, out of mind attitude is misplaced. Gangtok is not a very big hill, and when any part of it starts slipping, it leaves the monster above standing on wobbly legs as well.

By now, Sikkim should have mapped all its natural and manmade drainage channels and their carrying capacities, installed rain gauges at least at all disaster-prone locations, worked out a way by which realtime information could be shared so that the moment inundation neared the carrying capacity limit of any jhora or drain, warnings could be sent out and disaster drills put into effect. On ground, however, this has not been explored even for Gangtok. Hence, the administration prepares for post-disaster scenarios, which, while necessary, should not be the only component of preparedness. And, without the deployment of available technology and science, which the policy makers in Sikkim are yet to discover, post-disaster scenarios are all that it can build preparedness for. What that means is that Sikkim begins another blind date with monsoon now. All the best...

As India's COVID Crisis Worsens, Leaders Play the Blame Game While the Poor Suffer Once Again

India is witnessing a sharp spike in COVID-19 cases after months of declining numbers had given the country hope it had made it through the worst of the pandemic relatively unscathed.

On March 1, India recorded just 12,286 new cases, but since early April this figure has skyrocketed to over 100,000 every day. Earlier this week, it hit a record of 168,912 cases in a day — the highest in the world.

As the health crisis escalates, the poor are once again fearing a return to lock-down and economic hardship. Migrants have started fleeing from cities to their home villages in order to avoid the pain and trauma they went through a year ago when Prime Minister Narendra Modi enacted a nationwide lockdown. Many cities, including Mumbai and Delhi, have already announced nightly curfews.

For now, the Indian government has just asked the states to focus on "stringent containment and public health measures", including testing, tracing and inoculations. Modi has also appealed to people to get vaccinated during a four-day "Tika Utsav" (special vaccination drive), which began on Sunday.

However, the situation remains grim. Even though India is one of the world's biggest coronavirus vaccine manufacturers, some states are experiencing vaccine shortages. At the same time, experts fear a lack of social distancing and new variants of the virus are causing infections to potentially spiral out of control.

HOW THE POOR SUFFERED DURING LAST YEAR'S LOCKDOWN

When COVID-19 first appeared in India last year, the Modi government was quick to bring the country together:

In a speech to the nation last March, he announced a 21-day nationwide lockdown

of 1.3 billion people with only four hours' notice. All means of transportation were suspended. The rich and affluent started hoarding food and medicines, while the poor worried about their livelihoods.

A mass migration ensued as hundreds of millions of migrant workers headed from the major cities back to their home villages on foot. This was the most visible face of the humanitarian crisis. Others, however, suffered out of the public eye, such as the street vendors, waste pickers, domestic maids and shopkeepers in slums, who were all forced to stop working.

As part of a study last year, I helped conduct a series of six rounds of telephone surveys in 20 diverse slums in the city of Patna, the capital of the northeastern Bihar state from July to November.

Nearly all slum residents we spoke with — except the rare few with protected formal sector jobs — were cut off suddenly from their sources of income after the lockdown was announced. And more than 80% of slum households in Patna lost their entire primary source of income.

Economic recovery since the lockdown has also been slow. By mid-November, one-third of respondents had still not fully recovered their pre-pandemic incomes. Many had been hired back at their old jobs on a part-time basis or at a fraction of their former pay. Many jobs simply disappeared.

The poor survived by cutting back on their food, borrowing money and helping

Given these struggles, there is now a sense of anxiety in these slum communities and a mistrust of the government, especially Modi. Says Ajay, 35, a street vendor who lives in the Kankarbagh slum, "The government finds it is easy to lock us down but not to provide financial and livelihood support. PM is busy campaigning for an election

where thousands of people come without masks and are violating social distancing norms."

THE GOVERNMENT'S FAILED LEAD-ERSHIP

Undoubtedly, Modi still remains popular among most ordinary people. When he says something, India listens carefully. It worked well last year, and his appeal compelled people to wear masks and maintain social distancing, helping to flatten the curve and limit the loss of lives.

However, making public speeches will not be enough during this second wave. The prime minister needs to be seen adhering to these practices in his own daily life, but this is not happening on the ground.

In the ongoing elections in West Bengal, Assam, Kerala and Tamil Nadu, as well as the election in Bihar last year, Modi and other party leaders have addressed several rallies without paying much attention to COVID restrictions. Modi himself has addressed more than 20 rallies attended by thousands of unmasked people.

When leaders are seen addressing mass gathering without masks and social distancing, the public will not only assume everything is normal, they will lose their fear of COVID.

Modi has also insisted he would not politicise the pandemic, but he has done exactly that. In states like Maharashtra, Punjab and Chhattisgarh, which are facing a spike in cases, Modi's party is pointing the finger at the state leaders, who come from opposing parties. The states, meanwhile, are blaming Modi's government for failed leadership.

Another concern is the Modi government's decision to allow a major festival, Kumbh Mela, to take place in Uttrakhand state, which is ruled by his party, the BJP. Several million people gathered at the Ganges River for an auspicious bathing

day this week, flouting social distancing practices.

Uttrakhand's chief minister said the "faith of devotees will overcome the fear of COVID-19", at a time when infections are skyrocketing.

WHO WILL HELP THE POOR?

As the numbers of COVID-19 cases are rising every day, the fear of a return to lock-down is ever-present, haunting the poor. Many have yet to recover from their previous debts, and COVID-19 is now threatening their livelihoods again.

Last year, several not-for-profit, grassroots organisations came forward to help the migrants and urban poor dwellers, but this is going to be more challenging this year.

Not only have their funds been depleted, but recent changes brought by the government have stopped the flow of foreign aid money to many organisations. Amnesty International announced in September it would halt its operations in India after its bank accounts had been frozen.

One NGO volunteer, Prabhakar, who works with slum dwellers in Patna, told us, "if the government is going to announce the complete lockdown like last year, many people will run out of food, as parent NGOs have stopped sponsoring the small organisations which work with the slum dwellers."

This is the time for Modi to show decisive leadership in not only controlling the surge of the virus, but also providing financial assistance to millions of urban poor and helping them reach their home villages with their dignity intact. This is what is needed to instill trust in the prime minister again.

How a radical interpretation of the Great Depression became the orthodoxy behind solving the COVID economic crisis

At the start of the COVID-19 pandemic in March 2020, US Federal Reserve System governor Jerome Powell made an extraordinary declaration: "We're not going to run out of ammunition." The central bank stood ready to take any action necessary to stem the mounting economic crisis. Three months later, the Fed injected nearly US\$3 trillion dollars of liquidity into the US economy.

Such radical action by central banks – quantitative easing (QE) – has its critics on the right and left. Just as striking is that many prominent economists and economic historians have rallied in support of QE in responding to the threat of economic crisis. Their remarkable certainty reveals a story about how our understanding of present crises came to be dominated by lessons drawn from past crises, and in particular the Great Depression in the 1930s and its interpretation by economists, Milton Friedman and Anna Schwartz, in their 1963 book, A Monetary History of the United States.

Friedman and Schwartz claimed that the Federal Reserve System was responsible for turning an ordinary economic downturn into the Great Depression. When a massive financial crisis led to a sharp decline in the stock of money in the US economy, the Fed failed to take action to mitigate the problem.

By the end of the 20th century, their interpretation of the Great Depression had become sufficiently dominant in economics and economic history to qualify as the orthodoxy. When the global financial crisis struck in 2008, the Federal Reserve System proposed aggressive policies of monetary expansion to avoid its supposed mistakes during the Great Depression.

That flood of liquidity into capitalism's financial system is remarkable in historical perspective, surpassing all previous records for monetary interventions, outside of wartime, since the beginning of the 20th centurv. It defines our economic reality to such an extent that the fictional story of a mysterious "Professor", who meticulously plans a raid on the Royal Mint of Spain to print billions of euros, became the basis for the wildly popular television series, La Casa de Papel. As the Professor explained: "In 2011, the European Central Bank made €171 billion out of nowhere. Just like we're doing. Only bigger ... 'Liquidity injections,' they called it. I'm making a liquidity injection, but not for the banks. I'm making it here, in the real economy."

The Professor made these remarks long before central banks responded to the coronavirus crisis with an even greater flood of liquidity.

HISTORICAL ANALYSIS AS ECONOMIC HERESY

The onset of the Great Depression coincided with "a golden age" of theoretical and empirical research on business cycles and crises. Although they did not agree on the causes of cycles, economists tended to look for explanations of the recurrent fluctuations in economic activity in the internal dynamics of the economic system. This emphasis is readily apparent in the work of Wesley Clair Mitchell, an American economist in the early 20th century who was the foremost global authority on business cycles.

Mitchell began his career as a monetary economist at the University of Chicago where he met Thorstein Veblen and was inspired by the unconventional economist's criticisms of orthodox economic theory and, in particular, its neglect of the process of "evolutionary" economic change.

To Mitchell, it was the "precarious dependence" of material wellbeing on an economy organised for profit-seeking that generated business cycles: "Where money economy dominates, natural resources are not developed, mechanical equipment is not provided, industrial skill is not exercised, unless conditions are such as to promise a money profit to those who direct production." He looked to the dynamics of enterprises' profit-making to explain the recurrent phases of business activity and how they "grow out of and grow into each other" in a process of cumulative change.

The depth and persistence of the Depression, especially in the country that seemed to embody capitalism in its most sophisticated form, reinforced the importance of understanding fluctuations in economic activity. A novel perspective proposed by John Maynard Keynes attracted particular attention: Keynes looked to the internal dynamics of the economic system for the roots of cycles, echoing other economists' scepticism about its capacity for self-adjustment, but identified a significant new role for government in ensuring economic stability.

The significance of the interpretation of the Great Depression that Friedman and Schwartz laid out can be appreciated only by understanding the continuity and rupture it marked in economists' analyses of business cycles. Their book was based on a combination of theory and history that bears an uncanny resemblance to Mitchell's distinctive methodological approach to the study of cumulative change. But just as Mitchell had used historical annals and statistics to challenge the economic orthodoxy of his day, Friedman and Schwartz employed their historical research to confront not only what Mitchell and Keynes believed but what many economists believed about the inherent instability of a capitalist economic system.

In a Monetary History, Friedman and Schwartz conceived of the norm in capitalism as stability, as characterised by a harmonious covariance of money and income, interrupted only by aberrant cycles. It was during these unusual historical moments, they claimed, that money mattered a great deal. Insofar as the Great Depression was

concerned, they posited that it was the drop in money that caused income to fall. While they acknowledged the monetary collapse originated in the waves of banking crises that ravaged the US financial system in the early 1930s, they blamed the US monetary authority for failing to inject enough liquidity into the system to counter the collapse. In doing so, they held government responsible for what seemed to most people to be a crisis of capitalism.

To defend their bold claims, Friedman and Schwartz embraced a methodological approach inspired by Mitchell but increasingly castigated as old-fashioned against the growing influence of econometric analysis in economics. Econometricians agreed with Mitchell on the importance of integrating economic theory and evidence but they cast economic activity in terms of stable mathematical relationships that belied the importance of cumulative change that Mitchell emphasised.

Friedman and Schwartz refused to be swayed by methodological fashion, opting instead for history to discriminate among different explanations of "statistical covariation" by going "beyond the numbers alone" to "discern the antecedent circumstances whence arose the particular movements that become so anonymous when we feed the statistics into the computer".

Based on historical research, they purported to reconstruct the temporal sequence of events that they claimed led to a "catastrophic contraction" during the Great Depression. They also used historical reasoning to go further, to transcend a story that would otherwise locate the collapse of the US economy in the failures of its private financial system. The Federal Reserve System had "ample powers", they suggested, "to cut short the tragic process of monetary deflation and banking collapse" but did not use these powers "effectively". Through the use of counterfactual history, therefore, they created the impression of a crisis that did not have to occur.

Asking why the Great Depression occurred in the US was a difficult question. Friedman and Schwartz's answer was provocative and plausible, but much was left out and a great deal added in. We would expect criticism of their claims, and a plethora of alternatives. Yet, despite criticism over the years, many historians have extended the money hypothesis or qualified specific elements of it, rather than confront or evaluate the core claims on which it was constructed.

By the end of the 20th century, the radical interpretation of the Great Depression that Friedman and Schwartz proposed had become historical orthodoxy. The few scholars who were impertinent enough to directly confront it were subject to an onslaught of criticism. And for those unwilling to buy into the claim of capitalism's inherent stability, neglect

proved to be a powerful weapon. That such neglect was by design as much as ignorance can be seen in the writing of an academic economist, Ben Bernanke, who was to build an even more dazzling career as a central banker

Bernanke acknowledged an important gap in the money story and proposed to fill it. Friedman and Schwartz's interpretation of the Great Depression relied heavily on a banking panic, in which depositors pulled their money out of healthy and unhealthy banks, but without offering any serious explanation of the disruption of the US financial system. Bernanke came to the rescue but only by ruling out the few contemporaries like Hyman Minsky to whom he might have turned for insights on the instability of the US financial system, since their work departed "from the assumption of rational economic behaviour".

That Bernanke's paper garnered so much academic attention suggests the crushing effect of academic orthodoxies on purportedly scientific inquiry. But the stakes suddenly became a great deal more important, and the action more dramatic, when the historical orthodoxy of the Great Depression passed from academic minds into the policy sphere in the early 21st century.

Some sense of what was to come was in evidence at a celebration of Friedman's 90th birthday in 2002. By then, Bernanke was a member of the Board of Governors of the Federal Reserve System and in an oft-cited tribute, he said: "I would like to say to Milton and Anna: regarding the Great Depression. You're right, we did it. We're very sorry. But thanks to you, we won't do it again."

Bernanke's words surely gave the nonagenerian as much pause as pleasure. In Friedman's presidential address to the American Economic Association, a few years after A Monetary History's publication, he worried that "we are in danger of assigning to monetary policy a larger role than it can perform". Still, he could hardly have imagined what Bernanke would dare when the opportunity presented itself.

Friedman may not have been around to witness the aggressive policies of monetary expansion that Bernanke implemented in his determination not to "do it again". However, Schwartz suggested he was fighting the wrong war since the 2008-2009 crisis had nothing to do with liquidity. Ironically, many economists once believed much the same thing about the Great Depression of the 1930s. Just imagine what it would imply about our understanding of that crisis, not to mention the current fashion for quantitative easing, if they were right.

Higher altitudes beckon more wildlife in Nepal amid warmer climes

KATHMANDU, 14 APR [KATH-MANDUPOST]: Indra Dhara Bista remembers his childhood winters being biting cold. From December to February, the thatched roof of his home in Jomsom, a village in Gharapjhong Rural Municipality in Mustang district, would be blanketed by thick, white snow. Livestock would be kept indoors throughout the season; fed stored, sun-dried hay. When the temperature dipped too low, his family would be compelled to migrate down to lower elevation.

"But in the last decade or so, winters have become considerably warmer. And only few people move down these days," says 50-yearold Bista, a resident of Jomsom. "Not just temperatures, but rain and snowfall patterns have also become unpredictable in recent years. Even summer temperatures are rising."

Accompanying the changes in weather are the sightings of an insect unseen in the area beforethe tiny mosquito.

"As a child, I didn't know what a mosquito was. But now there are mosquitoes here in Mustang in the summer," he says. The insect, which has been known to live only at a maximum elevation of 1,500m, is being sighted in higher elevations, such as in Jomsom (2,743m). Last year, they were reportedly sighted in Lo Manthang (3,840m).

Erratic weather patterns are being witnessed across the Himalayan region of the country, affecting its delicate ecology and possibly even influencing species' habitats and biodiversity, climate change experts say. And the effects of changing climate will be exaggerated for such a geographi-

cally vulnerable region, especially considering the country's lack of economic resources and poverty-stricken population.

Mosquitoes are not the only species that are being sighted in altitudes that were previously unheard of.

A research study titled 'House Crow (Corvus Splendens) Heading Upwards in Nepal: Possible Climate Change Impact Influencing its Movement', conducted from 1999 to 2011 on the movement pattern of the bird, reveals that the species is moving by an altitude of 136m annually, from 2,000m to 4,200m, on an average, in Mustang.

"There have definitely been sightings of species at higher altitudes, in Nepal and abroad. Even our research on the house crow revealed just that," says Yadav Ghimirey, a conservation biologist and one of the authors of the report. "Increase in temperature could be a contributing factor in influencing species to adapt to the warming climate, forcing them to go upwards to survive."

In another part of the Himalayan region in Nepal, the mountain-dwelling pika is another animal that researchers have found to be moving upwards. A three-year study (2011-13) conducted by Narayan Prasad Koju, PhD programme coordinator, MSc Natural Resources Management, in Kyanjin (3,900m) in Langtang National Park shows the lowest elevation of pika habitat has shifted up by 200m in an interval of 46 years, suggesting they are either getting locally extinct or are migrating upwards.

"Either situation could spell a disaster for the local ecosystem. Pikas are extremely temperature



sensitive and are non-hibernating species, which means the slightest alterations in temperature can make them extremely vulnerable," says Koju. "It is also a keystone species and it has an immense effect on its surrounding natural environment."

Residents of Kyanjin Gompa, the last village in the Langtang valley, situated at 3,800m, too feel the effects of a warming climate.

"It is definitely warmer now, in the summers and winters. We are now able to grow cauliflowers in greenhouses throughout the year. This was not possible when we were children; it would be too cold to do so," says 45-year-old Mangalmu Lama, who runs a lodge in Kyanjin Gompa all year round. "When I was a child, Kyanjin would be buried in snow five feet deep. I haven't seen snow like that for years now," she says.

Another study conducted on the clouded leopard in 2020 in the Langtang area found the elusive animal surviving at 3,498m. The animal has so far been found only

And this kind of movement

has not just been witnessed in the mountains of Nepal.

A study led by the University of Colorado, spanning nearly 13 years, published in February 2021, has reported that critters such as the golden-mantled ground squirrel, a popular sight in the Rockies, are moving up as the mountain range warms. The report stated that on an average the ranges of the ground squirrel and 46 other species of small mammals have shifted upward by more than 400 feet since the 1980s. Species living at higher elevations, like the squirrel, have moved up by 1,100 feet.

Closer to Nepal, a study by the Zoological Survey of India, released in 2019, identified at least 49 species of moth and 17 species of butterfly that have shown "considerable new upward altitude records" in the Himalayas with a difference of more than 1,000 metres between their current and previously recorded mean habitat altitudes, according to Indian news

What all these changes mean for biodiversity and humanity isn't easy to predict.

"Species move but they do not move at the same time and at the same pace, meaning all species do not respond to the same signals," says Koju. "Some can move, some can adapt and some may die; the response of the species to a changing climate is unpredictable. But any kind of change in natural order or redistribution can have catastrophic implications on the local ecology and this will have a chain reaction."

However, experts also say that there could be other factors at play in the movement of animals and

"We cannot deny the fact that there is a basic warming trend that is being witnessed across Nepal," says Dipesh Joshi, a climate change expert with WWF Nepal. "But there are multiple factors that could be influencing these animals to move, such as better habitat, human-influenced transportation, easier prey."

In the same vein, Ghimire, the conservationist, too believes that it is too early to make conclusions. "To say that climate change is causing upward migration without proper, long-term research would be too rash. There is much more research needed to ascertain the biological responses towards climate change," he says.

But research opportunities are hard to come by in a poor, under-developed nation like Nepal that is always mired in political instability.

"Changing climate and biodiversity loss are two urgent, global issues, but in a developing country like Nepal, there are other more pressing issues that need attention," says Buddhi Sagar Poudel, chief of the REDD+ Initiative, a climate change adaptation initiative under the Ministry of Forest and Environment. "Right now, when it comes to climate change, the focus of the government is more on mitigation and adaptation. We just do not have the resources to carry out long-term extensive research

But if the climate continues to warm at its current rate, experts believe that consequences will be dire. According to the Intergovernmental Panel on Climate Change report titled 'Global Warming of 1.5 degrees Celsius', "twice as many plant species-and three times as many insects, which are critical to our food supply-could lose at least half their habitat under a 2-degree versus a 1.5-degree rise."

"Nature is constantly changing, always evolving-that is a given. But changes in the past few decades have taken place too quickly, and we have no idea what the implications will be," says Koju.

Back in Mustang, for people like Bista, these changes are already far too real. With the emergence of mosquitoes in mountainous regions, there has been an increase in malaria and dengue cases. A 2016 report states that since 1988, a total of 9,836 malaria cases have been reported from 13 out of 16 mountain districts—places where the disease was previously unheard of.

Changes in the climate directly and indirectly affect the lives of the people who call the mountains their home.

"These changes are subtle but they are definitely there," says Bista. "For people who live in the mountains year-round, they are much more visible already."

Assam issues new SOP for air passenger amid Covid surge

GUWAHATI, 14 APR [SHILLONGTIMES]: With the surge of Covid cases in the state, the Assam government on Tuesday issued modified Standard Operating Procedures (SOPs) for persons arriving in the state by air, making tests and quarantine compulsory, officials said.

Principal Secretary, Health and Family Welfare, Samir Kumar Sinha, who issued the modified SOP, said that all people arriving in Assam through any of its five airports, will have to mandatorily undergo the Rapid Antigen Test (RAT) free of cost.

Those found positive will have to undergo home isolation or get admitted in a private hospital or government health institution, depending upon their medical condition.

If the RAT is negative, the passenger will have to undergo an RT-PCR



test at the airport with minimum payment of Rs

"Any person violating the instructions would be liable to be prosecuted against as per provisions of section 51 to 60 of the Disaster Management Act, 2005, besides legal action under section 188 of IPC, and other legal provisions as applicable," the SOP said.

The numbers of Covid-19 cases have shot up by 732 per cent since the declaration of the three-phase Assembly elections.

According to the Assam Health Department, the Covid active cases were only 287 on February 26, when the Election Commission had declared the poll schedule for the 126-member Assam Assembly, but have climbed to 2,387 now.

So far, 2,20,893 people have tested Covid-19 positive, out of which 2.16.041 have recovered while 1,118 have suc-

cumbed. 9 candidates of Congress's key ally in Assam moved to Chhattisgarh

RAIPUR, 14 APR [PTI]: At least nine candidates of the Bodoland Peoples Front (BPF), a key ally in the Congress-led grand alliance in Assam, have been shifted to a resort in the Congress-ruled Chhattisgarh after the recently held Assembly polls in that state, a local Congress leader said on Tuesday.

Confirming the development, the senior leader said these nine candidates of the BPF were brought to Raipur on Saturday late evening in a flight and lodged in a hotel before they were shifted to a resort in



Nava Raipur.

These candidates were accompanied by some Congress leaders and other members of the BPF during their

journey to Chhattisgarh, he said.

They will stay in Raipur till May 2, the day when results of the Assam elections will be out,

he added.

Chhattisgarh Minister Bhupesh Baghel, state ministers and other senior leaders of the Congress had extensively campaigned during the three-phase assembly elections in Assam that concluded on April 6.

Congress-led The "Mahajoth" or Grand Alliance of opposition parties in Assam comprises the AIUDF, BPF, CPI(M), CPI and other parties.

The BPF had fielded 12 candidates in the polls and one among them joined the BJP amid the elections, the leader

Yogi Adityanath tests positive for COVID-19

LUCKNOW, 14 APR [PTI]: Uttar Pradesh Chief Minister Yogi Adityanath has tested positive for COVID-19 and is isolating himself, he tweeted this afternoon.

The announcement comes a day after he went under isolation following some of his officials of his office testing positive for the virus. The 48-yearold said all activities of the state government are being conducted normally and urged those who came in contact with him in recent days to get themselves tested.

"When the initial symptoms were seen, I got myself tested for Covid and my report came back as positive. I am in self-isolation and fully following the instructions of physicians. I am doing all work virtu-



ally," he tweeted in Hindi. Yogi Adityanath's an-

nouncement comes on the same as that of his predecessor, Samajwadi Party chief Akhilesh Yaday, who too has tested positive for COVID-19.

He had received the first dose of vaccine against COVID-19 in Lucknow earlier this month.

Apart from monitoring the Covid situation in the state, the Chief Minister had been actively campaigning for his party, the BJP, in West Bengal that is voting in eightphase assembly election.

Last week, the Uttar Pradesh government ordered the closure of all schools till

April 30. It also directed to impose night curfews from 9 pm to 6 am in districts reporting more than 100 new infections every day.

Uttar Pradesh recorded a single-day spike of 17,963 coronavirus cases in the last 24 hours. 85 people died of the disease in the same period.

100 Days: Tokyo Olympics marked by footnotes and asterisks

Токуо, АРК 14 (АР): Tokyo pitched itself as "a safe pair of hands when it was awarded the Olympics 7 1/2 years ago.

"The certainty was a crucial factor," Craig Reedie, an IOC vice president at the time, said after the 2013 vote in Buenos Aires.

Now, nothing is certain as Tokyo's postponed Olympics hit the 100-days-to-go mark on Wednesday. Despite surging cases of COVID-19, myriad scandals and overwhelming public opposition in Japan to holding the Games, organizers and the IOC are pushing on.

Tokyo's 1964 Olympics celebrated Japan's rapid recovery from defeat in World War II. These Olympics will be marked by footnotes and asterisks. The athletes will aim high, of course, but the goals elsewhere will be modest: get through it, avoid becoming a super-spreader event, and stoke some national pride knowing few other countries could have pulled this off.

"The government is very conscious of how the world' views Japan," Dr Gill Steel, who teaches political science at Doshisha University in Kyoto, wrote in an email.

"Cancelling the Olympics would have been seen, at some level, as a public failure on the international stage."

The price will be steep when the Olympics open on July 23.

The official cost is USD 15.4 billion. Olympic spending is tough to track, but several government audits suggest it might be twice that much, and all but USD 6.7 billion is public money.

Switzerland-based IOC generates 91% of its income from selling broadcast rights and sponsorship. This amounts to at least USD 5 billion in a fouryear cycle, but the revenue flow from networks like American-based NBC has been stalled by the postponement.

What does Tokyo get out of the 17-day sports circus?

Fans from abroad are banned, tourism is out, and there'll be no room for neighborhood partving. Athletes are being told to arrive late, leave early and maneuver around a moving maze of

There are also reputational costs for Japan and the International Olympic Committee: a bribery scandal, botched planning, and repeated misogyny in the Tokyo Olympic leadership.

The IOC is betting Tokyo will be a distraction "the light at the end of the pandemic tunnel" as the closing ceremony comes just six months



before the opening of the boycott-threatened Beijing Winter Olympics.

Various polls suggest up to 80% of Japanese want the Olympics cancelled or postponed. And many scientists are opposed.

"It is best to not hold the Olympics given the considerable risks." Dr Norio Sugaya, an infectious diseases expert at Keiyu Hospital in Yokohama, told The Associated Press.

Japan's vaccine roll-

out has been almost nonexistent, few will get shots before the Olympics open, and Tokyo has raised its alert level with another wave predicted about the time of the opening ceremony. About 9,500 deaths in Japan have been attributed to COVID-19, good by global measures but poor by standards in Asia.

And what's the impact of 15,400 Olympic and Paralympic athletes from more than 200 countries and territories entering Japan, joined by tens of thousands of officials, judges, media, and broadcasters?

"The risks are high in Japan. Japan is dangerous, not a safe place at all," Sugaya said. The heavily spon-

sored torch relay with 10,000 runners crisscrossing Japan also presents hazards. Legs scheduled for Osaka this week were pulled from the streets because of surging COVID-19 cases and relocated into a city park with no fans allowed. Other legs across Japan are also sure to be dis-

The IOC and Japanese politicians decided a year ago to postpone but not cancel the Olympics, driven by inertia and the clout of Japanese ad giant Dentsu Inc., which has lined up a record of 3.5 billion in local sponsorship probably three times more than any previous Olympics.

"I think the government knows full well the Japanese public doesn't want the Olympics as of now," Dr Aki Tonami, who teaches political science at the University of Tsukuba, wrote in an email to AP. "But no one wants to be the one to pull the plug.'

The Olympics may also determine the fate of Prime Minister Yoshihide Suga, who replaced control."

Despite being billed as the Recovery Olympics, the northeastern area of Japan is still hurting a decade later. Many blame the Olympics for the slow recovery and siphoning off resources.

Tonami said. "I think he knows his tenure as a PM will not be a long one, so even though it would be nice for him personally to pull it off, it probably doesn't change the political conditions around him."

Neymar calls PSG "home" amid contract extension talks



SAO PAULO, APR 14 (AP): Striker Neymar called Paris Saint-Germain his "home" after the team's 1-0 defeat against Bayern Munich, which was still enough for the French club to advance to the Champions League semiin Lisbon.

The Brazilian is currently negotiating a contract extension.

"I don't think this is Kimmich. even a topic anymore, I obviously feel very comfortable, at home at PSG," Neymar told TNT Sports Brazil after the match at Parc des Princes stadium

Durant, Nets top Wolves 127-97 in makeup game after shooting of their star center who

Kevin Durant and the Brooklyn Nets made quick work of the Timberwolves, even if focus was harder to come by than usual. Durant scored 31

points on 11-for-15 shooting in his most productive performance in $2 \frac{1}{2}$ months, as the Brooklyn Nets blew out the Minnesota Timberwolves 127-97 on Tuesday afternoon.

"I felt like my wind and legs are getting up under me, each and every minute I'm playing," said Durant, who missed 23 games with a strained hamstring until returning last week.

The game was rescheduled from the previous night, out of sensitivity to the community following the traffic-stop death of 20-year-old Daunte Wright. Players from both teams wore black warmup shirts that read, "With liberty and justice for all," with the last two words in all-caps for extra emphasis, and a moment of silence was held before tip-off.

"All we can do is be here for each other physically, emotionally try to comprehend what guys are going through," Tim-



berwolves guard D'Angelo Russell said, adding: "I encourage everybody to go out there and do what you can physically do to make things better, not just speak about it."

Anthony Edwards had 27 points and eight rebounds for the Timberwolves, who played without Karl-Anthony Towns on the oneyear anniversary of his mother's death from COVID-19 complications. Towns chose to sit out and spend the time with his family.

Joe Harris pitched in 23 points for the Nets, who had 31 assists on 46 made baskets. Missing James Harden (strained hamstring), Kyrie Irving (personal reasons) and LaMarcus Aldridge (non-COVID-19 illness), the Nets were in command from the jump and ahead by 23 points before the midpoint of the second quarter. Hong Kong's delayed legislative elections set for December



Hong Kong, Aug 14 (AP): Hong Kong leader Carrie Lam has said that semiautonomous Chinese territory's legislative elections will take place in December, more than a year after they were postponed by authorities citing public health risks from the coronavirus pandemic.

Lam also said on Tuesday that laws will be amended so that inciting voters not to vote or to cast blank or invalid votes will be made illegal, although voters themselves are free to boycott voting or cast votes as they wish.

"When a person willfully obstructs or prevents any person from voting at an election, we will consider it corrupt conduct," said Lam.

Lam said that the elections will take place former British colony.

on December 19. The elections were initially slated to be held last Sep-

Lam was speaking a day ahead of the first reading of draft amendments to various laws in the city's legislature, to accommodate Beijing's planned changes to the city's electoral system.

Beijing in March announced changes to Hong Kong's electoral system, expanding the number of seats in the legislature while reducing the number of directly-elected seats from 35 to 20.

The move is part of a two-phase effort to rein in political protest and opposition in Hong Kong, which is part of China but has had a more liberal political system as a China imposed a national security law on Hong Kong last year and is following up this year with a revamp of the electoral process.

The crackdown comes in the wake of months of pro-democracy protests in 2019 that brought hundreds of thousands to the streets and turned violent as the government resisted the movement's demands.

Somalia's president OKs mandate extension, alarming US, EU

MOGADISHU, SOMALIA (AP): Somalia's president has defiantly signed into law an extension of his mandate and that of his government as the United States and others threatened sanctions and warned of further instability in one of the world's most fragile

The standoff prolongs months-long election crisis after the February national vote was delayed. Critics say President Mohamed Abdullahi Mohamed's time in office is over. The international community had objected to a mandate extension and warned that the al-Qaida-linked al-Shabab extremist group could take advantage of the country's heated political divisions.

The president late Tuesday signed the controversial law after the lower house of parliament this week voted to effectively extend his mandate for two years while calling for direct elections during that time. Leaders of the Senate, however, called the vote illegal and Somalia's opposition protested.

The U.S. is "deeply disappointed," Secretary of State Antony Blinken said in a statement overnight that threatened the



possibility of sanctions, visa restrictions and a reevaluation of "our bilateral relations." The statement called for Somalia's federal government and regional states to urgently return to talks on the election crisis.

The European Union had warned that signing this week's decision into law would divide Somalia and "constitute a grave threat to the peace and stability of Somalia and its neighbors," and it threatened to consider "concrete measures" in response.

Britain said "underweek's move mines the credibility of Somalia's leadership" and it threatened to work with international partners to "reevaluate our relationship and the nature of our assistance to Somalia."

Somalia's government has been unable for months to reach agreement on how to carry out the election, with the regional states of Puntland and Jubbaland objecting on certain issues and the international community warning against holding a partial election. The crisis led to deadly violence against demonstrators who opposed an election

Contentious issues in months of talks on the election process included the formation of the electoral management commission, the selection of commission members for the breakaway region of Somaliland.

Somalia hasn't had a one-person-one-vote direct election in decades.

The country began to fall apart in 1991, when warlords ousted dictator Siad Barre and then turned on each other. Years of conflict and attacks by al-Shabab, along with famine, left this Horn of Africa country of about 12 million people

Iran president calls 60% enrichment an answer to 'evilness'

DUBAI, UNITED ARAB EMIRATES (AP): Iran's president on Wednesday called his country's decision to dramatically increase its uranium enrichment after saboteurs attacked a nuclear site "an answer to your evilness," saying Israel hoped to derail ongoing talks aimed at reviving Tehran's tattered nuclear deal with world powers.

This weekend's sabotage at the Natanz nuclear facility appears to be part of an escalating shadow war between the two countries. Israeli authorities have not commented on the attack, but are widely suspected of having carried it out.

Iran announced Tuesday it would increase uranium enrichment up to 60%, its highest level ever, in response to the attack. That could draw further retaliation as Israeli Prime Minister Benjamin Netanyahu has vowed never to allow Tehran to obtain a nuclear weapon. While Iran's move keeps enrichment below weapons-grade levels of 90%, it is a short step away.

Speaking to his Cabinet, an impassioned President Hassan Rouhani said the first-generation IR-1 centrifuges that were damaged in the attack would be replaced by advanced IR-6 centrifuges that enrich uranium much faster.

"You wanted to make our hands empty during the talks but our hands are full," Rouhani said.

He was referring to ongoing talks in Vienna that are aimed at finding a way for the United States to re-enter Tehran's nuclear agreement with world powers and have Iran comply again with its limits. The accord, which former President Donald Trump withdrew the U.S. from in 2018, prevented Iran from stockpiling enough high-enriched uranium nuclear weapon in exchange for the lifting of economic sanctions. Rouhani added: "60%

"We must never remain apathetic to the threats of war and extermination of those who seek to eliminate us," he

Rouhani in his comments Wednesday insisted Iran is still hoping that the Vienna talks lead to a negotiated settlement over its program — and the accompanying lifting of punishing sanctions.

France, Germany and the United Kingdom, all parties to the nuclear deal, issued a joint statement Wednesday expressing their "grave concern" over Iran's decision to increase enrich-

"This is a serious development since the riched uranium consti-

tutes an important step in the production of a nuclear weapon," the countries said. "Iran has no credible civilian need for enrichment at this level."

Saudi Arabia, a regional rival to Iran, similarly issued a statement, saying enriching at that level "could not be considered a program intended for peaceful purposes."

"The kingdom calls on Iran to avoid escalation and not to subject the security and stability of the region to more tension, and to engage seriously in the current negotiations," Saudi Arabia said.

Iran insists its nucle-

ar program is peaceful, though the West and the International Atomic Energy Agency says Tehran had an organized military nuclear program up until the end of 2003. An annual U.S. intelligence report released Tuesday maintained the American assessment that "Iran is not currently undertaking the key nuclear weapons-development activities that we judge would be necessary to produce a nuclear device."

Iran previously had said it could use uranium enriched up to 60% for nuclear-powered ships. However, the Islamic Republic currently has no such ships in its navy.

EU to negotiate major vaccine contract extension with Pfizer

BRUSSELS (AP): Commission chief Ursula von der Leyen announced plans Wednesday for a major contract extension for COVID-19 vaccines with Pfizer stretching to 2023.

In a sign of confidence in a company that has been a mainstay of Europe's vaccination drive so far, von der Leyen said the EU will start negotiating to buy 1.8 billion doses of the Pfizer-BioNTech vaccine through 2023.

Von der Leyen expressed full confidence in the technology used for the Pfizer-BioNTech vaccine, which is different from the technology behind the Oxford-Astra-Zeneca vaccine.

"We need to focus on the technologies that have proven their worth." von der Leyen said.

Pfizer-BioNTech plans to provide the EU with an extra 50 million dozes in the 2nd quarter of this year, on top



of 200 million doses already earmarked for the bloc. The deliveries will be especially welcomed by the EU's 27 member nations considering supply delays and concerns over rare blood clots potentially linked to the Oxford-AstraZeneca vac-

Denmark decided Wednesday not to resume use of AstraZeneca COVID-19 vaccine after putting it on hold last month following reports of rare blood clots in some recipients. The

bulk of the shots given in the Scandinavian country so far have been the Pfizer-BioNTech vaccine.

The European Commission currently has a portfolio of 2.3 billion doses from a half dozen companies and is negotiating more contracts.

The planned negotiations with Pfizer left in the middle what the EU would do about any new contracts with AstraZeneca, which has had massive delivery problems during the first quarter and expects to send far fewer vaccines than its contract with the EU called for during the second quar-

The European Commission said in a statement, "We keep all options open to be prepared for the next stages of the pandemic, for 2022 and beyond. We can, however, not comment on contractual issues.

Von der Leyen, however, showed her full support for Pfizer-BioNTech, with the announcement for the massive order.
