# All inmates at Kyongsa quarantine facility test negative

**SUMMIT REPORT** GANGTOK, 16 JUN:

total of 183 new samples were tested in the Viral Research and Diagnostic Laboratory at STNM Hospital on Monday. These included 113 samples from quarantine facility of Kyongsa in Gyalshing, West Sikkim, and all tested negative, informed Health Department DG-cum-Secretary, Dr Pempa Tshering Bhutia in his daily

health bulletin on Tuesday.

The Kyongsa quarantine centre, it may be recalled, had been declared a containment zone after four people lodged there had tested positive for COVID-19 recently.

He further informed that samples of four positive patients from the isolation ward were also tested on Sunday but all tested positive again. He added that these samples were of a Mumbai re-

turnee who returned on 01 June 64 active cases in the State and and of three Delhi returnees who returned on 25 May.

"If they had tested negative then we would have conducted their repeat test within 24 hours and discharged them if they tested negative in the repeat test. But after being tested positive they will be kept for some more days under observation," he said.

# CM participates in video conference with PM

#### GANGTOK, 16 JUN (IPR):

Chief Minister, Prem Singh Tamang participated in a video conference called on by the Prime Minister with Chief Ministers of 21 States to discuss the situation emerging post-Unlock 1.0 and plans for combating the pandemic.

A PowerPoint presentation was presented by Secretary, Ministry of Health on the impact of lockdown on COVID-19 outbreak and the way forward.

The positive outcome of the lockdown was highlighted, duly giving credit to community participation, awareness, Jan Andolan initiated (behaviour change) which restricted the spread of the disease to a great extent. The continuous decline in the growth rate of cases and death rates in the country was also reflected.

Further, the current challenges were highlighted in view of the control, comprehensive phased-wise unlocking considering that India is one of the most populated countries in the world. Checking the spread of the disease, new areas getting affected by the movement of people, rise of cases by 2 ½ times in the last 14 days, 31 new



districts from the North-East States reporting new cases, 59 districts in 8 States reporting a surge of COVID-19 positive cases are some of the growing challenges.

The presentation em-

phasized on continued focus on surveillance and containment, notifying containment zones, active house to house case finding, strict perimeter contact tracking, adequate testing, community involvement for containment zone management, treatment of cases as per protocol, quarantine facilities in rural areas and appropriate behaviour, informed citizens, confident community, community awareness on social distancing, promoting homemade masks, Do Gaj ki Doori, frequent hand washing, respiratory hygiene and sanitation, emphasis on precautions for elderly and comorbid.

Thereafter the States provided feedback, suggestions and support for an effective plan for further phased unlocking in the country.

The Prime Minister, Narendra Modi reiterated that we need to realize that the fight is not over and hence be extra careful, alert and work in cooperation to combat the disease. He informed about trying to save every life and mentioned that the recovery rate is over 50% in the country.

He pressed on the need to focus on both life and livelihood, improving health infrastructure, testing and tracing as well as increasing economic activities. He expressed that timely decisions taken to combat the pandemic have been effective in containing its spread in the country.

The Prime Minister acknowledged the views and suggestions put forth by the States and thanked them for their continuous support in the fight against the pandemic which has been successful to a great extent as compared to other countries in the world.

Aviation turbine fuel (ATF) price was hiked by

litre and diesel by Rs 5.8 a litre. Rates have been increased across the country and vary from state to state depending on the incidence of local sales tax or VAT.

The hike in diesel rates is the highest daily increase since the state-owned fuel retailers started daily revision in rates in May 2017.

Tuesday's increase in petrol and diesel price marks the 10th straight day of rise in rates since oil companies on June 7 restarted revising prices in line with costs, after ending an 82-day hiatus.

The freeze in rates was imposed in mid-March soon after the government hiked excise duty on petrol and diesel to shore up additional finances.

Oil PSUs Indian Oil Corp (IOC), Bharat Petroleum Corp Ltd (BPCL) and Hindustan Petroleum Corp Ltd (HPCL) instead of passing on the excise duty hikes to customers adjusted them against the fall in the retail rates that was warranted because of fall in international oil prices.

The June 1 hike in jet fuel price had come after seven consecutive reductions in rates since February. ATF price in Delhi before the reduction cycle began in February was Rs 64,323.76 per kilolitre, which got reduced to Rs 21,448.62 last month.

# COVID vaccine at least a year away, say scientists

NEW DELHI, JUN 16 (PTI): Vaccine design is still an empirical, trial and error process and a preventive against COVID-19 could be at least a year away. say scientists as information on developments in therapeutics to combat the infection flows in a steady trickle from across the world.

While quelling the buzz of a quick breakthrough, the scientists also hold out hope that the process might be cut short by a few months if testing approvals and scale-ups in manufacturing happen simultaneously.

According to the World Health Organisation, 10 candidate vaccines for COVID-19 are in the clinical evaluation and 126 are in the preclinical stage.

Preclinical development is a stage of research during which important feasibility, iterative testing and drug safety data are collected, while clinical trials are research studies performed

There are different broad strategies by which SARS-CoV-2 vaccines are being developed the world over, explained immunologist Satyajit Rath.

While all are well-known strategies -- some almost two centuries old and some almost two decades old -- none are 'guaranteed' to yield a usable vaccine, the scientist from the National Institute of Immunology (NII) in New Delhi told PTI.

Vaccine design still remains mostly an empirical, trial and error process, rather than an innovative knowledge-driven one. This is why, while any of these approaches is being put through trial and error, it remains a 'vaccine candidate' rather than a 'vaccine', he added. According to Robert Gallo, director

of the Institute of Human Virology at the University of Maryland in the US, What's being confused -- and scientists and politicians are contributing to the confusion -- is the difference between a candidate and a vaccine."

He was speaking at a virtual meeting earlier this month when scientists at the University of California (UC) Davis and from other institutes in the US gathered to lay out a full picture of the complexities of developing and distributing a COVID-19 vaccine -- which they generally agreed won't happen until some time in 2021.

'We are not expected to return to a fully normal life until a vaccine is developed. But how long will that take? UC Davis Chancellor Gary S. May asked in the meeting.

About a year, maybe more, was the consensus.

In India, where the number of COVID-19 cases on Tuesday rose to 3,43,091 and the death toll to 9,900, scientists agreed with their counterparts

With at least six Indian companies

working on a vaccine for COVID-19 and the Serum Institute of India last week announcing a deal with the company Astra Zeneca to supply one billion doses of vaccine for low and middle-income countries to combat the coronavirus, the buzz has been growing

"We finally have a deal signed with @AstraZeneca, to exclusively manufacture their product for India and @gavi countries, up to a billion doses annually. This will ensure supply and access to all Indians," Adar Poonawala, the CEO of the Serum Institute, tweeted on June 13.

Earlier this month, Prime Minister Narendra Modi pledged USD 15 million as India's contribution to the vaccines alliance GAVI at the Global Vaccine Summit hosted by the UK.

But that does not translate into a vaccine anytime soon, scientists said. My guess for that is, not before the middle of the next year, Rath said.

However, he noted that the time estimates might be pruned by a couple of months with simultaneous movements on testing-approval and manufacturing scale-up, and also by exception-shortcuts from regulatory authorities.

He explained that there are several challenges that will arise once such vaccines are ready to go into the market, since 'going into the market' and going into the 'public health system' are not the same thing.

Questions will remain on the 'availability' at a large scale, especially to the

One limitation, of course, is the scale of manufacturing. Huge numbers of doses will have to be manufactured in very short times to reach everyone. A number of governmental and non-governmental organisations are trying to set up industrial partnerships to address this issue,"

A second issue, the scientist said, will be the cost of vaccines, with the linked issue of intellectual property rights.

A final issue, he noted, is of actual implementation and delivery of vaccination.

"The resources and the technical-administrative structures needed for such a vaccination campaign are massive. It is not clear if any national governments have the understanding and the practical commitment to them. That might end up being the biggest roadblock of all, Rath said.

Umashankar Singh, assistant professor, Biological Engineering, IIT-Gandhinagar, said he is hoping a candidate vaccine may be available by the end of 2020, even if it is for a limited set of the population.

Two facets of vaccine production, in his view, need to be considered mass production of the lab product and also ensuring that the product is actually effective enough to justify mass production.

There are other challenges too, he said, adding that there is evidence for a range of virulence, variable infection rates and asymptomatic infections and emergence of multiple strains.

The uncertainty posed by these issues is likely to throw spanner in the works towards mass production of vaccines. This vaccine development is like chasing a moving target, a target we don't know well enough. The question we should be asking is, even if a vaccine were to be available, how long would its effectiveness last?" he told PTI.

Singh noted that the emergence of a vaccine may or may not allow real protection against a rapidly evolving pathogen, but it would certainly allow us a psychological relief of being immune to the virus.

'That would allow us to move on to the issues of economy, social interactions and ease of governance, he said.

Even if by end of the year 2020 a candidate vaccine gets regulatory approval, mass production and supply chain is going to be a challenge, added an Indian virologist who didn't wish to be named.

If it is a single dose vaccine, the world will need at least eight billion doses, a task that might several months and maybe years. If it is a two dose vaccine, the challenge becomes bigger.

# One Nation, One Ration Card scheme will strip Sikkimese of their special status, Cong alleges

The Congress has advised the SKM Government to keep itself better informed about Sikkim's unique status within the Union of India and not allow the Centre to dictate dilution of the special status accorded on Sikkim by Article 371F of the Constitution of India. In the Congress crosshairs is the "One Nation, One Ration Card" initiative of the NDA Government, which, it believes, is a move towards "One Nation, One Citizen," something which will strip Sikkimese of their special identity.

Sikkim Pradesh Congress Committee president, Bharat Basnet, alleged that the ONORC scheme of was a process towards the One Nation One Citizen design.

He asserted that the scheme was a direct attack on Article 371F so the State government should rise above opportunistic politics and take stand against the scheme in the interest of Sikkim and its people.

Addressing a press conference here this morning, Mr Basnet criticized and condemned the statement attributed to UDHD Minister, Arun Uprety, who likened the One Nation One Ration Card scheme to an ATM - a provision which will allow ration-card holders to withdraw rations from anywhere in the country.

Mr Basnet stated that the Article 371F was not demanded by the people or political parties of Sikkim but was given by the Congress party to the people of Sikkim.



He added that ON-ORC was a move towards One Nation One Citizen regime and hence a direct attack on the Article

"We cannot be generalized with other citizens of the country as we are not at par with them due to the special provisions given to Sikkim and its people by the Article 371F. Even the BJP leadership has accepted that Sikkimese are not at par with other people of the country during discussions on CAB and demon-

etization," he expressed.

The SPCC president

stressed that the SKM government should stand for the mandate given to it by the people of Sikkim. He asserted that if SKM was not able to fulfill the hopes and aspirations of the people then it should leave office.

# CJM directs SHO to register complaint against Pataal Lok as FIR

hief Judicial Magistrate [East], on Tuesday, directed the Sadar Thana to register an FIR on the basis of a complaint lodged against web-series, Pataal Lok. The CJM order was on a petition filed by Arun Limboo and Prakash Gurung on 08 June contending that the series had offended them and the Nepali community and has sought directions that their complaint be taken as an FIR and their allegations investigated.

Speaking to media persons, counsel for the petitioners, Nawin Kiran Pradhan, said, "We decided not to sit silent on the indecent and racial slur made against the



Nepali community in the web-series and registered our objection to it."

He further informed that they had lodged a complaint at Sadar Thana on 23 May itself requesting the police to take strict action against the makers.

When the thana refused to register their complaint as an FIR even after they approached the SP [East], they decided to approach the CJM.

Mr Pradhan explained that the CJM passed the order today directing the SHO to register an FIR and have the case investigated to determine whether the dialog in question causes promotion or enmity between different groups on the grounds of race and language, or whether, commission of the this act is prejudicial to maintenance of harmonv.

He added that the order also states that investigation is also warranted to ascertain if the alleged insult was committed to provoke breach of peace or even create or promote enmity, hatred or ill-will between classes or to entice any class or community or person to commit any offence against any other class or community.

"We are very hopeful that the Sadar Thana will soon register the case to investigate the matter and issue notices to the directors and producers of Pataal Lok," Mr Prad-





# **Measures taken by Social Justice Dept** under Child Protection Scheme

GANGTOK, 16 JUN (IPR):

As the pandemic COVID-19 intensified in the country it was important that urgent measures needed to be taken on priority to prevent the spread of the virus in the Child Care Institutions (CCIs). Prompt and urgent action was taken by the Social Justice Department to pre-emt emergency and disaster situation arising with regard to children for State Care.

- The CCIs were instructed to keep adequate soap/hand wash/ sanitizer available to the children, display caution notice of preventive measures, provide warm drinking water to all children and staff, not allow unnecessary outing, restrict visitors, check flu like symptoms at the nearest medical centre, co-ordinate with Doctor when required, carry out medical checkup for COVID-19 of all children and provide awareness and information on safety from the virus to the children.
- The advisory from the Ministry of Women and Child Development to discourage entry of visitors, ensure proper cleaning and frequent sanitization of the Homes, particularly of the frequently touch surfaces, regular washing of hand, covering of nose and mouth with bent elbow or tissue during coughing or sneezing, disposal of used tissues immediately was also propagated to the CCIs along with the list of DO's and DON'Ts.
- DO's included maintained personnel hygiene and physical distancing, wash hands

even if they are visibly clean with soap and water, or alcohol based hand drop. Maintained safe distance from person during interaction especially with those having flu like symptom, not to cough in the palm of hand, check temperature regularly, check for respiratory symptom,

DON'Ts included do not shake hands, do not touch eyes, nose or mouth. Do not spit in public. Do not travel unnecessarily to any affected region, do not participate for large gathering including seating in groups, do not spread panic or rumor.

Bengalis are in for a pleasant surprise amid the COVID-19 gloom as fishermen, after a threemonth hiatus, have exuded hope of a bumper yield of hilsa, known as "maacher rani" (queen of fish) in Bengal, given the dip in economic activities in the seas due to the lockdown.

With the arrival of monsoon, many of them have already ventured out with their trawlers, trying their best to lay hands on the prized "silver crop" -- a nonpareil delicacy that can be savoured when fried, smoked or cooked in mustard sauce.

"As there was near-zero commercial activity in the seas and rivers, and no industrial effluthe waters during this three-month hiatus, fish breeding, which is common during this season, is bound to pick up pace.

"Since June 14, several fishermen have set sail. The catch is expected to be higher this time compared to the last two years," Sunderban Development Minister Manturam Pakhira told PTI on Tuesday.

The Ganga meets the Bay of Bengal near Sunderbans in South 24 Parganas district and the confluence happens to be the breeding ground for hilsa, which moves upstream from the seas to the rivers around this time of the year.

# Army officer, 2 soldiers killed in clash with Chinese Army in Galwan Valle

New Delhi, Jun 16 (PTI): An Indian Army officer and two soldiers were killed during a violent confrontation with Chinese troops in the Galwan Valley in eastern Ladakh on Monday night, in the first such incident in the last 45 years reflecting massive escalation in the five-week border row

The Army said India lost an officer and two soldiers during the violent face-off, while there were casualties on the Chinese side as well

The extent of casualties on the Chinese side is not immediately clear

According to a senior military officer, it is the first incident involving the casualty of an Indian soldier in a violent clash with the Chinese Army after 1975 when four Indian soldiers were killed in an ambush at Tulung La in Arunachal Pradesh along the de-facto border between the two countries

Official sources said there was no firing between the two sides

"During the de-escalation process underway in the Galwan Valley, a violent face-off took place on Monday night with casualties. The loss of lives on the Indian side includes an officer and two soldiers," the Army said in a brief statement

Army officer killed in the clash was the commanding officer of a battalion at Galwan. It is believed that the three Army men died due to injuries sustained following stone-pelting by the Chinese side.

However, there is no official word on it

Defence Minister Rainath Singh reviewed the current operational situation in eastern Ladakh along with Chief of Defence Staff Gen Bipin Rawat and the three service chiefs. External Affairs Minister S Jaishankar was also present in the meeting

Sources said Army Chief Gen MM Naravane's visit to a base outside Delhi has been cancelled

The incident comes days after the Indian Army Chief said both sides have begun disengaging from Galwan Val-

The Indian and Chinese armies are engaged in the standoff in Pangong Tso, Galwan Valley, Demchok and Daulat Beg Oldie in eastern Ladakh. A sizeable number of Chinese Army personnel even transgressed into the Indian side of the de-facto border in several areas including Pangong Tso

The Indian Army has been fiercely objecting to the transgressions, and demanded their immediate withdrawal for restoration of peace and tranquillity in the area. Both sides held a series of talks in the last few days to resolve the row

In their first serious efforts to end the row, Lt General Harinder Singh, the general officer commanding of the Leh-based 14 Corps, and Commander of the Tibet Military District Maj Gen Liu Lin held a nearly seven-hour meeting on June 6.The meeting was followed by two rounds of Major General-level talks.

#### COVID-19 cases in India climb to 3,43,091; death toll 9,900

New Delhi, Jun 16 (PTI): India registered over 10,000 new COVID-19 cases for the fifth day in a row pushing tally to 3,43,091 on Tuesday, while the death toll rose to 9,900 with 380 new fatalities, according to the Union Health Ministry data.

The country recorded 10,667 coronavirus infections in the last 24

The number of active cases stands at 1,53,178, while 1,80,012 people have recovered and one patient has migrated, according to the officially updated figure at 8 am.

"Thus, around 52.46 per cent patients have recovered so far," an official said.

India is the fourth worst-hit nation by the pandemic after the US, Brazil and Russia.

According to the Johns Hopkins University, which has been compiling COVID-19 data from all over the world, India is in the eighth position in terms of death

The total number of confirmed cases include foreigners.

Of the 380 deaths, Maharashtra accounted for the highest 178 fatalities followed by Delhi at 73, Tamil Nadu at 44, Gujarat 28, Haryana 12, West Bengal 10, Rajasthan 9 and Madhya Pradesh 6.

Andhra Pradesh and Punjab have reported 4 fatalities each, Jammu and Kashmir and Karnataka 3 each, Telangana 2 and Bihar, Chandigarh, Himachal Pradesh and Kerala 1 each.

Of the total 9.900 deaths, Maharashtra tops the tally with 4,128 fatalities followed by Gujarat with 1,505 deaths, Delhi with 1,400, West Bengal with 485, Tamil Nadu with 479, Madhya Pradesh with 465, Uttar Pradesh with 399, Rajasthan with 301 and Telangana with 187 deaths.

The death toll reached 100 in Haryana, 89 in Karnataka, 88 in Andhra Pradesh, and 71 in Punjab. Jammu and Kashmir has reported 62 COVID-19 fatalities, Bihar 40, Uttarakhand 24, Kerala 20 and Odisha 11.

# What After Cashing In? There is still need for better fiscal management tips for rural Sikkim

It might already be too late to talk about the following Loncerns because too much has already been allowed to drain away. But then again, even if some sense is allowed to prevail despite the late waking up, it would be an effort well undertaken.

Sikkim has been blustering ahead on a fast clip of infrastructure and industrial construction ranging from wider roads to more roads to hydel projects to an airport to grand public facilities and industries. Projects invariably attract protests ranging from individual reservations to mass discomfort. Much has been written about protests and responses, however now it is time to deliberate on the post project-clearance scenario and the management practices that should be introduced. Land comes at a premium in a hill state like Sikkim and even though agricultural productivity is falling and cash crop/horticulture options still in their infancy, the Organic Sikkim experiment notwith standing, land provides a sense of security to rural families. Most of the projects and investments require large transfers of land falling in the rural belt and this is where some initiatives, beyond the ones prescribed by laws and rules, need to be initiated.

The required processes of public hearings, rate negotiations and enumeration of affected families are easy to deliver because these form part of the guidelines by which projects need to be undertaken and come in clear ly prescribed check-lists. Given the sheer number of projects on the anvil and the crores that will be hand ed over to private land holders across rural Sikkim to complete the acquisition process, it becomes nec essary to ensure that the sudden liquidity in hands not used to manage finances does not drain away in momentary lapses of indulgence. One has to recognise the fact that Sikkim is not very organized when it comes to handling cash; there have been ample cases where even loans taken out for specific projects have been wasted on other non-productive pursuits and now one is looking at huge infusions of cash without any worries of repayment or interest servicing. A lot of these crores have already passed from the hands of project "developers" to affected land owners and then evaporated leaving behind deep resentments. It is import ant that enough is done to generate genuine fiscal prudence among the affected families. Money covers for the property relinquished, but only wise investments can fill in for the security that land has traditionally provided.

This is where the State machinery needs to step up beyond the brief prescribed by Delhi, by staying with the people after the lands have been acquired, compensation handed over and projects completed. The State should have (and can still explore the possibility) put in place a system which empowers 'compensated' land owners with sound knowledge of invest ment options. The need for such an initiative is only amplified by the scams of private finance companies which did prolific business in rural Sikkim selling dubious schemes. Unless 'informed' otherwise, the suddenly cash-rich landowners will continue to become easy prey to the persuasive skills of such operators. And then there is always the possibility that the money will follow the personal loan inspired acquisition of luxuries and wasted opportunities.

How can such a situation be averted? To begin with, the government can look into the possibility of the investors for whom land is being acquired to also organise a series of workshops and sensitisation programmes on fiscal management for the affected people. Simultaneously, the real concept of rural banking should be aggressively promoted and a group of NGOs, selected after a thorough screening process, could be provided with specialised training on formulating rural investment options with which they could then approach the affected areas. What the government could also incorporate is a special cell of handpicked officers to organise, monitor, improvise and advise such initiatives. It is the people's money at the end of the day and the government can do no more than inform them of possible options on what to do with their money, but should this information be intelligent and practical, it could turn around the rural economy and stand it more firmly on its feet. Like with all other initiatives witnessed in the State in the re cent past, this too will have to be one that is directed right from the top and if pursued in the earnest, could trigger an economic revival that delivers not only economic security, but catalyses rural prosperity as well.

# Maria Ressa's conviction should matter to everyone who cares about democracy

 $B^{\mathrm{y}}$  almost any measure, the conviction of Maria Ressa and her former colleague, researcher-writer Reynaldo Santos Jr, will have serious implications for democracy in the Philippines.

On Monday morning a court in Manila found the pair guilty of "cyberlibel" for a story published in 2012 on the news website Rappler.com that Ressa founded and now leads. The judge released them on bail pending an appeal but, if they lose, they could spend up to seven years in prison.

To reach her verdict, the judge had to accept the prosecution's breathtakingly thin arguments. First, that the website had violated the cyberlibel law, even though the story was published four months before the law even existed. The judge agreed that Rappler had "republished" the story, when it corrected a spelling error in 2014, thus making it subject to the law. The judge also accepted the prosecution's theory of "continuous publication", to get around the fact that the statute of limitations on libel in the Philippines is just one year.

In the words of the UK and Ireland's National Union of Journalists, it was a "shamelessly manipulated charge", and an "act of persecution by a bully government".

Amal Clooney - the UK's special envoy on media freedom and one of Ressa's lawyers - has described the case as "one of the most brazen and consequential of the decade". Ressa calls it "lawfare".

As a journalist who has been in the dock to hear a guilty verdict after a sham trial, I viscerally understand what Ressa and Santos were going through. When I heard the news, I felt



a disturbingly familiar churn deep in my stomach, knowing - feeling - the stress that they will be experiencing. But the far greater issue is the impact of this verdict on the Philippines itself and the region more broadly.

The Philippines is one of the world's most dangerous nations for journalists. The Committee for the Protection of Journalists calculates that over the past 30 years, 145 have lost their lives.

President Rodrigo Duterte routinely calls reporters, "spies" and, "sons of bitches", and once suggested that most of those journalists who died, somehow deserved it. "You won't be killed if you don't do anything wrong," he said.

Duterte has also targeted and forced the closure of ABS-CBN, the largest media company in the Philippines, while the owners of the country's largest newspaper, Philippine Daily Inquirer, were forced to sell the publication to a Duterte ally after publishing news reports and editorials critical of the deaths mounting in his war on

Of course, no government likes the media. When it is doing its job - as Rappler was - it forces those in power to answer for the consequences of their policies. And when an authoritarian leader manages to crush other democratic checks such as parliamentary oversight and an independent judiciary, all that's left is the awkward squad armed with pens, cameras and microphones.

And if this case matters to democracy in the Philippines, it also matters to the region more broadly. In its latest report, the human rights group Freedom House said, "political rights and civil liberties declined overall in Asia, as authoritarian rulers showed their disdain for democratic values ... '

This verdict, and the sustained assault on press freedom, accelerates that trend. We know from bitter experience that as authoritarians extend their rule, instability tends to follow.

In the past, the US has led the

way in defending liberal democratic values like press freedom, the rule of law, and human rights. But rather than criticising them, President Donald Trump has infamously cozied up to the likes of strongmen such as Duterte, and it seems doubtful that he will speak up now.

Which leaves it to other democracies like Britain and Australia to lead

Australia's national foreign policy white paper published in 2017 said promoting transparency, accountability and the rule of law in our region is one of the government's key

Last year the UK and Canada jointly hosted the first Global Conference on Media Freedom in London, as a signature initiative designed to push back on a deeply troubling global slide in press freedom.

If those governments truly believe in protecting those fundamental democratic principles, they will speak loudly and forcefully in support of Ressa and her colleagues at Rappler.

At a news conference after the hearing, Ressa addressed the gathered journalists directly. "It is a blow to us," she said. "But it is also not un-

"We [Rappler] are meant to be a cautionary tale. We are meant to make you afraid. But don't be afraid. Because if you don't use your rights, vou will lose them."

She was talking to her countrymen but she might as well have been addressing us all.

# Global Poverty: Coronavirus could drive it up for the first time since the 1990s

s COVID-19 slows in developed countries, the **A**virus's spread is speeding up in the developing world. Three-quarters of new cases detected each day are now in developing countries. And as the pandemic spreads, governments face juggling the health consequences with economic ones as this shifts to becoming an economic crisis.

Our research shows that the poverty impact of the crisis will soon be felt in three key ways. There is likely to be more poverty. It is likely to become more severe. And as a consequence, the location of global poverty will also change.

Having looked at estimates from a range of sources - including the Asian Development Bank, Goldman Sachs, IMF and OECD - we considered three possible economic scenarios stemming from COVID-19, where global income and consumption contracted by 5%, 10% or 20%. We found that the economic shock of the worst-case scenario could result in up to 1.12 billion people worldwide living in extreme poverty - up from 727 million in 2018.

This confirms our earlier estimates that the coronavirus could push up to 400 million people into extreme poverty, defined by the World Bank as living on less than US\$1.90 (£1.66) per day - the average poverty line in low-income developing countries. This number rises to over 500 million if using the World Bank's higher average poverty lines for lower middle-income (US\$3.20) and upper middle-income (US\$5.50) developing countries.

The potential increase is driven by millions of people living just above the poverty line. These people are likely to be badly affected because many of them work in the informal sector, where there is often little in the way of social security.

Such a rise in extreme poverty would mark the first absolute increase in the global count since 1999 – and the first since 1990 in terms of the proportion of the global population living in pov-

On the severity of the poverty, the resources needed to lift the incomes of the poor to above the poverty line could increase by 60%, from US\$446m a day in the absence of the crisis to above US\$700m a day. For the existing extreme poor and those newly living in extreme poverty, their loss in income could amount to US\$500m per day.

In terms of where poverty is located, it is likely to increase dramatically in middle-income developing countries in Asia, such as India, Pakistan, Indonesia and the Philippines. This points to the fact that much of the previously poor population in these countries moved to just above the poverty line. In other words, these countries' recent economic progress has been relatively fragile. We'll also likely see new poverty in countries where it has remained relatively high over the last three decades, such as Tanzania, Nigeria, Ethiopia and the DRC.

HOW TO RESPOND TO THE POVERTY PAN-DEMIC

COVID-19 poses a significant threat to developing countries, as their health systems tend to be weaker. More severe cases have also been linked to high blood pressure, diabetes and air pollution, all of which are prevalent in developing countries. Meanwhile, there are suggestions that COVID-19 could hinder the treatment of other illnesses such as TB, HIV/AIDS and chronic malaria.

But developing countries generally have a lower proportion of people at high risk from COVID-19 in terms of age (>70 years). As such, economic shocks may pose a greater relative risk to their populations. The question emerges as to whether lockdowns are the best option to contain the virus

in developing countries if they entail severe income losses. Estimates of the share of jobs that can be performed at home is less than 25% for many developing countries - much lower than the ~40% recorded in, for example, the USA and Finland. It's as low as ~5% in countries such as Madagascar and Mozambique.

Consequently, there's also a clear need for a range of social safety-net policies. These already exist in many developing countries, but their coverage and funding needs to be expanded substantially. Such policies include cash transfer programmes, universal one-off cash

payments, in-kind food/vouchers, school feeding schemes and public works programmes. In middle-income developing countries, these are funded by the national government, whereas in low-income countries these are often co-funded by donors. Any set of policies should also incorporate "pay to stay home" or "pay to get tested" schemes.

THE LONG CRISIS

Looking further ahead, the poverty impacts beyond 2020 are closely related to if or when an effective vaccine is developed. Even if we take the best-case scenario and a vaccine is discovered later this year, it's uncertain how long it would take to reach the entire global population. It could take

There is no guarantee developing countries would get access to the vaccine at a reasonable cost, or if everyone in developing countries would get the vaccine for free. We could end up living in a new COVID-19 apartheid, with the vaccinated and non-vaccinated residing in separate areas and working in different labour markets. This is a startling but very real possibility that no one is talking about much yet.

While this might sound far off, there are already some countries - such as Chile - issuing "immunity passports". Such passports might determine what work people can do by determining where they can go. This could leave the poorest without access to earning opportunities or only with lower-income opportunities if their movement is restricted.

The crisis is increasingly looking like a long crisis. If so, it will have repercussions on global poverty for years to come.

BHUBANESWAR, JUN 16 (PTI): As many as 108 people, including 16 disaster response personnel, have tested positive for COVID-19 in Odisha, taking the state's tally to 4,163, a health department official said on Tuesday.

Of the 108 new patients, 95 were housed in quarantine centres upon their return from different states while 13 others were found to be infected with the novel coronavirus during contact tracing. The fresh cases were reported in 15 districts of the state, he said.

The new cases include 16 personnel of the Odisha Police Fire Serantine upon their return from West Bengal, where they were sent for restoration work following cyclone Amphan, the official said.

# Amphan stings beekeeping business in Bengal

KOLKATA, JUN 16 (PTI): At least 18,000 beekeepers in Bengal have been affected by Cyclone Amphan, which struck a month ago, pulverising farms and bee colonies across seven districts of the state, and the total loss incurred could climb up to Rs 2 crore, an association of apiculturists said.

Tarun Halder, the general secretary of the West Bengal Beekeepers' Association, said no financial assistance was doled out to the apiarists by the central or the state government so far, and many of them are finding it difficult to get back on their feet.

"We have around 18,000 beekeepers as members in seven districts, which have been largely devastated by Amphan. Bee colonies have been destroyed and the boxes totally damaged.

The worst-affected are the ones living in North-24 Parganas, South-24 Parganas and Nadia. The farmers (beekeepers) there have lost their livelihood," Halder told PTI.

A preliminary assessment suggested that losses could mount up to Rs 14 lakh in each of the North- and South-24 Parganas districts. In Nadia, the amount could be anything above Rs 10 lakh, he said.

Other than these three districts, beekeepers in Murshidabad and Purba Medinipore have also suffered losses.

Bengal produces an annual he said. 25,000MT of honey -- 5,000MT alone come from the Sunderbans in South 24 Parganas.

In the norther part of the state, beekeeping is popular in Uttar Dinajpur, Dakshin Dinajpur and Malda.

"We have been reeling under financial crisis since March, when the lockdown was imposed, as none of us could tend to the farms or sell the produce. The cyclone added to our woes. There is no proper market in Bengal to sell our products. We depend on private agencies for survival. As of now, beekeepers are in need of some financial aid to tide over this crisis,'

Seeking help, the association has written to Khadi & Village Industries Commission.

"We have written to KVIC for immediate help... I've personally sent a mail to them giving them the details of the damages and the current situation. We are waiting for a reply," Halder said.

The KVIC, under the Union MSME ministry, had been playing a significant role in protecting the pollinators and training people to become beekeepers.

State forest minister Rajib Banerjee, when contacted, told PTI that the government is planning to purchase honey directly from the beekeepers and steps have been initiated

"We have decided to purchase honey directly from the beekeepers. I hope this decision benefits them. We have already made progress in this matter," Banerjee said.

The association secretary, however, said no such approach has been made by the state so far.

"I haven't heard of any such initiative. None of us was contacted by the government. Had it been so, some of us at least would've known," Halder add-

RANCHI, JUN 15 (PTI): An elderly person died of COVID-19 in Jharkhand on Monday, raising the toll of coronavirus fatalities in the state to nine, while 30 more people tested positive, a state government bulletin said.

A total of 1,793 people have so far tested positive for the disease in Jharkhand, of which 784 are active cases, it said, adding 1,000 patients have recovered and been discharged from hospitals. With 198 active cas-

es, East Singhbhum district tops the COVID-19 list followed by Simdega district at 146. Jharkhand's mortali-

ty rate stood at 0.50 per cent as compared to that of the country at 2.86 per cent, the bulletin said.

Earlier in the day, Principal Secretary (Health), Nitin Madan Kulkarni, said a health check-up programme will be

launched in rural and urban areas of the state from June 18.

Meanwhile, officials said over 6.89 lakh people, including around five lakh migrant labourers, have returned to Jharkhand by different mode of transport since May 1.

On June 17, 76 people will be brought back from Bangladesh, Chief Nodal Officer (COVID-19) Amrendra Pratap Singh told reporters here.

"Seventeen others will travel by road from Bhutan," he added.

### 2 fresh COVID-19 cases in Nagaland; count rises to 179

KOHIMA, JUN 16 (PTI): Nagaland reported two new COVID-19 cases, taking the tally to 179 on Tuesday, Health and Family Welfare minister S Pangnyu Phom said.

Both the patients are from Kohima quarantine centre, he said.

The number of active cases in the state now stands at 79 while 100 persons have recovered, the minister said.

A district-wise breakup shows that Dimapur accounted for the highest number of 126 coronavirus positive cases, followed by 31 in Kohima, 9 in Mon, 8 in Peren and 5 in Tuensang.

The remaining six

districts have reported no COVID-19 cases so far. Eighty-five patients have so far recovered in

Dimapur, 10 in Kohima and 5 in Tuensang. According to data provided by the Health

and Family Welfare department, over 7,000 samples have been tested in the state till now. Chief Minister

Neiphiu Rio had said on Monday that from a state with no testing facility, Nagaland now has the capacity of analysing 600 samples per day.

The only BSL-3 laboratory at Naga Hospital Authority Kohima was conducting coronavirus tests and 20 TrueNat machines have been installed in other districts for the purpose,

About 470 tests have been done by TrueNat machines and all the samples vielded negative results, the chief minister

With the installation of more TrueNat machines, the testing capacity of the state is expected to double by next week, he said.

As part of its efforts to ramp up the testing capacity, the Indian Council of Medical Research (ICMR) had approved the use of TrueNat system for conducting coronavirus tests.

# 3.75 lakh migrants have returned to Chhattisgarh: Govt



RAIPUR, JUN 16 (PTI): Nearly 3.75 lakh migrant workers and others from Chhattisgarh, who were stranded in various parts of the country due to the lockdown, have returned to their home state so far, a government official said on Tuesday.

Of these, 1,06,928 migrant workers returned by 78 Shramik Special trains, the others returned by various other modes of transport and some even walked back home, he said.

The first Shramik Special train arrived in the state on May 10.

"Altogether, 3.75 lakh labourers and other people from Chhattisgarh who were stranded in

various parts of the country have safely returned by trains, buses and other modes of transport, the official said. The state government

has spent Rs 4.16 crore on the transportation of migrants by trains and buses, he said. government The

sanctioned Rs 75 crore to the health department and Rs 18.20 crore to the revenue and disaster management department for providing facilities to labourers, the official said.


State Labour Minister Shivkumar Dahariya said ration and monetary relief are being provided to workers by constituting teams of the departmen-

# Reaction to the powerbroker behind Fury v Joshua is a mirror to boxing itself **IONATHAN LIEW** LONDON, 16 [THEGUARDIAN]:

footage is horrible, harrowing, traumatic. All the same, you can't look away. The scene is the Regency hotel in Dublin in February 2016, the event a nondescript weigh-in before the big fight the following night. There's terrible rock music playing. A couple of gormless-looking bald men standing on the podium bearing clipboards. A local cruiserweight called Gary Sweeney steps on to the scales in blue Superman briefs. The gormless bald men peer forward and write on their clipboards. Sweeney steps aside. All of a sudden, we hear the whip-crack of an assault rifle.

At which point, a lot of things happen at once. There's breaking glass, chairs being overturned. We see a blurred Sweeney, still in his briefs, desperately fleeing for safety through a side door. Through the poppop of bullets and the din of grown men shouting, a single piercing child's voice: "Daddy, what was that?" Within minutes the gunmen have departed, leaving one man dead and two wounded. But the main target of the attack, according to Irish police, has already left the building. Daniel Kinahan will live to fight another day. For many, the first

time they will have heard Kinahan's name was last week, when Tyson Fury name-checked him three times in a video announcing an agreement to fight Anthony Joshua in 2021. If made, it will be one of the biggest fights in British boxing history. Yet for now, much of the attention has been fixed on the man who has helped to arrange it. The Criminal Assets Bureau in Ireland has said that Kinahan "controlled and managed" the operations of the family syndicate, and "has associations that facilitate international criminal activity in Europe, Asia, the Middle East and South America". A 2019 Europol report describes the Kinahan gang as "an organised crime group" and "key players in the drug trade". Kinahan, for his part, describes himself as "just an Irish businessman". He has never been convicted of a crime.

A question, if you're a boxing lover: how does all this make you feel? Depressed? Repulsed? Vaguely enthralled? There's no right or wrong answer to this question, by the way. Some fans are simply delighted the fight is being set up. Others are ripping up their metaphorical season tickets and vowing never to watch the sport again. In many ways, the reaction to Kinahan's brokering of Fury v Joshua serves as a mirror to boxing itself: a game that bombastically likes to think of itself as a struggle between the forces of eternal darkness and eternal light.

The truth is that both come from the same place and the first thing to observe is that this does not smell like your usual PR spiel.

# Pep Guardiola's Manchester City braced for a defining few weeks

**JAMIE JACKSON** LONDON, 16 [THEGUARDIAN]: When Arsenal are welcomed to an empty Etihad Stadium on Wednesday the Pep Guardiola era at Manchester City enters four weeks that could prove to be both seismic and defining.

Lose against an Arsenal side managed by Guardiola's former assistant Mikel Arteta and Liverpool can dethrone City by winning at Everton on Sunday. Lose an appeal against their two-year Champions League ban when the verdict is announced in the first half of next month and Guardiola may lose his best player, Kevin De Bruyne - and others.

Factor in Guardiola having a new assistant, Juanma Lillo, in place, and the club's all-time top scorer, Sergio Agüero, turning 32 at the start of this month - plus the departure of a football genius, David Silva, when the season finally ends - and the sense is of the supreme side of the past two years becoming one in transition.

The loss of De Bruyne could be a game-changer. In words that surely chilled Guardiola and all City supporters, the Belgian playmaker suggested in May that if the court of arbitration for sport upholds the ban in full he will seek a transfer, adding that if it is reduced to one year he still "might see" about his future.

The fading of David



Silva in recent seasons has barely registered because of De Bruyne's excellence. This is a midfielder with 16 league assists who needs four more to equal Thierry Henry's record total, as he aims to head the chart for a fourth time.

Should De Bruyne decide to go it could represent an unwanted triple-whammy. Guardiola would lose his star player; soul-searching from other lead acts regarding a Champions Leaguefree zone until 2022-23 may occur, and a De Bruyne-less City would be even less appealing for players the manager wants to attract.

Lillo's appointment also intrigues. When Guardiola hired Arteta in the summer of 2016 he put in place a 34-yearold who had just retired from playing, with 11 vears in English football on his CV. He knew its players, managers, coaches, stadiums and media: in short, the complete culture, and so

Just as fundamental was the Arteta's willingness to be more than a sounding board: instead, he was the sole member of the coaching staff who offered a firm opinion on any tactical or strategic matter, even if this ran counter to his boss.

All of this underlines how vital Arteta was to Guardiola and to City claiming six of the past seven domestic trophies, a sequence that included a record-breaking 100-point 2017-18 title

win, and last season's 98-point triumph as the club became the first for a decade to seal consecutive crowns.

Lillo, Guardiola may have made as shrewd a choice. The 54-year-old coached the City manager towards the end of his playing career, at Dorados de Sinaloa in Mexico, and Guardiola considers as his mentor a man who at 29 was La Liga's youngest manager and who has held 19 previous coach-

But given the packed schedule City are about to embark upon – 10 league games plus at least one match in the FA Cup and one Champions League outing - and his zero knowledge of working in England, whether Lillo can be as valuable as Arteta, in the short or long term, remains to be seen.

Before the season was suspended City were in fine form: losing only one of their last six matches while winning the rest, including an impressive 2-1 Champions League last-16 opening leg victory at Real Madrid. Yet the sole reverse was in the last of these games: a concerning 2-0 defeat at Manchester United in which they were oddly toothless and Guardiola lacked his usual in-game answers to the home team's rapid attacking.

The manager has Leroy Sané available again for the first time since

Roberts resigns as Cricket Australia CEO, Hockley given interim charge

Melbourne, Jun 16 (PTI): Cricket Australia CEO Kevin Roberts resigned on Tuesday and was replaced by T20 World Cup chief executive Nick Hockley in an interim role, the change coming at a time when the Board is under severe financial stress due to the COVID-19 pandemic.

CA chairman Earl Eddings announced the decision via live stream, saying the Board needed fresh leadership to move on from the disruption that engulfed the organisation in the past few months.

"The CA Board has accepted his resignation and announced the appointment of Nick Hockley, currently Chief Executive of the ICC T20 World Cup, as Interim Chief Executive, effective immediately," the CA said in a statement.

The leadership change comes ahead of an operational reset for the organisation to be detailed later in the week.

"Cricket, like all national sports, has been going through a period of significant change and in recent months we have had the added uncertainty delivered by COVID-19," Eddings said in the statement.

"The entire cricket community has been affected and difficult decisions have been and will continue to be necessary to ensure that cricket at every level is in the best shape it can be now and in the future."

Eddings thanked Roberts for his service to cricket during his eight years at CA, initially as a board member and more recently as Chief Execu-

"Kevin has worked tirelessly since taking on the role in difficult circumstances in 2018, and particularly during the challenges of the past few months," Eddings said. "He is a man of principle who has always put the best interests of cricket first. We wish him all the best for his future."

Roberts, who had been appointed on a three-year term to replace James Sutherland in October 2018, leaves his post after just 20 months at the helm. He had taken over when Australian cricket was still grappling with the aftermath of the ball-tampering scandal in South Africa in 2018.

The 47-year-old was contracted until the end of 2021 but has fallen out of favour with the CA board. Roberts was among the first to say that the fate of the T20 World Cup in October-November uncertain due to the pandemic, leading to intense speculation on whether the event will go ahead. However, the ICC has held back on taking a final call and the chances of the tournament happening have increased because of Australia's success in flattening the infection curve.

Roberts said: "It's been a privilege to lead and serve the sport I love as CEO of Cricket Australia... I'm proud of what we've achieved together. As a lifelong and passionate member of the cricket community, I look forward to seeing the game thrive into the future."

KARACHI, JUN 16 (PTI): The Pakistan Cricket Board will not allow players and officials touring England next month to take their families with them due to the precautions being taken to tackle the COVID-19 threat. The English Crick-

"The board has made it clear to players their families can't travel with them and also explained to them it would be of no use even if their families reached and staved in England separately. The team will be competing in a three-Test and three-T20 series starting July 30 in a bio-secure environment owing to the threat posed by the COVID-19 pandemic.

"...this time the board has told the players that as soon as they reach England they will spend around 14 days in quarantine in Birmingham before they move on to Manchester after staying in isolation and in a bio-secure environment for around three to four weeks for their practice and training," he said.

The source said that the total restriction on families travelling with the players was the main reason for batsman Haris Sohail pulling out of the

During the 2015 World Cup, Haris claimed to have spotted a ghost in his hotel room in New Zealand after which the board allowed him special permission to have his wife accompany him on every foreign tour as he was not comfortable travelling or staying alone.

But this time, due to the new restrictions Haris was told his wife can't accompany him after he decided to opt out of the long tour.

The PCB on Monday got the clearance from its patron in chief, Prime Minister Imran Khan, to go ahead with the tour which the ECB sees as essential to avoid a huge loss during the pandemic.

#### US considers withholding aid to Jordan to force extradition

WASHINGTON, JUN 16 (AP): The Trump administration is considering withholding aid to one of its closest Arab partners, Jordan, in a bid to secure the extradition of a woman convicted in Israel of a 2001 bombing that killed 15 people, including two American citizens.

The administration says it's weighing all options to press Jordan to extradite Ahlam Aref Ahmad Al-Tamimi, who is wanted by the US on a charge of conspiring to use a weapon of mass destruction against American nationals.

The charge was filed under seal in 2013 and announced by the Justice Department four years later.

The extradition issue is likely to be raised this week when Jordan's King Abdullah II speaks to several congressional committees to voice his opposition to Israel's plans to annex portions of the West Bank.

Al-Tamimi is on the FBI's list of most wanted terrorists for her role in the suicide bombing at a crowded Jerusalem piz-

It was one of the deadliest attacks during the second Palestinian uprising.

She has lived freely in Iordan since Israel released her in a 2011 prisoner swap with the militant group Hamas.

Jordanian authorities have rebuffed US requests to turn her over, despite an extradition

Jordan has a large Palestinian population and it's unclear if a threat over aid would cause it to rethink its position.

Ahead of King Abdullah's video congressional appearances, scheduled for Wednesday with the Senate Foreign Relations and House Foreign Affairs committees, the State Department said that billions of dollars of foreign assistance to Iordan could be used as leverage to get Jordanian authorities to extradite al-Tamimi.

The threat came in written answers submitted by the administration's nominee to be the next US ambassador to Jordan, Henry Wooster, to the Senate Foreign Relations Committee in response to questions posed by Sen. Ted Cruz, R-Texas.

The United States has multiple options and different types of leverage to secure Ahlam Aref Ahmad Al-Tamimi's extradition, Wooster wrote. We will continue to engage Jordanian officials at all levels not only on this issue, but also on the extradition treaty more broadly. US generosity to Jordan in Foreign Military Financing as well as economic support and other assistance is carefully calibrated to protect and advance the range of US interests in Jordan and in the region.

The coronavirus out-**■** break has exposed existing inequalities but without reform, argues Nobel prize-winning economist Angus Deaton, it also risks making them much worse.

In an interview with AFP, the Scottish-born Princeton professor called for changes to the US healthcare system and the power of the country's big tech firms.

"Someone compared the pandemics to an X-ray machine that makes the inequalities already there much more transparent," the 75-year-old said.

"The educated people, most of us have jobs we can continue to do almost the same way, we talk to people on Zoom and we get paid just the same.'

But those with less formal education are often "essential workers (who) risk their lives with COVID. Or if they are in non-essential things, they might lose their jobs".

In the United States, death rates have risen for those without a university degree and are going down for those with one, he says.

In addition, "mortality rates from COVID are much higher for African Americans than they are for whites".

He said these factors could not have predicted the wave of protests that have swept the US following the death of George Floyd.

"And they cannot pay these bills -- even people who have insurance, because often insurance has huge deductibles."

Asked what could replace the US system, Deaton rolled off a list that includes the French, Canadian, German, Dutch and Swiss models.

"Anything is better than pretending that the market can deliver healthcare -- because it can't," he said.

"All you get is this enormous conspiracy to sort of transfer money from ordinary people to much better-off people.

"It's been a major destroyer of jobs and a major source of inequality."

He added: "The stumbling block for better welfare state in America has often been race, and maybe what's happening now will change that."

However, Deaton is not optimistic: "The most likely thing it that it will end up the same as it was."

The global outbreak has paralysed many economies, although reopenings and government aid in the United States are credited with lowering the unemployment rate to a still-high 13.3 percent.

"I'm worried that unemployment will last for a very long time, that this will strengthen the share of capital relative to GDP," Deaton said.

"I'm really worried that big tech firms are going to prosper while many other businesses go bankrupt."

And he warned: "If you have more monopolistic firms, that's a recipe for GDP to be distributed towards capitalists."

Deaton warned that reform was needed to break up the big tech companies -- along with reform in other areas, such as improving policing in inner cities.

"Unless the system breaks and you get major reform I think all of this, I think all the indicators turn towards making inequalities worse," he said.

### Obama to join Biden for first joint virtual fundraiser next week



WASHINGTON, JUN 16 (PTI): Democratic presidential nominee Joe Biden has announced that he will be joined by his "friend" and former US president Barack Obama for the first virtual fundraiser next week.

Biden's campaign announced the reunion of Obama and his former vice president for the fundraiser will be a week from Tuesday.

In a tweet, Biden, 78, announced that his "former boss" Obama would join him next week.

"Folks, I've got some big news: Next week, I'm getting together with my friend and former boss. President Barack Obama, for a virtual grassroots fundraiser. We would love to see you there," Biden said on Monday.

The tweet came hours after the former vice president announced to have raised USD 80.8 millions in the month of May for his campaign war chest. "I'm proud to an-

nounce that last month - with your support - and the support of so many others - we raised USD 80.8 million, with an average online donation of USD 30 to our campaign," Biden said in an email to his supporters.

"These last few weeks have shown that we are a nation furious at injustice. We feel it in our bones; we see it in our streets. On top of that, COVID-19 is still a threat. We've crossed the mark of over 115,000 deaths -115,000 people whose lives were cut down too soon," he said.

The event plans to target tens of thousands of small-dollar donors.

In a fundraising email to the campaign, Obama described this as the most important election of the lifetime.

In November, we have the chance to rebuild our economy so that it works for everyone. We have the chance to cover everybody with health insurance,' Obama said.

The former president officially endorsed Biden in April after Senator Bernie Sanders, Biden's last serious competitor. dropped out and threw his support behind the former Delaware senator.

"We have the chance to declare that no matter what we look like, where we come from, or who we love - all of us are equal and each of us should have the chance to make of our lives what we will." Obama said.

"This is a critical moment in our history - and we need Americans of all backgrounds and political stripes to join together and fight to create a more just, more generous, more democratic America where everybody has a fair shot at opportunity," he said.

Meanwhile, Biden Victory Fund held a virtual fundraiser with Biden hosted by Senator Elizabeth Warren, Paul Egerman, a retired software entrepreneur, and Shanti Fry, a board member for the National Center for Learning Dis-

abilities. The fundraiser hosted by Warren was sold out, and brought in USD 6 million, the most successful fundraiser the Biden Victory Fund has

# North Korea blows up inter-Korean liaison office near border with South

Torth Korea blew up **IV** an inter-Korean liaison office on its side of the border on Tuesday, after days of increasingly virulent rhetoric from Pyongyang.

The demolition came after Kim Yo Jong -- the powerful sister of North Korean leader Kim Jong Un -- said at the weekend the "useless north-south joint liaison office" would soon be seen "completely collapsed".

Footage of the explosion released by Seoul's presidential Blue House showed a blast rolling across several buildings just across the border in Kaesong, with a nearby tower partially collapsing as clouds of smoke rose into the sky.

Analysts say Pyongyang may be seeking to manufacture a crisis to increase pressure on Seoul while nuclear negotiations with Washington are at a standstill.

After an emergency meeting, the National Security Council said it would "react strongly" if Pyongyang "continues to take steps that aggravate the situation".

"All responsibility for repercussions stemming from this action falls squarely on the North," it added.

The liaison office -in a dormant industrial zone where Southern companies once employed Northern workers -- was opened in September 2018, days before the South's President Moon Jae-in flew to Pyongyang for his third summit with

tioned at the office during subsequent months.

But inter-Korean relations soured following the collapse of the Hanoi summit between Kim and US President Donald Trump in February last year over sanctions relief and what the North would be willing to give up in return.

Operations at the office were suspended in January because of the coronavirus pandemic.

And since early June, North Korea has issued a series of vitriolic condemnations of the South over activists sending anti-Pyongyang leaflets over the border -- something defectors do on a regular basis.

Pyongyang's official Korean Central News Agency said Tuesday the liaison office's destruction was in line with "the mindset of the enraged Around 20 officials people to surely force hufrom each side were sta- man scum and those who have sheltered the scum to pay dearly for their crimes".

Last week Pyongyang announced it was severing all official communication links with Seoul.

"North Korea has started a provocation cycle with stages of escalation," said Leif-Eric Easlev, a professor at Ewha University in Seoul, calling the destruction of the office "a symbolic blow to inter-Korean reconciliation and cooperation".

"The Kim regime is also signalling the United States won't have the luxury of keeping North Korea on the back-burner for the remainder of the year," he added.

**Pyongyang** Since condemned the leaflet launches -- usually attached to hot air balloons or floated in bottles -- the Unification ministry has filed a police complaint against two defector groups and warned of a "thorough crackdown" against activists.

On Monday, the left-leaning Moon urged the North not to "close the window of dialogue".

The two Koreas remain technically at war after Korean War hostilities ended with an armistice in 1953 that was never replaced with a peace treaty.

Last week the North criticised Trump in a stinging denunciation of the US on the second anniversary of the Singapore summit, with its foreign minister Ri Son Gwon accusing Washington of seeking regime change.

### Pakistan does not meet minimum requirements of fiscal transparency: US report

WASHINGTON, JUN 16 (PTI): Pakistan does not meet the minimum requirement of fiscal transparency, an official US report has said, alleging that the country did not adequately disclose all government-guaranteed debt obligations, including financing to stateowned enterprises for the projects under the USD 60 billion China-Pakistan

Economic Corridor. The CPEC is a planned network of roads, railways, and energy projects linking China's resource-rich Xinjiang Uyghur Autonomous Region with Pakistan's strategic Gwadar Port on the Arabian Sea.

Launched in 2015 when Chinese President Xi Jinping visited Pakistan, it is the flagship project of Xi's ambitious multi-billion Belt and Road Initiative (BRI).

In its annual "2020 Fiscal Transparency Report" issued on Monday, the US State Department said Pakistan was one of the countries that made no significant progress in meeting the minimum requirements of fiscal transparency.

Bangladesh is the other country from south Asia to figure in the list that also includes Saudi Arabia, Sudan, and China. In the report, the state

department concluded that of the 141 countries evaluated, 76, including India, met the minimum requirements of fiscal transparency. "Two governments, Samoa and Togo, met minimum requirements in 2020 after not meeting minimum requirements in 2019. Sixty-five governments did not meet the minimum requirements of fiscal transparency. Of these 65, however, 14 governments made significant progress toward meeting the mini-

mum requirements of fis-

cal transparency," it said.

During the review period, the government of Pakistan made its executive budget proposal, enacted a budget, and endof-year report widely and easily accessible to the general public, including online. The government published limited information on debt obligations, the report said.

"The government did not adequately disclose all government and government-guaranteed debt obligations, including financing to state-owned enterprises for China-Pakistan Economic Corridor (CPEC) Projects," it added.


