Covid claims 5 more in Sikkim, week's toll 12 in six days

SUMMIT REPORT GANGTOK, 30 JUL:

Cikkim's COVID death toll Oclimbed to 342 with five more COVID fatalities reported in the last 24 hours. With the four lives lost to the virus yesterday, one of them a month-old baby with congenital complications, a 29 year old, a 42 year old and an 84 year old, the State has lost nine to Covid in two days. The week's count [[25-30 July] stands at 12. By comparison, the previous week [18-24 July] had seen 9 Covid deaths.

Out of five new COVID deaths. three were reported from STNM Hospital and two from Central Referral Hospital.

Meanwhile, 179 more tested positive for Covid in the testing of 1,487 samples on Thursday giving the state a daily test positivity rate

Out these new cases, 65 were

registered in East District, 34 in West District, 79 in South District and 01 in North District.

On the other hand, the state's figure of recovered cases further improved to 22,398 with the discharge of 169 persons from home and facility

isolation on Thursday.

As per the Daily Report of COVID-19 in Sikkim released by the Integrated Disease Surveillance Programme of the Health Department, 95 new cases were detected in RT-PCR testing of 700 samples and 84 in rapid antigen testing of 783 samples.

The state's tally of confirmed

cases of COVID-19 has now

reached 26,311. There are currently 3,302 active Covid cases in Sikkim, of whom only 107 are in hospital with symptoms severe enough to require medical attention while the rest are recovering in home or facility isolation. The 107 include 20 who were hospitalized today and the 10 currently in ICU.

HYDERABAD, JUL 30 (PTI): Adding more quality to a youthful contingent, Indian Super League side Hyderabad FC have completed the signings of defender Nim Dorjee Tamang and goalkeeper Gurmeet Singh for the long-term, the club announced on Friday.

The duo who join from North-East United have each signed three-year contracts till the end of the 2023-24 season.

A center-back who can also fill in at right-back, Nim Dorjee hails from Sikkim and started his career with Shillong Lajong where he made 45 I-League appearances, gaining valuable experience at a young age.

Nim Dorjee, who has played for the Highlanders since 2019, already has 18 ISL appearances to his name to add to two caps for the India U19s.

"I am really excited to be a part of Hyderabad FC, a team which has good young and experienced players. The club has played top-quality football last season and I am delighted to be a part of the club's journey," said the 25-year-old after completing his move.

Twenty-one-year-old meet Singh is another promising youngster who will join Manolo Marquez's side for the upcoming campaign.

A talented goalkeeper, he has spent the last three seasons with NEUFC and will look to provide more competition for a place under the bar in the first team. He featured eight times for the Highlanders last season keeping two clean sheets.

"I am grateful to the club for providing me this opportunity. As a young player, seeing others my age flourish here makes this a really important project for me," said Gurmeet.

"It is a very important season for us at Hyderabad FC. We will look to build on the campaign last season and I am sure we as a team are ready for the challenges," he added.

The duo takes the number of young Indian arrivals at the club to five following Aniket Jadhav, Aaren D'Silva and Abdul Rabeeh, and Manolo Marquez believes these additions are important for the club in the upcoming season.

"Gurmeet is a good goalkeeper, and someone who can become one of the best in India soon. He is young but has experience, is quick with his movements in goal, trains hard, and wants to improve in every session.

"Nim Dorjee is a defender who can play as a center-back or as a full-back. He also has good positioning and played at a high-level last season," said Manolo.

"As a coach, you want youngsters like these, who can play in different positions which is really crucial for us this season," he added.

Approve civic body's plan to re-vaccinate fake inoculation camp victims: High Court to Centre

MUMBAI. 30 IUL [PTI]: The Bombay High Court on Friday directed the Union government to approve the proposed plan of action of the Brihanmumbai Municipal Corporation (BMC) to re-vaccinate those citizens, who had fallen victim to several fake anti-coronavirus vaccination camps in different parts of the city a few months ago.

A bench of Chief Justice Dipankar Datta and Justice GS Kulkarni directed the Centre to approve the Mumbai civic body's plan of action, "with or without modifications, within seven days" from

The directions came after senior counsel Anil Sakhre, who appeared for the BMC, told the High Court that it had re-vaccinated 161 of the 2,053 people, who had fallen victim to such fake camps.

Mr Sakhre had told the high court earlier this month that the victims had been administered saline water instead of the anti-COVID-19 vac-

"Of the 391 cases at Hiranandani in Kandivali, 363 people were traced and 161 of them were vaccinated. We are in the process of getting the remaining of the total 2,053 victims re-registered on the CoWin portal so that they can be re-vaccinated correctly," Mr Sakhre told the court.

He submitted the civic body's plan of action that proposed, among other things, de-registering all such victims from the CoWin portal so that they can re-register on the portal afresh and get the correct vaccine administered.

Mr Sakhre said that the victims could not get re-registered without the Centre's approval.

At this, Additional Solicitor General Anil Singh, who appeared for the Union government, told the high court that although de-registeration from the portal was not possible presently, the Centre will look into it.

"For the time being, the victims can re-register on the portal for vaccination," Mr Singh said.

The Novel Coronavirus (nCoV) is new strain of Coronavirus that originated in Wuhan, China. Notorious for mutating quickly and acquiring new qualities, it is a rising epidemic that was previously not identified in humans.

Japan to widen virus emergency after record spike amid Games

Токуо, Jul 30 (AP): Japan is set to expand the coronavirus state of emergency in Tokyo to neighbouring areas and the western city of Osaka on Friday in the wake of record-breaking surge in infections while the capi-

tal hosts the Olympics. A government panel approved the plan putting Saitama, Kanagawa and Chiba, as well as Osaka, under the state of emergency from Monday until Aug. 31. The measures already in place in Tokyo and the southern island of Okinawa will be extended until the end of August.

Prime Minister Yoshihide Suga is scheduled to officially announce the measures later Friday. Five other areas, including Hokkaido, Kyoto, Hyogo and Fukuoka, will be placed under less-stringent emergency restric-

Tokyo has reported a record rise in cases for

three days in a row, including 3,865 on Thursday. The cases have doubled since last week, and officials have warned they may hit 4,500 a day within two weeks.

Officials said 2,995 were hospitalized, about half the current capacity of 6,000 beds, with some hospitals already full. More than 10,000 others were isolating at home or designated hotels, with nearly 5,600 waiting at home while health centers decide where they will be treated.

At Friday's meeting of government experts, Health Minister Norihisa Tamura said the spike in Tokyo despite being under the state of emergency for two weeks is an alarming development that is different from anything we have seen before.

Nationwide, Japan reported 10,687 confirmed cases Thursday,

exceeding 10,000 for the first time. It has recorded 15,166 fatalities from COVID-19, including 2,288 in Tokyo, since the pandemic

Japan has kept its cases and deaths lower than many other countries, but its seven-day rolling average is growing and now stands at 28 per 100,000 people nationwide and 88 per 100,000 in Tokyo, according to the Health Ministry. This compares to 18.5 in the United States, 48 in Britain and 2.8 in India, according to data from Johns Hopkins University.

The emergency measures focus on an alcohol ban at eateries and karaoke bars and their shortened hours, but they have become less effective because people are only requested to stay and work from home. Many were defying the measures at a time when the more

infectious delta strain is spreading.

Tokyo Gov Yuriko Koike noted that adults in their 30s or younger dominate recent cases and reminded them of following basic anti-virus measures including mask-wearing and avoiding having parties.

As of Thursday, 27 per cent of the Japanese population has been fully vaccinated. The percentage of the elderly who are fully vaccinated is 71.5 per cent.

Pegasus snooping scandal: Israel launches probe into allegations against NSO

JERUSALEM, JUL 30 (PTI):

Israel has launched a probe into the allegations of wrongdoing against the NSO Group in the Pegasus snooping scandal, with authorities inspecting the cybersecurity company's offices over alleged abuses of its spyware by several government clients which have raised eyebrows the world over.

Representatives several bodies visited the office of NSO to assess the allegations raised in regards to the company on Wednesday, a spokesperson for Israel's Ministry of Defence said.

When asked to share details, she told PTI that "we aren't elaborating at the moment".

Local media reports said that the bodies conducting the inspection are the Export Control Division of the Ministry of Defence and the National Security Council, which is also authorised to conduct investigations if necessary.

The focus of the investigation is to examine whether the company acted in accordance with the permits and powers granted to it by the Export Control Division of the Ministry of Defence, the

reports said. The alleged use of the Pegasus software to spy on journalists, human rights defenders, politicians and others in a number of countries, including India, triggered concerns over

issues relating to privacy. Politicians, rights activists and journalists were among those targeted with phone spyware sold to various governments by the Israeli firm, according to an international media consortium.

Amid reports of the use of spyware against French President Emmanuel Macron, Israeli Defence Minister, Benny Gantz, visited Paris on Wednesday and assured his French counterpart, Florence Parly that Jerusalem is taking the issue 'seriously"

"Minister Gantz addressed the topic of NSO and stated that Israel is taking the allegations seriously. He noted that the State of Israel approves the export of cyber products exclusively to governmental entities, for lawful use and only for the purpose of preventing and investigating crime and counter terrorism," a spokesperson for the Israeli Defence Minister said. "He also informed Minister Parly that officials visited NSO's office (Wednesday) and that Israel is investigating the allegations thoroughly", she said.

Israel last week established a committee to review the allegations of misuse of the NSO group's surveillance software and hinted at a possible "review of the whole matter of giving licences".

The defence establishment appointed a review committee made up of a number of bodies," lawmaker Ram Ben-Barak, the head of Knesset's Foreign Affairs and Defence Committee, had announced without sharing further details.

When they finish their review, we'll demand to see the results and assess whether we need to make corrections," Ben-Barak, who earlier was the former deputy head of Israel's Mossad spy agency, added.

Prepped for Disasters?

Not always all ready. And that is a worry

lacktriangleright n 2016, at around this time of the year, a cliff had collapsed in Dzongu. The bhir crumbled at a safe enough distance from the nearest habitation to ensure that no casualties occurred. It was however still close and dramatic enough to be captured on smartphones and the frightening visuals and videos were circulated widely on social media. The material loss at Mantam, a habitation of around 24 homes, was substantial. The settlement was battered by the extremely violent headwinds of the landslide, suffered through the confusion of zero visibility caused by the fine-as-talc dust kicked up by the landslide and watched Rongnyu Chu, an otherwise friendly stream, turn into 3km long lake dammed up behind a nearly 300 feet high dam of debris. The debris-dammed reservoir is still there, becoming a camping site during winters and ferocious flood-threat during monsoons. Road connectivity is still snapped at this spot, the people appear to have moved on, and repairs and rehabilitation continue to consume funds in the crores. That was then. People in the region woke up on Friday to news that mountain streams like Mam Khola, which do not even receive a second glance as people zip by on the national highway, had broken their banks and left devastation in their wake. Lives were lost, machinery pulverized and a national highway's dodgy engineering exposed.

The region has traditionally been unlucky when it comes to natural disasters, but what keeps things on as even a keel as its situation would allow is the diligence of the officers it has always had. At the end of the day, no one person or set of officers can do much after a major disaster has struck. But when they make the effort and reach affected people despite obvious dangers and difficulties, they reassure them that people matter. And for a people grappling with nature at its most fearsome, such assurances go a long way. It is in a similar context that one needs to see the rush of good Samaritans who had raced to disaster-hit places with relief materials. Even if the relief was collected without checking what the affected area really required, it was the gesture that counted. And then there was also the National Disaster Response Force which was pressed into service. They were unfamiliar with the terrain, unsure of what to do since no rescue was required and their boats unlikely to navigate the debris-heavy lake at Mantam, but seeing these men in their orange overalls busy at the site was a reassuring sight for the people there since it convinced them that they were not forgotten. But all of these were for the immediate days after the disaster.

After the adrenaline has worn off and the sympathy wave ebbed, the real task of rehabilitating and adjusting should have begun in earnest. The true mettle of the officers and the authenticity of good Samaritans gets tested then. In the Mantam incident, the number of affected people is low, so rehabilitation was never very challenging, so what remains of this space can be used to discuss the importance of disaster prevention over disaster management.

For a place which has a natural disaster for every season, the region is staggeringly casual about preventive measures. It is also very poor when it comes to mitigation. and it is thanks only to its small size and conscientious officers, that the fallouts of disasters are not much worse than what is seen. When it comes to preparation, the first requirement should be area-specific list of potential threats, preventive measures to keep those threats at bay and a checklist of things to do in worst-case-scenarios. These should be worked in detail down to the ward level, but has obviously not been done at any scale, anywhere beyond documents which speak in vague generalities. These documents should be given to village elders to draft because they know the history of natural disasters in their respective areas, still remember the traditional safeguards the communities had worked into their lifestyles, and, well, will be motivated more by the greater common good than the civil-works priorities which might influence the less public spirited consultants. That is really where Sikkim's preparation for disasters needs to begin, should have begun rather.

Male Fertility is Declining - Studies Show That Environmental Toxins Could be a Reason

In the U.S., nearly 1 in 8 couples **I** struggles with infertility. Unfortunately, physicians like me who specialize in reproductive medicine are unable to determine the cause of male infertility around 30% to 50% of the time. There is almost nothing more disheartening than telling a couple "I don't know" or "There's nothing I can do to

Upon getting this news, couple after couple asks me questions that all follow a similar line of thinking. "What about his work, his cellphone, our laptops, all these plastics? Do you think they could have contributed to this?'

What my patients are really asking me is a big question in male reproductive health: Does environmental toxicity contribute to male infertility?

MALE FERTILITY DECLINE

Infertility is defined as a couple's inability to get pregnant for one year despite regular intercourse. When this is the case, doctors evaluate both partners to determine why.

For men, the cornerstone of the fertility evaluation is semen analysis, and there are a number of ways to assess sperm. Sperm count - the total number of sperm a man produces – and sperm concentration – number of sperm per milliliter of semen - are common measures, but they aren't the best predictors of fertility. A more accurate measure looks at the total motile sperm count, which evaluates the fraction of sperm that are able to swim and move.

A wide range of factors – from obesity to hormonal imbalances to genetic diseases - can affect fertility. For many men, there are treatments that can help. But starting in the 1990s, researchers noticed a concerning trend. Even when

controlling for many of the known risk factors, male fertility appeared to have been declining for decades.

In 1992, a study found a global 50% decline in sperm counts in men over the previous 60 years. Multiple studies over subsequent years confirmed that initial finding, including a 2017 paper showing a 50% to 60% decline in sperm concentration between 1973 and 2011 in men from around the world.

These studies, though important, focused on sperm concentration or total sperm count. So in 2019, a team of researchers decided to focus on the more powerful total motile sperm count. They found that the proportion of men with a normal total motile sperm count had declined by approximately 10% over the previous 16 years.

The science is consistent: Men today produce fewer sperm than in the past, and the sperm are less healthy. The question, then, is what could be causing this decline in fertility.

ENVIRONMENTAL TOXICITY AND REPRODUCTION

Scientists have known for years that, at least in animal models, environmental toxic exposure can alter hormonal balance and throw off reproduction. Researchers can't intentionally expose human patients to harmful compounds and measure outcomes, but we can try to assess associations.

As the downward trend in male fertility emerged, I and other researchers began looking more toward chemicals in the environment for answers. This approach doesn't allow us to definitively establish which chemicals are causing the male fertility decline, but the weight of the evidence is growing.

A lot of this research focuses on endocrine disrupters, molecules that mimic the body's hormones and throw off the fragile hormonal balance of reproduction. These include substances like phthalates – better known as plasticizers – as well as pesticides, herbicides, heavy metals, toxic gases and other synthetic materials.

Plasticizers are found in most plastics - like water bottles and food containers - and exposure is associated with negative impacts on testosterone and semen health. Herbicides and pesticides abound in the food supply and some – specifically those with synthetic organic compounds that include phosphorus – are known to negatively affect

Air pollution surrounds cities, subjecting residents to particulate matter, sulfur dioxide, nitrogen oxide and other compounds that likely contribute to abnormal sperm quality. Radiation exposure from laptops, cellphones and modems has also been associated with declining sperm counts, impaired sperm motility and abnormal sperm shape. Heavy metals such as cadmium, lead and arsenic are also present in food, water and cosmetics and are also known to harm sperm health.

Endocrine-disrupting compounds and the infertility problems they cause are taking a significant toll on human physical and emotional health. And treating these harms is costly.

THE EFFECTS OF UNREGULATED **CHEMICALS**

A lot of chemicals are in use today. and tracking them all is incredibly difficult. Today, more than 80,000 chemicals are registered with the National Toxicology Program. When the program was founded in 1978, 60,000 of those were grandfathered into the program with minimal information, and nearly 2,000 new chemicals are introduced each year. Many scientists believe that

the safety testing for health and environmental risks is not strong enough and that the rapid development and introduction of new chemicals challenges the ability of organizations to test longterm risks to human health.

Current U.S. national toxicology regulations follow the principle of innocent until proved guilty and are less comprehensive and restrictive than similar regulations in Europe, for example. The World Health Organization recently identified 800 compounds capable of disrupting hormones, only a small fraction of which have been tested.

A trade group, the American Chemistry Council, says on its website that manufacturers "have the regulatory certainty they need to innovate, grow, create jobs and win in the global marketplace – at the same time that public health and the environment benefit from strong risk-based protections."

But the reality of the current regulatory system in the U.S. is that chemicals are introduced with minimal testing and taken off the market only when harm is proved. And that can take de-

Dr. Niels Skakkebaek, the lead researcher on one of the first manuscripts on decreasing sperm counts, called the male fertility decline a "wake-up call to all of us." My patients have provided a wake-up call for me that increased public awareness and advocacy are important to protect global reproductive health now and in the future. I'm not a toxicologist and can't identify the cause of the infertility trends I'm seeing, but as physician, I am concerned that too much of the burden of proof is falling on the human body and people who become my patients.

'Outing' of priest shines light on power - and partisanship - of Catholic media

It had all the hallmarks of a sensationalist tabloid

On July 21, 2021, an article appeared alleging that a senior U.S. priest, Monsignor Jeffrey Burrill, had used the hook-up app Grindr, with data from the app placing him at a number of gay bars. Burrill, the now former General Secretary of the United States Conference of Catholic Bishops, promptly resigned.

But the report was not published by an outlet that many Americans would associated with such sex "exposés." Indeed, most would have never have heard of it at all. It was The Pillar, a small newsletter founded in early 2021, that makes up just a tiny part of the Catholic media landscape in the U.S.

As a scholar of American Catholicism and culture. I take a keen interest in Catholic media. My recent book, "Follow Your Conscience: The Catholic Church and the Spirit of the Sixties," draws upon dozens of articles in the Catholic media as primary sources for historical analysis. While many Americans may be familiar with evangelical outlets like Christianity Today or the Christian Post - not to mention the hundreds of evangelical radio stations across the nation - the Catholic media seems to have less prominence on the national stage.

But as The Pillar's reporting on Burrill shows, Catholic journalism can nonetheless be influential - and can split opinion in just the same way as media with a wider audience.

A NEWSPAPER FOR EVERY DIOCESE

The Catholic mediascape is made up of a series of publications at the local, national and global level. Almost every diocese has its own newspaper that covers local events like first communions when a Catholic receives the Eucharist, the bread and wine transformed into Christ's body and blood, for the first time - or the construction of a new school gym.

But many Catholic readers also like to be informed on the bigger picture of Catholicism, and notably the Pope. In 2014, the Boston Globe, with the help of journalist John Allen, founded Crux to report on the Vatican for an American Catholic au-

Catholic journalists not only report on the church itself, they aim to offer a Catholic perspective on broader American stories. That was the founding premise behind important Catholic magazines like Commonweal, founded by laypeople in 1924, and America, a monthly publication run by Jesuits in New York City.

Increasingly, like the secular media, Catholic outlets have been polarized and drawn into the culture war. They too have taken positions that divide readers and win constituents with particular worldviews. National Catholic Reporter, in the spirit of the Second Vatican Council - the meeting of

the world's bishops 1962 to 1965 that introduced changes like Mass in the vernacular and a new respect for the religious liberty of members of other faiths – is a liberal outlet that cut its teeth on criticism of the Vietnam War and continues to promote

Its counterpart, the National Catholic Register, prefers the moral clarity and conservative positions offered by Popes like John Paul II and Benedict XIV, particularly on matters of gender, sexuality and politics. Its readers overlap with viewers of the Eternal Word Television Network, a network critical of the more liberal Pope Francis.

On the issue of homosexuality, Catholic media similarly expresses a variety of views. America magazine consistently features the writings of Father Jim Martin, a Jesuit priest who has encouraged the church to treat the gay community with more dignity. The periodical First Things, meanwhile, delights in offering readers searing critiques of secular modernity by Catholic conservative writers.

ETHICAL CONCERNS

Into this partisan media mix emerged The Pillar in 2021 and its recent report on Burrill. The investigation prompted ethical concerns over the use of data privacy - The Pillar's report relied on geolocation data from the Grindr app that it legally bought. There were also complaints that the reporting appeared to conflate Burrill's apparent homosexuality with the child abuse scandal in the Catholic church.

The ethics of The Pillar's article aside, the reporting does tap into a tradition of Catholic media shining a light on church issues and elevating it to national attention.

A generation ago, Catholic media reporting was crucial in helping expose the sexual abuse of children by priests.

On June 7, 1985, an article by investigative journalist Jason Berry in the National Catholic Reporter exposed not only the pedophilia of priest Gilbert Gauthe, but also the church's complicity to cover it up. Berry, a practicing Catholic who covered the case initially for a local Louisiana paper, detailed for a national readership how Gauthe had abused dozens of children in the Diocese of Lafayette starting in 1972. He charted the local hierarchy's efforts to keep the case out of the public eye and how church officials ignored reports of the abuse. Berry's article ran for several pages, replete with headlines like "PEDOPHILE PRIEST: STUDY IN INEPT CHURCH RESPONSE" and "MANY KNEW OF FATHER'S PROBLEM BUT NO-ONE STOPPED HIM."

The national press picked up the story only after it appeared in National Catholic Reporter.

The publication of Berry's writings on Gauthe marked the beginning of a new, vigorous mode of national criticism in the Catholic press of church hierarchy for allegedly covering up sex

abuse scandals.

REPORTING ON SCANDALS

Without journalists like Jason Berry, the exposure of the clergy abuse crisis may have played along very different lines. To put it simply, it moved the interpretation of the crisis away from a "bad apple" paradigm - it which individual priests were to blame - towards a much more systemic approach which looked at a Catholic culture that facilitates abuse.

The Pillar has tried to frame its investigation of Burrill in a similar light. It implies that Bur rill's use of hookup apps might further develop a culture of abuse in the church. The Pillar's article quotes moral theologian Father Thomas Berg and the late psychological and clergy sex abuse expert Richard Sipe, both of who argue that there is a connection between a cleric violating his vows of celibacy with other adults and a potential abuse of adolescents. The suggestion is that it encourages "networks of protection and tolerance among sexually active clerics," as The Pillar suggests.

But this argument requires a fine dance that risks falling into the trap of connecting the act of homosexuality with pedophilia. Not everybody is convinced that The Pillar's article drew this

Nonetheless, it has rekindled a debate over the role of Catholic media.

In his 1996 book, "Pedophiles and Priest," historian Philip Jenkins criticizes Berry's landmark reporting for making it appear as if everyone in Louisiana Church structure, from the bishops to fellow priests, were at fault for Gauthe's prolific abuse. Jenkins argues that the June 1985 article provided a formula for future reporting: first a journalist details some rumors, then he or she writes about how the allegations troubled parents, then the reporter mentions a transfer of a priest to a new parish and, finally, the investigator quotes an expert who comments on the structural nature of the crisis. In this way, Jenkins suggested, journalists make abuse appear more pervasive than it is. Although Jenkins book was written in the mid-1990s, his analysis, while problematic, remains important.

The abuse crisis is not the only challenge the Catholic Church faces – it is currently in the midst of struggle between conservative and more progressive elements. In tying to draw a connection between Burrill's apparent homosexuality and his potential future complicity in the clergy abuse crisis, The Pillar, one of the newest entrants in the Catholic media landscape, has waded into the church's culture war and placed itself among the outlets that will be reporting on it in the months and years to come.

Nepal's search for Covid vaccines continues, but no new deal in sight yet

ARJUN POUDEL KATHMANDU, 30 JUL [KATHMANDUPOST]: Covid-19 vaccine doses may have been trickling in lately, but Nepal's struggle to secure additional jabs is not over yet, with Health Ministry officials saying the government is ready to grab any opportunity to procure them from any company or country willing to sell the shots.

"Our efforts are on, but we have not been able to sign any new deal with any vaccine manufacturing firm or country to procure vaccines," said Dr Roshan Pokhrel, a secretary at the Ministry of Health.

Nepal so far has Covishield, the AstraZeneca type vaccine manufactured in India, Vero Cell of China's Sinopharm, and Janssen of Johnson & Johnson to inoculate its population. A majority of the doses were supplied to Nepal under grant assistance or through COVAX, an international vaccine-sharing scheme backed by the United Na-

Officials say the government is also in talks with companies like Moderna and Pfizer-BioNTech.

"There has not been any progress in buying vaccines from Pfizer-BioNTech, but we are ready to pay if the company is ready to sell," Pokhrel told the Post.

Nepal had in the third week of April, through its embassy in Washington, DC, approached Johnson & Johnson and Moderna to buy 5 million and 2 million doses, respectively. But both Ameri-



can firms had expressed their inability to supply the jabs before 2022, citing supply chain constraints.

Officials say the government has been pulling out all the stops to secure vaccines but given the shortages, pre-booking orders and supply chain constraints, it has not been able to make substantial progress. "We [the govern-

ment] had sent diplomatic notes to the governments of major vaccine producing countries like India, China, Russia, the United Kingdom and the United States to help facilitate vaccine procurement for us, saying we are ready to pay for the shots," said an official at the Health Ministry who did not wish to be named. "Several rounds of talks were also held with various firms, including Pfizer-BioNTech."

The Pfizer-BioNTech Covid-19 vaccine is an mRNA vaccine that is reported to be 95 percent laboratory-confirmed SARS-CoV-2. The double-shot vaccine has to be administered within a gap of 21 days.

The US Food and Drug Administration has even authorised the use of Pfizer vaccine on children between 12 and 15 years.

Nepal, meanwhile, has yet to roll out any plan to inoculate children aged 14 and below. The group accounts for 28 percent of the total population.

Officials say if the government procure Pfizer vaccines, they will be administered to those aged 12-18. At present only those above the age of 18 are being immunised against Covid-19.

According to the latest data from the Health Ministry, 55,904 children under 18 years have been infected with Covid-19 so far and 80 of them have died.

"A lot of countries have yet to start administering Covid-19 vaccine to children but we should focus on the adult groups first," said Upreti.

As many as 1.4 million people aged 65 and above in Nepal have not received their second shots of Covishield even though they had taken their first doses more than four months agoin the second week of March.



Gone in 6 *minutes:* Another *Olympic* heartbreak for Deepika, crashes out in quarters

TOKYO, JUL 30 (PTI): Another Olympics, another heartbreak for India's Deepika Kumari.

The world number one archer's quest for an Olympic medal ended in heartbreak for the third time as she surrendered tamely to Korean top seed An San in straight sets in the quarterfinals here on Friday.

It was all over in six minutes.

The fancied Indian misfired three 7s in a row after drilling in as many 10s in succession to snuff out any chance of a comeback after being 0-2 down in the opening set.

An, who had a perfect opening set of 30, closed it out despite shooting in the red-circle thrice in succession (7-8-9) in second and third sets.

"I am not sure what happened. I tried hard but I could not perform to my own expectations," Deepika, who shot a pathetic four 7s from seven arrows, said after her loss at the Yumenoshima

"I feel very sad, because I did well in the last two World Cups. I had high expectations but I could not start off well," she admitted.

"It was not a hard match at all, but I could not perform to my potential and she had it easy," Deepika, who lost to her in straight sets in the final of the Tokyo Test Event here two years ago, said.

Deepika's husband Atanu Das is the only Indian left in medal contention after his stunning shoot-off victory over two-time Olympic champion Oh Jin Hyek.

In his last-16 match slated on Saturday, Das will face home favourite Takaharu Furukawa, an individual silver medallist at the 2012 Olympics and a team bronze winner here.

Barring her three 10s on the trot in the opening set, there was no exceptional shooting from An, who had broken a 25-year-old Olympic record in the ranking round en route to winning two gold medals (team and mixed) in these Games.

But it was all about her Korean 'heavyweight tag' that proved to be the undoing for Deepika who came in as world number one after winning five World Cup gold medals this year.

"Rankings don't matter much in the Olympics. It happens once in four years and one bad match can cost you a medal. Every match is like a final here.'

Deepika, however, said she would keep striving for an Olympic medal.

"As I'm getting old, it's getting tougher for me every day now. But archery does not stop for me. It's the only thing I do well. So I will keep trying every time."

In the 2016 Rio Olympics, she had lost in the pre-quarterfinals, while at her maiden Olympics in London, where also she had gone as a number one ranked player, she had crashed out in the opening round.

Didn't have any strategy, just wanted to fight fearlessly: Lovlina on historic Olympic win

Токуо, Jul 30 (PTI): She delivered a thoroughly clinical performance to ensure an Olympic medal on debut but Indian boxer Lovlina Borgohain (69kg) on Friday said she stepped into the ring against former world champion Nien-Chin Chen without a concrete plan as she knew just a fearless approach would be enough.

The 23-year-old Assam boxer was smiling ear-to-ear after making the semifinals but also well aware that the task is only half done.

"Isi ladki se 4 baar haar chuki hun (I had lost to her four time earlier), all I wanted to do was prove a point to myself by being fearless against her. I was just looking for revenge," she said with a wide grin in an online media interaction.

"I enjoyed myself in this bout, khul ke khela. There was no strategy, no plan. I knew her from before, the plan wasn't even needed," she added.

"In today's bout the key was that I didn't take any pressure, it would have been counter-productive. I only tried to give my 100 per cent."

The boxer, who has matched the Olympic performance of legends Vijender Singh and M C Mary Kom, will face reigning world champi-

"I regret not being there because of training. I could give her very little time. Even today the media frenzy at my home has ensured that I have not been able to speak to my parents properly so far," she said.

A fan of Muhammad Ali and M C Mary Kom, Borgohain said, "I follow his (Ali's) footwork and long punches.

"As for Mary didi, it is an honour to be a part of the same camp, to train with her. She is an inspiration.

For the rest of her story, she said, "It is a long one, Olympic gold lene ke baad bataungi.

Lovlina Borgohain: the kick-boxer turned boxer who likes to keep it cool

NEW DELHI, JUL 30 (PTI): "Wo aaram se jeetegi, koi tension nahi hai (She will win easily, no reason to worry)," the man who first spotted the boxer in kick-boxer Lovlina Borgohain had said before her historic medal-clinching win in Tokyo Olympics.

And Sports Authority of India coach Padam Boro's assertion, while talking to PTI a day before the contest, has turned out to be prophetic.

Borgohain kept her calm to upstage former champion Nien-Chin Chen to enter the semifinals of the Tokyo Olympics, the third Indian boxer ever who will now finish on the podium at the quadrennial showpiece.

So where did the journey begin for the reticent youngster, brought up in Baro Mukhia village of Assam's Golaghat district, the home to the famous Kaziranga National Park.

For one, she had elder sisters -- Licha and Lima -- who are kick-boxers and parents who were immensely supportive of their children's sporting ambitions despite limited means.

"They backed her to the fullest, often discussed her game with me and were willing to do anything for her dreams," said Boro.

And what a dream she is living. The ever-smiling boxer is the first woman from Assam to make the Olympic boxing cut and clinch a med-

23-year-old's victory on Friday also seemed like the beginning of a new era in Indian women's boxing.

As M C Mary Kom exited the Olympics with what seemed like a terrigohain rose from relative obscurity to create the biggest moment of her career.

"She seemed to have the talent and physique to make a good boxer. We merely guided her through. What stood out about her was her calm mind even at that time. She is not the sort who gets easily ruffled, tension nahi leti hai," Boro recalled.

"She is also a very disciplined kid." It is not hard to be-

lieve that statement.

Her mother Mamoni underwent a kidney transplant last year. Borgohain visited her for a few days at that time and ended up testing positive for COVID-19 a day before she was to leave with the Olympic-qualified group for a 52-day training trip to Europe.

That exposure trip would have been crucial for her given that the pandemic had caused a shutdown all across and in India too, boxers were not allowed to spar for a while even after the camps reopened.

The fear was that the contact sport would end up causing infections among the practitioners.

It was deflating for the boxer but the government stepped in to assist Borgohain after she recovered from COVID-19, including a personalised training camp in Assam for her.

But away from her teammates, it was tough for the youngster to build up all by herself.

And it showed in the Asian Championships last month where she lost in her very first bout although the small size of the draw ensured that she still ended up with a bronze medal.

"I kept telling myself that I have to fight, that I cannot give up. But at the same time not take pressure. That would have hurt me," she said after her triumph in Tokyo while talking about the last few months.

She has also not been averse to talk about her lack of self-belief, especially after the firstround exit from the 2018 Commonwealth Games.

Khachanov advances to goldmedal match in Olympic tennis

TOKYO, JUL 30 (AP): Karen Khachanov is into the gold-medal match in tennis at the Tokyo Olympics.

The 25th-ranked Russian player beat Pablo Carreno Busta of Spain 6-3, 6-3 on Friday to reach the biggest final of his career.

Khachanov's opponent for gold will be either top-ranked Novak Djokovic or Alexander Zverev of Germany, who were next to play on another humid but overcast day at the Ariake Tennis Park.

Khachanov pushed to three sets in three of his previous four matches in Tokyo but showed no signs of fatigue against Carreno Busta, who had knocked

off second-seeded Daniil Medvedev in straight sets a day earlier.

To celebrate, Khachanov launched a ball high into the air that landed on the arena's retractable roof.

Khachanov is coming off a quarterfinal appearance at Wimbledon.

TOKYO, JUL 30 (AP): After losing to Russian swimmers in two races at the Olympics, American backstroke star Ryan Murphy said Friday that doping remains a huge problem in the sport and he wonders if all his com-

petitors are clean. Seeming to take aim at a country that has repeatedly run afoul of doping rules, Murphy revealed his frustration after taking the silver medal behind Evgeny Rylov in the 200-meter backstroke.

That came three days after Murphy who swept the backstroke events at the 2016 Rio Games settled for a bronze in the 100 back. In that race, he touched after both Rylov and another Russian, Kliment Kolesnikov.

It is a huge mental drain on me to hear I'm swimming in a race that's probably not clean, Murphy said.

That is what it is.

But later, at a news conference with fellow medalists Rylov and third-place finisher Luke Greenbank of Britain. Murphy said he was not accusing the Russian of

I need to be clear, he said.

My intention is not to make any allegations here. Congratulations to Evgeny, congratulations to Luke. They both did an incredible job. They're both very talented swimmers. They both train real hard and they've got great technique.

Rylov, who has long been one of the world's top backstrokers, denied being involved in any doping schemes.

The new revelations resulted in a four-year sanction against the country, but Russia denied any wrongdoing and the penalty was cut in half by the Court of Arbitration for Sport.

Most Russian athletes were allowed to compete at Tokyo, even though

Critics have pointed out that the punishment lacks any real bite, since Russian teams are wearing full national colors. Their flag is banned and their national anthem can't be played during medal ceremonies, but they do get music from Russian composer Tchaikovsky.

European economy grows 2%, ending double-dip recession

FRANKFURT, GERMANY (AP): Europe emerged from a double-dip recession in the second quarter with stronger than expected growth of 2.0% over the quarter before, according to official figures released Friday, as southern European economies previously hard hit by the pandemic showed surprisingly strong results.

But the economy in the 19 countries that use the euro currency still lagged pre-pandemic levels and trailed the faster recoveries in the U.S. and China, with the delta variant continuing to cast a shadow of uncertainty over the up-

The growth figure for the April-June quarter announced Thursday by the European Union's statistics agency Eurostat compared to a drop of 0.3% in the first quarter as the 19 countries that use the euro endured a double-dip recession after a rebound in mid-2020. The second-quarter growth figure was stronger than the 1.5% foreseen by market analysts.

Italy, which saw pandemic 128,000 deaths and a deep recession, was a major positive surprise, growing 2.7% as consumer spending revived. Portugal boomed with 4.9%. Meanwhile growth returned in major economies France, which grew 0.9% compared to the previous quarter, and Germany, which saw



growth of 1.5% after a sharp drop of 2.1% in the first quarter. German auto companies in particular have shown strong profits despite a shortage of semiconductor components as global auto markets recover, particularly for the higher-priced vehicles sold by Mercedes-Benz and by Volkswagen's Audi and Porsche luxury

Yet the recovery lags the one in the U.S., where the economy surpassed its pre-pandemic level during the quarter. Friday's figures leave the eurozone 3% smaller than before the virus outbreak, according to Capital Economics. China was the only major economy to continue growing during pandemic year 2020.

The stronger performance in southern Europe may be the result of stronger spending by households as restrictions are eased, said Andrew Kenningham, chief Europe economist at Capital Economics. Spain, with growth of 2.8% and consumer spending up 6.6%, both illustrated the rebound and underlined how far it has to go. Gross domestic product remains 6.8% below where it was before the pandem-

Lagging vaccinations held back the European economy in the first part of the year but have made steady progress since. Yet the spread of

more-contagious delta variant has led to predictions that it may slow, though not derail, the economic upturn. Travel and tourism, key for places like Spain and Greece, are recovering but remain

subdued.

"Given its reliance on tourism, the Spanish economy looks especially vulnerable to the delta variant that is forcing several regions in the country to impose new restrictions, while foreign governments are discouraging trips to the Iberian Peninsula," said Edoardo Campanella, economist at UniCredit Bank in Milan.

Officials figures Friday also showed eurozone unemployment at 7.7% in June, down from 8.0% in May. Inflation rose to 2.2% in July from 1.9% in June.

The eurozone economy has been sustained by government spending on pandemic relief including subsidies for companies that keep furloughed workers on the payroll. The European Central Bank is adding monetary support by keeping interest rate benchmarks at record lows and by purchasing 1.85 trillion euros (\$2.2 trillion) in government and corporate bonds through at least March 2022. That step drives down longer-term borrowing rates and helps keep credit flowing to businesses and govern-

Philippine leader recalls decision to void US security pact



MANILA, JUL 30 (AP): Philippine President Rodrigo Duterte has retracted a decision to end a key defence pact with the United States, allowing large-scale combat exercises between US and Philippine forces that at times have alarmed China to proceed.

Duterte's decision was announced Friday by Defence Secretary Delfin Lorenzana in a joint news conference with visiting US counterpart Lloyd Austin in Manila. It was a step back from the Philippine leader's stunning vow early in his term to distance himself from Washington as he tried to rebuild frayed ties with China over territorial rifts in the South China Sea.

The president decided to recall or retract the termination letter for the VFA, Lorenzana told reporters after an hourlong meeting with Austin, referring to the Visiting Forces Agreement.

There is no termination letter pending and we are back on track.

Austin thanked Duterte for the decision, which he said would further bolster the two nations' 70-year treaty alliance.

Our countries face a range of challenges, from the climate crises to the pandemic and, as we do, a strong, resilient US-Philippine alliance will remain vital to the security, stability and prosperity of the Indo-Pacific, Austin said.

A fully restored VFA will help us achieve that goal together. Terminating the pact

would have been a major blow to America's oldest alliance in Asia, as Washington squares with Beijing on a range of issues, including trade. human rights and China's behaviour in the South China Sea, which Beijing claims virtually in its entirety.

The US military presence in the region is seen as a counterbalance to China, which has used force to assert claims to vast areas of the disputed South China Sea, including the construction of artificial islands equipped with airstrips and military installations.

China has ignored a 2016 international arbitration ruling that invalidated its historic basis.

China, the Philippines, Vietnam and three other governments have been locked in the territorial standoff for decades. The U.S. doesn't take sides and insists on freedom of navigation in international waters, and doesn't recognize China's claims.

In a speech in Singapore on Tuesday, Austin said that Beijing's claim to the South China Sea has no basis in international law and treads on the sovereignty of states in the region. He said the U.S. supports the re-

gion's coastal states in upholding their rights under international law, and is committed to its defense treaty obligations with Japan and the Philippines.

Duterte notified the U.S. government in February 2020 year that the Philippines intended to abrogate the 1998 agreement, which allows large numbers of American forces to join combat training with Philippine troops and sets legal terms for their temporarv stav.

US and Philippine forces engage in about 300 activities each year, including the Balikatan, or shoulder-to-shoulder, exercises, which involve thousands of troops in land, sea and air drills that often included livefire exercises. They've often sparked China's concerns when they were held on the periphery of the sea Beijing claims as its own.

The pact's termination would have taken effect after 180 days, but Duterte has repeatedly delayed the decision. While it was pending, the US and Philippine militaries proceeded with plans for combat and disaster-response exercises but canceled larger drills last year due to the coronavirus pandemic.

The Balikatan exercises resumed last April but were considerably scaled down due to continuing COVID-19 outbreaks and lockdowns.

Hong Kong protester given 9-year term in 1st security case

Hong Kong, Jul 30 (AP): A pro-democracy protester was sentenced Friday to nine years in prison in the closely watched first prosecution under Hong Kong's national security law as the ruling Communist Party tightens control over the territory.

Tong Ying-kit, 24, was convicted of inciting secession and terrorism for driving his motorcycle into a group of police officers at a July 1, 2020, rally. He carried a flag bearing the banned slogan, "Liberate Hong Kong, revolution of our times".

President Xi Jinping's government imposed the law on the former British colony last year following protests that erupted in mid-2019. Beijing has rolled back the territory's Western-style civil liberties and tried to crush a pro-democracy movement by jailing activists. The public's role in picking Hong Kong's legislators has been reduced.

Critics accuse Beijing of violating the autonomy promised when Hong Kong returned to China in 1997 and wrecking its status as a global business centre. Human rights activists say the security law is being abused to attack legitimate dissent.

Tong's sentence was longer than the three years requested by the prosecution. He faced a

in prison.

Tong's sentence is a hammer blow to free speech and shows the law is a tool to instill terror in government critics, Amnesty International's Asia-Pacific regional director, Yamini Mishra, said in a statement.

The law lacks any exemption for legitimate expression or protest, Mishra said. "The judgment at no point considered Tong's rights to freedom of expression and protest.

Chinese officials reject the criticism and sav Beijing is restoring order and instituting security protections like those of other countries. More than 100 people have been arrested under the security law.

Defence lawyers said Tong's penalty should be light because the court hadn't found the attack was deliberate, no one was injured and the secession-related offence qualified as minor under the law.

Tong nodded but said nothing after Judge Esther Toh announced the sentence for a three-judge panel in the Hong Kong High Court. The former restaurant waiter wore a black shirt and tie with a blue blazer as he had throughout his trial.

possible maximum of life journed, a spectator yelled Executive Carrie Lam. to lead defence lawyer Clive Grossman, Mr Grossman, appeal! Another lawyer, Lawrence Lau, said Tong expressed thanks to the Hong Kong public for their support.

The judges convicted Tong on Tuesday, ruling his actions were aimed at intimidating the government and public. It said carrying the flag was an act of incitement to secession, rejecting defence arguments that Tong couldn't be proven to be inciting secession just by using the slogan.

Tong was sentenced to eight years for incitement to secession and 6 1/2 years for terrorism, with some time to be served concurrently for a total of nine years, said Toh, the judge.

Tong expressed remorse but that didn't count toward reducing his sentence because he failed to plead guilty, the judges said in a written ruling. They said he had good character and no criminal record but due to the serious offences" those would not mitigate the penalty.

The sentence reflects the abhorrence of society , the ruling said.

Tong's trial was conducted without a jury under rules that allow an exception to Hong Kong's British-style common law system if state secrets need to be protected or foreign forces are involved. The judges were picked by Hong Kong Chief

The protests began over an extradition law proposed by Lam's government and expanded to include other grievances and demands for more democracy. At their height, thousands of people held marches and rallies every weekend.

The last pro-democracy Hong Kong newspaper, Apple Daily, shut down last month after journalists and executives were arrested. Its owner, Jimmy Lai, is serving a 20-month prison term and faces charges of colluding with foreigners to endanger national security.

Also last year, Hong Kong's Legislative Council was rearranged to guarantee a majority to Beijing-allied figures. Rules for elected officials were tightened to require them to be deemed patriotic.

Last November, the remaining 15 pro-democracy legislators resigned after four were expelled for urging foreign governments to impose sanctions on China and Hong Kong over Beijing's crackdown.

The US stopped treating Hong Kong as a separate territory for trade, citing its reduced autonomy. Washington imposed travel and financial sanctions on leaders of China's ceremonial legislature. Canada, Australia and other governments suspended extradition treaties with the territory due to the security law.

Johansson sues Disney for breach of contract over 'Black Widow' release, studio fires back



LOS ANGELES, JUL 30 (PTI): Hollywood star Scarlett Johansson has sued Disney Studios for breach of contract over their decision to release Marvel Studios' "Black Widow" standalone film on Disney Plus and in theatres simultaneously.

"Black Widow", featuring Johansson as the titular superhero, released in the theatres and on Disney's streaming platform on July 9.

The film set a pandemic-era box office record with its 80 million debut in North America and earned 78 million overseas. It also made 60 million on Dis-

According to Deadline, in a lawsuit filed on Thursday in Los Angeles Superior Court, attorneys for Johansson claimed that the star's contract was breached when the studio opted not to

debut the film exclusively in theatres. The lawsuit contends that the Dis-

ney Plus release siphoned potential theatregoers, costing her potential compensation tied to the movie's theatrical revenue.

Disney intentionally induced Marvel's breach of the agreement, without justification, in order to prevent Ms. Johansson from realizing the full benefit of her bargain with Marvel, the suit reads.

The suit seeks unspecified damages and names the Walt Disney Company as the sole defen-

The Walt Disney Co. responded to Johansson's lawsuit via statement in which the studio said that the litigation showed a callous disregard to the

COVID-19 pandemic and even revealed that she has so far received USD 20 million from the project.

There is no merit whatsoever to this filing. The lawsuit is especially sad and distressing in its callous disregard for the horrific and prolonged global effects of the Covid-19 pandemic.

"Disney has fully complied with Ms Johansson's contract and furthermore, the release of 'Black Widow' on Disney+ with Premier Access has significantly enhanced her ability to earn additional compensation on top of the 20M she has received to date," a Disney spokesper-
