Onion prices continue to rule high

on quality and region. Onion prices have been on the rise for the last one month due to supply disruption from flood-affected producing states like Maharasthra. Prices have risen sharply Cooperative in the last few days due to heavy rains in the key growing states. "Centre has adequate

stock of onion and asked state governments to take as much onion they want," Consumer Affairs Minister Ram Vilas Paswan tweeted on Wednesday.

The Centre is improving supply in the domestic market by offloading its buffer stock. The buffer stock stands at about 50,000 tonnes, out of which 15,000 tonnes been released through agencies like Nafed, NCCF and Mother Dairy's Safal outlets.

Paswan said the Centre has so far released 1,850 tonnes of onion to

kg. These states will sell onion to consumers at a maximum rate of Rs 23.90/kg. "Delhi government has requested for 100 tonnes of onion per day for 5 days from 28th of September. We will provide required quantity of onion to Delhi." Paswan tweeted. The Centre is ready

to provide onion to all states as per their requirement at Rs 15.59

in the coming days.

The Centre has taken several measures to arrest the prices of onion in Delhi and other parts of the country. It is offloading onion from its buffer stock through agencies like Nafed and National Consumers' Federation of India (NCCF) discouraged exports of onion by increasing the minimum export price and has withdrawn incentives. It is also cracking down on black marketeers. At present, stored onion is being sold in most parts of the country and fresh Kharif (summer) crop will hit the markets from November onwards, traders said. They further said there is enough supply of stored onion (previous year's crop) but its transportation has been affected due to heavy rains.

Prices have also picked up on a likely fall in Kharif output owing to the lower planted area following excess rains, according to sources.

SRINAGAR, SEP 25 (PTI): Normal life remained affected in the Kashmir Valley for the 52nd consecutive day on Wednesday with public transport off the roads even as few vendors set up stalls here, officials said.

Main markets and other business establishments continued to remain closed, However, few vendors set up stalls on the TRC Chowk-Lal Chowk axis here.

Public transport was largely off the roads, even as few inter-district cabs and auto-rickshaws were seen plying in some areas of the city, the officials said.

Movement of private cars was unhindered, they added.

There was no classwork in schools as efforts of the state government to open educational institutions have not borne any fruit as parents continued to keep children at home due to apprehensions about their safety, the officials said.

Mobile services remained suspended in Kashmir except in Handwara and Kupwara areas in the north, while Internet services -- across all platforms also continued to be snapped in the valley, they said.

They said the authorities would take a call on the resumption of mobile as well as Internet services, especially leased-line and BSNL Broadband, at an appropriate time.

There are apprehensions of mobile and Internet services being misused by anti-national elements to fuel violence in the valley, they added.

The officials said there were no restrictions anywhere in the valley, but the deployment of security forces continued in vulnerable areas to maintain law and order.

Restrictions were first imposed across Kashmir on 5 August when the Centre announced its decision to abrogate Article 370 of the Constitution and bifurcate the state into two Union territories. The restrictions were lifted in phases from many parts of the valley.

Most of the top level and second rung separatist politicians have been taken into preventive custody while mainstream leaders, including two former chief ministers -- Omar Abdullah and Mehbooba Mufti, have been either detained or placed under house arrest.

Another former chief minister and sitting Lok Sabha MP from Srinagar Farooq Abdullah has been arrested under the controversial Public Safety act, a law enacted by his father and National Conference founder Sheikh Mohammad Abdullah in 1978 when he was the chief minister.

NRC becomes political hot potato in WB, Mamata claims 11 committed suicide

MIDNAPORE/KOLKATA, SEP 25 (PTI): With the NRC becoming a political hot potato in West Bengal, Chief Minister Mamata Banerjee claimed on Wednesday 11 people have committed suicide fearing loss of citizenship, while senior BJP leader Kailash Vijayvargiya asserted the exercise will be undertaken in the state but no Hindu will be deported.

Banerjee, who has often been accused by the BJP of Muslim appeasement, asked Block Development Officers and public representatives to visit every household to assuage the concerns of people about getting stripped of Indian citizenship.

BJP general secretary Vijayvargiya, however, insisted a National Register of Citizens (NRC) will be prepared in the state but no Hindu will be left out.

"So many people have died. 11 people have died so far over this NRC panic. I would ask government officials and public representatives to visit every household in their respective areas and allay public fear," she told an administrative meeting at Debra in West Midnapore district.

"There will be no NRC in Bengal," she declared.

The state's TMC government has also started issuing advertisements to television and print media asking people not to panic.

A 4-minute audio-visual clip being aired by state has been their place

local TV channels shows Banerjee asking people not to panic or be misled by "false claims" about NRC.

BJP chief Amit Shah had repeatedly said during the Lok Sabha poll campaign that the NRC exercise, which was limited to Assam, will also be extended to West Bengal.

Banerjee said her government's gramme to issue, replace and update ration cards had nothing to do with the NRC, as some people apprehended.

Though the Centre is yet to decide on whether to replicate the NRC exercise in West Bengal, large queues of people are being seen outside the offices of BDOs, borbody offices across the state for the last few days to procure documents that could prove that the

Governor attends 50th Governor's Conference Sub-Group Consultative Meeting

overnor of Sikkim, Ganga Prasad at-Utended the 50th Governor's Conference Sub-Group Consultative Meeting at Ashoka Hotel, Chanakyapuri, New Delhi today. The Sub Group on various subjects for wider consultation and submission of report was formed by Rashtrapati Bhavan through a written communique in the month of August this year. Accordingly the subjects such as Tribal Issues, Reforms in Agriculture, Jal Jeevan Mission, New Education Policy: Higher Education and Governance for 'Ease of Living' were allocated to different sub groups of Governors and Lt. Governors.

The meeting on Governance for "Ease of Living" allocated to the Sub Group of Governors, of which Governor of Sikkim is a member, is being presided by Governor of West Bengal, Jagdeep Dhankar as the Convenor of Sub Group.

Its member being Governor of Manipur, Governor of Jammu & Kashmir, Governor of Sikkim, Governor of Bihar, Governor of Nagaland, Lt. Governor of Delhi and Administrator, Union Territory of Lakshadweep with Vice Chairman and CEO of NITI Aayog as its invited participants.

Governor during his address highlighted the clarion of Sabka Saath, Sabka Vikas and Sabka Viswas given by Prime Minister, Narendra Modi towards the vision of New India to which following goals are the precursors.

- Attaining the target of 5 Trillion Dollar Economy by 2024-
- Achieving Sustainable Development Goals 2030, and
- Attaining the target of being largest economy in the world by 2047, the 100th year of Independence.

The Governor stressed on the need of multisectoral reforms and the way



the public resource is utilized in the country. These include Reforms in Allocation and Utilisation of National Resources, Reforms in Projects and Schemes of Public Welfare and Development being undertaken by Central and State Governments, Reforms in Monitoring and Evaluation of Schemes and Developmental Projects, Co-operative Federalism in letter and spirit, Electoral Reforms, Accountability and Efficiency in delivery of public services, Focus on E-Governance and Digitisation of Economy, Civil Service Reforms and also Building a Just and Law Abiding Society. Besides, the Governor also highlighted the need to improve accountability and efficiency in each rupee of the government spending.

While deliberating on the primary needs towards ease of living, Governor also submitted his suggestions on the following issues which a large segment of our population is still struggling with.

1. Ensuring basic amenities such as clean drinking water, housing and sanitation for all citizens.

2. Ensuring free delivery of services on quality health care and education for all citizens including bridging the Urban-Rural divide in the health care and education facilities.

- Concerted and concrete efforts on strengthening the public delivery system through robust implementation of E-governance and Digital India Mission.
- 4. Strengthening Road, Railway, Air and Broadband connectivity across regions, cities and villages on priority for bridging existing regional connectivity gap.
- More welfare and social security measures with focus on universal pension, nutrition, women safety, capacity building and employment and economic empowerment of differently abled and weaker section of society, strengthening social harmony and cohesion by eliminat-
- ing discrimination in the society. Extending banking facilities to all individuals and promoting saving culture by linking all small savings to life insurance directly. Simplifying Mudra Yojna for the benefit of small and marginal entrepreneurs to promote self-employment on priority.
- Ensuring public participation in all developmental and welfare schemes and following bottom up approach to developmental planning more vigorously.
- Mobilisation and involvement of citizens on issues of national importance such as water conservation, energy saving, switching over to renewable energy sources, ban on single use plastics and other environmental concerns and converting these issues into people's movement in line with Swachhta Abhiyan.

Meanwhile, SDF founder-member, BL Gurung, who quit the party today, added that more office bearers and members of the SDF party from Soreng-Chakung constituency will be resigning over the next few days.

He held forth that the party lost the last elections because of internal problems and misunderstandings in the party. He also said that the recent defection of 12 SDF MLAs was an embarrassing incident and one that had humiliated the mandate of the people and left the party supporters confused.

He also alleged that the party has failed to retrospect on the developments and this has left party workers convinced that there was virtue in remaining with the party.

want to assure all of you that NRC will be implemented but not a single Hindu will have to leave the country. Each and every Hindu will be given citizenship," he asserted.

As long as India's Prime Minister is Narendra Modi and Union Home Minister is Amit Shah, Hindu refugees have nothing to worry about, Vijayvargiya said.

"India is not a charity house that those who are the majority community in Bangladesh, Afghanistan and Pakistan (Muslims) can just infiltrate, spread terror and take away the livelihood of our citizens," the BJP's Bengal minder said.

Out of the over 19 lakh people omitted from the final NRC in Assam, which was published on August 31, about 12 lakh are Hindus. NRC was one of the provisions of the Assam Accord which was signed in 1985. The accord envisaged identification and deportation of illegal immigrants, especially Bangladeshi settlers.

"The TMC has been opposing NRC to protect Bangladeshi Muslim infiltrators who are its vote bank in West Bengal. But after many Hindus were omitted from the NRC list in Assam, it is trying to project us as anti-Hindu and an anti-refugee party," said a senior state BJP leader, who did not wish to be named.

Amit Shah is scheduled visit Kolkata on October 1 to address a seminar on NRC and the Citizenship (Amendment) Bill.





RBI rebuts social media rumours on closure of 9 banks down permanently by

MUMBAI, SEP 25 (PTI): Rebutting social media rumours swiftly, the Reserve Bank of India on Wednesday said no commercial banks are going to be shut.

Finance secretary Rajiv Kumar discribed such social media messages as "mischievous" saying the government was in process of strengthening public sector banks by infusing capital in them.

"Reports appearing in some sections of social media about the RBI closing down certain commercial banks are false," the central bank said in a statement.

Messages are circulating in various social media platforms that nine banks will be closed

the RBI and appeals being made to public to withdraw their money from them. "No question of closing any #PSB, which are articles of faith. Rather Govt is strengthening PSBs with reforms and infusion of capital to better serve its customers," Kumar said in a tweet.

The messages are being circulated a day after the RBI placed restrictions on withdrawals in the crippled Punjab & Maharashtra Cooperative Bank (PMC), thus affecting lakhs of customers.

Most of the banks named in the messages are those that have been either merged with other banks or are in the process of being merged. Last month, the government had announced that 10 public sector banks would be merged into four.

Oriental Bank of Commerce and United Bank of India will be merged with Punjab National Bank, while Syndicate Bank will become part of Canara Bank.

Andhra Bank and Corporation Bank will be merged with Union Bank of India, and Allahabad Bank with Indian Bank.

The government has already merged Dena Bank and Vijaya Bank with Bank of Baroda. Also, the IDBI Bank was taken over the public sector insurance behemoth LIC. Recently, the government announced to infuse capital into the IDBI Bank.

failed as he had been turned back from the airport by the authorities.

"I have not seen such a terror of the administration anywhere in the world. Democracy is nowhere in the state after the change in its status. It has vanished from the state," Azad said.

He claimed that the people are afraid of talking, feeling that someone was going to tip-off the government about it.

visit became possible after the Supreme Court on September 16 allowed him to tour the state.

A bench, headed by Chief Justice of India Ranjan Gogoi, had allowed the leader of the Opposition in the Rajya Sabha to visit four districts -- Srinagar, Jammu, Baramulla, Anantnag -to meet people.

The bench had been told by Azad's counsel and senior advocate A M Singhvi that the Congress leader wants to meet people and inquire about their welfare.

In his petition filed in his "personal capacity", Azad had told the Supreme Court that he had tried to visit the state thrice, but was turned back from the airport.

A number of delegations representing various sections of the society including traders, transporters and border residents met Azad at his residence here.

Azad also visited traders of Raghunath Bazar, Purani Mandi, Residency Road and other areas of the city to know about their difficulties in the prevailing situation in the state, a congress spokesman said.

NEW DELHI, SEP 25 (PTI): The HRD Ministry on Wednesday directed the National Institutes of Technology (NITs) to expedite the recruitment process after the issue of faculty shortage was

Working together versus cracking down and/or pushing back

ops, who see themselves the world over as the ucustodians of law & order and personnel ensuring security for the people, have rarely evoked confidence as such, and of late, have found themselves at the receiving end of rebuke from the very public they are paid to protect & serve. While such a situation would visit only rarely in the past, it has become worryingly frequent of late, everywhere - from streets in the US of A, to the corridors of power in Delhi to shameful investigations in UP to crackdowns in neighbouring Darjeeling and even around Sikkim on rare occasions for most lay people, but too often for addicts and peddlers. Policing is increasingly, and not always without reason, attracting allegations of atrocities, excessive use of force and over exuberant crackdowns, often even in the absence of context or necessity.

Given that the police is weighed down by a huge colonial baggage, people are the most comfortable when cops are in the background. It is when police presence is overt and overpowering, that public responses can turn disdainful and even hostile. Overt and overpowering are not always about sheer numbers and can also manifest through attitudes, and no one will contest that cops tend to swagger around with an overbearing air. Why, the moment one crosses Rangpo, anyone in uniform flaunts more pompous officiousness than can be healthy, as is suffered by travelers in the hands of that vague community police kind of force that flags down vehicles and keeps finding new ways of challaning Sikkim vehicles. While people let such attitudes slide during "normal" times, when situations turn tense, the pent up frustrations explode and the backlash can be strong. Sikkim had such a moment in the college episode some years back, but to their credit, more recently, Sikkim Police managed the pre-poll tamashas rather well, not only keeping their cool, but also keeping the peace [and sanity] despite some offensive provocation and shallow posturing.

For whatever misgivings one might have about the police in Sikkim, what one cannot ignore is the fact that the force has been diligent in its crackdown on substances of abuse. Drugs hauls are made frequently, and sometimes of mind-numbing volumes, and yet, by Sikkim Police's own admission, there remains no way of knowing whether any dent is being made in the consumption and supply network. This is because only Sikkim Police appears to be combating substance abuse here. This has to be a collaborative effort in which the society at large endorses a more intimate partnership between the police and recovering addicts in devising ways and means to tackle addiction. In the hands of the police, it becomes an exclusively a law & order matter and with NGO's it remains a social issue. Since addiction involves a crime and a victim and exacts a social cost, all these aspects need to be addressed simultaneously, and this can happen only through a collaboration. But for such a collaboration to happen, trust will have to be established. As things stand, in Sikkim, the elite don't care for the police because they can be shaken off with a phone call and the underprivileged do not care because not even genuine pleas appear to move them. To begin with, if the cops were just allowed to do their jobs without any interference, they will be able to evoke some faith among the people. Then some collaborations might become possible.

Police wields enormous power, and clearly shoulders enormous responsibilities as well; it is thus in its interest, and more so in public interest, for the personnel to be better trained and routinely briefed about their role in society. One option could be in loser community participation in the managing of neighbourhood outposts and police stations so that the police and the public learn to work together instead of, what is increasingly becoming against each other.

An increasing number of countries are banning e-cigarettes - here's why

The White House recently announced plans to **I** ban flavoured e-cigarettes − except for tobacco-flavoured products - because of a rise in the number of middle and high school students using these products.

A few days later, India's cabinet approved an emergency order banning the production, import and sale of e-cigarettes.

To date, over 20 countries, mostly in South America, the Middle East and South-East Asia, have banned the sale of e-cigarette products. Some countries have also banned possession of these products. Thailand has the strictest laws, while countries such as Australia, Canada and Norway have introduced many restrictions.

Research suggests that e-cigarettes may help smokers quit regular cigarettes benefiting their

long-term health. But young people who have never smoked traditional cigarettes are taking up e-cigarettes, which are available in over 1,500 flavours, including bubble gum and candy floss. In a survey of US youths aged 12-17, 81% of e-cigarette users reported that the first product they ever used was flavoured and that they use e-cigarettes because "they come in flavors I like".

According to the US Centers for Disease Control and Prevention (CDC) over 3.6m children in the US use e-cigarettes, with a jump of 78% (from 11.7% to 20.8%) of US high school students reporting e-cigarette use from 2017 to 2018. And in the UK, 1.6% of those aged 11-18 use e-cigarettes more than once a week, compared with 0.5% in 2015.

Because of the highly addictive nature of nicotine, there is a risk that young e-cigarette users might switch to using traditional cigarettes. Indeed, some healthcare professionals refer to e-cigarettes as a "gateway drug".

HARMFUL ENZYMES

E-cigarettes create an aerosol by heating a complex solution of chemicals, comprising oils, flavouring and nicotine. The fine particles released in the vapour are similar in size and concentration to tobacco smoke and so can reach deep into the lungs. Several of these chemicals are toxic to cells, but what makes research into their safety difficult is that each product is very different with the final composition of chemicals being determined by the temperature at which the vaping device heats them.

Researchers have found that vaping irritates and inflames the airways, leading to the production of a greater amount of mucus and an increase in tissue-degrading enzymes called proteases. High levels of proteases can destroy sensitive lung tissue and reduce the ability of our lungs to function. The resulting damage to the lungs is irreversible and over time can lead to severe lung conditions, including emphysema which is commonly found in chronic obstructive pulmonary disease (COPD). For those who already have a chronic lung disease, such as COPD or asthma, vaping has been linked to an increase in the severity of symptoms.

Another study found that proteases are stimulated by e-cigarette vapour. The vapour was prepared from different e-cigarette brands and then used to treat isolated white blood cells in the lab. Levels of the enzymes were found to be similar to or more than when the cells were exposed to an extract prepared from cigarette smoke. The increase in enzyme levels was also found with nicotine-free e-cigarette products suggesting that other components in the e-cigarette vapour were responsible.

(benzyl alcohol, benzaldehyde, vanillin) that can be toxic to the airways. Several other toxic chemicals were also found and measurable levels of tobacco-specific nitrosamines (TSNAs), an important group of carcinogens in tobacco products, were in 70% of the products tested. The effect of inhaling these complex mixtures of chemicals will be very difficult to determine.

The recent reports of deaths in the US associated with vaping fans further concerns on safety. The CDC has reported a rising number of cases (530 across 38 states) of a mysterious "lipoid" (presence of fat in the lung) pneumonia, most of which have occurred in young men who vape, and which has been linked to eight deaths. But it is worth noting that some who have developed lipoid pneumonia admitted that they vape THC (the active ingredient in cannabis), although others have insisted that they only used nicotine products with their e-cigarettes.



A recent US study, published in the American Journal of Respiratory and Critical Care Medicine, investigated the effect of chronic e-cigarette use on markers of lung injury in the airways of vapers. Proteases linked to tissue damage were increased in both smokers and vapers, compared with non-smokers.

DIFFICULT TO RESEARCH

The problem with investigating the potential harm of e-cigarettes is that there is such a vast array of products, devices and flavourings that it's impossible to create a "standardised exposure".

According to a report by the US Surgeon General, 97% of young vapers used a flavoured product in the previous 30 days. Individual e-cigarette products are reported to have over six flavouring chemicals with the sweetest flavours having a significantly higher number of compounds.

Tests of 166 e-cigarette products showed that one in five (21%) contains flavouring chemicals

One substance called vitamin E acetate has been identified in all the samples tested by New York state health officials, but there isn't enough evidence to say if this is the cause of disease. And so far, no cases of lipoid pneumonia have been reported outside the US.

The evidence to date suggests that vaping is not a safe alternative to smoking tobacco. This, coupled with the worrying trend of young, previous non-smokers being attracted to vaping, raises fears of yet another generation suffering from chronic lung disease. Indeed, a recent study in The Lancet estimates that in 2040, COPD will be the only disease in the top ten leading causes of death that will still be increasing. Although how much will be driven by vaping remains to be seen.

Four-day work week is a necessary part of human progress - here's a plan to make it happen

"We should work to live, not live to work", declared John McDonnell in his speech to Britain's Labour Party Conference. He followed this up with a commitment to the goal of a 32hour, four-day work week. The goal, McDonnell said, was to be achieved within ten years and, importantly, was to be realised with no loss of pay.

The reduction of the working week to four days would be truly transformative. It would represent a radical break with the dominant work culture that exists in our contemporary capitalist society.

Yet its radicalism also presents challenges. Will business accept a cut in the working week? What kind of legislation will be required to achieve the cut? Ultimately, can capitalism be adapted to accommodate a four-day week or will it require us to imagine - and create - a future beyond capitalism?

THE CASE FOR WORKING LESS

The arguments for working less are compelling. Shorter work hours would free up time for us to do and be things outside of work. It would enable us to live better lives.

Evidence shows how longer work hours are associated with various forms of sickness – both physical and mental. The reduction of work hours, in this case, could help to raise the health and well-being of workers.

Beyond personal benefits, we could mitigate the effects of climate change by working less. The workspend treadmill has an environmental cost that we could resolve by curbing the time we devote to work.

Less work could also pay for itself by giving rise to higher productiv-

for more productive hours and offer the opportunity to produce what we need with more free time.

Finally, we might also work better. If we eliminate hours of drudgery, we could leave more time for us to enjoy more rewarding work. Reducing working hours is as much about enhancing the quality of work as about reducing its burden.

WORK'S PERSISTENCE

But the system in which we live keeps on pressing us to work more. It was once assumed that capitalism would develop in ways that would deliver shorter work hours. Back in 1930. the economist John Maynard Keynes famously dreamed of a 15hour work week by 2030. He thought this would be achieved through no fundamental reform of capitalism.

In reality, however, hours of work in capitalist economies have remained stubbornly high and have even shown signs of increase (especially since the global financial crisis). Large differences in work hours exist between countries, to be sure. German workers enjoy shorter work hours than their US counterparts, for example.

But no country stands anywhere close to achieving a 15- or even 30hour work week in the next ten years. On current trends, most capitalist economies look set to have average working weeks more than double Keynes's prediction.

The reasons for this stagnation in work hours are varied. On the one hand, there is the issue of power. Workers cannot hope to secure shorter hours if they lack the bargaining power to realise them. The decline of

ity. Rested bodies and minds make unions and shift towards the "shareholder value model" of management, which measures a company's success by the return it brings to shareholders, has resulted in many people working longer, or the same hours, for lower pay.

On the other hand, the continued force of consumerism has acted as a prop to the work ethic. Advertising and product innovation have created a culture where longer hours have been accepted as normal, even while they have inhibited the freedom of workers to live well.

MAKING IT HAPPEN

The challenge for any political party that is committed to the goal of working less is to overcome the above obstacles. Notably, the Labour Party has rejected an economy-wide curb on work time. Instead, it favours a sector-by-sector approach, via a renewed system of collective bargaining.

McDonnell has suggested that working hours (along with wage rates and conditions) could be agreed at a sector level through negotiation between employers and trade unions. Any agreements brokered on reduced working hours could then become legally binding. This approach, in some ways, follows the lead of collective bargaining arrangements in Germany, where employers and trade unions have agreed on shorter working weeks.

The problem here will be reviving collective bargaining at a time of low union membership. Some service sectors, such as the retail and care sectors, have a very limited union presence and curbing work hours may be difficult to achieve under this policy.

McDonnell also proposed a "Working Time Commission" with the power to recommend the government increases statutory leave entitlements as quickly as possible without increasing unemployment. This is more promising in that it aims to create a new debate - and ideally a new consensus - around the case for shortening work time across the economy as a whole. One effect of this commission might be the recommendation and implementation of a four-day work week in all sectors.

A wider policy agenda for shorter work hours is outlined in a new report written by Lord Skidelsky, which was commissioned by Mc-Donnell. While there are areas to disagree on, the report itself - and Labour's commitment to this policy - mark a significant step forward in the discussion of reducing work time. Generally, there now seems greater pressure to secure a four-day or even three-day work week.

Still, the barriers to change remain formidable. As seen in the reception by industry groups to Labour's announcement, business will take some convincing about the merits of a shorter working week.

But the scepticism of business only shows how far we need to rethink the economy and life more generally. If we continue to work as long as we do, we will not just keep on damaging ourselves, but also our planet. Working less, in short, is not some luxury, but a necessary part of our progress as human beings.

NRC won't happen in Bengal: Mamata



MIDNAPORE (WB), SEP 25 (PTI): West Bengal Chief Minister Mamata Banerjee on Wednesday allayed fears among the people that NRC exercise will be carried out in the state.

There are apprehensions among a large section of the people that NRC will be carried out in the state in future. Prime Minister Narendra Modi and Union Home Minister Amit Shah had repeatedly said during the campaigning for the Lok Sabha elecimplemented in Bengal which has evidentally trigerred the fear.

Banerjee said the state government will start the process of updating digital ration cards again after the festive season and there will be new ration cards in two colours.

There will be one set of digital ration cards for people who want to keep it for identity proof, while the second set of cards in a different colour will be for those who want to avail subsidised food items and also for identity proof, she said.

Banerjee cautioned people against middlemen while updating digital ration card at government offices in the districts.

She claimed that she had reports that some of the government officers in the districts are not following the directives of the secretariat.

"I have heard allegations that some BDOs have been harassing common people and are not following directives of the state government. This can't go on," Banerjee said.

A CID probe has also been ordered into a similar fraudulent investment scam in Bengaluru Rural district by some companies and Deputy Commissioners of all districts have been asked to submit a report to the Revenue department on such "dubious companies" in three months.

"The IMA case has taken many major turns. The Revenue Department has now ordered attachment of the properties related to IMA and its group entities," Revenue Minister R Ashoka told reporters here.

He said "the government was convinced that IMA has made people believe in their business and collected money from them as investment and then did not pay them capital and profit share amount and thereby indulged in fraud.

So, in order to protect the interests of the investors, I have approved the attachment of movable and immovable properties of the company by the Revenue Department," he said.

Among the properties attached by the government were 17 in Bengaluru with a market value of Rs 21.73 crore, Demand Drafts worth Rs 8.86 crore, gold and silver ornaments and materials worth Rs 91.57 lakh and 5,880 fake gold biscuits weighing 303.07 kg.

An amount of Rs 2.85 crore cash was also seized.

The government had recently entrusted the CBI to probe the IMA scam, in which over one lakh people, mostly Muslims, were were duped.

IMA director Mohammed Mansoor Khan had allegedly duped investors, promising high returns, saying he was promoting Islamic way of investment.

Many touts and some religious preachers were also among those who lured people to invest in the IMA.

The case came to light a couple of months ago when Khan fled the country, leaving behind a video message saying he would commit suicide because of "corruption in the state and central governments".

He was later brought back to India from Dubai and is currently in judicial custody.

The IMA properties were attached under relevant sections of the 'Karnataka Protection of Interest of Depositors in Financial Establishment Act, 2004 (Karnataka Act 30 of 2005).

Ashoka said such scams were growing and the government would take 'merciless action' to put an end to 'mafia' like fake investment firms

Naming five companies involved in such fraudulent activities in Bengaluru Rural Limits, he said they had collected Rs two lakh to Rs 2.5 lakh from each investor.

The firms had promised returns of between Rs 10,000 to 25,000 each month on renting out cabs purchased in the name of investors.

As per preliminary information, about 2,000 people had invested about Rs 40 crore to 60 crore in the firms, he

Noting that the cars were not registered in the names of investors. Ashoka said....'the model of business itself looks fraudulent, aimed at duping investors and is like a blade company.

He said the police and Deputy Commissioner there have conducted an inquiry and informed them these are bogus firms.

"To stop such mafia and to protect investors, I have ordered a CID probe into the case and asked police to arrest those behind it and get the money back to investors," he said.

Deputy Commissioners of all districts have also been directed to send a report to the Principal Secretary, Revenue department, on such companies in three months, he said.

NRC will be implemented in WB: Kailash Vijayvargiya

Singh was speaking at a programme held at a party office here on Tuesday to felicitate five Congress councillors


who joined the BJP. "Congress leaders

How Ibrahimovic and Rooney became advocates for MLS players' rights

He is one of the best strikers of his generation, yet for many Zlatan Ibrahimovic is defined by what he says off the pitch rather than what he produces on it. Never before has this been truer than it is now. The Swede's hat-trick against Sporting KC last week saw him break LA Galaxy's single-season scoring record, and he now has 27 goals in 26 games. But that still doesn't do justice to the way Ibrahimovic has affected the narrative in Major League Soccer this season.

He has had his say on the league's playoff format (which he calls "shit"), the quality of his teammates (he is "a Ferrari among Fiats," apparently), his place in the pantheon of great MLS players and the league's artificial pitches. In typical fashion, there's very little that Ibrahimovic hasn't had his say on.

Ibrahimovic's criticism of MLS comes from more than a place of trademark narcissism. Wavne Rooney, the league's other globally renowned superstar, has also joined his former Manchester United teammate in exposing the league's flaws, with the DC United forward this week highlighting the gross pay disparity in North American soccer.

"I feel that American players get underpaid," said Rooney in an interview with ESPN FC. "I feel they deserve to get more money



to stay in line with football in the rest of the world but also in terms of the American sports. I'm not saying it to benefit me, I obviously won't be in the league next season. I think it's only fair to those players who are putting in the same work as all have to earn the right to earn more money for doing it."

This comes just a month after Rooney criticized the league's policy on charter flights, with MLS teams only permitted four charter flights per season (a return trip would count as two flights). "Gutted about result last night. We deserved more," he tweeted after an away defeat to the Vancouver Whitecaps last month. "Looking forward to a 12 hour travel day which could be done in six (sic) but hey this is MLS."

Rooney certainly isn't the only active player to have spoken out against the current charter flight arrangement, but the former En-

gland and Manchester United striker has the sort of audience few others in MLS have. In fact, Ibrahimovic is the only figure who can match Rooney for his clout and it feels like both players are fighting for their fellow MLS professionals.

MLS's centralized system has resulted in a culture of unwritten censorship. The league stamps the paychecks of every player, coach and member of staff at every one of MLS's 24 clubs, and many choose

feeds. Even in the way the league is covered largely by reporters on the MLS payroll, there is a soft-touch approach.

There's no suggestion that MLS itself actively enforces this culture. It is a by-product of North American soccer's structure. But this is why it's so important that the likes of Ibrahimovic and Rooney, figures with the status to be heard and quality not to be cut from the roster for causing a fuss, continue to offer their colleagues a voice. They don't have as much to lose.

Ihrahimovic Rooney's comments are particularly pertinent due to the looming collective bargaining agreement discussions in MLS. The current CBA deal expires on 31 Ian-

uary 2020 and so the league and the Major League Soccer Players Union (MLSPA) will sit down soon to start official negotiations after two years of informal talks. Many of the hot button topics have been hit by Ibrahimovic and Rooney of late. That's unlikely to be a coincidence.

Indeed, a number of players have changed their social media avatars to a graphic declaring "I much more than just Ibrahimovic and Rooney taking on MLS HQ to keep themselves amused. Alejandro Bedoya and DaMarcus Beasley have also made themselves heard on a number of issues, with the latter taking aim at the format of the MLS season. "No disrespect to MLS, but when you lose a game and you don't play well, it's like 'Eh," said the Houston Dynamo veteran. "For MLS, making the playoffs is the threshold. That's where the line is. Really? That's how it is. It shouldn't be that way."

Increasingly, it seems that MLS is at a pivotal point of its recent history. Off the field, the league continues to grapple with the implementation of its new political signage ban, with the discourse over what makes something 'political' causing strife. Regarding on the field matters, discussion over the salary cap, the Designated Player rule and the general format of MLS has never before been so highly charged.

If fundamental change does occur in MLS, the pressure from Ibrahimovic and Rooney will have played a part. Not all superstar Designated Players would feel such a sense of responsibility for a league that will likely be no more than a footnote on their shimmering resumes once they call it a day. Their impact on North American soccer won't just be quantified by the number of goals they scored.

Umesh Yadav has replaced him in the Indian squad for the three matches. Bumrah is also likely to miss the upcoming T20 and Test assignment against Bangladesh scheduled for next month.

Bumrah had been rested from the recently-concluded Twenty20 series against South Africa, which ended in a 1-1 draw.

The paceman, with a sling action, is feared for his immaculate line and length, particularly the perfectly-placed yorkers.

In the Test series against the West Indies, which was his last assignment, Bumrah emerged as the wrecker-in-chief for India with 13 wickets in two Tests.

He became the fastest Indian pacer to take 50 wickets in Tests during the course of that assignment last month.

He achieved the feat during the second Test against the Caribbean side in his 11th Test, surpassing Venkatesh Prasad and Mohammed Shami, who took 13 matches each to touch the mark.

Pakistan PM says Trump asked him to mediate with Iran

UNITED NATIONS (US) SEP 25 (AFP): Pakistani Prime Minister Imran Khan said on Tuesday Donald Trump had asked him to mediate with Iran to defuse tensions, though the US president later suggested it was Khan who approached him and nothing was final.

Khan met Trump and Iranian President Hassan Rouhani on the sidelines of this week's United Nations General Assembly, before which he visited Crown Prince Mohammed bin Salman in Saudi Arabia, whom he said had made the same request.

"Trump asked me that if we could de-escalate the situation and maybe come up with another deal," Khan told reporters at the gathering of world leaders in New York.

"Yes, we did convey this, and yes, we're trying our best," he said.

"I immediately spoke to President Rouhani yesterday after the meeting with President Trump. I can't say anything right now more than this, except that we're trying and mediating," he added.

In Saudi Arabia, which was hit earlier this month by attacks on its oil infrastructure blamed on Iran, the crown prince "also asked me to talk to the Iranian president", Khan said.

Speculation has been rife about a possible faceto-face between Trump and Rouhani on the sidelines of the general assembly, with France's Emmanuel Macron trying to broker what would be a historic meeting.

At a separate briefing to reporters where Trump spoke on Iran, he said: "They would like to negotiate. It certainly makes sense but we ha ven't agreed to that yet."

Asked about Macron's involvement, he responded: "He's also talking to us, a number of people are.

"So is Prime Minister Khan of Pakistan. A lot of people, Chancellor Merkel just now and she's very much involved, we have a lot of people involved. A lot of people would like to get us to the table." But pressed on whether he had asked Khan to get involved, Trump said: "Well, he'd like to do that and we have a very good relationship and there's a chance that that could happen.

"But no, I haven't spoken -- he actually asked me, he thought it would be a good idea to meet and we're here, we're in New York together and we have the time to do it, although we've done a lot of bilats in the last two days."

Pakistan traditionally has strong relations with Saudi Arabia but also maintains ties with Iran, with Islamabad representing Tehran's consular interests in the United States in the absence of diplomatic relations.

The leaders of France, Germany and Japan were all also meeting Rouhani and Trump at the UN in hopes of reviving diplomacy.

Greta Thunberg showed the world what it means to lead

At the 2019 annual gathering of world leaders at the United Nations, a 16-year-old climate activist took the mantle of global leadership usually reserved for the US president.

Donald Trump's decision to not participate in the UN climate summit illustrated just how devastatingly Trump's climate-denying policies have undermined America's role in the world as a force for good, and how his actions could contribute to the destruction of the futures of countless billions. Meanwhile, Greta Thunberg called him - and other world leaders - out for their malign neglect in failing to address the single most existential threat humanity faces, while revealing the energy with which a new generation of leaders is determined to act. Each year, leaders come

to New York and remind us of the promise of the United Nations – the notion that the international community can work together to solve shared challenges. The meetings can also showcase the ability of US leadership to encourage countries to tackle serious threats. These gatherings can yield genuine results - commitments to tackle a pandemic like Ebola, for instance. Whether crafting solutions to pressing challenges or inspiring the world to act, UNGA can remind us how much America can achieve when it leads and works together with partners.

Not this year. Of course, Trump's mere presence is more than enough to sap the power of American diplomacy on the world's greatest dip-



lomatic stage, and this year Trump again came ready to embarrass himself - and America - by roaming the halls of the UN reminding the public that he attempted to force the president of Ukraine into investigating Joe Biden in a move that should be worthy of a unanimous impeachment conviction.

And so, Trump refusing to participate in the UN climate summit was little surprise from a president who gutted domestic environmental protections, announced his intention to withdraw the United States from the Paris climate agreement, and is even trying to prevent California from enacting higher emissions standards for automobiles.

Enter 16-year-old Greta Thunberg. The climate activist from Sweden - who has helped spark a global movement of young people striking from school to press their leaders to urgently confront climate change – was the star of the show. Her remarks reminded us what leadership, courage and sacrifice look like.

Speaking to the assembled world leaders, Thunberg outlined the stakes of inaction on climate change and denounced the world's focus on "money and fairytales of eternal economic growth." Thunberg made clear what's coming: "You are failing us. But the young people are starting to understand your betrayal... We will not let you get away with this... The world is waking up. And change is coming, whether you like it or not."

Read all of what Thunberg said. Watch the passion and the justified anger - in how she said it. Too many of the world's leaders - political, corporate, civic – are collectively robbing the world's youth of their futures. The lack of action means that young people like her have to sacrifice, Thunberg said: "This is all wrong. I shouldn't be standing here. I should be back in school on the other side of the ocean. Yet you all come to me for hope? How dare you! You have stolen my dreams and my childhood with your empty words."

Thunberg's sacrifice couldn't find a stronger contrast than the selfishness of Trump, who only looks out for himself. His egotism was illustrated yet again when he mocked Thunberg's speech.

If politicians can't find a way to act quickly and on a scale the likes of which the world has never seen in order to mitigate the effects of climate change, the student strikes and marches will pale in comparison to what we are likely to see in the future. If entire generations know as a scientific fact that earth will, in their lifetimes, become violently inhospitable to vast swathes of humanity, what kinds of actions would we expect them to take?

Thunberg is right - change is coming. There are leaders of countries and businesses making commitments to tackle climate change. Local governments, like California, are trying to move ahead on their own when their countries abdicate their responsibility. And, as Thunberg exemplifies, younger generations are beginning to mobilize. One poll of US teenagers noted that roughly one in four people ages 13 to 17 have taken action – attended a protest, taken part in a walkout, written to an public official - to advo-

cate for change in climate policy. But time is not on our side, and the longer that the actions of Trump and other leaders defending the use of fossil fuels are allowed to stand, the more catastrophic the results will be for our children.

Tackling the climate crisis requires American leadership. America is by far the largest cumulative contributor of emissions since the industrial revolution and is currently the second largest emitter (after China). America has a responsibility to act; the worst effects of climate change cannot be averted without US action, and Americans are already feeling the pain of the climate crisis.

Furthermore, American leadership, when wielded the right way, can produce results. The United States has the unique ability to bring countries together on climate, as we saw when the US and China (the world's largest current emitter) struck a deal that created the political momentum that led to the Paris agreement.

The speech that Thunberg gave should be echoed by an American president and accompanied by sweeping actions to cut emissions. Unfortunately, right now, such an America lies dormant. In his annual UN speech, Trump yet again trumpeted his nationalist "America First" policies that do nothing but spurn the world. Trump has, for the time being, eviscerated the power of American leadership to do good.

But Greta Thunberg and her generation are ready to lead and to sacrifice. The world's youth won't accept failure – they have no choice.

Europeans see last chance for Iran-US meeting



UNITED NATIONS, SEP 25 (AFP): US President Donald Trump and his Iranian counterpart Hassan Rouhani face their last chance Wednesday for a historic meeting as European leaders raced to arrange talks aimed at defusing soaring tensions.

A meeting between arch-adversaries would be historic but also come under a political cloud, with Trump's Democratic rivals on Tuesday announcing an impeachment inquiry against him.

With world leaders gathered in New York for the annual UN General Assembly, French President Emmanuel Macron made a fresh push for Trump to meet Rouhani.

Escorting a smiling Rouhani to a meeting with British Prime Minister Boris Johnson, Macron said that time was running short. "If he leaves the coun-

try without meeting with President Trump, honestly this is a lost opportunity because he will not come back in a few months," Macron said.

"And President Trump will not go to Tehran, so they have to meet now," he said, as Johnson voiced agreement.

Macron has spearheaded efforts to arrange a historic summit, selling Trump on the idea last month as he hopes to salvage a 2015 denuclearization accord with Iran.

But tensions have flared anew after attacks this month on Saudi Arabia's oil infrastructure. The United States blamed Iran, a finding backed this week by France, Britain and Germany.

Trump earlier voiced willingness to meet Rouhani but made clear Tuesday that he would not ease economic pressure on Iran -- a condition set by Rouhani for any meeting.

"As long as Iran's behaviour menacing continues, sanctions will not be lifted. They will be tightened," a grim-faced Trump told the General Assembly.

"All nations have a duty to act. No responsible government should subsidize Iran's bloodlust," he said.

Trump is set to address a news conference on Wednesday that will no doubt be dominated by the impeachment moves

He has come under fresh fire over allegations he pressured the president of Ukraine to investigate the son of former US vice president Joe Biden, who is seeking to challenge Trump in next vear's election.

Trump last year pulled out of the nuclear agreement and imposed punishing sanctions.

Rouhani -- responding to Trump's speech in an interview with Fox News, which the tycoon president is known to watch avidly -- said that the withdrawal from the nuclear accord had badly shaken confidence.

"We must create mutual trust," Rouhani said. "If the government of the United States of America is willing to talk, it must create the needed conditions."

But German Chancellor Angela Merkel, who also called for a Rouhani-Trump meeting, said after seeing the two leaders that Iran's condition on sanctions was "unrealistic," although Macron said that "conditions have been met for a rapid resumption of negotiations."

Macron warned in a speech to the General Assembly of further risks in the Middle East, where Saudi Arabia is also mounting a devastating air campaign in Yemen.

"The risk is that there would be a flare-up based on a miscalculation or disproportionate response," Macron said.

"I am not naive and I don't believe in miracles but rather in the courage to make peace, and I believe that the United States, Iran and all signatories of this (nuclear) accord have that courage," he said.

Despite his strong words, Trump is known for his fondness of made-for-television drama, as witnessed in his three meetings with North Korean strongman Kim Jong Un, and for following last-minute gut instincts.

Pakistani Prime Minister Imran Khan said that both Trump and Saudi Crown Prince Mohammed bin Salman, whom he met on his way to New York, had asked him to mediate with Iran.

"Trump asked me if we could de-escalate the situation and maybe come up with another deal," Khan told reporters. "I can't say anything

right now more than this, except that we're trying and mediating," he added. Pakistan has a close

relationship with Saudi Arabia but also maintains ties with Iran, representing its interests in the United States.

Trump, however, said Monday that he was "not looking for any mediators," saying of Iran, "they know who to call.

More than 80 students wounded during Indonesia protest



JAKARTA, SEP 25 (AP): More than 80 students in Indonesia's capital are being treated at a hospital after clashing with police during protests sparked by a new law that critics say cripples the country's anti-corruption agency.

Officials at Jakarta's Pertamina Hospital said Wednesday that the injuries included broken bones, head wounds and respiratory problems due to tear gas.

The protests outside Parliament were dispersed just before midnight after descending into violence. By Wednesday morning, city officers were cleaning up rocks, plastic bottles, banners and other debris from the protest.

Other demonstrations were held in cities around the country.

Several student groups vowed to return to the streets Wednesday and do so until the new law is revoked. The House speaker has called on the students to stop protesting and invited them for dialogue.


