CM convenes video conference with CMOs, takes stock

GANGTOK, 31 MAR [IPR]: Chief Minister Prem Singh Tamang [Golay] convened a video-conference with Chief Medical Officers and District Medical Superintendents of all four districts at Samman Bhawan today.

During the conference, the Chief Minister took detailed stock of healthcare, status, and preparedness about COVID-19 in all four districts including all health care cen-

SC directs Centre to prevent migration, set up portal within 24 hrs for real time info NOT POLICE, BUT VOLUNTEERS SHOULD ATTEND TO STRANDED MIGRANT WORKERS

New Delhi, Mar 31 (PTI) The Supreme Court asked the Centre on Tuesday to prevent migration of people due to coronavirus and set up within 24 hours a portal for disseminating real time information on the pandemic to counter the panic be-

"Panic will destroy more lives than the virus", the top court said and asked the Centre to get trained counsellors and community leaders of all faiths to calm down the migrants, who are kept in shelter homes across the country.

ing spread through fake news.

It said these shelters should be run by volunteers and not the police, and there should be no use of force and intimida-

It asked the Centre to prevent migration of people and take care of their needs of food, shelter, nourishment and medical aid.

The Centre told the apex court that the suggestion by a petitioner to sprinkle water and chemicals on migrants to sanitise them does not work scientifically and is not the

right way.

The top court, which refused to restrain high courts from taking up the issue of migrants, said they may monitor the issue more closely.

It, however, asked the Centre to tell government lawyers to inform high courts about the orders passed by the apex

A bench of Chief Justice S A Bobde and L Nageswara Rao, which took up two PILs on the issue of migration through video conference, asked the Centre to look into the letter petitions filed by Kerala MP from Kasaragod constituency Rajmohan Unnithan and one filed by an MP from West Bengal on the issues related to coronavirus.

The bench adjourned the hearing on the PILs to April 7, asking the Centre to ensure that duties of managing the shelter homes are entrusted to volunteers and not to the police and there should not be any use of force or intimida-

Solicitor General Tushar

Mehta, appearing for Centre said that migration of people cannot be allowed at this juncture as this would enable the spread of coronavirus.

Referring to the last census, Mehta said there were about 4.14 crore persons who had migrated for work but backward migration is now happening due to coronavirus

He said the entire country was required to be locked so that people don't mix and can't meet each other and adhere to social distancing.

"We are trying to ensure that no migration is permitted," he said, adding, "It would be risky for them and for the village populations. So far, rural India is unaffected by coronavirus but there is possibility of three out of 10 moving from cities to rural areas carrying the virus.

Mehta said advisory has been issued to the states regarding complete prohibition of inter-state migration and as per the central control room, around 6,63,000 persons have been provided shelter so far.

He said that over 22,88,000 persons are being provided food as these are needy persons, migrants and daily wagers who have reached somewhere but have been stopped and kept in shelters.

The bench, initially observed "We will be passing an order that the portal for information will be set up in 24 hours. You will have to ensure that all those whose migration you have stopped are taken care of in terms of food, shelter, nourishment and medical aid. You will also follow up on those who you have identified as cases of COVID-19 and quarantined".

Mehta told the court that government would shortly implement a system where panic of migrant workers would be addressed and they would also be offered counselling.

"When will you set up the centres? Where are the counsellors coming from? Where will you get them from? Where will you send them?", the bench asked, adding, "This is

not a definite statement".

Mehta said trained counsellors of the district mental health programs would be sent to which the bench said, "There are 620 districts in India. How many counsellors do they have in total?"

"We want to impress upon you that the panic will destroy more lives than the virus. You need counsellors," the bench said, adding, "You can have 'Bhajan, Kirtan, Namaz' or whatever but you have to give strength to the people."

Mehta said the authorities would mobilise religious leaders to counsel the migrants in shelters so that they could stay calm and added, I am making a statement here that within 24 hours, we will mobilise trained counsellors and religious leaders".

The bench told Mehta that community leaders belonging to all faiths should be involved in the process so that panic could be prevented.

Mehta told the bench that a petition has been filed in the Kerala High Court regarding

migration and since the top court is seized of the issue, the other courts should not deal

"In this kind of situation, we should not stop the high courts from hearing these matters. High Courts may be able to monitor closely," the bench said, and asked Mehta to instruct government lawyers to inform all the high courts about the orders passed by the top court in the matter.

The bench, while referring to two other petitions filed before it by Parliamentarians from Kerala and West Bengal on issues related to coronavirus, asked Mehta to look into them and said there may be some good suggestions.

Regarding the shelters where these migrant workers have been kept, the bench said that authorities should entrust duties of managing them to volunteers and not to police.

"You ensure that you bring volunteers. There should not be use of force or intimidation," the bench said.

MGNREGA wages hiked by Rs 13

GANGTOK, 31 MAR (IPR): The Chief Minister's Office has issued an advisory for the payment of additional wages of Rs 13 per day to MGNRE-GA workers from the 01 Apr onwards.

Similarly, the ex gratia payment of Rs 1,000, to be made in two installments of Rs 500 each, to holders of widow, old age and disability pensions was also announced by the Government of India.

Meanwhile, the State Government had announced in the recent budget session that a sum of Rs 500 will be provided by the State in addition to the amount announced by the Central Government.

Female members of self-help groups will also be provided with an amount of Rs 1,500 in three equal installments starting 01 April. The self-help groups will also get loans of up to Rs 20 lakh without any collateral guarantees as an encouragement for them to adopt higher-income generating activities.

The Chief Minister has thanked the Union Minister for Agriculture & Farmers Welfare, Rural Development & Panchayat Raj, Narendra Singh Tomar for helping the people at the grassroots level in this hour of need.

Torrent Group commits Rs 100 Crores to fight COVID-19 pandemic

GANGTOK, 31 MAR: Pharma-giant Torrent Group today announced plans to contribute Rs 100 crores to strengthen the Union Government's efforts to fight the COVID-19 pandemic and its fallout on the poorer sections of the society.

forms that Rs 50 crore will be donated to the PM-CARES Fund while Rs 50 crore will be spent under various initiatives such as providing essential medicines to various Govt. hospitals free of cost, contributions to State Government relief funds, contributions to NGOs doing grassroots work to address

the issues arising from the COVID-19 pandemic, provision of PPEs to healthcare workers and our own direct efforts to contain the impact of the COVID-19 pandemic on the vulnerable sections of society.

The release goes on to state that the pandemic has disrupted operations at the Torrent Group's

Centre wants SC to direct media not to publish COVID-19 info without ascertaining facts with govt

New Delhi. Mar 31 (PTI): The Centre sought a direction from the Supreme Court on Tuesday that no media outlet print, publish or telecast anything on coronavirus without first ascertaining facts from the mechanism provided by the government.

It said that in an unprecedented situation of this nature, any deliberate or unintended fake or inaccurate reporting either in electronic, print, social media or web portals has a serious and inevitable potential of causing panic in large sections of the society.

Considering the very nature of the infectious disease which the world is struggling to deal with, any panic reaction by any section of the society based upon such reporting would not only be harmful for such situation but would harm the entire nation," it said.

It is, therefore, in the largest interest of justice that when this court has taken cognizance, this court is pleased to issue

a direction that no electronic/print media/ web portal or social media shall print/ publish or telecast anything without first ascertaining the true factual position from the separate mechanism provided by the Central government, said the Centre's affidavit filed in the top court. The government said

that though an act of creating panic is a criminal offence under the Disaster Management Act, 2005, appropriate direction from the top court would protect the country from any potential and inevitable consequence resulting from a false alarm having the potential of creating panic in a section of the society.

The affidavit highlighted the steps taken including social distancing and lockdown to prevent the spread of Coronavirus and sought direction to all States and Union Territories to implement all directives issued by Union of India.

It is submitted that Ministry of Home Affairs has also taken many immediate, timely, effective and proactive actions almost on daily basis. The Home Minister is personally supervising the implementation of various directives/ advisories issued by the home ministry along with the cabinet secretary and the home secretary and senior officers in the control room which is operational for

24 hours, it said. Dealing with the issue to prevent migration of workers, the Centre said that it has issued directions under the Disaster Management Act, 2005, and a 24X7 control room has been setup.

As per the details received by the Control room 21,064, relief camps have already been set up by state governments and Union Territories as per the directions of the Central government in which they are providing food, shelter and medical facilities as per the requirement of migrant workers. Around

6,66,291 persons have been provided shelter; 22,88,279 persons have been provided food, the affidavit said.

The Centre said it is, along with state governments and NGOs, religious organisations and companies, coordinating to deal with the situation of migration of workers and those en route workers are provided with all basic amenities "so that they do not penetrate into the rural area which so far has remain uninfected.

The Centre added that the present bare foot migration which has taken place consists of on a very rough estimate 5 to 6 lakhs persons across the country.

It is most important and crucial to point out at this juncture that this kind of migration by the migrant workers on their own in large numbers, defeats the very object of the preventive measures taken by the Central government, the affidavit said.

Northeast Frontier Railway to convert 315 coaches into isolation wards ifving 315 coaches for bathroom and three toi-

GUWAHATI, MAR 31 (PTI): The Northeast Frontier Railway on Tuesdav said it will convert 315 coaches into isolation wards to supplement medical requirements for treating COVID-19 patients.

The converted coaches will be equipped with basic facilities needed for isolation as per medical guidelines, Northeast Frontier Railway (NFR) Chief Public Relations Officer Subhanan Chanda said in a statement. "NFR will be modplacement in various locations. If needed, more coaches can be modified," he added.

These coaches are going to be equipped with mosquito nets, charging points for mobiles and laptop, space for paramedics among others, Chanda said.

"These coaches will be prepared zone-wise. Placement of the coaches will be notified by Railway Board in due course as per need. One Isolation coach will have nine beds, one

lets for use by patients," he added. The Indian Railways

is planning to modify 5,000 passenger coaches in the first phase to meet the requirement of any possible exigency for keeping novel coronavirus patients in isolation.

There are 125 hospitals under Indian Railways across India and more than 70 of them are being planned to be kept ready for any COVID-19 related con-

"Efforts are being made to designate dedicated Covid wards or floors in these hospitals. Approximately hospital beds are being made ready to meet the possible needs of patients," Chanda informed.

The Indian Railways has already given permission to all zones to explore possibility of hiring doctors and paramedics, and also to re-employ retired railway doctors as a temporary measure to meet the increased requirement to manage COVID-19 pandemic.

Spicelet to cut up to 30 pc salary of employees in March

MUMBAI, MAR 31 (PTI): Budget carrier SpiceJet has decided to cut up to 30 per cent salary of its employees in March with Chairman Ajay Singh opting for highest 30 per cent trimming in compensation, the airline said in an e-mail communication to the staff on Tuesday.

Moreover, the employees will also be treated as "on leave without pay" for the March 25-31 phase due to the suspension of air passenger services during the period, said the airline, which offered its aircraft and crew to the government for any "humanitarian mission" last

Significantly, the paycut announcement coincides with the termination of service contracts of over a dozen expat pilots with the airline, as per a source.

"These are extremely tough time and call for appropriate and exceptional measures to sale through the exceptional challenge. As tough as it seems, most Indian carriers have already announced a pay cut for their employees.

"Unfortunately Spice-Jet is not too immune to the situation which has unquestionably affected the airlines in the most severe form across the globe. Therefore in our bid to stay lean, and under absolutely unavoidable circumstances, we have been forced to take certain bold decisions, which will help the SpiceJet family surmount these difficult times." Human Resource department of the airline told employees in the

SpiceJet management has decided to implement a pay cut between 10-30 per cent in March across our employee base. Our Chairman and Managing Director (Ajay Singh), in fact, has opted for the highest cut of 30 per cent in compensation, SpiceJet said.

It, however, spared employees in the lowest pay grades from any pay

In an official statement later, the airline said it has implemented a 10-30 per cent pay cut for all its employees across top and mid-rung levels.

"The COVID-19 pandemic and the subsequent lockdown have forced us to take some tough measures to ensure that no one at SpiceJet is re-

trenched. What we are facing is a global phenomenon and no airline in the world is immune to the impact, Singh said in the statement.

India's aviation industry, reeling under the impact of the global outbreak of COVID-19, is seeking help from the government to mitigate the financial impact of the pandemic, SpiceJet said.

Coronavirus driven lockdown has adversely impacted the industry, leading to significant economic headwinds. Several airline companies, both in India and abroad, have been forced to undertake severe measures in their attempt to survive amidst tough market conditions, it said in the

"There are a over a dozen expat captains on the Bombardier Q400 (regional jets) fleet who have been served the termination notice," an airline source privy to development told PTI.

"SpiceJet has not sacked any pilot. We have served a one-month notice' to 13 expat Q400 captains, as per their official contract. They have also been paid a month's salary as per their con-

"We have accepted the resignation of 18 Boeing captains," a spokesperson of SpiceJet said in response to a PTI query.

Other budget carriers IndiGo and GoAir have already announced similar moves earlier.

SpiceJet, in the e-mail, also said, "unfortunately due to the lockdown, we are forced to announce 'leave without pay for employees during March 25-31, the lockdown period during which all air passenger services remained shut".

India is under a threeweek lockdown starting March 25 to curb the the virus spread.

IndiGo was the first domestic carrier to announce a 25 per cent across-the-board pay cut on March 19, and it was followed by government-owned Air India, which affected a 10 per cent cut in employees allowance to deal with the precarious finances amid coronavirus pan-

demic. IndiGo's smaller rival GoAir also announced salary cut for all its employees in March.

Goa's coronavirus testing lab develops snag on Day 1

PANAJI, MAR 31 (PTI): The coronavirus testing lab set up at Goa Medical College and Hospital failed to take off on Tuesday after it developed a snag, said Chief Minister Pramod Sawant.

He said 55 samples had to be, therefore, sent to NIV, Pune for testing.

"I will not be able to tell you what exactly went wrong but we could not get tests started. The fault will be rectified and testing is likely to begin from tomorrow," the CM said.

Goa has five COVID-19 patients as on Tuesday.

Sawant also said stickers would be placed on the doors of houses of people advised home quarantine, adding the move was not about discrimination but aware-

Sawant said Rs 120 crore of the Rs 400 crore in the Goa Iron Ore Permanent Fund would be used to fight the novel coronavirus outbreak.

He said some 7000-8000 Goans working as seafarers are stuck in foreign countries.

"We will have to solve this issue along with Union Ministry of Home Affairs and the NRI Commissioner. We have to also think on how to quarantine them when they arrive," he said.

Out of the 103 cities where air quality was recorded, 23 registered 'good' air quality while 65 others recorded satisfactory air quality, according to the data from the Central Pollution Control Board.

An AQI between 0-50 is considered good, 51-100 satisfactory, 101-200 moderate, 201-300 poor, 301-400 very poor and 401-500 severe.

Air Quality Index is assessment of the air quality by taking into account different factors. The lower the AQI the better the air is considered to be.

The national capital witnessed a slight dip in air quality after the effect of rain subsided but it remained in the satisfacto-

UP's Bulandshahr and Guwahati were the only two cities out of 103 that recorded poor air quality.

India is currently under the biggest lockdown with around 130 crore people asked to stay home in view of the coronavirus outbreak, which has claimed 29 lives and infected over 1000 people in the country.

The government has urged people to avoid unnecessary travelling, significantly reducing the traffic movement across the country.

Since the lockdown was imposed the air quality across the country has shown drastic improvement due to eradication of local pollutants generated due to construction activiites and vehicular traffic among others.

According to the Centre-run System of Air Quality and Weather Forecasting and Research (SAFAR), the impact of the measures taken due to the coronavirus outbreak has resulted in a drop in PM2.5 (fine particulate pollutant) by 30 per cent in Delhi and by 15 per cent in Ahmed-

The level of Nitrogen Oxide (NOx) pollution, which can increase the risk of respiratory conditions, has also reduced. NOx pollution is mainly caused due to a high motor vehicle traffic. In Pune, NOx pollution has reduced by 43 per cent, in Mumbai, by 38 per cent and in Ahmedabad, by 50 per cent.

Gufran Beig, a scientist at SAFAR, said generally in March, pollution is in the "moderate" category (Air Quality Index range: 100-200) while presently, it is in the "satisfactory" (AQI 50-100) or "good" (AQI 0-50) category.

Environmentalists said that though it is not the ideal way to bring down air pollution but at least it proves that such outcomes can be brought. Jyoti Pande Lavakare,

co-founder, Care for Air NGO, said the low AQI and the blue skies proved beyond doubt that a lot of the polluted air was "anthropomorphic, that is, man-made".

"Obviously, slowing down the economy to such a degree is not the ideal way to bring down air pollution, but at least it proves that it can be done. We can achieve the same outcome by doing this mindfully, using technology and

low-emission tives," she said.

Lavakare emphasised on the need to realise that air pollution weakens the lungs, so countries like India with higher pollution and lower nutrition levels will be more affected by COVID-19, and morbidity and deaths are likely to be higher.

Ravina Kohli, environmentalist and part of the #MyRightToBreathe campaign, said it was a "huge wake-up call" for governments obsessed with development at the cost of the environment.

"We, the people, are the problem. Our communication on solutions now also include how to reduce pollution at a personal level by being able to understand our behaviour and its consequences on our environment.

Lockdown Nation

This is required, but so is more informed planning

The nation is in a lockdown because Novel Coronavirus has proven to be an extremely contagious virus. It might not have been around long enough for us to understand it completely or find a cure, but the four months that it has been around have amply proven that it spread exponentially. The media-space is rife with stories of how quickly the number of infected people doubles and how quickly things can get out of hand if level-3 - community infection when even people with no travel history or direct contact with someone who has travelled from an infected region – is reached.

Given the desperate status of the public healthcare network in the country and the profiteering instincts of the private hospitals, delaying the spread of the virus was a necessary undertaking. What this "difficult" decision, however, exposed is the inadequacy of the system. The steel frame of the bureaucracy is still blundering through the crisis still caught-up in its hierarchies and red tape and the police refusing to learn any new nuances in how to handle an unprecedented situation. The address to the nation completely forgot that a million migrant workers spread across the country would be in panic and destitution, and while one understands that lockdown is necessary, the inconsistency and boorishness with which it continues to be enforced leaves on bewildered. The Centre and State Governments announce that migrant workers will be taken care of wherever they are even as they are packed into buses and trucks and ferried in nightmarish conditions to their home-states which quite obviously lack the infrastructure to either test or properly quarantine them. And then, the Central Government tells the Supreme Court that three in every 10 of these migrant workers returning home could be carrying the virus. Can the country afford the virus reaching the rural areas where social distancing is even more difficult and which lack even the most basic of healthcare services? And vet, this was allowed to happen even as neighbourhoods in other areas are threatened with lathicharges and imprisonment if they break the lockdown. Shouldn't accountability be demanded of the officers and political leaders who allowed this to happen because they could not plan things properly and with more empathy?

This confusion is worrying because what is clear is that a lockdown is necessary. And no, not because the virus would have miraculously gone away even if the harshest lockdown was imposed, but, because of the above cited reasons, it is up to the people themselves to keep the virus from spreading. COVID-19, as mentioned earlier, spread exponentially and with limited testing capacity, this difference between those who are getting infected and those who are getting tested grows larger every day. As more and more people get infected and don't know of their "positive" status, they spread the virus to more and more people and the chain keeps growing. This is the chain that the lockdown is seeking to break. This is the only constrain possible on the virus at present because it denies nCoV a place to go and secludes it. Those who manifest symptoms can call in the doctors and receive treatment. Those who are asymptomatic, don't infect any more people than they might already have in circles they are intimate with on a daily basis any ways. The lockdown does not kill the virus, but puts a bubble wrap around it to contain it as best as the situation allows. What a lockdown achieves is that by isolating people, communities and areas, it disrupts the chain of people-to-people transmission the virus needs to sustain itself. If this chain is not "broken," the gap between actual and reported cases will get larger and the virus would have spread too wide to be contained. In the absence of a cure and the status of our country's healthcare network, this would be disastrous.

Meanwhile, if a lockdown is relatively effective as in Sikkim's case, the limited testing facilities can be dedicated to those who are displaying symptoms. This has worked well in Sikkim where those with a combination of travel-history and symptoms are getting proper medical attention and quick tests. Thankfully, all of they have tested negative thus far. The story is rather grim elsewhere in the world and the country.

This section has argued often that while this might be a time of crisis, emergency even, it is not a law & order situation where the usual tools of enforcing law & order should be deployed. This is a medical and even a humanitarian crisis which needs convincing and collaborations, stronger communication and effective state support. The people need to be convinced that the best way to combat the virus is not by going into paranoid huddles suspecting every outsider or everyone outside of being a carrier but by behaving as if they themselves have contracted the virus and then conducting themselves in a way that they do not infect anyone else. And while we internalize this approach, also send up a prayer that the pause is being used by the authorities to prepare better for whatever the virus still has in

She nonchalantly wipes the dirt on her hand with her spotless white saree and nimbly walks through the multitude to board her car on way to inspect hospitals, sirens of the pilot car blaring.

For the last three weeks West Bengal

COVID-19 patient dies in Bengal, death count 3

KOLKATA, MAR 31 (PTI): A 47-YEAR-OLD WOM-AN INFECTED WITH THE CORONAVIRUS DIED AT A HOSPITAL IN WEST BEN-GAL'S HOWRAH DISTRICT. TAKING COVID-19 death toll in the state to three, a health department official said on Tuesday.

The woman had recently visited Dooars in North Bengal but had no foreign travel history.

"The woman, a resident of Salkia in Howrah, died on Monday night before test results came. Her test results confirmed that she was infected with the coronavirus." the official said.

The woman was admitted to the Howrah Zilla Hospital on Sunday evening with fever and severe breathing problem.

The health department is considering quarantining the family members of the deceased and all those who came in contact with her, the

"We need to find out persons whom she had recently come in contact with. Swab tests of her family members will be conducted. The nurses and doctors who treated the woman will also be quarantined, he said.

The department will also enquire whether any family member of the deceased had recently returned from abroad or not.

The woman will be cremated as per the prescribed protocol set by the health department.

After the death of

the woman, nurses and group D staff of the hospital on Tueday staged a demonstration, alleging that the woman was initially admitted to the general ward for nearly three hours, and they had to attend to her without personal protective gears such as masks, gloves and jackets.

"The woman was admitted here on Sunday evening as a suspected coronavirus patient. Despite several requests to provide personal protective equipment (PPE), the authority did not pay heed to our demand. We had to attend to her without any protection," one of the nurses of the staterun facility said.

She alleged that the woman was initially admitted to the general ward here, and she was shifted to the CCU later that night, and was on ventilation support since

"The woman was also taken for X-ray. We have no isolation ward here in this hospital, the nurse Meanwhile, four new

cases of coronavirus have been reported in West Bengal, taking the count to 26, the health department official said.

Two men from the city- one from Salt Lake and another from Tollygunge area- tested positive for COVID-19, and are undergoing treatment at two separate private hospitals here.

"Neither they have any history of travelling abroad, nor to any other state. We are trying to find out whether any of their family members had gone overseas or other states.

Family members of the two will also be quarantined," he said.

Another man, in his early 30s, who had recently returned from Maharashtra, was admitted to the Midnapore Medical College and Hospital and tested positive for the coronavirus.

The details of the fourth person, who tested positive for COVID-19, are yet to be ascertained, he said.

Meanwhile, the man, who had tested positive for COVID-19 after returning from the UK, the first case in West Bengal, is likely to be discharged from the Beliaghata I D Hospital here on Tuesday.

He is son of a senior state government official.

The health department will also discharge the woman from Habra, who had tested positive for COVID-19 after returning from Scotland.

"The latest test results of the two were found negative. They will be advised a 14-day home quarantine," the official said. The father of the Bal-

lygunge-resident, who had returned from the UK and tested positive for coronavirus, will also be discharged on Tuesday after his swab test came out negative, the official added.

PATNA, MAR 31 (PTI): A 35-year-old man with a travel history to Dubai tested positive for COVID-19 on Tuesday here, taking the tally of those afflicted in Bihar to 16, an official said.

Pradip Das, Director of ICMR Rajendra Memorial Research Institute, which is conducting the bulk of coronavirus tests in the state, said the latest case was that of a resident of Gopalganj district who had returned from Dubai before the lockdown came into force.

Meanwhile, 45-year-old woman, who had tested positive on March 22 and had been admitted to AIIMS, Patna, was on Monday discharged after full recovery, hospital authorities said.

The woman, who resides in Anisabad locality of the city, had recently travelled to Nepal and had turned up at the hospital to get tested as a precautionary measure.

The hospital authorities said she remained stable during her stay at the facility, developed no symptoms and looked perfectly healthy, though a close watch would be kept on her for another week.

Her family members, including her son who had recently travelled to Italy but did not test positive, have been living at home in self-imposed quarantine.

According to the state

health department, close to 1,100 samples have been tested so far.

A 38-year-old man whose test results came on the same day as that of the woman, breathed his last before it was confirmed that he was infected with coronavirus. He had a history of travelling to Qatar and was admitted to AIIMS, Patna, because of renal failure.

Testing of samples is likely to pick up in the state with hordes of migrant workers having poured in from different parts of the country, notwithstanding assurances by the Nitish Kumar government that it would ensure they were looked after wherever they happened to be.

Farmers destroy millions of flowers for lack of demand

LAXMI DEVI New Delhi, Mar 31 (PTI): Brightly coloured roses, chrysanthemums, lilies, marigold and other flowers that might normally have been destined for marriage decoration and temples -- are now being destroyed by growers in unprecedented manner as the rapidly spreading coronavirus brings demand to a standstill.

When people are seemingly keen to stockpile essential food items, flowers are the last thing on their mind.

Also, flower wholemarkets across the country are shut because of the 21-day lockdown announced to prevent the spread of coronavirus, affecting thousands of growers and traders associated with the floriculture business.

Currently, the government has given exemption from the lockdown rules for movement and distribution of only essential vegetables, fruits and other food items but not

"In such a situation, there is no option but to destroy. The survival of the industry is going to be tough as flowers are not essential commod-Bengalure-based floriculturist Bollapally Srikanth told PTI.

Bollapally cultivates flowers like Rose, Gerbera, Carnation, Anthurium and Gypsophila in greenhouses in 35 acres land in Tubagere in Doddaballapura taluk, Bengaluru rural district. He employs about 250 labourers.

Srikanth, who distributes flowers across the country, has estimated about Rs 10 lakh per day loss due to the lockdown as he begins to dump millions of flowers in huge skips.

Sharing similar plight, another grower Prakash Chandra Shukla from Sidhi district, Madhya Pradesh said: "I have cultivated rose, marigold and dahlia in 3 acres to cater for festival demand of Ram Navami. Now I cannot sell it in the market

due to the lockdown. I am feeding it to livestock and making com-

Shukla, who has incurred a loss of Rs 1 lakh from his flower crop, said some people may want to buy flowers for doing puja at home but it would be difficult to supply in the wake of restriction on movement and social distancing.

Arjun Singh, a grower from Rohtak, Haryana, said lily flowers grown in 6 acres are ready for sale but are now being destroyed in farm fields and some dumped in garbage as there are no takers for it in the current difficult times

"What will the government do? Flowers are not priority now for most people who are more worried about basic food. But farmers like us will suffer," he said.

Ajay Barua, a wholedistributor of flowers in the national capital, said: "There is no demand for flowers anymore because of the coronavirus. Our business has come to a complete halt as five star hotels and event management companies have cancelled the orders".

Even unsold stock is rotting due to shutdown of both wholesale and retail markets, he add-



Misbah calls for uniform policy in dealing with corrupt cricketers

KARACHI, MAR 31 (PTI): Pakistan head coach and chief selector Misbah-ul-Haq on Tuesday demanded a clear policy for players who are found guilty of corruption at any level.

However, the former Test captain also didn't agree with the public comments made by Muhammad Hafeez, who feels tainted players should not be allowed back into the national

"It is my personal opinion that if you are playing as a player you shouldn't be giving such opinion as the ICC and PCB are the authority on these matters and they take decisions as per existing law," he said in a video interaction with the print media.

He advised Hafeez to avoid making comments because as a player one has to share the dressing room.

"It is good that the PCB CEO Wasim Khan has had a long talk with Hafeez on this issue and Hafeez has shared his ideas as well. I think he will now understand that it is totally up to organisation to take a decision on these issues."

Asked about Hafeez's suggestion that a clause should be put into the players contracts on the issue of what should happen if a player is found guilty of corruption, Misbah said that there should be a unanimous law for all players.

"But we have to take into count many things like a player's education and his understanding of his position and situation and his decision making ability. In most cases we have seen it has been about players failing to report any approaches to them."

Misbah players like in the recent Umar Akmal case tended to take things lightly and landed into trouble.

"My personal view is that if you want to put such a clause for players, it should be unanimous and should be decided once for all."

Misbah also indicated that Hafeez might not be in the team management's future plans in the ODI format.

"When we sit down to talk about ODI cricket we will have to see whether Hafeez would be playing in the 2023 World Cup because you have to start planning about a World Cup well in time.

Lionel Messi says players will help staff at Barcelona but hits out at board again

Madrid, 31 [theGuardian]: Lionel Messi has announced that Barcelona's firstteam footballers will not only take a 70% pay cut for as long as the "state of alarm" continues in Spain but also make contributions to guarantee that staff at the club earn their full salary throughout the coronavirus cri-

In a statement also released by Luis Suárez on Monday, Messi embraced the need for the players to be the ones to bear the brunt of the economic impact on the club but criticised the board for their handling of those measures and for what he sees as an attempt to turn public opinion against them. A statement from Barcelona soon after confirmed the measures.

Barcelona announced last week that they were going apply for an ERTE, tion of 70% of our sala-

which allows companies to impose a temporary pay cut of up 70% on their employees during the crisis. That measure is applied unilaterally, as per Spanish labour laws, and was announced by Barcelona before an agreement with the players for a negotiated settlement had been

The statement from the players, released on Messi's Instagram account, accepts that measure and confirms that the players will have their salary cut by the full 70%. On top of that, the first-team squad, whose collective annual salaries amount to €391m (£347m), have promised to protect the rest of the staff. Barcelona had announced that the ERTE would include pay cuts for "non-sporting" staff, although the details were not revealed.

"Beyond the reduc-



ries during the state of alarm, we are also going to make further contribution to ensure that the employees can continue to be paid 100% of their salaries for as long as this situation lasts," Messi's statement read.

Far from ending tension at the Camp Nou, the statement underlined the mistrust and the breakdown in the relationship between the boardroom and the dressing room.

Spain's football authorities are no closer to knowing whether competition will resume this season or the full impact on the game. Barcelona were the first club to announce plans to request an ERTE, followed by Atlético Madrid, Espanyol and Alavés, and of the teams in the top division their situation is probably the most precarious. This is the latest in a long series of increasingly public conflicts between the players and the president, Iosep Maria Bartomeu, as Barcelona's institu-

tional and financial cri-

sis deepens.

That mistrust helps to explain why a negotiated settlement proved hard to reach, despite the players' initial willingness to reduce their salaries. That those negotiations were played out in the press, with players well aware of the relationships the club has with certain media, worsened the situation. Reports were seen by some of the players as deliberate leaks from the board, designed to point the finger of blame at them for a crisis not of their making and forcing them into a corner. Messi was not prepared to let

that pass. "A lot has been written and said about the football first team at Barcelona, when it comes to the players' salaries during this state of alarm," the statement opened. "First of all, we would like to clarify that we have always been willing to apply a wage cut, because we understand perfectly that this is an exceptional situation and we are al-

ways the first to help the club when we have been asked to. Indeed, we have often done so on our own initiative in those moments in which we have considered it important or necessary.

"For that reason, we

cannot help but be surprised by the fact that from within the club there are those trying to put us under the microscope or apply pressure for us to do something that we have always been clear that we would do," he added. "In fact, if an agreement has taken a few days to be reached it is simply because we were seeking a formula to help the club and also to help its employees in these very difficult times.

"If we did not speak publicly before, it was because our priority was to find real solutions that could truly help the club and also those who are going to be most affected by this situation."

Pay cut a small thing, players are prepared to do their bit for game's survival: Paine

MELBOURNE, MAR 31 (PTI): Australian cricketers might have to accept a pay cut due to the COVID-19 pandemic, conceded Test captain Tim Paine but insisted that making financial sacrifices is a "small thing" in the current situation and they are prepared to "do their bit".

A pay cut for the top cricketers seems to be on the cards with Cricket Australia delaying annual contracts for both the men's and women's national teams. CA is preparing for the possibility of a severely-affected home summer due to the coronavirus outbreak.

"Certainly discussions will start happening in the next week or so," Paine was quoted as saying by 'ESPNCricinfo'.

"Certainly if things happen similar to what's happened to football and other sports, then we've certainly got to do our bit to make sure the game survives and remains really healthy for years to come.

"If it comes to that, I'm sure that's something that the players will look at. But there are bigger issues going on around the world at the moment than how much



our sportsmen are going to get paid. That'll be a small thing to us if that was to happen."

Australia could have overtaken India in the World Test Championship ahead of the Border-Gavaskar series if Paine's side would have managed a 2-0 series win over Bangladesh in June but with the coronavirus outbreak forcing a cricket shutdown, the tour is now unlikely to go ahead.

"You don't have to be Einstein to realise (the Bangladesh tour) is probably unlikely to go ahead, particularly in June. Whether it's cancelled or pushed back, we're not quite sure at the mo-

ment," Paine said. "Some series have been cancelled and whether ones going forward are going to be continually cancelled or we're going to postpone them (is uncerof Test matches and if at the end of the day we have to miss them, then so be it."

There is a lot of uncertainty over the rescheduling of the international calender, especially with the World Test Championship final slated for June 2021.

Paine said they are eager to make the decider and might need to play five successive weeks to complete the World Test Championship.

"... maybe players are going to go through a period where we play five weeks' cricket (at a stretch) if we can to complete the Test championship. I think all players will be in favour of trying to finish that in any way we can.

"But again if it doesn't happen as I said there are bigger issues in the world and missing a few Test matches isn't going tain) but it's a couple to hurt us," he said.

Coronavirus crisis forcing Hull KR's Mose Masoe to leave hospital early

Wakefield, 31 Mar [THEGUARDIAN]: KR's Mose Masoe has been told he will have to leave hospital in the next 72 hours and continue his rehabilitation from a career-ending spinal injury at home.

The rugby league team's co-captain will be discharged from Wakefield's Pinderfields hospital this week, with beds being freed up for coronavirus patients. Masoe has only recently started walking with the assistance of parallel bars, and says he is "not ready" to go home.

The 30-year-old prop has urged people to "stop being selfish" and stay at home, after becoming a victim of the ripple effect of the pandemic.

"They've got to clear out a lot of wards to get in the people who have coronavirus so a lot of us have to go home," Masoe told the Hull KR website. "I'm not really ready to go home at all.

"It will be nice to get home so I can spend some time with my kids but there's a lot of things I can't do myself, like going to the toilet and things like that. I don't want to put a burden on my missus. We just got the news this morning so

we're still in the dark."

Masoe says he has been told hospital staff are concerned about patients catching the virus. "When you get a spinal injury we're at a high risk. A lot of people forget our immune systems drop," he said.

"We need people to stay home so we can get back into the hospital to do rehab. People need to stop being selfish because we've felt the effects already. It's the first time in the world you can save lives by just staying home

watching TV or playing PlayStation.

"That's my frustra-

tion with people who aren't listening. My wife is pregnant so they've all been staying home and she's only going out to get food. They've been doing the right thing and staying away. I haven't seen them for two weeks.

The former Samoa international suffered the injury in Rovers' pre-season game against Wakefield in January and was transferred to Pinderfields' spinal unit after four days in the intensive care unit at Leeds General Infirmary.

Masoe is unable to take any equipment home with him due to limited resources at the hospital, but Hull KR and the RFL Benevolent Fund are hoping to help him

"I called my missus this morning and she's tried to get a stair-lift and the benevolent fund have pretty much said they'll sort that for me," he said. "I'm very lucky and grateful to have the support and that network but I feel real sorry for the other patients that don't have that. It'll be tough for them.

"I'm gutted to be going home because I wanted to keep my progression going. The next step was to go from parallel bars to a walking frame to crutches and then you can pretty much walk by vourself."

Last week, Air Canada -- the first Canadian airline to be hit hard by the pandemic -- announced the temporary layoff of more than 5,100 flight attendants, including 1,500 members of its low-cost subsidiary Air Canada Rouge.

"The unpredictable extent and duration of the COVID-19 pandemic requires a significant overall response," Air Canada president Calin Rovinescu said in the statement.

"To furlough such a large proportion of our employees is an extremely painful decision but one we are required to take given our dramatically smaller operations for the next while." The Montreal-based compa- April.

ny will reduce operations for the second quarter of 2020 by 85 to 90 percent compared to the same period the previous year.

A cost reduction program will be implemented to generate "at least 500 million" (320 million euros). Senior executives will give up a part of their salary, and the president and chief financial officer will give up their entire salary.

Air Canada has suspended most of its international flights, including to the United States, after the announcement of the temporary closure of the US-Canada border in an attempt to stop the spread of the coronavi-

US judge grants early release to **Brazilian in FIFA corruption scandal**

NEW YORK, MAR 31 **(AFP):** - A federal judge in New York on Monday granted the release from prison on humanitarian grounds of an 87-yearold former senior Brazilian football official major football official tarnished by the FIFA corruption scandal.

Judge Pamela Chen authorized the release of Jose Maria Marin, a former Brazilian Football Confederation president, who was serving a fouryear prison sentence for accepting millions of dollars in bribes as part of the global FIFA corruption scandal.

Marin was scheduled for release in early December 2020, according the US Federal Bureau of Prisons.

But following a request from the Brazilian's lawyers Chen granted a "compassionate release," for reasons "including his advanced age, significantly deteriorating health, elevated risk of dire health consequences due to the current COVID-19 on!" he wailed.

Marin was the first found guilty and sent to prison in the United States as part of the "FIFA gate" scandal of kickbacks and bribes that smeared the reputation of the global sports organization.

Sharif in his petition had requested the court that he should be granted exemption as his doctors in London are not allowing him to travel.

Maryam Nawaz was also given exemption from personal appearance.

She has also filed a petition in the Lahore High Court seeking permission to go abroad to look after her father. This case is pending in the court.

The National Accountability Bureau has accused Sharif along with two others of money laundering under the garb of sale/purchase of the sugar mills' shares. According to Sharif's

brother Shahbaz, the former premier will undergo a heart procedure this week. He said Sharif cannot return the country till he gets well.

The Imran Khan government has already declared Sharif an 'absconder' after refusing

to extend his four-week bail granted by court on medical grounds.

The Pakistan government says it is not satisfied Sharif's medical reports and he should return to the country forthwith.

The Lahore High Court in October last granted to Sharif on medical grounds for four weeks, allowing the Punjab government to extend it further in the light of his medical reports.

US judge grants early release to Brazilian in FIFA corruption scandal

NEW YORK, MAR 31 (AFP): - A federal judge in New York on Monday granted the release from prison on humanitarian grounds of an 87-vear-old former senior Brazilian football official tarnished by the FIFA corruption scandal.

Judge Pamela Chen authorized the release of Jose Maria Marin, a former Brazilian Football Confederation president, who was serving a four-year prison sentence for accepting millions of dollars in bribes as part of the global FIFA corruption scandal.

Marin was scheduled for release in early December 2020, according the US Federal Bureau of Prisons.

But following a request from the Brazilian's lawyers Chen granted a "compassionate release," for reasons "including his advanced age, significantly deteriorating health, elevated risk of dire health consequences due to the current COVID-19 outbreak, status as a non-violent offender, and service of 80% of his original sentence," a court document seen by AFP read.

Marin was the first major football official found guilty and sent to prison in the United States as part of the "FIFA gate" scandal of kickbacks and bribes

that smeared the reputation of the global sports organization.

He was being held in FCI Allenwood, a minimum security facility in the state of Pennsylvania.

In August of 2018, a New York jury found Marin guilty of accepting 6.6 million in bribes -- along with his deputy, Marco Polo del Nero -- in exchange for contracts to broadcast major tournaments.




Unable to bear the monotony of his PR manager job, Sajjad quit in 2011 and packed his bags to head to Bollywood.
