#### Railways to introduce new system to tackle water shortage in trains

NEW DELHI, 09 DEC [PTI]: Water woes on trains will soon be a thing of the past with Indian Railways set to introduce a system which will reduce water filling time from the existing 20 minutes to just five minutes at stations.

The Railways will intro-duce the system in March next year at 142 stations which have the water filling system for trains. The rail board has sanctioned Rs. 300 crore for the project. Water in long-distance trains, used in toilets and washbasins, is filled every 300-400 km. With the use of quick watering system, a 24-coach train can be filled up within five minutes and multiple trains can be simultaneously watered at the same time.
"Earlier the water in the

coaches was filled with the help of four-inch pipes. These would now be replaced with six-inch pipes with high power motors and the water would be supplied to the train coaches through a computerised system called SCADA (Supervisory Control And Data Acquisition), designed by RDSO," said Railway Board Member (Rolling Stock) Rajesh Agarwal.

### THE MORE PLEASANT SIDE OF MANDALAM-MAKARAVILAKKU PILGRIMAGE TO SABARIMALA

### When a Hindu deity's Muslim-Christian 'friendships' set a pilgrim tradition in Kerala

THIRUVANANTHAPUR-AM, DEC 9 (PTI): Can vou imagine Hindu devotees circumambulating a mosque in their ritual attire and taking bath in a church pond as part of their annual temple pil-

grimage? This is not a fairy tale of religious harmony but a real-life scene in Kerala where pilgrims of the famed Sabarimala Lord Ayyappa Temple visit a mosque and church as part of the annual Mandalam-Makaravilakku

pilgrimage. Both the Erumeli Nainar Juma Masjid, also known as Vavar Palli (mosque), in Kottayam district and Arthunkal St Andrew's Basilica in neighbouring Alappuzha have been opening its portals for the devotees of Lord Ayyappa for decades during the two-month-long pilgrim season beginning in mid-November.

Wearing the tradi-tional black dress and bead-chain and smearing 'bhasmam', the holy ash, on forehead, chest and arms, Hindu pilgrims visit the mosque and the church every year and offer prayers, reviving the local myth of the Lord Ayyappa's friendship with a Muslim youth and a Christian priest.

It is heartening to see how the managements of the mosque and church wholeheartedly welcome and provide facilities for the Hindu pilgrims who step in chanting aloud 'swamiye saranam Ayyappa' mantras praising their deity.

According to local lore, Vavar, for whom the mosque is dedicated, was the Muslim companion of Lord Ayyappa, the adopted son of the erstwhile Pandalam king as per Hindu belief.

The Arthunkal church legends stated that one of its erstwhile vicars, popularly known as Arthunkal Veluthachan (fair-skinned father) among local people, had been a great friend of Ayyappa.

Even when the country had witnessed tensions in the name of and belief, mple, church religion temple, and mosque stood as a unique example of deep-rooted commu-nal harmony in Kerala.

According to Hakim, nt secretary, Eru-eli Mahalla Muslim meli Jama-ath, not only Ker-alites but devotees from neighbouring states of Tamil Nadu, Karnataka and Andhra Pradesh also visit the Vavar mosque, situated over 60 km from Sabarimala, every year and offer prayers before

they start trekking the hill shrine.

"A large number of Ayyappa pilgrims visit the mosque throughout the November-January annual pilgrim sea-son. They do not en-ter the prayer hall but circumambulate the mosque, provide kan-ikka (offering) and break coconut at the

premises," he told PTI.

"It is beautiful to see when we perform namaz inside the hall, our Hindu brothers perambulate the mosque and offer prayers as part of their traditional believes. The legend of the friendship of Ayyappa and Vavar is the reflection of the deep-rooted secularism and communal harmony in Kerala," he said.

The Jama-ath, which takes care of the administration of the centuries-old mosque, pro-vides parking facilities and space for placing 'viri' (bed spread) for the Ayyappas', how the Sabarimala pilgrims are generally known as.

The Nainar Juma Masjid also conducts an annual festival named 'Chandanakudam' as a prelude to the 'pettathullal', the ceremonial mass dance of Ayyappa dev-otees, at the end of the

yearly pilgrim season.
Interestingly, there is a place at Sabarimala

known as 'vavar nada', dedicated to the 'Vavarswamy', how the Mus-lim friend of Ayyappa is fondly being called by Hindu devotees. Meanwhile, Fr Chris-

topher M Arthasseril. the parish priest of Arthunkal Basilica, said it has for long been a custom for the sea-side church to receive the

Sabarimala pilgrims.

After offering prayers at Sabarimala, a large number of Ayyappa dev-otees visit the 16th-century Arthunkal Basilica, built by Portuguese missionaries, to take out their mala' (bead-chain) worn as part of the pilgrimage.

"Majority of the pilgrims visit the church to remove the traditional bead-chain marking the end of their 41-day vrata (renunciation of worldly pleasures)," Fr Arthas-seril told PTI.

After removing the chain by paying respect before the idol of Saint Sebastian, the devotees take a bath in a tank in the church premises or a dip in the sea, he said.

Detailing the legend behind the church's Sabarimala connection, the priest said the visit of the pilgrims commemorate the bond between Lord Ayyappa and a Jesuit priest, one of the early vicars of the church.

### 4 more medical devices to be regulated by Govt for safe use

NEW DELHI, 09 DEC [PTI]: The health ministry of India has notified medical devices such as nebulizers, blood pressure monitors, digital thermometers and glucometers as drugs under the purview of the Drugs and Cosmetics Act, a step the government says will ensure their quality and performance.

Once the proposal gets approved, it would mean companies which are engaged in manufacture and import of these equipment will have to seek necessary permission or license from the Drug Controller General of India January 1, 2020 onward. "The

Ministry Health has through a notification dated December 3, specified devices intended for use in humans for internal or external use in the diagnosis, treatment, mitigation or prevention of disease or disorder in human beings or animals, to be included in the definition of drug under the Drugs and Cosmetics Act. 1940: effective from January 1, 2020," the notification read.

All these devices will have to be registered under the quality parameters prescribed under Medical Devices Rules, 2017 and other standards set by the Burea of Indian Standard (BIS) certification.

The Drug Technical Advisory Body (DTAB), India's highest drug advisory body, had approved the proposal to include nebulizers, blood pres-sure monitoring devices, digital thermometers and glucometers under the purview of the Drug

Currently, only 23 medical devices are monitored for quality by the country's drug regulator. With these four new devices being notified, 27 medical devices now fall under the definition of drugs under the Act.

### Centre calls all-party meet ahead of winter session of Parliament NEW DELHI, 09 DEC: The government has called an all-party meeting on Monday ahead of the winter session of Parlia ment to build a consensus for smooth functioning of

the two Houses. At the customary ses-sion-eve meeting called by the Parliamentary Affairs Ministry, the prime minister usually lists the government's agenda and seeks the opposition's support for smooth transaction

of official business.

This would be the last full-fledged Parliament session before the Lok Sabha polls. The results of the assembly elections, in which both the ruling BJP and the Congress have high stakes, are bound to cast a shadow on parliamentary proceedings.

The results of polls in Madhya Pradesh, Raiasthan. Chhattisgarh. Telangana and Mizoram would be out on December 11, when the session begins. The government would push for the passage of the 'triple talag' bill pending in the Rajya Sabha. It had promulgated an ordinance to make the practice of instant triple talaq a penal offence.

The government also wants the Indian Medical Council amendment ordinance and the com-panies amendment ordinance to be passed as bills in this session. The Win-ter Session of Parliament usually starts in November. However, it would be the second year in a row when it would begin in

## Depopulation empties 734 U'khand villages

DEHRADUN, DEC 9 (PTI):
Migration from development-starved villages of Uttarakhand, especially those in the hills, continues to present a grim picture with over 700 of them totally depopulated in seven years.

Of nearly 16,500 villages in Uttarakhand, as many as 734, mostly in the hilly areas, are to-tally depopulated. Not a soul lives in them. Vice President of Uttarakhand Rural Development and Migration Commission S S Negi told PTI.

Such ghost villages with their houses lying in ruins and fields overgrown with vegetation abound in Pauri district where 186 out of 298 villages are totally depopulated, he said citing a report submitted to the sate government recently by the commission.

by migration followed by Almora district where a study by a commission team is already underway.

The data covers a pe-

riod of seven years after

the 2011 census, he said.

Describing the situation as "grim", the commission's vice president said while migration from development-starved hill areas is a common problem total depopulation of villages is unique to Uttarakhand.

"Wherever there is lack of development in the country or anywhere in the world, migration is a reality but total de-population of villages is a rare phenomenon which seems Uttarakhand specific," he observed.

One of the reasons behind total depopula-tion is that while migration from states like Bihar is of a temporary and

seasonal nature, outflux from the hill villages of Uttarkhand is of a permanent nature, he said.

"While people from Bihar and Uttar Pradesh for instance migrate often to work as labourers in urban areas temporarily and come back, those who migrate from Ut-tarakhand hills are often educated people who do so in search of better employment opportunities and prospects for set-tling down," the commission's vice president said.

There are also a number of villages in the state where the population size is 8-10 or 2-3 people.

Citing an instance, Negi said while touring Nainidanda block of Pauri district they came upon a village where no one lives except a retired post master and his wife who said they bolt the doors of their house at 4

pm and keep indoors in the fear of leopards. "There are also villag-

es in Nainidanda block where there is no male population with all of them working outside and in case of one of the women dying men have to be sent from neighbouring villages to carry the bier on their shoul-

ders and participate in the funeral," he said.

Pegging the rate of migration at 50 per cent, Negi underlined the need for immediate steps to boost rural economy to op further migration from Uttarakhand's villages.

"The basic factors behind the high rate of migration from Uttarakhand's villages is lack of income avenues, non-accessibility of quality education and quality health care.

The situation can be improved only through creation of better income

avenues with fresh impetus to ecotourism," Negi

tus ic said. "Five-star ously tourism is obviously not going to work in villages. A renewed thrust on ecotourism like home stays and adventure tourism activities like trekking, rafting etc may create better income avenues for locals and stop fur-ther migration from our villages," he said.

Temple tourism is another area which needs to be paid more attention as villages of Uttara-khand abound with centuries-old temples that can attract people and generate income avenues for locals, he suggested.

Better facilities can be created for devotees around these temples which will create em ployment opportunities for locals and increase their income, he said

### Over 1,700 arrested in latest 'yellow vest' protests in France

PARIS, DEC 9 (AFP): More than 1,700 people were arrested across France during the lat-est round of "yellow vest" pro-tests, in which demonstrators clashed with riot police, the interior ministry said Sunday.

Clashes broke out in sever al cities, including Marseille, Bordeaux, Lyon and Toulouse, during a fourth weekend of nationwide protests against rising living costs President Emmanuel

Macron in general.

A total 1,220 of the 1,723 detained were ordered held in custody, the ministry said.

Police in Paris said they made 1,082 arrests on Saturday, up sharply from 412 in the previous round.

The interior ministry said



some 136,000 people took part in Saturday's protests, around the same number as on December 1.

But it was Paris which again bore the brunt of the violence and destruction.

Protesters in the capital set fire to cars, burned barricades and smashed windows in pockets of violence, clad in their emblematic luminous safety jackets, as

armoured vehicles rolled through the streets.

City authorities said the 'yellow vests' had caused "much more damage" than on December 1.

"The sector concerned by

the incidents was much larg-er... With fewer barricades, there was much more dispersion, so many more places were impacted by violence," Paris deputy mayor Emmanuel Gregoire told France Inter radio. The embat-tled president -- whose name rang out across the name rang out across the Champs-Elysees as pro-testers shouted "Macron, resign" -- is expected to ad-dress the demonstrations in a much-anticipated speech in the coming days.

### AG Venugopal expresses concern over concept of constitutional morality

NEW DELHI, DEC 9 (PTI): Attorney General KK Venugopal Saturday expressed concern over the Supreme Court re-lying on the concept of constitutional morality after it gave a 4:1 verdict in the Sabarimala case and said it might be used now for the purpose of testing laws.

On September 28, a five-judge Constitution bench, headed by the then Chief Justice Dipak Misra, in a 4:1 verdict, had paved the way for entry of women of all ages into Sa-barimala temple in Kerala, saying the ban amounted to gender discrimination.

While speaking at the Second J Dadachanji memorial debate here, Venu-gopal hailed as "enlightened" the dissenting judgment given by apex court judge Justice Indu Malhotra in the Sabarimala case.

"I am saying all this because of a fear that this new concept of constitutional morality may now be used for the purpose of testing laws," he said.

"In the Sabarima-case, the dissenting judge, Justice Indu Mal-hotra, relied upon con-stitutional morality and said that constitutional morality will require that



with what is the matter of faith," Venugopal said. Referring to the majority judgement by four judges in the Sabarimala case, he said they had elaborately stressed on constitu-

tional morality and said that constitutional morality was equality and equality before the law means you cannot discrimi nate against a class of

"If a bench of the Supreme Court speak in two different voices, one

says permit and other says no, then this is dan-gerous," he said, adding, that "no one knows where this fight will go and therefore, I am hoping that constitutional morality will die".

Venugopal said from the very beginning, there has been conflict a between Parliament and the executive on one hand, and judiciary on the other, and it was not proper for the court to believe that unless they interfere, the country is doomed.
"The Supreme Court

has not been given the powers of legislation. If the Supreme Court tries to assert legislative powers, it would not be supremacy of the constitution, but supremacy of the Supreme Court of India which is wholly impermissible," said

Venugopal.

He also referred to
Article 142 of the Constitution, which deals with enforcement of decrees and orders of

the apex court.

"Article 142 merely permitted the court to pass such decree or make such order as to do complete justice in any cause or matter pending before the court...But the Article was treated as a 'Kamadhenu' from which unlimited powers flowed to the apex court of the country," he said.

### Around 5,000 migratory birds flock in Gharana wetland in Jammu

JAMMU, DEC 9 (PTI): About 5,000 migratory birds has arrived at Gharana Wetland Conservation Reserve along the International border in the outskirts of Jammu, an official said.

Located about 30 km from Jammu, Gharana is surrounded by wet-lands of Makwal, Kukdian, Abdullian and Pargwal where more than 170 resident and migratory bird species, such as bar-headed geese, gadwalls, com-mon teals, purple swamp hens, Indian moor hens, black-winged stilts, cor-morants, egrets and green shanks flock during the winter - making it a treat for bird watchers.

"Around 5.000 bar-headed geese and birds of many other species have arrived at Gharana in R S pura sector. Their number is expected to increase manifold in the coming weeks," Wildlife warden, Jammu, Shahzad Chowdary said, adding all necessary measures were being taken to ensure the safety of the winged guests.

He was speaking at a meeting convened by Commissioner Secretary, state Forest Department, Manoj Kumar Dwivedi here to review the status of Gharana wetland conservation reserve.

During the meeting Dwivedi stressed on prioritising the conservation and management issues like sewage disposal by setting up sewage treatment plant (STP), monitoring and ensuring optimum water lev el in the wetland, an official spokesperson said.

The commissioner secretary also stressed on desilting and selective deweeding for boosting eco-tourism in the area and generating liveli-hood opportunities for the communities and stakeholders.

Delhi's air quality

**(PTI):** Delhi's air quality significantly deteriorated Sunday with a fall temperature which wed dispersion of slowed pollutants, as authorities warned pollution level might further increase in

the next two days.

The Central Pollution Control Board (CPCB) recorded an overall air quality index (AQI) of 377, the highest pollution level in nearly 20 days.

In NCR, Ghaziabad,

Noida and Faridabad re-corded 'severe' air quality, CPCB data showed.

An AQI between 201 and 300 is considered 'poor', 301 and 400 'very poor' and 401 and 500 is 'severe'.

The air quality in seven areas -- Anand Vihar, Mundka, R K Puram, Rohini, Vivek Vihar, Jahangirpuri and Nehru Nagar recorded 'severe air quality while 20 ar-eas recorded 'very poor' air quality, according to the CPCB.

The overall PM2.5 -fine particulate matter in the air with a diameter of less than 2.5 micrometre level was recorded at 221 and the PM10 level at 389, it said.
The Centre-run Sys-


Weather Forecasting (SAFAR) said the overall air quality of Delhi will further deteriorate over the next two days.

"Winds are calm and dispersion is low. Western disturbances influence may impact Delhi's air quality by introducthe moisture and making air heavy. The expected fall in temperature and moderate fog is likely to increase pol-lution over coming two days is expected to the upper level of very poor," the SAFAR said.

The SAFAR said that the air quality might improve on Wednesday if sufficient amount of rainfall occur, which is expected. "However, marginal shower often deteriorates air quality because high moisture content over shadows the wash out effect. In all probability, the AQI will remain within the limit of very poor and will not touch severe," it said.

"Levels of gaseous pollutants, NOx and CO are forecast to be enhanced -- up to moder-ate range -- after a long time due to a fall in boundary layer height and reduced vertical mixing," the SAFAR said.

### Too Many Suicides And not enough support

 $\mathbf{Y}^{ ext{es}}$ , this section has been returning to this topic more often than it has in the recent past. Part of the reason is that we are upon a season when suicides tend to see a spike, and one of the reasons is also because the election season is here, and one hopes that the challenge of suicides receives some earnest discussions. Visitors of Social Media pages frequented by "locals" would have noticed the persistent march of lost notices on such pages Hopefully, most of these are cases of runaways, but many undoubtedly also turn up as suicide victims

A death affects everyone. The trauma travels through family members, friends, colleagues/ classmates, neighbours... The loss is permanent, and hence the grieving is long. When a death is by suicide, confusion and guilt, even among those who knew the victim only at a very casual level, are added to the already difficult emotion of grief. When the life lost is young, or leaves young dependents behind, the situation grows even more complex and a nagging conscience begins gnawing minds already grappling with shock and sorrow and returning to thoughts of whether something could have been done differently, whether the suicide could have been prevented... Sikkim has a serious problem staring it in the face with the number of lives it is losing to suicides. The social challenge posed by suicides has been flagged often for Sikkim, and although it is now universally accepted as a major problem, nothing is being done to address it. Organisations which one would turn to - the Government for a policy commitment to confront the problem, the healthcare sector for the professional intervention required and social and people's organisations to provide the necessary involvement and outreach- have remained unmoved. Unmoved might be too strong a word to describe the response, the ennui is perhaps because none of these organisations know what to do. This is a worrying situation and the time is now urgent for one of these groups to take a leadership role in talking about the problem more forcefully and with its proactive engagement, inspire others to join forces and help save lives. Yes, the State government recently set aside a kitty to fund research into suicides in Sikkim, and while that is a good first step, it will take more collaborations to ensure quality work and intelligent analysis.

Suicides in Sikkim are not limited to any specific age-group, but what has very specifically been proven by now is the recklessness with which lives are being allowed to self-destruct.

Any attempt at curtailing suicides in Sikkim will have to begin by reinforcing the support system for those at risk need. When it comes to the young, it will mean by treating them with more respect and addressing, with genuine concern, their requirements. The elders will need support groups, timely detection of their suicidal tendencies and effective interventions. Suicidal tendencies don't always require medical expertise to detect. Depression and other mental conditions feelings of worthlessness, signs of abuse and other warning signs manifest rather clearly. What is missing is the correct response. Family and friends, the first to notice these signals, perhaps prefer to ignore them because it is a difficult situation to address and they find themselves at a loss on how to respond. Maybe they will seek help and counseling if they were made to understand how serious the problem is.

Any attempt at generating wider awareness and involvement on curtailing suicides has to also begin by sharing case studies of how apparently "normal" children from "normal" families have also ended their lives. The social support required to save lives will perhaps then reinforce itself better.

It is also true that even people worried by warning signs they notice, don't know how they can help. That is where governmental and non-governmental organisations can take a leading role. It is important to bear in mind that awareness is required not only to highlight suicides as a problem, but also in equipping the first-responders - friends and family - to panic signs, on what they can do and whom they can approach for help. And one is still discussing the first step of addressing suicides and generating awareness for Sikkim here. The equally important phase of helping friends and family of suicide victims deal with the trauma and heal themselves is not even being considered in what little is being done here on the issue of suicides. Although the pain, grief and associated guilt may never go away, if left ignored, they could intensify and put more lives at risk. The chances of suicides, do after all, increase in cases which have a family history or instances of people [friends and acquaintances] having taken this drastic option. It is worrying that a State which has lost as many lives to suicide as Sikkim does not have an effective support group to counsel and help heal friends and family of suicide victims.

### Sexual violence as a weapon of war: why the Nobel Prize for Peace matters

 $F^{\text{or ordinary women and men,}}_{\text{peace is vital - as essential as air itself. Denis Mukwege and Nadia Mu-}$ rad, the recipients of the Nobel Peace

Prize award of 2018, know this.

Mukwege is "the helper" who has provided medical care and surgery for thousands of survivors of sexual violence in his country, the Democratic Republic of Congo (DRC). In 1999 he founded the Panzi Hospital that's become known for its comprehensive support to over 48,482 survivors of sexual violence.

Mukwege's response to the Nobel Committee was both a call to action and a promise to all survivors of sexual violence that "the world refuses to sit idly in the face of your

For her part, Murad is "the witness". A young woman from the Yazi-di community in northern Iraq, she was abducted and held captive by the Islamic State just over four years ago Now she's a global voice against sex ual violence, human trafficking and genocide. Murad displays relentless courage as an author, human rights activist, and story teller. As a survivor of human trafficking and sexual violence, she has challenged the UN, national governments, and international organisations to take action to ensure that she truly is "The Last Girl" to experience such horrors

The recognition of the role played by these two people matters enormously in strengthening the cam-paign against the use of sexual violence as a weapon of war. Although this isn't a new concept, it's nevertheless taken an eternity to be acknowl-

#### PATTERNS

Forms of conflict-related sexual violence include - but are not limited to - rape, forced pregnancy, slavery and

Sexual violence can serve the purpose of humiliation, rewarding recruits, instilling fear or as a mechanism of ethnic cleansing. As such,

atic and organised; or targeted, indiscriminate, opportunistic and merely tolerated; or a combination of both.

Patterns of sexual violence in wartime are extraordinarily varied and complex. It's often perpetrated by a few armed actors, rather than all of them. The Sexual Violence in Armed Conflict data set shows that

domestic relations, in close proximity to mines and armed actors. One factor seems to be that easy access to weapons, lootable resources, and financing seems to make armed groups more organisationally incoherent. This means that they are prone to under-investing in discipline. In turn this leads to forced recruitment and other cheap and coercive means for

violence.

My own research has provided

Traviewed postwar sexual violence reports between 1989 and 2011, of 23 armed actors in sub-Saharan Africa. Five didn't have any sexual violence events attributed to them following settlement. Only eight were reported as responsible for 68% of abuses and assaults. Reliance on material benefits is

one explanation for brutal behaviour against unarmed civilians. Livin g in an area with valuable commodities and natural resources has often been associated with the prevalence of wartime sexual violence. For example, in eastern DRC, the presence of minerals has contributed to organised armed violence, wartime rape and other forms of sexual violence.

This is backed up by research

which has found a higher risk of experiencing sexual violence outside of

mobilisation. Leaders who don't need civilian support or who have abduct-ed their foot soldiers, strikingly, seem to enable gang rape as a form of so-cialisation within the ranks.

#### THE BURDEN

Other forms of violence in wartime can linger in the bodies and psyches of men and women for a long time. However, while soldiers are recognised for their heroism or courage, recompensed with a pension or integrated into a new army, survivors of sexual violence are silenced and

And yet many cannot bear chiland yet many cannot bear children and are ca st out of their communities as "polluted" or "unmarriageable". They suffer from disease, chronic illness and complicated sexulated as the state of the stat al and reproductive health concerns. They must endure long-term, recurrent depression and anxiety, among many psycho-social-spiritual costs. They are made to feel worthless, disposable to society, marginal. They are often poorer, less able or likely to access education, training and opportunities.

These consequences intersect with social and familial constraints stigma, impoverishment, alienation, fragmentation - which can accompany war and humanitarian crisis and have particularly negative consequences for survivors of sexual

#### ADDRESSING THE COSTS

In the absence of structures and institutions and processes to address these consequences, Mukwege and Murad strive to shift stigma and shame away from the survivors, and to call on

all to respond with social justice.

Mukwege's work at the Panzi
Hospital in Bukavu, in South Kivu, is increasingly taken up with more than general medicine. The foundation that grew from this facility now also provides social, economic, judicial and psychological assistance.

For its part, the Nadia Initiative works with advocacy tools to make life in the Sinjar province in northern Iraq of the Yazidi community possible, and to seek justice for sexual vi-

olence survivors.

Both Nobel laureates are highlighting the need to do more. Survivors and their communities deserve recognition for the atrocities that have been committed against them. But they also need material support in the form of services and funda-

mental human rights and justice.

A Nobel Prize for this work means recognising sexual violence as a weapon of war. But Mukwege and Murad probably don't want us to stop there. After all, they and the women and men they champion need resources for health care, education and legal assistance and post-conflict reconstruction. Just as their bodies and spirits need healing, so do their countries and communities.

# **Opening Pandora's Box: Gene** editing and its consequences

Today, the scientific community is aghast at the prospect of gene editing to create "designer" humans. Gene editing may be of greater consequence than climate change, or even the consequences of unleashing the energy of the atom.

CRISPR is an acronym for Clustered Regularly Interspaced Short Palindromic Repeats. This is the immune system that bacteria developed to protect themselves from infections by bacteriophages - the most abundant life form on the planet

### SMALLER THAN ANY KNOWN LIFE


Bacteriophages were discovered in Paris by Felix d'Hérelle at the Pasteur Institute in 1917. He was studying a subset of patients spontaneously re-covering from dysentery. D'Hérelle proposed that an antimicrobe smaller than any known life form had killed the bacteria in infected patients. He demonstrated conclusively the existence of this new life form, and named them bacteriophages: viruses that attack bacteria.

The bacteriophage has been stud-ied intensely: its beauty was revealed genome was the first life form sequenced. with the electron microscope and its

### RESPONDING TO A BACTERIO-PHAGE ATTACK In 2007, Rodolphe Barrangou and

Philippe Horvath of the food production company Danisco collaborated with Sylvain Moineau of Laval University to solve a long-standing problem in yogurt production. They asked: Why were bacteria that were essential for the production of yogurt and cheese susceptible to bacteriophage attack, and how could this be prevented?

Barrangou, Horvath and Moin-



eau made the astonishing discovery that bacteria actually had an im-

mune system.

After an initial bacteriophage attack, a small number of surviving bacteria would recognize the DNA of the newly attacking bacteriophages. The surviving bacteria would then mount an immune response leading to the death of the bacteriophages. The bacteria that survived a phage attack would embed a fragment of bacteriophage DNA within their bacterial genome to serve as a "memory of the infection

### TARGET AND SEVER

Barrangou, Horvath and Moineau then discovered how the invading bacteriophages were eliminated. Upon recognition of the newly invading bacteriophage, the bacteria would target and sever the DNA of

the invading bacteriophage.
Biologists Jennifer Doudna and
Emmanuelle Charpentier discovered further that "guides" had evolved in the bacterial immune system. Any

bacteriophage whose DNA corresponded to the acquired memory fragment from a prior infection would be recognized and severed by a "guided" elimination machinery. Together, the bacterial immune system encompassing memory fragments of the bacteriophage DNA and the bacterial response machinery are known as the CRISPR-Cas9 system.

Commercial exploitation of the discovery followed. Doudna, Char-pentier and others recognized that this new biological system could be

exploited to edit genes in any life form.
The CRISPR-Cas9 system is not the first gene-editing system to be discovered. The late biochemist Mi-chael Smith, while at the University of British Columbia, was awarded a Nobel Prize in 1993 for the discovery of a chemical means of gene editing with applications relevant to cancer er diseas

#### BACTERIOPHAGES AS A POTEN-TIAL SOLUTION

D'Hérelle observed that the same

bacteriophage isolated from patients recovering from dysentery could be used to protect rabbits from an otherwise fatal infection. Coming before the discovery of antibiotics, d'Hérelle's discovery inspired Sinclair Lewis to feature bacteriophage therapy of humans in his Pulitzer Prize-winning novel Arrowsmith.

One of the largest collections of bacteriophages globally is at Laval University. Sylvain Moineau is the curator, and the collection is named after Felix d'Hérelle.

The hope now is that bacteriophage therapy may be considered a potential solution to antibiotic resistance. However, any expectations of phage therapy are dwarfed by the current exploitation of the commercial benefits of the CRIS-

PR-Cas9 system.
Today, the consequences of opening a Pandora's Box are upon us. The application of the CRISPR-Cas9 system to generate designer humans through "germ-line" gene editing of harvested human eggs would cre ate permanent changes that continue through successive generations, and the fears over these actions may be comparable to the consequences of nuclear warfare and climate change.

But there are other potential applications of "non-germline" CRISPR-Cas9, like the gene editing of disease. This has recently been successfully accomplished for muscular dystrophy in dogs. Akin to the myth of Pandora's Box, the pessimism about "germ-line" gene editing may be offset by the hope for future benefit to humankind.

### China and Pak gave support to Mizo insurgency, says Zoramthanga in his autobiography

TRIDEEP LAHKAR AIZAWL, DEC 9 (PTI): Once a dreaded militant and now a leading politician in North East, Zoramthanga has completed writing his autobi-ography, which, he terms, will be a very controver-sial book and is likely to be objected by both Pakistan and Chinese governments because of detail accounts of their "support" to the insurgency in Mizoram.

The two-volume book, to be called 'MI-LARI' in Mizo language, is currently being trans lated into English and the Mizo National Front President Zoramthanga plans to make it into a Hollywood movie in future with the potential of being at par with the flicks on the life of legendary revolutionary Che Guevara. In an exclusive interview to PTI, the two-time Chief Minister of Mizoram expressed confidence of his party forming the next government in the state and said he will release the Mizo version of the book post the election results on December 11.

"I have written my

autobiography in two volumes. It will be really, let us say, a very controversial book. (It) may be objected by Pakistan gov-ernment and the Chinese



also," Zoramthanga said

The book will have detailed descriptions of his 20 years of under-ground days, which will in-clude how Dhaka had failed with the capture of Lieutenant General AAK Niazi's one lakh troops by Indian forces, he added.

Zoramthanga in-formed that MNF cadres were mixed with commandoes of East Paki-stan and were captured by Lieutenant General JS Arora, but later all escaped and went into jungle again.

The autobiography will talk about "how we made a dead devil James Bond type escape to East Pakistan through Rangoon and through the Arakan forest marching for days and days, how we met Bhutto and how we started peace talk with the Government of India in foreign countries", he added. Zoramthanga said it will also mention about how he and MNF insurgents had gone to China and "met Premier Zhou Enlai, Mao Zedong, Lin Biao and Chiang Ching" along with other Chinese

...and how we here got a help from the Chinese government in the form of arms etc. This has to be recorded. Some of the publishers dare not publish these things. But anyhow, I have written these in Mizo language and it is now being trans lated (into English)," the MNF President said.

Asked when he plans release the book, Zoramthanga said the printing of the two volto showcase everything that includes MNF's fights strategies against the Indian government... and many other sensitive information. "So in India, they may not like to make it into a Bollywood movie. But in the United States, where every-thing they dare to make it. I believe that it will be at some sort of par with the Che Guevara's those underground days mov-ie. And I will try to publish these and make it into a movie. And it will be a very good movie for the Hollywood people,"

Zoramthanga said.

After releasing the
English version of the book, if any Hollywood movie maker shows interest, he is ready to discuss and make the project successful, he said enthusiastically.

'MILARI' is the name of Zoramthanga's daughter. It is also a collection of initials of different

"MI stands Mizoram, LA stands for Lalpa that means Lord and R stands for arrangements -- Remruatna arrangement. The last one 'I' took it for myself. That is, Mizoram -- the lord's arrangements and my-self. And the book is going to be called MI-LARI," he added.

### India, China to resume military drills after one year gap



BEIJING, DEC 9 (PTI): India and China will resume their joint military drills after a oneyear gap on Tuesday in the southwest Chinese city of Chengdu to im-prove capabilities in fighting terrorism and promote mutual un-derstanding, officials said on Sunday.

The opening cere-mony of the drills will be held on December

11, they said.
Each side will send 100 troops to take part in the 7th India and China joint military exercises - 'Hand in Hand' which will focus on counter-terrorism operations Chinese Defence Ministry spokesman Col Ren Guogiang said last month.

The exercises will be held after a gap of one year as both the sides were locked in a 73-day standoff in Doklam in the Sikkim sector of the border in 2017.

The strained relations between the two sides later improved resulting in an infor-mal summit between Prime Minister Narendra Modi and Chinese President Xi Jinping in the Chinese city of Wuhan in April this year.

"The drill will promote understanding between the two militaries and improving

their capabilities in fighting terrorism," Col Ren said.

The exercises and conclude the on December 23, will include live shooting and adoptive and basic training, he said, add-ing that true to its name 'Hand in Hand', China and Indian militaries should also work hand in hand for the benefit of people in both the nation.



Human Rights are commonly understood rights as inalienable fundamental rights, to which a person is inherently entitled simply because she or he is a human being. Human rights are rights inherent to all human beings, whatever our nationality, place or residence, sex, national or ethnic origin, colour, religion, language, or any other status. All are equally entitled to their human rights without discrimination. These rights are interrelated, nterdependent and indivisible. Human rights, as such, are those rights which an individual being an individual is entitled to and which in a civilized society are recognized and enforced. The core element of such rights is universal

and consists of freedom, equality and liberty.

The Protection of Human Rights Act, 1993, (Central Act No.10 of 1994) defines the "human rights" in Section 2 (d) as under:

"Human Rights" means the rights relating to life, liberty, equality and dignity of the individual guaranteed by the Constitution or embodied in the International Covenants and enforceable by courts in India.

Universal human rights are often expressed and paranteed by law, in the forms of Treaties, Customary International Law, General Principles and other sources of International Law, International Human Rights law lays down obligations of Governments to act in certain ways or to refrain from certain acts, in order to promote and rotect human rights and fundamental freedoms of individuals or groups. The principle of universality of human rights is the cornerstone of international human rights law. This principle, as first emphasized in the Universal Declaration on Human Rights in 1948, has been reiterated in numerous international human rights convention, declarations, and resolutions. The 1993 Vienna World Conference on Human Rights, for example, noted that it is the duty of States to promote and protect all human rights and fundamental freedoms, regardless of their olitical, economic and cultural systems

### THE ORIGIN:-

The concept of human rights is as old as ancient concept of "Natural Rights" based on natural law. Various theories have been advanced by jurists with regard to origin and nature of human rights and fundamental freedoms. The earliest of these can be regarded as the Roman doctrine of 'Jus Naturale'. It means the law which nature herself established. God is the source of this law. Although the concept of human rights developed mainly because of the doctrine of natural rights under natural law, but it has originally evolved in the field of domestic legislation as in Magna Carta (1215). Petition of Rights (1628), the Habeas Corpus Act (1679), Bill of Rights (1689) and the Act of Settlement in England (1701) which may be regarded as landmarks in the path of liberty.

### CLASSIFICATION OF HUMAN RIGHTS:

Human rights can be classified and organised in a number of different ways, at an international level. The most nmon categorization of human rights are civil, political, nomic, social and cultural rights.

### DEVELOPMENT:-

The effect of Second World War compelled the international community to codify rules to protect human rights and the Charter of United Nations which came into force on 24th October, 1945 recognized that human rights have an international dimension and they are no longer solely a matter falling with in the exclusive jurisdiction of a State. This charter gave legal authority to United Nations to embark pon codification of human rights and the world's first International Human Rights documents viz., Universal Declaration of Human Rights, 1948 came to be adopted on 10 December, 1948 in the form a resolution passed by the United Nations General Assembly. Besides the preamble it consists of 30 Articles. It was during second half of the 20th century that human rights jurisprudence began to develop very fast. Number of International Conventions came into existence covering economic, social and cultural rights of the people living in this world. The Indian parliament also enacted, "The Protection of Human Rights

Act, 1993".

With the passage of time, human rights came to be interpreted having regard to International bill of Rights which refer to (i) Universal declaration of Human Rights (1948) (ii) International Covenant on Civil and Political Rights (1976) and (iii) International Covenant on Economic and Socio Cultural Rights (1976). From these three bills of rights which actually form the touchstone for implementing nan rights provisions, several Covenants and Acts owed and one such Act is "The Environment (Protection) Act, 1986 which has its origin in the U.N. Conference on Human Environment held at Stockholm.

### RELATION OF HUMAN RIGHTS WITH ENVIRONMENT:-

In recent years, the recognition of the links between man rights and the environment has greatly increased. The number and scope of international and domestic laws, judicial decisions, and academic studies on the relationship between human rights and the environr

All human beings depend on the environment in which we live. A safe, clean, healthy and sustainable environment

is integral to the full enjoyment of a wide range of human rights, including the rights to life, health, food, water and sanitation. Without a healthy environment, we are unable to fulfill our aspiration or even live at a level commensurate with minimum standards of human dignity. At the same time, protecting human rights helps to protect the environment. When people are able to learn about, and participate in, the decisions that affect them, they can help to ensure that those decisions respect their need for a

### SIKKIM STATE HUMAN RIGHTS COMMISSION:-

The Sikkim Human Rights Commission was established in October, 2008. The Human Rights Commission is supposed to be an institution with the responsibility of promoting and protecting the human rights of the people of the State, thereby fostering an administration for good governance.

The Commission is required to perform all or any of the functions mentioned in Section 12 read with Section 29 of the Protection of Human Rights Act. 1903 which

29 of the Protection of Human Rights Act, 1993, which

includes the following functions also:(i) Inquire, suo motu or on a petition presented to it
by a victim or any person on his behalf or on a direction
or order of any court, into complaint of violation of human rights or abetment thereof; or negligence in the prevention

of such violation, by a public servant.

(ii) Visit any jail or other institution under the control of the State Government, where persons are detained or lodged for purposes of treatment, reformation or protection, for the study of the living conditions of the inmates thereof and make recommendations thereon to

(iii) Spread human rights literacy among various sections of society and promote awareness of the safeguards available for the protection of these rights through publication, the media, seminars and other

(iv) Encourage the efforts of non-governmental ganizations and institutions working in the field of

man rights.
The State Commission is an autonomous and The State Commission is an autonomous and independent body working for betterment of human rights and is concerned about violation of such rights. The State Human Rights Commission is to facilitate and help the Government to discharge its duty of good governance and to promote the maintenance of the dignity and worth of human being. In order to avoid the violation of human rights it is imperative to provide quality service to the people of the State which is the ultimate object of a Welfare State as enshrined in the Directive Principles of the Constitution.
