## East Sikkim emerges best performing in North East in meeting sustainable development goals

With a score of 75.87, East Sikkim edged past Gomati district in North Tripura districts which scored 75.73 points in the North Eastern Region District SDG Index Report and Dashboard 2021-22 released by the NITI Aayog and Ministry of Development of North Eastern Region to-

A total of 103 districts in the eight states of the North East Council were evaluated for the Report and received points ranging from 53 to the highest received by East Sikkim at 75.87.

The NER District SDG Index& Dashboard, developed with technical support from UNDP, is a first of its kind in

the country as it focuses on it up as a unique policy-tool the districts, especially in our the North Eastern Region, the release adds.

The Index measures the performance of the districts of the eight states of Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura on the Sustainable Development Goals and their corresponding targets and ranks the districts based on

The index itself is based on NITI Aayog's SDG India Index - the principal and official tool for monitoring progress on the SDGs at the national and State and Union Territory levels and shares the common ethos of benchmarking performance and ranking on the SDGs to foster competition among the dis-

The index, the release adds, offers insights into the social, economic, and environmental status of the region and its districts as they move towards achieving the SDGs.

which has immense potential to measure district level progress, highlight critical gaps, facilitate resource allocation, and also provide a handy tool for policy makers in the North Eastern states, Ministry of DoNER and other Union Ministries.

The modular nature of the index makes it a policy tool and a ready reckoner for gauging progress of districts on the expansive set of the Global Goals, including health, education, gender, economic growth, institutions, climate change and environment, among others.

# SDF demands judicial enquiry into forged FIR scandal

Cikkim Democratic **3**Front today demanded a judicial enquiry headed by a retired High Court judge into the forged FIR scandal which has been playing out in the public domain for the past few days.

Addressing press conference, SDF vice-president [cheli morcha], Sakun Gurung, contended that since a big name of the present government had been dragged into the complaint, only an independent enquiry will be able to get to the truth and nail those behind the forged FIR which has led to despicable comments aimed at defaming a



woman.

She also expressed disappointment the deafening silence of the State Women's Commission on the issue even though a woman has been so publicly targeted.

"It is also very disappointing to see that there is still no word from the Chairperson of the State Women Commission on the matter. If the Chairperson cannot give justice to a member of the commission, then how can she give justice to the lay women of Sikkim," she contended.

ther alleged that the Sikkim Krantikari Morcha and its government have no genine concern for women.

She also lashed out

its disinterest in getting to the bottom of the case and effectively investigating who was behind the forgery or finding out how the FIR leaked.

SDF general secretary [cheli morcha], Divva Sharma, in turn challenged the Sikkim Police claim of the case having being closed on 22 July and went on to claim that she has evidence related to the allegations which she would share only with a judicial enquiry or the Sikkimey Naagarik Samaj which had released copies of the FIR and demanded action.

SDF also stands with Sikkimey Naagarik Samaj on the issue if they were genuine in their concern, they added.

The opposition-ruled, densely populated southern state is currently reporting the most number of coronavirus cases in the country and accounts for the second-highest national tally - unflattering headline numbers that PM Modi's BJP has seized upon as a reflection of bungled local leadership.

However, a Reuters analysis of national and state data, and interviews with epidemiologists and Kerala health authorities paint a different picture.

It shows the state's containment measures have helped to catch infections early, allowing authorities to better manage the illness and dramatically lower the death rate - a stark contrast to people dying in carparks and outside hospitals for lack of oxygen and beds in big cities like Delhi at the height of the health crisis a few months earlier.

"While the government may have its views on rapid antigen tests, it is important to consider that the state's stratesucceeded in not just fections and deaths. compared to one in 33 nationally," said Rajib Dasgupta, head of the Centre of Social Medicine & Community Health at New Delhi's Jawaharlal Nehru University.

The efficient detection rate and its population density at more than twice the national average explain the high number of cases in Ker-

All the same, at 0.5%, Kerala still has the lowest fatality rate among all but one thinly populated state. The national figure is 1.4% and it is 1.3% for the country's most populous state, Uttar Pradesh. The difference

comes down to Kerala's reliance on rapid antigen tests to detect and strictly isolate infected people at home, an approach the health ministry has sharply criticised but which state officials argue has helped them to better allocate hospital beds and oxygen supplies for those who really need them.

The government-recommended RT-PCR tests are more accurate but take longer to produce results, meaning by the time a positive COVID-19 case is confirmed the infected person is more likely to have developed severe symptoms and passed it on to others in a

Kerala's rapid test tion which then narrows the virus' path to infections, state officials say. These factors, along

with the strained medical resources across much of India, largely explain why the overall national death rate is much higher than in the state. Kerala officials also

say a state-run support service that includes consultation, phone provision of drugs and pulse oximeters that detect blood oxygen levels for people recovering at home provide a bulwark in the battle against the disease.

Delhi had a similar support structure but it collapsed when cases surged.

"We do have a different model and our fatality rate shows our model is on the right track," Kerala Health Minister Veena George told Reuters.

But Kerala officials acknowledge that the fast-evolving pandemic can undo even the best thought-out plans unless authorities remain nimble and flexible.

When Reuters recently visited Kerala's most populous Malappuram district, which is reporting the greatest number of infections in India, a quarter of the 344 COVID beds in its biggest hospital were vacant and oxygen supply was ample.

## Make 'bumper-to-bumper' insurance mandatory: Madras HC

CHENNAI, AUG 26 (PTI) has ruled that "bumperto-bumper" insurance should be mandatory whenever a new vehicle is sold, from September

This must be in addition to covering the driver, passengers and owner of the vehicle, for a period of five years.

Thereafter, the owner of the vehicle must be cautious in safeguarding the interest of driver, passengers, third parties and himself/herself, so as to avoid unnecessary liability being foisted on the owner of the vehicle, as beyond five years, as on date there is no provision to extend the bumper to bumper policy, due to its non-availability, Justice S Vaidyanathan said in a

recent order. The judge was allowing a writ petition from the New India Assurance Company Limited in Avalpoondurai, challenging the orders dated December 7, 2019 of the Motor Accidents Claims Tribunal, Special District Court in Erode.

tion was only an "Act Policy", which would cover only the risk that might be confronted by a third party to the vehicle and not its occupants. The coverage for an occupant of the vehicle could be extended upon payment of additional premium by the owner of the car, the insurance company con-

tended. The judge passed this order, which would go a long way in coming to the aid of lots of accident victims. He, however, could not come to the rescue of the claimants in this case, as the vehicle, in which their breadwinner was travelling/driving, was covered only with third-party insurance.

Left with no other choice but to deprive the claimants of the accident benefits ordered by the Motor Accidents Claims Tribunal in Erode, the judge quashed the order of the Tribunal awarding a compensation of Rs 14.65 lakh to K Parvathy and three others.

Before parting with this judgment, the judge said that it is saddening to point out that when a vehicle is sold, the purchaser/ buyer is not clearly informed about the terms of policy and its importance. Similarly, at the time of buying the vehicle, the buyer is also not interested in thoroughly understanding the terms and conditions of the policy, as he/ she is more concerned about the vehicle's performance and not about the policy.

When a buyer is ready to pay a huge amount for purchase of a vehicle, it is really shocking as to why he/ she is not interested in spending a paltry sum to take a policy so as to safeguard himself/ herself and others.

"Therefore, this court directs that whenever a new vehicle is sold after

"Still witnessing 2nd Covid wave": Centre warns of festive season spike

New Delhi, 26 Aug [NDTV]: Parts of India are still in the midst of the second Covid wave that began earlier this year, the Union Health Ministry said today. It warned of a possible spike in the weeks ahead as a result of the approaching festive season.

"The second surge has not vet concluded. It is not over and, therefore, we have to maintain all necessary precautions, particularly in light of our experience that after every festival we see a spike," Union Health Secretary Rajesh Bhushan said today at a press briefing in New Delhi.

"The coming months of September and October are crucial for us because we would be celebrating a few festivals. Thus, festivals have to be celebrated with Covid-appropriate behaviour."

Mr Bhushan's comments came a day after Kerala reported a huge surge of over 30,000 new cases, which was dubbed "Onam Spike" by the state government. The state celebrated its annual harvest festival last Saturday.

Over 46,000 new cases were reported in the country in the past 24 hours. Of these, 58 per cent were reported from Kerala while the rest of the states were still showing a declining trend, Mr Bhushan.

## **Allow Students to Think**

Open doors, don't spoon-feed

What Sikkim requires its schools to create are sensible citizens who can think for themselves, weigh options and take practical decisions. In these times of fake news and manufactured consent, an open mind willing to learn and analyse will be required to side-step the shackles of time-serving mediocrity. The pandemic and its attendant compromise of online education might just end up doing some good if we could leverage the potential it contains to allow students to explore and discover on their own. And we would all wish that for the next generation, won't we? The one place where clear thought can be honed into an instinct is the classroom [or through the screens in the present times] - allow the education system to adopt genuinely learning-friendly practices and future generations will dazzle with their confidence and carry Sikkim forward. Don't do so, and a majority will remain hesitant and unsure, seeking out charlatans to form their beliefs, ideologies and pursuits.

If education was approached with the aim to open minds, not suppress inquisitiveness, the quality that everyone seeks to infuse into the system will become a reality. What the present system delivers, and this is a national malaise, is infectious indecisiveness. Students are not encouraged to enquire or seek clarifications and every effort is made to drill them into an army of monotony, their uniqueness and differences brushed over by soul-sapping rigour and mind-numbing routine. It is rare to find students with wide-ranging interests any more. In fact, the syllabus and pattern of education does not even allow children the space to develop any meaningful interests any more. Even when these interests are displayed at annual day functions they are mostly hobbies decided for them by the teachers or "talents" singled out by them for display. Student projects for interschool competitions are prepared by teachers and every intonation of a poetry recital for competition dictated to them. We just won't allow them to make their mistakes and learn from them or stand by the side in case assistance is required; we believe that we are serving them by hand-holding them through their years in school, college, university, and if we have the "contact", even their employment.

More and more teachers are so scared that students will "fail" them that they end up spoon-feeding them. At the other extreme are teachers who see no hope in their students so they don't get involved at all. In both scenarios, the student meets the same fate – a confidence stamped down even before it could develop. A good way to start delivering Sikkim a more confident generation would be to allow students to discover more things by themselves and in doing so, they will also discover the confidence required to think and decide for themselves later in life

## Taliban's Religious Ideology - Deobandi Islam - has roots in colonial India

Pollowing the Taliban's rapid taking of power in what it describes as a reestablished "Islamic Emirate of Afghanistan," fears of a certain kind of Islamist ideology being brought back have led a large number of Afghans to flee, or fear for their lives.

The Taliban were known for their oppressive rule. They ruled Afghanistan from 1996 to 2001, at which point they were pushed out of power by U.S. and British troops. Under the Taliban rule, religious minorities and other Muslims who did not share their fundamentalist understanding of Islam were not tolerated. The Taliban also severely restricted the rights of women and girls.

As scholars who research ethno-religious conflicts in South Asia, we have studied the origins of the Taliban's religious beliefs. The roots of this ideology – Deobandi Islam – can be traced to 19th century colo-

COLONIALISM AND ISLAM

Deobandi Islam emerged in India in 1867, 10 years after a major Indian nationalist uprising against the rule of the British East India Company.

Two Muslims clerics, Maulana Muhammad Qasim Nanautawi and Maulana Rashid Muhammad Gangohi, were behind the setting up of the Deobandi school. Their aim was to indoctrinate Muslim youth with an austere, rigid and pristine vision of Islam. At its heart, Deobandi Islam was an anti-colonial movement designed to revitalize Islam.

This school of Islamic thought had a very particular understanding of the faith. The Deobandi brand of Islam adheres to orthodox Islamism insisting that the adherence to Sunni Islamic law, or sharia, is the path of salvation. It insists on the revival of Islamic practices that go back to the seventh century – the time of the Prophet Muhammad. It upholds the notion of global jihad as a sacred duty to protect Muslims across the world, and is opposed to any non-Islamic ideas.

The first madrassa – or Islamic school – to educate Muslim youth in the Deobandi tradition was set up in the north Indian state of present-day Uttar Pradesh toward the end of the 19th century.

The Deobandi school system spread over the next several decades and attracted Muslim youth in different parts of the Indian subcontinent. For instance, the Deobandi tradition became the most popular school of Islamic thought among the Pashtuns, an ethnic group living in an area on either side of the Afghanistan-Pakistan border.

Pashtun leaders played an instrumental role in establishing and expanding the Deobandi curriculum and tradition in the Pashtun belt across the Durand line, the colonial border separating British India from Afghanistan.

FUNDING AND ENROLLMENTS

After British India was partitioned in 1947 between India and Pakistan, many prominent Deobandi scholars migrated to Pakistan, setting up a large number of madrassas.

With the independence of India and Pakistan, the school placed its full attention on training the students within this fundamentalist Islamic tradition.

In the years and decades after the independence of Pakistan, Deobandi madrassas spread across Pakistan, and one of their principal causes of political activism became India's treatment of Muslims in the Indian-controlled portion of Jammu and Kashmir.

According to one estimate, by 1967 there were as many as 8,000 Deobandi schools worldwide and thousands of Deobandi graduates mainly in India, Pakistan, Bangladesh, Afghanistan and Malaysia.

At first, the Deobandi madrassas tended to be poorly funded. One event that greatly boosted the growth of enrollment in Deobandi madrassas was the Soviet invasion of Afghanistan in 1979.

The CIA's covert involvement in the war fueled Islamic militancy and inadvertently helped organize and orchestrate a resistance movement mostly composed of ardent religious fighters. A substantial number of these Afghan fighters were drawn from the Deobandi madrassas, especially the Pashtuns, who played a leading role in the resistance.

During that time, the Deobandi madrassas also gained financial assistance. This assistance, as scholar Thomas Hegghammer writes, came mainly through American aid dollars meant for Pakistan and money from Saudi Arabia.

Saudi leaders, in fact, used the influence of their money to push their own interpretation of Islam – Wahhabism – at the Deobandi madrassas. Wahhabism is a deeply conservative form of Islam that believes in a literal interpretation of the Quran. At this point, the Deobandi madrassas moved far away from their religious roots.

TIES OF KINSHIP

Following the Soviet invasion in Afghanistan in 1979, millions of Afghan refugees, in several waves, took shelter in Pakistan, especially in its Pashtun belt.

Keen on obtaining a strategic toehold in Afghanistan, Pakistan actively recruited young men in refugee camps, imbuing them further with religious zeal to fight the Soviets

Driven out of their homes in Afghanistan, the dispossessed young Afghans thrived in the refugee camps, in part due to ties of ethnicity as Pashtuns. Drawn to a religiously based offensive against what they deemed to be an infidel, or foreign occupier, they became ready recruits to the anti-Soviet cause.

Many of the Taliban's key leaders and fighters, including Mullah Omar, the founder of the organization, had studied in the Deobandi seminaries in both Afghanistan and Pakistan.

AFTER THE CIVIL WAR

After the Soviets withdrew from Afghanistan in 1989, the fighters continued to enjoy the support of Pakistan's security establishment and private actors for financial assistance

When Afghanistan plunged into a civil war in 1992, various factions of the anti-Soviet resistance vied for power. Among them was the Northern Alliance, a group that India and Russia had backed and was under the leadership of an ethnic Tajik, Ahmed Shah Massoud, who resisted the Taliban and acquired an almost mythic status.

However, as scholar Larry P. Goodson writes, with the crucial and substantial assistance of Pakistan's security establishment, the Taliban emerged victorious and seized power in 1996.

Once in power, they imposed their distinctive brand of Islam on the country – far removed from its religious roots in colonial India.

# Afghanistan: What Responsibility Do Other Nations Have Towards People Fleeing the Taliban?

Whith the Taliban back in Kabul, thousands of Afghan nationals who serviced the ousted government, the US and its allies are desperately attempting to seek asylum. Many attempted to board US jets at an airport in Kabul, some even clinging to the outside of aircraft as they took off. Videos show gruesome scenes of people falling from the sky after trying to escape.

The US has pledged to accept up to 22,000 Afghan servicemen and their families. Among the allied countries, Canada will accept 20,000 people and the UK "up to" 20,000 in the next few years, beginning with 5,000 in the immediate term.

German Chancellor Angela Merkel is pushing for commitments on helping people who serviced the Afghan government, but nothing has been confirmed yet. France and some other EU member states have pledged to resettle Afghan refugees in relatively small numbers.

The US has also been asking other nations, such as Qatar and Ghana to accept people on its behalf. This "external management" approach has been adopted by European member states in recent years as a way to delay or block asylum-seeking at their own borders.

It's important to note that the current evacuation is largely focusing on specific groups of people rather than anyone fearing persecution more generally. Beyond those who have worked for the former government and allies, there are many more people who have a legitimate case for asylum.

LAST-MINUTE SCRAMBLE

Because the Taliban took control of Kabul much faster than the US and allied forces had anticipated, evacuating their troops, diplomats and nationals has become the top priority. Many Afghan servicemen who assisted the allied forces in Afghanistan as interpreters, suppliers, contractors and their families have been left stranded.

By focusing support largely on people who have travel documents and documentary proof of providing services to allied forces, these missions will necessarily leave many people behind. That includes a huge number of ordinary people who have a legitimate fear of oppression under the Taliban – particularly women.

Despite high levels of public concern about the fate of people left in Afghanistan, the wider asylum schemes being proposed by western nations come with significant caveats. The terms of the UK and European resettlement policies are vague, but the resettlement policies generally cover asylum seekers who have been granted refugee status by the United Nations High commissioner



for Refugees (UNHCR) or any state. It may be that Afghan asylum seekers have to seek refugee status in neighbouring states first to be eligible for resettlement schemes. There are already millions of Afghan refugees in Pakistan and Iran.

And while the UNHCR prioritises vulnerable groups such as unaccompanied children and single mothers, it generally operates on a first-come, first-resettled basis. So any Afghan asylum seekers still in the country, including those desperately waiting outside the Kabul airport, may not be eligible for these resettlement schemes any time soon.

PROTECTION FROM INHUMAN TREATMENT

The Taliban has announced an amnesty for all its adversaries, including those who served the ousted government and allied forces. But the situation outside the Kabul airport remains chaotic and dangerous.

One of the main grounds for seeking refuge in the US and allied states is knowing that there is a foreseeable threat of inhuman and degrading treatment. In such circumstances, Article 33 of the Refugee Convention (1951) and Article 3 of the Convention against Torture (1984) prohibits states from returning asylum seekers to a territory. The European Court of Human Rights and the Inter American Court of Human Rights have, in multiple cases, ruled that nations who sent people back to unsafe places to face such treatment were responsible for their suffering.

In the case of Afghan asylum seekers, the immediate threat to their lives might have been averted after the Taliban's announcement of amnesty. Nevertheless, there remains a significant threat that basic human rights will be violated under the new regime. A particular point of con-

cern is how the legal system will operate under the Taliban.

During the last Taliban rule, men and women were often tried in front of unofficial, ad-hoc courts and punished without the right to appeal. The Taliban police could whip women in public if they were not wearing a burka or if their knees were visible. Men could face punishment for not having a beard.

It is because of this history that people have a legitimate fear of inhuman and degrading treatment now that the Taliban have returned. Afghan nationals are clearly therefore eligible to seek refuge in the US, the UK and EU member states, if they arrive at the borders of these states.

However if these people remain inside Afghanistan – rather than making it across any borders – it is for the US and allied states to decide whether to evacuate them on humanitarian grounds. If not, they will have to find their way across a border.

The US has announced special immigrant visas for Afghan servicemen. Similarly, the UK has agreed to allow the Afghan servicemen to travel without passports

Nonetheless, the US and allied states are showing reluctance when it comes to evacuating ordinary Afghan asylum seekers despite the existence of a foreseeable threat of inhuman and degrading treatment. The situation warrants a larger-scale evacuation on humanitarian grounds. Until the Taliban regime shows satisfactory policies on basic human rights, protecting Afghan asylum seekers will remain a responsibility of the international community, particularly the US and its allies.

Afghanistan's Tokyo Games **Paralympians** safely evacuated, says IPC

TOKYO, AUG 26 (PTI): Afghanistan's two para-athletes, who were forced to pull out of the Tokyo Paralympics because of Taliban's takeover of their country. have been safely evacuated, the International Paralympic Committee (IPC) said but declined to comment on their whereabouts.

The two taekwondo athletes, Zakia Khudadadi and Hossain Rasouli, were due to compete at the Tokyo Paralympics but were forced out of the Games after the Taliban's takeover trapped them in their own coun-

When asked about the athletes and the possibility they will compete at the Games, IPC spokesman Craig Spence said, "The situation hasn't changed."

"We displayed the flag in the Opening Ceremony as a sign of solidarity. The two athletes are outside of Afghanistan now, they've been evacuated. We know where they are," he added at the daily press briefing.

The Afghan athletes were forced to withdraw from the Games as all flights out of capital Kabul got cancelled after the Taliban seized control of the country.

Spence added, "Our priority at the moment is not to focus on sport, it's their health and wellbeing, and we're working with relevant people to ensure that.

"What's important is they're safe, and they are."

Before the Games began, the IPC confirmed that the Afghan athletes would not be able to compete in Tokyo.

The Afghan flag, howfeatured during Tuesday's opening ceremony as the IPC stood by the country.

IPC chief Andrew Parsons had said on Monday the Tokyo Paralympics opening ceremony would feature the flag of Afghanistan as a "sign of solidarity".



## These days I bowl less in nets and save it for matches: Anderson

LEEDS, AUG 26 (PTI): Ageless English pacer James Anderson says the secret to his longevity in Test cricket lies in cutting down on his time at the nets to save it for the matches.

Anderson's masterclass was full on display in an awe-inspiring spell of 8-5-6-3 with the new ball as England bowled India out for 78 after Virat Kohli opted to bat in the first Test here on Wednesday.

"As I get older, I feel like I have to work that little bit harder in the gym. I feel like I bowl less in the nets, and try to save it for when it matters in the middle," the 39-year-old said after the first day's play.

"The biggest test in Test cricket is mentally getting yourself up for bowling big spells and playing in big games. It's about keeping yourself switch on through games and switch off when you are not bowling -- that's something I've always had."

Just a week ago during the Lord's Test, Anderson, having grabbed a five-for in the first innings, was overbowled in the second as the Indian tail frustrated the hosts with its remarkable resilience and invaluable runs.

"Walking off the pitch during the second Test at Lord's, pretty much everything hurt, but that gives so much satisfaction knowing that I have put a shift in for the



team."

Asked about his problematic right shoulder, he said: "It still hurts. You just find a way of putting up with it. it's just part and parcel of the job."

Anderson said that after all the talk during the Lord's Test, the aim here was to "shut the noise" and focus on the job.

India took a 1-0 lead at Lord's riding on the tail-enders' brave display with the bat followed by their excellent bowling.

"We have made a conscious effort of trying to just focus on us, on what we do well and try and ignore everything else, the outside noise or wherever there might be there's a real focus on what we do well," Anderson said.

He did admit that they had a chat in the dressing room.

"Yeah, I think there was a bit of chat about that. We were just making a point of trying to focus on what we do well.

"I think that you know the first three or four days at Lord's, we probably played brilliantly and maybe until day three, and then after that, just at times it did affect a little bit.

"We're individuals, at the end of it. We have made a conscious effort to try and focus only on us, what we do well: try going on, and make sure and ignore everything the seventh time in Tests.

else, the outside noise, or whatever that might be, going on."

At Headingley, Anderson took off by dismissing KL Rahul with the fifth ball and then deceived Cheteshwar Pujara with an incoming delivery that swung away, but the biggest breakthrough came when he won his mini battle with Indian skipper Virat Kohli.

"I think so (it was special). We have had some great battles over the years. He is someone you want to keep quiet. Especially, in a five-match series, if he gets going he can be very disruptive," Anderson said of Kohli after dismissing him for

"I think the way we have bowled to him throughout the series has been very good. We just got to keep doing that and keep him quiet

as often as we can."

In reply, England openers Haseeb Hameed (60) and Rory Burn (52) remained unbeaten as the scorecard read 120 for no loss with a lead of 42 runs after day one.

Rating England's show as one of the best, Anderson drew parallel with their famous Boxing Day Test in 2010 when they had skittled out Australia for 98 before Andrew Strauss and Alastair Cook put on a 157-run opening stand. "It doesn't get much better than that. These days don't come around very often, so you just have to be happy when they do.

'The only difference with Melbourne is that I was keen to bowl there and I wasn't today for some reason. I was trying to tempt Joe into batting.

"But losing the toss, being asked to bowl and then putting in a performance like that, it doesn't get much better. We've talked about trying to bowl as a unit, as a group, and we just absolutely nailed it. With both ball and bat we've displayed exactly what we wanted to do."

Showering praise on their opening duo, he said: "It was outstanding batting and exactly what we have been asking for."

"When you bowl someone out for less than 100 you're never quite sure whether you've bowled well or if the wicket is not as good as you think it might be. So to see the way they both went about their business, just felt so calm in the dressing room.

"The way they were so measured, they were solid in defence, left well and put away the bad ball when they got one. I just thought it was brilliant Test match batting."

Anderson was particularly happy for his former Lancashire teammate Hameed who shrugged off his Lord's disappointment with a half century.

## Japan suspends 1.63M doses of Moderna over contamination

TOKYO (AP): Japan suspended use of about 1.63 million doses of Moderna vaccine Thursday contamination was found in unused vials, raising concern of a supply shortage as the country tries to accelerate vaccinations amid a COVID-19 surge.

The health ministry said contamination was reported from multiple vaccination sites. Some doses might have been administered, but no adverse health effects have been reported so far, officials said.

Takeda Pharmaceu-

tical Co., a Japanese drugmaker in charge of sales and distribution of the vaccine in Japan, said it decided to suspend use of doses manufactured in the same production line as a safety precaution. It asked Moderna to

conduct an emergency investigation and told medical institutions and organizers to stop using the vaccine produced in Spain and shared the production numbers that may be affected.

## Greek health care workers protest against mandatory vaccines

ATHENS, GREECE (AP): Workers at public hospitals in Greece held a five-hour work stoppage Thursday to protest a government decision vaccination

against COVID-19 mandatory for all health care workers in the public and private sector.

About 300 hospital workers rallied outside the health ministry in Athens to protest the measure, which goes into effect on Sept. 1. The government has made clear that no extension will be grant-

Those working in the public and private health care sector and those working in care homes who haven't received at least one dose of the vaccine by that date, or who don't have a certificate of recent recovery, will be suspended from work.

The public hospital workers' union said that while it supports the vaccines, it opposes making them mandatory.

"We will not leave defenseless the health care and social care workers who have a personal right to vaccination," the union said. "Patients are not at risk of catching the coronavirus from health care workers. Hospitals are filling up again with patients suffering from the coronavirus which they caught in the com-



Health Minister Vassilis Kikilias said those who were protesting against the measure were "small minorities" who frequently protest about an assortment of issues related to the national health system.

"They are in the opposite direction of the majority of Greek society, which wants to protect public health," he said.

Speaking on Skai TV, Kikilias announced the start of a pilot program to have mobile vaccination units administering shots in town squares outside churches. The program would start this

Sunday on the island of Crete, the minister said, and would expand to the country's main cities.

Greece has been seeking to boost its vaccination drive with a series of incentives. It has been seeing a steady increase in confirmed coronavirus cases and deaths, as well as hospitalizations and intubations, over the past several weeks. ICU beds for COVID-19 patients are more than 69% full, while regular COVID-19 wards are 45% full, health ministry figures

On Tuesday, Kikilias

said that "significantly more than 90% of patients who are in COVID ICUs are unvaccinated," without specifying whether some of them are unvaccinated. had received one vaccine dose and weren't yet fully

Looking at 'options' on diplomatic presence in Afghanistan after Aug 31: US



WASHINGTON, AUG 26 (PTI): The US has said it is looking at a number of "options" on its diplomatic presence in Afghanistan after the August 31 withdrawal deadline.

August 31 is the cutoff date set by both the US and the Taliban for America's pullout from the war-torn country.

"With regard to our own potential presence going forward after the 31st, we're looking at a number of options, Secretary of State Antony Blinken told reporters at a press conference on Wednesday.

"I'm sure we'll have more on that in the coming days and weeks, but we're looking at a variety of options, he said, referring to America's diplomatic presence in Afghanistan after the withdrawal deadline.

Over the next few days, Blinken said, the focus of the US is on getting American citizens, other Afghan partners, third-country partners -- who were working in Afghanistan with the US -- out of Afghanistan and to safety.

And for that purpose, "whether we like it or not", it's important to work with the Taliban, who are "largely in control of Afghanistan", to try to facilitate and ensure the departure of all those who want to leave, Blinken said.

"And that has actually been something that we've been focused on from the beginning of this operation, because as a practical matter it advances our interests, he added.

According to Blinken, the US has been engaged with the Taliban for some time diplomatically going back years in efforts, to try to advance a peaceful settlement of the conflict in Afghanistan.

There's still talks and conversations way even now between the Taliban and former members of the Afghan government with regard, for example, to a transfer of power and some inclusivity in a future government. I think it's in our interest where possible to support those efforts, he said.

Going forward, Blinken said, the US will judge its engagement with any Taliban-led government in Afghanistan based on one simple proposition: America's interests, "and does it help us advance them or

vance the enduring interests we will have in counterterrorism, the enduring interest we'll have in trying to help the Afghan people who need humanitarian assistance, in the enduring interest we have in seeing that the rights of all Afghans, especially women and girls, are upheld, then we'll do it, he said.

But fundamentally, the nature of that engagement and the nature of any relationship depends entirely on the actions and conduct of the Taliban. Blinken asserted.

If a future government upholds the basic rights of the Afghan people, if it makes good on its commitments to ensure that Afghanistan cannot be used as a launching pad for terrorist attacks directed against us and our allies and partners, and in the first instance, if it makes good on its commitments to allow people who want to leave Afghanistan to leave, that's a government we can work with, he said.

If it doesn't, we will make sure that we use every appropriate tool at our disposal to isolate that government, and as I said before, Afghanistan will be a pariah, said the top American diplomat.

## Israel to allow goods into Gaza in move to ease tensions



JERUSALEM (AP): Israel said that it would be easing commercial restrictions on the Gaza Strip and expand entry of goods to the Palestinian enclave following days of heightened tensions.

The announcement came after hundreds of Palestinians demonstrated Wednesday near the Israeli border, calling on Israel to ease a crippling blockade days after a similar gathering ended in deadly clashes with the Israeli army.

Hamas kept the crowds from approaching the barrier, and the protests ended without a repeat of Saturday's intense clashes that left one Palestinian dead and an Israeli border policeman critically injured after being shot from point-blank range.

The defense ministry body in charge of Israel's crossings with the Palestinian territory said in a statement late Wednesday that it would increase imports of new vehicles, goods and equipment for civilian projects in the Gaza Strip, and issue more permits for Gazan businessmen to enter Israel starting Thursday. The easing of restric-

tions would be "conditional upon the continued preservation of the region's security," and could be further expanded if the border situation improves, the body, known as COGAT, said.

Hamas officials said Egypt would also be partially reopening its key border crossing with the

Gaza Strip Thursday, after closing it in a bid to persuade Hamas, the Islamic militant group ruling the territory, to reimpose calm.

Egypt has been trying to broker a long-term cease-fire between the enemy sides since May's 11-day war that killed around 260 Palestinians and 13 people in Israel.

Israel and Hamas have fought four wars and numerous skirmishes since 2007, when the militant group seized power in Gaza in an armed coup following its victory in the Palestinian elections. Israel and Egypt imposed a devastating blockade since Hamas took control, which Israel says is necessary to keep Hamas from rearming.

The territory has no civilian airport and those who can afford a plane ticket must catch their flights in neighboring Jordan. But just outside the northern city of Nablus, a pair of twins is offering people the next best thing.

Khamis al-Sairafi and brother Ata have converted an old Boeing 707 into a cafe and restaurant for customers to board.

"Ninety-nine cent of Palestinians have never used an airplane. Only our ambassadors, diplomats, ministers and mayors use them. Now they see an airplane and it is something for them." said Khamis al-Sairafi.

After a quarter century of effort, the brothers opened "The Palestinian-Jordanian Airline Restaurant and Coffee Shop al-Sairafi" on July

Families, friends and couples turned up for drinks in the cafe situated below the body of the plane. Many others came to take photos inside at a price of five shekels (about \$1.50) per person.

Customers they were motivated to visit after seeing pictures of the renovated plane circulating online. "For a long time, I have wanted to see this place. I wish I had seen this place before it was turned into a café," said customer Majdi Khalid.

The congress came months after Kim during another political conference showed unusual candor by acknowledging that his plans to improve the economy weren't succeeding.

Despite its economic troubles, the North has so far rejected the Biden administration's overture to resume nuclear diplomacy, saying that Washington must discard its "hostile" policies
