## Sikkim records one more death and 64 new COVID cases

**SUMMIT REPORT** GANGTOK, 24 SEPT:

**∼**0VID-19 claimed one more life in Sikkim today, when an 82-yearold resident of Daragaon, Jorethang, passed away Thursday morning, eight days after having tested positive for the virus on 16 September.

The patient was reportedly discharge on his own request on 21 September and was under home isolation when he passed away.

With this, Novel Coronavirus has claimed 31 lives in Sikkim even as 64 new cases were detected from samples collected and tested on Wednes-

cases in Sikkim has now increased to 607 and the state's total COVID-19 caseload has bulked up to 2,611.

Among the new cases, 59 have been reported from East district, one from West Sikkim, one from North District and three from South District.

Also on Wednesday, 31 more patients were discharged from covid care centres taking the number of COVID patients discharged thus far in Sikkim to 1,973.

### **COVID-19 tally** in India crosses 57-lakh mark

NEW DELHI, SEP 24 (PTI): India's COVID-19 caseload breached the 57-lakh mark, while over 46 lakh people have recovered from the disease, pushing the national recovery rate to 81.55 per cent, according to the Union Health Ministry data updated on Thursday.

The total coronavirus cases mounted to 57,32,518 with 86,508 people testing positive in a day. The death toll climbed to 91,149 with 1,129 people succumbing to the disease in a span of 24 hours, the data updated at 8 am showed.

The total recoveries surged to 46,74,987 in the country so far.

The COVID-19 case fatality rate due to the coronavirus infection was recorded at 1.59 per cent.

There are 9,66,382 active cases of coronavirus infection in the country which comprises 16.86 per cent of the total caseload, the data stated.

India's COVID-19 tally had crossed the 20lakh mark on August 7. 30 lakh on August 23, 40 lakh on September 5 and and it went past 50 lakh on September 16.

According to the ICMR, a cumulative total of 6,74,36,031 samples have been tested up to September 23 with 11,56,569 samples being tested on Wednesday.

The 1,129 new deaths include 479 from Maharashtra, 87 from Uttar Pradesh, 64 from Punjab, 63 from Tamil Nadu, 61 from West Bengal, 45 from Andhra Pradesh, 42 from Madhya Pradesh, 38 from Karnataka and 36 from Delhi.

A total of 91,149 deaths have been reported so far in the country including 33,886 from Maharashtra followed by 9,010 from Tamil Nadu, 8,266 from Karnataka, 5,506 from Andhra Pradesh, 5,299 from Uttar Pradesh, 5.087 from Delhi, 4,544 from West Bengal, 3,367 from Gujarat, 2,990 from Punjab and 2,077 from Madhya Pradesh.

The health ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

"Our figures are being reconciled with the Indian Council of Medical Research," the ministry said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.

## Rangpo-Rorathang road blocked

**SUMMIT REPORT** Gangtok, 24 Sept:

Dangpo-Rorathang  $\mathbf{\Gamma}$ road has been blocked after110 meters of road was washed away at 4th Mile Bhasmey. The road connects Rhenock, Rongli, Pakyong, along with more than 50 villages in the area.

Heavy and continuous rainfall in the past few days led to the incident on Wednesday. The road sees a lot of traffic due to the several pharma companies and two hydel power projects being located on the route.

In case of emergencies, commuters are now crossing the area on foot.

SDM Rangpo, Himmat Rai, Sikkim Krantikari Morcha Drivers Front, East District president, Roshan Mangar, and Local Panchayat Members visited the spot today.

SDM, Mr Rai mentioned that a survey report will be sent to the concerned authorities and action will accordingly be taken. He also said that movement of trucks with heavy loads together with incessant rain could have caused the landslide which washed away the road formation.

Local residents have said that a bailey bridge should be constructed as an immediate solution.

results arrived on Thursday and he has isolated himself in his official quarters in Mangan. He also informed that all primary contacts have been asked to isolate themselves as well.



## Where the Sikkim Government failed and where it passed in its Covid-19 Exam

ikkim enjoyed a rare national spotlight for its zero Covid-19 status until May 23 this year when the first case was detected. Fleeting as it might have been, Sikkim's Covid-19 story was worthy of a 'hurried mention' in the national media. We watched our Chief Minister, PS Tamang and others giving interviews to various TV channels with pride. The joy and pride soon passed, giving way to fear, frustration and even mourning. In four months, Covid-19 positive cases have crossed 2500. And now the state is all set to open its borders for interstate transportation. It would be worthwhile to revisit the six months of our Covid-19 battle for a rapid evaluation. Here are three major areas where the state government did well.

Implementing a complete ban



inkling of doubt, thinking that the

government was too late. I had

written, "The state administration,

in a delayed reaction to the spread

of the coronavirus threat and ris-

hope it is not too little too late." I was wrong. It was not too late. PM Modi announced a nation-wide complete lockdown a week later -Sikkim was leading the way. Secondly, we can see that the

priority of the government was spot on. Chief Minister Goley said that the lives and health of the people of Sikkim come above all else. This was a time for a cardinal choice between economy and life. Sikkim chose life.

The third area of exemplary ing public frustration and fear, performance was the way contract on the entry of domestic tourists announced a partial lockdown. I tracing was conducted initially af-

ter positive cases were detected. Every single person was tracked down and brought under quaran-

The saying - 'well begun is half done' is not a propositional statement. It is merely a cheer leader's shout. Sikkim's good beginning probably instilled unnecessary overconfidence in us. Very soon, lapses began to increase both in number and proportion. Now let me talk about three areas where the government's performance was not up to scratch.

Failure to facilitate a composite

Sikkimese force against Covid-19 was unfortunate. What the BJP government did at the centre, SKM did in the state. They isolated the opposition parties. The government should have brought all the political parties on board. The government's energy was diverted to answering oppositional criticism and questions resulting in an overall distracted focus on the real enemy - namely Covid-19. An all-party approach could have benefited Sikkim by way of collective wisdom. This was not a time for politicking – it was a time for a united, determined battle of life and death.

The second biggest failure was the administrative failures at various levels. The premature celebration and over-confidence during the zero Covid-19 days were symptoms of systemic lapses. The government had made all the right decisions at the right time. However, what went unnoticed by

the governmental radar was the utter negligence on the part of a few. The Melli in-in-out-out fiasco, the Rongli GREF camp debacle and the IT department's disaster will remain as indelible stains on the administration for years to come.

To me, personally, the third major lapse was the delay in fashioning Sikkim specific Covid-19 protocols. We have depended on centrally designed protocols and guidelines for far too long. They are highly significant ones but tailoring certain guidelines to meet our local nuanced situation is equally important. Some notifications released by the Sikkim government seem emotionally driven and devoid of scientific rationale.

Finally, I will always maintain that our initial success zero covid-19 status was overhyped. We were merely enjoying the temporary bliss of locational advantage. Along with us, many Northeastern states like

## Landslide in Saurini leaves 81 families in danger

Landslides in Sauriini area under Mirik sub-division of West Bengal due to continuous rainfall of the past few days have forced the evacuation of 27 houses at Ramite Dara following orders of Mirik SDO Ashwini Kumar Roy.

81 families in four villages have been affected due to this landslide.

A connecting bridge has been washed away due to which 21 families of Bamrang village have not been able to leave the village. The affected villages are Upper Saureni, Dhad village, Bamrang village and Deurali.

GTA chairperson Anit

Thapa said, "I went to inspect the site. Mr. LB Rai,

Chairman of Mirik Municipality, Mr. Arun Sinji, Liaison Officer of GTA was also present during the inspection. Due to the positive initiative of the Disaster Management Committee, 27 families have been able to move to safer places. I will soon send an engineer to the area for the reconstruction of the destroyed bridge which connects the villages or will seek any other option which will be helpful to connect the villages. Kumar Pradhan of the Saureni Pani Golai Relief Committee said that "A sudden landslide was heard on the nearby Ramite Danda last night. We went to inspect some member sites. Large boulders began to fall due. We immediately called SDO of the sub-division Mr. Ashwini Kumar Roy and informed him about the incident. He came at night. As per his order, we evacuated the members of 27 houses under Ramite Danda to a safe place.

Kamal Rai of Upper Saureni village added that five bridges over the river have been destroyed due to the rising waters of Kashi Jhora.

GANGTOK, 24 SEPT (PIB): Anaemia is a major form of under-nutrition that pervades all life stages and Assam is facing an enormous challenge of prevalence of Anaemia among the adolescents. This was opined by the Nutrition experts during the webinar organised by Press Information Bureau, Guwahati on 'Adolescent Nutrition' while exhorting the necessity to strengthen anaemia control programming in the state based on knowledge.

Government of India has launched POSHAN (Prime Minister Overarching Scheme for Holistic Nourishment) Abhiyaan, to address malnutrition challenges in India by engaging all the important stakeholders in a convergent approach. Poshan Abhiyaan has special focus on reducing under-nutrition and low birth weight in children, and anaemia in adolescent girls, pregnant women, lactating mothers as well as children. The 3rd Rashtriya Poshan Maah is being celebrated this month across


Taking part as a

speaker in the webinar today, Prof Department of Food Science and Nutrition, Dr Mridula Saikia Baruah, College of Community Science, Assam Agricultural University, Jorhat said, "India is home to 253 million adolescents (10 to 19 years) and we stand with them at a crossroad between losing out on the potential of a generation or nurturing them to transform society". In her deliberation she said that under nutrition is a major and common problem among adolescents. In India 40 percent of girls and 18 percent of boys are anaemic, so there is a need to have balanced diet which includes fresh fruits and vegetables she added.

Consultant Nutrition, Dr Priyakshi Borkotoky, National Health Mission, Assam gave a detailed briefing on the on-going campaign of the Poshan Abhiyan in Assam. She discussed about the nutrition intervention for adolescents through National Health Mission. She said that there is higher prevalence of Anaemia in Assam than the national average in the adolescent age group and the government of Assam is taking all steps to decrease the anaemia rate. She further added that Friendly Health Clinics are being established in all district hospital, CHCs and SDHs in selected districts.

Joint Director, Samrat Bandopadhyay, PIB Guwahati in his welcome address said that the objective of the webinar is to create awareness among people about the importance of nutrition and the health schemes of the government. Deputy Director, Pallab Chakraborty, PIB Guwahati delivered the closing address in the webinar. Field Exhibition Officer, Hiramani Das moderated the webinar.

### Former Sikkim MP attends launch of 'Talking Trash' report

Thiruvananthapuram/Gangtok, **Sept:** Indian government must enforce stringent Extended Producer responsibility (EPR) rules to ensure that plastic pro-

ducers and brand owners take back their plastic waste instead of shifting the blame to the consumers and costs to the local au-The call was made by speakers at the

India launch of 'Talking Trash: The corporate playbook of false solutions to the plastic crisis' a new report from The Changing Markets Foundation that reveals how, behind a veil of nice-sounding initiatives and commitments to address the plastics crisis - the plastics industry, consumer brands, and retailers have obstructed and undermined proven legislative solutions to the crisis for decades.

The report reveals how plastic producers and brand owners like Coca-Cola, Colgate-Palmolive, Danone, Mars Incorporated, Mondelēz International, Nestlé, Pepsi-Co, Perfetti Van Melle, Procter & Gamble, and Unilever who have a joint plastic footprint of almost 10 million tonnes per year, lobby at every level to fight against proven solutions to solve the plastics crisis, which would require them to fully step up their responsibility and take on the true costs of plastic pollution. Instead, they use distraction tactics, which are designed to make people think real change is happening or that responsibility for the problem lies elsewhere.

Nusa Urbancic, Campaigns Director at the Changing Markets Foundation, said, "This report exposes the two-faced hypocrisy of plastic polluters, which claim to be committed to solutions, but at the same time use a host of dirty tricks to ensure that they can continue pumping out cheap, disposable plastic, polluting the planet at a devastating rate. Real solutions, such as mandatory collection of packaging, policies to increase reuse and phase out certain problematic plastic types or products, rarely feature in the voluntary approach and are fiercely fought against if proposed by policy-makers."

Plastic is pouring out into the natural world at a rate of 8 million tonnes a year, or one garbage truck per minute, and production has skyrocketed, with half of all plastics ever made having been produced since 2005. Production is expected to double again in the next 10-15 years.

Former Member of Parliament from Sikkim, PD Rai, said, "In the Himalayas, the plastic crisis is all-pervading despite the best efforts of the state governments and local Panchayats to ban all plastics. Extended Producer Responsibility, by which companies take back their packaging is the ultimate solution but there must be disincentives and penalties to successfully enforce such laws."

Joint Secretary of Integrated Mountain Initiative, Priyadarshinee Shreshta said, "The existing and proposed waste management rules are one size fits all, they do not recognise the fragility of mountains or the ecosystem services they provide. We urgently need to change the narrative from consumer behaviour to producer responsibility. Efforts taken by the corporations to reach their problematic products to remote corners should be matched by efforts to take them back or not make it at

India Coordinator of GAIA- Asia Pacific, Shibu KN said, "In India, the proposed Uniform Framework for Extended Producer Responsibility (under Plastic waste management rules, 2016) have been formulated with inputs from industry associations to protect their business interests and profits, there was no consultation whatsoever either from State governments or local governments. It is unfortunate to see there is no concrete measure to reduce the use of plastics or safe recovery of plastics."

Talking Trash report has shown that voluntary initiatives and commitments by the industry rarely work and are in fact used across the world to undermine leg-

For this reason, policymakers should adopt progressive legislation, built on the following key elements:

1. The Plastic Waste Rules 2016 has clear and time bound commitments on Extended Producer Responsibility (EPR) which have still not been met despite the lapse of the prescribed deadlines and directions by the National Green Tribunal. The government needs to ensure that producers/brand owners meet their obligations under the rules at the earliest.

- 2. Develop a binding national packaging policy with timelines and targets.
- 3. Pass legislations aimed at phasing out of harmful chemicals used in packaging plastics such as BFRs, BPAs, Phthalates, Lead etc.
- 4. Reverse the 2018 amendment to the plastic waste management rules and reintroduce the 2-year phase out deadline on multi-layered plastics.
- 5. Add EPR cess to plastic packaged products to promote non plastic alternatives and reduce tax tariff for plastic products maintaining stipulated percentage of recycled content.
- 6. The 2018 amendment to the plastic waste rules is a regressive step as it promotes false solutions such as mass incineration, cement kiln co-incineration and plastic roads in the guise of recycling. The government should remove these practices from the scope of recycling.
- 7. Implement minimum recycled-content targets in the production of packaging and containers of at least 50% for beverage containers and at least 30% for other items, as a starting point. This creates a market for effective plastic recycling and maintains plastic in a closed loop without downcycling the material.
- 8. Central or state governments should consider a tax on virgin plastic, which ensures the use of recycled plastic is incen-

tivized over virgin plastic. This should be accompanied with a clear position on the use of alternative materials, such as biobased, biodegradable and compostable plastic, with justifications for what is - and what is not – a good use of these materials.

9. Introduce bans on unnecessary or harmful plastic materials, such as PVC and polystyrene.

- 10. Prioritise reusable alternatives and act to avoid regrettable substitutions - for example, replacing single-use plastic with other single-use materials, such as bio-based, biodegradable or compostable plastic - which do not fix pollution problems and may also lead to other environmental problems.
- 11. Indian urban local bodies should support the Zero Waste Cities approach by creating and implementing systems that continuously intend to phase out waste not by incinerating, landfilling or exporting it, but instead by not generating waste in the first place.
- 12. India could spearhead the establishment of an intergovernmental negotiating committee at the United Nations Environment Assembly to negotiate a dedicated global agreement - a Convention on Plastic Pollution – that eliminates plastic discharges into the environment while also promoting a safe circular economy for plastics; one that addresses the full life cycle of plastics, from production and design to prevention and waste management.

#### Hold Us Accountable, Please

News requires reader-engagement to stay the course

Tournalists live a charmed life. Those outside the clique have an inflated perception of our effectiveness and readers in general believe media persons to be much better informed than they actually are. This fiction, when it circulates too widely and for too long can start convincing those who wield the pen [hammer keyboards nowadays] that they are indispensable, and with that comes the arrogance which, at least in our country, has also caused substantial damage to politics and administration. There is a fine line dividing standing up for something and becoming overbearing, but it is an important marker still, and over-stepping it can compromise the best of intentions. If the news-media is indeed seen as the fourth estate/pillar in a democracy, then hollowing it out weakens the overall structure, so, as much as it needs to be supported and backed, it also needs to be held accountable. A free press, after all, is a necessity to ensure real progress.

It goes without saying that the right environment needs to be created for press to be free, and this is provided by institutional and civil-society support systems. It is also obvious that such an environment is always under constant pollutions by agencies which are threatened if journalists are allowed genuine freedoms. But new-media cannot be shackled only by a repressive systems, it can also be compromised by unethical practitioners. It is always a bad idea to pass the correctional cane into the hands of the powers-that-be, because they will definitely misuse it, so, it becomes important for every person with a stake in world affairs or national developments and also Sikkim to start reading newspapers [because more readers will mean more power, more independence for newspapers] and more importantly, start sending in more letters. At present, most letter writers are inspired by personal reasons to write. What is required for a more accountable media is to have a wider response base. Not eulogies, please write in hate mail letters that point out errors, letters that demand clarifications, letters that complain of half-truths and incomplete reportage, letters that mention that readers notice the personal agendas of editors, publishers and reporters being packaged as news. The media needs feedback to stay on course, battle somnolence, remain relevant, and most importantly, remain accurate. The willingness to admit mistakes is an important part of being accurate. This has become even more significant in the age of online archives, although it has always been the case that mistakes in old newspaper cuttings could be repeated and result in an inaccurate report being circulated again years later. Accuracy, it needs no further stressing, is essential if journalism is to inform the public debate. And if public wishes to be served well with accurate information, significant perspectives and intelligent opinions, they need to engage, maintain a pressure which inspire excellence. Do that often enough, and even if newspapers do not publish them, the editors will be forced to read them and soon, the guilt will lead to more responsible, more accountable journalism.

This, in case you have forgotten how media peddled outright lies in how the Kanhaiya episode at JNU was reported, or how a Hindi news channel dredged the bottom of the ignorance barrel to claim and explain the nano-microchips they believed to be embedded in the new currency notes, or the comatose disinterest with which the northeast continues to be reported, or how when a certain national party wins state elections it becomes about local issues but when another national party wins in states it is credited to the charisma of The Leader... all of these should convince any consumer of "news" of how the sector requires more professionalism. In Sikkim's case, the news-media admittedly needs to evolve beyond the incident-based reportage and press release/ press conference-driven political reporting that currently pack our pages, in colour. These happen because the readers remain aloof consumers. Much more and much better will arrive if readers became more engaged and started demanding

## Cash transfers can help refugees, but they also carry risks. Insights from Kenya

umanitarian organisations - such as the World Food Programme (WFP) - are increasingly using cash transfers as a way of assisting vulnerable people. Conventionally, humanitarian organisations procure food or other goods and distribute it directly to recipients. But cash transfers allow people to choose and purchase what they need for themselves.

They are widely praised for enhancing autonomy, reducing costs, and boosting local markets. And this has encouraged their use. For instance, in 2019, the WFP distributed US\$2.1 billion transfers to 27.9 million people.

Cash transfers come in many forms, such as mobile money or transfers into bank accounts. They generally provide recipients with greater choice, but sometimes come with restrictions on the kinds of goods that can be purchased.

These options raise important questions that organisations must consider during programme design. For instance, the degree of autonomy recipients have in their use of assistance and how the transfer should be made.

In an effort to shed some light on this we studied the impact of WFP's cash transfers in the Kalobeyei refugee settlement in Kenya.

Established in 2016, a few kilometres away from the 28-year-old Kakuma refugee camp, Kalobeyei was envisioned as a new model for aid provision to refugees. The idea was to promote self-reliance for refugees, while also providing benefits to the local host population.

For the first three years, all households in Kalobeyei received restricted cash assistance from the WFP of Ksh1,400 per person (about US\$14) per month. The cash was distributed as mobile currency via SIM cards and could only be spent on food items at particular retailers. The idea was to have better accountability in how it was used and to reduce spending on temptation goods, such as alcohol and tobacco.

In June 2019, the WFP began to roll out a new cash transfer programme - for about 1,000 households - which had a different approach: it removed the restrictions on purchases, transfers were paid directly into bank accounts and the cash could be spent on any item at any shop.

We studied both of these approaches and two key lessons emerged from our research:

First, there are some pros and some cons to removing restrictions on cash. So whether the cash is restricted or not matters.

Second, the cash transfer programmes encouraged the extension of credit to refugee beneficiaries. This in turn created a problem of indebtedness among vulnerable cash recipients. This happened regardless of whether the cash was restrict-

The overall results of the pilot experiment of unrestricted cash transfers are therefore mostly positive. But importantly, our study also shows that many people do not realise the benefits of unrestricted cash due to high levels of indebtedness.

#### PROBLEM OF DEBT

In Kalobeyei, a staggering 89% of sampled households were indebted to retailers. Shopkeepers provided food on credit as a form of social support to assist food insecure refugees. But cash transfers contributed to higher levels of debt than conventional food aid.

This is because the technologies required for receipt of cash assistance - mobile SIM cards for

> the restricted programme and ATM cards for the unrestricted programme - can be retained by shopkeepers as a form of collateral.

Debt affected people in both the restricted and unrestricted cash programmes. And the debt undermined the effectiveness of the cash transfer programmes.

For one, refugees indebted to their shopkeepers are forced to turn over their cash transfer technologies as a form of collateral. Shopkeepers therefore withdraw their money on their behalf, and so these customers are unable to access hard

cash as intended.

Indebted households are more likely to be food insecure, more likely to be dissatisfied with their circumstances, and less likely to have savings. This leaves them with anxiety, helplessness and fear.

In addition, interviewees revealed that debt subjected women to the coercive strategies of some male shop owners, putting them at risk of sexual harassment and abuse.

#### **MOVING FORWARD**

Credit is a form of informal community support, and completely eliminating it is both undesirable and infeasible. However, agencies should take steps to prevent highly vulnerable refugee households from falling into high levels of debt.

Potential strategies include supporting community safety nets, facilitating schemes for debt repayment, and adjusting the value of transfers to ensure they provide sufficient purchasing power as prices fluctuate. However, this requires humanitarian organisations to recognise indebtedness as an important facet of vulnerability, and donors to provide the required level of support.

Our analysis reveals that the switch to unrestricted cash transfers had robust positive effects on household asset accumulation and subjective well-being.

Unrestricted cash gave recipients the option to use their assistance on non-food necessities like clothing, cooking fuel, and school equipment for their children. Moreover, refugees could negotiate for more favourable prices with shopkeepers.

Under the restricted programme, refugees could only purchase non-food items by first selling their food for cash, forcing them to sell at below-market prices.

Unrestricted transfers also offered recipients a broader market of retailers from whom to purchase goods. Whereas restricted cash can only be used at a limited number of retailers who have been selected by WFP, the unrestricted cash can be used in any shop.

Finally, recipients of unrestricted cash benefited from a 'cash-in-hand' discount: goods purchased with hard cash tend to be cheaper than those purchased with restricted cash.

There is some evidence that unrestricted transfers lead to higher expenditure on alcohol and tobacco, but this was only reported by a low percentage of households (14%) and a small proportion of

### Coronavirus: the road to vaccine roll-out is always bumpy, as 20th-century pandemics show

If you have been following the media coverage of the new vaccines in development for COVID-19, it will be clear that the stakes are high. Very few vaccine trials in history have attracted so much attention, perhaps since polio in the mid-20th century.

A now largely forgotten chapter, summer polio outbreaks invoked terror in parents. Today, restrictions on gatherings and movement in the efforts to control COVID-19 have been a huge strain on society, but in the 1950s, parents locked their children in stifling hot buildings during

the summer with windows sealed shut because they were terrified polio would somehow seep through the cracks in the wall.

The development of the polio vaccine in the US in 1955 was a moment of global celebration. Reaching that point involved millions of citizens raising funds to develop the vaccine, political goodwill by the bucket-load and a driven public-private scientific collaboration, with scientist Jonas Salk at the helm. Children across the US were enlisted in one of the largest clinical trials in history.

Clearly, setbacks and challenges occurred along the

way, even once the vaccine was being rolled out. In a shocking episode called the "Cutter incident", a failure in making and inspecting the vaccine by a California-based firm called the Cutter Laboratories led to children getting polio from the vaccine, which contained viable poliovirus.

The incident led to a major tightening of federal regulations to ensure production safety. It also resulted in new laws being passed that prevented vaccine manufacturers from being sued. (The fear was that drug manufacturers would not want to develop vaccines without being protected by the law.)

A lack of urgency for vaccine up-

take quickly set in. It is taken for granted that children are vaccinated routinely, but this acceptance took time. In the early era of vaccination, it was a tool against epidemics and people expected to be vaccinated during an outbreak. Through health education and communication, funding of immunisation services, and political support across party lines, vaccination was promoted as a central pillar

#### of a public health globally. PROMISE OF AN AIDS VACCINE

When the next big plague of the 20th century hit - Aids - naturally it was vaccination that would be looked to. Within a short time of scientists confirming HIV was the cause of Aids in

1984, the US health and human services secretary, Margaret Heckler, announced that a vaccine would be ready in two years. The high expectations and hope instilled in vaccination were not surprising, particularly following the eradication of smallpox from the planet in 1980. However, an Aids vaccine proved to be unattainable.

Unfortunately, many aspects of HIV infection make it very difficult to develop a vaccine. Instead, it has been antiretrovirals - a group of drugs that inhibit various steps in the HIV replication process - that have proved to be the most effective strategy for treating Aids.

The stigma of Aids was also an inhibitor for controlling the disease. Health officials at the beginning of the Aids crisis coyly referred to the transmission being through "bodily fluids", instead of specifying blood and semen. This lead to misunderstandings about the disease being spread through touch.

#### NEW PANDEMIC, **PROBLEMS**

Today, COVID-19 is the latest public health crisis that cannot be separated from politics and society. Fear of this disease, and whether it is taken seriously and seen as important to protect against, will play a major role in the support and uptake of a

vaccine. Most people want to return to a "normal life", and a vaccine is the most reliable way to achieve this. However, the public's desire for a vaccine is balanced against concerns about the speed of vaccine development, wariness about new types of vaccines, and mistrust of pharmaceutical companies, governments and the "health establishment".

Public action in communities has been evident throughout the COVID-19 pandemic, in neighbours supporting the elderly and those unable to leave their homes by delivering groceries and medication, as well as compliance with government health messaging, and willingness to take part in medical trials. But national political stakes for a vaccine remain high with politicians using "vaccine deals" to bolster popular support and win elections.

The acceptance of vaccines is fragile, so when leaders promote their country's vaccine with clear political motivations, it can knock the public's confidence and draw intense scrutiny. As with the polio vaccine of the past, the world is watching.

## Nagaland in deep financial crisis; 2020-21 expected to close with Rs 2358.81 cr deficit

DIMAPUR, SEPT 24 [NA-GALANDPAGE]: Nagaland is facing deep financial crisis despite austerity measures as a result of shortfall in receipts of share of Central taxes and duties as well as poor revenue collection due to imposition of lockdown following the outbreak of the COVID-19 pandemic.

The financial issue confronting the State and the likely impact these will have on the activities of the Government was discussed in a State Cabinet meeting today, said a press release issued by the State Finance Department.

The Finance Department said out of an estimated monthly receipt of Rs 320.96 crores per installment as share of

The total deficit during 2020-21 on account of shortfall in receipts of share of Central taxes and duties alone comes to Rs 1080.13 crores. The negative impact is not confined to Central receipts only. Our own revenues have fallen by about Rs 38 crores a

month below the budget- expected to close with ed amount during the period April-August 2020, the department said in a press release.

Given the present trends, the revenue receipts of the State are likely to witness a decline of Rs 1650 crores during 2020-21 against what has been budgeted, it said. The FD said when

the present Chief Minister had handed over the reins of the Government in 2013-14 the deficit stood at Rs 950.09 crores. However, it said by the time the present Government returned in 2018 the deficit had grown to Rs 1607.73 crores.

The Finance Department estimated that the current year 2020-21 is

a deficit of Rs 2358.81 crores as per budget estimates and this includes an increase of Rs 939 crore since 2014-15. This, the release said, is mainly due to various factors such as implementation of the last pay revision for State Government employees and payment of pending dues and liabilities to contractors following various Court judgments in their favour, leaving the Government with no alternative but to pay.

However, in view of the unforeseen developments caused by the pandemic, the year is expected to close with a much higher deficit than estimated, it feared.

Stating that the neg-

demic has been so widespread and pervasive that the Government has been compelled to adopt drastic measures to mitigate the negative effects of the fall in receipts to avoid a potential collapse, the release said some of the measures adopted include prorata cuts in the budgets of the departments, imposition of various austerity measures and mobilization of additional resources through imposition of COVID-19 cess.

### COVID-19 tally breaches 8K-mark in Arunachal with highest one-day spike of 289 cases

ITANAGAR, SEPT 24 [PTI]: Arunachal Pradesh on Thursday reported its highest single-day spike of 289 COVID-19 cases, which took the tally in the northeastern state to 8,133, a senior health department official said.

Barring 21, all new patients are asymptomatic and have been shifted to COVID-19 care centres, State Surveillance Officer (SSO) Dr L Jampa said.

"Ten security personnel — six from the Assam Rifles, two from the Indo Tibetan Border Police, one each from the Army and the Indian Reserve Battalion — are among the new patients," the SSO said.

Of the 289 fresh cases, 173 were reported from the Capital Complex region, 17 from Changlang, 13 from East Siang, nine each from Papumpare and Pakke Kessang, eight each from Namsai, Lohit, and West Siang, seven from Upper Subansiri and six each from Anjaw, Longding, Upper Siang and West Kameng.

Five cases were recorded in Lower Dibang Valley, two each in Lower Siang and Kra Daadi and one each in Tawang, Tirap, East Kameng and Siang districts, Dr Jampa said.

Arunachal Pradesh currently has 2,216 active cases, while 5,903 people have been cured of the disease. Fourteen patients have succumbed to the infection.

The state's Capital Complex region - comprising Itanagar, Naharlagun, Nirjuli and Banderdewa areas — has reported the maximum number of active cases at 1077, followed by West Siang at 172, Papumpare at 150 and Changlang at 137.

As many as 2,31,045 samples have been tested for the infection so far, including 2,803 on Wednesday, thS SSO added.

Sinha said it is a composite machine using ultraviolet (uv) rays and heat technology to sanitise books. He said the machine

can sanitise up to 150 books in one cycle of about 45 minutes at a cost of 20 paise per book. NEHU Vice-Chancel-

lor Prof SK Srivastava inaugurated the book sanitising machine at the central library of the university on Wednesday.

Prof Srivastava said, "The development of such a sanitising machine was a fantastic fusion of library, a place to provide knowledge and the School of Technology, the place to convert that knowledge into the means for so-



cial benefit."

He also came out with the acronym 'ABSCoM' for the machine.

Training has been imparted to the library staff to operate the machine, officials said.

NEHU Librarian Incharge Dr FR Sumer said the device was felt necessary, about two months

ago to manage the handling of the books and other reading materials, while in circulation among the students and other users, especially in the post lockdown situation.



The Uruguay striker, who is Barca's third alltime top scorer with 198 goals in all competitions, had a year left on his contract with the club.

The Uruguayan was deemed surplus to requirements by new manager Ronald Koeman, who is keen on changing the old guard and rebuilding the squad, with 33-year-old midfielder Arturo Vidal also completing a permanent move to Inter Milan.

Despite a turbulent season with Barca dogged by injuries, Suarez still hit 16 goals in 22 La Liga starts to finish as the fourth top scorer in Spain's top flight. Atletico's top scorer was Morata with 12.

Suarez becomes the third striker in recent years to switch between the two La Liga clubs after David Villa was sold to Atletico in 2013 while Griezmann Antoine moved to Barca last year.

While Villa became an instant hit, scoring 13 goals in Atletico's 2013-14 league title-winning campaign, Griezmann has yet to hit the same heights at Barca following his 120 million euros (\$140.86 million) move.

Atletico struggled for much of last season

without Griezmann and will hope the capture of Suarez will significantly improve their chances of challenging Real Madrid and Barca for the title.

Suarez had also been linked with Serie A side Juventus and took an Italian exam in an attempt to get an EU passport to be eligible to play as a European player as the Turin side's non-EU player slots were already filled.

However, Italian prosecutors said on Tuesday they had evidence the language exam taken by Suarez to obtain Italian citizenship was rigged.

## **Eddie Nketiah's poaching instinct smooths** Arsenal's route past Leicester

**PAUL DOYLE** LEICESTER, 24 SEPT [THEGUARDIAN]: This was essentially a meeting between shadow sides and its turning point was a slapstick Leicester own goal by Christian Fuchs but it provided further evidence, nonetheless, that Arsenal are growing into a serious unit under Mikel Arteta.

Following success in the FA Cup and Community Shield, Arteta oversaw progress in the Carabao Cup with a now familiar performance of rigour and hunger, with a dollop of good fortune. Eddie Nketiah's scrappy late goal from close range put a cherry on top for Arsenal.

The contest was not exactly decorated with flamboyant play but the basic ingredients Arteta demands, and that Arsenal often lacked before his arrival, were apparent. Arsenal are a team who know their jobs and are fully committed to the mission; and the display from young players on the fringes, such as Nketiah, Bukayo Saka, and Reiss Nelson, gave the club's outlook a brighter glow.

Arteta gave an indication of how he sees Mesut Özil and Matteo Guendouzi's futures by leaving both out of the squad at the King Power while fielding a starting lineup with seven changes from their last Premier League outing.

When asked about Özil's absence, the manager tried to deflect the question. "I'm really happy with the performance



of the players here," he said. Pressed, he added: "The team is evolving. You can see the level they are achieving ... We are picking the players we believe are the best for each game.

"You can see the players we are changing and using. It is very difficult for some players, not just Mesut, to make the squad. It's difficult for others who haven't been involved.

"We have a squad of 26 or 27 players at the moment. I have to do my job as fair as possible and I have to try to select five minutes. On the second of the players who in my opinion are in better condition."

Leicester fielded an entirely different lineup to the one who started Sunday's league victory over Burnley, with Daniel Amartey impressing on his first appearance since breaking a leg against West Ham nearly two years ago.

That happy development was offset by Brendan Rodgers' revelation after the match that Leicester's influential midfielder Wilfred Ndidi will be out for at least six weeks with a groin injury suffered against Burnley. "It will be at least 12 if he needs an operation," Rodgers said.

Leicester started brightly, with Kelechi Iheanacho going close twice in the first those occasions Bernd Leno denied him, rushing off the line to make a good save with his feet. In between those efforts Nelson, who has been linked with a loan move away from Arsenal, showed his promise

firing just over the bar.

Arsenal gained control, advancing with moves of impressive fluidity and geometry, and in Saka they had a player apt to glide past several opponents at any moment.

When he did so in the 20th minute, starting from his left wing-back position, he sent a pass across the face of goal that a teammate should have anticipated.

But Leicester came closest to scoring in the first half when James Maddison, making his first start of the season, curled an exquisite shot over Leno from the edge of the box. The goalkeeper's luck was in, as the ball bounced back off the post and into his arms.

Maddison should have by cutting in from the left and threatened again just after the break but ballooned a shot from 20 yards after clever service by Demarai Gray. Both sides were popping the ball around pretty well but neither looked sharp in the box.

It took a blunder and good fortune to bring a breakthrough. First, Fuchs misjudged a bouncing ball, allowing it to run to Nketiah, who fed Nicolas Pépé. Danny Ward dived in to cut out the Ivorian's pass across the face of goal but inadvertently sent it back to Pépé, whose instant shot from an acute angle struck the near post and ricocheted into the net off the dumbfounded Fuchs.

Nketiah nearly doubled Arsenal's lead with a nifty lob over Ward but Wes Morgan recovered to clear off the line. Ayoze Pérez, on as a substitute, should have drawn Leicester level in the 81st minute but headed wide from close range after a lovely free-kick by Marc Albrighton.

Then another substitute, Héctor Bellerín, helped Arsenal seal victory by dancing into the box and flashing the ball across goal to Nketiah. The striker, summing up the qualities Arteta has instilled. showed greater alertness and determination to poke the ball over the line as Ward seemed to dawdle.

### 'Are people to be left to die?' Vaccine pleas fill UN summit

JOHANNESBURG (AP): If the United Nations was created from the ashes of World War II. what will be born from the global crisis of COVID-19?

Many world leaders at this week's virtual U.N. summit hope it will be a vaccine made available and affordable to all countries, rich and poor. But with the U.S., China and Russia opting out of a collaborative effort to develop and distribute a vaccine, and some rich nations striking deals with pharmaceutical companies to secure millions of potential doses, the U.N. pleas are plentiful but like-

"Are people to be left to die?" Honduran President Juan Orlando Hernández, a COVID-19 survivor, said of the uncertain way forward.

More than 150 countries have joined COVAX, in which richer countries agree to buy into potential vaccines and help finance access for poorer ones. But the absence of Washington, Beijing and Moscow means the response to a health crisis unlike any other in the U.N.'s 75 years is short of truly being global. Instead, the three powers have made vague pledges of sharing any vaccine they develop, likely after helping their own citizens first.

This week's U.N. gathering could serve as a wake-up call, said Gavle Smith, president of the ONE Campaign, a nonprofit fighting preventable disease that's developing scorecards to measure how the world's most powerful nations are contributing to vaccine equity.

"It's not enough for only some G20 countries to realize that an equitable vaccine is the key to ending this virus and reopening the global economy," she said.

With weeks remaining before a deadline for countries to join COVAX, which is co-led by the U.N.'s World Health Organization, many heads of state are using the U.N. meeting as a high-profile chance to wheedle, persuade and even shame.

Ghana's president, Nana Akufo-Addo, pointed out the illusory nature of borders and wealth: "The virus has taught us that we are all at risk, and there is no special protection for the rich or a particular class."

The president of the COVID-free Pacific island nation of Palau, Tommy Remengesau Jr., warned against selfishness: "Vaccine hoarding will harm us all."

And Rwanda's president,

Paul Kagame, appealed to the deployed all-caps in a stateuniversal desire for a return to normal: "Ensuring equitable access to vaccines, therapeutics and diagnostics will speed up the end of the pandemic for ev-

Just two days into nearly 200 speeches by world leaders, it was clear the urgent need for a vaccine would be mentioned by almost everyone. Considering the mind-popping challenges ahead, that's no surprise.

"We've never dealt with a situation where 7.8 billion people in the world are needing a vaccine at almost the same time," John Nkengasong, head of the Africa Centers for Disease Control and Prevention, said this month.

That has led to difficult questions: Who will get vaccine doses first? Who is making private deals to get them? This week's speeches make clear that such questions have existential meaning.

"The COVID-19 vaccine must be considered a global public good. Let us be clear on this," said Rodrigo Duterte, president of the Philippines.

U.N. Secretary-General Antonio Guterres kicked off the General Assembly by declaring in an interview with the U.N.'s media arm: "To think that we can preserve the rich people, and let the poor people suffer, is a stupid mistake."

It's not clear if the world leaders' remarks, delivered not in a diplomatic scrum at U.N. headquarters but in videos recorded from national capitals, will make a difference. Health experts, activists and others anxiously watching the issue raised a collective eyebrow.

"It's important we continue to be making these speeches, but ultimately, speeches alone won't have an effect if there are no real measures put in place to make sure poor countries, and within them the poorest of poor, have access" to the vaccine, said Tendai Mafuma with the South Africa-based social justice group Section 27. It's part of a coalition pressing to make medicines more affordable and accessible.

South Africa, along with many African countries, knows the deadly consequences of having to wait. Health experts say 12 million Africans died during the decade it took for affordable HIV drugs to reach the continent.

Mafuma's countryman Shabir Madhi, lead researcher on a clinical trial in South Africa of the vaccine that Oxford University is developing with pharmaceutical company AstraZeneca, was a bit more optimistic. That most of the world's richest countries have joined COVAX "is promising," he said.

But whether this week's impassioned speeches at the U.N. will make any difference, Madhi said, is still "difficult to tell."

### Kenyan leader asks what UN brings to world today

UNITED NATIONS, SEP 23 (AP): Kenya's president has given a generational jolt to the 75-year-old United Nations, pointing out that the world body is older than 96% of the global population.

In a prerecorded speech on Wednesday at the UN General Assembly, Uhuru Kenyatta said the UN was created to bring hope to a world in ruins after World War II, but what does it bring to the world today?

The statement is fitting coming from an African nation. The continent has the world's youngest population, with a median age of 19. And that booming population is increasingly impatient with leaders multiple times their age.

### China's military flew surveillance planes on 3 days

TAIPEI, Taiwan (AP): Taiwan on Thursday condemned recent Chinese military activity after Beijing sent two military surveillance planes toward the island for three straight days, calling it a "deliberate provocation."

Tensions have risen in the Taiwan Strait as the U.S. has stepped up its official engagement with the self-ruled island that China considers part of its national territory.

On Monday, Tuesday and Wednesday, China sent two planes into Taiwan's air defense identification zone, according to Taiwan's Ministry of National Defense. In response, the Taiwanese side dispatched air patrols, the ministry said.

"We oppose Chiusing military force ately violating Taiwan's

### Drug companies work jointly to boost vaccine confidence

LONDON (AP): Two firms COVID-19 developing vaccines say pharmaceutical companies are trying to give the public as much information as possible about their testing regimes as drugmakers and public health officials seek to boost confidence that any approved vaccine will be safe.

AstraZeneca CEO Pascal Soriot and Paul Stoffels, chief scientific officer of Johnson & Johnson, said Thursday that they recognize the coronavirus emergency demands increased transparency from vaccine developers to ensure the public has faith in the end product. They stressed however that there are limits to the information they can release because they must protect patient confidentiality and the integrity of their scientific research.

Ultimately, the public will have to trust regulators around the world and the independent experts that oversee drug trials, Soriot said during a panel discussion sponsored by the World Economic Forum.



"You've got to trust that the experts whose job it is to monitor these trials and these developments are doing a good job," Soriot said. "Medicine should not be practiced for the media, it should be practiced by experts."

The comments come as scientists scramble to develop a vaccine that would protect the public from a pandemic that has killed nearly 1 million people worldwide and as numerous countries battle against a surge in cases. The United States and other countries have invested billions of dollars to develop a vaccine that would allow them to ease restrictions on social interactions that have devastated the glob-

al economy. But public health experts have expressed concern that political pressure on regulators to quickly approve vaccines will undermine public confidence in their safety and effectiveness. U.S. President Donald Trump has repeatedly touted his belief that a vaccine will be approved before the presidential election on Nov. 3, calling scientists' estimation of a longer timeline "confused."

Public concern about a vaccine could be disastrous to its widespread acceptance and undermine efforts to vaccinate enough people to stop transmission of COVID-19.

Soriot pointed out that the vaccines being developed by his company and others must be approved by regulators around the world, not just the U.S.

"You really would have to love conspiracy theories to believe that all regulators around the

world will all agree to approve a vaccine that is not safe and effective," he said. "It's hard to believe that every country would do that, so you're going to have several sets of eyes from different countries looking at this data."

The U.S. Food and


Administration has said it would not approve any vaccine unless it meets a 50% efficacy threshold, while the European Medicines Agency said they do not have a minimum criteria and that potential coronavirus vaccines would be considered on a case-by-case basis. The World Health Organization said it hopes experimental vaccines will prove at least 70% effective, but acknowledged that first-generation shots may not reach that target.

Against this backdrop, drugmakers have come under pressure to release more incremental information on the progress of their vaccine trials - information that they normally wouldn't release until the trials are

The heat only increased after an Astra-Zeneca trial was put on hold while it investigated whether a British volunteer's illness was a side effect or a coincidence. The trial remains on hold in the United States, but has resumed in other countries.

Soriot and Stoffels said drugmakers are looking at other how they can increase transparency given the "very special set of circumstances" surrounding the potential COVID-19 vaccines. Astra-Zeneca, Johnson & Johnson and two other companies recently released the detailed protocols for their vaccine trials.

"We are discussing with other companies as an industry what kind of transparency could we offer without compromising patient privacy, of course, but also without compromising the trial itself," Soriot said. "Because if you disclose ... too much information you can actually compromise the clinical trial itself."
