#### SC's 5-judge Constitution bench not to sit this week

#### NEW DELHI, APR 22 (PTI): A five-judge Constitution bench of the Supreme Court which was scheduled to hear certain important cases, including the land ac-

quisition matter from Tues-

day, will not sit in this week.

According to the notice uploaded on the apex court website, the hearing of cases by the Constitution bench headed by Chief Justice Ranjan Gogoi was cancelled.

Other cases included as to whether lawmakers enjoy immunity from prosecution for accepting bribes to vote in Parliament or an Assembly.

"In supersession of earlier notice dated the April 16, 2019 uploaded on the Supreme Court website mentioning that Constitution bench will sit in Chief Justice's court from April 23, 2019, now, take further notice that the Constitution bench will not sit in the week commencing from April 23, 2019," the notice said.

As per the earlier notice of April 16, the fivejudge bench was scheduled to hear from April 23, two matters pertaining to interpretation of Section 24 of the Land Acquisition Act, 2013.

### Jet employees stage demo, appeal to govt to bail out airline

BENGALURU, APR 22 funds to keep Jet Air-(PTI): Around 100 staff members of the ailing Jet Airways Monday staged a demonstration here, urging the government to intervene and bail out the airline.

Jet Airways had on April 17 announced temporary suspension of operations after it failed to receive emergency funds from lenders, leaving about 23,000 employees to face a bleak future.

This evening, the employees, dressed in their uniforms, staged the demonstration at Town Hall in the heart of the city.

Holding aloft placards, they raised slogans like 'Save our families, save Jet Airways', 'Don't make us cry, give a chance to fly' and 'Humko Tum Na Dhoka Do, Udne ka ek Mauka Do' (Don't ditch us, give a chance to fly).

'We pay loads of tax, Don't get us under the Axe' and 'We have dependents to feed, please don't let our 9W bleed' read the messages in some of the placards.

Milind Paradkar, an engineer with Jet Airways, urged the gov- of emergency funds for ernment to infuse some

ways afloat.

"We want the government to infuse some funds instead of our aeroplanes being taken over by other airlines and being flown over by them," Paradkar told PTI.

He said there were rumours that somebody has shown willingness to take over let Airways, but the employees have no information who that is.

"The government has to be transparent. Presently employees are not being informed. They are in the dark," Paradkar said.

Other demonstrators said they had not received salaries for the past three months and had somehow been managing their family needs.

Some among them said they had previously worked with the now defunct Kingfisher Airlines.

On April 20, the employees had written to President Ram Nath Kovind and Prime Minister Narendra Modi, seeking their intervention to recover outstanding dues as well as to expedite the process the airline.

## CJI showed "procedural impropriety" in dealing with allegations against him: SC Advocates on Record Association

NEW DELHI, APR 22 (PTI): The Supreme Court Advocates on Record Association (SCAORA) on Monday expressed its "deep reservation" against the "procedural impropriety" shown by Chief Justice Ranjan Gogoi in dealing with the sexual harassment allegations against him.

As the apex court reassembled after the weekend recess in the backdrop of the stunning allegations by a former court staffer, the SCAORA said the charges against Justice Gogoi should be dealt with as per established procedure.

The allegations cropped up against Justice Gogoi on Saturday prompting him to convene an urgent extraordinary hearing by a three-member bench headed by him during which he asserted that the charges by a former apex court staffer were "unbelievable". The allegations by the woman, who had worked at Justice Gogoi's home office in Delhi, dates back to October last year.

"The allegations of the ex-employee of the Supreme Court have to be dealt with as per the established procedure of law and law must be applied in each and every case uniformly," the top court lawyers' body said in a resolution passed on Monday.

The Supreme Court Employees Welfare Association on its part came out in support of Justice Gogoi, claiming that the allegations were "false and fabricated".

The association, in a one-page resolution, said it strongly condemned the "false, fabricated and baseless allegations" against the CJI which is aimed at maligning the institution of judiciary.

The Supreme Court Employees Welfare Association on behalf of all the employees strongly condemns

the false, fabricated and baseless allegations against Chief Justice of India Ranjan Gogoi," it said.

The SCAORA, which is a body of lawyers comprising advocates empowered by the apex court to file pleadings on behalf of parties in the top court, sought immediate appointment of a committee headed by full court of the apex court to impartially investigate and inquire into the allegations and give an independent finding.

"Supreme Court Advocates On Record Association expresses its deep reservation against procedural impropriety shown by Justice Ranjan Gogoi in the suo motu proceedings held on April 20 in the issue relating to allegations of sexual harassment against Justice Ranjan Gogoi, by an ex-Supreme Court employee,' the SCAORA resolution said.

'It is therefore resolved that the SCAORA strongly disapproves the

manner in which the complaint was dealt with and seeks enquiry and action in the above matter..." it added.

Justice Gogoi said during the Saturday hearing that the allegations were part of a conspiracy by some "bigger force" to "deactivate" the CII's office.

The CJI also said he would not stoop too low even to deny them.

In her affidavit, copies of which were sent to the residences of 22 apex court judges, the woman described two incidents of alleged sexual harassment by Justice Gogoi, days after he was appointed CII last October and her alleged subsequent persecution.

The woman alleged that she was removed from service after she rebuffed his "sexual advances". She claimed that her husband and brother-in-law, both of whom were head constables,

The apex court had on April 2 asked the Centre and the parties concerned, who have challenged the validity of various provisions of the Act, to consensually frame the questions of law to be answered by a five-judge Constitution bench.

The hearing in two land-acquisition matter is ongoing. The third case to be taken up by the bench related to the issue whether a lawmaker enjoys immunity under Article 194(2) of the Constitution from prosecution for accepting bribes to vote in Parliament or Assembly.

This crucial question with "wide ramification" and of "substantial public importance", will be dealt by the apex court as it has decided to revisit its 21 yearold verdict in the sensational Iharkhand Mukti Morch (JMM) bribery case earlier this month.

In 1998 five-judge constitution bench had held in the PV Narasimha Rao versus CBI case that lawmakers have immunity under the Constitution against criminal prosecution for their speech or vote given in the house.

### **Notification for last phase** of Lok Sabha polls issued

New Delhi, Apr 22 (PTI): The Election Commission Monday issued the notification for the seventh and last phase of the Lok Sabha elections in which 59 constituencies spread across eight states and union territories will go for polls.

While the first phase of election was held on April 11, the last phase will be held on May 19. So far, two phases

have taken place, while the third phase of polling is on Tuesday. All the 13 seats of

Punjab, four in Himachal Pradesh and one in Chandigarh will go for pols in a single phase on May 19.

The Election Commission had on last Tuesday postponed polling in the Tripura (East) Lok Sabha seat to the third phase on April 23 (Tuesday) from April 18, saying the prevailing law and order situation there is not conducive for holding free and fair polls.

With the issuance of the notification, the nomination process has started. April 29 is the last date of filing nominations and the scrutiny of papers will take place on April 30. The last date to withdraw from the electoral battle is May 2.

Uttar Pradesh, Bihar and West Bengal will head for voting in all the seven phases of the general elections.

The election will pit the BIP-led Nation-Democratic Alliance against mostly different opposition groupings in various states, including of Congress, the Left and regional forces which are continuing to work out a grand alliance to minimise a division of votes

against the saffron party. The BIP has worked out a seat-sharing formula with some new allies However, opposition parties are yet to do so in several states.

### Hoodas, Chautalas, Bhajan Lals, Bansi Lals slug it out in Haryana

decades, Haryana's politics has revolved around four prominent political families--the Hoodas, Chautalas, Bhajan Lals and Bansi Lals. Though none of these families are ruling the state now, they still wield considerable clout.

The three Lals--Devi Lal, Bansi Lal and Bhajan Lal-- ruled the northern state by turn for decades, with the Hooda family calling the shots in recent years.

The BJP formed its first government in Haryana in 2014.

The Lals and Hoodas are once again testing their political fortune in the crucial 2019 Lok Sabha elections from Haryana, where polling on all the ten seats is scheduled to be held on May 12. The youngest to enter the fray is Bhavya Bishnoi (26), the third generation leader from the Bhajan Lal family, and Arjun (26), the fourth generation leader from the Chautala clan.

Bhavya is the grandson of former chief minister late Bhajan Lal and son of Congress leader Kuldeep Bishnoi.

Interestingly, he is pitted against sitting MP from Hisar Dushyant Chautala (31), great grandson of former deputy prime minister late Devi Lal.

From Hisar, also in the fray, is Union minister Birender Singh's

CHANDIGARH, APR 22 bureaucrat son Brijendra. The BJP candidate is great grandson of famous peasant leader Sir Chottu Ram.

Dushvant Chautala grandson of former chief minister Om Prakash Chautala and son of ex-MP Ajay Chautala, floated his own outfit Jannayak Janata Party (JJP) last year after a split in INLD following family feud.

The JJP is contesting all the ten seats in alliance with AAP in the state.

Like Dushyant, his cousin Arjun Chautala, younger son of INLD leader Abhay Singh Chautala, is the fourth generation leader of the Chautala clan to have thrown his hat into the poll ring.

Arjun is contesting from Kurukshetra seat as an INLD candidate.

From Rohtak, former chief minister Bhupinder Singh Hooda's son Deepender Singh Hooda is seeking re-election as Congress candidate.

The Hooda senior, who is a sitting MLA, has also jumped into the fray and is contesting from

Shruti Chaudhary, former MP and grand daughter of former chief minister Bansi Lal, is contesting from Bhiwani-Mahendergarh parliamentary constituency.

The filing of nomination papers will come to a close in the state on Tuesday.

#### Rahul rakes up Rafale deal 'corruption' in Amethi

Amethi (UP) Apr 22 (PTI): Raking up his often-repeated poll theme of alleged corruption in the Rafale deal, Congress president Rahul Gandhi Monday exhorted people to ask Prime Minister Narendra Modi what he got in return for benefiting Anil Ambani with Rs 30,000 crore in the fighter jet deal. Mocking at the prime minister's "main bhi chowkidaar campaign" he said, "When his (Modi's) theft was caught in the Rafale deal, he says 'hum sab chowkidar hain."

Addressing an election rally in his parliamentary constituency here, Rahul said, "When the prime minister comes and makes false claims. iust ask him why he gave Rs 30.000 crores to Ambani and what Ambani did for him in return.

Addressing the rally in Tiloi area here, Rahul Gandhi said. "Soon after the Congress comes to power after the Lok Sabha elections, an inquiry would be instituted in the Rafale deal and the truth will be before everyone."

"What the former former (French) President Francois Hollande said and what is in the French defence files will come out. Only two persons' names will come out - first Anil Ambani and second Narendra Modi," he said.

He asked the audience if anyone has seen "chowkidar" before the house of a farmer or a labourer, Gandhi said for some time now, every farmer has been forced to do 'chowkidari' of his agriculture field.

In Amethi, Rahul Gandhi is pitted against Union Minister Smriti Irani, who, in a rally in the constituency on Sunday, urged voters to bid farewell to their "missing MP" in this election.

The voting for Amethi is scheduled to be held on May 6 in the fifth phase of elections. Dwelling on the Congress poll promise of NYAY - the Nyuntam Aay Yojna or the minimum income scheme which envisages a grant of Rs 6.000 a month to 20 percent of the poorest people in the country, he said there was a thinking behind it.

"Prime Minister imposed Gabbar Singh Tax (GST) and the money that was taken from your pocket went to those thieves abroad. The moment money went out of your pocket, you stopped purchasing and the factories closed down leading to unemployment," he said.

Twenty-seven thousand vouths lose their jobs every 24 hours," he claimed, adding "this is the work of the chowkidar".

Talking of the Congress' promise to create employment opportunities in the country, if voted to power, Rahul Gandhi, went on to say that after 2019, 33 per cent women will be seen in the legislature and also  $in\ government\ jobs.$ 

He made the statement apparently in passing without making any specific promise to bring in the Women Reservation Bill in parliament, if voted to power, to reserve 33 percent of legislatures' seats for women.

Sharma said Trai's message to stakeholders is that regulatory framework should be implemented in letter and spirit.

"And consumers should really get the power...don't try to play with it (tariff order) or circumvent it," Sharma said.

Last week, Trai said six cable TV players, including GTPL Hathway and Siti Networks, violated several rules, especially those related to new tariff order, and directed them to ensure compliance.

#### Re-polling recommended in nine booths of Odisha

## **Cultures Live**

...provided we don't stifle them

**P**ecause some things need reiteration from  $oldsymbol{\mathrm{D}}$  time to time, we return here to arguments that have been tabled often and worries that have been raised frequently because the deliberations continue remain open, and will for some more time.

Turn to any corner of the world and one comes across voices of protest or groans of concern from a culture under threat, a way of life nearing extinction, a lifestyle on the brink. While there are always external elements like the influence of globalisation and the pressure to homogenise which eat away at the edifice of cultural uniqueness, the biggest threat comes from those who refuse to let cultures breathe - those who view it as a relic which needs to be preserved in the purest form as imagined or decided by them. Unfortunately for such groups, cultures are living systems which need to be nurtured, not pickled. But 'preserving' is easier since nurturing would entail allowing a culture to grow and that would go against ill-informed beliefs that cultures are perfect on which any growth is a blemish. Such mindsets refuse to accept that culture is not something that can be pickled and preserved as a museum piece for posterity. Culture, because it is about a people, is vibrant, alive and contemporary. It is spontaneous, almost instinctive, and not something that is learnt; it is imbibed. Since culture forms a part of evolution, it is also subject to fresh interpretations, nuances

Because culture is about people, it cannot survive on state patronage alone - that would be relegating it to the status of a museum display. Some years ago, members of the Museums Association of India conferred in Gangtok. The focus of that conference was "Intangible Heritage - Preservation & Portrayal." In layman's terms, they were speaking of ecomuseology, the science, or rather the attempt, to allow cultures to breathe and thrive unencumbered in their natural habitats. But even this comes with its pitfalls. In the Journal of Indian Museums released at the conference, the editorial spoke of the "very amateurish and vulgar commercialisation" of culture that one sees in the tourism sector of Rajasthan. What was true of Rajasthan is true for Sikkim as well. The message - preservation of cultures should not come at the cost of reducing vibrant lifestyles into caricatures. This can happen only if the people to whom the culture belongs want to nurture it. For the same reason, if a people reject their Culture as ripe for extinction, no amount of preservation helps. Yet, a culture should not be dismissed even before one has understood it. It is important that the repository of culture is passed on to the next generation to nurture and craft as it feels right. And yes, people can discard a culture if they want to, but only after they have understood it and decided that it does not serve their purpose any more. What the current holders of culture can do is pass it on to the next generation in an as unadulterated a form as possible. What the younger generation, equipped with its better education, can do is research deeper into their roots. Then, even if the physical form of cultures dwindles away, at least the records will survive for future generations, if it feels so in-

What is required of the establishment is to provide the support which allows these aspirations to manifest.

## It's a century since an international civil service came into being. Why it matters

This year marks a century since a formal inter-I national civil service was introduced into the world. The first time this particular breed of professionals came into existence was at the signing of the Versailles Peace Conference during 1919 and the subsequent establishment of the League of Nations in January 1920.

The United Nations (UN) will mark the occasion later this month when it discusses the challenges of multilateralism committed to a rulesbased world order.

For global governance, an international civil service matters. Simply because it would be impossible to promote and maintain a rules-based world

An autonomous civil service is crucial for operations within the global governance system - an idea conceptualised a 100 years ago at the League of Nations. Already then, international civil servants were expected to be loval to the aspirations of the international community and to remain neutral and independent of any authority outside their organisation.

Eric Drummond a British diplomat involved in the drafting of the League of Nations Covenant and the first Secretary General of the League of Nations (1919-1933), played a crucial and pioneering role in conceptualising an independent international civil service. But it was Dag Hammarskjöld, the UN's second Secretary General (1953-1961), who elaborated the concept. He set lasting standards that survive to this day.

An independent civil service was a huge part of Hammarskjöld's arsenal. As his numerous statements and speeches document, his terms in office were guided by strong and coherent ethics concerning the independence of the international civil service.

At the core of his ethics were integrity, loyalty to the principles of the UN Charter, independence from any national or regional interests and the

In my new book I pay tribute to Hammarskjöld's commitment to these principles as they applied to self-determination on the African continent.

The main focus is on the interpretation and implementation of the principles adopted by the UN member states through his diplomacy during the Cold War era. I present arguments and evidence why frameworks for governance, their interpretation and implementation matter.

#### THE UN AND DECOLONISATION

Decolonisation on the African continent gained momentum during the 1950s. The UN became an important forum for the growing demands for self-determination. As Secretary General, Hammarskjöld played a prominent role as events unfolded. These culminated in the Congo crisis of 1960/61. Faced with the secession of the Katanga province and Belgian destabilisation threats soon after independence, the Congolese government requested the UN to intervene. This resulted in one of the biggest UN interventions ever.

Hammarskjöld's role in the process is at the centre of the analysis. It examines the scope and limitations his office provided under the existing unequal power relations of the post-

His support for the struggles for national sovereignty shows that individuals and their running of office do matter. This is true even though the policy of big powers imposes limitations on them.

When Hammarskjöld and 15 others in his company died in a plane crash near the Northern Rhodesian mining town of Ndola in the night of September 17/18, 1961, the adjacent white settler-minority regimes were visibly relieved. And despite the world-wide recognition and appraisal, the secret services of all big powers had closely followed his attempts to bring the Katanga province back into the Congolese territory.

and other Western mining companies. It was the higgest supplier of uranium for the US nuclear arms race. As a mineral-rich resource of global relevance it was of highest geo-strategic interest.

#### WHY GLOBAL GOVERNANCE AND LEADERSHIP

My book argues that despite all the limitations, values matter for a global governance body seeking to solve - or at least contain - conflicts through multilateral diplomacy. It highlights the battles over the power of definition by different interest groups in the era of decolonisation and the East-West conflict as well as the potential role and influence of an individual in charge of the UN Secretariat.

It recognises Hammarskjöld as an outstanding international civil servant, who believed in the spirit and word of the UN Charter and the virtues of a service guided by loyalty to its values and principles.

Individual leadership is important. But I also emphasise the limitations such an office and its incumbent have. The study also critically reflects on some of the failures and flaws during Hammarskjöld's time as Secretary General. After all, while he set the bar very high and remains widely respected, he was far from unfailing.

Nevertheless, I argue, his term ended with his integrity intact. This was evident from the fact that towards the end of his time in office he was portraved through a lens of suspicion and mistrust in the West and open calls for resignation in the East. Revealingly so, the newly independent states remained to a large extent supportive. For them he was "their" Secretary General.

A hundred years after the creation of an inter-Reassessing Hammarskjöld's anti-hegemonic national civil service, Hammarskjöld deserves to be remembered for leading by example.

## New cholesterol study may lead you to ask: Pass the eggs, or pass on the eggs?

The recent news that eating three ■ to four eggs a week is linked to a slight increase in risk for developing heart disease was a bummer for egg lovers. Should you stop eating eggs because of this new finding?

The study, published in March in the Journal of the American Medical Association, examined the association between dietary cholesterol or egg consumption with cardiovascular disease and all causes of mortality.

The analysis pooled the data of over 29,000 participants from six major U.S. studies conducted between 1985 and 2016. The authors reported that when 300 mg of dietary cholesterol were consumed per day (one large egg contains about 180 mg of dietary cholesterol), there was a 17% higher risk of a cardiovascular disease incident. including stroke, heart attack, coronary heart disease or heart failure. There was also an 18% higher risk of mortality from all causes when compared to not consuming dietary cholesterol.

of the Dietary Guidelines for Amerition to limit consumption of dietary cholesterol, it left many consumers confused. Since the initial release of the Dietary Guidelines in 1980 and in the six following editions, there has always been a recommendation to limit total fat, saturated fat and dietary cholesterol.

The 2015-2020 Dietary Guidelines' key recommendation instead focused on consuming less than 10% of daily calories from saturated fats with no mention of dietary cholesterol. Many consumers concluded that dietary cholesterol must no longer matter.

I am a registered dietitian nutritionist and will try to explain the study and previous findings

#### WHAT IS CHOLESTEROL ANYWAY?

Cholesterol is a waxy, yellowish fat that is produced in our liver and intestines. It is found in every cell of the body. It is a necessary component for many of our bodies' physiological and structural functions, including cell membrane construction, hormone production and other vital functions. All the cholesterol we need can be produced by our bodies, so it is not essential that we consume dietary sources of cholesterol for our well-being.

While our bodies make cholesterol, we can also consume cholesterol from the foods we eat. These "dietary" sources of cholesterol are found in animal sources that produce cholesterol. So foods, such as beef, pork, lamb, chicken, eggs, fish and shellfish all contain cholesterol in various amounts. Small amounts of dietary cholesterol can also be found in items produced from animals, such as milk.

One reason the 2015-2020 Dietary Guidelines Advisory Committee gave for not focusing on dietary cholesterol is because dietary cholesterol and saturated fats are found in similar foods. So, when one consumes foods with low amounts of saturated fats, they are generally consuming low amounts of dietary

Of course individual animal foods will differ, with some containing high amounts of cholesterol and low amounts of saturated fat, low amounts of cholesterol and high When the most recent version amounts of saturated fat, or anywhere in between. For example, a 2-ounce large egg contains 180 mg of dietary cholesterol and 1.5 g of saturated fat, while a 2-ounce top sirloin contains 60 mg of cholesterol and 3.5 g of saturated fat.

Plant sources, including vegetables, fruits, grains, nuts and seeds do not contain cholesterol. However, some plant sources naturally contain saturated fats, and through processing and preparation can have saturated fats or trans fats added to the final product. The 2015-2020 Dietary Guidelines recommended limiting saturated fats from all sources to less than 10% of total calories (that would equal about 22 g of saturated fat in a 2,000 kcal/day eating pattern).

#### IN THE END, THE GUIDELINES FACED FAT. NOT CHOLESTEROL

The 2015-2020 committee decided not to provide a daily limit of dietary cholesterol intake, which had been included in previous versions of the Dietary Guidelines. This was due in part to a lack of evidence regarding just how much of an effect dietary cholesterol had on an indi-

vidual's blood cholesterol level.

The advisory committee also noted that the average daily intake of dietary cholesterol in the United States was already below the 300 mg recommended threshold.

The omission of any definitive recommendation combined with the increasing popularity of low carbohydrate-high fat diets almost seemed an endorsement of dietary cholesterol. However, this was not the 2015-2020 DGA committee's intent.

#### WHAT ABOUT THOSE WITH HIGH **BLOOD CHOLESTEROL?**

Less than optimal levels of blood cholesterol continues to be a critical risk factor for cardiovascular disease.

The body produces several types of cholesterol, but two are of primary concern. HDL, "good cholesterol" which removes cholesterol from the body, and LDL, "bad cholesterol," which carries cholesterol to arteries and tissues. Over time high LDL levels of cholesterol can lead to a buildup of cholesterol in the arteries.

According to the Centers for Disease Control and Prevention, more than 125 million adults have a total cholesterol above the recommended 200 mg/dL.

symptoms but raises a person's risk for heart disease, the leading cause of death, and for stroke, the fifth leading cause of death in the U.S.

For those where high cholesterol is not a current concern, consuming eggs three to four times per week appears to pose little risk to their overall health, especially if they are following other aspects of a hearthealthy diet.

However, people who have high cholesterol should continue to pay close attention to sources of saturated fat and dietary cholesterol.

#### WHAT CAN WE LEARN FROM THIS EGG STUDY?

It is always difficult to draw a definitive conclusion based on the result of a single study. In fact, most scientists discourage doing so. It is also very important to consider the study's design.

Regarding the JAMA article, this was not a single study with over 29,000 participants. Instead, it was a collection of six large studies conducted over a long period of time

and then combined into one study.

Considering methods differed between the studies, it can be difficult to align the studies and participants exactly. While the authors worked hard to correct for this, it will still remain a limitation.

Second, the initial studies used self-reported dietary data which can result in inaccurate data and relied on a single measurement of both egg and dietary cholesterol intake, which may not reflect habitual intake.

Finally, while many additional heart disease risk factors were considered in this study, there is still a risk of "residual confounding," which results when some other variable may actually be responsible for an outcome instead of the main variable investigated.

So, where does such a study combined with our current knowledge of the subject leave the public?

People who have normal blood cholesterol levels can continue to eat foods such as eggs and shellfish, which contain high levels of dietary cholesterol but low levels of saturated fat. These individuals should also consider following the Dietary Guidelines key recommendations. Currently, there isn't sufficient evimuch for this segment of the population. And as previously noted, ongoing concern continues to be placed on the effect of saturated fat from all sources.

However, for those with high cholesterol, there remains strong evidence that a heart-healthy eating pattern that focuses on limiting daily intake of saturated fat, trans fatty acids and dietary cholesterol while consuming a variety of fiber-rich vegetables, fruits, whole grains, low-fat and fat-free dairy, nuts, seeds and legumes is still very important.

Since determining to what degree each factor plays in every individual's blood cholesterol is impractical, the prevailing logic for those who have high blood cholesterol is to continue care with their primary health care provider and adopt an eating pattern that supports their cardiovascular health.

NEW DELHI, APR 22 (PTI): Former deputy election commissioner Zutshi was on Monday appointed as special observer for Tripura where the Lok Sabha polls to one of the seats was postponed in view of the law and order situation.

## AIFF signs coaching convention with AFC



NEW DELHI, APR 22 licenses carry paramount (PTI): All India Football Federation (AIFF) has signed an agreement called Coaching Convention with the Asian Football Confederation to extensively focus on coaching rules and methods.

The Convention is an endorsement tool which will highlight the regulations and guidelines of coach education.

AIFF's Acting Technical Director Savio Medeira said the Coaching Convention will help the coaches to manage their schedule in a better way.

"It will be done in modules and it will also help them to work on their deficiencies during the break. Coaches will also have to undergo assignments which was not there before. Overall it will help coaches to be more confident and efficient in their approach towards coaching," Medeira said.

The licensing system will be refurbished in 2020 and the coaching diplomas will be broken into modules. "Coaching

importance with regards to pursuing a professional career which remains valid for three (3) years. Unless a coach does not undergo Continued Professional Development (CPD) courses during the period of three years, the license will be revoked," the AIFF said in a statement.

On the other hand. the License will be renewed for another three years if the candidate acquires his CPD of 21 points. Otherwise, the person will have to repeat the specific diploma course again.

With regards to the 21 CPD points within three years, a coach must gather a minimum of four points but not more than seven points per year. If a particular coach gathers four CPD points every year, he/she will be allowed six months of additional time to complete the minimal 21 CPD points. Should they fail to do so, the coaches will be advised to re-attend the course. "Coaches and assistant coaches assigned with respective responsibilities of professional teams, club academies, accredited academies etc will have to collect 3 CPD points from off-field platforms i.e. seminars, workshops and online courses annually," the statement said.

Medeira said the CPD will "help the coaches who aren't employed to stay connected".

"CPD is one of the criteria of the convention to renew their licenses. It will help coaches who are not employed to stay connected to the latest trends of the game by attending CPD courses. If coaches don't attend refresher courses and collect credit points within 3 years they will have to repeat the entire course again," he said.

However, world championship bronze-medallist Lovlina Borgohain (69kg) bowed out of contention after a quarterfinal loss to reigning world champion Chen Nien-Chin of Taiwan.

#### Trump decides not to grant waiver to India, 7 others importing Iranian oil

Lalit K Iha Washington, Apr 22 (PTI): In a move that could have implications on India's energy securi-Trump on Monday decided not to grant sanctions exemptions to any oil customers of Iran, further squeezing Tehran's top export commodity.

"President Donald J. Trump has decided not to reissue Significant Reduction Exceptions (SREs) when they expire in early that global oil markets May. This decision is intended to bring Iran's oil exports to zero, denying the regime its principal source of revenue," White House Press Secretary Sarah Sanders said. The US re-imposed sanctions on Iran last November, after President Trump pulled out of the landmark 2015 Iran nuclear deal.

COLOMBO, APR 22 (PTI): Sri Lanka on Monday lifted the curfew which was indefinitely imposed after the island nation was rocked with eight blasts targeting churches and hotels that killed over 215 people.

Sri Lankan government on Sunday imposed curfew with immediate effect after the blasts which was lifted at 6 am Monday morning, police said.

A string of eight powerful blasts, including suicide attacks, struck churches and luxury hotels frequented by foreigners in Sri Lanka on Easter Sunday, killing 215 people, including three Indians, and shattering a decade of peace in the island nation since the end of the brutal civil war with the LTTE.

According to the Sir

Lankan authorities, 13 people were arrested in connection with the bomb blasts. However, the government said it will not disclose the details of the suspects involved in the attacks to prevent them from getting publicity.

Don't give extremists a voice. Don't help to make them martyrs, State Minister of Defence, Ruwan Wijewardene, told reporters when asked for details of those in custody.

However, police officials privately said the suspects were all from the minority Muslim community.

Police said the van which had carried explosives to carry out bomb attacks at the three hotels was arrested with its Muslim driver.

the bombers had lived for nearly three months leading to the attacks were discovered in the south of Colombo suburb of Panadura.

## Possible intel failures to be examined in Sri Lanka blasts

Police in Sri Lanka said Monday the investigation into the Easter Sunday bombings will examine reports that the intelligence community failed to detect or warn of possible suicide attacks before the violence.

The nine bombings of churches, luxury hotels and other sites was Sri Lanka's deadliest violence since a devastating civil war in the South Asian island nation ended a decade ago.

spokesman Ruwan Gunasekara said Monday the death toll had risen overnight to 290 dead with more than 500 wounded.

Two government ministers have alluded to intelligence failures.

Telecommunications Minister Harin Fernando tweeted, "Some intelligence officers were aware of this incidence. Therefore there was a delay in action. Serious action needs to be taken as to why this warning was ignored."

He said his father had heard of the possibility of an attack as well and had warned him not to enter popular churches.

And Mano Ganeshan, the minister for national integration, said the security officers within his ministry had been warned by their division about the possibility two suicide bombers would target politicians.

Gunasekara said the Criminal Investigation Department investigating the blasts will look into the reports.

Minister Defence Ruwan Wijewardena previously described the blasts as a terrorist attack by religious extremists, and police said 13 suspects were arrested, though there was no immediate claim of responsibility.

Wijewardena most of the bombings were believed to have been suicide attacks.

The US said "several" Americans were among the dead, while Britain, India, China, Japan and Portugal said they, too, lost citizens.

The streets largely deserted Monmorning, with most shops closed and a heavy deployment of soldiers and police. Stunned clergy and onlookers gathered at St. Anthony's Shrine, looking past the soldiers to the stricken church.

The Sri Lankan government lifted a curfew that had been imposed during the night.

But most social media remained blocked Monday after officials said they needed to curtail the spread of false information and ease tension in the country of about 21 million people.

Sanjeewa Appuphamy said that hundreds of people had turned up for the Easter celebrations in the church and it was almost the end of morning's celebrations when the bomb went off.

The series of eight bomb blasts, that targeted Easter worshippers and high end hotels popular with international guests, killed over 290 people and injured more than 500 others.




