On anniv of Gangtok rally, aggrieved adhoc teacher highlights continuing denials

m n}$ adhoc teacher, Prakash Parajuli, today alleged that the both, the former and the present governments have failed to address the issues and problems being faced by adhoc teachers in the State.

His statement was to mark the anniversary of 19 February last year when adhoc teachers had taken out a massive rally in Gangtok demanding regularization of their services. Four teachers, including Mr Parajuli, had been taken into custody on the day marked with confrontation and tension in the capital, it may be recalled.

Addressing a press



conference here today. Mr Parajuli held up 19 February as 'Sikshak Chetna Diwas' [Teachers Awakening Day] and congratulated all teachin the movement.

He contended that although adhoc teachers had taken to the roads for their rights, their demands remain pending till date despite assuranc-

es made on the day in the run-up to the elections.

He stated that there were two types of teachers in government schools - regular and adhoc - who work equally hard but are

not paid the same.

Mr Parajuli stressed that this practice has been affecting teachers emotionally and would ultimately affect the development of students and schools as well.

He said, "Our movement is not only for job regularization but change in the system which allows such disparity."

He stressed the need to eradicate the adhoc system and insists that all appointments be on regular basis. In this regard, he said that the recent notification for appointment of adhoc teachers was a clear sign that the Department has no plans to end the adhoc system of teacher appointment.

by 63pc in 75 yrs: WTI

GANDHINAGAR, FEB 19 (PTI): The population of whale sharks, one of the endangered migratory species, has declined by 63 per cent in last 75 years in the Indo-Pacific region, a nature conservation body has said while urging the government to intensify steps and train enforcement agencies to con-

serve the species. Wildlife Trust of India (WTI) said whale sharks, the largest living fish in the world, are vanishing from the face of the earth due to factors like climate change, rampant fishing and ocean pollution.

However, a senior official from the Union Environment ministry said efforts were on to revive the number of whale sharks and if needed, the government will spend around Rs 2-3 crores annually for its conservation.

Whale sharks have been classified as endangered in the red list of International Union for Conservation of Nature (IUCN), and are also called 'Gentle Giants' with maximum aggregation off the Gujarat coast.

Sajan John, marine expert from WTI, said these giants are mainly targeted for their meat but ocean pollution and warming were also affecting them.

"India needs to have stronger dialogue with countries to protect this mega fauna which migrates from one country's coast to another and gets killed on the way.

"The population of these large and vulnerable aquatic animals which are deliberately targeted for meat, has declined by 63 per cent in the last over seven decades, also due to other factors like climate change, ocean pollution and fishing pressure," John said at the sidelines of The 13th Conference of Parties to the Convention on Conservation of Migratory Species of Wild Animals (CMS COP 13) here.

WTI is working with the Gujarat government to rescue whale sharks which get stuck in fishing nets along its coast.

John said fishing of whale sharks is also done to collect and trade its fins.

"Though government has banned export of shark fins, illegally it is still being done," said the WTI official.

John also urged that the government should be proactive and intensify its steps to conserve the species.

"The enforcement agencies like Wildlife Crime Control Bureau, Customs etc should be trained on how to identify protected species of sharks. Capacity building of the enforcement team is a major thing that needs to be strengthened.

"Government needs to intensify the steps it is taking. Information dissemination in stages has to be ensured. People at ground level should also be aware of the importance of protected species," he said.

Soumitra Dasgupta, IG, Wildlife, Union Environment Ministry said, "Whale sharks have been under tremendous threat. Their population has seen a sharp decline but with the assistance of fishing community and WTI, revival work is going on.

Necessary to prevent statelessness when nationality laws are changed: UN chief

ISLAMABAD, FEB 19 (PTI): Amid concerns over India's Citizenship Amendment Act and the proposed National Register of Citizens (NRC), UN chief Antonio Guterres has said it is necessary to do everything to prevent "statelessness" when when a nationality law is changed.

Guterres, who was on a three-day visit to Pakistan, when asked whether he was concerned about new laws in India during an interview, said, "Of course (I am concerned). Because this is an area in which the relevant UN body is quite active."

"The present High Commissioner for Refugees is quite active to this situation like many others like this. Because there is risk of statelessness created by those national laws," the UN Secretary General told Dawn News TV. "It is abso-

lutely essential when a nationality law is changed, the statelessness is prevented. Because when basic right of anyone anywhere is to have a country that a person calls his, then everything should be done in order to avoid statelessness, he said.

The new citizenship law passed by the Indian Parliament in December 2019 offers citizenship to non-Muslim persecuted religious minorities from Pakistan, Bangladesh and Afghanistan. After the enactment of the law, protests erupted across the country over fears that it may marginalise the minority Muslim community.

The Indian government has maintained that the CAA is an internal matter of the country and stressed that the goal is to protect the oppressed minorities of neighbouring countries.

The NRC has been prepared to identify genuine Indian citizens living in Assam since March 24, 1971, or before, and identify illegal Bangladeshi migrants in the state.

Out of 3.3 crore applicants, over 19 lakh people were excluded from the final NRC published on August 30.

On Kashmir, Guterres said two reports by the UN High Commissioner on Kashmir played an important role in clarifying exactly what is happening there and it is essential that these reports are taken seriously.

Guterres on Sunday said in Islamabad that he was concerned over the situation in Kashmir, and that he was ready to mediate between India and Pakistan to resolve the long pending issue. Reacting to his offer, India said the vacate territories "illegally and forcibly" occupied by Pakistan. "India's position has not changed.

Jammu and Kashmir has been, is, and will continue to be an integral part of India. The issue that needs to be addressed is that of vacation of the territories illegally and forcibly occupied by Pakistan," the Ministry of External Affairs said in New Delhi.

"Further issues, if any, would be discussed bilaterally. There is no role or scope for third-party mediation," it said.

India revoked Jammu and Kashmir's special status on August 5. Reacting to India's move, Pakistan downgraded diplomatic ties with New Delhi and expelled the Indian High Commissioner.

Poet, journo held over recital of anti-CAA poem at govt function in Karnataka

BENGALURU, FEB 19 (PTI): A poet and a journalist have been arrested in connection with recital of a poem against CAA and NRC at a government sponsored function in Koppal district of Karnataka last month, police said on Wednesday.

The arrests were made based on a complaint from a BJP functionary alleging that Siraj Bisaralli, a poet had recited an anti-CAA poem at 'Anegundi Utsava' in Gangavathi town of Koppal district in January and Rajabaxi, editor of an online news portal uploaded it on social media.

Police had registered a case against them under section 505 of IPC (statements conducing to public mischief).

On Tuesday, Bisaralli and Rajabaxi surrendered before a court in that district, which rejected their tails with," police said.

When asked why the UN has failed to constitute a high-powered inquiry commission to go to Kashmir and investigate alleged rights violations, the Secretary General said: Only the governing bodies of the UN or the Security Council can make that decision, but these reports are credible, relevant and very important.

He acknowledged that the current structure of the UN and the veto power to only its five permanent member states were hampering the ability of the UN to deliver the very objective it was created for conflict resolution.

In order to ensure increased efficacy of the UN, he felt the body had to be reformed to be made "more democratic, more open and more effective and to be more representative of today's multilateral world.

"We lived in a bipolar world, the rules were relatively clear. Today it is no longer bipolar, not yet multipolar, it is a kind of a chaotic world. Power relations are unclear so we see situations of conflict to which many spoilers can do whatever they want because there is no way to create a minimum of order, he added.

When asked about the position of the UN on the Palestinian question, Guterres responded that our position has not changed, asserting that he remained committed to the two-state solution, with the "two states living side by side.

Guterres also affirmed that the UN stood ready to facilitate a dialogue between Israel and Palestine based on international law and principles.

Guterres during his three-day visit to Pakistan met officials, attended a conference on Afghan refugees, visited Gurdwara Kartarpur Sahib and saw cultural places in Lahore.

Govt makes crop insurance schemes voluntary for farmers

NEW DELHI, FEB 19 (PTI): The government on Wednesday made its flagship crop insurance schemes voluntary for farmers with existing crop loans or those willing to take new ones, as it seeks to address the concerns raised by farmers' body and states in implementation of these programmes.

"The Union Cabinet has approved revamping of 'Pradhan Mantri Fasal Bima Yojana (PMF-BY)' and 'Restructured Weather Based Crop Insurance Scheme (RWBCIS)' to address the existing challenges in implementation of crop insurance schemes," an official statement said.

Under the PMFBY, which was launched in February 2016 by Prime Minister Narendra Modi, it is mandatory for loanee farmers to take insurance cover under this scheme.

The PMFBY provides comprehensive crop insurance from pre-sowing to post-harvest period against non-preventable natural risks at extremely low premium rate of 2 per cent for kharif crops, 1.5 per cent for rabi crops and 5 per cent for horticulture and commercial crops.

The Cabinet approved modification of certain parameters/ provisions of ongoing PMFBY and RWBCIS schemes.

the "Enrolment under scheme to be made voluntary for all farmers (both PMFBY/ RWBCIS)," Agriculture Minister Narendra Singh Tomar told reporters here.

He said currently 58 per cent of total farmers are loanee and the remaining 42 per cent are non-loanee. The number of farmers opting for these crop insurance schemes may drop immediately but the enrolment would eventually pick up, Tomar said.

The minister said the government would launch a campaign for creating awareness among farmers about the need to take a crop insurance policy.

These modifications will help in addressing the concerns raised about the PMFBY scheme by farmers organisations and states, he said.

Among other modification, Tomar said the allocation of business to insurance firms through tender process would be done for three years as against the current policy of one to three years.

"Central share in premium subsidy to be increased to 90 per cent for north eastern states from the existing sharing pattern of 50:50 (Both PMFBY/RW-BCIS)," the statement said.

Tomar said States will not be allowed to implement these schemes in subsequent seasons in case of considerable delay in release of requisite premium subsidy to insurance companies beyond a prescribed time limit. Cut-off dates for invoking this provision for Kharif and Rabi sea-

sons will be 31st March and 30th September of successive

years, respectively. The Cabinet also approved provisioning of at least 3 per cent of the total allocation for the scheme to be made by the Centre and implementing state governments for administrative expenses.

For estimation of crop losses/admissible claims in the PMFBY, two-step process will be adopted based on defined deviation matrix using specific triggers like weather indicators, satellite indicators, etc, for each area along with normal ranges and deviation ranges. Only areas with deviations will be subject to crop cutting experiments (CCEs) for assessment of yield loss.

Technology solutions like Smart Sampling Technique (SST) and optimization of number of CCEs would be adopted in conducting CCEs. In case of non-provision of yield data beyond cut-off date by the States to implementing insurance firms, claims will be settled based on yield arrived through use of technology solution.

The central subsidy under PMFBY/RWBCIS to be limited for premium rates up to 30 per cent for un-irrigated areas/ crops and 25 per cent for irrigated areas/crops. Districts having 50 per cent or more irrigated area will be considered as irrigated area/district.

States have been given flexibility to implement the schemes with option to select any or many of additional risk covers/ features like prevented sowing, localised calamity, mid-season adversity, and post-harvest losses. Further, States/UT can offer specific single peril risk/insurance covers, like hailstorm etc, under PMFBY even with or without opting for base cover (Both

PMFBY/RWBCIS). "As the scheme is being made voluntary for all farmers, therefore, to provide financial support and effective risk mitigation tools through crop insurance especially to 151 districts which are highly water stressed including 29 which are doubly stressed because of low income of farmers and drought, a separate, scheme in this regard would also be prepared," the statement said.

The concerned provisions/ parameters of scheme and operational guidelines of the PMFBY and RWBCIS would be modified to incorporate these modifications and made operational from Kharif 2020 season.

"With these changes, it is expected that farmers would be able to manage risk in agriculture production in a better way and will succeed in stabilizing the farm income. These changes will also enable quick and accurate yield estimation leading to faster claims settlement," the statement said.

The apex court, however, did not seek presence of the minister after Additional Solicitor General A N S Nadkarni raised objection. A bench, headed by Chief Justice S A Bobde, enquired from Nadkarni as to whether the minister can come over for an interaction to assist this court.

curb air pollution.

"Can the minister come to Supreme Court and explain proposal to introduce non-polluting vehicles run on electricity/hydrogen," the bench asked the law officer.

The bench noted that the minister has been ternative fuels in private and public transport, so the court would like to interact with him.

Without seeking the presence of the transport minister, the top court further said: "We consider it appropriate that all the issues be considered simultaneously with the assistance of authority empowered to take decision." It then put up the matter for hearing after four weeks.

During the hearing, Bhushan, appearing for NGO - CPIL, said that as per the National E-Mobility Mission Plan (NEM-MP), 2020 EVs were to be procured by the government. The authorities were also required to provide charging points for electric vehicles at public places like malls and petrol pumps.

Bhushan also said that under the scheme the authorities were required to promote sale of EVs by providing subsidies.

The bench adjourned the hearing for four weeks and ordered that in the meantime all issues relating to EVs be considered by the government with the assistance of an authority empowered to take decisions.

COVID-19: 36 return to Maharashtra from quarantine camps

MUMBAI, FEB 19 (PTI): Thirty-six people from Maharashtra, who were airlifted from the novel coronavirus-hit Wuhan city of China and quarantined for 14 days at facilities in the National Capital Region, returned to the state on Wednesday, Health Minister Rajesh Tope said.

These 36 people were among the 645 Indians who were airlifted from Wuhan about a fortnight back due to the coronavirus (COVID-19) outbreak in China. Wuhan is the capital of central Chinas Hubei province, the epicentre of the coronavirus outbreak. They were kept under observation at two special facilities - an ITBP camp in Delhi and an Army camp at Manesar near Gurugram - for two weeks.

Tope said the 36 travellers from Maharashtra were allowed to return home as they had completed 14-day-long follow-up period.

"Their swab samples also tested negative for the novel coronavirus infection," said Tope.

Cong demands HC judge probe into Mangaluru police firing during anti-CAA protest

BENGALURU, FEB 19 (PTI): The violence during the anti-CAA protest in Mangaluru in December 2019, which left two people dead in police firing, rocked the Karnataka assembly on Wednesday, with Congress holding the ruling BJP responsible for it and demanding a judicial probe headed by a sitting High Court

judge into the incident. Terming the 'golibar' (firing) as "pre planned" and blaming the city police commissioner for it, Leader of the Opposition Siddaramaiah questioned the government on the rule of law, as he expressed fears about the 'danger' to democracy and 'anarchy' taking over the system.

The debate on the law and order condition saw heated exchanges between ruling and opposition sides, even forcing an adjournment

Treasury and opposition benches clashed over LoP quoting the High Court's observations against police, while granting conditional bail to 21 people, who were allegedly involved in Mangaluru violence, stating that the matter was sub-judice.

"It was pre planned by police. The court itself has remarked about police excess. Even the complaint by the family of two innocent persons killed in the Golibar was not taken.

Twenty one people, mostly youths, were arrested in the case and sent to jail... This is police excess. Karnataka had never in the past become

a police state," Siddaramaiah said.

Questioning whether there was rule of law in Karnataka, he said "we believe in rule of law. Without rule of law there will be anarchy and democracy will be filed against BJP leaders in danger."

Stating that those killed did not belong to any party,he demanded to know how police had opened fire, despite instructions from the Chief Minister that there should not even be a lathicharge.

He suspected the role of some "unseen hand" behind the violence and police firing.

"I demand a judicial inquiry into the Mangaluru incident by a sitting judge of the High Court. The guilty should be punished," he said as he held the police department, Mangaluru police commissioner and state government directly responsible.Two people were killed in police firing in-Mangaluruin December 19 as the protest against the CAA had turned violent, following which the city was brought under curfew and mobile internet service was suspended.

Siddaramaiah referred to the recent arrest of a parent and a school headmistress (now on bail) in the "sedition case" for their alleged involvement in staging a drama, portraying the Prime Minister in poor light over CAA and NRC and charged the government with using police to 'fix' political opponents and those opposing BJP's "divisive polices."


He said Congress leader U T Khader and a student from Mysuru were booked under sedition charges for opposing CAA and NRC and holding a 'Free Kashmir' poster, while no cases were Somashekara Reddy, Anant Kumar Hegde and RSS strongman Kalladka Prabhakar Bhat for their "inflammatory speeches".

The discussion saw repeated arguments between Siddaramaiah and Law and Parliamentary Affairs Minister J C Madhuswamy as the former often referred to the High Court's observations on the matter.

As Siddaramaiah tried to defend Khader, saying his alleged inflammatory statements did not amount to sedition, Madhuswamy pointed out that the case was before the court raised objections to it, leading to exchanges between both sides.

While senior Congress legislators like R V Deshpande and K J George came to the LoPs defence, Minister C T Ravi and many BJP MLAs targeted Khader and Congress for his alleged comments during the anti CAA protest.

Georges comment that police was working as per orders being received from higher ups on filing cases against political opponents and in the Mangaluru incident drew a rebuttal from Home Minister Basavaraj Bommai, who said police have worked efficiently to maintain law and order.

On Every Street

...there are just too many vehicles to allow for managed traffic

Drive through Gangtok at night, and you will not be faulted for thinking that there was a traffic jam because that is the appearance that the sheer number of vehicles give out, parked as they are, even double-parked at some places, all along the highway in town. Okay, we exaggerate. But only very slightly. And since the parking regulations kick back into force with daybreak, these vehicles, as one of the taxi drivers once explained to his half-full share-cab, need to keep moving around because to stop would bring in the headache of finding a place to park. And this, in a nutshell and only in partially accurate terms, explains the endless march of traffic snarls in the capital.

Several years ago, the Traffic cops in Gangtok had organized a "khulla manch" (open session) to discuss Gangtok's traffic problems. Questions were fielded from vehicle owners and drivers to open deliberations on how the issue could be resolved. In the end, the session succeeded only in one aspect - allowing a platform for the "stakeholders" to let off some steam and rant against traffic personnel. The agenda set for the day could not be addressed in any earnest, which is perhaps why the Khulla-Manch platform is not a regular feature of police-driver interactions any more. What the deliberations also served to remind us was that traffic, despite every innovative measure deployed to manage it, will remain a problem in a hill town like Gangtok where the girth of the roads has no scope of increasing and the aspiration for bigger cars is showing no signs of receding. As things stand, the number of vehicles on the roads will increase every day and since there cannot be a commensurate increase in road-cover, congestion will get worse, skilled drivers will become rarer, pedestrians will keep getting pushed out and traffic management will get more complicated.

The problem with traffic in Gangtok is clearly not so much its management as its size. There are simply too many vehicles on the roads and a big contributor to the congestion on the streets is the absence of a proper and dependable public transport system in the capital [the city runner, let's accept it, is a poor pretender]. It is in the absence of a cheap, affordable and reliable public transport, that taxis abound and private vehicles proliferate. A regulation size bus for Gangtok roads was always a bad idea and an example of not thinking a good idea through. Smaller buses and more of them to more destinations within Gangtok on a fixed and reliable routine is what the capital needs. Even though people prefer a cheap mode of transportation [and even the share cabs are not cheap], they also need it to be reasonably quick [a bus-ride in Gangtok can hardly be swift]. If such a system is put in place, fewer people will take cabs, there will be no pressing need to own a vehicle (or ride it routine chores) and even the numbers of government vehicles can be reduced. Individual officers, speeding around in individual government vehicles is a luxury that Gangtok cannot afford to enjoy for long. Departmental vehicles should be pooled and issued out on individual basis only for field visits. The resources thus saved could be invested in strengthening the public transport system and maintaining the fleet. Tourist and city taxis could also be segregated so that they do not poach on each other's passengers or parking space.

If thought out properly, these options are not very complicated to implement and could make the traffic on our streets much saner.

Conservative Islamic views are gaining ground in secular **Bangladesh and curbing freedom of expression**

 ${f B}$ angladesh has seen an increase in terrorist activity in recent years, including attacks on foreigners, activists and religious minorities.

Perpetrators of these attacks have included people from privileged backgrounds. News reports indicate they were all motivated by the idea that Islam is under attack by secularists and must be defended.

This is significant in a country that was founded in 1971 on principles of secularism following an independence war with neighboring Pakistan.

My research on Islamist social movements has taken me to Bangladesh regularly for the past seven years. Over that time, I have found, conservative Islamic views have come to play a more central place in Bangladesh's politics and society.

THE BIRTH OF BANGLADESH

When the Indian subcontinent gained independence from the British Empire in 1947, it was partitioned into two states, creating Pakistan out of the Muslim-majority regions of British India. The newly formed Muslim country was split in two parts, West and East Pakistan, separated by the vast landmass of northern India.

While these two parts of Pakistan shared a common faith, Islam, there were significant cultural, linguistic and political differences between them. The population in the eastern region – predominantly ethnically Bengali and speaking their own language, Bangla – was politically marginalized by the western region.

In 1971, the people of East Pakistan launched a war for independence and founded the "Land of Bangla" - Bangladesh.

While language and culture was at the core of Bangladeshi national identity, most people still identified as religious. In other words, it was a secular country founded by people of faith. "Secularism" in Bangladesh did not imply absence of religion, but rather that the state be neutral toward religion.

ISLAMISTS AND POLITICAL POWER

Since then, my research shows, Islam has come to be a prominent political force in the country.

Islamists, a broad label that covers political parties, preachers and militant groups, among others, actively promote a more conservative version of Islam.

The most influential Islamist party is Jamaat-e-Islami, whose name means "Islamic gathering." Though it has never won many parliamentary seats, Jamaat-e-Islami has come to exert considerable influence in government.

Bangladesh's parliamentary system requires mainstream parties to ally with smaller ones to gain the majority necessary to form a government. Because of this, major political parties in Bangladesh have at different times relied on alliances with Jamaat to secure a parliamentary majority.

MOBILIZATION AGAINST SECULARISM

Other Islamists use "street power" to promote their agenda.

In February 2013, a high-ranking official with Jamaat-e-Islami received a life sentence for war crimes committed during the 1971 independence struggle. This was considered by some as too light a sentence. A few days later, protesters began rallying in the streets to demand the death penalty for

These secular-minded supporters of the war tribunal wanted local collaborators of the Pakistani army to be punished for atrocities they committed against Bengalis and religious minorities.

Most of those being tried by the tribunal came from the ranks of the Islamist party Ja-

The protesters wanted local collaborators of the Pakistani army to be punished for atrocities they committed against Bengalis and religious minorities. They demanded that Jamaat-e-Islami be banned and their financial interests, including Islamic banks, be dismantled.

This mobilization, however, was soon met with a coordinated counterprotest led by a movement known as Hefazat. As many as 500,000 people shut down major roads to the capital and interpreted the protesters demands as defaming Islam and the Prophet Muhammad.

In a 13-point list, the Hefazat demanded the death penalty for blasphemy. The group also asked for an end to Bangladesh's education policy, which, in its view, prioritized "secular" subjects like science and math over religious studies. The group also wanted compulsory Islamic education.

ISLAM UNDER THREAT

To appease Islamist interests, the government agreed to meet some of the demands.

One major concession was expanding the government's ability to crack down on those who "hurt religious beliefs" and for "acts of defamation."

Under this revised law, called the Information and Communication Technology Act, Bangladesh has arrested at least eight bloggers since 2013. The alleged crimes of these bloggers include writing articles critical of the Saudi government and posting derogatory remarks about the Prophet Muhammed online.

Police have used the defamation clause of the Information and Communication Technology Act and its replacement, the Digital Security Act of 2018, to silence criticism of the government. Over 1,200 people have been charged under this law between 2013 and 2018.

Educational policy too has shifted toward Is-

lamic education. THE ISLAMIC REVIVAL

Hefazat did not see all their demands met, but my research shows it moved Bangladesh away from its secularist ideals.

In truth, the shift in Islam's role in politics and society really began as early as 1975 when Bangla-

desh's founder and first president, Sheikh Mujibur Rahman, was assassinated in a military coup.

After that, Bangladesh experienced considerable political instability and was ruled by successive military governments until 1990, when a nonviolent mobilization ushered in a return to democracy.

During the dictatorship years, however, military rulers began to gradually open up politics to

A ban on Islamist political parties was lifted in 1975, which allowed Jamaat-e-Islami to run candidates for office and establish itself as a legitimate Bangladeshi political party.

In 1979, the commitment to secularism was removed from the preamble of Bangladesh's constitution. In 1988, Islam was made the official

The number of religious schools - madrasas - increased exponentially, from 1,830 in 1975 to 5,793 in 1990. And that's just government-sanctioned Islamic schools following a state-approved

Reliable data is missing for the vast majority of private madrasas in Bangladesh, which operate without any curricular control from the state. **CHANGES IN SOCIETY**

In today's Bangladesh there is another influential group: preachers who aspire to shape society according to their interpretations of what constitutes "pure" Islam.

Popular Islamic televangelists reach millions across the Muslim world, spreading the notion that Islam in the Indian subcontinent must be "purified" of non-Arab elements. They believe Arabic is God's language and to be properly pure, Muslims should use Arab practices and the language whenever possible.

For example, Muslims in South Asia commonly say "Khuda Hafiz" when parting, a phrase derived from Persian, meaning "God be your protector." Now, a popular Islamic televangelist, Zakir Naik, has revived an old argument that emerged in the 1980s in Pakistan, saying that "true Muslims" should use the Arabic version "Allah Hafiz" instead.

Similarly, as several Bangladeshis have told me, it is not uncommon in today's Bangladesh to be corrected when using the Persian "Ramzan," when referencing the Muslim holy month. The Arabic is "Ramadan."

These may seem like minor semantic changes, but they are representative of a broader "corrective movement" that seeks to "purify" Islam of perceived "un-Islamic" tendencies.

In my view, Bangladesh's secularism, a constitutional concept meant to guarantee the separation of religion and state, has become so vilified by Islamists that it has come to mean something akin to "atheistic" or "anti-Islamic."

Even very young children can become prejudiced but schools can do something about it

acism has negative consequenc-**N**es for children's health. It harms the kids who experience it personally and those who witness it, according to the American Academy of Pediatrics, an organization that represents 67,000 doctors who treat children.

I'm a developmental psychologist who studies the origins of prejudice in children, including teenagers. The research team I lead investigates the kinds of experiences that can help make kids become less prejudiced. We help local school districts with their efforts to encourage all children to get along well with others, including their classmates and teachers.

WHAT MAKES IT HARD TO HAVE FRIENDS?

Getting along well with others in childhood is about making friends, respecting others' viewpoints, and thinking about what's fair when resolving conflicts. Kids who have repeated conflicts with their classmates suffer in many ways, including experiencing stress and anxiety. Consequently, they may become withdrawn and not feel like going to school.

Bias can make it harder for people from different backgrounds to become friends with each other. That includes implicit biases that lead to things like microaggressions - everyday verbal and nonverbal insults that are often unintentional but nevertheless convey negative messages about others based on personal characteristics. It is also hard to make friends when other kids at school exclude you simply because your family is from another country.

By adolescence, implicit bias can

lead teenagers to use explicit racial likely to harbor prejudice as children slurs or harass their classmates. Unfortunately, instances of explicit bias in childhood and adolescence - such as calling someone the n-word or disparaging them for being an immigrant – are growing more common.

What's important to know, though, is that while these biases are taking hold, children also are developing positive beliefs about the importance of what it means to be fair. That can mean the need to take turns, share toys and avoid hurting anyone.

This contradiction can sometimes result in confusion and conflict.

CHANGE IS POSSIBLE

Children often don't get the consequences of their actions or what makes someone else feel bad. The good news is that the biases of children are not as hard to overcome as is the case with adults. Scholars like me call friendships with other kids from different cultural, ethnic and racial backgrounds "cross-group friendships." These bonds play a positive role to help children to reject or at least question stereotypes, from the internet, movies, politicians, the media, family or peers may not be true.

My research team has found that children who have friends from different backgrounds are able to reject stereotypes.

When children observe others who are friends from different groups then they are more likely to think "If someone from my group likes them then they must be OK." Discovering shared interests, hobbies, and values with new kids helps to diminish attitudes that might be based on stereotypes.

Psychologists have found that people who form cross-group friendships when they're young are less

or adults.

EQUIPPING TEACHERS

My colleagues and I have learned that when teachers encourage children to listen to one another, care for each other, and form friendships, children do better in school. What's more, when students learn about the historical contributions of famous individuals from both majority and minority backgrounds, they are less likely to display prejudiced attitudes.

Our University of Maryland program, Developing Inclusive Youth, is an eight-week program for elementary school students in third through fifth grade. Students log into an online curriculum tool and watch social exclusion scenarios among an animated group of characters, boys and girls, spanning many ethnicities as well as different immigration and class statuses. These situations occur during recess, in class, at home, and other everyday situations.

Kids use this app for 15 minutes, clicking on options to make decisions about how each character feels, and what should happen in the situation. Immediately afterwards, they sit in a circle with a teacher and talk about what they've been feeling and learning for half an hour.

Students often open up and describe their own personal experiences.

"Some kids said 'you can't play with me because you're a different skin color," observed an African American girl in third grade. A white girl sitting next to her replied: "That's not nice." The teacher asked the children what they should do if they see this happen and talked about the importance of changing this type of behavior.

After participating in the eight-

week program, children's responses to an in-depth survey about their attitudes and behavior revealed fewer stereotypes about girls and kids of color. They also expressed an increased desire to have friends from different social and cultural backgrounds than do students who don't

take part in the program. **COUNTERING STEREOTYPES**

A group of Harvard and Arizona State University researchers developed another program, the Identity Project, to give 9th graders the tools they need to learn about their racial and ethnic identity, and to make them more aware of the historical and societal sources of stereotypes and discrimination. Students get eight lessons that combine brief lectures, classroom activities and homework assignments.

As an example, students create a family tree and learn about their family's origins. Following the program, students had a greater understanding about their own ethnic and racial background and improved self-esteem. In addition, they learned about their classmates' cultural backgrounds and traditions.

The prejudices kids acquire early on can become deeply entrenched and hard to change as adults. In my view, it's important for schools to encourage students to overcome the bigotry they've learned by making friends with people who don't look like them. This will not only help these children. If it's done on a big enough scale it may well contribute to the creation of a more just and civil society.

Mamata blames Centre for Tapas Paul's death



KOLKATA, FEB 19 (PTI): West Bengal Chief Minister Mamata Banerjee on Wednesday alleged that "pressure" created by central agencies and "vendetta politics" led to the death of Trinamool Congress leader and actor Tapas Paul.

Paul, a two-term former MP, died at the age of 61 in Mumbai on Tuesday after a heart attack.

The actor-turned-politician was an accused in the Rose Valley chit fund scam case and was in jail for over a year. He was the brand ambassador of the Rose Valley group.

Banerjee, while paying homage to Paul, also alleged that another TMC leader Sultan Ahmed had also died of cardiac

arrest as he was under stress after being named an accused in the Narada tapes scandal of 2017.

Ahmed, a former Union minister, had died the same year. The wife of party MP

Prasun Banerjee, too, was a victim of the Centre's "vengeful" politics, the TMC supremo claimed.

where Paul's mortal remains have been kept for people to pay homage.

"It is an untimely death for Tapas Pal. He was a victim of continued mental torture by a central agency and that led to his death," she alleged.

Praising Paul for his work in films such as "Dadar Kirti" and "Saheb", the chief minister said actors and artistes are associated with several organisations as brand ambassadors.

"But is this a fault for which he (Paul) had to spend more than one year in jail? Is this right? This is pure political vendetta," she said. Even chargesheets in murder cases are filed within three months, the TMC leader said.

She said the same was the case with film producer Shrikant Mohta and a veteran journalist who had been incarcerated for a long time.

The CBI had in January last year arrested renowned Bengali film producer Shrikant Mohta in connection with the Rose Valley chit fund case.

2 crew members of Chinese ship under isolation in TN



CHENNAI. FEB 19 (PTI): Two Chinese crew members of a ship, which arrived from the novel coronavirus-hit China, have been kept in isolation due to fever while the vessel has been "kept away from access", the Chennai Port Trust said here on Wednesday.

The ship with 19 Chinese crew had visited ports in that country and was allowed here on Tuesday after the 14-day incubation period from its last visit to a Chinese Port and after ensuring that all the crew were healthy based on pre arrival monitoring, a release from the Port Trust said.

On berthing, a health team of the Port Health Officer (PHO) boarded the vessel and examined all the crew.

"It was observed that two of the 19 crew members had mild fever without other respiratory symptoms and otherwise healthy in all respects."

"These crew members were isolated within the ship and the ship is kept away from access of anybody from shore side and no crew is allowed shore access," it added. The blood samples

of the isolated individuals were collected on Wednesday by a state Health team and the PHO and sent to the city-based Kings Institute of Preventive Medicine, it said, adding, the results were expected later in the day.

"After receipt of the report, the Port authorities and officials of PHO will take strict measures as per the SOP (Standard Operating Procedure) regarding further action," the release added.

The outbreak coronavirus, known as COVID-19, in China has left 2004 people dead in the Asian country, even as the overal confirmed cases has crossed 74,000.

On February 9, two children were rescued from a brick-kiln at Jhugudi, near here. The children were from Bolangir district, the sources said.

11 Indian universities in top 100 for emerging economies ADITI KHANNA ties in world rankings,

LONDON, FEB 19 (PTI): Indian universities had a good performance year within the emerging economies of the world as a record 11 made it to the top 100 Times Higher Education's (THE) Emerging Economies University Rankings 2020.

Only China has more universities than India in the top 100 at 30 from a total of 47 countries and territories included in the analysis released in London on Tuesday evening.

A total of 56 Indian universities appear in the full ranking of a total of 533 universities across emerging economies of the world. The Indian Institute of Science (IISc), ranked 16th, is India's top-ranked institution followed by the Indian Institute of Technologies (IITs).

"There has long been a debate about the success of Indian universiand for too long they have been seen as underperforming on the global stage," notes Phil Baty, Chief Knowledge Officer for the THE.

"The Emerging Economies University Rankings 2020 suggests that real progress is being made by a number of institutions in a number of metrics across our robust methodology, and could mark an exciting turning point for Indian higher education, enabled in part by the Institutes of Eminence scheme," he said.

The Indian government's Institutes of Eminence scheme was established in 2017 and one of its participating universities, Amrita Vishwa Vidyapeetham, has entered the top 100 for the first time, moving up a huge 51 places from joint 141st in 2019. Amrita declared improvements in almost all the ranking metrics compared to 2019, THE notes.

The other universities included in the Institutes of Eminence scheme that appear in the top 100 mark the biggest improvers in the ranking with IIT Kharagpur moving up 23 places to 32nd, IIT Delhi improving by 28 places to joint 38th and IIT Madras climbing 12 places to joint 63rd.

Indian Institute of Technology Ropar and Institute of Chemical Technology are entering the ranking for the first time, and both debut in the top 100.

The Institutes of Eminence scheme provides participating universities with government funding and greater autonomy with the aim of moving them into the top 100 of the world university rankings, including Times Higher Education's World University Ranking, over time.



If India's net session on Wednesday is taken into consideration, Wriddhiman Saha is starting as the wicketkeeper ahead of Rishabh Pant for the series opener beginning here on Friday.

Hanuma Vihari, team's designated No 6 batsman for away Tests, will be the fifth bowling option with Jasprit Bumrah, Mohammed Shami and Ishant being three specialist pacers.

Ravichandran Ashwin is in the mix for the lone specialist spinner's spot though Ravindra Jadeja's all-round skills can't be ignored either.

Ishant, who was out for three weeks with ankle injury sustained during the Ranji Trophy game, bowled full tilt at the nets and even earned appreciation for troubling batsmen with his pace and bounce.

"He (Ishant) looked pretty normal and pretty similar to what he was bowling before the ankle injury. He is hitting good areas again and he has played (Test cricket) in New Zealand couple of times, so



his experience will be useful to us. It was really good to see him bowling with pace and in good areas," Kohli said during his media interaction.

The skipper also said in as many words that the team wouldn't like to change Shaw's natural stroke-play which was a good enough hint that Shubman Gill will have to warm the benches for now.

"My idea is to have a residential complex with all the multi-sports facilities and since (it will be) in the mountains, we will have access to the ski area, ice hockey," Keshavan told reporters here.

"It can be built over time. So, I'm speaking to a couple of state governments to give a little bit of land or get some sponsors (involved in it)."

Keshavan, a six-time Olympian, was speaking on the sidelines of the 'CII Conclave on Winter Sports', but he did not divulge which state governments he is in talks with.

"By doing so (having an academy), India can become a hub in the region. We have Nepal, Pakistan, Bangladesh, Sri Lanka, all countries that have budding winter sports teams," he said and wished that other athletes should not go the way he had to take in his career.

He's happy to see the sports ministry's interest in winter sports.

"The investments are starting to come in from the ministry and I think that was the missing link. I have been participating in winter sports for over 20 years. There is not a single winter sports federation recognised by the Sports Ministry.

"It is incredible to think how did I do (make) six Olympics without a Federation being recognised, which also means that I was not funded," Keshavan lamented.

Asked if he believed that India could win a medal in Winter Olympics, he said: "100 per cent. I

could have won a medal if I had a coach few years before, by the end of it I was (just) 6/10th of a second behind. It is possible"

He also rued the fact that a country like the Netherlands has 130 medals at the Winter Olympics, while India was yet to open its account.

"At five meters below sea-level, Netherlands has 130 medals at the Winter Olympics and we (India) at the roof of the world are yet to open an account," he said.

He was also asked whether winter sports can help a state like Jammu and Kashmir. "A lot of athletes

Priti Patel launches UK's historic' points-based visa system BY ADITI KHANNA

LONDON, FEB 19 (PTI): Home Secretary Priti Patel on Wednesday announced the launch of the UK's new pointsbased visa system, aimed at attracting the "brightest and the best" from the world, including from India, and cutting down numbers of cheap, lowskilled workers coming to the country.

The new system will come into force from January 1 2021 at the end of the transition period after the UK's exit from the European Union (EU) last month, which will formally end free movement of people within the economic bloc for the UK as a non-member.

The new post-Brexit system, which will apply equally to the EU and non-EU countries like India, is based on assigning points for specific skills, qualifications, salaries and professions, with visas only awarded to those who gain enough points.

"Today is a historic moment for the whole country. We're ending free movement, taking back control of our borders and delivering on the people's priorities by introducing a new UK points-based immigration system, which will bring overall migration numbers down," said Patel, the senior-most Cabinet Indian-origin minister.

We will attract the brightest and the best from around the globe, boosting the economy and our communities, and unleash this country's full potential. Patel. in charge of the UK's visa and immigration system,

The UK Home Office said the new system is a direct response to the 2016 referendum in favour of Brexit, which was seen as a vote to end the country's reliance on cheap migrant labour and reduce overall levels of migration with tighter security.

"The new single global system will treat the EU and non-EU citizens equally. It will give top priority to those with the highest skills and the greatest talents, including scientists, engineers and academics, the Home Office said.

The Global Talent Scheme, a fast-track visa to be in operation from Friday, will also apply to the EU citizens from next year to allow highly-skilled scientists and researchers to come to the UK without a job offer.

Professor Alice Gast, President of Imperial College London, said: British science is global. The new post-study work and Global Talent visas will help us to attract the world's brightest students and researchers, wherever they come from. From the race to develop a coronavirus vaccine to clean energy, British science's international collaborations drive innovation and excellence.

The government said the points threshold for the new system will be carefully set to attract the talent the UK needs.

China turns to internet for food supplies amid virus fears

BEIJING, FEB 19 (AP): Wang Feng, house-bound by China's virus outbreak, counts on the parka-clad delivery drivers of e-commerce giant JD.com to keep her kitchen stocked.

Demand for online food vendors has surged since China's government told the public to stay home as part of the most sweeping anti-disease controls ever imposed.

On Tuesday, Wang's phone buzzed with a text message that a delivery had arrived. The retiree bundled up against the winter cold, put on a face mask and emerged from her apartment complex to collect walnut milk and other goods from shelves on the sidewalk an anti-virus measure to limit contact with drivers who normally go door to door.

They work really hard, and it's dangerous, said Wang. Without their services, we would not be able to survive at all." JD.com Inc. and rivals including Pinduoduo, Missfresh Inc. and Alibaba Group's Hema are scrambling to fill a boom in orders while trying to protect their employees.

E-commerce is one of the few industries to thrive after anti-virus controls starting in late January closed factories, to work, said one of Wang's



restaurants, cinemas, offices and shops nationwide and extinguished auto and real estate sales.

The government is trying to revive economic activity but has told anyone who can work from home to stay there. Some cities have imposed controls that allow only one member of a family out each day. That creates a ready market for online entertainment and shopping.

Pinduoduo said orders for apples, strawberries and other fresh fruit from its 586,000 sellers of agricultural products were up 120% in January.

Disease fears in other Asian markets also have propelled e-commerce demand for food and hygiene supplies. The Korea Economic Daily said online mask sales in South Korea rose 37,000%

Chinese e-commerce companies emerged in a market that lacked credit cards, reliable delivery and other features their counterparts in the United States and Europe take for granted.

That required JD, Alibaba and some other competitors to create their own online payments systems or networks of warehouses and delivery drivers.

JD has a 180,000-strong workforce of drivers and warehouse workers and says it is hiring 20,000 more to meet demand. The company said Dada Group, a delivery service in which JD is an investor, is adding 15,000 to its workforce.

At a JD distribution center on Beijing's southeast side, employees in red parkas, masks and gloves sorted packages and sprayed them with disinfectant. Goods from oranges and toilet paper to 32-packs of beer and cat litter came off trucks on one side of the building and passed down a conveyor belt to be sorted for individual drivers. Padded blue boxes held fresh fruit and vegetables.

The average driver delivers 150 to 190 packages a day, according to Sun Lansong, the facility's manager.

Passengers leave Japan virus ship as China toll tops 2,000

Hundreds of relieved passensoon on board again," tweeted passensers finally disembarked a senger Yardley Wong, who left afcoronavirus-stricken cruise ship in Japan Wednesday after testing negative for the disease that has now claimed more than 2,000 lives in China and spread panic worldwide.

With 542 positive cases, the Diamond Princess is easily the biggest cluster outside China, and Japan has faced mounting criticism for its quarantine arrangements as the passengers disperse into the wider world.

"I'm relieved... I want to take a good rest," said a 77-year-old Japanese passenger, who declined to give his name. He said he would be boarding Japan's famously crowded railway system home.

A fleet of vellow-dotted city buses, plus a dozen or so taxis, whisked away the passengers, many of whom dragged their luggage behind them and waved to former ship-mates on balconies as they disembarked.

Fresh figures from China showed the death toll surging beyond 2,000 with more than 74,000 infected, although the rate of new cases continued to slow.

Hundreds more cases have been reported in two dozen countries, including 15 in South Korea -- a 50-percent rise -- with a cluster of at least 11 around the southern city of Daegu.

Hong Kong also reported its second death from the virus, which has proved extremely infectious.

For the 500 passengers disembarking the Diamond Princess after testing negative, a difficult 14day quarantine period has come to an end after their dream cruise turned into a nightmare of fear and boredom confined in many cases to small windowless cabins.

senger Yardley Wong, who left after 14 days cooped in a small cabin with her six-year-old son.

- 'Major failure' -

Many were left onboard with an anxious wait for test results that would allow them to disembark.

Asked how he felt seeing others disembark while remaining on the ship, American lawyer Matt Smith told AFP: "I need an emoji for envy."

Michael Ryan, head of WHO's health emergencies programme, said the outbreak was "very serious" and could grow, but stressed that outside China's Hubei, it was "affecting a very, very tiny, tiny proportion of people."

But in Japan, some have raised concerns about allowing people from the cruise ship to board flights home or spread out into the notoriously busy Japanese capital.

Kentaro Iwata, a professor at the infectious diseases division of Kobe University, blasted the onship quarantine as a "major failure, a mistake".

"It is highly likely secondary infections occurred," Iwata told AFP, saying scepticism from abroad of the quarantine was "only natural".

He later said in a video published online that he was self-quarantining after a brief visit to the ship where he raised major concerns about the procedures on board. "It was completely chaotic," he said.

- 'Hugs and flowers' -

Elated passengers also began disembarking from a second cruise ship that has been at the centre of coronavirus fear, the Westerdam, which made shore in Sihanoukville in Cambodia.

Hundreds were departing after receiving a clean bill of health, as Prime Minister Hun Sen greeted the first passengers with hugs and

American Christina Kirby, fret-

ted about the stigma some Westerdam passengers could face once they return home. "I want people to remember that... there's a human behind each of these stories and those who are ill deserve compassion," she told AFP. Several countries appear to

have lost patience with the quarantine on board the Diamond Princess and chartered planes to repatriate citizens. In the first such evacuation

Monday, more than 300 Americans flew home even though 14 had tested positive.

Britain, Hong Kong and Australia are among other countries that have vowed to repatriate people from the ship but will insist on a further 14-day quarantine on home soil. Nathalie MacDermott, a medical expert at King's College London, recommended a further 14-day self quarantine for those leaving.

"Given the circumstances on board the Diamond Princess, those passengers leaving the boat should be managed in a similar manner to those individuals departing a highly affected city or region," said MacDermott.

South Korea vowed to block foreigners who have been on board the Diamond Princess from entering the country.

Disembarkation is expected to take around three days as more test results become available. The crew will begin a new quarantine when the last passenger has left.

People in Yokohama appeared supportive of the decision to allow the passengers out despite the virus fears. "I am sure those people on board must be really worried. I hope they can go back to their normal life soon," said 51-year-old Isamu Habiro.

"As a Yokohama resident, I don't want them to be treated unfairly. I want to cheer for them," Habiro told AFP.

Death toll from China virus surges past 2,000



BY K J M VARMA BEIJING, FEB 19 (PTI): The death toll from the coronavirus epidemic in China crossed the 2.000-mark on Wednesday with the death of 136 more people, while the overall confirmed cases climbed to 74,185,

The National Health Commission said in its daily report that 2,004 people had died of the disease known as COVID-19. NHC said 1.749 new cases of novel coronavirus infection have been confirmed.

authorities said.

Of the new deaths, 132 were reported from the worst-hit Hubei Province and one each from Heilongjiang, Shandong, Guangdong and Guizhou.

Another 1,185 new suspected cases have been reported. On Tuesday, 236 patients became seriously ill, while 1,824 people were discharged from hospital after recovery.

The commission added that 11,977 patients remained in severe condition, and 5,248 people novel coronavirus pneuwere suspected of being infected with the virus, the state-run Xinhua news agency reported. By Tuesday, 62 con-

firmed cases including one death had been reported in Hong Kong, 10 confirmed cases in Macao and 22 in Taiwan including one death.

China's daily number of newly recovered novel coronavirus patients has surpassed that of new confirmed infections for the first time, according to NHC.

So far, 14,376 patients infected with the novel coronavirus had been discharged from hospital after recovery, NHC said.

On Tuesday, Dr Liu Zhiming, president of Wuhan Wuchang Hospital in Hubei, died of the monia highlighting the risks posed by virus to the medical staff.

Liu was a leading neurosurgeon in Wuhan.

Last Friday, the NHC said a total of 1,716 medical workers had been confirmed contracting the infection. As of February 11, six medical workers were killed while treating patients. This included the whistle-blower ophthalmologist, Dr Li Wenliang who was reprimanded by police for alerting about the virus over the social media in December.

Former South Korean president jailed after losing appeal

m ormer}$ South Korean president Lee Myungbak was taken to prison Wednesday to begin a 17-year term for bribery and embezzlement after losing an appeal against a lighter sentence.

Lee, in office from 2008 to 2013, was briefly jailed in 2018 after being sentenced to 15 years and fined 13 billion won (\$11 million), but was

granted bail while he saying Lee "did not show appealed. He was found guilty of creating slush funds of tens of millions of dollars and accepting bribes from Samsung Electronics in return for a presidential pardon for its chairman, Lee Kun-hee, who was jailed for tax evasion.

At a hearing on Wednesday, Seoul's Central District Court ordered a heavier sentence, a sign of remorse or sense of responsibility" for his wrongdoings. He instead blamed

civil servants he worked with and Samsung employees, the court said. Several South Korean

presidents have ended up in prison after leaving office -- often as a result of investigations started by political rivals. Lee's

successor, Park Geun-hye, is currently serving 32 years in jail for bribery and abuse of power after being ousted in 2017 over a nationwide corruption scandal that prompted massive street protests. Another former lead-

er, Roh Moo-hyun, committed suicide after being questioned in a corruption probe involving his family.



Avengers 3 and 4 worked so well because Marvel built a massive overarching story that spanned a decade, allowing us to get to know a slew of exciting characters over the course of 24 movies. Now that Iron Man, Nat, and Captain America are gone from the Avengers team, and Thor and Hawkeye are on a course toward retirement, we're going to need a new team — which is why Avengers 5 will be a soft reboot for the series. But before we get there, we need to meet these new heroes and fall in love with them just as we did

As we've already explained, everything we've learned so far suggests Marvel is working on a new Avengers roster, one that could be more diverse than ever before. While we have no idea how many new Avengers we're getting or when they'll be officially anointed, we have one more name to add to the list, and this one is apparently confirmed to have a bigger role to play in the future of the MCU.

Still, it feels like Endgame didn't give Hulk a proper send-off. With that in mind, we'd expect to at least get a Hulk cameo in the new She-Hulk TV series — and we already know Mark Ruffalo was supposed to meet Marvel to discuss more Hulk pitches.

What's clear is that She-Hulk will: definitely premiere well before the MCU treats us to the first Avengers sequel after Endgame. And by the time Marvel is ready to announce Avengers 5, Jennifer could be • ready to join the Avengers.
