### SDF COMPLAINS TO ECI AGAINST GOLAY AS CM CANDIDATE ANNOUNCEMENT

# SDF wants SKM deregistered for spreading false info

**SUMMIT REPORT** GANGTOK, 28 MAR:

Sikkim Democratic Front has written to the Election Commission of India seeking the deregistration of Sikkim Krantikari Morcha for violation of model code of conduct and for propagating false and misleading information. SDF's complaint stems from SKM's announcement of its president, PS Tamang [Golay], as the party's chief ministerial candidate even though he stands disqualified from contesting elections for a period of six years following his conviction

corruption case.

In a letter to the Chief Election Commissioner dated 26 March, the SDF general secretary, administration, Dev Gurung, accused the SKM president and other officebearers of not only disrespecting the Constitution of India with such a claim but also "intentionally and knowingly" trying to "misrepresent, mislead and misguide" the voters of Sikkim in clear violation of the Model Code of Conduct.

The letter, which includes copies of the SKM press release in

"Such a claim as made by him and his party is nothing but done with mala-fide intention with ulterior motive," the letter states while contending that Mr Tamang and other SKM leaders were aware of the facts all along and still misled the people.

The letter also contends that not just Mr Tamang, but even those who signed the press release in question, are guilty of making misleading claims intentionally and hence in violation of model code of conduct norms. The release was also signed by three SKM assembly election candidates.



After ASAT test, concern

After the successful anti-satellite missile test by India, concerns are being raised from some quarters, including the United States and the UN Institute for Disarmament Research (UNIDIR), over creation of space debris.

The United States on Thursday said it will continue to pursue its shared interests with India in space and technical cooperation, but expressed concern over the issue of space debris.

"The issue of space debris is an important concern for the US government. We took note of Indian government statements that the test was designed to address space debris issues," State Department spokesperson said.

After the missile test on Wednesday, the Ministry of External Affairs (MEA) here had sought to assuage such concerns stating that the test was done in the lower atmosphere to ensure there is

Incidentally, the United States was the first country to test ASAT.

In September 1959, a High Virgo missile was launched by the US from B-58 aircraft targeting an Explorer satellite. However, it was unsuccessful, according to a paper presented by Anatoly Zak at the UNIDIR.

A month later, a Bold Orion missile launched from a B-47 aircraft at an 11-kilometer altitude passed within four kilometers from the Explorer-6 satellite at an altitude of 251 kilometres.

Further as latest as 2008, during Operation Burnt Frost, the US destroyed its own satellite, USA-193, with an SM-3 interceptor creating 174 pieces of trackable debris, plus non-trackable shards.

In 2007, China destroyed its FengYun 1C weather satellite with an SC-19 missile, leaving behind space debris consisting of 3,280 pieces of turn to pg02

There are 17 women candidates, including one Lok Sabha candidate, participating in the upcoming elections. The second highest number of 15 women candidates was back in the 2009 elections. In 2014, 1985 and 1979 there were 11 women candidates.

#### General Observer assess election preparedness in North Sikkim



MANGAN, 28 MAR (IPR): General Observer for North District General Election 2019, Dr Pratibha Singh, assessed election preparedness of the various Polling Stations

trackable debris, as well as up to 32,000 pieces that are non-trackable.

The UNIDIR too raised concern over the space debris.

"Testing anti-satellite weapons in space can create damaging debris. Guidelines on testing these systems can prevent collateral damage and the escalation of tensions in outer space," the UNIDIR tweeted with a video on the subject.

Matthias Maurer, a European Space Agency (ESA) astronaut, said shooting down a satellite and voluntarily creating space debris is not a sign of being a re sponsible space power.

"Shooting down a satellite to prove you're a space power only shows that you're not. No responsible space power contributes to creating voluntarily space debris! Space belongs to all mankind. Let's use it for peaceful purposes and for the benefit of the people. @ esa @dlr," Maurer tweeted.

On Wednesday, Daniel Porras, Space Security Fellow, UNIDIR, said conducting the tests at an altitude of 300 km does not augur well for satellites in the Low Earth Orbit.

"It was not a good sign for LEO (low earth orbit)... which has telecommunication and earth observation satellites and also the International Space Station," which cruises at a height of 400 km, he said.

"The test was done at 300 km, so pretty low, meaning most of the debris will slowly come down. However, lots of objects near that altitude.... Not a good sign for all those LEO constellations. Also, if any debris damages other objects, India will be liable under the Liability Convention (if attribution is established)," Porras had tweeted.

The MEA, in Frequently Asked Questions (FAQs) released on Wednesday, said "whatever debris that is generated will decay and fall back onto the earth within weeks".

in the 2009 election with 82.77% turnout against the 81.46% male voter turnout.

In the 2014 elections, there were five constituencies which had more women voters in the rolls than men, namely Upper Tadong, Namchi-Singithang and all three constituencies of North Sikkim.

Incidentally, North Sikkim has never had a woman MLA and has seen only three woman candidates in the eight elections held in the State since 1979. This year's SKM candidate for Dzongu, Chung Kipu Lepcha will become the fourth woman ever to contest elections in the district. If successful she will script history by becoming the first woman MLA from a district where female voters outnumber the males.

The first woman candidate to contest elections in North Sikkim was Phutik Bhutia [Sikkim Prajatantra Congress] in 1979 from Lachen-Mangan.

And one is still only talking representation here; real issues of gender equality remain largely unaddressed with issues of independent identities and inheritance receiving only lip-service.

#### **Training** on Farm **Technologies** in West Sikkim **SUMMIT REPORT** GANGTOK, 28 MAR:

Mevedir, Service Provider Agency organized a ward level training on off farm and on farm technologies on 28 Mar, 2019. The training program was conducted at Upper Lungzik ward under Sardung Lungzik GPU and Anden ward under Upper Thambong GPU, West Sikkim, a press release informs.

The key participants of Upper Lungzik were Til Bdr Subba (Field Assistant) along with Mevedir Master Trainer, Sabita Rai and Kumar Gurung whereas in Anden ward, the key participants were Dawa Lhamu Sherpa (Ward Panchayat) along with Mevedir Master Trainer, Mangal Moti Limboo and Chuten Sherpa.

In Upper Lungzik, Rai (Mevedir Sabita Staff) demonstrated about the preparation and usage of Amrit jal by using local materials like cow dung, cow urine, jaggery (Gur), water and soil from the farmer's field. She informed that this preparation could be ready within a period of 4 to 5 days and to be utilized within a week. This highly nutrient rich liquid fertilizer would greatly enhance the fertility of the soil and provides good yield results for crops. The farmers were also informed the dosage of this liquid manure.

Similarly at Anden ward, the demonstration program on the use of Madhyam was conducted by the master trainers of Mevedir, Mangal Moti Limboo.

In both the training, farmers were informed that the preparation and usage of this on farm and off farm inputs needs to be recorded in the ICS documents like the farmers diary. Before concluding, the farmers of both areas were also informed about the Organic Input Store at Jorethang & Gyalshing where vegetable seeds, flower seeds and certified farm inputs are available.

More than 50 farmers participated in this ward level training program. The training program on both sides concluded successfully.



### **Isolationist Tendencies**

Conversations could resolve what whispers tend to instigate

It is embarrassing how easily Sikkimese **I** people allow themselves to be taken for a ride. Apolitical organizations with blatantly political ambitions and inclinations are allowed to create issues, raise furore, fan paranoia, sometimes even sell impossible hopes and then revel in the confusion. But more than the people's susceptibility to a con game, it is their willingness to get communalised that is embarrassing. After all, how effectively can a population of barely 6 lakh be divided? Into how many sub-groups? Over how many issues? And how often?

It is pointless to deny that divisions exist within the Sikkimese society. Given that each of us belongs to some community or the other, it is an accepted fact that we are inherently communal. But, because we are also social animals living in more cosmopolitan times, this inherent communal streak seldom develops into paranoia or gets directed against other communities. This social grooming, however, collapses when the leader of the pack smells blood the possibility of making an issue emotive and convincing enough for people to feel threatened and gather ranks. Few things move off the counter faster than a fabricated conspiracy theory. The more preposterous the fabrication, the more looming is the threat perception.

In these times of flux, there is definitely need for everyone to feel insecure, but to feel threatened enough to take leave of logic is as embarrassing as the belief that Indian culture is threatened by foreign television channels - a threat being waved often, but also preposterous to boot, or the fiction that "romeos" or beef-eaters pose a bigger threat than jingoistic imposition of nationalism. Sikkim's problems hark from its refusal to stop whispering and start talking. Since perceptions of a threat are interpreted from social signals, it would bode well for everyone if they genuinely started believing that they live in a democracy and that dialogue is possible in this system. Sikkim's communities continue to opt for the more anonymous route of pamphlets (and nowadays also social-media circles), kitchen gatherings and insular meetings to discuss their problems while presenting a mask of amity for public consumption. The mask has been ripped off many a times, but the people tend to shut their eyes when the real face is unveiled only to wake up to a new mask and new arguments later. The routine has been played out again and again and will be tried in the future too. 44 years of exposure to this charade since it adopted democracy and the centuries for which the same routine was played out under a monarchy do not seem to have wizened the people.

# China's 'Silk Road urbanism' is changing cities from London to Kampala – can locals keep control?

massive redevelopment of the old Royal Al-Abert Dock in East London is transforming the derelict waterfront to a gleaming business district. The project, which started in June 2017, will create 325,000 square metres of prime office space a "city within a city", as it has been dubbed - for Asian finance and tech firms. Then, in 2018, authorities in Kampala, Uganda celebrated as a ferry on Lake Victoria was unloaded with goods from the Indian Ocean, onto a rail service into the city. This transport hub was the final part of the Central Corridor project, aimed at connecting landlocked Uganda to Dar es Salaam and the Indian Ocean.

Both of these huge projects are part of the US\$1 trillion global infrastructure investment that is China's Belt and Road Initiative (BRI). China's ambition to reshape the world economy has sparked massive infrastructure projects spanning all the way from Western Europe to East Africa, and beyond. The nation is engaging in what we, in our research, call "Silk Road urbanism" - reimagining the historic transcontinental trade route as a global project, to bring the cities of South Asia, East Africa, Europe and South America into the orbit of the Chinese economy.

By forging infrastructure within and between key cities, China is changing the everyday lives of millions across the world. The initiative has kicked off a new development race between the US and China, to connect the planet by financing largescale infrastructure projects.

#### **SILK ROAD URBANISM**

Amid this geopolitical competition, Silk Road urbanism will exert significant influence over how cities develop into the 21st century. As the transcontinental trade established by the ancient Silk Road once led to the rise of cities such as Herat (in modern-day Afghanistan) and Samarkand (Uzbekistan), so the BRI will bring new investment, technology, infrastructure and trade relations to certain cities around the globe.

The BRI is still in its early stages – and much remains to be understood about the impact it will have on the urban landscape. What is known, however, is that the project will transform the world system of cities on a scale not witnessed since the end of the Cold War.

Silk Road urbanism is highly selective in its deployment across urban space. It prioritises the far over the near and is orientated toward global trade and the connections and circulations of finance, materials, goods and knowledge. Because of this, the BRI should not only be considered in terms of its investment in infrastructure.

It will also have significance for city dwellers - and urban authorities must recognise the challenges of the BRI and navigate the need to secure investment for infrastructure while ensuring that citizens maintain their right to the city, and their power to shape their own future.

#### **LONDON CALLING**

Developments in both London and Kampala highlight these challenges. In London, Chinese developer Advanced Business Park is rebuilding Royal Albert Dock - now named the Asian Business Port – on a site it acquired for £1 billion in 2013 in a much-criticised deal by former London mayor Boris Johnson. The development is projected to be worth £6 billion to the city's economy by completion.

But the development stands in sharp contrast with the surrounding East London communities, which still suffer poverty and deprivation. The challenge will be for authorities and developers to establish trusting relations through open dialogue with locals, in a context where large urban redevelopments such as the 2012 Olympic Park have historically brought few benefits.

The creation of a third financial district, along-

side Canary Wharf and the City of London, may benefit the economy. But it remains to be seen if this project will provide opportunities for, and investment in, the surrounding neighbourhoods.

#### KAMPALA'S CORRIDOR

The Ugandan capital Kampala is part of the Central Corridor project to improve transport and infrastructure links across five countries including Burundi, the Democratic Republic of the Congo (DRC), Rwanda, Tanzania and Uganda. The project is financed through the government of Tanzania via a US\$7.6 billion loan from the Chinese bank Exim.

The growth of the new transport and cargo hub at Port Bell, on the outskirts of Kampala, with standardised technologies and facilities for international trade, is the crucial underlying component for Uganda's Vision2040.

This national plan alone encompasses a further ten new cities, four international airports, national high speed rail and a multi-lane road network. But as these urban transformations unfold, residents already living precariously in Kampala have faced further uncertainty over their livelihoods, shelter and place in the city.

During fieldwork for our ongoing research into Silk Road urbanism in 2017, we witnessed the demolition of hundreds of informal homes and businesses in the popular Namuwongo district, as a zone was cleared 30 metres either side of a rehabilitated railway track for the Central Corridor required.

As Silk Road urbanism proceeds to reshape global infrastructure and city spaces, existing populations will experience displacement in ways that are likely to reinforce existing inequalities. It is vital people are given democratic involvement in shaping the outcomes.

# Why fear and anger are rational responses to climate change

N ot everyone cheered for the school children striking against climate change. In the US, democratic senator Dianne Feinstein accused them of "my way or the highway" thinking. German Liberal Democrats leader Christian Lindner said that the protesters don't yet understand "what's technically and economically possible", and should leave that to experts instead. The UK's prime minister, Theresa May, criticised the strikers for "wasting

These criticisms share a common accusation - that the striking children, while well-intentioned, are behaving counter-productively. Instead of having a rational response towards climate change, they let emotions like fear and anger cloud their judgement. In short, emotional responses to climate change are irrational and need to be tamed with reason.

The view that emotions are intrusive and obscure rational thinking dates back to Aristotle and the Stoics - ancient Greek philosophers who believed that emotions stand in the way of finding happiness through virtue. Immanuel Kant - an 18th-century German philosopher - saw acting from emotions as not really agency at all.

Today, much of political debate is moderated with the understanding that emotions must be tamed for the sake of rational discourse. While this view stands in a long tradition of the inaction of governments, would

Peterson and Ben Shapiro to insist that "facts, reason and logic" can dismiss an emotional response to anything in debates.

However, the view that emotions aren't part of rationality is false. There's no clear way of separating emotions from rationality, and emotions can be rationally assessed just like beliefs and motivations.

#### **EMOTIONS CAN BE RATIONAL**

Imagine you're walking in the woods, and a huge bear approaches you. Would it be rational for you to feel fear?

Emotions can be rational in the sense of being an appropriate response to a situation. It can be the correct kind of response to your environment to feel an emotion, an emotion might just fit a situation. Fear from a bear coming towards you is a rational response in this sense: you recognise the bear and the potential danger it represents to you, and you react with an appropriate emotional response. It could be said to be irrational not to feel fear as the bear walks towards you, as this wouldn't be a correct emotional response to a dangerous situation.

Imagine you find out that a meteor will kill millions of people across the world, displace hundreds of millions more, and make life for the remainder of humanity much worse. The world's governments neither put a defence system in place, nor do they evacuate the people threatened. Fear from the meteor, and anger at

Western philosophy, it invites Jordan be a rational response as they are an appropriate reaction to danger. And if you don't feel fear and anger, you're not appropriately responding to a

dangerous situation. As you've probably guessed, the meteor is climate change. The world's governments aren't addressing the causes of climate change or preparing to mitigate its impact. For the people of Mozambique, who are reeling from the devastation of Cyclone Idai, anger is entirely appropriate. Climate change is largely a product of economic development in richer countries, while the world's poorest are bearing the brunt of its effects.

#### ARE EMOTIONS COUNTER PRO-**DUCTIVE?**

Regardless of how fitting an emotional response is, it may sometimes be unhelpful for what a person wants to achieve. Theresa May makes this point about the school strike: understandable, but young people missing valuable lessons makes it harder for them to solve climate change. As others have already pointed out, climate change demands rapid action - waiting until some vague point in the future when the children are old enough to do something is relinquishing responsibility instead of meaningful action.

It is, however, hard to deny that fear and anger sometimes lead people to choices they regret. However, dismissing emotional responses on this basis is too quick. There are many examples where fear and anger have triggered the correct response and created a motivational push for

change. As Amia Srinivasan, an Oxford philosopher working on the role

of anger in politics, puts it, "Anger can be a motivating force for organisation and resistance; the fear of collective wrath, in both democratic and authoritarian societies, can also motivate those in power to change their ways."

A lot of social change has happened because of anger against injustice, empowering the weak and oppressed, while causing those in power to fear they may be ousted leads to reforms and change. We do need scientific understanding of the climate crisis to solve it, but banning emotions from the debate and dismissing rational fear and anger about climate change may encourage people to do nothing.

So, not only are children, who are angry and scared about climate change, rational, they might be more so than the adults criticising them. Emotions play a bigger part in life beyond rationality - they mark values and indicate what people care about. Fear of the future and anger at inaction are ways young people can express their values. Their emotions are, in the words of feminist writer Audra Lorde, an invitation to the rest of society to speak.


Dismissing the emotions of school children not only invalidates their rational responses to a grave situation - it implicitly states that their values aren't taken seriously, and that adults don't want to reach out to them.

We have to frame a policy to resolve the demands. Please give me time," Banerjee had told the agitating aspiring teachers.

She had said she would ask the education minister to look into their demands after the elections.

The seven-phase Lok Sabha polls in the state will begin on April 11 and results will be announced on May 23.

Around 200 aspiring school teachers were on relay hunger strike and dharna from February 28 demanding recruitment to vacant posts in staterun institutes.

**Education** Minister Partha Chatterjee last Friday met representatives of the aspiring teachers and formed a five-member committee to look into their demands.

The agitators were on dharna and relay fast since February 28 under the banner of the SSC Yuva-Chhatra Adhikar Manch.

The CPI(M) and the Akhil Bharatiya Vidyarthi Parishad (ABVP), the students' wing of the RSS, have backed their demands.

Faruk, an MBA student at Dhaka University, was declared dead after he was rushed to the Dhaka Medical College Hospital," the paper reported.

Another person, who was yet to be identified by the authorities, was declared dead at Kurmitola General Hospital after he fell off the building while trying to escape the fire. "Similarly, three more male victims were declared dead on arrival by the doctors of United Hospital," officials were quoted as saying.

The people who lost their lives were among half a dozen people who jumped off from various floors of the high-rise grave injuries, senior officials said. Apart from 21 fire tenders, Bangladesh Air Force helicopters and Navy commandos have been sent to the spot to douse the blaze.

While the actual reason behind the blaze was not known, eye witnesses and a government officer at the spot said that the fire broke out on the eight floor of the building and later spread to the other floors.

However, fire service did not comment on what caused the fire.

They, however, said that around 35 people have been rescued from the building while the operation to save othof Bangladesh Navy are working to tame the blaze. We have brought around 50 per cent of the fire under control," Siraj, a Navy officer, said.

Inter-Services Public Relations (ISPR) Director, Abdullah Ibn Zaid, said that three Bangladesh Air Force helicopters are aiding the search and rescue operations, along with teams from the Bangladesh Army and Navy.

Last month at least 70 people were killed and over 50 injured when a fast-moving fire swept through an apartment buildings and chemical warehouses in Dhaka's congested Chawkbazar area.

# Tripura second in country in child marriage, says report

AGARTALA, MAR 28 (PTI): Tripura occupies the second position in India in terms of child marriages among girls between 15-19 years of age, an international study has found.

Over 80 percent of total child marriages in the areas of three districts, said the report.

"Tripura occupies the second position with respect to highest prevalence of child marriage among girls aged 15-19 years at 21.6 per cent which is significantly higher than the national average of 11.9 per cent," said Young Lives - an international study on childhood poverty, quoting data from the National Family Health Survey

(NFHS). The study is a collaborative research project coordinated by a team based at the University of Oxford. Young Lives India Co-

ordinator Suntala Khan said the study found four districts of Tripura in the state take place in rural list of top 100 districts of of children born to teenthe country which have age mothers reveals that the highest prevalence of child marriages.

Khan addressed a workshop on "Development of multi-spectral action plan to child marriage and teenage pregnancy in Tripura" here.

The Young Lives report, prepared on NFHS-4 (2015-16) data, said Dhalai district had 24.7 per cent prevalence of child marriages, which was the highest in the state. Other affected districts are South Tripura, North Tripura and West Tripura. The report also said 52 per cent of the surveyed girls were found to have conceived pregnancy at least once.

"Analysis of number 52 per cent of married teenage girls have given birth to one child, 5.5 per cent had 2 children and one per cent had more than 2 children by the tender age of 19," the report said.

Tripura Commission for Protection of Child Rights chairperson Nilima Ghosh said child marriage rate is increasing at an alarming rate in the state.

#### Want to hold on to my form: Rana KOLKATA, MAR (PTI): Consecutive fifties in different batting positions ought to be a confidence-builder but Kolkata Knight Riders batsman Nitish Rana says he is occupied by the concern of maintaining his form that usually "fiz-

zles" out early in the IPL. As a makeshift opener in the absence of Sunil Narine, Rana struck a fine 68 in KKR's first match against Sunrisers Hyderabad on Sunday.

Back at No.4 in their second match, Rana scored a 34-ball 63 against Kings XI Punjab on Wednesday to overtake Delhi Capitals' Rishabh Pant (103 runs in two matches) in the early Orange Cap race.

"I haven't thought too far ahead. But for the last couple of seasons, I start well but my form fizzles out towards the later half of the tournament," Rana said after KKR's 28-run win here on Wednesday night.

"So this time around, I want to work on this. I want to continue the kind of form I have started in till the end of the tournament."

Rana did not have a good season with Delhi in the domestic circuit, managing just 147 runs form 10 matches in the Syed Mushtaq Ali T20 and 191 runs from six matches in the Ranji Trophy.

Disturbed by his poor form, the top order KKR batsman spent some time at the Mumbai-based KKR Academy speaking to Abhishek Nayar and Dinesh Karthik.

"I did not work on batting as such but I worked on the mental toughness. KKR academv was quite helpful in that sense because I got one-on-one time with Abhishek bhaiya and DK bhaiya. They helped me clear self doubts. Now, I feel, I've

become a better player. Having impressed at different batting positions, Rana said, "That's the sign of a good team. My plan was clear -- to hit a loose ball and then, let DK (Dinesh Karthik) or (Andre) Russell take over for the last four-five overs." Four of his seven sixes came against India's top off-spinner Ravichandran Ashwin but Rana said the attack was not pre-planned.

"I was just trying to build my innings. I was taking it ball by ball at the start and then when I thought I could charge, I did that. "It doesn't matter for me who the bowler is. My game plan was simple. I thought that was the time to attack and I did. That was the plan for the two overs -- of Ashiwn and South African pacer (Hardus Viljoen)."

Rana also hailed Andre Russell's 17-ball 48 and said the lifeline, when the Jamaican survived owing to a no ball, gave them 20-25 runs extra. "Having 218/4 definitely worked in our favour, how Russell got a lifeline and that probably gave us those 20-25 runs extra.

"But even if we had 180 or 200, we would have fought this hard. It wasn't very easy (to chase) because the ball started seaming in the second innings.

# Hesson regrets lack of alertness that saved 'game-changer' Russell

KOLKATA, MAR 28 (PTI): Kings XI Punjab coach Mike Hesson said "game-changer" Andre Russell completely snatched the match away from his team in the IPL clash against Kolkata Knight Riders and rued the no ball that let off the swashbuckler before he went on a rampage. Russell was on three off five balls when he was bowled by Mohammed Shami with an inch-perfect yorker on off-stump but it was declared a no ball because the side had three fielders, instead of the mandatory four, inside the circle in the 17th over.

Russell then smashed eight boundaries in a row to add 44 runs in the next 12 balls to push KKR to a record 218/4 at the Eden Gardens. "It's a fine line when you're bowling to Andre Russell. He's a gamechanger," Hesson said as Russell returned with a second man-of-the-match award in KKR's 28-run win.

Russell was the star with a 19ball unbeaten 49 in KKR's six-wicket win over Sunrisers Hyderabad in their opening match here on March 24. "The game changed in the 17th over. Obviously we had a plan for Russell that we executed well, but we weren't quite alert enough in the field, and that's where the game changed." "We had that little bit of jubilation and then things turned pretty quickly (with the no ball) and we weren't quite able to turn the last few overs for 12 or 14 runs. Instead we ended up giving giving away 22 or 24 runs, and it probably changed the game."

Their 14-run win over Rajasthan Royals was overshadowed by R Ashwin's controversial 'Mankading' of Jos Buttler but Hesson said the incident did not affect the skipper. "We were very focused in terms of preparing for KKR. So that's very much been our focus."

Skipper Ashwin's decision to bring on their Rs 8.4 crore buy Varun Chakravarthy to bowl the second over backfired spectacularly. Sunil Narine hammered the uncapped mystery spinner for three sixes and a four in a 25-run over.

Defending the ploy, Hesson said: "It wasn't so much Narine. Lynn was on strike at the start of that second over. That was the match-up we were looking for. And then Narine came on strike and you know he was able to take a toll." Hesson also backed Chakravarthy and said he was nervous

like anyone else playing their first game. "The way he came back in the second and third over was excellent. And it will give him and us a lot of confidence. You know, playing your first game in front of a crowd like this is difficult.

"Narine's obviously going to hit you from ball one. I think he will learn to settle down a bit quicker. But I'm still very pleased the way how he came back." Chasing 219 in an away game was always difficult as they banked heavily on their opening combination of KL Rahul and Chris Gayle.

But the duo failed, both departing for 37 inside five overs as Kings XI Punjab were restricted to 190/4 in the designated 20 overs.

"The first two games, we haven't got a huge amount of runs from the top, but we've got runs from the top six. Mayank Agarwal, Sarfaraz (Khan) got runs in the last game. Gayle, Mandeep has played a couple of cameos and obviously, David Miller's come in and played a role. Asked if they were top heavy in batting, he said: "I think that statement could be true for Kings XI teams of the past, I don't think it's true now. I think we've got power and ability right through the top six and even deeper."

NEW DELHI, MAR 28 (PTI): New Zealand pacer Trent Boult Thursday said his countrymen are still coming to terms with the terror attack on two Christchurch mosques that killed 50 people.

The attack took place on March 15 and New Zealand's Test match against Bangladesh starting the very next day was called off.

"It was an emotional week for all of us in New Zealand. It was tragic and people are still coming to terms with the terror attack. It will take some time," Boult said on the sidelines of a promotional event to announce his IPL team Delhi Capitals' association with American loudspeaker manufac-

On the controversy that followed Ravichandran Ashwin's 'Mankading' of Jos Buttler in an IPL match, Boult chose to steer clear of the matter.

"It's there in the rules and that's what matters. It's interesting though," he said.

Boult will be an integral part of the New Zealand attack in the World Cup, starting May 30 in England, but he is not overtly bothered

about workload management given the hectic IPL schedule.

"Right now, my focus is to do well for Delhi in the IPL. I am not thinking too much about workload and focussing on the present. The team (Capitals) is in good shape and happy space," the Black Caps pacer said.

However, Boult's South African teammate Kagiso Rabada admitted that World Cup is there at the back of his mind.

"But I have decided to take one match at a time. I haven't had any discussions with the (Delhi Capitals) team management but if I feel stiffness or soreness, I will definitely take precautions. It will be an individual call," Rabada said.

# Israelis unveil 'world's longest salt cave'

MOUNT SODOM, MAR 28 (AFP): Israeli cave explorers said Thursday that a salt cave with striking stalactites near the Dead Sea is the world's longest, beating the previous record-holder in Iran.

The cave named Malham, stretching over 10 kilometres, runs through Mount Sodom, Israel's largest mountain, and spills out to the southwest corner of the adjacent Dead Sea. Pale salt stalactites hang from the ceilings, and some of the walls sparkle with salt crystals. Drops of salty water are visible at the tips of some of the stalactites. Malham became known to researchers through the work of Amos Frumkin, founder and director of the Hebrew University's Cave Research Centre, who in the 1980s mapped around five kilometres of it.

But in 2006, researchers mapped over six kilometres of the N3 cave in southern Iran's Qeshm island, granting it the widely recognised status of the world's longest salt cave. Two years ago, Israeli spelunker Yoav Negev decided to complete Frumkin's work, reaching out to Bulgarian cave explorers for reinforcements with the promise of a warm winter adventure.

Negev, founder of the Israel Cave Explorers Club, joined forces with Boaz Langford, a researcher at the university's research centre, to organise a delegation of eight European spelunkers and another 20 locals.

They spent some 10 days mapping the cave in 2018. A second 10-day expedition this year with 80 local and interna-



tional spelunkers completed the measuring and mapping of the cave with lasers, determining its length at more than 10 kilometres. Mount Sodom is essentially a huge salt block covered by a thin but resilient layer of cap rock.

The rare desert rains find their way through cracks in the cap rock and dissolve the salt to form small caves that flow down toward the Dead Sea.

Even in the short period of time since Frumkin's mapping, the cave's structure has changed, and will continue to do so. Much of the cave's interior is covered by a fine dust that blows in from the desert. Massive slabs of salt, some amber-coloured from dust

and minerals, jut out in dramatic formations. A thin slab appearing to have been sliced out is nicknamed "The Guillotine," while twin slabs in a different hall earned the title of "The Ten Commandments."

Reporters touring the site clambered and crawled through the narrow passages before reaching the "wedding hall," where hundreds of white stalactites of various shapes and lengths created a festive backdrop. To Negev, Malham was in "a category of its own." "There's nothing like it in Israel," he said, claiming that no other cave came even close to the 10-kilometre mark.

Negev pointed to its vast network of "caverns, passageways, piers, plateaus, one over another". He called it "the most impressive and complex in Israel... and one of the most beautiful and fascinating ones I've been in". Negev downplayed the significance of retaking the title from Iran -- Israel's main enemy -- saying he had "excellent ties" with Iranian spelunkers through social media and professional conferences. "The political rivalry creates a desire to connect and mutual curiosity," he said. "They're really



While there is no set timescale for the judge to pronounce a decision on whether Mallya will be granted an appeal in the UK High Court, a decision is likely within the next few weeks. The 62-yearold former Kingfisher Airlines boss, wanted in India on alleged fraud and money laundering charges amounting to about Rs 9.000 crore, took to social media yet again to claim unfair treatment in the context of struggling Indian airlines Jet Airways being thrown a lifeline by public sector banks.

In her ruling at the end of his extradition trial in December last year, Chief Magistrate Emma Arbuthnot had concluded that Mallya has a case to answer in the Indian courts over substantial "misrepresentations" of his financial dealings.

#### China protecting violent Islamic terror groups from **UN sanctions: Mike Pompeo**



WASHINGTON, 28 (PTI): US Secretary of State Mike Pompeo Wednesday chided China's "shameful hypocrisy" over its treatment of Muslims in the Communist nation while protecting violent Islamic terrorist groups from sanctions by the United Nations.

Pompeo was apparently referring to China blocking a proposal to designate Pakistan-based Jaish-e-Mohammed's chief Masood Azhar as a 'global terrorist' at the UN Security Council earlier this month.

"The world cannot afford China's shameful hypocrisy toward Muslims. On one hand, China abuses more than a million Muslims at home, but on the other it protects violent Islamic terrorist groups from sanctions at the UN," Pompeo said in a tweet, without mentioning the JeM or the outfit's chief. France, along with Britain and France had moved a proposal in the 1267 Al Qaeda Sanctions Committee of the Security Council this month to designate Azhar a "global terrorist" following the February 14 Pulwama attack, but China, another veto wielding permanent member, blocked it.

China put a hold on the resolution arguing that it needs more time to study it. Every member of the UN Security Council, except China, had supported the proposal. The JeM had claimed responsibility for the Pulwama attack in which 40 CRPF personnel were killed.

Pompeo's criticism of China came on a day when it emerged that the US, supported by France and the UK, has directly moved a draft resolution in the UN Security Council to blacklist Azhar.

Pompeo made the

statement soon after he met a former prisoner and relatives who recounted abuses as part of Beijing's widespread detention of its Uighur minority in resource-rich Xinjiang. China, Pompeo alleged, has detained more than one million Uighurs, ethnic Kazakhs, and other Muslim minorities in internment camps in Xinjiang since April 2017.

"The US stands with them and their family members. China must release all those arbitrarily detained and end its repression," he said.

Wednesday, Pompeo met with survivors and family members of China's "campaign of repression and mass detention" against the minority groups in Xinjiang.

"I call on China to end these counterproductive policies and release all arbitrarily detained," he said.




