### COVID-19 caseload in India rises to 96.44 lakh

**NEW DELHI, DEC 6 (PTI):** national recovery rate to India's COVID-19 caseload rose to 96.44 lakh. while the total number of people who have recuperated from the disease crossed 91 lakh pushing the national recovery rate to 94.37 per cent, according to the Union Health Ministry data updated on Sunday.

The COVID-19 active caseload plunged to almost 4 lakh after 138 days

The total coronavirus cases mounted to 96,44,222 with 36,011 new infections being reported in a day, while the death toll crossed to 1.40 lakh with 482 new fatalities, the data updated at 8 am showed.

The number of people who have recuperated from the disease surged to 91,00,792 pushing the 94.37 per cent, while the COVID-19 case fatality rate stands at 1.45 per

There are 4,03,248 active coronavirus infections in the country which comprises 4.18 per cent of the total caseload, the data stated. COVID-19

India's tally had crossed the 20 lakh mark on August 7, 30 lakh on August 23 and 40 lakh on September 5. It went past 50 lakh on September 16, 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, and surpassed 90 lakh on November 20.

According to the ICMR, 14,69,86,575 samples have been tested up to December 5 with 11,01,063 samples being tested on Saturday.

#### **Petrol price up 28 paise, diesel 29** paise a litre; rates touch 2-yr high

NEW DELHI, DEC 6 (PTI): Petrol price on Sunday was hiked by 28 paise per litre and diesel by 29 paise, the fifth straight day of increase in rates due to firming international oil prices. Petrol price in Delhi rose to Rs 83.41 per litre from Rs 83.13. Diesel rates went up from Rs 73.32 to Rs 73.61 per litre, according to a price notification of oil marketing companies.

Rates crossed Rs 90mark for petrol and Rs 80 in case of diesel in Mumbai.

This is the fifth straight day of price hike and the 14th increase in rates since November 20 when oil companies resumed daily price revision after

nearly two-month hiatus. Rates are now at the highest level since September 2018. In 17 days, the petrol price has gone up by Rs 2.35 per litre and diesel rate has risen by Rs 3.15.

Brent crude oil has risen 34 per cent from USD 36.9 per barrel on October 30 to USD 49.5 on December 4 - the last trading day - on hopes that COVID-19 vaccines would lead to demand recovery.

Prior to the November 20 hike in rates in India, petrol prices had been static since September 22 and diesel rates hadn't changed since October 2.

Public sector oil market ing companies - Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL) - revise rates of petrol and diesel daily based on benchmark international oil price and foreign exchange rate.

# 27 new cases take Sikkim's **COVID** tally to 5,194

**SUMMIT REPORT** GANGTOK, 06 DEC:

Tikkim's tally of the **S**confirmed COVID-19 cases reached 5.194 with the detection of 27 new cases on Sunday. No new deaths were reported today.

Of the 27 new cases, 21 are from East District and six from South Sik-

On the other hand, the number of discharged COVID-19 patients further improved to 4,602. There are now 384 active cases of novel coronavirus in Sikkim, of whom four are admitted in the ICU facility of COVID-dedicated STNM

Hospital. In the daily health bulletin on Sunday, Health Department State IEC Officer, Sonam Gyaltsen Bhutia, informed that the 27 new cases were reported from the testing of 206 samples on Saturday.

While 20 of the cases were reported in RT-PCR testing of 166 samples, one person was found positive in TrueNat testing of 10 samples and six cases confirmed in rapid antigen testing of 30 samples

Among the new cases reported from in and around Gangtok, are one person from Upper Chandmari, three from Manbir Colony, four from Development Area, one from near Tamang Gumpa in Upper Sichey and two from DPH Area, while new cases reported from Tadong area include one person from the PG Hostel above Central Referral Hospital, one from Gairi Gaon, one from near the Sikkim Milk Union quarters in Lumsey and one from near Greendale School.

Likewise, one person from Namcheybong, one from near 8th Mile near SBB camp Marchak, one from Tambutar, Ranipool and one from Rumtek in East District have also tested positive.

New cases reported from South District include one person from the IRB camp at Pipaley, one from near Bikmat Secondary School, two from Boomtar, Namchi, one from near Lal Bazaar in Rabongla and two students who had gone to attend an NCC camp at Kamrang and were tested in keeping with the COVID- protocol of the

Mr Bhutia informed that one person from the West Bengal side of Rangpo also tested positive in TrueNat and the concerned authorities on the other side have also been informed.

# Welcome to 'Love Jihad' law times: Hindu woman heckled, Muslim husband arrested in UP

Moradabad, 06 Dec [NDTV]: A Muslim man and his brother have been arrested by the police in western Uttar Pradesh's Moradabad after he and a 22-year-old Hindu woman tried to get their marriage registered in the district's Kanth area.

The men were handed over to the police after a group of people from a right-wing group, the Bajrang Dal, accosted the trio at the marriage registration office and stopped them from going ahead with formalities, and then took all three to the local police station.

In a 1 minute and 11-second video that has gone viral on social media, the men surround the woman inside the premises of the Kanth police station in Moradabad.

"Show us the permission you have

from the DM (District Magistrate) to convert your religion," one of the men tells the woman, as at least two policemen, one of them with a lathi look on.

"Have you read the new law or not?" another man says, adding "Ye tum jaise logon ke liye banana pada hai (the law had to be made for people like you)".

The woman, however, told journalists she and the man were married with consent. "I am an adult, I am 22 years old. I got married of my own free will on the 24th of July. This is the fifth month that we have been married," the woman told journalists.

The police said the complaint in the case was filed by the mother of the Hindu woman who claimed the Muslim man had tricked her daughter into marriage and conversion. "We have arrested both men and will investigate the case thoroughly," Vidya Sagar, a senior police official said in a statement.

It is not clear if the man or the woman had converted or were planning to do so. The arrested men have been booked under Section 3 of the Uttar Pradesh Prohibition of Unlawful Conversion of Religion Ordinance 2020, that deals with forced conversion. Both face between 1-5 years in prison if the charges against them hold in a court.

This case is the fifth to be filed in UP since the anti-conversion ordinance became law a week ago in the state amid heightened sensitivity about "Love Jihad", the right-wing conspiracy theory that Muslim men try to seduce Hindu women to have them convert their religion.

The term "love jihad is not defined by law", the Union Home Ministry had told parliament in February, adding that no such case had been reported by the central agencies. However, since last month, several BJP-ruled states have moved towards making a law against it.

Uttar Pradesh, which has a chunk of Muslim population, has been first off the block with an ordinance or executive order, which says religious conversions that use falsehood, force or an incentive, or take place solely for marriage will be declared a crime.

Those who plan to convert after marriage will have to give two months' notice to the district magistrate. The person converting will have to prove that it was not forced or for marriage. All cases will be non-bailable.

#### Haryana: 2 more IJP MLAs come out in support of farmers

CHANDIGARH, DEC 6 (PTI): Two more MLAs from the JJP, an alliance partner of the ruling BJP in Haryana, on Sunday came out in support of the farmers seeking the repeal of the Centre's new agri laws.

Jannayak Janta Party MLA Ram Kumar Gautam also demanded that a special assembly session be convened to bring a resolution urging the Centre to scrap the three

Separately, JJP legislator Amarjeet Dhanda too came out in support of the farmers, saying he backs their agitation.

We hope the government will agree to their demands. I appeal to the Centre that they should listen to what the farmers are demanding and resolve the issue, Dhanda, an MLA from Julana constituency, said.

Earlier, two other JJP MLAs -- Jogi Ram Sihag and Ram Karan Kala -- had announced their support to the farmers and participated in an agitation in Haryana, going against their party's stand on the issue.

Sihag had also refused to accept his appointment by the state government as chief of the Haryana Housing Board.

In the 90-member Haryana Assembly, the BJP has 40 MLAs, JJP has 10 and the Congress has

Seventy-four-yearold Gautam said the Centre and the M L Khattar government in Haryana have said that the laws will benefit the farmers, but asked why they were being forced upon them.

Hitting out at the Narendra Modi government, Gautam asked, If the farmers don't want these laws, why are they being thrusted upon them? What is their (Centre) compulsion?

He demanded that the state government convene a special session of the state assembly and urged all the political parties of Haryana to join hands and bring a resolution urging the Centre to repeal the laws.

I want to tell the Khattar government that a special session should be summoned immediately and all parties should join hands to bring a resolution urging Modi ji (Centre) to repeal these three laws before it is too late, the legislator from Narnaund constituency in Hisar district, told reporters.

Meanwhile, another JJP MLA and senior leader Ishwar Singh said the Centre is engaged in talks with the farmers and everyone is hopeful that a solution will be found at the earliest. Singh said that he stood with the farmers and nobody was against them.

Congress legislature party leader Bhupinder Singh Hooda had on Friday said that the party will seek the convening of a special session of the assembly to bring a no-confidence motion against the BJP-led state government.

Hooda had claimed that the Khattar government had lost the confidence of both the people and the House.

#### Over 2,500 court complexes to get video conference cabins: Centre

NEW DELHI, 06 DEC [PTI]: Seeking to boost the capability of the lower judiciary to hear cases online, funds have been released to set up "video conference cabins" in 2,506 court complexes across India, Law Ministry officials said.

While funds to the tune of ₹ 5.21 crore were released in September to set up video conference cabins, another ₹ 28.886 crore were given in October to buy additional video conference equipment, including hardware, cables and monitors, the officials.

The funds were provided by the e-committee of the Supreme Court and the Department of Justice in the Law Minis-

While India has 3,288 court complexes, which house thousands of subordinate courts, the funds have been released for 2,506 court complexes to set up video conference cabins.

Bigger court complexes with a large number of courtrooms would get multiple cabins as compared to smaller complexes.

The size of a court complex, including the number of courts it houses, depends upon the size or population of the state.

As courts continue to hear cases online amid the COVID-19 pandemic, the government has procured 1,500 additional video conferencing licences at an approximate cost of rupees nine crore for providing the facility for high courts and district courts.

While the procurement has been completed, the process of installation is on, an official said.

Such licences are required for legal and extended use of the video conference facility software, the official said.

From the day the na-

tionwide lockdown was imposed to check the spread of coronavirus in till October 28, high courts and district courts across India have heard over 49.67 lakh cases virtually, according to data collated by the Law Ministry. The Centre had imposed the lockdown from March 25 to prevent the spread of the novel coronavirus. From June 8, it started gradually relaxing restrictions under "Unlock".

New Delhi, Dec 6 (PTI): A number of bank unions have expressed their solidarity with farmers protesting against recently passed agri laws and requested the government to resolve the issue at the earliest.

The All India Bank Employees' Association (AIBEA) in a statement said the government should come forward and resolve their demands in the interest of the nation and farmers.

Officer unions All India Bank Officers' Confederation (AIBOC), All India Bank Officers' Association (AIBOA) and Indian National Bank Officers' Congress (INBOC) have also requested the government to initiate meaningful dialogue to resolve the impasse by referring the bills to a select committee by a special Presidential Order.

The farming community has expressed apprehension that three new laws -- Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020, Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act, 2020 and Essential Commodities (Amendment) Act, 2020 -- would pave the way for dismantling of the minimum support price system, leaving them at the "mercy" of

in the agriculture sector that will remove the middlemen and allow farmers to sell anywhere in the country.

"Our nation needs peace and main stakeholders of the nation should not be made to suffer, as the agriculture sector alone performed positively in the COV-ID-19 pandemic, which reflects the inherent strength of the sector," three officers' unions said in a joint statement.

The peasants constitute 80 per cent of the customer base of the public sector banks, regional rural banks, cooperative banks and old generation private banks and thus are major stakeholders of India's banking system, it said.

KOLKATA, DEC 6 (PTI): Continuing his tirade against the ruling TMC, BJP state president Dilip Ghosh on Sunday said the social welfare projects launched by the state government does not provide any "real benefit" to the public.

Addressing a rally in East Midnapore, Ghosh said Chief Minister Mamata Banerjee has announced schemes with big names but they haven't catered to the needs of people.

that the state, after failing to utilise central grants of over Rs 2,000 crore for Cyclone Amphan relief, is now writing to the Union government for allocation of Rs 8,500 crore, but "no one trusts Didi (Mamata Banerjee) anymore." "None trusts Didi will use the amount judiciously.

Everyone has seen how Amphan relief money went into the account of local leaders from her party, from panchayat pradhan to other chieftains. And once the matter came to public knowledge, Didi said it was an exception, a mis-

Swasthya Sathi is a non-take. Is it really a mistake! We know that after May 2021 such mistakes won't recur anymore." Ghosh said.

Pointing out that leaders and activists of the ruling TMC are now revolting against the leadership, Ghosh said "every other day someone is deserting party, which is slowly turning into a crumbling edifice."

"The ruling party is withdrawing security of leaders who have left the TMC and slapping false cases on opponents.

This will stop after six months," he said.


Ghosh predicted that the BJP will win 200 seats in the upcoming assembly elections, and TMC wont be able to bag more than 50.

### Waste Does Not Understand

...but should we be dumb too

neaders would have noticed the occasional Surfacing of news-reports on awareness sessions being held at the GPU and ward levels around Sikkim in pursuit of zero-waste status.

This is welcome and urgently required.

It was after all not fair that lavish budgets were expended on waste management limited to the urban sprawls at the cost of 75% of the population which resides in rural Sikkim. 4.55 lakh of Sikkim's population of 6.07 lakh resides in rural areas. This as per the 'Provisional Population Totals' [paper 2, volume 2 of 2011] Rural-Urban Distribution of Population Sikkim [series 12] released by the Directorate of Census Operations, Sikkim. And this is after the urban spread was significantly expanded in Sikkim some years back. The point being made here is that the 75% population which resides in rural Sikkim lives more or less the same lifestyle as families in urban areas, following similar patterns of consumption, and hence generating similar waste. They should thus be provided matching organizational and infrastructural arrangements to manage their waste. The traditional modes of disposal will not deliver for the nonbiodegradable and excessive nature of contemporary waste. Most village homes have a pit to dispose their waste. When this waste was organic in nature, the 'pit' approach worked well, but kids no longer buy loose balls of 'Anda' mithai wrapped in paper anymore and their sweets come in plastic wrappers and guests at social gatherings are no longer served in plates stitched from 'malatho' or banana leaves and even drink water from Styrofoam cups (sorry, scratch that since Styrofoam is now thankfully banned in the State, but it is still poor plastic cups) now.

The traditional waste management system, which focused only on household level disposal and had no need for segregation, collection and organized disposal, just won't do anymore. The rural areas generate the same waste as urban zones, hence it is necessary that they are extended matching systems of collection and disposal. This requirement becomes even more urgent as more areas start hosting tourists and village tourism becomes the new mantra for development here. Look around, most tourist spots even in the outskirts of Sikkim do not have any semblance of waste disposal or collection. Sure, they have their rabbit and panda bins, but those are but fig leaves when it comes to waste management. Look into the backyards, and a study on consumption patterns is laid out strewn along the slopes. Sikkim is now an organic state, inorganic waste encroaching into its fields and jhoras does not sit well with this status. It is no longer even about appearances. Proper waste disposal systems, and the once a week garbage truck runs to ship away waste is not even close to proper, are an urgent requirement in the bastis and at all tourists spots. The sooner the planners start working out sustainable plans and projects to deliver this, the better it will be for Sikkim and its environment.

# **Social Norms and Poor Services Drive Petty Corruption in East Africa's health sector**

n East Africa, there are concerns over widespread petty corruption in some of the countries' health and medical services. This makes access to them conditional on who you know or who you can pay, to the detriment of everyone else who doesn't have the money or connections.

In Uganda and Tanzania health service providers are ranked as some of the most bribery-prone institutions in the country. By contrast, health and medical services in Rwanda are ranked as the least

We wanted to understand the behavioural drivers, such as the role of social norms and beliefs, in spurring petty corruption. To do this, we investigated the decisions of those seeking medical treatment and of health service providers that fuel petty corruption in Tanzania, Uganda and Rwanda.

We focused on these three East African countries, which share a common border west of Lake Victoria, because we wanted the opportunity to compare attitudes and experiences. All three countries have robust anti-corruption legislation and institutions in place but all yielded different results.

Our research found evidence that social norms and shared beliefs spur corruption. For example, people are swayed by social pressure to help relatives, share contacts or reciprocate favours received from their networks. Many also believe that corruption is normal.

This was very evident in Uganda and Tanzania, but to a much lesser extent in Rwanda. This highlights our findings on why this behaviour comes about in the first place: people engage in corruption when health services are less available or accessible.

In Rwanda effective government social programmes exist. For example Ubudehe provides targeted support to the poorest and most vulnerable groups. The programme has reduced the reliance of citizens on informal social networks by ensuring access to public services and social benefits.

We hope that our research provides insights into the importance of incorporating behavioural insights into anti-corruption policymaking that conventional measures have largely failed to address.

However, unless basic problems of accessibility and quality of public services are addressed, it will be extremely difficult to eradicate informal strategies to obtain the desired healthcare.

SOCIAL NORMS AND NETWORKS

The research was conducted between January 2016 and August 2017 in Rwanda, Tanzania and Uganda.

For our research we carried out interviews, focus group discussions and surveys. Our target communities were providers and receivers of healthcare. For those seeking treatment, we targeted women of child bearing age, young men, and elderly and disabled people.

The evidence suggests that social norms and networks play a role in fuelling and reproducing practices of petty corruption. Users of public health facilities in Uganda and Tanzania often turned to their social network, family, friends, friends of friends, when seeking medical services.

When personal connections are absent, offers of unsolicited bribes and gifts are used to create a relationship with the provider. The expectation is that having a "provider friend" helps facilitate access to treatment.

Social norms even dictate how large a bribe should be. In both Uganda and Tanzania, for those that were close - like family members - it would be a small gift or bribe. But for those more socially distant, like friends of friends, they were asked to pay more.

PRESSURE FROM RELATIVES

The research also illustrated how corruption was perpetuated by relatives working within the health industry. The duty to help and provide for one's relatives was an essential, unquestionable premise of social life in the three countries.

A health sector district official in Tanzania explained that: "It's not that we have a lot of money to help five or six relatives, but...whatever you get you share with others."

The imperatives of helping out, and sharing with, the family results in practices of favouritism as explained by a health provider in Kampala, Uganda, who observed that, "Your relative must be given priority if there is not an emergency. My mother, father, son or daughter come first."

In some cases, family pressures pushed public servants to abuse their positions and engage in illegal acts, such as embezzlement of public funds or misuse of public resources. For example, focus group discussions in Tanzania showed that the misuse of public resources was motivated by the

need to contribute to family duties such as paying for children's school fees, weddings and funeral

Another big driver of corruption in Tanzania and Uganda was the belief that corruption is commonplace, and is expected and accepted. This stereotype is used to justify corrupt behaviours and those of the doctors, nurses and pharmacists.

**RWANDA CASE** 

Our research in Rwanda suggests that accessing health services by relying on networks is much less and limited to those very close to health staff.

This is predominantly associated with the fact that you don't need special connections or money to have access to good quality health services. The East Africa Bribery Index illustrates this point: the least probability for the request or offer for bribery was recorded at Rwanda's medical and health

Our research suggests that this is because it's less socially accepted. And it is partially helped by authorities publicly shaming those caught engaging in corruption, preventing it from becoming a norm.

#### TRADITIONAL MEASURES

Conventional anti-corruption measures and approaches often seek to scale up penalties and, by so doing, increase deterrence. Some focus on better laws, regulations and education and awareness campaigns about the negative effects of corruption. But these aren't necessarily effective in addressing root issues.

Integrating behavioural insights into anti-corruption programming can provide complementary avenues to strengthen these endeavours. They pay attention to social norms and beliefs that have supported the persistence of corrupt practices to be-

We are exploring this in detail by developing an intervention that works with social networks and community opinion leaders. It uses behavioural techniques - such as environmental nudges which would encourage a certain type of behaviour, like anti-corruption posters - to address the social norm of accepted use of bribery in the provision of

# This DIY Contact Tracing App Helps People Exposed to COVID-19 Remember Who They Met

good circumstances, it will probably be at least Monday before a contact tracer calls from the health department. And then some phone tag may ensue before you speak with anyone - if you get a call at all.

Once a contact tracer does reach you, you will be asked to remember all the people you were in close contact with, starting two days before you began feeling symptoms. That means recalling all the places you went and the people you saw over the past week.

It isn't easy. As time passes, memories fade. Unfortunately, your contacts, unaware they were exposed to the coronavirus, may have already infected others.

Concerned about those delays, three of us and our colleague Ronald Fisher, all psychology professors with expertise in memory, developed a way for people who have been exposed to COVID-19 to effectively trace their recent contacts on their own.

Self-driven contact tracing shouldn't replace health department efforts. Professional teams of trained contact tracers are critical for locating the people you came in contact with but don't know, such as at a restaurant or on an airplane, and

However, jump-starting the effort on your own can improve your chances of remembering and allow you to warn your contacts sooner.

NOTIFYING CONTACTS FASTER

Contact tracing, along with testing and isolating people who are infected, is considered crucial for controlling the coronavirus's spread until a vaccine becomes widely available.

Health department contact tracers try to notify and interview anyone who was within 6 feet of an infected person for a total of 15 minutes or more. Studies show that, to be effective, that notification needs to happen within a few days of the person's symptoms appearing. But case numbers have gotten so high, it's become impossible for many states and counties to keep up. Some, including in Alaska, Missouri and Wisconsin, have urged residents to start notifying contacts on their own.

We created CogTracer as a free online tool to help people start tracing those contacts using best-practice interviewing methods.

With DIY contact tracing, the timetable changes. For example, while you're waiting for your test, you can be given the link to the website and start walking yourself through a contact tracing interview.

HOW PSYCHOLOGY CAN HELP JOG YOUR MEMORY

CogTracer uses prompts, in words and photos, to spark your memory

then tracing the next ring of contacts. for as many contacts and locations visited as possible. It urges you to look back at places that might have evidence of your movements that week, such as social media posts and credit card records, and it provides scientifically supported interviewing techniques to reduce the chances of forgetting a contact. Research in investigative interviewing shows that people can effectively remember events on their own when they have scientifically supported methods.

> One technique for remembering is known as context reinstatement. It involves putting yourself back in a specific time and place.

For example, if you attended a family gathering over the holidays, you might mentally recreate the event. You could think back on how you arrived and departed, what you wore, who was there, what you ate, what you heard and what you saw. The technique encourages closing your eyes during this process to help you concentrate.

"Reliving" this experience should make it easier to remember your close contacts at the event.

Another important way to improve memory is varied retrieval. When you search your memory only once, or in the same way over and over, it is likely that something will be forgotten. What you recall depends on how you cue your memory. If you prompt your memory in different ways, you'll recall different things.

CogTracer takes advantage of re-

peated and varied recall by including broad category cues, such as "people you interact with in homes" or words such as "babysitter," that may trigger memories of nonroutine activities

Applying these proven methods should result in more complete recall of those who could be at risk for contracting COVID-19.

that may otherwise be forgotten.

ONLINE TOOLS CAN OVERCOME OTHER BARRIERS, TOO

This DIY approach can also help overcome other barriers to effective and timely contact tracing.

Because many people put a high premium on privacy, some are resistant to providing information to contact tracers. CogTracer is anonymous and private - you don't enter any information, and you make your own lists. This provides a way for those who otherwise would not engage in the process to contribute to contact tracing efforts on their own terms. Additionally, non-English speakers may require an interpreter, further delaying the contact tracing process. Online interviews can more quickly bridge these language gaps.

As the pandemic rages, public health workers are engaged in Herculean efforts to fight this disease. By reimagining contact tracing and applying the science of memory, we can leverage the power of individuals to attack the problem from as many fronts as possible.

LONDON, 06 DEC [THEGUARD-**IAN]:** It's the question that fans have been debating ever since the pandemic forced football to be played behind closed doors: is home advantage no longer so advantageous?

Well, perhaps to the chagrin of those fans – and as a limited number of home supporters are allowed back into stadiums - a comprehensive new study suggests that their absence has had barely any impact on results.

This is not to say, however, that the coronavirus has had no influence on what happens on the pitch.

The study finds that, with no fans, referees are far less likely to dole out yellow cards to visit-

An analysis of 6,481 matches, played in 23 professional leagues and 17 countries during the 2019/20 season, found that matches played behind closed

doors were only around three percentage points less likely to result in a home win.

The authors of the report acknowledge such fine margins could lead to substantially different league outcomes, such as relegation.

But Professor James Reade, head of the department of economics at the University of Reading, who carried out the analysis with colleague Carl Singleton and Professor Peter Dolton of the University of Sussex Business School, said the data showed that the absence of crowds had not really helped level the playing field for visiting teams, despite what many believe.

"People still think there is a reduced home advantage and that's seeping into the discussion about the return of fans with people saying, 'Well, it's not fair.' But from what we are seeing here, there is no clear and

obvious effect on the match outcomes," Reade said.

The economists examined a range of outcomes, including goal difference and total goals scored, and concluded that only one - the number of yellow cards issued behind closed doors - was statistically signifi-

They found that the absence of a crowd reduced the number of yellow cards issued to a visiting team by between a third and almost half a card per match.

This led them to conclude that, without a home crowd, the social pressure on referees to "punish" the away team more harshly was reduced, leading to "fairer" decisions.

Some have suggested that teams may play differently behind closed doors and that player behaviour, not the decisions of referees, is responsible for the drop in yellow cards issued.

But the study suggests this

is unlikely since the final scorelines of matches were not particularly different without fans.

"It does point us to the conclusion that maybe it is a referee effect," Reade said.

While the reduction in yellow cards being issued might not affect the results of individual matches, it can still have a bearing on where a team finishes at the end of a season.

"If you are picking up more and more yellow cards per game, then you are likely to end up with suspensions and weaker squads, so there is an effect on this even if yellow cards don't affect the outcome on the day of the match," Reade said.

The findings have potentially wide implications not just for football but for many sports.

The economists said those running sport businesses had a responsibility to ensure fans, who pay substantial sums for season tickets and TV subscriptions, watch high-quality contests that are neutrally refereed.

Ultimately, though, maybe the main takeaway from the study was that referees, so often the objects of derision, need all the help they can get.

"The study suggests it isn't that referees are terrible and they need to have more training. it's that they need to have more support," Reade said.

"As much as we dislike VAR [video assistant referees] and the way it's having an impact on the game, one thing it does is slow things down and gives the referee more time to make their decision."

The state's positivity and fatality rates stand at 4.91 per cent and 0.33 per cent respectively, Dr Jampa said.

The Capital Complex region, comprising Itanagar, Naharlagun, Nirjuli and Banderdewa areas, has the highest number of active cases at 552, followed by West Kameng (55) and Changlang (18).



Thomas Tuchel fielded a surprising 5-3-2 formation with Angel Di Maria and Kean up front as Mbappe started on the bench and Neymar was rested ahead of Tuesday's key Champions League game against Istanbul Basaksehir.

Dagba put the visitors ahead in the 33rd minute, scoring from inside the box from Di Maria's

Montpellier hit back four minutes before the interval when Mavididi beat Keylor Navas at the far post after Dagba had saved the Englishman's first attempt on his goal

PSG had three chances early in the second half but Idrissa Gueye and Kean, twice, lacked accuracy.

Di Maria came closer in the 69th with a low shot but Jonas Omlin fully stretched to deny the Argentine as PSG struggled to make their domination count.

# Papa Bouba Diop's winner against France was Senegal's Maradona moment

**JONATHAN WILSON** LONDON, 06 DEC [THEGUARD-IAN]: There are a handful of goals that are universal, that resonate with almost everybody who follows the game. Diego Maradona scored two of them in the space of five minutes against England in the World Cup quarter-final in 1986 - goals much better remembered, in Argentina, in England, everywhere, than either of his brilliant goals in the semi-final or than any of the five goals in the final. What makes a goal indelible is far more to do with context and narrative than the quality of the strike or even the stage at which it is scored.

There are very few truly universal goals. How many, really, could you mention to a fan in Beijing or Baltimore, Jakarta or Johannesburg, in the realistic expectation they could describe it? Maybe it is a facet of ageing, but as the volume of football on television has increased, such strikes seem to have become fewer and further between.

Zinedine Zidane's headbutt and, some way behind, Luis Suárez's handball are probably the biggest World Cup moments of the past 20 years. Goals, it turns out, are overrated, but it may be that the most memorable in the World Cup in the 21st century was the first: Papa Bouba Diop's winner for Senegal against France in the opening game of the 2002 finals.

Diop died last Sunday, four days after Maradona, aged 42. His passing was respectfully marked, and Ademola Lookman celebrated scoring for Fulham against Leicester with his Senegal No 19 shirt, but there was nothing like the vainly for offside. Diop is on



same outpouring of emotion. Why would there be? Maradona was one of a handful of all-time greats; Diop was a popular and diligent midfielder for Fulham and Portsmouth. Even in that Senegal side in 2002, Diop was overshadowed by El-Hadji Diouf and Salif Diao. Yet he, too, had his moment.

Omar Daf catches Youri Djourkaeff in possession and slides a pass down the left for Diouf to chase. He beats a lunging Frank Leboeuf and cuts the ball back along the edge of the six-yard box. Diop arrives in front of Emmanuel Petit and although Fabien Barthez saves his initial shot the ball rebounds back to him as he slides towards the line, allowing him to hook it in as Bixente Lizerazu appeals his feet immediately, running to the corner flag, where he lavs his shirt on the ground and orchestrates a dance around it.

That passage from Daf winning the ball to the celebration in the corner are, globally speaking, probably the most famous 20 seconds in Senegal's history - not Senegalese football's history, but the history of the nation. Ask somebody in Britain to name anyone from Senegal and while some may know the musician Youssou N'Dour, far more will be able to name Diouf or Diop - or, more recently, Sadio Mané.

For some players – Lionel Messi at times, for instance - that can become a terrible burden, but it's also an extraordinary opportunity. It is easy, in the face of the vapid

laughter of a million adverts and Fifa's cant about the football family, to become cynical, but no cultural pursuit is so universal. (In 2002, without realising who he was until half-time, I sat next to N'Dour during Senegal's Cup of Nations quarter-final against DR Congo in Mali, exchanging the odd polite comment about the football.)

Diop was born in Rufisque, once a thriving port but now run-down and subsumed into Dakar. At 18, he started playing in the Senegalese top flight. At 21, he secured a move to Switzerland, fulfilling the dream of a lucrative European move. In January 2002, iust after joining Lens, he was part of the Senegal squad at the Africa Cup of Nations.

There were already whispers this was a special side. They kept themselves apart, booking out a small hotel while every other side based in Bamako, Mali's capital, stayed in the huge concrete Hôtel L'Amitié. There was a mood about them that is particular to a national side tasting significant success for the first time, or for the first time in a long while, at least: a mixture of excitement, pride and disbelief.

While those in the hotel seemed stuck on the familiar players' treadmill of bedroom-dining room-training, Senegal's players relaxed in the garden. They were probably the best side at the tour- last month was marked by the nament, but lost on penalties in the final to Cameroon.

Diouf, also at Lens, was the ebullient and charismatic face of the squad, but Diop was there in the background. Beye described him as a giant it wasn't just his physique he was talking about. The defender Alassane N'Dour, another member of the squad, described Diop as "a partner, a role model, a friend, a brother and a patriot", as though being "a fantastic and extraordinary player" was incidental.

But Diop was a fine player, so influential that, by 2008, Tom Vernon, who ran an academy near Accra in Ghana, was complaining of the "Papa Bouba Diop template", of European clubs coming to west Africa only interested in signing defensive midfielders in his image, just as they had once gone to South America to sign No 10s.

The irony is that a player so adept at breaking up opposing attacks should be most famous for a goal he scored. To those who wanted to see it, there was symbolism in a winner against the former colonial master - although there was no animosity: 21 of Senegal's 23-man squad had played in France and most said they happily supported France in tournaments they were not involved in. More immediately relevant was it was the goal that beat the world and European champions, a goal that made people, perhaps for the first time, take notice of Senegal.

There, again, the breadth of the World Cup's appeal is made clear. The last week of deaths of two players from very different but similarly humble backgrounds, who conditioned how the rest of the world regarded their na-

# Barca slump to shock loss at Cadiz after Ter Stegen gaffe

Barcelona conceded two embarrassing goals as they suffered a shock 2-1 defeat away to Cadiz in La Liga on Saturday.

glet following a throw-in. Alba aimed the throw towards Lenglet but the Frenchman could not control the ball and Negredo, on the pitch for less than a minute, ran to press Ter Stegen, blocked his kick out and dribbled the ball past the diving Frenkie de Jong and into

the unguarded net. Barca's fourth defeat of the season left them seventh in the standings on 14 points after 10 games, 12 points behind leaders Atletico, and Ronald Koeman's side have failed to win their last four away matches.

The Dutch coach criticised the attitude of his players.

"It's incredible that we lost because of a goal like that, it's an error you do not expect this team to make. It shows we were not concentrating," he said.

"The attitude was not good tonight. I'm very disappointed."

Barca midfielder Sergio Busquets said individual errors had cost them a lot of points this season.

"You cannot question the team's attitude or commitment, but when you start like we did today it makes the game very difficult," he said.

# Iran sends biggest ever fleet of oil tankers to Venezuela

JAZEERA]: Iran is sending its biggest fleet yet of tankers to Venezuela in defiance of U.S. sanctions to help the isolated nation weather a crippling fuel shortage, according to people with knowledge of the matter.

Some of the flotillas of about 10 Iranian vessels will also help export Venezuelan crude after discharging fuel, the people said, asking not to be named because the transaction is not public.

The Nicolas Maduro regime is widening its reliance on Iran as an ally of last resort after even Russia and China have avoided challenging the U.S. ban on trade with Venezuela.

The country's fuel crunch follows decades of mismanagement, corruption and under-investment at state-owned Petroleos de Venezuela since the time of Maduro's late mentor and predecessor, Hugo Chavez.

The country that was once a top supplier of crude to the U.S. and boasted one of the lowest domestic gasoline prices in the world, now can barely produce any fuel.

The last Iranian fuel shipments sent in early October on three vessels are running out, threatening steeper nationwide shortages with hours-long queues at gas stations.

The oil ministry in Tehran declined to comment on the matter. Messages sent to several officials at PDVSA, as Venezuela's state oil company is known, weren't immediately answered.

In addition to importing fuel, Venezuela also needs to export enough crude oil to free up storage space and prevent field stoppages, a task made more difficult by the sanctions against Maduro's regime.

Production at Venezuela's network of six refineries has gone into steady decline, with spills and accidents becoming routine. Maduro's government has increased pressure on the poorlymaintained infrastructure to ensure output for local consumption.

Sanctions have made it difficult to import parts or hire contractors, and the Maduro regime is running out of cash.

Consequently, two nations are also discussing ways for Iran to help Venezuela overhaul its Cardon refinery, the last fuel plant there to operate more or less regularly, people with knowledge of the situa-

In 2018, Chinese oil companies also looked at helping Venezuela fix its refineries, but lost interest after a review of the installations, people familiar with those plans

It's unclear whether the Iranians would be able to achieve what the Chinese didn't. Venezuela's refineries were built and operated for decades by U.S. and European oil majors until nationalization in the 1970s.

vaccinations. Authorities in Sichuan province in the west, which has about 85 million people, announced Monday they were already buying vaccines.

An official newspaper in Anhui province, southeast of Beijing, said a local residential committee issued a notice asking a vaccine

The Sichuan and Anhui announcements said the vaccine, given in two shots, would cost a total of 400 yuan (USD 60).

Vaccines from Sinovac and Sinopharm were approved for emergency use in July.

In October, Zhejiang province south of Shanghai offered the public vaccination under emergency use authorization.

It said people considered high-risk would get priority. In November, the

Communist Party secretary for Sinopharm said almost 1 million people had received its vaccine.

In September, Sinovac's CEO said about 3,000 of its employees had taken their vaccine.

He said the company provided tens of thousands of doses to the Beijing city government.

Developers have yet to disclose how effective their vaccines are and possible side effects.

Sinopharm has clini-

cal trials under way in 10 countries including the United Arab Emirates, Egypt, Jordan, Peru and Argentina with nearly 60,000 volunteers.

It has built two facilities in China capable of producing 200 million doses per year.

Sinovac has trials in Brazil, Turkey and Indonesia. Its most recent publicized data, a study in the science journal the Lancet, showed its candidate produced lower levels of antibodies in people than those who had recovered from CO-VID-19.

The company projects it will be able to produce a few hundred million doses of the vaccine by February or March of next year. Another producer, CanSino, is testing in Russia, Pakistan and Mexico and pursuing partnerships in Latin

# UK races to deport asylum seekers ahead of Brexit

Three flights this week, two to Germany and one to France, with possible transfers to Austria, Poland, Spain and Lithuania, are planned amid opposition from campaigners who say they have evidence that cases are being "rushed" through to avoid Patel's own published policy on identifying trafficking victims.

The development comes days after Patel branded those calling for last week's deportation flight to Jamaica to be stopped as "dogooding celebrities", a label that prompted victims of the Windrush scandal to describe the home secretary as "deeply insulting and patronising".

Groups monitoring the impending round of flights to the EU say that the Home Office's planned operation to remove potential trafficking and torture victims without proper screening is unlawful and breaches a recent interim high court order.

The flights are operating under the EU's Dublin convention legislation that allows states to return people to an EU country where they have already made an asylum claim - a right the UK retains during the Brexit transition period.

Soon, unless another transfer arrangement is agreed with the EU, the UK will no longer be able to forcibly deport asylum seekers who have passed through other EU countries.

Lawyers acting for those scheduled to be deported on this week's flights say they haven't been properly screened to identify serious

An interim high court ruling last month said the Home Office's failure to ask such questions was arguably "unlawful" and risked a "serious risk of injustice and irreversible harm." The ruling ordered the Home Office to reinstate the two questions for arriving asylum

Teather, whose group is representing eight asylum seekers due to be deported by charter flight this week, added: "They've been told this practice is unacceptable by the high court, yet they continue to rush people through the process regardless, perhaps safe in the knowledge that the most vulnerable and traumatised asylum seekers are struggling to access legal advice in detention right now. It demonstrates a complete disregard for human life and it is a shameful episode."

A Home Office spokesperson said: "We remain determined to fix the broken asylum system so that it is firm and fair and make no apology for removing those with no right to remain in the UK.

### China coal mine accident toll climbs to 23

BEIJING, DEC 6 (PTI): The death toll due to a carbon monoxide leak inside a coal mine in southwest China has gone up to 23, while one person has been rescued, officials said on Sunday.

The accident took place at around 5 pm (local time) on Friday at the closed Diaoshuidong colliery in Yongchuan district of Chongqing Municipality.

The dead are among 24 people trapped underground by excessive levels of carbon monoxide gas at the coal mine, where they were dismantling equipment in a pit.

The mine was suspended and shut down over two months ago. The cause of the accident is being further investigated, state-run Xinhua news agency reported on Sunday.

The Diaoshuidong coal mine, which was established in 1975 and became privately-owned in 1998, has an annual production capacity of 120,000 tonnes of coal, according to the local emergency management department.

In March 2013, hydrogen sulfide poisoning in the mine left three dead and two injured.

Though safety improvements have reduced deaths at coal mines in recent years, mining accidents are common in China, which is the world's largest coal producer. At least

16 people died in late September after high levels of carbon monoxide trapped miners at the Songzao coal mine in Chongqing.

China, which is both the world's largest producer and consumer of coal, has now reported more than 100 coal mining accidents in 2020.

In November, the government launched a yearlong review of all working coal mines and coal-mining projects, focusing on infrastructure, risk prevention management and capabilities for emergency response and rescue.

Coal production in China typically ramps up between November and February in order to meet production targets.

### **COVID-19 could push number of people living in** extreme poverty to over 1 billion by 2030: UN

UNITED NATIONS, DEC 6 (PTI): An additional 207 million people could be pushed into extreme poverty by 2030 due to the severe long-term impact of the coronavirus pandemic, bringing the total number of the world's extremely poor to more than a billion, a new study from the UN Development Programme (UNDP) has found. The study assesses the impact of different COVID-19 recovery scenarios on the Sustainable Development Goals (SDGs), evaluating the multidimensional effects of the pandemic over the next decade.

The study is part of a long-standing partnership between the UNDP and the Pardee Center for International Futures at the University of Denver.

"Severe long-term effects of the COVID-19 pandemic could push an additional 207 million people into extreme poverty on top of the current pandemic trajectory, bringing the total to over 1 billion by 2030," noted the study.

The 'Baseline COVID' scenario, based on current mortality rates and the most recent growth projections by the International Monetary Fund (IMF), would result in 44 million more people living in extreme poverty by 2030 compared to the development trajectory the world was on before the pandemic.

Under a 'High Damage' scenario, where the recovery is protracted, COVID-19 is likely

to push an additional 207 million people into extreme poverty by 2030, and increase the female poverty headcount by an additional 102 million compared to that baseline, says the report.

The 'High Damage' scenario anticipates that 80 per cent of the COVID-induced economic crisis would persist in 10 years' time due to loss in productivity, preventing a full • recovery to the growth trajectory seen before the pandemic.

However, the study also finds that a focused set of SDG investments over the next decade in social protection/welfare programmes, governance, digitalisation, and a green economy could not only prevent the rise of extreme poverty, but actually exceed the development trajectory the world was on before the pandemic.

"This ambitious, yet feasible SDG Push' scenario would lift an additional 146 million people out of extreme poverty, narrow the gender poverty gap, and reduce the female poverty headcount by 74 million, even taking : into account the current impacts of the CO-VID-19 pandemic," UNDP said.
