

# ICAR-NOFRI organizes capacity building programme for women on Vanaraja chicken farming

GANGTOK, 24 FEB [PIB]: ICAR-National Organic Farming Research Institute (NOFRI), the erstwhile ICAR Research Complex for NEH Region, Sikkim Centre, Tadong, organized a three-day capacity building programme for tribal women on "Backyard Poultry Farming with Vanaraja Chicken for Livelihood and Nutritional Security in Rural Sikkim" under the Tribal Sub Plan Project from 20 to 22 February under the leadership of Dr Ravikant Avasthe, Joint Director, ICAR-NOFRI.

22 participants from different villages of Sikkim, comprising six participants each from North, South and West districts and four participants from East district, attended the training program.

In his welcome address, Dr Rafiqul Islam. Principal Scientist. ICAR-NOFRL and coor-



dinator of the training program explained that the training was organized to train trainers to educate and train other farmers, particularly women farmers, in their respective areas.

All the participants were very interactive during all the theory and practical sessions held on various aspects of Vanaraja poultry farming. The training programme included nine lectures and two hands-on sessions on housing, feeding, lighting, preventive and

of Vanaraja birds both at intensive and backyard rearing systems including soil health management, organic vegetable and crop production in integration with poultry farming.

# CIC rules EVMs are 'information' under RTI Act

New Delhi, Feb 24 (PTI): An Electronic Voting Machine is "information" under the Right to Information Act and can be demanded by an applicant from the Election Commission of India on a payment of Rs 10, the Central Information Commission has ruled.


This implies the Election Commission has to respond to an RTI application seeking the EVM either by providing it or refusing it under exemption clauses in the Act. But that also can be contested before the CIC, the highest adjudicating authority in RTI matters.

Deciding a unique RTI application, through which the applicant had sought an EVM from the Commission, Chief Information Commissioner Sudhir Bhargava recently said the machine was covered under the definition of "information" and can be demanded from the ECI.

The Election Commission had rejected the application saying the EVMs held by it do not come under the definition of "information".

The applicant, Rajaak Khan Haider, approached the CIC with a strong argument that as per Section 2(f) and 2(i) of the RTI Act, the definition of 'information' and 'record' also includes 'any model or any sample' held by a public authority, calling the rejection as wrong.

Section 2(f) of the RTI Act defines 'Information' as any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any



electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.

The Election Comrepresentative admitted that model and samples of the machines are available with it but the same are only kept for training purpose, and not saleable to the general public.

ditional apology for rejection, the Election Commission representative agreed that it was wrong on its part but reiterated that EVMs did not come under the definition of information, an argument rejected by Bhargava.

"The EVM which is available with the Election Commission in a material form and also as samples, as admitted by the respondent (ECI) during the hearing, is an information under the RTI Act." the CIC ruled.

In the next sentence, however, the Commission tried to nip in the bud any aspiration of accessing the machine underlining the second contention of the EC that the software installed on these machines is an intellectual property of a third saying the rejection of party, the disclosure of which would harm its competitive position.

The CIC, however, did not give any view whether it was upholding or rejecting the EC's position on commercial confidence leaving a grey area which can be pursued further by any applicant.

An information can be denied by a public authority if it attracts itive position of the third any exemption clauses listed in the RTI Act which also exempts information pertaining to commercial confidence or intellectual property from disclosure.

One of the clauses Section 8(1)(d) exempts information including commercial confidence. trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party, unless the competent authority is satisfied that larger public interest warrants the disclosure of such information.

The issue of larger public interest in the wake of allegations of EVM tampering was not mentioned in the order.

### National programme for elimination viral hepatitis launched

NEW DELHI, FEB 24 (PTI): Union minister Ashwini Kumar Chouhev launched a national programme aimed at eliminating viral hepatitis, recognized as an important public health problem across the world, on Sunday in Mumbai.

The minister of state for health launched the National Action Plan - Viral Hepatitis in presence of Amitabh Bachchan. the goodwill ambassador for hepatitis, WHO South-East Asia Region.

Bachchan described how he contracted the disease, an inflammatory condition of the liver, when blood was transfused into him after he was injured during the shooting of "Coolie" in 1982.

One of the blood donors had Hepatitis B, the actor said, ruing that the detection process for the virus was not available then. He came to know about the condition in 2005.

According to WHO estimates, viral hepatitis caused 1.34 million deaths globally in 2015, a number comparable to deaths due to tuberculosis, worldwide.

In India, it is estimated that there are 4 crore people suffering from Hepatitis B and 0.6-1.2 crore people suffering from Hepatitis C, a ministry statement said.

The action plan was developed by experts from across the country. It provides a strategic framework, based on which the National Viral Hepatitis Control Programme was framed and launched in July 2018 under National Health Mission by the Health Ministry.

"This programme is also in line with our global commitment towards achieving Sustainable Development Goal (SDG) 3.3. India has affirmed this commitment at the 69th World Health Assembly," Choubey said.

India is one of the few countries to roll out management of Hepatitis B and Hepatitis C in a public health approach and offer free diagnostics and drugs lifelong to its beneficiaries. The aim of the programme is to combat hepatitis and achieve countrywide elimination of Hepatitis C by 2030, he said.

The minister also released the Technical Guidelines for Diagnosis and Management of Hepatitis B.

In India, Hepatitis B vaccine was introduced in the Universal Immunization Programme almost a decade ago. Since healthcare workers and high-risk groups by virtue of their occupation and behaviour are more vulnerable to acquiring infection, it is envisaged to extend the beneficiaries for this vaccine to healthcare workers and high-risk groups under the National Viral Hepatitis Control Programme (NVHCP).

Focus under the programme is also on screening of pregnant women for hepatitis B. in places where institutional delivery is less than 80 pc, to ensure provision of birth dose Hepatitis B vaccination and Hepatitis B immunoglobulin, if required, the statement said.

Another important strategy adopted by the programme is propagating the use of Re-use Prevention (RUP) syringes in the country. The NVHCP website was also launched on the occasion.

Today, we have taken a pledge to fight hepatitis; while we have done this in the presence of hundreds of people, the message should go to crores of people," Choubey said.

Bachchan said, "I am here today because I am a Hepatitis B victim. While shooting for the film Coolie, I got injured and required a lot of blood: the blood given by 200 donors saved my life, but one of the donors was carrying the Hepatitis B virus.

"The detection process for that virus was not in order at that time, and that went into my system. This was discovered only in 2005, when I came to know that 75 per cent of my liver had been destroyed. I am a living example of a Hepatitis B victim."

### Piaggio aims to scale up two-wheeler biz in India

NEW DELHI, FEB 24 (PTI): Italian two-wheeler maker Piaggio is looking to expand its sales network in India to over 350 dealerships by the end of this year as part of scaling up its business in the country, a top company official said.

The company, which currently has around 250 sales outlets, will however stick to its premium lineage even as it seeks to grow its volume in the world's largest two-wheeler market as it does not want to be perceived as mass segment player. "We plan to expand our volumes in both domestic and export markets. Currently, our sales network is very limited (in India) as we are one of the last players to come on board here," Piaggio Vehicles India Managing Director & Chief Executive Officer Diego Graffi said here during an interaction.

There is huge area in India where the company is not present in terms of sales network, he said adding that it has only been 6 years since the company re-entered the country.

"Through this expansion of sales network, we plan to expand our presence...we are planning to have 350 active dealerships by the end of this year," Graffi said.

When asked if the company would like to compete with mass market players in the country, Graffi said: "Wherever we are present all across the world in the two-wheeler space, we do not want to be perceived as a mass segment player." He further said: "We are not interested in that (mass segment). We are not interested in market share...we are among the top when it comes to brand recall... that is what we are looking at."

The company, which sells Vespa and Aprilia brands in the country, sold 74,704 units in India in 2017-18. Piaggio has a manufacturing plant in Baramati in Maharashtra, where it manufactures the iconic Vespa alongside the Aprilia SR 150.

Graffi also supported the call for reduction in GST on two wheelers.

"In two-wheelers, we have seen a lot of challenges starting from mandatory third-party insurance which came into force from September 2018...then we have new legislations like mandatory usage of ABS from April 2019," Graffi said.

Then there is BS-VI challenge as well, so due to all these factors, the industry is going to provide better service, content, safety to

"So, my idea is that reduction of GST rates on two-wheelers from 28 per cent to 18 per cent is quite recommendable from even our point of view." Graffi noted.

The company sees two-wheelers as a normal medium of mass transportation and "we don't see having such high GST applied (on the segment), he added.

Earlier, Bajaj Auto, Hero MotoCorp and TVS Motor Company had asked the government to slash GST on two-wheelers from the current 28 per cent slab to 18 per cent to give

# Sebi orders impounding of Rs 1 cr from ADF Foods' promoters, 4 others in insider trading case

Markets regulator Sebi has ordered impounding of alleged illegal gains worth over Rs 1.02 crore from ADF Foods' promoters Bhavesh Thakkar and Priyanka Thakkar and four others in an insider trading case. The other four are Pallavi N Mehta, Shefali B Mehta, Navin M Mehta and Abhishek Mehta.

As per Sebi's order, on July 27, 2016, ADF Foods informed the BSE and NSE that the board of directors in its meeting on the same date had approved a buyback of equity shares for an aggregate amount not exceeding Rs 18 crore.

On May 21, 2016, the discussion of idea to under take buy back or payment of dividend was first tabled at a meeting. Sebi said. Therefore. Sebi considered the time period from May 21-27

Regarding the other four, Sebi noted that Navin Mehta and Abhishek Mehta being insiders, traded in the shares of ADF Foods through the trading accounts of Pallavi Mehta and Shefali Mehta when the price sensitive information remained undisclosed in violation of insider trading regulations.

Accordingly, Sebi ordered to impound the alleged unlawful gains of Rs 1,02 crore (alleged gains of 77 lakhs with interest of Rs 25 lakh) to be paid jointly and severally.

The regulator further added that entities may file their replies to Sebi within 21 days from the date of receipt of this order, if they so desire.

### Evaluate Results to **Empower People**

Change evaluation from inputdriven to result-oriented

It is not rare in the cramped huddles of share-cabs or service jeeps to overhear complaints of days and hours lost to making the rounds of government offices trying to get even routine works done. Lethargy and impromptu truancy remain ingrained habits in departments across the board. Of course, there is an impressive club of diligent officers as well, but accept it, their numbers pale in comparison to those who have too many other more important chores and distractions vying for their time. This situation as entrenched in head offices as in the branch offices and the inconvenience suffered by the people is also evenly spread out among the urban and rural aam janta.

Given the sheer number of government offices now opened across the State and the scale of personnel deployment this entails, it would be almost unfair to expect all these offices to be staffed by able and diligent officials. It will not be surprising to learn that there are more offices which are underperforming, but that really should not be the case since even if there are a more offices now, Sikkim is still a very small state and fixing accountability should not be too difficult.

Admittedly, that is easier said than done. It is not impossible though if the right administrative corrections are allowed through. In fact, the Administrative Reforms Commission [ARC] of the Government of India had made some interesting recommendations on how the country should be administered. And no, compulsory military training for all joining even the civil services was not one of the recommendations. It would be wonderful if the army itself was allowed more funds to improve training and arsenal, but that clearly is not how chest-thumping nationalists and their need to over-express their machismo thinks. But we are talking of the civil services here and the ARC, the draft report of which had suggested that bureaucrats be held responsible for service delivery. That was a decade ago in 2008! And service delivery remains unaddressed. No surprises there since the Centre believes announcements are enough to claim delivery. Hence, performance continues to be gauged on input-centric indices in our country and also the State. Bureaucrats, as also the schemes they oversee, are rated on the basis of money spent, man-hours supposedly devoted and manpower deployed. The ARC had noticed this fault a decade ago and recommended that assessment be based on quantifiable output targets. This was a good idea, even if an obvious one, and a welcome relief from attitudes which focus only on "effort" [which are all about claims] and ignore the all important aspect of "impact" [as in results]. Schemes are evaluated and sustained [with release of subsequent funds] based on Utilization Certificates. Although Sikkim's bureaucracy fares poorly even on this formality, as the Chief Minister and recently even the Chief Secretary admonished them for, should the ARC's recommendation be adopted [along with its penal clauses on failure], development could attain an even steeper trajectory here upwards.

More importantly, it would also fix accountability and embarrassments like complaints of delays even in routine official processes would not occur too frequently, and if they did, there would be a prescribed process to readdress them. After all, officials who do not report to even push files will not fare too well in service delivery either. Basically, the problem with the present model of evaluation [and thus also work culture] is that because it is "input centric" it makes no demands on the bureaucracy to remain true to its public service epithet.

One of the biggest hurdles holding up effective decentralization of power, despite devolution of substantial responsibilities to the panchayat level, is that lay people still do not have an important enough say. While they can vote for change every five years, that is about the only control they have on delivery of development. They cannot touch the bureaucrats. And the babus can continue to talk down to them because when it comes evaluating their performance, it is based on data of inputs which they control along with the elected representatives [who become a part of the System the moment they get elected].

Should performances instead be evaluated on returns accrued on the inputs made, the end-recipients, that is the people, will have at least a deciding say because it will be their assessment of the effectiveness of administration's ability to deliver that will decide which officers stay and who is shown the door. Yes, the ARC draft had also recommended that civil servants who continually fail to "perform" are compulsorily retired. The Departments will automatically become populated by "public servants" in the real sense of the term. Devolution of power would have been attained and job-satisfaction ensured for public servants who make the grade and every penny of the pay commission rewards would have been well earned. That said, 10 years since the idea was mooted, it has still not happened...

# Why Paris is the perfect city to introduce break dancing to the Olympics

long with surfing, climbing and skateboarding, Abreak dancing has been proposed for inclusion at the Paris 2024 Olympic Games. While fans of the sports have been delighted by the news, it has provoked some criticism too, not least from followers of sports such as squash and karate which will not

be considered for the 2024 games.

But the inclusion of break dancing in Paris 2024 would not be a complete surprise. Indeed, there are several reasons why it would actually make sense. Firstly, break dancing proved itself as a nonular event when it was included in the Youth Olympics for the first time at Buenos Aires in 2018. Secondly, the launch of break dancing as an Olympic sport in 2024 would fit

with the very ethos of the Paris games. The Paris 2024 organising committee plan to locate Olympic events in two key areas - a Central Paris zone and a Greater Paris zone. The Olympic Marathon will pass many central Parisian landmarks, archery will take place near the Eiffel Tower, at Esplanade des Invalides, and the road cycling will travel along the Champs-Elysees. Meanwhile, athletics events as well as the opening and closing ceremonies will take place outside central Paris, in the Stade de France.

So why does this mean that break dancing should have a place in the 2024 games? The Stade de France - like much of the Greater Paris zone is located in Seine-Saint-Denis, a part of Paris's suburban fringe that is said to be the birthplace of hip hop in France. Including an event like break dancing would not just be a big moment for urban culture worldwide, but important for French culture in the capital too.

Hip hop culture is big in France overall. Indeed, the hip hop market in France is now the second largest in the world, after the USA. And since the 1980s, break dancing, rap music, and graffiti have been particularly popular in the often-impoverished "banlieues" outside many major French cities.

However, French politicians have often been suspicious of break dancing. Within French rap music, there is an at times aggressive critique of French politicians and the police. Leading rap groups such as NTM, Sniper and La Rumeur have used their music to blame both groups for injustices and inequalities experienced by young people in the banlieues.

In an attempt to change negative perceptions, several films, including Jean-Pierre Thorn's

Faire kiffer les anges (1997) and On n'est pas des marques de vélo (2003), have shown how important hip hop culture has been in giving young people from such areas a powerful means of expression. Thorn's 2010 film 93, La Belle Rebelle sought to reinforce the idea that areas such as Seine-Saint-Denis are characterised by cultural diversity and dynamism. The film showed how many varied performers have come from the often stigmatised area, including well-known figures such as Serge Teys-

become more inclusive. Crucially, Perryman argued that the Olympics would be more successful if more events were free for spectators to attend. He cited the Tour de France as an example of a highly profitable major sporting event that is free for spectators. Perryman also argued that the Olympics should favour sports which are accessible to participants because they do not require expensive equipment. Including break dancing at Paris 2024 would connect the games with the urban culture of the area surrounding the Stade de France. It would see the French capital embracing a discipline often associated with its outer suburbs rather than the city centre, and provide a means to engage with young people too. It may even go some way to dispelling the negative reports more often coming out of these areas.

Prior to London 2012, sports activist Mark Per-Génération hip hop ou le mouv' des ZUP (1996), ryman argued that the Olympics can, and should,

or professional training is necessarily needed to begin break dancing.

However, it is important to add a note of caution. If Olympic break dancing is to successfully engage young people from Paris's banlieues, this will partially depend on them being able to buy tickets. The distribution and pricing of tickets for some Olympic events attracted criticism at Rio 2016 and London 2012. Empty seats were visible at several venues. notably due to tickets remaining unsold or being given to sponsors who did not use them.

On one hand, the symbolic importance of including break dancing in the Paris 2024 games should perhaps not be overstated. However, this one event could help anchor the games within the areas in which many venues will be located, as well as re-energise the Olympic movement for a young, urban audience both in France and worldwide.

# Language has become a tool for social exclusion

Within a week of the Salzburg Global Seminar's Statement for a Multilingual World launching in February 2018, the document - which calls for policies and practices that support multilingualism - had reeived 1.5m social media impressions.

The statement opens with some striking facts, including that "all 193 UN member states and most people are multilingual". It also points out that 7,097 languages are currently spoken across the world but 2,464 of these are endangered. Just 23 languages dominate among these 7,097, and are spoken by over half of the world's population. As these statistics show, the

oundtrack of our lives and the visual landscapes of our cities are multilingual. Languages, in their plurality, enrich our experience of the world nd our creative potential. Multi lingualism opens up new ways of being and of doing, it connects us with others and provides a window into the diversity of our societies. And yet, despite the more positive statistics above, we are currently witnessing a deep divide.

On the one hand, multilingualism associated with mobility, productivity and knowledge creation (see, for instance, the EU's objective for all citizens to speak two languages in addition to their first one). On the other, monolingualism (speaking only one language) is still perreived as both the norm and the ideal for an allegedly well-functioning society. Linguistic diversity is seen as both suspicious and costly. LINGUISTIC PENALTIES

This is particularly visible in relation to the most vulnerable groups seeking a new home: refugees and asvlum seekers. Newcomers are often required to prove they can read, write and speak the national language/s to be given the right to remain. Fluency, however, goes beyond technical ability in the majority languages. In



language is more than just a code by access to power structures.

Language skills are critically important for engagement with a host society and lacking those skills can be an insurmountable barrier for accessing opportunities in education, work. and other areas of social life. Success in finding one's place in a new social context, however, requires more than instrumental use of language.

Research has shown that refugees pay a "linguistic penalty" when transitioning to a new socioeconomic environment. That penalty refers to the consequences of being categorised as "different" or not "one of us" on the basis of language performance that does not follow established societal norms

Speakers who inadvertently break societal rules of expected behaviour are assessed as "not having enough language", which becomes a proxy for an inability to "fit in". That inability, in turn, is interpreted as a moral deficiency: lack of fluency becomes a sign of insufficient desire to become "one of us" and marks the migrant as both a "failed" and a "bad" citizen.

longing, becomes a gatekeeper for inwhich we communicate, it is related clusion/exclusion, regulating access are perceived as problems or costs. citizenship and education, health and legal protection. The responsibility for success or failure falls firmly on the shoulders of the "other" - the migrant, the minority member, the one who "does not fit in". This process is clearly visible in citizenship and language tests. The tests blur language assessment with reproducing and assessing abstract values about the home society. They take a narrow approach to cultural diversity and represent one hegemonic set of "ways of doing things around here".

**DEFICIT APPROACH** 

The myth of one nation, one (national) language, one (national) culture which was at the heart of the ideal of the nation state in the 19th and 20th centuries - perpetuates the master narrative of national homogeneity. The consistent and robust evidence that "native speakers" (a political term in its own right) fail citizenship tests and that the evaluation process is deeply political has not yet produced an alternative narrative.

By projecting a deficit approach onto refugees and asylum seekers, their contribution to society is dis-

missed and both their presence and the linguistic diversity attached to it a hierarchy in which not all languages are equal or desirable.

"Their" language(s) are low on the pecking order that the majority perceive as needed or wanted. Monolingual models insist on a "subtractive" principle in which one dominant language replaces another less "desirable" one, rather than recognising and valuing how multilingualism, by adding the ability to communicate in more than one language, can benefit everyone in our increasingly connected world.

These attitudes silence the contributions that new multilingual citizens make to economic growth, social cohesion or artistic production. A different approach is urgently needed, one that moves away from multilingualism as deficit and towards a recognition of linguistic and cultural diversity as a creative engine of civic participation and social well-being.

### Arunachal govt to not accept recommendations to grant PRC to 6 communities: Rijiju

New Delhi, Feb 24 (PTI): Amidst violent protests in Arunachal Pradesh, Union minister Kiren Rijiju said Sunday the state government has decided to not accept the recommendations of a high-level committee to grant permanent resident certificates to six communities, and blamed the Congress for "instigating" a section of people.

In separate tweets, Rijiju said the Arunachal Pradesh government has passed an order to not accept the recommendations of the Joint High-Powered Committee to grant PRC to six communities living in Namsai and Changlang districts.

Widespread violence has been reported in the state capital Itanagar and other places, leading to the death of at least two persons, injury to several and destruction of properties and vehicles.

The central government has dispatched 1,000 paramilitary personnel to the state to help the administration in maintaining law and order.

"Evervone must come together without blaming each other for the sake of peace. It's very unfortunate that innocent lives were lost in the violence." Rijiju, who hails from Arunachal Pradesh, said.

The Union minister of



state for home accused the Congress of "instigating" people of the state to protest against the move to grant permanent resident certificates to six communities.

Rijiju said Chief Minister Pema Khandu has clarified that the state government was not bringing the bill on PRC but only tabling the report of the Nabam Rebia-led committee consisting of members and student organisations.

"It means the state government has not accepted it. In fact. Congress Party is fighting for PRC but instigating people wrongly," he said.

Rebia is a cabinet minister in the state government.

Rijiju alleged that the Congress has supported and "instigat-

non-Arunachal Pradesh STs in Lekang area to fight for PRC but "misguided" innocent people in Itanagar.

"From the beginning I have strongly urged the state government not to grant PRC unless people are convinced of full protection of indigenous rights. We must stand united," he said.

People in some parts of Arunachal Pradesh have been protesting after the state government announced that it was considering issuing permanent resident certificates (PRC) to six non-Arunachal Pradesh Scheduled (APSTs) communities living in the Namsai and Changlang districts and to the Gorkhas living in Vijaynagar.

# The Vanishing Knowledge

Human health is a complex phenomenon which is often defined as a state of physiological and psychological wellbeing. Numerous factors like the socioeconomic, environmental, biological and cultural factors affect human health at different levels i.e. both in physiological as well as psychological levels.

In other words, health can be defined as the absence of diseases/illness.

When we talk about health and illness, it is very important to understand how different communities perceive health and illness based on their cultural beliefs and practices. Before the introduction of modern medicine and healthcare practices, almost every community relied exclusively on traditional healing practices which are basically nature and ritual-based. Now, looking at the present scenario modern healthcare practices have taken over the traditional systems and along with it the knowledge about those traditional healthcare practices is slowly fading away.

This article is an attempt to showcase the factors leading towards the decline of traditional healthcare knowledge and practices.

was always fascinated by traditional healers and often wondered how they healed simply by beating the patient with a clutch of grass and the smell of herbs which was in fact my first experience of encountering a traditional healer. It was measles for which I had already visited the doctor and was taking medication but the fever got worse and the next thing I remember was a healer performing rituals and beating me with grass and later giving me something to eat. I had little idea of what was going on but was doing everything as directed perhaps because all I wanted was to get better and after an hour or two I started feeling better as well. I do not know whether it was the medicine from the doctor that worked or the herbs I was made to eat and smell or both but the situation I want to fo $cus\,on\,to\,is\,the\,first\,step\,taken\,to$ cure my illness.

Nowadays, everyone prefers modern medicine over traditional healing yet one will always opt for an alternate solution if the former

modern medicine that was preferred first despite the availability of a traditional healer, but during my fieldwork I came across many cases where traditional healers were preferred over modern healing methods which again had many reasons. Firstly, socioeconomic conditions play a vital role in determining preference for a healing method. When asked, patients simply said that the convenient fee made local traditional healers the preferred choice. Another reason is the obligatory reason which is the lack of modern medical facilities or difficulty to avail the same. One of the main reasons is however the belief system of the people towards traditional healing. As mentioned earlier that influence of modern medicine is a recent case, many people have not deviated from their faith in traditional healing which have been in practice since ages.

The things mentioned above are from the patient's perspective.

Now, when traditional healers are asked about challenges they are facing despite acquiring such vast knowledge about healing, they came up with some valid points, one of the important fac tors being the lack of recognition from the concerned authorities because of that the validation of their knowledge is always in question. Since the knowledge they acquire is totally based on oral traditions and experiences, it is obvious for some to have doubts. The decline of traditional healing and healers is also because the younger generation is not sensitised about it and as a result they are not interested in learning. Another reason is tha traditional healing does not earn enough for the practitioners and as such they want their children to opt for something better. One of the healers who is an expert in healing fractures said that it takes a lifetime for a healer to learn about the medicines and experiment those on themselves before recommending it to patients hence they want that knowledge to be kept within a few people mostly their families so that it can be a mode of earning for livelihood for them. Since their medicines are found in the forests and also because they need to grow

doesn't work. In my case, it was some themselves, manual labour is also a barrier for elderly healers who can no longer dwell in the woods or work in the fields. In recent years, it is also seen that many people buy medicinal plants from the villages in bulk which has left the healers without access to the required medicinal plants themselves. There are multiple issues which are leading to a decline in the ancient knowledge which is now drifting away in the winds of ignorance.

It is time to think of a solution to safeguard such a valuable treasure which, if it is not taken care of will turn to ashes along with the healers. As a researcher, and also based on my understanding, I think it is important to listen to their voices before taking further steps. In a sense, instead of plucking a flower and placing it in a golden vase, it is better to nurture the whole plant which will last longer and bear seeds. What we do for them based on our understanding and what they actually need are two important things which should match. Policy makers should understand that it is not only to raise the living standard of the people but also keeping safe the knowledge which should be passed down. ne younger generation be sensitised regarding the importance of such things so that they become interested in acquiring the knowledge. There should be a proper channel and platform created for them so that they do not have to think twice before sharing their knowledge. Their knowledge should be their shield and not an

obligatory choice for them. I believe we have somehow been very ignorant and failed to acknowledge such people who hold such abundant knowledge about nature and healing. But it is never too late as long as the ship is in harbour. It is not that one should totally stop using modern medical facilities and opt for traditional healing, but the alternate should be looked after as well. Sometimes, even though we have choices the alternate choice is the only choice we are left with so keeping it safe may be something we can do before being left with no choice.

# Messi hits 50th hat trick to give Barca 4-2 win at Sevilla

Just when Barcelona was at its worst, Lionel Messi gave one of his best performances of the season.

Messi scored his 50th hat trick for club and country on Saturday in a 4-2 victory at Sevilla, helping Barcelona to take a big step toward retaining the Spanish league title.

Sevilla went ahead twice, but Messi hit back each time before he netted a third goal with five minutes remaining.

After taking his league-leading tally to 25 goals, Messi added an assist for Luis Suarez to round off the win before the whistle.

It was Messi's 44th hat trick for Barcelona, to go with another six for Argentina, according to the club.

"This doesn't mean the league is ours yet. There is a long way to go, but it was very important to win here to protect the advantage we have over our rivals," Messi said.

"The game turned against us but we knew how to pull it out."

Barcelona had drawn four of its previous five matches and its only goal in three games had been a penalty by Messi. A setback in Seville would have given Atletico Madrid and Real Madrid the



chance to spark up the title race when they play on Sunday.

Instead, Messi almost singlehandedly ensured Barcelona opened a 10-point gap over Atletico and a 12-point advantage over Madrid.

Barcelona also rediscovered its scoring form in time for a critical week of back-to-back clashes with Madrid.

in the second leg of their Copa del Rev semifinal on Wednesday after a 1-1 draw at Camp Nou, before clashing again in the league next weekend.

"We went through a patch when we weren't playing our best and that makes everything more difficult. We were having trouble converting our chances," Messi said.

Messi cancelled out 22nd-minute opener four minutes later with an exquisite volley, as the Argentine blasted Ivan Rakitic's cross into the top corner of the net.

Messi equalised a second time in the 67th after Rakitic recovered the ball, laid off for Ousmane

Barcelona's all-time top scorer alone on the edge of the area and he curled the ball into the corner.

Messi finally put Barcelona in charge when he nonchalantly chipped the ball over Vaclik.

"Not only did Messi score three great goals, it was how he scored them," said Barcelona coach Ernesto Valverde.

There was a lot at stake in this match. We weren't playing well and then he appeared. That is Messi."

Sevilla fell into fifth place, with Getafe moving up into the Champions League spots after beating Rayo Vallecano 2-1.

Defender Samuel Umtiti played his first match for Barcelona after being sidelined since late November with a left knee problem that has plagued him since helping France win the 2018 World Cup.

Umtiti, who played the full 90 minutes, has only made nine appearances for Barcelona this campaign.

In other results, sixthplace Alayes drew 0-0 with relegation-threatened Celta Vigo, while Athletic Bilbao won 1-0 against Eibar. Raul Garcia scored a first-minute goal for Athletic, which is up to eighth.


# Pakistan should be isolated like it happened with South Africa during apartheid: Vinod Rai

New Delhi, Feb 24 (PTI): Committee of Administrators chief Vinod Rai Sunday said the sporting community "needs to ostracise Pakistan" for fomenting terror activities just like South African was banned from international cricket due to the country's policy on apartheid. There had been calls

He cited the example of South Africa, which was banned for 21 years from 1970 till 1991 due to the apartAfricans were racially discriminated.

"I believe something similar needs to be done with Pakistan. They should be banned from all sporting activities just like it happened with South Africa," Rai said. The CoA chief also

# Fear and hoping: expectations surge ahead of new US-Taliban talks

KABUL, FEB 24 (AFP): The US and the Taliban are to meet in Qatar for fresh talks Monday seeking an end to 17 years of grinding conflict in Afghanistan, with the stakes ratcheting higher as the spring fighting season approaches.

Marathon talks held in Doha last month have stoked hopes of a breakthrough after the two sides walked away with a "draft framework" that included a Taliban commitment to prevent Afghanistan from once again becoming a safe haven for international terror groups.

It was the most substantial engagement by Washington with the militants since US forces ousted them from power in 2001.

But there is still no accord on a timetable for a US withdrawal or a ceasefire -- both major issues on which previous efforts have foundered.

This time Washington's special envoy Zalmay Khalilzad, who has spearheaded the months-long effort, is expected to face an expanded Taliban negotiating team headed by Sher Mohammad Abbas Stanikzai, the Taliban's former deputy minister of foreign affairs.

Neither side has stated how long they expect the meetings to last or the details of what will be discussed.

Analysts say this round will likely see the Taliban push for the



removal of its leaders from a UN travel blacklist, matched with pressure from the US for the militants to open a dialogue with the Afghan government.

"Both sides are going into this process with open minds and a sense of urgency as the weather gets warmer and fighting season draws closer," Graeme Smith, a consultant based with International Crisis Group, told AFP.

The Taliban have steadfastly refused to negotiate with Kabul, whom they dismiss as "puppets". They have also stated that, without a withdrawal timetable, further progress is "impossible'

# Pope compares child sex abuse to 'human sacrifice'



VATICAN CITY, FEB 24 (AFP): Pope Francis on Sunday compared the sexual abuse of children to human sacrifice as he addressed the Catholic Church's top bishops at the end of a landmark summit to tackle paedophilia.

"Our work has made us realise once again that the gravity of the scourge of the sexual abuse of minors is, and historically has been, a widespread phenomenon in all cultures and societies," he said.

"I am reminded of the cruel religious practice, once widespread in certain cultures, of sac- frequently children - in pagan rites," he added.

Francis was speaking after a four-day meeting which he had opened by calling for "concrete measures" on tackling priests and handing 114 senior bishops a roadmap to shape the debate on how to stop a global scandal.

"If in the Church there should emerge even a single case of abuse which already in itself represents an atrocity - that case will be faced with the utmost seriousness"

The ongoing scandals have hit countries around the world, with recent cases affecting Australia, Chile, Germany and the US.

Francis said those who priests who pray on children are "tools of Satan".

"No explanations suffice for these abuses involving children," the Argentine pontiff said.

"The echo of the silent cry of the little ones who, instead of finding in them fathers and spiritual guides encountered tormentors, will shake hearts dulled by hypocrisy and by power.

"It is our duty to pay close heed to this silent, choked cry," he added.

### Iran launches cruise missile from submarine during drill



Tehran, Feb 24 (AP): Iran says it has launched a cruise missile from a submarine for the first time during an ongoing annual military drill in the Strait of Hormuz.

The semi-official Fars news agency reported the launch on Sunday and released an image showing a green submarine on the surface of the water launching an orange missile. It says other submarines have the same capability.

Iran frequently touts its military arsenal, much of which is manufactured locally because of international sanctions. The Strait of Hormuz, at the mouth of the Persian Gulf, is a crucial bottleneck for global energy supplies, with about a third of all oil traded by sea passing through it.

Tensions have risen since the US withdrew from Iran's 2015 nuclear agreement with world powers and restored wide-ranging sanctions.

WASHINGTON, FEB 24 (AP): Former Trump campaign chairman Paul Manafort committed crimes that cut to "the heart of the criminal justice system" and over the years deceived everyone from bookkeepers and banks to federal prosecutors and his own lawyers, according to a sentencing memo filed by special counsel Robert Mueller's office. In the memo, submitted Saturday in one of two criminal cases Manafort faces, prosecutors do not vet take a position on how much prison time he should serve or whether to stack the punishment on top of a separate sentence he will soon receive in a Virginia prosecution.

But they do depict Manafort as a longtime and unrepentant criminal who committed "bold" crimes, including under the spotlight of his role as campaign chairman and later while on bail, and who does not deserve any leniency.

"For over a decade. Manafort repeatedly and brazenly violated the law," prosecutors wrote. "His crimes continued up through the time he was

first indicted in October 2017 and remarkably went unabated even after indictment." Citing Manafort's lies to the FBI, several government agencies and his own lawyer, prosecutors said that "upon release from jail, Manafort presents a grave risk of recidivism."

The 25-page memo, filed in federal court in Washington, is likely the last major filing by prosecutors as Manafort heads into his sentencing hearings next month and as Mueller's investigation approaches a conclusion. Manafort, who has been jailed for months and turns 70 in April, will have a chance to file his own sentencing recommendation next week.

He and his longtime business partner, Rick Gates, were the first two people indicted in the special counsel's investigation. Overall, Mueller has produced charges against 34 individuals. including six former Trump aides, and three companies.


Manafort's case has played out in stark contrast to those of other defendants in the Russia investigation, such as former national security adviser Michael Flynn, who prosecutors praised for his cooperation and left open the possibility of no jail time.

Manafort guilty to two counts of conspiracy arising from his Ukrainian political consulting work and his efforts to tamper with witnesses. As part of that plea, he agreed to cooperate with Mueller's team, a move that could have helped him avoid a longer prison sentence.

But within weeks, prosecutors say he repeatedly lied to investigators, including about his interactions with Konstantin Kilimnik, a business associate who the U.S. says has ties to intelligence. Russian That deception voided the plea deal.

sentencing memo comes as Manafort, who led Donald Trump's 2016 campaign for several critical months, is already facing the possibility of spending the rest of his life in prison in a separate tax and bank fraud case in Virginia. Mueller's team endorsed a sentence of between 19.5 and 24.5 years in prison in that case.
