Afghan woman news anchor barred from work after Taliban takeover

KABUL, 19 AUG [AFP]: An Afghan woman journalist has said she was barred from working at her TV station after the Taliban took control of the country, and pleaded for help in a video posted online.

Wearing a hijab and showing her office card, well-known news anchor Shabnam Dawran said "our lives are under threat" in the clip on social media.

Under the Taliban's regime from 1996 to 2001, women were excluded from public life, girls could not attend school, entertainment was banned and brutal punishments were imposed.

Female journalists have also been targeted by the militants in a wave of assassinations in recent months leading up to their takeover of the country.

However, since seizing power in a lightning offensive the Taliban have claimed women will have rights, including to education and work, and that the media will be independent and free.

One Taliban official even sat down for a oneon-one interview with a woman journalist on TV to press the point.

But Dawran, who has worked as a journalist for six years in Afghanistan for state-owned broadcaster RTA, said this week she was barred from entering her office while male colleagues were allowed in.

"I didn't give up after the change of system and went to attend my office, but unluckily I was not allowed despite showing my office card," she said in the video.

"The male employees, those with office cards were allowed to enter the office but I was told that I couldn't continue my duty because the system has been changed."

Dawran then pleads with viewers, saying: "Those who are listening to me, if the world hears me, then please help us as our lives are under threat."

Among those to share the footage was Miraqa Popal, an editor at Tolo News, a 24-hour channel in Afghanistan.

"Taliban didn't allow my ex-colleague here in @TOLOnews and famous anchor of the Stateowned @rtapashto Shabnam Dawran to start her work today," Popal wrote in a tweet on Wednesday that was shared thousands of times.

In a tweet on Tuesday, Popal posted a picture of a woman news presenter on Tolo, with the caption: "We resumed our broadcast with female anchors today."

Daily new cases below 100 and one more Covid death in Sikkim

The second wave has

■ been so brutal for Sikkim that every time the number of daily new cases falls below 100, it comes as a relief. And today was one of those days when the Daily Report of Covid-19 in Sikkim released by the Integrated Surveillance Disease Programme of the Health Department informed that 94 new cases were detected in the State in the past 24 hours. While new cases have dropped below 100 over the past two weeks, they have always done so on Mon-

days when the numbers

picked up on Sundays, when the testing labs screen much fewer samples, are released. Today was the first time in months that the number has fallen below 100 on a week day.

The 94 new cases were detected from the screening of 819 samples on Wednesday giving Sikkim a daily test positivity rate of 11.4%.

Unfortunately, State also lost one more life to Covid over the same 24 hours taking the state's COVID related death toll to 364. This new death was reported from STNM Hospital, Gangtok.

While 51 of the new

cases were detected in RT-PCR testing of 334 samples, 42 new cases were found in rapid antigen testing of 479 samples and one more person tested positive in TruNat testing of six

Of the 94 cases, 37 were registered in East District, 31 in West District, 21 in South District and 05 in North District. Sikkim's tally of the confirmed cases of COVID-19 has now reached 29,075.

samples.

With 146 more persons getting discharged from home and facility isolation on Thursday after making full recoveries, the number of recovered cases has also climbed to 26,626.

There are currently 1,806 active cases of Covid in the state, only 108 of whom have symptoms severe enough to require hospitalisation. Of these, ten were admitted to hospital in the past 24 hours and 12 are in ICU.

With the IDSP providing slightly more granular data now, it is also learnt that of the 108 Covid patients in hospital, five are under-18, all of whom were admitted yesterday.

The report also provides an update on COVID vaccination in the State and informs that 22,022 healthcare

dose and 10,259 second dose], 32,098 frontline workers [17,503 first dose and 14,595 second dose], 2,95,215 above-45 year olds [164,302 first dose and 130,913 second dose] and 318,758 people in the 18 to 45 age-group [311,922 first dose and 6,824 second dosel have received the Covishield vaccine in the State thus far.

Hamro Sikkim Party working president, Bhaichung Bhutia, has called it "unfortunate" that Chief Minister, PS Tamang did not raise the demand for Inner Line Permit for Sikkim during his recent Delhi tour.

"The Center invited

all the coalition leaders to meet the new cabinet and the Hon. Prime Minister. It is unfortunate that Mr Golay did not think of raising the demand for Inner Line Permit for Sikkim. The recent ONORC was a great bargaining point for him to demand the ILP. Most North East states having international borders already have the ILP in place and Assam being a BJP ruled state has not implemented the One Nation One Ration Card scheme due to heavy Bangladeshi Influx," Mr Bhutia states in a press release issued today.

"The CM has virtually given New Delhi the green signal for further dilution

of Article 371F in Sikkim if not now, then surely in the longer run," he alleges.

Setting the Stage for India's Gold Quest

The sight of our Prime Minister offering L choorma to Neeraj Chopra, ice-cream to PV Sindhu, laughing with BajrangPunia, telling Ravi Dahiya to laugh more and hearing the experiences of MirabaiChanu brought a smile on every Indian's face. What was equally encouraging was that he spent time with each and every athlete who took part at Tokyo Olympics. The next day, he interacted with the Paralympic contingent, discussing their inspiring life journeys.

These gestures indicate a different side to NarendraModi - a person who is passionate about sports and a person willing to go the extra mile for India's athletes. Before the Tokyo Games began, NarendraModi held an extensive review meeting to take stock of our preparedness in Tokyo.

Those who have seen NarendraModi closely can vouch for the passion he personally has towards supporting a culture of sports and games among the youth. As CM of Gujarat, he began the KhelMahakumbh initiative which boosted grassroots level sports participation in a state that is not historically known for sporting excellence. There is also a method to which NarendraModi has supported sports and sportspersons, which would make me argue he is India's first and foremost 'Sportsperson's Prime Minister'!

A few days ago, a 2013 video went viral. In that video, NarendraModi was addressing a group of college students in Pune, where he lamented that India has a large and talented population as well as a history of sporting excellence but Olympic after Olympic we struggle to raise our medal count. He said that there is no reason a nation like ours should remain deprived of Olympic success. But, according to him, the issue was not the players but our inability to create the right supporting atmosphere whereby sports gets the support and dignity it merits. The women's and men's Hockey team has gone on record saying that the Prime Minister's phone calls after their defeats played a key role in boosting their morale. Back in 2019, when Neeraj Chopra suffered a grave injury, PM Modi wished him a speedy recovery, which was widely appreciated.

When it comes to sports, the Prime Min-

ister has understood the root of the problem University system can be transformed into - that sports generates much interest but when it comes to incentives and participation, there is a wide gap. When he remarked after meeting the Olympic winners, "Seeing the recent successes in sports, I am confident there will be a shift in parental attitude towards sports." There was both fact and optimism in this remark. When parents see India's medal count rising, one hopes

they will surely be more open to their children pursuing sports. But, more importantly when they see all arms of the Government, the corporate sector support our players, they will realise that sports makes for an attractive and honour-

able career.

Amongst the various ways we may further enhance India's sporting success is by looking at encouraging our states towards a 'One State - One Sport' outlook; they can prioritise one particular game or a few to promote (while not ignoring others) based on the available talent pool, natural interest, climatic conditions and available infrastructure in their region. Not only will this bring a focussed approach but also allow for optimum utilisation of existing resources in the state.

Further, we must also on-board corporate India to adopt 'One Sport - One Corporate'. Across the world, corporates are at the forefront in extending support to budding talent, building leagues, enhancing the fan experience, marketing as well as merchandising to enhance the financial kitty of players. The success of corporates with Cricket over the years is a case study to point. Additionally, the sponsorship pattern has transitioned from FMCG brands to new FinTech unicorns. This can be a win-win for players, corporates and the game itself.

Another important aspect to promote and amplify sports and talent acquisition in the country is by building a grassroots sporting culture. For this, it is imperative to expand the calendar of various games at the local, state and national level. India needs 'Regional Leagues' in every sport that will provide an opportunity for young athletes to hone their skills through the year at various levels, build a competitive spirit as well as enhance the sports ecosystem and infrastructure in the country. I also believe our an oasis for Olympic excellence.

These measures will fill the gap between interest and participation going forward.

One of the things that has helped Indian sports is the emphasis on quality and global standards. The conventional route was bureaucratic and tiresome; this has changed in Modi government, where even the Prime

Minister prefers to directly receive feedback from the players themselves. While meeting the Tokyo 2020 contingent, he asked them to keep sharing their views on ways to strengthen sporting infrastructure. Be it Mirabai or Mary Kom, the PM has personally ensured they got the best treatment during their injuries.

One of the other issues impacting Indian sports is (ironically) the rise of modern technology. NarendraModi has addressed this in his book 'Exam Warriors' and also during his 'ParikshaPeCharcha' Townhallprogrammes. He talked about giving as much importance to the playing field and the play station. Modi has not dismissed the advent of modern technology. He has sought a healthy balance where the human elements of sports- teamwork, togetherness are maintained. Furthermore, the National Education Policy also consists of mechanisms that will make sports education an attractive option. In the years to come Manipur will get India's first sports university, which will be a boon to athletes and specially harness the rich sporting legacy in the Northeast.

Tokyo 2020 was an Olympics of many firsts for India. We won our first Gold in athletics, the Hockey team did wonders and there were successes in other sports such as discus throw, golf, fencing, etc. The Target Olympic Podium Scheme, Khelo India and the Fit India Campaign have laid the foundations for greater success. New India has fire in their belly; our sports carry the full support of the government and Prime Minister in their quest for sporting excellence.

Awareness prog held on energy efficient appliance loan

An awareness programme on energy conservation and energy efficient appliance loan, organized by the Department of Powerin collaboration with SISCO Bank under the aegis of Bureau of Energy Efficiency (BEE), Ministry of Power, was held at the District Administrative Centre, Rabdentse, today.

The programme was led by SE Cum Nodal Officer SDA (State Designated Agency), Pemba Lepcha along with AGM/ SISCO Bank, Smt. AnujaPradhan; DE (State Designated Agency), Smt. SigrathaPradhan and JE (State Designated Agency), Miss NawangChoden Lepcha.

The main aim of the programme was to generate awareness and sensitize the gathering regarding energy conservation & energy efficient appliance loan and to make general power consumers aware of importance of energy conservation, as it is a matter of fact that 65% of existing power generation is through fossil fuel which is a non-renewable energy which is causing pollution in the environment so it is all about consuming power judicially.

Addressing the house, Pemba Lepcha briefed about the Energy Conservation Act, 2001 and informed that the Act is enacted all over India. He also briefed about the State Energy Conservation Fund and urged the use of heating appliances in a disciplined manner. He stated that by reducing specific energy consumption, people should be made aware of their responsibilities.

He informed that SDA (State Designated Agency) Sikkim has signed an MoU with SISCO bank for disbursement of loan for which maximum of Rupees 1 lakh will be provided to the potential loanee to purchase energy efficient electrical appliances with 5 stars label product i.e., Refrigerator, AC, Geyser, TVs, Laptops, Microwave, Washing Machine etc.

Further, he informed about the energy conservation loan schemes and said that the Group C and D category (Regular) employees can avail the benefit. Additionally, he mentioned that interested people may contact nearby SISCO Bank.

The total 36 EMI will be deducted by SISCO bank with 0% interest. States preparing for next Covid wave with focus on children

MUMBAI, 19 AUG [RE-**UTERS**]: Several states are building facilities with more paediatric beds, plus oxygen, due to concern that children returning to school without being vaccinated will be among the most vulnerable during a third wave of coronavirus infections.

Health administrators have taken heed of trends in the United States, where a record number of children have been hospitalised as the coronavirus Delta variant, first detected in India, has surged through unvaccinated popula-

During the second wave of infections in India that peaked in April and May, hundreds of thousands of people died for want of oxygen and medical facilities, and now there are concerns that another third wave will gather during the

winter months.

"We don't know how the virus will behave, but we cannot afford to be unprepared this time around," Suhas Prabhu, who heads the Paediatric Task Force in Maharashtra, said.

"No mother should have to run around looking for a hospital bed when her child is sick."

The Maharashtra government has stockpiled medicines and built facilities for additional pediatric beds and oxygen provisions in new centres in Mumbai and Aurangabad.

Built on empty stretches of land or in repurposed stadiums, the Mumbai facilities have a total of 1,500 pediatric beds, most of them with oxygen.

"We can upgrade this capacity to double if needed," Suresh Kakani, a senior official with Mumbai's civic body said.

About history lessons, again... because history tends to repeat itself

I istory, they say is written by the victor who Π decides which aspects of the vanquished history suits his greater plans and which bits are best left untold or nudged into the domain of myths and fantasy. The same has held true for the history taught in schools in India. The curriculum is embarrassingly North India-centric, so much so that even though students learn by rote the names of all those who made it emperor in the Slave Dynasty, ask them about what the northeast was up to in the meantime and they draw a blank. It is accepted that prior to the advent of the East India Company, there was no concept called India as a single country. The region was a collection of empires, kingdoms and princely states; each with its own intrigues and their own histories. That said, the subcontinent did share a common culture, one evidence of which is how the religious geographies were not limited to state boundaries and myths, music, fashion, language and food habits were shared and intermingled.

Returning to the theme, the history we learn in school is actually the composite histories of the areas which came together to form the Union of India in 1947 and later? Well, not really. The focus is too limited to the areas which either the British researched well or were studied in detail by later day historians. Only the histories of areas which were on the ascendent in the 19th century and since are taught. Take a close look at the number of MPs each state has and the number of pages devoted to those areas in books teaching Indian History in schools will be directly proportional to that number. But that's not history. In fact, in the hands of the Right Wingers, history is even being distorted into fiction and chauvinistic re-imaginings. Unfortunately, even these distortions are limited to a region which is only one part of the country.

Before moving further, it is important to make clear why we study history at all. The main reason is to get a better understanding of where we belong - where we fit into the larger scheme of things. There has been much talk about making Sikkim join the mainstream which is why it is not enough to just study Sikkimese history in schools in Sikkim. Sikkim needs to figure in the history books studied elsewhere in the country. In junior school (even in Sikkim), students learn of what Confucius meant to China even before they are taught when and how Sikkim joined India. Ask a child, even in Sikkim, which dynasty ruled Sikkim and chances are that you will get the wrong answer. One is not suggesting going parochial here, but Sikkim does have a history that's worth learning. Few dynasties have ruled for the three hundred years that the Namgyal dynasty has to its credit. The British rule which hogs the history books lasted less than a hundred years and stretched 200 years if we include the East India Company's real interference in affairs of kingdoms here. Surely the British intrigues with Tibet should make for interesting reading as should the Gorkha adventures in Sikkim under those who followed after Prithvi Narayan Shah. If kids can learn of the distant Great Wall of China, why can't the story of the Lepcha tower of pots be told to them? There are some who might argue that most of what is passed off as Sikkimese history is actually myth. Well, it will remain so till some keener study is conducted on it and shared more widely at all levels of comprehension.

Why I no longer think we can eliminate COVID - public health expert

round the world, countries are having to strike Aa balance between COVID-19 cases and restrictions. In the UK and the US, daily new cases number in the thousands, but restrictions and limitations are being lifted. In contrast, New Zealand has started a short national lockdown to contain just a

For the past 20 months, New Zealand, Australia and several other east Asian countries have pursued tough policies aiming to completely eradicate COVID-19. The hallmarks of these "zero COVID" approaches are strict border controls and quarantine arrangements as well as the early introduction of lockdowns when discovering cases.

So far they've helped minimise infections and deaths. The economic impacts experienced by countries adopting these approaches have also been less severe than those who have not. New Zealand has said it intends to continue its COV-ID-19 eradication strategy indefinitely.

Is this sustainable? In an ideal world, completely eliminating COVID-19 is what all countries would aim to do, and earlier on in the pandemic I supported this strategy. But now the pandemic has evolved, the approach makes less sense.

AN IMPOSSIBLE DREAM?

Many countries now have high levels of the virus circulating and aren't aiming to eradicate it. And it's unlikely countries with few infections, such as New Zealand or Australia, can continue to keep COVID-19 at bay indefinitely in a world where the virus circulates.

There will always be the risk of importation by infected travellers from other regions. And in a globalised world, isolating a country from most others long term would likely be too costly and unpopular to maintain. Plus, it requires a degree of luck. Vietnam, Thailand and South Korea, once cited as zero COVID success stories, have struggled to contain the virus when it's been imported despite various border controls being in place.

The fact that the virus is mutating may explain why they've found it harder to keep it at bay. The virus is becoming better at spreading in humans.

transmissible than the original virus that emerged in late 2019, and delta around 50% more transmissible than alpha. The more infectious the virus becomes, the more that has to be done to enforce suppression.

There are other factors to consider too. The virus can infect both domestic and wild animals. If humans give the virus to animals, such that new viral reservoirs are created, then the virus could then potentially spill back into humans after being suppressed.

On top of this, a large proportion of human infections are asymptomatic. These infections are difficult to detect early and so are likely to spread. Both factors raise the likelihood of COVID-19 being reintroduced at some point - unless high levels of restrictions in zero COVID countries persist.

But how long will people continue to support a zero COVID approach if it means periodically entering lockdown to handle a small numbers of cases? In Australia, people appear to be growing tired of repeated restrictions, especially as the virus seems to be taking hold anyway. Trust in the government's COVID-19 response is waning and stress is building. That said, support is still there for New Zealand's strict approach.

THE ROLE OF VACCINES

An important counterpoint is that countries such as Australia and New Zealand still have low vaccine coverage. Relaxing current policies may see the virus spread quickly and cause large amounts of disruption, illness and death that could be avoided.

And although zero COVID policies are costly, one thing this pandemic has taught us is that in the short term, adopting a stringent approach leads to the least damage to the health and wealth of societies. In countries with low levels of infection and low vaccine coverage, there's a very good case for continuing with maximum suppression

But it's less clear what the optimal long-term solution is. The virus has yet to settle into its ecological niche, so it's unclear what behaviours it will eventually fall into. There are several possible outcomes, and they depend on to what degree vaccines block people from catching and spreading the

The alpha variant is around 50% to 100% more virus, as opposed to simply stopping them from getting ill.

> If vaccines protect well enough against infection, and enough of the population is vaccinated, then cases should subside to low levels. It may then be possible to achieve eradication of COVID-19 across much of the world through immunisation, much like measles. There will remain the risk of the virus being reintroduced from areas where cases are higher or of the virus persisting in unvaccinated groups - which is how measles behaves today.

> However, it's not known how long vaccine protection lasts, and substantial inequity in global vaccine distribution is a significant barrier to widespread suppression of COVID-19. Increasingly, the view of public health experts is that reaching population-level immunity is unachievable at the present time.

> The other possibility is that vaccines do not sufficiently block the spread of infection. In this scenario, the virus would continue to circulate, but with severe disease, hospitalisations and deaths reduced. We would see periodic outbreaks and probably seasonal epidemics, similar to flu. This is the more likely scenario. The focus then would be less on trying to stop the spread of infection and more on protecting vulnerable individuals through immunisation.

> Accepting that COVID-19 will become endemic - as many already are - and preparing for that eventuality may be the only realistic endgame strategy for all countries. As such, countries with low levels of infection and immunity, like Australia and New Zealand, should urgently immunise their populations. This is key if they want to avoid the considerable COVID-19 mortality and morbidity seen in Europe and the Americas.

> But once this is done, continuing with recurrent lockdowns could be both socioeconomically disruptive and challenging to maintain public support for. Together with the virus being more transmissible, the near impossibility of having completely closed off borders long term, and the fact that other countries aren't pursuing zero COVID, these factors likely will make completely eliminating the virus unachievable.

Warrior, servant, mother, unifier – the Virgin Mary has played many roles through the centuries

In a recent article in the Jesuit magalacksquare zine "America," author Whitney Bauck pointed out that the Virgin Mary has become "an icon for pop stars and social justice warriors."

Visitors to the website of designer Brenda Equihua, for example, will find outerwear with a colorful image of Mary displayed on the back. These coats feature prominently in the closets of numerous celebrities. The Puerto Rican singer Bad Bunny wears one in his "Cuidao por Ahí" music video," and rappers Lil Nas X and Shelley FKA DRAM, among others, have likewise been spotted wearing theirs in various settings. Equihua keeps a full list of such appearances on her website.

While Mary may be enjoying renewed popularity as of late, this is not the first time she has been "in the spotlight." In fact, because of the enormous and consistent impact that she has had on both Christians and some non-Christians for nearly 2,000 years, it's difficult to conceive of a time in which Mary wasn't a prominent figure.

As a scholar of early Christian literature who has done extensive research on traditions about Mary, I argue that the early interest in Mary came from her role as mother of Jesus, and that ancient authors transformed her into a sort of mythological figure by putting special emphasis on her virginity.

But others also came to emphasize Mary as an important character in her own right. For nearly 2,000 years, different Christian groups have understood Mary in various ways: as a servant, a warrior, an advocate, a leader, an exemplar, or as some combination of these.

MARY THE MOTHER

The four New Testament Gospels - Matthew, Mark, Luke and John – are the earliest sources that mention Mary.

She is a minor character in Matthew, and never speaks, even at the time of Jesus' birth. She has a slightly more pronounced role in Luke, which is the only other New

Testament Gospel that mentions The Greek historian Plutarch makes the birth of Jesus. In Luke, she talks with an angel, visits a family member and speaks words of prophecy. She also visits Jerusalem on two occasions: once for a purification ritual in the temple, and a second time to celebrate Passover.

In Mark, she seeks out Jesus while he is preaching, and she is also mentioned in passing by people in Jesus' hometown. The first of these scenes also appears in Matthew and Luke.

Finally, she appears twice in the Gospel of John. The first is at a wedding where the wine has run out. and the second is at Jesus' crucifixion, where she stands nearby while

Apart from one fleeting reference to her in the Book of Acts, Mary appears nowhere else in the New Testament.

Because Jesus is the chief focus of the New Testament Gospels, it is not surprising that they contain so few biographical details about Mary. She is present as a supporting character because she was integral to how these ancient authors thought about her son. The fact that Jesus has a mother, for example, reminds readers that Jesus was, at a basic level, a human being.

MARY THE VIRGIN

The Gospel authors also use Mary to stress that Jesus was a particularly noteworthy person.

Matthew and Luke accomplish this by "mythologizing" the story of his birth, by emphasizing that Mary was a virgin when he was conceived, and that her pregnancy was of divine origin rather than the result of human sexual activity.

The theme of the virgin mother impregnated by a god is not uncommon in the ancient world, and early readers of Matthew and Luke would have understood Mary's pregnancy in the context of other well-known stories of "divine children" born to virgin mothers.

The Roman poet Ovid, for example, writes that the mythical hero Perseus was born from a divine-human relationship between the god Zeus and Perseus' mother Danaë.

a similar claim about Romulus and Remus, the legendary twins whose virgin mother Rhea Silvia insisted that her pregnancy was the result of divine intercourse with Ares, the god of war.

Because Matthew and Luke use Mary's purported virginity in order to make claims about what they see as the importance of her offspring, this detail is only important for them until Jesus is born. Matthew, for example, alludes to the consummation of Mary and Joseph's marriage after Jesus' birth when he writes that "[Joseph] had no marital relations with [Mary] until she had borne a son."

By contrast, some later, Christian authors highlight Mary's virginity as something that defines her even after Jesus' birth. In the latesecond century, for example, an anonymous Christian author wrote an influential collection of stories about Mary's birth and early life. This text is known to scholars today as the "Proto-Gospel of James," and in it, Mary remains a virgin even after Jesus is born.

The Proto-Gospel is important for how scholars understand Mary for a number of reasons. Not least of those is that it evidences an early fascination with Mary not only as the mother of Jesus, but as an important character in her own right. Jesus is a character in this text, but he is a relatively minor one, appearing only toward the end. The author's primary focus is the life of the Virgin.

MARY THE MIRROR

Like so many biblical characters, the way that a group understands Mary has much to do with how that group understands itself.

On one level, this plays out clearly in artistic representations of Mary. In the Basilica of Saint Mary Major in Rome, for example, fifthcentury mosaics portray Mary as a noble woman dressed in Roman imperial clothing, which reflects the historical context in which these mosaics were made.

On the other side of the world, in Mexico City, is the famous 16th-

century icon of Mary known as Our Lady of Guadalupe. According to legend, Mary appeared in 1531 to an Aztec man named Juan Diego, and she left this image of her imprinted on his cloak. Visitors to Our Lady of Guadalupe will note Mary's darker complexion, which is indicative of the icon's Spanish-Mexican context. Historically, it has been a powerful and unifying symbol of Mexican identity.

A more recent example is the artist Ben Wildflower and his popular woodcut of Mary, in which she clenches her raised fist and stomps on a serpent while surrounded by the words "Fill the hungry. Lift the lowly. Cast down the mighty. Send the rich away." When asked about Mary's presence in his art, Wildflower commented: "Mary is who I want to be in the world."

This phenomenon is at work also in the values that are imposed on Mary, and which sometimes seem at odds with one another. Mary has been upheld both as an exemplar for motherhood, for example, but also as a model for a more strictly ascetic, virginal life.

Her temperament is another detail that frequently shifts according to context. Mary is hailed by some Catholics as "Queen of Peace" and is frequently upheld as a paragon of free submission to the divine will. Yet, there are also medieval manuscript illustrations that show her in a more active and perhaps even violent role, punching and wrestling with demons.

Drawing from this image of the seemingly "violent" virgin, some online retailers have begun to sell merchandise featuring the slogan "Hail Mary, full of grace, punch the devil in the face."

As I see it, she will no doubt continue to fascinate in both new and familiar ways for years to come.

Bengal post-poll violence: CBI, special team to probe cases, says court

The BJP had alleged that after the Trinamool's sweeping victory its goons attacked women members, killed workers, vandalised houses and looted shops and offices belonging to party members

Kolkata: Allegations of rape, murder and crimes against women after the Bengal election will be probed by the Central Bureau of Investigation, or CBI, the Calcutta High Court said Thursday afternoon.

Other criminal cases related to the post-poll violence, will be investigated by a special Bengal Police team led by SumanBalaSahoo, an IPS officer of DG rank, and include Kolkata Police Commissioner Soumen-Mitra and senior officer Ranbir Kumar. The court will track the SIT's prog-

Both teams have been directed to submit reports in six weeks.

A five-member bench headed by acting Chief Justice Rajesh Bindal ruled on petitions seeking an impartial probe into the post-poll vio-

The Trinamool has expressed its unhappiness over the judgement, with LokSabha MP Saugata Roy quoted by news agency ANI as saying



the Bengal government could "appeal to a higher court". "I'm unhappy with verdict. If in every law and order matter, which is entirely within a state's jurisdiction, the CBI comes... it is transgression of the state's right. I'm sure the (Bengal) state government will judge the situation and take a decision to appeal to a higher court, if necessary," he said.

The BJP, however, has welcomed the court's decision, with Union Minister Anurag Thakur being quoted by ANI as saying that "there is no place for violence in a democracy".

The court had earlier directed the National Human Rights Commission. or NHRC, to carry out a preliminary inquiry.

Last month the court,

in its strongest remarks so far, told the state government it was in "denial mode", and that the NHRC's interim report indicated enough evidence to establish postpoll violence.

The report proved to be hugely controversial because it indicted Chief Minister Mamata Banerjee and her government, and accused them of "appalling apathy". It also backed a CBI probe into "grievous offences like murder and rape", and called for such cases to be tried outside Bengal.

The NHRC claimed the situation then was a "manifestation of law of ruler instead of rule of law", and that "local police has been grossly derelict, if not complicit, in this violence"; it said

police failed to file FIRs for alleged rape and murder cases.

The incendiary report did not go unanswered; Ms Banerjee lashed out at the NHRC for "disrespecting the court" and pursuing the "political vendetta" of the BJP by leaking its report.

"The BJP is now using impartial agencies to settle political scores and malign our state. NHRC should have respected the court. Instead of leaking findings to the media, it should have first submitted the same to the court," she said.

The NHRC, however, denied Ms Banerjee's charge that its report was leaked, and pointed out that the report was available with "all concerned parties as per directives

of the court". The Bengal government had urged the High Court to "disregard the contents of the entire report" as it "does not depict the true and correct picture".

In a detailed affidavit submitted last month, the government also claimed several members of the NHRC panel were linked to the BJP.

The BJP has accused the Trinamool of unleashing its thugs to kill party workers, attack women members, vandalise houses, and loot shops and offices belonging to its leaders.

The Bengal government hit back saying reports were greatly exaggerated, with fake videos and images circulated to create incorrect narratives.

"We have been able to reach out to community elders; headmen, civil society and build trust and so we are able to relax the curfew. We have ordered a judicial inquiry on the killing of the former militant leader. People sometime don't realise the effort police puts in to maintain peace and security," said Conrad Sangma. Other members who were part of the meeting with the Chief Minister on Wednesday said the buck stops with him.

"It is time that the Chief Minister show that he has the capability to lead the state," said MarbudDkhar, part of delegation that met the Chief Minister. The opposition, too, has targeted the Chief Minister. "Even before the probe (has begun), the Chief Minister is defending the police, this is not acceptable," said leader of the opposition DrMukulSangma.

Ruins of Ancient Temple found in Bhargavi River bed in Odisha

four-member The four-member team of the Rediscover Lost Heritage, which is currently listing the archaeological monuments of the Ratnachira Valley, found the ruins near the mouth of the Bhargavi river in Balanga area, 31 km from Puri city.

Bhubaneswar: A heripossible ruins of an ancient temple of 13-14th century Common Era in Odisha'sPuri district.

The four-member team of the Rediscover Lost Heritage, which is currently listing the archaeological monuments of the Ratnachira Valley, found the ruins near the mouth of the Bhargavi river in Balanga area, 31 km from Puri city.

Project coordinator Deepak Navak said the remains of the ancient temple were found scattered, both inside the river bed and the surrounding areas. The temple may date back to 13th-14th century Common Era or earlier, considering the iconography of the antiquities, MrNayak said in a release.

Many of the blocks have also been carted away by the villagers for construction. A stairway from the river bed to the steep bank has around carved ancient temple blocks, it stated. According to team leader Anil Dhir, the Ratnachira Valley is a treasure house of many archaeological wonders, most of them being obscure and unbeen documented.

Legend has it that Lord Rama had drawn the Ratnachirariver to

quench Sita's thirst, using her pearl ring to chart its course. The ancient river, which now runs dry for most of the year, has many myths and legends with flourishing heritage on both sides of its short stretch.

The team found broken images, pillars, door tage research group team jambs and a multitude of on Thursday claimed that minor broken artifacts. it had stumbled upon the They also discovered carved stone panels, some of which have been affixed in the sides of the nearby Akhandalamani temple, which was made about a century ago.

"We came across an intricately carved lintel section of a broken door jamb. The central figure is a beautiful Goddess Gajalaxmi image," MrNayak said.

"Nagakanya ages were seen in many carved stone blocks, besides a lot of fine filigree work of the older temple," he added.

The team discovered that there was a large cluster of blocks in the middle of the river that appears to be the foundation of the ancient temple, according to the statement. There are hundreds of huge sunken stone slabs documented on the bank, possibly once used in the temple's construction.

Some of the stone slabs two dozen of these -- sandstone and laterite -- have consistent and identical holes on both their sides, suggesting the use of iron clamping. Many were damaged and ruined by machinery used for sand mining, it added.

"Considering known as they have not bulky size of the stone slabs, one can imagine it was not a small temple but a mid-sized or bigger temple," MrDhir said.

Naomi Osaka tested by Gauff, wins 3-setter in tour return

MASON, OHIO (AP): Two days after a thoughtful exchange with a local sports columnist, Naomi Osaka delivered a more relevant statement on the court.

She's back.

Down a set and a break to 17-year-old Coco Gauff, the secondranked Osaka fought back to pull out a 4-6, 6-3, 6-4 win at the Western & Southern Open on Wednesday, her first WTA Tour event since the French Open in late May.

Osaka appreciated being tested so quickly.

"It's definitely been a while since I played a tough opponent in a three-set match," she said. "It was definitely really tough, but I feel really good right now. I'm super excited to play another match." Citing discomfort with postmatch news conferences, the four-time Grand Slam champion withdrew from Roland Garros and skipped Wimbledon. She was eliminated in the round of 16 at the Tokyo Olympics after lighting the Olympic cauldron in her native Japan.

The 23-year-old Osaka is outspoken on many social issues and announced during Monday's pre-match media session that she would be donating her tournament prize money to earthquake-ravaged Hai-



ti, her father's homeland. Cincinnati Enquirer columnist Paul Daugherty asked how she balanced her discomfort with news conferences and her need to speak out.

Osaka paused in thought and, declining the moderator's suggestion to move on from the topic, asked Daugherty to repeat the question. She responded with what the writer later described as the best answer he's ever heard in 34 years of covering sports.

"Um, I mean, for me, I feel like this is something that I can't — I can't really speak for everybody," she said. "I can only speak for myself, but ever since I was younger, I have had a lot of media interest on me, and I think it's because of my background as well as, you know, how I play, because in the first place, I'm a tennis player.

"That's why a lot of people are interested in me, so I would say in that regard, I'm quite different to a lot of people, and I can't really help that there are some things that I tweet or some things that I say that kind of create a lot of news articles or things like that, and I know it's because I have won a couple of Grand Slams, and I have gotten to do a

The CM honoured Chopra by presenting him a shawl, a memento and the holy book Shrimad Bhagavad Gita.



MADRID (AP): As Barcelona continues adjusting to life without Lionel Messi, Antoine Griezmann gets his best chance yet to take a leading role at the Catalan club.

Griezmann will be making his 101st appearance with Barcelona when the club visits Athletic Bilbao in the second round of the Spanish league on Saturday. The French striker finally has the opportunity to take center stage and become a protagonist in Messi's absence.

"I hope I get to play another 100 games and carry on giving everything to make history with this club," Griezmann said. "I want to keep helping the team both on and off the pitch, in attack and defense, and enjoying being at Barça."

He had some key performances while Messi was still on the team but has never fully met the high expectations that came when he signed from Atlético Madrid for 120 million euros (now \$140 million) in 2019, a year after he was the man of the match in the World Cup final won by France.

30-year-old The Griezmann, who has 35 goals with Barcelona, used to play a secondary role even to Luis Suárez and youngsters such as OusmaneDembélé and AnsuFati. At times, he wasn't even a regular starter and had few minutes off the bench.

Now he has the competition of Barcelona's biggest offseason signing, Dutch international Memphis Depay, but coach Ronald Koeman has already hinted they will not be fighting against each other for a starting spot. Koeman said after the preseason that he "liked the connection" between Griez-



mann and Depay.

Both played well in the team's 4-2 opening victory against Real Sociedad, which marked the start of Barcelona's first season without Messi after 17 years. The Argentina star joined Paris Saint-Germain after Barcelona failed to give him a new contract because of its financial struggles.

Other forwards for Barcelona this season include Sergio Aguero and Martin Braithwaite, who scored twice against Sociedad.

"It was very important to get a win," said Griezmann, who is 14 goals from equaling Thierry Henry as the club's highest scoring Frenchman. "It was a good game and hopefully we can now get another win against Athletic."

Indonesian police arrest elephant poacher, ivory buyers

BANDA ACEH, INDONESIA 300 meters (1,000 feet) it to four buyers in Aceh (AP): Indonesian police say they have arrested an elephant poacher in Aceh province along with four people who bought ivory from an animal he killed.

The elephant was found without its head on July 11 at a palm plantation in East Aceh, police said. Local police worked with the Aceh Natural Resource Conservation Center to investigate the death.

"The team found indications that the elephant had been given poison before it was killed. The team also found the elephant's head without its tusks

away," East Aceh Police Chief EkoWidiantoro told reporters Thursday.

Police arrested a suspect on Aug. 10 who admitted he had tried to kill elephants five times since 2017 by poisoning them, but had succeeded only twice, including the recent death, Widiantoro said. On July 19, he and a partner poisoned mangos near a herd of wild elephants and executed a weakened elephant two hours later with an axe, he told police. The partner is still

on the run. The suspect said he sold the ivory to someone in East Aceh, who sold and West Java provinces. The last buyer, a craftsman in West Java, made the ivory into a dagger and cigarette pipe, Widiantoro said.

All of the buyers were arrested and are being held at East Aceh police station along with the poacher, he said. They face up to five years in prison and a fine of 100 million rupiah (\$7,000) if found guilty.

In the last seven years, 46 dead elephants have been found in Aceh, Indonesia's westernmost province. Many were attributed to illegal hunting and conflicts with humans.

Hezbollah says Iranian fuel tanker to sail to Lebanon soo BEIRUT (AP): The lea

Lebanon soon
BEIRUT (AP): The leader of the Iran-backed
Hezbollah militant group
said Thursday that an
Iranian fuel tanker will
sail toward Lebanon
"within hours," warning Israel and the United
States not to intercept it.

The delivery organized by Lebanon-based Hezbollah, would be an apparent violation of U.S. sanctions imposed on Tehran after former U.S. President Donald Trump pulled his country out of a nuclear deal between Iran and world powers three years ago.

Sayyed Hassan Nasrallah said in a televised speech that the tanker, carrying diesel fuel, will be followed by others to help ease Lebanon's crippling fuel shortage that has paralyzed the country for weeks.

Nasrallah did not say how Lebanon will pay for the fuel but in a previous speech he said Tehran could be paid in Lebanese pounds. The currency has lost more than 90% of its value since the country's economic crisis began in October 2019.

"I would like to say that at the moment the tanker sails — within hours — and moves in the sea, it will be considered in Lebanese territory," Nasrallah said. He said the West was imposing an undeclared siege on Lebanon, causing the current crisis.

Hezbollah and its allies accuse the U.S. and some Arab gulf nations of punishing Lebanon because of Hezbollah's military activities in other countries, including Syria and Iraq.

"I tell the Americans and the Israelis that this is Lebanese territory," Nasrallah said about the tanker, without elaborating on what his group will do if it is intercepted. Neighboring Syria has blamed Israel for mysterious attacks that have targeted oil tankers heading from Iran to Syria this past year.

For weeks, Lebanese have been waiting in long lines at petrol stations to fill their car tanks. Diesel shortages amid severe power cuts have shut down thousands of private generators, leading to shortages of bread. Some hospitals have warned that patients could die because of the diesel shortage.

The shortages are blamed on smuggling, hoarding and the cash-strapped government's inability to secure deliveries of imported fuel.

Lebanon has for decades suffered electricity cuts, partly because of widespread corruption and mismanagement. The Mediterranean nation of 6 million — including 1 million Syrian refugees — is near bankruptcy. The situation deteriorated dramatically last week after the central bank decided to end subsidies for fuel products. The decision will likely lead to a hike in the prices of almost all commodities in Lebanon.

Nasrallah said his group does not aim to "defy anyone," by arranging the fuel shipment from Iran, but added that "we cannot stand idle amid the humiliation of our people whether in front of bakeries, hospitals, gas stations and darkness at night."

Afghans protest Taliban in emerging challenge to their rule

KABUL, AFGHANISTAN (AP): Afghan protesters defied the Taliban for a second day Thursday, waving their national flag in scattered demonstrations that were met with renewed violence by the militants who are facing growing challenges to their rule.

A U.N. official warned of dire food shortages in this nation of 38 million people reliant on imports and experts said the country was severely short on cash, highlighting that the Taliban face the same problems as the civilian government they dethroned without the level of international aid it enjoyed.

In light of these challenges, the militants have moved quickly to suppress any dissent, despite their promises that they have become more moderate since they last imposed draconian rule on Afghanistan. Many fear the Taliban will succeed in erasing two decades of efforts to expand women's and human rights and remake the country.

On Thursday, a procession of cars and people near Kabul's airport carried long black, red and green banners in honor of the Afghan flag — a banner that is becoming a symbol of defiance since the militants have their own flag. At another protest in Nangarhar province, video posted online showed one demonstrator with a gunshot wound bleeding, as onlookers tried to carry him away.

In Khost province, Taliban authorities instituted a 24-hour curfew Thursday after violently breaking up another protest, according to information obtained by journalists monitoring from abroad. The militants did not immediately acknowledge the demonstration or the curfew.

Protesters also took the streets in Kunar province, according to witnesses and social media videos that lined up with reporting by The Associated Press.

The demonstrations — which come as Afghans mark the Independence Day holiday



that commemorates the 1919 treaty that ended British rule — were a remarkable show of defiance after the insurgents violently dispersed a protest Wednesday. At that rally, in the eastern city of Jalalabad, demonstrators lowered the Taliban's flag and replace it with Afghanistan's tricolor. At least one person was killed.

Meanwhile, opposition figures gathering in the last area of the country not under Taliban rule talked of launching an armed resistance under the banner of the Northern Alliance, which allied with the U.S. during the 2001 invasion.

It was not clear how serious a threat they posed given that the militants overran nearly the entire country in a matter of days with little resistance from Afghan forces.

The Taliban so far have offered no specifics on how they will lead, other than to say they will be guided by Shariah, or Islamic, law. They are in talks with senior officials of previous Afghan governments. But they face an increasingly precarious situation.

"A humanitarian crisis

of incredible proportions is unfolding before our eyes," warned Mary Ellen McGroarty, the head of the U.N.'s World Food Program in Afghanistan. Beyond the difficulties of importing food, she said that drought has seen over 40% of the country's crop lost. Many who fled the Taliban advance now live in parks and open spaces in Kabul.

"This is really Afghanistan's hour of greatest need, and we urge the international community to stand by the Afghan people at this time," she said.

Hafiz Ahmad, a shopkeeper in Kabul, said some food has flowed into the capital, but prices have gone up. He hesitated to pass those costs onto his customers but said he had to.

"It is better to have it," he said. "If there were nothing, then that would be even worse."

Two of Afghanistan's key border crossings with Pakistan, Torkham near Jalalabad and Chaman near Spin Boldak, are now open for trade. Hundreds of trucks have passed through, Pakistani Interior Minister Sheikh Rashid Ahmed has said. However, traders still fear insecurity on the roads and confusion over customs duties that could push them to price their goods higher.

Amid that uncertainty and concerns that the Taliban will reimpose their brutal rule, which included largely confining women to their homes and holding public executions, many Afghans are trying to flee the country.

At Kabul's international airport, military evacuation flights continued, according to flight-tracking data. However, access to the airport remained difficult. On Thursday, Taliban militants fired into the air to try to control the crowds gathered at the airport's blast walls. Men, women and children fled. Fighter jets later roared overhead, but no airstrike accompanied their pass.

Overnight, President Joe Biden said that he was committed to keeping U.S. troops in Afghanistan until every American is evacuated, even if that means maintaining a military presence there beyond his Aug. 31 deadline for withdrawal.

Indirectly acknowledging the resistance they face, the Taliban on Thursday asked preachers to urge congregants to remain in the country and counter "negative propaganda" against them.

The Taliban have also urged people to return to work, but most government officials remain in hiding or are themselves attempting to flee. Questions remain over Afghanistan's \$9 billion in foreign reserves, the vast majority now apparently frozen in the U.S. The International Monetary Fund, meanwhile, said the militants for now would not be allowed to access loans or other resources.

The head of the country's Central Bank warned that the supply of physical U.S. dollars is "close to zero," which will batter the currency, the afghani, and raise the prices of much-needed food.

"The afghani has been defended by literally planeloads of US dollars landing in Kabul on a very regular basis, sometimes weekly," said Graeme Smith, a consultant researcher with the Overseas Development Institute. "If the Taliban don't get cash infusions soon to defend the afghani, I think there's a real risk of a currency devaluation that makes it hard to buy bread on the streets of Kabul for ordinary people."

Still, Smith, who has written a book on Afghanistan, said the Taliban likely won't ask for the same billions in international aid sought by the country's fallen civilian government — large portions of which were funneled off by corruption.

"You're much more likely to see the Taliban positioning themselves as sort of gate-keepers to the international community as opposed to coming begging for billions of dollars," he said.

That could limit the power of the international community's threat of sanctions.

There has been no armed opposition to the Taliban. But videos from the Panjshir Valley north of Kabul, a stronghold of the Northern Alliance militias that allied with the U.S. during the 2001 invasion of Afghanistan, appear to show potential opposition figures gathering there. That area is in the only province that has not fallen to the Taliban.

Those figures include members of the deposed government — Vice President AmrullahSaleh, who asserted on Twitter that he is the country's rightful president, and Defense Minister Gen. BismillahMohammadi — as well as Ahmad Massoud, the son of the slain Northern Alliance leader Ahmad Shah Massoud.

In an opinion piece published by The Washington Post, Massoud asked for weapons and aid to fight the Taliban.

"I write from the Panjshir Valley today, ready to follow in my father's footsteps, with mujahideen fighters who are prepared to once again take on the Taliban," he wrote.

Gulf Coast's beloved 'Redneck Riviera' now a virus hotspot

GULF SHORES, ALA. (AP): Tourists and servers alike dance atop tables and in the aisles at one restaurant on the "Redneck Riviera," a beloved stretch of towns along the northern Gulf Coast where beaches, bars and stores are packed. Yet just a few miles away, a hospital is running out of critical care beds, its rooms full of unvaccinated people fighting for their lives.

On maps that show virus "hot spots" in red, this part of the U.S. coast is glowing like a bad sunburn. And a summer of booming tourism that followed the lockdowns and travel restrictions of 2020 is making the turn toward fall with only a few signs of slowing down.

Health officials believe the spike is due to a combination of some of the nation's lowest vaccination rates, unabated tourism, a disregard for basic health precautions and the region's carefree lifestyle, all combining at a time when the mutated virus is more contagious than ever and conservative states are balking at new health restrictions.

On a recent afternoon, one shopper after another walked through the mouth of a giant, fake shark into a Gulf Shores souvenir shop. Mini-golf courses, bars, go-kart tracks, hotels and condominium towers were full. The National Shrimp Festival, which draws as many as 250,000 people to the Alabama coast, is set for October despite the COV-ID-19 explosion.

Inside The Hangout restaurant, where dancing on tables is encouraged, "Cotton Eye Joe" received a raucous reception from the largely unmasked customers.

"Where did you come from, where did you go? / Where did you come from, Cotton Eye Joe?" the speakers blared.

The revelry came as just 12 miles (19 kilometers) to the north, South Baldwin Regional Medical Center was treating more than three dozen COVID-19 patients, nearly 90% of whom weren't vaccinated, said spokesperson Taylor Lewis.

"After Memorial Day it was, 'Everything is back to normal, go to the beach, take off

your mask," said Dr. Bert Eichold, the chief public health official of Mobile County, just west of Gulf Shores. Mobile County's CO-VID-19 positivity rate has skyrocketed to nearly 30%, and the county has the most new cases in the state.

Lisa Hastings, a Louisiana native and nurse visiting the Alabama coast with her two sisters, looked at the situation in two ways. She was a little unsettled by the wide-open scene from a professional standpoint, but she also doesn't hold it against anyone who wants to get out and have fun, vaccinated or not.

"I think people are kind of over being afraid and so they've got to live their lives," said Hastings, who is vaccinated. Nearby, a tourist from Illinois railed that the pandemic is fake and vaccinations are just another method of government control.

Some have decided against both getting vaccinated and wearing face masks, choosing instead to party without precautions at places like the Flora-Bama, a massive beachfront bar on the Alabama-Florida line. There, bands play to big crowds fueled by alcoholic drinks including the sugary Bushwacker, a coastal favorite.

Lulu's, a popular Gulf Shores restaurant owned by Lucy Buffett, the sister of singer Jimmy Buffett, is among those that recently had to shut down for a week because the virus was racing through workers.

At The Dock, a beachfront restaurant that serves cold beer and seafood beside the public beach in Pensacola, Florida, manager Justin Smith said the tourist season has been busy and his staff has managed to stay healthy, at least so far. While more vaccinations could help, Smith said he'd never require his staff to get inoculated.

"I've been here 18 years. It ain'tgonna happen," he said.

Outbreaks caused by the coronavirus are threatening to overwhelm the region's health care system and traditions. Panama City Beach, Florida, cited the pandemic in canceling an annual country music festival

set for early September, and New Orleans has clamped down on mask-wearing and called off multiple events.

While urging people to get vaccinated, state leaders including Florida Gov. Ron DeSantis and Alabama Gov. Kay Ivey have resisted imposing new restrictions, even as hospital beds fill up. On Monday, officials said 1,560 patients needed intensive care treatment in Alabama, where hospitals have just 1,562 ICU beds.

Hospital executives joined together in Pensacola last week to plead for more vaccinations while also knocking down false rumors about vaccines and masks. In an area dominated by Christian conservatives, Mayor Grover C. Robinson IV made a direct appeal for churchgoers to get shots.

"Two of our hospitals are Christian affiliated," he said. "One of the first things it says all throughout the Bible is, 'Do not be afraid.""

More people are getting initial vaccine doses than a few weeks ago, but it hasn't been enough so far to stop the spread of CO-VID-19. Of 11 coastal counties in Mississippi, Alabama and Florida, Okaloosa County in Florida has the region's highest share of fully vaccinated residents at 41.3%, statistics show. Many are around one-third, and all are below the national average of nearly 51%.

Natalie Fox, a nursing executive with USA Health in Mobile, said medical workers are tired after more than a year of fighting the pandemic. Still, people sick with COVID-19 — the vast majority of them unvaccinated — keep arriving.

"We're kind of getting patients from all over because everybody's dealing with this increased strain," she said.

It didn't take a mandate for Rhonda Landrum, a 50-year-old health care worker from near Mobile, to get a shot recently after watching all three of her unvaccinated daughters contract COVID-19. People aren't taking the pandemic seriously, she said, and it's just not safe to be out in public without the vaccine.

The film, directed by SarthakDasgupta and co-written by Dasgupta and Gaurav Sharma, touches upon the issues of sexual violence, caste oppression, corruption, and legal loopholes through the eyes of 200 Dalit women.

Palekar, known for 1970s Hindi films

like Rajnigandha ,Chitchor Chhoti Si Baat, GolMaal, said producers usually shy away from such "disturbing" top-

The script of this film dealt with caste issues which have remained invisible in Indian cinema. Such themes are disturbing and not conventionally 'entertaining'. Producers have shied away from backing such projects all through our cinematic journey, Palekar told PTI in an email interview.

Caste issues have successfully featured in Marathi and Tamil cinema with films such as NagrajManjule's "Fandri" and "Sairat" and Pa Ranjith's "Kaala"

In Hindi mainstream cinema, caste has largely stayed invisible, barring NeerajGhaywan's "Masaan" and "Geeli-Pucchi", a short in the Netflix anthology film "AjeebDaastaans".

Palekar said the Hindi film industry still refuses to come out of "Brahminical aesthetics".
