ontractual employees of National Health Mission, Sikkim State AIDS Control Society and Ayush of Sikkim have unanimously decided to continue their pen-down strike until they received their regularisation orders.

Contractual employees of NHM, SSACS and Ayush from across the State have been on a pen-down strike since 01 February on the single-point demand of regularisation and have of late also been sitting on dharna everyday at the State Secretariat.

Speaking to media persons, a representative of contractual employees mentioned that following a collective decision, it

was decided that the ongoing peaceful pen-down strike and dharna at the Secretariat will continue until they receive their regularization orders.

larise all employees who

have served five or more years but has not given any written assurance so far.

He added that as per the department, the notification to this effect will come out on 15 February and the office memorandum on 22 February after which regularization orders will be handed over.

On the same, he asserted that the department should hand over the order on 15 February itself as there will many other processes to be completed.

He mentioned that another demand seeks entry level point for employees having service of less than five years. "We are still going on this issue and until this demand is fulfilled our pen-down strike will be continued," he said.

SC notices to Centre and State on LT seat demand

The Supreme Court I today issued notices seeking responses from the Union and Sikkim Government on seat reservation for Limboos and Tamangs in the Legislative Assembly by virtue of their having become Scheduled Tribes. The notices were issued following a petition filed by Adeep Tamang, Saman Prasad Subba Limboo, Surendra Moktan, Dhan Rup Limboo and Binod Yonzon, all reportedly members of the Sikkim Limboo-Tamang Tribal Joint Ac-

tion Committee. have ap-They proached the Supreme Court seeking its intervention for early resolution of seat reservation for Scheduled Tribes and for directions to the respondents to amend Section 7(1A) of the Representation of Peoples Act, 1950 and Section 5A of the Representation of Peoples Act, 1951 to provide for seat reservations

for the two communities. The division bench of Justice AK Sikri and Justice S Abdul Nazeer heard the petition today and directed that notice be issued directing the respondents viz. Home Ministry, Chief Secretary, Government of Sikkim; Delimitation Commission and Election Commission of India to file their responses to the said election writ petition within six weeks.

The petitioners have also sought that directions be issued to the Delimitation Commission to issue a final notification giving effect to the reservation in the Legislative Assembly Seats based on the 2011 census data.

According to the petition, as per Census 2011, there are 53,703 Limboos and and 37,696 Tamangs in Sikkim totaling 91,399 and constituting 15% of the population here. On this basis, the two two tribes are entitled to get 5 seats (15% of the 32 seats) in the Sikkim Legislative Assembly.

I-T sleuths unearth Rs 20,000-cr hawala, money laundering racket in Delhi

NEW DELHI, FEB 11 (PTI): The Income Tax Department on Monday claimed to have busted a nexus of hawala operators who were running a money laundering racket in the national capital estimated to be worth Rs 20,000 crore. Official sources in the department said a "series of" raids and surveys were conducted by sleuths of the Delhi investigation over the last few weeks in different business areas of old Delhi.

These operations led to unearthing of illegal financial activities by three groups of operators, a senior official said. A survey was con-

group in the Naya Bazar area, that led to the detection of bogus billing of about Rs 18,000 crore. This group had floated a dozen bogus entities for providing fake bills, the official said. The identities of the

accused were not disclosed by the department. In the second case, "highly organised" unit of the I-T Department money laundering racket has been unearthed where current transactions in well-known shares were fraudulently camouflaged as being sales of old shares held for years, the official said.

He said this way, the beneficiaries have been found claiming "bogus long-term capital gains." The taxman suspects

the magnitude of this purported scam to be over Rs 1,000 crore. "This figure appears

to be the tip of the ice berg. This modus operandi has been found to be going on for many years," the official said.

The department similarly conducted searches against a group and found "undisclosed foreign bank accounts and a well established racket of claiming bogus duty draw back/ GST through over-invoicing of exports."

Sikkim Democratic Front has lashed out against Bhaichung Bhutia and his Hamro Sikkim Party for issuing deceptive and baseless statements on Limboo-Tamang seat reservation issue.

Condemning it sees as Mr Bhutia's half-baked knowledge and blinkered politics. SDF points out that it was the consistent leadership of Chief Minister Pawan Chamling which had won ST status for the two communities after the demand had dragged since the 1970's.

An SDF press release issued by its general secretary, Kavita Subba, asserts that the SDF Government has already presented a scientific and historic proposal to reserve five seats for Limboos and Tamangs in the State Assembly to the Union Cabinet. This, while Mr Bhutia and other inimical to the LT seat issue at heart but supportive on surface have only protested every proposal but not offered any formula of their own, the release adds.

The ruling party has further stressed that Mr Bhutia, who has been giving immature statements since coming into Sikkim politics, should first study the division of powers between the State and the Centre.

Lord Ayyappa shrine is all set to reopen on Tuesday for monthly worship, after witnessing frenzied protests during the recently concluded annual pilgrim season over the entry of young women.

The hilltop temple would be opened for five days till February 17 for the monthly pujas during the Malayalam month of Kumbam, temple authorities said Monday. Several special rituals including 'kalabhabhishekam', 'sahasrakalasam' and 'laksharchana' would be performed during the five days at the shrine, the 'sanctum sanctorum' of which would be thrown open by chief priest Vasudevan Nampoothiri Tuesday evening.

Tantri (head priest) Kandararu Rajeevaru would also be present during the time of pujas, they said. As the shrine is set to open, state police has stepped up vigil in and around Sabarimala in view of possible protests by Sangh outfits against the entry of women, belonging to the traditionally barred age group. The police said certain restrictions had already been imposed in areas from Nilackal, the base camp to Sannidhanam (temple complex) to ensure smooth dar-

shan for devotees. "Considering the untoward incidents caused by various organisations in areas around Sabarimala when the shrine

THIRUVANANTHAPURAM, was opened for the Thu-**FEB 11 (PTI):** There is a lamasa puja and the prosense of anxiety in and tests over the Supreme around Sabarimala as the Court order allowing entry of women of all ages into the shrine, certain restrictions have been imposed in areas to ensure smooth darshan for devotees," an official release said.

Devotees and reporters would be allowed to travel from Nilackal to Pamba and Sannidhanam only after 10 am on February 12, it said.

The BJP and Sangh Parivar outfits, which had spearheaded the agitations against implementation of the September 28 Supreme Court verdict permitting women of all age groups into the shrine, are yet to reveal whether they would try to block young women. The areas in and around the hilltop shrine had witnessed widespread violence after the CPI(M)led LDF government decided to implement the apex court order allowing women of menstrual age into the temple.

Marking the culmination of the over twomonth-long stormy annual pilgrimage season, the Lord Ayyappa temple was closed on January 20. Traditionally, women of menstruating age or in the age group of 10 to 50 years were not allowed to enter the temple as the deity, Lord Ayyappa, is believed to be in the form of "Naishtika brahmachari" (perennial celibate).

Introduce Employers to the Resource Pool

Skills need introductions after they have been imparted

The skill development initiative of the State ■ Government has now been underway for quite some years. In fact, we now see this effort being replicated at the national level as well. Meanwhile, news about the homegrown skill development mission has visibly dwindled. The livelihood schools must still be functioning and imparting skills to the youth, but for such an exercise to bear real fruit, they need to be consistently promoted and publicized. That does not appear to be happening enough. By now, employment melas, events during which the courses on offer in the State and the human resource being created there are unveiled, should have become at least biannual events. Not events in which only employers open stalls, but also ones in which the livelihood schools showcase their graduates and mediate employment deals on their behalf. Don't do that, and the mission gets reduced to another bureaucratic routine which tries to make up with paperwork what it lacks by way of inspirational involvement.

Career Fairs are not a new concept, but they have become more about promoting more courses and uninteresting jobs than actually leading to careers. A proper one is long-awaited in Sikkim and pregnant with a lot of potential. To begin with, such events should make it worthwhile for all investors and private companies based in Sikkim to maintain a stall. These can be venues, which, even if they do not hand out hiring slips, offer opportunities for livelihood school managements to collect information on the nature and volume of jobs available there. This would help them plan their own course materials and intake capacities accordingly.

Job openings have definitely multiplied substantially in Sikkim in recent times, but one rarely sees employment notices to match the number of jobs being placed. Fact remains, that while private investments and new jobs have been created in Sikkim, the hiring practises still remain oldschool, the ranks filled through recommendations, contacts and by chance. Something like a proper employment mela. Career fair could begin the process to make the hiring process more professional and transparent; and this will be to the benefit of both, the job-seekers as well as the employers. It is important that every agency which employs people in Sikkim is allowed space at such events even if they have no immediate job-openings; they could inform potential employees about the profile of existing positions and the qualities and qualifications they seek whenever they hire next.

The next step for the State authorities would be to encourage private agencies in Sikkim to visit educational institutions [schools and colleges] and the 31 Livelihood Schools, not necessarily to hire a workforce from the campuses, but at least to introduce the young to their organisations and the kind of employment and emoluments they offer. The young can plan better that way and the units based in Sikkim will get a wider pool to choose from. This transparency will also reward merit more than contacts. One might contend that such an initiative does not require State involvement and can be initiated by the 'morally upright' investors themselves. What one ignores with such a projection is that educational institutions are impossibly bureaucratic and the only way that an attempt to inform the youth about prospects awaiting them locally can succeed is if the Government mediates.

What this concept of bringing the unemployed and the employers together at one venue also triggers is a parallel initiative in which the industrial and production units here and the local growers and suppliers are brought into direct contact. Supplies need not always be about raw materials for the industry, and can even be about supplies of basic and essential commodities for the workforce. Take for example, the substantial number of universities, pharma companies, schools and hostels in Sikkim, all of which at least have canteens and kitchen which need supplies which can be met by local growers and suppliers provided they know the exact nature of their requirements and have the time to plan ahead. Yes, they tender these requisitions, but a 'notice inviting tenders' works only for existing suppliers who are already in the business. Village self help groups and such bodies could deliver the goods just as well if they had enough lead time and information on what is required. What such interactive events also initiate is the first step forward in a process that gets increasingly more refined in its ability to introduce employers to the available resource pool and local entrepreneurs to opportunities.



Why stop at plastic bags and straws? The case for a global treaty banning most single-use plastics

Single-use plastics are a blessing and a curse. They have fueled a revolution in commercial and consumer convenience and improved hygiene standards, but also have saturated the world's coastlines and clogged landfills. By one estimate 79 percent of all plastic ever produced is now in a dump, a landfill or the environment, and only 9 percent has been recycled.

This growing legacy poses real risks. Plastic packaging is clogging city sewer systems, leading to flooding. Abandoned plastic goods create breeding grounds for mosquitoes, and can leach toxic additives such as styrene and benzene as they decompose. Single-use plastics are killing birds and harming marine life.

I study international environmental law with a focus on marine ecosystems. In my view, land-based pollution from single-use plastics is a slow-onset disaster that demands a global response.

One attractive strategy is pursuing a legally binding phase-out of most single-use plastics at the global level. I believe this approach makes sense because it would build on current national and municipal efforts to eliminate single-use packaging, and would create opportunities for new small and medium-sized businesses to develop more benign substitutes.

SINGLE-USE PLASTIC BANS

About 112 countries, states and cities around the world have already imposed bans on various single-use plastic goods. Of these measures, 57 are national and 25 are in Africa. And the list of these restrictions continues to grow.

Most of these bans target thin single-use plastic carrier bags or imports of non-biodegradable bags. Some, such as the one in Antigua-Barbuda, include other single-use or problematic items, such as foam coolers and plastic utensils. A few measures – notably, Kenya's plastic bag law – impose stiff punishments on violators, including jail time and fines of up to US\$38,000.

Groups of states are starting to enact regional policies. The East African Legislative Assembly has passed a bill to ban the manufacture, sale, import and use of certain plastic bags across its six member states, with a combined population of approximately 186 million people. And in October 2018 the European Union Parliament approved a ban on

a number of single-use plastic items by 2021, along with a requirement to reduce plastic in food packaging by 25 percent by 2025 and cut plastic content in cigarette filters 80 percent by 2030.

Most of these bans are quite new or still being implemented, so there is limited research on how well they work. However, researchers at the United Nations who have reviewed 60 "national bans and levies" estimate that 30 percent of these measures have reduced consumption of plastics.

Plastics manufacturers contend that better recycling is the most effective way to reduce the environmental impact of their products. But many factors make it hard to recycle plastic, from its physical characteristics to insufficient market demand for many types of recycled plastics. In many instances, single-use plastics can only be recycled, optimistically, 10 times before their fibers become too short to be reprocessed.

LESSONS FROM OTHER GLOBAL BANS

Several global bans and product phase-outs offer lessons for a treaty banning single-use plastic goods. The most successful case is the 1987 Montreal Protocol on Substances that Deplete the Ozone Layer. This treaty phased out production and use of chlorofluorocarbons in a variety of products, including refrigerators and spray cans, after they were shown to harm Earth's protective ozone layer.

Today scientists predict that stratospheric ozone concentrations will rebound to 1980 levels by the middle of this century. According to the Environmental Protection Agency, the Montreal Protocol has prevented millions of cases of skin cancer and cataracts from exposure to ultraviolet radiation. In 2016 nations adopted the Kigali Amendment, which will phase out production and use of hydrofluorocarbons, another class of ozone-depleting chemicals.

Why has the Montreal Protocol worked so well? One key factor is that every nation in the world has joined it. They did so because alternative materials were available to substitute for chlorofluorocarbons. The treaty also provided financial support to countries that needed help transitioning away from the banned substances.

Where countries trying to reduce use of these chemicals fell short of their goals, the Protocol provided institutional support rather than punishing them. But it also included the option to impose trade sanctions on nations that refused to cooperate.

Another pact, the 2001 Stockholm Convention on Persistent Organic Pollutants, banned or severely limited production and use of certain chemicals that threatened human and environmental health, including specific insecticides and industrial chemicals. Today 182 nations have signed the treaty. Concentrations of several dangerous POPs in the Arctic, where global air and water currents tend to concentrate them, have declined.

Nations have added new chemicals to the list and created "elimination networks" to help members phase out use of dangerous materials such as PCBs. And producers of goods such as semiconductors and carpets that use listed chemicals are working to develop new, safer processes.

Even though the United States has not signed the Stockholm Convention, U.S. companies have largely eliminated production of the chemicals that the treaty regulates. This shows that setting a global standard may encourage nations to conform in order to maintain access to global markets.

Other international bans have been less successful. In 1989, seeking to reduce the slaughter of elephants for their tusks, parties to the Convention in Trade of Endangered Species banned ivory sales by ending trade in African elephant parts. Initially demand for ivory fell, but in 1999 and 2008 treaty states allowed African nations to sell ivory stockpiles to Japan and China, ostensibly to fund conservation. These two sales reignited global demand for ivory and created unregulated domestic markets that stimulated high levels of poaching.

AN OPPORTUNITY TO LEAD

What lessons do these treaties offer for curbing plastic pollution? The Montreal Protocol shows that bans can work where substitute products are available, but require reliable monitoring and the threat of sanctions to deter cheating. The Stockholm Convention suggests that industries will innovate to meet global production challenges. And struggles to curb the ivory trade offer a cautionary message about allowing exceptions to global bans.

I believe the rapid spread of single-use plastic bans shows that enough political support exists to launch negotiations toward a global treaty. Emerging economies such as Kenya that are aggressively tackling the problem are especially well placed to take a lead at the U.N. General Assembly in calling for talks on stemming the tide of plastic pollution.

Routine blackouts in Haiti symbolize a loss of political power for its citizens

Haiti's public utility company just announced it's reducing output again. The move comes after a series of blackouts throughout the country, some lasting weeks. The power outages are the result of a weeks-long fuel shortage that has led to fuel rationing and gas station closures as reserves run dry.

Haiti is dependent on fuel imports, and the national electrical grid is small and inefficient. Haiti's already weak infrastructure has been damaged by a string of natural disasters. Yet, for many Haitians, blackouts are not just the result of the country's vulnerability; they are also a symbol of political crisis.

BLACKOUTS ROUTINE IN HAITI

Blackouts are expected occurrences in Haiti. When they inevitably happen, talk quickly turns to the government's inability to provide basic services.

Most electricity comes from the state-run provider, Electricité d'Haiti (EDH), which is seen as being poorly managed and corrupt. When the lights go out, as they invariably do, the problem of the lack of services is made abundantly visible.

Electricity is a charged political issue in Haiti. Only about 25 per cent of the population has access to elec-

tricity, and those who do rarely have it all day, every day. Private businesses and wealthy families rely on diesel generators for their shops and homes. Poor Haitians use wood, charcoal or kerosene.

Most governments have sought to expand access to energy sources and to subsidize their cost. Most recently, President Jovenel Moïse pledged to bring "24 hours around the clock" electrical service to Haiti within two years. Instead, he presides over a country wracked by chronic energy shortages.

THE POLITICS OF FUEL

The Caribbean has some of the highest utility rates in the world. In 2005, Venezuela launched Petrocaribe, an oil alliance designed to alleviate fuel costs and promote economic co-operation.

Under the plan, member states paid only 40 to 70 per cent of the price of fuel imports. The remainder was deferred, to be repaid over 25 years with an annual one per cent interest rate. Funds from fuel sales were to be spent on social development programs.

The current fuel shortage in Haiti is part of a larger story about the fallout from the crisis in Venezuela. In 2017, the Haitian Senate released a report claiming that \$1.7 billion from the Petrocaribe fund had been lost or stolen and that the program had racked up US\$2 billion in debt.

A just-released audit conducted by Haiti's Superior Court of Accounts and Administrative Disputes confirmed these claims and added that many of the development projects sponsored by Petrocaribe funds were never finished or never existed.

The Petrocaribe scandal and the energy crisis have both given rise to renewed calls to privatize Haiti's energy sector. Haiti has been forced to end its involvement in Petrocaribe; the country now buys its fuel from American providers, in U.S. dollars, continuing a long-standing program of American energy imperialism in the region.

If the new fuel prices imposed by the International Monetary Fund last year are any indication, privatization and liberalization of the energy sector in Haiti will make life more expensive for most people and make the country more dependent and more indebted to foreign powers.

It's a situation reminiscent of Puerto Rico, where debt and disaster have been leveraged to push through a series of neoliberal structural adjustment programs in the aftermath of Hurricane Maria.

LOSING POWER

In Haitian Kreyòl, the word for power outage is blakawout. It refers to the loss of electrical power but, like its English equivalent, can also be used to talk about a bodily condition. In Port-au-Prince, it is common to hear people talk about blackouts in a

number of ways.

Where we might say in English that a person can suffer a blackout, meaning a loss of consciousness, Haitians might say they are "living in a blackout," a phrase that speaks to a more generalized loss of physical and social energy.

Sometimes they refer to power outages to complain about the government and the lack of essential services. Other times blackouts provoke memories of repression by the Haitian military and paramilitary forces, who would often cut power to neighbourhoods before conducting violent raids.

Sometimes people say that when there is a blackout they simply "can't do anything" at all, as if the lack of light and electrical power is only the visible symptom of a more general condition — the loss of agency.

For many Haitians, blackouts do not just signal a political crisis — they also symbolize feelings of their loss of political power. In that sense, blackouts are not just the result of a weak government. They are a symptom of a deeper crisis of sovereignty as the Haitian people continue to struggle, still, for democracy, autonomy and self-determination.

Bihar registered fastest economic growth in 2017-18: Governor

PATNA, FEB 11 (PTI): Governor Lalji Tandon Monday said Bihar has registered the highest economic growth of 11.3 per cent in the country during 2017-18 and curbed crime to a great extent, thereby providing a better society for its citizens.

Addressing the Budget session of both Houses of Bihar Legislature, the governor quoted Central Statistical Organisation (CSO) figures to say that Bihar registered the highest economic growth rate of 11.3 per cent among the states in 2017-18 against the national growth rate of 7 per cent.

With a focus on development of infrastructure and ensuring better implementation of various schemes, the size of the state's budget has increased to Rs 1.77 lakh crore in 2018-19, which is 18 per cent more than the previous year, he said.

The states own tax revenue collections is expected to be around Rs 31,000 crore in 2018-19 against Rs 23,136 crore in 2017-18.

The governor also highlighted the governments priority on womens empowerment, "seven resolves" and prohibition -- the schemes and policies which have left a positive impact on peoples life.

Chief Minister Nitish Kumar. Deputy Chief Minister Sushil Kumar Modi, Leader of opposition in the Council Rabri Devi were present during the joint sitting held at the newly inaugurated central hall in the annexe building of the state legislature.

The governor was flanked by Speaker of Legislative Assembly Vijay Kumar Chaudhary and Acting Chairman of Legislative Council Haroon Rashid.

Monday was the first day of the 10-day Budget session.

The governor also referred to the latest National Crime Records Bureau (NCRB) data to show that Bihar is better placed among states in maintaining law and order situation.

As per the NCRB data, the number of cases relating to cognizable offences in Bihar is 157.4 against the national average of 233.6 per one lakh population.

Tandon said Bihar ranked 22nd among all states and union territories in terms of crime rate.

Police have been able to crack the cases lodged in major categories besides being able to ensure conviction in 3,650 cases that took place in 2018, he said and added that the state government is working to achieve population-police



ratio as per national standard for which it has been filling posts and making fresh recruitments.

Tandon said the government has adopted "zero tolerance policy" towards corruption and it has also attached top priority to establish rule of law and create a society free of fear.

He said the governments decision to reserve 50 per cent seats in panchayats, urban local bodies and teachers appointment for women is a step in the right direction.

The state government has also implemented 35 per cent quota for women in government jobs and in the recruitment of constables and sub-inspectors in police department. Tandon said that the government has introduced Mukhya Mantri Kanya Uthan Yojana for making girls self-reliant by providing them protection, education and health

The scheme takes care of a girl child right from her birth to graduation level by providing financial

The governor said power supply reached 5,139 MW in September 2018 against a meagre 700-800 MW in 2005.

He said the government successfully implemented prohibition which has become a "social movement". Meanwhile, Bihar's revenue surplus increased from Rs 6,441

crore in 2013-14 to Rs 14,823 crore in 2017-18. The state has been a revenue surplus state since 2007-2008, Deputy Chief Minister Sushil Kumar Modi, who also holds finance portfolio, said after tabling the 13th Economic Survey 2018-19 in the Assembly.

The surplus, projected to be Rs 21,312 crore during 2018-19, is considered to be the result of better financial management, Modi said adding that the surplus could be used for asset creation like roads, building etc.

The Gross Fiscal Deficit (GFD) of the state government went down from Rs 16,480 crore in 2016-17 to Rs 14,305 crore in 2017-18, which was 2.9 per cent of Gross State Domestic Product (GSDP) keeping it within the Fiscal Responsibility and Budget Management Act, the Deputy CM said.

The total revenue of the state government increased from Rs 68,919 crore in 2013-14 to Rs 1,17,447 crore in 2017-18, implying an increase of 70.4 per cent over a period of four years between 2013-14 to 2017-18.

The growth in agro-based industries in Bihar is 19.2 per cent which is almost five times the all India growth rate of 3.6 per cent, the minister said.

WASHINGTON, FEB 11 (AFP): Donald Trump pushed back Sunday at the suggestion he spends much of his work day taking it easy, as the White House kept up the hunt for the person behind an embarrassing leak of the president's schedule.

According to details published last week by Axios, 60 percent of Trump's work life is categorized as "executive time," meaning unstructured time to make phone calls, read newspapers, tweet and watch television.

Seeking to set the record straight, the president said such free time should be viewed as "positive, not negative."

"When the term Executive Time is used, I am generally working, not relaxing," Trump tweeted. "In fact, I probably work more hours than almost any past President.

"The fact is, when I took over as President, our Country was a mess," Trump continued.



Protests against the bill have rocked the entire northeast over the past six weeks, with several organizations and political parties claiming that the bill threatens the identity, language and culture of indigenous people.



McMillan said the conclusion of the showpiece tournament was the right time to move on after five years in the job, including helping New Zealand reach the final of the 2015 World Cup. "It's been a privilege to be able to work with the likes of Brendon McCullum, Kane Williamson and Ross Taylor day-in and day-out and to see the records they've accomplished has been very satisfying," he said.

McMillan, who played 55 Tests and 197 one-day internationals for the Black Caps, was given the role of batting mentor by former head coach Mike Hesson, who was replaced by Gary Stead last year. The 42-year-old said he would pursue other coaching opportunities after the World Cup but did not specify what they might be.

The tournament runs from May 30 to July 14 and New Zealand Cricket said McMillan's replacement would be announced before the team depart for a tour of Sri Lanka in August.

China rejects Turkey criticism on Uighurs, denies poet died

BEIJING, FEB 11 (AFP): China hit back on Monday at Turkish criticism over its treatment of Uighurs and denied Ankara's claim that a renowned poet from the Muslim minority had died in custody, calling it an "absurd lie". Turkey's foreign ministry had released a statement on Saturday severely criticising China's mass detentions of its Turkic-speaking Uighurs, and claiming that poet Abdurehim Heyit had died serving an eight-year Chinese prison sentence imposed as punishment over "one of his songs".

But China on Sunday released a video showing a man who identified himself as Heyit and saying

that he was alive and well. "China has made solemn representations toward Turkey. We hope the relevant Turkish persons can distinguish between right and wrong and correct their mistakes," Foreign Ministry spokeswoman Hua Chunying said during a daily press briefing.

She called the Turkish statement "vile" and urged Ankara to withdraw its "false accusations". "I saw his (Heyit's) video online yesterday, showing that he is not only alive but also very healthy," she said.

A UN panel of experts has said that nearly one million Uighurs and other Turkic-speaking minorities had been herded into "re-education camps" in China's northwestern Xinjiang region, where most of the country's more than 10 million Uighurs live. Turkey had said China's treatment of Uighurs was "a great embarrassment for humanity" -- perhaps the



vet from a Muslim country. The Muslim world has been conspicuously quiet on the Uighur issue, possibly to avoid Chinese diplomatic or economic retaliation.

The plight of China's Uighurs is closely followed in Turkey due to shared linguistic, cultural and religious links and the presence of tens of thousands of ethnic Uighurs there.

In its statement on Saturday, Turkey did not say how it had learned that Heyit died, but said the "tragedy has further reinforced the reaction of the Turkish public opinion towards (the) serious human rights violations" in Xinjiang.

PARIS, FEB 11 (AFP): Romania reached the Fed Cup semi-finals for the first time on Sunday with a 3-2 win over defending champions Czech Republic as Irina-Camelia Begu and Monica Niculescu stunned Wimbledon and French Open winners Barbora Krejcikova and Katerina Siniakova in a marathon doubles decider.

Begu and Niculescu triumphed 6-7 (2/7) 6-4 6-4 in a thrilling rubber in Ostrava which lasted just seven minutes short of three hours.

Krejcikova and Siniakova, the world's leading pair, trailed a break early in the final set before hitting back to 4-4. But the Romanian pair broke straight back for 5-4 before Begu, ranked at 35 in doubles, served out the tie.

The result ended the 10-time champions Czechs' hopes of making the Fed Cup semi-finals for an 11th successive year and represented their first home defeat in a decade.

Despite its brevity, the princess's foray into politics has electrified the political landscape of the country, as speculation over who wins and loses from her tilt ricochets across the kingdom.

It may face censure by election authorities that could ultimately see it dissolved, although it was not clear if any ban could be in place before the election takes place.

Thailand's generals have a penchant for coups, backroom plotting and factional struggles.

They have grabbed power 12 times since the end of absolute monarchy in 1932, including against existing juntas seen to have overstepped their mark.

Prayut has agreed to stand for premier after the election and is aided by an army-scripted constitution.

But critics say he has

presided over a remark-

personalised power and outstayed his welcome with a public wearied by his finger-jabbing style.

The king appointed a new army chief, Apirat Kongsompong, last year from a rival faction of the army to Prayut and his junta allies.

Recent days have seeded unease, with the first election in eight years now seemingly dependent on behind-thescenes power plays by the elite.

Meanwhile, the fate of Thai Raksa Chart hangs in the balance.

The party, a second to the Thaksin political powerhouse Pheu Thai, was expected to help the Shinawatra machine secure a majority in the 350-seat lower house.

But it is under intense pressure following its bid to bring in the princess.

"I think the party leader and board should take a responsibility by resigning," said Srisuwan Janya of the Association for the Protection of the Constitution, a royalist activist group, who submitted a petition to election authorities Monday calling for the party's censure.

Malaysia's Najib in last-ditch bid to delay trial

KUALA LUMPUR, FEB 11 (AFP): Malaysia's former prime minister Najib Razak was making a last-ditch bid Monday to delay the start of his trial over the 1MDB scandal, which contributed to his government's shock election defeat. Najib is due to go on trial Tuesday for the first time over allegations that he was involved in the looting of Malaysian sovereign wealth fund 1MDB in a fraud that stretched

around the world. Billions of dollars were allegedly stolen by Najib and his cronies from the fund, which was set up to help develop Malaysia's economy, and spent on everything from highend real estate to expensive artworks.

The scandal was a major factor in his long-ruling coalition's loss at polls in May. Since losing power, Najib has been arrested repeatedly and hit with a total of 42 charges linked to 1MDB. He has denied wrongdoing. The trial due to begin Tuesday is on seven charges related to allegations Najib pocketed 42 million ringgit (USD 10.3 million) from SRC International, a former unit of 1MDB.

But his lawyers have filed an application for the trial to be delayed pending an appeal on a technicality related to the transfer of charges between different courts. The Court of Appeal is

due to rule on the application later Monday.

It is just one of several trials Najib is expected to face over 1MDB and involves a fraction of the total purportedly stolen from the fund. But the start of the first trial will be a key moment, and may relieve pressure on the new government following criticism that it has been slow to act over 1MDB.

Far from keeping quiet, Najib has gone on a bizarre publicity blitz in recent weeks.

The United States see a friendly rapport with Bangladesh as vital to Washington's goal of an open, US-friendly Indo-Pacific region. Unlike neighbors such as Sri Lanka, Bangladesh has not drawn high-profile infrastructure deals with China.

Another country is even more critical to the US relationship with Bangladesh - regional power and emerging US ally India, which has staunchly supported Sheikh Hasina, limiting the scope for Washington to take another approach even if it so chose.
