India reports lowest daily rise in coronavirus cases since July 10

MUMBAI, 08 DEC (RE-**UTERS):** India reported 26,567 new coronavirus infections, data from the health ministry showed on Tuesday, the lowest daily increase since July 10, according to a Reuters tally.

Daily cases have been falling in India since hitting a peak in September. The country has 97 lakh cases, second-highest caseload in the world after the United States.

Deaths rose by 385, the health ministry said, with the total now at 140,958.

The number of active COVID-19 cas-Les in Sikkim rose by a slim 13 new cases to now stand at 363 on Tuesday. Of the 13 new cases, 11 were re-

ported from East Sikkim and one each from West and South districts. Meanwhile, the number of discharged

COVID-19 patients in the State further improved to 4,642 with the release of 21 more patients - one from hospital and 20 from home isolation on Monday.

That said, there are six patients currently in the ICU facility at the COVID-dedicated STNM Hospital.

Sikkim's tally of the confirmed cases of COVID-19 detected so far has now reached 5,215.

In the daily health bulletin on Tuesday, Health Department State IEC Officer, Sonam Gyaltsen Bhutia, informed that the 13 new cases were picked up from the testing of 251 samples yesterday.

The screening of 184 samples by RT-PCR at the VRD Lab returned 10 positive cases, while three new cases were detected in rapid antigen testing of 57 samples. All ten samples tested by TrueNat returned negative for COVID-19 yesterday.



Lead, Nickel found in blood of people with mystery illness in Andhra

HYDERABAD, 08 DEC [PTI]: Traces of lead and nickel were in the blood of the people who contracted the mystery illness in Andhra Pradesh's Eluru, doctors from the All-India Institute Medical Sciences have found. In all, 467 people have been found ailing since December 5, more than 45 children below the age of 12 are among them. All complained of convulsions, nausea and fainting. One person, a 45-year-old, has died.

Doctors have been trying to diagnose the illness, which struck parts of the town last week amid the Covid outbreak. A battery of teams from various medical organisations and hospitals are working to detect the

Today, a communique from the Chief Minister's Office said preliminary findings indicated the presence of lead and nickel in blood which could have caused the symptoms.

"More tests are being conducted by Indian Institute of Chemical Technology and other institutes and the results are expected soon," the Chief Minister's Office release said.

Chief Minister Jagan Mohan Reddy has told the authorities to "inquire on how lead and nickel particles could have got into the bodies of the people of that region and asked to conduct a detailed study and submit a report".

Mr Reddy has also asked the public health personnel and other departments to "probe the issue deeply and find out the reasons for the illness," the statement read.

What the authorities have pointed out is that the episodes of fits and fainting seem to happen only once. The source of water for different cases reported is not the same. Not more than one member per family has reported the symptoms. The disease does not seem to spread from person to person.

"Our earliest tests had ruled out heavy metals. Even organochlorine could cause these kinds of neurological symptoms," one source said.

Mr Reddy -- who visited the hospital in Eluru yesterday where 150odd patients are admitted -- met the Governor today to discuss the situation. After Governor Biswa Bhusan Harichandan's advise to take the help of Central institutes, teams were flown in from Delhi's AIIMS, the National Institute of Nutrition, the Indian Institute of Chemical Technology (IICT) and the Centre for Cellular and Molecular Biology.

The Chief Medical Officer of the state has said that the test reports should be compiled for analysis.

Aids and appliances for disabled distributed in South Sikkim

NAMCHI, 08 DEC [IPR]: A program for distribution of aids and appliances was organised by District Disability Rehabilitation Centre (DDRC) at DAC, Conference Hall, today.

The chief guest for the program was Additional Political Secretary, Anieeta Raialim who was accompanied by Joint Commissioner, MB Chettri, Assistant Commissioner, PN Pradhan, Social Welfare Officer (South), Nakul Rawat along with staff of the concerned department.

It may be mentioned here that this distribution program was held under the Scheme of Assistance to Disabled Persons for Purchase/ Fitting of Aids and Appliances (ADIP Scheme), Ministry of Social Justice and Empowerment.

Addressing, the gathering Chief Guest, Anjeeta Rajalim spoke about the aim of this program which is to distribute aids to the disabled and also to hear their suggestions as to how the concerned department and able bodied person can help the disabled. She added that it is extremely imperative for one and all to contribute in a substantial manner for the betterment of



the disabled people and highlighted that the Sikkim State Government has always looked after the difficulties faced by the disabled so that they

can live a dignified life. She also underlined state specific schemes like Chief Minister's Disability Pension Scheme and the recently announced cash incentive by the Chief Minister, PS Golay for differently-abled toppers of class X and XII board exams from 2021 onwards and informed that the Sikkim State Government will continue to prioritize the needs of the disabled in order to transform Sikkim to be truly inclusive in nature

Assistant Commissioner. PNPradhan briefed about District Disability Rehabilitation Centre which would provide rehabilitation support to persons with disabilities through surveys and identification of persons with disabilities and by other various outreach programs.

He updated that the population of disabled persons in Sikkim currently is 18,187 out of which 5,375 are in South Sikkim. He also informed about Unique Disability Identity (UDID) card and added that this card is valid throughout the country.

He further emphathat disabled sized persons in the district should be issued with Disability Certificates on priority and appraised that presently this certificate has been given to a total of 5,767 person in Sikkim out of which 1,355 Certificates has been distributed in the south district. Moreover, he notified about the various special schools running at present and some of them are Jawaharlal Nehru Institute for the Visual Impaired in Namchi, Speech and

Hearing Impaired in Sichev, Intellectual Disabilities in Burtuk and added that the department has consistently tried to give quality attention to these schools. Speaking, during the

program Social Welfare Officer, Nakul Rawat stated the Rights of Persons with Disabilities Act and other various kinds of Rights issued to the disabled persons as per the norms of the Government. He also underscored process and other documents required if any disabled persons has to get certificate or any financial assistance from the department. He pointed out that the department is putting its earnest efforts in assisting the disabled persons in providing accessible facilities.

During the course of the program various items were distributed namely Wheel Chair for adults and children, Walking Stick, Axilla Crutch, Daisy Player, Hearing Aid and Elbow Crutch and the beneficiaries included students and adults. An interaction session was also held wherein the beneficiaries put forth their suggestions to the concerned officials.

KOLKATA, DEC 8 (PTI): 8 to protest against the The TMC on Tuesday began its three-day-long sit-in demonstration against the new farm laws and demanded that the "anti-people" legislation should be withdrawn immediately. The farmers and agri-

cultural workers wing of the TMC, led by its state president and TMC MLA Becharam Manna, began its sit-in demonstration in front of the statue of Mahatma Gandhi in central Kolkata this after-

Party activists carrying placards and demanding the withdrawal of the new farm laws shouted slogans against the BJP government at the Centre.

"We support the issues raised by the farmers and will hold protest programmes and sit-in demonstrations. But we are against shutdowns and the bandh culture and will not enforce it in the state," Manna told reporters.

The ruling Trinamool Congress in West Bengal has decided to extend "moral support" to the nationwide strike called by farmers on December

new agriculture laws and will stage sit-ins in various parts of the state for three days, in solidarity with the farmers.

It will culminate with Chief Minister Mamata Banerjee's address at the protest programme on December 10.

The 'Bharat Bandh', called by agitating farmers' unions against the Centre's farm laws, partially affected the state with private vehicles remaining off the roads, while public transport, including buses and taxis, operating fewer than the usual.

Supporters of the Congress and Left parties on Tuesday blocked railway tracks at several places and held sit-ins on roads to enforce the nationwide shutdown, which evoked a mixed response in West Bengal.

Representatives of thousands of agitating farmers are sitting on various borders of the national capital since November 26 demanding repeal of the three agri laws.

6. Monitoring of counselling and treatments facilities in the districts.


7. Formulation of students clubs in colleges to discuss and spread awareness and revival of SAATHI programme. 8. Strict implementation of ban in

In Pursuit of Happiness

One way to address so many social ills haunting a land of such few material worries

nd no, this is not a moral science lesson. It will $m{\Lambda}$ however begin with reference to an international conference the State Government had organized several years back on "Science, Spirituality and Education" with the Dalai Lama as a special guest and speaker. The conference was motivated by a felt need to work on school curriculums in a way that would tease out more empathy and deeper engagements from students and deliver Sikkim the much-needed involved citizenry for the future.

The Dalai Lama had charmed the audience with his ready wit and open mind and set the conference on course by suggesting that the participants deliberate over how common sense, and not necessarily religious regimen, if harnessed with conscious empathy could deliver an education which inculcated moral ethics. Individual moral ethics, he stressed would link together to deliver genuine social empathy which would in turn manifest in more compassionate societies peopled with citizens with a stronger sense of universal responsibility and calmer dispositions. Strife and an unbridled pursuit of material acquisitions, whether at the individual or the nation-state level, have come to define the 21st century which has now almost made a virtue out of mercenary materialism. Proof of this faulty prioritization is apparent in how "happiness" is now increasingly being sought in acquisitions and not so much in the satisfaction derived from contributing to the world. While the former results in competition and hence conflict, the latter is a more personal experience which in not in competition with anyone else and hence does not lead to strife Also, as societies get more and more obsessive with acquiring more to be happy, they can also slip into depression when they cannot gather enough 'benefits'. Sikkim should understand this phenomenon well because it has to be accepted that apathy - that listless lack of interest and refusal to get excited or engage - underlines social response and engagement here.

This apathy does not necessarily stem from denial or oppression, but is born from an inferred sense of loss over not having acquired enough. Even as this manifests in listlessness in outward behaviour, internally, the mind is agitated and it is perhaps in this internal disquiet that Sikkim can find the reasons to explain the high suicide rates, addiction and other social challenges, including corruption and even the universal inurement towards dishonesty. Obviously, what has happened in Sikkim, as in societies across the world, is that the pursuit has been for a warped interpretation of happiness, one that is incomplete.

Sikkim requires to seek out answers on how to address the paradox of so many social ills haunting a land of such few material worries. Expecting solutions to be provided and executed by someone else or the government would doom the possible solutions to failure because social course-corrections require social engagement, not governmental or even divine interventions. To return to what the Dalai Lama has often said, Change depends on individual action. Divine intervention, he stresses. is fine so long as it was for individual consolation, but for change and betterment, it was individual action that is needed. This proactive engagement needs to be internalised by Sikkim at the individual, then community and governance levels. A generation groomed with a stronger sense of universal responsibility will also be one with a clearer sense of self and more importantly, with more respect for the aspirations and needs of others. That is the kind of generation which Sikkim needs to reach out for and chalk up as resolution for the New Year...

Refugees are at risk from dystopian 'smart border' technology

Tew technologies deployed on borders for mi $oldsymbol{IN}$ gration management and border security under the umbrella of smart border solutions are ignoring the fundamental human rights of migrants.

Unmanned aerial vehicles (drones, for example) are often deployed in the surveillance of refugees in the US and the EU; big data analytics are being used to monitor migrants approaching the border. Though methods of border security and management vary, a great deal are increasingly used to prevent migratory movements.

Artificial intelligence (AI) is an important component of migration management. For instance, the EU, the US and Canada invest in AI algorithms to automate decisions on asylum and visa applications and refugee resettlement. Meanwhile, the real-time data collected from migrants by various smart border and virtual wall solutions such as satellites, drones and sensors are assessed by AI algorithms on the border.

At the US-Mexico border, for example, the US Customs and Border Protection (CBP) agency is using artificial intelligence, military drones with facial recognition technologies, thermal imaging and fake cellphone towers to monitor migrants before they even reach the border. They can listen to conversations between migrants, try to identify them from their faces, check out their social media accounts and locate people trying to cross borders.

A new UN report has warned about the risks of so-called "smart" border technology on refugees in particular. These technologies are helping border agencies to stop and control the movement of migrants, securitise migration governance by treating migrants as criminals and ignore the fundamental rights of people to seek asylum. Furthermore, they collect all data without taking the consent of migrants - factors that in other circumstances would likely be criminal if deployed against citizens.


As researcher Roxana Akhmetova has written: "the automated decision-making processes can exacerbate pre-existing vulnerabilities by adding on risks such as bias, error, system failure and theft of data. All of which can result in greater harm to migrants and their families. A rejected claim formed on an erroneous basis can lead to persecution."

This is a good example of how algorithmic technology more generally can be influenced through the biases of its creators to discriminate against the lower classes of society and serve the privileged ones. In the case of refugees, people who have had

to flee their homes because of war are now being subjected to experiments with advanced technology that will increase the risks carried by this already vulnerable population.

DATA AND CONSENT

Another issue at stake here is the informed consent of refugees. This refers to the idea that refugees should understand the systems they are subvate partnerships and technical preparations for a long period of time before refugees encounter them on the ground. And at the end of all the processes to decide, fund and develop algorithms, recognition of the right of "beneficiaries" to reject these technologies is not realistic, nor is it practical. Therefore, most of these tech-based investments categorically undermine refugees' informed consent because the



jected to and should have the chance to opt out of them. While voluntary informed consent is a legal requirement, many academics and humanitarian NGOs focus on "meaningful informed consent" which is more than signing a paper and helping refugees to fully understand what they are subject to. Secret surveillance gives them no such chance. And the technologies involved are so complex that even the staff operating them have been said to lack the expertise to assess the ethical and practical implications.

Despite the recent UN report warning on the smart border solutions, many governments and various UN agencies dealing with refugees increasingly prefer to employ tech-based solutions, for example to assess people's claims for aid, cash transfer and identification. But what happens to people who are not willing to share their data, for any reason, be it political, religious or personal?


Use of these technologies requires public-pri-

nature of the work of those behind these decisions is to deny their rights.

Refugees can benefit from the increasing use of digital technology, as smartphones and social media can help them connect with humanitarian organisations and stay in touch with families back home. But ignoring the power imbalance created through their loss of rights as a result of using such technology leads to the romanticisation of the relationship between refugees and their smartphones.

It's not too late to change this course of technological development. But refugees do not have the same political agency as domestic citizens to organise and oppose government actions. If you want to see what a dystopian tech-dominated future in which people lose their political autonomy looks like, the daily experiences of refugees will provide sufficient clues.

Is it safe to have more than one type of COVID vaccine?

If we are ever to return to some semblance of normality, then the world's population needs to be immune to SARS-CoV-2, the virus that causes COVID-19. But with so many different vaccines in production, questions are undoubtedly going to be raised, such as can I still have a vaccine if I have been involved in a trial testing other versions? And, what if I've already had COVID - do I still need a vaccine?

A basic understanding of immunology can answer all these questions. All COVID vaccines try to generate an immune response to proteins the virus needs to enter your cells. Whether this is by using a harmless virus carrying the protein that mimics SARS-CoV-2 but doesn't replicate, or by using the genetic code for those proteins (a messenger RNA), the outcome is the same. The protein critical to stopping SARS-CoV-2 is displayed, recognised by the immune system,

and the body produces antibodies and T cells that are then ready to stop future infection.

IS IT OK TO HAVE A DIFFERENT SECOND DOSE?

A booster vaccination enhances the quality of the immune response and sends a reminder about the virus. It doesn't matter if the vaccine used to prime the immune system is different from the one used to boost, as long as they both contain the critical viral protein.

Booster vaccinations are common, and the time interval between them varies. For example, a booster for tetanus is advised every ten years whereas vaccines for hepatitis A or measles are one-shot wonders - a booster is not needed.

Only by studying the immune response in people who have been vaccinated, will we be able to tell when and if further booster vaccinations are needed. This will be determined by measuring SARS-CoV-2 specific antibody and T cell responses in a sample of blood. It is possible that certain groups, such as older people, might need a different booster strategy – and this will take time to work

WHAT IF I'VE ALREADY HAD A TRIAL VACCINE?

If you've taken part in a COVID vaccine trial, it could give you a head start on the prime/boost approach, and you could reach the required immunity threshold quicker. Alternatively, your trial vaccination may have been so effective that the non-trial version of the vaccine isn't necessary.

It is important for vaccine developers to follow up people who have had the vaccine to see how their immune system has reacted and whether or not the vaccine gave them immunity. This follow up should be conducted over a long period and encompass different sections of the population: young, old, different ethnic groups, and patients on drugs that dampen the immune system (such as chemotherapy).

WHAT IF I'VE HAD COVID? Even if you have recovered from COVID-19, you can still benefit from vaccination. There is evidence in hospitalised patients that the infection was so overwhelming that the immune response became exhausted and so immune memory to the virus was not created efficiently. Also, if you had a very mild infection, your immune system may not have reached the point of laying down immune memory. So vaccination could be beneficial, regardless of whether you experienced severe or mild disease.

Though vaccination is a choice, don't forget that vaccines have been around a long time and have saved more lives than any other medicine. The risk of getting COVID and its awful and often long-term side-effects outweigh any theoretical risk of a vaccine.

CBI issues look-out notice against coal trader

KOLKATA, DEC 8 (PTI): The CBI which is probing the illegal coal trading case has issued a look out notice against an accused Anup Majhi alias Lala, a spokesperson said on Tuesday.

The notice was issued to ascertain his whereabouts as his interrogation is needed during the course of the probe, spokesperson said. The central inves-

tigating agency had on November 28 conducted raids at 45 places, including in West Bengal against illegal coal mining at different places including West Bengal.

Search operation were also carried out at different locations of Eastern Coalfields Limited in Jharkhand, Bihar and UP as well against illegal coal mining. Premises of two gen-

eral managers of ECL, three officers, unknown officials of ECL, CISF and Indian Railways were raided along with that of Majhi. These people have been accused of illegally mining coal and theft from Kunustoria and Kajora mining areas

under ECL. The spokesman had said no arrests have been made so far.

ITANAGAR, DEC 8 (PTI): Twenty more ple tested positive for COVID-19 in Arunachal Pradesh, pushing the tally in the northeastern state to 16,415, a senior health official said here on Tuesday.

Of the fresh cases, four were reported from East Siang and three from Changlang, State Surveillance Officer (SSO) Dr Lobsang Jampa said.

Two cases each were also recorded in the Capital Complex region, West Kameng, Lepa Rada and Lower Subansiri and one each from Siang, Papumpare, Namsai, Lower Dibang Valley and Lohit, he said. Eighteen infections were detected through rapid antigen tests while one each was diagnosed through RT-PCR and True NAT tests, the SSO said.

Barring eight, all the new patients are asymptomatic and shifted to Covid Care Centres, he said. Forty-eight people recovered from COVID-19, taking the total number of recoveries in the state to 15,653.

The state now has 707 active coronavirus

A total of 55 patients have succumbed to the infection so far, the official said. The recovery rate among the coronavirus patients in the state is 95.35 per cent, he said.

The state's positivity and fatality rates are 4.65 per cent and 0.33 per cent respectively, Dr Jampa said.

The Capital Complex region, comprising Itanagar, Naharlagun, Nirjuli and Banderdewa areas, has the highest number of active cases at 541, followed by West Kameng (50), Changlang and Lower Subansiri at 13 each.

The state has so far tested 3,65,286 samples for COVID-19, including 866 on Monday, he added.

Suspected NLFT ultras kidnap three constructions workers

AGARTALA, DEC 8 (PTI): Suspected insurgents of the banned National Liberation Front of Tripura (NLFT) have kidnapped three construction workers from a village near the Indo-Bangla border in Dhalai district, police said on Tuesday.

The workers were engaged by NBCC for the erection of border fencing in the Maldapara village under Ganganagar police station of the district, about 140 km from here.

The kidnapped persons were identified as Subhash Bhowmik, JCB driver, Subal Debnath and Ganapati Tripura. Police said a group

of six insurgents armed with automatic weapons raided the construction site bordering Chittagong Hill Tracts (CHT) of the neighbouring country and took the

three workers to Bangladesh on Monday. Immediately after re-

ceiving the news of the kidnapping, Superintendent of Police, Kishore Debbarma rushed to the spot with a huge contingent of police and Tripura State Rifles (TSR) and launched a search operation in the area. In another incident, a

35-year-old trader, identified as Litan Nath was kidnapped at gunpoint on November 27 by suspected NLFT insurgents from Joyrampara, a remote tribal village along the Tripura-Mizoram inter-state border in North Tripura district, police said. The ultras have demanded Rs 1.5 lakh as ransom for his release, they said.

Tripura Police and Mizoram Police have jointly launched a search operation to rescue the kidnapped trader.

The opposition CPI(M) in a statement condemned the incident and alleged that a BSF camp is situated within 200 metres of the border, but still, the persons were kidnapped.

BJP resorting to politics of bandh: Subrata Mukherjee

KOLKATA, DEC 8 (PTI): Ruling TMC on Tuesday accused BJP of resorting to the politics of bandh in West Bengal and asserted that the reason for the death of the saffron party worker in Siliguri was not firing by police but from shot gun pellets probably carried by a participant of the BJYM rally on December 7.

The BJP observed a 12-hour shutdown in certain parts of north Bengal on Tuesday over the death of its supporter during the rally.

Senior TMC leader Subrata Mukherjee told a press meet that the police was far away from the location of the rally and the wounds on the BJP worker's body was caused by firing from close distance. To buttress his point, Mukheriee quoted from the post mortem report of the dead BJP activist Ulen Roy, who had taken part in the BJYM march in Siliguri.

The wounds, he claimed, were caused by pellets fired from a shot gun which is not used by police. Used for shooting birds, it was probably carried by people in the rally to hurt the police. "The post mortem

exposes BJP's gameplan of causing large scale disturbances and provoke the police to open fire," Mukherjee, also senior minister in Mamata Banerjee cabinet said.

Claiming that the police "kept it's cool despite great provocation by the

rallyists", he said "The police used the baton and tear gas as last resort.

Police had fired teargas shells and used water cannons on Monday to quell a violent protest called by the Bhartiya Janata Yuva Morcha (BJYM) against the Mamata Banerjee government during which a BJP worker died. Several protesters and police personnel were injured in the clashes.

The BJP had alleged that a party worker identified as Ullen Ray was "beaten to death" by the police during a baton charge and demanded imposition of President's Rule in West Bengal in view of the "breakdown of law and order". However, police claimed there was no lathicharge.

Mukherjee said "BJP has turned mad in the pursuit of power. They are resorting to falsehood just for the sake of power. But the people of Bengal will vote to power the Mamata Banerjee-led Trinamool Congress for the third term." "BJP is trying to foment trouble in Siliguri and other places in north Bengal today in the name of strike," he said.

On the issue of Bharat Bandh called by farmers bodies and supported by almost all opposition parties, Mukherjee said "Though TMC is against any strike we support it this time due to the cause and factors which necessitated this shutdown call." "TMC believes not only a movement of farmers, the strike is all about bread and butter issue of ordinary farmers and the common man. We are also protesting by coming out in the street by holding sit-ins," he said.

"We are holding protests in 344 blocks for three days from today and near Gandhi statue in the city. Our MPs had protested in both houses of Parliament as the three farm bill's were passed by the Centre. Our MP (Derek O'Brien) had also expressed solidarity by visiting the agitating farmers near the Delhi border," he said.

61 new cases take Nagaland's COVID-19 tally to 11,479

Olympics branded a 'mockery' after inclusion of breakdancing for Paris Games Sydney, 08 Dec [AAP]: Australian squash great Michelle Martin says the Olympic Games have become a "mockery" after breakdancing was added to the program for Paris 2024.

Australia's three-time world champion's immediate reaction to learning squash had been overlooked yet again, this time in favour of breakdancing was "oh my god".

"You just look at the whole thing and you just go 'where's the Olympics going?' I know some people say breakdancing's a sport but ... I don't understand," Martin told AAP.

"The Olympics was all about a score, or it was a running race. There was a definitive answer and results to sports. You bring in all these judging things and it just gets so corrupt and so out of control. I just don't get it anymore."

Squash has been lobbying hard, unsuccessfully, for decades to be included at the Olympics. But not even support from tennis star Roger Federer has been able to give squash a look-in.

Before breakdancing, officially named "breaking" beat it, squash has lost out to sports including skateboarding, sport climbing, BMX, surfing, golf and wushu, which was trialled in Beijing in

As heartbroken as she is, Martin – who also won six British Opens, the Wimbledon of squash – is no longer surprised.

"After the last ones, you get to the point where it's almost expected," the former long-time world No 1 said. "Why? I don't know because the amount of effort squash players put in.

"I know what it was like, training for the sport. It's one of the hardest sports to train for and play. They've obviously got something against squash, because it's been rejected in the past, it just keeps getting overlooked. I don't know, I don't know what to say."

The 53-year-old has lost all hope of squash ever gaining Olympic status, especially when the IOC has opted for breakdancing on this occasion.

"It's sort of making a mockery of what the Olympics is," Martin said. "When you look at what it all used to stand for, the Olympics, it definitely fits in the category. What does the Olympics stands for these days, I don't really know.

"They either need to go back to what the Olympics was about and let the other sports stay outside of that because the problem is it's having such an impact on the sports that don't get into the Olympics now.

"The Olympics has lost what it was. Yes they're trying to move with the times but it's creating a mockery of the thing." But Australia's Olympic chief, Matt Carroll, said the addition of events like breaking were a positive sign of a more modern Games.

"The Olympic Games are adapting to a post-corona world as well as a continuation of the IOC's Agenda 2020," Carroll said.

Liverpool revive their relentlessness in ominous sign for title rivals

LONDON, 08 DEC [THEGUARD-IAN]: Between a quarter and a third of the way through the season the table is, at least, beginning to take on some sense of normality. Tottenham are first and seven points separate the top half, so it's not entirely normal. But as a vaccine is approved, fans are allowed back in limited numbers and a return to something approximating to what we knew before can be imagined, so familiar tropes return to football. Manchester City are casually dismissing lesser sides at home, West Ham are losing leads, Everton are flaky and Liverpool are overpowering opponents at Anfield. Welcome back, normality, we've missed you.

Within that sense of the plates settling, of everything calming down, though, Liverpool's situation still feels odd. The perception remains that this has been a difficult season for them. The early part of their campaign was characterised by wild football, by the 4-3 win over Leeds, the 7-2 defeat at Aston Villa and the 2-2 draw at Everton, the repercussions of which continue to be felt. There has been a raggedness to some of their play and, the win away to Atalanta aside, their Champions League form has been no better than it needed to be.

Jürgen Klopp's spikiness after the draw at Brighton – while a reminder that he, like most managers, is a ter-



rible loser (or drawer when the circumstances feel like a loss) – suggested a man under pressure. And that, perhaps, is understandable enough as the injuries mount up, even if blaming the broadcaster seemed misguided when the whole culture of elite football, in which Liverpool are as complicit as anybody, is founded on squeezing fans for as much as possible to watch as many games as possible.

Yet since losing Virgil van Dijk in the derby, Liverpool have conceded just four goals in six league games. Add in the Champions League and it's six clean sheets in 11. They've only actually lost one league game this season, al-

beit a spectacular one. More than that, the last two home games, against Leicester and then Wolves, have followed a very encouraging pattern for the champions. Both fixtures were, on the face of it, testing games against sides adept on the counter. If there were weaknesses in a back four stripped of three regulars, the sense was that these were opponents equipped to take advantage. But between them they managed just seven shots on target and lost by a combined score of 7-0. Both were entirely emphatic.

The victory over Leicester was arguably Liverpool's best performance since beating the same opponents at the King

Power last Boxing Day. The win over Wolves might even have been better, if only because it was achieved without the reassuring figure of Alisson in goal. Caoimhín Kelleher was just as assured replacing him as he had been against Ajax in midweek, though, and made one fine first-half save from Daniel Podence when the score was still 0-0.

In the long run, it may even be that these awkward few weeks come to be seen as having been a positive, in getting pitch time for players such as Kelleher, Curtis Jones and Neco Williams. The young right-back impressed again before being removed for Trent Alexander-Arnold

midway through the second half. His return after a hamstring pull is, clearly, a relief for Klopp, but the form of Williams means there should be no need now for Alexander-Arnold to be flogged through seven games in 23 days as he was before sustaining the injury.

Liverpool's unbeaten run at home now extends to 65 games, and matches like this are the kind to make opponents blanch at the prospect of a trip to Anfield, even with only 2,000 fans. Wolves, admittedly without Raúl Jiménez, who might have offered some kind of outlet, never looked like being able to build anything. This may

be a slightly more restrained Liverpool than the side of a year or so ago, but it stifles opponents with similar effectiveness.

Comparisons with last season must be treated with caution given the differences in the calendar but back then Liverpool kept only two clean sheets in their first 15 league games before embarking on a run of seven in a row from early December. This season there have been three in 11. The last two games at Anfield have been characterised by a sense of a balance, of a team comfortable in holding their opponents at arm's length but still lethal when chances come.

The stereotype of Liverpool is of relentlessness, of wave after wave of attacking. And they are capable of that, as various comebacks or demolitions have proved. But last season they also had the best defensive record in the league - and that despite a fairly ragged end after lockdown. What made them unstoppable was the three-month spell from the beginning of December to the middle of February in which they conceded just one goal in 11 games while always having the firepower to win. The Brighton game casts some doubt, but the last two home games have suggested a side rediscovering that sort of balance and relentlessness.

That it is being achieved with so many absentees is all the more ominous for the rest of the league.

Booing those that kneel is an act of violent disrespect, a handshake met by a punch

LONDON, 08 DEC [THEGUARDIAN]: There is a famous, perhaps apocryphal tale about the Millwall end throwing a hand grenade on to the pitch at Griffin Park in November 1965. That story is often taken as an example of extreme Millwall hostility. In fact it was a joke (the grenade was a harmless blank).

Fast-forward more than half a century and something similar was lobbed on to the pitch at the Den in the moments before kick-off on Saturday. Except, this one isn't a dud. And its explosive effects are far from over.

It is hard to know what to make of the news that Millwall and QPR players will now link arms before kick-off on Tuesday night at the Den "in a show of solidarity for football's fight against racism".

This is clearly a case of damage-limitation – and too little, too late for a club, in Millwall's case, who knew this was coming weeks ago, failed to respond to the warning signs, and have yet to work out a way to placate both their fans and the demands of the outside world. The damage is out there, though. And it won't be solved by a clapping circle.

It is also hard to overstate the effects of the sustained booing from the home fans before kick-off against Derby. The boos were directed at Millwall's players for taking a knee against discrimination, and specifically racism. They were also in evidence at Colchester. Social media is awash with supportive messages purporting to speak as fans of other clubs. This is a very real point of tension.

There doesn't seem much point at this stage in dwelling on the extraordinary lack of respect shown toward those for whom such gestures have a deep and personal meaning. Or on the inability to remain silent for five seconds if your politics preclude you from sharing the moment. Not to mention the fact those involved must realise that booing – not ignoring, but actually pissing all over – a gesture that expresses anti-racism is by its nature a racist act.

Yes, really. Call it what it is. No need to hide behind the trumped-up connection to Black Lives Matter UK, a fringe organisation that has nothing to do with English football; and which doesn't really exist in the everyday lives of anyone concerned, other than as a distant enemy in the culture wars.

As for the idea this was a response to having "politics" inserted into our football grounds, well, politics are everywhere. Ig-

nore them if you like. That is one of the freedoms we have.

The idea that BLM UK is simply an unignorable enemy, Marxist anarchists currently threatening our very way of life, is laughable

Neither the Premier League nor the EFL have any formal connection to this small, fringe organisation (the EFL's anti-racism slogan is Not Today or Any Day, a terrible slogan, but not a political one).

Plus, of course, BLM UK in no sense "owns" or defines the taking of a knee, which goes back at least as far as the civil rights movement. For many people who have experienced prejudice, taking a knee at football is a sign they are now welcome in these places, that their children can safely come, that acceptance awaits them not hostility.

To boo across the top is an act of violent disrespect totally out of kilter with the gesture itself, a handshake met with a punch to the throat. Not to mention a pretty good way of keeping the gate numbers down for the foreseeable future in a borough where 47% of people are black British or other minority ethnic group.

A statement of personal interest: I have been going to The Den, old and new, for 35 years. I can see the ground from my front door. Via these pages I helped to stop Millwall being forced out of the Den a few years back but I know also that simply writing this article will cause huge offence.

There will be fans who see it as a betrayal of the club to point out the hurt caused on Saturday. This is incorrect. It is instead an act of despairing love and a refusal to allow this version of Millwall, south-east London or modern life – tribally angry, consumed by the wider culture war – to drown out everything else.

The other side of this discourse is also incorrect: the urge to pile on, to dismiss everything and everyone here as defective human matter, a bad lot to be given up on.

There has been significant progress at Millwall and in this part of London over the past four decades. These are changes that actually matter, because this is where the rivers meet, a football club that exists in one of the few remaining ungentrified areas of inner London.

It is an attractive fiction for some to maintain South Bermondsey was always a hive of far-right activity (the National Front was chased out of Millwall in the 1970s). But we do know that racism exists in society. We

know that it exists where tensions are felt most keenly.

When an institution like Millwall FC promote anti-racism, when it works to break barriers down – as the community trust has – when the people in the ground become more mixed (as they have), when black players are routinely voted player of the year (a small thing but still the case); then this is actual progress in a place where it is felt, not just a gallery of the pre-converted.

Club, fans and community trust have been proud of this progress but it has also now been beaten into tiny pieces with the bluntest of clubs.

There has been some talk already this week of internal meltdown, with disenchanted employees considering their positions and long-standing home-and-away fans who feel bereft, betrayed and humiliat-

This may now get much worse. Millwall play QPR on Tuesday night with that pin already pulled. A group of 2,000 home fans will again be present. Both teams intend to take a knee. The talk around the place is that at least one player is prepared to leave the pitch if the boos are repeated.

The Den has always been a place of naysaying, of fuck-yous, of comically cussed hostility. For all the upset caused, it is still the case that no one can or will be punished for booing. This is also one of our freedoms.

But the delusion here is that by booing the taking of a knee those present are standing up to some greater power, refusing to be told by those in charge, taking back control.

This is entirely back to front. There is nothing to be gained from disempowered people squabbling among themselves. The best fuck-you in the world is the one directed towards those with actual influence, those who do actually have the power to deny you opportunity or freedom; a fuck-you that involves punching up not down.

The club itself has the power to intervene here, to set an example and to lead. The anger that led to Saturday was a long time brewing, germinated in part, it seems, by a failure to adequately accommodate the club's remembrance game in November.

For now south-east London holds its breath. Some still maintain this was about politics. It has been made quite clear, and from many sides, that it looks and feels like racism. An escalation will pose the question of how exactly the club can survive such contortions.

Cricket faces tough test as long bio-bubble stays add to mental stress

CAPE TOWN, 08 DEC England's [REUTERS]: cricketers hoped rounds of golf would ease the stress of long periods within a bio-secure bubble but after the One-Day series in South Africa was postponed organisers are taking a fresh look at the impact of COVID-19 protocols on players' mental health. The decision to postpone the series came after potentially five COVID-19 cases were flagged inside the teams' bio-secure environment in Cape Town -- one South Africa player, two hotel staff and two members of the England touring party.

With cricket tours requiring players to be away from their families for weeks or even months, the sport is having to look carefully at how teams handle the strict conditions imposed on them by host countries.

Some have found the toll of moving from bubble to bubble too much. England's Tom Banton and Tom Curran have already pulled out of Australia's domestic T20 Big Bash League this month.

With England's players restricted to bio-bubbles throughout the home summer, and some spending more time locked away while playing in the Indian Premier League, the England and South Africa boards agreed to create a "bio-secure environment", where some movement was allowed under strict guidelines.

"Golf was a key request for the tour to go ahead and we were com-

fortable with that because some allowances have to be made for the players' mental wellbeing," South Africa team doctor Shuaib Manjra was quoted by the Daily Mail.

"Many of the England players have been in some sort of bubble for months and you cannot expect them to sit in their rooms all day. Such concessions will have to be made if we want to continue playing cricket."

The teams did manage to play a three-match Twenty20 series prior to the ODI games, which England won 3-0, but the postponement will come as a massive financial blow to embattled Cricket South Africa.

It also casts doubt on their ability to host planned future tours with Sri Lanka, Pakistan and Australia all set to arrive in the coming months.

Manjra says there would be changes to the bio-secure environment for the visit of Sri Lanka, who start a two-test tour in Pretoria on Boxing Day. "The Sri Lanka series was set to be very different because the hotel is very different," he said.

"Again, we were looking to try and balance the mental wellness with strict COVID-19 protocols. But now maybe need a different approach." ECB managing director of men's cricket Ashley Giles said there were early concerns about the bio-secure environment, and that this build-up of anxiety among the players led to the decision to call off the remainder of the tour.

Australia to reveal laws to make Google and FB pay for news

CANBERRA, DEC 8 (AP): Australia's government will reveal legislation in Parliament on Wednesday that would make Facebook and Google pay for journalism.

Treasurer Josh Frydenberg said Tuesday that the legislation to create the News Media Bargaining Code will be scrutinized by a parliamentary committee following its introduction and before lawmakers vote on it next year.

This is a huge reform, Frydenberg told reporters. This is a world first. And the world is watching what happens here in Australia.

This is comprehensive legislation that has gone further than any comparable jurisdiction in the world, he added.

The legislation differs from draft proposals that were released in July after consultations with the social media platforms as well as Australian media organizations.

The government had initially planned to exclude state-owned media Australian Broadcasting Corp. and the Special Broadcasting Service from being compensated by the tech giants for their journalism.

Chinese online platform JD Health rises 50% in stock debut

BEIJING (AP): Shares in China's biggest online health care platform rose 50% in their Hong Kong stock market debut Tuesday, reflecting investor enthusiasm for the fledgling industry as the country emerges from the coronavirus pandemic.

ID Health, an arm of JD.Com Inc., China's biggest online retailer, sells medications, hospital care packages and online consulting by doctors.

Chinese internet companies increasingly offer health services in a society where hospitals are crowded and distribution of drugs and medical supplies outside major cities is uneven. Online consulting with Chinese-speaking physicians is popular with families from China who live in the West or other developing countries.

Other competitors include e-commerce giant Alibaba Group's Alibaba Health; Baidu Health, run by search giant Baidu. com Inc.; and WeDoctor, run by Tencent Holding, operator of the popular WeChat messaging ser-

The coronavirus pandemic has boosted demand for Chinese online platforms.

Investors have "high hopes for this kind of companies to develop in China," said Jackson Wong, asset management director for Amber Hill Capital Ltd. in Hong Kong.

The ruling Communist Party has encouraged growth of the industry by authorizing online pharmacies to deliver prescription drugs.

During the pandemic, patients switched from going online only for urgent care to staying in touch with doctors about chronic conditions, according to industry analyst Kevin Chang of Bain

"This new pattern of digital engagements is likely to continue and to increase the frequency of consultations," Chang said in a report.

Consumer spending and business activity have rebounded to above pre-pandemic levels after China, where the pandemic began in December, declared the disease under control in March and eased most controls. Restrictions on travelers coming from abroad still are in place and visitors to public buildings are checked for fever.

JD Health raised

about \$3.8 billion by selling 20% of the company to public shareholders.

It was Hong Kong's second-biggest stock offering this year behind parent JD.Com, which has shares traded in New York and raised \$4.5 billion in June when it joined the Hong Kong exchange.

The ruling party is encouraging use of online health services to reduce the burden on hospitals.

JD Health said it plans to expand its online pharmacy and develop "smart healthcare solutions" supported by artificial intelligence to work with physicians.

The company says it had 72.5 million active users in June, up 30% over a year earlier.

The industry might face tougher competition once the coronavirus is brought under control and patients have more offline options, said Wong.

"If vaccines are very effective and people start going out again, the growth of these online service providers might not be as high," said Wong. "That would be the biggest risk for this kind of company."

New Zealand mosque shooter travelled to India before carrying out attack: Report

MELBOURNE, DEC 8 (PTI): Brenton Tarrant, the Australian-born attacker who killed 51 Muslim worshippers at two mosques in Christchurch, travelled extensively around the world, including India where he spent nearly three months, before moving to New Zealand to carry out the country's worst massacre in 2019, according to a detailed report into the shootings released on Tuesday.

Five Indians were among those killed in the terror attack on March 15 last year that also left dozens of others wounded and had shaken New Zealand, regarded as one of the most peaceful countries in the world.

The 792-page Royal Commission of Inquiry report notes that after leaving school, the 30-yearold attacker worked as a personal trainer at a local gym until 2012 when he suffered an injury.

"He never again worked in paid employment. Instead, he lived off the money that he had received from his father and income from investments made with it With the money from his father, the individual travelled extensively. First, in 2013, he explored New Zealand and Australia and then between 2014 and 2017 he travelled extensively around the world," it said.

Between April 15, 2014, and August 17, 2017, the individual travelled extensively and always alone, except for his travel to North Korea as part of a tour group.

"The longest visit the individual made to any one country was to India where he stayed between November 21, 2015, and February 18, 2016. The countries that he visited for periods of about a

month or more included China, Japan, Russia, South Korea among others," said the report that took about 18 months to compile. The inquiry report did not provide details of what Tarrant was doing in India during his nearly three-month stay in India.

However, The New Zealand Herald reported that there was no evidence that he met with extremist groups while oversees, investigated potential targets, or carried out any training, in a report.

The inquiry did not believe that the travel fuelled his racist views to any great extent, rather concluding: "Put simply, he travelled widely because he could and had nothing better to do." it said. But he did visit right-wing internet forums, subscribe to rightwing YouTube channels, and "read a great deal about immigration, far right political theories and historical struggles between Christianity and Islam", it added.

About the attacker's upbringing in Australia, the Royal Commission of Inquiry report notes that it was marked by a number of stressors, including his parents' separation and his mother's subsequent relationship with an abusive partner.

He expressed "racist ideas" from an early age and was also an avid internet user, it said.

"In February 2017, he booked flights to New Zealand to arrive in Auckland on August 17, 2017, and then on to Dunedin on August 20, 2017. We see these activities as the first manifestations of his terrorist intent," said the report that details the extensive world travels of Tarrant.

Capsule with asteroid samples arrives in Japan for research



TOKYO (AP): Japanese space agency officials were delighted Tuesday by the return of a small capsule containing asteroid soil samples obtained their Hayabusa2 spacecraft and they are anxiously waiting to look inside after preparations are complete.

Hayabusa2 The dropped the capsule from space and it landed in the Australian Outback over the weekend. It arrived in Japan earlier Tuesday and it will soon be studied for insight into the origin of the solar system and life on Earth.

The Japan Aerospace Exploration Agency said the capsule, tightly sealed and carefully stored in a container box, arrived at its research facility in Sagamihara, near Tokyo, for curation and analysis beginning later this month.

"It's really like a dream," said Yuichi Tsuda, the Hayabusa2 project manager. "After 5.2 billion kilometers (3.2 billion miles) of space journey which took six years, (the capsule) has returned and now it's here with us."

Mission officials will have to wait until next week to look inside.

"I'm anxious to find out if the samples are really inside and how much is there," project manager Makoto Yoshikawa said. "Otherwise, everything is perfect so far."

At the end of its yearlong journey from asteroid Ryugu, more than 300 million kilometers (190 million miles) from Earth, Hayabusa2 released the capsule Saturday from 220,000 kilometers (136,700 miles) in space, successfully sending it to land on a targeted area in a sparsely populated desert in Australia.

The extremely high precision work at the end of Hayabusa2's six-year mission thrilled many Japanese.

Launched in December 2014, the unmanned Hayabusa2 spacecraft touched down twice last year on Ryugu. Despite an unexpectedly rocky surface that even forced the mission's team to revise landing plans, the spacecraft successfully collected data and soil samples from two locations — on the surface and from underground.

Scientists say the samples, especially ones taken from under the asteroid's surface, contain data from 4.6 billion

years ago unaffected by pace radiation and other environmental factors. They are particularly interested in studying organic materials in the samples to learn about how they were distributed in the solar system and if or how they are related to life on Earth.

The samples will be treated in a clean room at the Sagamihara facility to avoid any external impact, and the work is expected to start soon. After initial studies and curation in Japan, some of the samples will be shared with NASA and other international scientists for further study.

Initial inspection at a quick check facility in Australia detected unidentified gases from the capsule, a sign they are related to solar wind or Ryugu samples. JAXA will further analyze the gasses, which could provide information about organic elements and water.

Outside the JAXA's facility in Sagamihara, senior members of the Hayabusa2 team and local fans lined up at the gate Tuesday and welcomed the arrival of the capsule, transported from the airport on a truck, some holding up a sign saying "Welcome back!"

Hong Kong, Dec 8 (AP): Hong Kong police on Tuesday arrested eight pro-democracy activists over their role in an unauthorised protest last summer, widening a crackdown on dissent in the semi-autonomous Chinese city.

The arrests, which included several former lawmakers, are tied to a July 1 demonstration in which thousands defied a protest ban and rallied on the streets against a national security law imosea on the city by jing the day before.

Former pro-democlawmakers Wu Chi-wai, Eddie Chu and Leung Kwok Hung were arrested at their homes on charges related to organising and participating in the protest, posts on their respective pages. Hong Kong police said in a statement that eight men aged between 24 and 64 had been arrested for inciting, organising and taking part in an unauthorized assembly.


