COVID-19 cases rise to 433; active cases 402

New Delhi, Mar 23 (PTI): The death toll due to the novel coronavirus pandemic rose to nine on Monday after West Bengal and Himachal Pradesh reported a casualty each, while the number of confirmed cases soared to 468, the Union health ministry said.

The number of active COVID-19 cases are 424 now and 35 people have been cured/discharged/ migrated, while nine have died, taking total number of confirmed cases to 468, including 40 foreign nationals, according to the ministry data.

Seven deaths were earlier reported from Gujarat, Bihar and Maharahstra, Karnataka, Delhi, Maharashtra and Punjab.

Gujarat, Bihar and Maharashtra reported a death each on Sunday, while four deaths were earlier reported from Karnataka, Delhi, Maharashtra and Punjab.

With four new cases, the number of COVID-19 cases in Maharashtra stand at 74, including three foreigners. In Kerala, 67 cases were reported, including seven foreign nationals, according to the ministry data.

Karnataka has 33 cases of coronavirus patients after seven more persons tested positive for the deadly virus. The number of cases in Telangana have risen to 32 including 10 foreigners.

Uttar Pradesh now has 31 positive cases, including a foreign national. Delhi and Gujarat have reported 29 cases each, while Rajasthan has 28 positive cases, including two foreign nationals.

Given that there will still be

Within the state, there will be a complete ban on movement of vehicles from 6 a.m on 25 March and, additionally, the odd-even rule will apply till 25 March.

The State Government has also notified quarantine rules and now, everyone returning to Sikkim from abroad will be required to stay under strict home quarantine or facility quarantine for a period decided by local health authorities.

Those refusing to cooperate will be penalised under section 188 and 270 of IPC.

Amendment placed to grant autonomy to Sikkim State Univ Vice-Chancellor, as chair-

SUMMIT REPORT GANGTOK, 23 MARCH:

The State government **■** with a view to grant autonomy status to Sikkim State University, tabled a fresh amendment bill to the Act today.

Education Minister Kunga Nima Lepcha, in the statement of objects and reasons accompanying the amendment, explains this was being done to allow the Sikkim State University to function as an autonomous institute of Higher Education.

Amendments been proposed to Section 6A and to make changes in Clause (6) and (27), insertion of Sub-Clause 8 in the clause 8 of the Schedule of the Sikkim State University Act, 2003 thereby allowing the University to function independently.

The amendment authorizes the Executive Committee to constitute a Selection Committee to make recommendations to the Executive Council for appointment of teachers. Sub-clause 2 fur-

authorizes

person of the Selection Committee along with Dean of the School of Studies, Head of Department concerned, two experts nominated by Vice Chancellor and one expert nominated by Chancellor as members.

The amendment also proposes that the Chancellor of the University be divested powers to remove the Vice-Chancellor from the office on grounds of incapacity, misconduct or violation of statutory provisions, provided no such order is made by the Chancellor unless the Vice Chancellor has been given reasonable opportunity of showing cause against the action proposed to be taken against him.

However, the Chancellor shall have statutory powers at any time before making any order and can place the Vice Chancellor under suspension, pending enquiry.

The amendment will put to vote on Tuesday.

5.94 lakh screened for nCov in Sikkim GANGTOK, MAR 23 (PTI):

A total of 5.94 lakh people entering Sikkim have been screened amid the coronavirus outbreak, the health department said on Monday.

Of the total number of people who were screened at five inter-state border checkposts till March 21, coronavirus-like symptoms were found in four of them, it said in a release.

"Swab and blood samples of three of the four persons were sent for tests. They have tested negative for coronavirus," it said.

Three quarantine centres have been set up at Majitar, Rangpo and Karfectar, it said.

The Health Department has also set up isolation wards at four hospitals, the release said.

1. The Sikkim Protection of Interests of Depositors (In Financial Establishments) Amendment Bill, Bill No.2 of 2020 was introduced by Chief Minister, PS Tamang who is also the Minister-in-Charge of Finance Department.

The state Government has deemed it necessary to amend Sections 2, 3, 14, 17 and 18 of the Sikkim Protection of Interests of Depositors (In Financial Establishments) Act, 9003 for:

- a. Making the definitions more specific and clearer, leaving no room for ambiguity. Defining entity which was earlier left out;
- b. Creating a mechanism on information sharing with regard to the reports of the financial establishments with the regulators of the Country and the State;
- c. Re-appointing the Competent Authority and appointing the Co-competent Authority and financial empowering them with suo-motto powers to deal with the defaulting establishment for recovery of dues to the depositors,
- d. Appointing the Co-administrator to manage the attached properties of the defaulting financial establishment. This amendment aims to strengthen the Sikkim Protection of Interests of Depositors (In Financial Establishments} Act, 2009 making it all the more effective and well-structured.
- as required under Article 213 (2) (a) of the Constitution of India. Therefore, the Bill has been framed with the above objects in view.
- 3) Similarly, the Sikkim Fiscal Responsibility and Budget Management (Amendment) Bill, Bill No 5 of 2020 was introduced by PS Tamang Chief Minister also the Minister-In-Charge of Finance Department. Nitish announces package over coronavirus lockdown



PATNA, MAR 23 (PTI): In view of the lockdown enforced in urban areas of the state over coronavirus pandemic, Bihar Chief Minister Nitish Kumar on Monday announced a "package" under which one month ration will be given for free to all the card holders.

Three months advance pension will be given immediately to all the beneficiaries of schemes like Mukhya Mantri Vridhjan Pension, those given to differently abled persons, widows and old age over pensioners, Kumar said.

The amount will be directly transferred in their bank accounts, the chief minister said in an official statement.

He also announced that Rs 1,000 per family will be given to all the ration card holding families of urban local bodies and panchayat of block headquarters witnessing lockdown due to COVID-19 outbreak.

The amount will be transferafter to their accounts through Direct Benefit Transfer, he said after a review meeting on coronavirus here.

The meeting was attended by Deputy CM Sushil Kumar Modi, health minister Mangal Paandey, water resources minister Sanjay Kumar Jha, Chief Secretary Deepak Kumar and a host of other senior officials of the state government.

The state government had on Sunday enforced lockdown in all district headquarters, sub-divisional headquarters, block headquarters and urban local bodies of the state till March 31, 2020 in order to check break the transmission chain of coronavirus. The government has kept essential services- like grocery shop, milk, vegetable, medicines etc. out of the order.

The CM further said that scholarship to students (girls and boy) of class I to 12 will be transfered in their accounts by March 31, 2020.

All the doctors and health staff will be given one month of basic salary as incentive, Kumar said.

Kumar appealed to the people of the state to follow advisory issued by the state government on coronavirus pandemic.

The government will be able to tackle the situation only with the help of the people, the CM said.

RBI to infuse Rs 1 lakh crore through term repo auction

Mumbai, Mar 23 (PTI): In a bid to provide additional liquidity to the system hit by the coronavirus outbreak, the Reserve Bank of India (RBI) on Monday decided to inject Rs 1 lakh crore and assured such move further also if required.

The first tranche of term repo worth Rs 50,000 crore was conducted on Monday, while the second tranche of the same amount will be conducted on Tuesday.

Coming home and staying there in COVID-19 times

New Delhi, Mar 23 (PTI): Sweeping, swabbing, cooking, washing and more me time than ever imagined. With large parts of the country shutting down to ward against COVID-19, it is back to the basics and recalibrating life for millions of people, a mere inconvenience for some and a huge challenge for the elderly.

The unprecedented lockdown of cities and towns on Monday disrupted lives all over, for those dependent on domestic helps and finding it difficult to access daily necessities as much as for those denied their daily chats over coffee at their workplaces and addicted to their exercise

regimens. With the threat of coronavirus growing by the day, people began the process of de-socialising and learning how to live in isolation, without even the regular good morning' with the milkman and the newspaper vendor. And maybe, just maybe, a quick chat six feet apart with the friend and neighbour.

The experience was different for different folks, particularly the urban middle classes, but it all fell in the spectrum of adjusting to the new reality of coping with a pandemic that has affected over 340,000 people globally and claimed more than 15,000 lives. India has reported 415 cases and seven fatalities.



Population Figures

Census Numbers Hold Many Stories

The population totals of Census 2011 were released I some years ago, and now it's almost already time for a fresh round of the decadal headcount of the country. In that sense, the 2011 numbers are slightly dated, but still, the bits and pieces hold many stories. When the first set of Census numbers are released, they always generate much interest, sometimes even gasps over how the state is growing, or not as was the case with 2011. In the current census figures, Sikkim's falling fertility rate has hogged the limelight, convincing the State government to scrap the financial incentives it offered public servants for keeping their families "small". But there are so many more stories that the numbers tell. Statistics are not always boring, provided someone dug out the human stories behind them. This should be a study that more people undertake in Sikkim.

Sikkim's population as of March 2011 has been counted at 6,07,688 people, recording a 12.36% growth since 2001. Since 1911, when the first proper Census operation was undertaken in Sikkim, only three decades, the last being 1941-51, have population growths been lower than this. The first Census of Sikkim was conducted in 1891 by the Political Officer. A decade later, in 1901, the West Bengal Census authorities of British India were deputed to carry out the task and it was probably only in 1911 that the Directorate of Census Operations brought the detailed methodology by which India does a head-count of all its people. In the decade of 1901-11, Sikkim's population grew by 48.98%, the second-largest population spurt here since such counting was undertaken. In the next decade, 1911-21, the population fell by 7.05%, the only time it has done so. Population growth in Sikkim has shown marked variations, growing by little over 34% in the decade of 1931-41 and then almost grinding to replacement fertility-rate figure of 10.67% in 1931-41, creeping only slightly higher to 13.34% in 1941-51 and reaching 17.76% in 1951-61. It started rising from thereon, recording a nearly 30% population growth in 1961-71 and then hitting the record of 50.77% in 1971-81, dropping to nearly half this growth rate to 28.47% in 1981-91, rising five percentage points to 33.07% in 1991-2001 and then scaling back to its mid-Twentieth Century average of 12.36% growth in 2001-11.

Census findings are important indicators of socioeconomic conditions of the areas they cover. Populations obviously grow beyond the traditional average either due to influx or improvements in health services, both of which are indicative of the quality of life and opportunities. Of course, in the recent past, our country has been working towards containing its population through family planning schemes launched on mission-mode, but the population figures of the past slightly more than a century are untouched by such efforts and should attract closer academic scrutiny. From the pattern of these figures, one could understand the history of Sikkim from the point of view of the lay people, who, although they have lived through Sikkim and its transitions, rarely find mention in the few records of even contemporary events. The nearly 50% growth in population between 1901 to 1911 should make for interesting analysis, coming as it does in a decade when the palace and the Political Office were in direct confrontation and also the time when British India was most interested in Sikkim, using it as the route to open Tibet. The change in how the State was administered must have obviously created new opportunities triggering new arrivals. What can also not be ignored is that if this 1911 exercise was also the first head-count Census and would hence have accounted for population segments not covered in the previous two Census operations carried out the Political Officer who had relied on feedback from the landlords, who could have had their own reasons to under-report the actual number of people in areas under their jurisdiction.

The fall in population in 1911-21 should be even more fascinating for anyone interested in the people's history of Sikkim. The population fell by 7.05% due to the Influenza pandemic (Spanish Flu) which spread through the world in the wake of World War-I. Sikkim did not fight the Great War, but an epidemic which was born from it claimed too many lives here as well. The pandemic broke out in 1918 and is believed to have killed 50 million people across the world. One still does not know how many died of it in Sikkim. The numbers must have been huge because healthcare services were too rudimentary here to have been able to deal with an alien sickness. Most of these deaths would have taken place in the two years between the outbreak and when the Census was carried out. This 7% fall in population immediately after a 50% growth must have scarred an entire generation. It deserves to be researched because it could explain many things about how Sikkim lived in those times. As an aside, there are also references to how the Younghusband Mission of 1904-05 brought the Foot & Mouth disease to Sikkim. Agriculture and animal husbandry were the only occupations in Sikkim at that time. Isn't it important to research into how Sikkim resuscitated itself from that calamity?

These exercises are important for Sikkim to understand its past better and may be even understand issues which attract passionate opinions in a different light.

This virus is ravaging rich countries. What happens when it hits the poor ones?

Though Africa has fewer coronavirus cases and ■ a slower rate of infection than the UK, many countries in the continent have passed dramatically more extreme measures to prevent its spread than Britain has. In my birth country of Sudan, after only one case and one death was registered, all schools and universities were shut down. Several other nations, such as Egypt, have taken the ultimate precaution and closed their airports.

There is no denial here, no mixed messaging, and no unfounded promise of how soon we will send the virus packing.

The tough and timely action is borne less out of political maturity than it is bitter experience, and an awareness that already overburdened public healthcare systems cannot sustain an onslaught. The ebola epidemic of 2014 is still fresh in the mind in sub-Saharan African countries; it was an experience that showed prevention and containment are the only hope of fending off thousands of deaths.

If we are concerned about the failure to contain the virus in western Europe and the US, multiples of that horror await in the developing world. With few means of medical intervention, and several other risk factors such as malnutrition, high population densities, communal living and lack of access to water and washing facilities, the rates of mortality could dwarf what has been seen so far in the west. And economically, the virus risks ushering in an ice age. There are no war chests, no stimulus packages, no insurance payouts.

There is little data about the impact in Africa

of previous pandemics such as the 1918-19 Spanish flu (except from South Africa where, because of troop movements, 6% of the population perished). But we do have the experience of economically similar south Asian countries to go by. It is estimated that up to 30% of the entire fatal toll of the Spanish flu came from a single country, India. And in Africa it appears that the countries that suffered the highest casualties were those most exposed to global flows of people and capital - the ports or thoroughfares for troops on the move, and for sea and land labour.

There is something painfully predictable about how coronavirus was introduced to the continent. Well-off travellers to the rest of the world returned from holidays and business trips carrying the virus, as did infected tourists. In Egypt, the first cases of Covid-19 appear to be linked to one cruise ship, where locals who served the tourists contracted the disease.

The spread of the virus on the continent sits in the crosscurrents of travel and financial flows that expose African countries to the sharp end of globalisation - one where the flow of people is encouraged into the continent for business and tourism, and severely restricted out of the continent even for the wealthy and well connected.


It is the recurring theme of how the pandemic has played out so far. The poor, the uninsured, the disenfranchised, the information-poor and the less mobile are sitting ducks. Many western economies, including the US and the UK, have slowly pushed these people to the margins, while restricting employment benefits such as holiday pay, sick leave, and private insurance to an increasingly exclusive class. One of the reasons the British and US governments have been so slow to provide free testing, medical care and bailouts for those who've lost work is that these inequalities are now hardwired into the system. They cannot be undone overnight even when lives depend on it.

The global economy is set up in much the same way, with winners who hoard the spoils, and losers who scratch around for the leftovers. If wealthy single countries cannot scramble to save their own people, there is no hope for any effort to extend help to countries with a fraction of the resources.

But here is the tragic catch for those who think that this structural imbalance is not our problem. In this instance, national and international inequalities cannot persist without everyone losing. The realisation is just beginning to dawn upon lawmakers that the rich cannot be barricaded against the poor, no matter how high the barriers to the fortress are. Limiting the spread of the virus entails ensuring that everyone in the pool, be it local or global, is given the ability to test, self-isolate if need be, and receive treatment.

Yes, to some extent this is a utopian aspiration. But it is also essentially pragmatic. We cannot extol the virtues of small government and global societies without grasping that the risk to the majority cannot be halted from spreading: viruses do not distinguish between classes and nationalities.

Just as work and public life cannot be shuttered for ever, borders cannot be closed indefinitely. African countries are moving fast against coronavirus, well aware that they are on their own. But barring a miracle, or a pandemic Marshall plan by wealthier countries, if the virus explodes in poorer countries, the cataclysm will engulf everyone.



We can't let the coronavirus lead to a 9/11-style erosion of civil liberties

As a millennial, much of my adulthood has been punctuated by severe national emergencies. The first my generation experienced was the terrorist attack on September 11, 2001. We all watched in horror as the monthslong media spectacle replayed footage of the towers swallowing airplanes and crumbling into fire and dust. The moment of national solidarity and everyday heroism was brief.

The government quickly re-

sponded by attempting to achieve two things: one, expanding executive power, and two, transferring public wealth into private corporations. The Bush administration achieved the first by passing the Patriot Act, which built the foundation for what is probably the world's most expansive surveillance state, but also by setting legal precedents that violated basic constitutional rights and by creating the Department for Homeland Security, with its aggressive constituent agencies like Immigration and Customs Enforcement (Ice) and Customs and Border Protection (CBP). The second goal was achieved with the "war on terror", which involved unilateral occupations of Afghanistan and Iraq, and subsequent military forays into many African countries. In Iraq, private security, logistics and reconstruction contractors swallowed up \$138bn alone. Since 2001, \$5.9tn in taxpayer dollars have gone toward wars (not to mention resulted in hundreds of thousands of deaths and a foreign policy blackhole that till haunts the Middle East). Neither of these goals addressed the root cause of the crisis, and arguably exacerbated the conditions that led to 9/11.

The second national emergency my generation experienced was the 2008 housing bubble collapse and subsequent recession: the most severe economic meltdown since the Great Depression. Again the federal government, this time under Barack Obama's administration, sought to exploit the crisis to move vast wealth

bank accounts. A staggering \$14tn was transferred from taxpayers to private hands, including Wall Street executives who used that money to continue giving themselves seven-figure bonuses. One of the larg- such authoritarian measures wholly, est recipients of bailout money, Citi- no matter who says they're "necesgroup, paid out \$5.3bn to employees in bonuses. While the federal government debatably halted a further stock market collapse, they certainly did not address the root cause of the crisis. A mere 11 years later and we are again standing on the edge of a major economic crisis.

Ecological devastation, meanwhile, is the quiet crisis amplifier that has persisted through both of these national emergencies and cast a shadow over the whole of my generation. Its latest iteration is the Covid-19 pandemic, whose origins lay in habitat destruction and biodiversity loss.

Once again, the federal government appears poised to exploit this emergency to expand executive power and move wealth from the public treasury into private bank accounts. As the Nation recently reported, an internal CBP directive empowers the agency to indefinitely monitor and detain anyone suspected of carrying the virus. Meanwhile, the Trump administration has begun a bailout for the oil industry, which could exceed \$2.6bn in tax dollars going to oil industry control, and is toying with the idea of an airline industry bailout, which could exceed \$50bn.

The authoritarian lockdowns in China and Italy may soon arrive to the anglophone world. Seeing selfavowed leftists and liberals praising such draconian reactions is frightening. Anyone who cares about democracy and civil liberty should not welcome such responses. As we witnessed with the authoritarian reactions to 9/11, emergency violations of civil liberties are not easily rolled back, and often aggregate over time. In the wake of 9/11, Congress passed the National Defense Authorization Act, which gave sweeping powers to

from the public treasury into private the executive branch. In 2012, Obama signed an expanded version into law, which gave the president the power to "hold individuals, including US citizens, in military detention indefinitely", which means for life. We must reject

> The fact is, neither expanding executive power nor redistributing wealth upward will save lives or address the root cause of the crisis. In fact, both the oil and airline industries are accelerating the ecological devastation at the heart of this pandemic. As ecological collapse continues to unfold, more and more emergencies like this will occur with greater frequency and intensity. Now is the time to break out of the recurring pattern in which national responses not only fail to solve the problem, but even exacerbate the original cause, while transferring wealth from taxpayers to already-wealthy, well-connected executives. Instead, now is the time to implement a set of standards for what constitutes a response that puts the common good at the center.

In the case of this virus, there are plenty of good ideas already being discussed that would do exactly that. Instead of moving public wealth into private corporations, the government should be doing the opposite.

The first step to containing this virus is handing out cash to every American to fund their ability to self-isolate without having to go to work. A basic income of, at minimum, subsistence rate would achieve this. The New York congresswoman Alexandria Ocasio-Cortez has called for implementing an emergency universal basic income, while presidential candidate Bernie Sanders suggested delivering a monthly \$2,000 check to every household to deal with lost income.

Providing universal healthcare, both during the virus flareup and after, would also go a long way to containing its spread and reducing its seasonal intensity; the for-profit system is probably exacerbating the spread of the virus. Subsidizing or even nationalizing essential goods and services like utilities, pharmaceuticals and distribution of basic necessities could also help contain the virus and reduce its negative long-term impacts, and ensure that those services remain available to all. The Trump administration has (surprisingly) ordered the Department of Housing and Urban Development to halt evictions and foreclosures temporarily. Taking that further and reforming or eliminating them, even past the worst of the pandemic, could help soften conditions leading to virus spreading in the future.

Interim support for local services, like small businesses and charities, would also help keep local infrastructure intact beyond the most intense phases of social isolation. Dismantling the prison industrial complex and deeply reforming the justice system would help as well. The US has the highest incarceration rate and absolute prison population in the world. Abolishing the institution would go a long way toward reducing the impact of highly infectious viruses, given that prisons are "the perfect incubators" for coronaviruses. Finally, bypassing intellectual property laws with regard to vaccine development, and preventing anyone from limiting access for private profit, would also be important, both now and beyond the pandemic.

Of course the best thing we can do is halt the twin ecological and climate crises that are now driving so many existential emergencies like the Covid-19 pandemic. But, in the meantime of attending to that herculean task, the least we can be doing is agreeing on a set of responses that reject authoritarian exercises of executive power and the further enrichment of the already wealthy at the expense of the public. Instead, we should be responding to such national crises by saving lives and fortifying the common good. Through a series of compounding national emergencies, a benevolent response would be the first my generation has ever witnessed.

SC asks states, UTs to consider releasing prisoners to decongest jails

New Delhi, Mar 23 (PTI): The Supreme Court Monday directed all states and Union Territories to constitute high-level committees to consider releasing on parole or interim bail prisoners and undertrials for offences entailing up to 7-year jail term to decongest prisons in the wake of coronavirus pandemic.

The top court said overcrowding of prisons is a matter of serious concern, particularly in the present context of coronavirus (COVID 19).

In regard to the provisions of Article 21 of the Constitution of India, it has become imperative to ensure that the spread of coronavirus within the prisons is controlled, the court said.

A bench of Chief Justice S A Bobde and Justices L N Rao and Surva Kant said the state or UT could consider the release of prisoners who have been convicted or are undertrial for offences for which prescribed punishment is up to 7 years or less, with or without fine and the prisoner has been convicted for a lesser number of years than the maximum.

"We direct that each State/Union Territory shall constitute a High Powered Committee comprising of (i) Chairman of the State Legal Services Committee, (ii) the Principal Secretary (Home/Prison) by whatever designation is known as, (ii) Director General of Prison(s), to determine which class of prisoners can be released on parole or an interim bail for such period as may be thought appropriate," it said.

The top court said it would be open for the



High Powered Committee to determine the category of prisoners who should be released depending upon the nature of offence, the number of years to which he or she has been sentenced or the severity of the offence with which he/she is charged with and is facing trial or any other relevant factor, which the Committee may consider appropriate.

It also directed that the Undertrial Review Committee set up by the court in another matter, shall meet every week and take such decision in consultation with the concerned authority.

It said that the High Powered Committee shall take into account directions contained its 2014 verdict of Arnesh Kumar versus State of Bihar.

It asked the states and UTs who have not filed their responses to do so within three weeks from today and listed the matter after three weeks.

"Taking into consideration the possibility of outside transmission, we direct that the physical presence of all the undertrial prisoners before the Courts must be stopped forthwith and recourse to video conferencing must be taken for all purposes," the bench said, adding that the transfer of prisoners from one prison to another for routine reasons must not be resorted except for decongestion to ensure social distancing and medical assistance

to an ill prisoner. It directed that there should not be any delay in shifting sick person to a Nodal Medical Institution in case of any possibility of infection is seen and prison specific readiness and response plans must be developed in consultation with medical experts.

It said that 'Interim guidance on Scaling-up COVID-19 Outbreak in Readiness and Response Operations in camps and camp like settings' -- jointly developed by the International Federation of Red Cross and Red Crescent (IFRC), International Organisation for Migration (IOM), United Nations High Commissioner for Refugees (UN-HCR) and World Health Organisation (WHO), published by Inter-Agency Standing Committee of United Nations on March 17, 2020 -- may be taken into consideration for similar circumstances.

"A monitoring team must be set up at the state level to ensure that the directives issued with regard to prison and remand homes are being complied with scrupulously," it said.

The top court added that looking into the possible threat of transmission and fatal consequences, it is necessary that prisons must ensure maximum possible distancing among the prisoners including under trials.

The top court also noted the steps taken by various states and UTs including shifting of over 11,000 prisoners to less congested prisons in Jharkhand.

"An overview of the responses reflects that considerable measures for protection of health and welfare of the prisoners to restrict the transmission of COVID-19 have been taken by the State Governments," the bench said. It said these

measures generally include creation of isolation wards, quarantine of new prisoners including prisoners of foreign nationality for a specific period, preliminary examination of prisoners for COVID-19, ensuring availability of medical assistance, entry points scanning of staff and other service providers, sanitisation and cleanliness exercise of prison campus and wards, supply of masks etc.

It said that significant measures have been taken by Bihar, Karnataka, Maharashtra, Uttar Pradesh, Tripura, Jharkhand, Goa, Kerala, Telangana and UTs of Jammu & Kashmir and Chandigarh who have advised the prison authorities that visitors may be allowed to interact with prisoners only through video calling or telephonic call.

On March 16, the top court had taken suo motu cognisance of overcrowding of prisons across the country and said it is difficult for jail inmates to maintain social distancing to prevent the spread of coro-

Mamata requests Modi to stop all flights to West Bengal

KOLKATA, MARCH 23 (PTI): West Bengal Chief Minister Mamata Banerjee on Monday wrote to Prime Minister Narendra Modi requesting him to issue necessary instructions to stop all flights coming to the state as a precautionary measure to contain the spread of novel coronavirus.

In a letter to the prime minister, Banerjee noted that her government had suspended all inter-state public transport and reduced the number of intra-state buses due to Coronavirus threat.

"I would request you to kindly make arrangements to issue necessary instructions to stop all flights coming to West Bengal with immediate effect so that the source of spreading infection is effectively contained and the lockdown in the state is implemented in true letter and spirit," Baneriee wrote.

West Bengal on Sunday announced a partial lockdown from 5 pm on Monday till March 27 midnight, in an attempt

to arrest the spread of the viral disease.

"The government of West Bengal has taken multiple proactive measures to prevent the spread of infection and for upgrading the health infrastructure in the state to address the crisis. We have announced massive critical safety regulation measures from 5 pm today," the chief minister wrote.

West Bengal has reported seven Covid-19 positive cases so far.

Manipur announces lockdown till March 31

IMPHAL, MAR 23 (PTI): Manipur was placed under a lockdown with immediate effect till March 31 in the wake of the novel coronavirus pandemic, state minister Thongam Biswajit Singh announced on Monday.

Essential services, however, have been exempted from the purview of the lockdown. The decision was taken at a meeting of the state cabinet, the industries minister said.

The cabinet also decided to set up isolation wards at the Regional

Institute of Medical Sciences (RIMS) and the Jawaharlal Nehru Institute of Medical Sciences (JNIMS), Singh said.

The government has decided to distribute rice, meant for April under the National Food Security Act (NFSA), free of cost to support the needy during the lockdown. Beneficiaries of the Chief Minister Hakshelgi Tengbang health insurance scheme who do not possess the NFSA card will also be given free rice, he

Singh, the official

spokesperson of the government, said the spread of the deadly COVID-19 could be prevented only if guidelines issued by the experts were followed. He urged the people not to hide any signs and symptoms of the new coronavirus.

"Let us together fight COVID-19 and not allow our negligence to hinder our fight against it," the minister said. "Let us maintain proper hygiene, wash our hands regularly and maintain social distance to defeat COVID-19.

Medicine shops to remain open in Assam during lockdown

GUWAHATI, MAR 23 **(PTI):** All medicine shops and establishments in Assam will remain open and there will be no disruption in the supply of medicines, the Chemists and Druggists Association of Assam (CDAA) said on Monday.

The announcement was made after Health and Family Welfare Minister Himanta Biswa Sarma announced that Assam will be under lockdown from 6 pm on Tuesday till March 31 in the wake of the novel coronavirus pandemic.

The CDAA supports overcharging or hoarding

social distancing but as medicines come under essential services, all shops/establishments will remain open to ensure that there is no disruption in the supply of medicines to the needy patients and avoid panic among people.

CDAA president N L Agarwala and Secretary Jitu Barman in a statement requested all stockists, dealers and retailers to make all necessary medicines available to people at reasonable prices.

Elderly COVID stricken man dies in Bengal



KOLKATA, MARCH 23 (PTI): An elderly man infected with the coronavirus died in a Kolkata hospital on Monday, the first death recorded in West Bengal due to the contagion, hospital sources said.

The deceased was aged 57 years and was a resident of Dumdum in the North 24 Parganas district. He died at a private hospital.

He was in the hospital since February 16 and was on ventilator support. He had no recent history of travelling abroad but had visited Bilaspur in Chhattisgarh his February.

"The man had acute respiratory distress syndrome. We had taken proper protective measures but he died this afternoon," a spokesperson for the hospital said.

His family members are under observation in an isolation ward at a state-run hospital, state government officials said.

Ladakh imposes lockdown till March 31

LEH, MAR 23 (PTI): The Union Territory of Ladakh has been placed on lockdown till March 31 to check the spread of coronavirus even as the reports of 16 fresh samples of suspected cases have tested negative, a senior government official said on Monday.

The lockdown came into effect across Ladakh at 8 pm on Sunday and will remain in force till 6 pm on March 31, officials said.

Ladakh has so far recorded a total of 13 positive coronavirus cases.

The District Development Commissioners of both Leh and Kargil districts have imposed Section 144 of the Criminal Procedure Code (CrPC), the Disaster Management Act and the Epidemic Diseases Act under which only essential services will be available to the people till March 31, Commissioner Secretary (Health) Rigzin Samphel told reporters here.

Seeking cooperation of the people, he said, "We will ensure that they do not face any problem during the shutdown period".

He said the reports of all 16 suspected cases -- 12 hailing from Kargil



and four from Leh -- were received from Delhi on Saturday and were negative. "The test report of a person, having a recent travel history to the United States and who reached Leh on Saturday in a very bad condition with suspected symptoms of COVID-19, is likely to reach by this (Mon-

day) evening," he said. Samphel said all the co-passengers of the person have been contacted and asked to remain under home-quarantine for 14 days and to ensure no physical contact with family members and others.

He said the Leh airport will operate as usual and there is no change in schedule of flights arriving from Delhi or Jammu.


The deputy commissioners of Leh and Kargil said in the lockdown order that there would be a "complete ban on assembly of three or more persons for any reason, whatsoever, and complete shutdown of all shops and business establishments, educational institutions, markets and Anganwadi centres".

However, the essential services and supply chains to maintain the essential services were exempted from the purview of the shutdown, the officials said. They said there would be complete restrictions on the movement of interdistrict and intra-district commercial transport and other modes of public transport, except for authorized transport plying for essential purposes.

They said the residents were asked to stay at home and come out only to procure essential commodities for consumption (one person per vehicle) in the immediate vicinity of their homes, while strictly following the norms of social distancing.

IOC says Olympics postponement an option, cancellation 'not on agenda'

LAUSSANE, MAR 23 (AFP): The International Olympic Committee said Sunday that postponing the 2020 Olympics is one of its options as the world grapples with the coronavirus pandemic, but that cancellation of the Tokyo showpiece was "not on the agenda".

The IOC has faced strong pressure to push back the Games, scheduled from July 24 to August 9, from sporting federations and athletes worried about the health risk as the COVID-19 global death tally went past 13,000 on Sunday.

IOC president Thomas Bach said a decision on when the Games take place would be made "within the next four weeks".

"Human lives take precedence over everything, including the staging of the Games," Bach wrote in an open letter to athletes.

"We have, as indicated before, been thinking in different scenarios and are adapting them almost day by day.

"A final decision about the date of the Olympic Games Tokyo 2020 now would still be premature," he said.

Bach explained that the IOC was discussing its options with health authorities and stakeholders.

"We are confident that we will have finalised these discussions within the next four weeks." He made clear that there would a Games in Tokyo at some point.

"Cancellation would not solve any problem and would help nobody," Bach said.

"Therefore it is not on our agenda.'

- THUMBS DOWN-The idea of holding



the Games on schedule has drawn a swelling chorus of objections.

On Sunday, nine-time Olympic track and field champion Carl Lewis, as well as the head of French athletics added their voices to the US and French swimming federations, the US and Spanish athletics federations, the Norwegian Olympic Committee and past and current athletes.

Sprinter and long jumper Lewis, who won gold at four different Olympics, told Houston television station KRIV that he backed calls for postponement.

"I just think it's really difficult for an athlete to prepare, to train, to keep their motivation if there's complete uncertainty. That's the hardest thing," he said.

"I think a more comfortable situation would be two years and put it in the Olympic year with the Winter Olympics (Beijing 2022) and then make it kind of a celebratory Olympic year." World Athletics, the governing body of track and field, said they were "ready to work with the IOC and all sport on an alternative date". "World Athletics welcomes discussions with the IOC to postpone the Tokyo Olympic Games and wrote to the IOC earlier today to relay this feedback from its Area Presidents,

said in a statement. On Saturday, World Athletics president Sebastian Coe told AFP that the sporting world was in "uncharted territory".

"I don't think we should have the Olympic Games at all costs, certainly not at the cost of athlete safety," Coe said.

Britain's Dina Asher-Smith, the world 200m champion, said she was frustrated by the IOC's four-week window.

"So wait... does this mean that athletes face up to another FOUR weeks of finding ways to fit in training - whilst potentially putting ourselves, coaches, support staff and loved ones at risk just to find out they were going to be postponed anyway," she tweeted.

US media reported on Sunday that American athletes had voted during a virtual town hall with

Almost three-quarters of the 300 athletes who met online with USOPC supported delaying the Games, USA Today reported.

In all, 70 percent of the athletes supported a postponement with another 23 percent saying it would depend on the consequences, according to details supplied by a member of the USOPC Athletes Advisory Council. - 'REALLY SELFISH' -

Almost a quarter wanted a decision no later than April 15, while 18 percent wanted an immediate decision.

"I feel the IOC is being really, really selfish in trying to push it," US hammer thrower Gwen Berry said.

"Having spent countless hours communicating with IOC leadership and our peers around the world, we know the difficult obstacles ahead and we are all appreciative that the IOC has heard our concerns and needs, and is working to address them as quickly as possible."

The head of the French athletics federation said postponement was inevitable.

"Everyone agrees that the Games cannot be held on the dates planned," Andre Giraud said.

Australian athletes told to prepare for Olympic Games in 2021

Sydney, 23 Mar [AFP]: Tough and uncertain times are ahead for Australia's Olympic athletes, who have been told to prepare for Tokyo 2020 to become Tokyo 2021 amid the Covid-19 pandemic.

The Australian Olympic Committee executive board held an emergency teleconference on Monday morning and unanimously agreed a team could not be assembled for the 2020 Olympics given the current situation at home and abroad.

The International Olympic Committee and Japanese government, under increasing pressure to take action, flagged that postponement was possible during the past 24 hours.

The IOC indicated its next step could take up to a month but that timeline could change as Australia, Canada and other nations make it clear they do not expect the Games to take place this year.

Australia will miss the summer Olympics for the first time if the opening ceremony is somehow staged on 24 July. The far more likely outcome is an unprecedented shift to a non-Olympic year but even that is yet to be locked in.

"It remains difficult [to postpone an Olympics]. Hence why their decision is they'll come back to us within are very small organia month," an exhausted chief executive Matt Carroll said on Monday.

"Moving the world's biggest sporting event, which involves so many sports, athletes, the world's media, sponsors and the rest ... is not easy to do." The IOC insists cancellation is not on its agenda.

Australian team chef de mission for Tokyo Ian Chesterman admitted recent "stress and uncertainty has been extremely challenging" for athletes. A different type of stress may now take hold for those who made financial and/or professional sacrifices in an effort to compete at the Games.

"It is very difficult for those amateur athletes. Because some of them could have part-time jobs they don't have any more," Carroll said. "International competitions has stopped now so they don't have the prize money they would otherwise get.

"We're engaging with the athletes on that to find out if there are any doing it tough and we'll work with them."

Carroll passed on a similar message to his counterparts at various Australian sports governing bodies, plus Sport Australia and the AIS, during a teleconference on Monday. "A lot of them sations ... we're working with them and the government to see how we can assist the sports," he said.

The AOC last Thursday backed the IOC's stance, outlining extreme isolation measures that could potentially be used in coming months to help athletes try to compete at Japan and avoid contracting the coronavirus.

The penny dropped on Monday amid Australia's unprecedented ban on international travel, states closing their borders and a range of other extreme measures in place.

"Last Thursday was a different set of circumstances to standing here today," Carroll said. "There has been dramatic change in our own country and across the world.

"We have athletes based overseas, training at central locations around Australia as teams and managing their own programs. With travel and other restrictions this becomes an untenable situation."

Paralympics Australia released a statement, noting it "is wholly supportive of a postponement of the Paralympic Games in the best interests of public health, both here and abroad".

"It is hard to see another option," it said.

Postponing the Olympic Games: it's complicated

Токуо, Mar 23 (AFP): The Tokyo Olympics appears to be creeping towards a postponement, an unprecedented and costly exercise that involves ripping up years of planning. As International Olympic Committee president Thomas Bach told Germany's SWR:

"Postponing the Olympic Games is not like moving a football game to next Saturday." Here are just some of the challenges: - COMPETITION SCHEDULING -

Games put it, the Olympics "gravitate around... a four-year cycle. If you wake up and the sun is in a completely different place, there are going to be consequences". Much depends on the length of any postponement but shoehorning an Olympics into what is already a packed sporting calendar in 2021, for example, will be a logistical nightmare for both athletes, administrators and broadcasters.

One potential clash is the World Athletics Championships, currently scheduled for August 2021 in the United States -- a lucrative pay-day for athletes and TV networks.

Swimming is also scheduled to hold its World Championships in Japan from July 16 to August 1, 2021.

Adding to the crowded schedule is football's European Championships, already postponed from 2020 to 2021.

Olympic legend Carl Lewis has put the case for holding the Summer Games in 2022 alongside that year's Winter Games in Beijing, creating a "celebratory Olympic year". - VENUES -

There are 43 Olympic sites -- some temporary, some purpose-built, others repurposed for the Tokyo 2020 Games -- and all of them present difficulties in the event of a postponement.

The IOC highlighted this as one of the main concerns, warning: "A number of critical venues needed for the Games could potentially not be available anymore."

For example, one of the main selling points of the brand new 68,000-seater Olympic Stadium was that it would hold "cultural and sporting events" after the Games were over. Any such event would now need to be moved if it clashes with a rescheduled Games.

And it's not just sporting venues. Organisers have block-booked the enormous Tokyo Big Sight exhibition centre to host the thousands of interna-

tional journalists covering the Games. This is one of Asia's premier venues for hosting large-scale conferences, and is booked many months in advance. Finding a suitable slot or persuading others to move could also be a challenge. - ATHLETES' VILLAGE -

A major question mark hangs over the athletes' village, which occupies some prime real estate overlooking Tokyo Bay with a view of the city skyline As specialist website Inside the and its famous Rainbow Bridge.

> It will have 21 towers of between 14 and 18 floors with a total capacity of 18,000 beds during the Olympics and 8,000 for the Paralympics.

The plan was to renovate and convert the village into thousands of luxury condos, which are being sold off or put up for rent.

According to the website of the Harumi Flag developers, some 4,145 units were to be put up for sale. Viewings and sales of a first batch of 940 apartments began in summer 2019 and the vast majority have already been snapped up, according to Japanese media. Postponement would mean delaying the renovation process and huge uncertainty for those who have already signed contracts -- including whether force majeure clauses would be triggered. - HOTELS -

Among the "many, many" challenges the IOC mentioned, it highlighted that "the situations with millions of nights already booked in hotels is extremely difficult to handle".

In fact, one of the concerns before the coronavirus hit was a possible dearth of hotel rooms. One idea was to park a cruise ship offshore for emergency accommodation -- now surely a non-starter given the experience with cruise ships and the virus.

Hotel rooms have been blockbooked in advance for many months. Many have paid a large deposit in advance and could face losing this, in addition to having to re-book quickly for a postponed date. The hotel industry would also face huge uncertainty if the Games are delayed, adding to the headache already posed by a catastrophic drop in tourism.

A postponement by a few months to later in 2020 might solve what had previously been the biggest concern over the Tokyo Olympics: the sweltering heat of the Japanese summer.

'Little upset with China' over coronavirus: Trump

BY LALIT K JHA WASHINGTON, MAR 23 (PTI): US President Donald Trump has said he is "upset" with China over its late sharing of information on coronavirus.

"They should have told us about this," Trump told reporters at a press conference in the White House on Sunday.

"I'm a little upset with China. I'll be honest with you, because as much as I like (Chinese) President Xi (Jinping) and as much as I respect and admire the country," he said.

Trump said soon after he received information about the spread of the deadly viral infection in China, he wanted to send US medical team there. However, China did not allow.

Without specifying any timeline, Trump said he had spoken to President Xi "specifically" about sending US team to China, however, "he doesn't want this... this is not something that he

The US president said it is "out of pride" that China didn't "want us to send people" and "they didn't really respond".

Reiterating America's relationship with China is "very good", Trump said, "I wish they (had) told us three months sooner that this was a problem. We didn't know about it. They knew about it and they should (have) told us. We could have saved a lot of lives throughout the world."

Meanwhile, the US and Chinese officials continued with their war of words over coronavirus on Twitter.

"Since early January, the CCP has retaliated against its citizens and journalists in China for making information public, launched disinformation campaigns around the world, and limited the international community's access to valuable public health information," the National Security Council of the White House tweeted.

On March 20, Morgan Ortagus, spokesperson of the US State Department, tweeted, "By Jan. 3, Chinese authorities had already ordered #COVID19 virus samples destroyed, silenced Wuhan doctors, and censored public concerns online. @SpokespersonCHN is right: This is a timeline the world must absolutely scrutinize."

Responding to the tweet, Hua Chunying, spokesperson of the Chinese Foreign Ministry, said China has been updating the US on coronavirus and its response since January 3. On January 15, the US State Department notified Americans in China about the US Centre for Disease Control's warning against the coronavirus.

"And now blame China for Delay? Seriously," she said.

China, Hua tweeted, has treated COVID 19 as highly pathogenic virus according to the law on prevention and treatment of infectious diseases.

Global emergency efforts ratcheted up as pandemic deaths soar

¬lobal emergency efforts Uto slow the coronavirus pandemic ratcheted up Monday with more nations and cities imposing extraordinary lockdowns, as the death toll soared towards 15,000.

From Germany banning gatherings of more than two people, New Zealand announcing a four-week lockdown and Hong Kong shutting its borders to all non-residents, the new round of containment efforts highlighted a deepening sense of panic around the world.

The Tokyo Olympics slated for July also looked increasingly likely to be postponed, with Canada announcing it would not send athletes to Japan then and Australia saying it was preparing for a oneyear delay.

In the United States, President Donald Trump ordered thousands of emergency hospital beds to be set up at coronavirus hotspots as a trillion-dollar economic rescue package crashed in the

The death toll from the virus surged to more than 14,400, according to an AFP tally on Sunday, with Europe the epicentre.

Italy's world-worst toll from the pandemic approached 5,500 with another 651 deaths reported on Sunday, a day after it surpassed China with the highest number of fatalities.

European nations continued to choke people movement, with Greece on Monday morning to follow Italy, Spain and France in imposing



a nationwide lockdown. In Germany, Chancellor Angela Merkel on Sunday announced the ban on gatherings of more than two people. She did so while in quarantine herself because she had met an infected doctor.

Like in Europe and elsewhere around the globe, the lockdowns have decimated the tourism industry.

"That was heartbreaking. We have made a huge investment preparing for a successful tourism season," hotel owner Tamriko Sikharulidze told AFP in Tbilisi after Georgia declared a state of emergency over the weekend.

Police patrolled the deserted streets of Rome on the weekend, while checks were carried out on Italian beaches after local officials complained people were defying isolation orders by catching some time in the sun.

In his weekly

streamed online to avoid attracting crowds, the Pope urged all Italians to follow isolation measures "for the good of us all." Spain's prime minister said he would ask parliament to extend a 15-day state of emergency, which bars people from leaving home unless absolutely essential, until April 11.

Spain recorded close to 400 new fatalities Sunday, bringing the total to 1,720, suggesting the lockdown was failing to be effective. Opera star Placido Domingo said he had tested positive. Residents across France, where the death toll jumped to 674, remained shut in their homes.

A curfew was imposed in some regions and the mayor of Paris called for even more drastic confinement measures in a city under lockdown.

Britain inched towards similar measures as Prime Minister Boris Johnson warned the country was a couple of weeks behind registering similar numbers to Italy.

- Great Depression fears -In the United States, more than a third of Americans were under various forms of lockdown, including in New York, Chicago and Los Angeles, but the number of infections in the country has continued to climb.

Highlighting the desperation inside the world's biggest economy, the mayor of New York said his city was just 10 days away from running out of ventilators.

And a trillion-dollar Senate proposal to revive the US economy crashed Sunday after receiving zero support from Democrats, further traumatising investors who are watching stock markets implode worldwide.

Asian markets were hammered on Monday, and European stocks followed with a drop of four percent at the open, as they absorbed the failed US stimulus effort and the barrage of other bad news from across the world. "This is the biggest economic shock our nation has faced in generations," Australian Prime Minister Scott Morrison said as he warned the pandemic could lead to a crisis akin to

the 1930s Great Depression.

As the pandemic overwhelms hospitals, doctors are having to quickly prioritise patients based on their chances of survival, inflicting a huge moral burden.

"We go into medicine to heal people. Not to make choices about who can live," said Philippe Devos, an anaesthesiologist in Belgium.

The virus emerged in China late last year, after first being detected at a market that sold wild animals for human consumption in the central city of Wuhan. China has since

Wuhan, while portraying itself as a saviour in the global fight and a role model for quarantines. China on Monday reported no new local cases of the virus, but confirmed another 39 infections from overseas. However, Beijing's communist leaders have also been criticised at home and abroad for a perceived lack of transparency, particularly at the start of the outbreak.

Trump has been among those critics and angered China by branding it the "Chinese virus". On Sunday he complained again about a lack of information and transparency from Beijing.

Hong Kong, which had largely avoided the virus in the first wave despite being so close to the Chinese mainland, announced a ban on all non-residents from entering.

Chief Executive Carrie Lam said restaurants and bars would also be banned from selling alcohol. "Sometimes when people drink more, sought to sow doubts over there may be some intimate whether the virus began in acts," she told reporters.

Travel hub UAE to halt flights as virus reaches Gaza

iest international airport, announced early on Monday that it was suspending all passenger and transit flights for two weeks to stymie the spread of the new coronavirus.

Dubai's airport is a vital hub connecting Western nations with countries in Asia and Australia, and suspending transit flights there affects travelers around the world.

Saudi Arabia, meanwhile, announced that an evening curfew would go into effect starting Monday from 7 p.m. to 6 a.m. for three weeks.

Countries across the Middle East have ramped up restrictions on daily life in an effort to contain the global pandemic.

Most people only experience mild symptoms from the COVID-19 disease caused by the virus and recover within weeks. But it is highly contagious and causes severe illness in some patients, particularly the and spread the virus without showing any symptoms.

More than 331.000 people have been infected worldwide, and more than 14,400 have died. Nearly 100,000 people have recovered.

There are around 26,800 cases of the virus confirmed in the Middle East, but more than 21,000 of those cases are in Iran and many others are linked to travelers from Iran, which has reported nearly 1,700 fatalities.

Harvey Weinstein tests positive for coronavirus: report



WASHINGTON, MAR 23 (AFP): Disgraced Hollywood mogul Harvey Weinstein has tested positive for the novel coronavirus, US media has reported.

Weinstein, 68, is in prison in northern New York state after being sentenced to 23 years in jail for rape and sexual assault.

The fallen film producer's diagnosis was first reported on Sunday evening by local paper the Niagara Gazette.

The New York state Department of Corrections did not respond when contacted by AFP for confirmation of the reports.

Weinstein was transferred Wednesday to a prison near Buffalo, 350 miles (560 kilometers) northwest of New York City.

Prior to his transfer, he stayed at Rikers Island prison and a Manhattan hospital, where he was treated for chest

pains. Crowded US prisons have the potential to become hotbeds for coronavirus infections. Last week, guards at Rikers and New York's Sing Sing prison tested positive for the virus, local media reported.

As of Sunday, the virus has killed 417 people in the US out of more than 33,000 cases, according to a tracker managed by Johns Hopkins University.
