(PTI): Expressing concerns over "political interference" in influencing statistical data in India, as many as 108 economists and social scientists Thursday called for restoration of "institutional independence" and integrity to the statistical organisations.

Their joint statement comes in the backdrop of controversy over revision of gross domestic product (GDP) numbers and withholding employment data by the NSSO.

They said that for decades, India's statistical machinery enjoyed a high-level of reputation for the integrity of the data it produced on a range of economic and social parameters.

"It (statistical machinery) was often criticised for the quality of

Unhappy with SKM alliance bypassing Sikkim unit, 3 BJP office bearers resign

SUMMIT REPORT GANGTOK, 14 MAR:

Three office-bearers of ■ Bharatiya Janata Party's Sikkim unit resigned from the party today unhappy with the manner in which the electoral alliance with SKM was struck by the party bypassing the State functionaries and in contradiction with the BJP's expressed position against corruption.

state-unit's vice-president JB Darnal, who was also the party spokesperson, vice-president Madan Karki and general secretary DR Khatiwada of East District Committee have resigned from primary membership and all posts and responsibilities in the party.

Addressing a press conference this afternoon, Mr Darnal expressed deep dissatisfaction over the alliance process between BJP and SKM.

He mentioned that many leaders and workers of the state-unit were neither happy nor satisfied with the alliance.

"We are not pleased with the SKM for having

gone directly to the central committee of BJP in Delhi bypassing the Sikkim unit. We worked very hard to bring BJP

Climate change vulnerability map for 12 Himalayan states developed

NEW DELHI, MAR 14 (PTI): Re- able and how the government might searchers at IIT Guwahati, IIT Mandi and IISc Bengaluru have developed a climate change vulnerability map for 12 Himalayan states in India that will help prioritise resource allocation to address these vulnerabilities.

The exercise is unique because for the first time all the 12 Indian Himalayan Region (IHR) States have used a common framework resulting in the production of comparable state level and within state, district level vulnerability maps, the team said in a statement. The need for such an exercise is

due to the fact that IHR is one of the most sensitive regions to climate change and variability, the project investigators said. Most parts of the region under-

went significant long-term changes in frequencies and intensity of extreme temperature and rainfall events over the last decades, they said.

Such comparable vulnerability assessments are useful for officials, implementers, decision makers, funding agencies and development experts, to have a common understanding on vulnerability.

The maps will enable them to assess which states in IHR are more vulnerable, what has made them vulneraddress these vulnerabilities.

The results were presented here today during a workshop organised by Indian Institute of Technology Guwahati and Indian Institute of Technology Mandi with support from Indian Institute of Science Bengaluru, Department of Science and Technology (DST) and Swiss Agency for Development and Cooperation (SDC).

"Based on the common methodology, we came up with a state level vulnerability assessment for the IHR and organised training workshops for the state level officials to carry out district level assessments in all 12 IHR states," the investigators of the project said.

"Such a coordinated approach and enhanced cooperation between states in the IHR and the departments within the states are assumed to improve resilience to climate change because several adaptation interventions will require coordinated efforts across administrative boundaries," they said in a statement.

The 12 states include Assam, Manipur, Meghalaya, Mizoram, Nagaland, Tripura, Arunachal Pradesh, Sikkim and the hilly districts of West Bengal, and Himachal Pradesh, Uttarakhand and Jammu and Kashmir.

(University of British Columbia, Canada), R Ramakumar (TISS, Mumbai), Hema Swaminathan (IIM-B) and Rohit Azad (JNU).

The economists and social scientists said it is imperative that the agencies associated with collection and dissemination of statistics like the Central Statistics Office (CSO) and the National Sample Survey Organisation (NSSO) are not subject to political interference and their work, therefore, enjoys total credibility.

"Lately, the Indian statistics and the institutions associated with it have, however, come under a cloud for being influenced and indeed even controlled by political considerations," the statement said.

Citing an instance wherein the CSO revised upward GDP growth estimates for 2016-17 (the year of demonetisation) by 1.1 percentage points to 8.2 per cent, the highest in a decade, they said: "This seems to be at variance with the evidence marshalled by many economists".

The statement also expressed concern over withholding of Periodic Labour Force Survey (PLFS) of NSSO and news reports that the PLFS of 2017-18 will be scrapped altogether by the government.

Two members of the National Statistical Commission (NSC), including the acting chairman, subsequently resigned because they felt the NSSO was delaying the release of the report, though the NSC itself had officially cleared it, they added.

The 108 experts, from across the globe, further said that in fact, any statistics that cast an iota of doubt on the achievement of the government seem to get revised or suppressed on the basis of some questionable methodology.

"This is the time for all professional economists, statisticians, independent researchers in policy regardless of their political and ideological leanings to come together to raise their voice against the tendency to suppress uncomfortable data..." they said.

The experts also called for impressing upon the government authorities, current and future, and at all levels, to restore access and integrity to public statistics, and re-establish institutional independence and integrity to the statistical organisations.

The reputation of India's statistical bodies in the country and globally is at stake, they added.





Lose Hope and there is Nothing Left

Nothing worse than pessimism

Given how desperate things can get in our country, it remains a miracle that it still holds together. And the miracle comes by way of hope, the inexplicable optimism which sees a future despite the travails of the present. Take that away and everything will collapse. And the surest way to kill hope is by infecting the society with pessimism.

As pessimism sinks in, suspicions grow, and before one even realizes, it's misanthropy all around. Not only do people stop trusting, they also start hating. It is then no longer about being pragmatic, but an obsession with remaining defeatist. That is one condition that even democracy cannot assail. Demoralise a people to a nadir from where they can spy no silver lining and from thereon, democracy can be subverted at will. Fear can also help in the subversion, but fear is difficult to instill and even more difficult to sustain whereas pessimism is an instinctive trait in the present times of frequent dejections and thus easier to contaminate with. When the pollution is complete, the people become dejected, see no hope and refuse to get involved. The public domain is then occupied by "vested interests" who feed paranoia with one hand to keep people dispirited and "negotiate" favours for themselves with the other. The people are too distracted by their dejections to notice or even care and when they are so indisposed, surrender power that was theirs. Take away faith, dismember hope and then there are no solutions possible.

A society so disinclined then lives in an environment where there are no meaningful debates, because loaded with pessimism minds speak only to themselves and refuse to engage other voices. There are worrying trends all across the country which suggest that we are a people who are losing hope and hence clinging to straws as weak as projected nationalism and hollow strength, not because things are bad, but because we refuse to see the positives, refuse to engage. This is a worrying trend which has encroached on Sikkim too. There is too much of leader speaking/arguing with leader and not enough of people speaking to leaders. Because of this there is too much claiming and complaining in the public domain and not enough positivity. This trend has to be stemmed. People have to get involved more. Without involvement, there is no sense of achievement, no sense of belonging; what is democracy then? Perhaps we speak too soon here, both, for India and for Sikkim. But what if we are speaking up too late?

MPs vote against no-deal Brexit – but what does that actually mean?

Parliament has voted against leaving the European Union without "a deal". Having lost a second vote on her withdrawal agreement on March 12, May agreed to let MPs vote on whether they would accept leaving the EU without a deal on March 13. They voted 321 to 278 against no deal under any circumstances.

Some would say this vote is meaningless. Regardless of what the MPs say, the clock keeps ticking down to the UK leaving automatically on March 29. However, the vote is far from meaningless. It signifies that a majority in parliament understands that "no deal" is nothing like walking away from the purchase of a car. It shows that they don't believe that the EU will blink and give Britain what it wants if the UK just lets things go to the wire (as some Brexiteers keep asserting).

WHAT THE VOTE TELLS US

By initially allowing a free vote on this matter rather than whipping her party to support her, the prime minister was also tacitly acknowledging that her slogan "no deal is better than a bad deal" was just that – a slogan and a bluff called. It is also recognition of the political reality of a government ceding control to parliament given the likely scale of rebellion and resignations if whipped towards either outcome.

Still at least 278 were prepared to vote against a motion that not only would have left "no deal" on the table, but could have been interpreted as a positive instruction to the government to rip up the withdrawal agreement negotiated over two years with the European Union if March 29 rolled around without any other option in place.

The UK would then crash out of most legal frameworks that have governed trade and economic life in the country – not just with the EU, but many other trading partners – for decades, without a replacement. Such a decision would have created a major and long-reverberating political crisis, especially if the government refused to settle the £39bn bill it has agreed represents what it owes the EU for outstanding commitments.

The EU has already made clear that without the withdrawal agreement, there will be no transition period. This would have led to a major escalation in rhetoric across the Channel, as the EU would have held the whole of parliament, and indeed the Brit-

ish political class, responsible for a final act of bad faith on the part of country.

In the event of a no-deal Brexit, it is probable that mini deals would be struck in key sectors of importance to the EU. But, at the same time, the EU would apply economic pressure to get the UK to sign up to the essence of the withdrawal agreement – including the backstop. The UK may find

it very hard not to give in to this pressure in a final act of humiliation.

Meanwhile, there would be a surge in war rhetoric and polarisation between no-deal enthusiasts, who would invoke the spirit of the Blitz even more fervently, and those who think a no deal is entirely the fault of the UK government, with its unrealistic red lines and delay tactics.

Sometimes, it is helpful to acknowledge the importance of the road not

tance of the road not taken. WHAT THIS VOTE DOESN'T DO

What the vote against "no deal" does not do is prevent "no deal" from happening. It may still happen. No dealers in parliament might deliberately obstruct alternative outcomes or MPs might simply fail to agree on an alternative solution in the short time remaining before Brexit day.

Unless it agrees to pass May's deal, parliament has only two options under the Article 50 process. It could ask the EU for an extension. That would need to be agreed with unanimity by all 27 members of the EU. Some EU countries, especially France, have already expressed their opposition to granting such an extension just for the purpose of gaining more time to procrastinate further, prepare for "no deal" and thus inflict further uncertainty and political costs on the EU system and businesses. They want a positive resolution, which is in their eyes either the current negotiated withdrawal agreement (plus a tweaked political declaration putting a permanent customs union or Norway-Plus on the table, but not

deciding on it now) or a decision by the country to remain for good – whether confirmed by a general election or a second referendum.

The EU may require a minimum extension of, say, nine months or longer to get over the election of the European Parliament and the new European Commission. The Commons will therefore be under immense pressure to quickly decide whether they



want to hold an election or a referendum and how much time is needed to do either.

If the EU does not grant an extension, either because one or more of the EU member states has had enough of the uncertainty and procrastination and withholds its assent or because time is running out, then revoking article 50 is the only other option. According to the European Court of Justice, this needs to be done in writing, in line with the constitutional requirements of the UK and following a democratic process and it needs to be "unequivocal and unconditional" – the UK really has to stay. It cannot revoke Article 50 just to buy extra time.

Such a decision could be followed by a general election in which parties will be faced with the decision to stand by their vote to revoke or to offer the re-triggering of Article 50 to start Brexit afresh. Needless to say, this scenario is the less likely, but in the current impasse and unusual circumstances, unexpected and unusual things may still happen.

A cure for HIV? Feasible but not yet realized

This week a team of scientists and physicians from the U.K. published news of a second HIV positive man, in London, who is in long-term (18-month) HIV remission after undergoing treatment for Hodgkins lymphoma. The unexpected success has launched a new round of discussion about a potential cure for HIV.

Since 2008, scientists have been trying to replicate the treatment that cured the "Berlin patient" of HIV. At the time, many in the field of HIV research were excited to learn that this man, who tested positive for the human immunodeficiency virus in Berlin and had recently undergone treatment for acute myeloid leukemia, appeared to have been cured of his HIV. Until now, success in replicating that cure has been limited.

WHAT IS HIV?

HIV is the virus that causes AIDS. Since the virus was first discovered in the 1980s, more than 75 million people worldwide have been infected with HIV. Today, almost 37 million people live with HIV. Of these, about 1.1 million live in the U.S.

Infection with HIV almost always led to AIDS, which in turn was almost always fatal. The field was revolutionized in 1996 with the introduction of HIV anti-retroviral therapy medications. These drugs halt HIV from replicating and allow an infected person to regain a functioning immune system. These medications are so effective that today a person living with HIV has almost the same life expectancy of someone without HIV infection. However, these medications must be taken every day, have multiple distressing side effects, and can cost thousands of dollars each month.

Yet even with this life-extending treatment, a functional HIV cure, defined as when someone with HIV no longer tests positive for the virus and does not need to take these medications, has remained elusive.

THE 'CURE' TREATMENT

All of that seemed to change when in 2008 at the Conference on Retrovirus and Opportunistic Infections in Boston, Massachusetts, the news broke of the Berlin patient, named Timothy Ray Brown, who seemed to have been cured of his HIV. In order to achieve that serendipitous "cure," Brown had to undergo aggressive treatment for his acute myeloid leukemia that involved two hema-

topoietic stem cell transplantations – in which a patient's bone marrow is damaged – and full body irradiation.

This complex treatment involves destroying a person's own immune system with high doses of chemotherapy or radiation. Then the patient receives a transplant of new stem cells from either themselves or a donor.

This is a difficult treatment that carries a high risk of infection and other complications, such as graft-versus-host disease, blood clots and liver disease.

Researchers learned that Brown and the "London patient" both shared a novel treatment course. In the case of both Brown and now the London patient, the new blood cells transplanted into them were from donors who had two copies of a gene mutation for the CCR5 receptor. This CCR5 receptor mutation – present in about 1 percent of people of European descent – prevents HIV viruses from entering immune cells. This renders them resistant to most HIV infection.

However, it's not just surviving the transplant that confers the HIV "cure" or remission. After receiving treatment, both patients were eventually taken off their anti-retroviral medications and subsequent examination showed that that even with very sensitive blood tests, the team could not detect HIV in their blood. The inability to find HIV in their blood, coupled with the missing CCR5 receptor, constitutes the HIV viral remission of the London patient announced earlier this week.

WHAT THE NEW CASE SHOWS

Given recent disappointments after hematopoietic stem cell transplantations in people living with HIV, the team reporting on remission of the London patient does not describe their patient as cured. Neither should anyone else.

While a second patient experiencing HIV viral remission with a slightly less toxic cancer treatment is certainly encouraging progress, an 18-month remission does not equal a cure.

Also, while the London patient's cancer treatment was less intense, with just chemotherapy and the stem cell transplant, it was still toxic and is not a course of treatment that otherwise healthy people living with HIV infection

should embark upon.

Most importantly, the HIV community learned that Brown's case was not unique. This gives us another, and perhaps greater reason, to hope for future revolutions in the HIV cure scientific agenda.

TMC continues to add glitz and glamour to poll arena

KOLKATA, MAR 14 (PTI): Continuing with her penchant for bringing in silver screen personalities to politics, Trinamool Congress supremo Mamata Banerjee has fielded five film stars, including two greenhorns, for the coming Lok Sabha elections.

In the 2014 general elections, Banerjee had fielded the same number of cinestars and all the five had won.

It was Banerjee who had in 2009 started the practice of fielding people from the glamour world in West Bengal elections, which was considered to be the forte of southern states.

Of the 42 Lok Sabha constituencies in West Bengal, the TMC had won 19 seats in 2009 and 34

The party also adds a dash of colour to major public meetings, where celebrities from the film and television world assemble.

Fielding of Mimi Chakraborty, a popular actress in Bengali cinema and a political greenhorn, from the prestigious Jadavpur constituency for the 2019 elections has come as a surprise to many.

It was from this constituency in the city that Mamata Banerjee had



burst into electoral politics in 1984 as a young Congress candidate, by handing a stunning defeat to incumbent and towering Somnath Chatterjee of the CPI(M).

Sugata Bose, a professor of Oceanic History and Affairs at the Harvard University held the seat as a TMC MP in the outgoing 16th Lok Sabha. Reportedly, he has not been given permission by the university to contest the elections this time.

Another political greenhorn and Bengali film actor Nusrat Jahan has been fielded from Basirhat in North 24 Parganas district, a seat now

held by TMC's Idris Ali. Banerjee has said Ali will contest in an Assembly by-election.

Apart from these two. actors and sitting MPs Deepak Adhikari, popularly known as Dev, Satabdi Roy and Munmum Sen will also contest.

While Dev and Rov would seek re-election from Ghatal and Birbhum seats respectively, Sen has been shifted from Bankura to Asansol. which was won by singer-turned-politician Babul Supriyo of the BJP.

The TMC has dropped sitting MPs Tapas Pal and Sandhya Roy, well-known film stars of vestervears.

Pal had been arrested by the CBI in December 2016 in connection with the Rose Valley chitfund scam and is at present out on bail.

Pal and Satabdi Roy are two-time MPs of the TMC, both having earlier won in the 2009 elec-

The TMC supremo had also made Bollywood star Mithun Chakraborty a Rajya Sabha MP. But he had resigned in December 2016 citing ill health.

The trend of cine stars joining electoral politics has been a regular affair in the southern states, with former Tamil Nadu chief minister MG Ramachandran as the pioneer and Rainikanth and Kamal Haasan being the latest entrants.

Andhra Pradesh is another state where film

stars enjoy cult status and have made serious forays into politics, with NT Rama Rao having become chief minister of the state. In other parts of the country, film stars like Raj Babbar, Hema Malini, Vinod Khanna have been in politics and even mega star Amitabh Bachchan had a short tryst with it.

Film stars have, however, generally stayed away from electoral politics in West Bengal, where it has traditionally been viewed as a forte of those who grow from the ranks, barring one or two exceptions. The so-called glass ceiling was broken in 2009 when Satabdi Roy and Tapas Pal, both of whom were doing films regularly then, were fielded by the TMC chief and won.

The BJP has also brought in film personalities and those associated with it in West Bengal politics. Babul Supriyo, a playback singer who also dabbled in film acting, was one of the two BJP candidates who won in the 2014 Lok Sabha elections from West Bengal. He was also made a minister of state.

Actor Roopa Ganguly, who achieved national fame for her portrayal of the role of Draupadi in mega teleserial Mahabharat, is a Rajya Sabha MP of the BJP.

Bengal inks wage agreement with jute industry, CITU stays away



KOLKATA, MAR 14 (PTI): The West Bengal government has signed a wage agreement with the jute industry to ward off an impending strike in the mills, officials said Thursday.

agreement. which was signed late on Wednesday, came into effect from today, Labour Minister Malay Ghatak said.

As per the fresh agreement, new workers would get a maximum of Rs 385 per day, from the existing Rs 257.

In January this year, the state government had raised the wages for new joinees to Rs 327 a day as interim relief.

A worker is also entitled to get Rs 385 a day if his attendance is at

least 24 days in a month, failing which the wage would be reduced to Rs 370 a day.

The new agreement came in the backdrop of an indefinite strike call from March 15 by trade unions demanding wage revision and implementation of Minimum Wages Act, among others.

As many as 21 trade unions, barring Indian National Trinamool Trade Union Congress, had called the strike.

However, the Centre of Indian Trade Unions (CITU), stayed away from the fresh wage agreement terming it as "nti worker".

"The state government has budged before the jute mills management and forced an anti-worker wage agreement which is not acceptable to us. We have not ratified the deal," CITU backed Bengal Chatkal Mazdoor Union secretary Anadi Sahu said.

Out of 21 trade unions, 6 left Front backed trade unions have not signed the agreement. But other major trade unions including the Congress-backed IN-TUC, BIP's BMS, and Trinamool congress trade union INTTUC have signed the agreement last night, he said.

"There is merely a Rs 2 hike per day for the 2.5 lakh existing workers which is just not acceptable to us," Sahu said.

He said the CITU will soon announce its next

Offering her "Heartfelt tribute to all those who lost their lives," she said in a social media message, adding that "Farmers are our pride and our government is working for their allround development."

villagers were killed in firing at Nandigram. Many bodies could not be found. It was a dark chapter in the history of the State," she said in a tweet message.

"In memory of those who lost their lives in Nandigram, we observe March

every year and give away the Krishak Ratna awards," Banerjee said.

Banerjee, who had spearheaded campaign against acquisition of arable land for setting up industries at Nandigram and Singur by the then CPI(M)-led Left Front government in the state, reaped rich dividends in the 2008 panchayat elections with the TMC winning 50 per cent seats.

Following the year-long Nandigram movement, that had started with the death of six protesters in firing by alleged CPI(M)-sheltered goons on January six, 2007, the TMC gained huge political ground in the state, where the Left Front was in power since 1977.

Banerjee, who went to Nandigram "On this day, in 2007, innocent several times to lead the protests despite violent attempts to stop her, was the lone winning candidate of her party in the 2004 Lok Sabha elections.

TMC went on to win 19 seats in the 2009 Lok Sabha elections and wrested power from the Left in the state in 2011 Assembly elections.



Mane double breaks Bayern to send Liverpool through

MUNICH, MAR 14 (AFP): Sadio Mane scored twice to steer Liverpool into the Champions League quarter-finals after a superb 3-1 win at Bayern Munich dumped out the German giants.

Having missed the goalless first leg at Anfield three weeks ago through suspension, Virgil van Dijk's long pass led to Mane's excellent first-half goal at the Allianz Arena on Wednesday.

"His first goal was ridiculous, the calmness with how he's finished it off," Liverpool midfielder James Milner told BT Sport.

"He's on fire at the minute and let's hope it continues for the rest of the season."

Dutch centre-back Van Dijk then headed last season's runners-up Liverpool into a 2-1 lead from a Milner corner on 69 minutes after Joel Matip's own goal had handed Bayern a first-half equaliser.

Mane made absolutely sure of Liverpool's place in the quarter-final draw by nodding in six minutes from time.

Liverpool's 3-1 aggregate victory means they join Tottenham Hotspur, Manchester City and Manchester United in the quarter-finals, completing a clean sweep of English sides reaching the last eight for the first time since 2008/09. "It is good for En-



glish football -- that's what you want," added Milner.

"We have good feelings from last year, so hopefully we can carry that on and go as far as we can."

It is a bleaker picture in Germany as Bayern's exit leaves no Bundesliga club in the quarters for the first time since 2005/06. as Borussia Dortmund and Schalke also bowed out in the last 16 -- to Tottenham and Man City respectively. This is the first time since 2011 that Bayern have failed to make the quarter-finals.

"Both teams were very cautious for a long period, but the second goal took the belief out of us," said Bayern defender Mats Hummels. "Jurgen Klopp is good at neutralising the opponents' strengths and he did that once again.

"We didn't play well enough to create enough clear chances at this level." - HENDERSON FORCED OFF -

Milner was preferred to Fabinho in Liverpool's midfield, but Jurgen Klopp was forced into an early change when captain Jordan Henderson hobbled off on 12 minutes.

Brazilian Fabinho made an early entrance and Milner took the skipper's armband.

Klopp had urged his side to "be brave on the ball" and it was that, combined with an amazing piece of skill by Mane, which gave them

Van Dijk's pin-point pass over 40 metres found Mane in the Bayern box with goalkeeper Manuel Neuer off his line.

Mane spun away and looped his shot inside the far post to give the visitors a valuable away goal in the 26th minute.

The bravery Klopp wanted flowed through the Liverpool ranks and Milner, winning the midfield battle, set Firmino free in the box, but the Brazilian blasted his shot at Neuer.

However, the hosts drew level six minutes before the break when Serge Gnabry slipped his marker Andrew Robertson and hit a cross intended for Robert Lewandowski.

The ball went in off Matip, who was focused on marking the Polish striker, to the despair of the Liverpool centre-back and the delight of the home crowd.

The tempo of the game dropped sharply after the restart, but Bayern wasted a chance on the hour mark when Gnabry fired in a cross, only for Lewandowski to mistime his slide.

Liverpool were heading for the quarter-finals when Milner swung in the second of two corners in quick succession and Van Dijk powered a header past Neuer.

Mane scored his second when Mohamed Salah's chip found him at the far post to head home his sixth goal in four matches, as Liverpool's travelling fans started singing

"You'll Never Walk Alone", while the Bayern supporters began to slip away.

After BCCI complaint, police files case in Rs 80 lakh fraud over selection in Ranji teams

NEW DELHI, MARCH 13 Jharkhand, police said. (PTI): Three aspiring Delhi cricketers had allegedly paid Rs 80 lakh on the promise that they would be selected in the Ranji Trophy teams of three states, but were instead given fake selection letters, a case regarding which has been lodged after cricket board BCCI filed a police complaint, officials said Wednesday.

The case of cheating was registered after BC-CI's regional integrity manager of its Anti Corruption Unit Anshuman Upadhyay stated that they have received three complaints from Kanishk Gaur and Kishan Attri of Rohini and Shivam Sharma from Gurgaon.

They were allegedly duped of Rs 80 lakh on the pretext of getting them selected in the Ranji Trophy teams of Nagaland, Manipur and

Gaur told police that he was approached by a cricket coach last year who offered him to play in the Ranji Trophy team of Nagaland as a guest player, a senior police officer said. He later called him to

meet the official coach of the Nagaland cricket team and some members of their board. He was asked to pay Rs 15 lakh for five matches, the officer said. But after playing two matches for the under-19 team of Nagaland, he was asked not to play and when he inquired. he was told that his selection letter was forged, the officer said.

Around eleven people, including coaches as well as state cricket board members are being questioned in connection with the case, police said.

Series Overview: Plan A in place but what about Plan B?

NEW DELHI, MAR 14 (PTI): India captain Virat Kohli made it clear that he has his Plan A in place but what also became clear in the just-concluded ODI series against Australia was the lack of an effective Plan B ahead of the World Cup starting May 30.

Who is the No.4? Who is the third opener if Shikhar Dhawan continues to fail? Will there be a fourth specialist pace bowling option? Who is the second wicketkeeper? Has Ravindra Jadeja done enough?

These five questions did not find any answers during the 2-3 series defeat.

However, the format of World Cup (round robin) is such that India will have to be at their worst in order to not qualify for the semi-finals. All they need to do is win six out of nine games and take it forward from there.

Then, it's the matter of two good days in office and hence Kohli has less issues to deal with despite a patchy series for his team.

Save the skipper himself (310 runs with two hundreds) and his deputy Rohit Sharma (202 runs with two fifties), the batting didn't come together on a regular basis.

Shikhar Dhawan, Kedar Jadhav or Vijay Shankar had their moments but lack of consistency hurt the team. Mahendra Singh Dhoni as usual, was rock solid behind



the stumps, something that was highlighted even more by Rishabh Pant's fumbles in the final two games. Dhoni's astute cricket brain was not there to support Kohli in crunch situations in the final two games.

In the bowling department, Kuldeep Yadav (10 wickets) was expensive but got wickets while Jasprit Bumrah (7 wickets) did have his off days.

Ravindra Jadeja will still be wondering whether three wickets from four games is good enough or not. India wanted a few answers going into the World Cup with regards to their fringe players but there were more unanswered questions after the conclusion of the final phase of their World Cup

According to Kohli though, he knows his "playing XI going into the World Cup" and only one spot requires to be discussed. However, there remains a big question mark over who will be India's No.4 in the World Cup.

Will it be a floating position given that original choice Ambati Rayudu didn't exactly score those tough runs in Australia, New Zealand and now in India barring one game. If the idea was to give KL Rahul enough chances to settle down, it didn't happen as the Bengaluru-player got only one chance during the series.

The flamboyant Pant was also promoted up the order in the final ODI but he couldn't seal the spot.

Kohli himself came down at No.4 to accommodate Rahul in one game without much success.

So, No.4 does remain a concern with Shreyas Iyer and Manish Pandey not being tried at all during this phase. Kohli didn't indicate which is the one spot the team is looking at but it could well be a toss up between Pant and the more experienced Dinesh Karthik.

It is clear that Hardik Pandya is a far better bowler than Vijay Shankar. Siddharth Kaul was included in the squad for the first two games and not played. Umesh Yadav was dumped after two bad overs.

Yuzvendra Chahal, with lesser variation than Kuldeep, was benched often.

So, the questions remained and hopefully the picture will be clearer by April 20, by the time India announce their final 15.

"Argentina and Colombia are shaping up as joint venues of the Copa America-2020," MEBOL said after rejecting the US offer to host the tournament.

The decision marks the first time in the modern Copa America era that the tournament will be split between two countries.

For us far ahead, we want to enjoy this win first." Asked if the stunning performance makes Australia favourite to defend their World Cup title, Khawaja said, "I'm not sure."

"The World Cup is still pretty far away. We've have played some really good cricket. Moving forward it doesn't matter. There are new games, new teams, new wickets. "After playing cricket for a long time, I know if you look too far ahead you get in trouble. We have got to keep our heads down, keep working hard. Hopefully if we do that, everything else will take care of itself," he added.

Former skipper Steve Smith and David Warner will not be part of the squad for the Pakistan series but are expected to make their way into Australia's World Cup squad.

Asked if the current team members are aware about the competition for slots, Khawaja said, "I don't think anybody is really thinking about that."

In its analysis of the WPI data, CARE Ratings said inflation in the economy has started moving up from the trough reached last month both at retail and wholesale levels.

"The rise in wholesale inflation can be ascribed to increase in primary articles viz food and non-food articles... The build-up inflation so far (April 2018-Feb 2019) was 2.75 per cent, higher than the 2.56 per cent registered in the corresponding period last year," it said. Now, all eyes are on the Reserve Bank of India's (RBI) Monetary Policy Committee, which will be meeting in April for the first bi-monthly monetary policy review of the next fiscal, at a time when growth rate of industrial production is slowing and inflation inching up.

Assault on minister rattles New Zealand lawmakers

WELINGTON, MAR 14 (AFP): A senior New Zealand government minister was assaulted in an early-morning street attack Thursday that left him with a black eye and shook up Wellington's normally laid-back political atmosphere.

Green Party co-leader James Shaw was walking to the parliament building known as the Beehive when a man punched him in the face in what his office described as an unprovoked attack.

While Shaw's office played down any political aspect to the assault, Trade Minister David Parker told reporters the attacker "was said to be shouting things out about the United Nations".

Shaw, who is Climate Change Minister and whose party is part of the ruling centre-left coalition, was not seriously injured.

His office said two members of the public helped him and he continued to parliament, attending a meeting before going to hospital for a precautionary check-up.

He suffered a black eye, telling stuff.co.nz "it looks worse than it is".

Police said a 47-yearold man was arrested and would appear in court Friday charged with injuring with intent.

Political violence is practically unheard of in New Zealand, a nation of about 4.5 million where most government ministers do not have a regular security detail.

Prime Minister Jacinda Ardern said that "in New Zealand, you just don't expect these things to happen".

"We have an environment in New Zealand where politicians are accessible, and that's sometning we snould feel proud of," she told reporters.

"We are after all, here to serve people. But today's events really show we cannot take that for granted." Wellington mayor Justin Lester said it was "a sad day for democracy".

"This is outrageous behaviour and if undertaken by a Wellingtonian, shameful," he tweeted.

"Elected representatives of all hues show courage to represent New Zealanders and we are lucky to have unparalleled access to them."

There was condemnation from across the political spectrum, with the leader of the conservative National Party Simon Bridges tweeting: "Violence is never OK."

Ardern said Shaw had told her he was doing fine" and she had told him to take whatever time off he needed to recover.



Defying Trump, Senate votes to end US support for Yemen war



WASHINGTON, MAR 14 (AFP): The US Senate has dealt a stinging bipartisan rebuke to Donald Trump's foreign policy and his alliance with Riyadh, voting to end support for the bloody Saudi-led war effort in Yemen.

Lawmakers in the Republican-controlled chamber approved on Wednesday a historic curtailment of presidential war powers that directs Trump "to remove United States Armed Forces from hostilities in or affecting the Republic of Yemen" within 30 days.

The Senate vote was 54 to 46, with seven Republicans defying the president and aligning with Democrats.

The text now heads to the Democrat-led House Representatives, which approved a similar measure that stalled earlier this year, and which is likely to pass the latest effort.

The White House has threatened a veto, calling the measure "flawed" and saying it would harm bilateral relationships in the region and hurt Washington's ability to fight extremism.

But its full passage would set a historic marker. It would be the first measure passed by Congress to invoke the 1973 War Powers Resolution to directly curtail a president's use of military powers.

"Today, we begin the process of reclaiming our constitutional power by ending US involvement in a war that has not been authorized by Congress and is clearly unconstitutional," Senator Bernie Sanders, who is running for president in 2020 and is a sponsor of the measure, said on the Senate floor.

Republican Senator Mike Lee concurred, saying Saudi Arabia "is not an ally that deserves our support or our military intervention." The Saudis, he said, "are likely using our own weapons... to commit these atrocities of war.

The war in Yemen is the world's worst humanitarian crisis, with an estimated 14 million people at risk of famine.

That's not OK."

The World Health Organisation says about 10,000 people have been killed in the war between forces loyal to the Yemeni government, backed by the Saudi-led coalition, and the Iran-aligned Huthi rebels. Rights groups say the death toll is far higher.

The United States provides weapons and refueling to the Saudi coalition.

The resolution is a reminder that Congress has the legal ability to compel the removal of US military forces, absent a formal declaration of

Should it pass Congress, it could force Trump to issue the first veto of his tenure.

The vote may well be the first of two congressional rebukes of Trump in as many days.

On Thursday, the Senate is expected to vote on a resolution already passed by the House to reverse Trump's emergency declaration on border security, after the president went around Congress in a bid to secure more funding for his wall between the United States and Mexico.

In that case too, he has promised to use his veto.

Wednesday's Yemen vote, and the rare bipartisanship at the heart of it, came as US lawmakers have escalated their opposition to Saudi Arabia after the October murder of Saudi journalist Jamal Khashoggi at the kingdom's consulate in Istanbul.

Republicans Democrats alike have bristled over the White House's apparent embrace of the kingdom and its leadership.

Some members of Congress have publicly stated that they suspect that powerful Crown Prince Mohammed bin Salman was directly responsible for the killing, based on the CIA's conclusions.

Sanders, using unusually blunt language about an American ally, said the United States should not "simply follow the despotic lead of a government in Saudi Arabia." "We will determine our military and foreign pol and not be led around by a murderous regime," he said.

UK MPs vote against leaving EU without a deal, set to delay Brexit day

London, Mar 14 (PTI): British MPs have voted to reject the possibility of the UK leaving the European Union without a withdrawal agreement in place, raising prospects of delaying the March 29 deadline for the divorce to end months of political deadlock.

After her Brexit deal was heavily voted down for a second time on Tuesday, Prime Minister Theresa May announced a government motion ruling out a no-deal Brexit on March 29. May promised MPs a

free vote, but the motion was carefully worded, with the final sentence stating that, "leaving without a deal remains the default in UK and EU law unless this house and the EU ratify an agreement . The motion said the UK should not leave the EU without a deal specifically on March 29, but with the option of a no-deal Brexit at any other time. The government wanted to keep control of the Brexit process, and keep nodeal on the table.

MPs voted by 312 to 308 to support a backbench amendment which struck out that last phrase so as to rule out a no-deal exit altogether.

In chaotic scenes, the government then rescinded its promise of a free vote; and whipped its MPs to vote against the amended motion.

Several cabinet ministers who have warned about the risks of a nodeal Brexit, including Philip Hammond and Amber Rudd, appeared to abstain, but the government still lost the vote, by 321 votes to 278 a majority of 43.

This would now require the Commons to pass a new vote, expected on Thursday, which will authorise May to go back to the EU and seek an exlegal mechanism for Britain's exit from the union. May said there was a "clear majority" against a no-deal Brexit but the

"legal default" was that the UK would leave without a deal on March 29 if no deal is reached unless that is legally changed with another vote and EU ratification.

"The legal default in UK and EU law remains that the UK will leave the EU without a deal unless something else is agreed. The onus is now on every one of us in this House to find out what that is," May said in her statement soon after another long Brexit day in the Commons.

She also warned that any extension to the Brexit deadline will be pointless unless the House also set out a plan for the kind of deal it can support.

MPs also voted by 374 to 164 to reject a plan to delay the UK's departure from the EU until May 22, so that there can be what its supporters call a "managed no-deal" Brexit.

Opposition Labour leader Jeremy Corbyn said that Parliament must now take control of the Brexit process and his party will work across the House of Commons to seek a compromise solution.

He said: "In the last 24 hours Parliament has decisively rejected both her [May] deal and no deal.

"While an extension of Article 50 is now inevitable, responsibility for that extension lies solely and squarely at the Prime Minister's door."

All eyes will now be on a vote on Thursday, which is most likely expected to seek an extension to the time available for the UK to negotiate a new divorce arrangement with the EU.

This would have to be ratified by the EU and the length of extension will become the next focus on both sides. However, how tension to Article 50 the the EU will react to an extension request remains unclear at this stage, given that it is preparing for its own EU elections towards the end of May.

China defends blocking Azhar terror listing, says it will help in finding lasting solution

BEIJING, MAR 14 (PTI): China on Thursday sought to defend its fourth technical hold at the UN Security Council to block the designation of Pakistan-based JeM chief Masood Azhar as a global terrorist, saying it would help the parties concerned to engage in more talks to find a "lasting solution" acceptable to all.

The proposal to designate Azhar under the 1267 Al Qaeda Sanctions Committee of the UN Security Council was moved by France, the UK and the US on February 27, days after a suicide bomber of the Jaish-e-Mohammed (JeM) killed 40 CRPF soldiers in Jammu and Kashmir's Pulwama, leading to a flare-up in tensions between India and Pakistan.

The Al Qaeda Sanctions Committee members had 10 working days to raise any objections to the proposal. Just before the deadline ended, China put a "technical hold" on the proposal seeking "more time to examine" it.

The proposal was the fourth such bid at the UN in the last 10 years to list Azhar as a global terrorist.

Asked why China once again resorted to block the move, Foreign Ministry spokesman Lu



ing here that Beijing's decision is in line with the rules of the committee.

China "sincerely hopes that relevant action taken by this committee will help relevant countries to engage in dialogue and consultation and prevent adding more complicated factors into regional peace and stability," he said.

"As to the technical hold at the 1267 Committee our action is to make sure that the committee will have enough time to study the matter so that the relevant sides will have time for dialogue and consultation," Lu said.

"Only a solution that is acceptable to all sides could fundamentally provide a chance for a lasting solution to the issue. China is ready to communicate and coordinate with all sides including India to properly handle this issue," he said.

The Security Council 1267 Committee has clear standards on the

nating terrorist organisations and individuals, Lu said.

"China conducts thorough and in-depth assessment of these applications and we still need more time, so that is why we put forward the technical hold," he said.

India Wednesday expressed disappointment soon after China put a technical hold on designating Azhar.

The External Affairs Ministry in New Delhi said India will continue to pursue all available avenues to ensure that leaders of terror groups involved in heinous attacks on Indian citizens are brought to justice.

"This has prevented action by the international community to designate the leader of Jaish-e-Mohammed (JeM), a proscribed and active terrorist organization which has claimed responsibility for the terrorist attack in Jammu and Kashmir on February 14," the MEA said.

Without naming China, it said the UN's 1267 Sanctions Committee was not able to come to a decision on the proposal for listing Azhar on account of a member placing the proposal on hold.

To another question on the Wuhan summit between Prime Minister Narendra Modi and Chinese President Xi Jinping last year to improve the bilateral relations, Lu said, "Xi and Modi met four times. Particularly Wuhan summit made great progress. China is full of sincerity and ready to work with India to build on the consensus of our leaders for greater progress in the bilateral relations."

On the Kashmir issue, Lu said China's position on it is clear and consistent.

"This is an issue that is left over between India and Pakistan. We hope that the two sides will engage in friendly dialogue consultation and solve this issue and other related issues," he said.
