The declaration might ■ not be legally binding, but it is a public commitment nevertheless, one which could see the Sikkim Government replace its fleet of fuel-guzzling, smoke-spewing vehicles with zero-emission variants in as few as 14 years.

COP presidency underway at Glasgow currently, the Declaration aims to rapidly accelerate the transition to zero emission vehicles to achieve the goals of the Paris Agreement.

"Together, we will work towards all sales of new cars and vans being zero emissionglobally by 2040, and by no later than 2035 in leading markets," the declaration reads.

As for Sikkim's specific commitment pledged to yesterday, the declaration reads: "As cities, states, and regional governments, we will work towards converting our owned or leased car and van fleets to zero emission vehicles by 2035 at the latest, as well as putting in place policies that will enable, accelerate, or otherwise incentivise the transition to zero emission vehicles as soon as possible, to the extent possible given our jurisdictional powers."

While results of policy incentives to promote zero-emission vehicles is out of the hands of the State Government, converting its own fleet to zero emission vehicles is something it can deliver.

However, there is no official confirmation of this pledge from the State Government and senior officials were not in the know of things till the time this report was filed. It remains unclear as to who or which agency represented Sikkim at the COP26 deliberations of this declaration vesterday. CM releases Sikkim Adhoc **Teacher Regularisation Policy** on National Education Day

Chief Minister PS Tamang today released the Sikkim Adhoc Teacher Regularisation Policy at the National Education Day celebration organised by the All Sikkim Ad-Hoc and Temporary Employees Association here at Saramsa Garden.

Writing about the policy in a Facebook post, the CM observed: "The people of Sikkim deserve all the accolades for this policy as their trust and faith in us during the general election has led to this change in the previous system."

As per the policy,

adhoc teachers will be eligible for regularisation upon completing eight years of continuous service as on 31 Dec, 2020 and 31 Dec of every year thereafter.

Upon completion of this 8-year tenure, and provided that they meet the minimum NCTE norms, they will qualify for regularisation which will be subject to allocation of budget by the Education Department for that year, availability of corresponding vacancies and recommendation of the Sikkim State Teachers Recruitment Board.



### country lowest in 266 days **NEW DELHI, Nov 11 (PTI):** rate was recorded at 1.10

India added 13.091 new coronavirus infections in a span of 24 hours taking the country's total tally of COVID-19 cases to 3,44,01,670, while the active cases declined to 1.38.556, the lowest in 266 days, according to the Union Health Ministry data updated on Thursday.

The death toll climbed to 4,62,189 with 340 fresh fatalities, according to the data updated at 8 am. The daily rise in new coronavirus infections has been below 20,000 for 34 straight days and less than 50,000 daily new cases have been reported for 137 consecutive days now.

The active cases comprise 0.40 per cent of the total infections, the lowest since March 2020, while the national COVID-19 recovery rate was recorded at 98.25 per cent, the highest since March 2020, the ministry said. A decrease of 1,127 cases has been recorded in the active COVID-19 caseload in a span of 24 hours.

The cumulative doses administered in the country so far under the nationwide COVID-19 vaccination drive has exceeded 110.23 crore. India's COVID-19 tally

had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19.

India crossed the grim milestone of two crore on May 4 and three crore on June 23.

The 340 new fatalities include 259 from Kerala and 17 from Maharashtra.0f the 259 deaths, 48 were reported over the last few days and 211 were designated as Covid deaths after receiving appeals based on the new guidelines of the Centre and Supreme Court directions, a Kerala state government release said on Wednesday.

A total of 4,62,189 deaths have been reported so far in the country including 1,40,447 from Maharashtra, 38,131 from Karnataka, 36,247 from Tamil Nadu, 34,621 from Kerala, 25,091 from Delhi, 22,904 from Uttar Pradesh and 19,267 from West Bengal. The ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

"Our figures are being reconciled with the Indian Council of Medical Research," the ministry said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.

#### 38 injured as skulk of foxes attack Bengal village ENGLISH BAZAR (WB), **Nov 11 (PTI):** At least 38 people were injured in an attack by a skulk of foxes in West Bengal's Malda district on Thursday, police said.

The incident happened in Hardam Nagar village in Harishchandrapur police station area, they said.

A skulk of 15-20 foxes attacked several houses in the village at the break of the dawn, injuring at least 40 people as most were caught by surprise, police said.

Twenty of them were critically injured and are undergoing treatment, they said.

The angry villagers then beat two foxes to death, while the rest managed to escape, police said.

"Total 38 people were injured in the attack by the foxes. All of them are being treated at Harishchandrapur Rural Hospital," Harishchandrapur 2 Block Development Officer BijoyGiri said.

"The forest department has been informed and they have already visited the area," he added.

#### Supreme Court reserves decision on widening Char Dhamroads

New Delhi, 11 Nov [NDTV]: The Supreme Court has reserved its decision on widening of roads that are part of the 899-km Char Dham project in Uttarakhand. The court has asked both sides -- the Center and the petitioner non-profit -- to file their written suggestions within two days. The non-profit has asked the court to stop

the widening of roads. The Centre, citing the Chinese build-up on the other side, has appealed for widening the road, which, it said, are feeder roads for the border roads and are of great strategic importance. The Centre has also sought amendment to the top court's order of September 2020, in which the judges kept the Char Dham roads limited to 5.5 meters. The Centre has argued that the roads should be widened up to 10 meters.

During the hearing on November 9, the judges had said the issue was nuanced and the needs of defence and environment have to be balanced. "Defence concerns cannot be over-ridden especially in light of border incidents in the recent past," Justice DY Chandrachud said.

Representing Centre, Attorney General KK Venugopal said "We do not want the troops to be caught in 1962 situation" . "Wide roads are of strategic importance. Trucks carrying artillery, rocket launchers and tanks may have to pass through these roads," the Centre had said, pointing out that China is building "helipads and buildings on the other side".

The petitioner has argued that the army never sought widening of roads. "Someone high up in political power wanted highways on the Char Dhamyatra. And the army then became a reluctant participant".

#### South Africa's last white president of Apartheid era dies at 85

JOHANNESBURG, 11 NOV [AFP]: FW de Klerk, South Africa's last white president, died on Thursday aged 85, his foundation announced.

De Klerk and South Africa's first black president Nelson Mandela shared the Nobel Peace Prize in 1993 for leading the "miracle" transition from white rule in the country.

He died after a battle with cancer, his foundation said in a statement.

De Klerk had announced his diagnosis on his 85th birthday, on March 18 this year.

"It is with the deepest sadness that the FW de Klerk Foundation must announce that former president FW de Klerk died peacefully at his home in Fresnaye earlier this morning following his struggle against mesothelioma cancer," it

He is survived by his wife Elita, children Jan and Susan, and grandchildren.

"The family will, in due course, make an announcement regarding funeral arrangements," it added.

He is most remembered for his famous speech delivered on February 2, 1990, announcing the lifting of a ban on the African National Congress (ANC) and other liberation movements.

In the same speech he ordered the release from prison of anti-apartheid icon Mandela after 27 years in jail.

#### Supreme Court to hear plea of journalist to nix Tripura anti-terror case

New Delhi, 11 Nov [NDTV]: The Supreme Court has agreed to hear a plea by journalist Shyam Meera Singh and two others that seeks to quash a Tripura Police FIR under controversial anti-terror law UAPA for social media posts - including Mr Singh's "Tripura is burning" tweet - made during violence in the state last month.

In addition to Shyam Meera Singh, the plea was also filed by Supreme Court lawyers Ansar Indori (from the National Confederation of Human Rights Organisation) and Mukesh (from the Peoples' Union of Civil Liberties). Both lawyers visited Tripura as part of an independent fact-finding team.

The plea also seeks a court-monitored probe. a declaration that some parts of the UAPA are unconstitutional, argues that states being allowed to use UAPA to criminalise fact-finding will lead to a "chilling effect" on freedom of speech, and "only facts convenient to the government will come out".

The fact-finding team, the plea further states, 'did not question the sovereignty or territorial integrity of India" and that Mr Singh's 'Tripura is burning' tweet was "factual reporting".

A date for the hearing will be fixed shortly, Chief Justice NV Ramana said, in response to the plea by advocate Prashant Bhushan on behalf of Mr Singh and those seeking to quash the police complaint.

"Petition is filed regarding incidents in Tripura and FIRs and notices issued to lawyers who went on a fact-finding mission, and said 'Tripura is burning'... we've challenged several issues, including wide definition of 'unlawful activities'," Mr Bhushan told the top court.

"Why didn't you file before (the Tripura) High Court?" Chief Justice Ramana asked.

To this Mr Bhushan replied: "Because we are questioning UAPA as well, and the case needs to be heard urgently as these people face imminent arrest."

The FIR accuses Mr Singh and the others of spreading "fake news" and "distorted or objectionable" content about what the state government has dismissed as allegations of mosques being vandalised and local Muslim communities being attacked after communal violence in neighbouring Bangladesh.

The journalist and

those named in the complaint, who include lawyers and activists, face charges ranging from criminal conspiracy and forgery to spreading "fake news", and have been booked under controversial anti-terror law UAPA, or the Unlawful Activities (Prevention) Act. The vaguely worded law - the constitutional validity of which has been challenged in the top court - allows authorities to detain people, without charge, for six months.

Last month retired Supreme Court Justice RF Nariman called UAPA a "draconian act".

The 8-year tenure will be verified by a committee which has already been constituted.

Regularisation of services will also be subject to 'satisfactory performance report."

No new posts of any category will be created, the policy also details.

The policy also provides that in case no vacancies are available and/ or the adhoc teacher is found ineligible for regularisation, they can be given regular appointments against vacancies in C and D posts in the Education Department.

Teachers who were within the prescribed age limit at the time of adhoc appointment may be provided age relaxation if they have crossed the age limit at the time when they qualify for regularisation, the policy also provides.

Regularisation will be strictly on the basis of seniority and SSTRB is setting up a screening committee to select suitable candidates for regularisation, the policy adds.

Meanwhile, at the function today, the CM also announced the Government's decision to rename the Sikkim State University to Kanchenjunga State Uni-

In his address, the CM also reiterated the State Government's commitment to make Sikkim an education hub of the country.

"We have constantly provided budget to the education department to achieve our goal of creating and providing world-class education in the state with utmost priority being given to primary education," he writes.

#### **Human rights group questions** fair elections in Libya

CAIRO (AP): A leading rights group questioned Thursday whether Libyan authorities can hold free and fair elections as long as the rule of law, justice and respect of human rights remain absent.

Human Rights Watch's statement came on the eve of an international conference on Libya in Paris where world leaders and Libya's neighbors are pushing for elections to be held as scheduled Dec. 24.

"The main questions leaders at the summit should ask are: can Libyan authorities ensure an environment free of coercion, discrimination, and intimidation of voters, candidates, and political parties?" the New York-based rights group said in its statement.

The group criticized what it said were Libya's restrictive laws that undermine freedom of speech and association, as well as the presence of armed groups accused of intimidating, attacking and detaining journalists and political activists.

Libya has been engulfed in chaos since a NATO-backed uprising toppled longtime dicta-

tor Moammar Gadhafi in 2011. He was captured, and two months later, killed, by an armed group.

The oil-rich country was for years split between rival governments, one based in the capital, Tripoli, and the other in the eastern part of the country. Each side is backed by different foreign powers and militias. The interim government now in charge was appointed in February after months of U.N.backed negotiations to lead the country through elections.

HRW called on Libyan interim authorities to revoke all restrictive laws ahead of the elections and to show "a clear commitment" to holding accountable local and foreign fighters who committed crimes during the Libyan civil conflict.

"The upcoming elections are a chance for a much needed reset in Libya and international leaders should take the opportunity to ensure that when Libyans go to vote, they have the best chance to elect their new president and parliament in a free and fair way," read the statement.

#### 4th fatal hospital fire of pandemic kills 2 in Romania

BUCHAREST, ROMA-NIA (AP): A fire at a CO-VID-19 hospital in Romania killed two people Thursday, authorities said. It was the fourth fatal fire at a Romanian COVID-19 hospital during the pandemic.

The blaze broke out in the infectious disease wing of the hospital in the city of Ploiesti as 21 patients were receiving care, authorities said. Officials identified the two victims as men in their 70s. A nurse who reportedly suffered serious burns was transferred to a hospital in Romania's capital of Bucharest.

The cause of the fire, which was quickly extinguished, was not yet known, but an investigation was underway.

Interim Prime Minister Florin Citu sent his condolences Thursday morning to the families of the fire victims and said "such tragedies must not be repeated."

"I always asked that the hospitals be prepared for wave four," Citu said during a news conference. "We are facing an overload of the medical system due to wave four, and everyone involved must ensure that all measures are taken for the safety of patients.'

In recent weeks, Romania's health care system has grappled with a record number of virus infections and deaths. Romania is the European Union's second-least vaccinated nation, with just 40% of adults fully inoculated against the coronavirus.

More than 1,800 COVID-19 patients in Romania are currently receiving intensive care, and hundreds of people with the disease have died every day for the last month.

The Ploiesti hospital fire follows a string of deadly fires that have afflicted Romania's hospitals during the pandemic. On Oct. 1, a fire tore through a COVID-19 hospital in the Romanian port city of Constanta, killing at least seven people.

Ten people died in November 2020 after a fire engulfed an intensive care unit for COVID-19 patients in the northern Romanian town of Piatra Neamt. Another blaze in January engulfed a ward at Bucharest's MateiBals hospital, killing five people.

#### Meeting discusses ICAR-CIFA funded project on diversified fish culture

Areview meeting was organized for discussion on the Indian Council of Agricultural Research [ICAR]-Central Institute of Freshwater Aquaculture [CIFA] funded project of "Demonstration of diversified fish culture in raceways along different altitudes of Sikkim" at Pakyong, East Sikkim, on 09 Nov, 2021. Director, Dr Saroj Swain, ICAR-CIFA, Pr Scientists, Dr PP Chakrabarty & Dr Padmanav Routray, ICAR-CIFA, Additional Director (Fisheries), CS Rai and few other officials of State Fisheries Directorate along with 15 nearby farmers covered under the project were present in the programme.

A detailed status report on the implementation of the CIFA funded project was presented to the house by Range Officer (Hq), Directorate of Fisheries, Surendra Bhandari. It was informed that under the project nine different varieties of fish seed were stocked in 150 raceways along the different altitudes.

It was also informed that as per the report received from the field the growth of Amur Carp & Grass Carp were found to be very good in all altitudes of Sikkim attaining an average weight of around 500 grams in 8–9 months. The growth of Tilapia below 1200m was very good which was cultured for the first time

in the state. Chocolate Mahseer was also introduced in 10 raceways in the state for the first time. The growth of this fish in altitudes range of below 1000m

good. There is huge prospect in culture of fishes like Chocolate Mahseer and Tilapia in the state as their demand is very high.

#### Russia sends nuclear-capable bombers on patrol over Belarus



MOSCOW (AP): Russia sent two nuclear-capable strategic bombers on a training mission Thursday over Belarus in a show of Moscow's support for its ally amid a dispute over migration at the Polish border.

The Belarusian Defense Ministry said two Russian Tu-160 strategic bombers practiced bombing runs at the Ruzhansky firing range in Belarus. As part of the joint training, Belarusian fighter jets simulated an intercept, the ministry

A pair of Russian Tu-22M3 long-range bombers flew a similar patrol Wednesday, and Belarusian air defense assets practiced intercepting

Russia has strongly

supported Belarus amid a tense standoff this week as thousands of migrants, most of them from the Middle East, gathered on the Belarusian side of the border with Poland in the hope of crossing into Western Europe.

The European Union has accused Belarus' authoritarian President Alexander Lukashenko of encouraging illegal border crossings as a "hybrid attack" to retaliate against EU sanctions on his government for its crackdown on internal dissent after Lukashenko's disputed 2020 reelection.

Belarus denies the allegations but has said it will no longer stop refugees and migrants from trying to enter the EU.

The Belarusian Defense Ministry accused Poland on Thursday of an "unprecedented" military buildup on the border, saying that migration control did not warrant the concentration of 15,000 troops backed by tanks, air defense assets and other weapons.

"It looks more like forming a strike group of forces," the ministry said, adding that the Polish military buildup prompted Belarus to respond with actions "both independently and within the existing agreements with our strategic ally," a reference to Russia.



#### Lose the Jokes, Break the Spine

Humour is necessary to a democracy

Co, now we are country where a stand-up comic is **J**informed that his shows have been cancelled; not because not enough tickets were sold, but because his brand of sharp commentary pokes the wrong bears the kind who have successfully godified media, a feat they pulled off because their thin skin finally got access to easily riled bhakts and pockets the size of small countries. This, at a time when a Prime Minister, who is expected to be a somber statesman, cracks the crudest of jokes and spawns fawning copycats in pottymouthed ministers in the states. Comedians, however, whose job it is to mock and poke, need to hold their tongues out of fear of slipping a punch-line which could offend the powerful because even the comic mirror does not lie. Here, one may recall the tasteless remark that the PM made in Japan at around this time last year when he sniggered that many a marriage reception in India had been burned because of demonetization. The bhakts had laughed along at the time, even applauded. Shortly after, a comedy show censored a skit, dropped it completely in fact, when a mimicry artist aped the PM (and Rahul Gandhi as well). In the five years since, even media houses are suing fellow media houses for defamation for their satirical reviews of propaganda masquerading as news.

We, it appears, are not going to be allowed to stop shaking our heads in disbelief because we have bhakts fulminating over a sarcasm-laced public interest message which called for safer celebrations and a satrap having a melt-down because even though he breaks heads for a religion which has gods with fluid genders, gay couples being sanskari somehow compromises his faith. Our leaders were never known for their tolerance, but intolerance is now being worn on the sleeves leading to a scenario in which bigotry is sold as an essential component of patriotism. Thin-skinned, hard-nosed intolerance has always been the traditional response of those in power. The scary part is that is winning now. There used to be a time when media houses routinely stood up to such muscle flexing, but those days are in the past, now, the advertisers can influence even the HR departments of media houses. The joke, however, is on them now because many of the better journalists forced out of traditional newsrooms have established independent news platforms to which a staggering number of viewers have also migrated.

Meanwhile, intolerance of comedic comment does not manifest as one-off incidents, and form part of a steady progression of suppression of independent thought. It started with mainstream platforms and "regular" news, and after they had been cowed down or co-opted, it has turned to the jesters. This should not have surprised us because those with an inflated sense of self and/or blinkered by rigid ideologies have traditionally been quick to take offence and fast and furious with the pushback.

We make matters worse with self-censorship. Most often, satire, at least the effective ones which land proper punch-lines, ridicule policies and positions, not individuals even if they take the crutch of mimicry to tell the jokes. But who will explain these nuances to click-bait bhakts?

But all of this is about more than just getting embarrassed or scared, it's also about what we are allowing ourselves to become. Laughter, those among the readers who still remember the Reader's Digest will recollect, is the best medicine. It is the salve that helps maintain sanity when there is too much madness around. The moment people have to look around before they crack a joke or laugh to one, you know that their spine has been broken. Who wishes that in a democracy? Societies which lose their sense of humour and their ability to laugh at themselves also lose their optimism, faith and democratic instincts and few places prove this better than neighbouring Darjeeling which has allowed its funny bone to fracture and has now calcified into easy aggression and a perpetual victimhood syndrome. Come on, even monarchs realized the effectiveness of humour as a safe release for festering discontent and allowed jesters to mock and joke even in their presence. Force this out of the system and resentments will fester and harden into spite and hate to eventually explode because release valves have been too tightly shut.

## What the world can learn from the Buddhist concept loving-kindness

s the world deals with the trauma caused by  $oldsymbol{A}$ COVID-19, World Kindness Day, observed on Nov. 13 annually, is a good opportunity to reflect on the healing potential of both large and small acts of kindness. Indeed, it was the kind acts of essential workers that helped save many lives.

As a scholar of Buddhist studies, I have researched the ways in which Buddhist monks talk about kindness and compassion toward all beings.

The Dalai Lama has famously been quoted as saying "My true religion is kindness." Although there is more to Buddhism than just kindness, Buddhism's teachings and exemplary figures, I believe, have much to offer to a world experiencing intense suffering.

LOVING-KINDNESS TEACHINGS

Some of the earliest Buddhist teachings developed in India - which are recorded in the Pali canon, the collection of scriptures in the Pali language - emphasized the idea of "metta," or loving-kindness. One teaching from this collection of scriptures is the "Karaniya Metta Sutta," where the Buddha exhorts the good and wise to spread loving-kindness by making these wishes toward all

In gladness and in safety, May all beings be at ease. Whatever living beings there may be; Whether they are weak or strong, omitting none, The great or the mighty, medium, short or small, The seen and the unseen, Those living near and far away, Those born and to-be-born —

May all beings be at ease!

In order to put these words into practice, several Buddhist teachers from North America teach meditation practices meant to develop one's own metta, or loving-kindness.

During meditation sessions, practitioners can visualize people and chant wishes of loving-kindness using variations of phrases based on the Karaniya Metta Sutta. A commonly used version is from a well-known Buddhist meditation teacher, Sharon Salzberg.

May all beings everywhere be safe and well. May all beings everywhere be happy and content. May all beings everywhere be healthy and strong. May all beings everywhere be peaceful and at

Practitioners spread this kindness toward themselves, people close to them, people they do not know - even distant people or enemies - and finally all beings throughout the world. After visualizing this attitude of loving-kindness, practitioners find it is easier to radiate kindness toward others in real life.

In addition to metta, Buddhists also practice compassion (karuna), sympathetic joy (mudita) and equanimity (upekkha) for a peaceful state of

**CULTIVATING COMPASSION** 

Later forms of Buddhism in East Asia and Tibet developed the idea of compassion further through the figure of the bodhisattva.

The bodhisattva is a practitioner who has vowed to work selflessly for the enlightenment of other beings. The development of this state of mind is known as "bodhicitta." Bodhicitta provides the motivation and commitment to this difficult path of putting others before oneself.

One practice for cultivating bodhicitta is ex-

changing self for others. In this practice, those on the bodhisattva path would regard the suffering of others as if it were their own and would offer help to others as if helping oneself.

As the Indian Buddhist monk Santideva writes in his classic eighth-century work on the path of the bodhisattva, "The Bodhicaryavatara," one should meditate with this sentiment in mind: "all equally experience suffering and happiness. I should look after them as I do myself."

MANY BODHISATTVAS AND THEIR MEANINGS

The Buddhist figure most focused on kindness is the bodhisattva of compassion, known originally as Avalokiteshvara, who became popular in India by the sixth century A.D. A popular way to depict Avalokiteshvara is with 11 heads and 1,000 arms, which he uses to benefit all sentient beings. Tibetan Buddhists believe that all Dalai Lamas are manifestations of this bodhisattva.

This bodhisattva is known by various names across Asia. In Nepal, the bodhisattva is known as Karunamaya, and in Tibet as Lokesvara and Chenrezig. In China, the bodhisattva is a female figure called Guanyin and portrayed as a woman with long, flowing hair in white robes, who holds a vase tilted downward so she can drop the dews of compassion upon all beings.

Throughout East and Southeast Asia this is a popular figure. People make offerings to seek help, especially in regards to success in business and starting a family.

With practices that urge people to practice compassion toward others and with figures who can be asked to bestow it, Buddhism offers unique and diverse ways to think about and express kindness.

#### 7 ways to get proactive about climate change instead of feeling helpless: Lessons from a leadership expert

Exhibit A: Climate change is here, and things are changing quickly for the worse. However, even as dangerous and costly weather events grow more frequent and severe, we still don't do what we need to do.

Ideally, everyone would ratchet up their efforts to protect the climate as smartly as possible. But how can each person help in the most valuable ways? As a professor of organizational behavior, I study leadership and proactive problem solving. Research in these fields offers some helpful advice.

UNTAPPED HUMAN POTENTIAL "I'd love to change the world, but I don't know what to do, so I leave it up to you." - Alvin Lee, Ten Years After, 1971

When too many people think like those lyrics, problems don't get

The only way societies will do enough to keep climate change in check is if they reject passivity, experiment with new strategies and tactics, and wisely strengthen their coping repertoire.

People avoid doing much about climate change for many reasons: 1) They worry about time and cost; 2) they believe it's difficult to change; 3) they have faulty assumptions, like feeling unable to help or that other people or new technologies will save the planet; 4) they have psychological biases, like caring more about the present than the future; and 5) they're uncertain about the best ways to participate.

Laying a foundation for higherimpact action begins with changing common mindsets. Most essential, responsibility for fixing things on

more proactively than most people blame game, fossil fuel companies have up until now.

Based on psychological and organizational behavior research, here are some starting points:

1) View yourself as someone who cares about the planet and the future.

Your self-identity is how you view and describe yourself, and this generates corresponding behaviors. How you self-identify can help you think about your future, choose your preferred actions and provide a motivating standard or model to strive for. Take "caring" a step further by viewing yourself as a proactive person who thinks ahead and helps to make the future better than it would be without your contributions.

2) Assess, honestly, your efforts to reduce the harmful effects of climate

In the same way people tend to overestimate their driving, athletic and leadership skills, they also tend to believe they are more environmentally friendly than most other people. This misleading bias can breed complacency and hinder action.

If people assess themselves accurately compared to what they could and should be doing, most will see great untapped potential to make a difference. To unleash that potential, consider applying time management strategies found in business management that can free you from countless unpleasant and unproductive tasks and allow you to devote attention and time to impactful activities that take most advantage of your skills.

3) Assume responsibility for engaging more usefully in solving the problems of climate change.

Feeling responsible motivates action. A key question is how you define responsibility.

This is different from pinning all

> 4) Resolve to actively navigate the changing future.

> In general, thinking more about the future - rather than just the present and past - yields more positive life and work outcomes. Regarding climate change, it is imperative to look ahead and act accordingly so you're helping to forge the best possible outcomes rather than leaving them to chance.

> Today's leading psychologists strongly advise more mental prospecting - actively envisioning likely and possible futures, exploring for opportunities like old-time gold prospectors and salespeople searching for new leads - and continually seeking the best pathways forward.

> 5) Learn more about humanity's biggest challenges.

> Climate change affects everything, so it shouldn't be hard to find an arena that's personally interesting. Learn enough from accurate sources to discuss with others, consider how your skill sets can help and figure out where you can contribute best.

> Here are a few places to start: Project Drawdown offers big-picture solutions for lowering greenhouse gas emissions. NOAA provides advice for what individuals can do and where to learn more. The BBC had a good list of 10 simple ways to take action on climate change a few years ago. Climate scientist Michael Mann's new book discusses what individuals can do politically and collectively for the highest impact.

6) Help solve problems and seek

This approach opens conversations about long-term change rather than just short-term damage control. It also uncovers diverse views, addresses underlying problems rather than just their visible symptoms and encourages more ideas - thus enhancing problem-solving.

> 7) Address the root causes and embrace "multisolving."

In solving business problems, it's important to not simply treat the most visible symptoms but to identify and address root causes. "Multisolving" identifies solutions that address a root cause of multiple problems.

Climate change is one root of many current problems, from disasters and species extinctions to food and water shortages to social injustice and wars. Military officials often refer to it as a "threat multiplier." Stopping climate change could help alleviate pressures elsewhere. Backing up further in the cause-and-effect chain, carbon emissions cause global warming and climate change.

So, personal efforts to reduce your "carbon footprint," like using less fossil fuel, help. So does pushing politicians and businesses to reduce carbon and methane emissions by limiting fossil fuel extraction and investing in zero-carbon energy.

The best climate solutions will reduce harm and spread all kinds of benefits. Stabilizing the climate will require help from every direction. It isn't just an "all hands on deck" moment - the planet needs all heads and hands being proactive.

The swearing-in-ceremony began with the playing of the National Anthem in instrumental and ended with prerecorded singing of the state anthem 'O MorAponarDesh'.

BJP candidates Talukdar, Kurmi and Borgohain won Bhabanipur, Mariani and Thowra constituencies respectively. All the three were elected as opposition MLAs during the assembly elections held in March-April this year, but later resigned and joined the saffron party.

**UPPL's** Basumatary and Daimary bagged the Gossaigaon and Tamulpur seats respectively.

With these victories in the by-elections, the BJP's strength in the 126-member Assam Assembly has increased to 62 and UPPL's to seven. The other ruling ally AGP, which did not field any candidate in the by-elections, has nine MLAs.

In the opposition camp, the Congress's strength is 27, AIUDF has 15 members, BPF has three and CPI(M) has one MLA. There is also an Independent legislator.

#### 'NZ is strongest cricket team across all formats right now'

ABU DHABI, Nov 11 (PTI): Former England skipper Mike Atherton feels New Zealand is the strongest team across all three formats of the game at the moment after the Black Caps reached their maiden T20 World Cup final.

New Zealand registered a sensational five-wicket win over favourites England here on Wednesday in the first semifinals. It would be their third final appearance at an ICC global event in as many years.

Over the past few years, the Black Caps have proved themselves to be a force in all three formats. They reached the final of the ODI World Cup in 2019, losing to England on boundary count and are the holders of the inaugural World Test Championship title.

"They are an outstanding team, in all formats of the game really," Atherton told 'Sky Sports'. "They are through to another World Cup final, they were a sliver away from winning the last World Cup in 2019, they are the World Test Championship winners.

"Across formats, you would have to say they are the strongest team at the moment so congratulations to them, a fantastic achievement with limited resources in terms of personnel and money and things that we've often talked about," he added. Chasing 167, the Black Caps were on the back foot when star opener Martin Guptill and skipper Kane Williamson were dismissed by Chris Woakes inside the first three overs of the reply.

England kept mounting pressure but opener Daryl Mitchell and Jimmy Neesham had other plans. Mitchell blazed his away to an unbeaten 47-ball 72 before Neesham hit a flurry of sixes to give New Zealand the win. "It just changed so quickly tonight. For a long time in that chase, I thought England were ahead of the game," Atherton said.

"The pitch looked two-paced and sluggish, no one really got going and suddenly Neesham comes out and changed that game with some fantastic hitting," Atherton said.

Pakistan take on Australia in the second semifinal and Atherton feels the former champions have the edge over Aaron Finch and Co.

"I'm going with Pakistan, I think they have got the best and most varied attack in this competition.

"You think of that attack: Shaheen Shah Afridi, HarisRauf, the spinners, the combinations that they have so I reckon they got the best attack and I think they will win it," he said.

## No fresh COVID-19 case in Andamans

The COVID-19 tally of Andaman and Nicobar Islands remained unchanged at 7,665 as no fresh infection was detected on Thursday, a health bulletin said.

The Union territory's coronavirus death toll also remained unchanged at 129 as no fresh fatality was registered, it said. The archipelago now has nine active cases, while 7,527 people have been cured of the disease to date.

The administration has thus far tested over 6.11 lakh samples for CO-VID-19, and inoculated over 2.94 lakh people, of fully vaccinated, it said.

#### Saudi Arabia denies playing climate saboteur at Glasgow

**GLASGOW, SCOTLAND (AP):** The tighting to be ambitious" when it comes to fast est of smiles on his face and the fabric of his traditional thobe swirling about him as he strides through a hallway at U.N. climate talks, Saudi Arabia's energy minister expresses shock at repeated complaints that the world's largest oil producer is working behind the scenes to sabotage negotiations.

"What you have been hearing is a false allegation, and a cheat and a lie," Prince Abdulaziz bin Salman al Saud said this week at the talks in Glasgow, Scotland. He was responding to journalists pressing for a response to claims that Saudi Arabia's negotiators have been working to block climate measures that would threaten demand for oil. "We have been working well" with the head of the U.N. climate talks and others, Prince Abdulaziz said. Negotiators from about 200 countries are coming up against a weekend deadline to find consensus on next steps to cut the world's fossil fuel emissions and otherwise combat climate change.

Saudi Arabia's participation in climate talks itself can seem incongruous a kingdom that has become wealthy and powerful because of oil involved in negotiations where a core issue is reducing consumption of oil and other fossil fuels. While pledging to join emission-cutting efforts at home, Saudi leaders have made clear they intend to pump and sell their oil as long as demand lasts.

Saudi Arabia's team in Glasgow has introduced proposals ranging from a call to quit negotiations — they often stretch into early morning hours — at 6 p.m. every day to what climate negotiation veterans allege are complex efforts to play country factions against one another with the aim of blocking agreement on tough steps to wrench the world away from coal, gas and oil.


That is the "Saudis' proposal, by the way. They're like, let's just not work at nights and just accept that this is not gocuts in fossil fuel pollution that is wrecking the climate, said Jennifer Tollmann, an analyst at E3G, a European climate think tanks. And then "if other countries want to agree with Saudi, they can blame Saudi Arabia," Tollmann said.

Saudi Arabia long has been accused of playing a spoiler in the climate talks. and this year it is the main country singled out so far by negotiators, speaking privately, and observers, speaking publicly. Russia and Australia are also lumped in with Saudi Arabia at the talks as countries that see their futures as dependent on coal, natural gas or oil, and as working for a Glasgow climate deal that doesn't threaten that.

Despite efforts to diversify the economy, oil accounts for more than half of Saudi Arabia's revenue, keeping the kingdom and royal family afloat and stable. About half of Saudi employees still work for the public sector, their salary paid in large part by oil.

And there's China, whose dependence on coal makes it the world's current biggest climate polluter. It argues it can't switch to cleaner energy as fast as the West says it must, although the United States and China did jointly pledge to speed up their efforts to cut emissions. A core issue in the talks: Scientists and the United Nations say the world has less than a decade to cut its fossil fuel and agricultural emissions roughly in half if it wants to avoid more catastrophic scenarios of global warming. Not surprisingly, island nations that would disappear under the rising oceans at a higher level of warming are the bloc at Glasgow pushing hardest for the most stringent deal out of this summit.

Meanwhile, climate advocates accuse the United States and European Union of so far failing to throw their weight behind the demands of the island nations, although the U.S. and E.U. often wait until the last few days of climate talks to take hard stands on debated points.



## Full house: F1 is Brazil's biggest event since pandemic hit

SAO PAULO, Nov 11 (AP): Organizers at Interlagos are aiming for a triumphant return to the Formula One circuit this weekend, with all 170,000 tickets sold for the three days of action.

Formula One cut Brazil from its 2020 calendar because of restrictions in place for the COVID-19 pandemic.

Race organizers and local authorities on Wednesday said the 2021 edition will be the biggest total attendance for an event in Brazil since the virus hit the nation.

The Sao Paulo Grand Prix, renamed for this year after a company tried to take the race back to Rio de Janeiro, was allowed to open for full capacity only weeks ago when the state government eased restrictions for November.

Brazil has reported more than 610,000 deaths from the coronavirus, but the rate has sharply reduced all over the country. More than 57% of its people aged 12 and over are now fully vaccinated. Those figures are at around 70% in Sao Paulo.

Ticket sales began in June, with every batch sold within minutes. Prices ranged between 650 Brazilian reals (100)



and 12,800 Brazilian reals (2,300). We will have a full home after a difficult year, race organizer Alan Adler told a news conference.

We didn't know whether we would have a Grand Prix, then whether we would have people attending, and today we are celebrating we will have 100% of our attendance. Interlagos will host the 19th of the 22 races of the season.

Mercedes now leads Red Bull by just one point in the constructors' championship.

Brazil have shown multitudes of fans to largely ignore those protocols as soon as action begins.

We are ready to take 20% more attendance in comparison with 2019, so we added to our structures," Adler said, crediting the success in attendance to younger fans. Previously, parents dragged their children to the race here. Now it is seems to be children taking their parents to Interlagos, he said.

Many analysts expected Formula One to lose some interest in Brazil due to the absence of local drivers on the grid and a move that took the series off the screen of Brazil's popular TV Globo. But organizers said that did not materialize; there are only a few VIP seats on sale for Sunday's race.

Interlagos will also have the extra ingredient of holding the season's third qualifying sprint race on Saturday. The two previous qualifying sprint races were held at Silverstone and Monza.

The grid for the Sao Paulo GP will be determined by the result of Saturday's race instead of the traditional timed lap qualifying format, which will take place on Friday instead to set the positions for the sprint race.

#### Andy Murray beats top seed Sinner to reach Stockholm QF



**STOCKHOLM, NOV 11 (AP):** Andy Murray defeated top-seeded Jannik Sinner 7-6 (4), 6-3 to reach the quarterfinals of the Stockholm Open.

It was Murray's second victory over a top-10 opponent in the past two weeks after the threetime Grand Slam champion, who has had two hip surgeries, beat Hubert Hurkacz in Vienna.

Murray broke the 20-year-old Italian, who is ranked 10th, twice in the second set on his way to victory on Wednesday.

In the opener, he took his first set point after having saved the only break point.

It's probably my best win this season, said the 34-year-old Murray, a former world No. 1. The Briton has reached just his second ATP Tour quarterfinals in the last two years.

Obviously, if I want to move back up the rankings and have good runs in tournaments again, I need to win these matches, said Murray, who is ranked 143rd. I want to have a deep run here.

He next faces Tommy Paul, who upset doubles partner and fifth-seeded Taylor Fritz 6-4, 6-4.

Earlier, Denis Shapovalov finally got to launch the defense of his Stockholm title from 2019, beating qualifier Andrea Vavassori 7-6 (1), 6-1 to reach the quarterfinals.

The 22-year-old Canadian has had to wait two years to defend the only ATP title he has won in his short career, with the 2020 edition canceled because of the coronavirus pandemic.

It felt amazing to be back here, the thirdseeded Shapovalov said after breaking Vavassori's serve three times in the last 16.

Shapovalov, ranked No. 18, will next play Arthur Rinderknech after the Frenchman's 6-4, 6-1 win over JozefKovalik. Rinderknech had advanced to the last 16 after his first-round opponent, sixth-seeded Alexander Bublik, retired

Fourth-seeded Dan Evans and eighth-seeded Frances Tiafoe also advanced in straight sets and will meet in the quarterfinals.

**DUBAI, Nov 11 (PTI):** Pakistan batters Mohammad Rizwan and Shoaib Malik are suffering from "mild flu" and they could be doubtful starters for the T20 World Cup semifinal against Australia on Thursday.

Rizwan and Malik, who missed the team's training session on Wednesday, though tested negative for CO-VID-19. The team has also cleared the regular testing through the tournament.

"Both players were tested for COVID-19 and both tested negative," 'ESPNCricinfo' reported.

"As with the rest of their squad, they have cleared regular CO-VID-19 testing through the tournament, including one a couple of days ago. That is part of the ICC's policy to encourage teams to test as often as possible," it added.

According to the report, the two players woke up on Wednesday morning with "light flu and low fever" and were first advised to delay practice but were later allowed to give it a miss.

"Pakistan are not overly concerned at the moment about their participation in Thursday's game, and will be reviewing their status in the morning again," the report said. Both players have played key roles in the ongoing tournament and missing the services of either will be a huge blow for Pakistan.

## It's time to prove myself yet again: Geeta Phogat

GONDA (UTTAR PRADESH), Nov 11 (PTI): Ready to take the mat after a three-year break, wrestler GeetaPhogat is not short on inspiration and motivation but a tad nervous about how her second innings will pan out.

Set to turn 33 next month and after giving birth to her first child, a lot of people has been telling her that wrestling won't be the same again for her because not only the sport but also her body has changed in the last three years.

But she is determined to make a successful comeback. After all, there are living examples that motherhood or age are not obstacles for a woman sportsperson.

"A lot of people tell me that age is not on my side. You know how people are. They keep telling me these things," Geeta told PTI as she readies for a comeback after three years at the National Championships

"But look at Maria Stadnik (from Azerbaijan). She is 33-plus and a mother of two. She has four Olympic medals and is a multiple-time world medallist. If you have fitness and you are focussed, you can do it."

"I have worked hard on fitness and it's time to prove myself yet again," the wrestler, who became the first Indian woman to win a Commonwealth Games medal in 2010, said.

One of the first few Indian women wrestlers to make a mark at the



international level, Geeta says that mere thought of leaving the sport sends a chill down her spine.

"I have got a lot of success in my career but I have not yet got that feeling that it's time to quit. The sport is in my blood. I have been doing it for 20 years.

"Mann nahimaantachhodneka. The thought of leaving the sport scares me. I have Paris Olympics in mind," the winner of a bronze medal at the 2012 World championship added.

Geeta has spent the last few weeks at an Akhara (training centre) run by his husband PawanSaroha's relatives in Delhi. She has trained only with male wrestlers, which has advantages as well drawbacks.

She talks about both.

"There are not enough strong girls in this Akhara, so I have trained with the men's wrestlers there. So strength and stamina is not an issue. I can say that I am fitter than I was when I took the break three years back," said Geeta. "I'm not nervous about wrestling but I am coming back to the mat after a long time, so what I keep thinking about is how I am going to react to it now. I have not trained with girls, so I have no clue if I am strong or weak for my opponents. I don't know at what level my game stands today.

"When I will train with girls only then I can have a right assessment. Stamina, fitness and training have been good leading up to the Nationals. Even my family says that they see in me the same Geeta, that was at her best in 2012 but only competition will tell," she said.

Geeta acknowledged that the standard of women's wrestling has gone several notches up. They do not make just the number in India's travelling squad. They are treated with respect and considered a threat.

"The standard of women wrestling has really gone up in India. It's at a different level now. Wrestling has become fast now.

"Now we work more on sharpening technique and playing smart. The government is also now supporting sports persons and that is also making a huge difference."

So, does it make a

bit jittery since her opponents, especially SaritaMor, will prove to be a tough challenge? "I won't say I am feel-

"I won't say I am feeling pressure on comeback but that apprehension is there about how I am going to do in this fresh beginning. I still want to win medals for my country.

"I have wrestled with Sarita 5-6 times in the past. She has a strong defence and my game is a mixed one. But I am ready for the fight.

## We are devastated but proud of our performance: Morgan ABU DHABI, NOV 11 (PTI): England were

ABU DHABI, Nov 11 (PTI): England were "devastated" to lose to New Zealand in the T20 World Cup semifinals but proud to have fought "unbelievably well", said limited overs captain Eoin Morgan, who hopes to continue as the leader of the side.

New Zealand avenged their heartbreaking loss in the 2019 ODI World Cup final against England on boundary count by beating the same opponents by five wickets in the T20 World Cup first semifinals here on Wednesday.

"Yeah, we're devastated. To be on the wrong side of a close game is not easy to take. We fought unbelievably well on a wicket that didn't necessarily suit our batting, but we managed to post in and around a par score," Morgan said at the post-match press conference.

"I'm extremely proud of the performance that we put in. When you play really well, it doesn't always guarantee that you win games. Unfortunately, we found ourselves on the wrong side of a really tight game today.

"I hope to be back, I am still offering enough, and I love playing in this changing room. Incredibly proud to be their leader," said the 35-year-old, who has led the English T20 side since 2014.

Sent in to bat, England posted 166 for 4 with Moeen Ali remaining not out on 51. The Black Caps chased down the target with one over to spare with opener Daryl Mitchell playing a pivotal role with an unbeaten 47-ball 72.

James Neesham also played an important cameo, hitting an 11-ball 27 with one four and three sixes to take New Zealand to the final.



Morgan said England were in the game till the arrival of Neesham, who completely changed the complexion of the match, playing shots not even his batters could execute on a sluggish pitch.

"We were brilliant with the ball. We were right in the game probably until Jimmy Neesham came to the wicket, if not ahead of the game. Everything worked right up until Neesham came in. It was a fantastic cameo in high-pressure circumstances.

"Throughout those innings everybody struggled to clear the ropes on both sides, that was just the nature of the pitch. You have to take your hat off to him. He played really well. We've played against Jimmy a lot. He's not struck the ball like that against us ever. It's really good batting."

He also praised Black
Caps opener Mitchell
for his unbeaten knock
which was studded with
four boundaries and as
many sixes.

"I'd say, so he's played a hell of a hand today. He's played really well against the No. 1 side in the world and taken his side right to the final."

Morgan admitted that his side was outplayed by New Zealand.

"Maybe a little bit (of dew factor). But they have still outplayed us. We know the dew is around. We were still right in the game. I don't think it was a major factor, maybe an advantage slightly but not a major factor.

"We like pitches where you can free yourselves and get after the opposition. We didn't feel as if we could do that, the pitch being a little bit slower but full credit to the Black Caps. They were very disciplined in line and length they bowled, the use of slower balls, and their spinners bowled well."

Asked if injuries to Jason Roy and Tymal Mills during the Super 12 stage, had impacted the team's performance, Morgan said, "I don't think you can put a measure on missing a player. I think the 11 guys that took the field today gave absolutely everything.

## Cambodia dismisses US sanctions as 'politically motivated'

PHNOM PENH, CAMBODIA (AP): Cambodia on Thursday dismissed as "politically motivated" sanctions imposed by the United States on two senior defense officials over allegations of graft, accompanied by a broader warning of systemic corruption in the Southeast Asian nation.

Government spokesman PhaySiphan said Cambodia had not been told in advance about the sanctions, which are related to construction financing at the Ream Naval Base a project that has raised U.S. concerns over China's involvement. He said Cambodia did not intend to respond to Washington.

"The sanctions imposed by the U.S. government were made unilaterally and their decision was not based on the rule of law — it is an injustice for Cambodia," he told The Associated Press.

"These sanctions were politically motivated, and it is not the position of Cambodia to talk with the U.S. on this matter," he said.

The U.S. Embassy in Phnom Penh would not comment on whether Cambodia had been in contact regarding the sanctions but said that the move would not have come as a sur-

"U.S. officials have regularly raised concerns with Cambodia's officials about systemic corruption, transnational organized crime and human rights abuses," embassy spokesman Chad Roedemeier said.

"Regrettably there have been no meaningful changes,"



The sanctions, announced by the U.S. Treasury Department on Wednesday, target ChauPhirun, the director general of the Defense Ministry's material and technical services department, and Tea Vinh, the commander of the Royal Cambodian Navy and brother of Cambodian Defense Minister

The Treasury Department alleged that in 2020 and 2021, Chau conspired with Tea and other Cambodian officials to inflate costs of the Ream Naval Base construction project and then planned to use the funds for their own benefit.

"Chau and Tea were involved in corrupt acts that undermined the rule of law and the Cambodian public's faith

in their government institutions and public processes, including by using their political influence and official power for personal benefit," U.S. State Department spokesman Ned Price said in a statement.

Neither the Cambodian Defense Ministry nor the Royal Cambodian Navy could immediately be reached for com-

The sanctions render Chau, Tea and their immediate family members ineligible for entry into the U.S., and freeze any assets in the U.S. that they hold. The Treasury Department did not detail whether either individual or their immediate families had financial interests in the U.S.

In addition to the sanc-

tions, the Treasury Department, State Department and Commerce Department issued a business advisory cautioning U.S. firms "to be mindful of interactions with entities involved in corrupt business practices, criminal activities and human rights abuses."

It identified two primary areas of risk: illegal financial activities in the financial, real estate, casino and infrastructure sectors, and entities involved in the trafficking of humans, wildlife and narcotics and "related risks in some areas of the manufacturing and timber sectors."

American relations with the government of Cambodian Prime Minister Hun Sen, who has been in office for 36 years, have long been frosty over concerns about the country's poor record on human and political rights.

In recent months, the U.S. has expressed further worries about ties between Cambodia and China, and has urged the leaders of Cambodia, which frequently supports Beijing's positions, to maintain an independent and balanced foreign

New tensions have focused partly on China's construction of facilities at the Ream Naval Base, and the possibility its military could seek future basing rights there. Hun Sen has strongly denied reports that Cambodia would allow China to set up a military outpost there, saying such an agreement would be forbidden by Cambodia's constitution.

The base faces the Gulf of Thailand, which lies adjacent to the South China Sea, and holding basing rights in Cambodia would extend Beijing's strategic military profile considerably.

In a meeting with Hun Sen in June, U.S. Deputy Secretary of State Wendy Sherman expressed concern about China's construction of new facilities

the troika plus meeting are expected to issue an appeal for the world community to urgently provide humanitarian aid to the Afghan people. They also are set to urge the Taliban to respect human and women's rights and to ensure an inclusive government.

The latest development comes weeks after Russia hosted a similar talks on Afghanistan, but Washington at the time stayed way due to logistical reasons. On Wednesday, India hosted senior security officials from Russia, Iran and five Central Asian countries to discuss the ramifications of the Taliban takeover of Afghanistan in talks that were boycotted by rival Pakistan and its ally China.

## China, US pledge to increase cooperation at UN climate talks

**GLASGOW, SCOTLAND (AP):** The 2014 gave a huge push to the creation emissions, signaling a mutual effort on global warming at a time of tension over their other disputes.

In back-to-back news conferences at U.N. climate talks in Glasgow, Chinese climate envoy XieZhenhua and U.S. counterpart John Kerry said the two countries would work together to accelerate the emissions reductions required to meet the goals of the 2015 Paris Agreement on climate change.

"It's beneficial not only to our two countries but the world as a whole that two major powers in the world, China and the U.S., shoulder special international responsibilities and obligations," Xie told reporters. "We need to think big and be responsible."

"The steps we're taking ... can answer questions people have about the pace at which China is going, and help China and us to be able to accelerate our efforts," Kerry said.

China also agreed for the first time to crack down on methane leaks, following the lead of the Biden administration's efforts to curb the potent greenhouse gas. Beijing and Washington agreed to share technology to reduce emissions.

Governments agreed in Paris to jointly cut greenhouse gas emissions enough to keep the global temperature rise "well below" 2 degrees Celsius (3.6 degrees Fahrenheit) since pre-industrial times, with a more stringent target of trying to keep warming to 1.5 degrees Celsius (2.7 degrees Fahrenheit) preferred.

Both sides recognize that there is a gap between efforts taken globally to reduce climate pollution and the goals of the Paris deal, Xie said.

"So we will jointly strengthen climate action and cooperation with respect to our respective national situations," he said.

"It means the intense level of US-China dialogue on climate can now begin to translate into coopera-

The gesture of goodwill comes just days after President Joe Biden blamed Chinese President Xi Jinping's and Russian President Vladimir Putin's failure to attend talks in person for the lack of more progress in climate negotiations.

The U.S. and China will also revive a working group that will "meet regularly to address the climate crisis and advance the multilateral process, focusing on enhancing concrete actions in this decade," the declaration said.

Both Washington and Beijing intend to update the world on their new national targets for 2035 in 2025 — a move that is particularly significant for China. The declaration also said China will "make best efforts to accelerate" its plans to reduce coal consumption in the second half of this decade.

The announcement came as governments from around the world were negotiating in Glasgow about how to build on the Paris Agreement to reduce greenhouse gas emissions and protect vulnerable countries from the impacts of global warming.

U.N. Secretary General Antonio Guterres called the move "an important step in the right direction."

Some experts noted the deal was short on commitments that would significantly reduce heat-trapping gases.

Earlier Wednesday, a draft of a larger deal being negotiated by almost 200 countries in Glasgow called for accelerating the phasing out of coal — the single biggest source of man-made emissions — although it set no timeline.

Setting deadlines for phasing out fossil fuels is highly sensitive to countries that still depend on them for economic growth, including China and India, and to major exporters of coal such as Australia. The future of coal is also a hot-button issue in the U.S., where a spat among Democrats has held up one of President Joe Biden's signature climate bills.

Greenpeace International director Jennifer Morgan, a long-time climate talks observer, said that the call in the draft to phase out coal would be a first in a U.N. climate deal, but the lack of a timeline would limit the pledge's effec-

"This isn't the plan to solve the climate emergency. This won't give the kids on the streets the confidence that they'll need," Morgan said.

The draft also expresses "alarm and concern" about how much Earth has already warmed and urges countries to cut carbon dioxide emissions by about half by 2030. Pledges so far from governments don't add up to that frequently stated goal.

The draft is likely to change, but it doesn't yet include full agreements on the three major goals that the U.N. set going into the negotiations: for rich nations to give poorer ones \$100 billion a year in climate aid, to ensure that half of that money goes to adapting to worsening global warming, and the pledge to slash global carbon emissions by 2030.

try to achieve "net-zero (emissions) around mid-century," a target that was endorsed by leaders of the Group of 20 biggest economies in a summit just before the Glasgow talks. That means requiring countries to pump only as much greenhouse gas into the atmosphere as can be absorbed again through natural or artificial means.

In a nod to one of the big issues for poorer countries, the draft vaguely "urges" developed nations to compensate developing countries for "loss and damage," a phrase that some rich nations don't like. But there are no concrete financial commitments.

Britain's Alok Sharma, who is chairing the negotiations, acknowledged that "significant issues remain unresolved."

"My big, big ask of all of you is to please come armed with the currency of compromise," he told negotiators. "What we agree in Glasgow will set the future for our children and grandchildren, and I know that we will not want to fail them."

## Hong Kong's M+ museum opens amid censorship controversy

**HONG KONG (AP):** Hong Kong's swanky the city. Among them, the annual vigil new M+ museum — Asia's largest gallery with a billion-dollar collection — is set to open on Friday amid controversy over politics and censorship.

M+ boasts 183,000 square feet (17,000 square meters) of exhibition space, 33 galleries and over 6,400 works in its collection that range from modern and contemporary art to architecture and moving images. Designed by Swiss

architects Herzog & de Meuron, M+ aims to put Asia on the global map for art and was built to rival London's Modern Tate and the Museum of Modern Art in New York.

But the museum has come under fire for censorship, after it decided not to display a piece by Chinese artist and dissident Ai Weiwei after pro-Beijing politicians said that it was "spreading hatred against China" and could violate the city's sweeping national security law. On its website, M+ replaced the digital image of the work with its logo.

The work by Ai, titled "Study of Perspective: Tian'anmen (1997)," depicts Ai raising a middle finger at Beijing's Tiananmen Square, where a bloody crackdown by the People's Liberation Army on pro-democracy protesters on June 4, 1989, killed hundreds, if not thousands.

Some of his works will be on display, but not the other images from Ai's "Study of Perspective" series featuring middle fingers aimed at the White House, the Swiss parliament and the Mona Lisa, though they're still on the museum's website.

Beijing imposed the national security law after massive anti-government protests shook Hong Kong in 2019, challenging China's rule over the semiautonomous city that was promised Western-style freedoms after its handover from Britain in 1997.

The law outlaws secession, subversion, terrorism and foreign collusion, and has been used to arrest over 120 people and silence opposition voices in

commemorating the Tiananmen massacre as well as the June 4 museum.

Ai has criticized M+ over its decision to censor his work.

"Under the current National Security Law, I think Hong Kong is facing a very dramatic political change," Ai said in an interview with The Associated Press from Cambridge, England. "So the freedom of speech (can) no longer be

Some, however, believe that the artwork's removal may be justified.

"M+ is the start of possibly a 50, a 100-year-old institution, so it should be forward looking," he said, adding that the excitement visitors will feel walking into M+ could be similar to that of the Metropolitan Museum or the Museum of Modern Art in New York.

The collection of works in M+ also includes those from local artists, like South Ho. Ho's photos "Not Every Daily VI" and "Not Every Daily V" captured the city's Occupy Central protests in 2014, and are part of the museum's collection.

"As a contemporary artist, I think it's a good that the museum provides a new channel for us to get to know the arts in Hong Kong, and from Asia and other parts of the world," said Ho.

"This is a form of investment in culture which allows people to know that apart from Hong Kong's economic achievement ... it's a good idea that we also have some cultural developments as well," he said.

The duchess said she did not remember the discussions with Knauf when she gave evidence earlier in the case, "and I apologize to the court for the fact that I had not remembered these exchanges at the time." "I had absolutely no wish or intention to mislead the defendant or the court," she said.

Associated Newspapers says Knauf's evidence also undermines Meghan's claim that she did not intend the letter to be seen by anyone but her father.

In his witness statement, Knauf said the duchess "asked me to review the text of the letter, saying 'obviously everything I have drafted is with the understanding that it could be leaked."

Knauf said Meghan asked whether she should address her father in the letter as "Daddy," adding that "in the unfortunate event that it leaked, it would pull at the heartstrings." In her own written evidence, Meghan, 40, said she had not believed that her father "would sell or leak the letter, primarily because it would not put him in a good light."

"To be clear, I did not want any of it to be published, and wanted to ensure that the risk of it being manipulated or misleadingly edited was minimized, were it to be exploited," she said.
