"In an attempt to save SKM party and Government from public embarrassment, Political Secretary Jacob Khaling is unashamedly lying to Sikkimese people about the appointment of non-Sikkimese Sunil Saraogi as non violative of Rule 4/4," Passang Sherpa [Coordinator, I Am 371F Campaign] has said in a press release today.

BJP's priority is not development, but to create Hindu rashtra: Tharoor



KOLKATA, JAN 22 (PTI): Congress MP Shashi Tharoor on Wednesday asserted that in the absence of any development agenda, what the Bharatiya Janata Party wants is to create a "Hindu rashtra".

Speaking at the Kolkata Literary Meet here, Tharoor also claimed the real "tukde tukde gang" is the ruling party which is dividing the country into "bits and pieces".

"With no development on its agenda, the ruling party is making a complete exposition of its agenda to create a Hindu rashtra," Tharoor, also an acclaimed author, claimed.

The present central government does not have the mentality for development, the Congress leader alleged.

"The real tukde tukde gang is the ruling party which is dividing the pieces. The party wants to divide us further the way the British Raj did through the divide and rule policy", he said.

"Tukde tukde gang" is a term often used by the right- wing parties to attack those who they think are out to divide the country. The term was coined and used against the Left and Leftbacked outfits during the campus unrest at the Jawaharlal Nehru University in 2016.

"Should religion be a determinant for nationhood? Mahatma Gandhi went for a secular India. unlike Pakistan which went on to become an Islamic state. "Our Constitution re-

flects dignity and equality for all. The Constitution reflects that and also essentially rejected the idea of religion-based citizenship," Tharoor said. For the first time in In-

dia, religion is considered as a determinant for citizenship and excluding one religion, Islam, the former Union minister said.

"The onus will be on us to prove that we are Indians," the Thiruvananthapuram MP claimed.

BJP leaders often

quote Swami Vivekananda but the monk in his famous Chicago speech had greeted people of all faiths of the world country into bits and he said. "But BJP has re- regrettable that no Britduced this to six faiths and three nations", Tharoor said.

He was referring to the amended Citizenship Act that seeks to provide Indian citizenship to Hindus, Jains, Christians, Sikhs, Buddhists and Parsis entering India on or before December 31, 2014 from Bangladesh, Pakistan and Afghanistan after five years of residence here.

Referring to the pro-

CAA pleas: SC says no stay without hearing Centre, gives govt 4 weeks to respond

New Delhi, Jan 22 (PTI): Making clear it will not stay the Citizenship (Amendment) Act without hearing the Centre, the Supreme Court on Wednesday gave the government four weeks to respond to petitions challenging the CAA and said a five-judge Constitution bench will hear the matter.

Hearing a batch of 143 petitions, an apex court bench headed by Chief Justice S A Bobde issued notice to the Centre and restrained all high courts from hearing pleas on the CAA till it decides on the pleas.

The bench, also comprising Justices S Abdul Nazeer and Sanjiv Khanna, said it will hear the petitions pertaining to Assam and Tripura separately as the problem with the CAA in these two states is different from rest of the country.

"The matter is uppermost in everybody's mind. We will form a five-judge bench and then list the case," the court said.

Senior advocate Kapil Sibal, appearing for some petitioners, said the issue be referred to a Constitution bench and the NPR exercise be postponed by a couple of months. He also urged the bench to put on hold the operationalisation of the CAA. The bench said,



"Even we think that the matter should be heard by a Constitution bench."

Asserting that it will not grant any stay on the CAA without hearing the Centre on the matter, it said, "Will pass order on granting any interim relief to petitioner opposing CAA after four weeks."

The court also made it clear it will not pass any ex-parte order without hearing the Centre on staying the operation of the CAA and exercise of the National Population Register (NPR).

It said the earlier cut off date for citizenship in Assam was March 24, 1971 and noted that it has been extended till December 31, 2014 under the CAA.

The petitions concerning Tripura and Assam as well as the matters related to Uttar Pradesh, which is going ahead with the implementation of CAA without framing any rules, can be dealt with separately, the bench said.

The bench said it will decide in-chamber the modalities of hearing the batch of petitions on the CAA and may fix them for day-to-day hearing after four weeks.

Attorney General K K Venugopal, appearing for the Centre, told the bench the government has been given copies of around 60 pleas out of the 143 petitions. He said it wanted time to respond to all the pleas.

The CAA seeks to grant citizenship to migrants belonging to the Hindu, Sikh, Buddhist, Christian, Jain and Parsi communities who came to the country from Pakistan, Bangladesh and Afghanistan on or before December 31, 2014.

President Ram Nath Kovind gave his assent to the Citizenship (Amendment) Bill, 2019 on December 12, turning it into an Act.

Several petitions have been filed challenging the constitutional validity of the CAA. Among those who have filed pleas are the Indian Union Muslim League (IUML),

CBI registers four fresh cases against Chhota Rajan

New Delhi, Jan 22 (PTI): The CBI has taken over the probe into an attempt to kill a veteran journalist in 1997 and three other fresh cases allegedly involving jailed gangster Chhota Rajan, officials said on Wednesday.

Baljeet Shersingh Parmar, a noted crime reporter in Mumbai, was severely injured after motorcycle borne shooters of Rajan allegedly attacked him outside a building at Antop Hill on June 12, 1997, they said.

The agency has taken over the Mumbai police FIR in the case filed under IPC sections related to attempt to murder, they said.

The agency has registered two more cases of extortion by alleged gang members of Rajan and one case related to issuing threats to life, the officials said.

The agency has booked Rajan and his henchmen Guru Satam and Suresh for allegedly demanding Rs 20 lakh as extortion monev from businessman Devang Bipin Parikh in 1995, they said.

The other case pertains to alleged demand of Rs 25 lakh in 1998 from a man named Ghisulal Jain by Hemant, who is believed to be a member of Rajan gang, they said.

The Mumbai police had filed charge sheets in both the cases but Rajan remained absconding, they said.

The last case is related to threats issued to the life of builder Shabbir N Patel and his son in 1996, they said.

In November last year, the CBI had taken over 10 cases, including those of extortion and murder, in which Rajan was allegedly involved. These cases were registered in a 14-year period since 1992, they said.

These cases include killing of trade union leader Datta Samant in 1997 in Mumbai in which Rajan's role is suspected, they said.

Rajan was arrested at Bali airport in Indonesia on October 25, 2015, and deported to India. He is an accused in around 70 cases in Maharashtra, including the J Dey murder case in 2011. The Maharashtra government has handed over all these cases to CBI.

BJP calls Cong 'Muslim League Congress', oppn party hits back with Godse jibe

NEW DELHI, JAN 22 (PTI): The BIP on Wednesday cited reported comments of Maharashtra minister Ashok Chavan to accuse the Congress of "Muslim appeasement" and "insulting" Hindus, and said that the opposition party should be called "Muslim League Congress".

At a briefing, BJP spokesperson Sambit Patra referred to comments of several opposition leaders, including those from the NCP and the AIMIM, to allege that they were "abusing" Hindus in the name of anti-CAA protests and sought apology from Congress president Sonia Gandhi and NCP's Sharad

Referring to Chavan's reported remarks that the Congress joined hands with the Shiv Sena in Maharashtra as Muslims wanted the party to stop the BJP from coming to power, Patra said, "The Congress leader says they joined the government for Muslims. What is the sin of Hindus, Sikhs and others. The Congress has insulted Hindus and this comment has exposed it."

Hitting back, Conspokesperson gress Jaiveer Shergill said an empty mind is a devil's workshop and added that BJP spokespersons are calling names because of the impact the "rising unemployment" is having on them.

In his press conference, Patra also referred to a statement from an

NCP leader to attack the opposition. Asked about Congress leader Mallikarjun Kharge's reported jibe at the RSS for its "non-participation" in the freedom movement, the BJP leader shot back, asking if parents of Sonia Gandhi, who is of Italian origin, had fought in India's independence struggle.

The Indian National Congress, he said referring to the opposition party's full name, should be called "Muslim League Congress". The Congress does "Muslim appeasement" for the community's votes but has never done any good for it, he claimed

Highlighting a report in an Urdu daily, Patra said Congress leader Rahul Gandhi had once described his party as a "party of Muslims" and its leaders coined terms like saffron terror.

Since 1946, Patra claimed, the Congress has done "Muslim vote bank politics".

He also highlighted comments of AIM-IM leader Akbaruddin Owaisi, whose brother Asaduddin Owaisi heads the party, that Muslims ruled over the country for eight centuries to refer to him as Jinnah, Pakistan's founder.

Patra claimed that a video of Shaheen Bagh purportedly protests showed children talking about "murdering" the prime minister and the home minister and asked who has spread such "poison".

fundamental Right to Equality and intends to grant citizenship to a section of illegal immigrants by making an exclusion on the basis of religion. The petition had alleged that the government's

CAA was against the basic structure of the Constitution and intended to explicitly discriminate against Muslims as the Act extended benefits only to Hindus, Sikhs, Buddhists, Jains, Parsis and Christians.

The plea filed by Ramesh said the Act is a "brazen attack" on core fundamental rights envisaged under the Constitution and treats "equals as unequal".

The other petitioners include the Jamiat Ulama-i-Hind, the All Assam Students Union (AASU), the Peace Party, the CPI, NGOs Rihai Manch and Citizens Against Hate, advocate M L Sharma, and law students.

Owaisi dares Amit Shah to debate

on CAA with "bearded man"



HYDERABAD, JAN 22 (PTI): After Home Minister Amit Shah threw a challenge to leaders like Rahul Gandhi for a public debate over CAA, AIMIM chief Asaduddin Owaisi joined issue and wanted the former to discuss the law with him instead of others.

Addressing a rally in Karimnagar district on Tuesday night ahead of the municipal polls on January 25, the Hyderabad MP said the Home Minister called for a public debate on CAA with the opposition even as he asked Shah to debate with him on the legislation.

At a rally in Lucknow

Tuesday, Shahhad emphatically said the Citizenship Amendment Act (CAA) will not be withdrawn and those protesting can continue to do so even as he challenged opposition leaders for a public debate on the amended leglislation.

Accusing the opposition of "misleading" people on the amended citizenship law, Shah threw the challenge for the debate to Rahul Gandhi, Mamata Banerjee, Akhilesh Yadav (Samajwadi Party) and Mayawati(Bahujan Samaj Party).

Reacting to Shah's challenge, Owaisi said, "I am here.. debate with in support of the CAA on me.. why (debate) with these people.. 'Daadi wale se karo na' (Debate with a bearded man). We will talk and debate on CAA, NPR and NRC."

The CAA allows easier citizenship for Hindus, Sikhs, Buddhists. Christians, Parsis and Jains who entered India from three neighbouring countries before 2015 after facing religious persecution. Muslim migrants don't figure on this list.

The AIMIM chief hit out at the BJP over renaming of places, while mentioning about the 'Halwa' ceremony ahead of the Union budget.

"BJP says it will change names. I want to ask from where did the word halwa originate?

It is an Arabic word. It is neither Hindi nor Urdu (word). now remove the Arabic word..

They (BJP) say they will (continue to) change names.

Inshallah people of the country will change you," the Hyderabad MP said adding "remember I am not halwa.. I am lal mirchi (red chilli)."

Meanwhile, the AIM-IM has requested the Telangana State Election Commission not to use face recognition app being used on pilot basis in the polls for urban local bodies, alleging that it would invade the privacy of the citizens, among other violations.



Let's Give the Young a Library

Private collaborations to help children access the world of books

The weather just might be warming up, and the win-Let break is still holding strong. What the lull of winter weather should also be alleviating is the guilt the Sikkimese must collectively feel for not having factored in anything for the young when the crores were being apportioned for infrastructure development. Children in Sikkim do not have much to choose from by way of safe and healthy outdoor spaces. And now that the children are forced indoors by the weather and the holidays, another denial that the younger generation is suffering comes into focus – it is bad enough that Sikkim denies its young with convenient, accessible and safe outdoor spaces, the situation worsens in the face of the fact that they are even denied literary escapes. Not only is there no presence of children's literature either in the local publishing scene or substantially enough in the bookstands (we speak of 'local' reading material here), even access to a decent public library remains largely non-existent. The largest library in the State, the one housed in the erstwhile Gangtok community hall continues to pushed into a corner of an establishment still appropriated by the VIPs. Hopefully, now that the secretariat has at least officially moved out and the multipurpose Manan Bhawan will be allowed to serve more purposes for the young than its current single-purpose to house drab government offices. Till that happens, one continues to miss reading rooms and libraries in Sikkim. The only hope comes in the form of groups like the Wandering Souls of Sikkim which are building and refurbishing libraries in government schools. Unfortunately, they remain a very small minority.

The lack of well appointed libraries is not a new theme for this section and has been visited often and will definitely keep resurfacing until things improve. The absence of libraries is unfortunate because libraries, even though they are going under the world over, remain the only window available to most children to access the world of words and inspire creative thinking. And no, Facebook and Wikipedia cannot make up for that loss. The failure, like with most things in the State, is not so much of the government as it is of the society at large. Libraries and reading rooms or even child-specific activities need not necessarily come from the State exchequer. In fact the more successful endeavours have come from private initiative.

It is apt here to cite the example of the Bakul Children's Library in Odisha. This library in the Satya Nagar residential area of Bhubaneshwar houses some 20.000 books, includes a multimedia section, has internet access and stocks substantial educational material. All of these have come from community partnership. Everything is donated, children are charged no membership fees and access is free for every child. When it started about a decade ago, it was single-unit operation. Within a few years it had 8,000 books. Now, as mentioned, it has 20K titles and has opened its doors to general readers, yes, even grownups. It is managed by volunteers and children throng to it, as much to browse and borrow as to attend story-reading sessions, creative thinking workshops, staging of plays by other kids and everything else that children do. The library was born from a campaign in the year 2006 to collect books for free sharing with children. In its first attempt itself, the volunteers received pledges for book donations from 1,000 people! Not just books, people also pledged time and professional skills to set up the library and sustain it. Its operations now include a mobile library which routinely services 24 villages in Odisha. The model works because the society got involved. They operate on the motto: "If not us, who? If not now, when?"

The feeling to do something for the young surely exists in Sikkim as well, but like in Bhubaneshwar, it requires a core group to take the initiative and harness the desire. Surely, there are enough 'donors' around to stock a decent library to begin with. What will a library achieve? It will open a window for the young in what is becoming an increasingly claustrophobic and consumerist environment. A children's library is not only about books, it is about sharing, learning and even escaping; experiences and options that every child should have access to.

The Ominous Metaphors of China's Uighur Concentration Camps

The recent leak of Chinese Communist Par-I ty documents to the New York Times offers a chilling glimpse into the 21st century's largest system of concentration camps.

A million Uighurs and other Muslim minorities are now detained in a Chinese operation that combines the forced labour and re-education of Maoera laogai with the post-9/11 rhetoric of the "war on terror." U.S. President Donald Trump's Muslim ban, border camps crowded with migrant children and America's global archipelago of so-called black sites detaining terror suspects deserve condemnation. So too do the concentration camps of the world's newest superpower.

Retina scans, DNA databanks and facial recognition technology are now ubiquitous across China's Xinjiang province. They are modern-day updates to earlier surveillance technologies like Soviet internal passports.

KGB TACTICS

Satellite images and clandestine video footage of watchtowers, concrete barracks and barbedwire perimeters conform to the prison esthetic described by Holocaust survivor Primo Levi and Russian labour camp detainee Alexandr Solzhenitsyn.

Nighttime roundups resemble KGB tactics, while involuntary medical injections recall the dark history of forced sterilization, from Nazi eugenics to the targeted sterilization of Indigenous women in Canada

Another haunting parallel is the language Chinese officials use to justify their actions. Speaking of the concentration camps of totalitarian Europe, the late social theorist Zygmunt Bauman, himself a Polish Jew and Holocaust survivor, wrote that "gardening and medicine" have offered "archmetaphors" for the management of unwanted populations.

To cultivate a garden is to ensure the survival of some plants while eliminating others. Gardens require fences, walls and the extermination of weeds. As if to illustrate Bauman's point, a Chinese official in Kashgar recently informed a crowd of Uighers:

"You can't uproot all the weeds hidden among the crops in the field one by one. You need to spray chemicals to kill them all."

The tenderly pruned gardens of classical China were peaceful retreats for poets and philosophers. By contrast, the association of human beings with noxious weeds and the Chinese Communist Party's embrace of industrial agricultural metaphors have yielded dystopian results.

LANGUAGE OF DISEASE

More than anything, Chinese statements about Uighur concentration are saturated with the language of disease. Likening Islam to a contagion, an official Communist Party document suggests Uighers have "been infected by unhealthy thoughts."

"Freedom is only possible," it adds, "when the 'virus'...is eradicated.'

In an exercise in victim blaming for which cultural theorist Susan Sontag argues medical metaphors are especially conducive, Chinese officials have warned: "If you were careless and caught an infectious virus, like SARS" (a scenario that led to mass medical detention in China in the recent past), then "you'd have to undergo enclosed isolated treatment. Because it's an infectious ill-

Chinese officials are thus defending the camps as quarantine cells that will safeguard China from the Uighur epidemic while eliminating religious and cultural pathogens.

The human body has long served as a metaphor for state and society both in Western and Chinese thought. And medical analogies have proven central in the political calculus of extrajudicial detention. With a pseudo-scientific endorsement, policy-makers around the world have classified unwanted populations as parasites or social pathogens that need to be cured, physically isolated or excised completely.

FIRST CONCENTRATION CAMPS

The first concentration camps in contemporary history, established by Britain during the Anglo-Boer War (1899-1902), were directly inspired by plague quarantine camps in India and South Africa. The goal was to "cleanse" besieged towns of

"disease, crime and poverty" by introducing wartime refugees to sanitary enclosures administered by British medical officials.

The Soviet Union likewise consigned "parasitic classes" to the gulag, while earlier generations in China referred to political prisoners as "convalescents." Even today, xenophobic voices in America associate Latino migrants with "tremendous infectious disease."

The biological metaphors revealed by the Chinese government's recent document leak, however, find their most sinister analogies with Nazi Germa-

"The battle in which we are engaged" against the "Jewish virus," Hitler proclaimed, "is of the same sort as the battle waged...by Pasteur and Koch. We shall regain our health only by eliminating the Jew."

A germaphobe, Hitler imagined fighting "battles against a veritable world sickness, which threatens to infect the German people, a plague that devastates whole peoples." In this imaginary landscape, Nazi apologists invariably depicted concentration camps as sanitary spaces that isolated Jewish "parasites" in the name of

The genetic emphasis of Nazi racism ultimately meant "curing" Jews was an impossibility. By Hitler's logic, outright extermination — or "euthanasia" in sanitized state-speak — was the only recourse. China, by contrast, holds out hope that Uighur camps, or "re-education hospitals", can cure their "patients" and thus "clean the virus from their brain."

Yet like cancer, Chinese Communist officials fear, "there is no guarantee the illness will not return." And just because an inmate has "recovered from the ideological disease doesn't mean they are permanently cured," the documents reveal.

The language of disease justified some of the 20th century's worst crimes. If left unchecked by the international community, China is poised to continue that tradition in the 21st century. And where China leads, others are likely to follow.

Why Young Nigerians Risk Illegal Migration to Find Their 'Eldorado'

Joung Nigerians make up the Y largest population of the growing flow of migrants from Africa to developed countries. In 2016, over 20,000 involved in the Mediterranean Sea crossing were reported to be from Nigeria.

In addition, from 2017 until late 2019, hundreds of Nigerian migrants were deported from various destinations including Italy, Libya and South Africa.

These young people embark on very risky journeys across the globe, and casualties continue to increase on a daily basis.

Understanding their reasons for leaving the country is important if Nigeria is going stem the tide.

I conducted a study to establish the extent to which young people aged between 15 and 35 were susceptible to illegal migration and whether they were aware of what it entailed. I also examined the attitudes and survival strategies adopted by irregular migrants returning to Nigeria.

I focused on three groups of migrants who fall into the "irregular migration" category. The first were those who arrived in a country illegally. The second, those who arrived legally for instance on the basis of tourist or student visas - and then overstayed the period covered by their visas. And finally, asylum seekers whose claims have been rejected and who have not left the country as required.

My findings showed that most road" - as irregular migration is re-

Most said they believed that the "end will surely justify the means". And that they perceived ability to travel abroad as a sign of success.

RESEARCH

We conducted interviews with 63 young people who had not yet left the country in four Nigerian cities: Lagos, Ibadan, Ile-Ife and Benin City. We targeted those susceptible to migration. These included those who were unemployed, in their final year at a tertiary-level education institution and those engaged in Nigeria's compulsory National Youth Service Corps. We also included seven young people who had tried to migrate but had been returned.

We also ran separate focus group discussions for men and women. We chose people on the basis of whether or not they were familiar with the process of irregular migration.

Once in the groups we asked questions to determine their familiarity with the concept of irregular migration. Most said they were. We also established that most were unfamiliar with formal immigration procedures and that more than half did not have a valid passport.

Most knew someone personally who had travelled out of the country through illegal means such as forging a passport, using unauthorised agents, and travelling to "Europe by

Most expressed positive attitudes tivated by three factors: economic about irregular migration, stating that the end would justify the means. They all shared the view that migrants were far better off than those who stayed behind because they had access to a better quality of life.

> Bola, a 29-year-old female unemployed youth from Osun State, asserted:

"Sincerely, those who migrate outside the country often live far better than we in Nigeria. They enjoy constant power supply, good weather, eat good diet and to a reasonable

extent, they are secured." THE DRIVERS

Irregular migration tends to fester in the face of economic adversity. Nigeria's economy is in a bad shape. Unemployment among young people is particularly high at 36.50% in 2018.

In addition, poverty levels have got worse. In 2019, the number of extremely poor Nigerians was estimated at 91.6 million, nearly half of the country's total population. Nigeria also has 87 million people living in poverty.

This increase is one of reasons Nigerians leave the country in search of "Eldorado". In other words to find security, work and new ways of life in other countries.

A recent report launched by the United Nations Development Program (UNDP) on irregular migration echoed my findings. In documenting the experiences of Africans who had migrated to Europe using irregular means, it identifies

a lack of opportunity to exert influence on their governments as reasons for migration.

SOLUTIONS

Finding answers isn't easy. For example, some of the recommendations made in the UNDP report, such as creating more incentives for young people at home and expanding legal pathways for migration - come across as rhetoric. Most aren't new either.

Several suggestions have been put forward by scholars and development bodies. These include: facilitating circular migration between European and African countries, tackling the issues of unemployment and underemployment in countries of origin, and addressing the problems resulting from violence and other forms of political instability.

The common denominator is that all efforts must be designed with the aim of making the home a place people don't want to leave. And programmes to discourage young people from irregular migration must go beyond deterrence and punishments.

There should also be a concerted effort to challenge the fundamentally erroneous beliefs about migration. This must include demystifying fantasies about life abroad and educating young people about the realities of life as an irregular migrant.

Finally, those who stay home and succeed must be celebrated.

First unmanned mission, part of Gaganyaan, this December: ISRO

BENGALURU, JAN 22 (PTI): Ahead of the launch of India's maiden human spaceflight venture 'Gaganyaan' in December 2021, the ISRO will undertake two unmanned missions in December 2020 and June 2021, its chairman K Sivan said on Wednesday.

Addressing the inaugural session of a symposium on "Human Spaceflight and Exploration - Present Challenges and Future Trends," Sivan said the Gaganyaan mission not only aims at India's maiden human flight to space but also setting up a new space station for 'continuous space human presence.'

"We are doing all this (Gaganyaan) on three points - short term plan of two unmanned mission in December 2020 and June 2021, followed by human space flight demonstration in December 2021.

"We have the midterm goal of sustaining the human space programme and continuous space human presence in space on a new space station", he said.

In this regard, the ISRO has initiated a full-fledged astronaut training facility in close proximity to Bengaluru

for meeting its future requirements. It is also in talks with NASA and other space agencies and industries on how it can collaborate on human space flight and learn from their experience.

The Gaganyaan will also assist in ISRO's long term goal of inter-planetary mission.

"Inter-planetary mission is also on the agenda in the long term," the ISRO chief said.

mission, Sivan said the space agency has already developed and demonstrated key technologies such as having an operational launcher with 10-tonne playload capability to lower orbit, demonstration of mission design and management and recovery system like space qualified parachutes.

"The only missing elements were human life science and life support system, which we are developing now," he said.

ISRO, Sivan said has lab as well as many industries as stakeholders for the Gaganyaan programme.

Noting that four astronauts have been selected from a pool of Indian Air Force test pilots, Sivan said the generic space flight training will commence in India shortly. Later, speaking re-

porters, Sivan said the number of astronauts going to the space will be decided towards the end of the project. "In the first mission people will

Sivan refused to share the details about the astronauts selected for the mission. "At the right time that will be known to the outside people," he added. Along with the humanoid, micro gravity experiment will also fly in this unmanned mission in December 2020, he said.

New book to chronicle history of Yoga

NEW DELHI, JAN 22 (PTI): From the caves and forests of ancient India to the gyms, studios and village halls of the modern West, a new book unravels how the practice of Yoga reached its present-day ubiquity.

Touted to be the "first definitive history" of Yoga, "The Story of Yoga: From India to the Contemporary World" has been written by Scottish cultural historian Alistair Shearer, and will hit the stands later this month, announced publishing house Penguin Random House.

"This is not a 'how to' book -- there are already more than enough of those -- but a 'how come?' one. How come a time-honoured road to enlightenment has

turned into a 25 billion-a-year wellness industry? What have the original teachings of the sages lost, or perhaps gained, while being transplanted onto foreign soil?

"...This book is in part an attempt to define what this thing we call 'yoga' really is," writes the author in its introduction.



According to the book, in the US alone, where in the closing decades of the 20th century only a few hundred thousand were engaging in some form of yoga, the number rose to about "4 million" in 2001, and then to over "37 million" by 2016.

"That was twice as many as five years before, and the upward

trend continues. According to surveys conducted by 'Yoga Journal', another 80 million are 'very interested' in beginning some sort of practice," it said.


Divided into two parts, "Today" and "Yesterday", the book has nine chapters, including "The Age of Invasions", "Female Fitness" "Yoga Goes West".

Aston Villa haul themselves out of bottom three with late win over Watford

LONDON, 22 JAN [AP]: Tyrone Mings's last-gasp winner lifted Aston Villa out of the relegation zone and ended Watford's revival in dramatic style. The defender grabbed a fortunate deflection on Ezri Konsa's shot in the fifth minute of stoppage time with virtually the last touch of the game to snatch victory.

Douglas Luiz had earlier come off the bench to level in the second half, just as Villa looked like they would be plunged into further trouble. That cancelled out Troy Deeney's opener as Watford's six-match unbeaten run in the league was ended.

Villa's third victory in 11 Premier League outings moved them up to 16th and two points clear of the teams in the relegation zone, while Watford slipped back into the bottom three.

"We have to keep concentrating on the next game. The next one in the Premier League is against Bournemouth, another team below us," said the Villa manager, Dean Smith.

"Catching the teams above you and overtaking them, that's the players' job at the moment. Teams of mine finish the season better and I'm expecting a better points haul in the second half.

"It's the biggest win at this moment because it's the latest one. We have to concentrate on each game. With Watford being around us and giving us a good hiding at their place I said before the game it would be a different Villa team they faced. It was an important one because Villa Park is an important place for us in this league."

The defeat put a dent in Watford's revival, Nigel Pearson having hauled them off the bottom of the table. They looked like continuing their run when Deeney gave them the lead seven minutes before the break, heading in Gerard Deulofeu's cross.

Pepe Reina's save denied Deeney a second after the break and Douglas Luiz levelled after 68 minutes, following up after Ben Foster parried Matt Targett's

Villa snatched victory in injury time when, after Watford failed to deal with a deep freekick, the ball ran to Konsa and his strike clipped Mings on the ground and found the corner.

Konsa had the news broken to him on live television that he was not to be credited with the goal. He joked he was "heartbroken", while Mings added: "The three points is the most important thing but once you've got the three points, it's also nice to score!'

Aguero strikes as Man City blunt Blades

SHEFFIELD, JAN 22 (AFP): Pep Guardiola admitted Aymeric Laporte's return from injury will be key to Manchester City's hopes of a successful end to the season after Sergio Aguero sealed a 1-0 win against Sheffield United on Tuesday.

Guardiola's side were labouring to break down United until Aguero came off the bench to end their stubborn resistence at Bramall Lane.

City striker Gabriel Iesus had a penalty saved by Dean Henderson in the first half but with 17 minutes left Aguero bagged his seventh goal in four appearances in 2020.

His 21st goal of the season in all competitions moved second-placed City to within 13 points of runaway Premier League leaders Liverpool, who have two games in hand on the champions.

While City's hopes of winning a third successive title have been shattered by a combination of their own failings and Liverpool's incredible form, there is still much to play for this term.

Guardiola harbours dreams of leading City to their first Champions League crown and they also face an FA Cup date with Fulham this weekend, followed by the League Cup semi-final second leg against Manchester United.

With those cup ambitions in mind. Guardiola will have been encouraged by the way City coped with the Blades' aggressive game-plan and emerged with a fourth win from their last five league matches.

"Sergio is on fire right now. Strikers need momentum. It's good for us to have strikers in this form," Guardiola said.

Keeping just their third clean sheet in 14 league games was another boost for Guardiola, who gave French defender Laporte his first appearance since August after recovering from a serious knee injury.

FULHAM, 22 JAN [THEGUARDIAN]: There were two rookie coaches hopping around on the touchline and both will feel they have spent a lifetime in management after this emotional rollercoaster. While Frank Lampard seethed at Chelsea's lack of conviction at both ends of the pitch, Mikel Arteta wondered what on earth he is going to do with Shkodran Mustafi and marvelled at the fearlessness of Gabriel Martinelli. It was that sort of night, absorbing and bonkers in equal measure, and in the teta was entitled to argue Arsenal end it was difficult to know whether to focus on Chelsea's sense of bewilderment or Arsenal's jov.

For Lampard, the twist was tough to take but easy to explain. Chelsea played for more than an hour against 10 men, led twice and still dropped more points at home. They lacked creativity again, bolstering the argument that they need attacking reinforcements before the transfer window closes, and paid for their carelessness when Martinelli, an 18-year-old winger with a wonderfully direct style, hauled Arsenal level with a stunning solo goal just

them if they beat Burnley at home on Wednesday – and it spoke volumes that they were incapable of holding on after César Azipilicueta restored their lead with six minutes left. While there have been signs of progress under Arteta, the fact remains the Spaniard has inherited a squad containing a multitude of weaknesses. There is only so much Arteta can improve with his work on the training ground and that was underlined by Mustafi's blunder.

After a promising opening Chelsea unreliable player to self-destruct. Abraham had fooled Mustafi with a clever turn before scoring his side's late winner at the Emirates last month and this time he was in the right place when the centre-half sold Bernd Leno horribly short with a staggeringly incompetent back-pass. They lost their shape in midfield, where N'Golo Kanté had a disappointing game, and allowed Arsenal's belief to grow.

The hosts flirted with disaster early in the second half, Arrizabalga almost simply had to wait for Arsenal's most playing Jorginho into trouble. Chelsea's game management was dismal and Arsenal, who looked blunt at first without the suspended Pierre-Emerick Aubameyang, equalised in the 63rd minute. A Chelsea corner was cleared, Martinelli took possession in his own half, outpaced Emerson, raced clear after a slip from Kanté and slipped the ball past Arrizabalaga.

Greece elects first woman president

GREECE, JAN 22 (AFP):

Greece's parliament on Wednesday elected the first woman president in the country's history, a senior judge with an expertise in environmental and constitutional law. A cross-party majority of 261 MPs voted in favour of 63-year-old Ekaterini Sakellaropoulou, parliament chief Costas Tassoulas said. "Ekaterini Sakellaropoulou has been elected president of the republic," Tassoulas said. The new president, until now the head of Greece's top administrative court, the Council of State, will take her oath of office on March 13, he added.

The daughter of a Supreme Court judge, Sakellaropoulou completed postgraduate studies at Paris's Sorbonne university. She was also the first woman to head the Council of State. Although the president is nominally the head of the Greek state and commander-in-chief, the post is largely ceremonial.

Having risen through the ranks at Sporting Gijón, the Spanish defender made his La Liga debut in 2011 on the final day of the season. He retired that summer having made that one appearance for the club. He was 23 years old.

"What I've seen from within makes it clear: professional football is only money and corruption. It's capitalism, and capitalism is death," said Proves. "I don't want to be part of a system based on people earning money at the expense of the deaths of others in South America, Africa and Asia. To put it simply, my conscience will not let me continue with this."

Disillusioned and resentful,

Flat Earth FC: the football club who represent a conspiracy theory Poves hung up his boots and decided to travel the world. He made a brief return to football three years later with SS Reyes before eventually stumbling upon CD Móstoles, a club based 15 miles south of central Madrid. Poves became the club's president in 2016 and took them up to the fourth division last season. With his club's status on the rise, he decided it was time for a rebrand. It wasn't just any rebrand, though: Poves renamed the club Flat Earth FC.

> Football clubs have always represented their local communities. More recently, some clubs have taken on bolder messaging, such as Deportivo Palestino in Chile, who were founded by a group of Palestinian immigrants, or St Pauli in Germany, who represent their politically

left-leaning fanbase. Flat Earth FC is the first professional football club that represents a conspiracy theory.

"Football is the most popular sport and has the most impact worldwide, so creating a club dedicated to the flat earth movement is the best way to have a constant presence in the media," said Poves earlier this year. "Flat Earth FC is the first football club whose followers are united by the most important thing, which is an idea."

The club's crest is now a circular image of the earth, pressed flat on to all kits, and fans are encouraged to spark regular conversations in their pursuit of answers from the powers that be. The team mascot? An astronaut. It's a radical move, but the club is bringing in supporters from afar. "It's really amazing to be part of this amazing movement," says Flat Earth player Mario Cardete. "I think it's more than a club."

"More than a club" is a familiar phrase in Spain, given it is the adopted club motto of current La Liga champions, Barcelona. But, as journalist Rodrigo Fáez explains, Flat Earth FC are trying to push an even more radical message. "The rest of the clubs try to change something in people's lives," said Fáez in our film. "Poves tries to change everything in people's minds." What started out as local controversy may soon become national debate. Who knows, in years to come we may well see Flat Earth FC lining up at the Camp Nou, as "més que un club" meet "mas que un planeta".

deeply conservative about matters of sexual identity and is less tolerant of LGBT rights than some other parts of Asia, with many gay and transgender Koreans living largely under the radar.

Byun Hee-soo, a staff sergeant in her 20s, enlisted voluntarily in 2017, and went on to have gender-reassignment surgery in November in Thailand.

She had expressed her desire to remain in the army but a military panel ruled on Wednesday that she will be compulsorily discharged.

Byun waived her previous anonymity to appear at a press conference, wearing her fatigues and saluting the gathered journalists and cameras.

"I'm a soldier of the Republic of Korea," she said, her voice breaking.

Serving in the military had always been her childhood dream,



she said, but she had suffered from depression due to gender dysphoria, prompting her to undergo the sex-change surgery. "Putting aside my sexual identity, I want to show everyone that I can be one of the great soldiers defending this country," said Byun, fighting back tears. "Please give me that chance."

South Korea has a conscript army to defend itself against the nuclear-armed North, with all able-bodied male citizens obliged to serve for nearly two years. A defence ministry spokesman said Byun had undergone tests at a military hospital, which classified the loss of male genitals as a mental or physical handi-

cap, prompting the panel review. Her case "corresponded to one of the reasons for being unable to continue service", the army said in a statement,

without giving specifics and saying it sought to avoid "unfair discrimination and treatment".

The Military Human Rights Center for Korea, an advocacy group in Seoul, said the army had ordered Byun to be effectively discharged when she leaves hospital on Thursday.

"It shows the military's determination to not allow a transgender in the army even for one second," said the organisation's head Lim Taehoon. "It is truly cruel."

It is the first case of its kind in the South.

International rights groups have expressed concern about the way the country treats gay soldiers, who are banned from engaging in samesex acts and can face up to two years in prison if caught -- even though such actions are legal in civilian life.

36 civilians killed in northern Burkina Faso



OUAGADOUGOU, JAN 22 (AFP): Militants killed 36 civilians when they attacked villages on Monday in northern Burkina Faso, the government said Tuesday, appealing for local support in the fight against jihadists. A "terrorist group" killed 32 civilians when they attacked and burned the market in Nagraogo village before killing four more people in Alamou village, the government said.

Three other people were wounded in the attacks, it added.

"The Burkina government has learned with consternation and anger of the deaths of 36 Burkinade in Sanmatenga province, after a terrorist attack," communications minister Remis Fulgance Dandjinou said.

Faced with these "repeated attacks" against civilians, the government launched an appeal for the people's "frank collaboration" with the defence and security forces.

The Burkina parliament on Tuesday adopted unanimously a law allowing for the recruitment of local volunteers in the fight against jihadists, providing them with "light weapons."

Burkina Faso, as well as neighbouring Mali and Niger, has seen frequent jihadist attacks which have left hundreds of people dead since the start of 2015 when Islamist extremist violence began to spread across the Sahel region. According to the UN, around 4,000 people were killed in jihadist attacks in the three Sahel countries last year.

The Burkina Faso army is ill-equipped and poorly-trained to deal with the threat posed by jihadists in the country.

However, in recent months they have enjoyed a series of successes, claiming to have killed a hundred jihadists in many operations.

There are 4,500 French troops deployed in the Sahel region as well as a 13,000-strong UN peacekeeping force in Mali to fight insurgents, backing up national forces of the G5 -- Chad, Burkina Faso, Mali, Mauritania and Niger.

Charity brands number of UK prison deaths 'national scandal' justice minister Robert year to June 2019, there

UK, JAN 22 (AFP): The death toll in British prisons is "a national scandal", a pressure group said on Wednesday, calling for a reduction in inmate numbers just as the government is promising tougher sentences.

Inquest, which probes state related deaths, said in a new report that there were six deaths and nearly two suicides every week inside British jails last year.

It called the rate 'shocking and unacceptable", noting many fatalities were found to be preventable, and criticised record levels of distress and self-harm within the

The charity Prime Minister Boris Johnson should make "a substantial reduction in the prison population" and invest instead in health and community-based alternatives to jail. Johnson and his Conservative party won a comfortable parliamentary majority at elections in December on a manifesto that included vowing to be tougher on crime.

On Tuesday, interior minister Priti Patel and Buckland unveiled plans to increase sentences for more serious crimes, including terrorism of-The plans also target

the end of the early release of some prisoners. The Tories pledged

during the election they would create 10,000 more prison places and spend an extra £100 million (\$130 million, 118 million euros) cracking down on crime in jails.

Inquest's executive director Deborah Coles said the current rate of prison deaths, alongside families "traumatised".

"Appalling inspection reports, damning inquest findings, and statistics on yet more deaths, have become so regular that those in power seem to forget these are human beings to whom the state owes a duty of care," she

In its report the charity found there were 308 deaths in prison in the 12 months to September 2019 -- nearly double the number of a decade ago.

Meanwhile in the

were 166 incidents of self-harm every day --60,594 incidents in total, compared to 25,253 in 2009.

"Prisons are not just 'in crisis', they are places of crisis," the report said. "Deaths in custody are a national scandal in need of immediate and urgent attention."

As well as calling for a halt to prison expansions, it said the government should establish a "national oversight mechanism" to focus on prison deaths.
