Exhausting all options, LTTJAC approaches SC with LT seat petition

imboo Tamang Trib-Lal Joint Action Committee has asserted that after not getting justice from any quarter, the committee has finally approached the Supreme Court on Assembly seat reservation issue for the two communities. The committee has expressed hope that the Limboos and Tamangs will contest the upcoming election from their own seats.

The petition in the Supreme Court was filed by members of the committee on 15 January and the court admitted the case after a hearing on 11 February. The five petitioners are Adeep Tamang, Saman Prasad Subba Limboo, Surendra Moktan, Dhan Rup Limboo and Binod Yonzon and the four respondents named in the petition are the Union of India, State of Sikkim, Delimitation **Commission and Election** Commission of India.

prayed to the court "to issue a writ of mandamus or any other suitable writ, order or direction in the nature of mandamus directing the Respondent No 1 to take appropriate steps to amend Section 7 (1-A) in the Representation of Peoples Act, 1950 and Section 5 A of the Representation of Peoples Act, 1951 providing for reservation of Scheduled Tribes name 'Limboo' and 'Tamang' in the legislative Assembly of Sikkim in accordance with law."

The petition has also prayed to direct the State Government to implement whatever steps the Centre takes pertaining

to reservation of ST, Limboo and Tamang in the State Assembly, direct the Delimitation Commission to issue a final notification giving effect to reservation in the Legislative Assembly seats in the State for reservation of Scheduled Tribe Limboo and Tamang seats based on the 2011 census data and also direct the Election Commission of India to take appropriate steps accordingly.

Addressing a press conference here today, LTTJAC president, SP Subba, stated that the committee has taken all possible steps and reached out to all concerned sides to get the political rights of Limboos and Tamangs and when none of these avenues led anywhere, approached the Supreme Court.

Mr Subba accused the State government of not having the political will to secure seat reservation for Limboos and Ta-The petitioners have mangs and said that the State government should nave passed a resolution exclusively for LT seats in the State Assembly and sent it to the Centre.

> LTTIAC treasurer cum spokesperson, Adeep Tamang informed that the Committee has also submitted a memorandum to the President, Prime Minister and Union Home Minister on 17 January with a request to give five seats to Limboo and Tamang through a Presidential Ordinance.

He mentioned that the stand of the committee was to provide five seats to Limboos and Tamangs from the existing 32 seats in the State Assembly.

NEW DELHI, FEB 14 (PTI): The following were the six contentious issues before the Supreme Court which gave its verdict Thursday on division of powers between the Delhi government and the Centre represented by Lt Governor.

The three areas in which the Delhi government will have powers:

1. Appointment of special public prosecutors or law officers.

This power was already given to Delhi government by the High Court in its 2016 order. Before that order, both the governments used to make the appointments, the standing counsel for the AAP government Rahul Mehra said, but added that each time Delhi government had to assert its right.

2. Fixing land revenue rate. Earlier this power was with LG. In 2015, the then LG Najeeb Jung had stayed Delhi government's notification on revised circle rates of agricultural land. The Delhi High Court in its 2016 verdict on the power tussle issue between both the governments, had handed this power to the Centre which was challenged by the Delhi government in the Supreme Court.

3. Power to appoint or deal with electricity commission or board.

Earlier, the then LG Najeeb Jung in September 2016 had rejected Delhi government appointee Krishna Saini as chairperson of Delhi Electricity Regulatory Commission on the

Delhi vs Centre: 3 powers go to Delhi, 2 to Centre, 1 to be decided by larger SC bench basis that it was done without his approval.

Besides, appointment of Delhi government nominated directors on the boards of three power discoms were termed illegal by the High Court in 2016 for not having LG's approval.

Powers given to the Centre:

1. Delhi Anti Corruption Branch (ACB) cannot probe central government employ-

Earlier, Delhi government claimed control over ACB but Lt Governor exercised authority over it. Mehra said that till 2014 this power was with the Delhi government until the NDA government brought a notification in 2014 and took away this right. He said the

Delhi government challenged this notification in the high court but it was decided in favour of the Centre.

2. Centre has the power to appoint Enquiry Commission.

This power lay with the Centre even before the verdict. The undecided issue which has been referred by the apex court to larger bench:

1. Control over service matters involving transfers and posting of officers.

In SC verdict Thursday the contentious issue of control over service matters involving transfer and posting of officers of Delhi government has been referred to a larger bench by the two judges.

The division bench differed on the issue of control of services in the national capital. Justice AK Sikri said transfer and posting of secretaries and Heads of Departments can be done by LG while in case of officer of Delhi, Andaman and Nicobar Islands Civil Service (DANICS) and Delhi, Andaman and Nicobar Islands Police Service (DANIPS), the files need to be sent from the council of ministers to the LG. Justice Ashok Bhushan,

however, differed with the opinion expressed by Justice Sikri and said that under the law, Delhi government has no power to exercise control over services.

Earlier, this issue was with the Centre. It was challenged by the Delhi government in the Supreme Court.

"We took it as our turn to show our love and appreciation to those who work tirelessly 365 days but seldom get any recognition," a girl student Puja Gupta, who pulled a rickshaw said.

"My hands were aching. I realised the ship the rikshawpullers experience daily for a few rupees," she said.

Biswas, who had networked with friends in different intitutes for the move, said the rickshaw pullers live in the nearby Sealdah-Jorasanko-Rabindra Sarani pockets of the city and hail from different

districts of Bihar. The participants had approached the rickshawpullers in person for the programme as most of them do not posess any mobile phones and many of them do not understand Bengali, he said.

"But once we explained our initiative, they were too happy to turn up with their vehicles," he said.

Satyen, an elderly rickshawpuller hailing from Gaya, said "It was an altogether different experience. For a change I was sitting in my own rickshaw. I felt embarassed as it was being pulled by a girl who is as old as my daughter but she asked me to sit back and re-

NAMCHI, 14 FEB (IPR): Consequent upon the directives of the Chief Electoral Officer, Sikkim regarding door to door visit of the BLOs from 15 Feb. 2019 to verify from the household if there are any discrepancies in the final electoral roll being published by the Election Commission of India in terms of any members being left out, wrong entries, etc., a meeting with the BDOs, Supervisors and BLOs of South Districts was held today in the Conference Hall of DAC, Namchi chaired by DEO cum DC, South. All SDMs/EROs were also present in the meeting.

The meeting also deliberated on the recent launching of the Voter Verification and Information Programme (VVIP) by the Election Commission of India for citizens for verification of their names, new registrations, changes in the voters details and correction in the voter identity cards for the forth coming Elections 2019. They have been also apprised about the District Contact Centre being in operation with lane line

number: 03595-264404. The BLOs were given the prescribed format along with the copy of the final Electoral Roll in respect of their Polling Station for their intensive door to door visit during which time they shall meticulously verify and submit the filled up format. The BLOs have also been appraised that for those Polling Stations where there are more than 700 voters, the BLOs can engage the Aganwadi Workers and ASHA depending upon their competence to assist them in carrying out the verification work in time.

The DEO, South has directed all the BDOs and the BLOs to be in the field from tomorrow and start the work on topmost priority. Various technical issues relating to the final electoral roll were also discussed and all functionaries have vouched

to rectify the rolls during the continuous updation of the electoral roll 2019. In the course of the

Yet to come across any evidence supporting sedition charges against AMU students: Police

ALIGARH (UP), FEB 14 (PTI): Police said Thursday they have so far not found any evidence to support the sedition charges levelled against 14 Aligarh Muslim University after protests broke out on the campus earlier this week.

The AMU authorities suspended eight students late Wednesday night in connection with the protest during which a motorcycle allegedly belonging to a member of the Bharatiya Janata Yuva Morcha (BJYM), BJP's youth wing, was set on fire.

police The had booked the students for sedition after BJYM activist Mukesh Lodhi filed a complaint, alleging that he was assaulted amid chants of ant-India and pro-Pakistan slogans on Tuesday.

BJP's students' wing ABVP had protested reported plans by AIMIM lawmaker Asaduddin Owaisi to visit the campus. The BYJM members held a separate demonstration against the visit, demanding that the MP should be banned from the campus. There were then counter-protest by other AMU students. Owaisi did not come to the university.

Senior Superintendent of Police Akash Kulhari said all the evidence secured so far on the reported incident at AMU Circle has not revealed anything to

suggest sedition.

Police are collecting further evidence, including videos, and if they fail to get anything to substantiate the sedition charges, then it would be dropped, the SSP said.

He confirmed that all pieces of evidence, including video clippings of the clash at the university circle between AMU students and those belonging to the ABVP, have so far drawn a blank on this controversial issue.

The case of sedition and attempt to murder was filed on Tuesday evening on the basis of a written complaint by Lodhi, the Aligarh president of the BJYM.

In his complaint, Lodhi alleged that he was driving across the AMU Circle when these students surrounded him and launched a "murderous assault" while raising anti-India and pro-Pakistan slogans.

When contacted, the AMU spokesman confirmed that Lodhi is the same person who had issued an ultimatum to the AMU Vice Chancellor last week warning him if land for constructing a temple on the campus is not allocated within the next 15 days, "then we will ourselves begin the construction".

When newspersons asked the SSP as to why 14 students of AMU were booked under sedition charges merely on the basis of a complaint by

Shed the Mediocrity

Get informed, and then demand better

The talk about developing Sikkim into a "knowl-I edge-based" society has been around for a while. What it is being said in polite terms is that effort is required to draw Sikkim away from the mediocrity of its human resource that infiltrates just about every field of activity here. Take journalism for instance. No one will praise the media in Sikkim as outstanding. Promising, may be... maybe even prolific, but not outstanding. Not quite yet. At best, we can be accepted as average. Of course, we in the media will never admit even to ourselves that we compete in mediocrity, but that is another discussion altogether.

But why is the fourth estate so mediocre in Sikkim? Not because there is a dearth of committed media-persons in the region, but simply because no demands are made of them for excellence by the readers. Mediocrity flourishes in the absence of pressure. Much the same holds true for every other aspect of life here. Take governance for example. The bureaucracy remains somnambulant, because the public representatives don't shake them up often enough. Take a look around, administrative basics and even etiquette remain ignored until too late. And then a situation explodes into a dharna and issues get resolved, leading one to wonder why it takes public demonstrations to get heard. It is obvious that all of these situations arrived with enough advance warning, but remained unaddressed until only excuses and shifting of blame could be offered where simple outreach and consultations could have worked. That said, even public representatives don't get pro-active. This, primarily because the people don't demand delivery or even action from them and appear satisfied with securing favours instead of claiming their rights.

It's a vicious cycle, but not one that is impossible to break. All it requires is involvement.

No one will strive for excellence if it is not demanded of them. Also, no one will strive for excellence if it is not recognized either. And recognition is possible only if the people differentiate between what is downright puerile, what is average and what sets the bar of performance higher. And that brings us back to the need of having a "knowledge-based" society. Simply put, only a society that is "knowledgeable" will be able to demand that its intelligence is respected. This knowledge should not be confused with literacy [Sikkim does quite well on that front]. Knowledge here is about being informed. People who are aware of what is happening around them can take intelligent decisions and once the people think intelligently, then those who serve them [from the media, to the public servant, to the public representative] will have to improve their performance too. The pressure for survival [as professionals] will itself pull Sikkim out of the mediocrity it wallows in at present.

But how does one go about it? It is not really as complicated as it sounds. For people to become more aware, all they have to do is get more involved, ask more questions, demand better answers. The government can contribute towards this transition by making information accessible. It is only after the people have been provided with information that they can mull over it and debate it. Although the debates might be immature initially, they will get better eventually. Once that happens, the people themselves will shape the knowledge-based society that Sikkim needs to grow into now.

Book Review: Behrouz Boochani's unsparing look at the brutality of Manus Island

It is a matter of wonder that Behrouz Boochani was able to write No Friend but the Mountains at all. He did so while in Manus prison, using text messages in Farsi on smuggled mobile phones. Egyptian and Australian academic Omid Tofighian worked closely with Boochani to translate the text into English. In a detailed introduction to the book, Tofighian explains that Boochani's writing contributes to a Kurdish literary tradition. He describes his style as "horror surrealism".

This is not how I experienced the book. Although the imagery Boochani shares is horrific, and the brutality of the prison environment is almost beyond belief, Boochani is bearing witness to a system of detention that is part of contemporary Australian policy, and to which he is an on-going victim. This is no piece of imagination.

In a prologue to the book, author Richard Flannagan places the book in the Western genre of "prison literature", alongside writing by the likes of Oscar Wilde and Antonio Gramsci.

For me, the book invokes Ken Kesev's One Flew Over the Cuckoo's Nest for its use of insanity and humour to explore the brutality of authority, and Shahram Khosravi's 'Illegal' Traveller for its meditation on state techniques for exclusion through the eyes of the excluded.

The book begins with Boochani boarding a boat somewhere on Java, hoping to reach Australia. In elegant prose, he brings to life the refugee journey through detailed observations of his fellow travellers. He describes a rapid collapse of order:

"Men lie in the arms of another's wife, children lie on the bellies of strangers. It seems they have all forgotten ... the energy spent establishing a gender-based order."

A storm destroys the boat with waves the size of mountains that transport him back to the mountains in his native land.


"Where is this place? Why is my mother dancing?" After being rescued, a short interlude on Christmas Island begins the clinical process of dehumanising the asylum seekers. They are issued flip-flops and ill-fitting clothes, regularly strip-searched, exposed to CCTV in toilets, moved from cage to cage through layers of bureaucracy, and finally escorted (or carried) by two guards per prisoner to an plane bound for Manus Island.

From this moment, the sense of a journey ends, and the book is a meditation on survival in a prison system intent on destroying the prisoners' will.

Australians accept detention on Nauru and Manus as a "necessary evil" to prevent an uncontrollable flow of asylum seekers to Australia by boat. Boochani dissects this necessary evil. He sits us on a white plastic chair, our feet on the wire border fence, overlooking the jungle.

There is no silence. Only the constant grind of an old tractor generator, the whirr of fans, the noise of hundreds of prisoners crammed into a space the size of a football field, the static of the guards' walkie-talkies signalling an incident.

Boochani takes us on a sensory tour of the Manus prison. The smells - body odour and bad breath, rotting vegetation, diesel and excrement. The rubbing against one another in the tight spaces - flesh on hairy, sweaty flesh.



The uniforms are reminiscent of dystopian regimes - nurses in orange carrying boxes of yellow pills, local guards in purple, medical staff in white, and Australian federal police in flak jackets with shields and black gloves with metal spikes.

The heat is oppressive. The bottled water so warm it does not quench one's thirst. The only relief is a huge shade tree in the middle of the complex.

We learn of the daily routine, the constant queuing for meals, for the toilet, for cigarettes, for the telephone. Through a detailed analysis of how these queues operate, we begin to understand the way institutional power breaks the spirit of the prisoners by pitting one against another, and using an unbending authority to remove all human compassion.

In one incident, a man cannot swap his place in the telephone queue to speak to his dying father because the regulations make no provision for it. An appeal to a higher authority brings out the Boss, backed by 12 police officers. The Boss places his hand on the shoulder of The Man with the Dying Father (as Boochani calls him) and calmly explains that the rules are the rules.

The queues mean that stronger prisoners eat well, and weaker ones starve. Bouchani marvels at the fortitude of The Cow, a brick of a man, who is prepared to sit in the heat of the sun for hours to ensure his place at the front of the meal queue.

In the first few months of detention, there is still a sense of resistance. Maysan the Whore en-

tertains prisoners most nights with wild dancing in innovative costumes of bed sheets, "pretending to be happy as a form of revenge". But eventually Maysan begins to deteriorate. "We must find another way to cope with exile", Boochani laments.

Boochani shares his own weakness, anger, frustration and despair. He does not romanticise these feelings. He simply observes.

Periodically, he tries to make sense of his experience, musing on the strategies of oppression. He describes Manus prison as a Kyriarchal system, a system of total psychological control.

The generator, which Boochani calls Mr Generator, breaks down periodically, leaving rooms unbearably hot and filled with mosquitoes. Just when the tension is unbearable, the generator resumes.

Games are not allowed. When prisoners create a makeshift backgammon board on a table using bottle lids, it is destroyed.

"How can it be that soccer balls are prohibited, but cigarettes are always available?"

Milk is offered as a special treat. The allocation is always half a cup. If a cup is overfilled, even slightly, it is removed and binned. Why not just redistribute the milk? The lack of logic "confines the mind of the prisoner", Boochani writes, "leaving him just trying to cope".

The toilets flow with excrement. They are a place for sex. A place to cut wrists with a razor. Despite risk of punishment, people prefer to piss behind bushes after dark.

The sights and sounds outside the walls are important for retaining hope and sanity – the sound of the ocean just behind a thin strip of forest, the coconut trees, the chauka birds and crickets, the sunsets and phases of the moon, the white flowers along the sewage line.

"The prisoner's imagination is always occupied with the world beyond the fences."

Poetic streams of consciousness intersperse the narrative, and Boochani is occasionally transported back to the Kurdistan of his childhood. At these moments, the reader is with Boochani at the fence as he lets his mind run free, interpreting the confusion of his existence in this place of torture. These interludes make the book more intensely personal without descending into romanticism or self-pity.

The book ends with the description of a riot in the prison. The full brutality of authority is unleashed in response. We learn that The Gentle Giant, Reza Barati, has been killed.

No Friend but the Mountains reveals that Manus prison is designed to break the will of refugees so they see no option but to return home. It leaves no doubt that any prisoner who chooses to repatriate has been driven to do so through the brutality of the prison system, in clear breach of Australia's non-refoulement obligation under the UNHCR's 1951 Refugee Convention.

Every Australian should read this book and marvel at the extent of our brutality, the human cost of a "necessary evil".

A robot that can touch, eat and sleep? The reality of cyborgs like Alita: Battle Angel

Alita: Battle Angel is an interesting and wild ride, jam-packed full of concepts around cybernetics, dystopian futures and cyberpunk themes.

The film – in cinemas from today - revolves around Alita (Rosa Salazar), a female cyborg (with original human brain) that is recovered by cybernetic doctor Dyson Ido (Christoph Waltz) and brought into the world of the future (the film is set in 2563).

Hundreds of years after a catastrophic war, called "The Fall", the population of Earth now resides in a wealthy sky city called Zalem and a sprawling junkyard called Iron City where the detritus from Zalem is dumped.

We follow Alita's story as she makes friends and enemies, and discovers more about her past. Her character is great - she has many of the mannerisms of a teenage girl combined with a determination and overarching sense of what is right - "I do not stand by in the presence of evil."

So let's dig into the many scientific concepts touched on in the film and see how far from reality they are, or might be in the future.

TOUCH SKIN

Alita goes through two cybernetic bodies in the film, with the second being especially advanced. A big part of the film is the interaction between the human and cyborg components, and a major component of that is touch, especially with respect to the main love interest Hugo (Keean Johnson).

As shown in the film, Alita's cyborg body has a pretty advanced and location-sensitive sense of touch. In today's world, robot touch, or tac-

tile sensing, is relatively advanced ently almost instantaneously. (although not yet widely deployed) and uses a range of technologies including deformable skin that changes both its capacitance (to measure and "sense" the touch) and illuminance (to display the results of the touch).

Touch can also be detected in terms of changes in temperature, conductivity, resistance or even optical changes that result from a touch.

Verdict: Not a stretch.

ANTIMATTER HEART

Like Ironman from The Avengers with his arc reactor, and The T-850 from the Terminator series with its hydrogen fuel cells, Alita is powered by an antimatter heart.

We are nowhere close to an antimatter-type energy source at this stage - current robots of similar size like the ones Boston Dynamics builds are increasingly being powered by relatively conventional batteries.

There are multiple major obstacles to overcome in using antimatter as any type of energy source, including finding an efficient way to obtain the antimatter in the first place and capturing the energy released from a matter-antimatter event.

Verdict: Beating physics is difficult. **LEARNING TO USE A BODY**

Alita's first steps upon waking up in her new body cause her to stumble, but only momentarily.

Robot walking and other related motion capabilities have long been an active field of research, with companies such as Boston Dynamics making very publicly visible strides (see what we did there) in biped (two legs) and quadruped (four legs) movement.

Alita has likely never used the exact body that she is given at first – but manages to walk, jump and fight flu-

This is in stark contrast to current robots learning from scratch to walk - which can take thousands of hours of training in simulation and then on the robot to get right.

Instead it's likely that Alita has a range of pre-trained motion models for a variety of body configurations, and is able to rapidly tweak them to work on the body she is given.

Verdict: Runs well. WILL CYBORGS NEED TO EAT?

The doctor tells Alita she has to eat to provide nutrients to her (still organic) brain. This sounds reasonable, but she would need a complete digestive system to break the food down into nutrients and absorb them

into her bloodstream. Since her torso is completely inorganic, it's more likely that fluid, vitamins, minerals and macronutrients (proteins, carbohydrates and fats) would be injected directly into her blood.

Today, some people who have had their intestines removed due to illness continue to live relatively normal lives.

Verdict: Hard to swallow. WILL CYBORGS NEED SLEEP?

We first see the repaired Alita as

she wakes up from a deep sleep.

Scientists are not certain about all the reasons that sleep is needed, but it seems particularly important for the brain. While awake, your brain cells use lots of energy and produce lots of metabolic waste that accumulates around the cells.

At night while you sleep, your brain clears away the waste. Sleep also seems vital for remembering what you've learned.

Since Alita's brain is human, it's quite plausible she would need to sleep. Verdict: Not just a dream.

COULD A BRAIN SURVIVE FOR 300

YEARS?

Even while you sleep, your brain still needs a constant supply of oxygen. Brain damage from a lack of oxygen starts becoming irreparable after about 20 minutes without it, although with noted exceptions.

Brains can be temporarily put into a state of suspended animation by cooling them down dramatically, and operations like heart transplants are sometimes done this way today.

But keeping the brain cold also requires power, and a brain can only currently be kept alive like this for a few hours, not the 300 years portraved in the movie.

Verdict: A little brain-dead. THE FUTURE OF HUMANS - CYBORGS

Alita: Battle Angel presents a world full of cyborgs with varying remnants of their humanity (both physical and mental). Whether this is a realistic potential future is still up for debate - we don't know whether this ongoing hybridisation of humans and technology will be sustained or will rapidly switch completely over to robotics technology.

But if we are to have a future of cyborgs, the movie presents (sometimes realistically) a range of concepts that are fascinating to consider: will these cyborgs still need to eat, to sleep, and how will a mixed society of humans and cyborgs function.

Alita: Battle Angel is a vision of one such possible future, and is a worthy addition to the canon of films that provoke us to think about just what our world of tomorrow will look like.

Bangladesh rescues abducted Malaysiabound Rohingya

Bangladesh police have stopped 43 Rohingya refugees from being smuggled to Malaysia by boat claiming they were abducted by traffickers, officials said Thursday.

Acting on tip-offs, police found the refugees at two separate places in the southeastern border district of Cox's Bazar, raising the number of Rohingya being rescued from the traffickers to more than 100 in less than a week.

About 740,000 of the Muslim minority fled Myanmar for Bangladesh after a military clampdown in the Buddhist-majority nation in August 2017.

They have joined another 300,000 Rohingya who have already been living in overcrowded camps in Cox's Babouts of violence.

Officials fear many may end up being exploited by an internationally organised human smuggling racket who have previously sent thousands of Rohingya to Malaysia by boats until Bangladesh launched a crackdown in 2015 following the discovery of mass graves of refugees in Thailand.

Rapid Action Battalion, an elite police unit, said they rescued 12 women -- mostly in their 20s -- from a residential room in Cox's Bazar city early Thursday morning and arrested two alleged traffickers for "abducting" them.

"The young women from the refugee camps were lured by the traffickers. They were promised they would be sent to Malaysia. They were then brought to Cox's Ba-

DHAKA, FEB 14 (AFP): zar and kept in a house," RAB spokesman Mashkur Rahman told AFP.

Rahman said they were treating it as a case with a dozen women of abduction after the women claimed they were confined in a room without consent.

> In another drive late Wednesday, Cox's Bazar police rescued another 31 Rohingya from the southern island of Maheshkhali, some 110 kilometres (70 miles) away from the overcrowded Kutupalong refugee camp.

> Local police chief Provash Chandra said the 14 women, 11 men and six children were hiding in a coastal forest at Maheskhali waiting to board a Malaysian-bound boat.

"They paid some 20,000 taka (240) each to the traffickers for the journey," he said.

He said they arrestzar following previous ed a woman trafficker and were "searching for others".

> An analyst said the latest discovery of Malaysia-bound Rohingya was a "dangerous" sign and shows the desperation at more than 30 refugee camps where the Rohingya live in bamboo and tarpaulin made shanties in squalid conditions.

> "It is very natural for the desperate refugees to attempt the risk to search for a better future," Tasneem Siddiqui who heads a Bangladeshi think tank on migration issues, told AFP.

> "They know the way is full of obstacles, yet many think this is their only way out," she said.

> Authorities fear that more Rohingya will try to take boats to Malaysia while the Bay of Bengal remains calm before the arrival of monsoons at the end of March.

EU-India to jointly fund 7 research and innovation projects to tackle water challenges

The key focus areas of these projects include improving the quality of drinking water, waste water management and real-time monitoring and control systems. In total, 130 entities will be

> Those participating in the projects will include prestigious institutions such as IIT-Bombay, IIT-Guwahati, IIT-Bhubaneswar, IIT-Roorkee, IIT-Delhi, CSIR-National Environmental Engineering Research Institute (CSIR-NEERI) and TERI. Besides supporting India's Ganga Rejuvenation initiative, the projects will also support transfer of European technologies to India, which would require them to be tested, demonstrated, and customised to suit Indian needs at an affordable cost, the statement said.

> The cooperation will also lead to increased scientific excellence while ensuring that at the end of the project, the technology can be deployed and be of benefit to the entire Indian population, it said. "Many of these water challenges are common to India and the EU. India and Europe have, in the past, collaborated intensively on water, enriching each other's technological and scientific knowledge and management capacities to cope with stress on water resources," said Tomasz Kozlowski, Ambassador of the Europe an Union to India.

A pure match-winner, a back-up opener and an effortless six-hitter in the class of Rohit Sharma -- Pant is a left-hander and all in the same mould. The third reason cited by Nehra was Pant's ability to hit sixes effortlessly from the word go. Nehra said the fearless approach comes in handy in pressure situations.

"If it comes to effortlessly hitting sixes, Rishabh comes second only to Rohit Sharma with his big-hitting ability. India will need that in abundance during the World Cup," Nehra said.

US and China seek deal to prevent trade-war escalation



BEIJING, FEB 14 (AFP): US and Chinese negotiators on Thursday kicked off two days of high-level talks that President Donald Trump says could decide whether he escalates the bruising tariff battle between the world's two biggest economies.

Trump indicated this week he was open to extending a trade truce beyond March 1 depending on progress in Beijing. He is considering pushing the deadline back an additional 60 days, Bloomberg News reported, citing sources.

In December postponed plans sharply hike tariffs on 200 billion of Chinese imports to allow more time for negotiation.

The two economic superpowers have already imposed duties on more than 360 billion in two-way trade, which has weighed on manufacturing sectors and shaken global financial markets.

US Trade Representative Robert Lighthizer and Treasury Secretary Steven Mnuchin are meeting with China's top economic czar Liu He, seeking to build on progress made in Washington last month.

We are "looking forward to discussions today", Mnuchin said as he left his hotel Thursday morning for the talks.

Expectations for a trade deal have grown as China faces pressure from slowing economic growth, and as swooning global markets pose a challenge to Trump and his economic advisors.

Data released Thursday in China showed its trade surplus with the US -- a major source of anger within the Trump administration -- narrowed in January to 27.3 billion, even as its American imports plunged 41 percent for the month from a year earlier.

Last year the surplus hit a record USD 323.3 billion.

China's total imports also sank for the month, pointing to weak demand amid slowing economic growth.

Chinese President Xi Jinping plans to meet

with the US officials in Beijing this week, a report in the South China Morning Post said Wednesday, bolstering hopes for the talks and world markets.

Trump also has said he expects to meet with Xi "at some point" to clinch a trade deal.

Trump told reporters in the Oval Office on Wednesday that preliminary talks in Beijing were "going along very well," Bloomberg reported.

"They're showing us tremendous respect," he added. "Markets will continue to watch -- and react -- closely to the ups and downs of the negotiations," said Trey McArver of Trivium Research.

"But Sino-US relations are all about the two leaders, and it will ultimately be up to Xi and Trump to come to a deal -- or not," he wrote Wednesday in a newsletter.

The two sides said major progress was made in talks last month in Washington, but a wide gulf remains on some issues.

US says ex-intel official defected to Iran, revealed secrets

A former US Air Force counterintelligence specialist who defected to Iran despite warnings from the FBI has been charged with revealing classified information to the Tehran government, including the code name and secret mission of a Pentagon program, prosecutors said Wednesday.

The Justice Department also accused Monica Elfriede Witt, 39, of betraying former colleagues in the U.S. intelligence community by feeding details about their personal and professional lives to Iran. Four hackers linked to the Iranian government, charged in the same indictment, used that information to target the intelligence workers online, prosecutors said.

Witt had been on the FBI's radar at least a year before she defected after she attended an Iranian conference and appeared in anti-American videos. She was warned about her activities, but told agents that she would not provide sensitive information about her work if she returned to Iran, prosecutors say. She was not arrested at the time.

"Once a holder of a top secret security clearance, Monica Witt actively sought opportunities to undermine the United States and support the government of Iran

Witt served in the Air Force between 1997 and 2008, where she was trained in the Farsi language and was deployed overseas on classified counterintelligence missions, including to the Middle East. She later found work as a Defense Department contractor.

The Treasury Department on Wednesday sanctioned the New Horizon Organization, which organized the conferences Witt attended and hosts events that American officials say promote Holocaust denial, conspiracy theories and serve as a platform to recruit and collect intelligence from attendees.

Witt first traveled to a "Hollywoodism" conference in 2012, when she appeared in Iranian television videos in which she was identified as a former U.S. service member with critical views of America. She was then warned by FBI agents that she was a potential recruitment target for Iranian intelligence.

"She chose not to heed our warning that travel to Iran could potentially make her susceptible to recruitment," Tabb said. "She continued to travel." Later that year, she was hired by an individual who is not named in the indictment but who professed to have ties to high-level officials to help in the filming of an anti-American propaganda commercial.

She returned to an-"Hollywoodism" conference in 2013. This time, with free housing and computer equipment, she went to work for the Iranians, supplying information about a classified Defense Department program and assembling into "target packages" research she conducted into the lives, locations and missions of former colleagues, the indictment said.

The accused hackers exploited that research, contacting Witt's former colleagues through imposter Facebook and email accounts. Their goal was to induce the targets to click on links and attachments containing malicious software that could the compromise their computer and networks.

The case was unsealed soon after the Department Justice freed from custody an American-born Iranian television anchorwoman who'd been detained for days by the FBI as a material witness in an unspecified criminal investigation in Washington, where the Witt indictment was filed. Marzieh Hashemi works for the Press TV network's English-language vice. She has not been charged with crimes. Justice Department officials wouldn't say if the investigations were connected.

SINGAPORE, FEB 14 (PTI): Featuring in and as Captain Marvel helped Brie Larson realise a dream she didn't think was pos-

sible. The actor says the film gave her a "larger" platform to contribute to feminism, a cause dear to her heart.

Larson stars as US Airforce pilot Carol Danvers, who becomes one of the universe's most powerful heroes Captain Marvel.

The 29-year-old actor, who is a vocal women's rights activist, said it struck her while working on the Marvel film that she would be able to reach out to more people with the message of gender parity, a privilege not enjoyed by an indie movie that she usually collaborates on.

"It was really powerful and exciting. And it's also allowed me opportunities 'coz the film is so big, I knew I would be able to share certain concepts on a much larger scale than I'd been able to previously in indepen-

dent films and even carry that over in the press tours.

"I have never had a press tour like this where we were able to work on reaching parity along the way. I feel so lucky

that I made my first blockbuster movie and I just get to talk about feminism all day. I never would have thought that was like a possibility for me. That's like my dream, Larson told PTI

during a group interview.

With Captain Marvel, which is an origin story set in the 1990s, the actor has become the first woman to lead a standalone Marvel superhero film.

The Oscar winner says she toiled for nine months before she started shooting and the inherent connect with the story made her get up every day, even when she felt like giving up.

"I think you have to have something that kind of transcends the movie, that keeps you going, that gives you fuel every day. Because it takes too long to make it and I trained for nine months. Then the shoot was 75 days. It's almost a year to go at something really hard every single day.
