Covid breaks into Sikkim's jails 18 UNDERTRIALS TEST POSITIVE AT BOOMTAR DIST

JAIL, 79 FOLLOW SUIT AT STATE JAIL, RONGNECK

BIKASH CHETTRI NAMCHI, 19 DEC:

N ovel Coronavirus has broken into Sikkim's prisons, starting with the district jail at Boomtar, Namchi, South Sikkim, and exploding at the State Jail at Rongneck, Gangtok. For most of the time, jails can be expected to be at a safe social distance from the rest of the population, but with new inmates and undertrials, the restricted nature of prison life also makes it the ideal environment for an outbreak. And this has been proven by the situation at Sikkim's two prisons where nearly 100 have tested positive in the past ten

The first Covid-19 case at District Prison, Boomtar, came to light on 08 December when an inmate under judicial custody there tested positive.

Tests conducted over the next ten days have returned



18 positive cases, all males. The reassuring news from the Boomtar prison is that all the 143 people - personnel and inmates and primary contacts at the jail have been tested and the number has stopped at 18.

When contacted, DC-South,

M Bharani Kumar, confirmed the numbers and informed that the Covid-positive inmates have been isolated in a separate cell and the entire prison complex sanitized. None of the 18 positive inmates have any comorbid conditions, he adds.

All eighteen cases are asymptomatic and all are keeping well at present.

Further, the Medical Officer concerned from the District Hospital has visited the prison and examined and counseled all the positive inmates and other staff there. The staff nurse at the prison has also been instructed on all the precautionary measures to be taken. After the sanitization drive, additional supplies of masks, gloves, PPE kits and other required items were also provided to the prison authorities.

As a precautionary measure,

new inmates will be placed under two-week quarantine and only then assigned to their respective cells, it is informed.

The outbreak has been much bigger at the State Jail, but that was to be expected since it also lodges many more inmates and has a larger roll of personnel. In Gangtok, both under-trials and convicted prisoners are housed, albeit separately, while the Boomtar Jail primarily has under-trials.

At Rongneck, the virus was first detected a few days back with two inmates testing positive. Since all inmates and staff at the jail were primary contacts, tests conducted since returned 79 positive cases today taking the total positive cases there to 81.

The State Jail has now been declared a Covid Care Centre and doctors stationed there, health authorities inform.

In his daily health bulletin on Saturday, Department Health IEC Officer, State Sonam Gyaltsen Bhutia, informed that of the 122 new cases, 113 District, two from West District and seven from South District. He added that these

He said that the Choir managed to find an old man from Switzerland who spoke the Ancient Armani language and he helped translate the verse while another lady from London also lent a hand in translation.

"We are not alone in this. We had to learn a lot and to be able to learn and teach is one of the biggest things we can achieve in life," he added.

Meanwhile, one of the choir members said, "It was a welcome challenge. It was a challenge in a sense that we had never heard

anyone speak Ancient Aramaic. A wonderful experience although some songs were really challenging".

Talking about project, opera Nongkynrih said, "It is a three-hour-long opera in Khasi and one of the biggest works I am doing. I'm hopeful of finishing it by 2021".

Informing that the three-hour long opera will be done globally, he said expressed hope that the SCC will figure in the opera map globally.

OFOJ should be seen as Sikkim's gift to world economy

The subject of One Family One Job (OFOJ) scheme I has grabbed people's attention and headlines ever since this term was first coined in Sikkim in mid 2018. It has been a matter of debate and controversies owing to its implementation with both merits &

The scheme primarily being an employment guarantee scheme to one person of one family who had no government or any form of employment (MR, Adhoc, Co-Terminus etc) in the state of Sikkim due to various factors in getting employment in the government sector. When the OFOI scheme is about to celebrate its 2nd anniversary since its inception in Jan 2021 it has once again become a matter of debate in the state.

However, in my own understanding there are merits that the scheme of One Family One Job had directly or indirectly contributed towards the economic, social and human development growth of Sikkim. Here are few points:-

i) the famous OFOJ scheme have directly resulted in the growth of rural economy. With the increased income there has been a growing trend in the purchasing power capacity of people at large which has ensured fund flow in the market economy. Since a major percentage of OFOJ employees are employed in rural areas, a trend of higher fund flow in the form of salaries in rural markets have been witnessed which a great sign for the growth and development of state economy in long run. For example an average amount of ₹ 50 lacs per constituency are paid by the government in the form of monthly salaries to the OFOJ employees the purchasing power of individual buyers have increased providing better opportunities for the sellers to increase their sales and cash flow. Therefore there is a reciprocal increase in the incomes of both buyers & sellers. With this development the young entrepreneurs of state are finding better market avenues to start up new business ventures due to the higher income flow and change in the purchasing trend of people.

ii) with the introduction of the OFOJ scheme in the state it will directly or indirectly help in reduction of poverty rates or a sudden jump from BPL to APL category for families those rallied under below poverty lines for long. This change will help Sikkim better its standing amongst other states in the national economy. As an average beneficiary family

under OFOJ scheme earns an amount of ₹1.2 lakhs per annum that that is way above the fixed national rate or say per capita income.

iii) the various social issues related with suicides, drug abuse, theft, robbery etc has seen a decreasing trend those were a common practises in the state and one of the reason for such social stigma were due to low income, unemployment, early marriages etc. As the majority of young people are now engaged in one or the other form of employment under the OFOJ scheme this has directly resulted in better social stability in Sikkim.

iv) unemployment that is one the growing concern of any developed, developing or an underdeveloped economy and the state of Sikkim is not left far behind this global phenomenon. However, with the introduction of the such employment guarantee scheme the rate of unemployment has seen a decline in rate of unemployment which is an effective approach to fight against this global challenges and employment opportunities.

v) although, with the introduction of the OFOJ scheme it could have caused a major impact at the state exchequer due to the financial burden added on the already relying state economy. However, the policy decision makers must look at the merits for it to make the best possible use of the Human Resource's that is available at government disposal. Better training's facilities, job guarantee can be introduced that will serve the larger interest of common citizens of the state and boost the general morale of the employees under OFOJ. A more refined data collection (eg educational qualification, professional experiences) can be conducted of the employees under OFOJ schemes as the number of beneficiaries are well qualified under this scheme will help in proper Human Resource management.

There are end number of merits attached with the scheme of One Family One Job and this in my knowledge shouldn't be an act of controversies or to prove individual achievements rather it should Sikkimese gift scheme to the world economy those are fighting the menaces of unemployment, terrorism, drug abuse etc. And there is no denying the fact the Shri Narendra Modi himself has announced his ambitions "One Family One Job plan 2020", that has made ever individual Sikkimese people proud, as we were the first to coin this "One Family One Job".



Farooq Abdullah assets worth Rs 12 Cr seized in money laundering probe

New Delhi, 19 Dec Mr Abdullah, a National [NDTV]: Assets worth ₹ 11.86 crore of National Conference president Farooq Abdullah have been attached by the **Enforcement Directorate** Cricket Association (JKCA) money laundering case, the agency said on Saturday.

The Enforcement Directorate, which investigates financial crimes, is looking into money-laundering allegations connected to the J&K cricket body. The CBI had in 2018 filed

Conference MP, and three others, for alleged misappropriation of ₹ 43.69 crore between 2002-11.

Enforcement in connection with the Directorate claimed it has Jammu and Kashmir found that between 2006 and 2012, Mr Abdullah misused his position to launder JKCA funds. More than ₹ 45 crore appear to have been siphoned off including large cash withdrawals, it said.

His assets attached include three residential and one commercial properties and four plots of land in Jammu and a chargesheet against Kashmir. While the book

value of these attached properties is ₹ 11.86 crore, their market value is about ₹ 60-70 crore. officials in the agency told news agency PTI.

Mr Abdullah, who was questioned twice in Srinagar in the case in October, and his party have linked the investigation to the recent move by the 83-year-old to bring together all Jammu and Kashmir parties in a campaign for restoring special status.

"The letter from the **Enforcement Directorate** came after the Gupkar declaration. It is clear political vendetta after the 'People's Alliance' was formed in Kashmir," a National Conference spokesperson said.

"We knew it was coming," said the party, adding that the ruling BJP at the centre was using its agencies to fight the new political formation because it "couldn't fight it politically".

"This is the price one faces when opposed to the BJP's ideology and divisive politics. Recent history is witness to how the BJP has been employing coercive and intimidative measures through various departments to target opposition leaders

across the country. The recent ED summons to Farooq Abdullah is a case in point," said the National Conference.

Last year, Mr Abdullah was summoned by the agency was in July, days before the centre's August 5 move to end special status to Jammu and Kashmir under Article 370 and divided it into two union territories.

Mr Abdullah, his son Omar Abdullah and their rival-turned-ally Mehbooba Mufti - all former Chief Ministers - were among scores of politicians detained at the time.

There may not be second peak of COVID-19 in India: Experts **NEW DELHI, 19 DEC** a state election without a

[PTI]: Healthcare experts have said that there may not be a second peak of COVID-19 in the country, and even if it occurs, it is unlikely to be as strong

as the first one. The comments come as the country's number of daily cases and daily fatalities have been continuously coming down.

Noted virologist Dr Shahid Jameel said India's curve for daily cases is on a downward slope since a peak in

mid-September. "At this time, we are getting about 25,500 cases daily compared to over 93,000 cases per day in mid-September. I believe the worst is over. But there will be small peaks in the future just as we witnessed in late November," he said.

"I don't think there would be a second peak as we have gone through festive season (Dussehra to Diwali) and

significant jump. What is the reason for this? If we go by the second national sero-survey, likely cases were 16 times confirmed cases. By that factor, India would have 160 million cases now," he told PTI.

It is possible that by the one now there are over 300the country, Jameel said. "By that token, we

are seeing large parts of the population getting protected and breaking transmission of the virus." he said.

"Unexposed and susceptible people will continue to get infected. If immunity lasts a year or less, then we may have small peaks at regular intervals for the next few years. Good vaccine coverage will control this effectively," he said.

When asked about a possible second peak of COVID-19, noted clinical scientist Dr Gagandeep opined Kang the transmission will not be as rapid as was seen the first time and the peak will not be as high.

"I don't think the exposure is enough to say that we have herd immunity and won't need to worry about it again, but I think it is enough to ensure that we will have some level of protection so that the transmission will not be as rapid as was seen the crore mark, though the 400 million infections in first time and the peak be a second peak. If India will also be not as high, she said.

"The problem has not gone away it will not go away with herd immunity, but I don't think necessarily we will see second higher peaks as has been seen in the West." Dr Kang said.

Dr KK Agarwal, an eminent cardiologist, said there is still 30-40 percent population in India which has not been infected by COVID-19. He said India, Argentina and Poland are the three countries among the 15 nations having the highest number of COVID cases that are not showing a second peak.

"By all probability, India may not have a second peak, and if the second peak comes, it will only come due to the 501 new variant. Two of them have been described, one in south of England and one in South Africa.

"If you don't get that strain, then there will not vaccination starts its programme by the end of this month and vaccinates around 30 crore people, we should be able to control this disease by March 25," Mr Agarwal told PTI.

However, if there is a second wave, he said, then it would be a new variant of the virus which will mean more cases but lesser mortality and the second peak will help in building herd immunity.

Asked if the worst was over for India, Dr Samiran Panda, the Head of Epidemiology and Communicable Diseases at the Indian Council of Medical Research, said the epidemiological curve has come down for some states, while there is a fluctuation for others.

"In more states, we have seen effective control while in some of the states we need to be mindful and watchful. The state scenarios are different from each other," Dr Panda told PTI.



Stonewalling without Alternatives is Unfair on Sikkim

The wait for reserved seats stretches for Limboos and Tamangs in the absence of consensus

Another year draws to a close, and while Sikkim has much to celebrate for the year going by, there are some matters which remain unresolved and stranded at where they were nearly a decade and a half back. Reserved assembly seats for the Limboo and Tamang communities in keeping with their having become Scheduled Tribes is one of them. The two communities were included in the Scheduled Tribes list on 07 January 2003. This automatically entitled them to contest from Schedule Tribes seats, but when it comes to the Legislative Assembly of Sikkim, they have not been able to do so despite the four assembly elections which have taken place since then.

That said, reserving seats for the Limboo and Tamang communities is not an issue that is easily resolved. The enormously long time that has passed since they became entitled to such seats and the continuing delay has already established prove that The delay, it is also important to accept, is not because there are agencies working against the interest of the two communities because no agency is so powerful so as to keep constitutional provisions at bay. The delay because of a mathematical conundrum to begin with and lack of clear social and political consensus on the way forward, and this consensus building is hamstrung by the complicated distribution of seats in the Sikkim Legislative Assembly and the history behind it.

At one level, it is very straightforward in that with the inclusion of the two communities in the Scheduled Tribes list, assembly seat reservation for them becomes a mandated by the Constitution of India, right? The prescribed calculation - seats in proportion to their population composition in Sikkim – is simple in understanding and demanding what is required, but complicated in how one can arrive at that figure or find the seats.

Yes, things are rarely ever very simple in Sikkim.

Thumb-rule apportioning of seats cannot be undertaken for the exacting and keenly specific requirements of matters which involve the Constitution and when the matter needs to be processed through multiple Ministries. The calculations are further vexed because they do not offer an easily worked out or universally acceptable proportion because of the existing set of reserved seats, which, because they do not follow the proportionate-to-population allotment, make additional reservations unreasonable for the populations left outside the reserved seats in the Assembly. A situation like this cannot be resolved solely by mathematics or rules and laws or even amendments to the Constitution of India and requires involved deliberations at all levels. The political rhetoric that has hounded the issue has however effectively kept such deliberations and hence the required consensus

The only clearly spelled out solution was made in 2008 when the Assembly strength was proposed to be increased to 40, BL seats maintained at 12, Sangha at one and SC at two, and then, from the remaining 25 seats, seats marked out for the Limboos and Tamangs as Scheduled Tribes from their proportion to the population. More than a decade has passed since and while demands, all earnest and valid, have been raised often, no alternate "formula" presented. Admittedly, the proposal at hand is complicated, but this was never going to be a simple issue to resolve. If nothing else, this should have been taken as a starting point to begin deliberating how the seats are to be secured.

Criticisms and even condemnations are necessary reactions in a healthy democracy, but the affected communities would have been better served if these responses were backed by alternate proposals on how the political rights of the Limboos and Tamangs as Scheduled Tribes could be delivered without compromising the political expressions of any other community or section of the Sikkimese population. What is required is an unambiguous and consensual resolution ideally one passed by the Legislative Assembly but more necessarily one which has across the board endorsement of all sections of the Sikkimese society and polity.

PS: There is no central data vet on the proportion of Limboos and Tamangs to Sikkim's population but a Socioeconomic Survey by the State Government has posted the Limboos and Tamangs as making up 16.5% of Sikkim's population. Complications will begin with population data itself because the Centre will want the Directorate of Census Operations to attest this number and as things stand, the Directorate does not count individual communities and counts Scheduled Tribes as a collective group not broken down into individual communities. Its existing count of the ST population in Sikkim includes the Bhutias and Lepchas along with the Limboos and Tamangs. And therein sits another complication. Technically speaking, the new seats will be reserved for Scheduled Tribes [that is the Constitutional provision], and Sikkim will need to leverage its unique status as a part of India to work out how the ST seats will be apportioned since BLs already have reserved seats protected under Article 371F. But if their population is counted among the ST census, how will seats required to Limboos and Tamangs be worked out? There are many more complications round the corner, and Sikkim's refusal to arrive at a clear consensus has kept it stranded at the starting block for twelve years now. This should begin to change.

Granny's on Instagram! In the COVID-19 era, older adults see time differently and are doing better than younger people

Time in the era of COVID-19 I has taken on new meaning. "Blursday" is the new time word of the year - where every day seems the same when staying home and restricting socializing and work.

As a public health and aging expert and founding director of the Texas A&M Center of Population Health and Aging, I have been studying the impacts of COVID-19 with an interest in debunking myths and identifying unexpected positive consequences for our aging population.

It is common to view older adults as especially vulnerable. Public health statistics reinforce the picture of older adults infected with SARS-CoV-2 as more likely to have serious complications, to be hospitalized and

But what do we know about how older adults themselves are responding to social distancing restrictions in place to help mitigate the spread of COVID-19? And what does this changing sense of time mean for them?

CALMNESS, INTEREST **GRATITUDE**

Despite popular notions that older adults would have more negative reactions to forced social isolation, a recent national survey revealed that older adults - despite their awareness of increased risk - are generally not reporting more feelings of anxiety, anger or stress than younger age groups.

They are actually expressing more positive emotions - feelings of calmness, interest and gratitude. Indeed, other surveys suggest it's the youngest adults – ages 13 to 23 – who are experiencing the most stress.

This surprising finding has been attributed partly to older adults' perceptions of time and their coping mechanisms developed over a

Many older people have redefined their experiences in terms of time left to live, and they focus on what is most meaningful now. They let go of what they can't do anything about. Instead of looking back, older adults are motivated to enjoy the time they have left.

What have been difficult are the changing definitions of time and the persistence of a "blursday" existence. Being isolated during spring and summer seemed almost bearable. The uncertainty of knowing when – if - things will return to pre-COVID life is likely to be taking a toll on even the most robust older adults.

Older adults who have been self-isolating for months have been looking forward to getting together with their families over the holidays. Not seeing their families during the holiday season may be particularly difficult.

When I was talking to an older friend the other day, she indicated she was "basically doing fine." She was staying in touch with her family through regular Zoom calls. But she was "a bit sad about the upcoming holidays," and what she "missed most was not being able to hug" her children - "especially over the holidays."

FROM EXPECTATION TO REALITY During a recent SiriusXM Doctor Radio show on which I was the guest "expert," I heard many reallife challenges families face: An older woman with underlying health conditions worrying about not

and grandchildren. Adult children who were weighing what would be worse – possibly infecting their older relatives by visiting or not being able to see their elderly relatives in person for what could be the last time.

While vaccinations are now authorized for emergency use, their rollout will take time and we can't expect them to be an immediate solution for such hard decisions.

Public health guidelines still recommend using face masks and adhering to social distancing rules. They also recommend limiting travel well into the new year.

This push-pull, from expectation to reality, can be an especially hard adjustment. Instead of a one-time cure, will we be thinking of COVID-19 vaccinations as a perennial event, like with flu shot, and COVID-19 precautions as a fixture in our everyday lives?

GRANDMA IS ON INSTAGRAM

Contrary to stereotypes that cast older adults as tech-phobic, many older people are learning new skills to become more familiar with technology. That way, they can stay socially connected and accomplish tasks of daily living such as bill paying and grocery shopping.

Some older adults are even more likely than before to communicate with their loved ones during COVID-19 times using social media platforms.

HEALTH CARE CHANGING WITH THE TIMES

Health and social organizations are more attuned to negative impacts of social isolation and are instituting screening tools and referral sources for care. For example, a social isolation risk getting to travel to see her children screener asks brief questions to

detect early signs of social isolation and link older adults to needed

Another silver lining: Mental health problems may not be so stigmatized when many people have such obvious reasons for unhappiness.

Health care itself is changing, with benefits for patients' time. Instead of expecting older adults to spend hours getting up and out of the house for a 15- to 30-minute appointment, telemedicine has come into many older adults' homes.

There is renewed interest in advanced care planning as well. While doctors, older adults and their families may have been previously uncomfortable about bringing up the topic, such discussions are becoming more common, due in part to the high number of serious complications and fatalities in the older population.

And finally, as an aging expert, I see one more positive change: a destereotyping of older adults.

Beyond the statistics portraying the seriousness of COVID-19 among older adults, there is also a growing recognition that older adults are not all the same. COVID-19 experiences will be affected by existing physical and mental health as well as the social conditions in which older adults live.

While many older adults may be coping well, it's important not to overlook those socially isolated older adults with persistent mental health challenges or difficulties getting access to technologies that can help them connect to others.

International Statistic of the Year: Race for a COVID-19 Vaccine

The number of days between sequencing the **I** coronavirus genome and administering the first vaccine doses to the public.

Scientists in China published the complete genetic sequence of SARS-CoV-2 on Jan. 10, 2020. On Dec. 8, 2020, health officials in London began administering an effective coronavirus vaccine to the public. The global scientific community successfully developed a COVID-19 vaccine in just

I am a statistician, and this year I was on the judging panel for the Royal Statistical Society's International Statistic of the Year. Much like Oxford English Dictionary's "Word of the Year" competition, we choose one statistic that is meant to capture the zeitgeist of the year.

The statistic 332 days was the clear, standout winner. After a year of terrible tragedy, economic hardship and sorrow, this number represents an unparalleled collaboration in the history of medicine that gives hope for a return to normality in 2021.

FASTEST VACCINE DEVELOPMENT EVER

In 1981, researchers established the link between human papillomavirus and cervical cancer, a disease that still causes hundreds of thousands of deaths per year worldwide. But it wasn't until 2006, over 25 years later, that the first HPV vaccine was developed in the U.S.

On average, it takes over 10 years to develop a vaccine. Prior to this year, the fastest vaccine development was for the mumps vaccine. That took four years.

In April 2020, The New York Times played out multiple scenarios with vaccine experts as to how long it would take to get a SARS-CoV-2 vaccine. Under normal circumstances, experts estimated, a vaccine would be ready by November 2033.

So how is it possible that researchers got a vaccine to market in just 332 days?

GOVERNMENT FINANCIAL INVESTMENT

A number of things helped to get this vaccine done fast, including international collaboration of unseen proportions, an expedited trial phase process and the biology of the virus itself. In addition to these efforts, one very important



reason for the incredible speed was the huge amount of investment made by governments at the very beginning of the pandemic.

Usually, pharmaceutical companies have limited resources they are willing to spend on vaccine development, and usually, governments are not willing to sink endless money into a process that they aren't sure is going to work.

The COVID-19 pandemic has thrown the entire playbook to the wind. As of writing this, 641 therapies and 189 vaccines related to COVID-19 are under development, most of which are government-funded.

The U.S. government invested in multiple vaccines with the understanding that some of them wouldn't work, but with the hope that a few would. Under Operation Warp Speed, the U.S. government quickly pledged almost US\$9 billion to fund vaccine development and production. Moderna - whose vaccine is expected to become the second authorized for U.S. use after Pfizer's, received a little under \$1 billion of federal funding, with a

further \$1.5 billion for 100 million doses. While this number alone is not surprising - vaccines tend to cost between \$521 million and \$2.1 billion to develop - this was just one of many expensive projects.

Funding from governments and private donors also went toward building manufacturing facilities with the assumption that a vaccine was imminent and the usual regulatory hurdles would be passed quickly. For example, the Bill and Melinda Gates Foundation helped fund seven factories back in April, even though only one or two of the factories will actually be used.

This influx of money into multiple vaccines and early preparation for manufacturing was instrumental toward getting a vaccine developed and distributed in record time. The development of COVID-19 vaccines is a testament to the ingenuity, dedication and collaborative efforts of the scientific community. At the end of a seemingly hopeless year, there is a light at the end of the tunnel.

Of the 1,832 fatalities, Khurda district alone accounted for 312 deaths followed by Ganjam (246), Sundergarh (158), Cuttack (138) and Puri (113).The state currently

has 3,029 active COVID-19 cases, while as many as 3,20,947 patients have recovered from the infection. The state has so far

conducted over 65.69 lakh sample tests for COVID-19 including 33,067 on Friday. Odisha's positivity rate stands at 4.96 per cent, the data released by the health and family welfare department said.

NFR to operate Dibrugarh-Howrah special trains

Tinfoil Gloves: Why Has MMA Become a Breeding Ground for QAnon?

KARIM ZIDAN LONDON, [THEGUARDIAN]: There was anger on the streets of Huntington Beach.

At the intersection of Main Street and Pacific Coast Highway near the picturesque pier, hundreds gathered on 30 November in defiance of California's coronavirus curfew, which prohibits all "non-essential work, movement and gatherings" between 10pm and 5am until 21 December across most of the state. The so-called "curfew breakers" protest brought together a collection of coronavirus truthers, anti-maskers, and those who remain convinced that Donald Trump won the 2020 presidential election.

Among those gathered at the rally were former UFC champion Tito Ortiz, who was recently elected to Huntington Beach city council, despite a lack of any political or legislative experience. The fighter carried an American flag over his shoulder and stood among the raucous group, which bore signs such as "COVID is a SCAM," and "Disobey the lockdown."

"The public spoke and now it's time for the people to take over before we lose our constitutional rights," Ortiz said during an interview at the rally. "I know the ins and outs of what's going on before the rest of people with their 9-to-5 jobs. At the end of the day, electoral votes - it's a fraud."

When asked about The Great Reset, a term coined by the World Economic Forum to describe the rebuilding of economic sustainably following Covid-19

since become a cornerstone of anti-lockdown sentiment, Ortiz said he believes the plan is part of a 'globalist' conspiracy to diminish American freedoms. Ortiz said the plan would have already have taken hold had it not been for one man.

"Donald Trump is that person," he said.

Ortiz's interview littered with references to the QAnon conspiracy theory, and how it is likely to influence his newfound position of power. QAnon claims that a cabal of elite pedophiles consisting of Hollywood actors, Democrats, and high-ranking officials are behind a global child sextrafficking ring. Supporters of the theory believe that Trump is fighting the cabal and is planning a day of reckoning known as The Storm. The Federal Bureau of Investigation has labeled the movement a "potential domestic terror threat."

In the past, Ortiz used his platform to sell apparel marked with QAnon slogans such as WWG1WGA (Where we go one we go all). More recently, he started an account on Parler, the social media network tailored to the farright, in order to propagate conspiracy OAnon-linked theories among his significant

Ortiz is part of a trend of current and former MMA fighters who subscribe to QAnon and adjacent conspiracy theories. It is a trend that includes fighters and coaches from major MMA promotions such as the UFC and Bellator.

In June 2020, the UFC found itself involved in a



QAnon scandal when cutman Don House was spotted on an ESPN broadcast wearing the conspiracy's markings. House had a Q symbol on his chest and the WWG1WGA slogan on the left arm of his shirt. The UFC launched an investigation into House's actions, deeming it a "violation" of its outfitting policy. And while House said he regretted wearing the slogans during the broadcast, defended OAnon's supposed aim to "expose" child sex-trafficking.

There are also several prominent UFC fighters who have either used OAnon-related hashtags or propagated its principles. They include Jorge Masvidal, who used a QAnon hashtag when he posted a false quote by Kurt Cobain in reference to Donald Trump, and bantamweight Anthony Birchak, who tweeted about QAnon until his wife insisted he stop. As for Bellator, middleweight Andrew Kapel outed himself as a QAnon

were no mainstream media organs covering MMA for much of its early rise. The only places to either get info or connect with likeminded [people] was online in message boards or small websites." This trend has continued despite the sport's growth, leaving a portion of the MMA landscape operating on platforms known for peddling conspiracies.

For example, one popular QAnon channel on Telegram with more than 7,000 subscribers is operated by an admin who claims to be an MMA fighter with ties to several notable gyms and fighters. In one of the admin's posts, they claim that "the only athletes speaking the truth seem to be literally us pro MMA fighters." Several other channels operated by QAnon adherents have also shown support for MMA, and especially fighters who support Trump and reject mainstream reporting.

"QAnon followers believe that high profile their adherents give movement legitimacy," said Travis View, co-host of the QAnonAnonymous podcast, "which is why they were eager to support celebrity QAnon boosters

like Roseanne Barr, James Woods, and former Red Sox pitcher Curt Schilling. Despite the rapid growth and even congressional representation of QAnon, it remains a fringe movement. When QAnon is embraced by public figures like professional athletes, they see that as another step towards mainstream acceptance.

Meanwhile, the sport's leading organization, the UFC, has also shown clear favouritism for Trump. UFC president Dana White, has campaigned for Trump and QAnon is, as View notes, "foremost a pro-Trump movement."

There is also a case to

be made that the lack of regulation of MMA fighters' social media accounts in comparison to mainstream team sports such as basketball and football has played a key role in the proliferation of conspiracy theories. The consequences for fighters promoting unfounded conspiracy theories are nonexistent, as neither the UFC nor Bellator have taken any steps to limit their fighters from promoting QAnon. This laissez-faire approach to regulation has helped make MMA a safe space for QAnon followers.

"There is very little institutional pressure to get fighters to not espouse totally crazy beliefs," Thomas explained. "There aren't many sponsors in the sport and the ones that are there also face no consequences for a fighter promoting QAnon with the audience who watches MMA.

"So, where's the cost in terms of social forces? It doesn't really exist."

India slump to new low as Australia cruise to victory in first Test

ADELAIDE, 19 [AAP]: Australia cruised to an eight-wicket win in the first Test at Adelaide Oval, where Pat Cummins and Josh Hazlewood produced spells for the ages to skittle a shellshocked India for their lowest Test total in history.

Tim Paine's team secured a 1-0 series lead before the dinner break on day three of the pink-ball Test, hauling in a target of

The tourists were out for 36 in their second innings after Mohammed Shami retired hurt, having been struck on his exposed right arm by a brute of a ball from Cummins.

New-look opening pair Joe Burns (51 not out) and Matthew Wade (33) shared a 70run stand as Australia needed just 21 overs to complete an incredible comeback.

Shami was rushed off for scans and the paceman's is among a glut of concerns for India, whose captain Virat Kohli will soon fly out for the birth of his first child.

The visitors resumed at 9-1 on Saturday, leading by 62 runs. Cummins (4-21) and Hazlewood (5-8) created unmitigated chaos in the ensuing 90 minutes, during which no batsman reached double figures.

"We arrived today and just collapsed, completely ... it's very hard to find words for how everyone is feeling," Kohli said. "Literally an hour, you put yourself in a position where it's impossible to win. It really hurts."

Nathan would be excused for having flashbacks to the unforgettable Test collapses he was part of in Cape Town (2011) and Trent Bridge (2015), where Australia were all out for 47 and 60 respectively.

Qatar unveils fourth 2022 World Cup stadium

QATAR, DEC (REUTERS): Qatar inaugurated the fourth of eight 2022 World Cup venues, the Al Rayyan Stadium, when the country hosted the Amir Cup final between Al-Sadd and Al-Arabi on Friday. Al-Sadd, coached

by former Barcelona and Spain midfielder Xavi Hernandez, beat Al-Arabi 2-1 to lift their 17th Amir Cup title after Algeria forward Baghdad Bounedjah scored twice.

"It is a wonderful football stadium," FIFA President Gianni Infantino said in a statement.

"The atmosphere is incredible, with the seats extremely close to the pitch... I am sure this



will be a perfect football arena in 2022 when it hosts matches during the World Cup.

"The country is very well prepared for the next FIFA World Cup and on track to host a memorable instalment of the tournament – the first in the Middle East and the Arab world."

The Amir Cup final's date coincided with Qatar National Day and the country is scheduled to host the 2022 World Cup final in exactly two years' time.

The 40,000-capacity venue will host seven World Cup matches up to the round of 16.

After the World Cup, the precinct surrounding Al Rayyan, which includes six training pitches, will be transformed into a regional sporting hub for the local community.

Khalifa International, Al Janoub and Education City are the other three World Cup venues which have already been unveiled.

China to begin COVID-19 inoculations with frontline workers

BEIJING, DEC 19 (AP): China will soon begin coronavirus inoculations for workers in health transport and border control, a senior official said Saturday.

Vice Minister the National Health Commission Zeng Yixin gave few specifics but said the government was prioritising those most at risk of catching the virus.

Workers in logistics and in markets selling fresh meat and seafood would also be placed higher on the list of those receiving vaccines, along with the elderly and those with underlying medical conditions.

China says it has largely contained the spread of the virus domestically, announcing just three new cases of local infection on Saturday, two of them in the capital Beijing and one in the northeastern province of Liaoning.

Vaccines produced by Chinese companies are pending approval in Turkey, Indonesia and Brazil, as manufacturers continue testing the vaccines in more than countries dozen including Russia, Egypt and Mexico.. Bahrain became the second country in the world

Emirates. The UAE last week announced the vaccine was 86% effective, marking the first public release of information on the efficacy of the shot.

Chinese companies have yet to provide information about the results of their phase 3 trials. One of the top firms, Sinopharm, did not respond to multiple messages for comment on its prior efficacy announcement.

Chinese companies have previously released phase 1 and phase 2 clinical trial data for their vaccines through peer-reviewed academic journals.

Even before final market approval, more than a million people have received vaccine shots in a program critics say has not been transparent about safety, efficacy or scientific merit. China officially gave emergency use approval to Sinovac and Sinopharm's vaccine candidates in July. A third company, CanSino, had also given its vaccine Chinese military personnel.

Those receiving the shot included front-line health care workers, border personnel but also workers at state-owned firms who needed to travel abroad.

In the past few months, local governments have also started buying vaccines for immunisations under emergency use.

Health officials previously said China will be able to manufacture 610 million doses by the end of this year and ramp up to 1 billion doses next year.

Sinopharm Sinovac's shot relies on a tested technology, using a killed virus to deliver the vaccine, similar to how polio immunizations are made.

'Big win for democracy': Bosnian city of Mostar gets a vote

SARAJEVO, HERZEGOVINA (AP): Irma Baralija is looking forward to Sunday, when she intends to vote and hopes win her race in the first local election in 12 years held in her hometown — the southern Bosnian city of Mostar.

To make possible, the 36-year-old Baralija had to sue her country in the European Court of Human Rights for letting a stalemate between two major nationalist political parties in Bosnia prevent her, along about 100,000 other Mostar residents, from voting or running in a municipal election for over a decade.

By winning in court in October 2019, Baralija believes she has "busted the myth (that nationalist parties) have feeding to us, that an individual cannot move things forward, that we matter only as members of our ethnic groups."

Parties representing only one ethnic group have dominated Bosnian politics since the end of the country's devastating 1992-95 war, which pitted its three main ethnic factions — Serbs, Croats and Muslims - against each other after the break-up of Yugoslavia.

"I hope that my example will inspire citizens of Mostar, when they vote on Sunday, to be brave, to realize that as individuals we can bring positive change," said Baralija, who is running for a seat in the city council on the ticket of the small, multi-ethnic Our Party.



Muslim Bosniaks and Catholic Croats, who fought fiercely for control over the city during the 1990s conflict, Mostar has not held local polls since 2008, when Bosnia's constitutional court declared election rules to discriminatory ordered that they be changed.

The dominant nationalist Bosniak and Croat political parties, the SDA and the HDZ respectively, have spent over a decade failing to agree about how to do that. Meanwhile, Mostar was run by a de facto acting mayor, HDZ's Ljubo Beslic, and his office, which included the SDA's representatives, with no local council to oversee their work or the allocation of nearly 230 million euros from the city's coffers they have

trash repeatedly up on its streets and hazardous waste and wastewater treatment sludge dumped in its only landfill, which was supposed to be for nonhazardous waste.

An agreement between the two parties, endorsed by the top European Union and the U.S. diplomats in Bosnia, was finally reached last June — eight months after the court in Strasbourg had ruled in favor of Baralija and gave Bosnia six months to amend its election laws so a vote can be held in Mostar.

Mostar is divided in half by a river. During the war, Croats moved to the western side and Muslims to the east. Since the fighting stopped, the city has had two post offices, two electricity and water suppliers, two phone networks, two public hospitals and more — one crumbling set for each ethnic group.

On Sunday, several multi-ethnic parties will be vying for seats in the city council after campaigning on bread-and-butter issues. But the nationalist HDZ and SDA parties hope that, among them, they will secure a two-thirds majority in the council and keep their grip on

power. While acknowledging that the nationalists have armies of faithful voters whom they mobilize by stoking ethnic mistrust, non-nationalist election candidates in Mostar hope the past 12 years has shown that those two parties are too corrupt and incompetent.

"I think that many people finally realized that the abstract, ethnic interests are meaningless while their children are leaving (Mostar) in droves in search of decent jobs and a decent life" elsewhere in Europe, said Amna Popovac, a candidate from the multi-ethnic Platform for Progress party.

The nationalists are now promising to fix the city's many problems as if "Martians and not they were running Mostar, unchecked, for the past 12 years," she added.

Miljan Rupar's name will also be on the ballot. The 35-year-old, who is running as a candidate from the multi-ethnic Social Democrat Party, decided to get involved in politics after realizing that over 38 friends and relatives, including his sister, had left Mostar "for good" in search of a better life abroad.

Rupar wants his city focused on the future. just like the international school where he teaches physics, the United World College branch in Mostar. The school is one of 17 around the globe and run by a movement founded in 1962 with the aim of overcoming Cold War divisions by bringing high-achieving youngsters from all over to live and learn together.

"When I walk into the classroom or attend our bi-weekly assembly and see students and teachers from all over the world, including from various parts of Bosnia-Herzegovina, who share the same values and goals, it gives me hope," he said.

Political journalist Faruk Kajtaz, however, thinks that hope could prove to be treacherous in the divided city, despite local voters' well-justified grievances. He notes that not just Mostar but all of Bosnia has long been politically and administratively fragmented along ethnic lines.

"Maybe too much is expected from the people of Mostar," he said. "(But) just the fact that citizens of Mostar will finally get a chance to vote for their local legislators is in itself a big win for democracy."

Portugal's armed forces help nursing homes battle the virus

AMADORA, PORTUGAL countries by the London-(AP): Tears well up in Diana Correia's eyes as she recalls the October day that 24 of the 55 residents of her nursing home in Portugal tested positive for COVID-19.

The

discovery set off a scramble to enact the contingency plan and stiffen safety procedures. With some staff sent into isolation, others worked double shifts of up to 16 hours in full protective equipment, leaving them lathered in sweat and bone-weary. Some of the home's residents, suddenly confined to their rooms or their floor, were bewildered and chafed at restrictions, even trying to take the elevator and escape confinement.

"They were hard times," Correia says, trying hard to keep her composure. "Very hard times."

As a resurgence of the pandemic in the fall looked set to overwhelm Portuguese nursing homes like Correia's, and the country's public health service struggled to cope, the government mobilized all the resources it could. That included deploying military units.

The soldiers' mission: fan out across the country to visit hundreds of nursing homes and help shore up their defenses against the pandemic.

Long-term care facilities have proven vulnerable worldwide during the pandemic. The age of their residents, their physical closeness inside what is essentially a large house, and the residents' underlying health problems put them in peril. On top of that, nursing home staff in Portugal commonly work in several different care homes and travel between them on public transport.

Noting limited," a study of 21

based International Long-term Care Policy Network, which includes scientific researchers, found in October that those homes' average share of coronavirus deaths was around 46%.

The European Centre for Disease Control, an EU agency that monitors 31 countries, said the same month that up to 66% of all fatal COVID-19 cases have been among nursing home residents.

By that measure, Portugal hasn't fared badly. Care home deaths through Dec. 14 accounted for 30% of the country's COVID-19 fatalities, the General Directorate for Health told The Associated Press.

On Friday, Portugal's total deaths reached almost 6,000.

At the end September, fearing calamity, the Portuguese government sent distress call to military. As well helping with contact disinfecting buildings and providing beds for hundreds of virus patients at military hospitals, the armed forces were now being asked to buttress nursing home protections.

Dr. Maria Salazar, a physician and a colonel in the Portuguese Air Force, swiftly drew up a nationwide program to train care home staff at their workplace. The program also ensures the staff get the specific medical advice they need in almost daily online Q&A sessions with doctors, nurses and pharmacists.

Within a week, the program was launched, coordinated the CECOM military operations command center near Lisbon.

ANKARA, TURKEY (AP): A fire broke out Saturday at an intensive care unit treating COVID-19 patients in southern Turkey after an oxygen cylinder exploded, killing eight people, state-run media reported.

The Anadolu news agency said the fire took place at the privately-run Sanko University Hospital unit in Gaziantep. It cited a hospital statement identifying the victims as being between 56 and

85. The fire was quickly brought under control.

The statement said 14 patients undergoing intensive care treatment were transferred to other hospitals. An investigation underway. The provincial

governor's office later said 19 patients were in the unit when a "high pressure oxygen device" exploded at 4:45 a.m. (0145GMT). Other than the fatalities, no others were injured

in the fire, it sad. Intensive

units across Turkey currently have a 74% bed occupancy rate due to the coronavirus outbreak, according to government figures, although medical associations say the figure is higher and their hospitals are overrun with COVID-19 patients.

On Friday evening, Turkey's Health Ministry reported 26,410 new coronavirus bringing the country's

total since March to 1.98 million. The figure includes asymptomatic cases, which Ankara did not report in the four months up to late November, prompting criticism that the government was trying to hide the extent of the country's outbreak.

Turkey hit a record daily high of 246 COVID-19-related deaths reported Friday for an overall reported coronavirus death toll of 17,610.



Clooney, who played DC superhero Batman alongside Chris O'Donnell's Robin and Arnold Schwarzenegger's antagonist Mr Freeze in the 1997 movie, opened up about his production regrets during a virtual appearance on Howard Stern's SiriusXM show this week.

"It's so bad that it hurts to watch it... physically," the actor said when asked if he ever revisits the Joel Schumacherdirected Warner Bros movie.

"I couldn't have done that one differently. It's a big machine, that thing. You have to remember at that point, I was just an actor getting an acting job. I wasn't the guy who could greenlight a movie," he added.

Clooney also revealed that he and monster machine, and I just sort of jumped in and did what they said."


The actor said the film's debacle was the team's collective failure and no one person is to be blamed for it.

Getting offers for hero roles now, says Sonu Sood



MUMBAI, DEC 19 (PTI): Bollywood actor Sonu Sood has said filmmakers have started to approach him with lead roles in their films due to his philanthropic work for migrant workers during the coronavirus-induced lockdown.

Earlier this year, Sood, known for films like "Dabangg", "Jodhaa Akbar", and "Simmba", catapulted to the national spotlight for his work in helping migrants reach their homes during the lockdown.

During a virtual session of "We The Women" on Friday, Sood opened up about how 2020 has changed his personal and professional life, especially his image of an actor, who has previously played villain in films such as "Simmba", "R Rajkumar" and "Arundhati".

"I am getting all hero roles now. I have got four-five brilliant scripts. Let's hope... It's new beginnings, new innings, it is a new pitch and it will be nice fun," the actor said.

He recalled that during the shooting of his upcoming Telugu movie "Acharya", South superstar Chiranjeevi

expressed reservations about hitting him for a scene, given his new found image of a hero.

"We were doing an action sequence and Chiranjeevi sir said, You being in the film is a big problem for us because I can't hit you in the action scene'. He said if he does that people

"There was another sequence where he was placing his feet on me but that too was reshot," Sood said.

The 47-year-old actor also revealed that the makers of another Telugu film have changed the script according to his new image, meaning that he will have to shoot his portions

During the lockdown, Sood had launched an initiative to help reunite migrant workers who were stranded in Mumbai with their families in distant corners of the country.

He and his team rolled out a toll-free number and a WhatsApp helpline to connect with the workers and then arrange transportation - buses, trains and even chartered flights as well as food for the stranded migrants.

Khanna, sitting thousands of miles away in New York, launched a food distribution drive Feed India' that steadily reached millions across the country.

"Catering companies were shutting down and so were restaurants, even I was supposed to open two restaurants

"It was all affecting me. I wanted to do something we started in a small way. We put everything on the backburner and focused on this," Khanna said.

had sent the video to the NCB and his complaint was marked to the agency's Mumbai zonal unit, he said.

Sirsa had claimed that he had registered a complaint about this video with the Mumbai police in August last year, but no probe was conducted.

After the video went viral, Iohar had issued a public statement in connection with that video, saving reports of drug consumption at his party were slanderous and malicious.
