RBI Gangtok holds workshop on fake currency notes

GANGTOK, 11 MAR (PIB): RBI, Kolkata with the support of RBI, Gangtok and Bharatiya Reserve Bank Note Mudran Pvt Ltd (BRBN-MPL), Salboni organized a workshop on Identification, Impounding and Disposal of Fake Indian Currency Notes (FICN) at Police Headquarters, Gangtok, East District, Sikkim on 09 Mar, 2021. The programme was conceived and executed by General Manager, Anindita Bhattacharya, RBI, Kolkata and SP, Tenzing Loden Lepcha, CID for enhancing the awareness of State Police personnel and bank officials in detecting FICN through special security features of genuine bank notes vis-à-vis impounding and reporting cases of Fake Indian Currency Notes

(FICN). The workshop was inaugurated by Special DGP, A Sudhakar Rao, Sikkim Police along with Regional Director (RD), Susobhan Sinha, West Bengal and Sikkim. In his opening remarks, Shri Sinha underlined the importance of FICN detection, impounding and emphasised that it is also important that the bank officials should remain alert and vigilant for detection and prompt reporting of FICNs while dealing over the counter. Special DGP, A Sudhakar Rao, Sikkim Police in his address advised all police officials to be aware of various security features of genuine notes, especially the notes of the new series. Coloured Posters displaying the security features of new series notes in both English and Nepali languages were also exhibited by CGM, Ravindra V Sangvai, RBI, Gangtok, which were earlier supplied to Police Department to disseminate awareness. GM, Chetan N Balwir, RBI Gangtok shared his experiences with the audience in dealing with FICN. The workshop was

also addressed by SP, Tenzing Loden Lepcha, CID, Sikkim Police. Mr Lepcha urged the banks to sensitise their staff to not return or destroy fake notes detected at counters and report the same promptly to the Police. This would help in recording the chain of evidence, apprehend criminals within reasonable time and correct identification of the

A team from Issue Department, Kolkata comprising DGM, Onsing Marchang, Manager, Aakash Vats and Assistant Manager. Dharmendra Prasad along with Manager, Sourav Shome, BRBNMPL, Salboni demonstrated the overt and the covert security features of the new series banknotes and easy identification of FICN with the help of hand held Note Authentication Machines, UV lamp and even in plain sight. A practical demonstration on detecting fake notes using Ultra Violet lamp was also done. The procedure to be followed by banks on detection of FICN and the reporting thereof which is of paramount importance was briefed by Manager, Aakash Vats, Issue Department, RBI Kolkata. Manager, Dhiraj Gupta and Satadroo Guha from RBI Gangtok provided the local support for arranging the program. Around thirty-five Po-

lice Officials from Sikkim Police and ten Bank Officials attended the aforesaid workshop. SP, Loden Lepcha, CID and other senior officers of Sikkim Police also attended the program.







Our Inherent Racisms

Because we are also victims of prejudices, let us resolve to be better ourselves

R emember the moment a few years back when the High Court of Delhi asked the Central Bureau of Investigation to ascertain whether "Chinki," the term universally understood as a racist term used against people with Mongoloid features, had been notified as a casteist remark in laws and rules framed for the protection of scheduled tribes.

It is unlikely that the word has been officially registered as a derogatory or racist term even if that is how it is universally used. In fact it is unlikely that there is any updated list of racist or demeaning terms because even though the term Chinki has been derogatorily used for a long time now, babus move even slower it can be safely vouched that Chinki has still not made it into the list of such terms, i.e. if such a list even exists. That said, there is no doubting the fact that this moniker is almost always hurled to hurt and since everyone knows that, it should not matter whether it is officially listed as a slur-word or not and its use should be recognised as a racist attack. It is interesting that this judicial query arrives in April, must be the tomfoolery that we associate with the beginning of this month that silliness like the one which visited us at this time last year now play in a cycle. So, at almost exactly this time two years back, a spokesperson of a majoritarian party claimed that Indians were not racist. As evidence, he had argued that "we" continue to live with South Indians who are also black (like the Africans who suffer a string of attacks and prejudicial arrests in our

After we are done laughing at such artless dodges claiming sensitivity, and wondering in which alternate reality clear everyday evidence of bigotry can be used to claim openness, we need to stare deep into the mirror and confront the monster that gets reflected back.

We need to begin by accepting that we all carry our prejudices around with us. Much of it, we have imbibed subconsciously through stray comments and smart quips which are thrown around in casual conversations. This conditioning, we share with the rest of humanity, because that is essentially how we engage with others - by pigeonholing them, caricaturizing them, even demonizing them. Eventually though, people grow up. They recognize the shallowness of their prejudices as they meet more people, more different people and get exposed to more diversity. Some also grow more confident, and as they grow in confidence, they stop being fearful of others. As for the prejudices we grow up with, most of these are harmless generalizations and misconceptions which even the first flush of education can correct, but when they remain the only introductions one is exposed to, they harden into beliefs and convictions. These convictions become a dangerous liability when the minds which hold them need to negotiate with the others. Africans in India are suffering what the Northeasterners face in the mainland and what the "Indians" experience in the North-East. Most of Delhi had remained an island of North Indianess until a few decades ago when the number of Chinkies arriving in the capital increased substantially. Neither the northeasterners, nor the North Indians were eased into each other's company nor were they really informed in any detail about each other. We all brought along our prejudices though, so we began engaging with each other through these prisms. We remained ignorant and blundered about poorly informed and preferred to find our own communes even if it was possible to become cosmopolitan.

Our collective prejudices, our internalized instincts, often congealed into racist moments which primarily were to our detriment because they kept us ignorant, and often, when it found violent expressions pulled others into its blinkered vortex as well. The degrees and magnitude of this violence might differ from place to place, but they have happened everywhere - in Sikkim, in Nagaland, in Manipur, in Assam, in Maharastra, in Bengaluru, in Delhi, Mumbai... [do you get my point?]

We cannot, not as Indians, not as Northeasterners (whatever that means), not as Biharis, claim that we cannot be racist because we are and have been victims of racism ourselves. We have to instead resolve that because we have suffered prejudice, we need to be better - better informed, better behaved... better humans.

A Deeper Look at Political Conversion in Sikkim

India had probably never seen political conversions of such proportions as we see today. The number of top ranking leaders hopping from one pole to the other in blatant defiance of ideological polarity is staggering. There is nothing wrong with political conversion as politics essentially is a game of converting people to a particular political worldview. The changing of people's minds, therefore, ideally is an indication of a vibrant political interaction. However, that is strangely not always the case. The massive public reaction, some of which are vehement, to the political conversion of some Sikkimese leaders was compelling enough for me to think hard. This article is the conclusion of my thoughts.

Let me begin with a story. Years ago in a small kothey meeting in a village in East Sikkim a supporter put his leader on the spot, "Sir, this was the third time you jumped ship to join a new party. What makes you such a compulsive party hopper? Are you not ashamed to always be seen joining the party that is in government?"

The politician didn't flinch one bit, grinned from ear to ear, looked in the eye of the questioner and said, "Is your memory so short to have forgotten that I had landed you a job of a school peon when I was in my first party. Then your son and daughter-in-law got jobs. When I joined the second party, you were promoted to primary school teacher. Do you really want to stay outside this new ruling party? Don't you have anyone needing a job in your family?"

This is based on a true story and it partially explains the political wonkiness and utter lack of ideological allegiance in a huge chunk of leadership in the state. However, the underlying reasons are far more varied and some of them are

We have inherited a 'political culture of convenience'. Our political superstructure is founded on the substructure of the surrender of our sovereignty. Undoubtedly, for the sake of democracy, the merger was inevitably the most viable option. With China in the north drooling over Sikkim, we couldn't have found a third option to pull through. However, post-merger Sikkim, in general, is more guilty of using its merger history as a source of wrong inspiration than of the merger itself. Post-merger Sikkimese politics is rarely conviction based and the majority of politicians are merely creatures of convenience. Here are my reasons to think so.

One, a deeper look at the track record of many our party hopping leaders will show that their political conversion is always to the party in power. They have never sat outside the ruling party and they seem to lack the spine to stand outside of it. One could write a book on his/her conversion, crafting the most compelling argument in their defense, but their obsessive leaning to the party in power demolishes that argument.

Two, there is an acute dearth of ideological defense of their conversion/party hopping. Has any leader convinced you as to why he parted ways from his former party? Their argument is purely "ad hominem" meaning their defense is ridiculously personal and not ideological. The mischaracterization of their former party leaders and sometimes even assassination of their character is the only form of argumentation in favour of changing party that is often heard. Such ad hominem forms of argument spread personal hatred, resentment and even violence and banishes intellectual engagement to irrelevance. It looks like honing the skills to slander and denigrate one's former leaders and colleagues is the only capability of leadership. Reading, thinking

and articulating is too boring. Why can't they tell their leaders/ colleagues of their shortcomings straight in their face? Isn't it less than courage to change the party and slander? Isn't that disturb-

Three, silent conversion another disturbing reality in Sikkim politics. Imagine a member of a family suddenly going to live with another family and not saying a word. Silence doesn't settle issues. People in responsible positions of public leadership owe an explanation to the people for all their decisions.

Everyone is entitled to his personal choice of political, religious and philosophical worldview. That is our fundamental right. However, our choices should and can never be justified by our resentment of certain individuals or people. Even if that is the case, I have no right to verbalize my personal resentment and hatred in public. Washing dirty linen in public doesn't make me cleaner than the dirty person that I abhor. We watch western movies, listen to western music, play western sports, wear western clothes and sometimes eat western food. How about watching western political debates (except those involving Trump, Bolsonaro and their ilk). There are umpteen flaws in western political debates and they are no better humans than us. However, the civility and dignity that generally mark their political debate and speeches in general needs a closer look and nuanced imitation.

I totally condemn hateful posts and slogans against a few leaders that have changed their political allegiance recently. People have the right to support and oppose their leaders but lowering politics to such a level is detrimental to the founding of a humane and livable human society. Such hatred, if not restrained now, can spill into our homes and lives - if not today, surely tomorrow.

Going Down the 'Rabbit Hole' to Debunk Misinformation

 \boldsymbol{B} ig Ben was stolen from Palestine. So claimed an elderly woman, in Arabic, in a retweeted clip I received recently.

Yes, that Big Ben: the great bell in the iconic clock tower of London's Palace of Westminster. The British took it, she said, from a tower they demolished at Hebron Gate in Jerusalem in 1922

The claim pulled me up short. It seemed so outlandish. Who would invent something so easy to refute? And why? The woman spoke with great conviction, but could she really believe what she was saying? And if this was a hoax, then who was perpetrating it on whom?

These questions sent me down a Big Ben rabbit hole.

A MATTER OF SECONDS

Before I share what I discovered, let's pause here for a moment, where many would have shrugged and moved on.

You'd have to have some prior interest in the Arab-Israeli conflict or the history of British colonialism to give the claim even a moment's thought. And even then, you'd most likely judge it fact or fake, depending on your prior allegiances.

Palestinians and their allies would likely see it as further evidence of colonialist dispossession; their opponents would see a Palestinian lie to garner sympathy and incite resentment. In neither case would viewers have felt any need to investigate further. In this age of information overload, it's a matter of seconds before the next incoming message pings for our attention.

From my perspective, as a cognitive psychologist who researches how people justify their beliefs and assess the credibility of sources, it seems that this is where misinformation causes most damage - less by convincing people of specific untruths than by reducing the motivation to distinguish fact from fiction.

Relentless bombardment by incoming stories on social media makes our attention an increasingly scarce resource. And, as technologies of fabrication proliferate, the chance increases that any given story we encounter is fake. Worse still, research suggests that fake stories travel six times faster and farther on social media than do factual ones.

The net effect is general pollution of the information environment.

Long before the invention of the smartphone and the rise of social media, trust was declining in institutions and those who lead them. New communication technologies are accelerating and intensifying these processes. People are becoming less



place an exaggerated level of trust in sources whose views echo their own.

If these trends continue, reasoned debate with those whose views differ from our own will become rarer and more difficult. There will be a shrinking pool of facts on which those at the ideological extremes will be prepared to agree and a growing sense among the skeptical that debate is pointless because everything is ultimately a matter of opinion.

So, when do facts matter? And how can we distinguish them from fabrications?

DOWN THE BIG BEN RABBIT HOLE

In my case, the clip hit a nerve. I was born in London and emigrated to Israel 25 years ago. I'm familiar enough with London, Jerusalem and Middle Eastern geopolitics to have smelled a rat. So, I had motive to investigate.

But, were it not for recent research, I might not have had the means. In a recent series of pioneering studies, Stanford cognitive psychologist Sam Wineburg and his History Education Group have shown how bad people are at assessing the credibility of what they read online. With the notable exception of professional fact checkers, we're all bad at it: professors no less than schoolkids; digital natives no less than digital immigrants.

Based on what fact checkers did differently, Wineburg's group developed online lessons to teach "lateral reading" - which involves quick comparison across sites and sources rather than close reading of the target source. This enables readers to "determine where information is coming from before they read it."

So, going lateral, I went straight to Wikipedia to look up Big Ben. Contrary to snobbish dismissals by

trusting in general and more likely to some academics, Wikipedia is per- looked like she was in her 70s. To haps the most robust engine of peer review ever created. Although it can be edited by anyone, and entries on controversial topics are occasionally inaccurate, Wikipedia's processes of editorial oversight and control, including insistence on accurate citations to substantiate claims, make it a useful first stop on any fact-checking journey.

> I discovered (well, duh!) that the bell was cast at Whitechapel Bell Foundry in London and installed in the Palace of Westminster, with much pomp and circumstance, in 1858.

Next, I checked the Wikipedia entry on the clock tower at Hebron Gate in Jerusalem and discovered that it was not built until 1908 – a full half-century after Big Ben's installation in London.

Next, I tracked down the Twitter account from which the clip had been forwarded. It belonged to a pro-Israel satirical site, TheMossadIL, which masquerades as the official Twitter feed of Israel's secret service.

But the clip hadn't originated there – it had been reposted by that account as an object of ridicule. I noticed that the clip had a TikTok "watermark" – a stamp that appears automatically at the top and bottom of every downloaded TikTok video, comprising the TikTok logo and video creator's username - which identified the clip's author as @aliarisheq. So, that's where I went next.

The feed, seemingly curated by a young Arabic-speaking woman, contained additional clips featuring the woman in the Big Ben clip and advertisements for jewelry.

Using the View Page Source (Ctrl + U) function in my Chrome browser, I learned that the clip in question was uploaded at 17:12 on Dec. 19, 2019. The woman claiming that "Big Ben" was stolen in 1922

have witnessed the alleged theft, she would have to be a centenarian. So she wasn't a witness: What we had here was an oral tradition, of which she was, at best, a second- or thirdhand bearer.

PROTECTING FROM POLLUTION

All of which means that unless the many corroborating sources cited in Wikipedia's Big Ben entry are an elaborate hoax of QAnon proportions, her claim doesn't have a leg to stand on.

Big Ben was not stolen from Palestine and has no place on lists of controversial cultural artifacts like the Parthenon Marbles that former colonial powers are being asked to return to their countries of origin.

I emerged from this rabbit hole reassured about my ability to ferret out fakery when it matters. But it had taken hours. And I could think of few people to whom the outcome of my investigation would matter.

For me, the moral of the tale is threefold.

First, the idea that a person can, on any given day, sift through every incoming story, sorting fact from fiction, is increasingly implausible. There's just too much of both.

Second, this doesn't mean that the fact-versus-opinion distinction should be retired as a quaint idea from a bygone era. When it matters, there's little we can't eventually fig-

Third, the greatest challenge fake news poses may be an ecological one: namely, how to protect precious natural resources - our time and attention – from its pollution.

Disproving fake news is time-consuming. But ignoring it corrodes trust.

The sub-metropolis last week provided a two-day training to the teachers appointed as gender focal persons.

The focal persons appointed in schools have committed to play an active role in keeping in check the incidents of gender and sexual vio-

"I will actively work to end gender violence in our school and community. We will also be launching an awareness campaign against such forms of violence and harassment," said Srijana Basnet, a teacher who has been appointed as the gender focal person at Madan-Ashrit Basic School in Itahari-13.

Cambodia reports first COVID-19 death, 1 year into pandemic

PHNOM PENH, CAM-BODIA (AP): Cambodia on Thursday confirmed its first death from COVID-19 since the pandemic began more than a year ago as it battles a new local outbreak that has infected hundreds of people.

The 50-year-old man was confirmed infected last month while working as a driver for a Chinese company in coastal Sihanoukville and died at the Khmer-Soviet friendship hospital Thursday morning, the Health Ministry said in a statement.

Cambodia has confirmed only 1,163 cases of infection with the coronavirus since the pandemic began, but it is battling a new local outbreak that has infected several hundred people.

According to the Health Ministry, the new outbreak was traced to a foreign resident who broke quarantine in a hotel and went to a nightclub in early February. That caused a slew of infections and led the government on Feb. 20 to announce a two-week closure of all public schools, cinemas, bars and entertainment areas in Phnom Penh.

The government has since extended the closures for more two weeks for schools, gyms, concert halls, museums and other entertainment venues in Phnom Penh, nearby Kandal province and the coastal province of Sihanoukville.

On Thursday, the Health Ministry said 39 cases were reported from local transmission.

As the outbreak grows, a defunct luxury hotel in the capital has been converted into a 500-room coronavirus hospital, and authorities are enforcing a new law imposing criminal punishments for violating

health rules. The country began its vaccination campaign in February with 600,000 doses of the Chinese-produced Sinopharm vaccine. It also received 324,000 doses of the AstraZeneca vaccine this month that were donated by and produced in India.

Brazil hospitals buckle in absence of national virus plan

RIO DE JANEIRO (AP): Brazil's hospitals are faltering as a highly contagious coronavirus variant tears through the country, the president insists on unproven treatments and the only attempt to create a national plan to contain COVID-19 has just fallen

For the last week, Brazilian governors sought to do something President Jair Bolsonaro obstinately rejects: cobble together a proposal for states to help curb the nation's deadliest COVID-19 outbreak yet. The effort was expected to include a curfew, prohibition of crowded events and limits on the hours non-essential services can operate.

The final product, presented Wednesday, was a one-page document that included general support for restricting activity but without any specific measures. Six governors, evidently still wary of antagonizing Bolsonaro, declined to sign on.

Piaui state's Gov. Wellington Dias told The Associated Press that, unless pressure on hospitals is eased, growing numbers of patients will have to endure the disease without a hospital bed or any hope of treatment in an intensive care

"We have reached the limit across Brazil; rare are the exceptions," Dias, who leads the governors forum, said. "The chance of dying without assistance is real."

Those deaths have already started. In Brazil's wealthiest state, Sao Paulo, at least 30 patients died this month while waiting for ICU beds, according to a tally published Wednesday by the news site G1. In southern Santa Catarina state, 419 people are waiting for



transfer to ICU beds. In neighboring Rio Grande do Sul, ICU capacity is at

Alexandre Zavascki, a doctor in Rio Grande do Sul's capital Porto Alegre, described a constant arrival of hospital patients who struggle to breathe.

"I have a lot of colleagues who, at times, stop to cry. This isn't medicine we're used to performing routinely. This is medicine adapted for a war scenario," said Zavascki, who oversees infectious disease treatment at a private hospital. "We see a good part of the population refusing to see what's happening. resisting the facts. Those people could be next to step inside the hospital and will want beds. But there won't be one."

The country, he added, needs "more rigid measures" from local authorities.

Over the president's objections, the Supreme Court last year upheld cities' and states' jurisdiction to impose restrictions on activity. Even so, Bolsonaro consistently condemned their moves, saying the economy needed to keep churning and that isolation would cause depression. Measures were relaxed toward the end of 2020, as COVID-19 cases and deaths ebbed, municipal election campaigns kicked off and homebound Brazilians grew

fatigued by quarantine. The most recent surge is driven by the P1 variant, which Brazil's health minister said last month is three times as transmissible as the original strain. It first became dominant in the Amazonian city Manaus and in January forced the airlift of hundreds of patients to other states.

Brazil's failure to arrest the virus' spread since then is increasingly seen as a concern not just for Latin American neighbors, but also as a warning to the world, Tedros Adhanom Ghebreyesus, director of the World Health Organization, said in a March 5 press briefing.

"In the whole country, aggressive use of the public health measures, social measures, will be very, very crucial," he said. "Without doing things to impact transmission or suppress the virus, I don't think we will be able in Brazil to have the declining trend."

Last week's tally of more than 10,000 deaths was Brazil's highest since the pandemic began, and this week's toll is on track to be even greater after the country posted nearly 2,300 deaths on Wednesday — blowing away the prior day's total that was also a record.

"Governors, like a lot of the population, are getting fed up with all this inaction," said Margareth Dalcolmo, a prominent pulmonologist at state-run Fiocruz Institute. She added that their proposed pact is vague and will remain symbolic unless it becomes far-reaching and confronts the federal government.

Brazil's national council of state health secretaries last week called for the establishment of a national curfew and lockdown in regions that are approaching maximum hospital capacity. Bolsonaro again demurred.

"I won't decree it." Bolsonaro said Monday at an event. "And you can be sure of one thing: My army will not go to the street to oblige the people to stay home."

Restrictions can already be found just outside the presidential palace after the Federal District's governor, Ibaneis Rocha, implemented a curfew and partial lockdown. Rocha warned Tuesday that he could clamp down harder, sparing only pharmacies and hospitals, if people keep disregarding rules. Currently, 213 people in the district are on the wait list for an ICU bed.

Bolsonaro told reporters Monday that the curfew is "an affront. inadmissible," and said that even the WHO believes lockdowns are inadequate because they disproportionately hurt the poor. While the WHO acknowledges "profound negative effects," it says some countries have had no choice but to impose

slow transmission, and that governments must make the most of the extra time provided to test and trace cases, while caring for patients.

Such nuance was lost on Bolsonaro. His government continues its search for silver-bullet solutions that so far has served only to stoke false hopes. Any idea appears to warrant consideration, except the ones from public health experts.

Bolsonaro's ernment spent millions producing and distributing malaria pills, which have shown no benefit in rigorous studies. Still, Bolsonaro endorsed the drugs. He has also supported treatment with two drugs for fighting parasites, neither of which have shown effectiveness. He again touted their capacity to prevent hospitalizations during a Wednesday event in the presidential palace.

Bolsonaro also dispatched a committee to Israel this week to assess an unproven nasal spray that he has called "a miraculous product." Fiocruz's Dalcolmo, whose younger sister is currently in an ICU, called the trip "really pathetic."

Camila Romano, a researcher at the University of Sao Paulo's Institute of Tropical Medicine, hopes a test her lab developed to identify worrisome variants, including P1, will help monitor and control their spread. She also wants to see stricter government measures, and citizens doing their part.

"Every day is a new surprise, a new variant, a city whose health system enters collapse," Romano said. "We're now in the worst phase. Whether this will be the worst phase of all, unfortunately we don't know what's yet to come."

Still recovering, Japan marks 10th disaster anniversary TOKYO (AP): Japan on communities. He espe-

Thursday marked the 10th anniversary of the earthquake, tsunami and nuclear disaster that hit its northeastern region, where many survivors' lives are still on hold.

Carrying bouquets, many walked to the coast or visited graves to pray for relatives and friends washed away by the tsunami. Emperor Naruhito and Prime Minister Yoshihide Suga were among those observing a moment of silence at 2:46 p.m. — the minute the shaking started — at a memorial in Tokyo.

The magnitude 9.0 quake that struck on March 11, 2011, was one of the biggest on record and set off a massive tsunami that swept far inland, destroying towns and causing meltdowns at the Fukushima Daiichi nuclear plant. More than 18,000 people died, mostly in the tsunami, and nearly half a million people were displaced.

Additionally, government recognized about 3,700 others majority of them from Fukushima — who died of causes linked to the disaster.

Ten years later, more than 40,000 people are still unable to return home in and around Fukushima, where areas near the wrecked plant are still off-limits due to radioactive contamination.

"Reconstruction disaster-hit areas has moved forward significantly, but recovery of the survivors' hearts is not making as much progress as we wish," said Makoto Saito, a teacher at an elementary school in Minamisoma, a town hit by the triple disaster where he lost his 5-year-old son Shota in the tsunami.

Saito, representing Fukushima survivors. said in his speech at the ceremony that he is afraid memories are fading outside the disaster zone and he is committed to keep telling the lessons from the disaster and stories of his son.

Naruhito said "my heart aches" when he thinks of those who have struggled with hardships, drastic changes to their lives, lost their loved ones, jobs and cially noted the suffering of many Fukushima residents who cannot go

"I also consider it im-

portant to heal emotional scars and watch over the mental and physical health of those afflicted, including the elderly and children," he said. He stressed that it's important for people to stand by them and help reconstruct their lives "without leaving even a single soul behind in this difficult situation." Rebuilding roads,

train lines, and other key infrastructure and housing has mostly been completed at the cost of more than 30 trillion yen (\$280 billion), but a lot of empty land remains empty in coastal towns farther north in Miyagi and Iwate prefectures, where existing population losses were accelerated by the disaster.

In Otsuchi town in Iwate prefecture, where the tsunami destroyed the town hall, killing about 40 employees, families in dark suits gathered on a piece of empty land where the building used to stand. In Ishinomaki, Miyagi prefecture, dozens of residents prayed at a cenotaph carrying the names of more than 3,000 victims.

No deaths have been confirmed directly from the radiation, but Fukushima has fallen behind in the recovery efforts, with 2.4% of land classified as no-go zones near the nuclear plant. The decommissioning of the melted reactors is an unprecedented challenge, with some questioning after 10 years of work whether it can be done at all.

Thursday's ceremony is the last national commemoration for the 2011 disaster organized by the government. It comes just two weeks before the Olympic torch run begins from Fukushima for the delayed Tokyo Summer Games in July.

Suga has said the Olympics will showcase Japan's recovery from the disaster and will be proof of human victory over the coronavirus pandemic. Some disaster survivors, however, say their job is still only half done.

Chinese lawmakers endorse tighter control over Hong Kong up to its internation-

BEIJING (AP): China's ceremonial legislature on Thursday endorsed the ruling Communist Party's move to tighten control over Hong Kong by reducing the role of its public in picking the territory's leaders.

The measure adds to a crackdown against a protest movement in Hong Kong calling for greater democracy. The crackdown has prompted accusations Beijing is eroding the autonomy it promised when the former British colony was returned to China in 1997 and is hurting its status as a global financial center.

Beijing's crackdown on Hong Kong has added to irritants in relations with Washington, Europe and other governments that also include trade, technology and the party's treatment of ethnic minorities.

The National People's Congress voted 2,895-0, with one abstention, in support of the plan to give a pro-Beijing committee power to appoint more of Hong Kong's reducing lawmakers, the number elected by the public. NPC members, who are appointed by the party, routinely endorse party plans by unanimous vote or overwhelming majorities.

President Xi Jinping

and other leaders sat on stage in front of delegates as they cast votes electronically in the cavernous Great Hall of the People. The NPC has no real powers but the party uses its annual meeting, the year's highest-profile political event, to showcase government plans and major decisions.

The NPC also endorsed the ruling party's latest five-year development blueprint, which calls for stepping up efforts to transform China into a more self-reliant technology creator. That threatens to worsen strains with Washington and Europe over trade and market access

The NPC focuses on domestic issues but increasingly is overshadowed by geopolitics as Xi's government pursues more assertive trade and strategic policies and feuds with Washington, Australia and others over the coronavirus, conflicting claims to the South China Sea and accusations of spying and

technology theft.

Also Thursday, the country's No. 2 leader, Premier Li Keqiang, said economic growth might be faster than this year's official target of "above 6%" he announced last week, which surprised forecasters who expect an expansion of at least 8%. But he said Beijing is more concerned about firming up its recovery from the coronavirus and keeping growth steady.

China was the only major economy to grow last year while the United States, Europe and Japan struggled with renewed coronavirus outbreaks. Chinese growth accelerated to 6.5% over a year earlier in the final quarter of 2020. "There may be even

faster growth," Li said at a news conference. However, he said, "we must avert wild swings in economic performance."

As an anti-virus measure, the premier sat in the Great Hall and talked by video link with reporters at a media center 6.5 kilometers (4 miles) away. Reporters were required to arrive nine hours in advance to be tested for the coronavirus and wait in hotel rooms for the results.


Under the changes in Hong Kong, a 1,500-member Election Committee will pick the territory's chief executive and an unspecified "relatively large" number of members of its 90-seat legislature.

Committee members would come from five segments of society, including business and political figures. That would give pro-Beijing forces more influence than a popular vote would. Hong Kong news reports said earlier the committee will pick onethird of the members of the Legislative Council, or LegCo.

Beijing wants to see "patriots ruling Hong Kong," the premier said. He said the changes would "safeguard national security" in the territory and support "prosperity and stability."

Britain's foreign secretary, Dominic Raab, said the move is "contrary to the promises made by China itself" about Hong Kong. He said Beijing is trying to "hollow out" space for democratic debate.

"This can only further undermine confidence and trust in China living

Joint custody of son, no spousal support in Adele divorce

LOS ANGELES (AP): Adele will share custody of her 8-year-old son and won't be paying child support to her now-ex-husband Simon Konecki, according to divorce documents obtained Wednesday by The Associated Press.

The couple separated in August of 2019, and Adele filed for divorce the following month. A Los Angeles judge finalized the divorce last week.

According to the documents, the 32-year-old Adele and the 46-year-old Konecki used mediation to amicably reach the terms of the split. Both waived the right to seek spousal support, and both



agreed to joint legal and physical custody of son Angelo, who was born in 2012. The papers say they will seek to resolve any issues without litigation.

Adele kept her original legal name, Adele Adkins, during her marriage.

The British singing superstar married Konecki, co-founder of Life Water, an eco-friendly brand of bottled water, in May of 2018, according to court documents. But she referred to him as "my husband" during a Grammy acceptance speech in 2017, and the two had been a couple for several years when they wed.

China blasts BBC report after summoning UK ambassador



BEIJING (AP): China is complaining anew about rity law and the Chinese recent reporting by the BBC, days after summoning the British ambassador to Beijing to register displeasure over a recent article she penned defending press freedom.

The Chinese Embassy in London posted a statement on its website Thursday saying it had written to the BBC expressing "strong dissatisfaction" and urging the broadcaster to "abandon bias, correct its mistake and report China in a objective, fair and balanced manner."

On Tuesday, China's Foreign Ministry summoned Ambassador Caroline Wilson over her article posted on the embassy's Chinese microblog in which she said critical reporting of China did not imply hatred or disrespect for the country itself. Chinese Foreign Ministry spokesperson Zhao Lijian on Wednesday said Wilson's article reflected her "deep-rooted ideological prejudices."

The criticism reflects deep Chinese anger both over the BBC's reporting on sensitive issues such as the coronavirus outbreak and abuses against Muslim minorities in Xinjiang, and the British governments decision to open a pathway for residency and eventual citizenship for millions of Hong Kong residents.

China last month banned the BBC from the small number of hotels, residential compounds and offices where it had been shown, in apparent retaliation for its reporting on China and Britain's revocation of the license of state-owned Chinese broadcaster CGTN.

Britain has condemned a Chinese crackdown on civil liberties in the former British colony of Hong Kong that has gathered pace with the imposition last year of a sweeping national secuparliament's moves to eliminate even the possibility of government critics running for office in the semi-autonomous

Scores of activists have been rounded up and accused of violating the law, while free speech and assembly have been severely curtailed, seemingly betraying China's commitment to allow Hong Kong to retain its own social, political and legal systems for 50 years following the 1997 handover to Chinese rule.


In its letter, the Chinese Embassy singled out a BBC Radio 4 report titled "The Disinformation Dragon" that aired on Tuesday. The report made "groundless accusations against China on issues related to, among others, information, COVID-19 and diplomacy."

"China has always been a country of propriety and deeply values harmony. We have never been the one that starts provocations and have no intention to intervene in the internal affairs of other countries. It is the others who keep meddling in our domestic affairs and smearing China," the letter said.

In his criticism of Wilson's article, Zhao said China had stated to her its "solemn position on the relevant issue."

"Ambassador son's article, with a confused logic, avoids all the facts, including the British media's disinformation and false reporting on China," Zhao said.

He accused Wilson of ignoring the alleged suppression of Chinese media in the West and of praising "the socalled Western experience in an arrogant tone" and making "irresponsible remarks about China's system and media."
