# Initiative to make govt school students 'future ready'

#### HRDD-Microsoft MOU to equip students with new age tech capacity



**SAGAR CHHETRI** GANGTOK, 31 JAN:

The Human Resource ■ Development Department signed a Memorandum of Understanding with Microsoft India here on Thursday. The main objective of the partnership is to enhance digital literacy and build new age tech capacity among students and faculty at government schools here.

The agreement was signed between HRDD Director [Samagra Shiksha], Bhim Thatal, on behalf of the State government and by Microsoft India Director-Advocacy, Dr Vinnie Jauhari, on behalf of the company in the presence of HRDD Minister, RB Subba, Additional Chief Secretary HRDD, GP Upadhyaya and other senior officials from HRDD and Micro-

Initially, the agreement is for a period of one year and will be extended on mutual understanding between both parties.

As part of the collaboration, Microsoft will support the State in the integration of IT content

in the State board curriculum to build student capacity, whole school reform through the Microsoft Innovative School building Programme, teacher capacity through the Microsoft Educator Network and Innovative **Educator Programme and** enhancing digital literacy and digital citizenship.

On the occasion, the HRDD Minister stated that this initiative would chart an equipped future for the coming generations of the State. He expressed that this initiative was in continuation of the State government's effort to transform the education system.

He added that the agreement was to revamp the education system of Sikkim and to enhance digital literacy in government schools and to empower students and teachers.

### 67,000 new voters in Sikkim for Election 2019



**SUMMIT REPORT** GANGTOK, 31 JAN:

There are around **1** 67,609 new voters entitled to participate in Elections 2019. While there were 3,70,770 electors in Sikkim in 2014, the number of registered voters here as of 31 Jan 2019 is 4,23,325. The 67,000-plus number arrives after one factors in the fact that 15,054 electors have passed away between 2014 and 2019.

On a rough estimate, the number of new female voters is marginally higher this time at 27,350 compared to 25,205 new male voters. Interestingly, there are two voters who have recorded themselves as belonging to the third gender.

It may be mentioned that between 2009 and 2014, there was an increase in voter numbers by a little over 70,000.

The final publication of the Electoral Roll with reference to 1 Feb 2019 as qualifying date was released today by Chief Electoral Officer, Sikkim, R Telang in a press conference organised by the office of the CEO, Sikkim,

at the conference hall of District Administration Centre, East.

Addressing the press conference, R Telang said that the hard copies of the Electoral Roll would be available in a few days and a copy each would be provided free of cost to all recognized political parties, while registered political parties and members of the public can obtain it from office of CEO or District Election Officer on payment of a nominal amount fixed by the Commission.

The 22nd edition of the psychological counselling service, focusing on resolving issues related to exam stress, will end on April 4 and will be available between 8 am to 10 pm on all days, they added.

From this year, the CBSE has introduced the facility of Interactive Voice Response System on a toll-free number from where the students/ parents/stakeholders

can obtain a pre-recorded useful information on tackling board exams which includes tips for better preparation, time and stress management, FAQs along with live telecounselling services.

The CBSE telecounselling is offered by school principals and trained counsellors from within the CBSE affiliated schools located in and outside India, the board said, adding that it is a voluntary, free of cost service provided by the participants.

"I am happy ... to write on your dear land a new page in the relations between religions, confirming that we are brothers although different," he said in a video message to the Emirati people released Thursday.

DHAKUAKHANA(ASSAM), JAN 31 (PTI): The Assam government will set up a memorial park to preserve the rich legacy of the Ahom kings of Assam and cherish their contribution in building the Aster Sarbananda Sonowal announced Thursday. Sonowal made the announcement at the central Me-Dam-Me-Phi celebration, traditionally celebrated by Ahom people on January 31 every year as a mark of respect for their ancestors, at Dhakuakhana in Lakhimpur district on Thursday.

Stressing on the contributions of the Ahom Kings to give distinct identity to the Assamese community, he said the state government was committed to follow their ideals in building a robust and resurgent Assam.

"The Ahom Kings gave a strong foundation to the Assamese community following the ideals of harmony, co-existence and mental strength. Their principles of governance remain the fountainhead of inspiration for the Assamese community," he said. The 600-year-long Ahom rule was among the golden periods in world history and still creates awe among the intelligentsia globally, Sonowal said.

"The first Ahom king Chaolung Siu-Ka-Pha's(1228-1268) towering personality can be gauged from his vision to embrace the prevailing traditions, culture, heritage into the fold of his kingdom. He can be a unique role model for the youth to follow," he said.

Nagaland govt, other organisations oppose citizenship bill

The Nagaland government, along with a host of civil societies, tribal organisations, political parties and NGOs, on Thursday opposed the citizenship bill to "safeguard" the rights of the indigenous people of the north east.

During a consultative meeting convened by the state government here, a five-point resolution was adopted that expressed solidarity with the rest of the north east states, which have flagged concerns about the Citizenship (Amendment) Bill.

"Nagaland stands in solidarity with the rest of the region in order to safeguard the rights of the indigenous people of the region," members present at the meeting said.

Minister Neiphiu Rio and Deputy Chief Minister Y Patton attended the meeting along with members of political parties like the BJP, the NDPP, the NPP, the JD(U) and the NCP.

that no non-indigenous person can claim rights and privileges in Nagaland as "we stand protected under the provisions of Article 371 (A) of the Constitution of India and the Inner Line Permit mechanism".

Any person who acquires Indian citizenship through the amended citizenship bill will be as "ineligible for acquiring property or settling down in Nagaland as other non-Nagas", it said.

The resolution further said that the Nagaland assembly should discuss about enforcing the Inner Line Permit regulations all over the state, including in Dimapur district.

Citizenship The (Amendment) Bill, which was passed by Lok Sabha on January 8, seeks to provide Indian citizenship to Hindus, Jains, Christians, Sikhs, Buddhists and Parsis from Bangladesh, Pakistan and Afghanistan, after six years of residence in India even if they do not possess any documents.

Protests against it have rocked the north east, with those opposing it contending that it would harm the rights of the indigenous people.

On Tuesday, 10 political parties, most of which are members of the BJPled North East Democratic Alliance (NEDA), along with the saffron party's key ally in Bihar, the JD(U), unanimously decided to jointly oppose

#### Committees Require Commitment

Their failure in basic tasks snowballs into across the board deficiencies

One understands that agencies and committees instituted by the government have only so much motivation, leeway or even interest in going after other agencies of the same establishment when it comes to fixing accountability. But something needs to be done if such committees are not delivering even on the basic task of keeping track or maintaining at least a semblance of an over-watch. The Annual Technical Report on Panchayati Raj Institutions and Urban Local Bodies for the year ended 31 March 2016 by the Office of the Accountant General (Audit), Sikkim, tabled in the Legislative Assembly during the two-day session which concluded on Tuesday paints a rather dismal picture of the functioning of various committees constituted for smooth function of PRIs. And this is not the first time that such shortcomings have been flagged. In fact, the lethargy enumerated in the latest report have appeared in past reviews as well, but either no one is reading, or more worryingly, no one cares.

So, the State Government has constituted a string of such committees and appointed/nominated people into them as well, but there is a big slip between the tasked assignments and performance on ground. For instance, anyone who lives in rural Sikkim would be aware of Social Audit-cum-Vigilance Committees which, on paper, are required to ensure that works are executed at Panchayat level as per estimate. They should also monitor the quality of works and are to be comprised of a "wide spectrum" of stakeholders, users and marginalized and vulnerable sections of society including women and senior citizens of the respective Gram Panchayats. The Audit Comment accompanying the report on "position of functioning" of this committee informs that it "simply certified" works executed by the GPs "without exercising any checks". Adequate monitoring was not undertaken, hence quality of work "as envisaged in the estimate" was not ensured. As a result, the "certificate" issued by these committees were a "mere formality" so that payments could be released to the contractors. Then there are the important, but similarly inept Disaster Management Committees which have been found to be "largely ineffective" due to lack of training or involvement as a result of which "victims could not be given immediate relief at the time of need". And really, when has anyone heard of the involvement of DMCs in the wake of any disaster in Sikkim. Sure, the district administration responds and delivers relief, but the disaster management committees surface only occasionally in press releases informing about meetings of drills. Then there is the Block Development Committee which might have a wider jurisdiction territorially than the Social Audit committees but that does not make them any more serious or effective. The Audit Comment for them refers to them as "largely non-functional"; this, due to absence of proper coordination among line departments, DPC and Block Office. And this comes at a cost because in its non-functionality, "identification, scrutiny, implementation of schemes and proper monitoring of schemes for overall development of the GP and Block could not be done".

One would have thought that the State Government's flagship CATCH programme and the State's Total Sanitation status would have provided the required impetus to the Village Health Sanitation Committees to be better performing. But even that has not happened for these VHSCs which the Audit has found "not adequately functional". Since these committees did not bother to carry out household surveys or analyse health issues and health conditions of the villages, sanitation facilities were not created adequately and community toilets were not maintained in hygienic condition. Everyone is aware of the result, now we also know why. There are, apparently, also District Technical Support Committees in Sikkim which are required to support the preparation of District Perspective Plans for each sector by coordinating with the PRIs and technical experts. What the Audit discovered was that estimates prepared by the GPs were not technically vetted by the DTSCs and this resulted in "deficiency in preparation of estimate and also execution of a number of works without preparation of estimates". The litter abandoned and/or over-budget projects across the state stand testimony to this. A frequent complaint received from the villages is of the lack of proper drinking water supply. Water Supply & Sanitation Committees exist for preparation of Village Action Plans deliver "source to mouth" water supply proposals. These committees have remained "largely ineffective" the Audit Comment puts on record but that is being polite since records show that preparation of proposal for submission to district authorities has not even been initiated.

In its recommendations to the State Government, the auditors have suggested that utilisation certificates be submitted in time to avoid delayed or short release of funds; financial management be strengthened to avoid diversion of funds and/ or extra and avoidable expenses; programme execution be strengthened and dedicated and effective monitoring systems be established. All of these can be achieved if only the already existing bouquet of committees were somehow convinced to their basic tasks effectively enough.

### Hope and anguish in a Mexican refugee shelter: Researcher records stories of Central American asylum seekers

This month, a caravan of nearly 1,000 Central ■ American asylum seekers crossed Mexico's southern border with Guatemala. They followed in the footsteps of more than 7,000 asylum seekers who passed through earlier in October.

The Northern Triangle Region of El Salvador, Guatemala and Honduras continues to experience endemic poverty, extremely high homicide rates and widespread gang activity. These dire circumstances drive migration flows to the north.

The United States, until recently, was the northern destination of choice for Central American asylum-seekers. It was a "promised land" where they would find personal security and economic prosperity.

In contrast with those in earlier caravans, these newcomers to Mexico are unlikely to embark on the futile 4,000-kilometre journey north to the United States. Mobility to the U.S. is becoming increasingly more dangerous and the U.S.-Mexico border is more difficult to cross at both official and unofficial ports of entry.

President Andrés Manuel López Obrador directed officials at the Mexico-Guatemala border to distribute humanitarian visas to the newest caravan. The visas will allow the Central Americans to live and work in Mexican territory for one year while they navigate the country's refugee determination process.

Central American asylum-seekers are now stranded in Mexico. The journey north has left them in a state of limbo, keeping them tacked down in a location where they did not intend to stay permanently.

#### MEXICO ATTEMPTS TO FULFIL OBLIGATION TO

Mexico received 28,000 asylum claims in 2018 and 7,000 are backlogged from 2017. Its Law on Refugees is framed by the 1984 Cartagena Declaration on Refugees.

The Cartagena Declaration grants protection for people whose lives are threatened by generalized violence who would not be considered refugees under the 1951 UN Refugee Convention.

In this respect, Mexico is attempting to fulfil its international obligation to refugees. However, its refugee-protection system is massively under-resourced and unprepared to handle so many asylum cases.

#### THE ART OF THE WAIT FOR ASYLUM

Asylum-seekers who hold humanitarian visas often reside in temporary migrant shelters called albergues. Mexico City is home to several albergues that divide guests by age and gender.

Over the past two years, I have conducted research at one of these shelters, Albergue Tochán in southwestern Mexico City. Tochán (nuestra casa, our home in Náhuatl) houses men who have experienced violence in their country of origin or along their journey through Mexican territory.

Tochán responds to the basic needs of the men, including the provision of beds, clothing, meals and toiletries. The tall windowless structure with irregular architecture and steep stairways resembles a clean, warm, welcoming, albeit very cramped home. However, it runs over capacity with far fewer beds than guests.

While at the albergue, the men are free to come

claims would be rejected, resulting in official and permanent eviction from Mexico.

As days become weeks, and weeks turn into months, their notions of time and space need to be continually recalibrated as the wait drags on.

Waiting defines their identity. Some of the men reported no longer knowing who they are anymore or what they are waiting for. They described feeling "useless," "not even human," "impotent," "power-



and go. They use computers equipped with internet, watch television at specified hours and they adhere to a strict schedule of household chores.

I interviewed 15 of these men over many hours while accompanying them in daily activities, and visiting with my undergraduate students.

As a researcher, I can't help the thousands of Central Americans who are stranded in Mexico. But, I can help tell their stories. I believe stories can bring some humanity to a population that has been vilified and rendered nameless by recent political discourse.

#### THEY WANT TO BE REMEMBERED

Refugee determination procedures create many uncertainties and anxieties. Asylum-seekers often find themselves in situations of indefinite and unpredictable waiting.

Research has shown that the long wait for asylum in a host country can cause more stress and mental anguish than the events that happened before the refugee claimants went into exile.

The men at Tochán spoke about their current reality and described their daily activities, frustrations and coping mechanisms. They narrated their hopes and aspirations for the future, and they detailed the abuses they endured in the past.

The men were keen to talk — they want their stories to be documented. Many asked that they be identified in publications so that they could leave a piece of themselves behind in case they did not survive deportation back to Central America.

The men spoke about their sense of exclusion in a new territory. They worried that their asylum less," like a "beggar" and living "half lives."

Anxiety, uncertainty and lack of control over one's life and future are clearly factors inherent to the collective experience of the men at Tochán. FINDING UNITY IN ART

The men have been busy.

Multiple activities guide the men's days. They attend Sunday morning mass and afternoon soccer matches, and they craft and sell wooden artesanías, masks and paintings.

They paint enormous colourful murals that cover virtually every surface of the albergue and throughout the surrounding neighbourhood.

With the assistance of local artists, the director of Albergue Tochán has introduced art as therapy and as a source of income. While hesitant at first, the men have gradually found ways to express and distract themselves through art while they navigate daily, weekly and monthly waiting for the legal validation of their refugee status.

Through art, asylum-seekers have been provided the opportunity to share and learn from each other.

While painting together, they find a level of comfort and unity as they learn to trust and rely on each other.

As their initial dream of reaching the United States deteriorates during the long wait at the albergue, the men learn to embrace a Mexican hope: the possibility of staying in a new location while waiting for an uncertain future.

### How to train 21st century engineers for tech discoveries

he year is 1985. Portable CD playlers like the Sony Discman are the epitome of consumer technology: a battery-operated device that allows you to listen to music anywhere (provided you brought the CDs as well).

A recent graduate from electronics and computer engineering programs understands how the portable CD player works. They cannot build it without the precision tools and materials, but they can certainly design it: they understand how audio is encoded onto a CD's surface, the mechanics of reading those data and the signal processing hardware and software that transform them into sound.

The year is 2019. The smartphone is the epitome of consumer technology. A marvel of complex hardware: integrated circuits that handle wireless communication, graphics processing, a microprocessor more powerful than those found in home computers in 1985. Layers upon layers of software, from a complex operating system to applications powered by virtual machines. A device an engineering graduate does not understand.

#### THE SLOWER PACE OF ENGINEER-ING EDUCATION

Technology has surpassed technological education. There are so many concepts, techniques and tools that an engineering graduate should know, but there isn't enough time. This is not a novel insight, but it is getting worse, and this gap between education and market demand has serious consequences.

Students are less motivated, as they realize the gap between what they are learning and the technology they use will not be bridged over four years of undergraduate education. Employers are frustrated because they want graduates to have mastery over the latest programming language or design methodology. And yet, engineering curricula have

lete programming languages, but the bulk of the knowledge is the same.



We are moving towards connected curricula, where the boundaries between teaching and learning, research, outreach and community engagement are starting to disappear. We believe this



towards market requirements and teach only the latest programming languages or make students memorize the meaning of the latest buzzwords — but that would be a disservice. This would equip our graduates with the skills required for the next five years, but it would also prevent them from growing beyond that. We want to equip students with the knowledge and the skills to be life-long learners, which is the only way to survive in a technological profession.

But how to balance these conflicting requirements: graduate readiness versus strong foundations? The answer is twofold.

First, we need to change how students learn by fostering inclusion of students in research and mentoring towards continuing education. We're doing this: whilst the content of engineering curricula have not changed communities of other disciplines to address common real-world issues from the perspective of their program areas. More programs and initiatives aimed at offering diverse learning experiences are underway.

Second, we must realize that undergraduate degrees alone are not enough to train tomorrow's engineers. We are designing more and more master's programs that will provide advanced training across several sub-fields, from Biomedical Engineering to Embedded Systems. Within these, education paths are less and less linear, allowing students to select more refined specializations. For example, the Department of Systems and Computer Engineering offers several graduate specializations within its master's programs, to develop fine-grained expertise in students' sub-field of choice. The programmes

is the path to train 21st century engineers who will have to develop technology, not in isolation, but within a complex social fabric: think bitcoin or autonomous cars. But we need to deal with the societal aspects that are involved: the economic and personal strain on students who will have to take more advanced degrees, for more years, for longer hours. This will require joint efforts between universities and government.

For the most part, engineering schools are still teaching the same things they were teaching 30 years ago. Now, students are learning them differently, and that makes all the difference. Technology is still surpassing technological education. But we are moving towards better pedagogy.

We'll catch up.

ITANAGAR, JAN (PTI): The Ranganadi Hydro Electric project (RHEP) in Lower Subansiri district of Arunachal Pradesh will stop production of electricity for three months due to repair and maintenance of the project, state Power Minister Tamiya Tago said Thursday.

The RHEP located at Yazali with a installed capacity of 405 mega watt power, will stop production from February 1 to April 30 this year for repair work at the tunnel, which has reportedly developed leakage, Taga told reporters here.

With the shutting down of the project owned by the North East Electrical Power Corporation Ltd (NEEP-CO), Arunachal Pradesh would face power shortage to the tune of 60 MW daily, officials said.

The average peak demand of power in the state per day is 100 mw, excluding five districts Tawang, Anjaw, Upper Siang, Dibang Valley and Shi-Yomi, which are dependent on local generation of power, Power Department Chief Engineer (Western Zone) Gumdo Doji said.

"To overcome the

shortfall of 60 mw power, Chief Minister Pema Khandu and I wrote to the Union Minister of State for Power to allocate additional power from Central sector power generating stations and after much persuasion, the ministry allocated 30 mw of power from Unchahar-I Therma Power Plant of NTPC to the state on round the clock basis for three months." the minister informed.

Taga added that the NEEPCO had also consented to allocate regular 34 mw of power of Meghalaya for 5.30 hours regularly for three months.

"The NEEPCO will provide 10 MW power from Kathalguri gas power station in Assam and 24 MW from Agartala gas thermal combined cycle power project in Tripura which were meant for Meghalaya," the minister disclosed.

"The state power department on Wednesday inked power purchase agreements with NTPC Ltd for 30 MW and NEEP-CO for 34 MW for three months involving an expenditure of Rs 28.27 crore," Taga informed.

"In case of any exigency on real time basis, the department can draw to an extent of 12 per cent of scheduled quantum of power," the Power minister said and appealed to the people to cooperate with the department during the period.

Responding to questions why NEEPCO has decided to shut down the project when board exams are approaching along with general elections, Taga said that due to leakage in the tunnel, NEEPCO had decided to go for the shut down as it is a lean season and repair works would be much easier as the flow of water in the river is less.

Aizawl, Jan 31 (PTI): As part of its initiative to combat substance abuse, the Mizoram government Thursday sent 30 staff members of various de-addiction centres in the state to a well-known rehabilitation centre in Chennai for nine-day intensive training.

The 30 chosen members would receive lessons and guidance in clinical duties and medical and psychological

handling of patients at TTK Hospital in Chennai, an official statement said.

The ruling MNF, as promised in the poll manifesto, was determined to eradicate the problems of drug addiction in the state, it asserted.

A detailed road map has been prepared to build new de-addiction centres, while strengthening the existing ones, reportedly succumbed the statement maintained. "More such steps

would be taken in this direction in this northeastern state, where drug addiction has become a serious problem coupled with the spread of HIV/AIDS," it added. At least 1,504 people, including 171 women, have died due to drug abuse in Mizoram since 1984, according to government records.

### **CPI(M)** says man died of starvation, Tripura govt denies claim

AGARTALA, JAN 31 of Japanda Tripura, a (PTI): The opposition CPI(M) in Tripura Thursday alleged that a tribal man recently died due to starvation in Dhalai district's Purba Gobindabari village, where people have been apparently struggling to make ends meet owing to acute shortage of food, drinking water and jobs.

Deputy Chief Minister Jishnu Debbarman, however, dismissed the allegations and said the claims were "politically motivated".

A six-member delegation of the CPI(M), led by Leader of Opposition and former chief minister Manik Sarkar, on Wednesday visited Purba Gobindabari, a tribal hamlet in Longterai subdivision of the district, after receiving reports of food crisis in the area, a senior party leader said.

Radhacharan Debbarma, the state secretariat member of the CPI(M), said the delegation, of which he was a part along with MLAs Ratan Bhowmik, Mubassar Ali, visited the house

78-year-old tribal man who died on January 18 in Purba Gobindabari village allegedly due to starvation.

"The family consisted of eight members, including Tripura's son, daughter-in-law five children. The family members told us that they were facing acute shortage of food and drinking water for the past three months and no jobs were available under government schemes. "Japanda Tripura ate

nothing for four days and died of starvation," he told reporters.

Debbarma, who is also the chief executive member of Tripura Tribal Areas Autonomous District Council (TTAADC), said the family apparently received NREGA payment of Rs 1,500 on December 10, but after that there was no work for any of the members.

"Of Rs 1500, the family had to clear their debts and buy rice and dal. As there was no job available, Japanda had to die for want of food,"

The tribals in the district subsist on forest produce, harvest of Jhum cultivation and jobs under different government schemes, the senior CPI(M) leader said. The villagers collect 'Arjun flowers' from the forest and sell it in the market to make a living, but its rate recently dropped from Rs 25 to Rs 8, he said. Arjun flowers are primarily used to make broomsticks.

"Three months beginning from December is a lean period and people living in the hilly areas face acute drinking water crisis. Last year, the Left Front government had distributed water in tankers. But this year, no such arrangements were made. So people were drinking contaminated water from rivulets," Debbarma claimed.

The chief of the tribal council also said that many remote tribal hamlets, he visited recently, are struggling to put up with a similar crisis. "We have decided to meet Chief Minis-

ter Biplab Kumar Deb soon and apprise him of the situation. We will request him to take measures on war footing to save the people," he added.

In June last year, Jitendra Chowdhury, a parliamentarian and a tribal leader of the CPI(M), had alleged that tribals from Dhalai district were migrating to Bangladesh for collecting forest produce in the wake of food crisis.

A delegation, led by him, submitted a memorandum to the chief minister, seeking appropriate measures.

Deputy Chief Minister Jishnu Debbarman, when asked about the allegations, said it was far from truth.

"Man days under MGNREGA have been increased to support poor tribal families. The allegations made were far from truth and politically motivated," he said.


Talking about the migration claims, he said the government had checked the matter with appropriate agencies and found it to be "incorrect".

#### Sole survivors: Qatar plot Japan ambush in Asian final

Abu Dhabi, Jan 31 (AFP): While Japan have the Asian Cup pedigree, Qatar's over-achieving players might just feel that their name is on the trophy after a record-breaking run to their first-ever final. Against the backdrop of simmering political tension, the Qatari players were pelted with plastic bottles -- and even shoes -- by furious local fans in a 4-0 semi-final thrashing of the United Arab Emirates in Abu Dhabi.

After surviving that ordeal, the 2022 World Cup hosts believe they have nothing to fear from Japan. "We have already realised a dream that the whole country had," said striker Almoez Ali, who equalled Ali Daei's record of eight goals in a single Asian Cup against the hosts on Tuesday.

"We will need patience in the final but if we are patient, we have a chance of being champions." Japan, who captured the last of their record four Asian titles in 2011, upset tournament favourites Iran 3-0 in Monday's first semi-final and appear to be peaking at just the right time.

After threatening to bore crowds to death in their first five games, the Blue Samurai go into Friday's final in the UAE capital unbeaten in 11 matches since Hajime Moriyasu took over as coach after last year's World Cup. Yuya Osako's controversial second-half double floored Iran, and consequently Moriyasu's new-look Japan are suddenly being tipped to go all the way.

"We talked about going to war before we came out here," said captain Maya Yoshida, part of the Japan side which scooped the title eight years ago. "We're all fighting hard together for it."

"We put Leicester under pressure but we were unlucky with the goal in the last second before half-time. You have to take it how it is," Klopp said.

#### Boult's fifer hands NZ consolation win over India in 4th ODI

HAMILTON, JAN 31 (PTI): (2/25), the hosts com-India seemed shorn of their aura in the absence of talismanic skipper Virat Kohli as New Zealand pulled off a stunning eight-wicket win in the fourth cricket one-dayer to halt the visiting side's domination here Thursday.

With run-machine Kohli rested after the side claimed an unbeatable 3-0 lead in the fivematch series, India's much-vaunted batting was dismissed for its seventh lowest ODI total --92 in 30.5 overs here -after Trent Boult (5/21) dished out a deadly opening spell.

It was also the lowest total posted by any side on this venue, the previous lowest of 122 against India's also name.

With the series already out of their grasp after India won the first three games, Boult wreaked havoc with the new ball and in Colin de Grandhomme's (3/26) company utilised the swinging conditions at the Seddon Park.

"Never expected this to happen. (But) games like this happen...We've got ourselves to blame for this," said India's stand-in captain Rohit Sharma. In the absence of Kohli and an injured Mahendra Singh Dhoni, the Indian batting unit found the going tough against the Kiwi bowling attack.

India's lowest ODI total is 54 against Sri Lanka at Sharjah in 2000. It was also India's second lowest total in ODIs against New Zealand, having somehow managed to surpass the 88 scored at Dambulla.

Bowling his 10 overs at a stretch, Boult trouwith both ways movement to return with impressive figures of 5 for 21, while Grandhomme gave him perfect support from the other end after New Zealand won the toss and elected to bowl.

While chasing, even though New Zealand lost Martin Guptill (14) and skipper Kane Williamson (11) early to Bhuvneshwar Kumar

pleted the formalities in 14.4 overs with eight wickets in hand.

Grandhomme then joined the party and dismissed both Ambati Rayudu and Dinesh Karthik for ducks in a span of four balls in the 11th over.

A lot was expected from debutant Shubman Gill (9) but pressure got the better of him as he got out like Rohit, caught by Boult off his own bowling.

Reeling at 33 for 5, India desperately needed the experience of Kohli or Dhoni to bail the team out but in the duo's absence, the onus was on Pandya and Kedar Jadhav to do the repair job.

But it was not to be bled the Indian batsmen as wickets kept tumbling with Boult ripping apart India's line-up, dismissing both Jadhav and Pandya in quick succession.

### Language is my friend, fiction my first love: Arundhati Roy

New Delhi, Jan 31 (PTI): She writes poetic prose, employs redolent metaphors and evokes utmost admiration for her novelistic virtues. Arundhati Roy is anything but a boring author. The 1997 Booker Prize-winner, who is equally at ease writing scathing essays, says she is a "disciplined writer" whose heart lies in fiction as it is a "connective tissue" between many things which are sometimes looked at or studied in isolation.

"Much of my non-fiction writing is an argument, but fiction is where you create a universe through which you invite a reader to walk. It is much more complex. For me, it is the most satisfying thing. When I write fiction, I feel like I am using all my skills, it delights me the most," Roy told

PTI in an interview.

"It is only fiction that transcends what is increasingly being divided into subjects. Fiction is the connective tissue between so many things which are sometimes looked at or studied in isolation. It allows you not to isolate things," she said. Best known for her debut novel 'The God of Small Things' which won the 1997 Man Booker Prize and catapulted her into fame, Roy came out with her second work of fiction 'The Ministry of Utmost Happiness' in 2017 after a hiatus of twenty years.

The second novel which was longlisted for the 2017 Man Booker Prize has been received well and is already translated into nearly 50 languages, including Hindi and

Urdu. The Hindi and Urdu translations of Roy's second novel have been done by Rajkamal Prakashan Samuh. They will be launched on February 2. Manglesh Dabral has done the Hindi translation "Aapar Khusi ka Gharana" and Arjumand Ara's Urdu translation is titled "Bepanah Shadmani Ki Mumlikat". "The response was far be-

yond my expectation. For me, it has been years of experimenting with a form of novel, and which I knew was complex and cannot be consumed in one read," Roy said.

Noting that her experiment with a new form was "intentional", the 57-year-old author said she attempted to write something which would satisfy her "own complicated mind".

people were disappointed, but writing is not about satisfying everybody. It is your own inquiry that you have to follow," she said. "This was an attempt to deal with something more complex. 'The God of Small Things' is about a family and people understand those coordinates, whereas 'The Ministry of Utmost Happiness' starts out with a shattered heart, it starts out with people who are strange to normal people... It is a more complex book and needs many many readings," she said. Roy, who is quite often extolled for her lyrical description, credits renowned writ-"I have never been someers like William Shakespeare and body who wants to deliver

Rudyard Kipling for it, saying it is her early readings of their work which "makes one hear my language rather than just see it".

"Language is my friend. Every time I am able to write to close the gap between language and thought, the blood flows easier in my veins. That is why I think I am always writing," she said.

A major part of Roy's second novel is set in Kashmir. She has written about its longstanding conflict in her essays, but feels only fiction can do justice to its story.

"Right from the first time I started going to Kashmir, I realised that only fiction can deal with it. The fiction writer in me started going round and round. You can't tell it (story) through human rights reports or journalistic accounts," she said.

# Muse: Myanmar's militia-run, billion-dollar gateway to China



MUSE (MYANMAR), JAN **31 (AFP)**: With tinted windows and their militia name emblazoned on the side of their Ford truck, "Pan Say" fighters cruise the sleazy streets of Muse, Myanmar's main gateway to China and awash with weapons and cash from casinos, drugs and sex.

Ten armed groups run the Shan State border town of Muse, which is separated by a shallow river from the gleaming towers of its Chinese counterpart, Ruili.

All are under the tutelage of the same patron: Myanmar's army.

China and Myanmar have an agreement not to station troops along their border.

Instead, Myanmar's army uses the militias as proxies in a long-running conflict between the central state and ethnic rebel groups who operate in the area, including the Kachin Independence Army (KIA) and Taaung National Liberation Army (TNLA).

The Pan Say militia gave AFP a rare snapshot of the shifting alliances and rivalries which have defined Myanmar's frontier areas since its independence in 1948.

They have joined one of Muse's largest militias, which boasts several hundred men, armed with M-16 rifles and Kalashnikovs.

Pan Say insists it is funded by its own jade mines, cigarette factories and karaoke bars, denying knowledge of narcotics or other illegal activities that prosper along the border.

Like other Muse militias, Pan Say accepted a deal in 2009 to come under the military's control in exchange for a degree

The fighters cast themselves as unconventional but necessary keepers of the peace, accusing the rebel groups they fight against of extortion and racketeering.

Experts are less generous in their definition.

The "wasps' nest of militias" are as much behind the town's illicit economy as the rebels, says independent analyst David Mathieson.

"They drive around toting machine guns, running casinos, peddling yaba (low-grade methamphetamine), all as subcontractors of local security for the Myanmar military."

Either way the money keeps flowing.

Legal trade through the town -- rice, fish and electrical goods -- totalled USD 1 billion between October and December, half of the entire country's land border trade, according to official figures.

But the riches made

of meth, opium, illegal animal parts and jade --

as well as women being

sold into marriage in Chi-

na -- are likely to dwarf

those figures. Myanmar is now one of the world's largest sources of meth, with chemicals precursor from China feeding labs peppering the restive eastern borderlands, according to the UN's drug

Inside the town, barbed wire-clad walls and stern, gun-wielding guards protect a plethora of casinos, which are suspected of laundering money from both sides of the border.

Hotel rooms offer piles of condoms, while drug dealers buzz around the low-budget brothels, which give the town its reputation for sleaze, serving a transient population of border merchants and from the vast quantities long-distance drivers.

And prospects are looking even better for Muse's nefarious trades.

Routes between Muse and Myanmar's west coast are set to improve as investment pours in under China's so-called "Belt and Road" strategy of boosting the infrastructure of key trade partners.

transport Better routes could well give a boost to the town's "illicit profiteering" -- at least in the short-term -- a recent report by International Crisis Group (ICG) pre-

While money flows through Muse, little trickles down to its people.

Instead they run a daily gauntlet between the militias, rebels, drug addicts and petty criminals.

"We're scared to go out at night," says builder and father of two Kyaw Zin Latt, 23, who recently moved from the country's south for work.

An NGO provides one of the town's few life-line public services -- a fleet of ambulances.

They retrieved casualties from an attack on a bridge near the border last May, in which 19 people were killed, including 15 civilians.

The offensive by ethnic rebel group the TNLA descended into an eighthour stand-off with the Pan Say militia.

"A police officer was shot dead beside this building," says the NGO founder Thaung Tun, as he drives cautiously over the bridge.

It is now defended by the army, two different militia groups and the police. But outnumbered and outgunned, the cops languish far down Muse's pyramid of power.

"There are places that are too dangerous for us to go by ourselves," one police officer laments.

#### Kabul control slips in Afghanistan amid US talks with Taliban



WASHINGTON, JAN 31 (AFP): The Kabul government is steadily losing its grip over parts of Afghanistan even as American forces intensify their air campaign against insurgent groups, a US government watchdog said Thursday.

The latest grim assessment of Afghanistan's security situation comes as the US pursues talks with the Taliban and urgently seeks a way out of the 17-year war.

Numbers provided by Resolute Support, the US-led NATO mission in Afghanistan, show that as of October 31, only 63.5 per cent of Afghans are living in areas controlled or influenced by the Kabul government -down from 65.2 per cent the previous quarter.

According to the US Special Inspector General for Afghanistan Reconstruction (SIGAR), which compiled the data, the decrease came as Kabul's control or influence over Afghan districts dropped.

SIGAR said just 53.8 per cent of Afghanistan's 407 districts are in government hands, and experts on Afghanistan say the number is lower still.

Instead of looking at population metrics, the Pentagon in a response to SIGAR said it is more important to "focus on the principal goal of the strategy of concluding the war in Afghanistan on terms favourable to Afghanistan and the United States."

Officials pointed to ongoing talks between the Taliban and US special envoy Zalmay Khalilzad, who this week said he had sealed the outlines of a peace deal.

Highlighting the ongoing security crisis, SI-GAR said the US has dramatically increased air strikes, dropping 6,823 bombs in the first 11 months of 2018.

The "figure was already 56 per cent higher than the total number of munitions released in 2017 (4,361), and is more than five times the total in 2016," SIGAR said in its report.

Meanwhile. strength of Afghan security forces has continued to dwindle, and currently stands at 308,693 personnel. That means only 87.7 per cent of positions are filled, the lowest level since January 2015.

Afghan forces have suffered staggering losses since they assumed responsibility for their country's security four years ago. President

Ashraf Ghani last week said 45,000 security forces have been killed since he took office in September 2014. NATO combat forces

pulled out at the end of that year, and observers say the losses may not be sustainable. Officials say Presi-

dent Donald Trump has decided to pull half of fer any number of com-America's forces from Afghanistan.

The Pentagon insisted the numbers in SIGAR's report do not necessarily reflect poorly on his strategy to find an end to the conflict.

"Measures of population control are not indicative of effectiveness of the South Asia strategy or of progress toward security and stability in Afghanistan," the Pentagon said, according to SIGAR. Khalilzad has provid-

ed few specifics about a potential deal with the Taliban, but the militants are believed to have promised not to provide shelter again to foreign extremists. However. the Taliban have so far refused another key US demand -- that they talk to the internationally recognized government in Kabul, which the insurgents view as American "puppets." Ghani has warned against rushing into a deal, citing violence following the Soviet withdrawal in 1989. Acting Defence Sec-

retary Patrick Shanahan said Tuesday that he saw "some very encouraging possibilities" in Khalilzad's negotiations.

"But we need to give them time and space," Shanahan said.

Ryan Crocker, a former US ambassador to multiple nations including Afghanistan, said in an opinion piece in The Washington Post that US negotiations with the Taliban are akin to "surrender."

"The Taliban will ofmitments, knowing that when we are gone and the Taliban is back, we will have no means of enforcing any of them," Crocker wrote.

### Indian arrested in US on charges of fraud

(PTI): An Indian has been arrested in the US on charges of fraud for stealing at least USD 800,000 from more than 400 victims, mostly of Indian descent, through a provisional "credit" scheme.

Kishore Babu Ammisetti. 30. who has been charged by federal criminal complaint with fraud offenses stemming from an alleged provisional credit scheme, was arrested on January 25.

Ammisetti, appeared before US Magistrate Judge Donna Martinez in Hartford, Connecticut on Wednesday. He was ordered detained. Federal prosecutors said that Ammisetti entered the US in 2013 on a student visa, which was revoked in 2014.

Ammisetti used Facebook Marketplace and other media to victimise individuals, primarily of Indian decent, who advertised items for sale or rooms for rent.

Through this scheme, Ammisetti would contact a victim to express interest in purchasing an item or renting a room. He would then gather the victim's bank account in-

**WASHINGTON, JAN 31** formation and other personal information under the guise of making a deposit to the victim's bank account. He also would offer to provide a "deposit" directly into the victim's account via a Peerto-Peer (P2P) transfer.

Ammisetti would then contact the victim's bank and, posing as the victim, would claim to have made an ATM deposit that did not register on the victim's bank account, complaint alleges. While researching

"unregistered deposit", the bank would credit the victim's account with a provisional credit, it said. Ammisetti would then contact the victim and claim that the provisional credit to the victim's bank account was a mistaken transfer by Ammisetti to the victim's account. He would then request either a full or partial refund of that money, which the victim would provide via a P2P transfer. After the bank determined that there was no unregistered deposit to the victim's account, the funds provided as a provisional credit would be removed from the account, federal prosecutors said.

#### New H-1B visa filing rule to give priority to workers with advanced degrees from US

WASHINGTON, JAN 31 (PTI): The US has announced a new H-1B visa filing rule from April under which priority would be given to foreign workers with advanced degrees from American universities, a decision that could impact professionals who received higher education in countries like India and China.

The H-1B visa, popular among Indian IT professionals, is a non-immigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise.

The final rule reverses the order by which the US Citizenship and Immigration Services (USCIS) selects H-1B petitions under the regular cap and the advanced degree exemption.

Among other things, it introduces an electronic registration requirement for petitioners seeking to file H-1B cap-subject petitions.

To be published in the Federal Register on Thursday, the new rule will go into effect on April 1, though the electronic registration requirement will be suspended for the fiscal year (FY) 2020 cap season, the USCIS said.

"These simple and smart changes are a positive benefit for employers, the foreign workers they seek to employ, and the agency's adjudicators, helping the H-1B visa programme work better," said USCIS Director Francis Cissna.

Early this month, President Donald Trump said that he wants to bring in changes in the H-1B visa systems so that holders of these visas can stay in the country and accelerate their path to citizenship. The new registration system, once implemented, will lower overall costs for employers and increase government efficiency, he said.

Cissna said the US-CIS is also furthering Trump's goal of improving the immigration system by making a simple adjustment to the H-1B cap selection process.

As a result, US employers seeking to employ foreign workers with a US master's or higher degree will have a greater chance of selection in the H-1B lottery in years of excess demand for new H-1B visas, Cissna said Effective from April 1, the USCIS will first select H-1B petitions (or registrations, once the registration requirement is implemented) submitted on behalf of all beneficiaries, including those that may be eligible for the advanced degree exemption. Thereafter the US-CIS will select from the remaining eligible petitions, a number projected to reach the advanced degree exemption.

Changing the order in which the USCIS counts these allocations will likely increase the number of petitions for beneficiaries with a master's or higher degree from a US institution of higher education to be selected under the H-1B numerical allocations, a media statement said.

Specifically, the change will result in an estimated increase of up to 16 per cent (or 5,340 workers) in the number of selected petitions for H-1B beneficiaries with a master's degree or higher from a US institution of higher education.

The USCIS will begin accepting H-1B cap petitions for fiscal 2020 on April 1, 2019. The reverse selection order will apply to petitions filed for the FY 2020 H-1B cap season.


