Kerala journalists slam 'stories' in **UP chargesheet against colleague**

Kerala journalist Siddique Kappan was jailed last year when he was on his way to report the Hathras gang-rape case that triggered nationwide shock.

articles Thirty-six written by Mr Kappan accused of having links to the Popular Front of India (PFI), an outfit the Yogi Adityanath government wants banned - have been cited in the chargesheet.

"Kerala Union of Working Journalists is shocked to learn that the Uttar Pradesh Police has included the reports and interviews done by Siddique Kappan as a journalist in the chargesheet filed against him. The action of the UP Police is nothing but treating journalism as a crime. This goes against the very spirit of freedom of expression guaranteed under the Constitution," the journalists' union said in a statement today.

The chargesheet - filed in April by the UP Police's Special Task Force and presented before a Mathura court - has still not been made available to Mr Kappan or his legal representatives, his lawyers

petitioned the trial court,

One of the articles is ten by a journalist from on the protests against the controversial citizenship law that started in December 2019 across the country and continued till the pandemic began. "The article talks about the firing by a Hindu man Kapil Gurjar during the Shaheen Bagh protests and compares this incident to the assassination of Mahatma Gandhi. The article also criticises the way the Delhi Police handled the protests, the chargesheet reads.

The chargesheet also cites another article on the controversy over the alleged role of the Nizamuddin Markaz in spreading the pandemic, saying "it has been presented as a ploy by the central government to defame the Muslim community."

In the statement, the Kerala Union of Working Journalists (KUWJ) requested the Supreme Court to intervene and "quash the shameful act of the UP Police."

"The KUWJ is also anguished to learn that the copy of the chargesheet has not been given to Siddique Kappan even though we are on the brink of completing one year of his arrest and subsequent incarceration in jail... The KUWJ would reiterate its support for Mr Kappan and his struggle against the false charges made by the UP Police," the journalists' union said.

Sikkim's Covid toll increases by one after 4 days

SUMMIT REPORT GANGTOK, 02 OCT:

With Saturday morning arrived news that Sikkim's unbroken 4-day run of no Covid deaths, the longest in the second wave, had ended in the past 24 hours with the virus claiming one more life and taking Sikkim's Covid death toll to 388.

As per the Daily Report of COVID-19 in Sikkim issued by the Integrated Disease Surveillance Programme of the Health Department, this fatality was reported from STNM Hospital here.

Meanwhile, State's daily test positivity rate dipped under 6% over the same period when 25 new cases were picked up from the screening of 426 samples giving Sikkim a daily TPR of 5.8%. The tally of confirmed cases of CO-VID-19 reported in the State since testing began on 28 Feb, 2020, has

reached 31.507.

17 of the new cases were detected in RT-PCR testing of 192 samples and eight in rapid antigen testing of 230 samples. 15 cases were registered in East District. 03 in West District, 06 in South District and 01 in North District.

On the other hand, 40 formerly Covid-positive people were discharged

from home and facility isolation after making full recoveries taking the number of fully recovered cases to 30,201.

At present, there are 602 active cases of Covid-19 in Sikkim, most of whom are recovering under home or facility isolation. Of those in hospital, nine COVID patients are currently admitted ICU facilities at STNM hospital and CRH-Tadong.

On the vaccination front, a total of 6,239 doses were administered in the State on Friday. While 339 people received their first dose, 5.900 others completed their vaccine schedule with the second dose.

Ban on packaged mineral water in Sikkim from Jan 1

GANGTOK, OCT 2 (PTI): Sikkim Chief Minister PS Tamang on Saturday announced that packaged mineral water will be banned from January 1, 2022 in the Himalayan state, which is "blessed with natural resources that provide fresh and good

quality drinking water". Tamang, during his address here on the occasion of Gandhi Jayanti, also said that people, after the ban is implemented, will opt for water from natural resources, which is far healthier than that available in plastic bottles.

"Everyone in Sikkim

would now have to do away with mineral water bottles and opt for natural water resources," he stated. The CM further noted that a three-month buf-

fer time is being given to deplete the existing stock of mineral water bottles available with business establishments.

Tamang, who was accompanied by Governor Ganga Prasad during a cleanliness drive on the occasion, said that the state government is taking steps to stop supply of packaged drinking water from outside.

Notably, tourist hotspots like Lachen in North Sikkim have already banned packaged water bottles.

"Sikkim is rich in natural water resources and all requirements for water can be met within the state through environment-friendly initiatives," the CM added.

India records 24,354 Covid cases, 8.8% lower than yesterday

the last 24 hours, a slight decrease of 8.8 per cent from yesterday, taking the overall caseload to 3,37,91,061. At least 234 deaths due to coronavirus were also reported in last 24 hours.

India's active caseload stands at 2,73,889, lowest in 197 days, which accounts for less than 0.81 per cent of total cases -- lowest since March 2020.

The national COVID-19 recovery rate was recorded at 97.86 per cent, highest since March 2020. At least 25,455 recoveries in the last 24 hours took the total number of recoveries to 3,30,68,599.

The daily positivity rate - number of positive cases identified per 100 - stands at 1.70 per cent, less than 3 per cent for last 33 days. The weekly positivity rate stands at 1.68 per cent.

New Delhi, Oct 2 (PTI): Petrol and diesel prices soared to new record highs across the country on Saturday after rates were hiked again by 25 paise and 30 paise a litre, re-

The price of petrol in Delhi rose to its highest ever level of Rs 102.14 a litre and to Rs 108.19 in Mumbai, according to a price notification of stateowned fuel retailers.

Diesel rates too touched a record high of Rs 90.47 in Delhi and Rs 98.16 a litre in Mumbai.

Prices differ from state to state depending on the incidence of local taxes.

State-owned Indian Oil Corp (IOC), Bharat Petroleum Corp Ltd (BPCL) and Hindustan Petroleum Corp Ltd (HPCL) resumed daily price revisions on September 24 after international oil prices neared a three-year high. Global benchmark Brent crude is trading above USD 78 per bar-

In seven price increases since September 24, diesel rates have gone up by 1.85 paise per litre. Petrol price has increased by Re 1 per litre in four instalments this week.

When international oil rates fell in July and August, retail prices of petrol and diesel in the Delhi market were reduced by Rs 0.65 and Rs 1.25 per litre.

Prior to that, the petrol price was increased by Rs 11.44 a litre between May 4 and July 17. Diesel rate had gone up by Rs 9.14 during this period.

India is dependent on imports to meet nearly 85 per cent of its oil needs and so benchmarks local fuel rates to international oil prices.

Water cannons used as farmers protest at Haryana Chief Minister's house

CHANDIGARH, 02 OCT [NDTV]: Over a thousand farmers - shouting slogans and waving flags in protest against the controversial farm laws - gathered outside Haryana Chief Minister ML Khattar's Karnal residence on Saturday morning and announced their intention to mount an overnight vigil. Visuals from the area show the farmers standing on top of a pile of yellow police barricades and shouting angrily, while a handful of security forces in riot gear look on.

The farmers were briefly doused with water cannons by police with whom anti-farm law protesters have clashed several times this week alone - and who have been deployed in large numbers, with tear gas vehicles, at the spot.

Visuals of water cannons being used show a powerful jet of water fired at protestors, some of whom try to get up on their vehicles to escape.

Farmers are also pro-

testing in grain markets in parts of the state, and outside the residences of MLAs from the ruling BJP-Jannayak Janata Party alliance in several districts.

Yesterday farmer leader Rakesh Tikait warned of protests, including at the headquarters of the district collectorate in Punjab, to press the centre to start paddy procurement on time.

This was after the centre postponed buying kharif, or monsoon, paddy from Punjab and Haryana till October 11. It said crop maturity had been delayed due to recent rains. Also yesterday, farmers and police in the state clashed yet again as protesters marched against an event attended by Deputy Chief Minister Dushyant Chautala in Jhajjar.

Water cannons were fired to stop them, but dramatic visuals showed scores of men and women fighting back as they braved the streams of water and pushed through barricades.

Godse's photograph garlanded at Hindu Mahasabha event

GWALIOR, OCT 2 (PTI): Photographs of Mahatma Gandhi's assassins Nathuram Godse and Narayan Apte were garlanded at a seminar organized by the local unit of the Hindu Mahasabha here on Saturday.

Speaking to reporters after the event held on Gandhi's 152nd birth anniversary, a leader of the right-wing organization also blamed him for Partition.

We have nothing to do with Gandhi, but Gandhi and Mohammad Ali Jinnah were responsible for the partition of the country, Hindu Mahasabha national vice president Jaiveer Bharadwaj said.

Partition led to the biggest genocide and more than 10 lakh Hindus were killed and another 50 lakh displaced. That is why Nathuram Godse and Naravan Apte had resolved to kill Gandhi and Jinnah," he said.

While they assassinated Gandhi, they could reach Jinnah, the founder of Pakistan, he said.

The seminar on "Gandhi, and Hutatma (martyrs) Godse and Apte" was held at the Mahasabha's office in Daulat-

ganj area here. Photographs of Godse and Apte were garlanded and some workers shouted "Pandit Nathuram Godse and Narayan Apte Amar Rahe (Long live Pandit Nathuram Godse and Narayan Apte)."

In January this year, the Mahasabha opened a study centre on Godse at its office here but closed it two days later following intervention by the district administration. In 2017, the Mahasabha had installed Godse's bust at the office which was seized by the district administration.

Over 350 crimes against kids in India daily In 2020: Child Rights Body

NEW DELHI, 02 OCT [PTI]: A total of 1,28,531 crimes against children were recorded in India last year, implying that an average of 350 such cases were reported each day during the pandemic, according to an NGO's analysis of the NCRB data.

However, when compared with figures from the National Crime Records Bureau (NCRB) in 2019, there has been a drop of 13.3 per cent in the total number of such cases, Child Rights and You (CRY) said in its analysis.

There were 1,48,185 cases of crime against children recorded in 2019 which meant that each day over 400 such crimes are committed in the country.

"Though there is a drop in total number of crimes against children, child marriage has increased 50 per cent and online abuse has increased 400 per cent in one year," the child rights organisation said.

Further analysis of the decadal trend suggests that crimes against children in India have increased steeply by 381 per cent in the last one decade (2010-2020) and over the same time, the number of overall crimes decreased by 2.2 per cent in the country. "A state-wise analy-

sis shows that Madhya Pradesh (13.2 per cent), Uttar Pradesh (11.8 per cent), Maharashtra (11.1 per cent), West Bengal (7.9 per cent) and Bihar (5.1 per cent) account for nearly half of total crimes against children (49.3 per cent) in India,"

the organisation said.

Compared to NCRB data 2019, in the list of top five states, West Bengal has replaced Delhi while seeing a sharp increase in cases by more than 63 per cent.

Priti Mahara, Director, Policy Research and Advocacy, CRY, "Experiences during humanitarian crises have revealed that issues of child protection tend to get exacerbated. School closures during Covid, mobility restrictions to contain the spread of the pandemic coupled with the economic slowdown disproportionately impacted livelihoods and household economic and food security of marginalised families.

"Therefore, it was highly likely that it contributed to increasing children's vulnerabilities to child labour, child marriage, child trafficking as well as cases of genderbased violence," she said.

According to CRY's analysis of NCRB data, cases under Prohibition of Child Marriage Act, 2006 saw an increase of nearly 50 per cent from 525 in 2019 to 785 in

However, the number of cases recorded under the Child Labour (Prohibition and Regulation) Act, 1986 saw a decline of around 38 per cent from 770 cases in 2019 to 476 cases in 2020.

This is in contrast to the recently released ILO global estimates on child labour 2020 report, which states that there were 16.8 million more children within the agegroup of five to 11 years

in child labour in 2020 than in 2016, CRY said. The COVID-19 cri-

sis threatens to further erode global progress against child labour unless urgent mitigation measures are taken and new analysis suggests a further 8.9 million children will be in child labour by the end of 2022 as a result of rising poverty driven by the pandemic, it said.

'Therefore, this decline needs to be seen in the light of reporting and recording of cases before drawing conclusions regarding progress related to addressing child labour in India," it said.

Another important aspect related to child protection during CO-VID-19 has been the lack of avenues for recreation and socialisation, according to the organisation.

Since there were restrictions on socialising in-person, and teaching shifted online, there was a corresponding rise in time spent by children online, making them vulnerable to online abuse and exploitation, it said.

German Greens leadership steel party for government

BERLIN (AP): The leaders of Germany's environmentalist Green party urged their members Saturday to seize the chance to join the country's next government so they can help tackle the challenge of climate change.

The Greens placed third in Germany's national election last week with 14.8% of the vote. They are in a strong position to form a governing coalition under the firstplaced Social Democrats and the pro-business Free Democratic Party, which came in fourth.

A coalition between the Greens, the Free Democrats and outgoing German Chancellor Angela Merkel's centerright Union bloc is also possible, but currently regarded as less likely. Merkel's party placed second in the parlia-

mentary election with 24.1% of the vote, its worst-ever result. One hitch for either coalition is the left-leaning Greens' long-standing animosity toward the Free Democrats' free-market ideology. Some commentators have described an alliance of the two parties as one between hippies and yuppies.

Robert Habeck, coleader of the Greens, sought to sweep away delegates' concerns Saturday at a post-election congress in Berlin. Habeck told them that alliances should be possible even between parties that don't "think the same, feel the same, eat the same and sing the same songs."

acknowledged He that debates in the coming months would strain the Greens but insisted

it was worth the effort if the party ends up with a share of power. "If we don't act in a really dumb way, then we won't just help carry the government in the next four years but have a decisive say in it," said Habeck.

AnnalenaBaerbock, who ran as the Greens' first candidate for chancellor in the Sept. 26 election, urged the party to be disciplined if its wants to join a government for the second time after its first stint with the Social Democrats from 1998 to 2005.

Back in 1998, the party was a "small partner" with a share of just 6.7% of the vote, she said. This time, Baerbock continued, the Greens are in a better position and will aim to "renew society" and help put Europe on course to become the first climateneutral continent.

Panel formed to draw framework for Assam accord

The sub-committee will submit its report within the next three months.

Guwahati: The Assam government has set up an eight-member committee to prepare a framework for implementation of all clauses of the 36-year-old Assam Accord, especially the Clause-6 report prepared by a central panel pertaining to protecting the cultural, social and linguistic identity and heritage of the indigenous people, officials said on Saturday.

The Commissioner and Secretary of the Implementation of Assam Accord Department, GD Tripathi, issued a notification announcing the formation of the subcommittee, which will submit its report within

the next three months. "The Governor of As-

sam is pleased to constitute a sub-committee to examine and prepare a framework for implementation of all clauses of Assam Accord in general with special emphasis on Clause-6 (High Level Committee Report)," the notification said.

The latest panel will also lay emphasis on implementation of Clause 7, 9 and 10 along with update of National Register of Citizens, issues of flood and erosion, rehabilitation of families of martyrs and victims of Assam agitation, it added.

Besides, the subcommittee will consider various problems faced by the state and potential for all-round economic development while preparing the report for implementation of the historic pact.

The sub-committee, headed by Implementation of Assam Accord Minister Atul Bora, has three ministers and five members from the All Assam Students" Union (AASU), the notification stated.

Other ministers on the panel are Parliamentary Affairs Minister PijushHazarika and Finance Minister Ajanta Neog, while the five from the AASU include its president Dipanka Kumar Nath, general Secretary SankarJyotiBaruah, chief adviser Samujjal Kumar Bhattacharya, and advisers Prakash Chandra Das

UN agency for Palestinian refugees has urgent budget crisis

2 (AP): The UN agency helping Palestinian refugees is facing an existential budget crisis and appealing for urgent funding of USD 120 million to keep essential education, healthcare and other services running, the agency's chief said Friday.

We keep struggling, running after cash, Philippe Lazzarini told a small group of reporters.

The financial situation is a real existential threat on the organisation, and we should not underestimate this because it might force the organisation to decrease services, he added, and if that happens we risk to collapse very quickly.

At stake is the agency's ability to keep 550,000 children in school, provide health care for thousands, and pay the salaries for its 28,000 staffers in November and December, Lazzarini explained.

The UN Relief and Works Agency known as UNRWA was established to provide education, health care, food and other services to the 700,000 Palestinians who fled or were forced from their homes during the war surrounding Israel's

UNITED NATIONS, OCT establishment in 1948. Lazzarini added that it wasn't clear for agency officials if ves or no we will be able to keep our activities in November and Decem-

ber.

Не emphasised the importance of the United States returning as a major donor to UNRWA this year after former president Donald Trump stopped all funding in 2018.

The Biden administration announced in April it would provide a total of USD 235 million to projects in the West Bank and Gaza as well as to UNRWA.

But Lazzarini said the US funding has been offset by decreased funding from other donors as a result of the economic impact of the COVID-19 pandemic, and no information from potential donors in the Middle East.

He pointed to the United Kingdom's decrease in its overseas aid budget from 0.7 per cent to 0.5 per cent of GDP, and the decline in Arab support to UNRWA from USD 200 million in 2018 to about USD 89 million in 2019 and USD 37 million in 2020.

He said UNRWA's un-

certain funding has generated anxiety among Palestinian refugees that the lifeline provided by the agency could be weakened, and a feeling of being abandoned by the international community.

In an effort to reverse this trend, Lazzarini said Sweden and Jordan will be co-hosting a conference in mid-November in Brussels whose main aim is to ensure more predictable multi-year funding for the agency.

He said UNRWA is seeking USD 800 million a year for three years for its core" activities education, health care, and social protection and safety nets.

UNRWA also has a separate emergency budget which provides humanitarian aid to Gaza and Syria, he said. This year that budget was around USD 500 million, and he said it will probably be similar in 2022.

There are now 5.7 million Palestinian refugees, including their children and grandchildren, but Lazzarini said UNRWA only helps the 550,000 in school and 2.8 million who have health benefits.

Save the Young from Obscurity

Demand better from education

little over a decade ago, an obscure man, then in his mid-30s, hailing from a nondescript Andhra village, blazed a trail with his apparently crazy move. This "obscure man" was one called Narasing Lal Butt, and his "crazy move" was to claim "damages" through the human rights commission from his village school for its failure to provide him quality education. Education of even reasonable quality could have established him in life, but in his 30's he found himself ill-equipped and under-prepared for anything worthwhile, hence the claim for damages.

Google searches lead nowhere when it comes to ferreting out what happened of his petition. Most probably nothing. In all probability, Narasing has withdrawn into his obscurity only to be occasionally invoked in publications in distant Sikkim. But his petition was obviously never really about receiving damages, and was always about holding up the mirror. A decade since, the mirror still reflects the same image of a broken education system which is still as listless and continues to mass-produce mediocrity. The litigant had sued his school for making him so, well, 'obscure'. And although his complaint most probably secured him no reprieve, he "blazed a trail" in that he went to the human rights commission and not the consumer redressal courts. Even his incomplete education informed him well enough to recognise that education was not a commodity, but a Right, a human right.

Education, whether free, subsidized or exorbitantly paid for, should be better regulated and any lapses on this front should be seen as a violation of a whole generation's human rights. Fact remains that too few people are paying enough attention to education. Yes, there are huge budgets, there are many schools and literacy is on the rise, but what are the schools really churning out? The success stories of Indian academics [which are only a minuscule proportion of the studying population] are fuelled by individual drive and not institutional support or grooming. To blame the teachers would be too easy, they are only part players in a system which is failing, policy interventions have remained ineffectual and uninspiring. It is worrying that education and schools continue to be seen as readying people for employment when the first priority should always have been learning. In the more worrying trends, new policies have also been destructive, trying to dismantle institutions to suit new moulds.

What the nation now needs are more Narasing Lal Butts; more people from the masses to take the policy framers and deliverers to task; to demand better. May be then things will start improving



Sarah Everard: We Still Treat Indecent Exposure as Merely a 'Nuisance' Offence

s a child, I was taught to laugh if I **A**stumbled across a man who was indecently exposing himself.

My experiences growing up reflect a wider societal view that indecent exposure is not a serious sexual offence. The older stereotype is of a comical "flasher" in a long overcoat lurking in the bushes. These days, when women go online to try to make meaningful connections, they risk getting an unwanted dick pic. Whether the "flasher" is offline or online, we are encouraged to laugh about it.

Women are conditioned by society to see these experiences as funny and the men as pathetic. But it really isn't something to laugh about. The reality is that these incidents make women feel vulnerable, violated and unsafe. Indecent exposure is therefore a serious issue for women.

It also becomes a serious issue for society if culprits go on to commit contact sexual offences and violence. The Independent Office for Police Conduct is investigating three allegations of indecent exposure made against Wayne Couzens prior to the night he kidnapped and murdered Sarah Everard. Of these, two related to incidents alleged to have taken place just three days before the murder. It appears that these incidents were not taken seriously or formally investigated by police at the time

been reviewing all the available literature on indecent exposure from the last 30 years. I found a tendency to describe indecent exposure as a "nuisance" offence. When the Law Commission was trying to update the legal framework in 2015, its assessment included references to "flashing" - language that implies that legally we still aren't viewing indecent exposure as a serious and sexual

Indecent exposure was only formally classified as a specifically sexual offence in 2003. Before then, it was legally defined within the Vagrancy Act of 1824. This act suggested the offence was committed by "rogues and vagabonds".

So, up until relatively recently, if you'd been a victim of indecent exposure, you wouldn't have been seen as a victim of a sexual offence. This is surprising, given that indecent exposure involves the intentional exposure of the genitals. The slow shift in legislation reflects that indecent exposure is only just starting to be taken seriously.

And yet it is a prevalent offence. Although official statistics suggest that indecent exposure is not very common, studies undertaken with victims consistently suggest otherwise. A recent YouGov survey found that almost one in five participants had experienced indecent exposure. THE REALITY FOR VICTIMS

This contradiction between

be explained by the fact that women simply don't report the crime. There are various reasons why they might not go to the police. They might be traumatised and unwilling to revisit the experience or they might fear for their future safety after reporting

Crucially, victims might not believe the incident is serious enough to be reported, which wouldn't be surprising given that we are all taught from an early age that indecent exposure is not a big deal.

There is evidence that some victims do not report indecent exposure because they lack confidence in the system. If society continues to view indecent exposure as a "nuisance", then women will continue to feel reluctant to report their experiences to the police. This means they will carry around the psychological harm and fear that indecent exposure creates in silence.

RE-OFFENDING AND ESCALA-

Despite under-reporting, the research tells us that men who indecently expose themselves have high rates of re-offending. The largest consolidation of relevant research suggested 25% of men go on to commit further offences of indecent exposure (on average).

These high re-offending rates also include some exhibitionists escalating into other sexual acts. Men who indecently expose themselves can In the course of my research, I've cial statistics and victim studies can escalate to sexual offending involv-

ing physical contact, as appears to have been part of the picture with Couzens.

I do want to be clear: Couzens is not representative of the typical man who indecently exposes himself. But he is a reminder of the worst-case scenario. What happened to Sarah Everard demonstrates why we should take this type of offending more seriously.

When we identify indecent exposure, we do not know exactly who will escalate to commit contact sexual offences. The current research base does not agree on how and why this escalation occurs. Men who indecently expose themselves are a varied group with a wide range of motivations. This lack of clear evidence makes the punishment and rehabilitation of men who indecently expose themselves more difficult. However, it does not detract from the need for indecent exposure to be properly investigated, punished and treated.

And as long as victims remain reluctant to report this type of offence to the police, we cannot get an accurate picture of how regularly indecent exposure occurs. Ultimately, society as a whole does not take indecent exposure seriously. This is in spite of the significant psychological impact it has on victims - and the potential for offenders to go on to commit other crimes. Perhaps it is time to stop laughing.

Calling the latest gene technologies 'natural' is a semantic distraction — they must still be regulated

egislators around the world Lare being asked to reconsider how to regulate the latest developments in gene technology, genome editing and gene silencing.

Both the European Court of Justice and the New Zealand High Court have ruled that genome editing techniques should remain under the regulations specific to genetically modified organisms.

But a few other countries, including Australia, have exempted some uses of these techniques from their regulations, based on similarities to what occurs in nature. The main argument is that the biochemical processes of editing are like the processes that cause natural mutations.

The "equivalent to nature" narrative blurs the boundary between natural processes and technology.

Unfortunately, the risks from technology don't disappear by calling it natural. The risk of harm from gene technology accumulates over time and scale of production. In our new research, we propose a framework that regulates technologies depending on their scale of use.

Proponents of deregulation of gene technology use the naturalness argument to make their case. But we argue this is not a good basis for deciding whether a technology should be regulated.

RISK OF HARM GROWS WITH **INCREASED USE**

The notion of naturalness has been criticised as unscientific in the past, but now some scientists are using it to say that gene editing should be exempt from regula-

Geneticists have long used the term "spontaneous" to refer to events that are outside of human control. Mutations can be either spontaneous or caused by people using gene technology. Differences in DNA sequences produced by either might give rise to a new trait.

In nature, if a new trait brings an advantage to the organism, it is amplified through reproductive fitness. When humans amplify a trait through selective breeding, we substitute our hands for the invisible hands of natural selection. We therefore create additional potential for harm through our interventions.

Some uses and outcomes of gene technology can be made to appear natural, but this is a diversion from how and why gene technology should be regulated. Instead we should recognise that gene technologies allow more people to produce and amplify modified organisms more quickly and in more environments.

Any potential harmful out-

comes of the use of gene technology increase as it is used more. What makes gene technology useful is also what makes it risky.

speed up biological change and if this is carried out on a large enough scale, then we can say that if anything can happen it certainly



COMPLEX RISK

Nobel laureate Sydney Brenner described gene technology as a biological Archimedian lever for doing what could occur spontaneously in a faster, more concentrated and very different manner.

"We now have the tools to

Safety increases with the use of some technologies, such as car brakes. The more cars with brakes, the safer our roads. No tool of gene technology, including gene silencing and genome editing, becomes safer the more it is used.

Gene technologies can be improved incrementally, but that isn't making them safer when used more. Any potential risks multiply as more people use them more frequently and on more species. Regulation is our least imperfect tool to manage this risk.

Imagine if other technologies with the capacity to harm were governed by resemblance to nature. Should we deregulate nuclear bombs because the natural decay chain of uranium-238 also produces heat, gamma radiation and alpha and beta particles?

We inherently recognise the fallacy of this logic. The technology risk equation is more complicated than a supercilious "it's just like

nature" argument. CRITICAL CONTROL POINTS

We proposed the use of critical control points in a governance framework to regulate technology consistently with its risk to cause

One such critical control point is between the introduction of mutations and the release of the organism. Another is the decision to make genome editing and gene silencing reagents available for sale to nearly anyone.

Deregulation and tiered regulatory frameworks release important critical control points from oversight. That is a problem even for what might be considered lowrisk uses of genome editing and gene silencing because if they are used more without regulatory oversight, the likelihood of harm increases.

Critical control points tether governance to risk rather than downplay risk using metaphors that sound like science but are not. "No foreign DNA" or "just like nature" are slippery semantics they are not measurable but make risk assessments sound quantitative and precise.

This approach raises misunderstanding of the underlying causes of harm from technology, inviting Brenner's future where "if anything can happen it certainly will".

Whether it is by sweeping or creeping deregulation, carefully chosen metaphors descale the risk of any kind of genetic engineering. By sleight of speech any technology can be made to sound like an extension of nature.

Critical control points instead inform both risk assessment and risk mitigation with precision. Regulated gene technologies can produce safe and possibly socially acceptable products, but we don't get to them faster by taking short

MIZORAM COVID-19 GUIDELINES: The order issued on Friday night said that it has been felt necessary to give more focus on providing better treatment to COVID-19 patients than imposing stringent restrictions despite a spurt in CO-VID-19 cases.

Aizawl: The Mizoram government has issued new COVID-19 guidelines with a few more relaxations to ease economic and other activities in Aizawl Municipal Corporation (AMC) area and other parts of the state.

The new guidelines will come into effect on October 3 and will remain in force in the state till October 16.

According to news agency Press Trust of India, the order issued on Friday night said that it has been felt necessary to give more focus on providing better treatment to COVID-19 patients than imposing stringent restrictions despite a spurt in COVID-19 cases.

The new order allowed the re-opening of churches in COVID-19 affected AMC area and also in other parts of the state only on Sunday and Sabbath (Saturday) during daytime with 50 per cent seating capacity.

Churches in COVID-19 free towns and villages outside AMC area have been already re-opened on August 22.

School and other higher education institutions will continue to remain closed in AMC area but training institutes will be allowed to re-open with 50 per cent seating capacity in the state capital, the order said.

The government has already allowed re-opening of schools (KG to class 12) and Anganwadicentres in coronavirus free towns outside AMC area on August 15 and further allowed re-opening of all educational institutions, including colleges, on September 5.

Re-opening of public parks is now allowed even in AMC area with 50 participants subjected to permission of local level task force of the locality where such park is located.

Social or public gatherings like anniversary or birthday celebrations and other gatherings are now allowed in AMC area with either 50 per cent of the seating capacity or 50 attendees, whichever is less, the order said.

The number of attendees in funerals and weddings in AMC area has been increased from 30 to 50 or 50 per cent of the seating capacity, whichever is

The government has now allowed full re-opening of all business shops, market places, hawker stalls, hotels, restaurants (with 50% seating capacity) and tourist lodges, among others, across AMC area.

All government offices in the state will now open with full staff, the order

Intra-state movement is allowed under exceptional cases, it said.

Night curfew will continue to be imposed in all district headquarters between 8 pm and 4 am.

In areas outside AMC, deputy commissioners will issue separate guidelines depending on the COVID-19 situation of their districts or areas, the order said. Meanwhile, Mizoram today reported 1,626 new COVID-19 cases pushing the state's tally to 96,456, a health official said.

The number of deaths rose to 314 as three more persons succumbed to the infection in the last 24 hours, he said.

At least 263 children were among the newly infected people, he said.

KalakarDiwas will celebrate the International Artist Day 2021 said. with various activities to encourage local artists, he added.


The event will also celebrate the 126th birth anniversary of the Chogval Sir TashiNamgyal on 26 October.

While they did not lose many wickets, what did not help India's cause was that the batters could not capitalise on the loose balls on a pitch that looked pretty flat.

Meanwhile, Sharma, who started the day on 12, got to her second Test fifty with a sweep behind square, reaching the landmark in 148 balls with the help of five boundaries.

Ellyse Perry gave the team another breakthrough when she had PoojaVastrakar brilliantly caught by Beth Mooney at gully as the batter looked to drive through covers.

Theegala, Zalatoris and Nick Watney share the lead at 13-under.

Zalatoris, voted the PGA TOUR rookie of the year despite not having full status last year, made it look so simple at the Country Club of Jackson that his longest putt for par was 3 feet.

Theegala held his own after opening with a 64, new territory for the California rookie in just his second start as a PGA TOUR member.

He chipped in for eagle on the par-5 third hole to get right back in the mix. Theegala finished with a 30-foot birdie putt for a 67.

Among those who missed was Sergio Garcia, the defending champion playing a week after a draining Ryder Cup at Whistling Straits.

Former US Open champion Gary Woodland took two shots from behind the ninth green on his final hole and made bogey for a 73 to miss the cut by one. Cameron Young and Hayden Buckley each shot 65 and were one shot out of the lead. Roger Sloan of Canada shot 67 and was two behind.

Among the Asians, CT Pan (68-67) was the best at nine-under and he was followed by Sungjaelm (67-69) at eight-under. Si Woo Kim (66-71) was seven-under.

I need some wins to regain my confidence: Praneeth

NEW DELHI, OCT 2 (PTI): Struggling with form and a nagging back issue, India's B SaiPraneeth is desperate to get some wins under his belt to regain his confidence as he gears up for next week's Thomas Cup and Uber Cup Finals.

The rescheduled men's and women's team tournaments will be held from October 9 to 17 at Aarhus, Denmark.

Praneeth had clocked a lot of hours to prepare for the Olympics, but his campaign didn't go according to plan as he failed to win a single group match in Tokyo, returning empty handed.

He also suffered a loss in the only singles match that he played at the Sudirman Cup in Vantaa, Finland.

Up against China's Shi Yuqi, Praneeth lost in straight games as India suffered a 0-5 defeat in their Group A match to crash out of the quarterfinals race.

"I am training well but I really don't know what is happening on court. I just need a couple of wins to get that confidence back ahead of the important events," Praneeth, the 2019 World Championships bronze medallist, told PTI.

Talking about India's campaign at the Thomas Cup, Praneeth said: "India has a strong team for Thomas Cup. Earlier, we used to depend on three



singles for a win. It was tough Olympics due to overload, so to make it if we lose one but we have good doubles team now, so till quarterfinal it looks good."

The Hyderabad shuttler revealed that he had developed a back stiffness few days before the Tokyo Games, but he didn't put the blame on his fitness for the losses.

"I had developed a back pain just four days before the

I played with a bit of pain but that is not the reason why I lost. I lost mostly because of pressure," Praneeth made an honest assessment.

"I was positive, very confident and fit ahead of the Olympics but then some things kept happening, which affected me negatively. I could feel the tension on the court.

"I am fine now but I need to

keep doing strengthening exercises for my back or else it will become stiff again. Working hard on my game, training and taking care of my body -- that's

what is in my hands, so really

need some wins." While P V Sindhu excused herself after a hectic Olympic campaign, ChiragShetty and SatwiksairajRankireddy also missed out after the former pulled his abs muscle, leaving Praneeth as the only shuttler from the Olympic team to play in Finland.

"Sudirman Cup and Thomas Cup are important team events, then there is Denmark Open and French Open. Many events have been cancelled due to COVID-19, so we hardly played individual tournaments, so I am looking forward to some match time."

The Thomas and Uber Cup Finals will be followed by Denmark Open (October 19-24) and French Open (October 26-31). Praneeth said he can't afford to skip events as he needs to maintain his ranking ahead of next year's Commonwealth Games.

"You can't miss events as there are no events happening later. If you miss then later it could be a problem. We have commonwealth Games and everything is related to ranking," said the 29-year-old, who is currently ranked 15 in the world.

After the French Open, there is a two-week window before he heads to Indonesia for back-to-back events, and will end the season with the World Championships in Huelva, Spain in December.

"The schedule is hectic as I will have to play back-to-back tournaments but will have to manage," he signed off.

Speaking to reporters at a flood relief camp in Arambagh in the Hooghly district, Mamata Banerjee said she will request the Centre to prepare a master plan to prevent floods.

"This is a man-made flood. I will request Jharkhand to prepare a plan in consultation with us. Will request the Centre to prepare a master plan to prevent recurrence of floods. Had the dams in Jharkhand been dredged, Bengal would not have faced such a

situation," she said. After an aerial survey of a few flood-hit areas, Mamata Banerjee said discharge of more than 5 lakh cusec water by PSU DVC over the past two days without informing the West Bengal government has caused the flood in the state.

The situation in parts of East and West Midnapore, Bankura, Hooghly, Birbhum, Howrah and East and West Burdwan was grim due to excessive discharge of water by DVC, following rains in Jharkhand, the Chief Minister said.

Four lakh people of the state have been affected by the floods and the state government was providing them relief, she said.

Fifty rescue and relief teams of the National Disaster Response Force (NDRF) and SDRF were working in the affected areas, Mamata Banerjee said. "Hope the water will recede quickly," she added.

China investigates ex-official who led major corruption

case BEIJING, OCT 2 (AP): A former Chinese justice minister has become a target of President Xi Jinping's anti-corruption campaign.

Fu Zhenghua, who was also a former vice minister of public security, is under investigation for severe violations of party discipline and law, the ruling Communist Party's Central Commission for Discipline Inspection said Saturday. It did not provide any details in a one-sentence statement posted online.

It's unclear why Fu, 66, would become a target of the campaign. He was the longtime head of public security for Beijing and vice minister of public security from 2013 to 2018. He then served as justice minister from 2018 to 2020.

When he was vice minister for public security, Fu led the probe of Zhou Yongkang, one of the most senior officials convicted in the anti-corruption campaign. Zhou, a former public security minster, was one of nine members of the Politburo Standing Committee, the Communist Party's top body, under Xi's predecessor, President Hu Jintao.

Zhou was sentenced to life in prison in 2015 on charges of taking bribes, abusing power and leaking state secrets.

Xi has been accused of using the anti-corruption drive to drive out political adversaries, and Zhou's downfall was seen as burying a oncepowerful faction in the Communist Party.

The announcement of the investigation into Fu comes two days after the party's discipline commission said it had expelled another former vice minister of public security, Sun Lijun, citing accusations of corruption and abandoning his post during the CO-VID-19 outbreak.

West Bengal records 13 new deaths, 708 fresh cases

KOLKATA, OCT 2 (PTI): West Bengal's vid death toll reached 18,806 on Friday with 13 new fatalities, while 708 fresh cases pushed the tally to 15,69,778, a bulletin released by the state Health Department said. Kolkata and North 24 Parganas recorded four deaths each, the bulletin said. The number of active cases in the state was 7,571, it said.

The discharge rate in West Bengal stood at 98.32 per cent with 694 more people recovering from the disease, the bulletin stated. The percentage of positive cases out of the samples tested stood at 1.79 per cent, it said. A total of 15,43,401 patients have been discharged so far, the bulletin said.

Kolkata recorded the highest number of cases on Friday at 146, followed by 116 in neighbouring North 24 Parganas district, it said.

Africa internet riches plundered, contested by China broker

KAMPALA, OCT 2 (AP): Outsiders have long profited from Africa's riches of gold, diamonds, and even people.?Digital resources have proven no different.

Millions of internet addresses assigned to Africa have been waylaid, some including fraudulently, through insider machinations linked to a former top employee of the nonprofit that assigns the continent's addresses.

Instead of serving Africa's internet development, many have benefited spammers and scammers, while others satiate Chinese appetites for pornography and gambling.

New leadership at the nonprofit, AFRINIC, is working to reclaim the lost addresses. But a legal challenge by a deep-pocketed Chinese businessman is threatening the body's very existence.

The businessman is Lu Heng, a Hong Kong-based arbitrage specialist. Under contested circumstances, he obtained 6.2 million African addresses from 2013 to 2016. That's about 5 per cent of the continent's total more than Kenya has.

Antibody tests for COVID-19 remain popular in Russia

Moscow, Oct 2 (AP): When Russians talk about the coronavirus over dinner or in hair salons, the conversation often turns to antitela, the Russian word for antibodies the proteins produced by the body to fight infection.

Even President Vladimir Putin referred to them this week in a conversation with his Turkish counterpart RecepTayyipErdogan, bragging about why he avoided infection even though dozens of people around him at the European University in caught the coronavirus, including someone who spent a whole day with the Kremlin leader.

I have high titers, Putin said, referring to the measurement used to describe the concentration of antibodies in the blood. When Erdogan challenged him that the number Putin gave was low, the Russian insisted, No, it's a high level. There are different counting methods.

But Western health experts say the antibody tests so popular in Russia are unreliable either for diagnosing COVID-19 or assessing immunity to it. The antibodies that these tests look for can only serve as evidence of a past infection, and scientists say it's still unclear what level of antibodies indicates protection from the virus and for how long.

The US Centre for Disease Control and Prevention says such tests should not be used to establish an active COVID-19 infection because it can take one to three weeks for the body to make antibodies. Health experts say tests that look for the virus's genetic material, called PCR tests, or ones that look for virus proteins, called antigen tests, should be used to determine if someone is infected.

In Russia, it's common to get an antibody test and share the results. The tests are cheap, widely available and actively marketed by private clinics nationwide, and their use appears to be a factor in the country's low vaccination rate even as daily deaths and infections are rising again.

In Moscow and the surrounding region, millions of antibody tests have been done

at state-run clinics that offered them for free. Across the country, dozens of chains of private labs and clinics also offer a wide variety of antibody tests for CO-VID-19, as well as tests for other medical conditions.

In some cities I went to, I needed to take a PCR test and it wasn't possible, but I could take an antibody test it was much easier, said Dr. Anton Barchuk, head of the epidemiology group St. Petersburg and an associate professor at the Petrov National Cancer Centre there.

Antibody tests for COVID-19 were first widely publicised in Moscow in May 2020, shortly after Russia lifted its only nationwide lockdown, although many restrictions remained in place. Mayor Sergei Sobyanin announced an ambitious program to test tens of thousands of residents for antibodies.

Many Muscovites greeted this enthusiastically. Contrary to Western experts, some believed antibodies represented immunity from the virus and saw a positive test as a way out of restrictions.

The test looked at two different types of antibodies: ones that appear in one's system soon after infection, and ones that take weeks to develop. To their surprise, some of those who tested positive for the former were handed a COVID-19 diagnosis and ordered to quarantine.

Irina Umarova, 56, spent 22 days confined to her studio apartment, without experiencing any symptoms. Visiting doctors took six PCR tests that came back negative. But they also took more antibody tests, which continued to show a certain level of antibodies.

They kept telling me I was infected and needed to stay home, she said.

More interest in antibody testing came this summer when Russia had a surge of infections. The demand for tests spiked so sharply that labs were overwhelmed and some ran out of

That's when dozens of re-

gions made vaccinations mandatory for certain groups of people and restricted access to various public spaces, allowing in only those who were vaccinated, had had the virus, or had tested negative for it recently.

DariaGoryakina, deputy director at the Helix Laboratory Service, a large chain of testing facilities, said she believed the increased interest in antibody testing was connected to the vaccination mandates.

In the second half of June, Helix performed 230 per cent more antibody tests than in the first half, and the high demand continued into the first week of July. People want to check their antibody levels and whether they need to get vaccinated, Goryakina told The Associated

Both the World Health Organisation and the CDC recommend vaccination regardless of previous infection.

Guidance in Russia has varied, with authorities initially saying that those testing positive for the antibodies weren't eligible for the shot, but then urging everyone to get vaccinated regardless of their antibody levels. Still, some Russians believed a positive antibody test was a reason to put off vaccina-

Maria Bloquert recovered from the coronavirus in May, and a test she took shortly after revealed a high antibody count. She has put off her vaccination but wants to get it eventually, once her antibody levels start to

As long as my antibody titers are high, I have protection from the virus, and there is no point in getting injected with more protection on top of it, the 37-year-old Muscovite told AP.

High-profile officials, like Kremlin spokesman Dmitry Peskov and ValentinaMatviyenko, speaker of the upper house of parliament, both have been quoted as saying they didn't need to get vaccinated due to having high levels of antibodies, but they eventually decided to get their shots. Contradicting

guidelines may have contributed to Russia's low vaccination rate, said Dr. Anastasia Vasilyeva, leader of the Alliance of Doctors union.

of creating the world's first vaccine, Sputnik V, only 32.5 per cent of its 146 million people have gotten at least one shot. and only 28 per cent are fully vaccinated.

Critics have principally blamed a botched vaccine rollout and mixed messages the authorities have been sending about the outbreak.

Dr. Simon Clarke, an associate professor in cellular microbiology at the University of Reading in England, said antibody tests shouldn't influence any health-related decisions.

Getting an antibody test "is for your own personal satisfaction and curiosity, he added.

Barchuk, the St. Petersburg epidemiologist, echoed his sentiment, saying there are too many gaps in understanding how antibodies work, and the tests offer little information beyond past infection.

But some Russian regions disregarded that advice, using positive antibody tests to allow people access to restaurants, bars and other public places on par with a vaccination certificate or a negative coronavirus test. Some people get an antibody test before or after vaccination to make sure the shot worked or see if they need a booster.

Dr. VasilyVlassov, an epidemiologist and a public health expert with the Higher School of Economics, says this attitude reflects Russians' distrust of the state-run health care system and their struggle to navigate the confusion amid the pandemic.

People's attempt to find a rational way of acting, to base their decision on something, for example the antibodies, is understandable the situation is difficult and bewildering, Vlassov said.

While 106 patients were discharged after recovery during last total recoveries stood at 1,23,906.



knowledged that five workers had been killed on site during construction of the massive world's fair, revealing for

the first time overall statistics for worker fatalities.

Expo previously said that its 200,000 laborers who built the site worked some 240 million hours in its construction. It had not offered any overall statistics previously on worker fatalities, injuries or coronavirus infections despite repeated requests from The Associated Press and other journalists.

The admission comes after the European Parliament last month urged nations not to take part in Expo, citing the United Arab Emirates' "inhumane practices against foreign workers" that it said worsened during the pandemic. Ahead of Expo, businesses and construction companies are "coercing workers into signing untranslated documents, confiscating their

passports, exposing them to extreme working hours in unsafe weather conditions and providing them with unsanitary housing," the resolution said.

At a press conference a day after the event's opening, Expo spokesperson SconaidMcGeachin said the information about fatalities was previously available to journalists and referred reporters to a press release about a monument honoring the laborers who built the site from scratch, which offered no additional delater, unspecified time.

McGeachin also acknowledged that authorities were aware of cases involv-
