100 more test positive at Rongneck Jail, Sikkim's Covid count reaches 5.799

GANGTOK, 26 DEC:

The number of active COVID-19 cases in Sikkim has climbed to 517 with 115 fresh cases detected in the last 24 hours on Saturday. The State had 417 active cases on Friday.

Among these 115 new cases are 100 inmates currently lodged in the Central Jail, Rongneck in East

Sikkim's tally of confirmed cases of COVID-19 has also now climbed to 5,799, of whom 5,063 have already been discharged from the home and facility isolation. There are currently four patients admitted in the ICU facility of the COVID-dedicated STNM

In his daily health bulletin on Saturday, Health Department State IEC Officer, Sonam Gyaltsen Bhutia, informed that the 115 cases were picked up from 270 samples tested on Friday - 113 in RT-PCR testing of 240 samples and two through rapid antigen testing of 20 samples. Only one of the cases came from West District and three from South District.

While providing details of the new cases, Mr Bhutia informed that the 100 more who tested positive at Rongneck Jail have been kept in isolation. It may be recalled that 81 inmates have already tested positive at the Central Jail, following which it was declared a Covid Care Centre and doctors and support health staff deputed there.

Among the new cases reported from in and around the capital are one person from Lower Shyari, one from Yatri Niwas, one from Gangtok, one from Daragaon-Tadong and one from Joredhara-Tadong.

Two persons from Ranipool, one from 8th Mile-Marchak, one from Biring-Zarong, one from Lower Tarku and one from Mamring have also been found positive for COVID-19.

Mr Bhutia informed that samples of three persons from Namchi in South District and one person from "Upper Lunjizl" in West District were also tested COVID-19 positive.

25 Dec is observed every year as "Good Governance Day" to mark the birth anniversary of former Prime Minister, Atal Bihari Vajpayee.

Under the scheme, farmers falling into a scale fixed by the government are transferred an amount of Rs 6,000 every year. The money is deposited in three installments, of Rs 2,000 each.

Pradhan Mantri Kisan Sammann Nidhi is an initiative by the government of India in which all farmers will get up to ₹6,000 per year as minimum income support.

2020 was of struggle, innovation for teachers **GUNJAN SHARMA**

NEW DELHI, DEC 26 (PTI): From turning walls of mud blackboards into taking classes through loudspeakers on moving carts, from 'mohalla' classes to using public announcement system of panchayat bhawans, 2020 was full of struggle and innovation for teachers to ensure learning was not disrupted as schools remained closed due COVID-19.

The over 10-month-long shutdown inspired creative ways to teach thousands of students who could not log on to online classes because they did not have access to smartphones and computers in several villages across the country.

Government school teachers in Dumka's Dumarthar village in Jharkhand found a new way to impart education to students who do not have access to smartphones.

They created blackboards on the walls of students' houses to teach them while maintaining social distancing.

"We started with an initiative called 'shiksha aapke dwaar' (education at your doorstep) to provide education to children who did not have access to

smartphones and internet. More than 100 blackboards have been created on walls to teach students at their houses," said Tapan Kumar, a teacher in

Dumarthar. Every day, Indra Mukhi Chhetri, a maths and science teacher in Sikkim's Ravangala, visited homes of several students she identified and reached out to around 40 students in a week from class 1 to 5.

"Even if I take online classes, these students either do not have devices or Internet connectivity. Some of them may have access but then how do I maintain equality, others might feel left out. So I used to spend about 20 minutes with each student in a week.

"I collected their notebooks and write lessons for them, which they have to finish over the course of the week. I also brief the parents on what needs to be done," she said.

Ghanshyambhai, a teacher in Gujarat's Janan village, used the public announcement system of the village panchayat to share parents on how to deal with children during the lockdown period, importance of exercising and much more.

"I also announced when I will be at Panchayat Bhawan so students or parents who want to clear any doubts or to interact can see me there, while maintaining social distancing," he added.

Teachers in Chhattisgarh conducted Mohalla (neighbourhood) classes in areas with low infection rates.

"We set up mini classrooms, with small groups of students, in community spaces. The teachers spent a couple of hours in each room, engaging with all students at least twice a week," one of the teachers said.

Another teacher Chhattisgarh, Rudra Rana, used his motorcycle to conduct classes.

"The children were not able to go to study as schools were closed. So I thought why not bring the school to them. Even though schools continue to be shut, online classes are not viable for most rural students. I used a portable umbrella and a chalk board to take classes when I went to the village," he said.

In Haryana's Kanwarsika stories, songs, guidelines for village, the morning bell announcing the start of a teaching session used to ring, not in the local school, but from a van equipped with a

loudspeaker.

"Students settled down inside homes and in courtvards facing the street. First they recited a prayer following the teacher on loudspeaker and then they attended lessons of one subject each day," Noor Bano, a teacher with the government school in Nuh district, said.

In a newly-acquired daily practice, students in Haryana's Jhamri village opened their textbooks at the sight of the cart that arrived near their homes. filling the vacuum left by closure of schools due to the lockdown and lack of digital infrastructure such as feeble internet connectivity.

"I arranged for a loudspeaker system on a cart. The teachers were asked to turn-wise go with the cart and park it at a feasible location and impart lessons from there. It doesn't match up to the classroom learning levels but will at least ensure that students' don't drop out," said Satyanarayan Sharma, who runs a school in the village in Jhajjar district.

The lockdown induced by COVID-19 in March prompted schools and colleges to move to the virtual world for teaching and learning activities and exposed the existing digital divide in the The highlight of the

New Delhi, Dec 26 (PTI): Around 150 Army a very strict COVID-19 personnel who arrived in the national capital from various locations in the last Republic Day and Army few weeks to participate in Day parades. The safe the Republic Day and Army Day parades have tested positive for COVID-19, official sources said. The infection was detected during a mandatory testing for COVID-19 under a strict protocol formulated to insulate all the personnel taking part in the two parades from the COVID-19 infection, they said. Over 2,000 Army personnel have arrived in Delhi since late November for the Republic Day and Army Day parades using various modes of transport and all of them had to undergo the COVID-19 test before they were put into a "safe bubble", the sources said. Those who have tested negative are being put into the "safe bubble" that has been created to accommodate all the personnel who will be part of the marching contingents, they said.

The "safe bubble", created in the Cantonment area, comprises a large number of camps and those selected to stay in them will have almost "zero connectivity" from the outside world till the Republic Day celebrations on January 26, the sources said. The Army Day is celebrated on January 15.

The sources said the 150 personnel who have tested positive COVID-19 for "asymptomatic" and may be able to go to the "safe bubble" once they recover from the infection.

Oxford vaccine likely to be first to get approval in India, say officials

NEW DELHI, 26 DEC make a presentation. [PTI]: With preparations underway for a possible vaccine-rollout January, the Indian drug regulator is looking at the UK, which sources believe may give its nod to the Oxford COVID-19 vaccine next week, before deciding on giving emergency use authorisation to the Serum Institute that is

manufacturing the shots. Once the UK drug regulator gives its approval to the vaccine, Oxford the committee expert on COVID-19 at the Central Drugs Standard Control Organisation (CDSCO) will hold its meeting and thoroughly review the safety immunogenicity data from the clinical evaluations conducted abroad and in India before granting any emergency authorisation for the vaccine here, official sources said.

The process granting emergency use approval for Bharat Biotech's COVID-19 vaccine 'Covaxin" may take time as its phase 3 trials are still underway, while Pfizer is yet to

"Going by this, Oxford vaccine 'Covishield' is likely to be the first to be rolled out in India," a source said.

Serum Institute of India (SII) last week also had submitted some additional data required by the Drug Controller General of India (DCGI), the sources said.

Amid fears about the mutated variant of SARS-CoV-2 detected in the UK, government officials recently said that it will have no impact on the potential of emerging vaccines that are being developed in India and other countries.

Bharat Biotech, Serum Institute of India (SII) and Pfizer had applied to the Drugs Controller General of India (DCGI) seeking emergency use authorisation for their COVID-19 vaccines early this month.

The subject expert committee (SEC) on COVID-19 of the Central Drugs Standard Control Organisation (CDSCO) on December 9 had sought additional safety and efficacy data for COVID-19 vaccines of SII

and Bharat Biotech after deliberating upon their applications.

The application by the Indian arm of US pharmaceutical firm Pfizer was not taken up for deliberation as the company had sought more time for making a presentation before the committee.

The Pfizer vaccine has already been approved several countries including the UK, the US, and Bahrain.

While considering SII's application, the SEC had recommended that the firm should submit an updated safety data of phase 2 and 3 clinical trials in the country, immunogenicity data from the clinical trial in the UK and India, along with the outcome of the assessment of the UK Medicines and Healthcare products Regulatory Agency (MHRA) for grant of EUA.

As for Hyderabad-Bharat Biotech, based "after detailed deliberation, the committee recommended that the firm should present the safety and efficacy data from the ongoing phase 3 clinical trial in the country for further consideration",





Addiction Remains Because We Won't Engage

Cops should not be the only ones bothered by substances abuse

This section has often railed against the police, policing and the force's clearly askew priorities. And yet, they also remain the only defence that Sikkim has cobbled together to address the problems of substance abuse. Sikkim Police appears to be the only agency consistently bothered by the proliferation of substances of abuse in the State and the increasing number of youth who appear to be developing the habit. It thus keeps busy; making arrests and conducting drug busts in its bid to keep the streets free of easy accessibility to substances of abuse. At least someone is doing their bit about the disturbing prevalence of substance abuse in the State, because the society sure is not doing much. And even the policing now appears to be focused primarily at the interstate check-posts and traditional "hot-spots". There is, after all, only so much that solitary agency can do to address what is essentially a societal challenge.

The State Government did its part by giving Sikkim's youth the Sikkim Anti-Drugs Act which penalizes the peddling of prescription drugs of abuse, sourcing, hoarding and peddling of which used to earlier not even earn a proper rap on the knuckles. Sikkim Police has patrolled the streets to confiscate as much of this contraband as appears possible, and the process has now become so frequent and routine that even addicts are being picked up on "source" information and are being processed as dealers. A clutch, a very small clutch, of organisations also remain steadfast in their commitment to work among addicts and those wishing to kick the habit. What is also worrying is that the more serious narcotics are also finding their way to those who have already made it past the gateway drugs, and the volume of recent seizures suggest that this market is no longer limited to those with bigger purses.

And where is the society at large in this entire challenge? Substance abuse is a social challenge, a societal failing and policing and enabling laws can only assist a society on a mission to keep the young safe and cannot and should not be the only protection against addiction. Societal engagement is not expected in the form of street processions or community policing and should instead manifest as parent-groups, youth organizations and social associations and NGOs across all platforms recognizing that chemical dependence is ruining an entire generation and then collaborating to first figure out what makes addiction such an easy recourse for the youth and then addressing that problem. These social groups should engage the youth more actively and even invite them to decision-making positions and shoulder them more responsibility. Doing so would communicate respect and that would win over their trust, then efforts can begin to work with the youth to take on the challenge that their age faces in Sikkim. This is an important first step to take because we appear to have lost the trust of the young with our constant failures in looking out for them.

Make no mistake, substance abuse demands mission-level engagement of everyone in Sikkim because too many lives are being wasted in their prime here. No state-initiated or sponsored intervention to address the situation will be enough unless the society at large steps up and gets involved.

Would You Eat Indoors At a Restaurant? We Asked Five Health Experts

 $E^{\text{arlier this fall, many of the nation's}}$ restaurants opened their doors to patrons to eat inside, especially as the weather turned cold in places. Now, as COVID-19 cases surge across the country, some cities and towns have banned indoor dining while others have permitted it with restrictions. Still other geographies have no bans

The restaurant and hospitality industry has reacted strongly, filing lawsuits challenging indoor dining bans and, in New York state, pointing to data that showed restaurants and bars accounted for only 1.4% of cases there - far lower compared with private gatherings.

We asked five health professionals if they would dine indoors at a restaurant. Four said no - and one had a surprising answer. NOT AN OPTION

Dr. LAURIE ARCHBALD-PANNONE, Associate Professor of Medicine, University of Virgina

No. March 12, 2020 was the last day I ate indoors at a restaurant. At the time, there was mild apprehension - but much changed that week. The COVID-19 pandemic altered many aspects of "normalcy," and for me eating inside at a restaurant is one of those activities. I loved eating out and typically would eat out three times a week (sometimes more!). But understanding how the COVID-19 infection is transmitted, I feel that being inside without a mask on even just to eat - is not an option for me. I strongly believe that we need to support our community through these challenging times, so we still get curbside pickup or delivery from our favorite local restaurants at least three times a week - sometimes more! - but it will be a while before I'm back inside. When I do return I'm definitely getting dessert.

Dr. THOMAS A. RUSSO, Chief of Infectious Disease Division, Jacobs

School of Medicine and Biomedical response may seem surprising

Sciences, University at Buffalo No. And it's been "no" right from the beginning.

We have a little more information now, but what I said in the spring hasn't really changed. The greatest risk of getting infected with SARS-CoV-2 is being indoors with people who aren't using masks at all times. The concern isn't just big respiratory droplets when close to someone talking; it's also the tiny aerosols that linger in the air.

Making it even riskier is the generally poor ventilation in many restaurants. The key differences between indoor dining and shopping in a big box store or grocery store are: 1) big stores have more ventilation and greater air space; 2) everyone can wear a mask at all times; 3) you're not fixed in space, so if you see someone who just has a bandanna or their mask drops down below their nose, you can steer clear of them; and 4) it should take less time than dinner out. At a restaurant, you're stuck at that table. If a party near you is having an animated conversation, they could be generating a lot of respiratory secretions.

Some interesting studies have looked at the airflow and air currents in restaurants in relation to where people became infected. In one, a person was 20 feet away from the source for only about 5 minutes, but the person was directly in the airflow and became infected. It's a reminder of what we've been saying - there's nothing magical about 6 feet. The high degree of community disease in the U.S. right now increases the likelihood that another diner in the restaurant is infected. If you are tired of cooking and need a break, takeout is the way to go.

CAREFUL MIXED WITH TRUST SUE MATTISON, Provost and Professor in the College of Pharmacy and Health Sciences, Drake University Yes. As an epidemiologist, my

or hypocritical: I do eat at local restaurants, but only because in April, like more than 17 million Americans since that time, I tested positive for COVID-19 and recovered. According to the latest evidence, I believe I have immunity for now, and perhaps longer. But I am not pushing

I have my own list of four restaurants where I eat. I trust these restaurants because each has drastically reduced their number of tables and spaced them at least 6 feet apart, and everyone inside is diligent about wearing a mask. My husband and I also order takeout a lot. It is important to reiterate, however, that evidence shows restaurants are a significant source of infection, and those who have not recovered from COVID-19 should refrain from eating at restaurants until the community gets a better handle on the spread of infection.

SHORT-TERM SACRIFICES

Dr. RYAN HUERTO, Family Medicine Physician, Health Services Researcher and Clinical Lecturer, University of Michigan

No. While I understand many factors contribute to indoor dining. such as the mental health toll of social isolation, the opportunity to support small businesses and cold weather, I strongly recommend against indoor dining.

The risk of contracting COVID-19 from indoor activities is far greater than from physically distanced outdoor activities. The recent spike in COVID-19 infections, deaths and ICU bed shortages is likely linked to indoor gatherings during Thanksgiving.

On Dec. 22, 201,674 infections and 3,239 deaths due to COVID-19 were reported. This death toll is equivalent to approximately 20 Boeing 737 aircrafts crashing in a

approved, staying home, physically distancing, wearing a mask and good hand hygiene are as important as ever. Think of these as shortterm sacrifices to help protect your friends, family, neighbors and essential workers.

RESTAURANTS POSE BIG RISK

KATHLEEN C. BROWN, Associate Professor of Practice and MPH Program Director, College of Education, Health, and Human Sciences, University of Tennessee

No. The Centers for Disease Control and Prevention reported that patients testing positive were twice as likely to have eaten in a restaurant than those testing negative in the 14 days preceding their test. I regularly get takeout but do not eat in restaurants.

What I cannot control poses a risk. I have very open and honest conversations with family and friends about where we have been and who we have been with. From there, our risk is pretty clear but still not at zero. The more people I come into contact with, the greater the risk.

In a restaurant, I am not able to assess the risk posed by other patrons or the staff. Each person in that restaurant has a network of others that, taken together, increases my risk of contracting COVID-19. Currently, Tennessee, where I live, is the second-leading state for cases per 100,000, which means community spread is high.

In plain language, that means there is an increased likelihood that I may come into contact with someone who is infectious - symptomatic or not - if I eat inside a restaurant. I will continue to pick up my takeout for

A Brief History of Christmas Pudding - and Why it Can Actually be Quite Good For You

rven in these hard and strange times, Christmas vill be celebrated and traditions upheld. And for many British households, Christmas dinner would not be complete without a Christmas pudding - traditionally served with brandy sauce, brandy butter or custard.

The Christmas pudding originated in the 14thcentury as a sort of porridge, originally known as "frumenty", which bears little resemblance to the dessert we know today.

It was originally made with hulled wheat, boiled in milk, seasoned with cinnamon and coloured with saffron. It was associated with meatless days, lent and advent and was often served as a plain dish. But there are a variety of recipes which included additions such as beef, mutton, raisins, currants, prunes, wines and spices.

In some instances, this was the staple food for Christmas eve, although in Yorkshire it was eaten first thing on Christmas morning. In the 17th-century changes to the recipe were made. It was thickened with eggs, breadcrumbs, dried fruit and beer or spirits were added - and came to resemble something a bit more like a sweet pudding. However, it was the Victorians who fine tuned the recipe into the Christmas pudding many of us enjoy today.

A Christmas pudding should have 13 ingredients - that represent Jesus and the 12 disciples. Traditionally, these ingredients include: raisins, currants, suet, brown sugar, breadcrumbs, citron, lemon peel, orange peel, flour, mixed spices, eggs, milk and brandy. Brandy is also traditionally poured over the pudding and set alight. The flaming brandy is said to represent the passion of

Christmas puddings were traditionally boiled in a "pudding cloth", although today are usually steamed in a bowl. Presented on the table with a sprig of holly, they are then doused in brandy and

The last Sunday before Advent became known as "stir up Sunday". This was when the ingredients of the pudding would be assembled and stirred up in a bowl with a wooden spoon (representing the manger) from east to west - symbolising the journey taken by the three wise men. Traditionally, every family member stirs the pudding three times and makes a secret wish.

Trinkets were always included in the



excitement of waiting to see who was going to find the sixpence. Whoever found the coin was believed to have good fortune over the coming year.

A HEALTHY PUD?

Although the Christmas holidays can sometimes feel a little unhealthy - with a lot of sitting around and excessive food consumption the ingredients that makeup a Christmas pudding are actually pretty nutritious.

Traditional Christmas puddings consists of fibre rich ingredients, such as fruits, nuts and currants. Dried fruits are rich in fibre, enzymes, polyphenols (substances with a high antioxidant activity), vitamins and minerals. Sultanas, currants, apricots and pears are highly nutritious and packed with essential potassium and iron. And although dried fruits can contain a lot of sugar, they have a lower glycemic index value so don't impact your blood sugar in the same way as other sweet treats.

Raisins are also rich in antimicrobial compounds, fibre and iron. These compounds lower the risk of heart disease and can relieve constipation. Prunes too can also aid with digestion, relieve constipation, reduce inflammation and protect cells from free radical damage.

Walnuts, hazelnuts, pecans and almonds can also be added into the mix and these all come with a range of health benefits - from lowering cholesterol levels and reducing heart disease risk to delivering high levels of vitamin E, polyphenols and melatonin.

The mixed spices, cinnamon, ginger, cloves, pimentos (or all spice) in a Christmas pudding are also an incredible source of aromatic antioxidants. Spices aid digestion and have anti-inflammatory and anti-bacterial properties. They can supposedly

even help to reduce bloating, cramps and nausea -

There is one secret ingredient often overlooked but included in many recipes - the carrot. Rich in beta-carotene, which the body utilises to produce Vitamin A, carrots are good for lowering cholesterol levels and, yes, for the health of your

A GLOBAL TRADITION

Although a British tradition, the Christmas pudding is eaten in various countries including Australia and South Africa. The Canadians also have a version which includes potatoes alongside the carrots.

The Christmas pudding even makes its way into literature, with Charles Dickens' Christmas Carol making reference to it. Then there is the case for Agatha Christie's Hercule Poirot to solve in which he is advised to avoid the plum pudding - another name for the Christmas pud.

One well known fact about the Christmas pudding is that there always seems to be some left over after Christmas day. In fact Christmas puddings of the past could last up to a year, so it was often shared out. Indeed, in 1885 a British newspaper reported the joyful consumption of a plum pudding - sent overland via special envoy from Tehran — to a group of British soldiers stationed in northwestern Afghanistan.

If you don't fancy posting a pudding there are a number of ways you can share and use the leftovers - with a whole host of recipes from Christmas strudel to a black pudding breakfast replacement. Another firm favourite is Christmas pudding icecream - simply mix pudding with vanilla ice cream and enjoy!

I-T dept detects black income of Rs 100 crore after raids on contractors in Assam

New Delhi, Dec 26 Unaccounted income of Rs 100 crore been detected after the income tax department raided three "leading" contractors of Northeast India based in Assam early this week, the CBDT said on Saturday.

The search and survey action was initiated on December 22 at fourteen locations in Guwahati, Silapathar and Pathsala in Assam and in Delhi.

"Cash of Rs 2.95 crore has been seized. Overall, undisclosed income to the tune of approximately Rs 100 crore has been unearthed so far during the search and survey operation," the Board said in a statement without sharing the identities of those raided.

added that "jewellery of Rs 9.79 lakh has been seized and the sources of acquisition of some other jewellery worth Rs 2 crore is under



verification."

The entities covered are "leading contractors of Northeast and one group is also involved in the hospitality business," it said.

The Board said a number of suspect cash transactions have been detected.

"It has been gathered the during search action that one of the groups engages in huge cash transactions in hospitality business of proportions as high as 50 per cent, which is under examination."

"Some of the entities of the groups engage in purchases of jewellery in cash. The source of the cash purchases are under examination," it said.

Assam's new Bhakti Movement will stamp out armed movements, says Amit Shah

GUWAHATI, 26 DEC [NDTV]: Union Home Minister Amit Shah today promised social transformation villages in Assam's by reviving a Bhakti movement there so that young people do not take up arms. Towards this, he said, the government was extending a financial assistance of Rs2.5 lakh each to 8,000 "Namghars", the state's traditional Vaishnavite monasteries, that are over 50 years old

"There was a time when separatists ruled the roost. The youth were given arms. Now all the groups have joined the mainstream and Assam has become part of the growth engine. The biggest success was the Bodoland accords. I am proud that in the recent Bodoland election, 80 per cent polling took place without a single case of bloodshed," Mr Shah said today at a public rally in Amingaon, Kamrup district.

"The Bodoland election...was only a semi-final. Now the final is ahead. In the Assam polls, we will have full majority. The Sonowal-Himanta combination has worked wonders for Assam," he said referring to the state legislative polls scheduled for April 2021.

Не sought evoke 16th-century Assamese cultural icon Srimanta Sankaradeva to recall the richness of the state's culture and history, which, he said, will give it a new beginning. He excoriated previous governments and leaders, including former Prime Minister Manmohan Singh, for not working on the state's development.

Drumchapel United: helping Glasgow children cope with Covid life

EWAN MURRAY LONDON. [THEGUARDIAN]: Drumchapel United did not need a pandemic accentuate their commitment greater good. Slowly but surely this club in one of Glasgow's most deprived areas had been emphasising that the idea of football being intrinsic to a community need not be antiquated.

Drumchapel has needed positive reference point. Deprivation and life expectancy rates are among the worst in Scotland. The situation looks even more acute when compared with nearby Bearsden and Milngavie, both highly affluent areas.

"It is a place that will always have a stigma," admits Scott Bland, United's Drumchapel secretary. "I'm supposed to live five or six years less than people who are just round the corner from me. We live with these things. For the club, it is about putting down a marker where people throughout Scotland know Drumchapel as a really good club. We might have these poverty stats but it's not about that, it's about people. We are trying to promote our people."

Before Covid struck, Drumchapel had been given a Queen's award in recognition of voluntary work. However, a visit to Holyrood Palace and a civic reception in Glasgow city chambers have had to wait. Bland rather swats off such occasions; nice to attend, but not really the point.

Under the club's operation sit 31 teams - male and female, from under-nines to over-35s - and 136 volunteer coaches. "I think the community is really excited about what the club is doing," adds Bland. "There's a real bond and desire to put across a positive message for Drumchapel.

"There are 9,000-10,000 people Drumchapel. We have were 600-plus players and 136

volunteer coaches. So a strong percentage of the population are involved, playing, coaching, coming to support the teams or being involved in fundraising nights. Everybody in community knows our club and we are probably the biggest volunteer organisation in Glasgow when you consider those coaching numbers and an executive board of 13 people."

This, however, has been a year like no other. Bland and his committee members soon realised that essential services they provide had to be tailored as youngsters, many of them vulnerable in different ways, were banned for months on end from playing football.

"The initial challenge came in how quickly it all happened," says Bland. "I remember taking training on a Monday night and by the Tuesday everything had to stop. We have so many teams, so many coaches and people relying on our role in the community. It might be all some kids have during the week so we suddenly had to think about how we supported

"Initially it was very difficult because we hadn't been through this challenge before and had no idea what it looked like. We had umpteen meetings inside the first two weeks to look at how we dealt with things, but really we thought at that stage it would just be a couple of months and we would be back to normal. We had a plan, which really was all about continuing to support the young people and the community despite the situation we were in.

"The coaches had calls set up once a week for all the teams, even if that just meant some fun challenges; find your favourite player, come back next week and tell us who and why, that is sort of thing. We just tried to keep them engaged on focused on something."

wellbeing packs and packed lunches as many would rely on even in normal times. Mental health and wellbeing schemes were delivered, as was shopping trips for those in Drumchapel as were forced to shield and could not buy for

themselves. "That's what the club is about, it isn't about that big green pitch all the time," says Bland. "It is hard work but a lot of people relied on that. Our volunteers are from the community so they know what it all means; the don't mind that extra hour to knock on somebody's door or put a hygiene pack together. We don't get round everybody but we try

help as many as you can." There has also been time to draw breath. The community asset transfer of the Donald Dewar Centre, where teams play, to the club was allowed continue in the background. Drumchapel have plans for their West of Scotland men's team progress through Scottish football's packed pyramid; footpaths alongside the pitches as friendly games restarted bely any notion this operation isn't big enough to play in the professional leagues.

The club's academy teams are now full with parents apparently even more keen than normal see their children enjoy exercise. More than £3,000 has been needed to fund Covid signage and paperwork but, more pertinently, coaches have needed to be aware of wider fears.

"We saw a lot of girls [more than 100 play at the club] especially when they came back to training who were anxious, they wanted to talk about coronavirus and everything the virus affects, especially with the schools going back," explains Bland. "'I'm going into high school, there's going to be 1,000 people there, how am I going to cope with that?' The coaches had to be very good at talking

through all those issues.

We have kids with mental

health issues - anxiety,

depression - so we had

to be there for them."

Wider appreciation has arrived about the club's outstanding contribution. "I know I'm not the only person gets annoved when Drumchapel is mentioned and the term 'socially deprived' has to be attached," says Bill Kidd, the local member of the Scottish Parliament. "It's certainly a fact that 'the Drum' has genuine issues of poverty still to be overcome and that has to be a priority. At the same time, organisations like Drumchapel United have shown that a place for sport for all age groups is important during these difficult times.

Soon, Drumchapel United will return to what had become standard elements of their year. Christmas toy drops, clean-ups community and care facility visits by teams were routine long before coronavirus was part of our narrative. As soon as it was, the club stepped forward.

MCG may witness spectator surge if 3rd Test is shifted from Sydney

Melbourne, Dec 26 (PTI): If the third Test between India and Australia shifts to Melbourne because of stringent COVID-19 restrictions in Sydney, the MCG will consider allowing more than the currently permitted 30,000 spectators here, the ground's president Stuart Fox said on Saturday.

Uncertainty looms over the New Year's Test being held at the SCG from January 7 because of stricter quarantine rules set by Queensland, the host of the fourth Test, for people arriving from Sydney due to the surge in COVID-19 cases there. MCG is hosting the second Test right now and has capped the spectator count at 30,000.

India are set to play their fourth and final Test in Brisbane from January 15 and current health protocols would require the touring side to undergo quarantine if they play the third Test at the SCG.

"I would love it but we have to go do what's right for the community. If it's confirmed the MCG is hosting it, we go back to the government and re-submit another plan and they will have a look at it," Fox was quoted as saying by the 'Sydney Morning Herald' when asked if the permissable crowd numbers could



surge if the match is held

in Melbourne. "It's more important

we get this one away safely and then we will reassess after that," Fox said.

While Fox said that the MCG will be ready if required, he would ideally like SCG to host the Test match.

"Yes we can, we are ready to go but, I have said all along, we really do hope it can stay in Sydney. It's a really, really special Test," he said.

SEOUL, DEC 26 (AP): South Korea had seemed to be winning the fight against the coronavirus: Quickly ramping up its testing, contacttracing and quarantine efforts paid off when it weathered an early without economic pain of a lockdown. But a deadly resurgence has reached new heights during Christmas week, prompting soulsearching on how the nation sleepwalked into a crisis.

The 1,241 infections on Christmas Day were the largest daily increase. Another 1,132 cases were reported Saturday, bringing South Korea's caseload to 55,902.

Over 15,000 were added in the last 15 days alone. An additional 221 fatalities over the same period, the deadliest stretch, took the death toll to 793.

numbers keep rising, the shock to people's livelihoods is deepening and public confidence in eroding. government Officials could decide to increase social distancing measures to maximum levels on Sunday, after resisting for weeks.

Tighter restrictions could be inevitable because transmissions have been outpacing efforts to expand hospital

capacities. In the greater Seoul more facilities area, have been designated for COVID-19 treatment and dozens of general hospitals have been ordered to allocate more ICUs for virus patients. Hundreds of troops have been deployed to help with contract tracing.

At least four patients have died at their homes or long-term care facilities while waiting for admission this month, said Kwak Jin, an official at the Korea Disease Control and Prevention Agency. The agency said 299 among 16,577 active patients were in serious or critical condition.

Our hospital system isn't going to collapse, but the crush in COVID-19 patients has significantly hampered our response, said Choi Won Suk, an infectious disease professor at the Korea University Ansan Hospital, west of Seoul.

Choi said the government should have done more to prepare hospitals for a winter

The quiet streets and long lines snaking around testing stations in Seoul, which are temporarily providing free tests to anyone regardless of whether they have symptoms or clear reasons to suspect infections, demonstrate a return of public alertness following months pandemic fatigue.

Officials are also down clamping private social gatherings through Jan. 3, shutting ski resorts, down prohibiting hotels from selling more than half of their rooms and setting fines for restaurants if they accept groups of five or more people.

Still. lowering transmissions to the levels seen in early November 100 to 200 a day would be unrealistic, Jung said, anticipating the daily figure to settle around 300 to 500 cases.

The higher baseline necessitate might tightened social distancing until vaccines roll out a dreadful outlook for low-income workers and the selfemployed who drive the country's service sector, the part of the economy the virus has damaged

The government should do whatever secure enough supplies and move up the administration of vaccines to the earliest possible point, Jung said.

South Korea plans

to secure around 86 million doses of vaccines next year, which would be enough to cover 46 million people in a population of 51 million. The first supplies, which will be AstraZeneca vaccines produced by a local manufacturing partner, are expected to be delivered in February and March. Officials plan to complete vaccinating 60% to 70% of the population by around November.

Black doctor dies of COVID after racist treatment complaints

INDIANAPOLIS (AP): A Black doctor who died battling COVID-19 complained of racist medical care in widely shared social media posts days before her death, prompting an Indiana hospital system to promise a "full external review" into her treatment.

Dr. Susan Moore, 52, tested positive for COVID-19 late last month and was admitted to IU Health North Hospital in Carmel, Indiana, according to a Facebook post. Acutely of her condition and medical procedures, the physician said had to repeatedly ask for medication, scans and routine checks while admitted at a hospital in Carmel, Indiana. She noted a white doctor in particular who seemingly dismissed her pain and said she didn't trust the hospital.

"I put forth and maintain, if I was white, I wouldn't have to go through that," she says in a Dec. 4 video, her voice often cracking. "This is how Black people get killed, when you send them home, and they don't know how to fight for themselves."

She was released from the hospital run by Indiana University Health System on Dec. 7, but was again hospitalized 12 hours later when her temperature spiked and her blood pressure dropped, according to her post. She was taken to a different hospital, Ascencion St. Vincent in Carmel, and said she was experiencing better care.

Still, her condition worsened and she was put on a ventilator. She died Dec. 20, her 19-year-old son Henry Muhammad told news outlets. A listed number for Muhammad could not be located Friday. Messages left by The Associated Press for two family spokespeople weren't immediately

returned Friday. The coronavirus has disproportionately affected Black people, who suffer from higher rates of obesity, diabetes asthma, making them more susceptible the virus. Black Americans are also more vulnerable because of systemic racism, inequity in health care access and economic opportunity.

Many Black Americans report that medical professionals ailments seriously when they seek treatment.

Moore grew up in Michigan, where she earned a medical degree at the University of Michigan in 2002. She had an active medical license in Indiana at the time of her death, according to MLive.com.

Muhammad told The New York Times that his mother had often frequently experienced inferior medical care. She had an inflammatory disease called sarcoidosis that attacks the lungs and was often treated for her condition.

"Nearly every time she went to the hospital she had to advocate for herself, fight for something in some way,

shape or form, just to get baseline, proper care," he told the newspaper.

Murphy, Dennis the president and CEO of Indiana University Health, said Thursday he was saddened by Moore's death. He said he did not believe the medical team "failed the technical aspects" of Moore's care after a preliminary medical quality review but "may not have shown the level of compassion and respect we strive for in understanding what matters most to patients."

"I am asking for an external review of this case. We will have a diverse panel of healthcare and diversity experts conduct a thorough medical review of Dr. Moore's concerns to address any potential treatment bias," he said in a statement.

In the past year, public health experts nationwide acknowledged the role racism plays in health care with dozens of cities, counties and states declaring racism a public health threat. While public health experts have called it a first step, many are skeptical.

Muhammad, who said his mother was his best friend and a very caring person, didn't get the chance to say goodbye before she died.

"I am outraged beyond words ... because if what my mom thinks was true and that it was racism, and they neglected her because of that, nobody should go through that," he told ABC News.

Downtown Nashville explosion knocks communications offline on our community was

NASHVILLE, TENN. (AP): A recreational vehicle parked in the deserted streets of downtown Nashville exploded early Christmas morning, causing widespread communications outages that took down police emergency systems and grounded holiday travel at the city's airport.

Police responding to a report of shots fired Friday when they encountered the RV blaring a recorded warning that a bomb would detonate in 15 minutes, Metro Nashville Police Chief John Drake said. Police evacuated nearby buildings and called in the bomb squad. The RV exploded shortly

afterward, Drake said. "This morning's attack intended to create chaos and fear in this season of peace and hope. But Nashvillians have proven time and time again that the spirit of our city cannot be broken," Mayor John Cooper said at a news conference after issuing a curfew for the area. Police believe the

blast was intentional but don't yet know a motive or target, and Drake noted that officials had not received any threats before the explosion.

The chief investigators at the scene "have found tissue that we believe could be remains, but we'll have that examined and let you know at that time." Police could not say whether it potentially came from

someone inside the RV.

Three people taken to area hospitals for treatment were in stable condition Friday evening, Cooper said.

Surveillance video published on a Twitter account Friday that appeared to be across the street from the blast captured the warning issuing from the RV, "... if you can hear this message, evacuate now," seconds before the explosion. The blast sent black

smoke and flames billowing from the heart of downtown Nashville's tourist scene, an area packed with honkytonks, restaurants and shops. Buildings shook and windows shattered streets away from the explosion near a building

owned by AT&T that lies one block from the company's office tower, a landmark in downtown.

"We do not know if that was a coincidence, or if that was the intention," police spokesman Don Aaron said. He said earlier that some people were taken to the department's central precinct for questioning but declined to give details.


AT&T said the affected building is the central office of a telephone exchange, with network equipment in it. The blast interrupted service, but the company declined to say how widespread outages were.

The AT&T outages site showed service issues in middle Tennessee and Kentucky. Several police agencies reported that their 911 systems were down because of the outage, including Knox County, home to Knoxville about 180 miles (290 kilometers) east of Nashville.

AT&T said that it was bringing in portable cell sites and was working with law enforcement to get access to make repairs to its equipment. The company noted that "power is essential to restoring" service.

The Federal Aviation Administration temporarily halted flights out of Nashville International Airport because of telecommunications issues associated with the explosion

Leslie West, guitarist of rock band Mountain, has died at 75

LOS ANGELES (AP): Leslie West, an iconic guitarist-vocalist who was behind several '70s rock anthems including "Mississippi Queen" with the popular band Mountain, has died. He was 75.

His spokesman Steve Karas said West died Wednesday in Palm Coast, Florida. Karas said West died from cardiac arrest after being rushed to the hospital.

West battled with health issues in the past few years. In 2011, his lower right leg was amputated in a life-saving operation related to his diabetes.

Rockers like Gene Simmons and Slash showed support for West on social media a day before his death when it was clear he was in dire condition. Paul Stanley called West a "gentle man and guitar hero" on Twitter.

West began his music career in the mid-60s with The Vagrants with his brother Larry West Weinstein, who played bass. The band known as a blue-eyed soul group had a minor hit with "I Can't Make a Friend" and covered Otis Redding's "Respect" in 1967.

West stepped out on his own with a solo career, releasing the 1969 album "Mountain," which was produced by Felix Pappalardi. West and Pappalardi ended up starting the hard rock band Mountain, which was named after West's debut solo album.

In 1969, Mountain performed an 11-song set at Woodstock before the Grateful Dead. A year later, the band released their biggest hit "Mississippi Queen," which appeared on numerous movie and TV soundtracks along with video games including Guitar Hero. The song was covered by several artists such as



Ozzy Osbourne, W.A.S.P. and Bachman-Turner Overdrive.

Mountain's song "Long Red" became popular among multiple hip-hop artists including Jay-Z, Kanye West and Nas, who sampled the single. "Theme From An Imaginary Western" was another of the band's notable songs.

During a Mountain hiatus, West formed the group West, Bruce and Laing along with Cream bassist Jack Bruce and Mountain drummer Corky Laing.

West appeared in films such as "Family Honor" and "Money Pit." He was a regular guest on the Howard Stern Show. The musician was inducted into the Long Island Music Hall of Fame in 2006.

West is survived by his wife, Jenni, whom he married on stage after Mountain's performance at the Woodstock 40th anniversary concert in Bethel, New York in 2009.
