Sunday pause for Sikkim - Only 10 new cases against 26 recoveries

SAGAR CHHETRI GANGTOK, 27 JUL:

Ten new cases of COVID-19 were reported on Monday even as 26 patients made full recoveries and were discharged from hospital, bringing the number of active COVID cases here down to 380. There were 397 active cases in Sikkim yesterday.

The total number of COVID cases detected in Sikkim so far is 555 of whom a total of 174 have beaten the virus and recovered.

In his daily health bulletin on Monday, Health Department DG-cum-Secretary, Dr Pempa T Bhutia informed that five new cases were detected through RT-PCR testing of 363 samples yesterday at VRD Lab in STNM hospital.

Out of these five, four are primary contacts of the patient from Arithang and the fifth is a lady from Sichev whose mother had tested positive at Chanatar, Rangpo and is already in hospital.

Meanwhile, all 50 samples tested by TrueNat yesterday returned negative.

While giving break-up of rapid antigen testing on Sunday, Dr Bhutia mentioned that RAT of all six samples at Rongli PHC returned negative. They were family members of the patient who succumbed to COVID-19 yesterday.

He further added that one sample at Pakyong and two samples at Duga tested negative during RAT. Likewise, 11 samples were tested by RAT at Rangpo yesterday in which one returnee detected positive out of six and four more contacts tested positive, he informed.

India's COVID-19 tally crosses 14-lakh mark with record single-day spike of 49,931 cases



NEW DELHI, JUL 27 (PTI): With a record single-day jump of 49,931 COVID-19 cases, India's caseload climbed to 14,35,453 on Monday, while recoveries surged to 9,17,567, according to the Union Health Ministry data

The country's death toll rose to 32,771 with 708 fatalities being recorded in a day, the data updated at 8 am showed

There are 4,85,114 active cases of coronavirus infection in the country, while 9,17,567 patients have recovered and one person has migrated

The recovery rate stands at 63.92 per cent, according to the data

The total number of confirmed cases also

includes foreigners

This is the fifth consecutive day when COVID-19 cases have increased by more than 45,000

According to the Indian Council of Medical Research (ICMR), a total of 1,68,06,803 samples have been tested up to July 26, with 5,15,472 samples being tested on Sunday.

Injured Lineman tests positive at CRH emergency ward,

WhatsApp university peddles panic

SUMMIT REPORT GANGTOK, 27 JUL:

Lineman injured in the line of duty at Timburbong,

MWest Sikkim, was rushed to the emergency ward of the Central Referral Hospital at around 4AM Monday morning. Following prescribed COVID-19 protocol since he was brought in from a containment zone, he was screened for Novel Coronavirus and the Rapid Antigen Test returned positive. He was then shifted to the COVID-19 Wing at STNM Hospital.

WhatsApp warriors picked up this information and people woke up to various versions of this incident, all of which warned people against going to CRH even in the event of a medical emergency since the facility was "infected." This is dangerous advice, as was also attested by the CRH

management, which has stressed that anyone who needs emergency medical attention "should seek medical help because not doing so could be more harmful to critical patients needing immediate medical interventions."

"We would also request the public not to panic and follow COVID-19 safety measures diligently," an official communiqué from CRH states.

The release goes on to inform that in the process of initial management of the patient in the Emergency Room and the subsequent shifting of the patient to STNM Hospital, the staffs present at the Emergency Room were exposed and have been shifted to isolation. The facility has been sanitized.

"The Management of CRH would like to inform the general public that the Hospital is fully functional and

not sealed, contrary to the fake news making rounds in the several media platforms. Our OPDs and other departments are open and receiving and treating patients," the release issued by Sikkim Manipal University, PRO, Sarikah Atreya, informs.

The release adds, "The Management would also like to reassure the general public that CRH has been and will continue to serve the people of Sikkim at this hour of crisis, by performing all duties as a Non COVID-19 Health Care centre and will not put anyone at undue risk."

Meanwhile, the DC-West, has informed that all contacts of the Lineman at Timburbong and from there onwards to Jorethang PHC and the journey to Gangtok have been traced and isolated and some even tested through RAT [in which they returned Negative].

Govt okays home quarantine for asymptomatic COVID cases

SUMMIT REPORT GANGTOK, 27 JUL:

The "high-level" **▲** meeting chaired by Chief Minister PS Tamang today has decided that asymptomatic COVID-19 patients "may" be placed in home quarantine.

The meeting, which was also attended by the CM's Cabinet colleagues and senior government officers, agreed on this "in view of the increase in number of cases" in Sikkim. The State currently has 380 active cases, actually 17 fewer than it did on Saturday.

Be that as it may, the meeting also decided that the technical committee of the Health Department "may" issue Standard Operating Procedure in this regard.

Interestingly, also today, the SDM-Soreng directed the SHO, Soreng "immediately" register an FIR against four residents of Mangsari who had been sent to Home they were primary secondary contacts of a COVIDperson

from Budang but had attended a paddy planting ceremony when they should have been quarantined.

Meanwhile, the highlevel committee also decided that drivers and helpers of trucks carrying essential commodities and coming from Siliguri to be changed upon arrival at Rangpo. This will essentially mean having two teams of drivers/helpers on either side of the border.

For marriages, funerals, etc, permission will have to be taken from the concerned DC.

One time movement of GREF workers in Rongli, who have completed their quarantine period, to be allowed to enable them to reach their work sites.

Movement of workers in border areas may be allowed if the DCs are satisfied that all safety measures are being followed.

One time movement Quarantine because of Pharma workers stranded in different districts will be allowed with prior clearance from the concerned DC.

Order, DIG Range, and senior officers of the State administration. Chief Secretary, S.C. Gupta in his opening remarks presented a brief overview of the status of COVID-19 in the State. He also briefed about the second Notification issued on 26th July with regard to extension of lockdown, taking

The Chief Secretary apprised that the State is also facing monsoon woes due to incessant rainfall and the government is trying to restore the situation so that least hurdles and headships are being faced by

into account the prevailing situation in the

the people. The State administration has also pulled manpower (safaikarmacharis and office attendants) from various departments to augment the manpower in the Health Department.

During the meeting, contact tracing, testing and preventive measures of COVID-19 along with post lockdown scenario after 1st August was also discussed at length.

The Chief Minister in his address informed about the State Government's effective coordination to tackle the present situation. He pointed out in detail about the menace of fake news being circulated in social media which is adding to the already existing challenge. He stressed on the need to disseminate correct and factual information through credible source and all news or information in any form should be verified and thoroughly checked with concerned department before posting and uploading.

He further said that if anybody is found to be spreading fake news on social media, electronic media, or in any form, Government will take stringent action.



the need to consistently follow basic guidelines by everyone and added that the sudden surge of positive cases in the State is due to the gross violation of lockdown norms, despite repeated appeal from the State Government. He directed the Police to strictly initiate action against those who are found violating the lockdown

The Chief Minister also stressed on guidelines. The proper health guidelines should be enforced and implemented in letter and spirit.

The Chief Minister maintained that post 1st August, there could be slight relaxation to facilitate certain activities. He urged everyone to continue to abide by all safety norms.

It was also informed that a State Level

Steering Committee to be constituted in the State for manpower management and keeping in view both present and future requirements in all districts.

In the meeting, it was informed that if any person came in contact with COVID-19 positive cases, they should immediately contact the toll free State helpline number 104. The Chief Minister stressed that the Helpline Number should be adequately publicized as a potential medium to aid in contact tracing.

The meeting also took stock of the arrangements in place for operation of OPD services in Old STNM hospital as a makeshift facility to provide basic healthcare. Issues concerning supply of medicines and consumables in various hospitals, CHCs, PHCs, and PHSCs were also discussed in detail.

The Chief Minister also directed the State administration to immediately address the shortage of manpower in Health Department and make it fully equipped. There should not be dearth of manpower and medicines in the hospitals across the State, he stated.

Containment zones in Namchi sanitized



Following reports of COVID-19 being detected in Namchi and subsequent containment zones of the said area on 25 July, the Administration thorough ordered sanitization to prevent further spread of the disease in Mirage building and its surrounding areas today.

The area located in Namchi bazaar was also sanitized as per said safety hygiene protocol keeping in view the instance of positive case in the area a few days earlier.

ED books Sanjay Bhandari in fresh money laundering case

NEW DELHI, JUL 27 **(PTI):** The Enforcement Directorate has filed a money laundering case absconding against defence consultant Sanjay Bhandari to probe kickbacks worth USD 4.99 million allegedly received by him from South Korean major Samsung Engineering Co Ltd (SECL) in 2009, officials said on Monday.

Bhandari's firm was paid by SECL, in violation of rules, to influence government officials in awarding a Rs 6,744-crore contract for setting up a Dual Feed Cracker Unit in Gujarat to OPaL, a company promoted by some oil PSUs, including ONGC, they said.

OPaL, in turn. awarded the contract of the project to a consortium of SECL and Germany's Linde for Rs 6875.11 crore, they said.

They said the central probe agency has filed an Enforcement Case Information Report (ECIR), equivalent to a police FIR, under the Prevention of Money Laundering Act (PMLA) to probe these dealings.

The agency took cognisance of a CBI FIR filed early this month against Bhandari and others in the case, they

This is the second laundering money case against Bhandari he was booked the Enforcement Directorate (ED) for possession alleged of undisclosed assets abroad and other charges in February, 2017.

A charge sheet was filed by the ED in this case in Iune.

The central probe agency said Bhandari had and had run away from the country and was last stated to be in the UK or a nearby country.

In the latest case, the CBI has charged Bhandari for allegedly receiving kickbacks worth USD 4.99 million from SECL in 2009 to influence government officials in awarding the Rs 6,744-crore contract to ONGC Petro Additions Ltd (OPaL), a company promoted by like ONGC, GAIL and Gujarat State Petroleum Corporation.

The allegation is that the Dual Feed Cracker Unit (DFCU), the CBI had said, which was to be set up at Dahej Petrochemical Complex in Gujarat, was awarded in favour of SECL in 2009 and advance payments were released to it from ONGC in contravention Vigilance Central Commission (CVC) guidelines.

In its FIR, the CBI has also named the then Senior Manager of SECL Hong Namkoong, **UK-based** Foster Wheeler Energy Ltd, and Bhandari's UAEbased company Santech International officials of ONGC and OPaL, for alleged corruption in the award of the contract.

The tender for the DFCU project was floated on April 20, 2007 for which two consortiums -- Germany's Linde and Korean SECL, and USAbased Shaw Stone and Webster and Indian Larsen & Toubro -submitted their bids.

Linde and SECL consortium won the contract at their quoted "lump price of Rs 6875.11 not cooperated with it in crore" on the basis the probe in the first case of higher Net Present

Value (NPV)

NPV of Linde and SECL was calculated to be around Rs 4,160 crore while that of Shawstone and Webster and L&T around Rs 3,918 crore.

The tender committee came to the conclusion that NPV of Linde and SECL was higher and lump sum prices were 7.75 per cent lower than the competing consortium.

The other consortium challenged the decision but the objection was turned down and the contract was awarded to Linde and SECL consortium for a lump sum price of over Rs 6,744 crore on February 10, 2009.

The agreement signed between the consortium and ONGC OPaL had an integrity pact which said no agent or consultant was to be engaged and no commission or fee could be paid against the contract in India or abroad, the CBI had said.

The CAG had also raised objections to it and the project was not completed even two years after the deadline of August 2012.

The CBI has alleged that Bhandari in its Income Tax returns did not disclose maintenance of foreign bank accounts in the name of Santech International and also the receipt of USD 4.99 million.

Bhandari's case first came to light after the Income Tax department conducted searches against him in April, 2016 and recovered certain "sensitive" official defence documents from his premises.

The tax department had booked him under criminal charges of the anti-black money law.

Eight get life term for murder in Jammu

JAMMU, JUL 27 (PTI): A court on Monday sentenced eight people to life imprisonment after holding them guilty of attacking and killing a man over a property dispute in Kanachak border belt in Jammu district in 2006, officials said.

The court of Additional Sessions Judge, Jammu, convicted 10 accused in the case and slapped a fine of Rs 10,000 on each.

While Ramesh Singh, Tilak Raj, Suram Singh, Bhalwan Singh, Raghubir Singh, Mangal Singh alias Manga, Manoj Lal and Tilak Raj got life term, Bharat Bushan and Naresh Kumar were sentenced to two-year jail term, the officials

at Kanachak police station. According to the complaint, the accused had an enmity with Bodh Raj over some land, following which they attacked him at his home. was dragged and again attacked by the accused, leaving him critically injured. They, however, fled the spot after the alarm was raised.

Punjab farmers hold protest against Centre's ordinances

CHANDIGARH, JUL (PTI): Growers, representing 13 farmers' outfits in Punjab, held a state-wide protest against three ordinances of the Centre on Monday. The agitating farmers took out protest marches at several places in the state, including Ludhiana, Moga, Muktsar, Phagwara and Hoshiarpur, to express their anger.

They were protesting against the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Ordinance. **Farmers** (Empowerment Protection) Agreement on Price Assurance and Farm Services Ordinance, and the Essential Commodities (Amendment) Ordinance.

The farmers moved towards the residences or offices of the leaders of the Shiromani Akali Dal and the BJP in their tractors to protest against the ordinances.

Adequate numbers of police personnel were deployed in view of the Industry Som Parkash.

farmers' state-wide protest, officials said.

Thirteen farmers' outfits, including All India Kisan Sangharsh Coordination Committee, Bhartiya Kisan Union (Ekta Ugarhan), BKU (Krantikari) and BKU (Sidhuwal), joined hands to launch the protest.

The Centre trying to destroy the farming sector with the implementation of these three ordinances, said a protesting farmer in Muktsar.

Farmers slammed leaders of the SAD for supporting these ordinances.

The apprehension of the farming community against these ordinances was the dismantling of the minimum support system foodgrain procurement.

In Phagwara, farmers in around 500 tractors moved from the grain market to the residence of Union minister of state for Commerce and

They put up black flags and anti-ordinances banners on tractors.

The protest threw road traffic out of gear the Hoshiarpur-Phagwara road later the protesters were stopped by police at some distance from Parkash's residence.

They held rallies at grain market and on the main road of Urban Estate, a few furlongs away from the residence of the minister.

Manjit Singh Rai, President BKU (Doaba), alleged that these ordinances would pave way for the entry corporates into agriculture activities, forcing small farmers out of their ancestral profession.

They also alleged that the minimum support price (MSP) of crops would be withdrawn, leaving farmers at the mercy of private players.

Satnam Singh Sahni, General Secretary Doaba Kisan Union urged Punjab Chief Minister

Amarinder Singh to convene an emergency session of the Punjab Vidhan Sabha adopting a unanimous resolution against these

ordinances. Farmers said countrywide protest will be held against these ordinances on August 9.

In Amritsar, farmers also took out a protest from the Company Bagh area to the residence of BJP MP Shwait Malik.

In Ludhiana, farmers warned of intensifying their agitation if the ordinances were not rolled back.

Hoshiarpur, In of farmers' activists outfits took out a protest march from Tanda Chowk to Rahimpur grain market.

They also gave memorandum to the Naib Tehsildar at Rahimpur, demanding withdrawal of the ordinances.

At some places, including Moga, farmers reportedly flouted social distancing norms during the protest.

They also rued that rising diesel prices have raised their input cost.

The protests were held despite Chief Minister Amarinder Singh appealing to the farmers to postpone the agitation against the anti-farmer ordinances in view of the restrictions in place to check the spread of coronavirus.

On July 20, BKU (Lakhowal) and BKU (Rajewal) and some other outfits had staged protests on similar

Battle the Bottle

Booze is a problem that the society ignores at its own peril

The lockdown insanity is upon us; a march of at least a week **I** ahead and a few months in the past, a period in which the only consistent factor apart from a disconnected, entitled administration has been the consistency with which the tipplers have downed their favourite spirits. Yes, liquor shops are shut in the latest lockdown, but if anyone thinks that the regulars are staring at bare bar-cabinets, they are tripping on something which they should prescribe to the rest of State so that everyone can enter the make believe world. Soon, the festive season will also have arrived and although public celebrations will be toned down, expect the coming months to be as much about piety as they will be about excesses, making this the right time to speak about alcoholism. And no, cops at play with breathalyzers, stopping vehicles and inviting drivers to blow into the equipment is not the solution. Hmm.... There was that time as well when one actually had places to go to even late at night, pick up drunk friends wasted at gatherings which carried neither risk of infection or police action. But we digress. Checking DUIs penalizes and keeps the roads and passengers safer, yes, but it does not address the core problem. One could argue about the many levels at which such random stopping [without any apparent reason] for random checks is wrong [inconvenient in the least], but that line of argument will not find many backers in light of the fact that Gangtok roads used to be dangerous after dark with too many inebriated hands behind the wheels. While checking by cops might lead to some challans and avert some accidents, what remains unaddressed is the root problem - alcoholism, a condition which does not surface only on weekends or only at night and is a 24x7 worry for too many families.

The problem of alcoholism is not talked about enough probably because it is substance abuse and HIV/ AIDS which receive funding, leading unfortunately to a situation where this condition is not as widely discussed as the scale of the problem requires. Many people tend to identify alcoholism as a traditional dispensation of the Hill People. This is an illinformed preconception since alcoholism [as a wide-spread problem] could not have debuted in the hills more than half a century back or six decades at the most. Alcoholism really becomes possible with the arrival of the IMFLs [India Made Foreign Liquors] since the local brews required too much work and time to be manufactured in enough quantities to feed alcoholism on a scale that cause the kind of health and social complications which are now possible and common. It is hence wrong to begin any discussion on alcoholism by suggesting that it is a traditional weakness of the Hill People. The communities here might have allowed 'drinking', but that cannot be construed as addictive levels of drinking. The prejudice, however, because it serves so many businesses so well, has been allowed to set in and after it was ignored in the initial years [of IMFLs and other mass distilling units arriving], spread rapidly to ingrain itself in the society.

The damage wreaked by alcoholism cannot be stressed enough and media here should carry forward its success with getting the problem of substance abuse addressed and report more effectively and widely on the abuse of alcohol which is just as impairing. But the local media, when it overlooks the problem of alcoholism in the society, ends up reflecting the social acceptance of this malaise. Sikkim's indifference towards this problem will weigh heavy on its collective conscience some day. Many excuse alcoholism with the argument that the person is earning enough to indulge himself/ herself Substance abuse, because it usually starts at a much younger age, is more scandalous also because of the petty crimes that the addicts invariably resort to finance their addictions. While there is no denying that substance abuse is a serious concern, alcoholism, because not enough seem to be taking it seriously, is even more worrying. Even if one were to keep the emotions aside, the impact alcoholism has on the economy should attract corrective action. Most people turn alcoholic in what should be the most productive years of their lives, both professionally as well as part of a family. When their faculties are compromised, as alcoholism is wont to do, their work suffers as do their families. Indifference towards this problem puts too much at risk because like with all social problems, alcoholism does not affect only the individual but has the entire family suffering. While the younger 'addict' makes the elders of the family suffer guilt pangs, an alcoholic, because in most cases they are working members of the family, end up abusing the family [because they have more 'power' but less control]. This is a social problem and requires the community to step forward and engage proactively in its battle against the bottle. Sadly, in Sikkim, even the war-cry has not been sounded yet...

It's easy to judge. But some people really can't wear a mask

Victoria's chief health officer Brett Sutton said recently there were good reasons why some people can't wear a mask:

A number [...] are legitimately not able to wear masks so please don't vilify individuals or don't make the assumption they are simply stubborn. There will be people with medical, behavioural, psychological reasons [...] certainly don't make an assumption that they should be the subject of your ire.

He commented on the first day wearing a mask in public in Greater Melbourne and Mitchell Shire became mandatory, except for those without a valid reason.

IT'S EASY TO JUMP TO CONCLUSIONS

As wearing a mask in public becomes more common in Australia, either because it's mandatory where you live or because you choose to wear one, it might be tempting to assume people who don't wear masks are irresponsible, misguided

You might also question why you need to wear a mask when others

But some people find wearing a mask difficult or distressing. So, to reduce the risk of inflammatory or inappropriate comments being made, we need to understand some of the reasons why:

autism — some people with autism spectrum disorders find covering the nose and mouth with

feelings of panic, and extreme

disability — some people with a disability can find wearing a mask difficult if they cannot remove one from their face without help. For example, someone with cerebral palsy may not be able to tie the strings or put the elastic loops of a face mask over the ears, due to limited mobility

post-traumatic stress disorder, severe anxiety claustrophobia — people with these conditions can find wearing a mask terrifying and may not be able to stay calm or function while wearing

hearing impairment people who are deaf or hard of hearing, or those who care for or interact with someone who is hearing-impaired, rely on lipreading to communicate. So wearing a face mask can be a challenge

deformities facial physical trauma — may incompatible with wearing a mask.

THERE ARE LEGITIMATE SAFETY CONCERNS

This is not a list of exemptions. Nor should we assume all people who fall into these categories can't wear masks.

In some situations, wearing a face covering may worsen a physical or mental health condition, lead to a medical emergency, or be a significant safety concern.

In the United States and United Kingdom there have been reports

challenged, threatened with arrest, or excluded from retail and food outlets for not wearing a mask.

Conversely, there have been incidents in which anti-mask activists have feigned disability to avoid having to wear a mask in public. This could magnify scepticism and mistrust of people with legitimate, but potentially not officer of the American Lung obvious, reasons for not having to wear a mask.

While there are people who genuinely cannot wear masks, for others, it may just take extra time, resources, adaptions, alternatives and support to feel comfortable wearing one.

That might involve a bit of trial and error before finding a mask that fits well or is made from a comfortable fabric. Others may be able to wear a mask, but for only a short time.

There are online resources with useful tips and strategies to reduce the stress and challenges associated with using a mask or face shield. However, governments also need to ensure these resources are accessible to the people who need them, their family and carers.

BREATHING HOW ABOUT PROBLEMS?

The Victorian government includes people with breathing problems on its list of valid medical exemptions for not wearing a mask in public.

But this is a grey area. We don't have evidence-based guidelines

of people with disabilities being for judging these various medical exemptions. Each country is currently taking a slightly different approach in this area.

In any case, given the types of masks the public are wearing (cloth masks or surgical/face mask), some experts say it's unlikely these masks will cause problems.

For instance, the chief medical Association said recently:

"People with underlying chronic lung disease, such as [chronic obstructive pulmonary disease] or asthma, should be able to wear a non-N95 facial covering without it affecting their oxygen or carbon dioxide levels."

The World Health Organisation also says face masks of breathable material, worn properly, will not lead to oxygen deficiency or carbon dioxide intoxication.

FOR MOST OF US, WEARING A

While we all adjust to wearing masks in public, it is important we try to assume as little as possible about others based on whether they're wearing one.

Remember, the goal of the public wearing a mask when leaving the house is to reduce the risk of community transmission. If we can do that without vilifying people who genuinely can't wear masks, or need a bit of extra support to do so, we all benefit.

After COVID-19, nations can tackle environmental crises by shifting priorities to sustainable development

little over a year ago, in May 2019, a United ANations report on biodiversity made headlines for the bad news it contained: A million species at risk of extinction. The biosphere's many contributions to people are being degraded by a variety of industrial activities and resource use. Freshwater, soils and a stable climate are all under threat and giving way to droughts, floods, zoonotic diseases and more.

Amid all the bad news, however, were bright lights. I was one of the authors of that report, and we found a way out of the mess, with the seeds of solutions sprouting all over the world. While the report delivered a jarring message that only transformative change could address the climate and ecological crises, it also laid out a pathway to sustainability.

After days of negotiations with 132 nations over the wording of the report's summary, the other authors and I left Paris full of hope. Yet 14 months later, many nations already seem to have lost their way, focusing on restoring pre-COVID-19 economies rather than building resilient social and ecological systems for thriving sustainability.

There is a way forward, but it entails addressing several inconvenient truths.

TECHNOLOGY AND INNOVATION, DOUBLE-**EDGED SWORDS**

In a paper published in the new journal People and Nature. 39 co-authors and I identify what's needed for vibrant sustainable pathways. Here are a bundle of commonly misunderstood truths.

We are often told we need more technology, innovation, investment and incentives for sustainability. In truth, we actually need to shift all four. And restricting damaging forms of technology, innovation, investment and incentives is often harder — but more important — than boosting desirable kinds.

Technology, for one, is not only a source of good. It is also an enabler of ever-increasing human activity and associated environmental impacts.

In agriculture, for example, there is great scope for enhanced technologies to reconcile tough trade-offs. These technologies can help produce food for humanity while maintaining space for nature and its contributions to people, such as water purification, dust retention for air quality, the mitigation of floods and the esthetic and cultural values associated with pastoral landscapes. Think smart irrigation but also enhanced crop breeding.

Technology has not only improved yields and reduced environmental impacts, but it has also expanded agriculture into marginal lands and increased farmer dependence on other proprietary technologies, such as pesticides and chemical fertilizers.

Thus the answer is not more technology, innovation and investment, but a shift in focus. Evolved regulatory regimes would boost technologies that meet human needs while also



benefiting climate, wildlife, soils, water and broader ecosystems.

This is not simply a matter of rolling out low-carbon technology. Technology must also transition away from its reliance on newly extracted materials — which causes habitat degradation — and its production of waste. We need a circular economy, where products end their lives by becoming resources for future

SPEND MORE, BUT ALSO DIFFERENTLY

Underpinning innovation, investment and the use of technology are subsidies and incentives. Many have called for more public money to incentivize actions and approaches with smaller impacts on nature, including electric vehicle rebates, solar energy buyback programs and payments for ecosystem services.

Some have called for an elimination of harmful or perverse subsidies. But in governmental and intergovernmental circles, this is rarely accompanied by a specification of what is harmful or perverse, leaving the impression that most subsidies are OK.

Harmful subsidies are actually in the majority. A subsidy is harmful, we argue, if its primary purpose or effect is to enhance production or extraction. And in most contexts, including for fisheries, the majority of subsidies are just that, boosting fisheries catches and the vessels to catch fish.

The same is true for agriculture: most of the more than US\$600 billion per year in subsidies is production-oriented, which exacerbates environmental problems. Only a minority of subsidies target improved management and environmental performance.

FUND WORKERS AND THE TRANSITION

Governments struggle to fund incentive programs to cure environmental ills fuelled by harmful subsidies. Throwing good money after bad is inefficient and ineffectual. Instead, governments could re-orient all public funds towards strong and durable environmental stewardship and social sustainability.

Such a transition can help many workers whose livelihoods depend on current technologies and practices. In many nations, the wealthy co-opt most subsidies and reap the benefits of technological innovation, while the poor get left behind. Globally, small farmers are struggling with debt, droughts and crop failures, with farmer suicides in India providing a dramatic example.

Both people and nature can be served by reorienting subsidies away from producers and distributors of seeds and chemicals, and towards small-farmer loans and ecologically restorative farm practices. Similarly, ending fossil-fuel subsidies can facilitate the transition to clean energy without stranding workers, if those subsidies are reoriented to retool workers in clean technology.

Paradoxically, it's even harder to stop giving money to industries than to promise new money. THE FATE OF COVID-19 RECOVERY FUNDING Our new paper addresses several other

inconvenient truths. It's inconvenient to recognize that many of us must reduce our material consumption, and that we must collectively rein in human population growth. Or that solving environmental challenges requires comprehensively addressing inequalities in income and power across gender and other lines of social difference. And that effective and sustainable actions and strategies must transparently include diverse stakeholders, especially Indigenous Peoples and local

We now know the components of sustainable pathways, and they have been officially approved via intergovernmental negotiation. Do governments and businesses have the courage to follow them, including in COVID recovery funding and restructuring?

Perhaps if individuals and groups hold them accountable, they will.

32 fresh COVID-19 cases in Arunachal; count rises to 1,158

Thirty-two more people, six including ITBP personnel, have tested positive for COVID- 19 in Arunachal Pradesh, taking the northeastern state's caseload to 1,158 on Monday, a senior health official said.

Eleven fresh cases were reported in Seppa, the district headquarters of East Kameng, eight in Changlang district, six in Upper Siang, five in the Capital Complex region and one each in East Siang and Lower Subansiri districts, State Surveillance Officer Dr L Jampa said.

The new cases in Seppa are contacts of a COVID-19 patient in East Kameng district, while four of the eight new patients in Changlang are returnees from other states and two each are government employees and health workers, he

The six fresh cases reported in Upper Siang



Border Police (ITBP) personnel, while both the new patients in East Siang and Lower Subansiri had returned from other states, Jampa said.

The five fresh infections in the Capital Complex region were detected during rapid antigen tests, he said.

Barring nine, all district are Indo Tibetan the new patients are

asymptomatic.

They were shifted to COVID-19 care centres, Jampa said.

Seventy-seven more people, including 70 from the Capital Complex region, have recovered from COVID-19 and were discharged from hospitals on Sunday, he said, adding they have been advised strict home quarantine and selfmonitoring.

Of the 1,158 cases, 650 are active while 505 people have recovered from the disease and three patients have died. he said.

Shillong goes under 72-hour lockdown amid rising COVID-19 cases

SHILLONG, JULY 27 [PTI]:

A 72-hour lockdown started in Meghalaya's state capital Shillong from Monday amid rising cases of novel coronavirus in the state, officials said.

Around 30 localities, mostly in the worst-hit East Khasi Hills district, have already been declared containment zones, they said.

The lockdown in Shillong agglomeration — localities within the Shillong municipality and scheduled areas was announced after 56 new COVID-19 cases were reported in the last two days.

Meghalaya has 543 active COVID-19 cases, while 173 people have recovered from the disease. Five coronavirus deaths have been reported in the state so far.

"The lockdown reimposed in the entire Shillong agglomeration will continue till Wednesday midnight," the district's Deputy Commissioner Matsiewdor W Nongbri said.

Nepomniachtchi inflicts another defeat on Anand in Legends of Chess tourney

CHENNAI, JUL 27 (PTI): Former world champion Viswanathan Anand's struggles continued in the USD 150,000 Legends of Chess online tournament as he suffered his sixth defeat consecutive with a 2-3 loss to Ian Nepomniachtchi Russia.

Anand started the sixth round match with a draw as he came up with good defensive moves to keep the Russian at bay in a 53-move draw.

However Nepomniachtchi went ahead by pulling off a 34move win in the second game. The third saw the players sign peace after 48 moves.

The five-time world champion then fought back well to claim the fourth game in 42 moves to push the contest into the Armageddon (a tiebreaker).

Nepomniachtchi won the decisive tie-break in 41 moves to shatter the hopes of the 50-year old Indian superstar and left him winless after six rounds.

World champion Magnus Carlen continued his winning run and tops the standings with 17 match points. Nepomniachtchi is second on 16 followed by compatriot Vladimir Karmnik (12).

Anand, who is making his debut on the Magnus Carlsen Tour, lies ninth with three points.

Legends of Chess is a unique event where Carlsen, Ding Liren, Nepomniachtchi Anish Giri, semifinalists at the Chessable Masters (part of the Magnus Carlsen Tour), received an automatic invite and are up against six legends aged 40-52, who have been at the top of world chess at various points in their career.

The winner of this event will qualify for the USD 300,000 Grand Final, scheduled from August 9 to 20.

Sport's cascading tales of abuse and fear demand action from the very top

LONDON, [THEGUARDIAN]: In safer and saner times, the world's eyes would now be fixed on the Tokyo Olympics: the gleaming smiles, the shiny medals, the illusion of perfection. But the postponement of the Games has at least allowed space for something more vital: exposing the human cost of chasing glory, especially for young girls in aesthetic sports such as gymnastics and figure In the past week alone

athletes in Japan, China, Britain, Australia and the Netherlands have come forward with disturbing stories. Time and again they refer to the unequal power balance between them and their coaches and federations - and the impossibility of speaking out for fear of missing out on a world championships or Olympics. Poignantly, they have also mentioned how watching the Netflix documentary Athlete A had given them the reassurance that they are not alone, and to add their voices to the collective clamour.

In all the various stories we heard last week, there is a common theme. A survey of 800 Japanese athletes which found that 19% of respondents under 24 had been hit, punch, slapped, kicked or beaten was commissioned by Human Rights Watch. The other stories of



that of the championship figure skater Jessica Shuran "dehumanising" treatment in China. including regular beatings and abuse revealed in the Guardian - came from journalists. They were not coming the sports themselves, or their governing bodies.

Perhaps we shouldn't be surprised. While investment is linked to medals, as it is in so many countries, individuals will always face a temptation to take any shortcuts necessary to achieve the results, especially when they help sustain organisations and justify the salaries of the people they employ.

Britain is immune. Two years ago, UK Sport – the body that funds Olympic sport instituted a "culture health check" widespread allegations of a culture of fear in cycling, canoeing, bobsleigh and elsewhere. It insists the resulting policies have made a difference. The cascade of revelations from GB Gymnastics, as well as UK Sport's continuing focus on medals, gives reason to fear that it is as

effective a diagnostic tool

as a child's stethoscope.

It was certainly striking to hear the British Olympic silver medallist Cath Bishop say last week that medals were prioritised over welfare. As Bishop pointed out, when only medals count, then the way in which they are won becomes less important.

"Shortcuts welfare and coaching approaches encouraged so long as the results come," she wrote. "Athletes and coaches (and parents) lose their voice to raise concerns as results trump everything else. Toxic environments and 'cultures of fear' develop when winning any means. It's become Darwinian." She urged UK Sport to change its culture, from "medals and more" to "more than medals", a subtle but important distinction.

Of course it is not

just Britain that faces questions about whether enough has been done for athlete welfare. One study in 2016 asked an elite Dutch coach what they thought of Safe Sport. "It's a game," he said, adding that "when you are surrounded by people who think this policy is important you play along. When they are gone, you go back to doing what you did before. You just have to be smart in how you handle these things." Similar studies have found elite coaches often justify their methods by saying that because elite sport is tough, children need to learn to take criticism and pain, otherwise they won't make the grade.

But if sports and countries won't act, how will things change? When I spoke to Yu last week, she made the point that the International Olympic Committee needs to recognise young and vulnerable girls in aesthetic sports are particularly at risk. She called for it to set up a dedicated hotline staffed by child protection experts for abuse cases and to use more of its resources to help. Certainly, given it funds so many

Iran moves mock aircraft carrier to sea amid US tensions

DUBAI, JUL 27 (AP): Iran has moved a mock aircraft carrier the strategic Strait of Hormuz amid heightened tensions between Tehran and the US, satellite photographs released on Monday show, likely signalling the Islamic Republic soon plans to use it for live-fire drills. An image from Maxar **Technologies** taken Sunday shows an Iranian fast boat speed toward the carrier, sending waves up in its wake, after a tugboat pulled her out into the strait from the Iranian port city of Bandar Abbas.

Iranian state media and officials have yet to acknowledge bringing the replica out to the of Hormuz, through which 20% of the world's oil passes. However, its appearance suggests paramilitary Revolutionary Guard is preparing an encore of a similar mock-sinking it conducted in 2015.

The US Navy's Bahrain-based 5th Fleet. which patrols Mideast waterways, did not immediately respond to a request for comment.

European tourism faces turbulence only weeks after restart BERLIN (AP) — Europe's families abroad are also

revival is running into turbulence only weeks after countries opened their borders, with rising infections in Spain and other countries causing increasing concern as authorities worry about people bringing the coronavirus home from their summer vacations.

European countries started opening up to each other's tourists in mid-June, but recent events have shown that the new freedom to travel is subject to unpredictable setbacks. Over the weekend, Britain imposed a 14-day quarantine on travelers arriving from Spain, Norway ordered a 10-day quarantine for people returning from the entire Iberian peninsula, and France urged its citizens not to visit Spain's Catalonia region.

"The tourist season has already been very difficult," Ximo Puig told Cadena Ser radio. "We had some hope of salvaging something in August, but this is a very hard blow."

The northeastern of cases regions have Spain's most worrying virus clusters, prompting authorities to tighten restrictions in Barcelona, in a rural

area around Lleida and in Zaragoza that were relaxed only a month ago.

Catalonia is facing "the 10 most decisive days of this summer." regional leader Quim Torra said, warning that it is in everyone's hands to prevent a "critical situation" from worsening. But he also insisted that Catalonia is safe overall and said the tourism sector "is prepared with all the safety measures."

Elsewhere in Europe, authorities in Belgium said that COVID-19 cases are growing at an alarming rate amid a surge of infections in Antwerp. Greek authorities said they are likely to extend the mandatory use of masks at churches and shopping malls, citing worsening public adherence to safety guidelines.

And in north Africa, Morocco banned most travel to and from some major cities — including Tangier, Casablanca and Marrakech, usually popular tourist destination — to try to stem a small spike in cases. In the Asia-Pacific

region, many countries are still essentially banning foreign travelers or, if they do allow them to enter, requiring them to submit to tests and strict quarantine. That includes Australia. where the premier of Victoria Daniel Andrews, said the biggest driver in the region's current outbreak is people continuing to go to work after showing symptoms.

Crossing borders was linked to other outbreaks in Asia. South Korea said 16 of the 25 new cases it confirmed Monday were tied to people arriving from abroad.

Not wearing a mask outside could mean a \$645 fine in Hong Kong as city imposes strict Covid measures

HONG KONG (CNN): Hong Kong will make masks wearing public compulsory and limit gatherings to no more than two people as officials in the city grapple with a rising surge in coronavirus infections.

On Monday, Hong Kong's Chief Secretary Matthew Cheung announced that face masks would mandatory in both indoor and outdoor places from offenders facing fines of up to 5,000 Hong Kong dollars (\$645), although he didn't specify how the new measure would be enforced.

People "reasonable excuses" medical such as conditions or children under the age of two will be exempt, he added.

Cheung announced that the Chinese central government will help build a Wuhan-style makeshift hospital near Hong Kong's airport with a capacity of around 2,000 hospital beds.

"The epidemic situation is critical,"

The restrictions come as the city faces a coronavirus outbreak dubbed locally as its "third wave," with the origin of many infections still unknown. Number of fires more than doubles in Brazil's Pantanal BRASILIA, JUL 27 (AP): The number of fires in Brazil's Pantanal, the world's biggest tropical wetlands, more than doubled in the first half of 2020 compared to the same period last year, according to data released by a state institute.

Officials said it was the largest number of fires in a six-month Brazilian period in the last two decades.

The sharp increase fires comes domestic and international concern over Brazilian President

Jair Bolsonaro's calls to clear land in order to drive economic development, follows a surge in fires, many set to make land available for farming and other industry, in the Amazon last year.

There were 2,534 recorded fires in the Pantanal between January and June, the National Institute for Space Research said. Between January and June 2019, the institute recorded 981 fires. The 2020

158% increase than the 2019 numbers.

As of Saturday, the institute had registered another 1,322 fires in July, for a total of 3,856 blazes in the wetlands that extend through the states of Mato Grosso and Mato Grosso do Sul, in central-western Brazil.

Until the end of last month, technicians from the institute estimated the total area of the Pantanal burned this year at 1,969 square miles (5,100 km).
