While the State Government announced its decision to end all restrictions on entry into Sikkim starting 10 Oct, rural bodies at several places in the state have begun announcing their own counterdecisions to restrict entry of tourists. Lachung in North Sikkim was the first to make such an announcement on 25 Sept banning tourists till 30 Nov.

Single-day COVID-19 cases in India below 75,000



NEW DELHI. SEP 29 (PTI): Daily COVID-19 cases in India dropped below 75,000 and less than 1,000 deaths were reported in a day after nearly a month, while total recoveries crossed the 51 lakh-mark, according to the Union Health Ministry's data updated on Tuesday.

The total coronavirus cases in the country mounted to 61,45, 291 with 70,589 new infections, while the death toll reached 96,318 after 776 people succumbed to the disease in a span of 24 hours, the data updated at 8 am showed.

The total recoveries surged to 51,01,397 pushing the recovery rate to 83.01 per cent.

There are 9,47,576 active cases in the country

which comprise 15.42 per cent of the total caseload, the data stated.

The COVID-19 case fatality rate was recorded at 1.57 per cent.

India's COVID-19 tally had crossed the 20-lakh mark on August 7, 30 lakh on August 23 and 40 lakh on September 5. It went past 50 lakh on September 16 and crossed 60-lakh mark on September 28.

According to the ICMR, a cumulative total of 7,31,10,041 samples have been tested up to September 28 with 11,42,811 samples being tested on Monday.

The 776 new fatalities include 180 from Maharashtra, 70 from Tamil Nadu, 59 from Karnataka, 58 from Uttar Pradesh, 56 from West Bengal, 46 from Punjab, 37 each from Andhra Pradesh and Delhi and 35 from Madhya Pradesh.

Total 96,318 deaths reported so far in the country include 35,751 from Maharashtra followed by 9,383 from Tamil Nadu, 8,641 from Karnataka, 5,745 from Andhra Pradesh, 5,652 from Uttar Pradesh, 5,272 from Delhi, 4,837 from West Bengal, 3,428 from Gujarat, 3,284 from Punjab and 2,242 from Madhya

The health ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

"Our figures are being reconciled with the Indian Council of Medical Research," the ministry said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.


GANGTOK, 29 SEPT:

Cikkim's tally **S**confirmed COVID-19 cases bulged to 2,856 with 41 fresh cases of novel coronavirus detected in the 24 hours ending 8 AM Tuesday.

Meanwhile, 71 more COVID patients were discharged from isolation facilities on Monday taking the number of discharged patients to 2,154. With these discharges and the new cases, there are now 667 actives COVID-19 cases in the State.

Of the new cases, 20 were detected from RT-PCR testing of 249 samples at the VRD Lab while TrueNat testing of 37 samples found seven COVID-19 cases. 14 more cases were detected in rapid antigen testing of 77 samples.

While providing the details of the new cases found in RT-PCR testing,

India rejects China's assertion over following its 1959 stand on perception of LAC

NEW DELHI, SEP 29 (PTI): India on Tuesday rejected China's position that it abides by its 1959 stand on the perception of the Line of Actual Control(LAC), and asked the neighbouring country to refrain from advancing an untenable unilateral interpretation of the defacto border.

The stand by China spelt out by its foreign ministry insisting that it takes the 1959 line on perception of the LAC amid a nearly fivemonth-long border standoff in eastern Ladakh triggered strong reaction from India.

"India has never accepted the so-called unilaterally defined 1959 Line of Actual Control (LAC). This position has been consistent and well known, including to the Chinese side," MEA Spokesperson Anurag Srivastava said response to a question by the media on the issue.

The spokesperson's comments came after Chinese Foreign Ministry spokesperson told Times Hindustan that China abides by the LAC as proposed then Premier Zhou Enlai to Prime Minister Jawaharlal Nehru in a letter dated November 7, 1959.

Srivastava referred to various bilateral agreements including the 1993 agreement on maintenance of peace and tranquility along the LAC, 1996 pact on confidence said.

building measures (CBMs) and the 2005 agreement on political parameters and guiding principles for settlement of the boundary issue, emphasise that both sides showed commitment to reach a common understanding

"Therefore, insistence now the Chinese side that there is only one LAC contrary to solemn commitments made by China in these agreements," he said, adding the Indian side has always respected and abided by the LAC.

Referring to Defence Minister Rajnath Singh's address recent Parliament. Srivastava said it is the Chinese side which by its attempts to transgress the LAC in various parts of the Western Sector has tried to unilaterally alter the status quo.

The spokesperson talked about repeated affirmation of the Chinese side in the last few months that the current situation in the border areas should be resolved in accordance with the agreements signed between the two countries. "In the agreement

Lokayukta declares Goa minister `unfit' to hold office

PANAJI, SEP 29 (PTI): The Goa Lokayukta has held Solid Waste Management Minister Michael Lobo to be "unfit to hold his post" while passing an order on a complaint against him, and said it should be conveyed to the chief minister.

Though making such recommendations is 'futile', it is the duty of the anti-corruption institution to do it, said Lokayukta Justice P K Misra (retd) in his order of September 17, made public last week.

complainant, had applied to the NGPDA -- Lobo was then its chairman -- for a construction license.

The Lokayukta held that the "obvious vengeful action" the part of Sarpanch, Secretary and Lobo resulted in causing loss to the complainant.

"If any declaration is made (under section 16-A of the Lokayukta Act) that he should not continue as a minister, and such declaration is accepted or deemed to be accepted, the matter is left to the discretion of the concerned minister

to resign or not to resign," the order said.

"Therefore, in the present political scenario possibly no useful purpose would be served by giving a declaration that Lobo is unfit to continue as a Minister.

"In spite of such stark reality of futility of making such a declaration, institution considers that it is a solemn duty to give a declaration that Lobo should not continue to hold the office of Minister," the order said.

Since chief minister is the competent authority in respect of a minister, the order should be forwarded to the CM along with relevant materials on record, it said.

BENGALURU, 29 SEPT [REUTERS]: Serum Institute of India will make up to 200 million COVID-19 vaccine doses for poorer countries, including India, next year, as the Bill & Melinda Gates Foundation and GAVI vaccines alliance funding, the company said on Tuesday.

National camp for women wrestlers to begin on October 10

AMANPREET SINGH NEW DELHI, SEP 29 (PTI): The women's national wrestling camp will finally begin at the SAI Centre in Lucknow from October 10, the Wrestling Federation of India (WFI) said on Tuesday, with a warning that the grapplers who miss it will not be considered for national team selection.

The national camp from was to begin September 1 but postponed due the coronavirus pandemic.

To make matters worse, the country's two of the four Olympicwrestlers Phogat and Deepak Punia -- returned positive for the virus, creating more fear in the minds of many wrestlers.

After assessing the situation and on the advice of the Sports Authority of India (SAI), the WFI has finally made up its mind to start the

camp in six Olympic weight categories 50kg, 53kg, 57kg, 62kg, 68kg and 76kg -- till December 31.

Wrestling among nine disciplines that the SAI picked for resumption of activities from October 5, under its 'Khelo India Phir Se' initiative. "We are starting the

camp from October 10 in Lucknow. The strength of the camp will remain same, three wrestlers in each of the six Olympic weight categories," WFI Assistant secretary Vinod Tomar told PTI.

The wrestlers will have to undergo a 14day quarantine period and return negative test before they are allowed to begin mat training.

Asked if all the top wrestlers have agreed to join the camp, Tomar said, "All will have to come. Those who will miss the camp will be replaced and her. But the fear of will not be considered for selection."

Asked specifically if Vinesh has agreed to join the camp, Tomar said the WFI is arranging what she needs.

"She wanted to train abroad but in current situation, we are giving her good partners to train with at the camp."

Before the camp was postponed, 2018 World Championship medallist Pooja Dhanda had said that "we have to learn to live with Coronavirus", indicating that she will have no issues in joining the camp whenever it starts.

Meanwhile, coach of an up and coming wrestler said his ward will join the camp but only because a place in the national team is at stake.


"After speaking with the parents of the wrestler, we have decided to send

****complex **A**neurological surgery was performed on a middle aged lady at Central Referral Hospital Tadongunder Sikkim Manipal University recently, a press release informs.

The patient was suffering from advanced spondylosis involving the cervical spine (neck). She is a hardworking vegetable vendor in Lall Bazaar in Gangtok and because of her illness she was unable to go to work to earn her living.

Severe neck pain radiating all the way to her limbs with electric shock like sensations made it impossible for her to carry out her daily chores at home. She even lost sleep and her symptoms of clinical depression, which she

radiculopathy and early myelopathy. MRI scan of the neck showed advanced degenerative cervical spine disease with multiple levels intervertebral prolapses causing compression of the spinal cord and nerve roots. This explained all her symptoms.

It is known that the majority of cases improve conservative treatment and keeping this in mind she too was advised a trial of rest and medications. However, unfortunately her pain wasn't resolved and she called in a week later. Overcoming her fear of surgery she agreed to go for it and came for admission. A detailed preoperative workup, planning and preparation made it possible to post her case under general anaesthesia.

underwent C5-C6 and C6intervertebral discectomy (removal of the intervertebral between "numbered" vertebral bones) and fusion using an interbody cage stuffed

anterior which was secured with screws. These implants are made of Titanium and are much stronger than steel and resistant to corrosion and so can be kept permanently. It requires extensive planning and intraoperative guidance to achieve a stable construct.

A small incision in front of the neck was used to reach intervertebral disc space in target. procedure was performed by Consultant Neurosurgeon, PranavRai and his team, taking all precautions and safeguards COVID-19 infection.

After the procedure patient significant reduction in her symptoms. The pain was relieved and she recovered without any complications.

She still has to undergo long term physiotherapy strengthen her muscles at home which has been tailored to her case by the experts here in CRH.

There are various other procedures which done routinely CRH. Rights group Amnesty halts India operations, says facing witch-hunt

NEW DELHI, 29 SEPT (REUTERS): Human rights group Amnesty International stopped its work in India on Tuesday saying the government had frozen its bank accounts in the latest action against it for speaking out about rights violations.

had laid off staff after facing a crackdown over the past two years over allegations of financial wrongdoing that it said were baseless.

"This is latest in the incessant witchhunt of human rights organizations by the government of India over unfounded and motivated allegations," Amnesty said in a statement.

Its bank accounts were frozen on Sept. 10, it said.

Amnesty highlighted rights violations in recent months in the disputed Jammu and Kashmir region as well as what it said was a lack of police accountability during riots in Delhi in February, and the government had sought

to punish it, it said. There was immediate response government spokesmen to requests for comment.

Needed - Rural Pragmatism, Not Urban Vainglory Empower, for real, panchayats to

shoot down superficial projects

Dy now, the panchayats should be rather comfortably f D ensconced in their posts, busy with the tasks of Panchayati Raj, and still, rather frequently, one reads of Panchayats being told what to do. They are still taken through the processes on which amendments to which Acts made their election possible, given the drill on the usual stuff about working for the people in collaboration with line departments etc etc. These are the basics that one expected the elected Panchayats to already know when they filed their nomination papers, but wait, too many of them were elected unopposed and had no need to understand either the Act or their tasks so long as they kowtowed right for the "ticket". But that we leave for another time. And that said, one still hopes that such sessions, beyond making Panchayats "aware" about how and why they are more empowered today and whether earnest plans are afoot to divest even more powers to them, also get reassured that they can call the shots and need not "obey" babus or other politicians when it comes to the affairs of the villages they represent. And come the next panchayat elections and the rural representatives will also have shed their political colours and could then be expected to work more for the people and less for the party.

The next progression should see them flex their muscles and shoot down scatter-brained projects and proposals that only somnolent bureaucrats can dream up. For instance, if a "file" was moved to invest 55% of an Innovation Fund to purchase plastic chairs and a PA system, they should be able to laugh it out of the Panchayat Bhawan. For those scoffing and claiming that such "projects" are not mooted, a quick read of the Annual Technical Inspection Report on PRIs and ULBs for the year ended 31 March 2014 by the office of the Principal Accountant General (Audit), Sikkim, is recommended. Apparently, in 2013-14, the East Zilla Panchayat blew up Rs 55 lakh (out of Rs 1 crore) towards purchase of plastic chairs and sound systems on the argument that these assets would help in "dissemination of information about welfare schemes" and would also "generate revenue" for the Gram Panchayats through rentals. The Panchayats might need plastic chairs and even sound systems, but such purchases cannot be called "innovative". Apparently, the Thirteenth Finance Commission had recommended formulation of District Innovation Fund "with a view to support and promote innovation for better alternatives, reducing costs, increasing the efficiency of capital assets, improving service delivery and governance". This Fund was expected to fill "vital gaps in public infrastructure already available in the district, which is not being fully utilised for want of a relatively small investment". So, how did they propose this one - they already had the floor space and needed chairs to fill it up for "full utilization" or that they had speeches ready, but needed a sound system to broadcast them? The guidelines suggested drawing up of an Annual Plan for utilisation of funds after carrying out Strength, Weakness, Opportunity and Threat (SWOT) analysis to "trigger innovative measures" with a view to make Government accountable and accessible to all section of the society. And they came up with this? The dodge must have been originally drafted and processed by babus not panchayats and the latter must have just fallen in line. Real empowerment will see them advise and demand better and be able to reject and amend.

There is another glaring evidence of civil works and expense-driven problem-solving superficiality. Apparently, the Rural Management & Development Department (RMDD) (through ZP, South) developed a water harvesting structure at Tamley lake in 1998-99 to provide potable water to the three villages of Mungram, Guptigaon, Sirubari and Rajarukgaon. It should come as no surprise that this project did not age too well, and in 2008, the villagers complained that water supply was poor. By Feb 2008, RMDD-Jorethang had a DPR for Rs 79.51 lakh ready to repair the water harvesting experiment. The funds were expended and work completed two years later. So, did the people go without potable water for two years? Thankfully, no. They repaired the existing pipes carrying water from a distant source. It cost them Rs 2.08 lakh to do this! Meanwhile, the Rs 79.51 lakh spent by the RMDD delivered repairs to a water harvesting structure that does not serve as a source of water to the nearby villages! The obvious need for more rural pragmatism to direct the development and investment priorities cannot be stressed more tellingly than this example.

One needs to understand that the reason the nation has empowered the rural voters is because all other attempts at fixing accountability have failed. When Panchayats decide, and if they decide from their own wits and not departmental chits, more projects will achieve fruition. When decisions are taken through informed and involved gram sabhas, then the whole village knows; when the whole village knows, the whole village watches and because it is about them and about facilities they and their children will use, they are also expected to monitor. When projects fail, the blame ends at the village boundaries and the buck can actually stop at the right door. When such accountability becomes real, the bastis will begin noticing real improvements. Urban naiveté and vainglory need to be played out of the villages and rural pragmatism allowed back in and supported to express itself more forcefully.

Coronavirus: Is Manaus, Brazil, the first city to reach herd immunity?

Two years ago, I visited the ■ Brazilian city of Manaus at the start of a trip through the Amazon. Since my childhood, I had been fascinated by this dot on the map that sits at the centre of the Amazon basin at the confluence of the Amazon and Rio Negro rivers.

The city is ultra tropical, with life very much lived on the street in an intense atmosphere. I felt it had a slightly oppressive feel, giving the impression that either the river or the encroaching forest could claim it back for nature at any moment. Against this background, it was interesting to hear that Manaus is now regarded as one of the most coronavirus-infected cities in the world, with 44%-66% of the population infected, and is at the centre of a debate about herd immunity.

To an infectious disease and vaccine expert, herd immunity is a common term, but it is now becoming part of lay language and debate. Interestingly, although it is a critical component of how the spread of infections is limited, very few people really understand it and even fewer can actually measure it. Many infectious diseases naturally move through populations as incidence waves where rates of infection increase or decrease cyclically.

Before public interventions, the incidences of diseases such as whooping cough and measles oscillated over a period of several years. This was put down, at least in part, to herd immunity. As a wave moves through a city or region, people become immune and the disease dies down.

Over time, immunity can wane. Also, babies are born and vulnerable people move into a city and herd immunity declines, precipitating the next wave. Herd immunity is much about breaking transmission. Protected individuals protect others from disease by not infecting them, breaking the transmission chain.



They reduce the now-famous R number.

Even this is not so easily understood as some diseases such as flu escape immunity by varying their structure, and others, such as typhoid, manipulate natural immunity so that protection does not easily build up. Even with herd immunity present, the disease agent does not disappear but is suppressed. It can stay on in the soil or water, as with cholera, or even in human carriers, as with typhoid.

ARTIFICIALLY INDUCING **PROTECTION**

Natural infection is one way of inducing herd immunity. The other is by vaccination. Vaccines can artificially induce protection in people who have never been infected and break the natural transmission cycle. Indeed, routine vaccination has reduced incidence rates for many diseases and has eradicated one – smallpox.

It is important to understand

protection differently to natural infection. So even for diseases where natural infection is not completely one area often misunderstood in the

Also, although vaccines protect they don't always eliminate the disease from a population. A classic example is whooping cough, which can persist as an almost asymptomatic disease in adults who can then reinfect unprotected

HARD TO MEASURE

How do we measure herd immunity? Actually, this is really difficult. Many people COVID-19 infection rate trends think that you can just measure in the next year. Indeed, early antibodies in the blood. Antibodies that vaccines usually induce also tend to wane over time,

> Proving herd immunity in Manaus will be a challenge without a true correlate of protection or a carefully designed study. However, it will be interesting to watch how the evidence suggests that rates are on the rise once again in the city.

Fox News uses the word 'hate' much more than MSNBC or CNN

 $\mathbf{F}_{ ext{times}}^{ ext{ox News is up to five}}$ use the word "hate" in its programming than its main competitors, according to our new study of how cable news channels use language.

Fox particularly uses the term when explaining opposition to Donald Trump. His opponents are said to "hate" Trump, his values and his followers.

Our research, which ran from Jan. 1 to May 8, 2020, initially explored news of Trump's impeachment. Then came the coronavirus. As we sifted through hundreds of cable news transcripts over five months, we noticed consistent differences between the vocabulary used on Fox News and that of MSNBC.

While their agendas were largely similar, the words they used to describe these newsworthy events diverged greatly.

FOX AND HATE

For our study, analyzed 1,088 program transcripts from the two ideologically branded channels - right-wing Fox and left-wing MSNBC between 6 p.m. and 10:59

Because polarized media diets contribute to partisan conflict, our quantitative analysis identified terms indicating antipathy or resentment, such as "dislike," "despise," "can't stand" and

We expected to find

CURD KNÜPFER & ROBERT that both of the strongly ideological networks made use of such words, perhaps in different ways. Instead, we found that Fox used antipathy words five times more often than MSNBC. "Hate" really stood out: It appeared 647 times on Fox, compared to 118 on MSNBC.

Fox usually pairs certain words alongside "hate." The most notable was "they" - as in, "they hate." Fox used this phrase 101 times between January and May. MSNBC used it just five times.

To put these findings in historic context, we then used the GDELT Television database search for occurrences of the phrase "they hate" on both networks going back to 2009. We included CNN for an additional comparison.

We found Fox's usage of "they hate" has increased over time, with a clear spike around the polarizing 2016 Trump-Clinton election. But Fox's use of "hate" really took off when Trump's presidency began. Beginning in January 2017, the mean usage of "they hate" on the network doubled.

'US' VERSUS 'THEM'

So who is doing all this hating – and why – according to Fox News?

Mainly, it's Democrats, liberals, political elites and the media. Though these groups do not actually have the same interests, ideology or job description, our analysis finds Fox lumps them together as the "they" in "they hate."

As for the object of all

this hatred, Sean Hannity, Tucker Carlson and other Fox hosts most often name Anchors Trump. also identify their audience -"you," "Christians" and "us" as the target of animosity. Only 13 instances of "they hate" also cited a reason. Examples included "they

for [Trump]." Citing liberal hate as a fact that needs no explanation serves to dismiss criticism of specific policies or events. It paints criticism or moral outrage directed at Trump

can't accept the fact that he

won" or "because we voted

as inherently irrational. For loyal Fox viewers, these language patterns construct a coherent but dangerous potentially narrative about the world.

Our data show intensely partisan hosts like Hannity and Carlson are more likely than other Fox anchors to use "they hate" in this way. Nevertheless, the phrase permeates Fox's evening programming, uttered by hosts, interviewees and Republican sources, all painting Trump critics not as legitimate opponents but hateful enemies working in

bad faith. By repeatedly telling its viewers they are bound together as objects of the contempt of a powerful and hateful left-leaning "elite," Fox has constructed two imagined communities. On the one side: Trump along with good folks under siege. On the other: nefarious Democrats, liberals, the left and mainstream media.

Research confirms that repeated exposure to polarized media messages can lead news consumers to form firm opinions and can foster what's called an "in-group" identity. The us-versus-them mentality, in turn, deepens feelings of antipathy toward the perceived "out-group."

The Pew Research Center reports an increasing tendency, especially among Republicans, to members of the other party as immoral and unpatriotic. Pew also finds Republicans trust Fox News more than any other media outlet.

Americans' divergent media sources - and specifically Fox's "hate"filled rhetoric – aren't solely to blame here. Cable news is part of a larger picture of heightened polarization, intense partisanship and paralysis in Congress.

GOOD BUSINESS

Leaning into intense partisanship has been good for Fox News, though. In summer 2020 it was the country's most watched network. But using hate to explain the news is dangerous business plan when shared crises demand Americans' empathy, negotiation and compromise.

Fox's talk of undermines democratic values like tolerance and reduces Americans' trust of their fellow citizens.

This fraying of social ties helps explain America's failures in managing the pandemic - and bodes badly for its handling of what seems likely to be a chaotic, divisive presidential election. In pitting its viewers against the rest of the country, Fox News works against potential solutions to the the very crises it

2 more months required to kill damaged Baghjan gas well in Assam: Oil India chief

351 Jagannath Temple servitors test positive for COVID-19



PURI, SEP 29 (PTI): At least 351 servitors and 53 employees of Shree Jagannath Temple here have tested positive for COVID-19, an official said.

A total of 404 persons engaged in the 12th century shrine have tested positive for the virus since August, said Shree Jagannath Temple Administration (SJTA) administrator Ajay Jena said on Tuesday.

He said the Lord Jagannath's rituals, however, are continuing as usual despite the absence of so many servitors.

The Jagannath temple

COVID-19 pandemic. are in home isolation after testing positive for the infection and there is a shortage of knowledgeable people to perform rituals. At least a group of 13

priests each are required to perform rituals for the sibling deities -Lord Balabhadra, Devi Subhadra and Lord Jagannath. Therefore, the presence of 39 priests apart from other servitors are essential to perform daily rituals of the oldest Lord Vishnu Temple here, who is being worshipped since ages in the form of Lord Jagannath.

The uniqueness of the Puri temple is that rituals is closed for devotees are interconnected with since March due to the each other, they start from early hours till The official said as late in the night. If one most of the servitors ritual is not performed, next one could

be performed as per the temple tradition, said Bhaskar Mishra, a researcher in Jagannath culture.

If more number of servitors test positive for the virus in the coming days, there might be a problem. The administration is considering a proposal to engage junior servitors, he said.

So far, a total of 9,704 COVID-19 cases have been detected in Puri district of which 1,255 cases are reported from Puri Municipality area alone. Of the 52 deaths reported in the district, nine hail from the Puri Municipality area. At least three of the nine fatalities in Puri town are servitors engaged in the temple rituals, the district health officials

The administration had conducted COVID-19 test of all the servitors engaged in the annual Rath Yatra of Lord Jagannath. Then only two servitors had tested positive for COVID-19. However, the infection struck Puri about a month after the festival, an official said, adding that the SJTA used to provide homoeopathy preventive medicines to servitors' families to keep them safe.

Meanwhile, the state government in an affidavit informed the Orissa High Court that it is not possible to reopen the temple including Shree Jagannath Temple in Puri for devotees under the prevailing COVID pandemic. The temple remains closed for devotees since March.

The country's foreign reserves are drying up, the local currency is expected to spiral further out of control, and incidents of armed clashes between rival groups are escalating. politicians Bickering have been unable to form a government, putting an international bailout out of reach.

Last week, a French initiative to form a rescue government of specialists fell apart when the political factions split along familiar fault lines, deepened by the U.S.-Iran rivalry.

The country risks slipping into chaos.

"Absent a major change in either side's political calculations, the coming weeks will see continued stalemate, a government caretaker that lacks the capability implement any reforms, an acceleration of the economic collapse," said Mike Azar, a former Johns Hopkins SAIS professor of finance.

Dying winds give crews hope

SAN FRANCISCO (AP): Firefighters say they hoped dying winds would enable them to bear down on a wildfire that exploded in the Northern California wine country, prompting tens of thousands of evacuations while second blaze killed at least three people.

The Glass Fire raged through Napa and Sonoma counties on Monday, tripling in size to around 56.6 square miles (146.59 square kilometers) without any containment.

Some two dozen homes had burned, the San Jose Mercury News reported.

The fire north of San Francisco was driving through brush that hadn't burned for a century, even though surrounding areas were incinerated in a series of blazes in recent years.

dry winds But that gave the flames a ferocious push appeared to have eased by Monday evening and firefighters feeling "much more confident," said Ben Nicholls, a division chief with the California Department of Forestry and Fire Protection, known as Cal Fire.

"We don't have those critical burning conditions that we were experiencing those last two nights," he said.

The Glass Fire is one of nearly 30 wildfires burning around California and National Weather Service warned that hot, dry conditions with strong Santa Ana winds could remain a fire danger in Southern California into Tuesday.

In a forested far northern part of the state, more than 1,200 people were evacuated in Shasta County for the Zogg Fire.

Three people have died in the fire, Shasta County Sheriff Eric Magrini said Monday. He three years ago and she gave no details but urged people who receive evacuation orders: "Do not wait."

Pacific Gas & Electric had cut power to more than 100,000 customers in advance of gusty winds and in areas with active fire zones. By Monday the utility said it had restored electricity to essentially all of those customers. However. PG&E said about 24,000 people remained without power in areas affected by two fires in Napa, Sonoma, Shasta Tehama counties.

So far in this year's historic fire season, more than 8,100 California wildfires have killed 29 people, scorched 5,780 square miles (14.970 square kilometers), and destroyed more than 7,000 buildings.

The Glass began Sunday as three fires that merged and drove vineyards and mountain areas into eastern Santa Some 70,000 people are under evacuation orders, including the entire 5,000-plus population of Calistoga in Napa County.

Some people were injured and Sonoma County sheriff's deputies had to rescue people who ignored evacuation orders, officials said.

Sonoma County Supervisor Susan Gorin, who lives in the Oakmont area of Santa Rosa, heeded the order to flee late Monday night. It took her nearly two hours of crawling along a jammed road to reach safety.

Gorin's home was damaged in another fire was rebuilding it. She saw three neighboring houses in flames as she fled.

Death toll from coronavirus tops 1 million

virus After the killed the 27-year- to make it abstract." old Chaudhary in late July, his mother wept inconsolably. With her son gone, Premlata Chaudhary said, how could she go on living? Three weeks later, on Aug. 18, the virus took her life, too — yet another number in an unrelenting march toward a woeful milestone.

Now, 8 1/2 months after an infection doctors had never seen before claimed its first victims in China, the pandemic's confirmed death toll has eclipsed 1 million, according to a count by Johns Hopkins University.

That is partly due to the virus's quickening spread through India, where reported deaths have topped 96,000 and cases are increasing at the fastest rate in the world.

The United States, where the virus has killed about 205,000 people, accounts for 1 out of 5 deaths worldwide, far more than any other despite its country wealth and medical resources.

"It's not just a number. It's human beings. It's people we love," said Dr. Howard Markel, a professor of medical history at the University of Michigan has advised government officials on containing pandemics. On a Thursday morning

in February, Markel's mother, 84 and infirm, was stricken by an illness later diagnosed as COVID-19. She died before midnight.

"It's our brothers, our sisters. It's people we know," Markel said. "And if you don't have that human factor right in your face, it's very easy

Even at 1 million greater than the population of Jerusalem or Austin, Texas, more than four times the number killed in the 2004 earthquake and tsunami in the Indian Ocean — the toll is almost certainly a vast undercount.

Many deaths were probably missed because of insufficient testing and inconsistent reporting, and some suspect concealment by countries like Russia and Brazil

And the number continues to mount. Nearly 5,000 deaths are reported each day on average. Parts of Europe are getting hit by new outbreaks and experts fear a second wave may await the U.S.

"I can understand why ... numbers are losing their power to shock, but I still think it's really important that we understand how big these numbers really are," said Mark Honigsbaum, the Londonbased author of "The Pandemic Century: One Hundred Years of Panic, Hysteria and Hubris."

Few people can testify to those numbers like the Rev. Mario Carminati, a priest in the northern Italian province of Bergamo, which was hit by one of Europe's first major outbreaks last spring. When the virus overwhelmed local cemeteries, Carminati opened his church to the dead, lining up 80 coffins in the center aisle. After an army convoy carted them to a crematory, another 80 arrived. Then

"It was something completely unpredictable that arrived like a bolt of lightning in a clear sky ... and struck our reality," he

Eventually the crisis receded and the world's attention moved on. But the pandemic's grasp endures. In August, buried his Carminati 34-year-old nephew, Christian Persico.

"This thing should make us all reflect. The problem is that we think we're all immortal." Carminati said.

The virus first appeared late last year in patients hospitalized in the Chinese city of Wuhan. The first death was reported there on Jan. 11. By the time authorities locked down the city nearly two weeks later, millions of travelers had come and gone. China's government has come in for criticism that it did not do enough to alert other countries to the threat.

Government leaders in countries such as Germany, South Korea and New Zealand worked effectively to contain it. Others, like U.S. President Donald Trump and Brazil's Jair Bolsonaro, dismissed the severity of the threat and the guidance of scientists, even as hospitals filled with gravely ill patients.

Brazil has recorded the second most deaths after the U.S., with about 142,000. India is third and Mexico fourth, with more than 76,000.

Oscar Ortiz, an oil platform worker for

state-owned Petroleos Mexicanos, said he felt helpless while ill and quarantined this spring, as 14 of his coworkers died from the virus, three in a single

"It's very painful to see this and not be able to do anything," said Ortiz, whose company has reported more than 300 deaths in its ranks

The virus has forced trade-offs between safety and economic well-being. The choices made have left millions of people vulnerable, especially the poor, minorities and the elderly.

India, whose government relaxed tight restrictions in recent months to jump-start an economy where many subsist on earnings from day labor, is the latest example.

"When the pandemic actually started to get under control to some extent, the lockdown was eased and then completely lifted," said K. Srinath Reddy, president of the Public Health Foundation of India. "The virus had a free passage and could spread much more easily."


With so many of the deaths beyond view in hospital wards and clustered on society's margins, the milestone recalls the grim pronouncement often attributed to Soviet dictator Josef Stalin: One death is a tragedy, millions of deaths are a statistic.

The pandemic's toll of 1 million dead in such a limited time rivals some of the gravest threats to public health, past and present. It exceeds annual deaths from AIDS, which last year killed about 690,000 people worldwide. The virus's

is approaching the 1.5 million global deaths each year from tuberculosis, which regularly kills more people than any other infectious disease.

France to ban use of wild animals in circuses, marine parks

• PARIS (AP): France's environment minister has announced a gradual ban on using wild animals in traveling circuses, on keeping dolphins and killer whales in captivity in marine parks and on raising mink on fur farms.

Barbara Pompili, France's minister of ecological transition, said in a news conference Tuesday that bears, tigers, lions, elephants and other wild animals won't be allowed any more in travelling circuses "in the coming years."

In addition, starting immediately, France's three marine parks won't be able to bring in nor breed dolphins and killer whales any more, she said.

"It is time to open a new era in our relationship with these (wild) animals," she said, arguing that animal welfare is a priority.

Pompili said the measures will also bring an end to mink farming, where animals are raised for their fur, within the next five years.

The ban does not apply to wild



animals in other permanent shows and

Pompili did not set any precise date for the ban in travelling circuses, saying the process should start "as soon as possible." She promised solutions will be found for each animal "on a case-bycase basis."
