India to witness solar eclipse on June 21

KOLKATA, JUN 15 (PTI): India will witness a solar eclipse on June 21 and it will be annular in some parts of the country, where skygazers will get an opportunity to observe the "ring of fire" during the phenomenon, an official said on Monday.

However, for most parts of the country, the eclipse will be partial.

The path of the annular solar eclipse will start near Gharsana in Rajasthan around 10:12 am and the phase of annularity will begin around 11:49 am and end at 11:50 am, Director of the M P Birla Planetarium Debi Prasad Duari

The ring of fire will be visible for that one minute from places such as Suratgarh and Anupgarh in Rajasthan, Sirsa, Ratia and Kurukshetra in Haryana, and Dehradun, Chamba, Chamoli and Joshimath in Uttarakhand.

However, the ring of fire will not be as prominent this time as it was on December 26 last year and will be a little narrower, Duari said in a statement.

"The annular solar eclipse occurs when the sun, moon and the earth come in a straight line and almost on the same

"At that moment, the moon must be farther away from the earth in its elliptical orbit and hence, cannot cover the disc of the sun completely, resulting in a narrow band of light around the dark silhouette of the moon, making the ring of fire visible," the statement said.

But from a much wider-region country, people can observe a partial solar eclipse of a different magnitude.


In Kolkata, the partial eclipse will begin at 10:46 am and end at 2:17 pm, while the timing will be from 10:20 am to 1:48 pm in New Delhi, from 10 am to 1:27 pm in Mumbai, from 10:22 am to 1:41 pm in Chennai and between 10.13 am and

1.31 pm in Bengaluru. On June 21, the annular eclipse will first start for the people of Congo in Africa and progress through South Sudan, Ethiopia, Yemen, Oman, Saudi Arabia, the Indian Ocean and Pakistan, before entering India over Rajasthan.

It will then move on to Tibet, China, Taiwan, before ending at the middle of the Pacific Ocean.

11502 more COVID-19 cases, 325 deaths in India



New Delhi, Jun 15 (PTI): India saw a jump of over 11,000 novel coronavirus cases for the third consecutive day on Monday, taking the total number of infections to over 3.32 lakh, while the toll rose to 9,520 with 325 more deaths, the Health Ministry said.

There are 1,53,106 active cases of the coronavirus disease (COVID-19), while 1,69,797 people have recovered and a patient has migrated, according to the ministry data updated in the morning.

Therefore, 51.07 per cent of the patients have recovered so far, an official said. The number of confirmed cases rose to 3,32,424 with 11,502 new infections in the last 24 hours, the ministry said.

As many as 120 out of the 325 more deaths were from Maharashtra, followed by 56 from Delhi, 38 from Tamil Nadu and 29 in Gujarat. There were 14 more fatalities in Uttar Pradesh, 12 each in West Bengal and Madhya Pradesh, and 10 each in Rajasthan and Haryana.

Five COVID-19 deaths were reported from Karnataka, followed by four in Jammu and Kashmir, three each in Telangana

and Puducherry, and two each in Andhra Pradesh, Chhattisgarh and Punjab. A person each suc-

cumbed to the infection in Uttarakhand, Himachal Pradesh and Odisha. India is the fourth worst-hit nation by the

pandemic after the US, Brazil and Russia. According to the Johns Hopkins Universitv. which has been compiling COVID-19 data from all over the world,

India is in the ninth posi-

tion in terms of death toll. Of the total 9,520 deaths, Maharashtra tops the tally with 3,950 fatalities, followed 1,477 by Gujarat and 1,327 in Delhi.

The toll from the pandemic rose to 475 in West Bengal, 459 in Madhya Pradesh, 435 in Tamil Nadu and 399 in Uttar Pradesh. There have been 292 COVID-19 deaths in Rajasthan and 185 in Telangana.

The number of fatalities reached 88 in Haryana, 86 in Karnataka, 84 in Andhra Pradesh, and 67 in Punjab. Jammu and Kashmir has reported 59 COVID-19 deaths, followed by 39 in Bihar, 24 in Uttarakhand and 19 in Kerala

Pandemic leads to a bicycle boom, and shortage, around world

Portland (US), Jun 15 (AP): Fitness junkies locked out of gyms, commuters fearful of public transit, and families going stir crazy inside their homes during the coronavirus pandemic have created a boom in bicycle sales unseen in decades.

In the United States, bicycle aisles at mass merchandisers like Walmart and Target have been swept clean, and independent shops are doing a brisk business and are selling out of affordable family bikes.

Bicycle sales over the past two months saw their biggest spike in the US since the oil crisis of the 1970s, said Jay Townley, who analyses cycling industry trends at Human Powered Solutions.

People quite frankly have panicked, and they're buying

bikes like toilet paper, Townley said, referring to the rush to buy essentials like toilet paper and hand sanitizer that stores saw at the beginning of the pandemic.

The trend is mirrored around the globe, as cities better known for car-clogged streets, like Manila and Rome, install bike lanes to accommodate surging interest in cycling while public transport remains curtailed.

In London, municipal authorities plan to go further by banning cars from some central thoroughfares.

Bike shop owners in the Philippine capital say demand is stronger than at Christmas.

Financial incentives are boosting sales in Italy, where the government's post-lock-

down stimulus last month included a 500-euro (575) bici bonus rebate for up to 60% of the cost of a bike.

But that's if you can get your hands on one. The craze has led to shortages that will take some weeks, maybe months, to resolve, particularly in the US, which relies on China for about 90% of its bicycles, Townley

Production there was largely shut down due to the coronavirus and is just resuming.

The bicycle rush kicked off in mid-March around the time countries were shutting their borders, businesses were closing, and stay-at-home orders were being imposed to slow the spread of the coronavirus that has infected millions of people and killed more than 450,000.

Sales of adult leisure bikes tripled in April while overall US bike sales, including kids' and electric-assist bicycles, doubled from the year before, according to market research firm NPD Group, which tracks retail bike

It's a far cry from what was anticipated in the US. The 6 billion industry had projected lower sales based on lower volume in 2019 in which punitive tariffs on bicycles produced in China reached 25%.

There are multiple reasons for the pandemic bicycle boom. Around the world, many workers were looking for an al-

ternative to buses and subways. People unable to go to their gyms looked for another way to exercise. And shut-in families scrambled turn to pg 02

Law and order situation failing in Sikkim: Nawin Kiran

Sikkim Subject Committee [SSC] vice-convener, Nawin Kiran Pradhan has made a serious allegation that the law and order situation in the State is deteriorating and the police have failed to work independently. He was talking with reference to the recent attack on Sikkim Democratic Front spokesperson, JB Darnal by unknown persons.

Regarding the same, SSC submitted a memorandum to the Governor, Ganga Prasad on Monday urging that Sikkim Police be allowed to function without any pressure and asking for the Chief Secretary and the Director General of Police to be summoned regarding the attack on Mr Darnal. SSC has asked for the case to be handed over to an independent investigation agency if Sikkim Police cannot find the culprits.

A copy of the memorandum has also been sent to the Prime Minister with a request to ask for the investigation report on the attack on Mr Darnal from the State government. Copies have also been sent to Union Home Minister and National Human Rights Commission and State Human Rights Commission.

Addressing a press conference here on Monday, Mr Pradhan alleged that the life-threatening attack on SDF spokesperson could be a political conspiracy to suppress the voice of the people. He alleged that Sikkim Police has been taking action only against opposition leaders.

He stated that the police have not been able to make any progress in the investigation regarding the attack.

Another SSC member, Arun Limboo stated that if an opposition leader was attacked in broad day light in an urban area then such incidents can happen to anyone.

Odisha registered 11 coronavirus deaths so far, followed by eight each in Jharkhand, Chhattisgarh and Assam, and seven in Himachal Pradesh.

Five people have succumbed to the contagion in Chandigarh and Puducherry, and one each in Meghalaya, Tripura and Ladakh, the ministry said.

More than 70 per cent of the deaths are due to comorbidities, it added.

The maximum number of cases are from Maharashtra with 1,07,958 infections, followed by 44,661 in Tamil Nadu, 41,182 in Delhi and 23,544 in Gujarat.

The tally rose to 13,615 in Uttar Pradesh, 12,694 in Rajasthan and 11,087 in West Bengal. The number of COVID-19 cases has gone up to

10,802 in Madhya Pradesh, 7,208 in Haryana, 7,000 in Karnataka, and 6,470 in Bihar. As many as 6,163 people have contracted the

deadly disease in Andhra Pradesh, followed by 5,041 in Jammu and Kashmir, 4,974 in Telangana, 4,049 in Assam and 3,909 in Odisha.

There are 3,140 cases of the pathogen in Punjab and 2,461 in Kerala, while 1,819 people have been infected in Uttarakhand and 1,745 in Jharkhand.

A total of 1,662 people are afflicted with the disease in Chhattisgarh, followed by 1,076 in Tripura, 564 in Goa and 518 in Himachal Pradesh.

The number of coronavirus cases rose to 458 in Manipur, 549 in Ladakh and 352 in Chandigarh.

Puducherry has registered 194 COVID-19 cases so far, followed by 168 in Nagaland, 112 in Mizoram and 91 in Arunachal Pradesh. Sikkim has 68 COVID-19 cases, while there are 44

infections in Meghalaya and 38 in the Andaman and Nicobar Islands. Dadar and Nagar Haveli and Daman and Diu have

registered 36 COVID-19 cases so far.

The figures are being reconciled with the Indian Council of Medical Research, the ministry said, adding that 6,972 cases were being reassigned to states.

Statewise distribution is subject to further verification and reconciliation, it added.

Potters are on the brink of starvation

he lockdown due to Corona has also who make pottery. They have made the above people. earthenware pots but due to lack of sale, they are

also tired of eating. But now neither the chalk is running nor the shops are opening. The pottery lying for sale on

the house and chalk has to be taken care of. People of Prajapati Samaj all over the country work in making pottery.

The lockdown caused by Corona has turned their hopes upside down. Their utensils are not being sold. Months of hard work are kept out of the house. In these circumstances, it has become difficult to support the family. Given the summer season, potters made a

large number of pots. Designers also designed small pots and piggy banks with pots. Even today some people prefer potable water. But this time they lost money. How the family will run. No one is coming to buy pots. People involved in the business have also stopped selling pots by putting them on carts.

The initiative of Yogi Adityanath, the Chief Minister of Uttar Pradesh, has created a hope for the skilled workers earning their livelihood through pottery, for the people of Prajapati Samaj across the country, according to which a Micro Mati Kala Common Facility Center will be set up in every division of the state. (CFC) will be constituted. The cost of CFC will be Rs 12.5 lakh, to which the government will contribute Rs 10 lakh. The balance has to be borne by society or the concerned institution. Land, if not available with the institution or society, will be provided by the Gram Sabha. Each center will have gasfired furnaces, pugmills, electric pot chucks, and other equipment for processing soil in the earth. Workers will have all the facilities to develop their products under one roof. Employment will be provided to more and more people through these centers.

This is a great effort of khadi and village industry, if the products are of quality and their prices are reasonable, then there will be good demand for them in the market. This will increase employment opportunities locally for business people. Also, lifting soil from ponds will increase subsequent water-storage capacity. By making these products an alternative to polyethylene, polyethylene contamination will also be prevented. 8,894 people under quarantine in Mizoram

AIZAWL, JUN 15 (PTI): As many as 8,884 people are currently under quarantine in Mizoram, state Health minister Dr R Lalthangaliana said on Monday.

Most of them are quarantined at institutional facilities while others are lodged at community facilities, some are in home quarantine and some have put up in hotels.

The health minister on Monday visited several quarantine facilities set up by churches here.

Expressing apology to those inmates, who have completed their quarantine period but need to stay back at their respective quarantine facilities due to delay in getting sample results, Lalthanglaima said, the testing process could not be expedited because installation of automated RNA extractor machines was in progress.

He said that the government is currently running two Real-time Polymerase Chain Reaction (RT-PCR) machines, at Zoram Medical College (ZMC) to test samples for COVID-19.

Similar machines will soon arrive in the state and one of them will be installed at Lunglei to cater to the needs of people, he said.

"We hope that our testing ratio will increase once the new machines are installed," he said.

According to the International Atomic Energy Agency, the RT-PCR technique is highly sensitive and specific and can deliver a reliable diagnosis as fast as three hours, though usually laboratories take on average between six to eight hours.

The health minister also said that at least 116 coronavirus patients are currently undergoing treatment in different parts of the state.

Of the 116 patients, 43 are undergoing treatment at the ZMC, he said.

All the 116 patients are in stable condition, he added.

to find a way to keep kids active during stay-at-home

Kids are looking for something to do. They've probably reached the end of the internet by now, so you've got to get out and do something, said Dave Palese at Gorham Bike and Ski, a Maine shop where there are slim pickings for family-oriented, leisure bikes.

Bar Harbour restaurateur Brian Smith bought a new bike for one of his daughters, a competitive swimmer, who was unable to get into the pool.

On a recent day, he was heading back to his local

bike shop to outfit his youngest daughter, who'd just learned how to ride. His three daughters use their bikes every day, and

the entire family goes for rides a couple of times a The fact that they're getting exercise and enjoying

fresh air is a bonus. It's fun. Maybe that's the bottom line. It's really fun to ride bikes, Smith said as he and his 7-year-old daughter, Ellery, pedaled to the bicycle shop.

The pandemic is also driving a boom in electric-assist bikes, called e-bikes, which were a niche part of the overall market until now. Most e-bikes require a cyclist to pedal, but electric motors provide extra oomph.

VanMoof, a Dutch e-bike maker, is seeing unlimited demand since the pandemic began, resulting in a 10-week order backlog for its commuter electric bikes, compared with typical one-day delivery time, said co-founder Taco Carlier. The company's sales surged 138% in the US and

rocketed 184% in Britain in the February-April period over last year, with big gains in other European

The company is scrambling to ramp up production as fast as it can, but it will take two to three months to meet the demand, Carlier said.

We did have some issues with our supply chain back in January, February when the crisis hit first in Asia, said Carlier.

But the issue is now with demand, not supply.

Sales at Cowboy, a Belgian e-bike maker, tripled in the January-April period from last year. Notably, they spiked in Britain and France at around the same time in May that those countries started easing lockdown restrictions, said Chief Marketing Officer Benoit Simeray.

It's now becoming very obvious for most of us living in and around cities that we don't want to go back into public transportation, said Simeray.

But people may still need to buy groceries or commute to the office one or two days a week, so then they're starting to really, really think about electric bikes as the only solution they've got.



Fees fixed for COVID-19 tests in private labs, hospitals in Hyderabad

HYDERABAD, JUNE 15 (PTI): The cost of conducting a COVID-19 test in private lab has been fixed at Rs 2,200 and the fee for treatment of the infection in corporate hospitals Rs 4,000 per day.

These charged were fixed by the Telangana government on Monday.

The chief minister K Chandrashekhar Rao held a review with the chief secretary and other senior officials and announced some key decisions on Sun-

One of them is giving nod to private labs who have taken permission to conduct tests.

The fee for the test is Rs 2,200, Health Minister E Rajender told report-

The charge for treatment of patients in ICU without ventilator support has been fixed at Rs 7,500 per day, while it would be Rs 9,000 per day for those who are on such support, he said.

Since the cost of some anti-viral injections is in the range of Rs 40,000 Rs 50,000, such treatment can be charged separately, he said. The government would like to convey to the private players not to consider views of those who would like to get tested without having any symptoms, he said.

The information related to tests and those undergoing treatment at private government as preventive measures, including tracing of contacts and others, need to be taken, he said.

The chief minister has allowed recruitment of healthcare personnel on a temporary basis, if necessary, to conduct a survey of every house in Hyderabad for influenza like illness (ILI) and severe acute respiratory infections (SARI), pneumonia cases and others, he said.

He said Telangana is in a position to conduct about 7,500 tests per day, he said.

People should utilise government healthcare facilities and if those who can pay to go to private hospitals, they can do so, he said.

The state government has received requests from some people who wanted to choose the private sector, Rajender said.

Asked about the 50,000 tests proposed to be conducted in Hyderabad and adjoining areas as part of measures to contain the infection, he said the 50,000 tests would be conducted free of cost from the coming week to 10 days.

The government is ready to conduct more tests if necessary.

Quoting ICMR (Indian Council of Medical Research), Rajender said there is no community spread of the virus in Telangana.

The state has followed the guidelines of ICMR, he said.



Work Harder at Inspiring Excellence

More attention should be diverted to stem the regression from privileges to entitlement

A recent discussion on ideas of identity teased out something which should have been obvious all along – a lot of the passion behind reinforcing and reasserting identities, as much as they may be about ideas of self and of belonging, are also about privileges which accrue when such claims fructify. Privileges, however, are only one step away from ingraining a sense of entitlement even instilling sloth, and that is where futures can get compromised.

Maybe the minds that should be applying themselves to finding solutions are too occupied with other pursuits or maybe because the fire in the belly is just not burning strongly enough, whatever the reason, measures aimed at securing the futures for the present and coming generations remain perennially short-term in Sikkim. We speak of employment here. Quotas, reservation and guaranteed employ ment are short-term measures; options put in place till such time that the 'local' workforce acquires the skills and training required for the wider opportuni ties available. Make these protections permanent and the policy ends up rewarding mediocrity because it stops placing a premium on excellence. Why, after all will a 'local' work hard at becoming employable when the carrot of guaranteed placement keeps dancing in front of him/ her? In fact, to do so [work hard at becoming employable] would be seen as a waste of energy by many. But this approach is self-defeating. Sikkim is growing, both, in census figures and aspirations, and the job opportunities here will never be able to keep pace. Every job opportunity that opens in Sikkim in the next five years, once it is filled, will remain occupied on an average for the next thirty years Even if all these job openings are made available only to locals, one still looks at an increasing number of job seekers entering the job market every year. School enrolments are up and the number of graduates has been consistently rising in the State, why, despite the density of "universities" here and one proper Central University, the State is in the process of establishing a state university as well because of the overflow. Given how young the pursuit of education is in Sikkim and the manner in which the population is growing the number of job-seekers will keep multiplying ev ery year. The State, even after 100% reservation, will soon run out of job opportunities.

The policy makers in government and noise makers outside have to realise that the solution is not in reserving jobs in Sikkim, but grooming generations to become employable anywhere in the world. Once that happens, jobs in Sikkim will automatically go to locals and this will come bundled with pride because they would have been earned on merit and not recommendations or old laws. This cannot happen though if people are spoilt for doles. It is not suggested that jobs in Sikkim should not be reserved for locals; what is being suggested is that celebrating protectionism only grooms mediocrity. Protections exist and should be maintained as a safety net, but aspirations have to be set much higher. One way to do this would be by fixing accountability not just on those who organise skill development programmes [by checking up on how many self-employed youth emerged from the training], but also following up on the funds the government invests on students by way of free education, text books, scholarships and other aids. It would not be a bad idea to release figures on how much the State spends on an average on its youth since the time they join school to the time they graduate. When the figure stares them in the face in black & white, maybe more of the youth will be inspired to put their education to better use than demanding a job from the government If this happens, they will inspire more to follow in their footsteps. That is the chain reaction of achievers that the State has to aim at setting off, not pampering the youth with a policy that makes them lazy.

The next once-a-century pandemic is coming sooner than you think – but COVID-19 can help us get ready

COVID-19 is being referred to as a "once in a century event" – but the next pandemic is likely to hit sooner than you think.

In the next few decades, we will likely see other pandemics. We can predict that with reasonable confidence because of the recent increased frequency of major epidemics (such as SARS and Ebola), and because of social and environmental changes driven by humans that may have contributed to COVID-19's emergence.

A COVID-19-type pandemic had long been predicted, but scientists' warnings weren't heeded. Right now, while we have the full attention of politicians and other key decision-makers, we need to start rethinking our approaches to future preparedness internationally and within our own nations. That includes countries like New Zealand, where – despite getting its active COVID-19 cases down to zero in June 2020 – big challenges remain.

WE CAN'T SAY WE WEREN'T WARNED

Less than five years ago, I was one of about 100 global experts invited to a World Health Organization (WHO) meeting in Geneva, prompted by the then ongoing Ebola outbreak in West Africa.

Then, as now, WHO was criticised for its response to the outbreak. The December 2015 meeting was meant to improve international collaboration and preparation for future epidemics and other infectious disease risks.

The very last presentation was from Dr David Nabarro, then the United Nations Special Envoy on Ebola (and now a Special Envoy on COVID-19).

In the wake of the Ebola outbreak, politicians were more focused on public health than ever before. Nabarro urged us to show greater leadership and capture that interest, before political and public attention moved on. He stressed the importance of trust, respect, transparent communication, and working with nature.

Yet five years later, we're still talking about inadequate funding for pandemic preparedness; delays in adopting preventive measures; failure to develop surge capacity in health systems, laboratories and supply chain logistics; and reduced infectious disease expertise.

But there are signs that some lessons may have been learned. For example, countries most affected by SARS (such as Taiwan and Singapore) have tended to respond more quickly and decisively to COVID-19 than oth-

tively together internationally, each country will need its own strategy. So what should we be doing to protect New Zealand from future infectious diseases threats?

Our health system has, for the most part, responded well to COVID-19. Our research institutions and universities have engaged quickly and effectively to provide scientifter value from such collaborations.

We need to strengthen capability in such areas as epidemiology, modelling and outbreak management, and build pandemic plans that are flexible enough to respond to all eventualities. New Zealand has a Centre of Research Excellence in plant biosecurity – but not in animal biosecurity or infectious diseases. We also need to

Primed and ready, vaccine developers have progressed at enormous pace, with several COVID-19 vaccine candidates already undergoing clinical trials. The volume and pace of sharing scientific information about COVID-19 has been unprecedented.

We've also seen a number of rapid reports urging us to learn from this pandemic and past epidemics to protect us from future events – especially by taking an holistic "One Health" approach. This brings together expertise across human health, animal health and the environment.

For instance, last month the Lancet One Health Commission called for more transdisciplinary collaboration to solve complex health challenges. Similarly, the World Wide Fund for Nature's March 2020 report on The Loss of Nature and Rise of Pandemics highlighted the likely animal origin of COVID-19, and how intimately connected the health of humans is to animal and environmental health.

WHAT NEW ZEALAND CAN LEARN FROM COVID-19

Yet we can and must still do better. Our expertise and systems are not always well joined up – vital for coordinated and timely responses to challenges like COVID-19.

We allow scientists to work in silos, despite obvious overlapping interests and skill sets. Of particular importance for tackling infectious diseases is the need to break down artificial barriers between human, animal and environmental health.

This approach makes particular sense in New Zealand. We are an island nation vulnerable to introduced infectious diseases, and economically dependent on agriculture and the physical environment. But we're also home to an existing indigenous Māori worldview and knowledge system that emphasises interconnectivity between humans, animals and the environment.

University-led efforts, such as One Health Aotearoa, have brought together professionals and researchers from different disciplines. But more investment is needed to get even betbetter integrate science and research into the health system, a key feature of the New Zealand Health Research Strategy 2017-2027. This requires a culture change so research is regarded as business as usual for district health boards, providing the science needed to inform policy, preparedness and best practice.

Coronavirus: Fake news less of a problem than confusing government messages – new study

Studies have suggested social media is rife with disinformation, with surveys showing a high proportion of people have been exposed to false or misleading claims about COVID-19, fuelling dramatic headlines.

But our six-week diary study of news audiences between April 16 and May 27 found that the vast majority of our panel of 200 participants could easily spot fake news. They found stories such as the conspiracy theory that 5G is responsible for the spread of COVID-19 or the quack remedy that gargling with saltwater cures coronavirus immediately suspect.

So it wasn't fake news being peddled on social media or conspiracy websites that was of most concern. When we asked them about what false or misleading information about COVID-19 they had encountered, many instead referenced examples of what they saw as government or media misinformation.

Our panel of news audiences was made up from a representative mix of the UK population. We mainly asked them questions aimed at finding out about their knowledge of the pandemic and the way it was reported by news media.

RETHINKING COVID-19 MISINFORMATION

When representative surveys reveal that many people have seen disinformation about COVID-19, it is not always clear what the false or misleading information they have seen was – or where it came from. What's more, even when people are exposed to disinformation, we often assume rather than question whether it will affect their understanding of the pandemic.

But when we asked respondents about some of the most prominent false claims associated with COVID-19 disinformation they were easily detected. For example, the vast majority of participants rightly said 5G was not responsible for spreading the pandemic, that drinking more water does not kill the coronavirus and that gargling with saltwater is not a cure for COVID-19.

But while our panel could easily spot fake news, they were less aware of issues that may help them understand how the pandemic is being handled. Three in ten respondents did not know the government had failed to regularly meet its testing targets, for example. Almost a third did not realise living in more deprived areas of England and Wales increased the likelihood of catching the coronavirus. And many participants underestimated the UK's death toll compared to other countries and were suspicious of the UK government's figures.

After new lockdown measures were announced in England on May 10, we also found many people did not realise they did not necessarily apply to Scotland, Wales or Northern Ireland. Half of all respondents wrongly believed the UK government was in charge of the lockdown measures across all four nations.

GOVERNMENT AND MEDIA MISINFORMATION

When we asked participants what counted as misinformation, some respondents mentioned discredited medical claims, such as Donald Trump believing that injecting disinfectant protects against the coronavirus. But many more told us that either government claims or the media were responsible for spreading false or misleading information. As one respondent told us:

"Misinformation to me would be reading an article saying schools to go back on June 1 without many details and then finding out it's just a phased reintroduction for certain age groups. It's panicking many parents when that didn't need to happen, headlines should still be brief but not misleading."

Another participant believed misinformation "related to things the government have said that have later turned out to be false, such as the PPE shortage, number of tests done, care home deaths. I think misinformation in this case relates to the media rereporting facts that haven't been clear by the government in statements."

Broadcasters have long been caught up in debates about how far they fact-check government statements while ensuring that the public believe they are being impartial. When we asked respondents about this difficult balancing act, many believed a greater emphasis on fact-checking would enhance rather than undermine public trust in journalism.

As one respondent put it: "I think fact checking is more relevant than ever before because unfortunately people in power make false claims that, sad-

ly, are believed by many people."
ADDRESSING PUBLIC CONFUSION

Public faith in the government's handling of the pandemic has fallen dramatically since mid-April. We watched this develop during our six-week study from April 16 to May 27.

Over this period, participants told us they wanted more media scrutiny of government decision-making, including fact-checking dubious claims. They also wanted more experts informing media coverage rather than politicians.

If it becomes routine for government ministers to appear at the daily Downing Street press briefing without any scientific or health experts – as happened on June 6 – it may limit how far journalists can quiz them about their advice to ministers. As Sky News' political correspondent, Sam Coates, has pointed out, with no scientific advisers present, it allows the government to select the most politically convenient evidence when responding to questions.

With public confidence in the UK government plummeting, broadcasters have an increasingly important role to play in the pandemic. Over the sixweek study, our respondents have consistently said they want accurate and impartial information, with journalists regularly fact-checking political statements and challenging any dubious claims.

Our research suggests broadcasters may have helped people become fairly confident in spotting egregious examples of fake news. But many participants were confused by more routine political decisions, most strikingly the lockdown measures that can affect people in England differently to Scotland, Wales and Northern Ireland.

For broadcasters to more effectively counter misinformation, our research tells us it is not only about boldly questioning what politicians say and holding the government to account. It is about identifying what people are most confused about and finding ways to raise their level of understanding about complex and contentious issues.

Bengal's Tarapith temple still closed to devotees

JUN 15 (PTI): Though many famous places of worship in West Bengal have opened their doors to devotees with adequate precautionary measures in the wake of the COVID-19 outbreak, the Tarapith temple will take more time to unlock its gates, an official said.

The authorities of the centuries-old shrine have expressed concern over health safety of devotees, amid the rise in COVID-19 cases in the state, he said.

The state government has granted permission to all places of worship to unbolt their doors to the devotees from June 1, while stressing that safety protocols have to be strictly followed at all

The Tarapith temple committee had, earlier, announced that it would unlock the doors of the shrine from June 15.

"We have decided not to open the gates from Monday and will monitor the overall situation for some more days. The prevailing condition is not satisfactory as the number of COVID-19 cases is on the rise in the state and also in the country," the temple



committee's secretary Taramov Mukherjee said. India saw a jump of

over 11,000 novel coronavirus cases for the third consecutive day on Monday, taking the total number of infections to over 3.32 lakh, while the toll rose to 9,520 with 325 more deaths, the Union Health Ministry

According to a bulletin, West Bengal registered 389 fresh coronavirus cases on Sunday, taking the infection tally to 11,087 in the state.

Arrested ULFA cadre declared brought dead by hospital

JORHAT (ASSAM), JUN 15 (PTI): A suspected UL FA-I cadre who was apprehended during an anti-insurgency operation jointly by the army and the Assam police, was declared brought dead when he was rushed to Jorhat Medical College Hospital, a district official said on Monday.

On reaching there, the army team reported that the victim was feeling unwell so police from the Borhulla police station rushed him to the local community health centre. There doctors on duty gave him preliminary treatment and referred him to Jorhat Medical College Hospital where he was declared brought dead, the DC said.

A magisterial inquiry headed by senior additional deputy commissioner Tapan Gohain has been constituted and will submit his report within 10 days from today.

For, those in vehicles performed the prayers from inside their vehicles, those who came without vehicles went into the main building and those who could not make it to the mass attended it online," the pastor told PTI.

According to Vineeta who handles public relations for the church, its authorities stumbled upon the idea of organising the 'Drive-in Worship' to let the worshippers perform their religious obligation without any hindrance.

Odisha: 146 new COVID-19 cases; tally crosses 4,000

BHUBANESWAR, (PTI): Odisha's COVID-19 tally on Monday crossed the 4,000mark, with 146 more people, including nine disaster response personnel, testing positive for the infection, a Health Department official said.

With these fresh patients, the total number of COVID-19 cases in the state rose to 4,055, he said. Of the 146 cases, 128 were detected in various quarantine centres where people returning from different states are staying, while 18 were found in contact-tracing exercises, the official said.

"The new cases included nine disaster the state fire service, who were engaged in post-cyclone-Amphan restoration works in West Bengal and had returned from there," he said.

With this, the total number of disaster response men getting infected with the disease has increased to 158.

Odisha has now 1,333 active cases, while 2,708 people have recovered from the disease.

Eleven people have succumbed to the disease, while three other COVID-19 patients have also died in the state, but their deaths were attributed to other reasons.

The new cases

response personnel of were reported from 15 districts.

Kandhamal reported the highest of 48 fresh cases, followed by 19 each from Bhadrak and Cuttack and eight each from Balasore and Ganjam.

Russia sentences US ex-marine to 16 years in spy trial

A Russian court on had asked the judge to tinue to fight for his re-Monday sentenced sentence Whelan to 18 lease, and criticised the former US marine Paul Whelan to 16 years in a penal colony for espionage in a case that strained ties with Washington and fuelled speculation of a prisoner swap.

Moscow City Court found Whelan guilty of receiving classified information as he stood in the dock with a sign that read "Sham trial!" and pleaded for US President Donald Trump to intervene in the case.

The court process is "slimy, greasy Russian politics nothing more, nothing less," he said.

Whelan, 50, has been held in a Moscow jail since his arrest in December 2018 and his trial was held behind closed doors because of the accusations of seeking to obtain state secrets.

Throughout the trial he maintained his innocence, saying he was framed and comparing himself to the hapless comedy character Mr Bean. "Russia thought they caught James Bond on a spy mission, in reality they abducted Mr Bean on holiday," he said.

Whelan says he was detained on a visit to Moscow to attend a wedding when he took a USB drive from an acquaintance thinking it contained holiday photographs. The prosecution

"We had hoped that the court might show some independence but, in the end, Russian judges are political, not legal, entities," he said.

Whelan was dishonourably discharged as a marine before working as head of global security at a US auto parts com-There had been sug-

gestions that Whelan -- who also has British, Canadian and Irish passports -- could be returned to the US in a prisoner swap.

Whelan's lawyer said on Monday that Russian intelligence services were considering an exchange with two Russians detained in the United States, including pilot Konstantin Yaroshenko, imprisoned on drug smuggling charges.

David Whelan, the brother, said recently that the family hoped a conviction would allow Russia and the United States to "begin discussing Paul's release immediately".

Whelan had complained of being mistreated in prison and late last month underwent an operation in a Moscow hospital that his family said was emergency hernia surgery.

"So it was a bizarre entry into the whole thing, and rightly so. I mean, I had no coaching experience or anything," he said.

Kirsten said when he landed in India for the interview, a chance meeting with the then captain Anil Kumble had them both laughing at

> "I went for the interview, it was a bizarre experience in many ways because I kind of arrived at the interview and I see Anil Kumble, who's the current Indian captain, and he says, 'What are you doing here?'. I said, 'I have come for an interview to coach you!'.

"So we kinda laugh about it. It was quite a laughing matter."

Even though he didn't had any coaching experience then, Kirsten went on to become one of the most successful India coaches of all time, guiding the team to the top of the Test rankings in 2009, and then to the World Cup title two years later.

BP to take up to \$17.5bn hit on coronavirus

m ritish}$ energy giant BP said Monday that it will take a hit of up to \$17.5 billion in the second quarter as "sustained" coronavirus fallout ravages global oil

The company, fresh from outlining plans to axe almost 10,000 jobs on COVID-19 fallout, said in a statement that it will suffer a negative impact of between \$13 billion and \$17.5 billion (11.4 billion euros and 15.3 billion euros) in noncash impairments and write-offs.

BP also cut its longterm oil price forecast after the deadly virus outbreak slammed the brakes on the global economy and hurt oil prices this year.

"With the COVID-19 pandemic having continued during the second quarter of 2020, BP now sees the prospect of the pandemic having an enduring impact on the global economy, with the potential for weaker demand for energy for a sustained period," BP said, adding the virus



was set to accelerate a transition to lower carbon energy.

The group continued: "BP has revised its longterm price assumptions, lowering them and extending the period covered to 2050.

"As part of its longterm strategic planning, and in the context of its continuing focus on capital discipline, BP is also reviewing its intent to develop some of its exploration intangible assets.

"These actions will lead to non-cash impairment charges and writeoffs in the second quarter, estimated to be in an aggregate range of \$13 billion to \$17.5 billion post-tax."

BP Chief Executive in a significant charge in our upcoming results, but I am confident that these difficult decisions ... will better enable us to compete through the energy transition."

BP now expects European benchmark London Brent North Sea oil prices to average \$55 per barrel between 2021 and 2050, while it also lowered its guidance for gas prices. The London-listed energy major had announced plans one week ago to axe "close to 10,000" jobs, or almost 15 percent of its global workforce.

And it warned that oil prices had plunged well below the level which the group needed to turn a profit.

After companies worldwide closed their doors and airlines grounded planes towards the end of the first quarter, oil dropped off a cliff, causing prices to briefly turn negative.

Prices have however rebounded sharply in recent weeks as governments ease lockdowns and businesses slowly reopen.

Europe reopens borders but China battles new virus outbreak



raft of EU nations reopened their **A**borders to fellow Europeans on Monday after months of coronavirus curbs, but China was battling a new outbreak that has stoked fears of a second wave. As caseloads have declined in recent weeks across many parts of Europe, governments have been keen to ease painful lockdowns that have saved lives but devastated economies and wearied confined populations.

Belgium, France, Germany, Greece and Ukraine were among those lifting border restrictions on Monday, while shops and outdoor attractions in England were set to welcome their first customers since March and in Paris cafes and restaurants were allowed to fully reopen.

"We're desperate about tourists, we need them and we want them. If we don't have the people, how will we survive," says Michalis Drosos, who works in a souvenir shop in Fira, capital of the Greek island of Santorini.

However, the pandemic is gathering pace in Latin America, and Iran and India have reported worrying increases in deaths and infections -- adding to concern over challenges the world will face in the long fight against COVID-19.

China, where the virus emerged late last year, was the first country to implement extreme restrictions on movement early this year, forcing local transmission down to near-zero as the crisis hammered the rest of the world.

But health officials on Monday reported 75 cases of the respiratory illness in Beijing where the fresh cluster has been linked to a wholesale food market. Streams of people queued in a Beijing stadium as mass testing was carried out, and a strict lockdown was extended across 21 Beijing neigh-

- US reports lowest daily toll -

More than 430,000 people worldwide have died from COVID-19, nearly halfway through a year in which countless lives have been upended and the global economy ravaged by the crisis.

The United States -- by far the hardest-hit country with more than 115,700 recorded fatalities -- on Sunday reported its lowest 24-hour death toll since its infection rate peaked in mid-April.

President Donald Trump's administration has noted that some states have seen new flare-ups, but insists there will be no shutdown of the economy even if a new wave arises.

But stock markets tumbled again on Monday on fears that an upsurge of infections could put the brakes on the easing of lockdowns and dash hopes of economic recovery.

- 'Micro-outbreaks inevitable ' -

The Middle East's worst-hit country, Iran, reported an uptick on Sunday, recording more than 100 new virus deaths in a single day for the first time in two months.

Surging infections in India have highlighted the precarious state of its healthcare system, and more than 1,000 new cases are being reported each day in the capital alone.

Mortuaries in New Delhi are overflowing with bodies and cemeteries and crematorium staff say they cannot keep up with the backlog of victims.

There have also been two new outbreaks in Rome, with 109 infections including five deaths diagnosed at a hospital and 15 cases detected at a building inhabited by squatters.

"It means the virus hasn't lost its infectiousness, it isn't weakening... we shouldn't let down our guard," World Health Organization deputy director Ranieri Guerra told journalists.

"Such micro-outbreaks were inevitable, but they are limited in time and space. And today we have the tools to intercept them and confine them."

- 'It's going to be a party' -

Despite fears over fresh clusters, many countries are making moves towards semi-normality.

In Paris, restaurant and cafe owners were cheering after the government said they could once again open their dining rooms, three months after being shut to blunt the coronavirus outbreak.

Until now, restaurants in and around the capital could only serve clients on outdoor terraces, even though eateries in the rest of the country opened fully earlier this month.

"It's going to be a party," Stephane Manigold, owner of four Paris restaurants, including the two-starred Maison Rostang, told AFP.

In England, thousands of non-essential retailers such as bookshops and electronics outlets will be welcoming their first customers since halting instore business in late March.

Drive-in cinemas, safari parks and the outdoor parts of zoos will also be able to reopen, while places of worship are also set to swing open their doors again for individual prayer.

Egypt says it will open its doors for tourists to beach resorts in July, and Peru's Machu Picchu will also reopen next month, although it will sharply reduce the number of daily visitors.

And top-level football continues its return in Europe with the English Premier League making its long-awaited comeback this week, days after Spain's La Liga.

Facebook rejects call to share revenue with Australian media

 ${f F}$ acebook on Monday rejected calls from the Australian government and news companies that it share advertising revenue with the media, suggesting it would rather cut news content from its platform.

The US tech giant said in a submission to Australia's competition watchdog that news represents a "very small fraction" of the content in an average user's news feed.

"If there were no news content available on Facebook in Australia, we are confident the impact on Facebook's community metrics and revenues in Australia would not be significant," it said in a thinly veiled threat to boycott local news companies.

"Given the social value and benefit to news publishers, we would strongly prefer to continue enabling news publishers' content to be available on our platform," it said. In an effort being closely watched around the world, Australia is set to unveil plans to force Facebook and Google to share advertising revenue they earn from news featured in their services. The initiative has been strongly pushed by Australia's two biggest media companies, Rupert Murdoch's News Corp and Nine Entertainment.

They argue that the crisis roiling the news industry worldwide is mainly because of Google, Facebook and other large tech firms capturing the vast majority of online advertising revenues, without fairly compensating media companies for advertisements placed against news content.

Newspapers' loss of advertising dollars has forced cutbacks and bankruptcies across the sector, a process exacerbated by the economic downturn caused by the coronavirus pandemic.

More than 170 newsrooms have seen cuts or halted publication in recent years.

Australia's competition regulator, the ACCC, has estimated that Google and Facebook together earn some Aus\$6 billion (US\$4 billion) a year from advertising in the country. Leading news publishers have demanded the two companies pay at least 10 percent of that money each year to local news organisations. Google last month already rejected the demand, saying it made barely Aus\$10 million a year from news-linked advertising.

Google and Facebook both argue they provide hundreds of millions of dollars in value to Australian news companies by driving traffic to their websites, where they can be monetised through ads or turned into paying subscribers.

"We allow news organisations of all sizes, not just the big ones, to post links, raise awareness of their brands and drive monetisable traffic to their websites, free of charge," said Mia Garlick, Facebook's director of public policy for Australia and New Zealand. Facebook and Google also say they provide millions of dollars to media companies through grant programmes and limited purchases of news content. Both companies say they are willing to participate on a collaborative "code of conduct" in Australia to mediate complaints, provide greater transparency in how they rank and distribute news on their platforms and share data on user interactions with their content.

MANILA, JUN 15 (AP): An award-winning journalist critical of the Philippine president was convicted of libel and sentenced to jail on Monday in a decision called a major blow to press freedom in an Asian bastion of democracy.

The Manila court found Maria Ressa, her online news site Rappler Inc. and former reporter Revnaldo Santos Jr. guilty of libeling a wealthy businessman. The Rappler's story on May 29, 2012, cited an unspecified intelligence report linking him to a murder, drug dealing, human trafficking and smuggling. The site's lawyers disputed any malice and said the time limit for filing the libel complaint had passed.

"The decision for me is devastating because it says that Rappler is wrong," Ressa said in a news conference after the decision was handed down. Her voice cracking, she appealed to journalists and Filipinos to continue fighting for their rights "and hold power to account".

She was sentenced to up to six years but was not immediately taken into custody. Ressa posted bail for the case last year, and her lawyer said they will appeal the verdict.

Businessman Wilfredo Keng dismissed the allegations as baseless and false and said Rappler refused to take down the story online and publish his side of the story. He provided government certifications in court to show that he has no criminal record and sought 50 million pesos (USD1 million) in damages, which he said he would donate if he won the case. Rappler's lawyers said the story was based on an intelligence report and that the one-year period under Philippine penal law when a libel complaint can be filed had ended when Keng filed a lawsuit in 2017, five years after the story was published online.

A cybercrime law, which Rappler allegedly violated, was also enacted in September 2012 or four months after the story written by Santos was published. Rappler's lawyers said Philippine penal laws cannot be retroactively applied.

Rappler, however, acknowledged that it updated the story in February 2014 to correct a misspelled word but said it did not make any other changes. The Department of Justice, which brought the libel charges to court, contended that by updating the story, Rappler effectively republished the story online in 2014, an argument dismissed by the news site's lawyers.

The Department of Justice cited another law to say that a complaint can be filed under the 2012 cybercrime law for up to 12 years, countering Rappler's argument that Keng's complaint was invalid due to being outside a one-year deadline for libel.

If the Manila court upholds the Justice Department's position, journalists and media agencies can be sued up to 12 years after publishing a As Rappler's chief executive officer, Ressa faces seven other criminal complaints in relation to legal issues hounding her news agency, including an allegation that it violated a constitutional ban on media agencies receiving foreign investment funds.

The moves against Ressa, who has worked for CNN and was one of Time magazine's Persons of the Year in 2018, have been denounced by media watchdogs as a threat to press freedom. President Rodrigo Duterte's government said the complaints were part of normal criminal procedures and were not a press freedom issue.

But Ressa has accused the government of abusing its power and of using the law as a weapon to muzzle dissent. Rappler is one of several local and international news agencies deemed critical of Duterte's poli-

Duterte has openly lambasted journalists who write unfavourable stories about him, including about his anti-drug campaign that has left thousands of mostly poor suspects dead.

Duterte had already banned a Rappler reporter from his news briefings after a government corporate watchdog ruled that the news site violated a constitutional prohibition on foreign ownership of media when it received money from an international investment firm.

Rappler, founded in 2012, rejected the ruling. Duterte has openly

lashed out against the owner of the Philippine Daily Inquirer, a leading daily.

He has vowed in the past to block the renewal of the congressional franchise of ABS-CBN, which was shut down by the government's telecommunications regulator last month after its 25-year franchise expired. Congress has been hearing the leading TV network's request for a renewal of its franchise.



The devastating news of Sushant Singh Rajput's death has divided social media into two. Even as the actor's family prepares for his funeral at the Pawan Hans crematorium at Vile Parle, Mumbai, several Bollywood actors and filmmakers have called for an inward look, questioning the role of 'Bollywood mafia' in the apparent suicide of a 34-yearold promising actor, who managed to carve his niche in the industry without

Kangana Ranaut, who has always been extremely vocal about the issue, released a video on social media reiterating the same.

In the 2-odd-minute video, shared by the official Instagram handle of Team Kangana Ranaut, Kangana says, "Sushant Singh Rajput ki maut ne humein jhinjhor ke rakh diya hai, magar kuch is mein bhi ek parallel narrative chala rahe hai. Woh ye ki jinka dimaag kamzor hota hai woh depression mein aate hai aur suicide kar lete hai. Jo banda Stanford ki scholarship...woh rank-holder hai apne engineering ke entrance ki, uska dimaag kamzor kaise ho sakta hai? (Sushant Singh Rajput's death has left all of us devastated, but some are looking for a parallel narrative even here. That whoever has a weak mind, they slip into depression and kill themselves. A guy who has a scholarship from Stanford... he is a rank holder of his engineering entrance, how can his mind be weak?)"

She goes on to add that some of Sushant's last posts prove that he had been literally begging people to watch his films. "Aap agar unke last kuch posts dekhe, woh clearly keh raha hai, logon ko beg kar raha hai ki please meri filmein dekho, mera koi Godfather nahi hai, mujhe nikal diya jayega iss industry se. Apne interviews mein woh yeh zahir karta hai ki mujhe yeh industry kyu nahi apnati hai? I feel like a leftover (sic). Toh kya iss haadse ki koi buniyaad nahin hai? (If you look at his last few posts, he is clearly saying, begging people to see his films, that I don't have a Godfather, I will be thrown out of this industry. Even in his interviews, he says why doesn't this industry make me its own? I feel like a leftover. So doesn't this incident have any reason?)"

Talking about Sushant's films, Kangana said, "Unko unki debut film Kai Po Che ke liye koi acknowledgement nahi mila, ya MS Dhoni: The Untold Story, ya Kedarnath ya Chhichhore. Gully Boy jaisi ek wahiyat film ko saare awards milte hai, Chhichhore is the best film and by the best director, par unki film ko koi acknowledgement nahi. (He didn't get any acknowledgement for his debut film, Kai Po Che, or MS Dhoni: The Untold Story, or Kedarnath, or Chhichhore. A bad film like Gully Boy gets all awards, Chhich-

but his film gets no acknowledgement.)"

Rajput's death: Was it suicide or planned murder?

Sushant, much like Kangana herself, was an outsider who made his name on the basis of his good work. While nepotism is a constant in Bollywood, where only star kids seem to get the big projects, outsiders often lose out. But Kangana adds that they don't want their films, all they want is recognition for their work. "Humein aapse kuch nahi chahiye, humein aapki filmein nahi chahiye, lekin jo hum khud karte hai, aap uski acknowledgement humein kyu nahi dete hai? Main khud jo filmein direct karti hoon, unn superhit filmon ko yeh flop ghoshit karte hai. Mujhpe chhey cases kyu daale gaye? Kyu mujhe jail mein daalne ki koshish ki gayi? (We don't need anything from you, we

don't need your films, but the films that we do on our own, why don't you acknowledge us for that? The films I myself direct, why do declare those superhit films flop? Why have you slammed six cases on me? Why did you want to put me in jail?)'

Kangana's wrath also fell on a section of the media, who she thinks wrote against Sushant. "Kuch journalist aise hai jo Sushant pe blind items likhte hai ki woh psychotic hai, neurotic hai, addict hai. Sanjay Dutt ki addiction toh aapko badi cute lagti hai. (There is also a section of journalists who write blinds on Sushant, that he is psychotic, he is neurotic, he is an addict. But you find Sanjay Dutt's addiction very cute.)"

She further added, "Woh mujhe message karte hai ki tumhara bohot difficult time hai, tum koi aisa-waisa step mat utha lena. Aisa kyu kehte hai mujhe? Kyu mere dimaag mein daalna chahte hai ki aap suicide kar lijiye? (These people message me that you're going through a difficult time, you don't take any such step. Why do they tell me these things? Why do they want to put these things in my head, that you should kill yourself?)"

Kangana further asks about Sushant's death, "Toh yeh suicide thi ya planned murder tha? (So was it a suicide or a planner murder?)"

Kangana is resilient, and she feels Sushant made one mistake that he accepted others' criticism about himself. "Sushant ki galti yeh thi ki woh unki baat maan gaya. Unhone kaha tum worthless ho, toh woh maan gaya. He didn't remember what his mother told him. Woh log chahte hai ki woh itithaas likhe, aur usmein ye likhe ki Sushant kamzor dimaag ka tha. Woh nahi batayenge ki sachchai kya hai. Toh humein decide karna hai who will write history. We will decide that. (Sushant's mistake was that hore is the best film by the best director, he believed in them. They told him that OTT platform.

he was worthless, and he believed that. He didn't remember what his mother told him. Those people want that they write history, and in it, they write that Sushant was of a weak mind. They will not say what is the truth. So we need to decide who will write history. We will decide that.)"

This outsider vs nepotism battle has been raging on Twitter since the news of Sushant Singh Rajput's suicide broke yesterday. From Shekhar Kapur to Anubhav Sinha, Gulshan Devaiah to now Kangana Ranaut, several celebrities have shared very telling and pointed allegations towards what is known as the 'elite club of Bollywood' or the 'Bollywood mafia', as Kangana likes to call it.

Karan, where she called out KJo for running a cartel of sorts, giving opportunities to only star kids, and making it difficult for the outsiders to get in. She had also used the word nepotism on the show, which is now a part of Bollywood's vocabulary.

Earlier today, Shekhar Kapur tweeted a message for Sushant, talking about how he knew his pain. "I knew the pain you were going through. I knew the story of the people that let you down so bad that you would weep on my shoulder. I wish Iwas around the last 6 months. I wish you had reached out to me. What happened to you was their Karma. Not yours. #SushantSinghRajput (sic)," read Shekar's tweet.

Yesterday, Anubhav Sinha had tweeted, "The Bollywood Privilege Club must sit down and think hard tonight. PS- Now don't ask me to elaborate any further (sic)," after news of Sushant's death broke.

Gulshan Devaiah wrote, "As actors, somewhere deep down inside, we think we know why he did it & that's why it so disturbing even if you didn't know him at all. It's a hard game to play and he played it very well but the game won in the end (sic)." In the following tweet, he added, "Really sorry to be doing this but Bollywood is not a family, it never was and never will be . If one thinks it's a family .. there is the problem. Bollywood is an imaginary name for a place of work that's it . I am really not trying to put anybody down here & sorry if it seems (sic)."

Hong Kong Disneyland will re-open June 18

Hong Kong, Jun 15 (AP): Hong Kong Disneyland will re-open well as fill out health declaration forms and have their tem-June 18, as the city looks to gradually restart its economy amid a dwindling of coronavirus infections. Hong Kong Disneyland, which has been closed since January due to the coronavirus pandemic, will reopen with limited visitor capacity.

It will also introduce social distancing measures in restaurants, rides and other facilities, while suspending activities that require close interaction such as photo sessions with Dis-

nev characters, the park said in a press release Monday. Visitors to the park will also be asked to wear masks, as perature taken upon arrival.

It is the second Disney-branded theme park to re-open globally, following Shanghai Disneyland which opened its doors to guests last month.

Hong Kong's social distancing measures, which prohibits gatherings of more than eight individuals and limits the capacity of restaurants and eateries, are currently in place until June 18. The city has reported 1.110 cases of coronavirus infections so far, with four deaths.
