# Sikkim Votes! And the U-40 hold decisive share

### **VOTER TURN-OUT DROPS TO 78.19%**



### **SUMMIT REPORT GANGTOK, 12 APR:**

Sikkim voted on Thursday. An electorate of 4.32 lakh received the opportunity to decide who forms the next government in Sikkim and who represents the State in Parliament. However, fewer voters than have traditionally shown up exercised their franchise this time with the State reporting a voter turnout of 78.19%, noticeably lower than the 83% who voted in 2014. The districts, however, stayed true to past performances with North Sikkim reporting the highest turnout and East the lowest. Gangtok was again the

lowest voter turn-out.

And while this data will be interesting in its own right, a major factor to keep an eye out for is the youthfulness of the electorate. With 63% of the electorate under forty years of age, this segment now holds a decisive majority for the first time.

As per data collated by the Election office, the 18 to 40 year old voters number 2,74,200 which works out to 63.42% of the total electorate. Of these, the 18-19 year olds number 30,480.

The youth have never been in such a clear majority, and on 23 May, when the verdict locked in the EVMs is calculated, Sikkim will learn which party appealed most to this segment. It will also be interesting to see whether this bloc voted on issues which matter to their age-band or whether their vote was again decided by the traditional factors of community and family.

In the absence of any scientific data collection, there will be no clear answers even after the results are announced. but that should not mean that some speculation cannot be indulged in.

What the numbers confirm, for instance is that 64% of the electorate came of age with the present government already in office. Even

the 40 year old now was but a teenager when SDF formed its first government twenty-five years back.

Building from that, it is also safe to believe that they have no real experience of previous governments to compare the present government with. Their support or rejection of the ruling Front is hence based completely on their perception of the current government's performance.

Similarly, their image of the contenders, with SKM being the primary one, is also based solely on how SKM has conducted itself in the last five years.

But the present day youth is also better informed and can be expected to also evaluate performance and delivery while deciding on which promises appear convincing and which reek

superficial.

Principles and ideology also carry more resonance with the youth and the results will also reflect how the youth rate the parties on this parameter.

As for the parties in the fray, Sikkim almost always sees a quasi-presidential form of election with people voting for the party presidents with the hand-picked candidates having only limited result. When it comes to the youth, such absolute submission to the party will be rare and they can be expected to evaluate the candidates as well. This, if it happens, will be new for Sikkim.

That said. Election 2019 is still a Chamling versus Golay contest, which is unique in the sense that the latter cannot even contest the elections. In that sense. the SKM president, PS contribution to the final Tamang [Golay],

credit, has made a fight of the elections despite his corruption conviction and the law not allowing him to contest for six vears.

SKM remains the main opposition this time as well since no other party has fielded candidates for all 32 constituencies. Also, except SKM, all other opposition parties had forfeited their deposits in the 2014 elections.

ognising that "some political party supporters flagged issue of reserve/ un-used EVMs/ VVPATs being transported yesterday on Social Media." The DEO underlines

that as as per Election Commission of India rules only polled EVMs and VVPATs are kept inside the sealed Strong Rooms and all reserve/ extra/ un-used or defective un-polled machines are required to be kept at a different place in a designated warehouse.

When the unused EVMs were being moved out of the strong-room yesterday, SKM supporters had picketed the strong room and refused the truck to leave. They were clearly convinced that something nefarious was being attempted and it was only much after their candidates arrived and understood the matter from the election officials that the process was allowed to complete and the strong-room emptied of the unused EVMs.

SKM casts doubt on election process, seeks clarification from CEO

### **SUMMIT REPORT** GANGTOK, 12 APR:

Cikkim Krantikari Mor-**S**cha's Complaint Committee has written to the Chief Electoral Officer. Sikkim seeking clarifications on doubts surrounding the conduct of free and fair election in the State. The party has alleged that unused EVMs were being moved around in suspi-

cious manner.

Further, SKM has sought clarification on "speculations going around in the State of Sikkim with regard to replacing of EVMs used in poll with the pre-programmed, tampered machines as well as with regard to EVMs being stored at places other than the specified Strong Rooms".

In the complaint letter, the party has asked the CEO to issue a public declaration "with reasoned and detailed graphic explanation of the machines used, reserved and unused".


SKM has asked for a list of all machines with their numbers that have been utilised in the polling at respective booths, list of all machines that commissioned were but kept reserved for the polling day, list of

unused non-commissioned machines which were moved from various locations on the polling day, and the route map of all utilised EVMs as per their GPS movement tracks and the vehicle details in which these machines were sent to the Strong Rooms of the respective districts by the polling party. The party has also requested for a list of all postal ballots cast booth-wise and constituency-wise.

The letter states that the party reported these incidents to the General Observers appointed for the sole parliamentary constituency and to the general observers of the East District on the night of 11 April and in the morning of 12 April but has not received any clarification from them.

Copies of the complaint letter have also been submitted to the Election Commission of India and the Chief Secretary, Government of Sikkim.

### East DEO refutes allegations...

This, however, was not the only scene created by SKM supporters.

The DEO informs that "an issue of Route discussion and allegation of tampering with machine was made against one polling party of Upper Burtuk in late night and team was forced to wait for three hours on the way by some people. The issue was later resolved amicably on interaction by District Administration and Security agencies."

Eventually, when the polling party arrived at the reception centre all seals were checked and no tampering or irregularities were found.

Accordingly in both cases all political party representatives were briefed in detail and they were fully satisfied. Even these explanations were videographed and general observers were briefed on the issues, the release details.

DEO has requested all general public not to believe in any rumours about poll process tampering or any possibilities of manipulation in machines which is an impossible and unthinkable thing. Our District Election team has worked hard and always as per the Election Commission of India guidelines which will be followed in all process too, the DEO reassures.

He explains further, "All EVMs/VVPATs are numbered uniquely and the same is checked in every stage to ensure there are no manipulations or mistakes. Everyone needs to be assured that all due process have been followed and issue raised have been resolved to the full satisfaction of concern parties. All contesting candidates have been provided with list of Commissioned EVMs and those used in Polling on the Poll day which cannot be altered."

The DEO has also categorically denied allegations if any of attempts of deviations or malpractices during entire process till now and reiterates that it has been ensured polls are totally transparent, free, fair and in accordance with Election Commission of India's idea of democratic elections.

Congress has reiterated its boycott [partial] of the Assembly elections, considering that the matter was sub-judice since a petition challenging the constitutional validity of the Legislative Assembly elections in Sikkim 1979 was currently being heard in the High Court.

A press release issued by the Sikkim Congress Pradesh Committee on 11 April states: "The people of Sikkim still participating in the election process is testimony to either their ignorance of rights or the

acceptance of the fallacies and weaknesses of our country's system of governance, which includes all the three pillars our democracy, the political system, the judiciary and the executive. This is indeed unfortunate for the world's largest democracy."

The release contends that when the seats reserved for the Sikkimese Nepali were done away with in 1979 in violation of Article 371F of the Constitution of India.

"The violation of this article in terms of assembly seats reservation... has been virtually accepted by the electorate since 1979, since the concerned political

leaders never committed to restore it, nor did the people raise their voice in truly rejecting it," the release states, while adding, "This is probably because democratic responsibility amongst Sikkimese is yet to mature and true democracy yet to take deep roots in Sikkim. # Incriminating docu-

I-T raids multiple locations in TN to

CHENNAI, APR 12 (PTI): The Income-Tax Department Friday conducted searches at multiple locations in Tamil Nadu on suspicion of alleged illegal cash being pumped in to lure voters in the pollbound state and seized cash of about Rs 15 crore, officials said.

They said a total of 18 locations in Chennai, Namakkal and Tirunelveli are being raided since early morning hours.

In the first instance, tax sleuths searched the premises of a contractor firm PSK Engineering Construction Company on charges of routing and possession of alleged "unaccounted cash".

Three premises in Chennai and four linked to the company in Namakkal are being raided, they said.

"Unaccounted cash of Rs 14.54 crore, with Rs 13.80 crore from four premises belonging to the construction company, has been seized," a senior official said.

details of generation of unaccounted money by inflation of expenditure, payments made to influential persons and also unaccounted capital introduced into businesses were also seized, the official said.

In the second case, the Chennai investigation wing of the department searched a group of cash handlers and financiers against whom the sleuths obtained information that they are allegedly "mobilising cash for possible use in elections.'

The locations linked to two individuals identified as Akash Baskaran and Sujai Reddy were also searched, they said.

"Rs 18 lakh has been seized from the premises linked to Reddy," the official said.

Documents indicating investment of "unaccounted" funds of Rs 16 crore by Reddy in a Malaysian company have also been seized, the official added.

Sikkim Votes!...

And now that the Election officials, after a largely unimpressive organizational performance on polling day, have collated the voter turn-out details, its perhaps time to go over the data [see accompanying box

Like has become the norm, North Sikkim posted the highest turn-out at 81.74% with West coming in a close second at 81.64%, South failing to impress at 78.07% and East bringing up the rear with 75.60. Among the constituencies, Gangtok was the least motivated with only 62% of the electorate showing up to vote.

Usually, a noticeably higher voter turn-out is seen as a sign of people voting for change. If that yardstick is applicable to Sikkim, the ruling Front will be breathing easy. But the law of such averages do not always apply on Sikkim. In 2014, for instance, the constituency [Gangtok] with the lowest voter turn-out also posted the highest winning margin for the Opposition.

These speculations aside, what the results will definitely prove is which party worked harder and better and mobilizing their base to come out and vote. The delays and confusions and inexcusably long waits for voters discouraged many voters. While people have complained of these delays, no official explanation has arrived as yet.

### Samba spy scandal: HC seeks Centre's reply on plea to de-classify documents

NEW DELHI, APR 12 (PTI): The Delhi High Court Friday sought the Centre's response on a plea by two former Army officers, caught for allegedly spying for Pakistan in the infamous Samba spy scandal which broke out in 1975, to de-classify all documents related to the case.

Justice Vibhu Bakhru asked the Ministry of Defence and Chief of Army Staff to file their replies to the petition and listed the matter for further hearing on September 3.

Ashok Kumar Rana and Ranbir Singh Rathaur, formerly captains, said in the petition that their fundamental rights were violated by branding them as Pakistani spies/ agents and not disclosing the essential documents pertaining to the 'Samba Spy' incident to them.

They sought direction to the authorities to de-classify all the official documents pertaining to 'Samba Spy' scandal and put the same in public domain as more than 40 years have elapsed and all court cases have ended and no claim of national security can now be raised.

"In all the major democracies around the world including United States of America and several European countries, all the classified documents have a fixed duration of classification and are mandatorily required to be declassified after a passage of a specified time or a specified event," said the petition, filed through advocate Pranav Sachdeva.

It said the petitioners have tried all the legal recourse available to them to prove their innocence but to no avail as the entire basis of the charges and subsequent court martial proceedings against them were never properly and fully disclosed either to them or to the court.

### Cong welcomes SC order on electoral bonds, says BJP should reveal 'murky flood of money'

NEW DELHI, APR 12 (PTI): The Congress on Friday welcomed the Supreme Court judgement on electoral bonds and asked the BJP to reveal its "murky flood of money" received through such bonds.

The party said it has always maintained that transparency in political funding and governance must be adhered to and free and fair elections in a level-playing field must be ensured, hoping the Supreme Court goes to the root of the matter and opens the sealed envelopes of names of electoral bond donors.

spokes-Congress person Abhishek Singhvi said, "This so-called corrupt invention of bonds is nothing, but a direct assault on the Indian constitutional basic structure."

"The BJP should reveal the murky flood of money, which is earned through the 95 per cent electoral bonds having gone to one party. Financial dominance of the single party decimates the very concept of a level-playing field," he told reporters.

Singhvi said a level-playing field is the heart of free and fair elections and such elections are the heart of democracy, which, in turn, is the heart of the basic structure of the Consti-

"To ensure this flow of dirty money in a non-transparent manner by this so-called corrupt invention of bonds is nothing, but, a direct assault on the Indian constitutional basic structure." he said.

Congress spokesperson Priyanka Chaturvedi took a swipe at the BJP and said the judgement would bring out the "nexus" between the ruling party and its "suited-booted friends".

"We welcome this judgement coming from the Supreme Court. We have always maintained that transparency in political funding, transparency in governance must be adhered to," she told reporters.

Singhvi said the Supreme Court has provided the mechanism through its interim order about resolving the issue of electoral bonds which is in favour of the ruling party, even though it has

not quashed it. "The Supreme Court has now said that whatever has been given till now, you will give the names in a sealed cover. The Supreme Court has said that what will be given from now till May, you will also give the names in a sealed cover.

"Let me predict between now and May these donations will dry up. These great anonymous names donated generously to one party. Suddenly the generosity will vanish, because now there is a possibility that the sealed cover will be opened in May," he said.

The Congress leader said the crux of this design "of Modi, by Modi, for Modi" was to facilitate unanimity to keep names secret, to receive money without names being known and what benefit those names get also remains anonymous.

Chaturvedi alleged that the BJP, which came to power on the back of promises such as bringing in transparency in the system, has done nothing

She also alleged that the BJP has undermined the Right to Information and the Central Vigilance Commission and the party is doing everything to suppress transparency in governance.

"We hope that the BJP would explain how they got such kind of political funding. We also hope this would expose the nexus between their suited-booted friends and the political party, which has within its five years not given development to this country, but developed a five-star headquarters for itself in Delhi," she said.

The Supreme Court on Friday directed all political parties to furnish receipts of political funding received through electoral bonds and details of identity of donors in a sealed cover to the Election Commission.

In an interim order, the apex court also directed all political parties to provide details of the amount of the bond and bank account of donors by May 30 to the poll panel.

The apex court said it would examine in detail changes made in Income Tax law, electoral law and banking laws to make them in consonance with the electoral bond scheme and ensure balance does not tilt in favour of any political

### Mallya fails to delay USD 40mn Diageo claim, legal costs mount in UK

LONDON, APR 12 (PTI): Even as he renewed an appeal against his extradition to India, embattled liquor tycoon Vijay Mallya suffered another legal setback on Friday in a separate USD 40-million claims case brought by British liquor giant Diageo plc in the UK High Court.

Justice Clare Moulder ruled against the 63-yearold former Kingfisher Airlines boss' application to seek a delay in the full hearing in the case scheduled for May 23 and additionally ordered him to pay legal costs of 34,000 pounds.

She was extremely critical of the "unexplained" delays by Mallya in clearing the unpaid invoices of his previous solicitors Greenwoods, which resulted in his new solicitors Joseph

Hage Aaronson (JHA) finding themselves in difficulty and wanting to seek an unfair adjournment.

The delay is at best unexplained and arguably of the defendant's [Mallya] own making. In my view, the claimants [Diageo] are entitled to have their claim progressed expeditiously, Justice Moulder said, concluding that Mallya was the author" of his "own misfortune".

The claimants say that if the May hearing is adjourned they will suffer prejudice there would be a race in relation to Mallya's assets which are subject to a number of competing claims; Mallya may be extradited and this will affect the ability to enforce the judgment against him, the judge noted, in reference to the extradition order and worldwide freezing order already in place against Mallya.

While the judge agreed to a short extension until April 23 for Mallya's new lawyers to submit their evidence to the court, having missed an April 5 deadline, she ordered that meanwhile the businessman must pay additional legal costs of 34,000 pounds for Diageo's lawyers within 28 days.

Diageo, which had acquired Mallya's United Spirits nearly six years ago, is claiming USD 40 million paid to the liquor tycoon as part of an alleged breach of agreement.

The UK-based drinks giant is also claiming USD 141 million from Mallya, his son Sidhartha, and two companies linked to them for alleged questionable payments.

The case, dating back to November 2017, is being contested by Mallya and will now go ahead for a full hearing at the Business and Property Courts of the UK High Court on May 23. The three claimants in the case -- Diageo Plc, Diageo Holdings Netherlands BV and Diageo Finance Plc -- are seeking a total of USD 181 million from four defendants Vijay Mallya, his son Sidhartha, Watson Limited and Continental Administrative Services Limited (CASL). Mallya's counsel Barrister

Daniel Margolin argued for more time to prepare for the full hearing because his firm JHA had received all the documents in the case, including nearly 1,750 electronic files, only towards the end of March.

### 116 candidates in fray for six LS seats in Mumbai

MUMBAI, APR 12 (PTI): As many as 116 candidates are left in the fray for the six Lok Sabha constituencies in Mumbai after the last date of withdrawal of nomination papers ended on Friday.

In Mumbai South and South Central, two candidates each withdrew their papers.

In Mumbai South Central, 17 candidates in the fray, while in Mumbai South 13 candidates are contesting.

In South Central, sitting Shiv Sena MP Rahul Shewale is pitted against

Congress's Eknath Gaikwad. While in South, sitting Shiv Sena MP Arvind Sawant is contesting against Milind Deora of Congress.

Shewale and Sawant had defeated Gaikwad and Deora respectively in 2014.

In the suburbs, 86 candidates remain in the fray in four constituencies after five candidates withdrew their papers.

There are 18 candidates in fray in Mumbai North, 21 in Mumbai North West, 27 in Mumbai North East and 20 in Mumbai North Central.

Three candidates each withdrew from North, North West and North East, while two from North Central.

Actor Urmila Matondkar is contesting against BJP's Gopal Shetty in North; Sanjay Nirupam (Congress) is against Shiv Sena's Gajanan Kiritkar in North West, Poonam Mahajan of BJP is fighting against Congress candidate Priya Dutt in North Central and NCP's Sanjay Dina Patil is pitted against BJP's Manoj Kotak in North East.

Election in Mumbai will be held on April 29.

### Jet operates only 11 aircraft, PMO holds meeting to discuss situation

NEW DELHI, APR 12 (PTI): The crisis in Jet Airways deepened Friday as the airline could operate only 11 aircraft on Friday, leaving passengers stranded at various domestic and international airports and prompting the Prime Minister's Office (PMO) to hold an urgent meeting to discuss the situa-

According to sources, the meeting was called after Civil Aviation Minister Suresh Prabhu asked secretary of the department Pradeep Singh Kharola to review issues concerning Jet Airways.

After participating in the meeting at the PMO, Kharola held a meeting - through video conference - with the management of Jet Airways. Passengers were left

Kharola told reporters that Jet Airways flew 11 aircraft on Friday and will fly six to seven aircraft on both days this weekend on domestic routes.

When asked if the airline has enough funds to keep the operations going on till Monday, the secretary replied in affirmative.

# Monitor, Evaluate and Hold Accountable

### There will be fewer complaints then, and less resentment

Monitoring & Evaluation have always been part of governance. The least paid-attention-to part, but a part nevertheless. Its presence is token and piecemeal, extended by pick and choose when it should have been institutionalized and extended to all levels. Occasionally, one hears of moves underway to elevate this aspect of administration to the hierarchal dominance it deserves – right at the top – but nothing really moves beyond the talk of such things. M&E should prioritised. It is high time, especially now when those who control the release of funds and opportunities are demanding achievement records in black & white.

Too many doles, projects, funding and sponsorship have been invested in Sikkim without a scientific, unbiased or transparent appraisal of how far the buck travels in the State.

Frankly speaking, monitoring & evaluation is a simple science. Projects get drafted, funds get allocated, the release of payment requires numerous NOCs and clearance certificates to endorse that the work was done – that's monitoring. People look at roads carpeted a few months ago disintegrate with the first showers – that's evaluation.

So, when the government spends precious funds training its officers on monitoring and evaluation, it is expected that they bring something more to the table than the thumb rule that has the people monitoring and evaluating already. What is it that 'training' can deliver that one does not already know? Definitely the science to be able to monitor and evaluate so well that when things go wrong, the figures align themselves in a way that a shortlist of who is to be blamed how much is ready even before the Vigilance Police wakes up.

Monitoring and evaluation exercises can be carried out endlessly without delivering any results unless the most important follow-up to the M&E process is codified - accountability. And one does not speak of fixing criminal culpability and corruption charges on failed projects here. The M&E exercise should lead to pulling up lethargic officials who contributed to failed projects, those who compromise the impact of good initiatives with their poor delivery and those who routinely fail to see the larger picture. These can be departmental exercises leading to a red inked ACR or a compulsory admission to re-learning school so long as action is seen to be taken after the 'culprit' has been correctly identified. That would be true monitoring and evaluation because it would be delivering accountability. Such follow-up will also ensure that people do not have a reason to grow too resentful, because that is a common condition among the lay people who see expansive promises get processed with shallow intentions, and then tall claims being made without even a token gesture to evaluate or hold agencies to account.

# Islamic State: the 'caliphate' is off the map for now, but will evolve in dangerous ways

The so-called Islamic State (IS) recently lost its last remnant of territory in Syria, but observers were quick to remind the world that the war against the organisation is far from over. What then does this loss of territorial control actually mean for IS?

At its height, the self-proclaimed "caliphate" controlled an estimated 34,000 square miles across Syria and Iraq, so its defeat on the ground is clearly a severe blow for it. Nevertheless, IS is now expected to evolve. Its networks will disperse into virtual, online spaces and become largely invisible. It will focus on insurgency tactics and terror attacks with a wider reach.

In the face of this evolution, it may seem like maintaining IS in a contained geographic pocket would have been better than eradicating its primary territorial base altogether. With its defeat on the ground in Syria and Iraq, however, IS and its offshoots will have a more limited capacity for recruitment, indoctrination and growth.

#### THE IMPORTANCE OF TERRITORY

The success of rebel groups to survive protracted armed conflicts is dependent on their ability to maintain territorial control. They require it to extract resources and enlist local recruits.

Territorial control allows armed groups to force local populations into compliance and conformity with their ideological outlook. Since its inception, IS understood that its radical "Islamic" community does not locally exist. Instead, the organisation set about creating it, reshaping communities under its control in its own image.

Comparative evidence from civil wars around the world demonstrates how territorial control does not depend on a local population's ideological agreement with the forces in place. Instead, in his book The Logic of Violence in Civil War, Stathis Kalyvas argues that a combination of coercive measures and local administrative bodies allows a force to maintain order, stability and compliance.

For example, during the Liberian civil war in the early 1990s, NPFL (The National Patriotic Front of Liberia) rebels, led by Charles Taylor, used administrative bodies and courts in the territory they controlled to create an alternative order backed up by displays of brutality and violence. This led to an intricate system of patronage and loyalty that created new dependencies between local communities and the new regime.

These Taylor-era Liberian courts are comparable to IS's religious courts which controlled the issuing of permits for cross border activities, defined the educational content of local schools, distributed social services – and carried out extreme public punishments.

In enduring armed conflict, these administrative bodies, social services and displays of order encourage the cooperation of the local population. In other words, territorial control allows the occupier to manage the behaviour and, potentially, the ideology of the people under its control.



#### INSTRUMENTS OF CONTROL

Under IS, spectacles of brutality and violence were a key part of this. Public executions involved people being incinerated, stoned, decapitated, and thrown off towers. Staged in front of local people, these executions were carefully choreographed, and meticulously documented and disseminated – both locally and internationally.

IS explicitly claimed that these acts of brutality were intended to create a vacuum by disrupting local societal structures that could then be "filled" and "managed" by them. Essentially, displays of violence were used as an instrument of social organisation.

Data personally collected between 2012 and 2014 shows that many living under the rule of radicalised groups such as IS judge these groups based on their own immediate day-to-day conditions rather than the organisation's overall performance or outlook.

If administrative structures function and people have access to food and basic services, for example, local populations may overlook – or even adhere to – the occupying force's ideology (albeit under duress). And those that don't are severely and publicly punished as an "example" to others.

The 2014 executions of members of the Sunni Arab al-Sheitaat tribe, in Deir el-Zor, Syria, are a case in point. IS took the lives of more than 700 of its members for revoking a pledge of allegiance.

In addition, IS incessantly targeted other Jihadi or predominantly Sunni rebel formations. Indeed, the tally of those killed continues to increase as more mass graves are discovered.

### **VIOLENT CONSOLIDATION**

Such atrocities were examples of IS consolidating its power through the elimination of rivals and the suppression of potential or real dissent within its area of control. Faced with this, local populations had no choice but to imitate expressions of religiosity as defined by IS and to demonstrate compliance. For local people, this was a method of adaptation and survival – but IS's loss of territorial control now greatly reduces its capacity to control and indoctrinate local residents in this way.

The question of how IS's methods impacted local populations in the long run is yet to be answered. A lot will depend on what happens next in its former territory and to those living there now.

Either way, while IS is badly incapacitated, it certainly is not finished. It will most likely splinter into new organisations which might try to establish territorial control elsewhere. Parts of North Africa and the Maghreb are particularly susceptible, where control over vast swathes of land remain contested. In the meantime, IS will continue to try to nurture its virtual communities and seek new audiences online.

# #MeToo in Mexico: women finding their voice as campaign gathers force

The global #MeToo campaign seemed to have largely bypassed Mexico – until recently. There had been some activity through hashtags such as #MiPrimerAcoso ("My First Assault"), and individual cases such as actress Karla Souza's accusations of rape against an unnamed Mexican director. But this created cultural ripples rather than waves – and did not reach the scale of #MeToo and its transnational offshoots, such as the French #BalanceTonPorc, the Italian #QuellaVoltaChe, the Arab world's #AnaKaman, and #MeTooIndia.

That is not to say that harassment, abuse and violence against women is any less serious in Mexico. Sexual harassment at work is widespread throughout the country, as a recent poll released by the group Periodistas Unidas Mexicanas (Mexican Women Journalists United) demonstrated. The poll revealed that of 392 women journalists, 73% had experienced sexual harassment, with 63% of incidents carried out by male colleagues.

The earlier failure to establish a Mexican #MeToo movement was largely due to potential accusers fearing retaliatory action in a country that has tended to protect abusers over victims. Luis Miguel González of The Economist attributes this to concerns about financial cost, reputational damage, or indifference to the suffering of victims. But this all changed recently with a tidal wave of activity, via Twitter campaigns, across cultural sectors.

The origins of this Mexican #MeToo campaign began with a tweet on March 21 by political commentator Ana G. González (@anag-g), alleging abusive and violent behaviour against many women by a powerful literary figure. A Twitter account – @MeTooEscritoresMexicanos (#MeToo Mexican Writers) – soon followed, headed by the words "No estás sola" (You are not alone) and "Yo te creo" (I believe you).

This led to a proliferation of profession-specific #MeToo Mexican Twitter accounts in the fields of film, literature, journalism, academia, sport, music, theatre, law and politics – and a movement of women in the publishing industry using the hashtag #MujeresJuntasMarabunta made demands for more specific actions for equal rights.

Mexico now holds its breath as allegations against powerful men emerge with each new tweet – and heads have already rolled. The director of operations of the important Mexico City newspaper Reforma was fired following accusations of sexual harassment against him. Three employees of the Mexico City news outlets Chilango and Máspormás have also been suspended while investigations are taking place.

ACCUSERS ANONYMOUS

Mexico was clearly in need of its own #MeToo movement, but it had to find a way to protect women for it to take root. What is unique about



the Mexican #MeToo phenomenon is that these are industry-focused accounts that offer fearful accusers protection through anonymity. For instance, the account of the #MeTooEscritoresMexicanos features the words (my translation): "If you are afraid to identify your abuser, send an anonymous message with your story and the name of your abuser."

This anonymity has empowered women to speak out, while protecting their identities. But it has drawn criticism for protecting accusers, but not the accused, and any lack of judicial oversight.

The criticisms gathered pace, for example, following the suicide of the Mexican rock musician Armando Vega Gil on April 1. The author of an anonymous post had accused him of sexually abusing her when she was 13. His suicide note proclaimed that the act was taken as a declaration of his innocence to "clear the path my son will walk in the future".

POWER IMBALANCE
Indeed, the MeTooHombres Twitter account (that uses the English @
MeTooMenPower) voices the disquiet among some men about the potentially harmful effects of this flurry of anonymous denunciations. The account administrator, who goes by the name of Dante, has spoken against

the anonymity of #MeToo Mexico and has criticised what he sees as the lynch mob mentality of such social media campaigns.

While the pinned tweet at the top of the feed asserts that it is not

a site against women, but a space for men, the use of the English word "power" in the Twitter handle, does suggest that for some men this is a gender war. The assertion of such traditional notions of masculinity will certainly make many women seeking cultural shifts uncomfortable.

Women are turning to Twitter to denounce their abusers precisely because the legal system and other institutions have failed to offer them protection and justice. In an interview with me, for example, the renowned film critic Fernanda Solórzano summarised the debate thus:

"The lack of a legal system that can deal efficiently and judiciously with accusations of assault and abuse has meant that these fora for anonymous accusations are the only spaces for women to find support and a community that backs them. On the other hand, the anonymity polarises a society that should collectively engage with deep-rooted societal and educational problems."

Despite the flaws inherent in anonymous Twitter campaigns, #Me-Too Mexico in all its multiple forms is shaking up cultural life in the country. Women and girls have been given a space in which to speak out, and individual men will be more likely to check their behaviour from every-day sexism to violent assaults and rape. This is how cultures change in the digital age.

(PTI): The Indian Embassy in Nepal has asked Indian citizens planning to travel for Kailash Mansarovar Yatra through the Himalayan kingdom to get appropriate Chinese visa and travel permit for Tibet before commencing the journey.

In an advisory, the Embassy also advised the pilgrims to ensure that they have adequate insurance coverage to meet all exigencies, including high altitude sickness, emergency medical relief, evacuation and extended stay.

"The Chinese visa is to be obtained from the Embassy of China in New Delhi and not from Embassy of China in Kathmandu," the advisory said.

"They (the pilgrims) should ensure that travel agent has obtained Restricted Area Permit for Simikot/Hilsa or Rasuwagidhi in Nepal as per their itinerary/route," it added.

As there are minimal or no medical facilities in Simikot and Hilsa, the pilgrims are advised to carry adequate medicines for duration of the tour and reserve supply for at least another 10 "Simikot and Hil-

sa do not have ATM facilities, so yatris should carry adequate cash to meet any emergency. Pilgrims should carry SIM Card with international roaming facility," the advisory said and asked the pilgrims to install messenger applications like Whatsapp, Viber and WeChat to remain in constant communication even from places with poor or no mobile connectivity

ALIPURDUAR/KOLKATA, APR 12 (PTI): An estimated 83.79 per cent of 34.52 lakh voters exercised their franchise in Cooch Behar and Alipurduar Lok Sabha constituencies in the first phase of polls in the state, an election department official said Friday.

In Cooch Behar (SC), 83.88 per cent electorate cast their votes till 6 pm Thursday, while Alipurduar (ST) seat registered 83.70 per cent polling, he

No incident of violence was reported from any part of the two constituencies and the firstphase of the seven-phase election in the state was largely "peaceful", he

The ruling Trinamool

Congress (TMC) as well as the opposition BJP and the Congress, however, complained that polling was not undertaken in a free and fair manner in the two parliamentary seats.

TMCleader and North Bengal Development Minister Rabindranath Ghosh alleged that EVMs malfunctioned in several booths and it could be part of the opposition's conspiracy to manipulate votes.

A presiding officer at Sitalkuchi area of Cooch Behar constituency has been showcased following complaints that he allowed some unidentified persons inside the booth. the election department official stated.

Asked about parties

seeking re-poll in several polling stations in Cooch Behar constituency, he said the department is reviewing the reports of the presiding officers and a decision will be taken soon.

With the conclusion of the first phase, the fate of 18 candidates in the two seats has been sealed in the Electronic Voting Machines.

The ruling TMC and the BJP are the main contenders in the two north Bengal seats, while Left Front constituents - the Forward Bloc and the RSP - and the Congress are fighting to prove their existence.

Polling in the remaining 40 Lok Sabha seats in the state will be held in six more phases.

### Zero per cent polling in some Maoist-hit areas of Odisha

BHUBANESWAR, APR 11 (PTI): Though first phase polls remained violence-free in Odisha on Thursday, zero per cent polling was recorded in some Maoist-hit areas of Malkangiri district, while villagers in some places boycotted elections over local demands, an official said.

Around hald-a-dozen booths in Chitrakonda area of Malkangiri district recorded "zero polling," he said.

"Yes, we have received reports of poll boycott by villagers over some issues, while zero polling was recorded in some Maoist-hit areas of Malkangiri district," Chief Electoral Officer (CEO) Surendra Kumar said.

Sources in Malkangiri district administration said that in many places in Chitrakonda assembly segment, people did not turn up to cast their votes.

Though the polling stations were located close to the BSF camps



to ensure safety of voters, the people in Cutoff area and in Mathili block in Malkangiri district chose not to take any risk. Earlier, the Left Wing Extremists had appealed to the villagers through posters to boycott the polling.

Meanwhile, a report from Kalahandi district said that the people in five places boycotted votes on local demands like road connectivity, bridges and lack of development activities in their areas.

The vote boycott was reported from Bhejipadar village under Bhawanipatna assembly segment, Surli, Supel, Kusumdara, Sankriguda cluster of

villages under Junagarh assembly segment, Tetengpadar under Narla assembly segment, 4 villages under Taljhapi of Thuamul Rampur block in Lanjigarh assembly segment, Manibandha of Lanjigarh assembly segment.

The CEO said there is no provision for holding repoll in places where people boycotted the polls or refrained from voting due to other reasons.

Meanwhile, a delegation of BJP Thursday moved the Chief Electoral Officer and alleged that the ruling BJD activists indulged in violence and booth rigging at the Chikiti Assembly constituency in Ganjam district and Koraput assembly segment.

"They (BJD activists) rigged booths in the Chikiti assembly constituency. Even BJP polling agents were not allowed to enter as many as 18 polling booths", Mohanty alleged.

SINGAPORE, APR 12 (PTI): PV Sindhu survived a scare before making the semifinals but Saina Nehwal was thoroughly outplayed in her straight-game quarterfinal loss on a mixed day for India at the Singapore Open badminton tournament here Friday.

In the second, Saina rose to 4-0 but Okuhara clawed back at 6-6 and then turned the tables, reaching 11-8 at the breather.

The Japanese then moved ahead at 12-11 and didn't look back.

### 'Frightening' Vettel jolts Mercedes at landmark Chinese GP

SHANGHAI, APR 12 (AFP): Sebastian Vettel fired a warning as he powered his Ferrari to the fastest time in first practice at the milestone Chinese Grand Prix in Shanghai on Friday.

For what will be the 1,000th Formula One race, the four-time world champion clocked a best time of one minute 33.911 seconds, with Mercedes' reigning title-holder Lewis Hamilton 0.207 secs behind.

Third fastest was Vettel's young Ferrari teammate Charles Leclerc, 0.256 secs off the pace, followed by Red Bull's Max Verstappen and Valtteri Bottas in the other Mercedes.

But the session be longed to Germany's Vettel, 31, who has been under pressure after a series of unforced errors stretching back to last season.

He has been struggling with the set-up of his Ferrari and admitted on Thursday that he was still not really at home in it.

Vettel finished fourth in the season-opening race in Melbourne and was then fifth in Bahrain, where he was eclipsed by team-mate Leclerc, who is 10 years his junior.

Vettel's opening Shanghai salvo was all the more impressive because the Ferraris were on the slower medium tyres in first practice. The Chinese Grand

Prix has one of the longest straights in Formula One, which will suit Ferrari's awesome pace.

Toto Wolff, Mercedes team principal, called Vettel's straight-line speed "frightening".

"We need to stretch ourselves and fight," said Wolff, adding that Ferrari were clearly ahead of the rest in Bahrain despite the Mercedes one-two of Hamilton and Bottas.

"Having a benchmark like that helps and motivates." Leclerc, the supremely talented 21-year-old who led in Bahrain but finished third after his Ferrari lost power, struggled early on in practice before finding some rhythm.

The Monegasque locked his wheels in his opening run and was then told over the radio from his Ferrari team on a subsequent lap: "We need you to push a bit."

In warm Shanghai conditions and with a slight breeze, Racing Point's Lance Stroll took a minor spin, the Canadian's predominantly pink car shuddering down the track.

After two grands prix this season, Bottas leads his team-mate Hamilton by one point at the top of the standings, followed by Verstappen, Leclerc and Vettel.

### Trump laments EU toughness on Britain after Brexit delay

WASHINGTON, APR 11 (AFP): US President Donald Trump on Wednesday lamented the EU was being "so tough" with Britain after European leaders agreed to delay Brexit by six months.

Under a deal struck during late night talks in Brussels, Britain received a "flexible extension" until October 31, saving all sides from a chaotic nodeal British departure at the end of the week.

British Prime Minister Theresa May had originally asked for a delay until June 30, but European leaders voiced

### Dhoni let off with 50 per cent fine after angry reaction to umpire's call



JAIPUR, APR 12 (PTI): Chennai Super Kings captain Mahendra Singh Dhoni escaped a ban and was let off with a 50 per cent fine on his match fee for an unprecedented confrontation with the on-field umpires during the IPL encounter against Rajasthan Royals here.

In a rare instance, Dhoni, who was not even meant to be on the field of play, lost his cool and rushed out of the dugout to challenge umpire Ulhas Gandhe after he flip-flopped on a no ball on Thursday night.

"MS Dhoni, the Chennai Super Kings captain, was fined 50 percent of his match fees for breaching the VIVO Indian Premier League's (IPL) Code of Conduct during his team's match against Rajasthan Royals at Jaipur," the BCCI stated.

Gandhe had tried to rule a waist high full toss as no ball by RR all-rounder Ben Stokes. But he reversed his decision after square leg umpire Bruce Oxenford did not signal for it.

"Dhoni admitted to the Level 2 offence 2.20 of the IPL's Code of Conduct and accepted the sanction," it further stated.

As is the case with IPL teams, it's the franchise that will pay the fine on the player's behalf.

Dhoni was seen angrily gesturing at Gandhe for backtracking after initially signalling a no ball.

It took some convincing from Oxenford for Dhoni to head back to the dugout even though he seemed far from convinced.

But the confusion and the ensuing confrontation did not have a bearing on CSK's fortunes.

Stokes failed in the final over and Mitchell Santner finished the match with a six to take his team to a four-wicket win in a chase of 152.

According to the ICC Code of Conduct, which governs the IPL, showing serious dissent at an umpire's decision by words or action can lead to a maximum punishment of one-Test or two-ODI ban.

The ongoing edition of the IPL has had quite a few umpiring controversies so far. Not too long back, India and Royal Challengers Bangalore skipper Virat Kohli lambasted the standards after his team was at the receiving end of a poor no ball call.

The umpire failed to spot a clear case of over-stepping in RCB's clash against Mumbai Indians and Kohli had gone on to say that the officials "should keep their eyes open".

### South Korean constitutional court eases abortion ban



SEOUL, APR 11 (AFP): South Korea's constitutional court on Thursday ordered the country's decades-old abortion ban to be lifted in a landmark ruling over a law that campaigners say puts women at risk.

South Korea remains one of the few industrialised nations that criminalises abortion, except for instances of rape, incest and when the mother's health is at risk.

But the nine-member bench ruled by seven to two that the 1953 statute aimed at protecting lives and traditional values "goes against the constitution" and ordered the law to be revised by the end of next year.

"The abortion ban limits women's rights to pursue their own destinies, and violates their rights to health by limiting their access to safe and timely procedures," the court said in a statement.

"Embryos completely depend on the mother's body for their survival and development, so it cannot be concluded that they are separate, independent living beings entitled to rights to life." Hugging and celebrating, hundreds of women -- including teenagers and females with disabilities -cheered wildly in front of the Constitutional Court in central Seoul, where the official ruling was announced.

"Women deserve to be happy as much as we want to be today," said activist Bae Bok-ju told AFP.

"Today's decision was made because countless women ceaselessly fought for their rights for so many years. We deserve the world's attention and we deserve its recognition," Bae added.

Under the ban, women who underwent the procedure could face up to a year in jail and a fine, while doctors who performed the procedure were given two years in prison. The 1953 law had

been widely flouted and rarely resulted in prosecutions, but activists had claimed it left women facing being unable to pay for terminations, unsafe procedures and social ostracisation.

# Sudan army topples veteran leader Bashir

KHARTOUM, APR 11 (AFP): Sudanese president Omar al-Bashir was ousted by the army on Thursday, brought down by months of anti-government protests against his three decades of iron-fisted rule.

"I announce as minister of defence the toppling of the regime and detaining its chief in a secure place," Defence Minister Awad Ibnouf said in a sombre televised address to the nation.

A transitional military council would replace Bashir for two years, he said, adding that the country's borders and airspace would be shut until further notice.

The veteran leader, who swept to power in a 1989 coup, was one of Africa's longest serving presidents. He is wanted on charges of genocide and war crimes by the International Criminal Court.

Since early morning huge crowds of jubilant Sudanese had begun thronging squares across the centre of Khartoum on Thursday as the army promised an "important announcement".

Chanting "the regime has fallen." thousands poured into the open ground outside army headquarters where defiant protesters have braved tear gas to keep up an unprecedented sitin now in its sixth day.

The protests, which erupted in December over the government's tripling of the price of bread, were the biggest challenge yet to Bashir's long rule.

The security agency also announced it was freeing all political prisoners.

Army vehicles carrying troops were seen deploying across the centre of Khartoum from early Thursday.

Troops raided the offices of the Islamic Movement, the ideological wing of Bashir's ruling National Congress Party, witnesses told AFP. And martial music was played on state television as soldiers ordered the TV to halt its normal programming.

Outside army headquarters, dozens of joyful protesters climbed on top of landcruisers and armoured vehicles that had been posted to protect them from interven-



tion by other branches of the security forces.

Braving the searing 42 degree Celsius (108 degree Fahrenheit) heat, protesters hugged and kissed soldiers in the

Sudan's feared intelligence service said it was freeing all the country's political prisoners, state media reported.

"The National Intelligence and Security Service has announced it is releasing all political detainees across the country," the official SUNA news agency said.

But in the eastern cities of Kasala and Port Sudan, protesters stormed NISS buildings after the releases failed to materialise, witnesses said.

Protesters proached the NISS building in Kasala demanding that officers free their prisoners, a witness told AFP by telephone from the city.

"But NISS cers fired in the air after which protesters stormed the building and looted all the equipment inside," he said.

Protesters chanting slogans against Bashir also stormed an NISS building in Port Sudan, a witness said.

The raids on NISS buildings came despite a call by protest organisers for demonstrators to refrain from attacking government figures or buildings.

"We are calling on our people to control themselves and not to attack residence and the de-

anybody or government and private properties," the Alliance for Freedom and Change (AFC), the umbrella group that is spearheading the protest movement, said in a

"We had enough of this regime -- 30 years of repression, corruption, rights abuses, it's enough," said one protester at the sit-in.

Demonstrators have spent five nights defiantly camped outside the sprawling headquarters complex, which also houses Bashir's official fence ministry.

There has been an often festive mood at the sit-in, with protesters singing and dancing to the tunes of revolutionary songs.

The demonstrators have braved repeated volleys of tear gas from members of the NISS since they began camping outside the complex on Saturday, protest organisers say.

Officials say 49 people have died in protest-related violence since demonstrations first erupted in December.

"I hope our revolution will achieve its goal," said Alaa Salah, dubbed the protest movement's "Nubian queen", after a video clip went viral of her conducting chants with demonstrators outside army headquarters.

Earlier this week, the US, Britain and Norway for the first time threw their weight behind the protesters.

"The Sudanese authorities must now respond and deliver a credible plan for this political transition," the countries' embassies Khartoum said in a statement.

### Peak break: China to add 'eco' toilet on Mount Everest

BEIJING, APR 12 (AFP): Climbers with pressing needs on Mount Everest will soon find an "eco-friendly" toilet at a Chinese campsite 7,028 metres (23,058 feet) above sea level in an ongoing campaign to deal with the peak's waste problem.

Decades of commercial mountaineering have turned Mount Everest into the world's highest rubbish dump as an increasing number of big-spending mountaineers pay little attention to the ugly footprint they leave behind.

Fluorescent tents, discarded climbing equipment, empty gas canisters and even human excrement pollute the well-trodden route to the summit of the 8,848-metre peak.

During the climbing season this spring, a Chinese expedition company will add what state media dubbed an "eco-friendly" loo at the higher campsite on the northern slope in Tibet.

"The toilet makes it easy to collect human waste produced by the climbers as there is a barrel with rubbish bags underneath the toilet," Xinhua quoted Pema Tinley, deputy secretary general of the Tibet Mountaineering Association, as saying.

Similar facilities have been installed at lower camps, including at the 5,200-metre north base camp, in previous years, according to Xinhua.

The waste from the base camp is taken away daily and is provided to local farmers to use as fertiliser, the news agency reported in February, citing observations by its reporter and a member of the mountaineering management team.

The temporary toilets will be removed at the end of the climbing sea-

Governments on both sides of the mountain have been battling the human waste and trash left by an increasing number of climbers.

In February, China banned non-climbers from accessing its Everest base camp in Tibet in an attempt to clean up its side of the mountain.

Meanwhile, engineers in Nepal are considering installing a biogas plant near the more popular south base camp that would turn climber poo into a useful fertiliser.

Currently raw sewage from the camp is carried to the next village -- a one-hour walk -- and dumped into trenches, where it risks contaminating water sources down in the valley.

### New Zealand's new gun laws get final assent to take effect

WELLINGTON, APR 11 (AP): New Zealand's governor general on Thursday formally signed into effect sweeping gun laws outlawing military style weapons, less than a month after a man used such guns to kill 50 people and wound dozens at two mosques in Christchurch.

Governor General Patsy Reddy signed the bill as police said a gun buyback program will be announced to collect the now-banned weapons. The weapons will be illegal starting at midnight, but police said a brief amnesty program will be in effect until details of the buyback are announced. "For people who find themselves now in possession of a prohibited firearm, we ask you Zealand's firearms laws in New Zealand and pur- every case they spoke of

# North Korea bolsters diplomatic lineup amid stalled US talks

Seoul, Apr 12 (AP): North Korean leader Kim Jong Un has retained his most important leadership post as his rubber-stamp parliament made a slew of personnel changes that bolstered his diplomatic lineup amid stalemated nuclear diplomacy with the United States.

Some observers say the personnel appointments could show Kim's desire to keep nuclear diplomacy alive rather than returning to a policy of ratcheting up tensions. In Washington, President Donald Trump and visiting South Korean President met Thursday and agreed on the importance of nuclear talks with North Korea.

The North's Korean Central News Agency reported Friday that Kim was re-elected as chairman of the State Affairs Commission at the first session of the Supreme People's Assembly on Thursday. It said the assembly re-elected Kim because of "his outstanding ideological and theoretical wisdom and experienced and seasoned leadership." The 35-year-old Kim holds many governments, military and ruling party leadership

titles, but he officially rules the country in his capacity as the commission chairman. The assembly had first elected him to that post in 2016. KCNA also published

a list of other officials elected to top state posts. Among them is Choe Ryong Hae, one of Kim's top lieutenants who was made president of the assembly's Presidium. Choe was also elected to first vice-chairman of the State Affairs Commission, a new post.

By the constitution, the presidium president post is North Korea's nominal head of state though all state power is heavily concentrated on Kim, the third-generation hereditary ruler of a family that has ruled the North since 1948.

Choe's election to head the presidium means the departure of 91-year-old Kim Yong Nam, who has served all three generations of the ruling Kim family. His retirement has long been expected due to his age.

Three of the four senior officials involved in the nuclear negotiations with the U.S. have been re-elected or newly elected to members of Kim Jong Un's



state commission.

Among them was former military intelligence chief Kim Yong Chol, who travelled to Washington and met Trump twice ahead of Kim Jong Un's two summits with the president last year.

The fate of Kim Yong Chol had been the focus of South Korean media speculation since the second Kim-Trump summit ended without any agreement due to disputes over U.S.-led sanctions on the North. The nuclear negotiator who wasn't mentioned in the assembly-elected lineup is Kim Hyok Chol, the North's special representative for U.S. affairs.

The North's latest personnel changes show Choe strengthened his status as No. 2.

His appointment to first vice-chairman of the state commission could also allow him to oversee the U.S. diplomacy while

having the nuclear negotiators and others in the commission under his control, some observers say.



Un took power in late 2011. He went China and Russia as Kim's special envoy, and has assumed a series of high-profile jobs including the top political officer in the North's million-member military. In 2015, however, South Korea's spy agency speculated that he was briefly banished to a rural collective farm

for reeducation. "It's a positive sign that Choe has gained greater influence in negotiations" with the United States, said analyst Cheong Seong-Chang at South Korea's Sejong Institute.

He said there is a high chance for Kim Jong Un to send Choe as his special envoy.

Cheong said much of the responsibility for the failed nuclear diplomacy with the United States should be go to Kim Yong Chol, a hardline former military general blamed for two attacks in 2010 that killed 50 South Koreans.

Justice Wigney said that Rush's accuser, Norvill was not a "credible or reliable witness and was "prone to exaggeration" and embellishment".

Initially, he introduced his findings saying the case, which

had evolved against the backdrop of the #MeToo movement, was "sad and unfortunate".

Rush's legal team said the newspaper had implied he is a "pervert", a "sexual predator" and "committed sexual assault". He had Rush denied any wrongdoing and described the accusations as "slurs" and "hyperbole".

Those imputations were central to the judge's decision, with the Oscar winner able to prove these implications were conveved by the articles but were not true.

During the trial, Norvill alleged that Rush made "groping gestures in the air with two cupped hands" that simulated "fondling" her breasts during rehearsals.

The trial lasted 13 days late last year.
