Bhum Chu to be held without devotees today

PRITAM LAMA GYALSHING, 26 FEB:

 $B^{ ext{hum Chu, the annual}}_{ ext{sacred ritual held at}}$ Tashiding Monastery in West Sikkim which draws a large number of devotees from Sikkim and outside will not receive any devotees this year.

The monastery's management committee informed that while the ceremony (Bhumdrup) will be conducted in the monastery on 27 Feb, no devotees will be allowed in the monastery's premises this time.

The ceremony will be conducted by monks and on the midnight of the main day, the holy vase will be opened in the presence of officials from the state government and representatives of the monk body. Thereafter, the vase will be sealed again after being emptied out and replaced with fresh water from Rathong Chu.

The decision to keep devotees away was taken



in view of the COVID-19 pandemic by the monmanagement astery's committee after consultations with the zindags (patrons), West district administration and the Ec-

clesiastical Department. "We have decided not

to distribute the blessed water (Bhumchu) this year considering the Covid pandemic and safety of all. Bhum Chu is an international event where thousands of devotees from Sikkim and neighbouring countries

of Bhutan and Nepal come. It is not possible to maintain social distancing," said the committee.

The committee further pointed out that some foreign nations and some parts within India are imposing lockdown again due to rise in coronavirus cases.

In this scenario, the monastery committee thought it would be appropriate not to celebrate Bhum Chu in the traditional grand manner as it may pose risk to the devotees, said the committee.

2 new cases and 536 more vaccinated in Sikkim

SUMMIT REPORT GANGTOK, 26 FEB:

Two new cases of Novl el Coronavirus were reported in Sikkim in the past 24 hours while 536 more Covid-19 vaccination shots were administered across the State today.

The two new cases come rural Sikkim with a person from Namcheybong, East Sikkim, and one from Uttarey in West Sikkim testing positive for nCoV from among the 176 samples which were tested yesterday.

There are now 45 active cases of novel coronavirus in Sikkim. No one was discharged from isolation yesterday and the number of recovered cases hence holds at 5,858.

In his daily health bulletin on Friday, Health Department State IEC Officer, Sonam Gyaltsen Bhutia, informed that two new cases were reported from the testing of 176 samples on Thursday.

Both the new cases were picked up in RT-PCR testing of 142 samples, while all 17 samples tested by TrueNat and another 17 through rapid antigen testing returned negative for COVID-19.

He mentioned that the person who tested positive from Uttarey was 28-year-old Mony Hangma Limboo from Uttarey who could not be contacted on the phone number provided by her. She has been urged to immediately contact the concerned authorities.

On the vaccination front, Mr Bhutia informed a total of 536 persons - 219 healthcare workers and 317 frontline workers - were inoculated today.

76 healthcare workers were vaccinated at STNM Hospital, while 79 healthcare workers and on frontline worker received the vaccine at Central Referral Hospital, 101 frontline workers at Urban PHC, Gangtok, 72 frontline workers at the vaccination site at the SAP Camp at Pangthang and 51 frontline workers at ITBP Sang in East Dis-

Likewise, 51 healthcare workers and 29 frontline workers received the vaccine at Mangan District Hospital and 13 healthcare workers and 63 frontline workers were inoculated at Gyalshing District Hospital.

DC West suggests Saturday Sports Day in schools

GYALSHING, 26 FEB (IPR): A meeting pertaining to the conduct of various sports activities in schools under West District was held in the office of the District Collector West at Gyalshing today.

The meeting was chaired by the District Collector West, Karma R. Bonpo along with ADC West, Agawane Rohan Ramesh, Additional Director/Education, K.C. Gyatsho, Deputy Director/Sports, Nickjey Lamu Bhutia, and Head Mas-Gyalshing Secondary School, Tashi Ongyal Bhutia.

The DC West suggested that every school prepare activities calendar



and include every Saturday as sports day without getting classes disturbed so as to inculcate sporting spirit among students. He further suggested that interschool tournaments be conducted in football, basketball and badminton. He stated that interschool and block level sports activities are important as the

children will get a chance to showcase their talents.

DC West informed that fourteen basketball courts will come up in West district and ground repair work will be done gradually. He also informed about the increase in the number of sports centres with more sports activities in the days to come.

Police supposed to collect evidence for "true nicture": Court on Deep Sidhu's plea NEW DELHI, 26 FEB [PTI]: Police is not supposed to collect evidence only to prove the guilt of the accused but also to bring forth a true picture, a Delhi court said on Friday while directing a probe on the plea by actor-activist Deep Sidhu who

claimed he was not an "instigator" of the Red Fort violence on the Republic Day during farmers' tractor parade against the Centre's three new agri laws.

The court added, however, that appropriate action may be taken and relevant sections added to the charges if Deep Sidhu was trying to mislead the investigation by fabricating false evidence.

"IO (investigating officer) is duty bound to conduct proper investigation in the matter in a fair and impartial manner. He is not supposed to collect the evidence only to prove the guilt of the accused, rather he has to bring the true picture before the court," Chief Metropolitan Magistrate Gajender Singh Nagar said in his order. The court was hearing Mr Sidhu's plea seeking directions to the police to include all videos and other material on record which allegedly proved his innocence and conduct a fair and impartial investigation in the case.

During the hearing, advocate Abhishek Gupta, appearing for Mr Sidhu, told the court that he was not an instigator of the incident at Red Fort, as alleged by the police. "There is no video of him calling the people to gather at Red Fort. He did not indulge in any kind of violence taking place at Red Fort. He was only a peaceful protestor," Mr Gupta claimed.

He further claimed that Mr Sidhu was staying at a hotel in Murthal from where he checked out at 12 pm on February 26 and left for Delhi only after checking out.

"The CCTV footage of the hotel, which was in working condition, checkout bill showing the time/ payment details, as online payment was made, be obtained to ascertain this... Further, the car navigation system installed in the Ford Endeavor car used by him which is in police possession would also show the route taken by him to reach from Murthal to Red Fort along with timings and time taken in the same," he submitted.

"Mr Sidhu reached the area around Red Fort only around 2 pm, which can be proven by his phone location and by that time a huge crowd has already gathered at the spot," Mr Gupta said.

He claimed there was CCTV footage of the Red Fort in which Sidhu can be seen helping the police by requesting the crowd to leave the rampart where they were trying to hoist the flag.

Labour activist Naudeep Kaur granted bail by HC

(PTI): Around six weeks after her arrest in a criminal case filed under several charges including attempt to murder, labour rights activist Naudeep Kaur was on Friday granted bail by the Punjab and Haryana High Court.

"The court accepted the bail application of Naudeep Kaur. She has been granted bail by the high court," her counsel Arshdeep Singh Cheema said here.

Kaur was arrested in Haryana's Sonipat for allegedly gheraoing an industrial unit and demanding money from a company on January 12.

Police had claimed that a team of cops was allegedly attacked with sticks, resulting in injuin the incident.

A case under several sections of the Indian Penal Code including 307 (attempt to murder), 384 (punishment for extortion), 148 (rioting), 353 (assault or criminal force to deter public servant from discharge of his duty) and 379 B (snatching and use of force) was registered by the Sonipat police.

Kaur's bail plea came up for hearing on Friday. Justice Avneesh



Directions passed to complete link road from TNHS to Byepass by 31 March **SUMMIT REPORT** GANGTOK, 25 FEB:

Secretary, Urban Development Department, has directed the contractor engaged for the construction of the link road from Tashi Namgyal Senior Secondary School to Indira Byepass, to at least make the stretch a fair weather road by 31 March.

An official press release informs that the Secretary led a team of officials from the Department along with the contractor to an inspection of the work which links up to the byepass near Manbir Colony.

The release informs that road cutting on the Indira Bypass Road side has almost been completed and widening of the existing road on the TNHS side is under prog-

The presence of water supply lines, sewer lines, power lines etc have delayed progress and shifting of utilities is under process and will take about a month's time to complete, it is informed.

The major pending work is the construction of culverts and cross drains, which are being constructed simultaneously with widening of the road after which carpeting will be completed before monsoon, the release adds.

The Department is confident that once the Adampool to Ban Jhakri Falls road is completed, residents of Upper Development Sichey, Area, Baluwakhani, etc, can bypass the vehicular jam of NH-10 and reach Adampool much faster.



ICAR Sikkim organizes training for Bihar farmers

GANGTOK, 26 FEB (PIB): After a gap of nearly one year the first training for progressive farmers from outside Sikkim was organized by ICAR Sikkim Centre from 23-25 Feb.

students from both colleges and schools and organic farming practitioners/enthusiasts from 19 states and five UTs/ Councils Autonomous of our country numbering above 1400 have acquired knowledge on organic farming through more than 90 self-sponsored customized training programmes between December 2014 and March 2020 at ICAR Sikkim Centre.

The ICAR Research Complex for NEH Region, Sikkim Centre, Tadong, Gangtok successfully organized three-day inter-state training "Organic program on Farming of Important Vegetable Crops" for the progressive farmers of ATMA, Kishanganj, Bihar during 23-25 Feb, 2021.

A team of 20 persons visited ICAR Sikkim Cen-



tre to get equipped with recent advances in organic vegetable production techniques. During the program, Joint Director, Dr Ravikant Avasthe, ICAR Sikkim Centre highlighted the relevance of this training program for promoting the organic vegetable farming systems. He emphasized the need of good soil health in organic production system. He also discussed in detail the 'Concept of physico-chemical and microbiological properties of soil in relation to soil health' and the organic production

standards. He further said that we would look forward for long term association with the farmers of Bihar in organizing more training programs of such kind. Joint Director further reiterated to adopt dairy farming and vermicompost technology for profitable organic vegetable farming in Kishanganj, Bihar.

Former CEO, Dr Yashoda Pradhan, Sikkim State Organic Certification Agency addressed the farmers and briefed about the journey of organic farming in Sikkim. She also detailed about the role of certification in organic farming which is mandatory for the export of organic produce and also to fetch better prices in local market. Scientist SS (Soil Science), Dr Shaon Kr Das coordinated the program and talked on integrated organic nutrient management, soil sampling process along with plant nutrients functions, deficiency symptoms and their management.

Scientist SS (Fruit Science), Dr SK Dutta detailed on the organic nursery management and vegetable production techniques. Assistant Professor (Entomology), Dr. P Bhumita, College of Horticulture. CAU, Ranipool delivered talk on 'insect pest management in organic vegetable crop production';

Scientist (Agronomy), Dr Amit Kumar explained the 'integrated organic farming system and conservation agricultural practices in Sikkim; and Scientist (Plant Breeding), Dr E Lamalakshmi Devi discussed the 'organic vegetable seed production techniques and varietal selection. Finally, Assistant Professor (Pathology), Dr D Talukdar, College of Horticulture. CAU, Ranipool briefly discussed the organic disease management in vegetable crops.

The plea also alleged that the police has chosen not to check the evidence which completely belies the case thrusted upon the applicant/accused (Sidhu).

"Further, the CCTV footage of the Red Fort is already with the investigating agency which shows that the applicant/accused did not participate in any act of violence and rather he was helping the police in pacifying the crowd.

"Applicant/accused is apprehensive that the CCTV footage and the video will also not be considered by the police (CCTV footage of Red Fort from 10.00 AM to 4.00 PM). The applicant/accused has not committed any offence as alleged in the FIR and if the said record is not called, preserved and made part of the record, then it will be difficult for the applicant/accused to prove his innocence, further the ends justice would not be met," it claimed.

Additional Public Prosecutor Rajiv Kamboj, appearing for the police, opposed Mr Sidhu's plea saying the accused cannot guide the police to conduct investigation in a particular manner.

"Police is duty bound to conduct fair and impartial investigation. However, accused cannot be allowed to divert the investigation of the police from its path. By moving the present application, accused is trying to guide the investigation being done by the police," the public prosecutor claimed.

The court had on February 23 sent Mr Sidhu to judicial custody in the case. Police had earlier alleged he was one of the main instigators of the violent incidents at the Red Fort.

of Section 307, 332, 353 and 379-B IPC would be a debatable issue and to be considered during the trial, according to the order.

The Court observed, The petitioner is in custody since 12.1.2021. Albeit the matter is under investigation but that itself would not be sufficient ground to deny personal liberty to the petitioner.

Meanwhile, according to a medical examination report which was placed before the high court on Friday, Kaur had purplish bruises of around 10x7 cm present over LT (left) thigh, lateral aspect, bruises of around 5X6 cm over RT (right) buttock.

The court on February 24 had directed the State of Haryana to place on record the medical report of Kaur. The medical examination of Kaur was conducted at Sonipat civil hospital on January 25 on the orders

of a Sonipat court. In her bail plea, the 23-year-old activist had claimed to have been severely beaten up at a police station after she was arrested by the Sonipat police

on January 12. The Haryana police however had denied the charge as "baseless".

Kaur had also claimed that she was falsely arraigned as accused in an FIR lodged under various sections, including 307 (attempt to murder), of the Indian Penal Code (IPC).

The activist had also claimed she was targeted and falsely implicated in the case as she was successful in generating massive support for the ongoing farmers' movement against the Centre's three contentious farm laws.

Kaur is lodged in Haryana's Karnal jail. She is a member of the Mazdoor Adhikar Sangathan and a resident of Giadarh village in Punjab's Muktsar district.

On February 24, the high court had posted the hearing on her bail plea to Friday.

Earlier, a court in Sonipat had granted bail to Kaur in two separate cases of extortion, rioting and other charges.

Meanwhile, Kaur's family expressed happiness at the activist being granted bail.

Her sister Rajveer Kaur said the family was happy that she would be released from jail. "She had to spend one-and-a-half months in jail, said Rajveer who is pursuing PhD from Delhi University.

She said Naudeep will walk out of jail once necessary legal formalities regarding her bail order are completed.

Her mother Swarnjit Kaur said she was happy over the bail granted to Naudeep Kaur.

Being her mother, I am extremely happy. Now after she comes out of jail, we will be able to ask her what she has gone through, said Swarnjit Kaur.

She said she was not able to meet her daughter ever since she was in jail.



28 Feb, A Day for Sikkim Subjects

Deliberate issues of identity, belonging and even denials

There is still a day to go, and so we return to another I idea that we have been plugging for a while - Sikkim should consider observing 28 February as Sikkim Subjects' Day to mark the significance that this date bears for Sikkim Subjects and a moment it could celebrate.

To recap, it was on 29 February 2008 that the then Union Finance Minister introduced an amendment to the Income Tax Act which allowed for Income Tax exemption for all "Sikkimese" from all incomes earned in the State. 2008 was a Leap Year, and since it will be too long a wait to mark the occasion only once every four years, the suggestion that the Day be celebrated on the 28th of February every year. And this celebration not because Sikkimese were exempted from paying Income Tax, but more importantly because this was the first time that "Sikkimese" were officially defined by the Union Government in an official document and Sikkim Subjects formally recognized as a unique population group of Sikkim.

The wording of the exemption was as special. The exemption was extended to all "Sikkimese", an identity explained in a footnote as those with their names included in the Sikkim Subjects Register and their descendents. It was a historic development and one without any recent precedence in the country because special treatment was announced for "a people" collectively, and not divided by community, caste, or religious denominations or economic privation. The Centre had reiterated the individuality of "Sikkim Subjects". Interestingly, neither the 8 May Tripartite Agreement of 1973, nor even Article 371F, makes any specific mention of "Sikkim Subjects". Delhi has never really acknowledged the people of Sikkim as a uniform group rising above ethnicities or castes and even leaders here have acquired the rhetoric which speaks of the people of Sikkim as belonging to the three ethnic communities of Bhutia, Lepcha and Nepali (and now also the plainsfolk). Sikkim might claim the three communities to be united, but the segregation is obvious in how the references are made. Of course, even this Bhutia-Lepcha-Nepali coinage came into currency primarily with the Tripartite Agreement of 1973 and has continued to remain in circulation since then. These were always the underlying demarcations on which the Sikkimese were slotted. Of late, as mentioned earlier, the Byapari have been added in the mix as Old Settlers, but the point remains that the State is too small for such divisions and it is ironic that this message had to be driven home with an amendment of the same Bill which had, in 1994, cleaved Sikkim into perhaps its deepest ever communal divisions. It then took 14 years since that tumultuous confusion for Income Tax exemption to finally be extended to the Sikkimese as one people.

As far as the I-T exemption is concerned, it was citizenship [Sikkimese Subjecthood] which earned exemption, nothing else. The exemption can be looked at as a reward for everyone who decided to take on the risks of becoming subjects to a King because they loved the land or were so completely invested here that they did not consider any other option. Of course, like is the case with every privilege, there are sections which have been left out. For instance, Sikkim's old settlers or those who could not get enrolled in the Sikkim Subjects Register itself even though met the criteria for becoming Sikkim Subjects when it was first promulgated, but who either decided not to become Sikkimese at that time or did not have the wherewithal to get recorded. It also needs to be accepted that many who arrived in Sikkim after the "Old Settlers," but decided to become Sikkimese enjoy more privileges and exemptions than families of older antiquity in the State. In a way, the extension of special treatment also makes one wonder whether questions of identity and belonging are purely emotional or do material benefits and sops drive the passion? But then again, irrespective of the motivation, the claims and arguments cannot be ignored.

So, when the suggestion is floated that 28 February be celebrated as Sikkim Subjects' Day, it is more for people to discuss and deliberate issues of identity, belonging and history, not celebrate parochial and insular takes on what being Sikkimese means, which, unfortunately, seems to be the jingoism which dominates the public domain.

Work-life balance in a pandemic: a public health issue we cannot ignore

Defore the pandemic, a common objection to **D**remote working was the suspicion that staff would disengage and productivity levels would drop. But recent evidence suggests the opposite is true - working from home effectively means working more. In the UK, for example, many employees are reportedly putting in an extra two hours a day. It's even longer in the US.

Our survey also indicates that feeling fortunate to still be in work, the collapse of work-life boundaries, and the fear of being under surveillance from employers, have all led to people working harder for longer. Those juggling work and caring responsibilities are often struggling the most. A recent UK poll showed 71% of working mothers who requested furlough to look after their children were refused. The "sandwich generation", those managing childcare and caring for older relatives, are also having a hard time.

These factors all point to a future where overwork is normalised and work-life balance becomes nothing more than an aspiration. We must not allow this to happen.

But what is work-life balance precisely? It is a term so frequently dropped into conversation that it can sound vague and open to interpretation. According to Anna Cox, a professor of human-computer interaction at UCL, it means "feeling in control of how you balance the various demands of all aspects of life to enable wellbeing and avoid illness". It should involve "happiness, fulfilment and job satisfaction".

She adds: "Just because we can be connected to work all the time, doesn't mean we should be. Policymakers need to take concrete action to protect workers' rights to switch off."

The graphic below illustrates how a sense of wellbeing at work and the level of control one has over boundaries may interact.

Another disturbing trend that makes switching off so difficult is the emergence of so-called "bossware", controversial software that some companies use to monitor employees, under the guise of "productivity enhancement". In November 2020, there was uproar following reports that even Microsoft 365 gave bosses the ability to measure email activity and the use of shared documents.

Bossware - even the fear of it - encourages a culture of overwork. In our survey of 500 UK workers, respondents told us of their concerns over privacy during video calls, regularly interrupted

personal time and the constant pinging of work requests for those with caring responsibilities. notifications. One worker explained: "If I leave at 12.30 for a lunchtime walk, and later see my boss messaged me on Slack at 12.35, my heart sinks."

TAKE A BREAK

Our work, as part of the eWorkLife project, also included in-depth interviews to investigate the transition to remote working. Another finding was that social norms around taking breaks from work - a colleague inviting you out for coffee or lunch are vanishing. Expectations for workers to be avail-

Companies should also be strongly encouraged to update or publish flexible working policies.

Shockingly, 60% of US companies still haven't shared their remote working policies, and workers at all levels have had enough of inaction. One executive who quit due to spiralling workload confided to us: "Sure, employers are under huge pressure to survive this pandemic. But asking staff to carry the brunt through inhuman productivity rates is unsustainable."



able 24/7 were accelerating before the pandemic and, unchecked, they will become the norm.

It is vital to establish flexible social rituals around taking short breaks throughout the workday. But workers will gradually lose these healthy habits unless companies create work cultures and clear policies that encourage staff to take breaks. The government needs to take action to tackle these rapid social shifts, which should not be left to individual workers to navigate.

And although some companies are leading the way by regularly surveying employees, this is not the norm. Instead, trade unions are publishing research and pressing for change. (White-collar workers might feel joining a union is stigmatising, yet the pandemic has shown that any job can be precarious.) And when high-profile bosses talk of workers "playing the victim card" it's little wonder staff feel voiceless.

The immediate policy response should be to temporarily force companies to accept furlough

A change of approach is essential. Since the arrival of the pandemic, large numbers of people are working longer and harder. And even with increased rates of vaccination, home working in some form is surely here to stay. Ensuring it continues in a balanced way should not a responsibility that rests entirely on individuals.

The EU is now rightly urging its member states to implement policies that support work-life balance and the right to disconnect, and the eWork-Life project is urging the UK Government to take similar steps. Achieving a work-life balance is not just a worthwhile goal - it is an essential one. It is vital for mental health, physical health, and long-term economic success - and a task at which governments and businesses should be working much harder.

Daft Punk: How the Mystery Music Masterminds Used Their Robot Disguise to Take Over the World

While Daft Punk's break-up may have been unexpected, the enigmatic nature in how the public were notified was predictable. Announced via the electronic duo's YouTube channel, an upload titled Epilogue turned out to be a scene lifted from their 2006 Electroma film, alongside a vocal borrowed from a track on 2013's Random Access Memories album.

The pivotal desert scene features a prolonged trek by the duo in their instantly recognisable helmets and culminates in one self-destructing while the other walks away. Continuing then what is the pair's time-honoured preference for ambiguity, it indicates a finale while refraining from disclosing the explicit details.

Over the past 28 years, Thomas Bangalter and Guy-Manuel de Homem-Christo (the men behind the helmets) developed a complex and counterintuitive communication strategy. It was an approach that saw the pair hiding behind their alter-egos but going on to conquer the world of electronic music at the same time.

galter has indicated that this method was fundamental to Daft Punk's self-preservation. "If you can stay protected and get noticed then it's all good", he told journalist Suzanne Ely in 2006. What began with Bangalter and de Homem-Christo using various masks to hide their discomfort within photoshoots - obscuring rather than projecting a specific image - was eventually resolved when they reinvented themselves as androids.

Robot rock

Like the electronic group Kraftwerk before them, these cyborgs further celebrated the electronic, automated characteristics of their music, while at the same time orchestrated a mythology in conjunction with technology's all-pervasive influence.

Bangalter even presented an origins story in which he claimed that the duo's appearance was the result of an accident. Specifically, that the explosion of an electronic music sampler in 1999 had transformed them into their robot alter egos. Yet alongside this superhero version, Daft Punk also cited the conversion as being their response to fame.

"We don't believe in the star sys-

As the more vocal of the two. Ban-tem." Bangalter stated. "We want the focus to be on the music. If we have to create an image, it must be an artificial image. That combination hides our physicality and also shows our view of the star system. It is not a compromise."

Anti-celebrity superstars

In this sense, I believe Daft Punk have become an example of an "anti-celebrity celebrity". Yet despite what they might have claimed, with arena tours and cameos in Disney movies, Bangalter and de Homem-Christo were far from being "anonymous".

Theirs was a stance fraught with contradiction - and one maybe familiar to many working in arts and culture who find their rejection of consumer culture operating within the same market-driven constraints. In Daft Punk's case, it resulted in often uneasy relationships such as the robots' involvement in global advertising campaigns, and many Daft Punk interviews issued by media outlets that repeatedly assured us that they rarely give interviews.

The pair's press engagement has been particularly cultivated to maintain this "media reluctance" narrative. And it became a mutually beneficial arrangement, perpetuating Daft Punk's anti-stardom position while also enabling publications to claim they had an exclusive.

Got lucky?

For an audience that may similarly be suspicious of media saturation - and what it can indicate in terms of "selling out" - this notion of Daft Punk's interaction being rare, intimate and indifferent to the supposed demands of industry may also have been attractive.

Perhaps French sociologist Pierre Bourdieu had it right when he said that profits can be derived from "disinterestedness". Indeed Daft Punk's marketing succeeded because of its highlighted rejection of the most obvious, unromantic mechanisms of

The Epilogue video message is then a fitting end, highlighting remoteness and attachment, anonymity and familiarity, and all delivered by a self-destructing robot with no accompanying press release. It aptly concludes Daft Punk's legacy of technology-assisted public engagement. Over and out.


Indian economy grows by 0.4 pc in Oct-Dec

NEW DELHI, FEB 26 (PTI): After contracting for two quarters in a row, the Indian economy grew by 0.4 per cent in the October-December quarter amid coronavirus pandemic, official data

showed on Friday.

The gross domestic product (GDP) had expanded by 3.3 per cent in the corresponding period of 2019-20, according to the data released by the National Statistical Office (NSO).

In its second advance estimates of national accounts, the NSO has projected 8 per cent contraction in 2020-21. In its first advance estimates released in January, it had projected a con-

India vs England: Expected pitch to hold on a little longer than it did, says England head coach



AHMEDABAD, 26 FEB: England head coach Chris Silverwood on Friday said that his side expected the pitch in the third Test against India to hold on a little longer than it did at the Narendra Modi Stadium. India defeated England within two days in the pink-ball Test to take a 2-1 lead in the four-match series. The match saw poor batsmen from both sides fail miserably on a spinning track, with majority of them getting out to deliveries that didn't turn and skidded through from the spinners.

"First and foremost, it's just a follow-up from what Joe Root said yesterday, he got 5/8 yesterday but at the same time, whatever the pitch did or it didn't do, India ultimately played better than us on that surface, probably they pushed us to the extremes which our players haven't experienced before," said Silverwood in a virtual press conference on Fri-

day. When asked about whether England would be talking to the ICC about the pitch used in the third Test, Silverwood replied: "Listen, we will be talking about certain things behind the scenes. But at the same time, we were really disappointed that we lost with three days of cricket left. We are where we are, from my point of view, it's about heading into the next game and coming out fighting."

"We have spoken to Javagal (match referee), but it was not about the pitch. I think Joe and I need to have discussions about it really and see where we go from there. We have to accept that we need to get better on these pitches. You look at the first innings, we had an opportunity to score runs and make the best use of the pitch," he add-

England had opted to go in with just one spinner -- Jack Leach -- in the third Test. Root, who is normally a part-timer, picked his maiden five-wicket haul and Silverwood cited this performance to say that the visitors did not make a mistake in team selec-"Joe Root got 5/8 so

the second spinner did fine for us. We did expect the wicket to hold up a little longer than it did. Looking back in history in pink-ball Tests, the ball swung for us, Jimmy and all got movement during practice. With the experience we had and having two of our bowlers in the top ten in the rankings, we felt with this pink ball, it would have been an opportunity for seamers to make an impact for

"It's not that we did not think about it, there was logic, we had a look at the stats and how we can use pink ball the best. Root works very hard on his bowling, I am always saying to him that he always under bowls himself. But Joe being Joe, he had to do it this time and

he got 5/8," Silverwood

said.

When asked about what type of pitch he would like in the fourth Test, Silverwood said: "I would like the pitch in the fourth Test to be a fit flatter, it would suit our gameplan. Yeah, I would like it to be flatter, but we will see what the wicket looks like in the coming days and we will take it from there really."

After both teams failed to shine in their first innings, England were bowled out for 81 in the second innings, setting India a target of just 49 runs. The hosts chased down the total without losing any wicket to go 2-1 up in the se-

With match getting over well inside two days, there was a lot of debate around the pitch once again, but India opener Rohit Sharma clarified that he did not think the pitch had any demons in it.

Even skipper Virat Kohli was vocal about the dreadful batting display from both the sides. Kohli said the quality of batting was to be blamed as most of the batsmen got out to balls that didn't turn.

Stand or kneel? How Megan Rapinoe helped US Soccer change its tune

LONDON, 26 FEB [THEGUARDIAN]: It wasn't long after the death of George Floyd that the decision-makers at the US Soccer Federation realized they needed to make some changes - and one change was immediately obvious.

Years earlier, the federation had issued an edict requiring national team players to stand during the national anthem. It was targeted at Megan Rapinoe, who had been kneeling to protest systemic racism, and the federation framed its new policy as minimizing distractions and showing respect for the flag.

But in the aftermath of Floyd's death last summer, even many US Soccer board members who had originally voted in favor of the anthem requirement felt they had missed the point. They failed to see what Rapinoe was trying to highlight all along.

And so, about two weeks after Floyd's death, new US Soccer president Cindy Parlow Cone apologized to Rapinoe and asked the USWNT star to speak to the board about the policy.

"What I was asking them was: 'Where are we going? Where is the world going? What does this rule say to our black players and our black fans?" Rapinoe recalled to the Guardian. "It was great to be able to have that open line of communication and get to speak to the board directly because that's not something that has happened before at all to my knowledge."

The board voted to repeal the policy last summer and the federation formally apologized, but the issue won't officially be settled until Saturday, when the rest of US Soccer's membership body will vote at its annual general meeting to affirm the repeal.

If that does happen, which insiders tell the Guardian is likely but not guaranteed, it will signal a remarkable turnaround from five years ago. When the policy was first introduced at US Soccer's 2017 annual meeting, the voting membership, which is overwhelm-



ingly white and male, didn't simply vote in favor of it - they gave it an enthusiastic standing ovation.

In some ways that shift in tone around US Soccer reflects a larger change in America. The standor-kneel debate felt different after the deaths of Floyd, Ahmaud Arbery and Breonna Taylor. For many, kneeling during the national anthem now looks less like disrespect for the flag and more like an acknowledgement that the American experience isn't the same for

But those connected to US Soccer say it's not only that – they cite a deliberate effort from its new leadership to right its past wrongs. Board members and staffers tell the Guardian they feel a difference in not just tone, but in action since Parlow Cone took over one year ago.

After all, repealing the anthem policy wasn't going to be popular. The board had passed the rule in 2017 unanimously, and Parlow Cone admits she knew its repeal wouldn't be unanimous. After hearing from US Soccer's nonwhite employees on an all-staff Zoom call, however, she felt she had to do it. That call, she says, was "an awakening".

"Having been a member of the national team, I never fully understood the struggles that my black and brown teammates went through on a daily basis because we never talked about it," says Parlow Cone, who played in two World Cups for the USWNT. "For me personally, it was a moment where I was like, 'OK, it's time for me to be a better teammate. I'm not on that team anymore, so what can I do now?"

"I knew it was going to be a hard conversation," she adds of the repeal. "I knew that it was very going to be very divisive, not only within the board but publicly – but I felt like it was the right thing to

To be sure, the anthem policy is not the most important issue facing US Soccer.

If the federation is really serious about diversity and inclusion, there are better ways to make a lasting, tangible impact, including addressing its lack of diversity among its own staff and coaches. The federation says that is happening, and its new DEI Council is leading the way. But until US Soccer can point to concrete improvements, the anthem policy may serve as the best proxy to understand how US Soccer is evolving.

To that end, there's a clear contrast between how the policy was handled five years ago compared

In 2017, US Soccer's board, which was led by then-president Sunil Gulati, didn't speak to any black people about the issue, nor did anyone from the federation speak to Rapinoe, the only player kneeling at the time. "I felt like, I'm the one who's kneeling, so at least we should have a conversation about this going forward, but there was nothing," Rapinoe says, adding she only found out about the standing requirement after it had been approved.

In weighing the repeal, however, the board spoke to Rapinoe, former USMNT defender DaMarcus Beasley, who is black, and a member of the US men's Paralympic team who had served in the military. Board members now say that was the sort of dialogue that was missing 2017.

Critics may be skeptical that anything has really changed at US Soccer though, and they can point to Parlow Cone sitting on the board during the passage of the new anthem policy and other past controversies as well. But as a rank-and-file board - an unpaid volunteer that participates in board meetings a few times per year – she was hardly in a position

of influence.

Now that Parlow Cone is calling the shots after being unexpectedly thrust into the presidency by Carlos Cordeiro's forced resignation, board members and staffers tell the Guardian she's different than the power-broker types who went out of their way to campaign for the presidency.

Even Rapinoe is "hesitantly" optimistic about change at US Soccer, but she says she still needs to see more. The repeal is not the end of the work US Soccer needs to do - it's only the beginning.

"It's absolutely a positive step moving forward," Rapinoe says of the repeal. "In the end, the willingness to apologize to their black players, fans and media alike, to say it was wrong and repeal the ban, to say, 'We have to do better; we realize that and we will commit to doing better going forward' – I think that's all you can ask for."

Rapinoe adds: "In terms of racial equality, yes, they've done a good job this year, but obviously they had a lot to pivot from. I think the board and the leadership is looking very different - that's becoming quite apparent. We just need to keep that energy and keep it a focus."

Now the question turns to what happens Saturday.

To affirm the repeal, all that's needed is simple majority vote from US Soccer's membership representatives, which cover all levels of soccer in all 50 states. Not everyone who cheered for the protest ban five years ago is likely to be converted. But Parlow Cone is hoping enough will be.

"I led this charge and I think it's past time to do it, but I do also have an understanding that this remains a very divisive issue in our country and among our membership," she says. "I'm hoping that, like me, others have been more educated on the topic and want to give the athletes the right to kneel if they choose."

In some ways, it's a bit of a moot issue.

Ever since US Soccer's board voted to repeal the anthem policy last summer, many USWNT players have chosen to kneel before games. Whether US Soccer's membership affirms the repeal Saturday or not, the federation has made it clear it won't punish players who kneel.

When the USWNT faced Argentina on Wednesday in the SheBelieves Cup finale, Rapinoe stood - by choice - for the first time in years, and all her teammates did the same. As Crystal Dunn, who is black, put it: "We are ready to move past the protesting phase and move into putting all of the talk into actual work."

But for Rapinoe, the final repeal remains important.

"You know, at the annual general meeting, it's not necessarily just Cindy or just the board - these are the people that are close to the kids and in the youth programs and spreading the US Soccer Federation message countrywide. That's not good if we have a bunch of people who are not respecting people's right to protest, first of all, and then don't really respect the reason that people are protesting.

"That's a massive problem for me personally. I think it's hugely important that it's repealed and it's off the books. Otherwise, that's a huge stain on the books of US Soccer."

I accidentally became a cricketer, says Ashwin

"And every time I finish playing a game and if I give that winning result for the team, I just feel I am being given a blessing, but the COVID times made me feel how lucky I am to actually play for India.

"Even when I came back after the IPL, I never thought I will play in Australia, so that is what I said, everything has been a gift, for the love with which I play the game, the game is giving me back enough and more

Ashwin, who also be-Sri Lankan spin legend Muttiah Muralitharan, said that he watched a lot of old videos of great individual performances in the lock-down helped improve his understanding of the game.

"I used to watch a lot of footage even before, but the understanding of the game has gone one notch higher...during the lockdown, I was watching a lot of cricket from the past, especially Sachin's hundred in Chepauk, all sort of stuff on Youtube," recalled the 34-year-old Chennai-born player.

Diogo Goncalves levelled the contest with a magnificent free-kick and Rafa Silva gave Benfica a 2-1 lead on the night when he took advantage of an error from Dani Ceballos on the hour.

Kieran Tierney rifled in an equaliser and Aubameyang headed in the decisive goal from Bukayo Saka's cross on 87 minutes, earning the Gunners a 4-3 aggregate victory and saving them from an unusual away goals exit following a 1-1 draw in the first leg in Rome.

"Everyone is happy tonight. This is what gives me power every day, take errors from the past and transform to strength," Aubameyang told BT Sport.

"The team showed a lot of character and we deserved the win. It was a hard game. What we showed tonight will be an example for the future."

United cemented their place in Friday's draw with a 0-0 draw at home to Real Sociedad, having effectively clinched the tie last week with an emphatic 4-0 win on neutral ground in Italy.

Amnesty report describes Axum massacre in Ethiopia's Tigray



NAIROBI, KENYA (AP): Soldiers from Eritrea systematically killed "many hundreds" of people, the large majority men, in a massacre in late November in the Ethiopian city of Axum, Amnesty International says in a new report, echoing the findings of an Associated Press story last week and citing more than 40 wit-

Crucially, the head of the government-established Ethiopian Human Rights Commission, Daniel Bekele. says the Amnesty findings "should be taken very seriously." The commission's own preliminary findings "indicate the killing of an as yet unknown number of civilians by Eritrean soldiers" in Axum, its statement said.

The Amnesty report on what might be the deadliest massacre of Ethiopia's Tigray conflict describes the soldiers gunning down civilians as they fled, lining up men and shooting them in the back, rounding "hundreds, if not

The region has been largely cut off since fighting began in early November.

Ethiopia's federal government has denied the presence of soldiers from neighboring Eritrea, long an enemy of the Tigray region's now-fugitive leaders, and Eritrea's government dismissed the AP story on the Axum massacre as

"outrageous lies." But even senior members of the Ethiopia-appointed interim government in Tigray have acknowledged the Eritrean soldiers' presence and allegations of widespread looting and killing.

On Thursday, Ethiopia's government acknowledged that the Ethiopian Human Rights Commission was investigating "allegations relating to incidents in the city of Axum" in collaboration with unnamed international experts.

But Ethiopia's ambassador to Belgium, Hirut Zemene, told a webinar on Thursday that the alleged massacre in November was a "very highly unlikely scenario" and "we suspect it's a very, very crazy idea."

No one knows how many thousands of ci-

vilians have been killed in the conflict between Ethiopian and allied forces and those of the Tigray regional government, which had long dominated Ethiopia's government before Prime Minister Abiy Ahmed took office in 2018. Hu-

manitarian officials have

warned that a growing number of people might be starving to death as access, while improving, remains restricted. The presence Eritrean soldiers has brought some alarm. The United States has repeat-

edly urged Eritrea to withdraw its soldiers and cited credible reports of "grave" human rights abuses. On Wednesday it asked, "Does the Eritrean military have sufficient control over its troops to prevent them from committing human rights abuses?"

Witnesses of the massacre in Axum told Amnesty International that Ethiopian and Eritrean soldiers jointly took control of the city but the Eritreans carried out the killings and then con-

raids for men and teenage boys. Bodies were left strewn in the streets after the events of Nov. 28 and 29, witnesses said.

"The next day, they did not allow us to pick the dead. The Eritrean soldiers said you cannot bury the dead before our dead soldiers are buried," one woman told Amnesty International. With hospitals looted or health workers having fled. some witnesses said a number of people died from their wounds because of lack of care.

"Gathering the bodies and carrying out the funerals took days. Most of the dead appear to have been buried on 30 November, but witnesses said that people found many additional bodies in the days that followed," the new report says.

After obtaining permission from Ethiopian soldiers to bury the dead, witnesses said they feared the killings would resume any moment, even as they piled bodies onto horse-drawn carts and took them to churches for burial, at times in mass graves.

The AP spoke with a deacon at one church, the Church of St. Mary of Zion, who said he helped count the bodies, gathered victims' identity cards and assisted with burials. He believes some 800 people were killed that weekend around the city.After being left exposed for a day or more, the bodies had begun to rot, further traumatizing families and those who gathered to help.

Pandemic leaves many Romanian patients without critical care



BUCHAREST, ROMANIA (AP): Andrei, a 32-yearold Romanian man who has been HIV positive since he was a baby, began missing his regular medical check-ups when the coronavirus pandemic hit a year ago.

"That was the first thing that led me to a general state of frustration and fear," said Andrei. "After that, I got used to the idea of taking the antiretroviral treatment blindly without knowing if the parameters are OK or if the therapy works."

A year ago this week, Romania reported its first case of COVID-19, prompting the country's strapped medical system to turn its focus to treating COVID-19 patients. As a result, many patients with other conditions including cancer — have either been denied critical care or have stopped going to their regular appointments, fearful of becoming infected.

"Many of my close associates lost their battle against their diseases due to the loss of access to treatment, hospitals and specialists," Andrei, who didn't want his full name used due to the stigma surrounding his condition, told The Associated Press.

Romania's government is acknowledging the problem and has announced plans to reorganize the country's hospitals so more non-COVID-19 patients can get access to health care.

The attempts to reform the health care system come as a third virus surge looms and as a vaccine rollout is proceeding slowly across the 27-member European Union, to which Romania belongs. "Patients who didn't have COVID-19 didn't seek medical care because they were afraid of becoming infected," Dr. Andreea Moldovan, a state secretary in the Health Ministry, told the AP.

Previously, she said, there was "a lot of pressure to have as many beds available for COVID-19 patients as possible."

With a population of over 19 million, Romania has reported 792,000 COVID-19 infections and over 20,000 deaths.

Romania's Ministry says its hospital reorganization scheme will aim to create separate red and green zones in hospitals so both non-COVID-19 patients and those infected with the disease can be segregated yet receive the medical care they require.

In an interview at Bucharest's Colentina Hospital, interim hospital manager Victor Cauni said health care services in the long term must adapt to life with COVID-19 and not "discriminate" against other patients.

"Whether we like it or not, we have more patients with many other illnesses compared to COVID patients," he said. "We need to open for them at least partially. We're discriminating against patients with serious conditions."

Highlighting problem, Cauni noted that the hospital's urological ward used to perform from 400 to 500 medical interventions a month, but has barely had 50 in the past year.

"For the last year, patients did not have access to this hospital, and they were supposed to be transferred to different hospitals — but not many managed to find the required solutions," Cauni said.

"You cannot just function as a COVID-19 hos-

pital," he said. "We have many important wards here." The organizational changes in Romania's hospitals come amid growing concerns about new virus variants, including the variant first found in the U.K., which scientists say is both more transmissible and more deadly.

Romania faces these challenges as the EU nation with the lowest health care spending relative to GDP -5.2%, compared with almost 10% on average in the

Romania already has the highest rate of avoidable deaths of under-75s in the EU, according to EU statistics.

Health Minister Vlad Voiculescu expressed his concerns in a video address last week to hospital managers and public health officials, explaining the hospital reorganization effort.

"The pandemic has not wiped out all other chronic or acute health problems," Voiculescu said. "We need to make sure that all other patients have access to the medical services they

Andrei, who became infected with HIV as a baby while being treated in a hospital, says he considers himself "one of the lucky ones."

He has managed to pay privately for a few medical analyses in the past year. But he worries about his longer-term prospects if he doesn't return to the close monitoring of his illness.

"The situation is critical," he said. "If I keep blindly taking my treatment without proper monthly visits and analyses to check if the treatment is working ... there is only one outcome the loss of life."


In Mandalay, the country's second-largest city, anti-coup protesters also took to the streets Friday. They included a contingent of Buddhist nuns holding placards that read "We Immediately Need Action by Force from US Army." Other demonstrators carried signs reading "Free our leader Aung San Suu Kyi," "Pray for Myanmar," and "Reject Military Coup."

By midday, security forces had blocked the main road in downtown Mandalay to prevent the protesters from gathering. Suu Kyi has not been

seen since the coup. Around 50 of her supporters held a prayer Friday opposite her home in Yangon. The rambling mansion on University Avenue is where she spent many years under house arrest during previous military governments, and the residence has long had iconic status among her supporters.

"Because of the situation, on this day of the full moon we are sending love to, and reciting Buddha's teachings for Mother Suu, President U Win Myint and all those unlawfully detained," said Hmuu Sitt yan Naing, who joined the prayer group. It is believed Suu Kyi is currently being detained in the capital Naypyitaw. She is due to face a court on Monday on charges brought against her by the military junta that are widely seen as politically motivated.

Several Western countries have imposed or threatened sanctions against Myanmar's military. On Thursday, Britain announced further measures against members of the ruling junta for "overseeing human rights violations since the coup."

It's a smash hit! Chinese return big-time to movie theaters

BEIJING (AP): The thrills and chills of New Year festival, which began this year the big screen are back big-time in the world's largest film market.

With coronavirus well under control in China and cinemas running at half capacity, moviegoers are smashing China's box office records, setting a new high mark for ticket sales in February, with domestic productions far outpacing their Hollywood competitors.

February marked China's all-time biggest month for movie ticket sales, which have so far totaled 11.2 billion yuan (\$1.73 billion). China overtook the U.S. as the world's biggest market for movie ticket sales last year as the American box office took a massive hit from the closure of cinemas because of the coronavirus pandemic. Chinese theaters were able to reopen by midyear and have seen steady audience growth since then. Local movies have also benefited from periodic unofficial "blackout" periods, when only domestic productions are allowed to be screened. A dearth of major Hollywood blockbusters over recent months appears to have also boosted the market for Chinese films.

"People were encouraged to stay in Beijing for the Lunar New Year, and so watching movies in the cinema became the top choice of entertainment," said Chu Donglei, marketing manager at Poly Cinema's Tiananmen branch in central Beijing. Mask-wearing is mandatory and moviegoers must register with a mobile phone app so they can be traced in the event of an outbreak. Only every other seat was allowed to be occupied, making it even harder to obtain tickets for the most popular films.

According to the China Movie Data Information Network, 95% of ticket sales came from the seven top-grossing : films timed for release around the Lunar

on Feb. 12. "Hi, Mom," a time-traveling comedy written, directed and starring Jia Ling, was the top earner with 4.36 billion yuan, followed by action comedy "Detective Chinatown 3," with 4.13 billion yuan.

Wang Xiaoyu, 32, who works in the film industry, was only able to procure a ticket for "Hi, Mom" on Thursday and called the viewing experience "deeply moving." "I know there are some movies that are released and streamed online. But I think the experience of watching movies online is not as good as that of watching in a cinema. I prefer going to the cinema to watch movies. The experience is different," Wang said.

A lack of entertainment options had helped pump up ticket sales during the pandemic, foretelling a bright future for the Chinese film industry, Wang said.

College student Zhang Jiazhi, 21, said the live movie theater experience was a welcome break from staying at home watching videos. Successful online film promotion had also helped attract many viewers to brickand-mortar cinemas, Zhang said.

"I'm bored, and you can't stay at home watching (streaming service) Douyin all the time, so I came to the cinema to watch a movie. There's nothing to do," said Zhang, who is on winter break and came to the cinema to see "A Writer's Odyssey," a Chinese fantasy film which he said he didn't quite understand.

China became the world's biggest box office last year, selling an estimated \$2.7 billion in tickets compared to \$2.3 billion in the U.S., which saw an 80% drop in ticket sales. "The Eight Hundred," an action drama glorifying China's resistance to Japanese invaders in 1930s Shanghai, was the world's biggest hit, making \$461.3 million at the box office, most of
