Second wave on the ebb, hospitalizations down-vaccinations up in Sikkim

 $E^{\text{ven though Novel Coronavirus has proven to be}}$ unpredictable adversary, the numbers of late would have Sikkim breathe easier since infections continue to fall, and more importantly, hospitalizations of Covid-positive people and fatalities among Covid patients have dropped even more substantially.

The Daily Report of Covid-19 in Sikkim released by the Integrated Disease Surveillance Programme of Health Department on Sunday morning, for instance, inform that the daily test positivity rate in the State came in at 5% for the past 24 hours, new hospitalizations at barely six and no new Covid deaths.

Only 18 of the 354 samples screened for COVID-19 on Saturday returned positive. What is more, 127 people were discharged from home and facility isolation over the same 24 hours after beating the virus and making full recoveries.

This substantial difference



between new cases and recoveries has brought the number of active Covid cases down to 500 in Sikkim and now stands at 493.

Most of the Covid-positive people are on their way to recovery under home or facility isolation and there are only 47 Covid patients with symptoms severe enough to require hospitalization. Of these, six patients were admitted in the last 24 hours. Against all the are only seven under 18-year-

in the ICU. There are, however, nine adults admitted in ICU facilities at STNM Hospital and CRH-Tadong.

Meanwhile, against the fears of the virus affecting the 31,525 cases of Covid deyoung more severely, there tected in the State since testing began on 28 Feb last year, olds in hospital, none of them 30,328 people have already

made full recoveries. With this, Sikkim also broke the 97% mark on recoveries and the recovery rate now stands at 97.1%.

While there were no new Covid deaths in the past 24 hours, the State has lost 338 lives to Covid thus far.

The IDSP report further details that of the 18 new cases, eight were detected in RT-PCR testing of 232 samples, nine in rapid antigen testing of 118 samples and one in TruNat testing of four samples.

13 cases new were registered in East District, 04 in South District and 01 in North District.

On the vaccination front, Sikkim has already ensured that the entire eligible section of the population has received at least one dose of the Covid vaccine. On Saturday, a total of 3,600 people received Covishield jabs, of whom 3,459 completed their vaccination schedule with the second dose and 141 received their first dose.

With nearly 3.95 lakh of the 5.17 lakh people who make up the adult population of the State having already received both their Covishield jabs, more than 76% of Sikkim's eligible population is now fully vaccinated against Covid.


ARuGi Puraskar conferred on Prem Thulung

Fuel prices hiked for fourth straight day; Petrol touches new high

NEW DELHI, 03 OCT [NDTV]: The and 32 paise, respectively. state-run oil marketing companies (OMCs) on Sunday hiked fuel prices for the fourth consecutive day. With the latest price, petrol and diesel prices have touched new alltime highs across the country.

Petrol prices in Delhi stand at Rs.102.39 per litre, witnessing a hike of 25 paise, while diesel rates went up by 30 paise, currently standing at Rs. 90.77 per litre. At the same time, in Mumbai, petrol has reached an all-time high of Rs. 108.43 per litre, while diesel prices have touched Rs. 98.48 per litre, witnessing a price hike of 24 paise

As for other metro cities, petrol prices in Kolkata today have gone up to Rs.103.07 per litre, a hike of 30 paise, while diesel prices have touched Rs.93.87 per litre after receiving a hike of 30 paise.

Fuel rates are the most expensive in Sri Ganganagar district of Rajasthan where petrol currently stands at Rs.114.34 per litre, while diesel stands at Rs.104.64 a litre.

In Madhya Pradesh's Rewa and Anuppur districts, petrol prices have reached Rs. 113.30 a litre and Rs.113.70 a litre, while diesel rates have touched Rs.101.97 a litre

and Rs.102.34 a litre, respectively. Customers in Maharashtra's Parbhani district will now have to pay Rs.110.99 a litre and Rs.99.44 a litre for petrol and diesel, respectively.

Indian Oil Corporation, Bharat Petroleum, and Hindustan Petroleum are the three leading oil marketing companies. Changes in fuel prices are implemented at 6 am every day. The prices are determined as per global benchmarks of crude oil rates, and by making changes in the foreign exchange rates into account. The fuel rates vary from state to state in the country due to the value-added tax or VAT.

Other selected bankers are SBI Capital Market Limited, JM Financial Limited, Axis Capital Limited, BofA Securities, J P Morgan India Private Limited. ICICI Securities Limited and Kotak Mahindra Capital Company Limited.

Cyril Amarchand Mangaldas has been appointed as legal adviser for the IPO.

The ministry is in the process of estimating the embedded value of the life insurer and once that is done, the ministerial panel on disinvestment will decide on the government stake that will be divested through IPO, the official said.

The government has appointed actuarial firm Milliman Advisors LLP India to compute the embedded value of LIC ahead of the initial public offering.

The government is also mulling allowing foreign investors to pick up stakes in country's largest insurer. As per SEBI rules, foreign portfolio investors (FPIs) are permitted to buy shares in a public offer. However, since the LIC Act has no provision for foreign investments, there is a need to align the proposed LIC IPO with SEBI norms regarding foreign investor participation.

The listing of LIC will be crucial for the government in meeting its disinvestment target of 2 1.75 lakh crore for 2021-22.

Helpline for elderly logs over 3.39 lakh calls since May

NEW DELHI. OCT 3 (PTI): The government's senior citizen helpline, Elderline, has received over 3.39 lakh calls since May, with more than 79,000 of them from Uttar Pradesh.

The national helpline launched by the Social Justice and Empowerment Ministry in collaboration with Tata Trusts aims to reach out to the elderly seeking assistance.

Among states, the highest number of calls were received from Uttar Pradesh at 79,542 followed by Uttarakhand at 54,432, Telangana at 42,610, Tamil Nadu at 27,708 and Karnataka at 22.711.

More men than women reached out to Elderline seeking help.

According to the data, 23,390 men called the helpline while the number stood at 8,178 for women.

The top reasons for reaching out to the helpline included Covid support(13,496), pension (8,952), abuse (1890), health-related support (1202), rescue (423) and queries related to old age homes (632), according to the data.

However, out of the 3,39,879 calls received since May 1, as many as 3,02,195 calls were non serviceable calls which include non genuine requests like nuisance calls, calls with out of scope requests for non elderly among others, according to the data shared by the Social Justice and Empowerment Ministry.

While out of 37,684 genuine calls, 17,933 calls (47.59 per cent) were related to COVID-19 related support, vaccination information and voluntary services among others.

About 11,209 calls (29.75 per cent) were looking for guidance in subjects of legal counsel, direction for social security and pension related issues.

As many as 5,550 calls (14.73 per cent) were seeking information that includes calls which provides details of old age homes, caregivers, day care centres, hospitals, doctors among others.

While 2,313 calls (6.14 per cent) were for seeking field interventions when caller was seeking support for rescue of a homeless elderly or care for an abused elderly.

About 679 calls (1.80 per cent) were also received for seeking emotional support where callers were counselled.

An official said in some cases these calls were directed to mental health professionals with experience in geriatric therapy and counselling for in person support.

The official said the call pattern in the helpline can help the government in giving it direction for policy decisions for elderly.

Active COVID-19 cases in country lowest in 199 days

NEW DELHI, OCT 3 (PTI): ducted so far for detec- and surpassed the one-India added 22,842 new coronavirus infections taking the total tally of COVID-19 cases to 3,38,13,903, while the active cases declined to 2,70,557, the lowest in 199 days, according to the Union Health Ministry data updated on Sunday.

The death climbed to 4.48,817 with 244 fresh fatalities, according to the data updated at 8 am.

The active cases comprise 0.80 per cent of the total infections, the lowest since March 2020, while the national CO-VID-19 recovery rate was recorded at 97.87 per cent, the highest since March 2020, the ministry

A decrease of 3,332 cases has been recorded in the active COVID-19 caseload in a span of 24

As many as 14,29,258 tests were conducted on Saturday taking the total cumulative tests contion of COVID-19 in the country to 57,19,94,990.

The daily positivity rate was recorded at 1.80 per cent. It has been less than three per cent for last 34 days. The weekly positivity rate was recorded at 1.66 per cent. It has been below three per cent for the last 100 days, according to the ministry.

The number of people who have recuperated from the disease surged to 3,30,94,529, while the case fatality rate was recorded at 1.33 per cent.

The cumulative doses administered in the country so far under the nationwide COVID-19 vaccination drive has exceeded 90.51 crore.

India's COVID-19 tally had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 crore mark on December 19. India crossed the grim milestone of two crore on May 4 and three crore on June 23.

The 244 new fatalities include 121 from Kerala, and 49 from Maharashtra.

A total of 4,48,817 deaths have been reported so far in the country including 1,39,166 from Maharashtra, from Karnataka, 35,627 from Tamil Nadu, 25,303 from Kerala and 25,088 from Delhi, 22,894 from Uttar Pradesh and 18,815

from West Bengal. The ministry stressed that more than 70 per cent of the deaths occurred due to comorbidi-

"Our figures are being reconciled with the Indian Council of Medical Research," the ministry said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.

Not possible to destroy cryptocurrencies': Elon Musk says governments can only crunch crypto growth rate

New Delhi, 03 Oct [NDTV]: In a message to governments around the world, Tesla CEO Elon Musk has said that while the advancement of cryptocurrencies can be slowed down, these digital assets cannot be destroyed now. The crypto-supporting tech mogul further went on to reportedly advise the US government to do "nothing" about regulating the crypto-space if the aim is to curb crypto-expansion. The statement by the 50-year-old multi-billionaire came as he was addressing the "Code 2021" conference in the Beverly Hills area of Los Angeles, US.

"I suppose cryptocurrency is fundamentally aimed at reducing the power of a centralized government. They don't like that," news portal decrypt.co quoted Musk

as saving on Wednesday, September 29. "It is not possible to, I think, destroy crypto, but it is possible for governments to slow down its advancement". Musk's suggestion to the governments batting for "no action" against crypto comes days after the world's most populated country, China, imposed a blanket ban on cryptocurrencies mining and trading.

Post China's ban, the crypto market has witnessed major fluctuations this week, with the prices of highly valued ones like Bitcoin and Ether witnessing more lows than highs.

"Part of it may actually be due to electricity shortages in many parts of China. A lot of South China right now is having random power outages because the power demand is higher than expected.

Are We Sweeping Away a Legacy?

Gandhi valued cleanliness, but he was about much more

The Centre and its pliant state governments are go-**■** ing into a cleanliness hyper-drive. Given that our country could do with some saaf habits, this abhiyan is welcome. It is, however, this "missions" collateral damage [or maybe it was not an unintentional consequence] that makes one take pause and wish that a deeper abidance of the Gandhian Way was followed by those who coin the acronyms and slogans which dictate governance in the country.

It is important to realize that The Father of the Nation promoted cleanliness as a means to a larger end, and not the end itself. Filth, the physical kind, is clearly a result of unplanned urbanization and uncaring city administrators, and then these poor habits travelled back to villages which too had their sense of community responsibility erased by overbearing centralized planning. Now, the same disconnected offices are trying to guilt us into cleanliness drives. If our agencies and babus had done even half of what their charters required them to do, our settlements would have been clean and our citizens more participating than less supplicant. Too much inference? Probably. But it should be obvious to anyone that when Gandhi "enforced" cleanliness, it was not because his ashram was dirty, but because he wanted to promote dignity of labour, self-respect and self-reliance. Then, people could collaborate, shake off their prejudices and engage as equals. When we "organize" cleanliness drives because of a circular from the Home Department and make it a VIP event, complete with chief guests and brand new brooms, we turn Gandhi's idea of its head. That, however, is only a small part of what we are losing.

Cleanliness was a tool that Gandhi devised to hammer away at the divisions he noticed among us. Shared menial tasks and community participation for cleanliness and hygiene, like team sports and praying together, bring people together and make them rely on each other. This builds up well towards what is Gandhi's most important gift to the world - peaceful civil disobedience. Gandhi weaponised people with ahimsa and satyagrah. There is a very real danger that his essence will be reduced to cleanliness. Look around, we have become sycophants who celebrate intolerant governments which have gone after expressions of civil disobedience with a viciousness that competes with the disdain of the British and how they engaged with Gandhi for the longest time. Anti-dam protests, the Shaheen Bagh sit-in, activists working among exploited tribes, farmer protests, SPYF demonstrations on behalf of the people or the dharna by a section of the adhoc teachers; they have all come against official attitudes which clearly have no respect for Bapuji. In the end, we lost the Mahatma not to the violence of a colonial master, but to the intolerance of fellow free citizens. The misguided xenophobia which infected his assassin continues to be peddled. #Godse, did after all, trend on twitter on Gandhi Jayanti.

Gandhi was an ardent exponent of ahimsa and led us to Independence without a war. He was also a champion of the downtrodden, who, even as he led the Freedom struggle, refused to be distracted from the path of non-violence, even ending a non-cooperation movement once when he realised that not all Indians were completely committed to ahimsa just yet. What is more, even as he steered the struggle for Independence, he worked as tirelessly towards eradicating untouchability and powering other social reforms. He advocated religious tolerance and sowed the seeds of secularism which found roots in the Constitution. He stood for truth at all costs and was steadfast in his beliefs, refusing to make compromises even in the face of defeat or even ridicule. He believed in working with the people, taking them into confidence and leading them when he had won their endorsement and convinced them about the path to be taken. The basic Gandhian principle was to lead them away from conflicts of personal interests towards a community or community of interests. Gandhi's goal was to bring about a community of interests by holding it up as the common good, by making Sarvodaya the motivation of all individual action.

And what have we done with that legacy? When he spoke of harmony, he did not mean conditional tolerance, but we have abandoned even the latter and are now more suspecting of the other. Where Gandhi spoke espoused rural empowerment, we have institutionalized disdain for rural pragmatism and talk down to citizens in general and the basti-wallahs in particular. We try to dovetail bhakti to a cult and majoritarianism even into national events like Safai Abhiyan, and we do insensitively in the name of the Mahatma. When Gandhi said, "I will not let anyone walk through my mind with their dirty feet," he clearly did not mean that his cleanliness was just about a safai abhiyan in government offices or neighbourhood mandirs.

Powerful, Local Stories Can Inspire Us to Take Action on Climate Change

The climate emergency has put the world in grave peril, but that is hard to tell when watching the news or looking at the overall global response to the climate crisis, which continues to be lax.

Climate change is a complex and difficult problem to communicate. It is slow-moving, it does not always feel urgent and there is often very little gratification for acting to mitigate it.

For decades, the assumption has been that members of the public, politicians and policy makers would take the matter more seriously if only there was more information about the impacts and consequences of a warming planet.

The science, now, is unequivocal. Humans are responsible for climate change and the extreme weather events it generates.

We need to rethink the way we communicate climate change. The best tool at our disposal is a simple one: storytelling. Stories have the power to transform complex subject matters into something that feels personal, local, relatable and solvable.

But stories about the climate crisis – for example, about how people are responding in real time and making a difference - are still few and far between.

That needs to change.

THE ROLE OF EMOTIONS

Traditionally, emotions have been seen as separate from rational judgment. Sabine Roeser, an ethics researcher, investigates the role of emotions in communicating climate change: "Emotions are generally considered to be irrational states and are hence excluded from communication and political

Emotions, Roeser argues, play a very important role in how people engage with risk. As urgent as it is, the climate crisis does not always garner the same attention as other topics, such as COVID-19 or the economy. Climate change can still feel abstract, personal and even distant.

But that is rapidly changing. Around the world, more people are starting to agree that the climate crisis is not just a distant threat, but one that will affect them personally and directly.

In Canada, concern about the personal impacts of climate change has risen seven percentage points over the past six years. In 2015, 27 per cent of Canadians felt "very concerned" that the climate crisis was going to affect them personally. This past spring, that had risen to 34 per cent.

This growing concern over the personal impacts of climate change represents an excellent opportunity for journalists, policy makers and environmental advocates to localize and personalize climate communication to engage people more effectively through the power of storytelling.

As important as it is to communicate information about the impacts of climate change, it is also important to include stories that people can relate to and draw inspiration from.

IMPROVING SCIENCE COMMUNICATION

Enric Sala spent years as a university professor, doing research on ocean life. He thought that his increasingly alarming reports on the state of the world's oceans would spur policy makers into action. But that did not happen so Sala left academia.

When I was an academic, I thought that science was all we needed," he said in an interview on the podcast Outrage and Optimism. "That if we continued providing the scientific papers, that for some miraculous reason, leaders would read the papers."

Sala finally realized what science communicators already know: that the relationship between

That facts-based approach is necessary. As journalist Chris Hatch observes: "Most people still have a muddled understanding of climate breakdown of its urgency, that it's caused overwhelmingly by fossil fuel burning, and that carbon pollution from oil, gas and coal needs to be phased out entirely."

Fear can also play a productive role, as there is still far too much complacency. Fear can mobilize

But what is consistent is the power storytelling



how much people know about the climate crisis and how they act is not necessarily linear.

"I thought that having enough information, leaders would be able to make rational decisions," Sala said. But he quickly realized that "the world doesn't work like this and most decisions are made in an irrational way."

In their book Thinking Fast and Slow, psychologists Daniel Kahneman and Amos Tversky famously describe the interplay between the "System One" brain — the intuitive, emotive, non-analytic response mechanism in our brains — and the "System Two" brain — the analytic mechanism.

As journalist Dan Gardner succinctly puts it, the challenge for science communicators is to "help System 1 feel what System 2 calculates" — to make climate change feel personal, relatable and local.

ECOLOGICAL CRISIS STORIES

Most communication about the climate crisis builds on communicating facts and figures at people on the consequences and impacts of a warming planet.

What is missing are stories about ordinary people who are grappling with the crisis in deeply personal ways and doing something about it. Examples include stories of Indigenous communities fighting to protect environments from irreparable harm and students rallying for climate action.

These can be very mobilizing narratives about solutions to the climate crisis. They do not gloss over the fact that the world is in grave peril, or focus on technological quick fixes or hero worship. These stories both communicate facts and underscore the crisis the world faces.

EFFECTIVE COMMUNICATION

Climate scientists — passionate about the work they do — are reacting with sadness and disbelief to the speed with which glaciers are receding in the Canadian Rockies. Coral researchers are emotionally worn out by witnessing drastic coral bleaching. And firefighters are reaching breaking points.

Stories can connect us to ecological crisis on a deeply personal level. Luckily, those personal and emotional connections are being made with increasing frequency in the news media, in documentary films and even on social media.

"I am an Incident Commander with the #BC-Wildfire Service," Kyle Young of the B.C. Wildfire Service tweeted during this past wildfire season. "I am writing this post rather than sharing a video message because, frankly, it would be too emotional for me."

Kyle described the physical and emotional toll the ever-intensifying wildfires in British Columbia had taken on him and his colleagues.

These stories of sacrifice and courage are among the many relatable and personalized narratives that can connect us to the climate crisis. Climate scientist Michael Mann observes that it took elementary and high school students protesting in the streets for the adults to finally take note of the urgency of the crisis.

It is no longer an abstraction. It is is affecting people directly, and stories are one of the best ways to capture and communicate that urgency.

How 'deliberate listening' builds bonds between managers and workers

The digital transformation of the **■** workplace has created greater opportunities for new forms of work arrangements - remote, hybrid, dis-

While in-person meetings create opportunities for conversation, employees in online meetings tend to drop off immediately at the end of the meeting and return to their work in a split-second.

Physically, we may no longer work in the same office, have hallway conversations or grab a quick lunch or coffee together. The spontaneous conversations that occur in a shared physical environment requires deliberate attention with remote work.

Even before the pandemic, research has shown that remote workers feel left out and are less engaged with their work.

They worry that colleagues talk behind their backs, or that their work is considered a lower priority in the eyes of their supervisors. It's more difficult to interpret body gestures and facial expressions through a computer screen; the lack of informal yet physical nods of approval in the traditional setting can also let our negativity take over and paranoia hinder productivity.

These experiences have an impact on employees' sense of a shared reality — the perceived commonalities with other people when it comes to

the world. As researchers on listenfor managers to build this shared reality through what we call deliberate listening.

Here are three practices to deliberate listening:

LISTEN TO BRIDGE BOUNDARIES The idea of shared reality arises from our fundamental need to bond with other people and to understand the world around us. We communicate in order to share our realities, which also form the basis of our thoughts.

Listening builds bridges between different experiences and perspectives. Co-workers and employees may hesitate to share their struggles at home or their conflict with colleagues if not asked. They often only talk about these experiences via deliberate listening.

Managers can engage in deliberate listening to acknowledge differences, reduce defensiveness and to bridge the gaps between "us and them." Employees can express themselves more fully, expand their thinking and correct faulty generaliza-

Questions aimed at listening such as a simple as "How are things at home?" or "What's on your mind?" - can bridge these gaps and the invisible barriers created by distance. LISTEN TO AFFIRM

Sharing our inner thoughts strengthens our social connections.

feelings, beliefs and concerns about People tend to feel more connected if they have the same interpretaing, we provide some perspectives tion of events. American psychologist and researcher E. Tory Higgins introduced the idea that "sharing is believing" — people not only tweak what they say to fit with their communication partner's attitude, they also subsequently remember the ob-

servations they share. In order to listen well, managers can use external tools, like taking notes, to help them. Larry Bossidy, the former CEO of Honeywell, used the technique of dividing a sheet of paper and scribbling notes of what he heard on one side and his thoughts about the matter on the other.

Listeners can also intentionally adjust tones and descriptions to align with the attitude of their conversation partner. Sentences like "I feel the same way" and gestures such as nods build a twoway communication relationship in which interaction partners build on common beliefs and feel closer to each other.

Successful listening results in people feeling they clicked and fuels a desire to maintain this close relationship. That feeling can extend to other colleagues and thereby create a sense of cohesion at work.

LISTEN TO CHALLENGE

When others disclose negative emotions, mere listening as support offers minimal help, and can actually perpetuate the frustrating situation.

If the listener validates the nega-

tivity, the speaker can brood by immersing in the negativity and replaying the adverse reaction. The magic recipe for constructive listening is attentiveness plus some enlighten-

Responses that gently challenge the validity of the aggrieved person's feelings or their appraisal of a perceived problem are most effective for mitigating negativity. Such an approach can motivate people to reevaluate their initial reaction to the problem and reposition themselves, cognitively and emotionally.

LISTENING BUILDS SHARED RE-

Listening to others is often undervalued as only passive acceptance. But effective listening as people disclose details of both their professional and personal lives, including hardships and emotions that affect the workplace, takes dedication and

Listening is not passive. It creates a shared reality — one that is crucial for understanding, collaboration and

By bridging, affirming and challenging, listeners can build a shared sense of belonging and understanding that shape the realities of our work and world around us. That's regardless of whether we work in a physical office or online.

Mamata Banerjee secures Chief Minister's post with easy win in by-poll

KOLKATA, 03 OCT [NDTV]: Mamata Banerjee won a resounding victory in the bypoll from Kolkata today, which was crucial for her to continue as the Chief Minister following the defeat at Nandigram. She won with a record margin of 58,832 votes

over her BJP rival. The Chief Minister polled 84,709 votes at the Bhabanipur constituency in south Kolkata -the seat from where she won in 2011 and 2016 as well -- breaking her own record of 54,213 votes of 2011. The seat was vacated for her by state minister Sovandeb Chattopadhyay, who won the April vote by a margin of 28,000-plus votes.

The Chief Minister hailed the results by flashing three fingers to mark the Trinamool's victory, not just at Bhabanipur but at the Shamsherganj and Jangipur Assembly elections as well. The polls there had been countermanded in April due to the death of a candidate in each of those seats.

victory sign with two fingers. I am holding up three fingers. We fought three elections, we have



won all three today. I am not so selfish," Ms Banerjee said. "Ek, dui, teen, Ma Mati Manush kay dhonnobad din (One, two, three - let's thank the people)," she added.

"We are grateful we won... I lost in Nandigram but the matter is in court," she said. "What is most heart-warming is, I have not lost in a single ward in the constituency. In 2016, I had trailed in a couple of wards. Today, I have won in all," she added

Priyanka Tibrewal – a "I am not doing a lawyer and a long-time resident of the constituency - whom the BJP fielded against Ms Banerjee, polled 24,396 votes. The 41-year-old, who lost from Entally assembly seat in April and in a 2015 civic poll, she has become a familiar name as one of the petitioners in the post-poll violence case against the state

"As in every match, one loses, one wins. But not necessary that the man of the match is from the winning team. I am the man of the match," Ms Tibrewal said after the results were declared. "A little ant tries to climb through a door but falls a hundred times before it can make it. One shouldn't

lose faith," she added. BJP state chief Sukanata Majumdar said,

"I congratulate the chief minister. The BJP always accepts the people's verdict. But there is a question mark on how many people voted. Only 57 per cent. The rest didn't either because they didn't want to or could not. She said BJP would be erased

from Bhabanipur. We are

grateful for the support

we got." Mamata Banerjee, who lost the elections at Nandigram in the April-May polls, needed to be elected MLA before the end of six months to continue as the Chief Minister. She had chosen Nandigram -- where her agitation against land acquisition had catapulted

her to power a decade ago -- as a challenge to aide-turned-foe Suvendu Adhikari of the BJP.

The challenge is viewed as a tonic for her party that was edgy ever since BJP won 18 seats in the Lok Sabha elections in 2019. Her defeat in Nandigram was the one blot on Trinamool Congress's stupendous victory for a third term in face of the BJP's powerful election machine.

In the other two assembly seats where results came out today, Trinamool candidate Amirul Islam led by over 10,000 votes at Shamsherganj Jangipur's Trinamool candidate Jakir Hossain by 52,528 votes.

All eyes on Goa polls next year with entry of Trinamool, 2 new regional parties



PANAJI, 03 OCT [PTI]: The entry of Trinamool Congress (TMC) in Goa's political arena and the announcement by two regional outfits about fighting the next year's Assembly elections in Goa are sure to make it a multi-party and keenly-watched affair, where prominent players like the ruling BJP, opposition Congress, Arvind Kejriwal-led AAP and Shiv Sena are eyeing to fight the polls independently.

The two regional outfits that will be trying their luck for the first time are Revolutionary Goans and Goencho

Besides them, the Goa Forward Party (GFP) and the Maharashtrawadi Gomantak Party (MGP) are also there in the power game.

The BJP, which has been in power in the state since 2012 and is vying to continue to be at the helm for the third consecutive term, feels that the more number of parties there are in the fray, the better for it as it will cause division of opposition's votes.

The TMC, which is currently in power in West Bengal, recently said that it plans to contest all 40 seats in Goa.

Former Congress MLA Luizinho Faleiro joined the TMC a few days back. MGP's former legislator Lavu Mamlakar also joined the Mamata Banerjee-led party. But after that, no other influential local leader has done so.

The Aam Aadmi Party (AAP), which rules in Delhi, has also thrown its hat in the ring this time again. It had contested the 2017 Goa Assembly polls, but failed to open its account.

The opposition Congress, which has been vying to return to power, seems to be averse to start talks on alliance with like-minded parties.

"It's not my mandate. It is for the high command to decide," Goa Pradesh Congress Committee chief Girish Chodankar told reporters recently when asked about the alliance.

er, surprising the Congress, the saffron party allied with regional parties and formed government under the leadership of senior leader Manohar Parrikar. The party currently has only four MLAs.

The GFP, which had initiated the talks of joining hands with the Congress, has also announced that the proposal was on hold.

The Nationalist Congress Party (NCP) also has its presence in the state with its lone MLA Churchill Alemao.

A few days back, Shiv Sena leader Sanjay Raut said his party would contest 22 to 25 seats in Goa, where elections due in February next year. The party had fought the 2017 election in alliance with other political outfits, like the MGP, but failed to win any seat.

Some leaders feel that it was necessary for the opposition parties to come together in order to defeat the ruling BJP.

"Stitching a coalition of opposition parties is the way ahead to defeat BJP in the state. All the parties announcing to fight 40 seats individually will result in giving edge to BJP," Independent MLA Rohan Khaunte said.

The BJP, however, seems to be meticulously preparing itself for the big

The party has already announced that its campaign would be led by Chief Minister Pramod Sawant. It has been working in all the 40 assembly constituencies.

Former Maharashtra chief minister Devendra Fadnavis has been made the party's election in-charge and he has held a number of meetings during his recent visit to the state.

Although the party is grappling with infighting, the intervention of leaders like Fadnavis seems to be helping it tide over the crisis.

Odisha logs 528 new COVID-19 cases, 5 more deaths

BHUBANESWAR, OCT 3 (PTI): At least 528 more people, including 73 children, tested positive for COVID-19 in Odisha, taking the tally to 10,27,959, while Boudh became the coronavirus-free district in the state with no active case, an official said on Sunday.

The daily infection rate among people below 18 years of age was at 13.82, up from 11.92 per cent on Saturday, he said.

Khurda district, which comprises the Bhucapital baneswar, recorded the highest number of fresh cases at 243, followed by Cuttack at 69.

Nine districts - Bolangir, Boudh, Dhenkanal, Gajapati, Kandhamal, Keonjhar, Kalahandi, Nuapada and Rayagada- did not report any new case in the last 24 hours.

"Boudh became the state's first COVID-free district as there was no active case for the last two days. It has so far reported 12,594 infections of which 12,482 patients have recuperated and 112 succumbed to the disease," the official said.

Five fresh fatalities - two from Khurda and one each from Cuttack, Ganjam and Jaipurraised the coronavirus death toll in the state to 8,214, he said.

Fifty-three other CO-VID-19 patients have so far died due to comorbidities.

Odisha now has 5,280 active cases, while 579 more people were cured of the disease in the last 24 hours, taking the total number of recoveries to 10,14,412, the official

The state has so far conducted over 2.01 crore sample tests, including 69,030 on Saturday, and the positivity rate now stands at 5.09 per cent.

Over 87 lakh people have received both doses of COVID vaccines, he

Traffic at Jammu Airport jumps after scrapping of load penalty



JAMMU, 03 OCT [PTI]: Passenger traffic at the Jammu airport jumped soon after the load penalty for the strategically important airport was scrapped, allowing airlines to fly full capacity, officials said.

The airport saw embarkations 1,403 (departures) and 1,679 disembarkation (arrivals) on September 29. On September 30, when the penalty was scrapped, the number of departures jumped to 1,524 and disembarkations to 2,140, officials aware of the matter said.

On October 1, traffic further increased to 1,953 embarkations and 2,748 disembarkations, they said.

Currently, Jammu airport handles 35 flights from different cities on a daily basis.



New Delhi, 03 Oct air pistol team event [PTI]: Manu Bhaker shone bright as India claimed four gold medals out of the six on offer, along with two silvers, to surge to the top of the medal standings at the ISSF Junior World Championship on Sunday.

India swept the 10m air pistol medal events, including the mixed, women's and men's team competitions as well the 10m air rifle men's team gold, to end the day with six gold, six silver and two bronze medals. Luis Suárez strikes as Atlético Madrid push Koeman closer to Barcelona exit

MADRID, 03 OCT [THEGUARD-**IAN]**: It had to be him. The man who was forced out of Barcelona and immediately brought the league title to Atlético Madrid may also have brought Ronald Koeman's brief and ultimately bitter time at the Camp Nou to a close that has long been coming.

On the night when the Metropolitano filled for the first time since he arrived, becoming the fans' idol even in their absence, Luis Suárez provided an assist and a goal to beat Barcelona 2-0 and pushed the Dutchman even closer to a door already held open for him, the roles reversed a year on.

Suárez remains angry at how he was treated by his former manager at Barcelona -"like a 15-year-old" as he put it this week. Instead, he is 34 but the fire still burns and the finishing is still deadly - for Koeman especially. Barcelona's president, Joan Laporta, claimed on the morning of this match that the result would not change anything, which was true in that the manager was already finished and this can only have made his inevitable demise more imminent, providing an end – if that is what it proves – that could have been scripted and was soon signed.

When Suárez followed up Thomas Lemar's opening goal with the second, the Uruguayan lifted his fingers to his ear, emulating a phone call. It still hurts him - and drives him that Koeman had sent him to train alone and then dumped

him by phone. That conversation lasted barely 30 seconds; its consequences have lasted significantly longer. This was revenge of sorts, even if he refused to say so. And it was not the only call of a noisy night.

Suspended following a red card at Cádiz, Koeman was not on the bench for this but that did not make it easier to take. At one point in the first half cameras caught him shouting angrily, desperately down the phone, like a man whose taxi should have been here ages ago. Through the glass and out on the pitch below him, his team were already a goal down and did not wear the look of a side ready to rebel, so quick to

for Barcelona but not much presence, just a familiar fragility. Chelsea seize top spot after dramatic win over Southampton

LONDON, 03 OCT [AFP]: Timo Werner fired Chelsea to the top of the Premier League as the German's late goal inspired a controversy-filled 3-1 win against 10-man Southampton on Saturday. Thomas Tuchel's side ended a frustrating week on a high note thanks to Werner's contribution to a dramatic finale at Stamford Bridge.

After successive 1-0 defeats against Manchester City and Juventus, the Blues were in danger of another disappointing result with just minutes remaining in rain-soaked west London. Trevoh Chalobah's early opener for Chelsea had been cancelled out by a James Ward-Prowse penalty in the second half.

Ward-Prowse But was sent off for an ugly lunge on Jorginho and Chelsea took full advantage as Werner restored their lead with six minutes left before Ben Chilwell wrapped up the points.

Chelsea sit two points clear of second-placed Liverpool, with Jurgen Klopp's side able to regain pole position if they beat champions Manchester City on Sunday.

Failure to defeat a Southampton side still seeking their first league win this season would have raised serious questions about the European champions.

So it was a huge relief for Tuchel to get back on track heading into the international break as Chelsea put one of their rare blips of the German's reign behind them.



"After two defeats we had to be careful that we didn't start being too sad or too worried." Tuchel said.

"It was important to have a better performance than the last two games, that we sharpened our mindset so that we are not afraid to lose.

"It was nice to play the way we did and get a deserved win."

Frustrated by what he labelled a "strange display" against Juventus on Wednesday and an equally lacklustre loss to City last weekend, Tuchel made five changes in a bid to shake up his "tired" team.

For a man who has hardly put a foot wrong since taking charge in January, Tuchel showed he had not lost his Midas touch as three of the players he brought into the team combined for the ninth-minute opener.

Ruben Loftus-Cheek towered above the Southampton defence to flick Chilwell's corner to the

far post, where Chalobah dived to head home from close range.

Werner thought he had doubled Chelsea's lead just before halftime when he rose above two defenders to head in from Callum Hudson-Odoi's cross.

But, with both teams back in position to kick off, a late VAR intervention convinced referee Martin Atkinson to rule that Cesar Azpilicueta had clipped Kyle Walker-Peters' heel much earlier in the build-up to the goal. It was a debatable decision and Tuchel was incandescent with rage, waving his arms in protest as he briefly marched into the pitch -- an incursion that earned a booking as boos cascaded down from the

stands. "I was very angry because I could never believe this could happen in the Premier League. It was a 50-50 that wasn't even in close connection to the goal," Tuchel said.

"I understood before

the season that we didn't want soft fouls, that we wanted a contact game."

Shaken by that controversial moment, Chelsea lost their grip and Southampton equalised

in the 61st minute. Teenage right-back Tino Livramento, who left Chelsea in the closeseason, made an incisive raid that forced a panicked foul from Chilwell

in the penalty area. Atkinson pointed to the spot and Ward-Prowse stepped up to send Edouard Mendy the wrong way with the penalty. But Ward-Prowse could have no complaints when Atkinson sent him off for nasty foul that left Jorginho writhing in pain

with 14 minutes left. That proved the turning point and Chelsea went in front in the 84th minute.

Ross Barkley sprayed a fine pass out to Azpilicueta and his half-volleyed cross was perfect for Werner to drill home from close-range.

Outcry in Brazil over photos of people scavenging through animal carcasses

RIO DE JANEIRO, 03 OCT [THE-**GUARDIAN**]: Heart-wrenching photographs of destitute Brazilians scavenging through a heap of animal carcasses for food have laid bare the hunger crisis blighting Latin America's most populous nation, where millions have been plunged into deprivation by the coronavirus pandemic and soaring inflation.

The images, taken in Rio last week by the prize-winning photojournalist Domingos Peixoto, show the group rummaging for scraps in the back of a lorry that had been transporting the discarded offal and bones to a factory that makes pet food and soap.

"Some days ... I want to cry," the lorry's driver, José Divino Santos, told the reporter Rafael Nascimento de Souza, who was covering the story with Peixoto for the Rio newspaper Extra.

"Before people would come and ask for a piece of bone for their dogs. These days they beg for bones to make food," added Santos, who distributes the scraps to Rio's needy after collecting them from super-

One 51-year-old scavenger, Denise da Silva, said she need-



ed to feed her five children and 12 grandchildren having recently lost her partner. "It's been so long since I saw a bit of meat, since before the pandemic ... I'm so grateful for this," Silva said of the fragments.

The images, one of which appeared on Extra's front page under the headline "Brazil 2021: the pain of hunger", sparked an immediate outcry.

An estimated 19 million Brazilians have gone hungry since the start of a Covid outbreak that has killed 600,000 people. Elsewhere in the region the suffering is even more intense. Last week, a top Venezuelan university said nearly

77% of citizens there lived in extreme poverty, with crippling fuel shortages and Covid to blame for a 10% jump over the last year.

Thousands of protesters marched through the streets of Rio on Saturday to denounce a social calamity many blame on Brazil's rightwing president,

Jair Bolsonaro, whose Covid response has been globally condemned.

"It's inhumane," said Alex Frechette, a 43-year-old artist, who was carrying one of his paintings showing Bolsonaro chuckling beside three black children who clutched bowls filled with bones.

Canary Islands volcano 'much more aggressive' as new fissures erupt

La Palma, 03 Oct [AP]: The erupting volcano on Spain's Canary Islands has blown open two more fissures, with authorities reporting "intense" activity in the area.

The new fissures, about 15 metres (50 feet) apart, sent streaks of fiery red and orange molten rock down toward the sea, parallel to an earlier flow that reached the Atlantic Ocean earlier this week.

The Cumbre Vieja volcano was "much more aggressive", almost two weeks after it erupted on the island of La Palma, said Miguel Ángel Morcuende, the technical director of the Canary Islands' emergency volcano response department.

Overnight, tists recorded eight new earthquakes up to magnitude 3.5.

The eruption was sending gas and ash up to 6,000 metres into the air, officials said.

The prompt evacuation of more than 6,000 people since the 19 September eruption helped

prevent casualties.

A new area of solidified lava where the molten rock is flowing into the sea extends over more than 20ha (50

Officials were monitoring air quality along the shoreline. Sulphur dioxide levels in the area rose but did not represent a health threat, La Palma's government said.

However, it advised local residents to stay indoors. It also recommended that people on the island wear face masks and eye protection against heavy falls of volcanic ash.

The volcano has so far emitted some 80m cubic metres of molten rock, scientists estimate - more than double the amount in the island's last eruption in 1971.

The lava has so far destroyed or partially destroyed more than 1,000 buildings, including homes and farming infrastructure, and entombed around 709ha on the Spanish archipelago off north-west Africa.

Tunisia police arrest MP and TV host who called president a traitor

Tunis, 03 Oct [Reuters]: Tunisian police have arrested a member of parliament and a television presenter who have been prominent critics of president Kais Saied since his seizure of power in July, their lawyer said.

The lawyer, Samir Ben Omar, said the military judiciary had ordered the arrests, accusing the pair of conspiring against state security and insulting the army after they broadcast a programme on Zaytouna television station.

Aloui Abdellatif an MP for the conservative religious Karama party and Ameur Ayed a presenter on Zaytouna. In the programme, they strongly criticised Saied and called him a traitor.

Neither the police nor army were immediately available for comment.

In July, Saied suspended parliament, lifted the immunity of its members and assumed executive authority before saying last month he would ignore most of the constitution and rule by decree for a period of "exceptional measures" with no set end.

His intervention, following years of economic stagnation and political paralysis, was welcomed by many Tunisians but has cast doubt on Tunisia's democratic gains since the 2011 revolution that ended autocratic rule and triggered the Arab spring.

Saied has said he will not become a dictator and has promised to uphold rights and freedoms. Since July, a small number of parliamentarians have been detained on old charges that were activated when their immunity was lifted.

Many other politicians and business leaders have been subjected to travel bans, though Saied said these would be imposed only on people facing judicial summons or warrants.

Chinese planes fly over Taiwan defence zone in second day of record show of force

TAIWAN, 03 OCT [THE-**GUARDIAN**]: China has for the second day in a row flown more than 30 military planes towards Taiwan in yet another record show of force.

defence Taiwan's ministry said 39 aircraft entered Taiwan's air defence identification zone in two sorties on Saturday, one during the day and one at night. That followed a similar pattern on Friday, when 38 planes flew into the area south of the self-governing island.

Taiwan's premier, Su Tseng-chang, spoke out on Saturday against the first day's flights.

"China has always conducted brutal and barbarian actions to jeopardise regional peace," he said. China has been sending military planes into the area south of Taiwan on a frequent basis for more than a year. The 38 and 39 planes on Friday and Saturday were the most in a single day since Taiwan began releasing reports on the flights, Taiwan's Central News Agency said.

Tens of thousands of women march for abortion rights in US

Tens of thousands of women have marched across cities in the United States to protest increasing restrictions on abortion.

660 demonstrations around the US on Saturday, including on the steps of the Supreme Court in Washington DC, were largely sparked by a Texas law that bans abortions after six weeks of pregnancy.

The measure, which went into effect last month, is the most restrictive in the country.

In Washington, DC, protesters filled the streets surrounding the Supreme Court, shouting: "My body, my choice," and cheering loudly to the beat of drums.

They carried signs that said: "Mind your own uterus", "I love someone who had an abortion" and "Abortion is a personal choice,

shirts reading simply "1973", a reference to the landmark Roe v Wade decision, which made abortion legal for generations of American women.

"No matter where you live, no matter where you are, this moment is dark," Alexis McGill Johnson, president of Planned Parenthood, told the crowd at the Rally for Abortion Justice in Washing-

She spoke of women who have been forced to drive for many hours across state lines - sometimes multiple state lines - to end pregnancies since the Texas law went into effect. "No matter where you are, this fight is at your doorstep right now," McGill Johnson said. "This moment is dark, but

"I don't think that old men, politicians should be making the decision on what I can and can't do with my body," Alejandra Marquez, a protester in Austin, the capital of Texas, told Al Jazeera. "I think every woman should have the right to decide when they want to have kids, and how, and how many."
