First time in 44 days that Sikkim reports no Covid deaths!

The State was allowed a collective sigh of relief today to mark the first time in 44 days that Sikkim reported no Covid deaths. The second wave of Covid-19 has been brutal for Sikkim, the month and a half that it has been among us claiming as many lives as the virus had taken in the entire year till then. The last time that Sikkim saw no Covid deaths was on 24 April, 2021. In the 44 days that have passed since, Sikkim has lost a staggering 136 lives to Novel Coronavirus. In a weird coincidence, Sikkim's Covid death toll until the second wave hit, including a two month period from Feb to April in which only one life was lost, also stood at 136. The number of lives the virus snatched away in a year, the second wave managed to do so in barely 44 days.

For some further clarity, this news-

paper counts 22 April as the start of the second wave in Sikkim as it from that day the Covid deaths became a regular feature [while no deaths were reported on 23 and 24 April, from thereon, Sikkim has received no pause until today]. That was the 137th Covid death in Sikkim, and came after a more than two months of no fatalities due to the virus except one on 06 April. After a steady stream of deaths, Covid mortalities had stopped on 01 Feb,

A day without any deaths after a month and a half of averaging three deaths per day, including a record number of nine fatalities on 13 May, is special no doubt, but it is still too early for Sikkim to celebrate. The second wave is clearly on its way out, but Sikkim is still not out of the woods yet. Sikkim's COVID death toll stands at 273.

That said, yesterday being a Sunday, even the number of new cases were low since no RT-PCR tests were carried out and the number of recoveries also swelled. Against barely 59 new Covid cases picked up from the screening of 706 samples, 312 people made full recoveries and were discharged from home and facility isolation across the State in the 24 hours ending 8AM, 07 June.

Sikkim's figure of recovered cases now stands at 12,608 while its tally of confirmed cases of COVID-19 detected thus far has now reached 17,170.

There are currently 4,051 active cases of coronavirus in the State, of whom 25 are in ICU.

It was a markedly different picture a day earlier when on Sunday, Sikkim reported 340 new cases and five more Covid deaths.

The hike -- the 21st since May 4 -- took fuel prices across the country to historic highs.

Petrol is retailing above the Rs 100 per litre mark in six states and union territories -- Rajasthan, Madhya Pradesh, Maharashtra, Andhra Pradesh, Telangana and Ladakh.

In Delhi, petrol hit an all-time high of Rs 95.31 a litre, while diesel is now priced at Rs 86.22 per litre.

Himalayan Cleanup from home reveals 60% of our plastic waste is multi-layered non-recyclable food packaging

Tith over 350+ participants from across all the states of the Indian Himalayan Region, the reflective and insightful one week of The Himalayan Clean Up (THC) from Home comes to an end.

Organized annually by the Integrated Mountain Initiative and Zero Waste Himalaya, it is a call to all mountain communities, individuals and organisations to reflect, switch and demand for sustainable living as well as to bring to the forefront the Himalayan waste crisis. The usual site clean ups of the THC were made more personal this year by taking it to our individual homes due to the worsening state of the pandemic.

With participants from across the Indian Himalayan Region, this clean up from



our homes revealed that 60% of our plastic waste is multi-layered food packaging

which are non-recyclable. The Himalaya is littered with these problematic plastic wastes with waste management systems and institutions left clueless to address it. This revelation also alludes to nutritional challenges that these hyper processed and taste enhanced food that is being preferred during the lockdown.

The efforts of THC are to bring attention to the burgeoning waste crisis of our mountains specifically that of single use plastic waste. Our mountains are fragile ecosystems overburdened with woes of water, land degradation and the changing climate. The accumulating plastics only add to our growing problems. THCs demand is to bring in systemic changes through awareness and Extended Producer Responsibility especially for products and packaging that have no solution like the 60% multi-layered food packaging plastic waste that the THC 2021 has revealed.

Taking the question of who is responsible for the plastic waste, The Himalayan Cleanup included a Brand audit which was conducted in collaboration with Break Free from Plastics, a global movement envisioning a future free from plastic pollution. The brand audit revealed the top brands that are polluting our mountains and demands that the brands take responsibility for the waste through Extended Producer Responsibility mechanisms of providing support to waste management institutions and ultimately design out these products and packaging.

LEH, JUNE 7 (PTI): Ladakh has recorded 50 fresh COVID-19 cases, taking the overall tally to 19,197, while the active cases in the region dropped to 1,089 after 131 more patients recovered from the deadly disease during the past 24 hours, officials said on Monday.

Of the new cases, 38 persons tested positive in Leh, taking the infection tally in the district to 15,854, while 12 cases were detected in Kargil pushing the district tally

of infections to 3,343, the officials said.

They said the number of cured patients has risen to 17,913 after the recovery of 120 patients in Leh and 11 in Kargil.

THC2021 Conversations as part of The Himalayan Clean Up had active engagement from youth across the mountain states with over 200+ participants. The conversations unpacked food from the perspective of Zero Waste, sustainable menstrual health practice, composting for degradables and the alternatives to switch to a zero waste living. Participants were enthralled to learn their waste profiles, top polluting brands and how to make the switch.

The Way Forward session as a concluding event was held on 6th of June, 2021. It was attended by participants across the Himalaya with a special mention to Martin Luther Christian University, Scavengers Darjeeling, Clean Mokokchung campaign, Little Green World- Ladakh, Clean Chizami Campaign & Northeast Network. It emphasized the need to amplify the demand for EPR of companies. Multi-layered single use food packaging plastic is of utmost concern. THC2021 recommends mountain sensitive waste management policies as well as stop single use plastics and phase out multilayered plastic.

Satyarupa Shekhar from Break Free From Plastics in the concluding session stated that the Oil & Gas industry of currently 450 billion \$ is projected to see a 50% expansion in the next 10 years thereby increasing the production of plastics. THC provides the platform which plays a crucial role in providing data for policy advocacy to push national and global policies. Director, Dr Dipankar Ghose, WWF India raised the issue of pandemic generated plastic waste and the need to flag this burning issue.

PD Rai, President, IMI reiterates that as much as its important for IMI as a platform to engage with the process of systemic change, it is also important to engage here and now. The event ended with Robert Swain's famous quote: 'The greatest threat to our planet is the belief that someone else will save it'. In a Facebook post, Mr Chamling has said that the "state government has no idea about what a lockdown is and how it should be managed." He adds that Sikkim achieved the rare feat of becoming the only red zone in India in the middle of the lock-


Lt Gen MD Venkatesh takes over as SMU Pro-Chancellor

Days before Centre's policy change, Supreme Court's tough remarks

NEW DELHI, 07 JUN In a national address to-[NDTV]: The change in the Centre's Covid vaccination policy, announced today by Prime Minister Narendra Modi, came a week after the government faced some tough questions from the Supreme Court. A three-member bench had on May 31 flagged "various flaws" in the inoculation drive, criticising aspects such as differential pricing, shortage of doses, and a lack of access in rural India.

day. PM Modi announced that his government would take back control of the drive from the states and provide vaccines free of charge to all above 18 from June 21.

He revised the rules of the drive's third phase which came into force a month ago.

On May 31, the Supreme Court bench of Justices DY Chandrachud. LN Rao, and S Ravindra Bhat had observed, "Your rationale was high mortality in the 45+ group (but), in the second wave, this group is not seriously affected...it is 18-44. If the purpose is to procure vaccines, why should the Centre procure only for those aged over 45?"

It also asked why states were required to pay more for the vaccines under the Centre's new "liberalised" policy which allowed states to buy up to 50 per cent of their needs directly from manufacturers, although what the Centre had to

The court asked the Centre to revisit the new policy, calling it "arbitrary" and "irrational". It sought a roadmap of the availability of vaccines till December 31, along with the details of the 2 35,000 crore set aside in the Union budget to buy doses. The bench wanted a comparison of vaccines' prices in India and abroad. It also asked for documents and file notings related to the Centre's new policy.

When the Centre asked the Supreme Court to keep off policy-making, it refused to be a "silent spectator" when executive policies infringed constitutional rights.

"Let me tell you from my experience as a Judge -- the ability to say that you're wrong is not a sign of weakness, but a sign of strength," Justice Chandrachud had said.

The next hearing of the Supreme Court on the matter is on June 30.

ISRO develops 3 types of ventilators, will transfer technology

at prices higher than

BENGALURU, 07 JUN [PTI]: The Indian Space Research Organisation has developed three types of ventilators, and has come forward to transfer the technology to industry for clinical usage as the country battles the second wave of COVID-19 pandemic. A low-cost and portable critical care ventilator, "PRANA" ("Programmable Respiratory Assistance for the Needy Aid") is based on the automated compression of an AMBU (Artificial Manual Breathing unit)

The system has a sophisticated control system that includes airway pressure sensor, flow sensor, oxygen sensor, servo actuator as well as expiration and PEEP (Positive End Expiratory Pressure) control valves, according to an interest exploration note posted on the website of Bengaluru-headquartered space agency.

The clinicians can select the ventilation mode and set the required parameters through a touch screen panel and monitor various parameters like pressure, flow, tidal volume and oxygen concentration on the same screen.

The ventilator can deliver the required flow of oxygen-air mixture to the patient's lung at a desired rate set by the clinicians.

It has a provision to attach external battery for backup during power failure.

ISRO said PRANA supports both invasive and non-invasive ventilation modes and is capable of giving mandatory breaths (controlled by ventilator) as well as spontaneous breaths (controlled by the pa-

A robust algorithm controlled and ventilation of the patient is implemented which raises alarm and opens safety valves to prevent barotrauma, asphyxia and apnoea during the ventilation.

Alarm is also raised in case of wrong or improper connection of the ventilation circuit or inadvertent disconnection of the hose or sensors.

There are also provisions to attach bacterial viral filters at each interface to prevent cross-infection and the

contamination of air. The ICU grade positive pressure mechanical ventilator titled "VaU" (abbreviation of Ventilation assist Unit) can assist or replace the spontaneous breathing in patients under respiratory distress, ISRO

VaU is based on a centrifugal blower which draws in filtered ambient air, compresses it and delivers it to the patient to achieve ventilation and can therefore operate without a compressed pneumatic source.

Provision is also given in the ventilator to connect a high presoxygen source, from which oxygen is metered automatically, to achieve the desired oxygen concentration (FiO2) in the inspiratorv flow.

Microcontroller based control module in the ventilator acquires signals from an array of sensors and commands the electro-pneumatic components to effect closed loop control.

VaU also comes with an intuitive Human Machine Interface (HMI) System running on a medical grade touch screen PC, which allows the operator to set and monitor various ventilation parameters in real

A power supply unit, which can operate with 230VAC or an internal battery pack, is used to power the electro- pneumatic components, controller, and the HMI system of the ventilator.

VaU has been configured to operate in a variety of patient/ventilator triggered invasive and non-invasive ventilation modes and has provisions to detect fault conditions and raise alarms through the HMI system to alert the operator.

Gas-powered ventilator "Space Ventilator Aided System for Trauma Assistance (SVASTA)", a basic mode for noninvasive ventilation, is well-suited for emergency use for first line treatment and as transit ventilators inside vehicles, according to ISRO.

The basic design is simple, and the components can be easily mass produced for emergency use in pandemic like sit-

This ventilator, which runs on compressed air, is able to perform various ventilation conditions using manual mechanical settings.

The system is capable of pressure control ventilation (PCV) in its basic

mode of operation with provision for setting different tidal volumes.

The basic ventilator design can be re-engineered appropriately by the manufacturer to cater to various modes of ventilation with control systems, electronics, and associated software, it was stated.

The prototype of the three ventilators developed at Thiruvananthapuram-based Vikram Sarabhai Space Centre (VSSC), a major space research centre of ISRO has undergone in-house test & evaluation and meets various specifica-

responsibility of obtaining mandatory certification from approving agencies of government of India before clinical usage vests with the industry, the ISRO note said.

ISRO said it intends to transfer the technology of these three ventilators toPSUs/industries/ start-ups having good track record in manufacture of critical medical/ electronic equipment manufacturing.

It invited Interested industries/ entrepreneurs to submit their expression of interest before June 15.

New Delhi, 07 Jun [NDTV]: The Union Health Ministry's Directorate General of Health Services (DGHS) has issued revised guidelines for the management of Covid patients, dropping ivermectin, hydroxychloroquine and favipiravir - three widely-used drugs from its list of approved treatment options. The guidelines, however, differ from those provided by the Health Ministry, which recommends both ivermectin and hydroxychloroquine.

The new guidelines, which were issued on May 27, also do not mention taking steam inhalation and the use of vitamins for Covid treatment, which again contradicts the advisory on the Health Ministry website.

Ivermectin, hydroxychloroquine and favipiravir - used for asymptomatic and mild cases - were removed from DGHS guidelines after experts found they did not help patients infected with the coronavirus, according to officials.

Under the new DGHS guidelines, asymptomatic Covid patients (except those with comorbidities) have been advised against taking any medication.

Those with mild cases may take antipyretic (medication used to prevent, or reduce fevers) and antitussive (to relieve or suppress coughing) for symptomatic relief. Those with cough may inhale 800 mcg of budesonide (via metered-dose inhaler with space device) twice a day for five days.

"No COVID-19-specific medication is required. The patient may have to be investigated further if symptoms persist or deteriorate," the guidelines

said. Remdesivir, an antiviral drug in great demand in India - is to be used only in select cases - specifically for hospitalised Covid patients with moderate or severe symptoms, and who were placed on oxygen support within ten days of the disease onset, the

guidelines add. On the use of tocilizumab - which is also in high demand - the DGHS said it should be used only for severely and critically ill patients.

The new lines also warn against the unnecessary use of high-resolution CT scans.

This morning India recorded 1.06 lakh cases, a drop of 12 per cent from yesterday's 1.14 lakh that was reported to be the lowest in two months. The country's caseload now stands at 2.89 crore.

Water Issues

A knowledge-base drained

N early a decade back, there used to a hugely popular reality show which did not rely on obnoxious individuals to hook audiences and treated Sunday afternoon viewers to lucid explanations by subject experts and inspirational stories of best practices. Hosted by Aamir Khan, Satyamev Jayate used to air on multiple TV channels and today we take off from one of the episodes which introduced the country to the water crisis developing in India. That was in the year 2012 and nine years hence, we are living the prediction despite the monsoon having opened with a vengeance. For those too young to have experienced days when television had something decent in it, the series has a Youtube playlist worth checking out. In the episode in question, one of the experts blamed the situation on the British rule of India and the administration it spawned. Unfortunately, the same administrative mindset prevails pushing the nation on the

A specialist on water issues informs that when the British first landed and settled in India, they couldn't understand how a country that received barely 100 hours of rain on an average per year, could sustain such vibrant civilisations. For someone coming from a country which literally "pisses" [her words] rain all year round, this was definitely a culture shock. Also, the British spread across India from South up and noticed the water reserves of Himalayan glaciers which feed most of India's rivers much later. In the nearly three hundred years that the British spent in India [some years as traders, more than a century as the kingdom-grabbing East India Company and 90 as the Crown], the British tried to set

Unwilling to accept that the 'natives' had a better model for water conservation and sharing, the British administrators dismantled the traditional arrangements and started administering water supply [tourists, for example, would know of the many water tanks, called "kunds", which remain dry now and receive tourists across the dry belt of India]. The state-people collaboration which managed water in India was dismantled and British babus took control of supply. The first casualty was the sense of ownership among the people on their water sources and then was lost the traditional knowledge-base about water harvesting and conservation. This has remained the administrative model ever since and we suffer its consequences to this day in wide swathes of Bihar and UP and every pocket of Sikkim. Babudom, one needs to accept, has made a hash of more things than one.

Climate change and environmental degradation have contributed, but it has essentially been the cultural distancing of people from water sources which has created the water crisis. Images of rural folk walking hours to collect potable water brings to question the intelligence of the people in settling so far away from such a necessity as water. It is obvious that the people were not foolish, it is only that in the last century or so, the water has dried away from them. A water source they nurtured through generations, took less than a century of state control to trickle away from them. What is worrying is that the traditional knowledge base and traditional practices continue to recede further away from public memory.

Take Sikkim's example. Isn't it ironic that this land of plenty should have drought prone regions? Well, maybe having drought prone regions is not ironic, but what is ironic is that such regions are also among the more heavily populated. It is obvious that when people settled there, water not as scarce as it has now become. The moment RMDD or PHE pipe water to homes, the need to conserve the local source is no longer directly felt because the responsibility has shifted. Add to this the control Forest Department insists over forests and the traditional practices of forestry, which always ensure balance and conservation [not only of the forest, but also the catchment area of water sources], is lost as well. Before one realises, even Sikkimese, blessed with getting to live so close to nature end up believing in the myth of perennial water sources. There might not be water riots in Sikkim yet, although the rush at tanker supplies when the taps run dry can get quite aggressive, but if the connection between people and water is not returned to its traditional intimacy soon, the crisis will arrive here as well. The Dhara Vikas programme is a positive move towards this end, but for it to succeed, the bureaucracy will have to limit its role to facilitator and allow whatever can be salvaged from the traditional knowledge base to play the initiator.

COVID-19 recovery: some economies will take longer to rebound – this is bad for everyone

National economies are beginning to return to their pre-pandemic levels. But like the uneven impact of the pandemic itself, the pace of economic recovery is massively divergent across countries.

In 2020, the global economy contracted by 4.3%, with some countries doing considerably worse than others. For example, the UK economy suffered its worst recession in 300 years, shrinking by nearly 10%. The resulting impact on jobs was also unprecedented, and ten times worse than during the 2009 global financial crisis, with 114 million jobs lost globally

More than a year on from the start of the pandemic, global prospects appear to be improving, according to recent reports by the OECD and the World Economic Forum. The data shows that some countries - such as the US, South Korea, Japan and Germany – are on course to recover to pre-pandemic levels of GDP per capita by the end

But others, such as Spain and Iceland, both of whom suffered a huge blow from the collapse in tourism revenues, are expected to operate below pre-pandemic levels until at least mid-2023. Worse still, countries such as South Africa and Argentina are forecast to remain below their 2019 levels until the end of 2024, or well into 2025. **UNEVEN RECOVERY**

Two main factors underpin the speed of a country's economic recovery from the pandemic: the strength of its COVID-19 policy response, and the success of its vaccination programme.

Unsurprisingly, the UK and the US, with the highest projected growth rates among advanced economies - 7.2% and 6.9%, respectively – also top the league tables for size of pandemic response policy packages and share of the population successfully vaccinat-

Leaders across the globe deployed a range of economic policy responses in the fight against the pandemic. Public spending measures included transfers to (low-income) households, grants and tax holidays to businesses, and

ventional interest rate cuts with unconventional measures such as liquidity injections and asset purchases. Many governments also used financial measures including foreign exchange interventions.

Importantly, policy action varied significantly across countries in type, size and scope. The pandemic hit emerging markets harder than advanced economies, unlike in the aftermath of the 2008 global financial crisis. Many poorer countries have found it harder to contain and mitigate the virus because of their limited healthcare capacity, and with less ability to expand public spending, suffered greater losses from the pandemic.

The divergence in recovery can also be linked to the varying success of national vaccination programs – as the OECD put it, "more jabs, more jobs". For example, while Israel has vaccinated about 60% of its population, in many other countries, fewer than one in ten have received any vaccinations. Israel's economy is expected return to pre-pandemic levels by early 2022.

What is worse, many poor countries may see almost no vaccinations until at least the end of 2021. This – and the significant ongoing variation in both infection additional funding for healthcare and death rates – suggests that the **GLOBAL CONSEQUENCES**

This multispeed recovery from the pandemic and the ensuing economic crisis will have repercussions, not just for the countries with slower recoveries but also for the global economy. On the health front, no country will be fully safe from the virus until all are safe. Lobe sufficient to protect individual countries from potential further outbreaks, especially in cases of new variants.

But divergence in the speed and scale of economic recovery also entails substantial risk to individual countries as well as their trading partners. The COVID-19 economic crisis has exposed the fragility of existing international trade structures, where countries are highly dependent on one another. These interdependencies arise from the global value chains production broken into multiple stages and completed in different countries – accounting for 70% of current global trade..

One example of the global economy's reliance on certain countries is the shortage of semiconductors, the microchips used in the profrom mobile phones to home appliances. Lockdowns in the early days of the pandemic affected the

semiconductors. This led to production bottlenecks of electronic goods in many other countries, forcing a serious rethink of the costs versus benefits of global supply chains.

The pandemic and related economic crisis have also had different effects within national boundaries. In many countries, inequality has cal vaccination successes will not widened significantly in multiple ways. Less well-off households have lost out much more than those at the top of the income distribution, and there has also been a much more substantial contraction in contact-based service industries than in other sectors.

> A significant rebalancing will be an important step in a successful transition to a post-COVID world. In terms of international policy coordination, the immediate challenge is how rich and poor countries can work together to increase the vaccine coverage rates in as many countries as possible. The COVAX programme – an international effort led by the WHO to provide vaccines to poor nations – and the problems it currently faces show that while such international coordination is possible, it is fraught with difficulty.

On economic recovery, too, duction of every electronic device national gains are unlikely to be long-lasting if a significant part of the world remains behind.

Why politicians should be wary of publicly pursuing the Wuhan lab-leak investigation

The theory that SARS-CoV-2 originally leaked out of a laboratory in Wuhan, China, is making a comeback - so much so that President Joe Biden

has publicly ordered the US intelligence community to "redouble" its investigations into this hypothesis. Politicians, however, should be wary of publicly advocating the Wuhan lab-leak hypothesis. In doing so, they risk fuelling groundless and dangerous conspiracy theories.

Why might that be? The reason is not that the lab-leak theory is itself baseless and therefore unworthy of being pursued. Indeed, it was the predominant view until an investigation by the World Health Organization in February 2020 concluded that the lab-leak scenario was "extremely unlikely", and that it was far more probable the virus had naturally spread from humans to ani-

Yet its credibility has grown in recent weeks. In light of new evidence regarding the Wuhan Institute of Virology's research on coronaviruses, its inadequate safety practices, and the structure of the virus, many of the same sources that once dismissed the lab-leak theory as mere fantasy now regard it as plausible. Though this evidence is by no means proof, it arguably warrants further investigation.

But even if the lab-leak theory is credible and therefore worth pursuing, that doesn't mean that politicians should publicly pursue it. In doing so, they may accidentally lend credibility to the many COVID-19 conspiracy theories that also revolve

around a laboratory origin. For example, the conspiracy theory that SARS-CoV-2 is a Chinese biological weapon first created and later spread by the Wuhan Institute of Virology.

To be clear, the lab-leak theory pursued by the Biden administration differs from these conspiracy theories in important ways. For one thing, it sees the coronavirus spread as accidental, not deliberate. For another, it doesn't lay the blame exclusively at China's door. After all, the Wuhan Institute's coronavirus research was partly funded by the US National Institutes of Health.

ATTENTIVE READERS IN SHORT SUPPLY

Politicians have a responsibility to consider not just whether what they're saying is credible, but also how their words will be understood. And how their words will be understood depends importantly on how attentive their audience is. The problem is that in the era of social media, attentive readers may be in short supply. A 2016 study notably revealed that nearly 60% of stories shared on Twitter have not been read.

This matters for the lab-leak theory. A headline such as Biden Orders Investigation into Wuhan Lab-Leak Theory does not discriminate between the credible version of that theory and the conspiratorial version. The crucial differences between these two theories are therefore likely to be lost to a reader who - as many do - simply reads a headline and then shares the article.

The risk of conflation is not simply due to the audience's inattentiveness. It also results from how the lab-leak theory has previously been reported. Until recently, it was itself categorised as a conspiracy theory. In early March 2020, for instance, a widely circulated open letter published in The Lancet condemned as "conspiracy theories" all hypotheses suggesting that SARS-CoV-2

doesn't have a natural origin. This meant it was lumped together with the idea that the virus was deliberately created as a biological weapon. In turn, this creates problems when politicians later try to rehabilitate the lableak theory: if one supposed conspiracy theory turned out to be credible, some might wonder whether other related conspiracy theories might be credible too.

The problem with conspiracy theories isn't just that many people believe them. The bigger problem, a recent examination has shown, is that they cultivate an environment of uncertainty and disorientation. In other words, they create a situation where it's hard to tell what is credible and what isn't, which sources are trustworthy and which aren't. That uncertainty alone is enormously consequential.

If, for all I know, SARS-CoV-2 might have been an act of biological warfare by a foreign state, that already shapes what I'm willing to do. For example, I might be unwilling, because of my uncertainty, to use vaccines produced by that state.

The point is that, for COVID conspiracy theories to wreak havoc, they only need to be viewed as live hypotheses - hypotheses that are up for debate. Publicly saying that the Wuhan lab-leak theory is plausible, to a distracted public, in a context rife with closely related disinformation, runs the risk of making this the case. The Biden administration may be right that the Wuhan lableak theory deserves a closer look. But it should be cautious, for the time being, of publicly saying as much.

NITI Aayog report putting Bihar at the bottom rekindles special status demand from JD(U)

NACHIKETA NARAYAN PATNA, JUNE 07 (PTI): The long-standing demand for special status to Bihar has been rekindled by a recent report of NITI Ayog that put the state at the bottom and provided the opposition with fresh ammunition against the NDA which has been in power here

for more than a decade.

The NITI Aavog had last week come out with its latest SDG (sustainable development goal) index placing states like Kerala, Tamil Nadu and Himachal Pradesh at the top while Bihar with 52 points out of a total of 100 was at the bottom, a spot it has been occupying for long.

On cue, JD(U) leader Upendra Kushwaha came out with a couple of tweets tagging Prime Minister Narendra Modi whom he requested to reconsider the demand for special category status, asserting that while the Nitish Kumar government in the state had done all it could to improve the overall economic situation, a real turnaround has eluded Bihar.

JD(U) leaders contend that the state was been adversely affected by the carving out of the resource-rich Jharkhand two decades ago.

Kushwaha, who is the ID(U)s parliamentary board president, is at present seen as a key ally



of the Bihar Chief Minister whom he had parted ways with nearly a decade ago but to whom he has returned, merging his Rashtriya Lok Samata Party, after a series of political somersaults.

Notably, vishesh rajya ka darza (special category status) has been a pet demand of Kumar, who has been vehemently raising the same since coming to power in 2005 and often made it a poll

He had promised to support any government that fulfilled this demand while the Congress-led UPA ruled the Centre. He persisted in seeking special status, belying speculations that he will tone down his demand, on returning to the NDA-fold with an assertive Modi at the helm.

The BJP which has been saddled with similar demands emanating from other states since assuming power at the Centre, has however chosen to remain equivocal.

While the voluble Prime Minister has avoided touching upon the subject, late Finance Minister Arun Jaitley had pinned the blame on the 14th Finance Commission which had allegedly done away with the system of conferring special category status upon weaker states.

Jaitlevs averment had triggered hopes that the record would be straightened by the 15th Finance Commission. However these were dashed when the commissions head N K Singh said it was a demand that could be met only by the National Development Council.

Incidentally, Singh, now with the BJP, had been a strong votary of demand. The Niti Aayog report is not a reflection on Nitish Kumars performance. Rather, it affirms our stand that Bihar has been wronged and must get its due.

Bihars score of 52 in the SDG rankings against a national average of 66 and Keralas impressive 75, was an eyesore as even Jharkhand which was cared out of it has a higher ranking and score. However, the narrative woven by the JD(U) is that lack of resource allocations has made it even more difficult for Bihar to break out of the poverty trap it is in.

PORT BLAIR, JUN 7 (PTI): The COVID-19 caseload in Andaman and Nicobar Islands rose to 7,119 as 14 more people tested positive for the disease in the Union Territory, a health department official said on Monday.

Of the new patients, two have travel history and others were detected during contact tracing, he said.

The death toll remained at 122 as no new fatality due to the infection was reported in the last 24 hours.

At least 18 people were cured of the disease during the period, taking the total number of recoveries in the archipelago to 6,894.

The Union Territory now has 103 active cases.

The local administration has been strict to contain the spread of the disease and has adopted an approach of tracking, testing and treating, he said, adding that people arriving here from the mainland are mandatorily required to undergo COVID test.

Information, publicity and tourism secretary SK Singh urged people to cooperate with the ad-

ministration to combat the spread of the virus. He appealed to them to maintain discipline by strictly adhering to COVID appropriate behaviour.

"I don't want any ministerial berth for the next 20 years. Can Jay Shah (Home Minister Amit Shah's son, who was ap-



pointed BCCI Secretary in 2019) say the same about his BCCI post?" he asked.

Abhishek Banerjee - who is Chief Minister Mamata Banerjee's nephew - was named the Trinamool's General Secretary yesterday, in a move widely seen as reward for having played a key role in planning the party's emphatic win over the BJP in the April-May Assembly election.

Sasu wins US Women's Open

SAN FRANCISCO, JUN 7 (AP): Yuka Saso birdied the third playoff hole to beat Nasa Hataoka and become the second teenager to win the U.S. Women's Open after Lexi Thompson collapsed down the stretch.

Saso overcame backto-back double bogeys early in the round to make the playoff. She then won it with a 10foot putt on the ninth hole to become the first player from the Philippines to win a golf major on Sunday.

Saso matched 2008 winner Inbee Park as the youngest U.S. Women's Open champion at 19 years, 11 months, 17

Both players made pars at Nos. 9 and 18 in the two-hole aggregate playoff, sending the tournament to sudden death back at the ninth hole. That set the stage for Saso to win it just up the road from Daly City, dubbed the Pinoy Capital of the United States for its large population of Filipinos.

Thompson, who had a five-stroke lead after the eighth hole, played the final seven holes in 5 over for a 75 that left her a stroke back. Her approach shot on the par-4 18th ended up in the bunker and then she missed a 10-foot putt to make the playoff.

The only other players to finish under par on the Lake Course at Olympic Club were Megan Khang and Shanshan Feng, who both were at 2

High school junior Megha Ganne played in the final group but shot 77 and finished 3 over as the low amateur for the

tournament. Saso overcame a rough start to the final round with double bogeys on the second and third holes that seemed to knock her out of contention but she managed to steady herself with a

birdie at No. 7. Saso then made back-to-back birdies on the par-5 16th and 17th holes to get to 4 under and join Hataoka in the playoff. Hataoka used a run of three birdies in a four-hole span on the back nine that put pressure on Thompson.

Pulisic scores in extra time, US beats Mexico 3-2

DENVER (AP): Christian Pulisic lifted a trophy for the second time in eight days, this time his first for the United States.

Ethan Horvath, back in Colorado for the first time in three or four years, expected to watch the game from the bench and found himself saving Andrés Guardado's penalty kick — in the 124th minute!

The first CONCACAF Nations League final turned on an injury and not one or two but three video reviews.

"This is the perfect way to end the year," Pulisic said after his penalty kick in the 114th minute led the United States over Mexico 3-2 Sunday night in frantic finale of the first CONCACAF Nations League.

Or as U.S. coach Gregg Berhalter put it: "One of the classic, odd U.S.-Mexico games."

A testy match that was stopped for about three minutes in second-half stoppage time because of discriminatory fan chants at Empower Field also was marred by American attacker Gio Reyna getting hit on the face by a thrown object following Pulisic's goal.

"Total lack of respect for what's happening on the field and all effort that both teams are putting into the game," Berhalter said. "I think he's going to be OK, but he did take something to the head, and it could have been a lot worse."

earlier played his first international match since March 2019, entered in the 69th minute, seven minutes after starting U.S. goalkeeper Zack Steffen fell to the ground, clutching his left knee, after coming off his line in what seemed to be a routine manner to grab a through pass from Héctor Herrera that was too far for Uriel Antuna.

"If you're on the bench as a keeper, you don't expect to come in the game," said the 25-year-old Horvath, who had about 20 family and friends at the match.

Iesús Corona put 11th-ranked Mexico ahead 63 seconds in after a sloppy giveaway by defender Mark McKenzie, whose poor pass into Corona's path in the U.S. penalty area allowed the Mexican to break in alone on Steffen.

Pitti did not initially signal a penalty but consulted a video review and then pointed to the spot. Mexico coach Tata Martino appeared received red card, apparently for putting a hand on an official during the review, and Hirving Lozano was given a yellow card for arguing after the decision.

Pulisic sent the ball to the upper corner past the left arm of goalkeeper Guillermo Ochoa for his 16th international goal.

Pair of Jerusalem activists freed after detention by Israel

JERUSALEM, JUN 7 (AP): Israeli police on Sunday detained two members of a prominent family in the contested Sheikh Jarrah neighbourhood of Jerusalem who led protests against attempts by Jewish settlers to evict dozens of Palestinian families from their homes in the area. The twin brother and sister were released later in the day. The arrests of Muna and Muhammad al-Kurd, 23, came a day after police detained a well-known Al Jazeera reporter covering a demonstration in the neighborhood. The reporter, Givara Budeiri, was held for four hours before she was released and sent to a hospital to treat a broken hand. It was not clear how her hand was broken, but her boss blamed police mistreatment.

Earlier this year, heavy-handed police actions in Sheikh Jarrah and other parts of east Jerusalem fueled weeks of unrest that helped spark an 11-day war between Israel and Hamas militants in the Gaza

Those tensions are simmering again and could flare anew if Israeli ultranationalists follow through on plans to march Thursday through the Muslim Quarter of Jerusalem's Old City. Israeli police were expected to hold consultations on whether the parade, which was originally set to take place when the war erupted on May 10, would be allowed to proceed.

Renewed violence could complicate the task of embattled Prime Minister Benjamin Netanyahu's political opponents, who formed a fragile and disparate coalition last week, of passing a parliamentary vote of confidence required to replace him and take office. A close ally of Netanyahu oversees the police.

In Sheikh Jarrah, Jewish settlers have been waging a decades-long campaign to evict the families from densely populated Palestinian

The Israel Police will allow the freedom of press coverage, provided that these are done in accordance (with) the law while maintaining public order," according to a statement. The statement did not reference her broken hand.

Budeiri was held for four hours before she was released and sent to the hospital, said Walid Omary, the Jerusalem bureau chief for Al Jazeera. In addition to the broken hand, Omary said Budeiri also suffered bruises on her body. He said her cameraman's video camera was also heavily damaged by police.

As part of her release, Budeiri is banned from returning to the neighbourhood for 15 days, Omary said.

On Sunday morning, a couple in Istanbul were absorbed while watching Peker's latest release. They were among millions in Turkey who tuned in.

"I've added (Peker's videos) to the category of TV series I watch every week," Gulistan Atas said. "Just like a TV episode, I wait in excitement, and every week on Sunday, we prepare our breakfast when we get up and watch them along with our breakfast."

Clad in a waistcoat

geted former Interior Minister Mehmet Agar and his son, Tolga, a ruling party lawmaker, whom he accused of raping a young Kazakh journalism student and later covering up her murder as a suicide. Mehmet Agar, Peker suggested, misappropriated a luxury marina that may have been used in drug trafficking operations. Agar later resigned from the marina's board.

Subsequent eos leveled accusations against business people and media figures close to the government, as well as former Prime Minister Binali Yildirim's son, claiming he was involved in drug smuggling from Venezuela. But the target of Peker's most vitriolic and mocking attacks is Interior Minister Suleyman Soylu, whom he accuses of abuse of power and corruption while aiming to become Turkey's president. Peker justifies the tell-all by saying Soylu betrayed him despite the crime leader's help to defeat a rival faction within the ruling party.

All those implicated have rejected Peker's accusations.

In an explosive claim with international dimensions, the mob boss said that a former security advisor to Erdogan accused of leading a paramilitary force had sent weapons to Al-Qaida-linked militants in Syria. Erdogan hasn't yet addressed those claims although the government has in the past denied allegations that it had armed jihadis.

Erdogan ignored the Peker videos for weeks, but broke his silence on May 26, when he dismissed earlier allegations by the mafia leader as a conspiracy against Turkey.

"We will spoil these games, these plots. No one should doubt that we will disrupt this devious operation," Erdogan said. "We pursue members of criminal gangs wherever in the world they flee to ... We will not leave these criminals alone until we bring them back to our country and hand them over to the judiciary."

Peker responded to Erdogan that week and suggested that the Turkish strongman could be the focus of future videos. He later said he would speak about Erdogan after his meeting with U.S. President Joe Biden on June 14 so as not to "weaken his hand." In his latest video Sunday, he said his revelations would be conducted with respect and wouldn't hurt the state itself.

"Will finding and bringing me (to Turkey) change the reality," he

Opposition parties, meanwhile, have seized on the allegations to demand the resignations of implicated figures as well as parliamentary and judiciary inquiries.

The ruling party and its nationalist allies have blocked opposition bids to launch parliamentary inquiries into Peker's claims as well as into the arms smuggling allegations.

Authorities have issued a new warrant for Peker's arrest.

Can Selcuki, the director of polling and analysis platform Turkiye Raporu, said of Peker: "We shouldn't forget that he's a criminal," but explained the videos' popularity as a need for information.

Bulgaria's leader makes new push to fight endemic corruption

SOFIA, BULGARIA (AP): Bulgaria's interim prime minister on Monday urged the government to redouble its efforts to fight endemic graft, calling for changes in prosecutors' offices, the judiciary and all law enforcement agen-

Prime Minister Stefan Yanev spoke at a meeting of the government security council that he convened to discuss new anti-corruption policies following U.S. sanctions on Bulgarian officials and businessmen for their allegedly "extensive" roles in corruption.

Last week, the U.S. Department of the Treasury announced sanctions under the Global Magnitsky Act against the former member of parliament state-owned and media mogul De-

Vassil Bozhkov; and former national security official Ilko Zhelyazkov for their alleged roles in public corrupalso imposed

lyan Peevski; oligarch

sanctions on 64 entities allegedly linked to them, saying the move was its single biggest action targeting corruption to date.

The sanctions on the Bulgarians and companies effectively prevents them from accessing the U.S. financial system, freezes their U.S. assets and bars Americans from dealing with them.

Yanev said the Bulgarian government will try to minimize the political and the economic risks for the country from the U.S. sanctions.

"We must protect companies from financial sanctions being imposed. To this end, we must prevent bank transactions with these investigated persons, so that businesses and state-owned companies are not blocked," Yanev said.

He admitted, however, that the U.S. sanctions are a serious signal that corruption in Bulgaria has deep roots in the country's political and economic system and the consequences of that already go beyond the country's borders.

Bulgaria, a member of the European Union and NATO, has repeatedly been reprimanded by its Western partners for failing to effectively fight corruption. Transparency International, a corruption watchdog, has declared Bulgaria the most corrupt country in the

27-nation EU.

Yanev said the corrupt environment in Bulgaria not only destroys the country's international authority, it undermines its political system and the foundations of its democracy, making it dysfunctional and inefficient.

"There is no way we can have a stable political system, a prosperous economy, or a functioning social system without solving the fundamental problems with corruption,"

The interim government, appointed after an inconclusive general election in April, has made a series of revelations of alleged corruption involving the previous government under former Prime Minister Boyko Borissov.



Logan Paul Reacts to Those Memes About His Boxing Match With Floyd Mayweather

ogan Paul clearly heard the jokes people Lawere making about his boxing match with Floyd Mayweather.

Logan Paul is weighing in after the world watched his boxing match against Floyd Mayweather.

The 26-year-old YouTube personality took to the ring against the 44-year-old boxing legend on Sunday, June 6, and the exhibition event at Hard Rock Stadium in Miami lasted the full eight rounds. Since there was no knockout and no judges to score the fight, there was no official winner, although ESPN scored the bout 78 to 74 in favor of Floyd.

"HOLY F--K. MY BROTHER JUST BEAT FLOYD MAYWEATHER."

A number of individuals posted memes referencing the fact that the two fighters spent some of the fight leaning against each other and appeared to be hugging. Clearly, Logan noticed these memes.

Just before the fight, he reposted an illustration to his Instagram Story that depicted himself and Floyd engaged in a kiss. Then, after the fight was over, Logan reposted a Barstool Sports screenshot from the match that showed him resting his head on Floyd's shoulder with his eyes closed while both guys had their arms wrapped around each other.

"Having a heart to heart with your boy at 3am after drinking all the beers," Barstool Sports' caption read. Logan shared the post but did not add any message of his

Earlier in the day, the social media figure tweeted that when he moved to L.A. five years ago, his dream was to become the biggest entertainer in the world. "I had no idea HOW or WHEN it would happen, but after 6 years of manifestation, it's happening," Logan wrote. "Life is a wild ride."
