AAI spent Rs 4 crore in 2018-19 to maintain 26 non-operational airports

New Delhi, Jun 30 (PTI): The Airport Authority of India (AAI) spent Rs 4 crore in 2018-19 to maintain its 26 non-operational airports, according to an official document.

In 2017-18, the AAI had spent Rs 2.66 crore to maintain these 26 airports, the document stated.

The AAI owns and manages around 100 operational airports

However, it also has 26 non-operational airports with it that have no flight operations currently.

Some of these 26 airports are in the following places: Donakonda in Andhra Pradesh; Daparizo in Arunachal Pradesh; Rupsi and Shella in Assam; Muzaffarpur, Jogbani, Raxaul in Bihar; Deesa in Gujarat; Chakulia Deogarh

Iharkhand; Panna, Satna and Khandwa in Madhya

As per the document, the remaining of these 26 airports are in the following places: Aizwal in Mizoram; Nadirgul and Warangal in Telangana; Vellore and Thanjavur in Tamil Nadu; Kailashahar, Kamalpur and Khowai in Tripura; Bareilly and Lalitpur in Uttar Pradesh; Asansol, Balurghat and

Malda in West Bengal. In 2018-19, Rs 85 lakhs was spent by the AAI to maintain the nonoperational airport at

Vellore in Tamil Nadu, as per the document. On the operational airports of Warangal in Telangana and Kailashahar Tripura, the AAI spent Rs 56 lakhs and Rs 48 lakhs in 2018-19, respectively,

New Delhi, Jun 30 (PTI): The Congress on Sunday cited media reports to accuse the Modi government of indulging in "sheer vindictiveness" freezing advertisements to some newspapers critical of the dispensation.

Congress' attack came after media reports claimed that the government has stopped providing advertisements some newspapers critical of its certain policies and actions. Congress'

Monsoon deficiency comes down to 33 pc; active monsoon week ahead

New Delhi, Jun 30 (PTI): June ended with 33 per cent of monsoon precipitation and over 78 per cent of meteorological subdivision recording "deficient" rainfall, according Meteorological Department. However, monsoon is likely to become active this week.

IMD's Additional Director-General Mrutyunjay Mahapatra said formation of a low pressure in the Bay of Bengal will bring good rainfall to central India, including Odisha and parts of Rajasthan.

Parts of north India like Delhi, Punjab and Haryana may not benefit due to this low pressure area and it is unlikely that these states will get rainfall because of it, Mahapatra said.

Private weather forecaster Skymet's Managing Director Iatin Singh said monsoon surge is expected from June 30 to July 15 with a short break in between.

This spell would be a result of a low pressure area which is likely to form in the Bay of Bengal. Odisha, north coastal Andhra Pradesh, south Chhattisgarh, northern parts of Telangana, south Madhya Pradesh, Vidarbha region, parts of central Maharashtra, southwest Madhya Pradesh, south Rajasthan and Gujarat would benefit the maximum from this spell, he said. The official monsoon season in the country starts on June 1 and ends on September 30.

As of June 30, monsoon has reached almost the entire country, except a few parts of north India. It is yet to reach Delhi, Haryana, Himachal Pradesh and Jammu and Kashmir.

Fund transfer via RTGS, NEFT set to get cheaper from Monday

MUMBAI, JUN 30 (PTI): Fund transfer through RTGS and NEFT systems is set to become cheaper from Monday after the Reserve Bank of India decided it will not impose any charges on such transactions.

announcing After its decision to waive all charges on fund transfer through RTGS and NEFT systems from July 1, the Reserve Bank of India (RBI) had also asked banks to pass on the benefits to customers from the same day.

The real-time gross settlement (RTGS) system is meant for largevalue instantaneous fund transfers, while the national electronic funds transfer (NEFT) system is used for fund transfers of up to Rs 2 lakh.

"With a view to push the digital transaction, the RBI has decided not to charge the RTGS and NEFT transactions. This would help banks reduce the fees from customers for these transactions." Indian Banks' Association Chairman Sunil Mehta said in IBA's

The country's largest bank SBI charges between Re 1 and Rs 5 for transactions through NEFT and between Rs 5 and Rs 50 for RTGS route.

provide an impetus to digital funds movement, the central bank had decided to do away with the processing charges and time-varying charges levied on banks by the RBI for outward transactions through the RTGS, as also the processing charges for transactions processed in NEFT will be waived by the Reserve Bank of India.

Currently, RBI "levies minimum charges" on banks for transactions routed through its RTGS and NEFT system.

The RBI has also constituted a level committee under IBA Chief Executive V G Kannan to examine ATM charges and fees by banks amid demands for reviewing the levies.

overruns of Rs 3.3 lakh cr



New Delhi, Jun 30 **(PTI):** As many as 340 infrastructure projects, each worth Rs 150 crore or more, have shown cost overruns to the tune of over Rs 3.3 lakh crore owing to delays and other reasons, a report said.

"Total original cost of implementation of the 1405 projects was Rs 18,09,681.47 crore and their anticipated completion cost is likely to be Rs 21,39,924.38 crore, which reflects cost overruns overall 3,30,242.91 (18.25% original cost)," the Ministry of Statistics Programme Implementation's latest said.

The ministry monitors infrastructure projects worth Rs 150 crore and above. Of these 1,405 projects, reported cost overruns and 381 time escalation.

report, the expenditure incurred on these projects till March 2019 is Rs 8,53,680.47 crore, which is 39.89 per cent of the anticipated cost of the projects. However, it said

the number of delayed projects decreases to 300 if delay is calculated on the basis of latest schedule of completion

For 705 projects, neither the year of commissioning the tentative gestation period has reported.

Out of 381 delayed projects, 117 projects have overall delay in the range of 1 to 12 months, 63 are delayed by 13 to 24 months 103 reflect delay of 25 to 60 months and 98 projects show 61 months and above delay.

The average time overrun in these 381 delayed projects is 43.17 months.

The brief reasons for time overruns, as reported by various project implementing agencies, are delays in land acquisition, forest clearance and supply of equipment.

> Besides, there are other reasons like constraints, geological surprises, geo-mining conditions, slow progress in civil works, shortage of inadequate labour, mobilisation by the contractor, Maoist problems, court cases, contractual issues, ROU/ROW (right of use/right of way) problems, law order situation, among others, the report said.

Food contamination is a matter of growing concern today as the high concentration of chemicals present in the food poses serious health risks. Organically produced food is becoming increasingly popular with more and more people realising its benefits as organic farming practices helps eliminate pesticide and fertilizer residues from the food chain. The demand of organic food is high in India and is only growing every year. A study conducted by Associated Chambers Commerce & Industry of India revealed that the market size for Indian organic packaged food is expected to cross INR 871 million by 2021 from INR 533 million in 2016, growing at a rate of 17%. Consumers everywhere are looking for safer food produced in environmentally friendly conditions while also emphasising animal welfare, food quality and health. These attributes are important to today's ethically and ecologically conscious consumers.

The first talks of developing

an organic farming policy in Sikkim in alignment with 'Green Sikkim' happened in 2001 following which an official political commitment to the cause was made by the then Chief Minister Shri Pawan Chamling in 2003. After persistent efforts over 15 years from the government and active support from the farmers, panchayats, entrepreneurs and general public, Sikkim achieved its goal of becoming a fully organic state and was declared India's first organic state in January 2016 by Prime Minister Narendra Modi. Most of the policies implemented during the intervening period were very unique and could even be considered radical. For example, one of the policies was phasing out of pesticides, a move which was unheard of in India, a country where agriculture is often associated with increased use of pesticides and fertilizers owing to the greatly successful Green Revolution despite problems associated with inorganic agricultural practices.

Due to the success of all the

policies undertaken in the past

15 years, Sikkim received the Future Policy Gold Award in October 2018 for being India's first 100% organic state, awarded by the UN's Food and Agriculture Organization (FAO) in Rome, Italy which Shri Pawan Chamling received personally. This award, which has been dubbed the 'Oscar for Best Policies', crowns the best policies on agroecology and sustainable food systems around the world. This award is indeed a matter of pride every Sikkimese and brought international attention to our state.

Today, not only is all of Sikkim's farmland certified organic, the organic approach has proven transformational for the state and its citizens covering, but not limited to, areas of health and nutrition, rural development and sustainable tourism. The boom to the tourism sector has been very visible with a large number of urban tourists coming into the state to stay in Sikkim's homestays and to enjoy organically produced food. This has proved to be greatly beneficial to village eco-tourism. The youth

have adopted the organic mission enthusiastically. Highly educated youth have begun to engage actively in organic farming and market distribution produce, recognising the potential of the organic revolution that is happening worldwide. The educated young farmers have even started taking state produce to far off places in the country like Bengaluru and Delhi.

Organic farming has been the traditional way of farming adopted by farmers since ages in Sikkim and the use of chemical fertilizers has been lower than other states in India. Due to its fragile mountainous environment Sikkim is not well suited to intensive industrial Pesticide farming. synthetic fertilizer residues are major water pollutants which contaminate our rivers and impact marine life. These polluted rives, which are the main source of water for millions of Indians, then flow into the plains. Since most of India's rivers originates from the Himalayas, other mountain

Priyanka slams UP govt over reported reduction in honorarium of school instructors

New Delhi, Jun 30 (PTI): Congress leader Priyanka Gandhi Vadra on Sunday hit out at the BJP government in Uttar Pradesh over the reported reduction in the honorarium of school instructors, alleging the dispensation is committing atrocities on them.

Pedestrian-friendly CP: Parking woes irk visitors, traders miffed as footfall reduces

New Delhi, Jun 30 (PTI): There was chaos in parts of Connaught Place on Sunday as the NDMC set in motion its plan to make the shopping hub pedestrian-friendly, inviting sharp criticism traders who claimed the footfall in the inner circle has reduced massively.

Visitors complained of inconvenience, saying the parking areas are far and chaotic.

"It's okay for people who take the metro to CP, they can take the required exit. But there's auto-service for them if they want to go to another block. They will have to walk," said Shradha Gupta, who was visiting the area with her family for lunch.

Shahid, Nipunika who had to leave her car near Shivaji Stadium, said, "Since the entire inner circle parking was blocked, there was total chaos in the middle circle parking area. I had to go all

the way to Shivaji Stadium metro station and walk back to CP".

Representatives United Coffee House, a popular joint, said they usually have at least halfan-hour waiting time for visitors but on Sunday, only five tables were occupied.

"In B-Block parking, entry point is now exit point and exit is entry. And the parking machines are supporting this change. Parking attendants are going crazy," another visitor said.

Vinay Behel, of the the treasurer Delhi Traders Association, said, were assured that there would be no stopping of vehicles into inner circle for access to parking lots but it was the opposite and caused huge inconvenience to customers. And where are the pedestrians? Even the regular crowd has gone

"It is total chaotic. The footfall has fallen by 8590 per cent. The business is affected and customers at inconvenience. Who is benefiting from this plan?" said Amit

Gupta, a trader. On Saturday, the civic agency carried out a mock drill to test the new traffic and pedestrian movement plan.

Miffed traders removed barricades placed by the civic body and shouted slogans.

The civic body had said the vehicular movement to shopping hub will be restricted this Sunday and Monday as the NDMC plans to execute pedestrian-friendly

However, now the plan will be tested on Sunday only.

"A full-fledged plan Connaught pedestrianfriendly will be prepared based on the success of the trial run and after taking inputs from all

stakeholders," said a senior NDMC official.

Traders had raised objection to the plan, following which NDMC tweaked it.

The initial plan was to make the inner circle completely car-free and giving access to all parking areas in the inner and outer circles to car owners.

Connaught Place market Chandni Chowk initially chosen pedestrianisation in the national capital.

January 2017, In Union urban then development minister M Venkaiah Naidu had proposed the idea later taken forward by NDMC.

However, the plan never took off owing to strong opposition from traders.

This month, the NDMC announced it will do a trial run of the plan for two consecutive weekends.

Perform or leave: Tripura CM to govt employees

AGARTALA, JUN (PTI): Tripura Chief Minister Biplab Kumar Deb Sunday sent a stern warning to nonperforming government employees at all levels, saying anyone not found to be working properly would be sent on "voluntary retirement".

Make Space for People in the Public Domain

Enough of dictating terms while pretending to confer

retificates of Identification, Old Laws, land acquisition, statehood, identity chauvinism, territorial integrity, seat reservation... these are some issues which keep returning to make news. There have been many comments issued in the public domain on these matters, but start scratching the nature of reactions and it quickly becomes apparent that most of the voices come out from the same bouquet of opinionators. Public opinion is claimed by those who have traditionally usurped the privilege to speak from the people, an empowerment which now allows them to dictate even though they might be claiming to be conferring and set the agenda even when they are supposedly trying to build consensus.

There is a small clutch of voices which occupies the public domain and while there is nothing wrong in holding opinions and broadcasting them, the quality of debate suffers in the absence of variety or new voices. The region, unfortunately, is afflicted by a paucity of representative voices which can claim to be genuinely speaking for a wide section of people. The public space is monopolised by political viewpoints, each comment anchored in the political position projecting the view. It does not help that political personalities and leanings infiltrate other organisations with ease and get their views echoed from there as well. The ruling and the Opposition groups and all sections and fronts aligned with either of them react on expected lines and never surprise with the positions they take and rarely enlighten with lucid explanations or justifications. And no, they stopped explaining their actions a long time ago.

The priority for them is to embarrass or dominate the other side and this they pursue with spite instead of reason. The media allows them the platform to exchange their barbs, and while all of this can be very entertaining, it is rarely informative. Refer to the short list with which this piece begins and it becomes obvious that though many allegations, counter allegations, justifications and claims have been made on these issues, the issues themselves remain largely under-explained and widely misunderstood. Because the political voices get so belligerent in these debates, the unattached voices hesitate from entering the discussions because that would attract immediate political branding which most apolitical stances would be uncomfortable with. It is time that this hesitation was overcome, because the people's right to know and understand is suffering as a result.

The process can be initiated if genuinely apolitical groups and organisations, even social organisations, overcame their passivity and engaged more energetically on issues that concerned the people, tried to understand them better and then shared their informed stands. Until that happens, as far as the people are concerned, they will view debates on all issues only as rants and counter-rants between political opponents, not as important discussions which could affect them.

Period pain is impacting women at school, uni and work. Let's be open about it

m enstrual\ symptoms\ including}$ mood may be linked to nearly nine days of lost productivity per woman every year, according to a new study published in the British Medical Journal this week.

researchers The evaluated lost productivity associated with menstrual symptoms, as measured by time off from work or school (absenteeism) and or studying while feeling ill (presenteeism), in 32,748 Dutch women between the ages of 15 and 45.

While just under 14% of respondents said they had taken time off from work or school during their periods, more than 80% said they had continued to work or study while feeling unwell, and were less productive as a result.

These findings tell us we need to better recognise the impact menstrual symptoms are having on women.

PERIOD PAIN IS COMMON

We recently reviewed the literature and found that globally, almost three-quarters (71%) of adolescents and women under 25 reported having period pain.

Period pain (dysmenorrhoea) is perhaps the most common symptom associated with menstruation. It's characterised by pain in the lower abdomen that usually occurs just before or during the first few days of a woman's period. Period pain can be mild for some women, but more severe, and even debilitating, for

Primary dysmenorrhoea is the most common type of period pain and is mostly caused by changes hormone-like compounds called prostaglandins, which are responsible for the cramping feeling many women report during their period.

Secondary dysmenorrhoea occurs when pain is caused by an underlying problem in the pelvis, such as endometriosis or adenomyosis.



In our research, one in five young women (20%) reported missing school or university due to period pain. Two in five (41%) said pain affected their concentration or performance in class.

Many of these young women run the risk of falling behind during their final years of schooling – a crucial time in their academic lives.

Women in our research also missed social activities, other school activities and sporting activities because of their menstrual symptoms. This is concerning as social interaction and participation in physical activity are important for good health, particularly during adolescence.

JUST PART OF BEING A WOMAN?

Many women think of period pain and other menstrual symptoms as "normal". They don't always recognise that their pain may be a health problem, and often believe it's just something they need to "put up with".

So most young women use self care to manage the pain themselves rather than seeking medical care. This is likely due to a variety of factors, including not discussing menstruation because of social or cultural taboos, a lack of quality education on menstruation, feeling dismissed by medical professionals, or the pain occurring for so long it just becomes "normal".

While mild pain or discomfort could be seen as part of a "normal" menstrual cycle, if pain or any other menstrual symptoms are enough to prevent normal activities such

as going to school or work, it's important to go and speak to your

Moderate to severe period pain alone doesn't necessarily mean you have a condition like endometriosis, but it's likely that something can be done to help reduce the impact of your pain.

WHAT CAN BE DONE?

There is a range of effective treatments for period pain, although there's no "one-size-fitsall" approach that works for every woman. Some women may require multiple strategies to get their pain and symptoms to a level that doesn't impact their daily lives.

Non-steroidal inflammatories such as ibuprofen, and to a lesser extent the oral contraceptive pill, can be effective in treating primary dysmenorrhoea. Both treatments carry the risk of side effects, so should be discussed with a doctor.

Paracetamol, despite commonly used for period pain, doesn't appear to be particularly effective.

There's some evidence that heat and regular physical activity can help. Heat seems to work best if used when pain is present, whereas exercise, such as yoga, is better if it's done regularly throughout the month.

'PERIOD' ISN'T A DIRTY WORD

While symptom management is important, increasing young women's health literacy around menstruation is equally vital. Improving education on menstruation may help women make better self-care choices like choosing more effective painrelieving medications and taking the correct dose.

Several programs in Australia and New Zealand have been designed to help young people better understand the menstrual cycle. These include programs aimed at early adolescents, either at home or school.

The content of school-based programs varies but includes topics such as what a "normal" menstrual cycle looks like and how to identify symptoms that might indicate more serious conditions. Importantly, these programs generally target boys too, which should help reduce the stigma around discussing periods.

Whether at school, university or in the workplace, menstrual symptoms cause absenteeism and presenteeism among a significant proportion of women. We need to break down barriers that prevent open discussion of periods, so women of all ages feel they can discuss any periodrelated problems with their boss, teachers, family or doctor.

Secrecy and shame around periods can prevent access to effective health care. Ensuring menstruating women of all ages have the information they need to choose the best way to manage their pain and symptoms is vital.

Inequality and climate change: the rich must step up

From the beginning, the issue of inequality with respect to the impacts of climate change and the global response has been a recurring theme in international climate negotiations. Emerging and developing countries have been sought spur the developed world into acknowledging its greater burden of responsibility and, accordingly, its obligation to make a larger contribution to the shift toward a low-carbon economy. The concept of climate justice emerged from this debate, inspiring the legal principle of "common but differentiated responsibilities" (CBDR). The CBDR principle is recognised, among others, by the United Nations bodies charged with overseeing the negotiations – hence the effort at COP24 to translate the pledges enshrined in the Paris Agreement into specific, measurable commitments, particularly in relation to the financial transfers between the global North and South. This is the famous "100 billion dollars" a year that developed countries set as their collective target for 2020, with the aim of helping the countries of the Global South take measures to cut emissions and adapt to a changing climate.

UNEQUAL CO2 EMISSIONS

The complexity of the relationship between inequality and climate change is also linked to the scope of analysis we choose to adopt. Taking a simple approach, we can identify inequality in terms of carbon emissions on the one hand, and the inequality in terms of impacts on the other. The emissions gap can be measured at multiple levels.

At the country level, China recently became the world's biggest CO2 emitter, responsible for a startling 26% of global carbon emissions. Africa still has the lowest emissions of any continent, but this masks a great deal of variation between countries, with South Africa by far the largest emitter.

Oxfam. When we look at per-capita data for the entire globe, the contrasts become even more striking. The Oxfam study also indicates that the lifestyles of the wealthiest Americans are 10 times more emissions-intensive than those of China's richest.

In the United States, as the share of national income enjoyed by the top 10% grew between 1997 and 2012, there was a corresponding increase in emissions levels. Moreover, inequalities in consumption tend to encourage the formation of carbon-intensive habits: we know that the is one of the key drivers of consumption patterns, and the result of this social mimicry is escalating carbon emissions, as more and more people base their aspirations on the lives of the richest 1%.

Almost 8% of global CO2 emissions, and the sector's growth is outpacing all efforts to curtail its impacts. It seems quite clear that highly unequal societies, where economic, cultural, and political power is disproportionately held by the rich, tend to incubate conditions that foreshadow a dangerously carbon-intensive future.

Meanwhile, other mechanisms are also at work. Inequality erodes social cohesion and undermines individual willingness to engage in collective action. It weakens the sense of social responsibility that is so vital to foster demand for pro-environmental policies, as we are seeing at the moment with the climate protests taking place across Europe.

From a technological perspective, economists Francesco Vona and Fabrizio Patriarca have demonstrated how high inequality hampers the development and adoption of new green technologies, as such innovations are accessible to fewer people. Similarly, Lucas Chancel and Thomas Piketty have proposed a consumption-based emissions inequality index to measure differences between income deciles within each country – thus shifting the focus from the national to the individual level. They argue that in a globalised economy it makes more sense to consider the quantity of emissions "consumed" (through the products we buy and the services we use) than to talk about emissions "produced".

When we adopt this consumption-based approach, the map of emissions inequality reveals some arresting contrasts. A clear gap emerges between the North and South, but also between the world's wealthiest 10% and everybody else.

UNEQUAL EXPOSURE TO CLIMATIC HAZARDS

Differing degrees of vulnerability to the impacts of climate change are strongly correlated with existing patterns of income inequality. Individual and societal exposure to the hazards of a warming climate varies widely, not only between developed and developing countries (a gap we have known about for a long time), but also between different groups within a country.

In the United States, for example, the effects of climate change are disproportionately felt by the least privileged, and so climate becomes another

can be observed in an emerging country like Vietnam, which is doubly vulnerable due to its high proportion of agricultural employment and elevated susceptibility to the hazards of climate change. We have demonstrated this in the larger context of a project carried out by the French Development Agency (AFD), GEMMES Vietnam, which presents a systematic analysis of the "socio-economic impacts of climate change and adaptation strategies in Vietnam."

We found that one additional day per year where the temperature exceeds 33 °C seems to have a strong adverse effect on both the technical efficiency of rice cultivation and household income, widening the gap between income quartiles (the population having been divided into four income groups) irrespective of occupation. This highlights that exposure to climatic hazards is unequal.

Climate change not only increases the exposure of the most vulnerable to the ensuing climatic hazards, but it also heightens their sensitivity to its adverse effects and diminishes their capacity to adapt and recover following an extreme climate event.

All indications seem to point to the need to promote more restrained consumption patterns among the wealthy alongside the more general principle of reducing inequalities, if we are to have any hope of meeting the objectives set out in the Paris Agreement. Unless we address inequality and curb the excessive emissions generated by the lifestyles of the rich, there is a risk that efforts to live up to the Paris Agreement will lead to a breakdown in the social bond.

In other words, the responsibility to cut carbon emissions must be shouldered by the highestincome countries, and by the most privileged social groups in certain emerging and developing nations. Achieving this goal will require a drastic contraction of consumption habits. The surest path to meeting the COP21 objectives is by tackling inequality and strengthening the social bond - especially if we are to achieve the most ambitious goal of capping the average global temperature rise at just 1.5 °C.

He said the Health Ministry is providing all logistical and technical support to the state government in terms of surveillance and diagnostic kits to strengthen their efforts in addressing JE.

Noting community participation and empowerment are most crucial



prevention, Vardhan urged all the stakeholders to start rigorous awareness campaigns regarding the preventive steps to be taken by the communities.

The central team is headed by Additional Secretary Sanjeeva Kumar and he is accompanied by the senior officers from the National Vector Borne Diseases Control Programme, New Delhi, an official statement said.

As per the directions of the health minister, the team will reach the state by Sunday evening to review the situation.

The God of Small Things writer has now come out with My Seditious Heart , a collection of her non-fiction of a twodecade period when she devoted herself to the political essay as a way of opening up space for justice, rights and freedoms in an increasingly hostile environment.

She says as much as the fiction she writes comes from solitude, this book comes from companionship.

Soon after her first novel The God of Small Things won the 1997 Booker Prize, Roy was a frontrunner in the lineup of people who were chosen to personify the confident, new, marketfriendly India that was finally taking its place at the high table.

It was flattering in a way, but deeply disturbing, too. As I watched people being pushed into penury,

my book was selling millions of copies. My bank account was burgeoning. Money on that scale confused me. What did it really mean to be a writer in times such as these? she says.

As she thought about this, almost without meaning to, she began to write a long, bewildering, episodic, astonishingly violent story about the complicated waltz between corporate globalisation and religious medieval fundamentalism and the trail of destruction they were leaving in their wake. And of the remarkable people who had risen to resist them.

The backlash to almost every one of these essays when she first published them - in the form of police cases, legal notices, court appearances, and even a short jail sentence - was often so wearying that she would resolve never to write another.

But equally, almost

every one of them each a broken promise to myself - took me on journeys deeper and deeper into worlds that enriched my understanding, and complicated my view, of the times we live in. They opened doors for me to secret places where few are trusted, led me into the very heart of insurrections, into places of pain, rage and ferocious irreverence, she says.

Although writers usually walk alone, most of what I wrote rose from the heart of a crowd. It was never meant as neutral commentary, pretending to be observations of a bystander. It was just

another stream that

flowed into the quick, immense. rushing currents that I was writing about. My contribution to our collective refusal to obediently fade away, she adds.

The essays in this collection, published by Penguin Books imprint Hamilton, Hamish were written when a certain political space closed down, when a false consensus was being broadcast, when I could no longer endure the relentless propaganda and the sheer vicious bullying of vulnerable people by an increasingly corporatised media and its increasingly privatised commentators.

She says she wrote because she saw that what she needed to do would challenge her abilities as a writer.

LONDON, JUN 30 (PTI): Boasting of a good World Cup record, five-time champions Australia are the team to beat in the ongoing edition of the game's showpiece event, said New Zealand pacer Trent Boult.

In a repeat of 2015 final between the trans-Tasman rivals, pace spearhead Boult's historic hat-trick went in vain as Mitchell Starc's (5/26) brilliant five-for guided Australia to a convincing 86-run win over New Zealand at the Lord's here on Saturday.

With his swinging full-pitched deliveries, Boult sent back the wellsettled Usman Khawaja (88 off 129 balls), Starc and Jason Behrendorff, while giving away just two runs of the last over to become the first Kiwi to grab a hat-trick in the World Cup.

But his efforts proved futile as New Zealand were shot out for 157.

By virtue of the win, defending champions Australia, who are already through to the semifinals, have consolidated their position at the top with 14 points from eight games.

"Australia turn up for World Cups. They have a good record in them and they're peaking nicely. They produced the complete performance and they were too good for us," said Boult, who returned with figures of 4 for 51.

"There are some and all about timing in my opinion and Australia are performing well, there's only a couple of weeks left and they're the ones to beat."

Boult was effusive in his praise for pace counterpart Starc, the tournament's bowler so far.

Boult was leading wicket-taker in wickets.

alongside Starc. But this time Starc overshadowed him and is leading the wicket-takers list with 24 scalps ahead of secondplaced Lockie Ferguson of New Zealand, with 17.

"He's (Starc) six foot seven, bowls 157kph and swings it both ways! He's a classy bowler. He was used very nicely with short spells to be aggressive. He's had a stellar campaign so far," the Kiwi left-arm pacer said.

Boult, however, said it was special to grab a hat-trick at the 'Home of Cricket', his second in ODI cricket.

"It would have been nice if it was in the first over but any bowler dreams of getting three wickets in a row. To do it at the 'Home of Cricket' in front of a good crowd against Australia was pretty cool," he said.

"It's a pretty simple game plan. I wanted to disturb the woodwork and it was nice to see the stumps light up. It was a bit of entertainment for

He said New Zealand let Australia off the hook on Saturday.

"To have them 90 for five and let them get over 200 was frustrating. If we had kept them under 200, then it's a whole different ball game," he said.

New Zealand have suffered now two defeats, successive against Pakistan Australia, and quality sides here but it's face England in their final group match on Wednesday, a match that could yet decide who makes the final four.

England can beat the USA. As much as I hate to say it, my advice to Phil Neville would be to go direct. Most teams want to be entertaining, pass the ball, and play an attractive style that everyone likes to see and play. The problem for England is that the US knows how to defend against teams that play like that. The way to win is to catch the US with their lack of speed in defense and the way to do that is to play fast and

England can't let the US get ahead early. As the Americans showed against France, once they go one up, the US can lock up the game. The great irony is that at the Rio Olympics in 2016, Sweden packed the box against us and won a penalty shoot out. Against France, the US took a similar approach but executed it slightly differently by scoring early and then dropping the whole midfield back to defend.

At times against France the US had five players in the backline and eight behind the ball. It was a very conservative approach. They didn't attack in numbers and the midfield didn't get high up the field to support the attacking players. Money in Swiss banks: India slips to 74th place, UK remains on top

ZURICH/NEW DELHI, JUN 30 (PTI): India has moved down one place to 74th rank in terms of money parked by its citizens and enterprises with Swiss banks, while the UK has retained its top position, as per data released by the central banking authority of the Alpine nation.

India was ranked 73rd last year, after jumping 15 places from its 88th position a year ago.

An analysis of the latest annual banking statistics released by the Swiss National Bank (SNB) shows that India remains ranked very low when it comes to money parked by individuals Indian and enterprises in Swiss banks, including through their Indiabased branches, while accounting for just about 0.07 per cent of the aggregate funds parked by all foreign clients of Switzerlandbased banks.

the top-ranked accounted for more than 26 per cent of the total foreign funds parked with Swiss banks at the end of 2018.

Among the topranked jurisdictions. the UK is followed by the US, West Indies, France and Hong Kong in the top five.

The top-five countries alone account for than 50 per cent of the aggregate foreign funds parked with the Swiss banks, while the top-10 account for nearly two-thirds.

The countries account for nearly 75 per cent of all foreign money in Swiss banks, while the contribution of the top-30 is almost 90 per

top-10 The countries also include Germany, Bahamas. Luxembourg, Cayman Islands and Singapore.

Among the fivenation BRICS block of comparison, emerging economies,



India is ranked the lowest while Russia is ranked the highest at 20th place, followed by China at 22nd, South Africa at 60th and Brazil at 65th place in terms of amount of money parked by their residents and enterprises at the end of 2018.

countries ranked higher than India also include Mauritius (71st), New Zealand (59th), the Philippines (54th), Venezuela (53rd), Seychelles (52nd),

India's neighbouring nations are ranked lower, with Pakistan ranking 82nd, Bangladesh 89th, Nepal 109th, Sri Lanka 141st, Myanmar 187th and Bhutan 193rd.

This is the first time in the last four years that the funds linked to Pakistan in Swiss banks have slipped below that of Indians.

A number of other major countries also saw their funds falling in Swiss banks amid a global clampdown against the erstwhile banking secrecy walls in the Alpine nation.

The funds, described by SNB as 'liabilities' of Swiss banks or 'amounts due to' their clients, are official figures disclosed by authorities and do not indicate exact quantum of the much-debated alleged

black money held in famed safe havens of Switzerland.

The official figures, disclosed annually by Switzerland's central bank, also do not include the money that Indians, NRIs or others might have in Swiss banks in the names of entities from different countries.

It has been often alleged that Indians and other nationals seeking to stash their illicit wealth abroad use multiple layers of various jurisdictions, including tax havens, to shift the money to Swiss banks. Also,

Switzerland putting in place an automatic information exchange framework with India various other countries, the famed secrecy walls of Swiss banks are said to have crumbled. India will start getting this automatic data from this year, while it has already been getting information on accounts where proof of illicit funds can be furnished.

The funds officially held by Indians with banks in Switzerland now accounts for only 0.07 per cent of the total funds kept by all foreign clients in the Swiss banking system, almost same as the level seen at 2017-end after a modest increase from 0.04 per cent a year before that, as per an analysis of the latest figures compiled by the SNB (Swiss National Bank) as on 2018-end.

India was placed at 75th position in 2015 and 61st in the year before, though it used to be among the top-50 countries in terms of holdings in Swiss banks till 2007. The country was ranked highest at 37th place in the year 2004.

The total money held in Swiss banks by foreign clients from across the world fell by about 4 per cent to CHF 1.4 trillion (about Rs 99 lakh crore) in 2018.

terms of individual countries, the UK continues to account for the largest over two decades.

chunk at about CHF 372 billion (down from CHF 403 billion a year ago), which remains more than 26 per cent of the total foreign money with Swiss banks.

The US remains on the second position despite a dip to about CHF 144 billion (from CHF 166 billion a year ago), accounting for nearly 10.3 per cent of all foreign funds. The share is more than 1 per cent only for 21 jurisdictions.

India was ranked the top-50 continuously between 1996 and 2007, but its rank started declining after that -- 55th in 2008, 59th in 2009 and 2010 each, 55th again in 2011, 71st in 2012 and then to 58th in 2013.

OSAKA, JUN 30 (PTI): Donald Trump had a "productive discussion" with Prime Minister Narendra Modi topics like Iran, 5G and national security during their meeting here, the US President's daughter and top adviser Ivanka Trump has said as she described India as a "critical" trading partner, security partner and ally of America.

Modi and Trump met in the Japanese port city of Osaka on the sidelines of the G20 Summit, the first since the Indian prime minister led his Bharatiya Janata Party to a landslide win in the general elections.

In a video of Ivanka tweeted by the White House on Saturday, the final day of the G20 Summit, she gave a brief summary of Trump's bilateral separate meetings between her father and Prime Minister Modi and Japanese Prime Minister Shinzo Abe.

Ivanka, who has made

Foreign Secretary Vijay Gokhale told reporters that Prime Minister Modi and President Trump had a "very open and productive" meeting.

"This was a very open and productive meeting. The two leaders had a very warm discussion," he

President Trump congratulated Minister Modi on his victory and the two leaders discussed issues related to Iran, to 5G, to trade and to defence relations.

On the issue of Iran, Modi outlined India's energy concerns as well its concerns regarding peace and stability in the Persian Gulf region.

Both sides agreed that they would remain in touch on the issue of Iran and will continue to have mutual discussion on how to ensure regional peace and stability.

The discussion came at a time of heightened tensions between Iran and the US, which has Tehran accused being behind a series of operations against oil tankers in highly sensitive Gulf waters. The US has also deployed its warships and additional soldiers to the region.

On 5G, the prime

minister highlighted the technical and business opportunities that this new area provides for cooperation between India and the United States.

The Prime Minister outlined that India would have a billion users of the 5G technology and in that sense India is the second largest market in the world.

"The way India moves or the way whatever choices India makes will essentially determine the way the global trend will go," Gokhale said.

He said Minister Modi underlined the importance of Indo-US collaboration in the further development of 5G technology for mutual benefit. The two leaders discussed the issue of 5G at a time when Chinese telecom giant Huawei has urged India to make an "informed and independent decision" on permitting its 5G trials in the country.

Indian-origin Senator Kamala Harris racially targeted online

WASHINGTON, JUN 30 (PTI): Kamala Harris, the first Indian-origin Senator and one of the top Democrats eyeing the White House in the 2020 presidential run, has been racially targeted online of her identity as "not an American Black", according to media reports.

Harris, 54, who was born in the US to an Indian mother and a Jamaican father who were both immigrants, has directly confronted critics before who have questioned her black heritage.

Harris, Senator from California, was the target of birtherism-like attack, the latest jabs to racism faced by former President Barack Obama, CNN reported.

"Birtherism," promoted by some Republicans, including President Donald Trump before he assumed the presidency, was a movement that denied former President Obama was a natural-born US citizen, implying he was ineligible to be president. "Kamala Harris


