This was decided in a meeting of the association held today in Gangtok, the release mentions.

It may be mentioned that four adhoc teachers had been arrested on 20 Feb on charges of blocking the highway during their dharna staged on 19 Feb. They had been released on bail on 21 Feb.

"Respecting and honouring the assurance of Chief Minister on the issue related of Adhoc Teachers along with Non-Teaching Staff (HRDD/ SSA/RMSA/MDM/Non-Teaching - PTI) of Sikkim working in different schools have unanimously decided to call off their protest in a meeting held today in Gangtok," the release states.

The release further informs that the association has decided to work closely with the Sikkim Teachers Association to pursue the matter with the HRD Department. The association has also clarified that the protest was completely apolitical and that they had no intention to cause inconvenience to the public.

"We believe that justice will prevail and our just demands will be fulfilled by the government and also request the concerned Department (HRDD/STRB/SSA/DOP) kindly pursue our demands in fast track process," the release states.

The mood in the Lim-I boo Tamang Voluntary Committee is high at present in the wake of news from the Supreme Court that its petition demanding reserved seats in the Sikkim Legislative Assembly cleared the admission hearing in the apex Court today and notices issued to all the seven respondents.

An LTVC press release informs that the writ petition filed by Yehang Subba and Sancha Raj Limboo on 13 Feb was taken up for admission hearing today and was admitted successfully.

Accordingly, the Supreme Court has issued notices to the Delimitation Commission, Election Commission of India, State of Sikkim, the Rajya Sabha Secretariat, Lok Sabha Secretariat, Ministry of Home Affairs, and the Ministry of Law & Justice.

The respondents have been given a week's time to file their responses with the next hearing scheduled for 01 March, 2019.

"We have a very good feeling regarding the case and confident that Supreme Court will give justice to Limbu & Tamang communities of Sikkim. He added that the

While announcing SSWA support for the 28 February bandh call, he reiterated that SSWA was supporting the bandh because it believes that the 35 demands placed by the SKM were genuine and related the people of Sikkim.

He added that although a non-political organisation, SSWA has decided to support the bandh.

Mr Sherpa stated that SRC president of Nar Bahadur Bhandari Degree College opposing the bandh was within his rights to do so, but students need to be conscious about rights and issues of the society as well.

He informed that SSWA members will visit all colleges and universities to appeal to SRC members and students to support the bandh.

SSWA general secretary, Karan Silwal, in turn said that the Chief Minister had announced laptops for all students which had created hope in students but the distribution process has not started yet. On the same, he demanded that the government immediately announce the dates for the distribution of laptops in different schools and colleges.

"If our teachers have been demanding their rights then it shows how unsafe the future of students must be when teachers are not safe," he asserted.

SSWA vice-president Tseten Tashi Lepcha said that the government has only been distributing laptops to students in Sikkim and not to Sikkimese studying outside the State. SSWA wants laptops to be distributed to Sikkimese students studying outside State as well.

Shape the Monolith into an Asset

Don't blame the bureaucracy, inspire it

In some recent public addresses, the Chief Minister has consistently called upon public servants to adapt faster to the demands and requirements of the changing times. This is not a new call from his office and he has often stressed that government officers should be on the job 24x7. That he continues to make such appeals is a clear indication that the message has not gone through effectively enough. Now, with elections round the corner and administrative and executive shortfalls at the root of many current complications and confrontations, expect this sentiment to be voiced more often.

Of course, he obviously does not mean that officials should be in office throughout the day all through the week, and is only underlining the fact that officers should not shirk responsibility or dodge behind excuses. This call is required because there is simply too much procrastination in how government offices function, too much nonchalance in how work is put off and staggering insensitivity with which people's affairs are handled. What this leads to is a scenario where officials from departments get so inured by the routineness of things that they do not recognize obvious priorities and drag their feet even on urgently required interventions.

This attitude continues to remain entrenched. A work culture under which even on-the-spot directions [which would convey urgency] by the Chief Minister himself can be deferred, needs a vigorous shake up and this is clearly recognized by the CM as well. This comes after several attempts at working the bureaucratic monolith into better shape. There was the five-day week with longer office hours on working days idea which was abandoned as much because there was no guarantee that the extra hours will see adequate attendance as the complaint of teachers who too are government servants but will have to work an extra day every week. Then there are the smart-card and biometric attendance gadgets which were installed at offices. These obviously did not deliver because frequent appeals are still made for better attendance in government offices.

What is obvious is that the public as well as the public representatives are not very satisfied with the performance of the public servants. Improper as it may be to paint all officers and government employees with the same brush, the end-result, the performance of the departments on the whole makes it difficult not to be prejudiced.

But all of this should not lead to fatalistic acceptance. It is not as if government employees don't want to work at all. Given the multiplicity of agencies and offices, in many cases lethargy has set in for want of clear job descriptions, undefined roles and too much interference. A visit to any government office will bear out the fact that the work-culture is slack in Sikkim not because of the personnel, but because there are too many with too little work. There are few who abandon work midway and leave office, but there are many who have nothing constructive to do in all the hours they spend in their chambers. Here again, the tried and tested formula for similar problems elsewhere is VRS. It fails in Sikkim because even before the employees takes the option of VRS there are others in line to take up their jobs. The weight never really gets shed, especially not now when every agency of the government is on the verge of being over-staffed, because there are too many considerations and connections which cannot be ignored in a small state like Sikkim where most things work at a personal level.

So what does one do?

The oversized administration has been viewed for far too long as a burden and since no solution has really worked out, perhaps a change in attitude is required. What if, the same monolith is accepted as an asset and then segregated into compact units with clearly identified roles and responsibilities and then deployed on the field to deliver the "development" that is the final aim of every government. The BDO experiment was one such effort and has delivered rather well. To repeat a point here, there are very few government employees who don't want to work, they grow lethargic because they are not given anything interesting and constructive to do. If more clarity is offered and more responsibility given, things could start looking up. The approach should be to challenge the public servants with complex tasks, back it with greater autonomy in decision-making and then establishing a clear relationship between effort and reward. This, when complemented by the frequent trainings that have now become mandatory should keep refreshing the officials on their exact roles and contributions to Sikkim's future.

Few will fail to measure up if this is done. In the end, even this solution might not work out, but at least Sikkim would have tried and exhausted all options...

How young filmmakers are protecting artistic freedom in Kenya

A rtistic freedom was always tenuous in Kenya, but it's become even less so since Uhuru Kenyatta became president in 2013. The political pendulum has swung against political dissenters, intellectuals and a handful of media institutions that still believed in objective journalism.

Progressive gains made under the previous administration of President Mwai Kibaki(2002-2013), such as the freedom of press and speech, have disintegrated. In particular, Kenyatta and the men overseeing the country's cultural landscape, have rolled back artistic freedom by banning films that attempted to expand identity or interpreted it differently. The most prominent example is Rafiki, a recent Kenyan film that was banned for "promoting lesbianism."

Historically, artistic freedom has always been the outcome of struggle. For example, stage actors initiated the first struggle when post-colonial administrations outlawed theatre groups because actors associated themselves with institutions such as the University of Nairobi and Kenya National Theatre (see Ngugi wa Thiong'o's Decolonising the Mind). By and large, the two institutions hosted the most vocal government critics. It became standard procedure for the government to ask theatre groups to submit play scripts for "assessment" before it could issue a performance license.

Officials paid insignificant attention to musicians and film directors as they hardly antagonised the ruling elites and produced non-controversial items. An example was the sycophantic song, Tawala Kenya Tawala ("rule Kenya rule"), composed and produced by Thomas Wasonga. The lyrics exhorted Daniel Arap Moi, Kenya's second post-colonial president, to rule eternally. Wasonga's conservative counterparts in the film industry avoided politics, limiting their cinematic gaze to less controversial themes.

Recently, however, a progressive group of young filmmakers has changed the contours informing cinematic themes. Ambitious and daring, they have inspired a national dialogue of what constitutes free speech as encapsulated in the country's new Constitution, as well as artistic freedom, and individual and societal identity.

AMBITIOUS AND DARING

Unlike their forebears, young filmmakers are increasingly embracing cinema as an ideal platform on which to construct a pluralistic identity that includes the LGBTQ community. This has offended the government's sensibility. Consequently, it has brought cinema under heightened scrutiny.

In September 2014, the Nest Collective, a production company that produced The Stories of Our

Lives, applied for a license to distribute and exhibit the film. They received a rejection letter from the Kenya Film and Classification Board, a government agency that regulates film content, which claimed that the film had obscenity, explicit scenes of sexual activities and it promotes homosexuality which, is

imaginations. There should be freedom to express these imaginations, because imagination doesn't have boundaries."

The country's high court agreed with her. They lifted the ban for seven days, allowing the film to be screened and become eligible to be submitted



contrary to our national norms and values.

The classification board drew the producer's attention to a piece of legislation – the Film & Plays Stage Act – that borrows heavily from the colonial government's The Stage Plays and Cinematography Exhibitions Ordinance, 1912. During the colonial period the ordinance was used to censor Hollywood westerns to shield African audience from undesirable ideas such as kissing, sex, shooting and nudity.

Rather than evoke Kenya's Constitution – which protects the "freedom to seek, receive or impart information or ideas", and the "freedom of artistic creativity" – to sue the board, the Nest Collective retreated. It took its case to social media, where, as expected, it died.

SAME TACTIC

Four years later, classification board officials banned Rafiki in May 2018 because, as they pointed out, it contained, "homosexual scenes that are against the law, the culture and moral values of the Kenyan people."

It warned that anyone found in possession of the film would be in breach of the law in Kenya, where gay sex is punishable by 14 years.

The film's director, Wanuri Kahiu, sued the Board. She argued in court that the ban violated her constitutional right to free speech and artistic freedom of expression. Kahiu insisted that Kenya is, "made up of different types of people with different

as Kenya's entry for Best Foreign Language Film at the Oscars.

RANDOM ACT

The censorship of cultural productions doesn't happen in a vacuum, nor is it a random act designed to secure imagined norms and values. It is a calculated and premediated act of subjugation and an act of authoritarianism. In the cultural sphere this begins when the ruling class imagines and constructs a national identity that encompasses nonexistent and undefined principles — such as moral values and norms. It then moves to create competing categories of people, "us" versus "them". Once this is complete, the chips are expected to fall in place.

However, young filmmakers are resisting this path. Resisting it is the only way in which artists can ensure they retain a freer artistic spaces. But that requires acts of courage. As Martin Luther King Jr reminded the world in 1963 from a Birmingham jail:

"Freedom is never voluntarily given by the oppressor, it must be demanded by the oppressed."

This, exactly, is what Rafiki's Kahiu did when she sued the government. It's what the Nest Collective failed to do. Local artists seeking artistic freedom must follow in Kahiu's footsteps and peel back the veneer that legitimises censorship.

Sierra Leone takes welcome leap on rape: but next steps are crucial

The president of Sierra Leone Julius Maada Bio has declared a national emergency on rape and sexual violence following a public outcry over the high number of rapes of young girls in the West African country.

According to the country's police, there were over 8,500 reported cases of sexual and gender based violence in 2018. The number of incidents of sexual violence is likely much higher, as many cases go unreported. In 2012, the first year official police statistics were collected, 632 cases were reported.

The country's gender justice laws enacted in 2007 and 2009 - as well the Sexual Offences Act - ratified in 2012 - have certainly contributed to the higher number of reported cases. But, these increasing numbers show that much more needs to be done to prevent sexual violence and to respond to it better.

The Rainbo Initiative, an organisation offering free care to survivors, holds that young girls are disproportionally affected. President Bio has stated that about 70% of victims are below the age of 15. He made the statement after consulting grassroots women's organisations, NGOs as well as government ministries, judges, lawyers and the police.

Political attention of this kind is vital to addressing rape and all forms of sexual violence. And, declaring the national emergency provides an opportunity for the speedy policy changes needed to combat rape and sexual violence.

The reason the government has taken action is due to the relentless efforts of women's grassroots organisations and other NGOs that have put rape on the national agenda. The organisations help by providing free and confidential medical and psychosocial care to survivors, as well as campaigning to raise awareness. Some

assist the victims during court cases.

Based on my research on the subject, it's my view that the steps proposed by the president seem to reinvent the wheel, rather than build on Leone's medical, legal and police sectors is imperative for success.

A closer look at existing structures and services reveals a more critical reality. Several key organisations such as



strong existing foundations.

Success will depend on whether he's willing to listen to – and learn from – the civil society organisations involved in the fight against rape and sexual assault. They know the problems inside out and what's needed to engender real change. But their efforts to date have been hampered by a lack of funding and governmental support. **WHAT'S MISSING**

Bio wants rapists and other perpetrators of sexual violence to be charged with aggravated assault, and face up to life imprisonment if found guilty. He envisions that all public hospitals should provide free medical services for rape and other sexual assault victims. He also announced the creation of a police division, a special magistrate court to try sexual abuse cases and a public hotline dedicated to reporting sexual violence.

These are big goals indeed. But, to succeed, they require meticulous planning, a steady and reliable flow of resources. They also need tailored skills training for service providers, police and medical doctors to adequately respond to survivors of violence. Increased collaboration between Sierra

AdvocAid, L.A.W.Y.E.R.S. and the Rainbo Initiative have worked tirelessly to offer primary medical and psycho-social care to survivors as well as their proper representation at the courts.

But, these experienced specialists lack resources and support. So much so that they often struggle to keep their operations going. And, so far, their expert opinions have often gone unheard.

AdvocAid has repeatedly shown that women and girls who experience violence are disproportionally disadvantaged by Sierra Leone's legal system. They also lack opportunities to enable them to get out of abusive relationships. And, when using self defence against abusive partners, they can be charged as offenders themselves.

In addition, many women and girls don't know their rights and how to access support. AdvocAid, which has undertaken campaigns to teach women and girls about the law and their rights, points to the need for a national strategy to make rights, regulations and laws known to all in the country.

Since 2003, the Rainbo centres have provided free and confidential primary medical and psychosocial care to survivors of rape and sexual violence.

But working with rape and sexual abuse survivors requires specialised skills, which hospitals across Sierra Leone lack. The government could help by providing the necessary funding to increase the number of centres nationwide. This way, even more survivors could receive care by female doctors and nurses in separate, confidential and safe spaces.

Family support units have been set up to investigate domestic violence, sexual offences and child abuse cases. These are independent police units attached to 62 police stations across the country, with specifically trained police personnel as well as some 20 social workers.

But in a review, the Centre for Accountability and Rule of Law found that the units weren't sufficiently staffed, equipped or funded to be able to fulfil their mandate.

Moreover, the courts have heavy caseloads and litigants often wait years until their cases are heard. And, as my research revealed, lawyers and judges have long pointed to the need to amend the existing laws against rape and sexual assault. The Sexual Offences Act, for example, disproportionately targets the marginalised young boyfriends wrongfully accused of rape or sexual assault, while many wealthier perpetrators continue to escape justice.

Additionally, the discriminatory act of banning pregnant girls from school

remains in place. **NEXT STEPS**

Given the situation in the country, reviewing and adapting existing laws and regulations may be more effective than creating new regulations. Instead of adding to the plethora of existing laws, regulations, services and institutions, the government should look to undertaking the difficult task of strengthening the efforts of existing service providers.

powers granted to Assam

Rifles was turned down

by the Speaker Hitendra

Three separate adjournment motion were submitted by the Congress, AIUDF and AGP as they felt that the contentious notification giving special powers to Assam Rifles would "violate human rights and bring in military rule".

On Thursday, a Ministry of Home Affairs notification empowered Assam Rifles personnel to arrest anyone and search any place without warrant in Assam, Arunachal Pradesh, Manipur, Nagaland and Mizoram.

"It (special powers) will bring military rule and affect freedom of movement, which is given by the Constitution. It is like introducing undeclared emergency," the Leader of the Opposition Debabrata Saikia said while arguing for the motion.

The senior Congress leader asked why the notification was issued when the BJP-led government has been claiming that peace prevails in North East. "There is a report which says that out of 100 cases of Assam Rifles, human rights have been violated in 37. It empowers even the lowest rank officer to arrest a person without warrant. It will lead to complete violation of human rights," he added.

AGP member Pabindra Deka, who moved the resolution on behalf of his party, said that it is a dangerous and shocking notification, which can "devastate" peoples' lives in the region. "It will violate our fundamental rights. It seems the Centre and Narendra Modi want us to take back to Assam Agitation period of murder and loot by forces. Because of unlimited power given to forces, 855 people were martyred then," he added.

The Assam agitation of 1979-1985 was a popular movement against illegal immigrants in Assam. The movement was aimed at urging the Centre to identify and expel illegal, (mostly Bangladeshi), immigrants and protect and provide constitutional, legislative and administrative safeguards to the indigenous Assamese people. Deka alleged that a conspiracy was being hatched to exploit the North East and doubted if the special power was being granted to the paramilitary force to counter the massive protests against the controversial Citizenship (Amendment) Bill in recent months.

"It is against the interest of the people. Assam government has some duties to do in this regard and clear its position," he said.

Centre decides to keep in abeyance powers of arrest given to Assam Rifles

NEW DELHI, FEB 22 (PTI): The Centre decided on Friday to keep in abeyance the special powers given to the Assam Rifles to arrest anyone and search a place without warrant in northeastern states of Assam, Arunachal Pradesh, Manipur, Nagaland and Mizoram, officials said.

The Home Ministry will now revisit the issue with the concerned state governments, which apparently opposed the move to give sweeping powers to the paramilitary force.

It has been decided that the enabling notifications issued on February 19, giving powers to Assam Rifles be kept in abeyance and the entire matter be revisited in consultation with the state governments concerned, a home ministry official said.

While giving the powers to the Assam Rifles, a Home Ministry notification had said: "An officer of the rank corresponding to that of the lowest rank of members of the Assam Rifles" has been given these powersunder

Black Caps spinner Astle back for Bangladesh **Tests**

WELLINGTON, FEB 22 (AFP): Spinner Nathan Astle will resume his stop-start Test career against Bangladesh after beating Ajaz Patel for a spot in New Zealand's 13-man squad to face Bangladesh next week, selectors said Friday.

Astle was the only change in the squad that defeated Sri Lanka 1-0 in December to claim an unprecedented fourth Test series in a row for New Zealand.

Selector Gavin Larsen admitted it was "a tough call" to drop Patel, who was outstanding against Pakistan in the UAE.

"It's great though to have Todd fit again and we're keen to see what his wrist-spin can offer in New Zealand conditions, and he'll also bolster the batting," he said.

Astle, 32, made his Test debut against Sri Lanka in 2012 but since then has played only two more, most recently against England in March last year.

The first of three Tests begins in Hamilton on February 28.

No decision on Indo-Pak World Cup clash yet: CoA New Delhi, Feb 22 (PTI): The Committee of Administrators (CoA) running Indian cricket Friday decided against taking any stand on the World Cup clash against Pakistan but said it would individually urge ICC members to 'sever ties with any nation that is a terrorist hub".

There has been a call to boycott the June 16 World Cup face-off against Pakistan at the Old Trafford in the aftermath of the Pulwama terror attack, which killed more than 40 CRPF personnel. In a meeting to address the spiralling speculation around the match, the CoA deliberated on the matter but did not take any position for now.

"We are in talks with the government. No decision has been taken on the June 16 match," CoA chief Vinod Rai told reporters after the meeting. "We are expressing two concerns to the ICC. We will ask for more protection for players during the World Cup and we will tell cricketing nations to sever ties with anv nation that is a terrorist hub," he added.

There were reports that the CoA and the BCCI might approach the ICC seeking Pakistan's ouster from the mega-event in England that starts on May 30.

However, even such a move is unlikely to make any difference as there is no provision in the world body's regulations that allow one member to seek the ouster of another. The call to boycott the match has come from some prominent names in Indian cricket such as senior off-spinner Harbhajan Singh and former captain Mohammed Azharuddin.

Man Utd seek to derail Liverpool title bid as Spurs lurk

LONDON, FEB 22 (AFP): Liverpool travel to Manchester United on Sunday facing the toughest assignment of their Premier League run-in on paper as Tottenham seek to sneak back into the heart of the title race.

The trip to Old Trafford is effectively Jurgen Klopp's team's game in hand as they bid to open up a threepoint lead over Manchester City, who play Chelsea in the League Cup final on the same day.

Liverpool thumped United 3-1 at Anfield in the last match of Jose Mourinho's reign on December but they are transformed under interim boss Ole Gunnar Solskjaer and are back in the top four.

If Spurs beat Burnley and Liverpool slip up, Mauricio Pochettino's men will be just two points behind City and Liverpool, with all three clubs having played 27 matches.

AFP Sport picks out some of the main talking points ahead of this weekend's Premier League fixtures. WARY LIVERPOOL FACE OLD TRAFFORD LITMUS TEST

Liverpool know that a win at Old Trafford -- where they have won just twice in the league since 2004 -- would be a huge statement of intent as they hunt their first English top-flight title since 1990.

Klopp's men are 14 points clear of United but they will be facing a different team from the one they demolished in December, courtesy of a



goal from Sadio Mane and two from Xherdan Shaqiri.

"Since the new manager came in there is a new flow, they played good games and have won a lot and that is building confidence in the team," said Liverpool midfielder Georginio Wijnaldum. "It's also a home game for them so they will have a lot of confidence as they don't have the problems they had before."

SOLSKJAER'S TOUGH SIDE

Solskjaer has lifted his side into the Champions League places and knows any chance he has of becoming the next permanent manager probably hinges on staying there.

But defender Luke Shaw says the interim boss, known for his sunny demeanour, is capable of showing some steel.

"You know, Ole does it at the right time (shows another side)," Shaw told MUTV.

"He knows how good we can be

and, if we're not up to his standards or the standards of Manchester United, he will certainly let you know.

"We've had a few moments like that where we might have been comfortable in a game but got a bit sloppy. He's the manager and he tells the players what he wants. It's good and what we need sometimes, a kick up the backside from the manager, if we're getting too comfortable."

SPURS STEALTH ATTACK

Despite showing incredible tenacity to stay on the edge of the Premier League title race, Tottenham have gone under the radar, with Manchester City and Liverpool the constant focus. But four straight league victories have kept Spurs in the hunt for their first English topflight title since 1961 -- and they are getting ready to welcome talisman Harry Kane back into the fold.

"He is doing very well and maybe he is going to be available at Burnley (on Saturday)," said Pochettino.

"Harry is an animal and wants to be ready as soon as possible. In the last 10 days he has been fantastic and having him back available is a fantastic boost for everyone."

GOLDEN OLDIE HODGSON IS RE-**CORD-BREAKER**

Roy Hodgson will become the oldest manager in Premier League history when Crystal Palace take on Leicester. The former Liverpool and England boss will break Bobby Robson's record for the Premier League era, which has stood since Robson's final game at Newcastle in August 2004.

He will be 71 years and 199 days old on Saturday.

The pair are among four managers to take charge of a Premier League game in their 70s, with former United boss Alex Ferguson and Cardiff's Neil Warnock also part of the exclusive club.

IOC 'suspends discussions' with India for hosting global events

NEW DELHI, FEB 22 (PTI): The International Olympic Committee has decided to "suspend all discussions" with India regarding hosting of global sporting events after Pakistani shooters were not issued visas for the World Cup in New Delhi.

The Olympic committee also revoked the Olympic qualification status for the men's 25m rapid fire event from the New Delhi World Cup due to denial of visas to the Pakistani shooters in the wake of last week's Pulwama terrorist attack in which 40 CRPF personnel were killed.

The IOC said it will not allow India to or ganise Olympic-related events in the future, unless written assurances are obtained from the government.

The two Pakistani shooters' participation in the tournament had become doubtful after the terrorist attack had been reported. The IOC's decision comes hours after International Shooting Sport Federation (ISSF) President Vladimir Lisin announced that all the allotted 16 Olympic quotas for the 2020 Games would be scrapped. However, the apex body limited the withholding of quotas to only two while retaining 14.

"The IOC restricted

the withdrawal of recognition as an Olympic qualification event to the 25m rapid fire pistol competition in which the two Pakistani athletes were supposed to participate. This happened in the interest of the other 500 athletes from 61 countries participating in the other events who are already in India for their competition," the IOC said in a statement after its executive board meeting in Lausanne, Switzerland Thursday.

"Since becoming aware of the issue and in spite of intense last-minute joint efforts by the IOC, the ISSF and the Indian National Olym-

pic Committee (NOC), and discussions with the Indian government authorities, no solution has been found to allow the Pakistani delegation to enter India in time to compete." the statement said.

The IOC came down heavily on India for going against the Olympic charter.

"This situation goes

against the fundamental principles of the Olympic charter, in particular the principles of non-discrimination, as well as the IOC's and the Olympic movement's position, reiterated on many occasions over the past few years, that equal

treatment must be guaranteed for all participating athletes and sporting delegations at international sports events, without any form of discrimination or political interference from the host country.

"As a result, the IOC executive board also decided to suspend all discussions with the Indian NOC and government regarding the potential applications for hosting future sports and Olympic-related events in India, until clear written guarantees are obtained from the Indian government to ensure the entry of all participants in such events in full compliance

with the rules of the Olympic charter -- and to recommend that the international federations (IFs) neither award nor hold sports events in India until the above-mentioned guarantees are obtained," the IOC said.

The Pakistan shooting federation Wednesday requested the ISSF not to offer quota places in the events their shooters were scheduled to participate in.

Pakistan had applied for visas for two shooters -- G M Bashir and Khalil Ahmed -- in the rapid fire category as the event in New Delhi also served as a qualifier for the 2020 Olympic games.

Trump and Kim to have one-on-one meet in Hanoi

WASHINGTON, FEB 22 (PTI): US President Donald Trump and North Korean leader Kim Jongun will meet one-on-one and spend substantial amount of time together next week when the two leaders meet in Hanoi, Vietnam, the White House said Thursday.

Trump and Kim are meeting for their second summit on February 27 and 28. The first one was on June 12 in Singapore, which was part of the president's effort to improve his country's relationship with North Korea and ultimately have a denuclearised state.

"There will be opportunities for the two leaders to see one another respective delegations in laying out the objectives (which) is ultimately about denuclearisation of North Korea, a senior administration official told reporters during a conference call.

"That is what was agreed already between the two sides and that is the overriding goal that President Trump is seeking to achieve with this summit," the official said, who spoke with reporters on condition of anonymity.

This is an important step towards that ultimate goal, the official noted. "After breaking the ice with Kim in some aspects in June, Trump is also looking to talk in depth about the kind of future that North Korea could enjoy if it follows through on its commitment to the final and full of denuclearisation," the official said.

Trump would be accompanied by his Secretary of State Mike Pompeo, and several of his top aides for the second summit meeting with the North Korean leader. Hundreds of reporters are travelling to Hanoi to cover the much-anticipated summit.

Officials from the two countries are still negotiating on the text of the agreement or the joint statement that could be issued after the conclusion of the talks between one-on-one, to share a the two leaders next meal and indeed for ex- week, another senior adpanded meetings of their ministration official said, responding to a poser. "We are in the midst

of negotiating some issues and as is often the case in these negotiations nothing is agreed to until everything is agreed to. The official noted that the talks are an effort towards denuclearisation of North Korea. At the same time, he cautioned that nothing was guaranteed as of now.

No IPL opening ceremony this year, CoA says allocated money will go to Pulwama martyrs' families

NEW DELHI, FEB 22 (PTI): The IPL will not have an opening ceremony this year after the Committee of Administrators (CoA) running Indian cricket Friday decided to allocate the money set aside for it to the families of the CRPF personnel killed in the Pulwama terror attack.

The opening ceremonies of the cash-rich T20 league are a heady mix glitz and glamour with performances by Bollywood stars being the highlight. However, as a mark of respect to the slain CRPF men, it has been decided to scrap the ceremony for the event's 12th edition begin-

ning March 23.

"We will not have any inaugural function for the IPL and the money budgeted for that goes to the martyrs' families," said Committee of Administrators chairman Vinod Rai. The CoA took the call at a meeting here on Friday.

The Pulwama attack took place last week and its reverberations are being felt in the sporting arena as well. There has been a call to snap sporting ties with Pakistan.

The Rai-led CoA decided against taking any stand on the World Cup clash against Pakistan but said it would individually urge ICC members to "sever ties with any nation that is a terrorist hub".



Pope offers 21 proposals to fight abuse at start of summit

Pope Francis opened a landmark sex abuse prevention summit Thursday by offering senior Catholic leaders 21 proposals to punish predators and keep children safe, warning that the faithful are demanding concrete action and not just words.

The tone for the high stakes, four-day summit was set at the start, with victims from five continents Europe, Africa, Asia, South America and North America telling the bishops of the trauma of their abuse and the additional pain the church's indifference caused them.

"Listen to the cry of the young, who want justice," Francis told the gathering of 190 leaders of bishops conferences and religious orders.

"The holy people of God are watching and expect not just simple and obvious condemnations, but efficient and concrete measures to be established."

More than 30 years after the scandal first erupted in Ireland and Australia, and 20 years after it hit the US, bishops and Catholic officials in many parts of Europe, Latin America, Africa and Asia still either deny that clergy sex abuse exists in their regions or play down the problem.

Francis, the first Latin American pope, called the summit after he himself botched a wellknown sex abuse cover-up case in Chile last year and the scandal reignited in the US.

With his own papacy and the Catholic hierarchy at large facing a credibility crisis, Francis has now vowed to chart a new course and is bringing the rest of the

The Vatican's onetime sex crimes prosecutor delivered a stepby-step lesson Thursday on how to conduct an investigation under canon law, citing the example of Pope Benedict XVI, who turned the Vatican around on the issue two decades ago.

Calling for a conversion from a culture of silence to a "culture of disclosure," Archbishop Charles Scicluna told bishops they should cooperate with civil law enforcement investigations and announce decisions about predators to their communities once cases have been decided.

He said victims had the right to damages from the church and that bishops should consider using lay experts to help guide them during abuse investigations.

The people of God "should come to know us as friends of their safety and that of their children and youth," he said. "We will protect them at all cost. We will lay down our lives for the flocks entrusted to us."

Finally, Scicluna warned them that it was a "grave sin" to withhold information from the Vatican about candidates for bishops a reference to the recent scandal of the now-defrocked former American cardinal, Theodore McCarrick.

It was apparently an open secret in some church circles that Mc-Carrick slept with young seminarians. He was defrocked last week by Francis after a Vatican trial found credible reports that he abused minors as well as adults.

Francis offered a path of reform going forward, handing out a 21-point set of proposals for the church to consider including some that would require changes to canon law. He called for specific protocols to handle accusations against bishops, in yet another reference to the McCarrick scandal. He suggested protocols to govern the transfers of seminarians or priests to prevent predators from moving freely to unsuspecting communities.

One idea called for raising the minimum age for marriage to 16 while another suggested a basic handbook showing bishops how to investigate cases.

Abuse survivors have turned out in droves in Rome to demand accountability and transparency from church leaders and assert that the time of sex abuse cover-ups is over.

"The question is this: Why should the church be allowed to handle the pedophile question? The question of pedophilia is not a question of religion, it is (a question of) crime," Francesco Zanardi, head of the main

victims advocacy group in Italy Rete L'Abuso, or Abuse Network, told a news conference in the Italian parliament. Inside the summit hall Thursday, the church leaders heard five videotaped testimonies from victims about their abuse and cruel treatment from an indifferent hierarchy.

One woman from Africa told the summit that the priest who began raping her at 15 forced her to have three abortions over the following 13 years. "He gave me everything I wanted when I accepted to have sex; otherwise he would beat me," she said.

The victims' names were not released to protect their privacy, but Chilean survivor Juan Carlos Cruz confirmed he provided a video.

"You are the physicians of the soul and yet, with rare exceptions, you have been transformed in some cases into murderers of the soul, into murderers of the faith," Cruz said in his testimony. Manila Cardinal Luis Tagle choked up as he responded to such testimony, telling the bishops that the wounds they had inflicted on the faithful through their negligence and indifference recalled the wounds of Christ on the cross.

In the keynote speech, he demanded bishops and superiors no longer turn a blind eye to the harm caused by clergy abuse and cover-ups.

"Our lack of response to the suffering of victims, yes even to the point of rejecting them and covering up the scandal to protect perpetrators and the institution, has injured our people," Tagle said. The result, he said, had left a "deep wound in our relationship with those we are sent to serve."

Mention of JeM in UNSC statement only in general terms not a judgement: China



BEIJING, FEB 22 (PTI): China, a permanent member of the UN Security Council, Friday sought to downplay the scathing statement issued by the powerful organ of the world body naming Jaish-e-Muhammad in the Pulwama terror attack, saving the mention of the Pakistan-based outfit was only in "general terms" and "does not represent

a judgement". Forty Central Reserve Police Force personnel were killed in a suicide attack by Pakistan-based Jaish-e-Mohammed (JeM) in Jammu and Kashmir's Pulwama district on February 14, sparking outrage in the country.

The powerful UN Security Council (UNSC) on Thursday strongly condemned the "heinous and cowardly" terror attack.

"The members of the Security Council condemned in the strongest terms the heinous and cowardly suicide bombing in Jammu and Kashmir, which left 40 Indian paramilitary forces dead and dozens wounded on Februclaimed responsibility," it said in a statement.

about the Asked statement highlighting the role of JeM claiming the responsibility of the Pulwama attack, China's

Foreign Ministry spokesman Geng Shuang told reporters that Beijing was closely following the developments related to the terror incident.

"Yesterday, the UN Security Council issued a press statement that mentioned that a particular organisation but only in general terms. It does not represent a judgment on the attack," Geng said.

His remarks were seen as an attempt by China, without whose endorsement the UNSC statement could not have been released, aimed at placating its close ally Pakistan and play down the indictment of the JeM.

China has been repeatedly blocking India and several other countries' efforts to bring about a global ban on JeM chief Masood Azhar in the UN's anti-terror 1267 committee.

While China's endorsement of the UNSC statement was reflection of wariness on the part of Beijing to repeatedly defend JeM in the UN body, which casts a shadow on its relations with India, observers ary 14, 2019, for which say it is to be seen what Jaish-e-Mohammed has stand Beijing would take when France moves its resolution seeking to list Azhar as a global terrorist in the UN.

> France, also member of the permanent five of the UNSC, has officially

announced that it would move a resolution soon in the 1267 committee seeking Azhar's listing.

Since 2016, China has consistently blocked moves first by India and later by the US, the UK and France to designate Azhar as a global terrorist by putting repeated technical holds.

In his response on Friday Geng said that "China also noted that the Pakistani government showed readiness to cooperate with India on the investigation and that it is also ready to resolve differences with India through dialogue".

"China hopes all parties will work to find the truth about this attack. We hope Pakistan and India will engage in dialogue to jointly safeguard regional peace and stability," he said.

The UN statement also underlined the need to hold perpetrators, organisers, financiers and sponsors of these "reprehensible acts of terrorism" accountable and bring them to justice". The UN condemna-

tion came a day after Pakistan's Permanent Representative to the UN Maleeha Lodhi met top UN leaders including with Secretary-General Antonio Guterres to brief them about the escalating tensions in the region in the wake of the Pulwama attack.

Pak says not concerned over India's plan to stop flow of water

So if they want to use this whether through storing it, through construction of this dam or any other way for their people, they can do as we have nothing to do with it.

But we will definitely express our concerns and raise objections strongly if they use or divert waters of western rivers (Chenab, Indus, Jhelum) on which our right to use prevails, Shumail said.

According to Pakistan's Commissioner for Indus Waters Syed Mehr Ali Shah, as the IWT has already given a right to India in 1960 to use the water of eastern rivers, it is now up to it to do so or not.

Whether they diverted and used their unutilised share of eastern rivers' waters in 1960, we had no problem. They want to do it now, we have no problem. And if they don't want to use this, we have no issue, Shah said.

He said the planned Shahpurkandi dam was actually the stage-2 of the Ranjit Sagar dam. Though this project will also generate power, it will be used for irrigation purposes, he said.

While commenting about the proposed visit of Indian experts (India's commissioner for Indus waters) to Kotri Barrage (in Sindh province) keeping in view the tension between the two countries after the Pulwama attack, Shah said: Let's see what happens in this regard. But we hope for the best.

three-member delegation of Pakistani experts headed by Shah completed its general tour of inspection (from Jan 28 to Feb 1) to various hydropower projects 1,000MW Pakal Dul, 48MW Lower Kalnai, 850MW Ratlay and 900MW Baglihar dam at Chenab Basin in India.


Besides, India, a couple of days before the Pulwama attack, also shared the design data of its three planned runof-the-river hydropower schemes with Pakistan under the IWT. These included Balti Kalan, Kalaroos and Tamasha hvdropower projects which are planned to be constructed at Balti Kalan Nullah and Kalaroos Nullah at the Ihelum basin and Tamasha, a sub-tributary of the Indus river, respectively.

The reiteration to stop the flow of Indus water to Pakistan comes amid mounting Indo-Pak tension over the Pulwama terror strike that has triggered demands for action against the neighbouring country. India has already decided to revoke the Most Favoured Nation status to Pakistan and mounted a diplomatic offensive to isolate it in the international community.

There were demands to stop flow of India's share of Indus water to Pakistan after the Uri terror attack in 2016.

Under the Indus Water Treaty signed in 1960, the waters of the western rivers -- the Indus, Jhelum, and Chenab -- was given to Pakistan and those of the eastern rivers -- the Ravi, Beas, and Sutlej -- to India.

female superhero, a woman director, an origin story **T**in reverse and Nick Fury in a younger avatar, multiple firsts set the forthcoming Captain Marvel, the first movie to release after the death of Marvel creator Stan Lee, apart from the traditional Marvel Cinematic Universe (MCU) entertainers fans have grown up on.

Oscar winning-actress Brie Larson, who has graduated from comedies to independent drama and film franchises, has taken on the powerful role of Carol Danvers aka Captain Marvel in the movie, which marks the first time that MCU has a female superhero as the title character. And making it a reality is Anna Boden, one half of the film's director duo.
