Covid claims one more in Sikkim; Percentage of fully vaccinated eligible population crosses 60

SUMMIT REPORT GANGTOK, 23 SEPT:

ovid claimed a life in Lethe State in the past 24 hours, taking Sikkim's toll to 382. This was the third Covid death recorded in the State thus far this week. Also today, the proportion of fully vaccinated [eligible population] Sikkimese crossed the 60% mark.

Meanwhile, Sikkim's tally of confirmed cases of COVID-19 since testing began on 28 Feb, 2020, reached 31,136 with 62 fresh cases the virus reported in the last 24 hours. Over the same period, there were also 57 Covid patients who made full recoveries and were discharged from home and facility isolation, taking the total number of people who have beaten the virus in Sikkim to 29,798.

Of the 644 currently active cases of Covid-19 in Sikkim, only 57 are with symptoms severe enough to require hospitalization while the rest

are on their way to recovery under home or facility isolation. Of these 57, only seven are under 18 years of age and six are in ICU. Only one of the six in ICU is under 18 years of age.

Clearly, both, infections and hospitalizations have gone down substantially, and what should come as even more reassuring news is that vaccine-coverage has expanded substantially in the State. With the 14,129

doses of Covishield administered on Wednesday [542 first dose and 13,587 second dose], 60.93% of the adult population of Sikkim is now

fully vaccinated. As for the Covid updates from the past 24 hours, the Daily Report of COVID-19 in Sikkim released by the Integrated Disease Surveillance Programme of Health Department this morning, the 62 new cases were picked up from the testing of 640 samples yesterday, giving Sikkim a daily test positivity rate of 9.6%.

While 32 of the new cases were detected in RT-PCR testing of 286 samples, 29 more tested positive in rapid antigen testing of 349 samples and one case was detected in TruNat testing of five samples.

Of the 62 cases, 30 were reported in East District, 18 in West District, 13 in South District and one in North District.

This short children's book, focuses on helping children learn about COVID safety while also helping them understand and process emotions they may be experiencing during these unsettling times. Written by Maren Heiberg, Ajay's COVID Questions is illustrated by Judith Saloni Rai and translated by

Arpana Thapa. Ms Heiberg is a local children's book author whose "The Adventures of Pandi" is available at most bookstores here. When asked about the book, she said, "When I was asked to be involved in this project I was excited to do it. To help children explore their feelings about the pandemic and give them tools to express themselves is extremely important. I loved the concept

of doing it through a story book." Ajay's COVID Questions is set in Darjeeling and tells the story of Ajay who is feeling frustrated by the pandemic and the various changes it has forced on his life. Through sharing with family, he begins to realise it is okay to feel angry and learns that he can find healthier ways to express and deal with all these uncomfortable feelings.

The illustrator, Ms Rai, says this about the project: "I had a good time working on the illustrations in this book. Seeing how Covid has affected us globally as well as locally makes this book very special as it helps us relate to the present situation. I'd like to thank the people concerned for giving

me an opportunity to be a part of this Describing how the concept for the book came about, Catherine Canavan, Project Officer, Tealeaf Mansik Swastha, said: "Our work focuses primarily on promoting children's mental well-being. Since the pandemic began

we have been engaging different mediums through which to support children during this challenging time. We wanted to provide children with their own personal resource which could help them understand and cope with COVID 19. Through this story we hope to convey the message to children that it is okay to feel a lot of different and conflicting emotions while also guiding them on some basic strategies to help manage these emotions in a healthy way."

Tealeaf [Teachers Leading the Frontline] Mansik Swastha is a behavioural health intervention aimed at improving children's mental well-being by task shifting child mental health care to Primary School Teachers.

Arpana Thapa, translator and Project Officer at Tealeaf Mansik Swastha, adds, "For me personally, it was a very important project as there were not many local sources that explained COVID to children in a simple manner. So creating a child friendly story about COVID, and that too in our local language, felt like it was much needed."

This book will be distributed for free among communities that DLR Prerna works in and will be made available to purchase as well, it is informed.

DLR Prerna is a community-based participatory-focused organisation with over two decades of experience partnering with rural communities in the Darjeeling Himalaya addressing issues of equity, sustainable agro-ecology, water and sanitation and community health. Through their partnership with Broadleaf Health and Education Alliance, DLR Prerna have extended their work to engage directly with promoting the health and mental well-being of rural school going children.

2 dead in Assam protests; Man beaten with sticks caught on camera

NEW DELHI, 23 SEPT assess the situation." [NDTV]: Two civilians were killed and nine policemen injured today when an anti-encroachment drive in Assam's Darrang district blew up into a brutal clash between the police and people protesting eviction. On camera, policemen in riot gear and armed with guns and sticks chased and attacked protesters and even firing shots.

In horrifying visuals, a cameraman filming the clash attacked a protester who had earlier followed him with a stick. The protester, beaten by policemen, lay motionless as the cameraman kept attacking him until he was restrained.

Some 800 families were evicted in the drive against encroachments at Dholpur on Monday. The state wants to repossess 4,500 bighas of government land for an agricultural project.

The police said local people attacked them with stones today and they had to use force.

PM CARES "not a government fund", **Prime Minister's Office tells High Court**

NEW DELHI. 23 SEPT [PTI]: The PM CARES Fund is not a Government of India fund and the amount collected by it does not go to the Consolidated Fund of India, the Delhi High Court has been informed.

An affidavit filed by an Under Secretary at the Prime Minister's Office (PMO) who is discharging his functions in the PM Cares Trust on honorary basis, has said the trust functions with transparency and its funds are audited by an auditor - a chartered accountant drawn from the panel prepared by the Comptroller and Auditor General of India.

The affidavit was filed in response to a petition seeking a direction to declare the PM CARES Fund a 'State' under the Constitution to ensure transparency in its functioning.

A bench of Chief Justice DN Patel and Justice Amit Bansal has fixed the matter for further hearing on September 27.

"To ensure transparency, the audited report is put on the official website of the trust along with the details of utilisation of funds received by the trust," says the affidavit filed by Pradeep Kumar Srivastava, Under Secretary at the PM's Of-

"I state that when the petitioner is claiming to be a public-spirited person and seeking to pray for various reliefs only for transparency, it does not matter whether PM Cares is a 'State' within the meaning of Article 12 of the Constitution of India," the officer said in the affidavit.

Irrespective of whether the trust is a 'State' or other authority within the meaning of Article 12 of the Constitution or whether it is a 'public authority' within the meaning of provisions of the Right to Information Act (RTI), it is not permissible to disclose third party information, it added.

It said that all donations received by the trust are received via online payments, cheques or Demand Drafts and the amount received is audited with the audited report and the expenditure of trust fund displayed on the website.

"The trust functions on the principles of transparency and public good Pandemic.

in larger public interest like any other charitable trust and, therefore, cannot have any objection in uploading all its resolutions on its website to ensure transparency," it said, while reiterating that "the trust's fund is not a fund of Government of India and the amount does not go in the Consolidated Fund of India."

The officer said he is discharging his functions in the PM Cares Trust on honorary basis which is a charitable trust not created by or under the Constitution or by any law made by the Parliament or by any State legislature.

"Despite being an officer of the Central government, I am permitted to discharge my functions in PM Care Trust on an honorary basis," he said.

The court was hearing a petition filed by Samyak Gangwal who has said that the PM CARES Fund is a 'State' as it was formed by the Prime Minister on March 27, 2020 to extend assistance to the citizens of India in the wake of the public health emergency - the ongoing COVID-19

NEW DELHI, SEP 23 **(PTI):** Bestselling author Chetan Bhagat on Thursday released the trailer of his upcoming book "400 Days".

The book, published by Westland, is the third story from the Keshav-Saurabh series after "The Girl in Room 105" and "One Arranged Murder". It will be released on October 8.

The trailer, though not cinematic like the previous instalments from the series featuring actor Vikrant Massey, saw Bhagat narrating the plot himself about a missing girl Siya and her mother Alia Arora's determination to find the young girl and seeking help for the same from Keshav Rajpurohit. UNFAIR FARES ON NAMCHI-SILIGURI ROUTE

People travelling by share-jeeps from Namchi to Siliguri continue to be charged the Covid-inflated fares which are not only too high, but also unfair since these are clearly not the authorized rates. The "syndicate" at the Namchi taxi stand has abandoned the passengers and does not maintain a ticket counter for Siliguri and Melli. As a result, passengers need to haggle at the stand, and since only the desperate are travelling to Siliguri in a jeep in these present times, the situation is being exploited and passengers forced to pay Rs 600 for a seat to Siliguri. For Melli, they are made to shell out Rs 300. In Namchi, the drivers claim that the fares have been hiked by the State Government while at the Siliguri stand, drivers insist that local vendors have increased their commission, hence the hiked fares. The hiked fare, for some reason, is being charged only for the Namchi-Siliguri [with Melli on the way] route. Fares for destination elsewhere in Sikkim have reverted to the pre-Covid rates. At the upcoming tourney, 16 hockey playing nations will be vie for the top honours. The state has earlier hosted the senior World Cup in 2018, the FIH World League in 2017 and the Champions

"We look forward to welcoming 16 top teams from across the world to participate in the FIH Odisha Hockey Men's Junior World Cup Bhubaneswar 2021. We are delighted to be hosts of this prestigious tournament. Our priority will be to ensure a safe environment to compete during these challenging COVID times," he added.

FIH chief Batra said Bhubaneswar's good infrastructure will ensure that the tournament will be held smoothly.

PATNA, 23 SEPT [AFP]: A man accused of attempted rape has been given bail on condition that he wash and iron the clothes of all women in his village for six months.

Lalan Kumar, 20, will have to buy detergent and other items needed to provide six months of free laundry services to about 2,000 women in the village of Majhor in Bihar, under the ruling made Wednesday.

It's Everyone's Responsibility

The minors need to kept safe and allowed their childhood

It is not easy to grow inured to issues that demand Lour involvement. We ease into such somnolence after years of consciously looking the other way until we reach a stage where most people prefer to remain silent spectators even when they are witness to obvious maltreatment. We deflect guilt by pretending sympathy at discussions around the dinner table and convincing ourselves that it is not 'proper' to get involved in what transpires beyond our private spaces. Soon, with this distancing sets in indifference, and with that everything that a society stands for starts falling apart. The collapse is already happening all around us and this is because the society is not striving to make things better for the underprivileged and the marginalised. It is in societal impassivity as this that the government has to step in and make specific laws protecting the ignored, marginalized, underprivileged and even children; sections for whom the society should be looking out, but does not. Had the society remained involved, these sections would not have suffered so much that legislations had to be brought in to ensure humanity.

And with that setting up, we segue again into a problem that refuses to get contained. And no, "catching" the culprit, although necessary, is not the same as keeping the children safe. One of the most difficult demands of putting together a newspaper is filing reports about abuse against minors. Apart from the disturbing chore of piecing together details to highlight the level of depravity that made a victim out of a child who has not even begun understanding the life around her/ him, there is the fear of over-sensationalizing the incident in a way that might force the incident and the reaction to it on a tangent that is not necessarily what the situation demands. There is also the worry of underplaying it so much that it trivializes the issue. But that is an uncertainty that challenges journalists; what is that befuddles the society at large so completely that it remains insensate to the trauma of the young victims? It is one of those moments in the process of putting out a newspaper when we regret being the bearers of news [since we have to confront all the gory details] and not receivers [readers do have the benefit of not reading beyond the headline and a sanitized retelling of the incident]. What is even more disturbing is to realize that we continue to fail in keeping our children safe. And make no mistake, this is a societal failing, not a failure of the law and order machinery.

Crimes against minors continue to occur [a few get reported, many get swept under the carpet and too many remain secrets with victims and traumatize them throughout their lives] because Sikkim, as a society, blindsides its children. Secure years while growing up are the least that can be guaranteed to the young, and despite its small size, the society here continues to come up wanting in this regard. The solution is not in lynch mobs to punish the accused, nor even in over-protective cushions created by paranoia. As a society we need to start realizing that children here are in harm's way, as parents and hopefully because we are also responsible citizens, we need to educate the young and ourselves on the ways and means that the young can be kept safe. Child abuse is no longer rare in Sikkim and minors suffer sexual abuse in numbers which are distressing. Still more are denied their basic rights and continue to work as domestic servants in homes across the state, invariably working in conditions which are deplorable.

As per the 2011 Census, there were 64,111 children aged 0-6 in Sikkim. This is also the most vulnerable agegroup when it comes to abuse. Given that Sikkim has a population of 6.11 lakh, this means that there are more than 9 people above the age of six to look out for the minors. Pedophiles form a tiny, very tiny, sliver of this remaining population. And no, it is not being suggested that we form nine-abreast wall of bodyguards around the children, but ensure that these nine are adequately informed about warning signs and wrong behavior and are effectively reassured that when they spy a predator, he will be taken one and taken away.

Long COVID: Double vaccination halves risk of developing long-lasting symptoms

In unvaccinated people, around Lone in 20 who get symptomatic COVID-19 experience symptoms for at least eight weeks. Around one in 50 have symptoms that drag out for three months or more.

We wanted to know whether COVID-19 vaccines might protect against developing long-lasting symptoms. To find out, we looked at data provided by more than a million regular contributors to the COVID Symptom Study, a project in which members of the public log their symptoms via an app to help with research.

Our latest analysis of the study's data, covering around 2 million vaccine doses, shows that vaccines significantly reduce the risk of catching COVID-19, with only 0.2% of those fully vaccinated later testing positive for the virus.

Even if you're unlucky enough to catch the virus after being vaccinated, your chances of falling seriously ill or dying are slashed. Double-vaccinated people are 31% less likely to experience acute COVID-19 symptoms and 73% less likely to be hospitalised – a result that's borne out in the relatively low hospitalisation and death rates we're seeing now even as tens of thousands of people are still testing positive every day in

Reassuringly, for those who did fall ill with COVID-19 after being vaccinated, only around 5% went on to have symptoms that lasted for more than four weeks, meaning their chances of developing long COVID were cut by half. One of the best ways to reduce your risk of getting long COVID is to get fully vaccinated as soon as possible.

However, we did notice that frail older people and those living in more socially deprived areas were more likely to be infected and fall ill

with COVID-19 after being vaccinated, especially if they had only had one vaccine dose. This suggests that we should prioritise further vaccination efforts and public health measures such as masking and social distancing among these groups, especially where infection rates are high and people are mixing and moving around.

VACCINES AND LONG COVID

As the UK vaccination programme rolled out, we also started to notice anecdotal reports from people living with long COVID that their symptoms seemed to improve after being vaccinated.

The patient-led LongCovidSOS group chose to investigate this by surveying over 800 long COVID patients early in 2021. More than half of those surveyed noticed an overall improvement in their symptoms after vaccination, which then appeared to be sustained in about half of this group. Around a quarter of the overall respondents reported no difference and one-fifth said their symptoms had got worse. These findings have been released as a preprint, so haven't yet been reviewed by other scientists, but they've been backed up by data from the COVID Symptom Study, which we'll be publishing soon.

However, while there does seem to be some kind of link between receiving a COVID-19 vaccine and improvements in long COVID, it's not clear exactly how the two are connected. It could be that the immune response triggered by the vaccine has a direct impact on symptoms.

Alternatively, it could just be that time has continued to pass since these people were originally infected and they're experiencing a natural recovery from the virus. Or it could be a bit of both. Either way, more research is needed to tease out what's going on.

What we can say is that



COVID-19 vaccines certainly aren't harmful for people with long COVID. What's more, because we know that it's possible to be reinfected with the virus, there's a risk that catching it a second time could exacerbate symptoms for people living with long COVID and set them back even further. It's therefore vital that we encourage anyone with long COVID who has not been vaccinated to do so as soon as possible, to help protect themselves and those around

A SERIOUS THREAT

Although the chances of developing long COVID after being vaccinated are small, this is a numbers game and a small percentage of a big number can still be substantial. As long as we are seeing tens of thousands of cases every day, we can still expect to see a substantial number of people living with lingering

symptoms over the coming months.

This is particularly important for younger people, who may be less worried about hospitalisation or death, yet who can still be susceptible to the debilitating long-term effects of the virus. A lot can happen in a few months when you're young, and long COVID can mean that people miss out on life-changing opportunities, like sitting an exam or taking up a new job, as well as the social activities that bring joy and wellbeing to life.

We'll probably all be living with COVID-19 for some time to come. But with a combination of vaccination and public health measures where necessary, we can help to make sure that as few people as possible have to directly live with its life-limiting long-term effects.

Work-Life Balance: What really makes us happy might surprise you

 $F_{\text{no}}^{\text{inding the right work-life balance is by}}$ But the tension between the two has been heightened by the pandemic, with workers increasingly dwelling over the nature of their work, its meaning and purpose, and how these affect their quality of life.

Studies suggest people are leaving or planning to leave their employers in record numbers in 2021 - a "great resignation" that appears to have been precipitated by these reflections. But if we're all reconsidering where and how work slots into our lives, what should we be aiming at?

It's easy to believe that if only we didn't need to work, or we could work far fewer hours, we'd be happier, living a life of hedonic experiences in all their healthy and unhealthy forms. But this fails to explain why some retirees pick up freelance jobs and

some lottery winners go straight back to work. Striking the perfect work-life balance, if there

is such a thing, isn't necessarily about tinkering with when, where and how we work - it's a question of why we work. And that means understanding sources of happiness that might not be so obvious to us, but which have crept into view over the course of the pandemic.

Attempts to find a better work-life balance are well merited. Work is consistently and positively related to our wellbeing and constitutes a large part of our identity. Ask yourself who you are, and very soon you'll resort to describing what you do for work.

Our jobs can provide us with a sense of competence, which contributes to wellbeing. Researchers have demonstrated not only that labour leads to validation but that, when these feelings are threatened, we're particularly drawn to activities that require effort – often some form of work - because these demonstrate our ability to shape our environment, confirming our identities as competent individuals.

Work even seems to makes us happier in circumstances when we'd rather opt for leisure. This was demonstrated by a series of clever experiments in which participants had the option to be idle (waiting in a room for 15 minutes for an experiment to start) or to be busy (walking for 15 minutes to another venue to participate in an experiment). Very few participants chose to be



busy, unless they were forced to make the walk. or given a reason to (being told there was chocolate at the other venue).

Yet the researchers found that those who'd spent 15 minutes walking ended up significantly happier than those who'd spent 15 minutes waiting - no matter whether they'd had a choice or a chocolate or neither. In other words, busyness contributes to happiness even when you think you'd prefer to be idle. Animals seem to get this insitinctively: in experiments, most would rather work for food than get it for free.

EUDAIMONIC HAPPINESS

The idea that work, or putting effort into tasks, contributes to our general wellbeing is closely related to the psychological concept of eudaimonic happiness. This is the sort of happiness that we derive from optimal functioning and realising our potential. Research has shown that work and effort is central to eudaimonic happiness, explaining that satisfaction and pride you feel on completing a gruelling task.

On the other side of the work-life balance stands hedonic happiness, which is defined as the presence of positive feelings such as cheerfulness and the relative scarcity of negative feelings such as sadness or anger. We know that hedonic happiness offers empirical mental and physical health benefits, and that leisure is a great way to pursue hedonic happiness.

But even in the realm of leisure, our unconscious orientation towards busyness lurks in the

background. A recent study has suggested that there really is such a thing as too much free time - and that our subjective wellbeing actually begins to drop if we have more than five hours of it in a day. Whiling away effortless days on the beach doesn't seem to be the key to long-term hap-

piness. This might explain why some people prefer to expend significant effort during their leisure time. Researchers have likened this to compiling an experien-

tial CV, sampling unique but potentially unpleasant or even painful experiences - at the extremes, this might be spending a night in an ice hotel, or joining an endurance desert race. People who take part in these forms of "leisure" typically talk about fulfilling personal goals, making progress and accumulating accomplishments – all features of eudaimonic happiness, not the hedonism we

associate with leisure. THE REAL BALANCE

This orientation sits well with a new concept in the field of wellbeing studies: that a rich and diverse experiential happiness is the third component of a "good life", in addition to hedonic and eudaimonic happiness.

Across nine countries and tens of thousands of participants, researchers recently found that most people (over 50% in each country) would still prefer a happy life typified by hedonic happiness. But around a quarter prefer a meaningful life embodied by eudaimonic happiness, and a small but nevertheless significant amount of people (about 10-15% in each country) choose to pursue a rich and diverse experiential life.

Given these different approaches to life, perhaps the key to long-lasting wellbeing is to consider which lifestyle suits you best: hedonic, eudaimonic or experiential. Rather than pitching work against life, the real balance to strike post-pandemic is between these three sources of happiness.

Bhabanipur bypoll case: HC allows EC to file affidavit

KOLKATA, SEP 23 (PTI): The Calcutta High Court on Thursday allowed the Election Commission (EC) to file an affidavit regarding the contents of the notification issued by it for the Bhabanipur bypoll.

The court was hearing public interest litigation that urged it to step into the poll process in the constituency, as the EC allegedly mentioned that a constitutional crisis would arise if the by-election to Bhabanipur was not held, which the petitioner claimed the poll body cannot.

The advocate representing the EC sought a short adjournment to file an affidavit regarding the contents of two paragraphs of the notification issued for the election, in view of the arguments raised by Bikash Bhattacharya, the senior counsel for the petitioner.



A division bench comprising Acting Chief Justice Rajesh Bindal and Justice Rajarshi Bharadwaj adjourned the hearing in the PIL till Friday when it will be taken up again.

The West Bengal government had during an earlier hearing on September 13. submitted that the chief secretary of the state had only that the bypoll be held and the commission had accepted the request.

It had submitted that the state has no role in the decision to hold the bypoll and that it is the sole preserve of the

Bypoll to Bhabanipur was necessitated following the resignation of Trinamool Congress MLA Sovandeb Chattopadhyay to written to EC, requesting facilitate Chief Minister Mamata Banerjee's election to the assembly.

Banerjee lost in Nandigram, as per the results of the assembly election declared by the EC in Мау.

COVID-19 recoveries surpass fresh cases in West Bengal

KOLKATA, SEPT 23 (PTI): Single-day recoveries in West Bengal on Wednesday outnumbered fresh COVID-19 cases by four, as the coronavirus tally in the state increased to 15,63,393, a health de-

partment bulletin said. The state now has 7,724 active cases, while 15,36,978 people have recovered from the disease, including 687 since Tuesday.

Thirteen more COVID-19 deaths were reported in the state, as the toll mounted to 18,691.

Of the fresh fatalities, five were registered in North 24 Parganas district, three each in Kolkata and Howrah, and one each in

Hooghly and Nadia, it said. The state logged 683

Odisha logs 644 new COVID-19 cases, 7 fresh fatalities



BHUBANESWAR, SEP 23 (PTI): Odisha Thursday reported 644 new COVID-19 cases, including 72 children, taking the tally to 10,22,594 while seven fresh fatalities pushed the coronavirus death toll to 8,157, a health department official said.

The new cases were detected in 24 of the state's 30 districts, with 375 reported from different quarantine centres while the remaining 269 were local contact cases.

Khurda district of which the state capital Bhubaneswar is a part reported the highest 283 new cases followed by Cuttack (77) and Balasore (34). The new cases included 72 children and adolescents whose rate of infection stands at 11.18 per cent, he said.

INDIAN WELLS, SEP 23 (AP): Naomi Osaka pulled out of the BNP Paribas Open, a move that was expected after she indicated following her U.S. Open loss this month that she planned to take another extended break from tennis.

The withdrawal was announced by the official Twitter feed for the hard-court tournament at Indian Wells, which is scheduled for Oct. 4-17 after twice being delayed during the coronavirus pandemic.

Osaka is a four-time Grand Slam champion who has been ranked No. 1 and is currently No. 8.

She last played at the U.S. Open, where her title defense ended with a third-round loss to eventual runner-up Leylah Fernandez on Sept. 3.

After that defeat,

Osaka said: I honestly don't know when I'm going to play my next tennis match.

Osaka, a 23-year-old who was born in Japan and now is based in the U.S., took time off earlier this season, a mental health break that began when she withdrew from the French Open before her second-round match. She also sat out Wimbledon, then returned for the Tokyo Olympics, where she lit the cauldron during the opening ceremony.



Fears of global shockwaves from Chinese builder's debts ease

BEIJING (AP): Fears that a Chinese real estate developer's possible default on multibillion-dollar debts might send shockwaves through global financial markets appeared to ease Thursday as creditors waited to see how much they might recover.

Shares of Evergrande Group, one of China's biggest private sector conglomerates, rose 18% in Hong Kong after the company said it would pay interest to bondholders in China.

The company gave no sign whether it would make a payment due Thursday on a separate bond abroad.

Evergrande's struggle has raised fears it might destabilize China's financial system and set off a global chain reaction. But economists said while Chinese banks and other creditors are likely to suffer losses, there appeared to be little way a default on its 2 trillion yuan (\$310 billion) in debt would hurt the Chinese system or feed through to financial markets abroad.

"It's definitely a local problem in China," said Robert Carnell, head of Asian research for ING.

"There will be some suppliers and others who will go bust," Carnell said. "But it's not systemic in a sense that I can put my finger on."

Chinese regulators have yet to say what Bei-



jing might do. But despite that, plus uncertainty about how much banks and individual buyers of Evergrande's bonds might lose, stock markets appeared to recover from anxiety that caused Chinese stocks to tumble on Monday.

China's benchmark Shanghai Composite Index closed 0.4% higher on Thursday. Hong Kong's Hang Seng rose 1.2%. Markets in Australia and Southeast Asia, where economies depend heavily on trade with China, also rose.

Markets are "in a worst is over frenzy" after Evergrande's promise to pay bondholders, said Jeffrey Halley of Oanda, in a report.

Evergrande was caught by tighter restrictions on borrowing imposed by Chinese regulators last year in a campaign to reduce the economy's reliance on surging debt. The company has sold billions of dollars of assets to meet government limits.

Evergrande's billionaire founder, Xu Jiayin, has expressed confidence the company will survive, but it has yet to announce a plan for repaying debtors.

That includes an \$83.5 million payment due Thursday to buyers abroad of a U.S. dollar-denominated bond. The company has a month to pay before it would be declared in default.

Economists say any government action is likely to focus on protecting Chinese families that paid for apartments that are yet to built, rather than on bailing out banks or other cred-

Beijing has resources to prevent a Chinese credit crunch if Evergrande defaults. But it doesn't want to appear to organize a bailout while it tries to force others to cut debt, economists say. The ruling Communist Party worries surging debt that piled up during China's boom years might cause problems as economic growth slows.

shareholders, Chinese Estates Holdings Ltd., announced it sold part of its stake at a loss and might sell its remaining 5.66% of the company. Chinese Estates said it took a 1.4 billion Hong Kong dollar (\$177 million) loss.

Evergrande's debt problems come at a time when Chinese economic growth is forecast to weaken due to a slowdown in construction and home sales due to government pressure on the real estate industry to reduce reliance on borrowed money.

On Thursday, Fitch Ratings cut its growth forecast for China this year to 8.1% — still biggest among the world's strongest — from 8.4%, citing the real estate slowdown.

Meanwhile, Global Ratings downgraded the debt of a smaller Chinese developer, Xinyuan Real Estate Co., which has delayed releasing 2020 results. S&P said Xinyuan, which has shares traded on the New York Stock Exchange, faces "refinancing difficulty" that will make it harder to service \$229 million in debt due to lenders abroad in October.

Hundreds of smaller Chinese developers have gone bankrupt since Beijing started tightening financial controls on the industry in 2017.

Some commentators suggested Evergrande might become a "Lehman moment," invoking the 2008 collapse of Wall Street bank Lehman Brothers ahead of the global crisis. But economists say Evergrande's debts are relatively simple compared with those of a Wall Street bank and appear unlikely to set off a chain reaction.

Evergrande's debt is the equivalent of as much as 2% of China's annual economic output, but economists say the stateowned banking industry can absorb a possible default.

"There will be some banks exposed," said ING's Carnell. "The big ones can cope. The small ones don't matter."

Woman with Down syndrome loses UK abortion law challenge

LONDON (AP): A woman with Down syndrome lost a court challenge against the British government Thursday over a law allowing the abortion up until birth of a fetus with the condition.

Heidi Crowter, 26, and two others took the Department of Health and Social Care to court, arguing that part of the Abortion Act is discriminatory and violates the European Convention on Human Rights.

Abortions in England, Wales and Scotland are allowed up till 24 weeks of pregnancy. But the law states that terminations can be allowed up until birth if there's "a substantial risk that if the child were born it would suffer from such physical or mental abnormalities as to be seriously handicapped," which includes Down syndrome.

Crowter has said that she found the legislation "offensive" and disrespectful, and that she wanted to change the law to challenge people's perception of Down syndrome.

"By allowing babies with (Down) syndrome to be aborted up to birth, unlike neurotypical babies, the law sends a powerful message that the lives of people with (Down) syndrome are of lesser value," he said.

The Associated Press, he admitted that replacing a political appointee who quit after only three months was "intimidat-

At the time, Portugal was in the worst phase of the pandemic, when it was among the hardest-hit countries with public hospitals near col-

lapse. Promised vaccine deliveries weren't arriving. And jockeying for shots was threatening to undermine public trust in the rollout.

"I felt like I had the eyes of 10 million people on me," Gouveia e Melo said, referring to Portugal's population.

His 42-year military career helps explain how he handled the pressure.

He was a submarine commander, and at one point was in charge of two of the vessels at the same time -- returning to base with one, eating a meal on shore and then taking another out to sea.

Gouveia e Melo also captained a frigate, led Euromarfor, the European Union's Maritime Force, and has logged the most hours at sea of any serving Portuguese naval

He is unapologetic about couching the vaccine rollout as a battle and has worn combat fatigues ever since taking over the effort. He said he wanted to send a message that it was a call to

"This uniform ... was symbolic for people to comprehend the need to roll up our sleeves and fight this virus," he says. Gouveia e Melo did

away with Portugal's initial efforts to piggyback on established vaccination strategies, such as those used annually for flu shots in usually small, public health centers. The demands of scale and speed to address COVID-19 required very different approach.

Portugal began using large sports facilities around the country to set up what Gouveia e Melo called a "production line": a reception and processing area; a waiting room; cubicles where injections are given; and a recovery area. He used soldiers as guinea pigs at the Lisbon military hospital to figure out the fastest flow of people through a building. A major push came

with what he described as a "tsunami" of vaccine deliveries in mid-June, which allowed a shift into a higher gear.

Tiago Correia, an associate professor in international public health at Lisbon's New University Institute of Hygiene and Tropical Medicine, reckons that the public view of Gouveia e Melo as the principal factor in the successful rollout is an "exaggeration" of his

A key factor, Correia says, is the traditional consenting attitude in Portugal toward national vaccination programs. Its vaccination rate for measles, mumps and rubella, for example, is 95% -- one of the EU's highest - and there is no signifanti-vaccination icant movement.

Even so, Gouveia e Melo's military background meant he was able to "cut through all the politics" and ensure public trust in the rollout, Correia told AP. These days, Gouveia

e Melo is often greeted with spontaneous applause from the public when he visits vaccine centers and poses for selfies. He has been the subject of TikTok videos and poems.

Framed on the wall behind his desk is a drawing given to him by a child who wrote "Obrigado" — "Thank you" — in capital letters. On a visit Tuesday to a

vaccine center at the Lisbon University campus, Gouveia e Melo strode around in his combat fatigues and handed out a cloth crest he designed for the rollout to those waiting for their shots. The emblem, worn by many in the effort, depicts a three-headed hydra lunging at two virus cells, with a green border representing the more than 4,700 people who have worked at Portugal's vaccine centers.

Claudia Boigues, a 53-year-old waiting in the recovery area with her 15-year-old son who had just been vaccinated, said she marveled at the swift rollout.

Gouveia e Melo will soon be able to say "mission accomplished" for his immediate goal. But with significant vaccination hesitancy in some wealthier countries and many poorer countries without sufficient doses, he's under no illusion that virus variants could come back to torment Portugal.

"We've won a battle," he says. "I don't know if we've won the war against the virus. This is a world war."



Cancel culture is so far out of hand now that no one is safe: Johnny Depp

LOS ANGELES, SEP 23 (PTI): Embattled Hollywood star Johnny Depp said he is a victim of cancel culture and that "no one is safe" any more.

Depp addressed a press conference at the San Sebastian Film Festival on Wednesday where he was scheduled to receive the honorary Donostia Award, reported Deadline.

"It can be seen as an event in history that lasted for however long it lasted, this cancel culture, this instant rush to judgement based on what essentially amounts to polluted air," he said ahead of receiving the honour.

Cancel culture or call-out culture is a modern form of ostracism in which someone is thrust out of social or professional circles.


"It's so far out of hand now that I can promise you that no one is safe. Not one of you. No one out that door. No one is safe. It takes one sentence and there's no more ground, the carpet has been pulled. It's not just me that this has happened to, it's happened to a lot of people. This type of thing has happened to women, men. Sadly at a certain point they begin to think that it's normal. Or that it's them. When it's not," he added.

Last year, when Depp lost the high-profile libel case with a UK tabloid over its branding of him as a "wife-beater", the actor was dropped from the "Fantastic Beasts 3", the multimillion film franchise from Warner Bros. Mads Mikkelsen replaced him as dark wizard Gellert Grindelwald in the film titled "Fantastic Beasts: The Secrets of Dumbledore", slated to be released in April.

Depp also has a whopping USD 50 million defamation lawsuit against former wife, actor Amber Heard scheduled to go to trial in the US next year. "Aquaman" star Heard is pursuing a USD 100 million counterclaim.

"It doesn't matter if a judgement, per se, has taken some artistic license. When there's an injustice, whether it's against you or someone you love, or someone you believe in stand up, don't sit down. 'Cause they need you," Depp said in what appeared to be a reference to his legal troubles.

One of the members of the press attending the conference addressed the criticism of the festival for handing Depp a Donostia, particularly from Spain's Association of Female Filmmakers and Audiovisual



Media, which released a statement saying the award "transmits a terrible message to the public".

Before the actor could respond, the host of the event rejected the question out of hand and told the media to stick to questions about his career.

Depp later admitted he was concerned that his presence at the festival this year "would offend people" and that he "didn't want to offend anyone". He praised the event, its director Jose Luis Rebordinos, and the mayor of San Sebastian for their "undying support". "I haven't done anything, I just make movies," Depp added.

Asked about his views on Hollywood in recent years, the actor said the showbiz has "grotesquely underestimated the audience".

"Hollywood is certainly not through Saturday.

Nigeria-born designer Joy Meribe opens Milan Fashion Week

MILAN, SEP 23 (AP): Nigeria-born designer Joy Meribe opened Milan Fashion Week on Wednesday with her debut runway collection, a concrete success for a movement to promote diversity in Italian fashion just a year after launch-

The Italian National Fashion Chamber tapped Meribe to open six days of womenswear previews for Spring-Summer 2022 after her inaugural collection for the We are Made in Italy initiative last year found commercial success.

Beyond whatever video, proclamation or manifesto that we make, the real test is whether clients buy your products. Joy passed that exam,' said Italian-Haitian designer Stella Jean, who helped launch the initiative in the summer of 2020, asking the question, Do Black Lives Matter in Italian Fashion? inspired by the U.S. movement and following racists gaffes by major Italian fashion houses.

It wouldn't have been so quick, if there wasn't an acceleration from the United States,' said Jean, who basked in the early achievement in the front row alongside Italy-based U.S.-born designer Edward Buchanan and Afro Fashion Week Milano founder Michelle Ngonmo.

Meribe broke down in tears after the show as she thanked the fashion chamber and the movement's founders for getting her to the runway.

The collection featured tiered and ruffled skirts and jackets with built-in capes that were both regal, as seen in an off-shoulder dress sweeping the ground, and hip, including a mini day-dresses

and shoulder-baring tunic. Textiles were an explosion of bright yellow against an aqua blue, with tropic prints featuring thatched cottages against flourishing banana trees, which Meribe said was meant to celebrate a return to more normality.

We have passed from a dark moment, and I wanted to create something full of hope and light, the joy of restarting,' she said backstage.

The initiative that launched Meribe opened its second edition this fashion week, an all-female group of designers working in Italy with roots in Togo, Morocco, Haiti, Cuba and India, following last year's Fab Five inaugural class of all African-born designers.

There is movement happening,' said Buchanan, the American designer behind the Sansovino 6 label. Of course everything takes time, but it takes somehow an industry to get used to the idea that these are talents like any other.

To point, they have created a database of more than 3,000 fashion professionals with diverse racial and ethnic backgrounds living in Italy, including designers, merchandisers, photographers and stylists, with the aim of putting to rest the notion that diverse talents weren't available in Italy.

Zineb Hazim designed a line of business wear for abaja-wearing Muslim women, using European plaids on the long garments, which were double-sided to extend a business traveler's ward-

Fallylah Nyny Ryke Goungou sourced woven fabrics from her native Togo in western Africa for looks inspired by her love of Japan and know-how in her adopted Italy. Romy Calzado, a former textile designer born in Cuba, created a collection with honeycomb graphic elements on fabrics with anti-viral properties, while Sheetal Shah, originally from India, designed an all-denim collection from textiles treated to resist water and wear longer.

But even while marking progress on diversity being made in the industry, organizers said that a racist incident at a four-star hotel in Milan aimed at this year's Fab Five underlined the work still

Ngonmo said that she was checking into the hotel with the five women when the desk clerks rudely dismissed routine requests by paying guests, indicating that they didn't belong there.
