With 35 New cases, Sikkim's active COVID count rises to 226

SUMMIT REPORT GANGTOK, 20 JUL:

Sikkim's tally of coronavirus cases has crossed 300-mark on Monday with 35 fresh cases being detected across the State. With these 35 new cases, the total of numbers COVID-19 positive cases reported in Sikkim thus far has climbed to 318, of which 226 are still active cases. 92 people have made full recoveries and have been discharged from hospital while two have migrated out. On Sunday, two more people beat the virus and were discharged.

In his daily health bulletin on Monday, Health Department Secretary, Dr Pempa T Bhutia, informed that 111 samples were tested through RT-PCR at the VRD Lab at STNM Hospital on Sunday from which two returnees currently in quarantine tested positive.

He informed that while one person was quarantine at a paid facility, the other was currently admitted at the Triage facility after developing symptoms.

Meanwhile, 883 people were screened through Rapid Antigen Testing yesterday

at Rongli, Rangpo, Mamring and Timberbong, most of them primary contacts from the Rangpo funeral from where the first case was detected on 18 July and the remaining at risk of exposure because of their proximity to the GREF camp at Rong-

At Rangpo, 14 tests returned positive, nine at Mamring, two at Timberbong and seven at Rongli.

Testing was also being held at Chan-ready started contact tracing of these

atar near Rangpo today and the time of filing this report, three positive cases had been detected. These will be included in tomorrow's count.

Of the nine cases detected at Mamring, the Health Secretary shared that two were cause for special concern since one worked at the Wai Wai the other at Zydus pharma unit.

He informed that teams have al-

Dr Bhutia added that 70 samples of contacts of police personnel from Singtam, which includes 40 primary contacts of the cops and 22 from Singtam PS and eight from Singtam Fire Station personnel, have all returned negative.

He informed that out of Rapid Antigen Testing of 412 samples at Rongli in East Sikkim seven reported positive while RAT of 243 samples at Rhenock, contacts of positive patient from Golden Cross company, tested negative.

Also on Sunday, a driver from Sangkhola, who was brought to the flu clinic at STNM hospital tested positive through TrueNat screening. However, he added that primary contact of the driver has tested negative and testing of three more contacts will be carried out after seven days.

Meanwhile, testing of 12 persons from two teams of catering at Rangpo Transit Camp for drivers was carried out this morning and two tested positive, he informed. He mentioned that seven

were shifted to STNM hospital after developing symptoms.

"Many people have been coming to us for rapid antigen testing but it is important to note that to test after six days of any exposure would be more effective and accurate," the Secretary said further.

Meanwhile, Dr Bhutia informed that the indoor gymnasium hall at Paljor Stadium has been finalized to lodge asymptomatic patients and STNM hospital kept exclusively for symptomatic patients.

Likewise, he added that other facilities have also been identified in case of any emergency in the State.

He mentioned that the decision has been taken to use the old STNM hospital complex for routine OPDs and directions have been given to get the complex ready. He further mentioned that a decision has also been made to create a War Room and a control room at STNM hospital and MS and AMS of the hospital have already been directed patients at Chujachen isolation facility to immediately take necessary steps.

GANGTOK, 20 JUL:

With a sudden spike in COVID cases in the State and recognizing the apprehension in the minds of the people, the State Government today decided to put the entire state under lockdown starting 21 July

The "complete lockdown" will see all shops, offices and business closed. Like always, emergency services and shops selling essential commodities and food items will be allowed to remain open even as all normal vehicles, including taxis, will remain off the roads.

In an additional order issued after the original notification ordering the lockdown, the Chief Secretary exempted pharmaceutical companies from the purview of the lockdown. While pharma units outside the containment zones can continue operations with minimum required staff brought to work ensuring social distancing, those in the containment zone will have to bring in the required personnel and lodge them at the factory for the duration of the containment orders.

The notification on the lockdown also informs that educational institutions in the State will now remain closed at least till 31 August.

West Bengal banks to remain closed on all Saturdays

KOLKATA, JUL 20 (PTI): In view of an increasing number of bank employees getting infected by coronavirus, the West Bengal government on Monday directed that all bank branches in the state will remain closed on Saturdays.

Presently, the banks remain closed only on second and fourth Saturdays and all Sundays.

" the Governor is pleased to declare that all Saturdays shall be public holidays under the Negotiable Instruments Act, 1881 in respect of all bank branches working in the State of West Bengal, in addition to the existing holidays on 2nd and 4th Saturdays," the finance (audit) department said in a notification.

"This will take immediate effect and will remain in

force until further notification," it said. Over 2,000 employees of state-run and private banks of West Bengal have been affected by COVID-19, All India Bank Officers Confederation (AIBOC) state

secretary Sanjay Das said. Earlier in the day, the information and cultural department issued an advisory to the banks urging them to close branches on all Saturdays and Sundays and

Incomplete information results in Jholungey residents blocking access to pharma buses

NAMCHI, 20 JUL:

The residents of Jholungey in ■ South Sikkim, a short distance above Mamring, the town on the East-South district border, made headlines early Monday morning when they came out in strong numbers and refused buses ferrying pharma company employees to pass.

They were going by a government notification of Saturday which had declared their area a containment zone and directed that people remain indoors and that all shops and factories in the area be shut.

Only the previous day, people in the area had been allowed by officials to barricade entry points to the district at the Mamring bridge and at the bridge for pedestrians

at 20 Mile to block access. These areas were contained because they were uncomfortably close to the Rangpo which has been building up to be a hotspot.

In fact, when one of the barricades was taken down by some people, block officials had arrived at the spot on Saturday evening to help reinforce it.

The people went to bed convinced that the containment zone was to remain watertight to people from "outside." Hence, when pharma buses arrived, they came out and stopped them.

They were not completetion. Apparently, after the notification directing all businesses to remain closed had been passed, the district administration,

sources inform, issued another notification exempting pharma units for 72 hours. Apparently, medicines already in the process of being made needed this much time to become finished products. Shutting the factories down would mean that the entire batch would go to waste.

Word of this exemption had however not been passed down and resulted in the situation which required senior officials from police and the district administration to come down. Bengal announces 2-day lockdown every week

COVID-19 has been recorded in a few areas in West Bengal, the Mamata Banerjee government on Monday announced a complete lockdown across the state for two days every week to stem the spread of the disease.

The decision was taken following a high-level meeting, chaired by Chief Minister Mamata Banerjee, at the state secretariat, Home Secretary Alapan Bandyopadhyay said.

"There are a few places in the state where community transmission of COVID-19 has been detected. After talking to ex-

ment authorities, and the police, we have decided to impose complete lockdown for two days every week in the entire state to break the chain (of transmission)," he told reporters at the secretar-

All offices, transport services will be shut down on those two days, he said.

"This week, the total lockdown will be in force on Thursday and Saturday. Next week, the shutdown will be clamped on Wednesday (July 29)," the home secretary said adding that a review meeting will be held next Monday for further discussions on the matter.

Record single-day spike of 40,425 COVID-19 cases; India's tally crosses 11 lakh

NEW DELHI, JUL 20 (PTI): India saw a record single-day jump of 40,425 COVID-19 cases, pushing its tally past the 11-lakh mark on Monday, while the total number of recoveries crossed 7 lakh, according to the Union Health Ministry

that the total number of COVID-19 cases stands at 11,18,043. India's COVID-19 tal-

ly crossed the 11-lakh mark, just three days after it crossed the tenlakh mark. There are 3,90,459

active cases in the country, while 7,00,086 people have recovered and one person has migrated. The recovery rate stands at 62.61 per cent.

The total number of confirmed cases includes foreigners.

This is the first time that the single-day spike has crossed the 40,000-mark.

of 1,40,47,908 samples have been tested up to Iuly 19 with 2.56.039 samples being tested on Sunday.

Of the 681 deaths reported in the last 24 hours, 258 were reported from Maharashtra. 91 from Karnataka, 78 from Tamil Nadu, 56 from Andhra Pradesh, 38 from Uttar Pradesh, 36 from West Bengal, 31 from Delhi, 20 from Gujarat and 15 from Madhya Pradesh.

The total fatalities in one day include nine from Bihar, eight each from Punjab and Jammu and Kashmir, six each from Rajasthan and Telangana, five each from Haryana and Odisha, four from Assam, three from Jharkhand, two from Kerala, and one each from Goa and Ladakh.

Of the total 27,497 deaths reported so far, Maharashtra accounted for the highest 11,854 fatalities followed by Delhi with 3,628 deaths, Tamil Nadu 2,481, Gujarat 2,142, Karnataka 1,331, Uttar Pradesh 1,146, West Bengal 1,112, Madhya Pradesh 721 and Andhra Pradesh 642.

So far, 559 people have died of COVID-19 in Rajasthan, 415 in Telangana, 349 in Harvana, 254 in Punjab, 244 in Jammu and Kashmir, 217 in Bihar, 91 in Odisha, 57 in Assam, 52 in Uttarakhand, 49 in Jharkhand and 42 in Kerala.

Puducherry has registered 28 deaths, Chhattisgarh 24, Goa 22, Chandigarh 12, Himachal Pradesh 11, Tripura 5, Arunachal Pradesh 3, while Meghalaya, Dadra and Nagar Haveli and Daman and Diu, and Ladakh have reported two fatalities each.

The Health Ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

Maharashtra has reported the highest number of cases at 3,10,455 followed by Tamil Nadu at 1,70,693, Delhi at 1,22,793, Karnataka at 63,772, Gujarat at 48,355, Uttar Pradesh at 49.247. Andhra Pradesh at 49,650 and Telangana at 45,076.

The number COVID-19 cases has gone up to 42,487 in West Bengal, 29,434 in Rajasthan, 26,164 in Haryana, 26,569 in Bihar, 23,999 in Assam and 22,600 in

Madhya Pradesh. Odisha has reported 17,437 infections, Jammu and Kashmir 13,899, Kerala 12,480, while Puniab has 10.100 cases.

A total of 5.535 have been infected by the virus in Jharkhand, 5,407 in Chhattisgarh, 4,515 in Uttarakhand, 3,657 in Goa, 2,878 in Tripura, 1,999 in Puducherry, 1,911 in Manipur, 1,483 in Himachal Pradesh and 1,178 in Ladakh.

Nagaland has recorded 988 COVID-19 cases, Chandigarh 717, Arunachal Pradesh 740 and Dadra and Nagar Haveli and Daman and Diu together have reported 605 cases.

Meghalaya has reported 450 cases. Mizoram 284, Sikkim has registered 283 infections so far, while Andaman and Nicobar Islands has recorded 203 cases.

"Our figures are being reconciled with the ICMR," the ministry said, adding, state-wise distribution is subject to further verification and reconciliation.

AP hikes tax on petrol, diesel to mop up revenue AMARAVATI, JULY 20

(PTI): Citing resource crunch, the Andhra Pradesh government on Monday revised the tax structure on petrol and diesel, thereby increasing their prices by Rs 1.24 and Rs 0.93 per litre respectively to mop up an additional revenue of about Rs 600 crore per

annum. As per the new structure, issued vide a Government Order amending the provisions of Andhra Pradesh Value Added Tax Act, 2005, the revised rates for petrol and diesel will be 31 per cent (tax) plus Rs 4 (additional levy) and 22.25 per cent plus Rs 4 per litre respectively.

The states own resources have totally dried up because of reduction in revenues on account of the (Covid-19-imposed) lockdown. In April 2020, the state's own revenues realised were only Rs 1.323 crore as against Rs 4,480 crore in April 2019, which was just 29.5 per cent of the total expected revenue.

"Similar trends were observed in May and June as well, Special Chief Secretary (Revenue) Rajat Bhargava said in the order.

Under these circumstances and in order to overcome the financial crisis, the government after due consideration decided to revert to the earlier tax regime prevailing between 2015 and 2018.

We are also ensuring that the overall rates do not exceed those prevailing between 2015 and 2018. Several states are facing a similar situation and they too made upward revision of taxes to offset the loss of revenue, Rajat Bhargava said.

Arrested animal rights activist being brought to Kohima

KOHIMA, JUL 20 (PTI): Mumbai-based Animal rights activist Hema Chaudhary, arrested by Nagaland Police for allegedly making objectionable remarks against the people of the state, would be brought to Kohima late on Monday night, officials said.

Choudhary had made the alleged remarks in a YouTube vid-

eo following which an offence was registered against her by the cybercrime police station in Nagaland.

She was charged with promoting enmity between different groups, making imputation prejudicial to national- integration and issuing statements conducing to public mischief.

She was arrested from her Mumbai home on Friday.

The state police team along with the accused landed in Imphal from Mumbai and they are coming to Kohima by road from the Manipur capital, officials

On reaching Kohima, swab samples of the members of the police team and Choudhary would be collected for COVID-19 tests.

She would be put up in a COVID-19 quarantine lock-up, and the police officers who had gone to arrest her would also stay within the quarantine complex, they said adding that Chaudhary would be produced before a court by Tuesday.

Sebi comes out with guideline to verify upfront collection of margins

NEW DELHI, JUL 20 (PTI): Markets regulator Sebi on Monday released framework to enable verification of upfront collection of margins from clients in cash and deriv-

atives segments. The new framework will come into effect from December 1, 2020, the Securities and Exchange Board of India (Sebi) said in a circular.

The regulator has reiterated that the applicable upfront margins will be collected from the clients in advance of the trade.

Sebi said clearing corporations will send minimum four snapshots of client wise margin requirement to trading member (TM) or clearing member (CM) for them to know the intra-day margin requirement per

client in each segment. It further said number of times snapshots need to be sent in a day may be decided by the respective clearing corporation depending on market timings subject to a minimum of four snapshots in a day. The snapshots would be randomly taken in pre-defined time windows.

For commodity derivatives segment, Sebi said last snapshot for commodity derivatives will be generated at 5 PM.

The client wise margin file provided by the clearing corporations to trading or clearing member will contain the end of the day (EOD) margin requirements of the client as well as the peak margin requirement of the client, across each of the intra-day snapshots.

The member will have to report the margin collected from each client, as at EOD and peak margin collected during the day, in a manner prescribed by the regu-

EOD margin obligation of the client will be compared with the respective client margin available with the TM/CM at EOD and peak margin obligation of the client, across the snapshots, will be compared with respective client peak margin available with the TM/CM during the day.

With regard to penalty, Sebi said higher of the shortfall in collection of the margin obligations at the two prescribed manner will be considered for levying of fine.

The verification of availability of margins with TM/ CM will be done by exchanges or clearing corporations on a weekly basis by verification of the balances in the books or of the TM/

Sebi said peak margin obligation of client across snapshots will be adopted in a phased manner.

For three months from the date of implementation, Sebi said 25 per cent of peak margin

obligation of the client across the snapshots will be compared with respective client peak margin available with the TM/CM during the day. This will be 50 per cent for subsequent three months and thereafter 75 per cent for subsequent three months and finally

It further said shortfall in collection of margins will be calculated by taking into consideration the phased adoption of peak margin obligation of client.

100 per cent.

During the period of phased adoption, the member should be able to demonstrate that the balance peak margin obligation has been funded from the member's own funds and not from any other client.

In a separate circular. Sebi said it has modified the eligibility criteria for selection of underlying commodity futures for options on commodity

The former players cannot wait forever: ICA chief says BCCI must act quickly on demands

(PTI): Asserting that "nothing has happened" in the past 10 months, Indian Cricketers' Association president Ashok Malhotra on Monday urged the BCCI to look into the body's long-standing demands, saying the ageing former players cannot wait "forever".

Malhotra, who has been accused by the ICA directors of making public statements and approaching BCCI on important matters concerning the players' body without discussing them internally, said it is high time the Board pays heed to ICA's demands.

The demands include pension for former players who have played less than 25 first-class games, pension for widows of former cricketers, increase in medical insurance from Rs 5 lakh to 10 lakh and a benevolent fund to Manoj Prabhakar, whose BCCI ban ended in 2005 for match-fixing charges against him.

"It has been close to 10 months (since the Sourav Ganguly-led BCCI took charge) but nothing has happened for the former players. The ICA after all, is for the welfare of for-

mer cricketers and some of them who are as old as 70, cannot wait forever," Malhotra told PTI.

"I request the BCCI again to look into our demands. There are three former cricketers on the BCCI Apex Council (Ganguly and ICA representatives Shantha Rangaswamy and Anshuman Gaekwad. I am sure they understand the plight of the former cricketers. Four meetings (Apex Council) have taken place but nothing has happened," he said.

In his latest video

sent to ICA members, Malhotra courted controversy by saying that he was not concerned about domestic cricket and the current administrative mess in Bihar

cricket. "I had simply said that my concern and focus is on ICA and welfare of former cricketers. It is natural as I am the ICA president. What have we done in the last 10 months? Nothing, apart from raising money for former cricketers affected by the COVID-19 pandemic,"

said Malhotra.

The ICA, India's first ever players' association formed as per recommendations of the Supreme Court-appointed Lodha panel, was granted Rs 2 crore by the BCCI earlier this year to kickstart its operations. However, it is expected to sustain itself in the long-run.

Talking about the infighting in the ICA, Malhotra added: "Whenever I make a point, it is objected to more often than not. At the end of the day, we are all there to take care of former players.

Vikas Dubey encounter: SC asks **UP** to consider having ex-judge of top court in inquiry committee

NEW DELHI, JUL 20 (PTI): The Supreme Court Monday asked the Uttar Pradesh government to consider adding a former apex court judge and a retired police officer in the inquiry committee which is probing the encounter of gangster Vikas Dubey.

The top court also said it was "appalled" that the gangster got bail despite so many cases against him.

A bench headed by Chief Justice S A Bobde, hearing a batch of pleas seeking court-monitored probe into the encounters of Dubey and his alleged associates, told the Uttar Pradesh government that they have to uphold rule of law.

You as a state have to uphold the rule of law. It is your duty to do so, the top court said.

The bench said it can-

not spare a sitting top court judge to become a part of the inquiry committee.

Solicitor General Tushar Mehta, appearing for Uttar Pradesh, sought some time to take instruction and get back to the court on the issue.

We are appalled to the fact that a person like Vikas Vikas Dubey got the bail despite so many cases, the bench said.

This is the failure of the institution and the person, who should have been behind the bars, got bail, the bench observed during the hearing which is going on.

"The bubble is part summer camp, mixed in with the Olympic village, playing overseas and an AAU tournament with a little bit of college life thrown in," Bird said in a phone interview.

"It's like overseas, but a little bit easier as far as access to things as you

Each team was given two golf carts and they are usually parked in front of the villas where the players or operations staff are staying. Atlanta glossed up its carts with



"You say hello to people and could bump into someone a few times a day from another squad," New York guard Sabrina Ionescu said.

"It feels like the Nike Nationals AAU Tournament. You could be eating next to a team or hanging out at the pool with players that you're going to be playing against later

that day."

While a few players voiced their concerns the first few days about the quality of food and accommodations, league quickly addressed those issues.

With their quarantines concluded, players and staff now have a robust array of food options offered daily at the hotel. Or players can get groceries delivered

and cook for themselves in the villas. The hotel is also where the league does its daily virus test-"Food has been great.

Service has been great. People have had issues with their housing. but there is no protocol for this, and the league took care of it," Phoenix Mercurv veteran Diana Taurasi said.

in the bubble, the virus is still on everyone's mind. Players wear masks unless they are eating. When they line up for food and testing, marks on the ground remind them to stand at least 6 feet apart.

Even with the leisure activities, many players spend their free time relaxing in their rooms.

"There is a lot of sitting in your room, Face-Time with your family,' Taurasi said.

Muzaffarpur shelter home: Brajesh Thakur moves HC against jail for life for sexual assault

NEW DELHI, JUL 20 (PTI): Brajesh Thakur, who was sentenced to life imprisonment till his last breath for sexually assaulting several girls in a shelter home in Bihar's Muzaffarpur district, has approached the Delhi High Court challenging his conviction and jail

The high court is likely to take up this week his appeal seeking to set aside trial court's January 20 judgment convicting him in the case and February 11 order sentencing him to life imprisonment till his last breath.

A trial court here had sentenced Thakur to "rigorous imprisonment till remainder of his life" and imposed a hefty fine of Rs 32.20 lakh on him, saying he was the "kingpin" of a "meticulously planned" conspiracy and "displayed extreme perversity".

Besides him, the trial court has also sent others to jail for life in the

Advocate Pramod Kumar Dubey, who represented Thakur before the trial court, confirmed that the appeal has been filed on his behalf.

Thakur, in the appeal,

contended that the trial was conducted in a hurried manner by the special judge (POCSO), Saket, which was a flagrant violation of his right to a free and fair trial as guaranteed under the Consti-

He claimed that his applications and submissions were dismissed in a mechanical manner without due application of judicial mind with a view to somehow conclude the trial.

The appeal, filed through advocates Nishaank Mattoo, Anurag Andley and Shreed Krsna, claimed that the conviction judgement and sentencing order were passed by the trial court in a prejudiced and mechanical manner having been swayed by the gruesomeness of the allegations levelled against Thakur and the public perception.

The appeal also raised the issue that potency of an accused is one of the foundational facts which the prosecution has to establish in a case related to rape and said neither the Bihar Police nor CBI had conducted the potency test of Thakur.



A Pandemic of Fear

Consult, collaborate and communicate. Don't panic

 \mathbf{W} ith the arrival of Novel Coronavirus into the resident population, the valid fear that COVID invokes in the general population took over. Towns went into voluntary lockdown, in some areas barricades were erected to keep outsiders, out. WhatApp scaremongering took off. Social media went into rapturous joy over the people's initiative, and while one can understand the worry, it is also worrying that no one noticed the potentially dangerous direction that such attitudes can take a society in.

The short-sightedness of such moves, the othering of "outsiders," the insularity that such knee-jerkism promotes and how anarchic responses cannot deliver anything good were clearly lost in the mad scramble to keep areas "safe." There were instances of communication breakdown [not rare in Sikkim] and administrative disconnectedness, which, too the State has seen often of late. The state machinery, which no one expects to be perfect, disappointed once again.

While community mobilization is always welcome, it is important that people make informed decisions and understand that mass panic needs to be calmed down, not fanned further as some extreme measures can end up doing. It is important to recognize that when people are encouraged/ allowed to barricade their localities against outsiders, the administration is shirking its responsibility towards the people's safety during this health crisis. A barricade is an aggressive signal, and when managed by scared people can lead to situations down the line which can be distasteful when mild and criminal in extreme cases. It is important for everyone to realize that the COVID pandemic is an unprecedented challenge, hence it becomes even more important for decisions to be weighed carefully. The unanimous decision of the Lall Bazaar [Gangtok] shopkeepers to shut shop for 10 days after Thursday needs to be discussed here. This was immediately problematic. A public announcement was made and people told to stock up in the two days still at hand before the capital's main market for vegetables and other kitchen provisions shuts down for 10 days. Where the lockdown announcement had only teased the instinct for panic buying, this unilateral decision of Lall Bazaar shopkeepers forced it out. Lall Bazaar, which had seen reduced footfall on Sunday Haat, was flooded with people on Monday, everyone jostling to stock up for 10 days. When NCoV is in the air, any decision which encourages people to gather in a crowd should be discouraged. This announcement ended up urging people to rush to Lall Bazaar. And they did. Ideally, visits to Lall Bazaar and other places where big gatherings cannot be avoided should be spread out at least while wider testing is undertaken and those at risk of exposure themselves and infecting others are traced and cleared or quarantined. In fact, to make this possible, one should consider keeping shops and vegetable markets open for longer so that there is no rush hour. What we got instead was an announcement, clearly born of good intentions, but one which delivered a potential health hazard.

The only agency which could have avoided this situation, the district administration, did nothing. It is regretful that this potential disaster was not foreseen by the district administration. People are put under lockdown so that the virus does not keep getting new hosts. Because a lockdown has been imposed, the authorities probably know more about how much the virus has spread than the lay people do. Shouldn't it have then stepped in to reassure the people that there will be no shortage? If people are expected to look out for themselves, are allowed to go in for bandhs on their own and stop people from entering their localities, then why does Sikkim need a State Task Force or even a police force? If decisions taken by people at dawn are so clear and well-reasoned that the entire top-brass makes it official after a proper meeting later in the day, the State Government might as well consider disbanding the STF and following the comments section of Facebook posts and doing whatever the majority of smartphone users want.

The incident at Jhorlungey in South Sikkim when people stopped busloads of pharma company workers from reaching their factories could also have been avoided if the administration could just make up its mind and not keeping issuing and amending its notifications. A pandemic requires clear thinking, not panic decision-making; it requires clear and consistent communication, wider consultations and it requires for the government to take the people into confidence and win their trust. To combat COVID, Sikkim needs to work together and through its government, not in silos or through notifications

LGBTQ+ conversion therapy in India: how it began and why it persists today

India is facing a prolonged back-**I** lash from its LGBTQ+ community over the continued use of conversion therapies to "cure" homosexuality by changing people's sexual orientation. In May, the tragic suicide of Anjana Harish, a 21-year-old bisexual woman in Goa, sparked online protests. Harish had posted a video online before her suicide describing how she had been subjected to conversion therapy by her family in her home state of Kerala. Her death revitalised efforts by activists to call for an outright ban on the practice.

In June, the UN Human Rights Council received a report on conversion therapy by an independent expert on gender and sexuality, Victor Madrigal-Borloz. Based on research in over 100 countries that use conversion therapy, 8,000 respondents who had endured it were interviewed, with 98% reporting that it had caused them psychological or physical damage.

Despite this, the UN Human Rights Council has yet to officially support Madrigal-Borloz's call for a global ban on conversion therapy for minors. Currently, only five countries have a ban in place: Malta, Brazil, Taiwan, Ecuador and Germanv.

Homosexuality in India was criminalised under colonial-era legislation in 1861. This law was repealed in 2018, after which the Indian Psychiatric Society stated unequivocally that homosexuality was not a mental disorder. However, divisions exist within the medical community.

After Harish's death, the Kerala branch of the society released a statement arguing that "any attempt to treat a person to change sexual orientation or gender identity is unjustifiable and illegal". But some practitioners, even in Kerala, still consider homosexual desire to be a perversion that can be medically corrected.

The ease of access in finding professionals who practice conversion therapy on LGBTQ+ people has become a cause for concern. In early June, two apps which help people

ant sexuality was something which could, and should, be changed. The idea of homosexuality as a disorder that could be "treated" was then imported to various European colonies via medical, legal and sociological institutions from the 19th century onwards.

The conversion therapies that persist today grew out of a set of aversion techniques that were developed by psychiatrists. These aversion techniques – in which people are pushed to associate a behaviour with discomfort - were initially used for alcoholism and other addictive and destructive behaviours. But from the 1950s through to the 1980s they began to be used globally on people with same-sex attraction as a form of conversion therapy.

In India, the earliest documented medical use of aversion techniques were in the 1970s, following a renewed global interest in scien-

In my ongoing research on this period, I'm looking at how the expression of homosexual desire, private inclination and public propriety collided in India - and how the pressure of social tradition and familial duty to marry and procreate overruled same-sex desire for those who sought treatment.

The emphasis on traditional marriage remains a critical factor in the continuation of conversion therapies in India. In Indian post-colonial society, heterosexuality is often portrayed as the only acceptable form of sexual desire, despite long traditions of same-sex eroticism.

AVERSION THERAPY

When aversion therapy was introduced in India, it involved using electro-convulsive therapy as well as a programme of behavioural therapy to remove fear or anxiety of the opposite sex. Patients would attend sessions with a range of erotic or

pornographic same-sex photographs they had chosen themselves. While viewing them, they would receive an electric shock, creating a negative association of pain with their own feelings of arousal.

The photographs would then be replaced with a heterosexual image and the electric shock would subside, assigning a sense of relief to opposite-sex attraction. While visual aids were the primary stimuli, Indian practitioners also included sensory materials, such as women's perfume, to elicit stronger positive relations with opposite-sex stimuli. Women's perfumes are still being used today according to recent accounts of conversion therapy.

While their western counterparts in the 1970s and 1980s primarily used a combination aversive techniques with some behavioural therapy alongside, Indian practitioners relied more heavily on a set of "additional behavioural programmes" to develop "social skills" which would help patients navigate their newfound heterosexuality. The main point for western practitioners was the eradication of same-sex desires, whereas in India they wanted to redirect the sexuality and make it heterosexual and capable of procreation.

Male patients underwent therapy for "passivity", while female patients were encouraged to become more feminine through clothing choice. This practice reflected binary ideas of sex and gender which arose via colonial intervention, as pre-colonial India had long accepted the existence of the hijra or a "third gender".

The law which criminalised homosexuality in India was a colonial imposition. Homophobic narratives and those which try to medicalise same-sex attraction can also be traced back to colonial ideology. Yet some powerful post-colonial institutions and individuals adopted these narratives and incorporated them into an anti-LGBTQ+ agenda, which continues among some practitioners

The COVID-19 crisis has had a grave impact on l jobs, wellbeing, mental health and the economy worldwide. But it has also prompted public expressions of hope - people have come together to sing on balconies and clap in the streets. Communities have been joining forces, with a surge in people donating to local food banks and looking out for their neighbours and elderly relatives.

In many ways, the pandemic has also shown how hope and optimism can appear in dark times - and how, in some instances, this can even become a force for social change. Indeed, as a recent poll from the strategy consultancy BritainThinks shows, just 12% of people want life to return to "exactly as it was before" once the pandemic is over.

The idea that living optimistically can lead to beneficial changes at a societal level was a key philosophy of German thinker Ernst Bloch. Known as "militant optimism", Bloch proposed that this was the active side of hope: a form of social commitment that turns hope into a concrete decision and intervention.

In this way, militant optimism fights the idea that history is what happens to us. Instead, it shows that history is what everyone actively makes every day - hence it can be addressed, contested and remade.

PHILOSOPHY OF HOPE

Bloch was a Marxist philosopher, described as the "philosopher of hope". His writings radically reimagined utopia, religion and daydreams as positive forces for social change.

Bloch's three-volume work, The Principle of Hope, originally published in the 1950s, has been described by French-Brazilian philosopher Michael Löwy as "one of major works of emancipatory thought in the 20th century."

Always on the side of the oppressed and the defeated, Bloch's work is a struggle against the status quo and aims to revive unrealised possibilities of social justice. And the book's notion of "militant optimism" can offer some points of reflection for the world today.

Militant optimism should not be confused with a belief that "everything will be alright". Indeed, this naive optimism and unquestioning faith in history and progress can paradoxically lead people to accept the world and that there is no alternative - rather than changing things for the better. Similarly, militant optimism overcomes pessimism by fighting hopelessness and showing the role of human action and work in changing the course of history.

Take this current era as an example – with the global pandemic, environmental destruction, racial, class and gender inequalities, the exploitation produced by capitalism, ongoing wars and displacement of communities. A pessimist would look at the world around us and dispel any illusion of progress. But as the recent wave of anti-racist protests or the continuing fight against inequality and state violence in countries like Chile show, this isn't actually the case.

Pessimism may imply a cold and lucid analysis of the wrongs, losses and uncertainty of

the world around us. As Bloch notes in the first volume of The Principle of Hope: "at least pessimism with a realistic perspective is not so helplessly surprised by mistakes and catastrophes". Thinking pessimistically, Bloch reflects, is better than any false or uncritical optimism that blindly believes that things will be OK, because it is more realistic. But pessimism still falls into the same trap as naive optimism, in that it neglects human beings' active role in history along with the fact that the world can, indeed,

OPTIMISM AND POLITICS

In this sense, militant optimism can help us channel what could appear as an individual and naive feeling of hope into a collective, concrete and participatory knowledge of and involvement into the material reality of the world around us.

Indeed, optimism is always required because the outcomes of social engagement are always uncertain. And, as Bloch famously put it, "hope can be disappointed".

Militant optimism is a force driving human action and opening real possibilities. It involves imagining what has not yet taken place rather than fixating on the defeats of the past – as the mobilisation of thousands of people against racism around the world demonstrates. In this way, militant optimism can guide and inspire us towards social liberation.

Priests hit hard as income dries up amid COVID-19 crisis



KOLKATA, JUL 20 (PTI): With several weddings and religious functions being put on hold due to the COVID-19 pandemic, many Hindu priests in Kolkata and its vicinity are in dire straits, some even looking for an alternative source of income to make ends meet.

Sushanta Chakraborty, a priest in Agarpara on the northern outskirts of the city, is selling vegetables in his locality, something that he said his "ancestors couldn't have thought of, no matter what the circumstances".

"Some households which I had been visiting for decades to perform rituals on auspicious occasions wouldn't invite me anymore. Since March, I have been sitting idle. With four mouths to feed -- my aged parents, daughter and wife -- I finally decided to sell vegetables on a cart.

"Before March, used to earn anything between Rs 35,000 and Rs 40,000 every month. Now, I barely manage to take home Rs 800 per day," Chakraborty said.

Vijay Upadhay, a priest in the city's Kestopur area, has taken to Facebook to urge people that they be allowed to perform household ritu-

"Narayan puja rituals are now taking place without the presence of a priest in many households. I appeal to all of you to remove the misgivings and allow priests conduct the rituals," he

Vinod Jha, a committee member of a Hanuman temple in Kamarhati, said the management has decided to retain just one of the three priests on its payroll.

"The number of devotees has declined and so have the earnings. We have decided to let go of two priests and retain only one for performing the daily rituals," Jha

Montu Chakroborty, a priest in south Kolkata's Chakraberia area, believes that the situation will change for better during Durga puja.

"Some Durga puja committees have assured me that they would invite me. I am pinning my hopes on them. My earnings per month have come down to Rs 6,000 from Rs 11,000. But I know Maa (Durga) will set things right," he said.

The surveys carried out during different periods reflect an alarming picture regarding widening of the Brahmaputra, whose total area in the state has gone up to 6,080 sq km in 2006 from 4,850 sq km during the survey conducted between 1963-1975. In the first survey conducted during 1912-28, the river had 3,870 sq km of area.



Messi wins record 7th scoring title in Spanish league

VITORIA (SPAIN), JUL 20 (AP): Lionel Messi won a record seventh top scoring title in the Spanish league after netting twice in Barcelona's 5-0 rout of Alav s in the final round.

Messi ended with 25 goals, four more than Karim Benzema, who did not score in Real Madrid's 2-2 draw at Legan

Messi is the first player to finish as the league's top scorer in seven different seasons. He reached the milestone despite missing games because of an injury early in the season. The Argentine's 25 goals came in 33 matches.

Messi was tied with Telmo Zarra with six scoring titles. He has also now equaled Hugo Sanchez's feat of four straight top-scorer trophies.

"Individual achievements are always secondary," Messi said on Sunday. "I wished it could

have come along with the league title."

This is also the third successive season that Messi finished with the most assists 21 in the

Ansu Fati, Luis Su rez and Nelson Semedo also scored Sunday for Barcelona, which had already secured second place behind Madrid.

Fati opened the scor-

ing in the 24th minute, Messi added to the lead 10 minutes later and Su rez closed the first-half scoring in the 44th. Semedo got on the board in the 57th and Messi in the 75th to help Barcelona rebound from a 2-1 home loss to Osasuna.

"Today things were different," Messi said.

"The team showed better attitude and commitment. It was an important step forward for us ahead of what's left in the season."

Barcelona now turns its focus to its Aug. 8 home game against Napoli in the round of 16 of the Champions League. The first leg, played before the break, ended 1-1.

Barcelona coach Quique Seti n finished under pressure after the team relinquished two-point lead over Madrid when the league resumed following the pandemic break. It was four points back before Madrid's match at Legan

Barcelona defender Cl ment Lenglet had to be substituted early in the second half because of an apparent muscle injury.

Inter left to lament what might have been in Serie A as doubts resurface

Lbeen a little more selfish, then perhaps there would be life in the Serie A title race yet. He stepped up in a high-pressure situation on Sunday night, burying an 88th-minute penalty to bring Inter to 2-2 at Roma. It was the sixth he had taken this season, and the sixth he had converted.

A penalty he chose not to take, however, continues to linger in the memory. Inter were already a goal and a man up at home to Bologna on 5 July when they won a spot-kick in the 61st minute. Lukaku handed the ball to Lautaro Martínez, kissing his strike partner on the head in encouragement. The Argentinian's weak shot was saved, and Inter collapsed to a 2-1 defeat.

Lukaku could not have known that his gesture would backfire so dramatically. To the contrary, he likely considered that a goal for Martínez in that moment would have done Inter's title bid the world of good. His strike partner had scored only once in five games following the restart, and was in need

of a confidence boost. Still, in a season of 'what ifs' for so many teams, that will be the one that haunts Inter the most. It seemed at the time that their title challenge was over, as they fell 11 points behind Juventus. But the Old Lady has since suffered her own mid-summer swoon, losing to Milan before drawing with Atalanta and Sassuolo.

Inter had a chance to pull within three if they could win in Rome - piling pressure on Juventus before Monday night's game against Lazio. The Nerazzurri got off to a positive start, Stefan De Vrij heading them in front from a corner in the 15th minute. But on the stroke of half-time, the same player deflected Leonardo Spinazzola's shot into his own net. The goal should not have stood. Replays showed Aleksandar Kolarov kicking the heel of Martínez as he won possession at the start of the attack. Yet referee Marco Di Bello declined to overturn his decision after an On-Field Review.

Inter had controlled the tempo for most of the first half, but Roma came out sharper after the interval. Jordan Veretout went close, before Hen-Mkhitaryan put

Conte lamented the decision not to overturn Roma's first goal, but his greatest ire was reserved for the fixture list which he believes to have undermined his team. "Our schedule, which is mad, is going unobserved," he said. "It seems to have been made to put us in difficulty, against teams who have always had one day more of rest, with us playing away from home and kicking off at 9.45pm. That means getting home at 4am and barely being able to train the next day. Other teams rest for five days."

He finished with a classic Conte rejoinder that, "I don't want to stir up a controversy", having just done precisely that. His anger was not just but his own club's directors, with a suggestion that Inter clearly had not been as "present" as they needed to be when the calendar was made. His words were interpreted as a dig at the CEO Beppe Marotta, with whom he previously worked at Juventus.

The substance of his claim merits scrutiny. If Inter's title bid has died prematurely, it is not because of a creditable draw away to Roma but because they have thrown away second-half leads against Bologna, Sassuolo and Verona. As Eurosport's Enrico Turcato observed, they were given the same amount of rest ing into all three of those games.

To blame the schedule, in any case, is a cop-out. It is not the fixture list that has caused Martínez's form to drop off so sharply since the restart, nor can that explain why Eriksen - who sparkled briefly in games against Napoli and Sampdoria - looks once again like a foreign object in this team.

The true concern is that Conte and Marotta may not share a vision for how to proceed. The expectation was never that Inter should win the Scudetto this season - even if the manager himself has confessed he would not have taken the job if he thought there were no chance. Sunday's draw secured their place in the Champions League with four games to spare: clear progress after late scrambles in each of the past two seasons.

Yet more will be expected next term. Inter have been aggressive again in the transfer market, completing the permanent sale of Mauro Icardi to Paris Saint-Germain and signing Achraf Hakimi from Real Madrid. They are understood to be close to a deal to sign another bright young talent, Sandro Tonali, from Brescia.

Yet when Conte discusses what he believes to be missing from his team, he speaks always of a need for experience and veteran know-how. He wanted Arturo Vidal in January, and his admiration for Edin Dzeko is well known. As Sunday night ticked over into Monday morning, sports radio shows in Italy were alive with speculation as to what Lukaku might have said as he threw an arm around the Bosnian



And so it was no surprise to see him here nine months on, putting in a statement performance against one of the world's great midfields in a resounding FA Cup semi-final victory at Wembley. Hang on.

Thousands to walk off job to protest racial inequality

NEW YORK, JUL 20 (AP): Organisers of a national workers strike say tens of thousands are set to walk off the job Monday in more than two dozen US cities to protest systemic racism and economic inequality that has only worsened during the coronavirus pandem-

Dubbed the Strike for Black Lives, labor unions, along with social and racial justice organisations from New York City to Los Angeles, will participate in a range of planned actions. Where work stoppages are not possible for a full day, participants will either picket during a lunch break or observe moments of silence to honor Black lives lost to police violence, organizers said.

We are ... building a country where Black lives matter in every aspect of society including in the workplace, said Ash-Lee Henderson, an organizer with the Movement for Black Lives, a coalition of over 150 organizations that make up the Black Lives Matter movement.

The Strike for Black Lives is a moment of reckoning for corporations that have long ignored the concerns of their Black workforce and denied them better working conditions, living wages and healthcare, said Henderson, who is also co-executive director of the Tennessee-based Highlander Research and Education

Among the strikers will be essential workers: nursing home employees, janitors and delivery men and women. Fast food, ride-share and airport workers are also expected to take part in planned events.

The strike continues an ongoing global reckoning on race and police brutality set off by the death of George Floyd, a Black man who died at the hands of Minneapolis police in late May.

At noon in each US time zone on Monday, workers are expected to take a knee for about eight minutes the amount of time prosecutors say a white police officer held his knee on Floyd's neck.

Strikers are desweeping manding action by corporations and government to confront systemic racism and economic inequality that limits mobility and career advancement for many Black and Hispanic workers, who make up a disproportionate number of those earning less than a living wage.

Specifically, they are calling on corporate leaders and elected government officials to use executive and legislative power to guarantee people of all races can thrive.

That demand includes raising wages and allowing workers to unionize to negotiate better health care, sick leave and child care support.

When the strike was announced on July 8, partnering unions included the Service Employees International Union, the International Brotherhood of Teamsters, the American Federation of Teachers, United Farm Workers and the Fight for 15 and a Union.

Several more worker collectives have since joined, along with social and racial justice groups.

In Manhattan, essential workers will gather outside of the Trump International Hotel to demand the Senate and President Donald Trump pass and sign the HE-ROES Act.

House-passed The legislation provides protective equipment, essential pay and extended unemployment benefits to workers who have not had the option of working from home during the coronavirus pandemic. Organizers said New York Sen. Chuck Schumer is expected to rally with workers.

Strikers in Minneapolis, where Floyd was killed on May 25, will include nursing home and airport workers demanding a 15-per-hour minimum wage, organisers said.

In Missouri, participants will rally at Mc-Donald's locations in St. Louis and Ferguson, a key landmark in the protest movement sparked by the death of Michael Brown, a Black teenager who was killed by police in 2014. The Ferguson strikers will also march to a memorial site located on the spot where Brown was shot and

Organisers said many strikers are taking particular aim at corporations such as Walmart and McDonald's, which they say should be held accountable for widespread mistreatment and exploitation of hourly workers of color.

In the wake of Floyd protests, McDonald's expressed its support for Black victims of police violence and vigilante attacks.

On Friday, a group of McDonald's workers filed a federal lawsuit against the corporation in Florida, alleging that managers at a corporate-run store in Lakeland subjected them to a racially hostile work environment and also had mistreated Black customers.

The workers alleged that after they reported their concerns to corporate leaders, their managers retaliated by slashing their hours and changing their work re-

sponsibilities. McDonald's, if you really believe Black lives matter, it's time to stop with the lip service and start with real action: treat your Black employees like our lives matter, said Faith Booker, a Black plaintiff in the lawsuit who also plans to join strikers on Monday.

In a statement emailed to the AP, Mc-Donald's said it was taking the claims in the

GOP leaders, Trump to discuss virus aid as crisis deepens

WASHINGTON, JUL 20 (AP): Top Republicans in Congress were expecting to meet Monday with President Donald Trump on the next COVID-19 aid package as the administration panned more virus testing money and interjected other priorities that could complicate quick passage.

Senate Majority Leader Mitch McConnell was prepared to roll out the 1 trillion package in a matter of days. But divisions between the Senate GOP majority and the White House posed fresh chal-

Congress was returning to session this week as the coronavirus crisis many had hoped would have improved by now only worsened and just as earlier federal emergency relief was expiring.

Trump insisted again Sunday that the virus would disappear, but the president's view did not at all match projections from the leading health professionals straining to halt the U.S.'s alarming caseloads and death toll.

McConnell and House GOP leader Kevin McCarthy were set to meet with

Trump and Treasury Secretary Steven Mnuchin to fine-tune the legislation, acting chief of staff Mark Meadows said on Fox News.

The package from McConnell had been quietly crafted behind closed doors for weeks and was expected to include 75 billion to help schools reopen, reduced unemployment benefits alongside a fresh round of direct 1,200 cash payments to Americans, and a sweeping five-year liability shield against coronavirus lawsuits.

House weighed in, the administration was panning some 25 billion in proposed new funds for testing and tracing, said one Republican familiar with the discussions. The administration's objections were first reported by The Washington Post.

Trump was also reviving his push for a payroll tax break, which was being seriously considered, said another Republican. Both spoke on the condition of anonymity to discuss the private talks.

The new push from the White House put the administration at odds with GOP allies in Congress, a disconnect that threatened to upend an already difficult legislative process. House Speaker Nancy Pelosi already passed Democrats' vast 3 trillion proposal and virus cases and deaths had only increased since.

Trump raised alarms on Capitol Hill when he suggested last month at a rally in Oklahoma that he wanted to slow virus testing. Some of Trump's GOP allies wanted new money to help test and track the virus to contain its spread.

Senate Democrats were investigating why the Trump administration had not yet spent some of 25 billion previously allocated for testing in an earlier aid bill.

The payroll tax Trump wanted also divided his party. Senate Republicans in particular opposed the payroll tax break as an insufficient response to millions of out-of-work Americans, especially as they tried to keep the total price tag of the aid



package at no more than 1 trillion.

Trump said Sunday in the Fox News interview that he would consider not signing any bill unless it included the payroll tax break, which many GOP senators opposed

"I want to see it," he

Lawmakers returning to a partially closed Capitol still off-limits to tourists to consider what will be a fifth COVID-19 aid package. After passing the 2.2 trillion relief bill in March, Republicans hoped the virus would ease and economy rebound so more aid would not be needed.

But with COVID-19 cases hitting alarming new highs and the death roll rising, the pandemic's devastating cycle was happening all over again, leaving Congress little choice but to engineer another costly rescue. Businesses were shutting down again, schools could not fully reopen and jobs were disappearing, all while federal emergency aid

expired.

It's not going to magically disappear, said a somber McConnell, R-Ky., last week during a visit to a hospital in his home state to thank front-line workers.

As McConnell prepared to roll out his 1 trillion-plus proposal, he acknowledged it would not have full support.

The political stakes were high for all sides before the November election, but even more so for the nation, which now registered more coronavirus infections and a higher death count than any other country.

In Arab world's first, UAE successfully launches its spacecraft towards Mars

Emiratis brimmed with ney to Mars, it said. joy and pride as the UAE made history on Monday by successfully launching its spacecraft "Al Amal" towards Mars from a Japanese launch centre, marking the Arab world's first interplanetary mission, according to media reports.

Al Amal, or Hope Probe, weighing 1.3 tonnes was launched from the H-2A rocket from Japan's remote Tanegashima spaceport at 1.58 am local time.

The probe's telecom system was set up and it transmitted its first signal after it successfully separated from the launch vehicle and its solar panels were deployed with clockwork precision an hour after the launch, Mitsubishi Heavy Industries Launch Services, which is the launch operator, confirmed.

The signals were received by the Mission Control team in Dubai's Khawaneej, Khaleej Times reported.

The solar panels will charge the batteries of the spacecraft for its

Omar Sultan Al Olama, Minister of State for Digital Economy, Artificial Intelligence and Remote Working System, said COVID-19 was the "biggest" hurdle that the **Emirates Mars Mission** team had to overcome.

"The team had to work backwards just to ensure that everything arrives in Japan before the launch period, and so that COVID-19 and the closure of borders do not affect the launch and the mission itself," Al Olama was quoted as saying in the report.

The Dh735-million (USD 200 million) project, which is the first interplanetary mission by any Arab nation, took six years by a team of 135 Emirati engineers, scientists and researchers.

Hope's arrival in February 2021 is set to coincide with the 50th anniversary of the UAE's formation.

The Gulf News reported that around 200 days from now, the spacecraft will reach the Mars orbit and begin its Planet's atmosphere.

Thanks to proper planning and "countless sleepless nights", Hope is now on its way to Mars, the minister said, lauding the contributions of the team members.

"It's like a three-way race to Mars this year and the UAE is headed to be the first country to reach Mars before US and China," Ahmad Belhoul Al Falasi, Chairman of the UAE Space Agency, was quoted as saying by the Gulf News.

Most Mars missions orbit at a single local time that allows the atmosphere to be measured at only one time of day but Hope Probe will circle Mars for the entire Martian year, which is equivalent to almost two Earth years, the report

Kanye West's rambling campaign rally, which saw him criticise abolitionist Harriet Tubman, has been met with criticism by stars including 50 Cent and Q Tip.

The rapper held the rally in Charleston, South Carolina, where he is seeking to qualify for the state ballot as an independent candidate. His speech, which included boasts about having a "brain too big for his skull", has been met with condemnation from a number of stars.

On Instagram, 50 Cent reposted a clip of West's speech alongside the caption: "What the f*** did he just say? This is all Jay Z's fault. Kanye's first rally. LOL"

West's criticism of Tubman, one of the most respected figures in American history, also came under fire. The rapper made the Tubman comments while condemning white businesses for employing black symbols, saying: "Harriet Tubman never actually freed the slaves, she just had the slaves go work for other white people."

Tubman escaped slavery and subsequently rescued approximately 70 slaves using a secret network of safe houses and rural passage ways known as The Underground Railroad. It is unclear what West was talking about.

On Twitter, rapper Q Tip simply posted an image of Tubman along with the caption "#Hero". Actor Jeffrey Wright tweeted: "Harriet Tubman doesn't give a damn about anybody's k***futurist opinion."

Rapper Noname succinctly tweeted: "KEEP HARRIET TUBMAN NAME OUT YOUR F***ING MOUTH!!!!!!!

The Hate U Give author Angie Thomas tweeted: "If y'all don't stop disturbing Harriet Tubman's spirit with this foolishness...'

Others, however, expressed unease with people taking West's speech seriously, suggesting that the star needed help rather than condemnation.

Songwriter and producer Finneas O'Connell, the brother of Billie Eilish, tweeted: "Let's completely disregard politics. Kanye is going through an episode and needs love and care from his friends and family."

Rapper JPEGMAFIA tweeted: "I just hope Kanye is ok. I don't really know what else to say here."

It remains unclear whether West is indeed running for US president, despite his announcement on 8 July that he planned to run as a representative of a new political party known as "The Birthday Party". On 14 July, a member of West's campaign team claimed that he had already dropped out of the race.
