12,000 enter govt service with Rojgar Mela





CM assures safe and secure future to new appointees

GANGTOK, 12 JAN:

Thief Minister Pawan Chamling today launched the ambitious "One Family, One Job," scheme of the State Gov-ernment with the State's first Rojgar Mela here at Paljor Stadium. Some 16,000 youth are to receive temporary gov-ernment employment in phase-1, with the CM announcing today that the services will be regularised after five years, and around 12,000 of them received their appointment letters today.

The CM informed that despite of working even on holidays for the past two months, the depart-ment had been able to prepare the appointment orders only for around 12,000 youth thus far and assured that the rest will also receive their appointment letters very soon.

Congratulating the new government servants, the CM stressed that all programmes of the Sikkim Democratic Front government have been youth-centric and future-oriented. The CM was addressing a packed

Paljor Stadium at the programme organised by the Department of Personnel.

The government is committed to provide jobs in different government departments to 20,000 youth who do not have anyone from the family in government service.

Addressing the Opposition allegations that there were temporary jobs, the CM rejected these as irresponsible statements and urged the people to have faith in the government.

A notification issued by the Ministry of Law and Justice said on Saturday that the Constitution (103 Amendment) Act, 2019 has received the assent of the president.

The Act amends Articles 15 and 16 of the Constitution, by adding a clause which allows states to make "special provision for the advancement of any economically weaker sections of citizens".

These "special pro-visions" would relate to "their admission to educational institutions, including private educational institutions, whether aided or unaided by the state. other than the minority educational institutions".

Tulsi Gabbard announces 2020 presidential run to take on Trump WASHINGTON, JAN 12 (PTI): Tulsi Gabbard, the first Hindu elected to US Congress and a four-time Democratic lawmaker, has said she will run for President in 2020, becoming the latest member of her party to challenge Republican President Donald Trump. Gabbard, 37, said she

will formally announce her candidacy within a week. The Iraq War veteran is the second woman after Senator Eliza-beth Warren to enter the presidential race from the Democratic party.

More than 12 Demo cratic leaders including Indian-origin Senator from California Kamala Harris are expected to announce their White House bid to challenge President Donald Trump in 2020.

Gabbard, a four-time Democratic lawmaker in the US House of Representatives from Hawaii, told CNN Friday: "I have decided to run and will be making a formal announcement within the next week". "There are many reasons I'm offering to serve you as President to ensure every American gets the healthcare they need, to bring about comprehensive immigration reform, to make sure we have clean water and clean air for generations to come to fix our broken criminal justice system, to end the corrupt influence of special interests in Washington, and so much more.

"But the main reason I'm running has to do with an issue that is central to the rest war and peace. I look forward to talking with you more about this in the coming days. When we stand together, united by our love for each other and for our country, there is no challenge we cannot overcome," she wrote in an email sent to her supporters. In her first tweet after the announcement. Gabbard urged her fellow countrymen to join her campaign.

"When we stand to-gether, united by our love for each other and for our country, there is no challenge we cannot overcome. Will you join me?" she asked on Twitter. "The First Woman President of the US is ready to take the challenge," said her cam-paign's Twitter handle.

Born in the US territory of American Samoa, Gabbard has become the first-ever Hindu to run for the presidency in the US. Gabbard, who converted to Hinduism early in her life, is highly popular among Indi-an-Americans. If elected, she would be the youngest-ever and first woman President of the United States. She would also be the first non-Christian and first Hindu to occupy the top post.

tioning properly. PHC Incharge, DB Gadaily today informed that on 08 Dec 2018, one Ravi Khaling brought his wife to the PHC, immediately blood test and other basic tests were done and TT

vaccination was given.
Since there was shortage of IFA tablet and they only had expired stock so they had asked the patient party to get it from the District hospital or the market.

The patient had been asked to come to the cen-tre on 08 Jan 2019 for the second vaccination. However, the patient

came on 09 Jan at 3 30 p.m. by which time the PHC had closed since the work timing is from 9 a.m. to 3 p.m.

Further, the vaccine had been brought from Iorethang on 08 Ian and since Nandugaon PHC does not have freezer facility for storage of such vaccines, the vaccine had to be returned. Later, when Mr Khaling called him, Mr Gadaily was in Barebottey where a suicide had occurred. Mr Khaling was then asked to come on 10 Jan.

However, on 10 Jan Mr Gadaily had to at-tend a training on substance abuse at Namchi

District Hospital.
Mr. Khaling posted false information on so-cial media defaming the entire staff of Nandugaon PHC and also the Health department of the state, said Mr Gadaily.

"It was shocking to see such allegations against the PHC on social media by a local youth which is without any in-vestigation and we also regret that such issues being brought up on social media without investigation. said former Zilla Pancha-

Similarly, TR Pradhan informed that Mr. Khal-ing had asked him for the cell phone number of the PHC Incharge on 09 Jan and he was also informed that the PHC would be closed as duty hours are from 9 to 3 pm.

"We saw the post on social media about the PHC and we are not

clear about Mr Khaling's intentions as the PHC is providing all the facilities and services to the peo-ple," said Mr Pradhan.

Bandh in NE states against police firing on people protesting against Citizenship Bill in Tripura

AGARTALA, JAN 12 (PTI): Firing and lathicharge by security forces to quell protests against the Citizenship (Amendment) Bill, 2016 in West Tripura district earlier this week triggered 'bandh' in large parts of the northeastern state Saturday.

Agitators in neighbouring Assam and Mizoram too joined the stir against the bill that aims to provide citizen-ship to illegal migrants of Hindu, Sikh, Buddhist, Iain, Parsi or Christian extraction from Afghanistan, Bangladesh and Pakistan.

On Tuesday, the day bill was passed in Lok Sabha, seven people were injured in Madhabbari area of the district when police and the paramilitary forces resorted to lathi-charge and fired in the air to disperse protesters.

Normal life was crippled during the dawn-todusk bandh on Saturdav in Tripura Tribal Areas Autonomous District Council (TTAADC), which comprises two-thirds of Tripura's territory and is home to tribals who constitute a third of the state's population.

The bandh call was given by five indigenous parties Indigenous People's Front of Tripura (IPFT-Tipraha), Indige-nous Nationalist Party of Twipra, Twipra State Party, National Conference of Tripura and Tripura People's Party to protest against the police firing. Sunil Dev Debbarma, general secretary of Tripura Students Federation, said the seven injured in the lathi charge are admitted to a hospital but said to be stable

Khumulwng town, the headquarters of the tribal council around 18km from Agartala, remained deserted as shops were closed and markets were closed and vehicles stayed off roads. Schools, colleges and

government offices also remained shut, police said. There was no report of any violence from any part of the council during the bandh, said Subrata Chakraborty, the state additional inspector general (law and order).

"There were road blockades by bandh supporters in at least three districts Kalacherra, S K Para and Neilahabari in Dhalai district, Sachirambari in South Tripura district, Amarpur and Takcherra in Gomati district." Chakraborty said.

The officer said there was no road blockade or demonstration near Khumulwng town and adjacent areas.

When contacted, Radha Charan Debbarma, TTAADC chief executive member and prominent leader of the opposition CPI(M), said the situation in the council area remained peaceful.
"Over 1,800 schools

and eight colleges in TTAADC area remained closed and no employee turned up at their offic-es. Everything, including markets and shops, re mained closed and vehiDebbarma said. West Tri-pura Superintendent of Police Ajit Pratap Singh said the situation in Mad-habbari and adjacent areas was normal.

The ban on Internet services and prohibitory orders under Section 144 of the Code of Criminal Procedure have been lifted, Singh said.

Tripura Chief Min-ister Biplab Kumar Deb has ordered a magisterial inquiry into how and under what circumstances police opened fire on protesters in Madhabbari. During the bandh, Twipra State Party members wore black badg black flags in several places, TSP general secretary Sunil Debbarma said.

A motorbike with participants carry-ing black flags was organised in Barkathal in West Tripura district, he said. In the neighbouring Assam, the North East Students Organisation (NESO) observed a 'black day' to protest the firing incident in Tripura.

The All Assam Stu-

dents Union, a constituent of NESO, hoisted a black flag at its headquarters in Guwahati and student activists protest ed across the state.

AASU chief advisor nujjal Bhattacharya, who had gone to Tripura with a team of NESO members said they were stopped by police when they were proceeding towards Khumulwung Hospital to visit the injured persons after meeting other injured people at G B Pant Hospital.

The bill was passed by Parliament on January 9.
"For the purposes of this article and article 16,

'economically weaker sections' shall be such as may be notified by the State from time to time on the basis of family income and other indicators of economic disadvantage," the notification read.

Amendment of Article 16 stated, "Nothing in

this article shall prevent the State from making any provision for the reservation of appointments or posts in favour of any economically weaker sections of citizens other than the classes mentioned in clause (4), in addition to the exist-ing reservation and subject to a maximum of ten per cent of the posts in each category."

While introducing the Bill in the Parliament, Union minister Thaawarchand Gehlot had said that at present, the economically weaker sections of citizens have largely remained excluded from attending the higher educational institutions and public employment on account of their financial incapacity to compete with the persons who are economically more privileged. According to the objects of the bill, "The directive

principles of state policy contained in Article 46 of the Constitution enjoins that the State shall promote with special care the educational and economic interests of the weaker sections of the people, and, in particular, of the Scheduled Castes and the Scheduled Tribes, and shall protect them from social injustice and all forms of exploitation"

It said economically weaker sections of citizens were not eligible for the benefit of reservation.

"With a view to fulfil the mandate of Article 46, and to ensure that economically weaker sections of citizens get a fair chance of receiving higher education and participation in employment in the services of the State, it has been decided to amend the Constitution of India," the statement of objects of the bill said.

National Wildlife Board clears ONGC Trishna gas project

AGARTALA. IAN 12 (PTI): The state-owned ONGC Tripura Asset would soon start extracting natural gas from Trish-na Wildlife Sanctuary in Belonia subdivision of Gomati district follow-ing National Wildlife Board's clearance of its proposal, a top official

said Saturday.

We have discovered
10-12 gas bearing wells
long back in Trishna Wildlife sanctuary. As the gas bearing zones are in the wildlife sanctuary, we needed permission from the National Wildlife Board.

The National Wildlife Board, following recommendations from the state Wildlife Board, has cleared the project on Thursday," Gautam Kumar Singha Roy, As-set Manager of ONGC Tripura Asset told re-

porters here.

He said that after the state Wildlife Board sanctioned the project on September 17, the state government had taken up the issue with National Wildlife Board.

He said ONGC has already began laying the pipeline and the entire process would be completed shortly.

The gas extracted

from Trishna Wildlife Sanctuary would be transported to the North Eastern Electric Power Corporation Ltd (NEEP-CO) owned 100 MW gasbased thermal power project at Monarchak in Sonamura subdivision of Sipahijala district.

The official said that the ONGC Tripura Asset has completed the exploration target for 2018-19 three months ahead of schedule.

"Our exploration target of 19 wells was completed by December itself and six more wells would be explored in the remaining three months of the current financial year," Singha Roy said adding that ONGC has augmented 10 lakh standard cubic metres gas this year compared to the last year, which was a record.

Singha Roy said that 50 per cent geographical area of the state still remains to be explored and it would be a great achievement if gas is discovered in even 10 per cent area.

He said the Tripura unit of ONGC would provide Rs 25 crore to the state government for carrying out Swacch Bharat Abhiyan.

Tea Board, however, did not disclose in which of the 16 Arunachal Pradesh districts the prices was highest.

Assam's highest price was more than West Bengal at Rs 155.51 per kilo as against Rs 124 in the Darjeeling plains, the data showed.

Highest prices in Tamil Nadu and Kerala were lower as compared

to north Indian BLFs, it said. As per Indian Tea Association (ITA) estimates, the proportion of production by BLFs and small growers were in excess of 50 per cent which it felt would cause

disruption in the market. In 2017 (Jan-Dec) small growers and BLFs produced 631 mkgs. al-most half of total production of 1,348 mkgs.

In November 2018, West Bengal's production was lower at 35.99 mkgs as against 37.08 mkgs in the same period of the previous year

Production during November also declined during in south India and Assam.

Politics Demands Commitment

...but slack accountability makes casual flirtations too easy

Politics is an exciting engagement, one that evokes passionate stands and distracts very easily. Where Sikkim is concerned, its political milieu has been traditionally populated rather extensively by teachers and midlevel government servants. Nothing wrong with having political leanings, in fact that would be a healthy engagement in a democracy, but everyone knows that involvement here used to extend much beyond that. It is also difficult in a State as small as Sikkim for anyone of any significance to remain genuinely apolitical. And as mentioned earlier, unless politics is really "dirty", there is nothing wrong in having a political position even if your job description requires you to stay detached. What is important though is for the people concerned to keep their responsibilities (as government servants or "social workers") and interests and (political) beliefs in separate silos. Unfortunately, government servants, given the astoundingly slack concepts of accountability enforced by the administration, are easily tempted to flirt with politics. In systems where accountability is casually fixed and job-responsibilities poorly defined, it is easy to start dispensing favours and bending rules; and before one knows it, the administrators become rather deft political players themselves. Engagement with party level politics follows and then come political ambitions.

What blurs the line even more is the confusion with which politics is mixed up with administration and government mistaken for a party. Also, in a political environment thick with parties and slim on ideological differentiators, the decision to take the plunge comes easy because options never dry out and crossovers rarely need to be explained with any conviction. Not just government servants, but this situation makes it easy for everyone to 'try out' politics, move around political parties, taste all options and if nothing works out, step back into a supposedly "apolitical" life only to resurrect whenever occasion demands or opportunity arises. It is the facility with which this last option [the one of turning apolitical whenever it suits one] can be acquired that makes irresponsible dabbling in party politics so easy for most wannabes here.

Let us agree first that while ideological political positions are absolutely acceptable, and even welcome, it is the tendency to engage in 'active' politics, the one involving planning and negotiating, that vitiates work cultures and political engagements. This latter involvement diverts attention from the tasks they draw salaries for [in the case of government servants], and should they be aligning with factions opposed to the ruling party, could also lead to willful compromising of policy implementation. In the case of private people involved in "social work", simultaneous political and social pursuits come at the cost of sabotaging their responsibilities towards society. And this cannot be dismissed as inconsequential even if they are volunteering their time and energies, because when one occupies a public space, one is required to remain earnest and not allow their priorities to get colored by political exigencies.

Politicians rarely suffer the fallout of such situations and the loss, in the long run, is burdened on the people whom the politicians, the government employees and the social workers should be serving first. Politics does not compromise governance or administration; it is the ambitious politicking that robs people of deserved delivery. For that reason alone, it is advisable to maintain a healthy interest in politics and also hold opinions, but leave the politicking to politicians; and if one is to engage actively, then doing so with full commitment.

SummitTIMES Countering Russian disinformation the Baltic nations' way

s the new Congress begins, it will soon discuss the disinformation campaign of half-truths, outright fabrications and misleading posts made by agents of the Russian government on social media in the run-

up to the 2016 presidential election. After years of anemic responses to Russian in-fluence efforts, official U.S. government policy now includes taking action to combat disinformation campaigns sponsored by Russia or other countries. In May 2018, the Senate Intelligence Committee the Senate Intelligence Committee endorsed the concept of treating attacks on the nation's election infrastructure as hostile acts to which the U.S. "will respond accordingly." In June, the Pentagon unleashed U.S. Cyber Command to respond to cyberattacks more agrespond to cyberattacks more aggressively, and the National Cyber Strategy published in September 2018 clarified that "all instruments of national power are available to

prevent, respond to, and deter ma-licious cyber activity against the United States."

There are already indications that Cyber Command conducted operations against Russian disinformation on social media, including warning specific Russians not to interfere with the 2018 elections. However, low-level cyberwarfare is not necessarily the best way. European countries, especially the Baltic states of Estonia, Latvia and Lithuania, have confronted Russian disinformation campaigns for decades. Their experience may offer useful lessons as the U.S. joins the battle

THE BALTIC EXPERIENCE

Beginning in 1940 and continuing until they declared independence in the early 1990s, the Baltic countries were subjected to systematic Russian gas-lighting designed to make people doubt their national history, culture and economic development.

The Soviets rewrote history books to falsely emphasize Russian protection of the Baltic people from invading hordes in the Middle Ages, and to convey the impression that the cultural evolution of the three countries was enabled by their allegiance and close ties to Russia. Even their national anthems

were rewritten to pay homage to Soviet influence.
Soviet leaders devalued Baltic currencies and manipulated economic data to falsely suggest that Soviet occupation was boosting the Baltic econo-mies. Further, Soviet authorities settled ethnic Russians in the Baltic countries, and made Russian the primary language used in schools.

Since the fall of the Soviet Union and the inde-

pendence of the Baltic countries, the Russian Federation has continued to deliver disinformation to the region, making extensive use of Russian-language social media. Some themes characterize the Baltic people as ungrateful for Soviet investment and aid after World War II. Another common message criticizes Baltic historians for "falsification of history" when really they are describing the real nature of the Soviet occupation.

A MASSIVE RUSSIAN ATTACK

After independence, and as the internet grew, Estonia led the way in applying technology to ac-celerate economic development. The country created systems for a wide range of government and commercial services, including voting, banking and filing tax returns electronically. Today, Estonia's innovative e-residency system is being adopted in many other countries



These advances made the Baltics a prime target for cyberattacks. In the spring of 2007, the Russians struck. When Estonia moved a monument memorializing Soviet soldiers from downtown Tallinn, the country's capital, to a military cemetery a couple of miles away, it provoked the ire of ethnic Russians living in Estonia as well as the Russian government.

For three weeks, Estonian government, financial and media computer systems were bombarded with enormous amounts of internet traffic in a "distributed denial of service" attack. In these situations an attacker sends overwhelming amounts of data to the targeted internet servers, clogging them up with traffic and either slowing them down or knocking them offline entirely. Despite concerns about the first "cyber war," however, these attacks resulted in little damage. Although Estonia was cut off from the global internet temporarily, the country's economy suffered no lasting harm.

These attacks could have severely damaged the

country's financial system or power grid. But Estonia was prepared. The country's history with Russian disinformation had led Estonia to expect Russian attacks on computer and information systems. In anticipation, the government spearheaded partnerships with banks, internet service providers and other organizations to coordinate responses to cyberat-tacks. In 2006, Estonia was one of the first countries to create a Computer Emergency Response Team to

THE BALTIC RESPONSE

After the 2007 attack, the Baltic countries upped their game even more. For example, Estonia created the Cyber Defense League, an army of volunteer spe-cialists in information technology. These experts focus on sharing threat information, preparing society for responding to cyber incidents and participating in international cyber defense activities.

Internationally, Estonia gained approval in

2008 to establish NATO's Cooperative Cyber Defense Center of Excellence in Tallinn. Its comprehensive research into global cyber activities helps identify best practices in cyber defense and training for NATO members.

In 2014, Riga, the capital of neighboring Latvia, became home to another NATO organization combating Russian influence, the Strategic Communications Center of Excellence. It publishes reports on

Russian disinformation activities, such as the May

2018 study of the "Virtual Russian
World in the Baltics." That report analyzes Russian social media activities targeting Baltic nations with a "toxic mix of disinformation and propaganda." It also provides insight into identifying and detecting Russian disinforma-

tion campaigns.

"Baltic elves" – volunteers who
monitor the internet for Russian disinformation - became active in 2015 after the Maidan Square events in the Ukraine. And the Baltic nations have fined or suspended media channels that

The Baltic countries also rely or European Union agency formed in 2015 to combat Russian disinformation cam-

paigns directed against the EU. The agency identifies disinformation efforts and publicizes accurate information that the Russians are seeking to undermine. A new effort will issue rapid alerts to the public when potential disinformation is directed against the 2019 European Parliament elections.

WILL THE 'BALTIC MODEL' WORK IN THE US?

Because of their political acknowledgment of threats and actions taken by their governments to fight disinformation, a 2018 study rated Estonia, Latvia and Lithuania the three European Union mem-

bers best at responding to Russian disinformation.

Some former U.S. officials have suggested adopting similar practices, including publicizing disinformation efforts and evidence tying them to Russia. The Senate Intelligence Committee has called for that too, as has the Atlantic Council, an independent think tank that focuses on international affairs.

The U.S. could also mobilize volunteers to boost citizens' and businesses' cyberdefenses and teach people to identify and combat disinformation.

Disinformation is a key part of Russia's overall effort to undermine Western governments. As a result, the battle is ever-changing, with Russians constantly trying new angles of attack and target countries like the Baltic nations identifying and thwarting those efforts. The most effective responses will involve coordination between governments, commercial technology companies and the news industry and social media platforms to identify and address disinformation

A similar approach may work in the U.S., though it would require far more collaboration than has existed so far. But backed by the new government mo-tivation to strike back when provoked, the methods used in the Baltic states and across Europe could provide a powerful new deterrent against Russian influence in the West.

Phosphorus: 350 years after its discovery, this vital element is running out

t's time to buy a lot of candles. And birthday to the discovery of phosphorus, an element that is essential for life as we know it.

The story of how the 15th element

on the periodic table was discovered stands as one of the great accidents of human endeavour - the chemist's equivalent, perhaps, of Columbus setting out for India only to find the Americas by mistake. In the case of phosphorus, the explorer was Hennig Brand, a 17th-century alchemist and

merchant from Hamburg, Germany.

Brand had been trying to achieve one of the great goals of alchemy, to make the philosopher's stone. Alchemists thought this was the elixir of life, capable of transforming lead into gold. But where to find this leg-

endary substance?

Brand was convinced that the answer was human urine, for two good reasons. First, gold and urine were a similar colour. Second, urine came from the human body, which was regarded by alchemists as a work

THE DISCOVERY

The actual process that Brand set up in 1669 was remarkable. One would struggle to repeat it in a garden shed nowadays – unless you had neighbours who were willing to tolerate extremely bad smells. Brand concentrated large ints of human urine and left it to ferment. He then heated the residues,

performing dry distillation, as depicted below in the 1795 Joseph Wright painting, the Alchemist in Search of the Philosopher's Stone.

Brand was left with a white waxy solid which glowed in the dark even in a closed bottle, and combusted spontaneously with a very bright white flame when exposed to air. Intrigued by these properties, he named it phos-phorus because this meant "light bear-er" in Greek. He attempted many times to use the substance to transform lead

into gold, but to no avail.

Presumably disappointed, Brand may well have thought he had instead found one of the other great postula-tions of alchemy, pure phlogiston. Al-chemy had a spiritual framework rooted mainly in ancient Greek philosophy, which stipulated that all matter is formed of four elements, or qualities - air, earth, fire and water. When heat and light were generated during combustion, alchemists thought it was because of phlogiston, a fire-like element which was contained within combustible objects and released

when they burned.

The theory of phlogiston was not debunked until the 1770s, when Antoine-Laurent Lavoisier showed that combustion is a reaction with a gas – oxygen. More than a century after that, it became possible to transmute one metal into another – but using a nucle-ar reactor rather than a philosopher's stone. Economically, however, the process has never made sense as only tiny amounts of noble metals like gold can be made in this way.

On the other hand, the discovery of phosphorus opened up a dazzling

new chapter in what became modern chemistry. Some 50 years after Brand's discovery, Johann Thomas Hensing, a professor of medicine at the University of Giessen in central Germany. showed that phosphorus was also present in the human brain (it would be decades later before it was shown that there were also minerals contain-

ing phosphorus).

Early medicines containing elemental phosphorus started being sold, perhaps on the thinking that "if it is in your brain, it must be good for you". This turned out to be seriously flawed, however, since white phosphorus is in fact very toxic – a fatal dose is only 1mg per kilogram of body mass. Patients

BRINGER OF LIFE AND DEATH

Nonetheless, phosphorus is biologically vital. The average human body contains about 0.5kg of phosphorus, most of it in the form of phosphate to make bones and teeth strong. Phos-phorus also crucially holds together DNA and RNA molecules - the backbone of these long chain-like struc-tures contains two phosphate groups per pair of nucleic bases. Without phosphorus, it is hard to imagine any

Foods rich in phosphorus include various meats, seafood, lentils, beans, nuts and seeds. At the other end of the spectrum, white phosphorus was long used in rat poison. Even more extreme, chemical warfare agents Sarin and VX are phosphorus compounds. Sarin, for example, is 21 times more deadly than potassium cyanide. It's a great example of how elements occurring in dif-ferent forms can have both very different appearances and biological effects.

Phosphorus has many other pos-itive traits. Together with nitrogen, phosphates form the basis of the fertilisers used widely in agriculture. There is no substitute for phosphorus in this role; it cannot be replaced by any other element in plants.

This raises an important problem.
Supplies of phosphate rock – the only
major phosphorus ore – are limited.
So much so that phosphorus has been listed among the "endangered elements" where there is a risk to future supply. The problem is that the phosphorus used as fertiliser ends up dissolved in rivers and oceans as soluble phosphate, eventually becoming sediment. Currently there is no economically viable way of recovering it, and scientists predict a shortage within about 30 to 40 years.

This points to the need to develop phosphorus recycling, ideally at the point before it becomes highly diluted in our water streams. So how could this be done? Humans consume 3m tons more phosphorus than they need each year, which is eventually excreted as urine and faeces. Recycling phosphorus from human waste might not sound a very uplifting endeavour but it will be a golden egg for whoever finds a way to do it.

This raises an interesting point. It is tempting to look with amusement at the way Brand found phosphorus in buckets of urine. It may turn out that with the hindsight of 350 years, he was actually focusing on exactly the best

t is almost an unwritten rule that when Christmas comes, we come back from wherever we are the rest of the year and celebrate at our ancestral church. Once my brother arrived right on Christmas day and the parents didn't seem too happy. But he made it so they were relieved.

Over the years Christmas celebration has become pretty routine (if I may). Everybody is back, and on their best behaviors for Christmas day. The church is usually decorated with pretty lights, a Christmas tree and interesting decorations to say the least; like that one time when a huge Santa and his reindeer was placed in the front central wall and everybody's attention was on that instead. But old hymns are sung and new clothed children run around church premises as the love feast after church service unites those who were away and those stayed back to catch up and gossip. Laughters are shared and games are organized as gifts are distributed making it a pretty festive event throughout the day.

But this past Christmas, I found myself away from the church, the village, and the familiarity of Christ-mas celebrations I have known most of my life.

I woke up in a new city and found my way to a church in Yangon via google maps. The past week we had been traveling through the country and had reached the old capital on Christmas eve. So, on Christmas morning we found a church that was walking distance from where we were staying and the service had already started when we got there. We had entered the Cole Kayin Baptist Church –to a gathering of about 50-60 people belonging to the Karen tribe. Most of the men were attired in their traditional woven tops in-dicating their tribal identity as the Karens are a hill

tribe living primarily in Southeast Asia and speaking the Tibe-to-Burman language. The people who

The people who saw us enter looked friendly enough and made us feel comfortable as we joined the service. We did not understand their language but closed our eyes in prayers when the pastor prayed and hummed to the tunes of "joy to the world" when they sang that song next.

When the service

ended, everyone went around shaking hands, wishing each other "Merry Christmas" and

we joined in doing so as well. We decided to leave but an elderly lady stopped us and asked us to join their "love feast". We could not say no and joined the congregation in an already arranged table seating with naangyi thoke and tea. The lady beside me asked if we had something like this where we came from and since it had noodles, I thought of thukpa and said yes. But it was nothing like thukpa. It was dry noodles with chicken, slices of fish cakes and boiled eggs with powdered chickpea flour that needed to be mixed. It was different but we savored the meal and got invited for next year's Christmas meal as well.

When they heard we were from India, the lady

next to me asked about Karens in India. I was happy to report her that yes we have the Karen tribe in India too. I told her that they live in the Andaman Islands and I had actually met a lady cop hailing from the Kar-en tribe when I was in Port Blair four years ago. Most Indians however do not know about Karens in India for our own geographic and cultural ignorance. But it is believed that the Karen tribe of India actually calls the Andaman Islands the "land of paradise" because they were free from the kind of political set-up of

their counterparts in Myanmar.

Thereafter she was keen to know where in India I was from because I did not look Indian. I told her I also belonged to a hill tribe and that seemed to satisfy

her. After some photo sessions, we took leave, thank ful for the time, the food and the fellowship.

I did not expect to find a church in Myanmar espe-

cially after all the pagodas and temples we had visited earlier. But it was a nice reminder of a small commu-nity in a predominantly Buddhist country having the freedom to celebrate Christmas in their own fashion. It was nice to see a non-commercial, pretentious-free Christmas celebration where people welcomed strangers like us. I was grateful for the experience and did not mind that I skipped our regular Christmas celebration at the ancestral village. Instead it has inspired me to find a new place to celebrate Christmas next year perhaps.



Bandh in Tripura tribal council area affects normal life



AGARTALA, JAN 12 (PTI): Normal life was crippled in the tribal council area of Tripura on Saturday during the dawn-to-dusk bandh called by five indig-enous parties to protest against the police firing at

Madhabbari earlier this week.

The Tripura Tribal Areas Autonomous District Council (TTAADC) comprises two-third of the state's territory and is home to the tribals, who constitute a third of the state's population.

Khumulwng town, the headquarters of the tribal council and account 18 lm from here were a depart.

council and around 18 km from here, wore a desert-ed look as shops downed their shutters, markets remained closed and vehicles stayed off the roads. Schools, colleges and government offices also remained closed, the police said.

On Tuesday, seven people were injured at Mad-

habbari in West Tripura district when the police and the paramilitary forces resorted to lathi-charge and fired in the air to disperse those protesting

against the citizenship bill.

The parties, who called the bandh, are the Indigenous People's Front of Tripura (IPFT-Tipraha), Indigenous Nationalist Party of Twipura (INPT),
Twipra State Party (TSP), National Conference of
Tripura (NCT) and Tripura People's Party (TPP).
The entire tribal council area remained peaceful
so far and no untoward incident was reported from

any part of the council area, and no one was arrested, said Subrata Chakraborty, the state additional inspector general (law and order).

There were road blockades by the bandh supporters at least in three places. Those are Kalach-erra, S K Para and Neilahabari in Dhalai district,

Sachirambari in South Tripura district, Sachirambari in South Tripura district, Amarpur and Takcherra in Gomati district," the AlG said.

The officer said there were no road blockades or demonstrations near Khumulwng and adjacent areas. When contacted, Radha Charan Debbarma, TTAADC chief executive member and a prominent leader of the expecition CILCOL said the cityation. leader of the opposition CPI(M), said the situation in the tribal council area remained peaceful.
"Over 1,800 schools and eight colleges in TTA-

ADC are closed and no employee turned up in of-fices. Everything, including markets and shops, re-mained closed and vehicles remained off the roads,"

Debbarma said. West Tripura Superintendent of Police Ajit Pratap Singh said the situation in Madhabbari and adja-

ap Singh said the situation in Madhabbari and adjacent areas was normal.

"The ban on Internet services and prohibitory order under section 144 of the CrPC (Code of Criminal Procedure) would expire in the evening. If the situation demands, both would continue," he said.

Chief Minister Biplab Kumar Deb had told a press conference earlier that a magisterial inquiry was ordered to look into how the incident took place and under what circumstances did

took place and under what circumstances did the police open fire.

FIELDWORK REFLECTIONS

Women in Lepcha Community

Women are considered as the back-bone of a family. If we put this into a larger context, women can be considered as the backbone of an entire society or a nation given the fact what status the society provides them with Each society has its own set of laws which grants women access to their rights or overshadows their existent-ing rights. Inequality of rights between men and women exists in most of the societies, neglecting the fact that in order for a society to flourish organically, the contribution of both men and women plays a vital role. Various studies indicate that education has brought many social changes and autonomy of women being one, yet it is also a contradicting fact that education of women

alone does not give all the rights of decision making to women but the autonomy of women in a given society depends upon the autonomy provided by her culture and society. This article is in-

spired by all the women came across during my fieldwork in different villages I stayed. Every place I stayed, women of those areas never failed to amaze me be it carry-ing heavy loads of grass for their cattle every morning and afternoon or the heavy fire woods in weekends, working in

their fields under that scorching sun running small business alongside taking care of all household chores, to settling small disputes among villag-ers as a Panchayat, and so forth. The article reflects facts which many of us have not taken time to pay attention to yet women alongside men are the ones who have been keeping the art of

existence moving.

Since, women can be the backbone of a society; this paper consists of how women in Lepcha community actually functions as the backbone and what autonomies exists in the status provided to them by the community. There are many studies on the status of women in different communities, and every study has revealed a common fact that the status of women is largely dependent upon the nature of the society that treats their women either as an object or as a part of the society. Here, I have

considered different factors like social. religion, education, income, etc. in the Lepcha community that has contributed in shaping the status and role of women in the society and how far wom-en have been able to prove themselves worthy of the status they are allotted to.

It is a known fact that no matter how well educated and independent woman may be, her status and role always defined by the perception of the society for women where she comes from. However, when we look at the Lepcha community, women are given almost equal status as men. Here the term almost equal has been used because looking back in time there were certain cultural process in which Lepcha women had less autonomy in marriage decision making which with time has faded away. Now, women play



equal and important part in deciding their marriage. Women are considered as important an asset to the family as she is engaged in almost all the house-hold work. This is the reason why when they get married, the groom's family has to compensate the bride's family with goods and gifts as bride price. Widow remarriage is practiced in Lepcha community which is why widows are never looked down upon or treated in a different way. Among the Lepcha community religion has not played any negative role. Although there are some religious rituals (Falo: clan ritual etc.) where women's' presence is prohibited but during preparation of such rituals, the involvement of women is as equal as men even if it means indirect involve-ment. Since Lepchas are originally animists and later adopted other religions mostly Buddhism and Christianity yet animism is also practiced side by side

known as Bongthings (male) and Muns (female) are part of their animistic belief. So, it can be seen that both male and female plays a vital role in religious corner as well.

Among the Lepcha community there is no preference of male child over a female. After interviewing many Lepchas about their idea of male and female child their responses were that both

male and female child is equal for them. However, exceptional cases may be there where dispar ity between male and female child can be seen yet the general response did not reflect any bias notion where male child is preferred over female.

Income plays a vi-tal role in every aspect but its absence has not evolved into gender discrimination issue in Lepcha community. Women or girl child are not seen to be considered less over men or male child due to low

income. There is no unequal distribu-tion of food even if the food is less. The health check-up is based on the severity of illness and not on the basis of who should be (male child or female child). Even when buying clothes, it would be either for both or none.

Education is an important aspect

of development. In many parts of the nation women are deprived of right to education because of reasons like early marriage, women are considered domestic beings who are trained to look after the family before and after marriage, men are seen as the ultimate breadwinner because of which they are treated in a special manner. Education among women in Lencha community is considered as equal to the male counterparts. There seems to be no reason for the parents not to send the girl child to school. Considering employment in a greater context, there are no sectors


where Lepcha women are not a part of it, be at the administrative level, health sector, engineering, academics, etc. they are exceptionally doing well. In recent years it is seen that they are doing justice to positions like village pan-chayats, ASHA, ICDS teachers, etc. Lep-cha women also have self help groups which are seen to be more active than self help groups (SHG) of men. The women spare free time for the SHG and engage themselves in some creative things which can be sold to get some fund for the SHG and later those funds can be used in needy hours. As ASHA and ICDS teachers, women have contributed so much in providing better health to the community. An active participation of ASHA and ICDS teachers, have contributed better maternal and child health at village level. Women are equally involved in the political scenario of the community. Their voices are given importance which is why females are actively participating as village Panchayats and working for the betterment of their villages.

Violence against women (physical

or mental) is another considerable factor that shows how women are treat-ed in a society. As such, looking at the Lepcha scenario, violence on women is less prevalent. There may be cases of domestic violence but that is totally individualistic action and cannot be taken as a general action by the society against its women.

Women play a pivotal role in the community and are given a respectful status. However, it is also an undeniable fact that despite of having a better status of women in the community, there is no disparity among men and women. This however, will not justify some of the complex issues faced by women in a general or individual way. It is an utopian dream to see men and women having equal rights in all aspects yet women play an important part in the Lepcha community and are still doing well in every field and taking equal steps as men.

Canada takes in Saudi teen asylum seeker



OTTAWA, JAN 11 (AFP):
Prime Minister Justin
Trudeau announced
Friday that Canada was
taking in an 18-yearold Saudi asylum seeker
who fled her family and
harnessed the power of
Twitter to stave off deportation from Thailand.

Rahaf Mohammed al-Qunun was already en route to Toronto late Friday when the prime minister made the surprise announcement, after officials had previously given heavy hints she was bound for Australia.

"Canada has been unequivocal that we'll stand up for human rights and women's rights around the world," Trudeau said. "When the United Nations made a request of us that we grant al-Qunun's asylum, we accepted."

lum, we accepted."

The move is sure to further strain Canadian relations with the kingdom that went sideways

last August over Ottawa's rights criticism of Saudi Arabia, prompting Riyadh to expel the Canadian ambassador and sever all trade and investment ties in protest.

Canada also sparked fury in Riyadh by demanding the "immediate release" of jailed rights campaigners, including Samar Badawi, the sister of jailed blogger Raif Badawi, whose family lives in Quebec.

Qunun's attempt to flee the ultra-conservative kingdom was embraced by rights groups as a beacon of defiance against repression. Thai authorities initially threatened to deport her after she arrived in Bangkok from Kuwait last weekend.

But armed with a smartphone and hastily opened Twitter account, she forced a U-turn from Thai immigration police who handed her into the care of the UN's refugee agency as the #SaveRahaf hashtag bounced

across the world.

Qunun alleged that she was abused by her family -- who deny the allegations -- and rights groups also said she had renounced Islam, risking prosecution in Saudi Arabia. Rahaf first said she was aiming for Australia where officials had suggested they would give consideration to her claim for asylum, which was endorsed as legitimate by the UNHCR on Wednesday. But late Friday Thailand's immigration police chief said a smiling and cheerful Rahaf was bound for Toronto and had left on a flight after 11:00 pm (local time).

"She chose Canada... Canada said it will accept her," Thai immigration chief Surachate Hakparn lowers within a week, highlighting her plight at a time when Saudi Arabia's human rights record is under heavy scrutiny following the murder of journalist Jamal Khashoggi last year. Her deployment of so-

cial media allowed her to avoid the fate of countless other refugees who are quietly sent back home or languish in Bangkok detention centres. She refused to see her father who travelled to Thailand and expressed opposition to her resettlement. Surachate said her father and brother were due to return home on a flight in the early hours of Saturday.

Although her asylum case moved fast the final manoeuvres that led to her flight to Canada remain a mystery.

Australia had dropped strong hints it would accept her after the UN urged the country to do so and it remains unclear why the resettlement location changed.

On Thursday its foreign minister said Canberra was still assessing the request

the request.

Thailand's immigration chief Surachate had earlier told reporters Friday that "two or three" countries were ready to offer her asylum.

The Southeast Asian

The Southeast Asian country is not a signatory to a convention on refugees and asylum seekers must be referred to a third country.

The New York Times, based on unnamed sources, said that such an investigation against Trump that was started by the FBI carried explosive implications, as the law enforcement agents sought to determine if the president was knowingly working for the Russians or had unwittingly fallen under Moscow's influence.

Investigators have to consider if Trump's own actions constituted a possible threat to the national security, the paper reported on Friday.

"No evidence has emerged publicly that Trump was secretly in contact with or took direction from Russian government officials," The New York Times said.

"Agents and senior FBI officials had grown suspicious of Trump's ties to Russia during the 2016 campaign but held off on opening an investigation into him, the

people said, in part because they were uncertain how to proceed with an inquiry of such sensitivity and magnitude," the paper reported.

The White House has described The New York Times story as absurd. "This is absurd. Iames

Comey was fired because he's a disgraced partisan hack and his deputy Andrew McCabe who was in charge of the time is a known liar fired by the FBI. Unlike former president (Barack) Obama who let Russia and other foreign adversaries push America around, President Trump has actually been tough on Russia, the White House Press Secretary said.

The FBI did not respond to a query on the alleged investigation against Trump.

But according to the

But according to the daily, the FBI investigation was taken over by the Special Counsel Robert Muller who has been tasked to investigate into the allegations of Russian interference in the 2016 presidential elections.

The inquiry is part of Mueller's broader examination of how Russian operatives interfered in the 2016 election and whether any Trump associates conspired with them.

Trump has, however, denied of having any collusion with the Russians and repeatedly criticised the Mueller investigation as a "witch hunt" and views it as a stain on the legitimacy of his presidency.

"If the president had fired Comey to stop the Russia investigation, the action would have been a national security issue because it naturally would have hurt the bureau's effort to learn how Moscow interfered in the 2016 election and whether any Americans were involved, according to James A. Baker, who served as FBI general counsel until late 2017," the report said.

Baker privately testified in October before House investigators who were examining the FBI's handling of the full Russia inquiry, it said.

"Not only would it be an issue of obstructing an investigation, but the obstruction itself would hurt our ability to figure out what the Russians had done, and that is what would be the threat to national security," Baker said in his testimony, portions of which were read to The New York Times.

He did not explicitly acknowledge the existence of the investigation of Trump to congressional investigators.

The report casts pressure on the White House, which is already feeling the heat from months of investigations.

Trump's former campaign chairman Paul Manafort in August 2018 was convicted of financial crisis and later pleaded guilty to conspiring to defraud the US and conspiring to obstruct justice.

Trump's longtime lawyer and aide Michael Cohen is set to begin a three-year prison sentence in March after pleading guilty to fraud, campaign finance violations and lying under oath.

Government shutdown becomes longest in US history

WASHINGTON, JAN 12 (AFP): The US government shutdown that has left 800,000 federal employ-ees without salaries as a result of President Donald Trump's row with Democrats over building a Mexico border wall entered a record 22nd day Saturday. The Democrats' refusal to approve 5.7 billion demanded by Trump for the wall project has paralyzed Washington, with the president retaliating by refusing to sign off on budgets for swaths of ent departments unrelated to the dispute.

As a result, workers as diverse as FBI agents, air traffic controllers and museum staff, did not receive paychecks Friday.

The partial shutdown of the government became the longest on record at midnight Friday (0500 GMT Saturday), when it overtook the 21-day stretch in 1995-1996, under president Bill Clinton. Trump on Friday backed off a series of previous threats to end the deadlock by declaring a national emergency and attempting to secure the funds without congressional approval.

"I'm not going to do it so fast," he said at a White House meeting.

White House meeting.

Trump described an emergency declaration as the "easy way out" and said Congress had to step up to the responsibility of approving the 5.7 billion. "If they can't do it... I will declare a national emergency. I have the absolute right," he insisted.

Until now, Trump had suggested numerous times that he was getting closer to taking the controversial decision. Only minutes earlier, powerful Republican ally Senator Lindsey Graham tweeted after talks with Trump: "Mr. President, Declare a national emergency NOW."

It was not clear what made Trump change course. But Trump himself acknowledged in the White House meeting that an attempt to claim emergency powers would likely end up in legal battles going all the way to the Supreme Court.

Opponents say that

a unilateral move by the president over the sensitive border issue would be constitutional over-reach and set a dangerous precedent in similar controversies. The standoff has turned into a test of political ego, particularly for Trump, who came into office boasting of his deal making powers and making an aggressive border policy the keystone of his nationalist agenda.

Democrats, meanwhile, seem determined at all costs to prevent a president who relishes campaign rally chants of "build the wall!" from getting a win.

Both Democrats and Republicans agree that the US-Mexican frontier presents major challenges, ranging from the hyper-violent Mexican drug trade to the plight of asylum seekers and poor migrants seeking new lives in the world's richest country.

There's also little de-

hate that border walls are needed: about a third of the frontier is already fenced off.

But Trump has

turned his single-minded push for more walls into a political crusade seen by opponents as a stunt to stoke xenophobia in his right-wing voter base, while wilfully ignoring the border's complex realities. For Trump, who visited the Texas border with Mexico on Thursday, the border situation amounts to an invasion by criminals that can only be solved by more walls.

"We have a country that's under siege," he told the local officials in the White House.

Some studies show that illegal immigrants generally commit fewer crimes than people born in the United States, although not everyone agrees on this.

More certain is that while narcotics do enter the country across remote sections of the border, most are sneaked through heavily guard-ed checkpoints in vehicles, the government's own Drug Enforcement 2017 report. It said that most smuggling is done "through US ports of entry (POEs) in passenger vehicles with concealed compartments or commingled with legitimate goods on tractor trailers." Nancy Pelosi, the Democratic leader in the House of Representatives and a key figure in opposing Trump's agenda, said money should be spent in many areas of border security, but not on walls.

"We need to look at the facts," she said.

But Trump accused the Democrats of only wanting to score points against him with a view to the 2020 presidential elections.

"They think, 'Gee, we can hurt Trump," he said. "The Democrats are just following politics."

The name change will only be effective once it is also agreed by the Greek parliament.

Ahead of the vote, Macedonian Prime Minister Zoran Zaev had emphasised the historic importance of the decision.

"Without the accord with Greece, there will be neither NATO nor EU" membership, Zaev said.

"I changed my opinion on the name issue in the name of progress and at the cost of my political career," he added.

Athens has promised to lift its veto on Skopje's attempts to join NATO and the European Union on the condition Macedonia changes its name.

Greece has blocked the path to those international organisations since Macedonia broke away from the former Yugoslavia in 1991 because, it had said, the name Macedonia should apply solely to its own north-

ern province.
For the Greeks, Macedonia evokes national pride as the cradle of Alexander the Great's ancient empire.
The Friday vote brought an end to months of political bick-

ering in Macedonia that

included a controversial consultative referendum in September and a long parliamentary battle.

Officials of the main opposition conservative VMRO-DPMNE party, who refused to take part in the parliamentary debate, claimed the name change was national treason. However several opposition MPs broke ranks and voted for the change, alongside the ruling Social Democratic party and their junior coalition partners from the ethnic Albanian minority.

Notably the outcome was enabled thanks to four MPs who received an amnesty for their alleged roles in the violent storming of parliament in April 2017.

That prompted VMRO-DPMNE leaders to denounce "bribes and threats" used by Zaev to reach the necessary majority.


The vote is a political triumph for the Social Democratic leader who analysts say was weakened by the low turnout in the September referendum.

Macedonia's rightwing president, Gjorge Ivanov, has been a vocal opponent of the proposed name change and continues to speak out against it.

But the Macedonian

constitution stipulates that as the measure was passed by a two-thirds majority, the president has no choice but to sign it into law.

Zaev, who came to power in May 2017, will now look to Greek Prime Minister Alexis Tsipras to uphold his end of the deal, which was brokered
