#### All convicts in Nirbhaya case have to be hanged together, says Delhi HC

New Delhi, Feb 5 (PTI): The Delhi High Court Wednesday said all convicts in the Nirbhaya gang rape and murder case have to be executed together, and not separately.

Justice Suresh Kumar Kait directed convicts to file any application which they want within one week after which authorities should act.

The high court dismissed the Centre's plea challenging the trial court's order staying the execution of the convicts.

The Centre and the Delhi government had challenged the trial court's January 31 order staying "till further orders" the execution of all the four convicts in the case -- Mukesh Kumar Singh (32), Pawan Gupta (25), Vinay Kumar Sharma (26) and Akshay Kumar (31), who are lodged in Tihar Jail.

# Health Dept carries out intense screening process for coronavirus

Screening underway at all border posts; 81,237 screened so far

**SAGAR CHETTRI** GANGTOK, 05 FEB:

**T**ealth Department Thas so far screened a total of 81,237 persons entering Sikkim at five check-posts of the State as a preventive measure against Coronavirus. No cases of Coronavirus were found during this screening process.

Addressing a press conference here on Wednesday, Director General-cum-Principal Director, Health Department, Dr PT Bhutia mentioned that an intense screening process has been going on 24x7 at the State's check-posts at Uttarey [Indo-Nepal border], Rangbang, Rangpo, Reshi and Melli from 29 January.

He informed that till now 160 persons have been screened at Uttarey, 639 at Rangbang, 52,209 at Rangpo, 1908 at Reshi and 26,321 at Melli. He stated that the teams at the check-posts have been asking people entering the State about their travelling history and symptoms.

Dr Bhutia tioned that along with the screening at checkposts, the department has launched an awareness campaign across the State through postering and leaflets in different languages and messages on different media and social media.

The department has established a 20-bedded ward in old STNM hospital complex for quar-



antine process and isolation wards, ambulances and personal protection gears have been kept ready in all district hospitals, he said. He added that a 20-bedded ward in

new STNM hospital has also been kept ready for quarantine.

"So far 857 persons across the world have recovered from this disease, so it is treatable and people should not panic," Dr Bhutia said.

He added that the State has been in continuous touch with the Centre through video conferencing and other mediums.

Responding to a query on three students who returned to Sikkim from China, he informed that the department tracked and traced the three students who arrived in Sikkim before 10 January. He mentioned that the department kept them in home quarantine and they have already passed their incubation period of 14 days and are absolutely fine and safe.

Health Department Additional Director-cum-Nodal Officer, IDSP, Dr YD Chankapa mentioned that teams of doctors and nurses, Infected Disease Management Committee, Rapid Response teams were ready and orientations and trainings have been conducted for them.

## SACAA unloads criticism on SKM president's foundation day address

#### Group sees SKM Govt going the SDF way

**S**ship Amendment Act [SACAA] has criticized the address of Sikkim Krantikari Morcha president and Chief Minister, PS Tamang during the 8th foundation day celebration of SKM held at Rangpo on 04 Feb.

Addressing a press conference here today, SACAA member, Passang Sherpa alleged that Mr Tamang's speech was an attempt to hide the mistakes of his government in these 8 months. He stated that despite repeated protests on the appointment of Prof Mahendra P Lama as the Chief Economic Advisor, the CM defended him instead of removing him immediately.

It was during Prof Lama's tenure as economic advisor to the state from 2002 to 2009 under the previous government, that hydel projects and pharma companies were brought into the State without proper studies.

"Now these hydel projects and pharma companies have become a headache for the State government and the people of the State are only getting temporary jobs in insignificant posts," he said.

On appointment of retired CBI officers for Vigilance Police, Sikkim Pradesh Congress Committee president, Bharat Basnet, said that the State does not need any retired CBI officials as the people have voted for SKM in the hope that the party would allow CBI to investigate corruption in Sikkim.

"In 25 years of SDF government, PS Tamang had also served as a Minister for 15 years so he does not want to bring the CBI as he may also be

## 49 recommendations shortlisted for police reforms

New Delhi, Feb 5 (PTI): The government has shortlisted 49 recommendations made by various panels for bringing police reforms and a meeting of home ministers of states would soon be held to evolve ways to implement them, Rajya Sabha was informed on Wednesday.

Replying to supplementaries during Question Hour, Union Minister of State for Home G Kishan Reddy said four committees have been set up from time to time for making policing effective and transparent, out of which the government has identified 49 of them and is working on ways

to implement them.

"The government has set up four committees from time to time which have made several recommendations. The government has shortlisted 49 such recommendations and are making efforts to implement these recommendations. The government is evolving ways to implement them," the minister told Rajya Sabha.

"The government is planning to hold a meeting of home ministers of states shortly on 49 recommendations for police reforms made by various committees. Changes in the Criminal Penal Code and Indian Penal Code are also being envisaged by the government in this regard," he said.

Reddy said a new police system should be brought in the country. He informed that the age for retirement of central government police personnel has been raised to 60 years. He also informed that there are a total of 25,95,435 total sanctioned posts of police personnel in state governments of which a total of 5,28,165 vacancies exist.

The Minister informed that a total of one lakh police personnel have been recruited in this year itself.

Reddy said Police is a state subject and it is primarily the responsibility of states to make the police force efficient and capable and make its functioning more effective and transparent.

The union government supplements the efforts of states by providing funds for modernisation, issues advisories on various matters and formulates national standards and procedures.

"The role and responsibility of police personnel and their nature of duties is duly considered by respective state governments and UT Administrations while determining their salary and allowances," the Minister said in his written reply.

### EB-Man U proposed match hits financial hurdle

KOLKATA, FEB 5 (PTI): East Bengal are desperately looking for sponsors to host English Premier League giants Manchester United for a dream clash, later this year.

A Manchester United delegation did a recce for the match, planned as per their ongoing centenary celebrations, but with the budget estimated to be Rs 30-crore plus, East Bengal are now in a quandary.

"They are happy and have submitted the report after the inspection. After May we can decide whether they would play or not. As of now we are busy with finding a new investors," East Bengal executive member Debabrata Sarkar told PTI. Having severed ties with current sponsors Quess Corp who are set to leave after the end of the season, East Bengal are looking for sponsors.

On the field too East Bengal are going through a rough patch having suffered four defeats from five matches, including a derby debacle to slip to seventh in the table. East Bengal's Bengaluru-based title sponsors Quess Corp drew criticism in social for the performance as they have posted an apology.

"QEBFC management expresses its sincere regret and apology for any statement/comment which have hurt our fan base and anyone in the East Bengal Family," it said in their tweet post.

Last month, shoes were thrown at Quess East Bengal CEO Sanjit Sen and COO Biswajit Chatterjee following their 1-3 loss to Gokulam Kerala in an I-League match in Kalyani.

#### CBI registers *case in Rs 1,000* cr scam in Chhattisgarh

NEW DELHI, FEB 5 (PTI): The CBI on Wednesday registered an FIR against unidentified officials in connection with a Rs 1,000 crore rehabilitation scam in Chhattisgarh, officials said.

The officials are accused of siphoning funds amounting to Rs 1,000 crore from the State Resource Centre (SRC) and the Physical Referral Rehabilitation Centre (PRRC) of the state government over a period of 10 years. The Chhattisgarh High Court had directed the CBI to take over the probe, officials said.

On January 30, the high court ordered the CBI to register a First Information Report against 12 bureaucrats, including seven IAS officials, in the case of the alleged irreg-

ularities. The order was passed by a division bench of Justices Prashant Kumar Mishra and Parth Prateem Sahu.

In view of the evolving scenario related with 2019- nCOV, the following revised Travel Advisory is issued:

- 1. Existing visas (including eVisa already issued) are no longer valid for any foreign national travelling from China.
- 2. People have already been advised to refrain from travel to China through an earlier advisory. People

traveling to China henceforth will be quarantined on return.

## Opp parties in RS say Constitution under threat, defend anti-CAA protests

**NEW DELHI, FEB 5 (PTI):** Terming the are under attack.... Every day under protests over the amended citizenship law as "spontaneous", opposition parties in Rajya Sabha on Wednesday alleged that the Constitution is under threat from the ruling BJP which is "destroying" the social fabric of the nation.

Members from the NCP, DMK, TDP and the RJD also voiced concern over the detention of NC leader Farooq Abdullah since August 5 last year when Article 370 giving special status to Jammu and Kashmir was scrapped, and questioned the government's intent.

Participating in the debate on the Motion of Thanks on the President's address in the Upper House, the ruling BJP defended the government's decisions on Jammu and Kashmir and the Citizenship Amendment Act, saying they have strengthened the nation and democracy, and slammed the opposition for backing protests like in Shaheen Bagh.

"Nehru, Gandhi, Ambedkar, Constitution and we the people of India the present government is January 30 when Mahatma Gandhi was murdered.

"Ecosystem of the nation is being destroyed and days are not far off when the word Taliban will not be alien here," RJD leader Manoj Kumar Jha said.

He said the protests against the Citizenship Amendment Act were "spontaneous" including in Shaheen Bagh and the situation was so alarming that "5-6 states had passed resolution against CAA and NRC".

He apprehended that the days were not far-off when the fight between the Centre and states will reach the streets and added that "a majority in Parliament is not a licence for a majoritarian in Parliament".

Majeed Memon (NCP) asked what kind of terror was created by former J-K chief minister Farooq Abdullah that he was detained since August 5 and could not attend Parliament. The National Conference leader is an MP from Srinagar.

He charged that the President's

speech did not portray the true picture of the country and appeared like a political manifesto of a political party.

Memon said the constitutional validity of abrogation of Article 370 in Jammu and Kashmir is yet to undergo judicial scrutiny.

DMK's Vaiko termed August 5, 2019 as the "blackest day" in the history of India saying three former chief ministers were detained and added that it was a pre-mediated conspiracy of "Hindutva forces". Minority Affairs Minister Mukhtar Abbas Naqvi Naqvi said the BIP government has strengthened the social fabric of nation and believed in "Sabka Saath Sabka Vikas".

He took a dig at the Congress, saying this is a strong government unlike in the past when "there used to be a PM and super PM and super PMO".

He said electricity connection has been provided in all villages, 11 crore toilets were built and loot in the corridors of power was nipped.

Naqvi charged the Congress with

echoing Pakistan on surgical strike and supporting anti-CAA agitation like in Shaheen Bagh. "A conspiracy has been hatched and fear is being created in the minds of people, and women and children are misguided on CAA," the minister said, adding he never expected a seasoned leader like Ghulam Nabi Azad to say that that the whole country will turn into Shaheen Bagh.

"Bogus bragging brigade was out to create confusion and fear among masses," he said, adding the Congress was disturbed by the massive mandate to the BJP but it should respect it.

The opposition by states to the CAA was not good and a senior Congress member himself said that it was not proper, the BJP leader said.

Secularism and tolerance were in the DNA of the BJP government and it believed in inclusive and sustainable development, he said, adding that minority share in government jobs under Narendra Modi government has increased to 9 per cent from 4.9 per cent.

While criticizing the statement of the CM on the CAA, he stated that the State government should immediately pass a resolution in the Assembly against CAA and extend Inner Line Permit in the entire state.

Further, Mr Sherpa has asked the State Government to clear its stand on the Companies Act which has not been extended to Sikkim yet.

Stating that, in her budget speech, the Union Finance Minister, Nirmala Sitharaman mentioned tax holiday for young entrepreneurs of the country, Mr Sherpa said that without the Companies Act, the youth of Sikkim will not be able to take advantage of

He added that the Union Finance Minister has also mentioned that income tax exemption to Sikkim was for a certain period only. On the same, he questioned the silence of the State government on the matter.

Another SACAA member, Nawin Kiran Pradhan alleged that the State government has been trying to mislead people and is casting doubt on the competency of Sikkim Vigilance Police. While criticizing the CM statement on the service extension and reemployment, Mr Pradhan alleged that SKM government is repeating what the earlier government did.

SACAA member, Yehang Tshong brought up the Limboo-Tamang Assembly seat reservation issue and said that the SKM government should call a meeting of all stakeholders to resolve the issue.

Likewise, another member, Sonam Sherpa alleged that the CM is not talking about programme and policy for youths but is only using the youth as party flag carriers like the SDF government.

## Coronavirus: 104 kept at ITBP facility test negative

NEW DELHI, FEB 5 (PTI): A total of 104 people

kept at an ITBP facility here have tested negative for the novel coronavirus, while results for over 300 inmates are awaited, a force spokesperson said on Wednesday.

#### The NE Club

An idea whose time has come

**D**eople of the North-East are seen as one group by the mainland. Of course, this grouping-together is not political or issue-based or even cultural, but results from a collective profiling as "chinkis". And while we rant often about this "racial" attitude, we continually fail to leverage this recognition of people from the region as one group to secure better privileges for the states of the North-East. Efforts have been made in the past to find common ground to engage with Delhi, but these have too half-hearted and half-baked and have thus failed to deliver anything of any consequence. The CAA affront presents an opportunity for the region to command more attention, and even though it might appear so, it is still not too late to attempt it. Unfortunately, the region continues to ignore a huge opportunity by failing to unite at least for some common causes.


The region has had the North East Council since 1971 and a full-fledged Department for Development of North East Region as well, and even as these institutions have brought funds and infrastructure to the NE, the parochial suspicions of the member states have somehow held the region back from developing together and pursuing larger goals. One could blame petty politics for this lack of cohesion, but the differences obviously run much deeper than that. This, however, should not mean that the NE cannot cobble together a common minimum programme, a set of unanimously endorsed agenda points that the region can pursue with New Delhi. In this regard, Sikkim, the state initially seen as an aberration in the NEC in that it was not contiguous to any North East State, could play a major role. Since Sikkim does not have any shared 'history' with the rest of the NE states, it does not even have any points of conflict with any of them either. It is also a very small state, so it is not even in any serious contention for larger shares of NE funds. It is thus ideally positioned as the mediator to bring the region to collaborate more effectively. And this was even attempted some years ago when the North East Members of Parliament Forum met in Gangtok and passed a set of around a dozen resolutions on matters of common concern. The NEMPF had been around for a while before that meeting, but the Gangtok meet was perhaps for the first time that they formalised a common cause and agreed to present a united lobby in New Delhi to get the region heard in Parliament. The fact that the Members of Parliament were meeting on the neutral ground of Sikkim must have facilitated a more intense exchange of ideas and aspirations. But that was all that was achieved and the initiative lost momentum from thereon.

May be some MPs should have taken a more proactive role to keep the club together and then the initiative might have grown in strength. The Gangtok meet of 2010 was after all only the first such meeting and if the resolutions adopted then had been pursued in one northeastern voice in New Delhi, a strong lobby would have been created. The eight states send 37 MPs to the Parliament, including, until Modi happened, even the Prime Minister. In the fractured mandates of the recent times (save the 2014 and 2019 BJP sweep), this is a strong presence.

Mamata's TMC has only 22 MPs, CPM 3, Congress 52, DMK 24, and Samajwadi Party 5 and look at the kind of muscle they command in Parliament despite the record-shattering 303 MPs that wear the BJP colours in the Parliament. Granted, the MPs from the North East belong to different parties and espouse conflicting ideologies, but if they could agree on a common set of goals for the region and formalize an action plan on how to raise it in Delhi, the Centre will be forced to listen. These issues have to be about more than more funds and investments, they have to be about ensuring more participation in the planning process. The region also has a common complaint against the mainstream media and its ignorance of the region. When 37 MPs speak together and do so often enough, even the mainstream media will be forced to sit up and pay attention, it will be forced to learn about the region as well. And then there is the tiresome charade of lip-service paid to the region as the gateway to southeast Asia, and in Sikkim's case, to Tibet. Nothing substantial has come of it because thus far the interest has remained limited to individual states. Should the gateway actually open, at a scale more effective than Nathula, the entire region will benefit, but that can happen only if the people of the northeast are taken into confidence in the decision making process. A united body of 37 MPs can ensure that. But they have make a concerted effort first. Should such a collaboration be practiced often enough, even the inter-state issues that trouble the region could at least get discussed in a language more civilized than blockades and staredowns...

## **What is Systemic Racism and Institutional Racism?**

t the 2020 BAFTA awards, Joaquin Phoenix **A**called out systemic racism in the film industry in his acceptance speech for leading actor.

He said:

"I think that we send a very clear message to people of colour that you're not welcome here. I think that's the message that we're sending to people that have contributed so much to our medium and our industry and in ways that we benefit from. [...]

I think it's more than just having sets that are multicultural. We have to do really the hard work to truly understand systemic racism."

"Systemic racism", or "institutional racism", refers to how ideas of white superiority are captured in everyday thinking at a systems level: taking in the big picture of how society operates, rather than looking at one-on-one interactions.

These systems can include laws and regulations, but also unquestioned social systems. Systemic racism can stem from education, hiring prac-

In the case of Phoenix at the BAFTAs, he isn't calling out the racist actions of individuals, but rather the way white is considered the default at every level of the film industry.

Stokely Carmichael and Charles V. Hamilton first wrote about the concept in their 1967 book Black Power: The Politics of Liberation.

They wrote:

"When a black family moves into a home in a white neighborhood and is stoned, burned or routed out, they are victims of an overt act of individual racism which most people will condemn. But it is institutional racism that keeps black people locked in dilapidated slum tenements, subject to the daily prey of exploitative slumlords, merchants, loan sharks and discriminatory real estate agents. The society either pretends it does not know of this latter situation, or is in fact incapable of doing anything meaningful about it.

**INVISIBLE SYSTEMS** 

Systemic racism assumes white superiority individually, ideologically and institutionally. The assumption of superiority can pervade thinking consciously and unconsciously.

One most obvious example is apartheid, but even with anti-discrimination laws, systemic racism continues.

Individuals may not see themselves as racist, but they can still benefit from systems that privilege white faces and voices.

Anti-racism activist Peggy McIntosh popularised the understanding of the systemic nature of racism with her famous "invisible knapsack" quiz looking at white privilege.

The quiz asks you to count how many statements you agree with, for items such as:

"I can turn on the television or open to the front page of the paper and see people of my race widely represented

I can be pretty sure of having my voice heard in a group in which I am the only member of my race I can worry about racism without being seen as self-interested or self-seeking."

The statements highlight taken-for-granted privileges, and enable people to understand how people of colour may experience society differently.

#### **CULTURES OF DISCRIMINATION**

Under systemic racism, systems of education, government and the media celebrate and reward some cultures over others.

In employment, names can influence employment opportunities. A Harvard study found job candidates were more likely to get an interview when they "whitened" their name.

Only 10% of black candidates got interview offers when their race could be implied by their resume, but 25% got offers when their resumes were whitened. And 21% of Asian candidates got interview offers with whitened resumes, up from 11.5%.

Systemic racism shows itself in who is disproportionately impacted by our justice system. In Australia, Indigenous people make up 2% of the Australian population, but 28% of the adult prison population.

A study into how systemic racism impacts this over-representation in Victoria named factors such as over-policing in Aboriginal communities, the financial hardship of bail, and increased rates of drug and alcohol use.

Australia's literature, theatres and art galleries are all disproportionately white, with less than 10% of artistic directors from culturally diverse backgrounds.

Systemic racism damages lives, restricting access and capacity for contribution.

It damages the ethical society we aspire to

As Phoenix put it in his speech:

culture is made accountable.

"I'm part of the problem. [...] I think it is the obligation of the people that have created and perpetuate and benefit from a system of oppression to be the ones that dismantle it. That's on us."

Understanding systemic racism is important. To identify these systemic privileges enables us to embrace the point of view of people whose cultures are silenced or minimised.

When we question systemic racism, worth is shared and ideas grow.

## Quarantines have tried to keep out isease for thousands ot years

The recent global spread of a dead-**■** ly coronavirus originating in Wuhan, China, has led world leaders to invoke an ancient tradition to control the spread of illness: quarantine.

The practice is first recorded in the Old Testament where several verses mandate isolation for those with leprosy. Ancient civilizations relied on isolating the sick, well before the actual microbial causes of disease were known. In times when treatments for illnesses were rare and public health measures few, physicians and lay leaders, beginning as early as the ancient Greeks, turned to quarantine to contain a scourge.

In January, Chinese authorities attempted to lock down millions of residents of Wuhan and the surrounding area, to try to keep the new coronavirus from spreading outward. The country's neighbors are closing borders, airlines are canceling flights, and nations are advising their citizens against traveling to China, a modern instance of the old impulse to restrict people's movements in order to stop disease transmission.

U.S. authorities are holding travelers returning from China in isolation for two weeks as an effort to halt coronavirus' spread. Always at the center of the policy of quarantine is the tension between individual civil liberties and protection of the public at risk.

Keeping contagion at bay The meaning of quarantine has evolved from its original definition "as the detention and segregation of subjects suspected to carry a contagious disease."

Now it represents a period of iso-

lation for persons or animals with first law to enforce the act of quarana contagious disease – or who may have been exposed but aren't yet sick. Although in the past it may have been a self-imposed or voluntary separation from society, in more recent times quarantine has come to represent a compulsory action enforced by health authorities.

Leprosy, mentioned in both Old and New testaments, is the first documented disease for which quarantine was imposed. In the Middle Ages, leper colonies, administered by the Catholic Church, sprung up throughout the world. Although the causative agent of leprosy - the bacterium Mycobacterium leprae - was not discovered until 1873, its disfiguring and incurable nature made civilizations wrongly believe it was easily spread.

The plague of the 14th century gave rise to the modern concept of quarantine. The Black Death first appeared in Europe in 1347. Over the course of four years, it would kill between 40 million and 50 million people in Europe and somewhere between 75 million and 200 million worldwide.

In 1377, the seaport in Ragusa, modern day Dubrovnik, issued a "trentina" – derived from the Italian word for 30 (trenta). Ships traveling from areas with high rates of plague were required to stay offshore for 30 days before docking. Anyone onboard who was healthy at the end of the waiting period was presumed unlikely to spread the infection and allowed onshore.

Thirty was eventually extended to 40 days, giving rise to the term quarantine, from the Italian word for 40 (quaranta). It was in Ragusa that the tine was implemented.

Over time, variations in the nature and regulation of quarantine emerged. Port officials asked travelers to certify they hadn't been to areas with severe disease outbreaks, before allowing them to enter. In the 19th century, quarantine was abused for political and economic reasons, leading to the call for international conferences to standardize quarantine practices. Cholera epidemics throughout the early 19th century made clear the lack of any uniformity of policy.

Imported to America

The United States has also had its share of epidemics, beginning in 1793, with the outbreak of yellow fever in Philadelphia. A series of further disease outbreaks led Congress in 1878 to pass laws that mandated involvement of the federal government in quarantine. The arrival of cholera to the United States, in 1892, prompted even greater regulation.

Perhaps the best known example of quarantine in American history, pitting an individual's civil liberties against public protection, is the story of Mary Mallon, aka "Typhoid Mary." An asymptomatic carrier of typhoid fever in the early 20th century, she never felt sick but nevertheless spread the disease to families for whom she worked as a cook.

Officials quarantined Mary on North Brother Island in New York City. Released after three years, she promised never to cook for anyone again. Breaking her vow and continuing to spread the disease, she was returned to North Brother Island,

where she remained for the remainder of her life in isolation.

More recently, in 2007, public health officials quarantined a 31-year-old Atlanta attorney, Andrew Speaker, who was infected with a drug-resistant form of tuberculosis. His case grabbed international attention when he traveled to Europe, despite knowing he had and could spread this form of TB. Fearing quarantine in Italy, he returned to the United States, where he was apprehended by federal authorities and quarantined at a medical center in Denver, where he also received treatment. Following release, deemed no longer contagious, he was required to report to local health officials five days a week through the end of his treatment.

Quarantine today continues as a public health measure to limit the spread of contagious disease, including not just coronavirus, but Ebola, flu and SARS.

Its stigma has largely been removed by emphasizing not only the benefits of quarantine to society, by removing contagious individuals from the general population, but also the benefit of treatment to those who are ill.

In the United States, where the Constitution guarantees personal rights, it's a serious decision to restrict an individual's freedom of travel and compel medical treatment. And quarantine is not an ironclad way to prevent the spread of disease. But it can be a useful tool for public health officials working to stop the spread of a contagious disease.

#### BJP party of "fekus": Mamata

KRISHNANAGAR(WB), FEB 5 (PTI): West Bengal Chief Minister Mamata Banerjee on Wednesday described BJP as a party of "fekus" (those who bluff) who threaten people with guns and bullets to divide the country on the basis of religion.

Without naming Union minister Anurag Thakur or his 'gaddaron ko goli maro saalo ko" remark, Banerjee, who was speaking at a convention of TMC workers at Krishnagar in Nadia district, questioned how a central minister continues in a constitutional post despite speaking unconstitutionally.

The TMC supremo also slammed Uttar Pradesh Chief Minister Yogi Adityanath for his "goli vs boli" comment.

She said, "BJP is a feku party. It is only interested in giving out fake news. It is trying to divide the country on the basis of religion and are threatening people with guns and bullets".

"I was born in Hindustan, not in a nation governed by BJP who attack people with guns and bullets," she added.

The TMC supremo also criticised the BIPled government at the Centre for destroying the harmony in the country by forcibly trying to implement the CAA, the NPR and the NRC.

#### There will be no shortage of funds for NSFs: Rijiju

NEW DELHI, FEB 5 (PTI): Sports Minister Kiren Rijiju on Wednesday assured that there will be no shortage of funds for the National Sports Federations (NSFs), despite the government slashing its allocation in an Olympic year. The government last week gave a substantial hike of Rs 312.42 crore to its flagship Khelo India programme but reduced allocation to the NSFs, National Sports Development Fund (NSDF) and incentives for sportspersons.

"If there are shortage of funds for the federations, these can always be taken up, that is why there is a provision for revision. If they need more money, they will get more money," Rijiju told reporters during an interaction here. The highest reduction in the sports budget was seen in National Sports Federations with Rs 245.00 crore being allocated, which is Rs 55 crore less than the revised Rs 300.85 for 2019-20.

As far as incentives for sportspersons are concerned, the budget has proposed to slash the amount from Rs 111 crore to Rs 70 crore. The budget for NSDF also got reduced to Rs 50 crore from the earlier Rs 77.15 crore. Overall, Rs 2826.92 crore was allocated to the sports budget for the next financial year in the Union Budget, which is an increase of a mere Rs 50 crore from the revised estimates of 2019-20.

Rijiju said: "You are looking from a different angle. Whatever we got in the last budget allocation, we had a jump of more than 50 %, what you are saying 50 crores, you are comparing from the Revised Estimate (RE), if you see the original allocation in last budget, it is a historical jump.

# Rohingya demand role in running camps and tell NGOs stop 'ignoring us'

DHAKA, 05 FEB [THEGUARDIAN]: In a tea room just outside Bangladesh's Rohingya refugee camps, a group of young activists fiddle with their phones, which have suddenly started pinging in chorus now they are finally reconnected to the internet.

To circumvent a government internet blackout around the camps in Cox's Bazar, they have to break a ban on travelling to nearby Bangladeshi towns, from where they can communicate and coordinate messages for the international community.

With simple smartphones the activists have been able to build some kind of Rohingya voice, speaking to the world through WhatsApp, Facebook and Twitter. But their efforts have often been frustrated, mostly for a more fundamental reason than the technological barrier in place since August: they believe the aid community sent to help them is not listening.

"The Rohingya community are not weak, but the situation makes us weak," says Mohammad Arfaat, an activist who was part of a Rohingya team that made a short film about how violence had forced them from Myanmar in 2017.

He has been calling for more help for Rohingya to launch their own initiatives, for everything from education to arts, but complains there has been no support. "The Rohingya youth are very talented ... but nobody sits, nobody talks with them, so their voices have stopped," says Arfaat.

These concerns have risen since August, when Bangladesh responded to a failed attempt to repatriate the Rohingya – for which not a single refugee volunteered - by imposing tighter restrictions on their movement and communication.

Arfaat says that, despite the crackdown, UN agencies and international aid groups have not been present.

"No one comes to research what's happening. [They] have protection officers, but what are they



protecting? Whenever there's violence, they're not here," he says. "You see them on social media, talking to the public, but they don't come to talk to us." Lack of education has been a particularly pressing concern among Rohingya activists, who have campaigned for years against a government ban on all but the most basic level of schooling, warning of a "lost generation".

They won a victory last month when Bangladesh announced a pilot programme to teach children between 11 and 13 the Myanmar curriculum. Rohingya teachers and activists had little knowledge of how the plan would work, however.

The restrictions had been in place since the existing camps were established in 1991, when the same fears about future generations prompted Rohingya who had been educated in Myanmar to set up their own independent learning centres in secret, funded by small monthly contributions from parents.

Similar models have become more prevalent since 2017, when the Kutupalong refugee camp became the world's largest as it ab-

sorbed the hundreds of thousands of people who fled a Myanmar military operation described by the UN as having "genocidal intent".

Activist Khin Maung says that despite three decades of Rohingya experience in the refugee camps, their expertise is not tapped by humanitarian workers. "They don't have the interest

to develop our children, they just have the interest to implement their [own] projects," says Maung, who heads the Rohingya Youth Association. "They are ignoring us because we are refugees. If they treated us as human beings, they would listen

He complains that organisations implementing education projects often employ underqualified tutors who teach only basic phrases and nursery rhymes, failing to utilise the talents of refugees.

A 2019 study by the Peace Research Institute Oslo said that, despite the barriers imposed on the humanitarian community by the government's education ban, more could have been done to map out the work carried out by Rohingya themselves. "The humanitarian sector often falls short on centring community voices in this way, which I think is due in part to policy restrictions, limited resources and a lack of flexibility," says the report's co-author Jessica Olney.

"It's also due to quick staff turnaround, as many humanitarian staff are new to the Rohingya community and aren't encouraged or permitted by their agencies to spend time in the camps just talking to people and listening to gain a deep understanding of the context and people's

The relationship between the Rohingya and the humanitarian community has been strained by a recent government order to stop paying refugee volunteers in cash, which the authorities claim is used to buy false documents. The government has encouraged the hiring of Bangladeshis instead.

Refugees claim they have been removed from volunteer roles, which typically pay a daily stipend of less than £3, which forces them to rely solely on the aid supply of oil, lentils and rice. NGOs operating in

the area claim "miscommunication" was a reason some Rohingya had been dismissed.

"There is a major communication breakdown between some international humanitarian organisations and the Rohingya refugee volunteers about why they are being dismissed," says John Quinley, human rights specialist for the advocacy group Fortify Rights, which has documented the dismissals. There was a similar outcry by refugees when the UN refugee agency, the UNHCR, signed an agreement with Myanmar on repatriating the Rohingya in 2018. Refugees said they were not consulted on that deal, or about a system for biometric registration.

A spokesperson for the UNHCR says the agency used several methods to share information with refugees and engage community leaders, including face-to-face meetings, drama performances and podcasts.

The spokesperson adds: "The Rohingya refugee population in Cox's Bazar is more than 850,000 people. This alone presents a challenge in terms of ensuring that all voices are heard. Furthermore, to communicate effectively with a very large population requires the utilisation of technology. Currently, this presents challenges in Cox's Bazar due to restrictions on mobile connectivity.

"UNHCR works to ensure that refugees are consulted on key issues and are involved in decision-making processes including through regular protection monitoring and profiling, as well as community outreach. Refugees should be consulted on all issues related to their daily lives and not only significant political developments."

Maung says the role played by refugees in the humanitarian response over the past two years, from volunteering as translators to other key roles, has been underestimated.

"They ignore us but without Rohingya involvement they can't do anything in the camps, they can't even understand us properly. They don't know our language," he says. "We are the nuts and bolts."

#### Madhya Pradesh Cabinet passes resolution against CAA



BHOPAL, FEB 5 (PTI): The Madhya Pradesh Cabinet on Wednesday passed a resolution against the Citizenship Amendment Act and sought its abrogation, contending the new law was against the Constitution's secular character.

The resolution was passed during the state Cabinet meeting chaired by Chief Minister Kamal Nath, public relations department minister P C Sharma told reporters.

Madhya Pradesh is currently ruled by the Congress.

Kerala, Punjab, Rajasthan and West Bengal have already passed resolutions demanding scrapping of the CAA.

Sharma said the Madhya Pradesh Cabinet passed the resolution describing CAA as "against the secular character of the Indian Constitution and differentiating people on religious lines".

The Citizenship Amendment Act passed by Parliament in December last year endangers the "country's secular fabric and tolerant nature," the minister said.

"Secularism is the

basic foundation of the Indian Constitution and which can't be changed. It is clearly mentioned in the Constitution that India is a secular country.

Besides, Article 14 of the Constitution grants equality to all citizens of the country under the law," reads the resolution by the state Cabinet.

It asked the Centre to not only take back the CAA, but also clear doubts in the minds of citizens on the issue, as people across the country were protesting against it.

The resolution also demanded that information sought from people in connection with the National Population Register (NPR) be taken back and only after that the census be conducted. To a query, Sharma said a resolution will also be passed against the CAA in the state Assembly.

The CAA, under which non-Muslim refugees from Pakistan, Bangladesh and Afghanistan will be given Indian citizenship, came into force from January 10. It was passed by Parliament on December 11, 2019.

#### Rare reel of Kishore Kumar's banned Hindi film found after 60 years

PUNE, FEB 5 (PTI): The National Film Archive of India has found a reel of a banned 1957 Kishore Kumar starrer "Begunah", more than 60 years after the Mumbai High Court ordered all prints of the film to be destroyed.

The rare clip, found last week, shows music composer Jaikishen (of Shankar-Jaikishen fame) on the piano, actor Shakila dancing and Mukesh as the playback crooning the song "Ae Pyaase Dil Bezubaan".

"Several people have been searching for the reel for many years. Since we didn't have it, we too started looking for it actively. It is a miracle of a discovery," NFAI Director Prakash Magdum told PTI.

The film, which released in 1957, got mired in controversy with Paramount Pictures America alleging it was a copy of their 1954 movie "Knock on Wood".

It won the rights and

ordered all the prints of

the film to be destroyed. All the prints were

thought to have been destroyed after the court order but Magdum believes a few travelled elsewhere and survived.

"We obtained the reels from cinema lovers within India," he added.

He said fans of music composer duo Shankar-Jaikishan had been looking for the footage for a long time as it is the only film to feature Jaikishan in a major appearance.

"We have two 16 mm reels of Kishore Kumar's film 'Begunah' in two phases consisting of around 60 to 70 minutes. One reel came two months back and another came last week. The second one has the song 'Ae Pyase Dil Bezubaan'. It features Jaikishan on the piano and actor Shakila dancing. The song is sung by Mukesh," Magdum said. ## Quarantined Chinese footballers forced to train in Brisbane hotel corridor

SYDNEY, [THEGUARDIAN]: The Chinese women's football team have been forced to train in hotel corridors ahead of their Olympic qualifying opener in Sydney on Friday. The team has been in isolation at a Brisbane CBD hotel since their arrival in Australia last week due to strict protocols in response to the coronavirus outbreak.

Their quarantine does not end until Wednesday, meaning the 32 players and staff have been unable to leave their hotel during the past week and photos of the team stretching on towels in hotel corridors were published by Chinese sports media group Titan Sports on Twitter.

It is understood the team, who have shown no signs of the deadly virus, will arrive in Sydney on Thursday before taking on Thailand in their opening match at Campbelltown Sports Stadium on Friday. They then face Taiwan on Monday and the Matildas next Wednesday.

The team was placed in quarantine due to having trained in Wuhan the epicentre of the outbreak - within 14 days of trained in a Brisbane ho-



their arrival in Australia.

#### **Newcastle's Allan Saint-Maximin sinks Oxford** with stunning late winner **ED AARONS**

OXFORD, 05 FEB [THEGUARDIAN]: Steve Bruce was not even born when Newcastle won their sixth FA Cup in 1955. But after a superb individual goal from the substitute Allan Saint-Maximin helped them edge past Oxford in extra time, despite a stirring comeback from the League One side, the veteran manager may just allow himself a moment to dream.

Like Newcastle, Bruce has unfinished business in this competition having seen his Hull team surrender a 2-0 lead in the 2014 final against Arsenal and he will know they were fortunate to come through this contest. The visitors had been cruising into the fifth round for the first time since 2006 with only six minutes left to play before a free-kick from substitute Liam Kelly, and Nathan Holland's brilliant volley, turned this game on its head. With their owner, Mike Ashley, watching on in the stands, however, Saint-Maximin's brilliant solo effort set up a trip to West Brom in the next round that will have their manager and all Newcastle supporters hoping it may finally be their year.

"I thought we were in complete control until the last five minutes," said Bruce. "But overall the better team won. It's significant for a club like ours to get to the fifth round - I know what it means for the club and the city. We've made hard work of it but we're there."

Bruce had reacted angrily this week to suggestions that his side had sacrificed style over safety since he succeeded Rafael Benítez as manager, with pre-season predictions that they would struggle to survive having so far proved to be unfounded. Yet despite the mid-season break meaning that their next league match is not until mid-February against Arsenal, he still made five changes for what looked a tricky assignment at this strange stadium with only three stands.

Joelinton was retained in attack, while the Longstaff brothers were paired in midfield despite doubts about both their futures still swirling on Tyneside. A tribute to Jim Smith was unfurled by the home supporters just before kick-off in honour of the manager who took charge of both clubs during the 1980s and died at the end of last year. Oxford reached the top flight for the first time in their history under him before he fell out with the then chairman Robert Maxwell and left to join QPR. Smith subsequently lost to his former employer in the League Cup final the following season but remains a cult figure in this part of the world having returned for another spell in charge in 2006. As a proponent of attacking football, Karl Robinson is a fitting successor to his legacy although the sales of two of his best players - Shandon Baptiste and Tariqe Fosu - to Brentford in the final days of last month have not helped his main objective of achieving promotion to the second tier. Oxford came into this match having drawn five of their previous seven including the 0-0 at St James' Park 10 days ago, although victory over Blackpool at the weekend saw them move up to eighth spot.

With their celebrity fan Timmy Mallett watching on, they were the architects of their own downfall on two occasions in the first half. The decision to play the ball out from the back in the 15th minute appeared to have paid off until Alex Gorrin was caught in possession and an excellent lay-off from Joelinton allowed Sean Longstaff to curl home a brilliant shot.

### Messi demands Abidal name names after dressing room criticism

BARCELONA, FEB 5 (AFP): Lionel Messi has hit back at Barcelona sporting director Eric Abidal after the Frenchman blamed slackness in the dressing room for the departure of recently-fired coach Ernesto Valverde.

In an interview with Spanish daily Sport Abidal said that under Valverde, who was sacked in mid-January, many players had been unhappy, hadn't worked hard enough nor communicated properly.

#### Premier League boss admits VAR needs to improve major media interviews, Masters said

LONDON, FEB 5 (AFP): Premier League chief executive Richard Masters admits his organisation must try to improve VAR after a season marred by controversy surrounding the review technology. A recent survey from opinion polling firm YouGov showed more than twothirds of Premier League fans questioned believe VAR has made the game less enjoyable since it was introduced into the English top-flight.

Players, managers and fans have all complained about the way the system is used, with lengthy review delays and dubious eventual decisions causing widespread frustration.

Masters, who started his permanent role with the Premier League in December, told BBC Sport that VAR would stay in the game, but he hopes it can be improved. "I don't think VAR has been damaging but I accept it needs improvement," Masters said.

"Scrapping it is not an option -what we have to do is try and make VAR ent system," he said. better." VAR has been brought in to the Premier League to decide on goals, penalties, red cards and offside decisions.

Masters revealed to the BBC that the Premier League would discuss changes to VAR with the clubs in April.

"We are going to have a debate about what sort of VAR they would like next season and what improvements can be made to the system," he said.

"It's going to be a work in progress this season and next as we try to rebalance it so you get the positives of better decision-making and fewer of the perceived negatives about delay and sometimes confusion." Meanwhile, in his first he does not believe homegrown player quotas will improve the fortunes of the England team.

The balance between homegrown and overseas players in a 25-man Premier League squad is back in the spotlight following the United Kingdom's exit from the European Union, which will affect the way clubs do their international transfer business once the transition period ends at the end of the year.

#### - 'DIFFERENT SYSTEM' -

The Football Association has previously stated in November 2018 that it favoured cutting the number of overseas players per squad from 17 to 13 with a view to boosting the chances of young English talent. FA representatives are due to present to Premier League clubs at the league's shareholders' meeting on Thursday, and Masters says the conversation will be taken forward from there.

"We have to come up with a differ-

"The FA, the EFL and the Premier League all agree that (system) shouldn't impact on the competitiveness of the Premier League, that concept of the best versus the best. Clubs should still be able to acquire the best talent and support a cohort of homegrown players coming through the system.

"We don't necessarily believe quotas are the answer."

Masters also spoke about the relationship between Premier League clubs and betting companies, following criticism of the Football Association for allowing FA Cup matches to be streamed on betting websites.

## De Kock guides South Africa to seven-wicket ODI win over England

CAPE TOWN, FEB 5 (AFP): Quinton de Kock made an ideal start to his fulltime captaincy of South Africa's oneday international team on Tuesday when he hit a century as his side beat England by seven wickets in the first ODI at Newlands.

De Kock made 107 and Temba Bavuma hit 98 as South Africa chased down an England total of 258 for eight with 14 balls to spare.De Kock and Bavuma shared a second wicket partnership of 173 off 170 balls, dominating an England team which included only five of the side that won the World Cup last year.

De Kock made his 107 off 113 balls with 11 fours and a six, while Bavuma faced 103 deliveries, hitting five fours and two sixes. "It was a good night. It feels good

to get back to winning ways," said De Kock. "We had one or two chats about how

we want to take this ODI team forward. Today was a good start -- but it's only one game." South Africa's team also had an experimental feel, featuring only six of the squad who had a dismal



World Cup. "We were way off the mark," admitted England captain Eoin Morgan. "South Africa completely outplayed

us in every department."

Bavuma made a strong case for a long-term place in South Africa's oneday team. A veteran of 40 Tests, he had only played in two previous ODIs, both relatively low-key games in which he made 113 against Ireland in 2016/17 and 48 against Bangladesh the following season.

Batting at number three, Bavuma was largely untroubled, hitting the ball crisply, while he and De Kock seemed to have an almost telepathic understanding in their rapid running between wickets. Bavuma seemed set for a cen-

tury until he went back to Chris Jordan and was trapped in front of his stumps by a ball which kept low.

"We understood it was pretty difficult to hit boundaries," said De Kock.

"It was a matter of finding a way to get momentum and we understood that running hard between the wickets was the way to go about it."

Joe Denly was largely responsible for England reaching what appeared to be a reasonable total on a slow pitch. Denly made his highest one-day international score of 87 and helped rescue England from a precarious 131 for six. He and Chris Woakes, who made 40 in his 100th one-day international, put on 91 for the seventh wicket.

Left-arm wrist spinner Tabraiz Shamsi did the major damage for South Africa, taking three for 38.

"Every batsman apart from Joe Denly and Chris Woakes struggled to get on," said Morgan.

"South Africa bowled well, they bowled accurately and used the conditions with slower balls. (Then) the partnership between De Kock and Bavuma we couldn't penetrate.

WASHINGTON, 05 FEB [THEGUARDIAN]:

An emboldened Donald Trump bragged about the "great American comeback" in his State of the Union address on Tuesday night, in a speech resembling an 81-minute re-election rally that prompted the most powerful woman in Congress to rip up her copy of the speech on national television.

The House speaker, Nancy Pelosi, said she tore up the address, which he delivered on the eve of the verdict in his impeachment trial, because she couldn't find "one page with truth on it".

Only the third president to be impeached in US history, Trump addressed a joint chamber of Congress on the eve of his almost certain acquittal by Republican loyalists in the US Senate. Despite the ignominy of that position, he struck an upbeat, at times euphor-

"In just three short years, we have shattered the mentality of American decline and we have rejected the downsizing of America's destiny," Trump began, to shouts of "Four more years!" from Republicans in the chamber. "We are moving forward at a pace that was unimaginable just a short time ago, and we are never going back!"

This is not the first time a president has delivered a State of the Union speech in the midst of impeachment. Bill Clinton was still three weeks away from acquittal for lying in the Monica Lewinsky scandal when he gave his State of the Union in 1999.

But Trump also faces an election, now only nine months away. As such it was no surprise that the theme of the speech was the "great American comeback".

The president delivered a



speech rippling with jingoism, xenophobia and untruths just feet away from the Democratic leaders who inflicted on him the impeachment trial that he has tried so hard to dismiss as a "witch-hunt".

Several Democrats, including Congresswomen Ilhan Omar and Rashida Tlaib, walked out during the speech. One senator, Chris Murphy of Connecticut, compared it to a "2020 campaign rally".

"It was a total mistake for Democrats to be there. That was a 2020 campaign rally; that was not a State of the Union," he said. "I regret stepping one foot inside."

But Pelosi's protest overshadowed all others. As Trump came up to the podium, Pelosi reached out to shake his hand. In a striking moment, the president declined to return the gesture. She had the last laugh, though: the moment he finished speaking she calmly tore in half her copy of his script.

Republicans quickly seized on the moment, with former speaker Newt Gingrich accusing Pelosi of "childishness".

"Next week, when the president presents his budget, the American people will see the stark reality of his agenda," Pelosi later said in a statement defending the move. "A federal budget should be a statement of our national values, and the president has sadly shown that he does not value the good health of the American people."

Trump's advisers and senior Republicans had been pleading with him to take the high ground and focus on positives rather than unloading on his Democratic rivals in the joint chamber of Congress before him. As the White House counselor, Kellyanne Conway, put it: "Success is the best revenge."

Hewing to that advice, Trump devoted a lengthy part of his speech to what he called the "roaring" US economy, boasting that it was "the best it has ever been". Mindful that the economy is certain to be a major - potentially even decisive - factor in November's election, he ticked off all the electoral blocks that he needs to seduce if he is to have a shot at securing a second term.

He focused on low unemployment rates for African Americans, women, young people, workers without a high-school diploma all of whom will be critical in November's poll.

Trump said his administration had created 7m new jobs and reduced unemployment to the lowest in almost half a century. "Our agenda is relentlessly pro-worker,

pro-family, pro-growth, and most of all pro-American." But in common with his three previous State of the Union addresses, Tuesday night's was packed with misleading statements, exaggerations and blatant untruths. In one of the most memorable passages, Trump claimed that he was increasing social mobility in America.

"The vision I will lay out this evening demonstrates how we are building the world's most prosperous and inclusive society - one where every citizen can join in America's unparalleled success, and where every community can take part in America's extraordinary rise."

In fact, income inequality has reached its highest level since the Census Bureau began tracking the data 50 years ago.

Trump also repeated several of his favorite falsehoods in other areas. "We will always protect patients with pre-existing conditions," he said, when in truth he has encouraged numerous Republican attempts to overturn President Obama's Affordable Care Act and abolish protections for people with pre-existing conditions.

Without naming his presidential rivals, Trump unleashed a ruthless attack on several of them. In particular, he tore into the healthcare plans of Bernie Sanders, the Vermont senator who narrowly came second to Pete Buttigieg in the early results out of the Iowa caucus on Monday.

The "radical left", he said, wanted to "take away your healthcare, take away your doctor and abolish private insurance entirely". To ecstatic cheers from his Republican enablers, Trump addressed "those watching at home", telling them: "Tonight I want you to know we will never let socialism destroy American healthcare." That was not the only red meat that Trump threw his base. He hailed a "man beloved of millions of Americans" - the controversial rightwing radio talkshow host Rush Limbaugh who has been diagnosed with stage four lung cancer - awarding him the presidential medal of freedom.

Among other treats for the ranks of Trump supporters was his pledge to protect second amendment gun rights, backing of the right to pray in public schools, and his name-check for Neil Gorsuch and Brett Kavanaugh, the two conservatives he appointed to the supreme court. Most significantly, he returned to the toxic issue with which he initiated his presidential bid in 2015 - his attack on "criminal illegal aliens".

On foreign policy, Trump was no less contentious. He was self-congratulatory about his "peace plan" for the Middle East, no matter that it has been universally rejected by Palestinians.

He did some more bragging about the assassination last month of Qassem Suleimani, Iran's top military leader, without referencing the Iranian counter-attack on US troops in an Iraqi base that it provoked.

Among the exceptionally rare moments of concord within the chamber was when Republicans and Democrats stood together to applaud the Venezuelan opposition leader Juan Guaidó who attended as a guest of the White House. Brief bipartisanship returned when Trump talked of Afghanistan, saying "we are looking to end America's longest war and bring our troops home".

But for most of the 81 minutes the president addressed one half of the room, and one half of the nation.

#### Israel strikes in Gaza after projectiles, explosive *balloons*

IERUSALEM, FEB 5 (AFP): Israeli aircraft struck Hamas positions in Gaza early Wednesday, the military said, after Palestinians in the enclave launched projectiles and explosive balloons at the Jewish state.

The "fighter jets tar-Hamas terror targets in the southern Gaza Strip" including "a weapons manufacturing site", the army said in a statement.

There were no immediate reports from Gaza of casualties.

Prior to the Israeli attack, militants in Gaza launched three projectiles and a number of "explosive balloons" at southern Israel, the army said, with neither medics nor police reporting casualties or damage.

Since US President Donald Trump's announcement last week of his plan to resolve the Israeli-Palestinian conflict, rockets, mortar shells and explosive balloons have been launched almost daily from Gaza into southern Israel, provoking Israeli retaliation.

Palestinians strongly reject the US plan, seen as heavily favouring Israel.

Hamas and Israel have fought three wars since 2008 but over the past year the Islamists have gradually shaped an informal truce with Israel, under which the Jewish state has eased its crippling blockade of Gaza.

## Hundreds of Salvadorans deported by US were killed or abused, report reveals



has documented 138 deported Salvadorans murdered by gang members, police, soldiers, death squads and ex-partners between 2013 and 2019. The majority were killed within two years of deportation by the same perpetrators they had tried to escape by seeking safety in the US.

The report, Deported to Danger: United States deportation policies expose Salvadorans to death and abuse, also identifies more than 70 others who were subjected to beatings, sexual assault and extortion - usually at the hand of gangs - or who went missing after being returned.

El Salvador, the most densely populated country in Central America with just over 6 million citizens, has one of the world's highest rates of homicide and sexual violence. In addition, almost 11,000 people were registered missing during the last decade more than the number of people who disappeared during the 1979-1992 civil war. Authorities are largely ineffective in protecting the population from this violence, which is often perpetrated by street gangs which have

enforced disappearances and torture have also been perpetrated by state security forces with almost total impunity.

Amid widespread terror and impunity, the number of Salvadorans fleeing has soared, with asylum applicants in the US increasing by almost 1,000% in five years to 60.000 in 2017, according to UN figures.

The dire security situation is well documented, but despite this, the US continues to deport Salvadorans to face abuse and even death, according to HRW.

For instance, 17-year-old Javier escaped gang recruitment in 2010 and sought asylum in the US where his mother Jennifer had already fled. His asylum application was rejected, and Javier was deported in early 2017, aged 23. Four months later he was killed by members of the Mara Salvatrucha-13 gang.

"The United States has to have known this was happening because the cases were publicly reported and more importantly because Salvadorans make it clear in asylum applications that this is their reality. But this reality is ignored or not believed by US authorities," said Elizabeth Kennedy. co-author of the report.

International prohibits the US from returning anyone to a country where they face serious risks to their lives or safety.

About three-quarters of the 1.2 million Salvadorans living in the US without citizenship lack papers or hold a temporary legal status making them vulnerable to deportation. Between 2014 and 2018, the US deported 111,000 Salvadorans, and granted asylum to just 18.2% of applicants - the lowest rate in the region.

Deportations - and violence against deportees - is not a new phenomenon. But the approval of asylum claims plummeted since the Trump administration rolled out a series of hostile policies including Remain in Mexico - officially known as Migration Protection Protocols - and imposed tight restrictions on gender-based and gang-related grounds for asylum. "The attack

on asylum is unique

in the Trump administration, which has put even more Salvadorans - and others - at risk of deportation, and made it much less likely that they are able to even present their case to get effective protection," said Kennedy.

HRW researchers tracked and verified hundreds of press reports, and conducted 150 interviews with deportees, surviving family members, government and security officials, and US immigration attorneys.

The actual number of killings and attacks is probably significantly higher than reported as most crimes in El Salvador go unreported, state violence are covered up, and it's too dangerous for journalists to enter some neighbourhoods.

Alison Parker, managing director of HRW's programme and co-author of the report, said: "Salvadorans are facing murder, rape and other violence after denortation in shockingly high numbers, while the US government narrows Salvadorans' access to asylum and turns a blind eye to the deadly results of its callous policies."

### Syria: half a million people have fled Idlib offensive, says UN body

HAZANO, 05 FEB [AFP]: A regime offensive in Syria's last rebel enclave has caused one of the biggest waves of displacement in the nine-year war, as tensions spiked between Ankara and Damascus following a deadly exchange of fire.

Weeks of intensive aerial bombardment and a bruising ground offensive have emptied entire towns in northwest Idlib and sent huge numbers fleeing north towards the Turkish border.

"Since 1 December, some 520,000 people have been displaced from their homes, the vast majority - 80% - of them women and children," said David Swanson, spokesman for the United Nation's humanitarian coordination office, OCHA.

The exodus, coinciding with a biting winter, is one of the largest

"This latest displacement compounds an already dire humanitarian situation on the ground," Swanson said.

He said the UN was alarmed by the plight of more than three million people – half of them displaced by violence elsewhere - who live in Idlib province and surround-

Government troops and militia forces backed by Russian and other allied forces have in recent weeks upped the pressure on the jihadist-dominated region.

Mohammad Bahjat,

34, said he and his family were escaping deadly bombardment for the third time in days. "We fled in the middle of the night and have no idea

Regime forces also exchanged deadly fire with Turkish troops on Monday, an escalation UN chief António Guterres called "extremely worrying".

Regime shelling of Turkish positions in Idlib killed at least five Turkish soldiers and three civilians, Ankara said. The Syrian Observatory for Human Rights reported that retaliatory fire from Turkey killed at least 13 Syrian government troops.

President Tayyip Erdoğan on Tuesday told his Russian counterpart Vladimir Putin that Ankara would respond "firmly" to any new Syrian attack.
